Season of need and giving

ith Thanksgiving less than a week away and Christmas little more than a month away, Colleen Meyer, client services administrator for the Idyllwild HELP Center, is optimistic that the 50-plus needy families in Idyllwild will have a bountiful holiday season thanks to the generosity of local residents.

"We need food," Meyer said. "Our pantry is pretty low and any food donations would be appreciated." The center also welcomes donations of fresh turkey and other meats, but storage can be a challenge due to storage constraints. Meyer suggests that fresh meat donors call ahead so they can make the necessary arrangements to deliver the meat directly to the family scheduled to receive it.

Family sponsorship is also an option. "We've had people who have asked to sponsor an entire Thanksgiving meal for a family and that is so wonderful. Even though the recipient is anonymous, you have no idea how much this means to needy families," said Meyer. See HELP, page 9

Newborn calf 1, Coyotes 0

rednesday, Nov. 6, was like any other day at work for Rudolph Nuñez, the senior groundskeeper at Living Free Animal Sanctuary for the past seven years. Nuñez oversees the approximately 160acre sanctuary and was performing routine maintenance in an area near Johnson Valley where the sanctuary and Garner Valley Ranch meet, when he heard an unfamiliar sound.

"It didn't sound like the animals I'm accustomed to hearing," Nuñez explained. "Whatever it was sounded distressed." So Nuñez followed the sound and came upon three coyotes positioned in a circle about 30 feet from where he stood.

Nuñez looked down in the brush and spotted a calf. Nuñez chased off the coyotes and radioed the sanctuary office. "You're not going to believe this," he said. "There's a baby calf out here. Please send me some help."

Nuñez also suggested to the office staff that they call Garner Valley Ranch because he recalled seeing ranch hands loading up the cattle just a few days prior. When Living Free contacted the ranch, the staff at the ranch were relieved that the calf had been located.

"When we called Garner Valley Ranch, they knew that one of the cows had given birth, but they couldn't find the calf," said Sharon Maguire, Living Free board president. "They thought the calf was probably dead since it had been on its own a couple of nights. Ted Johnson [manager of Garner Valley Ranch along with his wife, Mary Elizabeth "Meg" Garner] was thrilled that we found him and

Living Free employees Tony White, Edgar Santiago and Cowboy Ray helped Nuñez move the calf to safety and waited for the ranch staff to arrive.

"When Ted Johnson arrived, he was really grateful to me for rescuing the calf. He invited my family to come up to the ranch sometime. He also asked me what I thought we should name him," said Nuñez, "I said how about 'Lucky 7' since I found him in Area Seven."

But Johnson had other ideas. As he put the calf in the cab of his truck he turned to Nuñez and said, "I think we should name him Rudolph."

[Rumors are little Rudy is getting a scholarship to Notre Dame, to the School of Agriculture.]

Disaster group makes headway with county

The Mountain Disaster Preparedness group met with several Riverside County officials last week to discuss emergency medical care in case of a disaster such as an earthquake, which might leave the Hill isolated from nearby medical facilities.

MDP has been developing plans for providing emergency medical services for more than a year. Among its initiatives is obtaining Red Cross approval for a shelter on the Hill if necessary and receiving county recognition of the medical response team.

This session was a very positive step forward, according to several of the participants.

"We thought it was very helpful," said Dr. Dick Goldberg, who heads up the medical response team. "We presented a very comprehensive review of our medical preparation at the volunteer level. They were very supportive of our efforts."

County officials were impressed with the skills and talent available here, said Emergency Services Coordinator Gina Moran-McGough of the county's Office of Emergency Services.

No formal agreements were signed at the Nov. 5 meeting, but the county's medical team has agreed to

provide specific training to MDP's medical volunteers. "They offered to send people here to train us as a

medical reserve corps," Goldberg said happily. "They have a lot of systems in place to augment our system."

MDP has been pursuing the county relationship at the Mountain Emergency Services Committee meetings (MEMSCOMM). Moran-McGough chairs those meetings.

She and Peter Lent, OES deputy director, arranged last week's meeting to introduce the Hill group to the county emergency medical leadership, including Dr. Cameron Kaiser, County Public Health officer, and Bruce Barton, director of the county's Emergency Medical Services Agency.

Moran-McGough knew that MDP members were Community Emergency Response-trained, but she wanted the county to know of the group's other emergency medical capabilities and what value they could add.

One advantage of a relationship with the county's public health organization is that seeking Red Cross approval of a medical shelter won't rest solely with MDP. The county can also approach Red Cross to designate this resource.

"It really worked out well," observed MDP President Mike Feyder. "We are only emergency prepared, but as well prepared as we can be."

Riverside County Transportation Department will be reconstructing the roads.



County grapples with potential budget disasters

After the first quarter of fiscal year 2013-14, the Riverside County financial condition continues to improve very slowly. However, several very dangerous issues are on the horizon before the fiscal year ends June 30, 2014.

The most egregious is the deteriorating finances of the County's Regional Medical Center in Moreno Valley.

Its current cash storage is already \$86.1 million, according to County Executive Jay Orr. The center's projected operating deficit is more than \$50 million.

Just last week, the Board of Supervisors approved an agreement with Huron Consulting Services to advise the hospital management on potential savings and efficiencies.

In a report submitted last month, Huron said it has identified several changes that would save millions.

For example, pharmaceutical discounts, which have not been implemented, could save \$8 million to \$10 million annually.

The county also has hired an interim hospital CEO to oversee needed changes to ensure the institution's survival and the assistance it provides the community.

The Sheriff Department's budget may also substantially degrade the county finances. At this point, the sheriff's budget projects a \$39 million deficit. The preponderance of this shortfall is attributable to the sheriff's need to expand staffing. Earlier this year, the Board of Supervisors directed the sheriff to increase patrol staff in the unincorporated areas such as the Hill.

The board wants the sheriff's office staffing to return to one deputy per 1,000 residents. Just a year ago, because of budget reductions, the ratio had dropped to nearly three-quarters of a deputy per 1,000 residents.

The slowly expanding jail situation also mandates more deputies and this staff also is growing. Between the two initiatives, the sheriff's budget may need another \$35.7 million, more than 90 per-

cent of the possible underfunding.

The executive office has not increased the sheriff's budget allocation yet, since these estimates may ultimately be less. For example, last year, at mid-year, the staff projected a \$10 million deficit in this budget. By the end of the fiscal year, a \$3.7 million savings was achieved because the rate of new staffing did not meet projections.

"We have an agreement with the sheriff that as they need money to pursue and to implement policy changes you made, we will provide the money," County Chief Finance Officer Ed Corser told the board last week. "Otherwise, we might have to unnecessarily cut other departments." Also contributing to this short-fall is the county's agreement with labor unions. In return for changes in pension, particularly for new employees, salaries have increased.

While Orr plans to have a mid-year budget review available in February, he is already planning for the 2014-15 budget.

"Achieving structural balance within cautious revenue assumptions is essential to laying a sound foundation for the county's future," Orr said in his report to the board. "Consequently, non-public safety departments are expected to absorb current and future labor-cost increases."

State's revenues are ahead of forecasts

California's economic recovery continued to bolster revenues in October for the fiscal year July 1, 2013 through June 30, 2014.

For the four months since July 1, tax receipts have run ahead of projections while disbursements have been generally in line with estimates.

"State revenues are more than \$600 million ahead of projections following a second straight month of strong collections," said State Controller John Chiang in a press release

"Importantly, because higher-than-expected payroll withholdings and estimated payments are driving the good news, it signals that Californians are beginning to earn more, work more, and the Great Recession is becoming a faint image in the rear view mirror ..."

October revenues exceeded the June budget estimates by \$510 million or 10.7 percent. Personal income taxes were \$439 million or 11.8 percent, also greater than initial projections.

Income taxes are about two-thirds of the state's total revenue.

Higher total income, driven by job growth, has supported the tax base, while capital gains resulting from this year's sharp rise in stock prices have provided a special boost.

Technology companies,

which favor California, have been in the forefront.

October saw both the effects of last year's income gains and this year's expected increases.

Payments linked to the filing of final returns for 2012 exceeded estimates, while refunds were lower. Reflecting higher anticipations for 2013 earnings and tax obligations, both estimated taxes and tax withholding were ahead of October's forecasts.

More jobs, higher stock prices, and rising home values drove consumer spending. Consequently, sales tax receipts were \$53.2 million, or 7.4 percent ahead of budget estimates.

Of the three major revenue sources, only corporate taxes missed estimates during the month, with a shortfall in tax receipts of \$16 million, or 8.9 percent.

Through Oct. 31, total General Fund receipts have surpassed budget forecasts by \$632 million, or 2.5 percent.

Personal income tax receipts have led that outperformance.

On the disbursement side, outlays were less than expected in October, including \$625 million linked to state-mandated educational reform (Common Core), along with other education bills.

These funds will be paid in November instead of October.



Lori Alexander, 64, teacher, pianist and composer, died peacefully Wednesday, Nov. 6, 2013, after a brave battle with cancer. She was at home in Santa Monica, surrounded by those who loved her.

Lori, whose parents were Jannette Alexander and Howard Alexander, both deceased, was born Nov. 13, 1948. She is survived by her husband William Waddell, stepson Paul Waddell and stepmother Connie Alexander, all of Los



Angeles; her brother Mark Alexander, sister-in-law Meg Alexander, niece Janine Alexander, all of Healdsburg; and her cousin Allan Abrams of Seattle.

As a young graduate of USC, Lori lived in Los Angeles where she composed for piano, worked in television and the movie industry, and ran a thriving piano studio. She also directed a nonprofit piano program for underserved students.

Around 1993, she "retired" her teaching studio to return to Idyllwild, where she had been a student at ISOMATA 20 years earlier. It was in Idyllwild that she was introduced to her husband, William. It was in Idyllwild, with the support of musical friends, that she fully developed her compositional talents and heard her pieces performed by the Idyllwild Arts Orchestra under the baton of Ransom Wilson and the University of Redlands Symphonic Band, and where a commission project for the San Diego Chamber Orchestra was initiated. Her compositions reflect detailed preparation and score study, a relentless search for new ways to express texture and timbre, as well as displaying Lori's signature humor.

In Idyllwild, she returned to teaching selected students and loved her time with these young people. She supported and served on the board of MUSICA! to make music training available to many others. Lori brought her rationality and thoroughness to solving all of life's challenges and, with that same diligence, encouraged her friends to realize their own dreams.

She loved her family deeply and often expressed her appreciation to those around her for the balance they contributed to her life. She will be sorely missed.



into this new office in the Oakwood Village on North Circle Drive in

June was not just an adjustment for us but one for our customers, as well.

Even now, in mid-November, locals still walk into the office almost daily and say they didn't know we had moved or they had not been in our new quarters. Nearly everyone agrees that the office, though small compared to the last two, exudes charm, warmth and comfort.

In general, we like it better, too. And opening not just a newspaper and publishing office but a visitors center more than doubled our foot traffic.

(As an aside, one recent Wednesday we helped more tourists than we do on a normal weekend.)

Despite that we keep our doors open seven days a week now (except a couple of holidays), any business with doors, phones and employees serves as a visitors center in a tourist town. Even Jack has stepped in at the front desk to answer the multitudes of questions ranging from hiking to eating to lodging to things to do.

Last weekend, he experienced two particularly poignant encounters with tourists. A woman asked for things to do that weekend. He suggested she look at the Arts and Entertainment calendar in the TC for ideas, and opened it to that section while he saw her reach for what he assumed was 75 cents from her husband to buy the paper. Instead, she leaned over Jack's shoulder with a cell phone and shot a photo of the page. We are still howling over that one.

A man stopped by for information and in passing, mentioned the dead trees he drove past in Mountain Center. He voiced concern about the destruction the bark beetles had caused in that area. Teaching beyond Moving typical clichés

In last week's article on the Common Core State Standard, it was stated that 'In the former instructional models, the teacher stood before the class, like Socrates, and was the keeper of knowledge."

The Socratic Method (named, not surprisingly, after Socrates), does not involve a "keeper of knowledge" standing before students and dispensing that knowledge.

Instead, the Socratic Method involves "inquiry and discussion between individuals, based on asking and answering questions to stimulate critical thinking and to illuminate ideas" (Wikipedia).

Maybe Socrates was onto something. After all, he was mentor to Plato, as Plato was mentor to Aristotle — some pretty smart guys.

Yes, they all believed the Sun went around the Earth, but I suspect that one day people will look back in a similar way on Albert Einstein, Roger Penrose and

Stephen Hawking.
I love clichés. They are like the carpool lane: Quick, efficient, but they never take you anywhere new.

Last week's article states, The [CCSS] focus becomes similar to the cliché parable of teaching someone to fish versus giving them the fish."

We need educators who think beyond cliché.

How about substituting this less-clichéd parable?

Teacher shows students how to rig a rod, bait a hook and cast. Lets students do it a few times. Lets them catch some fish. Lets them toss a few on the grill. (Thus far, students have been trained, not educated).

Next day, teacher takes away the fishing gear and says, "OK, I taught you how to fish, but today you don't eat until you figure out a better way to fish."

We'd soon have a boatload of fish.

And now we get to the good stuff, because at this point it would be appropriate to have students discuss whether or not catching so many fish is ethically responsible. (Try scoring that one on a standardized test.)

Teacher might even go off on a tangent not covered in the "How to Fish" textbook and suggest that students explore alternate ways of feeding themselves. Hmmm.

What would happen if we planted some seeds? Wow, that was cool. Who'd have thought? But wait, what if we genetically modified those seeds before we planted them?

Don't like that parable? Wonderful. But don't debate the issue. Instead, form a Socratic circle where the goal is not to prove one argument or another but, rather, to work together toward a better parable.

Teen center needs youth activities

I have found through data collected from a survey given to the public by my eighth-grade class that our community lacks youth activities. In volume 68, number 39 of the Town Crier, there was an article on plans for a community center. I believe this will be great for the youth. There are three building phases in this community center project. Phase one is the Butterfield Family Center, IDYLLWILD MIDDLE SCHOOL

Don't be scammed

Editor's note: Because scams are becoming so prevalent and sophisticated, the Town Crier is starting this column to warn readers of what to look out for.

The Internal Revenue Service is warning consumers about a phone scam targeting taxpayers, including recent immigrants, throughout the country.

Victims are told they owe money to the IRS and it must be paid promptly through a pre-loaded debit card or wire transfer. If the victim refuses to cooperate, they are then threatened with arrest, deportation or suspension of a business or driver's license. In many cases, the caller becomes hostile and insulting.

"This scam has hit taxpayers in nearly every state in the country. We want to educate taxpayers so they can help protect themselves. Rest assured, we do not and will not ask for credit card numbers over the phone, nor request a pre-paid debit card or wire transfer," said IRS Acting Commissioner Danny Werfel. "If someone unexpectedly calls claiming to be from the IRS and threatens police arrest, deportation or license revocation if you don't pay immediately, that is a sign that it really isn't the IRS calling." Werfel noted that the first IRS contact with taxpayers on a tax issue is likely to occur via mail

Other characteristics of this scam include:

- Scammers use fake names and IRS badge numbers. They generally use common names and surnames to identify themselves.
- · Scammers may be able to recite the last four digits of a victim's Social Security Number.
- Scammers spoof the IRS toll-free number on caller ID to make it appear that it's the IRS calling.
- Scammers sometimes send bogus IRS emails to some victims to support their bogus calls.
- · Victims hear background noise of other calls being conducted to mimic a call site.
- · After threatening victims with jail time or driver's license revocation, scammers hang up and others soon call back pretending to be from the local police or DMV, and the caller ID supports their claim.

If you get a phone call from someone claiming to be from the IRS, here's what you should do:

If you know you owe taxes or you think you might owe taxes, call the IRS at 1800-829-1040. IRS employees at that line can help you with a payment issue, if there really is such an issue.

If you know you don't owe taxes or have no reason to think that you owe any taxes (for example, you've never received a bill or the caller made some bogus threats as

Health site upgrading

On Monday, Nov. 11, officials at Covered California announced that the coveredca.com website will be offline beginning at 8 p.m. Saturday, Nov. 16. The site is expected to be back online at 6 a.m. on Tuesday, Nov. 19. Officials will be adding a new small-business marketplace to the site during the shutdown.

"Even though Covered California is doing relatively well ... there [are] still upgrades to do," said Anthony Wright, Health Access executive director. Plans to shut down the site will not be the subject of a press release or other public statement because Wright and exchange board members felt it could "needlessly alarm folks."

Small-business owners attempting to use the Covered California website have found it a frustrating experience. The small business health options program (SHOP) section on the website is not completely functional and while browsing the companies that provide coverage is functional, SHOP Health Insurance Plans is not; advising that an "update is coming soon."

Officials at Covered California announced that 179,562 applications were started through Oct. 26, but the state has declined to release the number of completed applications and the breakdown of small-business applications. Those figures will not be released until Nov. 14.

"It's not our preference to have the system down a day or two, but that's what it takes," said Wright.

Voting continues for Audubon California's 2013 Bird of the Year), which recognizes a California bird species of conservation interest.

This year also brings the addition of two new categories: Comeback Kid and Cutest Fluffy Fluff.

More than 10,000 votes have been submitted. The public is encouraged to cast their votes online on Audubon California's website at ca.audubon.org through Friday, Dec. 6, and people may vote as many times as they wish.

Audubon California established the contest four years ago to highlight the state's birds and the conservation challenges many of them face.

The Yellow-billed Magpie, the Barn Owl, the California Condor and the Sandhill Crane have all previously held the title of Bird of the Year.


"Birds are the one form of wildlife people see every day," said Brigid Mc-Cormack, Audubon California's managing director. "Our hope is to allow the public to celebrate their favorite species and become involved in our conservation efforts to protect all California birds."


Although the public may vote for any bird, Audubon California has nominated six species in particular: Burrowing Owl, Golden Eagle, Black-necked Stilt, Loggerhead Shrike, Brown Pelican or Western Yellow-billed Cuckoo.

"What's special about Audubon is our strong network of chapters and volunteers working to protect our most vulnerable birds," said McCormack. "Every bird on this list is supported by an Audubon conservation effort."



May Valley Trails Project back on track

The International Mountain Bicycling Association, Idyllwild Cycling and the U.S. Forest Service will work together to move the May Valley trails project forward after the Mountain Fire and a government shutdown stalled progress.

"For the immediate future, the Emergency Closure Order that encompasses the May Valley area is being reviewed and evaluated for possible adjustments. For the longer term, the USFS has pledged to complete the National Environmental Policy Act process by Sept. 30, 2014. That process will include input from interested parties, including but not limited to, the Idyllwild Cycling membership and local trail advocates, along with design suggestions from IMBA Trail Solutions, which will field a staffer in the area during 2014 to redesign some of the trails," according to the May Valley, California, Trail Plan Update posted by Patrick Kell, IMBA southwest regional director, on Nov. 6, on the IMBA website, www.imba.com

According to Kell, Idyllwild Cycling contacted IMBA in February 2012. IMBA met with Idyllwild Cycling and the USFS at the SBNF office in San Bernardino in March 2012. The parties discussed trail access issues in May Valley. "We then continued to have monthly (or so) meetings in Idyllwild until October 2012, at which stage the USFS told us that Riverside County had allocated funds toward the planning and review process in May Valley. I also attended the 2012 Spring Challenge race in May Valley and got to meet a lot of the local folk there," said Kell in an email to the Town Crier.

In July 2012, Idyllwild Cycling became an IMBA chapter club. The focus of IMBA and Idyllwild Cycling was to create a designated trail system in the May Valley area.

IMBA then appealed the USFS decision to restrict motorized and non-motorized vehicle travel to National Forest System roads and trails and limited areas designated for vehicle use. A settlement agreement was reached whereby the USFS would resolve unclassified (unauthorized) non-system routes

over time. A travel analysis process was conducted in the fall of 2012 and included input from forest resource specialists and special interest groups. TAP was the basis for the proposed May Valley Non-Motorized Trails Project and the resulting Scoping Document.

According to the Scoping Document, the actions proposed involve adding non-motorized trail improvements to the National Forest System in the May Valley area, maintaining and managing the improvements, and restoring unauthorized trails that are proposed for closure and abolishment. The actions proposed, it states, are dependent on partnerships for implementation. The Scoping Document outlines the plan in detail and includes maps and tables of proposed actions. Then in May 2013, David A. Austin, acting district ranger, issued a letter to interested individuals, organizations and

agencies seeking public comment for the May Valley Non-Motorized Trail Project which involved adding, maintaining and managing improvements along with restoring unauthorized trails proposed for closure and abolishment.

But then came July's Mountain Fire, burning 27,531 acres and ravaging the May Valley area resulting in the closure of all hiking and mountain biking trails in the area. With USFS resources taxed, the May Valley Trails project was put on hold. Talks were set to resume when the federal government shut down and stalled progress once again.

Now that the shutdown is over, talks are resuming. District Ranger Arturo Delgado, San Jacinto Ranger District, said, "Plans for the May Valley project are being coordinated with IMBA and are moving forward. We hope to have a draft of the environmental assessment completed and out for review by next spring or summer."

Recreation fee advisors sought

The Bureau of Land Management and the U.S. Forest Service are seeking nominations for key positions on the Pacific Southwest Region California Recreation Resource Advisory Committee, an 11-member group, through Dec. 8.

Five people are sought to represent winter non-motorized recreation, such as snowshoeing, cross country, downhill skiing and snowboarding; summer motorized recreation, such as motorcycles, boaters and off-highway vehicles; and summer non-motorized recreation, such as backpacking, horseback riding, mountain biking, canoeing and rafting.

Three people are sought to represent non-motorized outfitters and guides and local environmental groups.

Three people are sought to represent Indian tribes; and local government.

The term for these positions begins March 2014 when the current three-year term appointments expire. Current members who have only served one term may reapply. Terms for the current appointed alternates also expire March 2014 and they may apply for a position. Alternates may be selected from the applications received. Alternates do not take a member's place in their absence; they are appointed to fill a vacancy should the member find it necessary to leave the RRAC.

RRAC makes recommendations on recreation fees for federal lands within the state. This includes implementing or eliminating fees for BLM and USFS recreation sites and services, expanding or limiting the recreation fee program, and fee level changes.

Salvage logging ignores wildfire benefits

As part of its efforts to ensure counties with a large portion of public lands receive payments equivalent to the loss of property taxes, the House of Representatives has passed a bill that would increase timber logging efforts on many national forests.

While logging is in a long-term decline in America, the causes are varied. Certainly heightened environmental sensitivity, as well as specific laws such as the National Environmental Protection, Endangered Species and Wilderness acts, have reduced some logging. (All were originally enacted in the 10 years between 1964 and 1973.) But economic issues are generally even more powerful.

Last month, the House passed H.R. 1526, which not only requires the Secretary of Agriculture to designate lands within every national forest as eligible for timber harvest but also mitigates environmental protections such as applying NEPA.

Although the Obama Administration opposed the bill, during the House Natural Resources Committee hearings, little formal opposition formed. But since its September passage, more and more scientists and organizations are speaking out against several of these sections.

On Oct. 30, 250 scientists (including Dr. Jennifer Gee, director of the University of California's James Reserve, north of Pine Cove) signed a letter to the Senate objecting to the section enabling easier logging on areas burned by wildfires.

The letter encouraged recognizing the importance of the burned areas to the natural rejuvenation of the forest and its wildlife habitants.

"Though it may seem at first glance that a post-fire landscape is a catastrophe ecologically, numerous scientific studies tell us that even in patches where forest fires burned most intensely, the resulting post-fire community is one of the most ecologically important and biodiverse habitat types in western conifer forests," the letter reads. "Post-fire conditions serve as a refuge for rare and imperiled wildlife that depend upon the unique habitat features created by intense fire. ... This post-fire habitat, known as 'complex early seral forest,' is quite simply some of the best wildlife habitat in forests and is an essential stage of natural forest processes. Moreover, it is the least protected of all forest habitat types and is often as rare, or rarer, than old-growth forest, due to damaging forest practices encouraged by post-fire logging policies."

Complex early seral forests "occur when most of

the live trees in a stand are killed, leaving behind an area of dead trees (called snags) and a carpet of downed logs, flowers, shrubs, and small sapling," according to the Wild Nature Institute.

Trying to revive a diminishing industry, House Natural Resource Chair Doc Hastings (R-WA) argued, "Last year, 9.3 million acres of national forests burned in wildfires. As comparison, only 200,000 acres

were harvested by the U.S. Forest Service. This means that 44 times more acres burned compared to those acres that were responsibly harvested.

"The bill requires responsible timber production on at least half of the Forest Service's commercial timber lands — areas that were specifically identified by the Forest Service for timber harvest," he said.

The administration has already indicated that Presi-

dent Barack Obama's senior advisors would recommend he veto the bill. Among the reasons, are "Title I would negatively impact forest resources and the Department of Agriculture's current statutory obligations to manage forest lands by requiring [the department] to sell no less than 50 percent of the sustained yield from the bill's newly created Forest Reserve Revenue Areas."

Another reason is the bill "would also accelerate

commercial grazing and timber harvests without appropriate environmental review and public involvement, and would impede compliance with NEPA and Endangered Species Act (ESA) requirements."

Both the Los Angeles Times and the New York Times editorial boards have recently spoken against these provisions.
