## Hazardous waste collection Sat., Nov. 15

Riverside County Waste Management Department has announced it will be collecting household hazardous waste at the Idyllwild County Road Yard from 9 a.m. to 2 p.m. Saturday Nov. 15.

Electronic waste, such as televisions and computers, will be accepted for

free, as well as other hazardous waste. This is particularly important since Waste Management Corp. charges \$25 per item to leave electronic waste at the Idyllwild Transfer Station. If electronic waste is taken to the Transfer Station, payment must be made in advance by calling 1-800-423-9986.

There is a limit of 15 gallons of liquid waste or a

total of 125 pounds; however, multiple trips are permitted.

Other acceptable items at the household hazardous waste collection Saturday include used oil and filters, latex or oil-based paint, fluorescent tubes or bulbs, pesticides, cleaners, barbecue and camp-sized propane, aerosol cans, antifreeze, auto batteries, *See Waste, page 5*

## Local fuel treatments help during big fires

Organizations performed work prior to Mountain Fire

Last week, the U.S. Forest Service released a report evaluating the effectiveness of fuel treatments during the Mountain Fire in July 2013.

The primary goal of the

report was to assess the effect of the treatments on the fire's behavior and intensity and their ability to improve fire suppression efforts near communities.

"Our trends suggest that fuel treatments can facilitate suppression activities and potentially reduce fire behavior and fire

effects, depending on the fire weather or conditions," the report's authors concluded. The more recent the treatment, the more likely it reduced fire severity or aided fire suppression.

The Forest Service studied areas that had received fuels treatments such as tree removal, mechanical thinning, pile *See Fuel, page 28*

Riverside County 3rd District Supervisor Jeff Stone was elected to the state Senate last week. Stone's last Board of Supervisors meeting is Nov. 25. He will resign his county position Nov. 30 and the next day, Dec. 1, will be sworn in as a state senator.

Gov. Jerry Brown will choose Stone's replacement for the 3rd District and has no deadline to make the decision. Stone's

term ends December 2016. He was re-elected in 2012 and is serving his third term. The position is non-partisan.

Stone said he has asked to meet with Brown to describe the district and the major concerns and needs of its residents. "Hopefully, he will meet with me and then know the challenges

when he interviews people," said Stone.

One possibility is Temecula councilman and former Mayor Michael Naggar, who had announced in 2013 that he would like to succeed Stone, who had said after his 2012 re-election that he would not seek another term. Naggar has *See Stone, page 3*

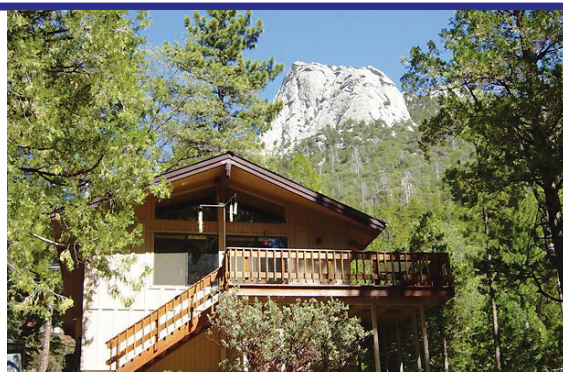

# Two fatalities on Hill identified

An Oceanside man committed suicide on the Idyllwild Summit Trail in Idyllwild County Park last week.

The Riverside County Sheriff's Department was notified at 12:13 p.m. Wednesday, Nov. 5, to respond to the suicide of Jastin Pak, 27. Because of confidentiality issues, Public Information Officer Albert Martinez said no details could be given of how he died and why.

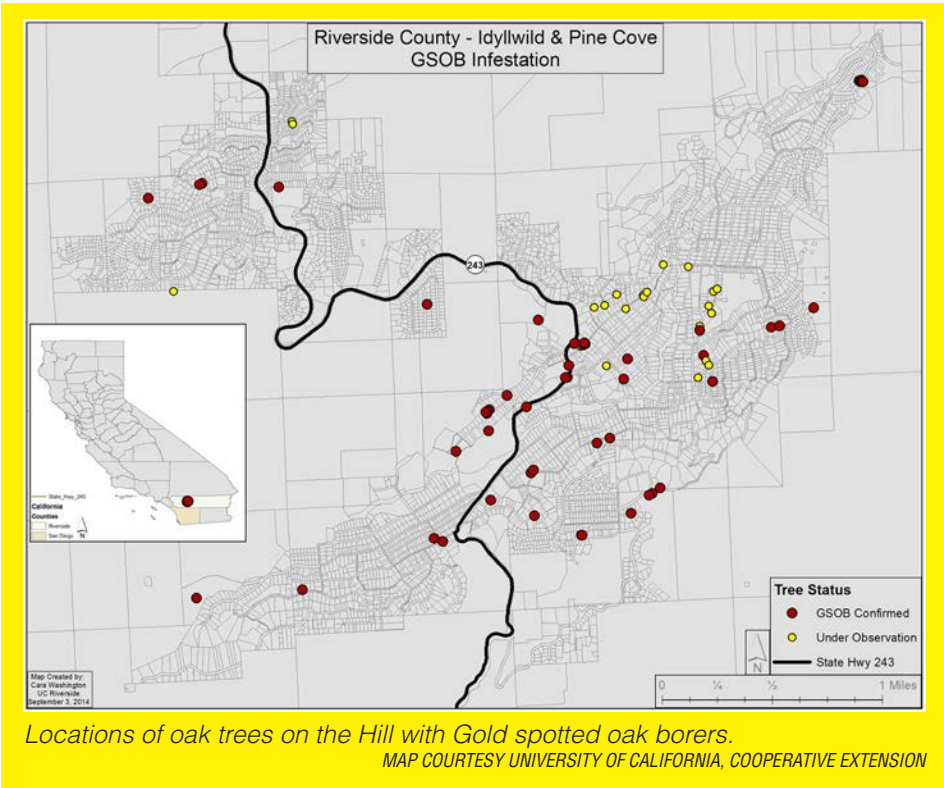
The Canadian rider who was killed in a motorcycle vs. truck collision on Highway 74 on Monday, Nov. 3, has been identified as Eric Lanktree, 25, of Weyburn, Saskatchewan, the Riverside County Coroner's office reported. According to DiscoverWeyburn.com, Lanktree was a six-year member of the Weyburn Fire Department.

The 42-year-old Hemet rider killed Tuesday, Nov. 4, on Highway 243 near Riverside County Playground Road in a solo motorcycle crash has not been identified pending notification of the legal next-of-kin, according to the Coroner's office. (See cutline below for more information.)

According to California Highway Patrol Officer **Mike Murawski** (right), the driver of a Honda Shadow 500 crashed on Highway 243 near Idyllwild Pines Camp about 5:20 p.m. Tuesday, Nov. 4. Civilians performed cardiopulmonary resuscitation before emergency personnel arrived. Here, first responders from Idyllwild Fire, Idyllwild Volunteer Fire Company 621 and Riverside County Fire apply emergency aid and had to close Highway 243 in both directions for about 30 minutes while emergency personnel worked. Idyllwild Fire transported the motorcyclist to Keenwild Forest Service Station in order to meet Mercy Air, however, he subsequently perished from his injuries before the air transport could occur. The 42-year-old Hemet man's name is not being released until the legal next-of-kin is notified.

# Hemet teachers stage protest after failed negotiations

Dissatisfied with the progress of salary negotiations with the Hemet Unified School District, members of the Hemet Teachers Association walked along Florida Avenue in Hemet Saturday carrying signs expressing their disgruntlement.

Even mediation has not solved the differences between the district administration and the union. According to a district press release, HTA and HUSD will proceed to fact-finding. A three-person panel reviews the disputed issues and proposes a settlement.

Officially the negotiations are currently for the 2013-14 school year. HUSD offered a 4-percent increase to the salary schedule retroactive to July 1, 2013, along with a \$1,500 increase to health and welfare costs. The total percentage increase of the district's salary and health-benefit proposal is about 6 percent. The district budget for fiscal year 2014-15 assumes another 4-percent increase.

Teachers, according to HTA President Robert Hudson, feel disrespected. When the school budget was falling because of less state funding and property taxes, teachers easily agreed to furlough days. But now that the budget problems have passed, the administration does not seem to making appropriate offers, he said.

Salary is not the only issue separating the parties. The number of students in each classroom is another issue. Lowering the student-teacher ratio requires more teachers.

As an example of the distance between the two organizations, in a message to staff and parents, HUSD Superintendent Dr. Barry Kayrell described the administration's package as "one of the highest in Riverside County." Yet Hudson said, "The salary for a Hemet teacher with five years experience is 27th out of 33 districts in Riverside County. After 10 years, the Hemet salary is 28th out of 33 districts."

About 68 new teachers have been hired this school year, Kayrell wrote. Class sizes district-wide have declined at all levels. For example, in grades six through eight, the ratio was 34 students per teacher last year and this school year it fell to 31 students. The declines in kindergarten, third, fourth, fifth and high school were not as great but all were at least one fewer student.

While class sizes throughout the district are the focus,

Hudson made the point that the administration ignores the differences between schools. For example, he said kindergarten classes at Valle Vista have 21 children, but at Whit-tier, the class exceeds 30. According to Kayrell's report, K-3 average sizes have dropped from 28.5 students per teacher to 27 this year.

"Students deserve the best and most qualified teachers. How can Hemet attract those teachers if it's in the lower half of the surrounding districts?" Hudson asked during Saturday's walk.

When asked if HTA had figures on the attrition rate of teachers leaving, he said district administration has refused to provide that data.

However, Kayrell wrote that at a job fair in the spring of 2014, more than 365 qualified applicants applied for jobs in HUSD.

Saturday's walk was billed as "Derail Kayrell" on a union flyer.

been on the Temecula City Council since 1999 and his current term ends in 2016.

Others have suggested another Temecula councilman and also former Mayor Chuck Washington. He was elected to the council in 2003.

Other media have said that Rose Salgado, who serves on the Soboba Foundation Board of Directors, the Valley-Wide Regional Park

District and the San Jacinto Unified School District Board of Trustees, would be interested.

Current 4th District Supervisor John Benoit was a state senator, representing the desert and Idyllwild, when former Gov. Arnold Schwarzenegger appointed him in 2009 to the county board to succeed Roy Wilson who died shortly after his resignation.

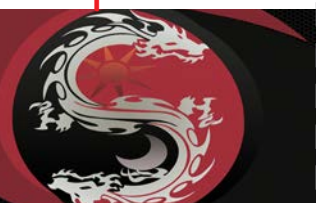

I can tell you from experience, if you can't handle a photograph of a half-dozen firefighters and EMTs valiantly trying to save a man's life, then you don't ever want to run a newspaper.

There are tough stories to write every issue that affect readers' feelings, and it's our job to write them.

And it's tough to run photos like the one we ran last week of the young Canadian firefighter who lost his life riding a motorcycle on Highway 74 and (this week) of the Hemet motorcyclist whose life was claimed on Highway 243 just a day later. Both photos show heroes trying to save lives.

One of our jobs here is to give people what they need to know in their community. Why was traffic held up? Why were ambulances all around? Why are so many motorcycle crashes occurring lately? We hope all is OK in our little town.

Some photos tell more than a story can, such as when the Marine motorcyclist was killed several years ago on Highway 243. Larry Donahoo, Village Hardware, donated an American flag, and the man's fellow Marines' ritual covering of his body with the flag on the highway while traffic stopped was a gripping photo. It broke our hearts to lose a man we didn't know.

Just as gripping is a photo of our paramedics working so hard to save the lives of all too many of these riders. In the whole of 2008, we had five motorcycle fatalities on our Hill highways. In just the last six months, we have had seven. That does not include crashes with or without just injuries.

Jeff Stone has promised when he reaches the Senate to work with CalTrans on solutions to motorcycle crashes in our mountains.

What will the TC do in the meantime? We'll work to inform you with more statistics while hoping never to have to cover one of these tough events again.

## California improves transparency/accessibility to public health data

The California Health and Human Services Agency has launched its Open Data Portal (<https://chhs.data.ca.gov/>) to make access to non-confidential data collected by CHHS departments user-friendly.

The Open Data Portal's goals are to spark innovation, promote research and economic opportunities, engage public participation in government, increase transparency and inform decision-making. "Open Data" describes data freely available, machine-readable and formatted according to national technical standards to facilitate visibility and reuse of published data by individuals, business, researchers, journalists, developers and others.

"Transparency and accessibility to information is so important to democracy," Diana S. Dooley, secretary of the

California Health and Human Services Agency, said in a press release. "This is the beginning of a very ambitious effort to open information portals that people want and need. This is an important step toward our goal of making California the healthiest state."

The California Department of Public Health and the Office of Statewide Health Planning and Development are the first departments to contribute data to the CHHS portal with other departments to follow. Participating departments will continue to add more data sets over time.

Data sets initially available include birth profiles, poverty rates, reports on asthma and West Nile virus, Health Professions Shortage Areas, utilization of specific medical procedures and hospital seismic compliance.

## Tips on talking to kids about Ebola

remember that it is very rare and it doesn't spread very easily. When someone does become sick, doctors, nurses and scientists take care of that person to make sure they get well and that they don't make anyone else sick.

• Kids should know that the health care and public health systems in the U.S. are among the very best and most advanced in the world. Doctors and scientists around the country are working hard to find ways to cure Ebola and to prevent it from spreading.

• Adult care-givers may want to consider limiting young children's exposure to the news and social media. Adults should decide what information on Ebola their children receive based on their level of understanding and maturity. Gener-

ally, adults should make sure kids are not exposed to overly graphic material on the news or Internet that may unduly scare them.

• It's important for kids and adults to know they are much more likely to get sick from colds and the flu this year; kids should be reminded that keeping up with hand-washing or hand sanitizers is one of the best ways to stay healthy every day.

• Adults should stay informed so they can talk knowledgeably to their kids. Care-givers and educators can get reliable information from the Centers for Disease Control ([www.cdc.gov/](http://www.cdc.gov/)), the California Department of Public Health ([www.cdph.ca.gov/Pages/DEFAULT.aspx](http://www.cdph.ca.gov/Pages/DEFAULT.aspx)), Riverside County's webpage on Ebola ([www.rivcoph.org](http://www.rivcoph.org)) and [www.healthychildren.org](http://www.healthychildren.org).



# Riverside County votes differently from state

In last week's general election for state offices, Riverside County voters supported the Republican candidates — more so than statewide voters. Neel Kashkari, the Republican gubernatorial candidate, received 53.27 percent of the gubernatorial vote, the least of the seven statewide partisan races. Ashley Swearengin, the Republican controller candidate, got 57.1 percent of the county vote.

However, the statewide sentiment was the complete opposite of Riverside County's preferences. Gov. Jerry Brown was re-elected with 59 percent of the vote. His 3.6 million votes were 1.1 million more than challenger Kashkari.

The other Democratic candidates all received between 53 and 58 percent of the state vote.

In the race for superintendent of public instruction, a non-partisan position, again Riverside County and state voters viewed the candidates through opposite perceptions. Incumbent Tom Torlakson garnered 52.3 percent of the total vote to defeat challenger Marshall Tuck. Torlakson beat Tuck by about 230,000 votes out of more 5 million ballots, but Tuck received 53.5 percent of Riverside County's vote.

## Hill had a strong voter turnout

Voter turnout for election day, Nov. 4, underperformed The Field Poll prediction issued that morning of turnout for the 2014 general election. The Field Poll release predicted 8.2 million people would cast ballots in the election, but total turnout was slightly less than 6.4 million voters.

Statewide turnout, 35.8 percent, was the lowest in more than 50 years. The Field Poll had predicted 46.1 percent of the voters would be involved, which would still be the lowest in same period. Voter turnout has not been less than 50 percent in this period.

In 2010, the last non-presidential election, statewide turnout was nearly 60 percent and more than 72 percent in the 2012 presidential election. Nationally, turnout was estimated to be slightly more than 36.4 percent.

But initial indications of voter interest on the Hill refute this trend. At about 7:30 p.m., with still 30 minutes before the polls closed, the Pine Cove voting precinct had nearly 105 voters come in during the day and cast ballots. This represents about 20 percent of the total voters in the precinct, but does not include the vote-by-mail

ballots, which were twice the number of votes cast in the June primary.

At Town Hall, with 10 minutes before the poll closed, 421 voters had cast ballots, representing about 28 percent of the 1,485 registered voters in that precinct. That total also excludes vote-by-mail ballots, which were about 77 percent more than primary day voters in June.

Riverside County turnout was about 37.7 percent. Sierra County, with only 2,229 registered voters, had the highest turnout of 73 percent. The lowest turnout percentage in the state was 24 percent in Mendocino County.

The Riverside County Registrar of Voters has about 24,000 uncounted ballots. Of this total, about 19,000 are provisional and may not be eligible to be counted. If all were counted, the county's turnout would barely be 40 percent. In 2012, the county turnout was 71 percent and 57 percent two years earlier.

## Ruiz and Jones re-elected Haley new school district director

In other races of local interest, incumbent Democrat Rep. Dr. Raul Ruiz retained his Congressional District 36 seat despite the Republican wave throughout the country. He defeated Republican challenger Assemblyman Brian Nestande by about 9,500 votes out of the 126,000 cast in this race.

From the initial vote-by-mail posted results Tuesday evening through Saturday's totals, Ruiz maintained a 54 to 56 percent lead.

State Assemblyman Brian Jones, of the 71st District that includes Idyllwild, also retained his seat. He easily defeated fellow Republican, challenger Tony Teora. Most of the district resides in San Diego County, where Jones' support is very strong. He garnered nearly 71 percent of the total vote in the district, but received only 54 percent from Riverside County voters.

For the seat of retiring Hemet Unified School District Director Paul Bakkom, Megan Haley overwhelmed her opponent Maurice Chacon. Haley earned nearly 73 percent of the total vote. "I was surprised by the significance of the win," she said Friday after the election results were essentially final. "I was really confident, but this was great support."

Haley, the former Assistant Principal at Little Lake Elementary School, will re-sign her administrative position before being sworn in as District Trustee.

"I really want to represent the Aguanga, Anza and Garner Valley areas," she said. "Some call us the 'red-headed stepchild of the district.'"

And she pointed out that Cottonwood Elementary and Idyllwild School are leading schools in the whole district. Maintaining their academic performance will be a high priority for Haley.

However, she knows that some HUSD students and graduates are not prepared to enter the work force. As a small business owner, she sees kids who need help with interviews and completing applications. A technical or career path is another priority she hopes to pursue while on the HUSD board.

# Stone bringing Idyllwild concerns to Senate

## Motorcycle crashes are on his list

Of the local races on the ballot last week, the state Senate District 28 was the most bitter and drew more attention. Since the June primary, the two Republican candidates — Riverside County 3rd District Supervisor Jeff Stone and former Assembly member Bonnie Garcia — have debated the issues and challenged each other's character as well.

On Tuesday, voters decided Stone would represent them for the next four years in the state Senate. He received 53.2 percent of the total vote, defeating Garcia by about 9,500 votes.

Stone's term begins Dec. 1. Last week, he began his travels to Sacramento. He was looking for a place to live and beginning his introductions to being a state legislator.

When asked about his thoughts regarding his new role, one of 40 senators as opposed to one of five supervisors,

Stone said, "One thing, always there is a challenge. I view my whole life as has been a David vs. Goliath series of challenges."

From birth that included medical problems, through elementary school and college until his business became successful, Stone has consistently overcome obstacles in his path. The intricacies of the Senate are just one more hurdle.

As a supervisor, Stone has served on many inter-governmental commissions and believes he has been able to "get things done. I'll emphasize what is in the best interest of the citizens of California."

On his immediate agenda will be several issues, he said. First and foremost will be efforts to improve the economy and create more jobs. But as a result of this campaign, Stone wants to take on campaign finance reform, too.

Current legislation, which permits unlimited funding for independent expenditures outside the candidate's control, is unfair, he said. "This favors special interests," Stone emphasized.

He wants to eliminate these accounts and raise or eliminate the limits on donations to candidates. These contributions must be made public and transparent so candidates are accountable, he said.

Idyllwild will continue to be a priority for Stone as it was during his supervisorial tenure. One issue Stone hopes to address is the State Fire Prevention Fee.

"People pay enough taxes and citizens of Idyllwild already pay for fire. But this affects the whole unincorporated area of the district," he noted.

Motorcycle fatalities on the Hill are one local issue Stone has promised to take to Sacramento.

"Now I'm in a position to affect the state and will work with CalTrans to come up with a solution," he said. "The people are concerned and I'm very concerned."

# Bonds, state budget reform and reducing some criminal sentences approved

Unlike the choices for state offices, Riverside County voters and statewide voters concurred on the disposition of the six propositions on the November ballot. Half passed and half were defeated.

Voters easily approved the water quality and bond, and the state budget propositions by nearly two to one margins.

Nearly 59 percent of voters throughout the state and 52.5 percent of county voters also approved Proposition 47, which will change some criminal sentences to misdemeanors.

The other three propositions on the ballot, Prop 45, drug testing of doctors, Prop 46, health insurance rate control, and Prop 48, the Indian Gaming compact, were all defeated. Nearly 60 percent of all voters opposed these measures.

# San Bernardino Forest Land Management Plan amended

## Two in areas in San Jacinto district part of changes

On Nov. 4, U.S. Forest Service officials announced their decision to make changes to the Land Management Plan for the San Bernardino National Forest. This is an amendment to the plan, which was originally adopted in 2005. Pyramid Peak A and Cactus Springs B are the two areas within the San Jacinto Ranger District affected by this amendment.

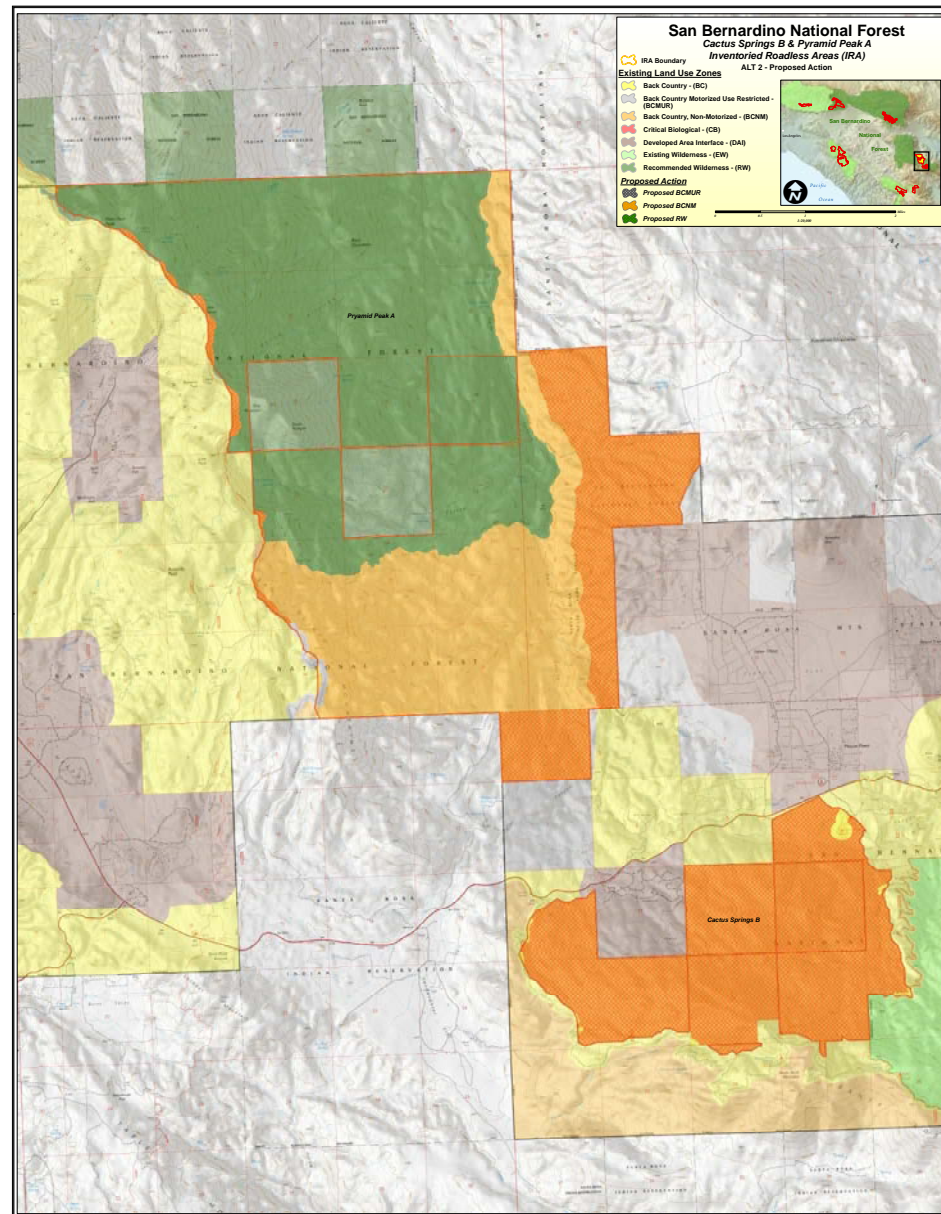
San Bernardino Forest Supervisor Jody Noiron's decision maintains the 18,200 acres currently zoned as Recommended Wilderness while rezoning 10,000 acres as Back Country Non-Motorized. These areas are currently designated as Back Country and Back Country Motorized Use Restricted.

"My decision to change the zoning for approximately 10,000 acres is based on my desire to protect the undeveloped character of the areas while having the flexibility to accommodate a range of uses that are not permitted in designated wildernesses," Noiron said,

explaining her decision. "The intent in the BCNM areas is to retain much of the undeveloped character, maintain habitat characteristics for plants and animals, and to leave options (including wilderness) on the table for consideration in the future."

The decision allows for continued fuels treatments around communities to reduce wildland fires threats.



The amendment also maintains existing public motorized access and does not amend any permits or con-

tracts. Noiron emphasized that the decision will not "change the suitability of mountain bike use on the

SBNF. Mountain bike use is suitable in areas zoned as BCNM..."

The decision document

emphasizes, "This plan level decision does not change the status of any existing road or trail, does not authorize any specific project activities such as vegetation management, does not amend any permits or contracts or authorize any activity allowed by permit or contract, and does not modify any prohibitions known as 'Forest Orders' issued under 36 CFR § 261 Subpart B."

"My decision brings a higher level of protection to the additional acres, yet allows for continued public recreational use," Noiron said in a press release. "The decision will not affect our ability to protect the national forest and adjacent communities from wildland fires."

The LMP amendment is part of the Settlement Agreement approved Jan. 3, 2011, in the case of California Resources Agency et al vs. United States Department of Agriculture, and Center for Biological Diversity, et al vs. United States Department of Agriculture, which challenged the SBNF 2006 LMP.

# Off the Main Roads

## A wall of green ...

If you're similar to most of the Hill populace, many of your trips into nature are characterized by toiling up a dusty path through an unidentifiable and somehow vaguely unsettling corridor of green. Sadly, most domesticated humans have an appalling lack of understanding of their vegetal surroundings and may even feel threatened by their leafy neighbors. ("Is that thing poisonous?") Even worse, we often pass this ignorance (and fear) down to our kids.

Want to end this environmental ignorance and help your little ones learn to relate to our photosynthesizing friends in an entirely new way? Well then, it's time for you to get to know your wild, green neighbors.

A well-informed nature walk can be one of the best ways to help your kids (and yourself) get to know the residents of your natural neighborhood. Here are some tips to help you make the most of your trip.

- Knowledge is power: Take the time before you go to learn about your green neighbors. An amazing number of resources are available from Wikipedia to books on local flora (check the library or Amazon), to meet-up groups and outdoor schools with naturalist and wild-foods walks.

- Ask the right questions: With so much information out there, boiling it down can seem overwhelming. Here are some good questions to get you started in understanding a plant's place in his ecosystem: Where does your plant like to live (and why)? Who are their usual neighbors? Who likes to eat or use them? How do they defend himself? How do they change throughout the year? (Flowers, fruiting, growth, deciduous?) How have we humans interacted with (and depended upon) them over the millennia? (Medicinal uses, food prep, as building or clothing materials?) What are their key identifying characteristics?

- People remember (and respect) people: When working with young kids, I'd recommend initially skipping the

Latin names and instead focus on helping them to see the plants as separate people with different abilities, complex personalities (not all good or bad), and likes and dislikes.

Talking with my 4-year-old niece might sound a little like this: "Miss Blackberry can be really prickly. If you move too fast around her, she'll scratch you with her thorns. She likes to live with her feet in the water and take deep drinks so that she can make extra-juicy berries."

- Respect plants' boundaries (and protect yourself): Make sure your kids learn not to touch or taste without knowing "who" the plant is and their temperament. Most plants have defenses to be aware of.

"Mr. Stinging Nettle's hypodermic hairs sting invaders with painful, itchy toxins to keep animals and you from eating too much of his really nutritious leaves."

Help your kids to understand that plant defenses are

part of the natural environment. These plants are not "bad" for defending themselves, they're just trying to protect themselves.

- Avoid black and white views: Describing a plant as all "good" or "bad" gets in the way of understanding the plant's role in its neighborhood (ecosystem). These "difficult" plants often also have a bounty of benefits for you and for their green neighbors.

"Mr. Nettle can provide a whole bunch of nutrients. Collect his newest leaves carefully with gloves, and cook them long enough to deactivate his sting, and you will get a really yummy green."

So get out there and explore. Understanding a plant's complex role in its natural neighborhood and our relationship to it helps your child begin to see themselves as a part of the natural world, not separate from our green neighbors.

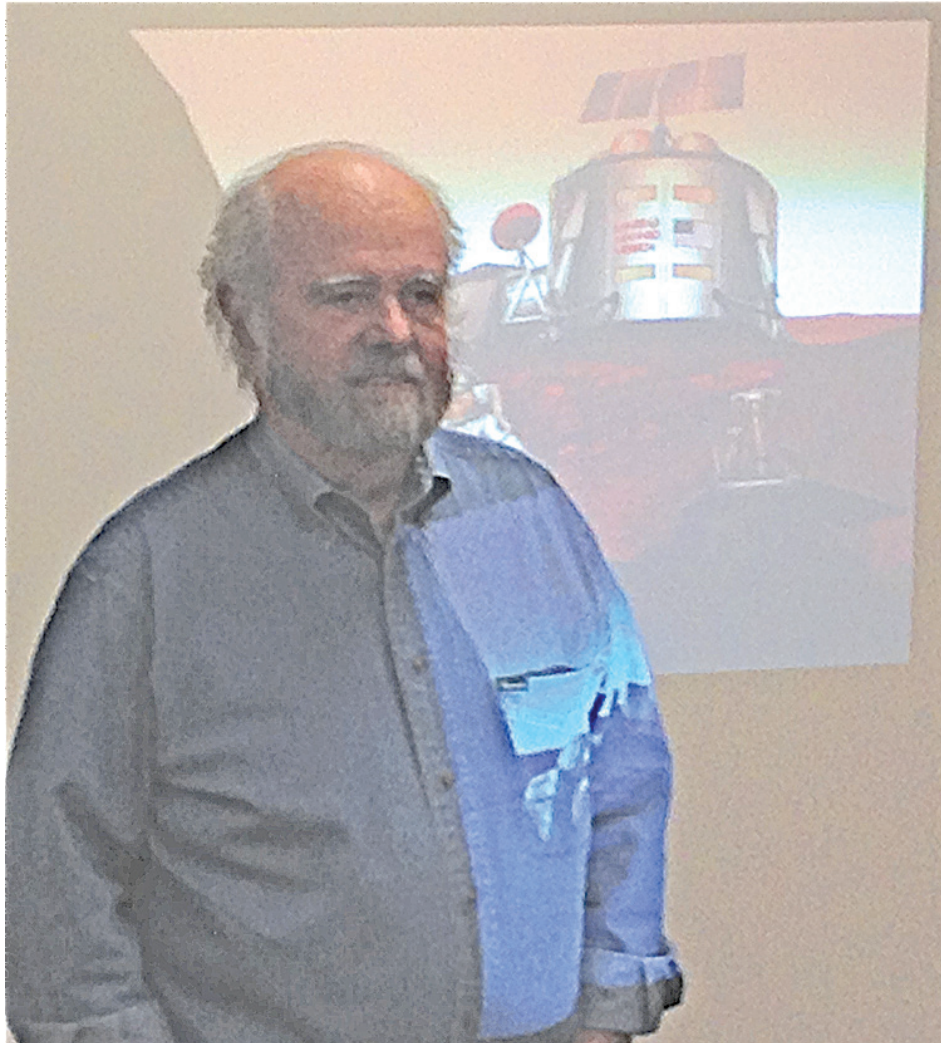

## HEALTH ON THE HILL

### Gym etiquette ...

I was 14 when I started working out. As I reflect now as to why, I have to say that physical exercise was put in my path in many ways just as much as I was drawn to it.

On my way home from school one day I noticed a few rusted metal weightlifting plates scattered on the ground next to a set of dumpsters behind our complex. After further searching the area I found that someone had discarded almost an entire set of weightlifting equipment. The bench had torn brown pleather with rusted semi-chromed legs and skinny black arms reaching up, almost daring me to put a weighted bar onto them. There was about 150 pounds of various metal and some plastic, sand-filled plates all with small holes in the middle, a metal bar with rusted collars and another bar that looked like a funky W to me.

It wasn't until the second trip struggling to carrying the equipment home that I noticed the wheelbarrow.

A few years later while working out in a large health club, I was asked by a member if I could show them how a particular machine operated. I found it became a frequent thing and would occasionally volunteer to show a few tips I had read in some books or magazines. It quickly became apparent to me that the majority of people coming into fitness were mostly left on their own to figure it all out. But not just the "How do I get in shape?" part, but the etiquette as well. There is a wealth of information on working out and we all have our opinions on what works best yet gym etiquette is rarely mentioned.

Many people say one of the reasons they have not thought of joining a fitness facility is due to the intimidation they experience. I believe a good deal of this fear is falsely driven due to a lack of understanding of the environment. Like any "club," the gym has its own particular language, code of conduct, and do's and don'ts.

For instance, the most common miscommunication I have been a party to is this interaction: one person is just finishing a set on a machine when they see another person waiting for them to finish. Person two will usually ask two questions: "How many sets do you have left?" "May I work in?" Time and time again I see person one get visibly upset and respond with, "I will be done in a minute," (rarely the case) or, "You can have it," and they walk away thinking person two was impatient, etc.

Please understand this is usually not the case. When someone asked to work in they only want to do a set in between your sets while you should be resting. This is not only efficient for the facility but gives both of you the chance to assist each other in possibly achieving more repetitions or higher weight — and who knows, maybe make a new friend who obviously has at least one interest in common with you.

Here are a few more handy points of gym etiquette...

- Bring a towel to protect everyone's health and preserve the fabric of the equipment.
- Keep the loud grunting to a minimum and not too far from your own earshot.
- Wear appropriate clothing and footwear.
- If you do not understand how to operate something, ask a professional not just a fit person.
- Be considerate of those around you and aware that heavy objects are being moved around sometimes with speed but always with the ability to cause great harm.
- If asked to "spot" someone and you're not comfortable, inform them before they attempt the lift.
- To know what it is you truly are looking to achieve, seek out a professional within the field to assist you in making that determination, understand your environment by getting to know the intricacies of its inner workings, and the most important thing is to enjoy yourselves.

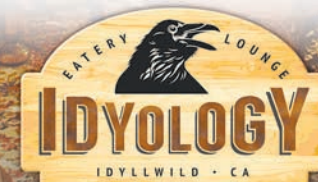

# Journal from the James

## Shepherds of nature ...

Greetings from the James Reserve. In the first installment of our column, we introduced the James Reserve and promised further “peeks into the natural world” in future columns. In thinking what this first “peek” should be, I have decided on mountain lions. I decided this because I have studied them for many years and as a recent trail camera photo from the James demonstrated, they do use the Reserve, as well as the rest of the San Jacinto Mountains. Being a big cat (America’s lion), mountain lions are the only large predatory animal we have in the Idyllwild area. As one of our wildlife neighbors, I thought it would of interest to talk about this elusive resident of the Hill.

What can I say about mountain lions? That subject can and has filled books. Here I want to talk about the ecological role they play in our “sky island” home. Besides being big, and to some a bit scary, what do mountain lions do? We know they kill and eat mainly deer. And for that, many think badly of them, killing poor Bambi. In fact, they and most predators are considered by some to be “vermin,” or as one fellow put it, “weeds” in the garden of nature. Are they indeed weeds that should be pulled out, eradicated, or do they play a role in the garden that is, in this case, the San Jacinto Mountains? And if so, what is it?

Though predators kill their prey to live, recent research is showing that predators actually have the greatest impact on their prey, not by killing them but by scaring them. Imagine a mountain lion attacking five deer. If she catches one, it is dead, end of story for that deer. However, in the process she scared the hell out of four others. What do they, the survivors, learn from that experience? They should learn to be afraid, be really afraid, of getting attacked again, especially in that area. The repeated near-death experiences of the survivors should shape in their minds the risks they face in different areas they live in, where it is more dangerous, where it is safer. This information should, and studies indicate does, alter their use of the landscape; some areas are just too dangerous to use. These dangerous areas become refuges for the favored plant food of deer. Without these refuges, deer can and do, seek these plants out, removing them and reducing the diversity, the makeup of the ecosystems in which they are found.

The result is that the true ecological role of predators such as mountain lions is very similar to that of the shepherd, guiding his flock over the landscape to avoid over-use of the vegetation that supports them. So predators are not the weeds of the garden, they are the gardeners, keeping grazing herbivores in their ecological place and maintaining the integrity of the various ecosystems we enjoy here on the San Jacintos.

# Sheriff's Department testing use of body camera

## Deputies in Jurupa Valley will wear cameras

In response to a proposal from Sheriff Stan Sniff, the Riverside County Board of Supervisors approved expenditures of about \$384,000 to further evaluate using body cameras for sheriff's deputies.

In his request to the board, Sniff wrote, "The Sheriff's Department recognizes the importance to stay current with emerging technology ... [body video camera systems] are designed to provide an unbiased records of events that occur between sheriff's personnel and citizens daily."

The funding will be used to acquire 165 cameras and

associated storage hardware. Cameras will be limited to patrol deputies at the Jurupa Valley Station, according to Sniff. Deputies working patrol, special teams and traffic assignments will now be able to provide input into this testing process.

However, the department has tested body-worn cameras with a limited number of personnel over the past few years and will continue the testing for another year or two, according to Deputy Albert Martinez, Sheriff's Department public information officer, in a press release.

"The testing to date generally showed that the body-worn cameras exonerate the actions of our deputies when complaints are lodged, making it far easier in defending against lawsuits and resolving complaints. It is believed that use of body-worn cameras will help agency accountability and transparency, reduce agency liability, and allow the review of past incidents to reduce false complaints."

# Byron Ely: The art of learning

Byron Ely is a man driven to learn — about everything. Ely's family moved to Southern California from the East Coast when he was 6 years old and settled in the Westchester, Playa del Rey area. He earned his bachelor's degree in management from the University of Redlands and subsequently attended California Polytechnic University in Pomona for his architectural graduate work. Ely also earned a degree in construction technology.

In the 1970s, Ely moved to Big Bear and commuted to his job with the County of San Bernardino. "I used to run the plan review section for the County of San Bernardino Building and Safety when I was a youngster and I lived up in the mountains. I ran the whole plan check, plan review [department], so I do have an interest in structural things," Ely said. "I used to be a California building official — the department head for the building department that does all of the inspections for whatever community they are in. I spent a number of years as a California building official." Ely built his home in Big Bear — he has built a dozen or so homes — but Big Bear's location was somewhat of a logistical problem for him. "I liked Big Bear. The problem with Big Bear is that it is a long way from everywhere. It's just [difficult] getting off the hill, especially in the winter-time." Ely moved across the mountain range to Lake Arrowhead in the 1980s, but eventually relocated to Redlands, then Glendale for his work. Currently, Ely lives in Newport Beach where he has spent the last six-and-a-half years.

After spending some 39 years in the development side of local government, Ely retired from his position as deputy city manager over development and public works in a city that built more than \$18 billion in construction during the 17 years he was employed there. On his retirement, Ely decided to take some art classes at Glendale Community College. "What I tried to do when I was taking



all of those art classes was to get exposure to everything, from figure drawing to sculpture of metal objects and welding them together to bronze casting to all of the design; you know, 2D/3D design. I took all of those courses because I wanted to have a broad understanding of art; I took a lot of art history classes, I just ran through the thing," Ely said passionately.

The art classes Ely took would be his first introduction to a small mountain community called Idyllwild. "I first heard about Idyllwild because of some of the instructors I had when I first started taking jewelry [making]. I came up in the summertime and taught out at [Idyllwild Arts Academy]," he recalled. "So that's where I first heard about it in any substantial way. I knew the name but I didn't really know what was up here." Ely was instantly attracted to Idyllwild's energy. "I like the mountain communities and I've always known that I was going to retire in the mountains and I want to stay in the general Southern California area," Ely said. "Arrowhead is a community that ... it doesn't have the same spirit that Idyllwild has, so I think from that standpoint I am more attracted to [Idyllwild]. I'm more interested in the intellectual and creative activities that happen in this community and it feels like it has a lot of energy in it."

With his time divided between his job as senior vice president of National Community Renaissance, a non-profit company that builds low-income housing, (currently they have more than 10,000 units and more than 27,000 residents that

live in their communities), his family life in Newport Beach, and his new-found passion for the Art Alliance of Idyllwild, Ely is a very busy man. "Part of what I like about the Art Alliance is that it's a really creative group of people; they are very supportive of new people coming in. There's a lot of positive outreach and there's a lot of great work they're doing; you know, the donating of materials and painting and keeping art alive in the community," he said. "I'm really impressed by all the things that [AAI] is doing. I've belonged to other art associations over the years, but none of them have been as sophisticated and active as these guys. Because I'm planning on retiring up here, I'm starting to get involved in the community; like today, I was up helping with the painting [of the panels for the Winter

Solstice event]."

Shanna and Dave Robb, unofficial but effective Idyllwild and AAI ambassadors, provided Ely with a perfect introduction to the community. "Shanna and Dave have taken me to a few different places and we've had dinner and gone for drinks; the one thing that struck me more than anything was that everybody I have met here is super friendly. There's no like, 'Who are you and where did you come from?' It's like, 'Hey, good to meet you,'" he said smiling. "You feel like you're part of [the community] without anybody doing anything other than just the way they react. I like that. It's more like a Midwestern kind of way where people are friendlier and there's more of a connection between people."

With his sights set on retiring in Idyllwild, Ely

comes up the Hill as often as he can. In addition to his positive experiences with the Idyllwild community, he also enjoys Idyllwild's location. "My interests are pretty broad so I really like to be able to go to a good bookstore or a museum or a good library or a good art gallery, so I'm really looking for that kind of stimulation also," he said. "I read a lot. I have always found that the more I understand and the more I get into, the more I realize I don't know that much. It fuels me to sort of keep stretching."

Ely's message to people afraid to try their hand at art, or other endeavors in life, is simple: "We are all trainable. I was lucky. I had a dad who [taught me] that you can do anything, and so that's always been in the

back of my head," Ely said. "I've learned over the years that if you educate yourself, you self-study it, and you go to college, you can go any place you want to in this world ... within reason."

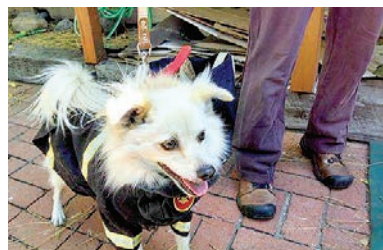
feline end, Mama **Lizzie** has her perfect home with her canine buddy.

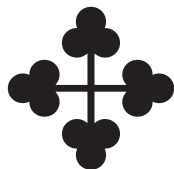

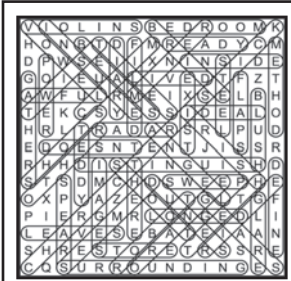

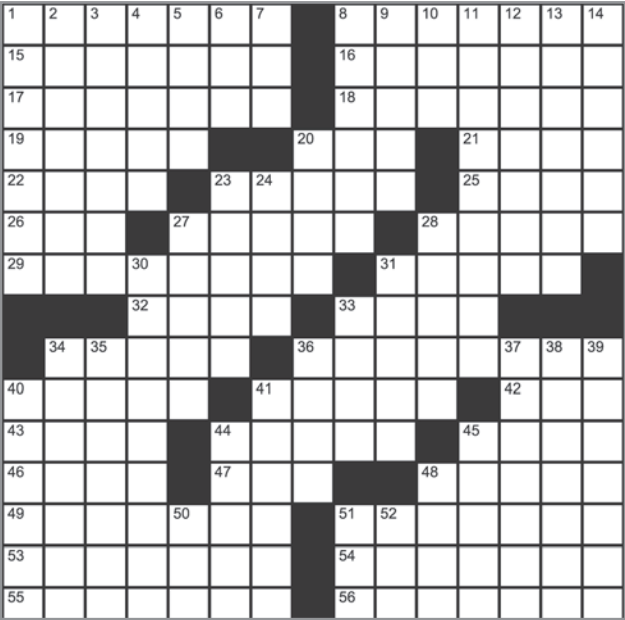

burns and prescribed area burns. The period covered started in the mid-1990s, but most of the work was accomplished in the past decade. The study also examined the effect of two previous fires in or near the Mountain Fire area.

Fuelbreaks in or near the burned area were generally beneficial. However, the authors noted that in areas where the fuelbreaks near private land were connected to treatments on agency land, they were more likely to reduce the fire’s effects. “Where

this was not the case (e.g., around much of the Bonita Vista fuelbreak), the fire burned through untreated fuels on private land.”

Forest Service investigators also observed a “treatment shadow” where the value of fuel treatments extended beyond their boundaries. These treatment shadow benefits included diminished fire behavior when it moved to untreated areas; reduced production of embers; and eased fire containment activities.

The fire severity data indicated that areas with taller pre-fire shrub cover tended to have the po-

tential for higher substrate (soil) and vegetation (shrubs) burn severity.

Another conclusion important to efforts on the Hill was the recognition that coordinated efforts of private landowners and the Mountain Area Safety Task Force in completing fuels reduction projects helped save homes in the communities.

“Everyone on the Hill should know that this analysis supports the basic principle that both we and the fire agencies have been acting on for years: reducing fuel around homes and

the community increases the safety of both,” said Mountain Communities Fire Safe Council President Mike Esnard. “The report has other useful lessons for land managers in the design of fuel treatments, but overall it argues for the value of consistent fuel reduction in and around the mountain communities.”

The area burned during the Apache Fire in 2008 was also less receptive to the devastation of the Mountain Fire. This reinforced the principal of fire as a natural fuel treatment process.

The Forest Service assessment began even before the fire was fully contained on July 30. The fire severity monitoring was conducted between July 22 and 25, just following the major rainfall event of July 21 and 22. Areas sampled included key sites near the Keenwild Station, Living Free and the Bonita Vista fuelbreak.

The Mountain Fire started in the afternoon of July 15, 2013. The fire spread quickly from private property near the junction of highways 74 and 243 to the east

through grass, chaparral and into timber. Considerable resources were deployed on the fire, including fixed and rotor-wing aircraft, ground crews and support infrastructure, at a cost of about \$26 million. Two weeks later on July 30, the fire was declared contained after burning nearly 27,531 acres.
