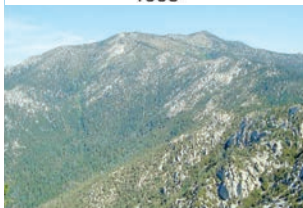

## A man, his son, a fire and an uncertain future

**T**he smoke woke me up," said Andrew Luke of the early morning of Friday, Jan. 30. "I walked out onto the deck off the upstairs bedroom and I could see the glow of the fire and could hear it below, the backdraft."

It was 2 o'clock in the morning and Luke screamed for help. He de-

scribed going back into the bedroom, now all smoke-filled, to find his 2-year-old son, Wyatt. "I couldn't see anything. It was pitch black." He said he could feel the panic rising because he could not see where his son was. Then he heard Wyatt's voice.

Luke said he moved to the voice, scooped Wyatt up in his arms, went out the bedroom slider to the second floor deck and

## Lawler Lodge to be designated county historical site

**L**awler Lodge, a few miles north of Idyllwild, has been recommended for designation as a Riverside County historical landmark.

In November, Keith Herron, resources bureau chief and county historic

preservation officer, made the presentation to the County Historical Commission, who recommended the designation to the Board of Supervisors. It was on the board's agenda for Tuesday, Feb. 10.

In 1916, Oscar Lawler, a Los Angeles attorney, and his wife Hilda, bought

## Little change to FS budget

Airtanker fleet upgrade continues

**F**or the federal fiscal year beginning Oct. 1, 2015, President Barack Obama has requested a \$6.5 billion budget for the U.S. Forest Service. This includes \$700 million of mandatory funding and a new proposal for \$850 million to supplement

fire suppression costs.

Without these two items, the president's request is \$4.9 billion, \$130 million less than the amount appropriated for the current fiscal year.

The request for overall management of the national forest system is \$1.6 billion, an increase of nearly \$154 million. Wild-fire management, the largest portion of the Forest Service budget, would increase \$20 million to a total of \$2.4 billion. This does

not include a separate request of \$850 million for the expenses of the largest and most costly fires.

"The budget again proposes a new approach to wildland fire suppression. It will treat severe wildfires like other natural disasters that can draw on emergency funding rather than raiding other critical programs, like forest restoration and management, research and other activities that help manage our

# Epperly trial set for July

Karen Epperly, 49, of Idyllwild, who was charged with embezzlement from Community Lumber in December 2013, will have a trial in July.

Epperly initially pleaded guilty in August and awaited a probation report filed in September. At the Sept. 19 sentencing hearing, the court announced it had read the probation report and she was not eligible for probation.

At that hearing, Epperly then withdrew her guilty plea and entered a plea of not guilty instead.

After several trial conferences, Epperly continued to maintain her not guilty plea. At the Jan. 30 information arraignment, both the prosecutor and defense announced they were prepared for a trial. Judge Mark Mandio then set July 20 as the starting day for the trial.

# Forest Service soliciting public comments for off-highway grants

The San Bernardino National Forest will be seeking public input for its upcoming California Off-Highway Motor Vehicle Recreation Division grants that will be submitted on March 2.

California state regulations require public input prior to the preliminary application deadline in this fund-allocation process. The agreements support off-highway vehicle management activities on the national forest, including operations and maintenance, law enforcement, development, planning, restoration, and education and safety.

The State of California Department of Parks and Recreation and the San Bernardino National Forest have maintained a partnership for more than 29 years, with funding assistance for well-managed OHV recreation on national forest lands. In 2014, SBNF received more than \$600,000 in grant funds to provide the public with OHV recreation opportunities.

SBNF officials request the public to provide suggestions for grants that will help improve the OHV program. Two meetings were to be held, one was Tuesday and the second is from 7 to 9 p.m. Wednesday, Feb. 11, at the Sizzler Restaurant, 1461 S. Rimpula Ave., Corona.

If you are unable to attend the meetings, or have any questions, the Forest Service would like to receive your input to this application. Email is the preferred means of sending comments to the agency. # Deer damaged due to DUI driver

## Surveillance videos show scene

The mystery of the second damaged painted deer (of the Deer Sightings Project) appears to have been solved. Robert Richard Rutherford, 56, of Idyllwild was arrested about 12:30 a.m. Saturday, Jan. 31, on several driving-under-the influence charges.

The arresting California Highway Patrol officer documented Rutherford's vehicle and the damage to the deer sculpture, according to CHP Officer Jeff O'Steen.

Rutherford was parked in the Idyllwild Inn lot for about an hour. About 10 p.m., he drove forward over the deer and over a wall about 20 inches tall on the street side, according to an Idyllwild Inn surveillance video, which can be viewed on the Town Crier website. He stopped in front of the BBVA Compass bank, according to CHP.

Rutherford also submitted to a chemical test for blood alcohol levels, and the arrest report indicates he "was under the influence," according to CHP Public Information Officer Darren Meyer.

The car, which crashed into the deer based on evidence collected at the scene, is registered to Rutherford, who was driving on a suspended license, Meyer added.

An individual witnessed the incident and notified CHP, which is why

CHP was on the scene so quickly and made the arrest and booked him. He was released the same day on \$10,000 bail.

The arresting CHP officer left the deer's remnants with a notification near the Bank, where it was found Saturday morning. Bank Manager Jeri Sue Haney said no surveillance camera captured the scene. She said the deer was left out near the entrance to the bank's driveway.

Joshua Sundsten of Fern Valley was waiting for a friend nearby. "I heard this terrible metal on metal sound," he said. He ran over to see the car already near the bank. He saw the deer's head and a couple of limbs lying on the street in front of Idyllwild Inn property. "It was amazing. I tried to wrap my head around what had happened."

Sundsten said the car's driver fell asleep at the wheel and he waited for him to wake up. "I wasn't going to let him drive," he said. When the driver awoke and started to drive away, part of the deer was still caught under the car so the engine revved and the wheels spun until the car finally got clear of the deer.

Sundsten banged on the car window and asked if he was OK. The driver was startled and Sundsten asked him to get out of the car and look at what he had done. "He had no recollection of anything," Sundsten said.

"I asked him if he had had a couple of drinks and he replied, 'Yeah, I had a couple.'"

Sundsten asked a man who had called law enforcement if he could handle the situation and keep him from driving. The man agreed so Sundsten left at that point.

Apparently, the CHP notification went missing from the deer, which was why Haney contacted the Riverside County Sheriff's Department about the vandalism and Marc Kasouf, AAI president asked anyone with information to contact the Sheriff's Department.

Sheriff's deputies began their own investigation of the incident until they learned Tuesday that CHP had already made an arrest. Wednesday morning, Capt. Lyndon Wood wrote, "I guess this has been sorted out?"

The AAI board was going to consider taking action against Rutherford at its meeting last week, according to AAI Public Relations Spokesperson Lesly Martin. On Monday, Martin said the board was still considering what to do.

# Proposed legislation would benefit volunteer fire departments

At the last Idyllwild Fire Protection District commission meeting, Paul Riggi, president of Volunteer Company 621, mentioned federal legislation that may benefit volunteer fire companies such as Idyllwild's.

H.R. 343 would amend the Internal Revenue Code to encourage people to volunteer for firefighting or emergency medical service.

The bill would allow individuals to value each hour of qualified services at \$20 and treat that as a contribution to the organization, with a limit of 300 hours per person annually.

"The bill creates a tax deduction for volunteer first responders and will help volunteer fire departments and other public safety organizations recruit and retain volunteers," said U.S. David B. McKinley (R-WV), who introduced the bill. After several meetings with volunteer fire departments in West Virginia, McKinley recognized the problem of recruiting volunteers and offered the proposed legislation as a solution.

He and Rep. Dave Loebsack (D-IA) originally submitted the bill at the end of the 114th Congress in December. They re-introduced it last month in the current congressional session. The bill has been referred to the House Committee on Ways and Means.

"... [L]ocal agencies are increasingly struggling to recruit and retain volunteer firefighters and EMTs. This common-sense bill would help bolster staffing in volunteer public safety agencies by allowing responders to claim a portion of the value of the services they donate each year as a charitable donation," said Chief Philip C. Stittleburg, chair of the National Volunteer Fire Council.

The idea of a public art project had been discussed by various AAI boards, even as far back as when Chris Trout founded the organization, but they could



not come to a consensus on the details of such a project.

# Off the Main Roads

## Guided by nature ...

Finding your way in the woods without a map or compass can be a daunting task. Yet our ancestors traveled their wild world — sometimes hundreds of miles — on foot without a breaking a sweat. How the heck did they do it?

Being guided by nature is based in reading its subtle patterns to which modern domesticated humans are often oblivious or they normally ignore them.

The directions of the world are worn into the very rocks, reflected in the undergrowth leaves reaching toward the sun and in the gnarled branches of trees twisting their way to the sky. Our ancestors could read these natural patterns as easily as you read a street sign, guiding them to their destinations and back again.

So how do we (re)train ourselves in this ancient human skill? No one fail-safe method or “trick” to natural navigation is true for every location.

Finding your way naturally relies on understanding the larger natural patterns of the area in which you live in. Examples include the amount and direction of light, prevailing wind(s) and level of moisture. These cumulative forces cause subtle asymmetries you can learn to interpret. In short, you must spend time in nature, observing and interacting.

Here are a handful of rough directional patterns to get you started:

**Into the light:** In an effect known as heliotropism, many plants orient themselves toward the greatest source of light. In our forest, one of the more sensitive and obvious heliotropic flora would be our lovely fiddlehead ferns.

**Ferns in direct sun** will tend to orient much of their growth southward to catch the most light. However, be sure to identify possible obstacles to light that might change the fern's orientation. For example, under heavy tree cover, heliotropic plants will orient toward the nearest bright opening in the canopy, no matter what direction it is. Open meadows may be your best bet.

**A tree's heavy side:** Lone trees tend to be “heavier” with more leaves and branches to the south side (in our northern hemisphere), enabling them to capture more of the life-giving Sun. Take the time to walk around the

tree and view it from multiple angles. However, this effect can be muted or overridden in a grouping of trees as their shadows interact with each other.

**Branching out:** Sunlight also directs the growth of individual branches. Southern branches tend to grow more horizontally (toward the Sun), while the shaded northern branches tend to grow more vertically in their quest for more sunlight. This can be most easily seen when observing the tree from east to west. Once again, individual trees are easier to read than groves.

**Moss and moisture:** Isn't moss supposed to grow on the north side of trees? Yes, but for the record, moss does not always grow just on the north side of trees.

Where moss grows depends mainly on the level of moisture, which is not always on the north side. Also, disregard growth in the first two feet up from the ground around the trunk because this tends to be influenced by the evaporating ground moisture.

Interested in exploring this further? An engaging guide to these skills is Tristan Gooley's book “Natural Navigation.” There are hundreds (possibly thousands) of more tips to explore and many more of your own to discover as you go out and start looking for your own patterns in nature.

5: A volunteer of the year is great but how do you know who it should be if volunteer hours are not recorded — another important practice of a nonprofit. That is how you get grant money.

7: This is a volunteer organization. Since I joined about a year and a half ago, I have volunteered for every event except the Art Walk as I was at the 2nd Saturday Art Fair. I know about volunteering.

As for Neil's letter, what can I say? Learn the difference between a for-profit corporation that made \$18 million last year and paid taxes and a Public Benefit Non-Profit Corporation that doesn't pay taxes and is responsible for following

the laws that govern it. Check out the California Corporate Code.

# Bill Weiser new Bautista Camp Division Chief

The new Bautista division chief is Bill Weiser. This division includes the Bautista Camp crews, Battalion 5, which is composed of the seven stations in San Jacinto and the Ryan Air Attack Base, and Battalion 11, which is the Hill from Anza and Lake Riverside to Poppet Flats. He is replacing Dave Fulcher.

Weiser is no stranger to this area. From early 2010 to August 2012 he served as Cal Fire battalion chief on the Hill.

"I'm excited. It's a new challenge and going to be fun," he said when asked how he feels about the new assignment. "I'm glad to be back working with all the people and agencies whom I worked with before. I learned how unique and important the mountain is and I'm happy to return."

Although an Alabamian at birth, Weiser's life experiences are thoroughly Californian. Son of a military man, he grew up in Fresno where his career with Cal Fire began in 1981. Since then he has climbed the ladder and touched each step on the way up — seasonal, engineer, captain, battalion chief and now division chief.

He's a firefighter and admitted that at times he misses being near the flames and heat. But when battalion chief in the Cajalco area, he missed the multiple relationships of various fire agencies and organizations on the Hill.

"What I will do now is just as exciting a challenge," he affirmed. "Lesson number one is maintaining and

improving the relationships between all the different departments such as the Forest Service and Idyllwild Fire and the [Mountain Communities] Fire Safe Council and the community."

As he settles into the new position, he is looking forward to re-engaging with the community and the various organizations that contribute and help with support. One of the major avenues enabling this engagement is the Mountain Area Safety Taskforce, which Weiser remembers well. He was MAST chief during his previous stint on the Hill.

The continuation of the drought and lack of precipitation has Weiser concerned. He easily remembers the Mountain and Silver fires of 2013, since he was assigned to both. He's also aware of the new presence of the Goldspotted oak borer and the revival of bark

beetle populations on the Hill.

"I'm worried about the bug kill coming back," he stated. "The biggest concern is this would build the fire threat."

But Weiser added that the additional staff and engines assigned to the Mountain Battalion will stay. "We are keeping them," he affirmed.

80 acres in Dark Canyon along the North Fork of the San Jacinto River. The house, modeled on Yosemite Lodge, was finished in 1919.

Over the years, Lawler, who became one of the first entertainment lawyers, brought many clients, among them Will Rogers, to the mountain retreat.

In July 1954, after his wife had died, Lawler deeded the structure and its surrounding 80 acres to Riverside County "[to be] used as a mountain campground and place of recreation for organized and supervised groups of normal boys and girls of school age..."

"Hilda became quite active in charitable work for the welfare of children, and that's what inspired Oscar to donate the lodge as a youth camp," wrote Robert Smith of the Idyllwild Area Historical Society.

As a county property, periodic maintenance and repairs are needed; but Herron feels these need to be consistent with its historical nature.

"As part of our capital expenditures, there were work items and, naturally, we wanted to treat it and approach it as a historical building," Herron said, "but to take the preservation approach and nominate it as historical county

landmark."

The lodge is a typical rustic retreat for urban dwellers in early 20th century built as a summer house," Herron added. "It's very unique with log construction and other native material. There are not a whole lot left."

Lawler, who was born in Iowa in 1875, moved with his family to Los Angeles in 1888. He apprenticed with Henry O'Melveny and successfully passed the bar exam in 1896. After a decade of private practice, he was appointed the U.S. district attorney of Southern California in 1906. Three years later, he was appointed assistant attorney general for the Department of Interior and temporarily moved to Washington, D.C. Eventually, he returned to Southern California and private practice.

However, his Wilshire Boulevard home was bombed and burned in 1919. Lawler suffered severe burns, but he, Hilda and their 5-year-old son escaped. Later, it was determined the bomber was the lover of a woman whose husband was successfully represented by Lawler. Lawler died in January 1966.

A countywide survey of possible historical resources in the early 1980s omitted Idyllwild, so there is no record on which to compare the Lawler Lodge to other similar properties. The Emerson Boy Scout Camp is the only county historical landmark in Idyllwild or Pine Cove. Lake Hemet and the dam are the other Hill buildings designated as landmarks.

## Obamacare hits tax returns

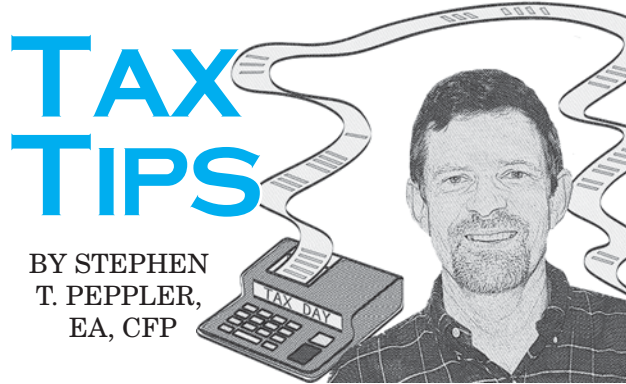

The Obamacare mandates become effective on our 2014 tax returns.

The Affordable Care Act (Obamacare) requires that you have health coverage that meets the law's requirements by 2014 or pay a penalty. Your spouse and dependents must also be covered or you may be subject to a penalty. However, there are 33 exemptions from the penalty you may qualify for. When you meet your tax professional or do your own return you will need to know whether your family members had qualifying coverage on a month-by-month basis.

Qualified health plans need to meet standards set by the government. You've probably read of thousands of people who've had to search for qualifying coverage after their plans got canceled.

If you purchased health coverage on an exchange such as Covered California, you probably received a subsidy or credit toward your insurance premium based on your estimated

income for 2014. When you do your return you must match the advanced credit to the actual credit based on your actual income to determine whether a portion of the credit needs to be repaid or whether you are entitled to an additional credit. Income for the purposes of the premium credit includes the income of your spouse plus dependents.

If you are an employer not offering health coverage you will want to check the regulations to see whether you are subject to a penalty.

Starting in 2015, if you are an employer or individual who provides health coverage to others you will be required to report the coverage on official IRS forms to the individuals and the IRS.

Beginning in 2018, there will be an excise tax

of 40 percent of the amount by which an employee's health coverage exceeds certain amounts. Most people affected by this tax will be the higher management of corporations or certain union members.

There are also additional taxes to help pay for the costs of the Affordable Care Act. The net investment income tax (NIIT) of 3.8 percent applies to individuals, estates and trusts with income over certain thresholds. There is also another 0.9-percent Medicare tax on wages and self-employment income over certain thresholds.

We're slowly finding out what was in the 2000-page Affordable Care Act. You will want to review the instructions closely before filing Form 8965 (coverage and exemptions) and Form 8962 (premium tax credit).

jumped to the ground below, all the while holding Wyatt tightly.

Luckily, Luke had his mother's car parked on the street. Barefoot, he buckled Wyatt in the car, and drove to his mother's house on Tollgate and called 911. Leaving Wyatt with his Mom he returned to the house to warn his landlords who lived next door, to make sure they got out of their house in case the fire spread. He arrived back just as engine companies from Idyllwild Fire, Riverside County Fire stations 23 (Pine Cove) and 53 (Garner Valley) and Volunteer Company 621 were pulling in. Although firefighters battled through the night to save the house, it was a complete loss. Both Luke and his son were transported to Eisenhower Medical Center in Rancho Mirage for evaluation and treatment for smoke inhalation.

"So many things we lost," said Luke. "Pictures, personal items, my son's Christmas presents and his soft blanket he loved."

Luke, a carpenter and handyman by trade, lost all but his most hardened metal tools.

"I'm so overcome by the amount of help we've received so far," said Luke, noting the cash donations, a Red Cross gift card for \$450 that Rick Foster and Nancy Layton brought by. "They came by a couple times," said Luke, "bringing blankets that the quilters [Mountain Quilters of Idyllwild] had made and some care packages."

Luke's mother, Kelly Hopper, is coordinating donations. Tools (see list) can be dropped at her house, 53675 Tollgate, and donations can be sent to Luke at P.O. Box 401, Idyllwild 92549 or c/o of Kaarin Elizabeth, memo "For Andrew Luke," at P.O. Box 3153, Idyllwild. Luke and Wyatt are currently staying with Luke's mother.

Friend Kaarin Elizabeth, who created a social media campaign to help Luke and Wyatt, had hoped to raise \$1,500 for the family. To date, about \$500 has been raised.

Luke can't work without his tools. Below is a list of the most important tools

"I am typically a Mil-

waukee [tool brand] guy and most of the tools that were lost in the fire were Milwaukee, but right now I need to be able to work so anything anyone has to offer would be more than appreciated," said Luke. He also mentioned that he and Wyatt are in need of a place to stay, preferably a one-bedroom in the \$600 per month range. "We can't stay at Mom's forever," said Luke.

## ART'S CORNER

Program:  
Brahms: "Serenade #1 in D Major, Opus 11"  
Mozart: "Concerto for Piano and Orchestra #27 in B Flat Major, K. 595"  
(First movement, "Allegro" only, with cadenza by Mozart)  
Beethoven: "Overture to Goethe's 'Egmont,' Opus 84'

The nature of classical music programming is such that it ordinarily can be viewed as pedestrian, especially regarding the core compositions of the late 18th and early 19th centuries. Fitting a program of such basic a repertory together is a problem even experienced orchestras and conductors find too difficult with which to wrestle, and therefore most programs of this sort tend to fall lackadaisically into the aforementioned paradigmatic category of "pedestrian," giving both performers and auditors an easy solution of the predicament. However, when traditional format is disrupted — either by chronological reordering or similar juxtapositions — innovation is effected, and the resultant novelty is put forth upon the public as change, for better or worse. The trick, of course, rests in making it work for both players and audience.

Mr. Timothy Verville's chosen program order this past Saturday evening showed both audience consideration as well as innovative structuring, and deserved all the accolades he and the Idyllwild Arts Academy Orchestra received in return. By scheduling the first of Johannes Brahms' orchestral serenades at the program's beginning, the work was put forward as both a series of symphonic studies for the composer's later works and as a revelation of the compositional process essayed in its overall six-movement structure. Particularly revelatory in the unfolding of this performance was the integral balance maintained between the wind and string sections, especially in the first and third movements; the latter section of the orchestra was at its most effective in the final movement's short, contrasting sections.

Following the intermission (when both orchestra and audience had a chance to relax and reflect), the stage was reconfigured for the first movement of Mozart's last piano concerto; a smaller accompanying en-

semble provided the award-winning soloist with a more than adequate backdrop for the foreground pianistic display. Ms. Helen Hanxiao Lai's distinct manner of presentation proved that she had not only the music's requisites (the so-called "Mozart touch," with as much bravura as necessary) but also the way around such melodic intricacies as the traditional classical period ornamentation; this was particularly evident in the cadential portion of the movement, where the proper amount of fortissimo was both forceful and substantial.

As a conclusion to the evening's proceedings, what would have normally been the opening offering on the program, proved a more than worthy final demonstration of orchestral prowess, and Mr. Verville's forces assembled put forth their collective best execution with a minimal amount of player fatigue. Their corroborative efforts on Beethoven's "Egmont" overture were a spectacularly put-forth, once-more cooperation of orchestral forces (chiefly horns and strings) in a display of the

music's essential tragedy and triumph, and a rousing, well-deserved audience response was similarly effective.

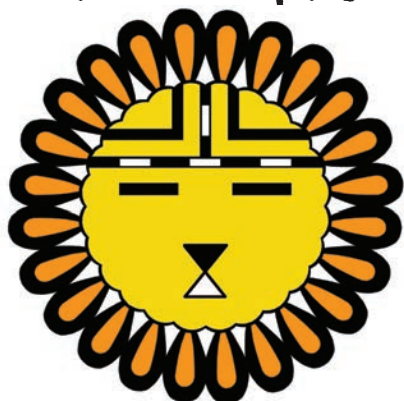

The word from the woods:  
A century of change in  
Idyllwild ...

More than 100 years ago, scientists had already begun to flock to the San Jacinto Mountains to study the unique and diverse wildlife that inhabits our chaparral, mixed forest, riparian and meadow habitats. Our sky island separates local wildlife from the surrounding ecological communities and allows them to evolve in isolation from their ancestors. The effect is similar to geographic isolation in rural Appalachia. That is, geographically isolated populations are also genetically isolated. Consequently, for many species, the San Jacintos have given rise to a branch of the family tree that is distinctly different from the rest of their kind down the Hill and across the pass to the San Bernardino Mountains. Geographic isolation also means there are fewer immigrants that populate our region from outlying areas. When populations dwindle, few outsiders repopulate the hill.

In 1908, Idyllwild was just developing as a tour-

ist destination. That year, two scientists from UC Berkeley, Joseph Grinnell and Harry Swarth, conducted an expedition to survey the fauna of the San Jacintos, including areas near by Idyllwild County Park, Humber Park, Fuller's Mill and the James Reserve. Their survey data along, with detailed notes, photographs and the collection of archived specimen, created a baseline for future

generations to use as a benchmark for environmental change. In 2011, a team of biologists from the San Diego Natural History Museum began to resurvey the 20 sites established by Grinnell and Swarth. The centennial resurvey concluded in 2014. In 2016, the San Diego Natural History Museum will publish survey results that span across the last century. Here's a sneak preview of the results:

## 1908 vs. 2015

*Species nearly vanished or locally extinct since 1908.*

- Mammals — San Bernardino flying squirrel, voucher specimen collected in Strawberry Valley in Idyllwild (1908). The JR is collaborating with the SDNHM to intensively survey for flying squirrels around Idyllwild.
- Herpetofauna — Rubber boa, last collected in 1982.
- Amphibians — Mountain yellow-legged frog (federally endangered), a species common in Idyllwild area only a few decades ago.
- Birds — the Black-chinned Hummingbird, Gray Vireo, Warbling Vireo, Chipping Sparrow, Lark Sparrow and Yellow Warbler.

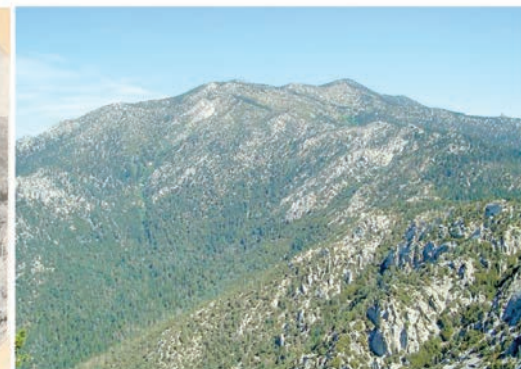
*Species that are new arrivals since 1908.*

- Mammals — Desert cottontail and brush rabbit.
- Birds — the Red-shouldered Hawk, American Crow, American Robin, European Starling, House Sparrow and Brown-headed Cowbird.

- Mammals — Twelve species of bats!

Why have some species disappeared from Idyllwild while others have colonized it? There is no single answer. Some species have spread to higher elevations, retreated from lower elevations, spread to lower elevations, retreated from higher elevations, attraction to urban development or retreated from urban development. The Mountain Quail, Song Sparrow, California Towhee, and Tiger or Western Whiptail appear to have spread to higher elevations. At the same time, some species breed at lower elevations than a century ago, such as the Red-breasted Sapsucker.

What are the consequences of our changing landscape? Predicting and mediating the biological impacts of habitat disturbance remains a great challenge for science and an area of research the James Reserve is actively engaged in. In fact, Janet Napolitano, president of the University of California system, has just awarded a large grant to a team of UC researchers led by Drs. Barry Sinervo and Laurel Fox (UCSC), to monitor climate change across the state of California, including at the James Reserve. # Art in Society panel discussion followed by Q&A

I'm speaking with Chris Wegemer who could be identified by his profession as a math teacher at Idyllwild Arts Academy, but he would be more meaningfully described as an extremely intelligent, soft-spoken man who could teach us all about perseverance. But that is a story for another time.

Last week, I interviewed Chris because he has been instrumental in bringing an event to the arts school that is sure to become an annual tradition, "Art In Society." Chris has a deep passion for the arts, so I thought the easy first question would be:

**Question:** Are you an artist yourself?

**Answer:** No, (with a slight chuckle) not in the traditional sense, but life is art, man, isn't it?

**Q:** So then what is your main motivation for bringing these artists together in this forum considering you don't have that traditional background?

**A:** Being up here, it is so easy to become isolated and disconnected from the world. I think it is important for the kids to be exposed to ideas where art can actually engage the world in social ways. The artists we are bringing up are artist activists who use their art for some social justice ends in society. With the majority of the school being international and of means, I feel it is important for them to be exposed to progressive ideas of how art can be applied to society.

**Q:** Tell us about some of the artists you and the school have invited and why you chose them.

**A:** OK, in no particular order, but one of the stars of the show will definitely be Claudia Rankine, who writes poetry about the experience of racism in the United States. She is very good at pointing out the subtle ways racism is present in our society without us being aware of it and this is a very good thing for Idyllwild because it is particularly homogeneous.

Another artist is George Blake, an ethnomusicologist who studies racial issues in jazz music and how jazz changed during the 20th century, having started in black communities before becoming integrated (or more appropriated) by whites and how different issues were reflected in the jazz music.

John Pennington is a dancer in L.A. who also started "A Room to Create" where kids come in to do creative things instead of being on the street. In addition, he is influential in making sure art is featured in the Los Angeles public schools system.

John David Mooney is a very prestigious artist and sculptor who does large-scale industrial sculptures which have been featured in the Chicago Olympics and in many high-profile places worldwide; he has been given three honorary doctorates and many awards for his works. His objective is to bring high-end art to the masses.

The final artist I want to mention is Mariana Amatullo, who if I had to guess just might steal the show. She founded the "Design Matters" program at the Art Center in L.A. She is considered a leader in social design, a field where groups like UNICEF will approach her to use creative and artistic design to address social problems throughout the world.

**Q:** What is the format going to be for the presentation and what kind of turnout are you expecting?

**A:** Each artist is going to have approximately 10 to 15 minutes to speak, much like a TED talk. Our goal is to keep it stimulating and flowing. We are expecting a good turnout with seating to accommodate 350. We are really encouraging locals to attend as we are looking to have

this more often, even periodically, throughout the year. Our hope is that this will also start and continue the conversation of art-activism for people from all walks of life to engage in.

**Q:** What would you expect the layman or the person with little knowledge of art in general to take away from this?

**A:** To get people to think; to see how they interact with the world. I'm hoping that by these artists presenting what they are passionate about, it will make all of us think about what we are passionate about. I also hope this helps the relationship between the town and the school because I feel like we are all in this together, we all interact and are connected in different ways, and I want this conversation to involve all of us. But the most important thing is that they enjoy it and hopefully everyone resonates with at least one of the artists.

**Q:** How long is the program and is there a fee?

**A:** We expect it to last an hour to one-and-a-half hours. There is no fee for attending and refreshment will be provided at the end in an open setting to allow interaction with the artists.

**Q:** I've gotta say, Chris, that I am honored to shake the hand of a man with such deep devotion to his craft, and further, to witness the dedication you have to the young minds you help shape. Is there anything else you would like to mention about this event or just in general?

**A:** Worth mentioning is that each of the featured artists will be offering master classes to the students before or after the event, with our goal to eventually offer adult workshops down the road. But I must say that the most important message is, "All are welcome."

As we end the interview, I can't help but smile as I watch Chris climb into his car, or more aptly put, rolling modern art affectionately hand painted by some of his students. This disheveled hodgepodge of teenage artistic expression somehow represents all that is still right in our little world. It makes me smile because it reminds me that freedom of expression is the ultimate expression of freedom.

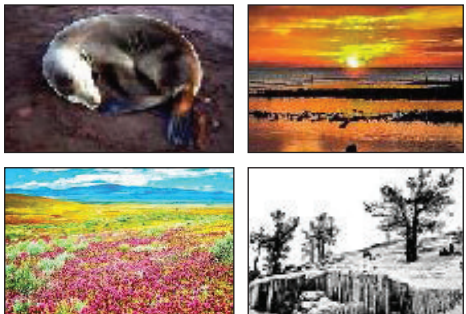

# Steele steady at Torrey Sunday

It wasn't one of his better tournaments this year, scoring wise, but Brendan Steele kept composure and patience throughout. Sunday, the Idyllwild native was 2-over-par on the day, giving him a 1-over-par 69-72-74-74 — 289 for the tournament and finishing him in a tie for 45th.

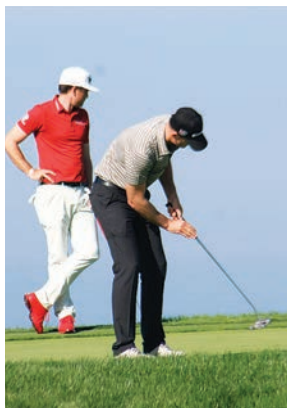
He did record four birdies Sunday, including this one at the par 4 14th hole. (See photo.) Note the claw grip he is employing with the short stick.

His putting was not off; he needed 1.727 puts per green and gained 2.708 strokes on the rest of the field; he stood 19th in the field in both those categories. But through eight tournaments this year, Steele's proximity to hole stat has been high — 36 feet, 5 inches, which ranks 104th on the tour. This suggests that his approaches have left him with birdie putts that are too long to be dropped with any consistency.

Steele has been working with Rich Smith, his swing coach, and lately has incorporated one of Smith's swing keys into his pre-shot routine on full swing shots. (See video attached to this story at our website, towncrier.com.) He says this swing key is designed to help him keep his butt down and his shoulders rotating under and through, something many of us amateurs would do well to emulate.

Steele is taking this week off, but currently is expected to tee it up next week at the Riviera Country Club in the Northern Trust Open in Pacific Palisades.

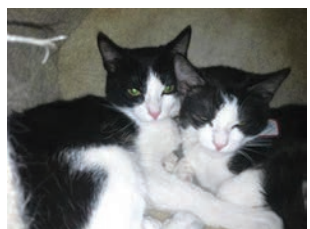
The purrfect Valentine's Day is cuddling up with a furry feline.

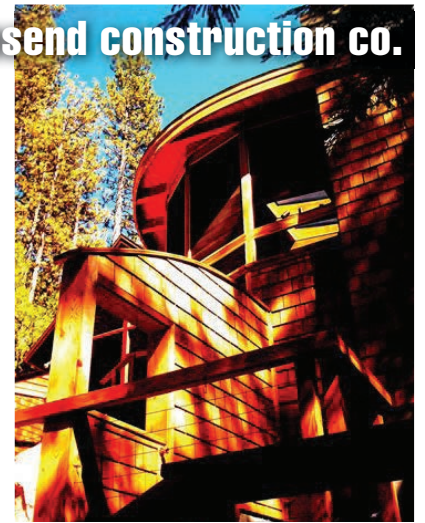

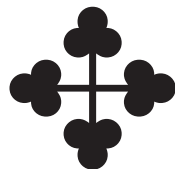

# Lemon Lily Festival introduced to California Native Plant Society

Last month I gave a presentation about the Idyllwild Lemon Lily Festival at the state meeting for the California Native Plant Society in San Jose. Native plant lovers from across California were a receptive audience for the story of the festival and the local efforts in conserving and restoring the Lemon Lily.

We were assigned a time slot in the "conservation negotiations" session and asked to emphasize the process of how people worked together. After a flurry of emails from Dave Stith, my co-author on the talk, and others, I attempted to put the history of how the Lemon Lily Festival in Idyllwild came to be. This report is happily supplied to the Town Crier. With the photos, I was able to show members of the California Native Plant Society exactly what the festival looked like (and how much fun it is).

The place to start, of course, is with the Lemon Lily. Most "native plant people" are familiar with native lilies, but not with our Southern California Lemon Lily. As this meeting took place in Northern California, some background was in order.

Lilium parryi is a beautiful yellow lily that grows along high-elevation creeks and streams, and wet meadows from a small bulb-like rhizome. The Lemon Lily is mainly restricted to the mountains of Southern California with a few populations known from the mountains of Southeastern Arizona.

This winsome lily can produce multiple 6-inch showy yellow flowers per plant in a season, and, is very easy to fall in love with. It was once very common in the creeks and meadows of the San Jacinto Mountains (and probably in the San Gabriels and San Bernardino, too). Older visitors attending the festival have even shared memories of seeing it in some of the creeks around Idyllwild.

We have reason to be-

lieve it was much more common from a single observation made by Harvey Monroe Hall, the first botanist to do a flora survey of the San Jacintos in 1902. On one day, a single bulb collector removed more than 5,000 bulbs from the Idyllwild area. Bulb collecting was quite common in those days as hobby gardeners from the turn of the last century were keenly interested in new garden plants.

Between the bulb poaching and continuing drought conditions, Lemon Lilies have become rare. Only those who can venture into the high country really have the chance to see them.

Next I explained and described Idyllwild — a small community without a single ski-lift or large, recreational lake. Our area attracts artists, nature lovers, rock-climbers and Pacific Crest Trail hikers. Families from all over Southern California visit Idyllwild, especially on summer weekends to escape the heat. People live and visit here because they like nature.

An important part of the history of the current interest in Lemon Lilies comes from a loosely organized group of rather serious amateur botanists, key among them, our own Stith, who started hiking and learning about plants from Tom Chester. As an energetic amateur botanist, Chester has made plant lists for many of the local trails in San Diego and Riverside County.

Chester is the one who brought the observations of Harvey Monroe Hall to our attention about the massive bulb poaching that happened earlier in the last century. Stith and Chester set out to survey and count the Lemon Lily plants on Forest Service and State Park lands.

Stith has been tracking one area, Candy's Creek, for at least five years now. He and I were talking one day when I made a completely off-the-cuff remark that "we ought to have a Lemon Lily festival" so that more people

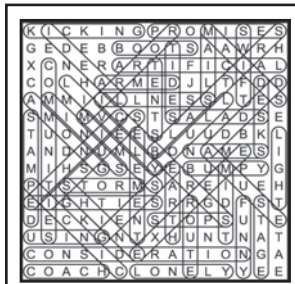

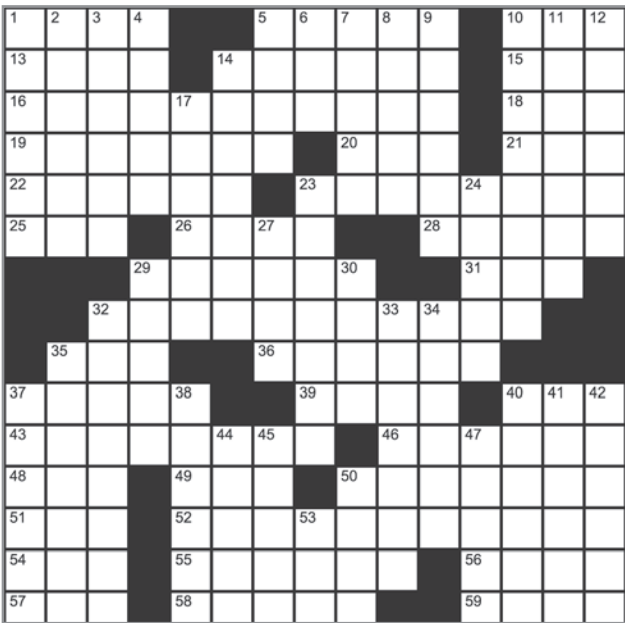

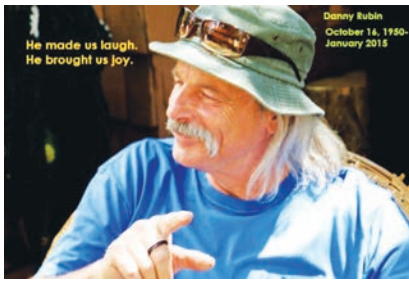
Besides the rock & roll and folk music genres his generation grew up with, he had an encyclopedic knowledge of American blues and was well-versed in jazz as well.

## County budget will need some adjustment

While county revenues are gradually improving, the budget for the current fiscal year that ends June 30 still projects deficits for each of the principal public safety agencies.

"While local economic indicators continue gradually trending positive, significant budgetary challenges lay ahead," Riverside County Executive Officer Jay Orr said in his

midyear budget report to the Board of Supervisors.

The Sheriff's Department has been able to reduce its projected deficit from \$46 million to \$40 million. The District Attorney revised its projected balance from \$10 million to \$7.5 million. However, the Fire Department's projected loss remains at \$4.2 million.

Orr advised the board to make no changes at this point in the fiscal year. His staff is monitoring

these expenses and working with the department heads.

One item of good news was that the estimated loss at the Riverside County Regional Medical Center has fallen from \$18 million to \$10 million.

But a major budget issue is on the horizon. One result of the passage of Proposition 47 was the transfer of costs for mental health and substance abuse patients to the county. This also includes up-

grades to obtain accreditation from the National Commission on Correctional Health Care.

Orr said the county Mental Health Department is requesting 75 more positions. The current year budget change is estimated to be \$2.5 million, which could grow to be \$6.3 million for the full year in 2015-16.

would know about them and want to protect them. Stith ran with this idea, and you know the rest is history.

So, how did this festival of five years running actually start? With the dedicated efforts of an original committee of five people — Stith, Shelley Kibby of the Idyllwild Nature Center, Harold Voorhees of the Garden Club, Denise Huntington of the Friends of the San Jacinto Mountain County Parks and Doug Yagaloff, representing the town merchants.

It took many meetings to plan the first festival, and various people cycled through the committee. It was often hard to keep everyone going the same direction and to decide on which ideas to use, but in the end it was a dedicated group of people with a common goal that pulled it off.

Since the talk was in a "negotiations" session, I mentioned some of the challenges, such as turnover of leadership (losing Yagaloff), merchants less involved, results from restoration efforts taking time and planning an event around a blooming plant.

The aspects we have going for the festival are a small, nature-loving community, a consistent supportive institution (the Nature Center), a wonderfully charismatic species and sustained conservation interest from the community.

It was easy to describe the festival (and great to have the photos). I related how popular it has been, with booths of information, special T-shirts, the quilt raffle, the banner contest, the theme of the turn-of-the-century activities for kids, the Penny-Royal Players, the art show, the hikes, the Lemon Lily

and general natural history information talks, and especially, the "Lemon Lily Song." I finished the talk with the clip of the Huel Howser episode of the Lemon Lily Singers in action. That conveyed the love and the fun that has made the festival what it is.

People have been coming up to me since the talk and saying how much they would like to come this year. The 2015 festival is set for July 11 to 12, so watch for more information and be part of the fun.

# Drought more likely than relief in 2015

Despite the rainstorms in November and December, 2015 appears to be becoming the fourth-consecutive drought year. However, the National Weather Service is still forecasting above-average rainfall for Southern California between February and April.

Through the end of January, rainfall on the Hill is substantially below the long-term average rain

through January of 14.2 inches. The Idyllwild Fire Station has reported 11.86 inches through January; the Forest Service's Keenwild Ranger Station has received only 6.7 inches and George Tate of Pine Cove reports 12.7 inches. All of these data points are below the average, which includes 5 inches just in January.

At the end of January, the state's Department of Water Resources reported the snowpack was only 25 percent of its historical av-

erage. An exceedingly dry January resulted in the water equivalent dropping 50 percent.

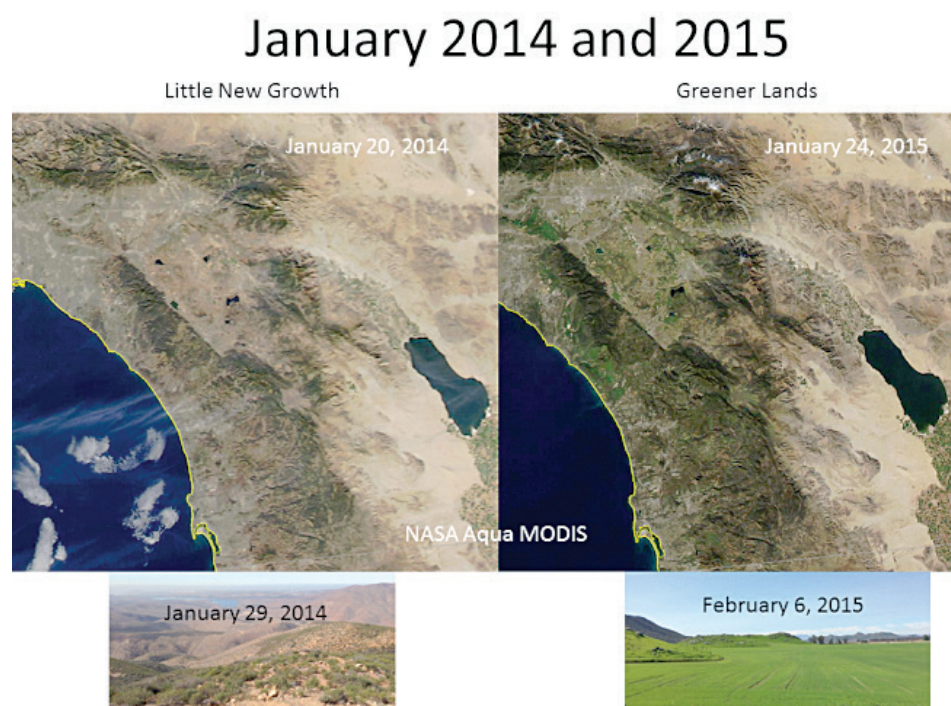
"The absence of precipitation in January, normally California's wettest month, has combined with warmer-than-average temperatures to produce a dismally meager snowpack for a drought-stricken state," according to DWR. "... manual snow survey makes it likely that California's drought will run through a fourth-consecutive year."

Cal Fire's Predictive Services unit was more direct in its description of the past month's weather. "... little meaningful precipitation to important water sheds across the state."

January was unusually dry this year. According to NWS, it was the fifth-driest January in Big Bear, Riverside and Palm Springs since keeping records began in the mid-1800s.

Although Northern California experienced major rainstorms last weekend, January was a record. For the first time, no rain was recorded in San Francisco during the month.

"Most long-term precipitation guidance continues to be bullish with regards to precipitation the rest of this winter in early spring," Cal Fire stated. "Take most of the models at face value,

forests and reduce future catastrophic wildfire," said Agricultural Secretary Tom Vilsack in a press release.

The fire management costs — both preparedness and suppression — have outgrown the remainder of the Forest Service's budget for more than a decade. Currently, these funds are more than 50 percent of the agency's budget compared to less than 15 percent in the 1990s.

During a year when fire costs exceeded the appropriated levels, the Forest Service must borrow funds from other parts of its budget. Since 2000, this has happened every year but two. In the worst fire years, the transfer can amount to more than \$500 million.

Then the agency must request congressional approval for supplemental funding to restore the money for its original purpose. This does not always occur; consequently, for several years, the Forest Service has been proposing alternatives to provide the emergency fire funding without disrupting its other programs.

"It is subsuming the agency's budget and jeopardizing our ability to successfully implement our full mission," the agency said in its budget justification.

The largest fires (about 1 percent of fires) consume nearly 30 percent of the suppression costs. This year, the Forest Service has included \$795 million within its suppression budget for the 70 percent of its 10-year average suppression

expenses attributable to 99 percent of all fires.

The costs for the most expensive fires, or 30 percent of suppression expenses, are requested as a special appropriation, which is called the "Suppression Cap Adjustment."

If this funding is approved, the agency believes its budget will become more stable. Access to these funds will be limited and require a declaration from the secretary of agriculture that one of several conditions has occurred and consequently, these monies are needed.

Two of the proposed conditions are a fire greater than 1,000 acres or a fire within 10 miles of a major urban area.

Despite a slight reduction to the total preparedness funding, the Forest Service said it expects to continue to implement its strategy to replace its airtankers. The proposed funding will allow the use of up to 21 airtankers; at least 15 will be next-generation airtankers.

Also, the agency is moving forward with the program to transfer seven C-130H aircraft from the U.S. Coast Guard to the Forest Service. Before the transfer is completed, the U.S. Air Force will retrofit them and install a retardant delivery system. One C-130H airtanker may be available for missions in FY 2015.

Neither the capital improvement nor land acquisition budget propose any major projects in the San Jacinto Ranger District.
