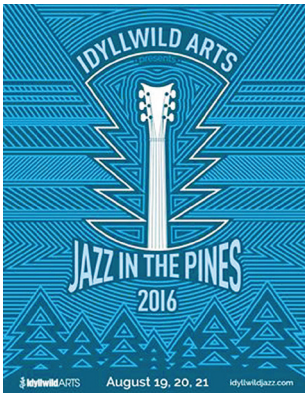

## Body found along Hwy. 74 on Sunday

The Riverside County Sheriff's Office received a call at about 10:45 a.m. Sunday from some hikers who saw a body along Highway 74. Shortly after, the California Highway Patrol also was called.

The body of a female was found, and her decomposition had proceeded such that her race was not identifiable from observation.

The Department's Media Bureau said, "Our department is investigating this death, and at this time it is

## Summer blackouts may be coming

The natural gas leak at the Aliso Canyon underground storage facility may affect Hill residents this summer. Reduced availability of natural gas may create power outages during peak days this summer.

The California Energy Commission and three other public agencies released a report last week and held a public workshop Friday to address how the underground storage facility problem could affect power in Southern California this summer.

## Weekend rain still shy of normal

Despite rain showers and clouds for most of the past five days, the dreaded El Niño has not drenched the Hill. The rain that has fallen since Thursday is barely half of the historic April showers on the Hill.

Pine Cove has recorded 1.56 inches this week, while the Keenwild Ranger Station has recorded 1.46 inches. Normal rainfall for April is about 2 inches.

With this week's rain, the total since July 1, 2015, has been more than 23 inches in Pine Cove and 19 inches at Keenwild, which is at a lower elevation. The

historic average rainfall from July 1 through the end of March is 22.8 inches and 24.8 inches through the end of April.

The last time rainfall amounts reached the historic average of 25.7 inches for a full year was 2011. In 2010, rainfall came within 2 inches of the average.

Statewide, the Department of Water Resources reported, "Water content of the mountain snow pack today is only 87 percent of the March 30 historical average."

According to the agency's press release, California's snow pack usually reaches its peak depth and water content each year around the first of April. Last

# Two fatalities reported during last week on Hill roads

Eutiquio Ramirez, 48, of Indio, a well-regarded and longtime employee of Griner Construction in Idyllwild, died in a single-vehicle crash reported at 5:42 p.m. Friday, April 8.

According to the California Highway Patrol report, Ramirez was driving his white Toyota T100 pickup truck east on Highway 74, when for unknown reasons he veered to the right and his vehicle left the roadway and went over the side about 50 to 100 feet down into a ravine. The incident occurred three-tenths of a mile east of Big Horn Road on a cloudy day with a clear roadway.

Ramirez was pronounced dead at the crash scene at 6:27 p.m. There were no passengers in the truck and no other vehicles were involved.

Separately reported in this edition, the badly

decomposed body of a female was discovered on Sunday, April 10, on Highway 74. The incident is being investigated to determine cause of death.

At 12:20 p.m. Thursday, April 7, Britta Hollowell, 66, of Pine Cove, was driving her 2011 Kia Sorrento west on Highway 74 when she allowed the vehicle to drift toward the right, causing the vehicle to hit the shoulder and slide over an embankment. The crash occurred eight-tenths of a mile east of Strawberry Creek bridge. Hollowell complained of pain and was transported by American Medical Response to Hemet Valley Medical Center. There were no passengers with Hollowell and no other vehicles were involved.

At 11:30 p.m. Thursday, April 7, Lee Putnam, 67, of Idyllwild, was driving his 2010 Jeep Cherokee east on Highway 74, three-tenths of a mile west of

# Powell's felony settlement conference postponed again

Nasir David Powell's felony settlement conference, set for April 6, was rescheduled for April 26, again at 8:30 a.m. in Department S204, Murrieta. It was the second time his FSC has been continued.

Powell, 18, is charged with five felony counts involving various sexual transgressions with minors ranging in age from 14 to 17 years of age. Although he claimed to investigators that all said activities were consensual, that cannot operate as an exonerating defense because they were all with minors. As a matter of law, minors are not capable of consenting to such activities, so lack of consent is not an element of these charges.

Four of the counts against Powell carry a maximum sentence of a year in county jail or state prison. One of the counts, dealing with a minor more than three years younger than himself, is punishable by either a year in county jail or as much as

three years in state prison.

# Flying Squirrel population not threatened

Federal agency says  
San Jacinto Mountains no  
longer their habitat

The San Bernardino Flying Squirrel is neither endangered nor threatened, the U.S. Fish Wildlife Service announced last week.

In response to a petition from the Center for Biological Diversity in 2010 and legal action to spur a response in 2014, the FWS did an extensive review of the Southern California mountains to determine the squirrel's status.

"Today, the U.S. Fish and Wildlife Service announced its determination that this native squirrel does not require protection under the Endangered Species Act," the FWS said in its press release on April 4.

threats to its long-term survival," the FWS concluded.

In April 2015, the U.S. Forest Service also asked

"In a thorough status review of the species using the best available science, the service found that the squirrel is abundant where it is found and that the threats of habitat loss from urban development, habitat fragmentation, wildfire, urban air pollution and climate change do not pose significant

local residents if anyone has seen the Flying Squirrel in either the San Bernardino or San Jacinto mountains, its normal range.

While Forest Service biologists have been studying the squirrel for more than two decades, its presence in the local San Jacinto Mountains has not been reported for about 20 years. FWS confirmed that no recent evidence of the presence of the squirrel in the local mountains has been documented.

The FWS does not believe that forest fires in the San Bernardino National Forest in the past century have had any significant effect on the squirrel's habitat. Nor does it appear that the more recent fuel treatments to reduce the risk of catastrophic wildfire have affected its population, the FWS stated.

## Ellis back in custody; sentencing set for April 19

On April 7, Ira Robert Ellis, 37, of Poppet Flats admitted a felony violation of his Post-Release Community Supervision in Riverside County Superior Court. Hearing Officer Judith M. Fouladi then reinstated his PRCS with the modification that Ellis is sentenced to 88 days in the county jail.

On Tuesday, April 19, at 8:30 a.m. in Department 63, Riverside, Ellis is scheduled to appear for sen-

tencing on 10 misdemeanor and/or felony charges including possession of a concealed dirk or dagger, possession of ammunition by a person prohibited from owning or possessing a firearm, mail theft, resisting or obstructing a public officer, hit-and-run property damage, possession of a controlled substance and controlled substance paraphernalia, and three sentencing enhancement charges owing to prior convictions, including a possible three-strikes enhancement.

That administrative law judge rendered his decision to reverse Capt. Jim Reyes' termination in July 2014 from Idyllwild Fire. Sadly, IFPD's pride proves too great to accept it.

The district's legal fees continue mounting, primarily because of this and Reyes' separate and pending civil lawsuit.

Last fiscal year, IFPD exceeded \$100,000 in legal costs; this year, it spent nearly \$55,000 just on the Reyes case. Legal expenses keep exceeding budget.

After the board rejected the ALJ's decision, Commissioner Nancy Layton blatantly wrote, "... we will be spending yet more money on the case that we believe is necessary."

IFPD requested the case's transcripts to pour over with its attorney and fight the ALJ. After IFPD comes up with its own decision countering the ALJ's, it will then have to fight off Reyes' petition for writ of mandate. It will then need more legal help with the already existing civil suit.

After all this costly legal spending, if IFPD must reinstate Reyes, it also must pay back his salary of two years plus benefits (or more, depending on when he's reinstated).

Could this holding out on pride because of a nebulous and unwarranted firing be what finally brings down the district?

Already, IFPD proved itself to be an independent agency acting on its own self-serving interests, not on behalf of the public it serves. Just consider it also rejected grand jury reports recommending such simple corrections as Brown Act training.

That brings me to the issue of taxes. It seems to be almost a done deal that Idyllwild property owners will see an IFPD unit fee increase of 140 percent on their November ballot.

How about you? Are you willing to cover the cost of blind pride?

Immediately, I told my daughter from out of the country to make them stop doing such a thing. Also, he said that ARF doesn't have liability. Then what do we do? Who is responsible for killing our loving member of our family? I want Lefty Lou.

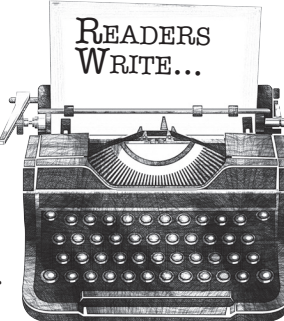
Ask him where he left her and if she was alive at that time, please.

Of course we said we would. However, ARF did

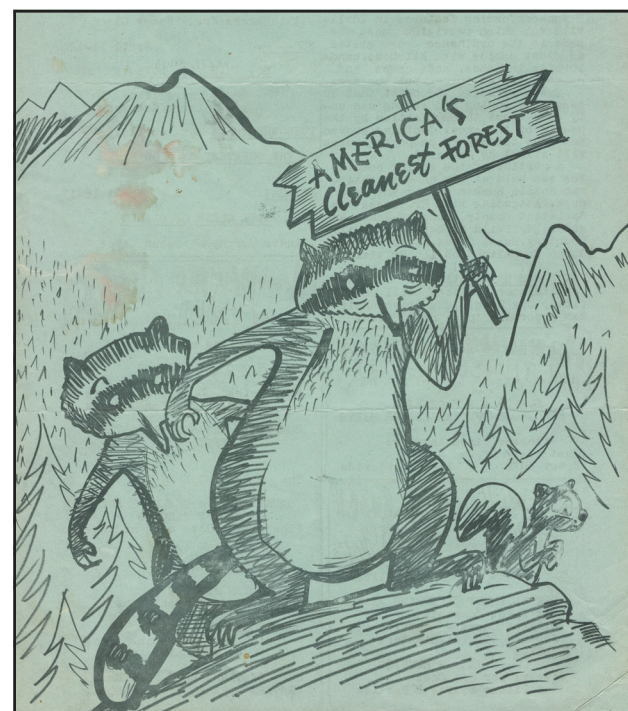
not do an "intake" of this dog, did not assume responsibility for her and did not place her with this foster. The placement of this dog with this particular foster was a decision and move made by solely AnaLia.

AnaLia (or her daughter) did send us \$100, which was used for Lefty Lou's care while in XXX's home. The \$100 did not cover the total cost for XXX to care for the dog, so ARF stepped up, providing food and veterinary care.

We also had Lefty Lou at the ARF House on weekends to see if we could find her a home. More than once when she was with us, she attacked ARF dogs, so we were unable to have her there if we had "our" dogs there at the same time.

AnaLia chose this foster. This foster's son had issues with the dog; his actions had nothing to do with ARF. It was a tragedy, and we feel terrible that it happened. All ARF did was try to help find a

## HOW WILDFIRE SPREADS AND THREATENS HOMES ...

Last month, I talked about fire behavior and how its travel and spread can be reduced around your home. We, the fire community, call this area of enhanced protection "Defensible Space."

This week I want to explain how a wildfire spreads to a home or building in its path.

Reducing the amount of combustible vegetation immediately adjacent to and outward from the home gives firefighters and your house a chance that an approaching fire can be slowed or stopped. Often this is enough to reduce the possibility of it igniting.

During a wildfire that is moving toward structures, ignition of a building can occur in several ways. One way might be sparks, firebrands or embers, byproducts of burning material most often carried by the wind.

Sometimes these embers travel far ahead of the fire and can create new "spot fires" in areas of unburned brush or grass. These same embers can find their way into and onto your home. And those that still have wood-shingle roofs are most vulnerable. Things like your wicker furniture, a cloth umbrella, a pile of pine needles on your deck or patio and even that cocoa mat outside the front door we wipe our feet on are all potential ignition sources.

Homes built on elevated foundations with crawl spaces and most homes built with an attic space will have required vents that allow the circulation of air in these areas to prevent moisture-related problems. These vents come in various shapes and sizes and are typically covered with a screen material to keep rodents, birds and other larger pests out. Most of these vents will not stop burning embers from finding a way through.

Radiant heat is another common way wildfire can ignite a home. This is the heat the burning vegetation too close to the side of the house gives off. If exposed to this heat for a long enough duration, ignition of the building can occur.

The final method is through direct flame contact. In other words, the flames of the burning brush, trees or grass are in direct contact with the home or building. In this situation, defensible space and/or fire abatement work was probably nonexistent.

One of the most valuable resources available to homeowners is the Mountain Communities Fire Safe Council. Our staff can help to educate and guide homeowners through an evaluation of their property and how to prepare it and create their own defensible space. The hardening of your home and other preventative measures can be discussed.

In my next column, I will introduce our project manager, Pat Boss. I also will explain the financial assistance available to offset some of the costs toward abating your property.

# New pickleball courts part of Phase 1 construction at Butterfield Commons

Last week's story about the plans for Phase 1 of the Butterfield Commons at Strawberry Creek did not clarify the future availability of the pickleball courts.

Currently, these are located on the surface of an old tennis court and just in front of the playground area. When construction begins, access to the pickleball courts, just as access to the playground, will be prevented unless some special provisions with the contractor are

possible.

However, Janice Lyle, board president for the San Jacinto Mountains Community Center, shared in an email that new pickleball courts are part of the Phase 1 construction plans. Only the location of the courts is being studied now.

"We haven't established their final placement but absolutely will have them as part of this first phase. Just wanted to reassure all of our pickleball enthusiasts," Lyle wrote to Ron Perry, a pickleball enthusiast.

## County crime statistics up for 2015

Earlier this month, the Riverside County Sheriff's Department and District Attorney's Office released the preliminary crime statistics for 2015. These data were from all independent and contract cities in the county, and its unincorporated areas.

Overall, reported crime increased throughout the county in 2015. However, specific trends and patterns were not identifiable because of the variation in changes among types of crime. Also, population size strongly influenced the number of crimes, which had substantial variation when compared on a per-capita basis.

For example, both the city of Banning and Moreno Valley reported 33 rapes in 2015. However, the frequency in Banning, whose population is about a fifth of Moreno Valley's, was almost 11 rapes per 10,000 residents compared to 1.6 in Moreno Valley.

Overall, violent crime, including homicides, rose 6.6 percent in the areas covered by the Sheriff's Department. The percent change for the city police departments ranged from a 4-percent decrease in Cathedral City to a 26-percent jump in Murrieta.

The Sheriff's Department reported that violent crime increased 18 percent in the unincorporated areas of the county. In Canyon Lake and Eastvale, which contract with the Sheriff's Department for law enforcement support, violent crime decreased 46 percent and 32 percent, respectively. At the other end, San Jacinto saw a 32-percent increase in reported violent crimes. Hemet, which has its own police force, reported a 30-percent increase in violent crimes.

Eleven homicides occurred in Hemet and 12 throughout the unincorporated areas.

Property crimes, which include residential burglary, commercial burglary, larceny or theft and vehicle theft, also grew in the past year. In the unincorporated portion of Riverside County, property crimes were up 14 percent, but only 7.4 percent in all areas within the sheriff's responsibility. The incorporated cities saw property crimes decrease 9 percent in Beaumont, but up 2 percent in Hemet and 25 percent in Murrieta.

There were 742 burglaries in Hemet, which was 19 percent fewer than in 2014, and 369 burglaries in San Jacinto,

which was 22 percent fewer than a year ago. The whole unincorporated areas of the county saw a 5-percent decrease.

However, larceny and vehicle thefts were up in Hemet and the unincorporated areas. These crimes include theft from vehicles and shoplifting. Public-safety officials believe the former are related to identity-theft crimes.

There were nearly 440 more vehicular thefts in 2015 than 2014, a 42-percent increase.

The National Insurance Crime Bureau notes that auto theft is on the rise all across the United States, yet there is no identifiable reason. Riverside County mirrors the national trend, in that the Honda Accord and Civic, Ford F-Series and Chevrolet Silverado trucks, and the Toyota Camry are among the vehicles most at risk for theft, according to the sheriff's press release.

Specific data were not available for the Idyllwild area, but Hemet Station Capt. Joe Borja stressed that in a community as small as Idyllwild, one or two individuals on a spree can create a sudden and abnormal spike in the crime statistics.

For example, overall crime rates were down a little in 2015 compared to 2013 and 2014, he said. "But burglaries were up from 2013 but about the same in 2014 and 2015," Borja added. "Auto theft nearly doubled and that's probably due to one or two individuals."

But he stressed that crime is low on the Hill when one compares the absolute number of crimes to these other areas.

The sheriff's press release also emphasized that the Board of Supervisors has limited patrol staffing in the unincorporated areas during the past two years.

"In contrast, the contract city partners [can] each staff their cities in accordance with their own desires," which can influence responses and investigations, he added.

These data were the preliminary figures each jurisdiction reports within 10 days of the end of each month. However, the actual number of crimes might change for several reasons. For example, an investigation might find that the crime report was unfounded or it occurred in a different jurisdiction.

In the preliminary figures, Murrieta reported nine rapes and 308 burglaries. The city's final figures were six rapes and 288 burglaries. So the actual data may be revised.

## Voter registration growing with primary election approaching

### Secretary of State warns of surge for June 7 election

California's Secretary of State Alex Padilla is forecasting a large surge in the number of voters for the June 7 presidential primary.

Last week, he wrote to both Gov. Jerry Brown and county officials urging them to prepare for an unexpectedly large turnout. Padilla's warning is based on the significant increase in the number of online voter registrations that have occurred and demand for registration cards.

"For example, in just the past three months, more than 600,000 California citizens have used our online voter registration site to register to voter, or update their registration," Padilla said in his letter to Brown.

According to the Riverside County Registrar of Voter's Office, the county registration has increased by 20,000 voters since January. There are now 865,000 registered voters in Riverside County and the 3rd District continues to be the largest with nearly 185,000 registered voters.

As of Jan. 5, the last reporting date for statewide registration, registered voters were 17.3 million compared to 17 million four years before and only 15.5 million in 2008.

"Given the increase in public interest in the upcoming presidential primary election and the rise in the number of online voter registration applications, it is anticipated that voter turnout in the June 7, 2016, presidential primary election could significantly increase as a result.

"Therefore, the Secretary of State's office urges that you plan accordingly to ensure your county has an ample number of ballots, including any required multilingual ballots and other voting materials, available at your office and at the polls on election day," Padilla said in his letter to state county election officials, urging them to prepare for the upcoming elections.

Riverside County Registrar of Voters Rebecca Spencer confirmed that her office had already initiated efforts for a large turnout.

"We are seeing an increase in voter registration cards and are expecting a higher turnout," she said in an email to the Town Crier. "We are hiring extra temporary staff to keep up with the demand of resources for the June election ... We have planned for a higher turnout in our current budget and will monitor our current budget closely and advise the Board of Supervisors accordingly."

The Registrar's Office is encouraging voters to vote by mail and return their ballots early to take some of the pressure off the polling places and allow for a large number of votes to be released in the first election results update shortly after 8 p.m. on election night.

## Supervisors want to turn county budget around

### Spending cap imposed until changes found

With little debate, the Riverside County supervisors recently approved spending \$18 million in a search to save a hundred million or more.

County Executive Officer Jay Orr warned the board in January that the fiscal year 2016-17 budget, which begins July 1, would suffer from a \$90- to \$100-million deficit. Some of this spending is the natural progression of negotiated salary increases and continued structural problems, but \$40 million is the result of a recent settlement for litigation over inmate health and mental health care.

Tuesday afternoon, the supervisors listened to Orr, County Finance Director Paul McDonnell and representatives from KPMG, the consulting firm hired to assess the county's criminal justice agencies — Sheriff, District Attorney, Probation and Public Defender.

Orr began the session with a history lesson that started with a discretionary budget level of about \$800 million 10 years ago that has fallen to about \$650 million now. While the county budget has recovered, Orr said the prisoner lawsuit was the "tipping point." The county cannot find \$40 million in its budget without seriously threatening its reserves, he stated.

Unless the board took action, McDonnell asserted that the county's reserves will likely fall 90 percent from

more than \$225 million to less than \$25 million by the end of fiscal year 2019-20. The first step must be a cap on future spending until long-term savings and changes can be identified and implemented, he stressed.

"Capping spending is essential to getting back on the track to fiscal sustainability," he said. "Finding savings in the public safety budget is essential."

As departments begin preparing their 2016-17 budget, Orr and McDonnell have told them to assume no increased funding. The lone exception will be the Sheriff's Department, whose budget will be "adjusted to the reflect the fiscal 2015-16 deficit. In addition, a balanced budget will consume \$29.1 million of the county's reserves.

Not only will KPMG begin to assess the 50 recommendations in its initial report, but Orr requested an evaluation of the other county departments, too. Implementing the criminal justice agency recommendations will cost the county \$15.7 million and take about two years.

The supervisors did not hesitate nor question Orr's recommendations. The board was supportive and hopeful of the effort. Supervisor John Tavaglione (2nd District) said, "This will change a culture. We're going to gain efficiency and more effectiveness."

First District Supervisor Kevin Jeffries added, "This is a long overdue, badly needed reform — reform no one ever imagined. It sets the stage of really incredible work as we go forward. It will bring the budget and reserves into balance."

But he did question the ultimate costs, including future investments for new computer systems.

# HUSD seeking new superintendent

## Community thoughts part of decision process

Consultants from McPherson and Jacobson, LLC, the firm helping the Hemet Unified School District search for a new superintendent, sought the Idyllwild community's thoughts about the search and selection process.

Although the April 6 session was open to the public, only a small group, less than 10, came to share their opinions with Ben Johnson, a director at Alvord Unified School District, and Dennis Murray, the former Perris Union High School District superintendent.

The consultants were seeking comments and response to four questions:

- Tell us something good about the HUSD community.
- Tell us some good things about the school district.
- What are the issues that a new superintendent should know about as they begin?
- What are the characteristics, attributes and skill that the next superintendent should possess to be successful?

The comments and suggestions from this and the other sessions would be shared with the HUSD board

as they consider the selection of the next superintendent, Murray stated.

The first two questions sought ideas that could be used to attract potential candidates to the district, they said.

While most of the district is located in the Hemet Valley, Beth Swanson, Idyllwild School office manager, noted that the areas from Idyllwild to Hamilton School offer unique situations and perspectives, including snow and the absence of traffic lights, that provide variety to the district.

Principal Matt Kraemer stressed that Idyllwild School is balanced and well-rounded. The school curriculum and activities include art, music and sports, including a good relationship with Idyllwild Arts.

And everyone agreed that Idyllwild School serves as a hub of the local community.

In response to the second question, the group stressed the success of HUSD's work to integrate technology into the curriculum as well as workflow. And Murray concurred, "Your technology is head and shoulders above other districts."

"The superintendent should recognize that our needs are sometimes different than down the Hill," Kraemer said. "There is a lot of community involvement here."

Another participant observed that HUSD has a large range of socio-economic demographics. Kraemer confirmed that he has observed a rise in the poverty rate during his 18 years with HUSD.

The third question elicited a comment noting that

the district had just negotiated new contracts with the teaching and support staffs.

This led to comments stressing that the new superintendent should possess strong "people" skills to maintain good relations with both the unions and community stakeholders.

The group also recommended someone with classroom experience rather than just an administrative background. Finally, Kraemer would prefer a manager who can recognize the different needs of the district's schools rather than one rule or formula applied across the board.

As the session finished, Johnson shared that many very qualified candidates had already reached out preliminarily. But he has stressed that the district needs a leader who will be "here awhile, not just two or three years."

Idyllwild was the ninth public meeting McPherson and Jacobson had scheduled and they were headed to Anza for an evening session the same day.

The next step is the application deadline on April 19. In early May, Johnson and Murray will meet with the board to develop a short list of candidates. The interviews are tentatively scheduled for May 10 and 11. A decision is expected at the May 17 board meeting.

## Waze, the user-fed traffic app, pairs with Caltrans

In a statewide move, Caltrans announced Tuesday, April 5, it would provide road condition, repair and potential closure information on state roads to Waze, the user-fed real-time traffic app.

According to the Mountain View, California-based company, Waze has more than 1.7 million active users per month in the Los Angeles metro area contributing more than 2.5 million alerts per month in real time, regarding such as potholes and crashes. Drivers, or their passengers, feed information to the Waze app as they observe traffic hazards, construction, collisions and other incidents likely to affect driving times and routes. In metropolitan San Francisco, 678,000 monthly users contribute nearly 970,000 alerts per month.

"Waze is only as strong as the information it receives from its users," said Paige Fitzgerald, Connected Citizens program manager at Waze. "The immense data Caltrans can contribute to the Waze app makes them a valued partner moving forward."

Under this agreement, Waze will share with Caltrans the free, anonymous traffic and incident report data from Waze users. The data will provide real-time travel information on California's roadways provided by Caltrans' Quick Map. Waze, in turn, will receive Caltrans' road condition reporting data to share with its users.

## Mosquito problems for travelers

California Department of Public Health Director and State Public Health Officer Dr. Karen Smith is urging Californians to protect themselves against mosquito bites if traveling to Mexico or Latin America, where there have been increased reports of the mosquito-borne diseases chikungunya and dengue. Travelers should also be aware that there is currently transmission of dengue on the Big Island in Hawaii, and precautions against mosquito bites are advised; there are no reports of dengue transmission on the other Hawaiian islands.

Chikungunya is a viral disease characterized by

acute onset of fever and severe joint pain. Dengue, another viral disease, is characterized by high fever, severe headache, muscle and joint pain, rash, and in severe cases bleeding manifestations. For both, treatment is supportive, the disease is not contagious person to person, and there is no vaccine.

CDPH recommends that travelers prevent exposure to mosquito bites by wearing protective clothing and applying insect repellent containing DEET, picaridin, oil of lemon eucalyptus, or IR3535 according to label instructions. DEET can be used safely on infants and children 2 months of age and older.

Jazz aficionados will mark their summer calendar for the 23rd-annual Jazz in the Pines, which is Aug. 19 to 21.

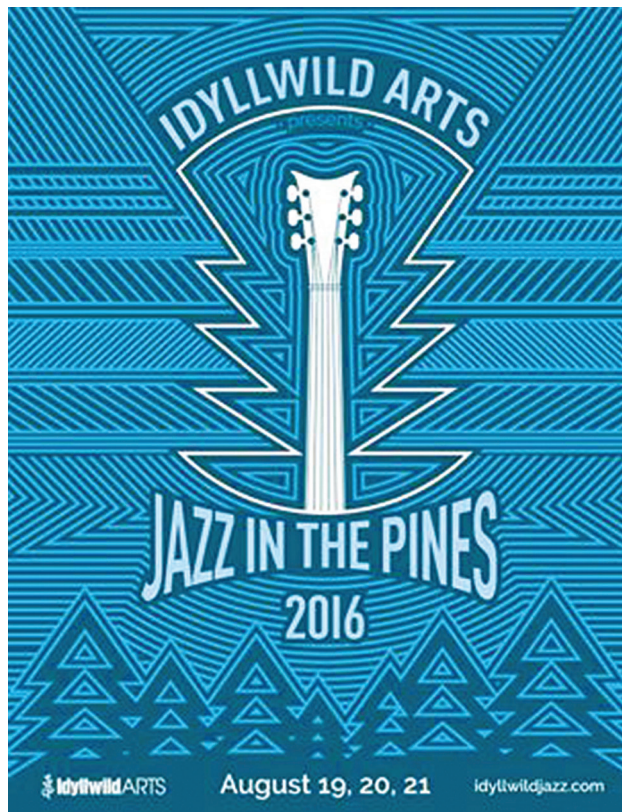
Many favorites, such as Casey Abrams, Chuck Alvarez, Graham Dechter, Yve Evans, Lisa Haley, Greg Jones and Harry Pickens, will return and perform over the weekend.

Two important jazz figures also will return to the Holmes Amphitheatre stage. Jazz vocalist Diane Schuur, who appeared here in 2013, and Richie Cole, who performed at the first Jazz in the Pines in 1994, will be among the featured performers Saturday and Sunday. As he has done in the past, Idyllwild's Abrams will close the Festival Sunday afternoon in the amphitheatre.

"Something special is in the works to feature Richie Cole on Sunday," said John Newman, chair of the 2016 festival and director of Business Operations for the Idyllwild Arts Foundation. "I've had my eye on Diane Schuur since last year. It's great to bring her back."

Besides the many popular and familiar artists, Newman continues to strive to produce both diversity and something new. This year the new acts include the Lori Bell Quartet, The Westerlies, Gregory Page Show, Los Hermanos Arango and Besos de Coco.

"We will continue to offer a variety of jazz styles,"

Newman promised. "Marshall [Hawkins] and I wanted to feature more women of jazz."

Besides Diane Schuur, two-time Grammy winner for best jazz vocalist, Idyllwild Arts alumna Nora Germain, a jazz violinist, will appear Saturday with the Seahawk

Modern Jazz Orchestra.

Bell, of San Diego, is a jazz flutist and her bassist is Katie Thiroux.

The Besos de Coco is a trio of female musicians. Lorraine Castellanos is the guitarist and sings, Evona Wasinski is the bassist and percussion is provided by the tap dancing of Claudia Gomez Vorce.

"This is an up-and-coming group," Newman said. "Gomez Vorce tap dances the rhythm."

As always, the jazz fest continues to spotlight jazz's various genres. Los Hermanos Arango, a seven-piece group, will offer a combination of Cuban and Afro music.

Once again, a Django Reinhardt-style group, Hot Club of Los Angeles, will be performing in the French Quarter. Reinhardt, born in Belgium, was a French guitarist who originated the popular European jazz style associated with the French gypsy culture. After World War II, Reinhardt toured in the U.S. playing solos with Duke Ellington's orchestra and in Carnegie Hall.

The Westerlies, a New York-based brass quartet, will be coming from an appearance at the Newport Jazz Festival. All four musicians are from Seattle.

"I'm enjoying year two [of chairing the festival]," Newman said. "It's not Idyllwild Arts in isolation. I am very pleased that everybody is back and helping."

Newman stressed that the success of Jazz in Pines is its traditional collaborative nature. It depends upon the town, the Associates of Idyllwild Arts Foundation and the hundreds of individual volunteers, many of whom are already working and preparing for the August event.

The Patrons Dinner and Dance again will open the festival and Gilbert Hansen, bass guitarist, will provide the evening's music. That will be Friday, Aug. 19. The Patrons' package will cost \$350 this year. Besides the dinner and tickets for both Saturday and Sunday, this year it includes a Patrons'-only admission to the Seahawk Modern Jazz Orchestra performance Saturday evening in the new William M. Lowman Concert Hall.

Tickets for Saturday and Sunday are currently available online at idyllwildjazz.com and sales are 20 percent ahead of 2015, according to Newman. Ticket prices are \$70 each day or \$130 for a pair until May 1, when they increase.

# Lewis returns as Town Hall recreation director

Bob Lewis, former Town Hall recreation director under the Idyllwild Community Recreation Council, returned Friday, April 1, to a slightly reconfigured job.

Lewis, a long familiar presence in community recreation, was hired by the Riverside County Parks and Open Space District, the current recreation managers under contract with the county. He began a one-year probationary period. Lewis will have full authority to manage and hire staff, according to Kyla Brown, Parks and Open Space recreation bureau chief.

"It feels surreal to be back. What we're trying to do is provide stability for the community, and we'll make this work," said Lewis. "I want to make a difference."

POS took over recreation management from the county's Economic Development Agency on July 1, 2014. Prior to that, EDA directly managed recreation in Idyllwild after having terminated ICRC's recreation contract with EDA on July 31, 2011. POS' tenure has been rocky, eliciting complaints from local recreation users that centered upon the agency's reputed failure to understand or adequately respond to the community's recreation needs.

In a rewind and repositioning move aimed at returning stability to and local confidence with the program, EDA will again directly manage Town Hall recreation beginning July 1, 2016.

"As long as the community is served, that's all that matters," said Brown about the change in management.

What that means for Lewis' tenure in Idyllwild will depend upon EDA, County Supervisor Chuck Washing-

ton and the newly constituted County Service Area 36 Advisory Council, a five-member board who is the liaison between Washington and the community regarding Idyllwild street lamps and recreation.

Brown said EDA, as new employer of record, would have to determine whether to affirm Lewis' tenure, or search for a replacement. She indicated if EDA were to decide not to affirm Lewis' appointment, he would likely continue his employment with POS, but would be moved to another posting.

The issue of "local control" of CSA 36 recreation has long been a flashpoint among recreation users. Lewis, should he be retained by EDA after July 1, would be a local face, with longstanding ties to community recreation management. Lewis' job would likely be different from working for a local recreation contractor such as ICRC, since he would be employed directly by the county.

On Tuesday, April 12, the county Board of Supervisors approved 3rd District Supervisor Chuck Washington's recommendations for the appointment of five members to the CSA 36 Advisory Council. The council acts as the "eyes and ears" of the supervisor on matters of recreation and street lights within the district. As part of that function, it holds public meetings. If approved, the new council will begin public meetings after EDA takes over recreation management from POS on July 1. The five recommended members are John Metroka Jr., Wendy Read, and Kathy Wilson for full terms ending on June 30, 2018, and Ginger Dagnall and David Hunt for one-year terms ending on June 30, 2017.

## Plants and wildflowers walk

David Bramlet and Patrick Temple, botanists and rare plants of the San Jacinto Wildlife Area specialists, will introduce you to the main plants of the coastal sage scrub, grasslands, riparian and wetland habitats of the SJWA.

Plants along the walk may include the San Jacinto Crownscale, Spreading Navarretia and Threadleaved Brodiaea, all rare plants hard to find outside of the SJWA.

You will learn not only the plants, but also the soil type and moisture regime of each of their unique habitats and their relationships to each other.

The walk is from 9 a.m. to noon Saturday, April 16. Meet at SJWA parking lot, 17050 Davis Road, Nuevo. This walk is not in the San Jacinto Mountains.

All walks are free and open to everyone. No reservations are needed. Children are welcome. Binoculars and birding books are provided. Wear comfortable shoes, hats and sunscreen and bring water, snacks and binoculars, if you have them.

## A healthy mind in a healthy body

You are better off taking the stairs up to your next class, particularly if you are an older American out to improve your knowledge base and protect your brain, according to the Association of Mature American Citizens.


Canadian researchers found that "education and physical activity affect the difference between a physiological prediction of age and chronological age, and that people can actively do something to help their brains stay young." Their study has been published in the journal, *Neurobiology of Aging*.

Jason Steffener, the lead author of the report, said the focus of the study was the positive effects of low-impact exercise such as climbing stairs on brain health. "In comparison to many other forms of physical activity, taking the stairs is something older adults can and already do at least once a day, unlike vigorous forms of physical activity."

## Pet owners beware

Every pet owner will tell you about the benefits of bonding with a dog or a cat, says the Association of Mature American Citizens. It's good for the heart and for the soul.

But the Centers for Disease Control reports that there's a downside to pet ownership. A CDC study indicates that tens of thousands of Americans wind up in the emergency room each year with injuries resulting from trip and fall accidents involving dogs and cats.

# Rick Barker next for ICC Speaker Series

## Explores the future of art

Richard Barker is not a painter or a visual artist. But he has developed a theory about how art can influence and shape us. In his talk, Barker will review recent history and the future direction of art, using painting as the medium for his discussion. Barker speaks as part of the Idyllwild Community Center Speaker Series from 6 to 7:30 p.m., with a reception at 5:30 p.m., free to the public at the Creekstone Inn, Thursday, April 21.

"Music, literature, paintings and films play such important roles in our lives. What need in us is fulfilled by art as nothing else can?" asked Barker. He believes that art has long had the ability to lift us, to inspire us and to cause us to experience a state of shared sublimity.

His 2014 book, "Transcending Evolution: A Christian Guide to Understanding, Accepting and Transcending Evolution," is an examination of how, with awareness and recognition of our long-held personal patterns, we can overcome hard-wired perceptions and consequent choices. Using his understanding of neuroscience, Barker also will show how awareness of our hard-wired patterns can open us to a wider appre-

ciation of art and a greater connection with our fellow humans.

"Every painting is an invitation to linger a while and take a closer look, which rekindles your connection with the external world and with others," said Barker. "If I focus on the differences in another's story, that can be distancing," he said. "But if I choose to focus on what we share, that can promote a sense of connection."

Barker believes current trends in art are creating distance rather than connection. "The history of fine art painting reveals that over the centuries, artists developed ever better techniques for rendering the world and humanity's place in it," he noted. "But the mid-1800s saw the beginnings of a radical shift in the intent of the artist — focusing less on the external world and more on the artist's internal impression or reaction to the world. Many modern painters completely ignore the external world altogether. What caused this shift? Where will art go from here?"

In his presentation, Barker will diagnose a current trend in art away from using the external world and our shared humanity to bring us together, to a post-modern trend toward fragmentation and "anything goes" pluralism — accentuating differences in our personal stories rather than commonalities.

For Barker, finding commonalities in the external world we share leads to empathy and understanding. When artists begin to ignore the external world and our common experiences, the result is a cultural moment with less empathy for and connection with others. He believes that is what is happening in the post-modern movement in art. He sees current trends in art as a reflection of growing fragmentation in our social structure and political discourse, "I think post-modernism is an accurate reflection of this age and my question is, 'What has happened to us?'" he posited.

As part of his presentation, Barker will feature paintings of a local artist, Michael Newberry, as an antidote to what he sees as current ego-based and divisive trends in art. "I developed my theory of art back in the '90s," he said. "I did not know which direction art would take in the future, but I did know the direction I hoped it would take. But after 20 years of waiting, I was starting to lose hope of it happening in my

lifetime."

Barker will feature Newberry because his paintings mirror the direction Barker had hoped art would take — celebrating humanity's place in the external world and elevating the viewer's experience to one of sublimity.

"None of our global problems will be solved from the top down," said Barker. "Meaningful social change can only happen from the bottom up so that people feel more connection and more commonality."

There is no charge for Barker's presentation and everyone is welcome to attend.

# This year, lilacs will peak just at the right time

Planning a Lilac Festival in spite of the vicissitudes of climate and weather patterns is a perilous endeavor.

Just ask Gary Parton, who has fathered this celebration since 2009 and continues to propagate and promote Idyllwild as a lilac tourist venue. Each year, Parton and his committee set the date for the festival, hoping the lilacs will bloom neither too early nor too late.

The good news is that this year, owing to a recent turn of colder-than-expected weather, lilacs at Parton's Alpenglow Gardens will peak during the festival's premiere event — the annual Victorian Lilac Tea, Garden Tour and Art Alliance of Idyllwild exhibit.

"Some are already blooming," said Parton on Monday, April 11. "But they'll probably be at their peak on Saturday, April 23, the day of the tea."

This year's events begin on Saturday, April 16, at the Idyllwild Library from 10 a.m. to 1 p.m. From 10 to 11:30 a.m., there will be a speaker and demonstration of cutting and arranging lilacs. After the demonstration, a lilac will be named after an Idyllwild personality, a contest that will be repeated until all of Reva Ballreich's unnamed varietals have been named. Selection of this year's recipient was made by Parton's seven-member committee. (Ballreich, who died in 2009, was widely known as "The Lilac Lady." She planted, hybridized, cultivated, and eventually displayed more than 887 lilac varietals on her Idyllwild property.)

Also on Saturday, from 11:30 a.m. to noon, a demonstration showing six ways to grow lilacs will be offered. Then from noon to 1 p.m., there will be a walking tour of lilacs in town — all of which were planted by Parton and his supporters.

From 1 to 4 p.m. Sunday, April 17, Parton's Alpenglow Lilac Gardens will be open to the public for lilac viewing. David Jerome provides music and refreshments will be available.

Finally, from 10:30 a.m. to 3 p.m. Saturday, April 23, are the Victorian Tea and guided garden tours. Guided tours explain the many varietals and their histories in Parton's acre garden site. Guided tour tickets cost \$5 at the door and tours run during the hours the gardens are open, concluding at 3 p.m. The Victorian Tea is served from 11 a.m. to 2 p.m. Tickets are available at the door for \$20 or by reservation at [www.idyllwildgardenclub.net](http://www.idyllwildgardenclub.net). The \$20 ticket includes a guided tour of the gardens. For more information, visit the Garden Club website or call Parton at 951-659-9711.

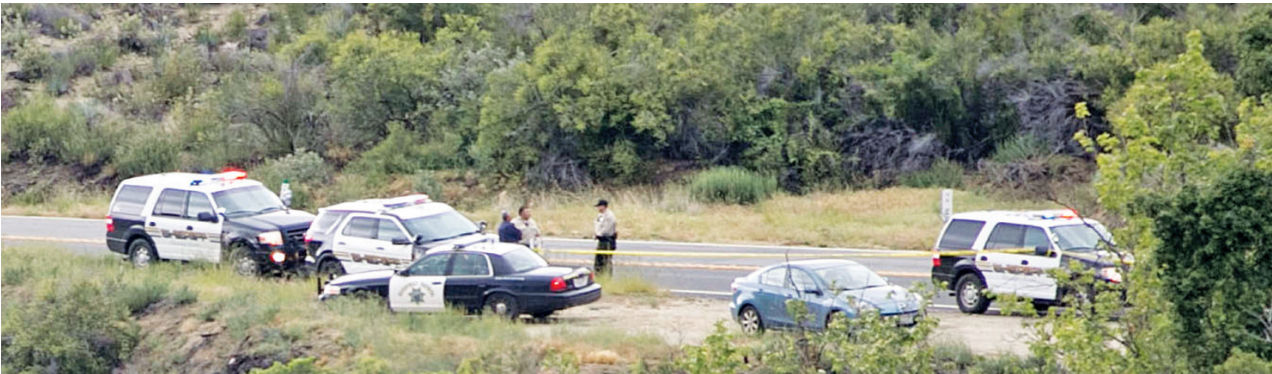
unclear how the person died.”

Based on modeling of the power grid and the natural gas supplies, the four agencies believe gas shortages to power plants this summer could result in 14 days of interrupted service to Southern California utility customers.

“Southern California Edison generates about 15 percent of the electricity it provides to customers with the remaining 85 percent purchased from independent power producers,” SCE said in press release issued after the Action Plan’s release. In 2014, about a quarter of its power came from natural gas and in 2013, it was more than 40 percent.

and what is needed, and that is when you might have a power outage.”

Cushnie assured customers that SCE will do everything it can to minimize the effect of natural gas storage issues on the reliable delivery of power, including contracts for electricity resources outside of Southern California. He encouraged customers to help the situation, too, by participating in conservation programs.

The draft Action Plan proposed 18 recommendations “to reduce the possibility of electrical interruptions.” Besides greater energy conservation, the draft plan recommends that 15 billion cubic feet of natural gas still stored in the Aliso Canyon facility should be available during peak demand this summer.

“SCE and other electric generators order gas the day before based on forecasting,” said Colin Cushnie, SCE vice president, for Energy Procurement and Management. “When an electric generator’s forecast is wrong — that could occur if temperatures are higher than forecast and customer usage is higher than expected — then you have an imbalance between what is available

The agencies, which prepared the report, were the California Energy Commission, California Public Utilities Commission, California Independent System Operator, and the Los Angeles Department of Water and Power.

week’s measurements were disappointing since many “... had expected to benefit more than [they have] from El Niño conditions.”

Water savings

Last week, the State Water Resources Control Board reported, “Californians came just shy of meeting Governor Edmund G. Brown Jr.’s 25 percent water conservation mandate” since June.

Between June 2015 and February 2016, water production declined by 1.2-million-acre-feet or 23.9 percent compared to the same nine months in 2013. This amounted to 96 percent of the 1.24-million-acre-foot goal.

“Twenty-four percent savings shows enormous effort and a recognition that everyone’s effort matters,” SWRCB Chair Felicia Marcus said in the press release. “Californians rose to the occasion, reducing irrigation, fixing leaks, taking shorter showers and

saving our precious water resources in all sorts of ways.”

Locally, the customers of all three water districts have reduced their consumption in the past nine months compared to the same period in 2013-14. The greatest fall was Fern Valley Water District, where production was down 22 percent.
