# Idyllwild Fire and San Jacinto proposing joint fire agency

Joint public meeting later this month

The Idyllwild Fire Department is in discussions with the city of San Jacinto to provide fire and emergency medical services to the city. Currently, Riverside County Fire Department provides these services to San Jacinto.

In a press release late Monday afternoon, Idyllwild Fire Chief Patrick Reitz said, "... joint discussions are currently taking place with the administrations of the district and city to form a Joint Powers Authority for the purpose of providing fire protection and EMS services to the citizens of San Jacinto."

"This is a big deal, very big," Reitz said Tuesday. And he stressed that neither the San Jacinto city nor the IFPD commission has yet endorsed nor approved the idea. "The two boards will discuss its formation and make changes to the draft document.

"Earlier in the year, it started with a casual comment and evolved into more detailed discussions later this year," he stated.

San Jacinto and the Idyllwild Fire Protection District will schedule a joint meeting later this month to discuss this idea, according to Reitz, who has been in private discussions with San Jacinto City Manager Tim Hults.

Job descriptions for fire captains, engineers and firefighters for the JPA, as well as job application forms, are already posted on the IFPD web site. None of these documents inform the applicants assert that the joint powers See Fire agency, page 28



# **Driver** in death of child arrested

The driver of the Porsche that went over the side of Highway 74 Sunday morning and resulted in the death of a 5-month-old child was arrested and booked at the Robert Presley Detention Center, Thursday, May 5.

Marcus Novell Green, 51, of Thermal, was charged by the district attorney with murder with malice aforthought and willful child cruelty. The California Highway Patrol arrested him on Wednesday and booked him Thursday. Green's bail was set at more than \$1.8 million. His initial hearing was Friday, May 6, and there is one scheduled for May 17.

With him in the car was Kristen Lauer, 22, of Rancho Mirage and a 5-month-old girl, identified by the Riverside County coroner as Armani Green, who died at the scene. His 2015 Porsche 911 coupe went over the side of Highway 74 near Vista Point above Palm Desert.

He and Lauer suffered injuries and were transported to a local hospital. The Porsche was two-seater, and it is not clear where the child was located before the car went off the road and down 200 feet.

# 9th century California trademarks

California Secretary of State Alex Padilla announced the release of nearly 4,000 digitized California trademark images and applications filed with the secretary of state between 1861 and 1900. These images and documents are the largest digital collection ever assembled by the State Archives, a division of the secretary of state's office.

"This is our history and it should be shared," said Padilla. "I encourage Californians to explore these images, which for the first time are easily accessible to the public online.

According to the California Highway Patrol, a solo-vehicle traffic collision occurred on Highway 74 near mile marker 52 about 5:30 p.m. Tuesday, May 3. The single occupant was driving eastbound when for an unknown reason, lost control of the silver Chrysler, smashing into the mountain on the westbound side of the highway. Highway 74 was closed in both directions for about one hour as Riverside County Fire used the jaws of life to extract the driver. The victim was transported by American Medical Response to a local hospital with unknown injuries.

# Mountain Center Market burglar sentenced to state prison

Nickolas Melendez, 27, of Cabazon, one of two men who pleaded guilty to burglary of the Mountain Center Market in September, was sentenced to two years and eight months in state prison.

Judge Mark Mandio dispensed the sentence Friday, May 6, nearly a week after Melendez missed the original sentencing hearing.

Melendez had a prior conviction that Mandio said qualified as a strike; however, he imposed a lower-term sentence.

Ryan Mason, 25, of Hemet, who also pleaded guilty, has undergone an evaluation for possible residential substance-abuse treatment prior to the felony settlement conference. Mandio requested the Riverside County Sheriff's Department Corrections Division to conduct the assessment. As a result of the report, Mason's sentencing is scheduled for Sept. 26 while he completes a program.



# Late spring rains beating average and forecast

The promised historic El Niño rainstorms may not have appeared in Southern California, but the recent spring rains are trying to overcome the image of a totally weak or missing El Niño.

During April and May, the U.S. Forest Service's Keenwild Station has had nearly 3.5 inches of rain and Pine Cove has recorded about 3.25 inches of rain and a quarter inch of snow. Historically, the Hill has received about 2.75 inches of rain during these two months. Although most of May could bring more rain, the forecast for the remainder of the month is dry.

Nevertheless, total rain at Keenwild has been 21.3 inches, the most precipitation on the Hill since 2011. And

# 2.8 magnitude quake Thursday night

A second in the past two weeks of a near-3.0-magnitude earthquake occurred at about 11:20 Thursday

The tremor was about 7.5 miles west of Idyllwild and 4 miles southeast of Valle Vista. It was located on the San Jacinto Fault on Rouse Ridge.

Initially, the quake's magnitude was estimated to be 3.2. While no damage has been reported, it was felt in Idyllwild and as far south as Carlsbad and east to Sun

On Monday, May 9, another quake, magnitude 2.5, occurred only miles northwest of the larger quake.

Pine Cove has reported nearly 25.25 inches, which is less than half an inch less than the long-term annual rainfall.

Public Information Officer Darren Meyer, California Highway Patrol, said (regarding Hill roads), "Caltrans had their plows out because of debris on the highways carried by fast flowing water."

During the year ending June 30, 2011, the Hill recorded more than 29 inches of rain, the only year in the past decade that has exceeded the annual historic average of 25.7 inches.



By all indications, I believe that Idyllwild Fire commissioners and the San Jacinto City Council knew about and condoned the Joint Powers Authority to provide fire protection service to a population about 20 times larger than Idyllwild.

The IFPD chief claims he and the SJ city manager put their heads together on this thing on a casual basis, but what's happening now is anything but casual. According to documentation on IFPD's website, the JPA already appears in place.

These two staff members cannot set up a JPA without authority from the public's elected officials in both communities.

We know this: Top heads, including Supervisor Washington and the county PIO, know about this deal.

We know at least two commissioners knew about the deal but won't discuss it. Another commissioner won't return a phone call or email.

But neither government agency shows anything about a JPA on any of their agendas.

It takes a great deal of work to create a JPA. So you're telling me that both boards are just getting the news like we did through a press release? That's difficult to believe.

Are they going to say next month to their boards, "Hey, here's this great idea we've already put in place. We just need you to rubber stamp it and we're on our way." No, they must have had board authority outside of an open hearing before the public, we think.

Next month you, too, are invited to come down to a meeting, perhaps in San Jacinto, to hear all about something that's been behind closed doors and looks like a done deal. So are the San Jacinto citizens.

To us, this implies that both boards violated at least the spirit of the Brown Act, the state's open meeting law, by not fully disclosing this was in the works.


# Advice from a past **CSA 36 member**

# Washington wants to keep county board seat

Editor's note: The seat for Riverside County's 3rd District supervisor is on the June 7 primary ballot. Three candidates are seeking the seat Chuck Washington currently holds. The two challengers are Randon Lane of Murrieta and Shellie Milne of Hemet. The top two vote getters will compete on the November ballot and the winner will be the next supervisor.

The Town Crier has interviewed each candidate. (See next three pages.)

In March 2015, Gov. Jerry Brown appointed Washington to fill the remainder of former Supv. Jeff Stone's term after he was elected to the state Senate. All three have city council experience. Washington served on the Murrieta and then the Temecula city councils. Lane is on the Murrieta City Council and serving his second term as mayor. Milne is currently on the Hemet City Council.

Although Chuck Washington has been Riverside County 3rd District supervisor for 14 months, he is no stranger to elections and politics. From 1995 to 2000, he served on the Murrieta City Council and from 2003 to 2015, when he was appointed to replace 3rd District Supervisor Jeff Stone, he served on the Temecula City Council. During his time on both councils, he also served

as mayor of the cities.

Serving as supervisor has been an education, according to Washington. Not only has he had to learn about the issues confronting the district, but the special challenges to each part of the district, as well as the broader issues confounding the entire county.

This opportunity to see and to wrestle with both the comprehensive and the specific issues has been hugely beneficial, Washington said. "Neither challenger has had the chance yet."

Washington, a Democrat, describes himself as a fiscal conservative and believes achieving a balanced budget is the biggest issue facing the board. "We need to keep tight reins on the purse strings," he stressed. "The Board of Supervisors controls the purse strings and we need to

manage the purse strings better.

"The 3rd District is part of the whole county and there is no way the 3rd District survives when the county sinks," Washington emphasized. "We need to stop the bleeding."

The growth of county staff salaries is a result of agreements between the board and unions prior to him joining the board, going back to 2012, according to Washington.

But Washington is not single-minded. New spending may be necessary and productive if it originates from the same thinking as occurred at the county medical center in the past two years. The center has eliminated its consistent annual deficits and looks for programs or equip-

ment that will ultimately save money. "We're at same place if we need to reorganize. We should see more efficient spending of public funds if that will provide a return on investment," he added.

Washington is looking forward to the results of KP-MG's study of the county's criminal justice system. "In 18 to 24 months, we should find significant savings," he said.

He also stressed his time on the Temecula City Council that prepared him for the budget analysis and work on the board. "It is not just cutting red ink," he said. "Those challenges created a difference between me and Lane and Milne. I've supported job creation and economic development."

Washington pointed to the core values he supports. They begin with creating a safe community and helping the economy thrive, which is what he will promote for Idyllwild — economic development and quality of life.

Law enforcement and fire safety are also important components that define the Hill's quality of life, he noted. But transportation and roads are critical and need to be maintained. The local infrastructure is stressed more than other areas in the county because of the seasons felt here.

Then he stressed, "It is not just roads which are the challenge. We need to help water districts maintain enough water to support economic development."

"Idyllwild is probably one of the most interesting places in the entire district," he observed. "Families, children, baby boomers, business owners all like their independent spirits but are looking to just do something useful in the community. They are happy to be there. And when they see things to do they step up and do it. Very few have their hands out."

# Milne unworried about Washington's and Lane's campaign coffers

# She has as much as she needs

Randon Lane of Murrieta and Shellie Milne of Hemet, who are challenging Riverside County 3rd District Supv. Chuck Washington in the June 7 primary election, have taken diametrically different paths to financing their campaigns. The top two vote-getters will face off in the November general election.

Washington has raised a total of \$325,000 in contributions, of which \$77,000 (or about a quarter) has been received since Jan. 1. While Lane trails in dollar amounts, his pattern is similar to Washington's. Lane has received about \$207,000 in total contributions and also about 25 percent or \$48,000 between Jan. 1 and April 23.

But Milne has taken a very different approach, unlike the traditional politicians. She developed a budget for her campaign shortly after deciding to enter the race. She figured out the cost of signs, ads and other campaign essentials. She sought donors who could help finance this budget and manages the campaign with only these resources.

By Dec. 31, she had raised about \$150,000, which still significantly trailed Washington but was about equal to Lane's pre-2016 contributions of \$160,000. Since Jan. 1, Milne has reported total contributions of \$5,350.

"That is all I expect I'll need," she said. "If I go on to the November election, I'll be developing another budget the morning of June 8."

Also, she emphasized her skepticism about campaign finance legislation. In general, she sees political contributions as a form of free speech and abridging it should be done care-

fully and thoughtfully.

Consequently, she has no interest in collecting more money than she needs. She does not desire to carry surplus contributions forward for another race, another year or another purpose. To her, that is another form of abusing the system.

If she were to need more money, Milne is confident she could raise it. And she also noted that with less than a month before the election, new contributions would not be secret since they have to be reported within 24 hours.

At this point in the campaign, Milne has outspent her opponents through the first four months of 2016. Her total expenses were \$77,000, compared to \$60,000 from Washington's campaign and \$46,000 from Lane's.

They appear to be saving money for the final weeks. Washington has \$166,000 in cash available to promote his election. Lane has about \$120,000 and Milne trails both opponents with only \$65,000 remaining available.

Lane had made a \$25,000 personal loan to his campaign and has subsequently repaid \$10,000 of it this quarter. Washington has loaned his campaign \$4,000. Milne has not made a loan to her campaign.

# Contributors

Washington has received many more total contributions than either Lane or Milne, as his total amount demonstrates. But each candidate also appears to have support from different groups.

Washington has received two donations of more than \$10,000 and two other gifts greater than \$8,000. The largest single donor is LIUNA Local 777, which contributed \$32,000, and is one of Riverside County's larger bargaining units. Global Investments and Development, through various sub-

sidiaries in Riverside County, has given more than \$30,000. Rancon, a Temecula developer, also has provided more than \$20,000 to Washington's campaign.

As the incumbent, Washington has received contributions from groups with business with the county such as Albert A. Webb Associates and CR&R, the manager of the local transfer station, and Bellacap LLC.

Besides LIUNA Local 777, other union or labor groups giving to his campaign include the International Union of Operating Engineers (\$2,500), Service Employees International Union Local 721 (\$2,250) and Cal Fire Local 2881, which is Riverside County, (\$1,000).

Milne's support comes from a few very large donors. She has received five contributions greater than \$20,000, including two from local vineyards — Ponte and Callaway — and the Hemet Community Medical Group.

Three land developers have given at least \$25,000 and another two have donated \$10,000 each.

Since Jan. 1, Michael Lumary of Home Energy Solutions has given nearly \$25,000 to Lane. The Soboba Band of Luisena Indians gave \$15,000 and CR&R and Global Investments have also contributed to his campaign.

# Murrieta Mayor Randon Lane is candidate for 3rd District supervisor

# Runs on 'three pillars' of infrastructure, public safety and economic development

When Murrieta Mayor Randon Lane and family first moved to the Inland Empire from Santa Monica, they bought a new house in Murrieta. Lane said he had several flat tires in the first few weeks because of the bad condition of local roads. "When we moved here there were no good roads," he related. His focused questioning of the city Planning Commission regarding the city's poor infrastructure led to an appointment to the Planning Commission.

While on the commission, Lane focused on infrastructure improvement as the key to bringing in new businesses, increasing employment opportunities and improving quality of life for city residents. He championed improving roads, interchanges and facilitating better freeway access. In campaigning for mayor, Lane ran on an "infrastructure first" platform. He cites Murrieta's low unemployment and FBI rating as one of the safest cities in the U.S. as evidence of what infrastructure improvement can do to improve quality of life for residents.

Lane, a Republican, is now running for Riverside County 3rd District supervisor, an office currently held by Democrat Chuck Washington. "Riverside County will have a million more people by 2025," said Lane. "For District 3 cities to prosper there need to be better highways, interchanges and E-W and N-S corridors." Lane proposes local control, from a combination of affected cities and

Riverside County management, of Highway 74, from interstates 15 and 215 into Hemet and San Jacinto. "There also needs to be better access from Interstate 10 for these communities to grow," he noted. In addition to road improvements, Lane supports water reclamation projects as the county grows its population. "We need to be able to capture and retain water that is currently lost in runoff," he said. "Similarly, we need to look at all forms of energy savings, including solar and natural gas."

With regard to spending priorities, Lane feels the Riverside County budget has not been well managed. "It's all about spending priorities," said Lane. "I would make public safety a 110-percent spending priority. The first thing I would do, if elected, would be to request a full third-party audit of the budget from top to bottom. It's not necessarily to focus on negatives but to better see and understand what we are doing right and what we could do better. I want to look at an audit and comprehensive review before addressing budget cuts."

Lane also espouses measures that would make it easier to fast-track permits for new business and residential construction in the 3rd District. "That's what we did in Murrieta and that helped us get the Loma Linda University Medical Center — we fast tracked the process," he said. "I'd also move to do away with the deposit base [construction] permit process in Riverside County. People should know how much they're going to be spending on a specific project like building a garage. It should be a stated fee, not a requirement to deposit \$30,000 against which county inspectors and administrators charge time."

To prioritize business growth in the county, Lane believes in opening doors. "[Supervisor] Washington believes we can get there by raising taxes," he noted. "I believe in opening [regulatory] doors for economic development to make it easier for small and large businesses to relocate here and function here."

When asked to address unemployment in much of the district, compared to the relatively low unemployment in Murrieta, Lane said, "The safer the communities are, the better the infrastructure, the easier it is to get from one place to another, and the more fast tracking there is for new development, the more businesses will thrive and employ people."

With regard to growth of homeless populations in the district, Lane proposed a joint power authority between cities and county. "No single jurisdiction can solve the problem on its own," he said. "A JPA would allow everyone to have some 'skin in the game.' The issues are two-fold—lack of finances and resources and growing mental health issues within the homeless population. This can't be solved just by building facilities. The mental health problems must also be addressed."

Asked how Idyllwild/Pine Cove fits into his priorities for the district, Lane demurred. "This is not a one-size-fits-all district," he noted. "The issues in Idyllwild are different from those in other parts of the district. My job is to listen to what residents in the unincorporated areas have to say."

Asked why he is running for this office, Lane said, "I enjoy local politics. I never had the ambition to run for office before moving here." Lane has a business background, having worked for Nextel, Media-One, AT&T Broadband, Telecommunications Inc. and Sprint in the Los Angeles area. He currently serves as public affairs manager for SoCal Gas for Southern California.

Lane, married and the father of three, became interested in working in the public sector after moving to the Inland Empire. Beginning in 2006, he served as field representative for California State Assemblyman Kevin Jeffries. In 2009, he became political director for Meg Whitman's campaign for California governor. In 2011, he was elected chair of the Republican Party in Riverside Coun-

ty and held that position until this year, when he stepped down to run for supervisor. He was elected to the Murietta City Council in 2008, elected mayor in 2011 and re-elected in 2012. 

AMAC says that you can work with your tax preparer to determine the exact amount of taxes you must pay using your Social Security Benefit Statement (Form SSA-1099/1042S). The Social Security Administration automatically sends that statement out to all benefit recipients each year.







# James Reserve director talk at next Nature Center lecture

Dr. Jennifer Gee to speak about the geologic, biologic and social history

The next and final speaker for the 2016 Nature of Nature Lecture Series will be Dr. Jennifer Gee, director of the James San Jacinto Mountains Reserve. The University of California operates 39 reserves, of which four, including the James, are associated with the Riverside campus' Department of Biology.

In 1966, Harry and Grace James sold the land to the university. The formal educational property will celebrate its 50th anniversary next month; but its biological significance has roots much deeper in history.

Gee, who assumed the directorship in 2012, will speak about the noteworthy history of the reserve, and the research ideas and products that have germinated on the Hill. She describes the reserve, as well as the entire San Jacinto Mountains, as "ecologically rich."

Its value derives from its unique location. The Sonoran desert essentially surrounds the mountain. Geologically distinct from the Peninsular Range, the San Jacinto Mountains are unlike the coastal ridges and mountains to the west and north, for example, the San Bernardino Mountains.

Species such as the spotted owl or black bear can make their way to the Hill, but they don't establish robust and lasting populations since it is not their natural habitat.

"Essentially, we are a 'Sky Island,' "Gee said. "We're isolated here and it's attracted biologists for a long time."

The James has been the site and sponsor of many UC retreats. And many current thoughts and ideas about biology and evolution and other scientific topics began to grow and sprout here. The early leaders were Jarod Diamond, author of the 1997 Pulitzer Prize winning book

"Guns, Germs, and Steel," Martin Cody and Chuck Taylor. All were at one time members of the UCLA faculty.

These retreats led to the development of the Center of Embedded Networked Sensing that was funded with grants from the National Science Foundation. One of the important leaders of this movement is former James Reserve Director Dr. Michael Hamilton.

"While these were scholarly retreats, it's amazing the ideas that start informally around campfire discussions," she said. "To have the time and space to gather with other people with similar questions is a rare opportunity."

Gee is not sure what attracted her to the James and the Hill. She did not know about the geology, except for her quail research. Gee has learned about the mountain since arriving here. "It's nothing in geologic time," she

Gee's presentation will be 6:30 p.m. Saturday, May 21, at the Idyllwild Nature Center. Admission is \$4 for adults, \$3 for children and free for members of the Friends of the San Jacinto Mountains County Parks. The James Reserve and the Nature Center co-sponsored the four lectures this year.






# Cartoonist John Marshall exhibit at IAHS

Cartoonist and Idyllwild character John Marshall eschewed what was politically or socially correct. His book, "Nobody Loves a Fly," featured a label on the front cover: "Warning: Contains Filth!" Some of his iconic cartoons, including many from "Nobody Loves a Fly," are featured in a current exhibit at the Idyllwild Area Historical Society Museum.


Marshall, who died in 2007, July was the featured cartoonist at the Town Crier 1996 from until early 2007. His "For strip, the Hill of It,' devilwas ishly provocative, wickedly funny and absolutely devoid political of correctness.

Marshall contributed cartoons to such disparate publi-

cations as Penthouse Magazine and the Los Angeles Times Book Review section.

"I never had an art lesson," said Marshall in a 1996 interview. "I used to get into arguments with teachers all the time about the things I'd draw. I kind of rebelled against them."

Marshall's drawings and sense of humor were quirky. In his book "Chickensh\*\*," detectives are seen roughing up a distressed chicken, with the caption reading, "Talk! Why does a chicken cross the road?"

Sometimes, well yes, even often, Marshall's work featured characters and situations that were both risqué and ribald

Marshall also felt passionately about certain issues. He was a peace activist in the late 1960s. He created a one-minute short, "Peace," that protested the protracted Vietnam War. Set against a background of an American flag while a boy whistles "Yankee Doodle Dandy," a baby grows to manhood until gunfire abruptly ends his life, and while blood begins to pool, these words are said, "Eager to be a man, he looks ahead, then war comes and he is dead. Stop it!" The short caught the attention of comedian and anti-war activist Pat Paulsen who wanted to feature it in his tours of college campuses. Paulsen wanted to change the last words from "Stop it!" to "Why?" Marshall refused



authority has yet to be established.

Not only do the job applications have to be submitted by the deadline of May 20, but applicants must meet "minimum requirements of the Idyllwild San Jacinto Regional Fire Authority Rules and Regulations," which do not yet exist.

Reitz explained that the plan is being drafted so that it can be implemented if the city and district approve. "Once they accept it, we have to flip the switch," he said.

Currently, he anticipates that one station will immediately be staffed. Over time, the JPA staff will work with the JPA board to provide a larger fire service to San Jacinto, whose population is more than 45,000 people.

The release specifically said the fire and EMS services would be provided to San Jacinto and did not identify what benefits would accrue to Idvllwild.

"Idyllwild will get cost savings from the shared administration costs," Reitz said. For example, his salary as the likely chief of the JPA would be shared between IFPD and the JPA.

"Joint powers" is term used to describe government agencies that have agreed to combine their powers and resources to work on their common problems. When the public officials of two or more agencies agree to create another legal entity or establish a joint approach to work

# California's smoking age 21 in June

Gov. Jerry Brown signed legislation raising the legal age to smoke in California from 18 to 21 years. The exception is active-duty military personnel who may smoke at age 18.

On Wednesday, May 4, Brown signed five new bills that all affect smoking within the state and become effective June 9. Other bills address regulation of e-cigarettes, smoke-free workplaces, school properties and licensing fees for distributing tobacco products.

Brown did veto the bill authorizing cities and counties to impose their own tobacco tax. In his veto message, Brown wrote, "Although California has one of the lowest cigarette tax rates in the nation, I am reluctant to approve this measure in view of all the taxes being proposed for the 2016 ballot."

"Tobacco companies know that people are more likely to become addicted to smoking if they start at a young age," said Sen. Dr. Ed Hernandez, who sponsored the bill to raise the age for legal smoking. "We can no longer afford to sit on the sidelines while big tobacco markets to our kids and gets another generation of young people hooked on a product that will ultimately kill them."

Nine in 10 smokers take up the habit by age 18, according to the American Lung Association in California, and 36,000 California kids start smoking each year.

The bill raising the age to legally purchase tobacco products also establishes a \$75 fine or 30 hours of community service for persons under age 18 who purchase, receive or possess tobacco products.

The workplace smoking prohibitions are now extended to owner-operated businesses. The owner must be the only employee with no independent contractors or volunteers.

Also, the current provision, which allows smoking in 65 percent of guest rooms in hotels, motels or similar lodging, has been reduced to 20 percent of rooms in which smoking maybe permitted.

A state Department of Public Health report stated e-cigarette aerosol contains at least 10 chemicals on California's Proposition 65 list of chemicals known to cause cancer, birth defects or other reproductive harm. Consequently, DPH recommended that "[e]xisting laws that currently protect minors and the general public from traditional tobacco products should be extended to cover e-cigarettes." SBX2 5 will do exactly this by including e-cigarettes within California's smoke-free laws.

"The e-cigarette is nothing more than a new delivery system for toxic and addictive nicotine," said Sen. Mark Leno, (D-San Francisco), who authored the e-cigarette bill. "Ensuring that e-cigarettes fall under California's comprehensive smoke-free laws is critical to protecting public health, especially given the alarming rate at which young people are picking up these devices."

# Hurkey Creek Bridge replacement completed

Only landscaping remains unfinished

In 2012, Caltrans announced plans to replace the Hurkey Creek Bridge, a 1930s-era relic deemed too narrow for today's larger and higher-speed vehicles.

The \$2.5 million project widened the bridge from 23 to 43.5 feet and lengthened the span from 34.1 to 50 feet. One-way traffic, controlled by traffic lights in both directions, was in effect during construction that began in April of last year and wrapped last month with completion of the bridge structure.

According to Caltrans Public Information Officer Joy Schneider, all that remains to be completed is landscaping, final striping and removing all construction fencing and signs in the area. Schneider noted the landscaping portion of the project should be completed in May 2017.

on a common problem, fund a project or act as a representative body for a specific activity, "joint powers" are being exercised.

When contacted by the Town Crier for comment, attorney Niki Moore, an attorney for the California Newspaper Publishers Association, opined that for two existing public entities simply to come together at a joint meeting with an already fully-formed concept of a joint powers authority, without having held open public meetings of their own to broach the matter to their public, "files in the face of the Brown Act."

Moore said that a reasonable interpretation of the Brown Act would require that each agency hold a separate public meeting, allowing for citizen comments, before holding a joint meeting to finalize the formation of the new joint powers authority.

# Grand jury reports on registrar's operation of polling sites

Late last month, a Riverside County grand jury report raised concerns over the how the county's Registrar of Voters manages polling places. After observing operations at several polling places during the November 2015 election and reviewing voting material, the grand jury released its report at the end of April. The Registrar of Voters has until July 26 to respond to the report.

Concerns include the accuracy of the polling sites' addresses. For three out of seven sites, the material distributed with their location had an incorrect address.

The grand jury also felt the training for poll workers was occasionally inadequate and inconsistent.

Other issues the grand jury referred to the registrar for comment and correction included the accessibility kit, security seals and accessible voting units.

For example, in one precinct the accessible voting unit, which provides audio for voters with visual problems, was still in storage.

The report recommended that the poll workers assigned to sites have different levels of experience to ensure that not all the workers at some sites are inexperienced. It also recommended improved training for configuring polling equipment.

Moore also said that she cannot fathom that the administrative heads (Chief Reitz and City Attorney Hults) could have come together to formalize job requirements, applications, and application deadlines, without advanced approval from their respective boards, which would require open meetings. And to obtain board approval for their joint powers authority negotiations outside of open meetings would itself constitute a violation of the Brown Act.
