State says Lynch failed water exam three times

In February 2014, when Tom Lynch was hired to be general manager of Idyllwild Water District, he was required by the district to obtain a California Water Treatment Grade II Operator Certificate ("T2" certification) from the State Water Resources Control Board within six months as a condition of his employment. This was one of several conditions included in a Feb. 5, 2014, letter from outgoing GM Terry Lyons to Lynch. The IWD board made the letter available to the public as part of its agenda packet for an IWD board meeting.

At the IWD board meeting of July 20, 2016, Lynch was pressed by members of the public about the status of his certificate. It was asserted that the online records of the SWRCB did not show that he has yet obtained T2 certification. Lynch responded that the issue was "pending." When asked what "pending" meant, he replied, "Pending" means ... 'pending.'" When further pressed, Lynch responded, "I have taken the exam, and the issue is pending. And that's all I'm going to say about that; it's a personnel issue."

On Aug. 1, the Town Crier served the SWRCB with an emailed California Public Records Act request for evidence of Lynch's certification application.

On Aug. 2, the Town Crier personally delivered to the IWD office a CPRA request for the same information, which included the following paragraph:

"This requested information is not protected from disclosure under the 'personnel exemption' of Government Code section 6254, subdivision (c), which protects from disclosure [p]ersonnel, medical, or similar files, the disclosure of which would constitute an unwarranted invasion of privacy."

Attempted suicide on Highway 243

Just after 6 a.m. Monday, Aug. 15, first responders, including fire personnel and California Highway Patrol deputies, arrived at the scene of an attempted suicide on Highway 243 just above Smith Creek Bridge.

An as-yet unnamed 55-year-old male, who had earlier been reported missing from Orange County, had driven his white Toyota Tacoma into an embankment, starting a small vegetation fire that threatened to consume his vehicle. The man had his windows rolled up, had his doors locked and continued to depress his accelerator pedal even after authorities arrived, according to CHP's initial report.

Fire personnel put out the fire and CHP deputies broke the vehicle's windows in order to remove the man. He was uninjured and was transported by American Medical Response to San Geronio Memorial Hospital in Banning for psychiatric evaluation. CHP impounded his vehicle for safekeeping. By 8:30 a.m., the roadway was fully cleared, according to Darren Meyer, CHP Pass Station public information officer.

At 3:05 p.m. Saturday, Aug. 13, Kimberly Sullivan, 49, of Los Angeles, was driving her 2012 silver Honda Fit east on Pine Crest Avenue in Idyllwild when, after stopping at a stop sign, she continued into the intersection of North Circle Drive. Sullivan's vehicle collided with a 2008 black Harley Davidson motorcycle ridden by Christopher Mellot, 55, of Mountain Center. Mellot, with a female passenger, Gwyneth Mellot, 62, was proceeding southbound on North Circle at the time of the collision.

Gwyneth complained of pain in the leg and was transported by Idyllwild Fire personnel to Eisenhower Medical Center in Rancho Mirage.

There were no other injuries or other vehicles involved in the incident. Alcohol was not suspected as a cause.

Registrar responds to grand jury report

In April, the Riverside County Grand Jury delivered a report critical of the county's Registrar of Voters Office's preparation and conduct of the November 2015 election. The grand jury visited seven different polling places in the county.

In its response, which the Board of Supervisors approved in late July, the registrar agreed to change some practices and improve others. However, except for the recommendation regarding the set-up of three polling places, according to photographs in the accessibility kits, the registrar partially disagreed with all the other grand jury findings and recommendations.

For example, regarding inaccurate addresses for three of the polls, the registrar re-affirmed that all addresses were confirmed by the owners or managers of the sites.

Nevertheless, the registrar replied, "More attention will be given to including specific building names or numbers ... [and] more attention will be given to lighting and signage."

The grand jury also addressed the training and experience of the poll workers and lamented the inconsistency of their training.

In response, the registrar assured the grand jury that "all polling places had experienced poll workers working on election day [and no] polling place [was] staffed with all new poll workers." But more attention would be given to election-officer training in the future.

Another issue involved the security seals on the ballot boxes. The grand jury was concerned that some boxes were not secured sufficiently. However, the registrar replied that the ballot box does not have to be "locked" but it does have to be "sealed."

That means at last one intact seal must protect the box from being opened.

"The ballot box cannot be opened without breaking both seals. It would be impossible to tamper with the paper ballots if one seal is still intact," stated the registrar's response.

With little debate, the board approved the registrar's response to the grand jury.

Body found in Idyllwild

Late Saturday afternoon, officials from the Idyllwild Fire Department were alerted to a body on the Butterfield Commons on Strawberry Creek, the future home of the Idyllwild Community Center, and the Riverside County Sheriff's Department confirmed the location where the body was found.

Late Sunday, the Riverside County Coroner's office released the following information: The deceased was Brandon Schellenberg, 37, of Idyllwild. No cause of death was listed and the Sheriff's Department is still investigating the situation.

According to Idyllwild Fire Chief Patrick Reitz, the district received a call of a possible deceased body in the area of the creek behind the ICC property.

"RSO was notified and was responding while district personnel met with and were led to the location by the juveniles that had found the body. District personnel confirmed that the individual was deceased and secured the scene until RSO deputies arrived and assumed control of the scene," Reitz wrote in an email.

The public can't get a straight answer from a water district general manager about something as simple as his required T2 certification. The public can't get a straight answer from their water board about something as simple as a general manager's required T2 certification.

The responses range from "pending" to "satisfactory progress" to "barking up the wrong tree."

The State Water Resources Control Board says Lynch has yet to pass the T2 exam and is set to take it for a fourth time in November.

To us, the serious part is not Lynch's certification — the IWD board can decide to waive that requirement. (Although you must wonder why they have not waived it long before this. If it weren't important to them, why has Lynch repeatedly taken the exam?)

Rather, what's serious is: The public can't get a straight answer from these people — our own local, elected officials.

Lynch specifically denied to the Town Crier that he'd taken the exam three times without passing, and that he's scheduled for a fourth try in November. Lynch says his certification is "pending," and refuses to explain further.

And Director Jim Billman told the Town Crier (on information he got from Lynch?) that Lynch was "awaiting final results of the state exam."

Well, the Town Crier has copies of Lynch's exam applications to the SWRCB, signed by him, showing that he did in fact fail the T2 exam three times. He's not awaiting results, and the only thing "pending" is that he's scheduled to try yet again in November.

I'm finding this seriously disturbing. If Lynch is willing to lie to us about this, what won't he lie about at IWD?

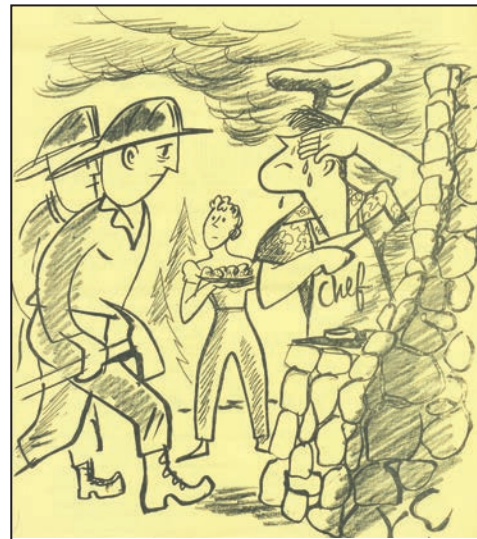

Christin Smith's defense in Pinyon homicide case seeks full dismissal of all charges

Arrested twice, charges dropped once, nearly 10 years after the crime, 27-year-old Christin Smith's defense in a triple-homicide case is much more aggressive than that of his co-defendant and friend Robert Pape, 28. Both men were re-arrested in June and charged with committing a 2006 triple homicide in Pinyon. The victims were Jon Hayward, Vicki Friedli and Vicki's daughter Becky Friedli.

Smith's lawyer has filed two separate motions, one of which has already been denied, to dismiss the charges against Smith and a third motion to discover the name of a confidential informant the district attorney used as supplying new evidence to bring the latest charges.

In separate motions, his attorney asked the court to dismiss the case against Smith. In the first motion, his attorney, John Dolan of Indio, claims the 10 years the prosecutors took to file charges may "constitute a denial of the right to a fair trial and to due process of law under the state and federal constitutions."

Dolan also filed a motion claiming that the state penal code (section 1387) bars the prosecution of a defendant whose charges have been dismissed twice. According to Dolan, the original indictment in March 2014 included Smith's name, but it was stricken and only a complaint was initially filed against him. Then in October 2014, all charges were dismissed against both Smith and Pape.

The DA's office replied that removing Smith's name from the indictment and simultaneously moving with the complaint and a preliminary hearing "was a continuous prosecution..."

On Aug. 5, Judge Bernard J. Schwartz denied this defense motion. He set Sept. 7, as the date to hear the first dismissal motion and also for a preliminary hearing for Smith.

A third motion, asking the court to reveal the name of a confidential informant, also has been set for hearing on Sept. 7.

According to the case records, an anonymous caller to the Riverside County Sheriff's Department told Investigator Patterson that they overheard a conversation "in 2007 between people close to Smith" who knew about the search warrants, the investigation and the caller was told "not to talk."

Finally, in May 2016, county investigators located and identified the anonymous caller who supplied more information. In the most recent statement, the DA says the caller stated, "... Smith directly told the informant that 'something went wrong and we torched the whole f---in' place.'"

While Smith's attorney would like the name of the informant, the DA replied that the only reason to identify a confidential citizen informant is if the person "could supply evidence on the issue of guilt that might result in the defendant's exoneration."

Schwartz also will hear this motion on Sept. 7.

Pape's hearing rescheduled for Aug. 26

Hearings and settlement conferences for Robert Pape, 28, and Cristin Smith, 27, continue to be re-scheduled. Pape's latest court appearance was Aug. 5 when a new felony settlement conference was set for Aug. 26 and a possible preliminary hearing on Sept. 7.

Pape has had several attorneys replaced and issues of conflict declared. The public defenders' office declared a conflict after its appointment as his

attorney. Subsequently, another panel was in conflict and now a third group is defending Pape. He is still in county jail as the pre-trial sessions continue.

Both men have been arrested for the 2006 triple murder of Jon Hayward, Vicki Friedli and Vicki's daughter Becky Friedli in Pinyon Pines. They had been arrested for the triple murder in March 2014, but nearly seven months later, the office of the former district attorney dismissed all the charges against Pape and Smith.

County confirms second Zika case

A woman from the Coachella Valley has tested positive for the Zika virus and health officials say the woman contracted the illness during her travels.

The woman is the second travel-associated confirmed Zika case in Riverside County, according to Riverside University Health System-Public Health. The first case involved a 50-year-old man who had recently traveled to the Caribbean.

There have been no cases of Zika being acquired locally in Riverside County or California. The second patient is not pregnant and is expected to fully recover, according to the county's press release.

Zika is typically transmitted to people by a bite from an infected mosquito. However, it can also be spread from mother to unborn child, through sexual contact and through blood transfusions. The mosquito that carries Zika has been found in portions of Riverside County, including Corona, Riverside, the Coachella Valley and parts of the San Jacinto Valley.

Following the confirmation of the latest Zika case, The Coachella Valley Mosquito and Vector Control District will intensify mosquito surveillance and control efforts in the area in an effort to detect mosquito species known to transmit the Zika virus, suppress mosquito populations and reduce the risk of potential local virus transmission. The work will be carried out in the area bordered by Tachevah Drive, Date Palm Drive, 30th Avenue and Landau Boulevard.

There is no medication to treat Zika and no vaccine is currently available.

The best way to prevent Zika is to avoid travel to areas where active transmission is present. Zika is only one of several diseases that can be spread by mosquitoes.

To protect yourself from mosquito bites, consider the following:

- Wear long-sleeved shirts, long pants, socks, and shoes.
- Use EPA-registered insect repellents and apply according to the label instructions.

- Stay and sleep in places with air conditioning and screened-in windows.

- If you are returning from a Zika area, which includes parts of Mexico, the Caribbean, and some Pacific islands, wear insect repellent both there and also for at least three weeks when you return here to reduce the risk of spreading it locally.

About 80 percent of people infected with Zika do not have any symptoms. Illness may develop in 20 percent of infected people within three to seven days after a bite from an infected mosquito. Symptoms are generally mild and can last for several days to a week. Common symptoms include fever, rash, joint pain, conjunctivitis (red eyes), muscle pain or headache.

Serious complications are extremely rare for the patient, but Zika has been linked to abnormal brain development in the baby when it infects a pregnant woman.

Prop 56 will increase cigarette tax and include electronic brands

Proposition 56 (The California Healthcare, Research and Prevention Tobacco Tax Act of 2016) proposes to amend the state constitution to increase current state excise tax on cigarette sales by \$2 a pack with equivalent increases on other tobacco products.

And, for the first time, electronic cigarette products containing nicotine would be classified as "other tobacco products" and subject to state excise tax. Estimated revenues of from \$1 billion to \$1.4 billion in 2017-18 would be used primarily to augment health care for low-income Californians, and for smoking prevention and treatment programs.

The tax-per-pack of cigarettes will increase from the current level of 87 cents to \$2.87 per pack. The tax on other cigarette products — cigars, chewing tobacco and other products "made of or containing at least 50-percent tobacco" — would increase from the current level of \$1.37 to \$3.37.

Electronic cigarettes, battery-operated nicotine devices that turn specially designed and flavored liquids into a vapor are the fastest growing segment of the nicotine industry in California, especially among youths and young adults. Themes such as Barbie, Minions and Tinker Bell, and flavors like cotton candy and bubble gum are aimed at attracting new young consumers.

Cigarettes and other tobacco products are currently subject to federal and state excise taxes, as well as state and local sales taxes. Should Prop 56 pass, electronic cigarette products, which are currently subject to only state and local sales tax, would now also be subject to federal and state excise tax. Just as with "other tobacco products," electronic cigarettes would be taxed at \$3.37 per-unit sale.

California has one of the lowest smoking rates in the country, estimated by the Department of Public Health to be 12 percent of adults, down from 24 percent in 1988. But use of e-cigarettes has doubled from 2 percent in 2012 to 4 percent in 2013.

Proponents argue that smoking and smoking-related illnesses incur health-care costs of \$13.29 billion annually, \$3.58 billion of which is being paid annually by California taxpayers. Proponents believe increased taxes will help reduce the number of smokers in California, inhibit the rapid growth

of e-cigarette sales, and begin to drive down health-care costs for smoking-related medical and dental illnesses.

To date, more than \$50 million has been spent in support of and in opposition to this initiative. Opponents, primarily big tobacco companies Phillip Morris and R.J. Reynolds, have spent \$35,588,850 to "Stop the Special Interest Tax Grab," as they call it.

Supporters, including "Yes on 56," a coalition of doctors, dentists, health plans, labor, hospitals and nonprofit health advocate organizations, have spent \$16,381,890 to back this constitutional amendment. The text of the initiative states: "An increase in the tobacco tax is an appropriate way to decrease tobacco use and mitigate the costs of health-care treatment and improve existing programs providing for quality health care and access to health-care services for families and children."

Opponents argue that passage of this initiative would fund insurance companies and special interests more than it would fund treatment for smoking-related illnesses and youth smoking prevention.

The non-partisan California Legislative Analyst's office summarized how revenue from the new tobacco and e-cigarette tax would be spent: Revenues would be deposited into a new special fund to be used only for purposes set forth in the initiative; and revenues from the e-cigarette excise tax would be directed to tobacco education and health services, and early childhood development programs.

Revenues would first be used to replace tax-revenue losses caused by lower consumption of tobacco products. Next, the state Board of Equalization would receive up to 5 percent of the remaining funds to pay for administrative costs to administer the measure. Then, specific state entities would receive fixed annual amounts: for enforcement of tobacco-related laws, \$48 million; physician training to increase number of primary care and emergency physicians, \$40 million; tobacco education, \$30 million; and audits of agencies receiving funds from the measure, \$400,000.)

The LAO states, "After covering revenue losses resulting from the measure, the revenue available for specific activities funded by the measure — mostly health programs — would be between \$1 billion and \$1.4 billion in 2017-18. If cigarette use continues to decline, these amounts would be somewhat less in future years."

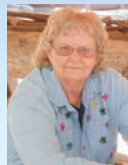
Supporters of Prop 56 include the American Cancer Society; California Medical, Dental and Hospital associations; California Labor Federation; California School Board Association; NAACP-California; Children's Defense Fund-California; and the California and Los Angeles County Democratic Party.

Opponents are Phillip Morris USA Inc. and the R.J. Reynolds Tobacco Company.

Saruwatari describes role, future of county's Emergency Management agency

Kimberly Saruwatari, director of the the Riverside County Emergency Management Department, was the featured speaker at the Mountain Emergency Service Committee meeting last Thursday at the library. She discussed the agency's creation, its need and its goals over the next few years.

In early 2014, County Executive Officer Jay Orr created a task force to assess how the county handles emergency situations, particularly large-scale incidents. After a year, Orr presented a report to the board of supervisors and his recommendation to establish one department for emergency management.

In May 2015, the board combined two public health agencies — the Emergency Preparedness and Response Branch, and the Emergency Medical Services Agency — with the Office of Emergency Services from the county Fire Department into a single comprehensive emergency management organization, which reports directly to Orr.

The overriding goal is to oversee the county's preparedness, response, mitigation and recovery to all hazardous incidents.

While all three agencies were responsible for different aspects of emergency situations, they each had different constituencies. For example, OES worked mostly with local governments, special districts and tribal entities, as well as first responders to emergencies. The two public organizations had more interaction with hospitals, EMS providers, community clients and medical personnel.

"Merging these two cultures into one was one of the bigger challenges as the department started up," Saruwatari said. So the early steps were a "challenge to the old ways."

Over time, one shift has been increasing the efforts on recovery after a situation is mitigated or over. Also, the new department is developing an information center to collect and disseminate information about situations more effectively. Both of these goals will depend upon her efforts to improve "our ability to conduct damage assessments."

Another important goal is greater interaction with volunteers, including offering more training opportunities. Several non-public organizations, such as Radio Amateur Civil Emergency Services, Community Emergency Response Teams, medical reserves and others are a vital component of the emergency response, according to Saruwatari. So she wants to improve the response and strengthen the relationships. A possible training academy may be in the future.

When discussing the role of volunteers and their con-

HUSD trustees postpone bond measure

No bond measure will be on the November ballot for the Hemet Unified School District. At its Aug. 2 meeting, the trustee board voted 6-1 against putting a \$165.3 million proposal in front of taxpayers.

The funds would have been for constructing a new elementary school in the Winchester area, and repairs and improvements at 26 other sites, including Idyllwild School. The work at Idyllwild School would have been for improvements for building safety, security and ADA compliance.

Since the November ballot will include several state propositions and bond referenda, as well as the Hemet re-visit of its public safety tax and San Jacinto's tax measures, the school board chose to avoid the plethora of financial measures and a possible voter rejection. Trustee Megan Haley of Anza cast the only vote in support of submitting the measure to voters.

"There will be plenty of other tax and bond measures to choose from," said Trustee Vic Scavarda of Idyllwild. "There is no fewer than 17 propositions. We were afraid we'd be drowned in all the other noise..."

"We'll have a better chance in an off-year," he added.


Idyllwild Art Fair back on Sept. 3

Lisa Haley and her Zydekats close the Summer Concert Series

Electricity. That's what emanates from Lisa Haley's blue violin. Dressed in her signature homespun and singing, playing and dancing with joyful intensity, Haley is a force of nature.

And don't be surprised if storm clouds gather when Haley and her Kats take the stage at 7 p.m. Thursday, Aug. 25. The humidity of the Louisiana delta tends to envelop any area where Lisa and the Kats gather. That, and the foot stomping that moves out from Haley into the audience, creates a condition called "zydecosis" — it's contagious as it moves from dancer to dancer. It causes smiles and an irresistible urge to move, to dance and to celebrate.

Zydeco and Cajun music are part of the damp, earthy and darkly rich delta from which they spring. The music is combustible, capricious, illuminated by lightning and wonderfully intoxicating.

Haley is an alum of the Idyllwild Arts Summer Program, so Idyllwild is, in fact, her stomping grounds. She attended for four high school summers. "My folks ate beans so that I could come to ISO-MATA's summer music camp," she recalled. She played viola at each of her four summers in Idyllwild. Although classically trained in viola and piano, Haley recognized early on that her calling was Cajun

music, with its heat, counterpoint and rhythm.

Haley's Acadian roots are deep even though she was 8 when, for reasons of her mother's health, the family moved to California. "When we went outside our house it was Southern California but inside it was all Louisiana," said Haley.

With Haley on her return to Idyllwild are David Fraser on accordion, harmonica, keyboards and vocals; Andy Anders on bass and vocals; and Cam Tyler on drums, rub board and percussion.

With Haley closing the series, attendance should be strong. She is a favorite of Idyllwild audiences. And that is a good thing, because, with only two concerts to go, the Idyllwild Summer Concert Series is still over \$9,000 short of making budget.

Each year, thanks to the generosity and gratitude of Idyllwild audiences, ISCS makes budget. This year may be the first time it does not. As of this writing, only \$24,686 out of the \$32,420 budget has been raised.

So bring chairs, flashlights, food, libations and cash to fill the donation jars. Ken Dahleen and his board produce this series on faith — trusting that the community will respond with attendance and financial support.

As of yet, there is no opening act inked for the 6:15 p.m. spot, although board member Pete Holzman said there will be

one.

The concert is the last of the season and the last before Butterfield Commons undergoes a major facelift as construction be-

Idyllwild Calvary Chapel stages free Saturday concert

Idyllwild's Calvary Chapel, in association with other off-Hill churches, stages a free concert of Christian-themed music covering a wide range of musical genres.

Chaplain Cory Sundeen, affiliated with Calvary Chapel Indio, is unofficial music coordinator of the Idyllwild concert. "The purpose of the church is to serve the people, all people, and bring them closer to God and let them know God loves them," said Sundeen. "And sometimes in churches, the traditional hymns are not joyful. Many people are not exposed to the joyful praise music we'll be presenting. And because Idyllwild is a music town, that's how we wanted to reach out."

From noon to 6 p.m. Saturday, Aug. 20, at the Butterfield Commons on Strawberry Creek, six different bands from off-Hill church programs, several with professional musicians, will be performing. Sundeen stressed that all musical styles and genres will be performed. "One group, Church 180 in Joshua Tree, is like a biker-blues Christian band," he noted. Another group, from Hosanna City Church in Cathedral City, features April Murphy, who won the 2013 McCallum Theater's annual 'Open Call' contest." Murphy won the Helen Turner Grand Prize. In winning, Murphy sang "Someone Like You," from the Broadway production "Jekyll and Hyde." She had previously been a semifinalist in 2010.

Sundeen reminded attendees to bring their own chairs and water. He said there would be an independent food vendor nearby.

"My wife and I came up last year, loved the town and connected with Pastor Earl Summerville of Idyllwild Calvary Chapel," said Sundeen. "We thought the concert would be a way to let people know about Calvary Chapel's presence in the town (Calvary Idyllwild was established in 2015).

Sundeen acknowledged they'd be competing with Jazz in the Pines, but noted that this is a free event, an opportunity for those who can't afford the festival ticket prices to still have a beautiful and joyful afternoon of music.

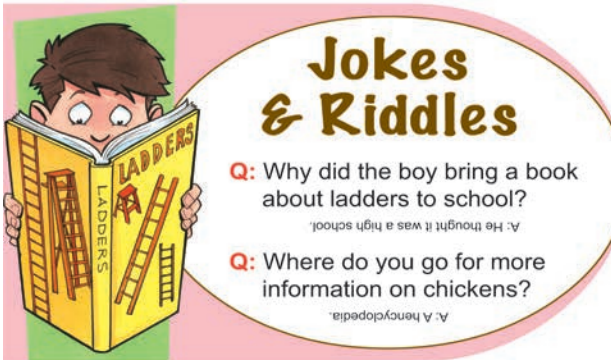

65 years ago - 1951

Dutton's Corner Store, owned by Leigh and Maggie Dutton, opened its doors at Fern Valley Corners on the site of the former Fern Valley Market.

60 years ago - 1956

At a ceremony held at the little Native American cemetery at Cahuilla, a marker on the grave of Juan Diego was unveiled. Diego was the lover of Ramona, also buried there.

50 years ago - 1966

Dolores Bergman, first director of the Town Hall recreation program created by the newly formed service area that contracted with the Idyllwild Chamber of Commerce for use of Town Hall, reported that in addition to daily activities for children, adults and children could take craft, art, music, pottery

and chess classes, attend nature talks and take guided hikes. There was also a Friday night "teen time," with records, refreshments and games, and a community campfire with entertainment on Saturday nights.

40 years ago - 1976

The endangered Peninsular bighorn sheep were given another 11,459 acres to roam, thanks to the actions of the Nature Conservancy, a private protective society that engineered the purchase of nearly 17 square miles in the Santa Rosa Mountains.

There was a new taxi cab service in Idyllwild, the Village Cab Co. In addition to transporting people to local and off-Hill destinations, owners Kat and Barry Davis delivered pets and parcels.

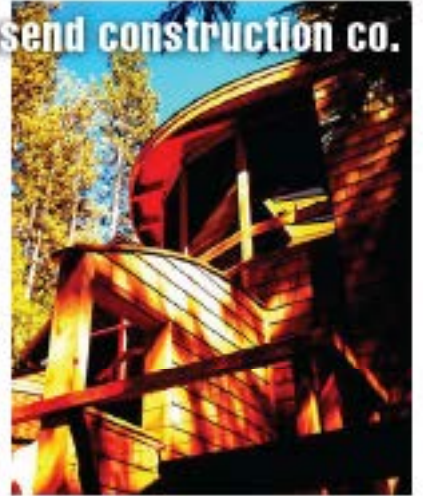

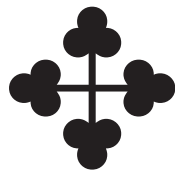

sure of which would constitute an unwarranted invasion of personal privacy,' because "[t]his "personnel exemption" was "developed to protect intimate details of personal and family life, not business judgment and relationships."'" (Braun v. City of Taft (1984) 154 Cal.App.3d 332, 343-344. ...) (Bakersfield City School Dist. v. Superior Court (2004) 118 Cal.App.4th 1041, 1045.)"

On Aug. 3, the Town Crier received a response from the SWRCB to its CPRA request. The SWRCB response included documents showing: Lynch had taken the T2 examination on Nov. 15, 2014, again on May 16, 2015, and again on Nov. 21, 2015. Each time he had failed the exam. He registered for a fourth exam on May 16, 2016, but five days before that date, he arranged to postpone his taking of the exam until the next exam date of Nov. 16, 2016. The SWRCB response affirmatively stated, "Mr. Lynch to date has not passed the T2 exam."

On Aug. 8, Town Crier News Editor JP Crumrine contacted IWD Director John

Cook to ask about a comment Cook had made at the Aug. 3 board meeting, which seemed to suggest that the board might no longer be requiring Lynch to obtain a T2 certification. Crumrine inquired as to whether the board actually had made that decision, and, if so, when. Cook responded, "My position is that Tom is making satisfactory progress towards the goal. Sorry for any confusion that caused you to believe it is no longer a goal."

On Aug. 12, Lynch responded to the Town Crier's CPRA request for his T2 application and testing records: "This is to advise you that the district has no such documents in its possession."

The Town Crier then reached Lynch by telephone and reminded him that our CPRA request covered documents in his own possession as well as in the possession of the district. Lynch replied, "I am aware of your request and I have nothing to give you." At that point, the Town Crier informed Lynch that we were going with this story, that he had taken the T2 exam three times and had failed it each time, and that he was now scheduled to retake the exam in November. We offered him an opportunity to comment. Lynch replied, "You have erroneous information."

When asked which part of our information was erroneous, — that he failed the exam three times or that he was retaking it in November — Lynch replied, "All your information is erroneous." When the Town Crier informed Lynch that our information came directly, in writing, from the SWRCB, the state testing agency, in response to a CPRA request we had sent them, Lynch replied that he was standing by his response.

On Monday, Aug. 15, Cook was asked what "satisfactory progress meant." Cook replied, "He has taken the test."

He apparently did not know that the State Water Resources Control Board has informed the Town Crier that Lynch has taken but not passed the exam three times. When asked if three examinations without passing were satisfactory, Cook said he "would have to discuss it with Tom." He would not elaborate on whether taking the Level II exam three times without a pass was satisfactory without talking to Lynch first.

After discussing the situation with Lynch, President Jim Billman and Cook have no problem with Lynch's evasive responses and inability to comply with his hiring requirement.

Billman said, "[Lynch] is doing what we asked. He is awaiting the final results of his exam."

"We requested that he have a rudimentary knowledge of treatment, not waste water," Billman continued. "He was hired as an administrator and is doing quite well."

"Jeff Smith and the Town Crier administration is barking up the wrong dead tree," Cook stated. "Tom Lynch was hired for his management experience and evidence for this choice has been amply demonstrated."

According to Cook, Lynch has added two wells (12 and 27) back into production. Their production has increased from 10 to 46 gallons per minute. This has increased their contribution to the district's supply by 33 percent.

Further, Lynch has brought the disabled horizontal wells back into production and will augment their productivity with more rehabilitative work this fall.

While Lynch announced in June 2015 that the horizontal wells were back on line and added 10 percent to supply that was insufficient to re-consider the Stage 2 status, now he has said the horizontal wells need rehabilitation to improve production.

Cook also congratulated Lynch with obtaining more than \$400,000 in grants, which is more than his salary. Cook also credited Lynch with obtaining the district's recycling project. IWD had submitted paperwork years before Lynch was hired, however. Finally, he complimented Lynch for encouraging three underperforming employees to leave the district's employment.

"Water treatment and distribution is not an area where the district has experienced problems," Cook stated.

June Rockwell, who was elected a year ago and only assumed her board seat in December, replied, when told of Lynch's licensing issues, "Does that mean we have another inadequate employee?"


This is a reference to Lynch's frequent comments on the incompetence and errors of district employees.

William Curry, who retired from San Juan Capistrano Water District, said the Level II exam is not difficult. "You just have to know the state nomenclature. But you do have to pass the math part, even if you know the nomenclature."

When asked if the Level II exam was difficult, Fern Valley Water District General Manager Victor Jimenez replied, "Not really. I passed it on my first time. I had only two water courses and wasn't technically in a water position [at that time]. Then I passed my Grade III on the first time."

The other IWD board members, Michael Freitas and Steve Kunkle, could not be reached for comment.
