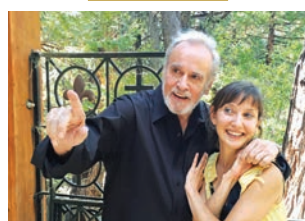

## Local students' performance on state tests: excellent and improving

Last week, the California Department of Education released the results of the second California Assessment of Student Performance and Progress, and once again, Idyllwild School's performance was better than state-wide or districtwide averages.

"We did well, scoring higher than Riverside County [students] in every grade level," said Idyllwild School Principal Matt Kraemer. "And we were above Hemet district average."

At Idyllwild, grades three through eight were tested. Schoolwide, 64 percent of the students met or exceeded the English language and literacy standards. For the entire state, 49 percent of students achieved these levels, and in the Hemet Unified School District, 38 percent of students were able to meet or exceed these standards.

For the math portion of the evaluation, 52 percent of Idyllwild students met or exceeded the standards compared to 37 percent of students throughout the state and 25 percent within HUSD.

At Idyllwild School, this year the percentage of students who met or exceeded the English language and literacy ranged from 81 percent of the fourth graders to 46 percent of the sixth graders.

With the previous testing protocol, Idyllwild regularly had high and excellent results. "This format is a different way of looking at it," Kraemer explained. "Rather just 80 percent effectively over the bar. Now we're looking at a growth model. Are students improving their

## FS tightens fire restrictions as dry weather continues

The San Bernardino National Forest will increase the current seasonal fire restrictions effective this Friday, Sept. 2.

"Continued hot and dry conditions, coupled with a long-term outlook that predicts no change in weather trends and normal fall winds, have prompted local fire managers to implement additional fire restrictions on the national forest," the Forest Service wrote in a press release. "Designed to prevent accidental wildfires, these restrictions will affect additional recreation sites and become more restrictive

in areas already in restrictions."

"It is prudent to do everything we can to prevent unwanted wildfires that have the ... potential for rapid growth," said Forest Supervisor Jody Noiron in the release. "The safety of the public and our neighboring communities is our primary concern and this is one measure we can take that will address that concern."

# Horse trapped in ravine rescued after two days

On Saturday, Aug. 27, a horse and rider tumbled into a deep and steep ravine in the Apple Canyon area. The rider, who incurred minor injuries, is a member of the U.S. Forest Service Volunteers, according to Lt. Dean Spivacke of the Riverside County Sheriff's Hemet Station. The incident occurred about 3.5 miles up Spitler Peak Trail.

While the rider was able to walk out, the horse was trapped in the ravine and could not extricate itself. The volunteers worked several hours to rescue the horse but were unable to free him and the horse was trapped overnight, Spivacke said.

On Sunday, the volunteers made more efforts to free the animal. By the middle of the morning, the Sheriff's Department and the Riverside County Fire Department were called.

After verifying the rider did not need help, the Riverside Mountain Rescue Unit was released since the rescue of large, non-human animals is not part of their mission.

The Horse & Animal Rescue Team from Riverside was contacted, as well as the sheriff's Aviation unit.

After several flights over the scene, the Aviation Unit concluded that it was too dangerous to attempt an extrication Sunday afternoon. The altitude of the ravine was nearly 6,000 feet, temperatures were in the high 90s and the terrain was steep and slippery, Spivacke explained.

The owner and others stayed with the horse Sunday night.

On Monday morning, HART and the Aviation Unit were able to recover the horse safely about 10:30 a.m.

"The volunteers were assisting with trail work as part the Mountain Fire trail repairs," said John Miller, public information officer, San Bernardino National Forest.

# Suspected DUI fueled crash last week

Driving under the influence was the cause of the only crash on Hill roads over the last week. At 12:55 p.m. Monday, Aug. 29, Ronald Cook, 48, of Hemet, was driving his black 2007 Volkswagen Jetta eastbound on Highway 74 just west of McCall Park Road in Mountain Center when he ran off the road and crashed into the mountain.

Cook was transported to San Geronimo Memorial Hospital in Banning with lacerations to his face. He was subsequently arrested for driving under the influence, according to the California Highway Patrol report.

Cook had no passengers in his vehicle and no other vehicles were involved in the incident, according to Darren Meyer, CHP public information officer.

# Body found in Pinyon identified as Josephene Youssef Missing since June 7

Deputy Mike Vasquez, public information officer at the Hemet Station's Riverside County Sheriff's office, confirmed Wednesday, Aug. 24, that the body found by a hiker on Sunday, Aug. 21, is that of Josephene Youssef, 71, of Pinyon.

Youssef had been missing since June 7 when she went for a walk from her family's home in the 70-300 block of Highway 74 in Pinyon Pines.

Youssef was considered at risk since she suffered from dementia and spoke only Arabic. At the time of her disappearance, authorities conducted a ground-and-air search-and-rescue operation, but to no avail. Her family had organized a Facebook campaign and continued to have hope long after the official search had concluded.

# Pape hearing moved to Sept. 7

The attorney for Robert Pape, 28, requested to re-schedule his preliminary hearing to Wednesday, Sept. 7. This is the same date co-defendant Cristin Smith, 27, has his preliminary hearing scheduled.

Both men have been arrested as suspects for the 2006 triple murder of Jon Hayward, Vicki Friedli, and Vicki's daughter, Becky Friedli, in Pinyon Pines. They had been arrested as suspects for the murders in March 2014, but nearly seven months later, the District Attorney's office dismissed all charges against Pape and Smith. In June, both men were re-arrested on suspicion of these murders.

# Fire Safe Council begins to update Community Wildfire Protection Plan

Executive Director Edwina Scott and President Chris Kramer of the Mountain Communities Fire Safe Council, want to revise and bring the Hill's last Community Wildfire Protection Plan up to date.

However, the plethora of fires throughout the state has made it difficult to include the local fire agencies in this effort. Nevertheless, as fall and winter approach, they hope to piggyback on a future Mountain Area Safe-

ty Taskforce meeting later this month.

The current and original CWPP took several years to prepare. The Riverside County Board of Supervisors adopted it in July 2006. In 2010, much of the data and maps were updated.

To begin the revision, a first meeting was scheduled for Aug. 18. About 15 minutes after the proposed start, Kramer said, "Too many fire people are at fires," although several participants from other agencies were able to attend.

## OUT LOUD



We saw quite a bit of citizen activity at the July 20 IWD meeting. Investigative reporting since then revealed more info on an issue raised at that meeting: the Water Operator Grade II Certification exams GM Tom Lynch attempted.

As said previously in this column, what's important is not whether Lynch ever manages to get certification — the board initiated that requirement, and it can waive it if it so desires. What's important is Lynch lied to the TC, and therefore, the public, about his certification attempts.

But was he up front with his own board even?

Director Billman said Lynch currently was "awaiting results." (That hasn't been true since last December.) Director Cook said Lynch was making "satisfactory progress" toward his certification. (Progress? Three failures?) Director Frietas said he thought Lynch had taken the exam only once. (He took it three times.) From where did they get their erroneous information were it not from Lynch? And yet these three directors appear publicly to still support Lynch.

When Director Rockwell asked Lynch during a recent meeting about his certification, he refused to answer in public saying it was a "personnel matter." But under the Government Code, not all personnel matters qualify for closed sessions and exemption from the California Public Records Act. Certifications are public matters, which is why the SWRCB could respond by disclosing that info to the TC.

Now some citizens have erected signs around town calling for Billman's, Cook's and Freitas' resignations. Whether you believe the three must have been duped by Lynch and should be forgiven, or whether you believe they should resign, this direct, personal involvement of the citizenry is understandable.

## Water-treatment operator?

In the Aug. 4 paper, contained within a letter to the editor titled "Services offered to IWD," Dr. Jim Gates offers himself out as a T5 water-treatment operator and long-time educator in this field.

Regardless of licensed field within California — whether it be a paramedic, attorney, educator, physician, engineer, architect, roofer, painter, water-treatment operator or any other field requiring licensing within the state, it is not acceptable to hold yourself out as a licensed individual qualified to practice within the state if you don't hold that license.

It is not acceptable to argue possession of extensive knowledge within the field and licensing being just a formality or overlooked/maintained process.

In fact, I have seen this problem across several fields including those who claim to be qualified water operators more than I care to mention within Idyllwild.

Now to the point. I cannot find Dr. Jim Gates within the water treatment operator licenses database found at [www.waterboards.ca.gov/drinking\\_water/certlic/occupations/documents/opcert/treat\\_oper\\_a\\_l.pdf](http://www.waterboards.ca.gov/drinking_water/certlic/occupations/documents/opcert/treat_oper_a_l.pdf). It's a character flaw that cannot be mitigated with an apology simply because the proffered services establish linkages to regulatory oversight with serious penalties for those who depend upon them.

### THE NEXT COMMUNITY WILDFIRE PROTECTION PLAN BEGINS ...

The San Jacinto Mountains Community Wildfire Protection Plan, a document created more than 10 years ago, is about to undergo a much-needed update.

The CWPP came about and was authorized by a congressional action back in 2003. The Healthy Forests Restoration Act of 2003 was designed to improve the ability of governmental agencies to conduct hazardous fuels reduction projects on National Forest System and Bureau of Land Management lands. The main focus is protecting communities and surrounding areas from catastrophic wildfire.

The HFRA encourages and emphasizes the need for communities to work with federal agencies and collaborate on developing hazardous fuels-reduction projects, and to prioritize these within the CWPP.

Before I go too far and since I'm throwing around acronyms, let me introduce another one that needs an explanation about now. The Wildland Urban Interface (WUI) is the area "where structures and other human development meet or intermingle with undeveloped

wildland."

Now think about a few cities we all know: Hemet, Riverside and San Diego, for example. While we might think of these as dense urban areas, they do have locations on their hillsides and canyons where structures intermix with wildland fire fuels. Therefore, a WUI within a city is not uncommon.

Our WUI boundaries for the San Jacinto Mountains are roughly at the base of the mountain to the west, north and east, and to the unincorporated community of Anza to the south across to the Pinyon area. Our CWPP encompasses this general area.

The various agencies and groups involved in creating our current CWPP will have input to update their section of the plan. The revised plan will cover many topics, such as forest condition, values at risk, fire-protection capability, community preparedness, community action plan and environmental concerns.

It really is a well-put-together document with a great deal of background, history and the resources

involved to protect not only our forest but our community, should it be needed. It also serves as a necessary document that is sometimes required when applying for grant monies to justify proposed fuel reduction and fire-abatement work projects in our area.

So as the work on this progresses and it gets further along, public meetings will be scheduled for feedback and input. Before then, stop by the local library or online ([www.mcfsc.org/Documents/2006\\_sanjac\\_fire-plan.pdf](http://www.mcfsc.org/Documents/2006_sanjac_fire-plan.pdf)) and become enlightened and familiar with the SJMCWPP. It's only a few hundred pages of light reading and gives a great deal of insight into what has gone into preparing our mountain communities for the threat of wildfire.

# Therapist Karla Leopold confronts desperation in Louisiana

## Elderly and children severely impacted by storm

Recent torrential rains and flooding in Louisiana, the second-poorest state in the country, have again severely impacted children and the elderly.

And, to worsen matters, some families who lost their New Orleans homes during Hurricane Katrina, then relocated to Baton Rouge, lost their homes again during recent flooding.

Art therapist and Idyllwild resident Karla Leopold arrived in Baton Rouge, as she did 11 years ago after Katrina devastated New Orleans, to use art therapy to help ease the trauma of storm victims staying in shelters. "Desperation is everywhere," noted Leopold.

"The situation here in Louisiana, Baton Rouge and surrounding areas affected by the recent floods continues to be difficult and heartbreaking." She noted the difference from Katrina, in the affected communities, is that emergency response teams and the Federal Emergency Management Agency showed up immediately.

"The current focus is getting children and elderly with health issues out of the moldy, unhealthy homes — no easy task as so many of the elderly are reluctant to leave everything they own," said Leopold.

She said her therapeutic focus has been on working with children in area shelters. "Yesterday [Sunday, Aug. 28] there were approximately 350 people in the [Lama Dixon] shelter," she said. "We worked with over a dozen children ages 2 to 15." She described having the children create journals, to carry and keep with them, in which to draw and write their stories of escaping floodwaters. "We also used drama therapy," she related. "We used scarves and fabric sent to us by some won-

derful donor and created costumes of a royal court including two royal chiefs. There were a lot of smiles, laughter and empowerment during this activity. We continued with the idea of empowering the children, after they write in their journals, and created hats and crowns.

"Today we are going to the River Center shelter where there are over 1,100 people," she said. "The large arenas are lined with cot after cot. The energy in the air is certainly depressed, tense and uncomfortable. Today will certainly be a challenge as we have been asked by the medical team to provide an art activity to get the adults moving and off their cots. So many of them are covered in their blankets and just lay there all day, as they have no place to go and no homes to go back to."

Leopold said that is the core of the desperation so many are facing — they have nothing to go back to. Or if the home is only marginally habitable, some refuse to leave, risking health issues that come from mold.

Sister Judith Brun, who directs the Baton Rouge Area Foundation, and with whom Leopold is again working, recruits volunteer teams to help clear debris and begin to rehabilitate damaged homes. They also work with authorities to arrange medical help for those affected. "The balance of the good is that we have clarified pathways for children with medical difficulties who are in homes with mold and sheet-rock dust," she said. "Parents typically do not want to leave their homes even though the health of their children could be compromised. Parents continue to believe they can protect their children even in the worst circumstances. We must now work on a similar plan for elders who refuse to leave."

Leopold said the need

for art therapy — using art to externalize internal fear and desperation — is everywhere in the many area shelters. "It's overwhelming just to be in the shelter for any period of time," she noted. "Please continue to send donations, prayers and healing thoughts." She thanked those who have sent art supplies.

## Grinding facility going to three weekdays per week

At its Aug. 23 meeting, the Riverside County Board of Supervisors approved a change to the days the local grinding facility is open. Beginning Friday, Sept. 2, the facility will be open three days per week — all during the week and no weekend days.

The new schedule will be from 8 a.m. to 4 p.m. Monday, Wednesday and Friday, and closed for an hour between noon and 1 p.m. for lunch, according to Lisa Thompson, program administrator of the county's Department of Waste Resources.

The department initiated the changes after attending recent Mountain Area Safety Taskforce meetings. Several local agencies had urged the change to offer contractors more opportunities to dispose of green and woody waste after abating local properties.

"Being open during the week is pretty much what I've been getting from the community," Thompson said. "It's what everyone wants."

During the past year, the facility received about 7 tons of woody waste from six customers each day, according to Waste Management Director Hans Kernkamp's memo to the board.

"Residents of the Idyllwild community who pay parcel fees for trash service under Franchise Area 8 will continue to be able to go to the Idyllwild Transfer Station at no charge," Kernkamp emphasized in his memo.

The grinding facility is on Highway 243 about 1 mile south of the Idyllwild Transfer Station.

A county press release stated, "The grinding facility accepts wood waste affected by the bark beetle. Prohibited waste includes household waste, appliances, e-waste, metals, tires and other hazardous, explosive and medical wastes. Customers who use the facility pay a per-ton rate with pre-paid accounts."

## Parcel measure on November ballot Chief earns pay raise

At the Idyllwild Fire Protection District's commission meeting last week, Fire Chief Patrick Reitz said the Riverside County Registrar of Voters has accepted the IWD's proposed parcel fee increase. It will be included on the November presidential election ballot as Measure W.

Commissioner Nancy Layton, chair of the Education and Dissemination Committee, reported that a flier explaining the purpose of the measure and how the funds will be used is being prepared.

Also, the commission is planning at least one community meeting, possibly more, for voters to ask questions and gain knowledge about IFPD's needs, she said.

In the absence of President Jerry Buchanan and Commissioner Jeannine Charles Stigall, the other three commissioners completed the chief's evaluation for 2015-16 and authorized a 2-percent pay raise. This would bring his total salary, exclusive of benefits, to about \$88,000.

The increase is consistent with the increase for career staff proposed in the recently adopted memorandum of understanding with the Career Firefighters Association.

"The chief received a very favorable review and a salary increase in line with the MOU," said Commission Vice President Rhonda Andrewson.

Other business was limited. Financial results for July, the first month of fiscal year 2016-17, were negative, which is typical for the summer months because property tax revenue does not flow to IFPD until after the first payments in December.

The July net income was a negative \$137,400 compared to a negative \$60,500 in July 2015. The loss was bigger this year because last July, the fire department received a \$100,000 reimbursement for work on other fires.

Besides personnel costs, the largest expenditure (\$18,000) was for legal services.

In other financial business, Treasurer Nancy Layton reported that she and Finance Committee Chair Calvin Gogerty were still recruiting two citizen members for the committee.

The district is installing and beginning to use new financial software. The transition is not complete yet, but Layton expects it to occur in the next few months.

Reitz also reported that several crews had been called to the recent spate of fires in Northern California.

# Stratford Players presents 'Will in the Woods IV'

Continuing its commitment to the classics, the Stratford Players presents "Will in the Woods IV," a full immersion in some sonorous Shakespeare snippets — sonnets, and scenes from some of the bard's most memorable, merry and moving masterpieces — "A Midsummer Night's Dream," "Taming of the Shrew," "Macbeth" or, for the superstitious actor, "The Scottish Play," "Richard II," and "The Merry Wives of Windsor."

Artistic and WITW IV director Marsha Kennedy decided to mix it up a bit this year. "We've added excerpts from excellent and seldom-seen plays by Shakespeare contemporaries Thomas Middleton and Cyril Tourneur," she noted. "There's also a comic sketch made famous by British actors Hugh Laurie and Rowan Atkinson that features Christopher Morse and Mark Rogers as Shakespeare and his agent. This year's program also introduces a quartet of madrigal singers."

Kennedy observed that Stratford is serving up Shakespeare for a broad audience, not just for those who hang on every word of even his longest play (for the record, "Hamlet," at 4,024 lines). "Everyone knows that Shakespeare wrote some of the most beautiful prose in the English language," she said. "However, by modern

standards, his plays can seem a bit long and slow-moving." Again for the record, Shakespeare is normally spoken at the rate of 1,000 lines an hour, making "Hamlet" a four-hour experience, unless edited.

"Our solution," said Kennedy, "is to extract the funniest, the most thought-provoking, and the most dramatic and soul-stirring moments. We think the result is Shakespeare at his most enjoyable. Even people who think they don't like Shakespeare will enjoy this one!"

WITW IV plays, as it did in Shakespeare's time, during the day with natural sunlight providing the illumination. Performances are at 3 p.m. Sunday, Sept. 11, and Saturday and Sunday, Sept. 17 and 18. Tickets are \$12 and are available online ([www.stratfordplayers.com](http://www.stratfordplayers.com)) or at the door. Fancy Pants Box Seats, elevated and soft, are \$25.

Kennedy advised that seating, in the outdoor Sylvan Stage at St. Hugh's Episcopal Church, is on benches, just as it was in Shakespeare's time. Patrons may bring cushions if they like.

Featured players are Barbara Rayliss, Christine Hunt, Christopher Morse, Derrik Lewis, Dick English, Doug Austin, Harriet Briant, Jeannette Rogers, Mark Rogers, Rena May and Kennedy. Julie Pence stage manages.

## Ice cream and information at Historical Society social

### Dr. Robert Reyes book signing — Saunders Meadow history

The Idyllwild Area Historical Society, a rich repository of Hill history, holds its annual ice cream social on the IAHS grounds from noon to 2 p.m. Saturday, Sept. 3.

Although one visits the IAHS to sample things old, longtime IAHS volunteer Bob Smith assures the public the ice cream will be deliciously new. "It's a give-back to the community," said Smith, "a thank you."

In keeping with its mission to chronicle and catalogue Idyllwild's history, IAHS will also host a Saturday book signing by Dr. Robert Reyes — a book detailing the history of the Saunders Meadow tract.

Starting with his purchase of one of the original U.S. Forest Service cabins in Saunders Meadow, Reyes chronicles the tract's history and evolution in "Saunders Meadow — A Place Without Fences, a History of the Term Occupancy Permit Act of 1915" (Mill City Press, 2016).

The book follows Congressional passage of the Occupancy Act in March 1915, that allowed private citizens the opportunity to occupy national forest or public domain lands for certain periods of time for "family recreation summer homes, campgrounds, resorts and stores."

Reyes details how in the 1960s the Saunders Meadow tract and the Forest Service executed a land exchange and order that allowed cabin owners to own the land on which their cabins were built — land that was part of the San Bernardino National Forest. As a result, the tract is now Saunders Meadow Inc., with an annual homeowner fee of \$50 that helps maintain Saunders Meadow, common ground for the 57 homes located in the tract.

Reyes will sign books and answer questions, while attendees sample ice cream.

The event is free to the public and is located in the garden of the IAHS on North Circle Drive.

# Prop 60 to require more stringent condom regulation in porn industry

## Opposed by both California Democratic and Republican parties

On its face, Proposition 60, "Adult Films, Condoms, Health Requirements Initiative Statute," would seem likely to attract wide approval as a health initiative designed to reduce risk of sexually transmitted disease by requiring use of condoms in the adult film industry.

But the story may be in the united front opposing the measure. Prop 60 is the only ballot initiative opposed by both the California Democratic and Republican parties, as well as the California Libertarian Party. Other opponents include AIDS Project Los Angeles, the Los Angeles LGBT Center and the San Francisco AIDS Foundation.

Opposition centers on the proposition's vague wording, cost to enforce, free-speech constraints, redundancy (existing laws already in place) and delegation of power to one man, chief proponent and CEO of the AIDS Healthcare Foundation Michael Weinstein.

The non-partisan Legislative Analyst's Office notes that the California Division of Occupational Safety and Health already requires adult film con-

dom use. Cal/OSHA generally enforces these rules by responding to complaints from within the industry.

Industry practice varies — some adult film production companies require use of condoms. Some don't. Other companies, instead, require regular STI testing to confirm that performers are free of harmful infections. Proponents argue Prop 60 would close loopholes and create a highly detailed regulatory process to ensure condoms are used in the adult film industry.

Prop 60 would change workplace health and safety rules by adding a specific condom requirement to the California Labor Code; require adult film producers be licensed and provide information to the state about adult film shoots; expand time frame for enforcement of some adult film workplace health and safety violations; make distributor and agents potentially liable for violation of some adult film workplace rules; and allow, in some cases, any California resident to bring a civil lawsuit against producers for some adult film workplace health and safety violations.

Probably the most contentious piece of the proposed legislation is the provision allowing any California resident, including the chief proponent of this legislation, to request Cal/OSHA investigate some alleged adult film workplace health and safety violation, and the consequent costs of legal process.

Language also gives "a private right of action to adult film performers to recover civil damages for economic or personal injury caused by adult film producers' failure to comply with the health and safety requirement of this Act."

Also, one section of the act "Aiding and Abetting," has fueled the opposition's ire. Specifically it states, "Any person found to have aided and abetted any other person or persons in violation of Labor Code sec-

tion 6720.5 (a) shall be found liable for violating [the section]." The section is an addition to the Labor Code that requires adult film producers to maintain "engineering controls and work practice controls" to ensure condom use on the set.

Opponents contend the proposition is overreaching and too broad in its regulatory process.

The LAO posits the cost to enforce would exceed \$1 million annually but that much of that cost would come from new fees on adult film producers. Other possible budget effects cited would be possible reduction in number of adult films made, thereby resulting in a minor increase in state or local costs for health or social service programs.

In 2012, Los Angeles voters overwhelmingly approved a similar initiative, Measure B, which required adult film actors to wear condoms on the set. The Los Angeles Times noted that the government is ill-equipped to mandate and enforce the provisions of Measure B.

Opponents contend the initiative's language is poorly drafted, that passage would lead to many lawsuits that could threaten the safety of adult performers, that the proposition would violate worker privacy, that it would create a state employee who would review pornographic films for infractions, only legislators would be able to vote the individual out of the position, if necessary, and that cost to taxpayers would exceed millions of dollars and be "unnecessary."

They also argue that the more than \$2 million spent to get this measure on the ballot and potential costs to enforce would be better spent on health education campaigns and disease prevention for the wider populace.

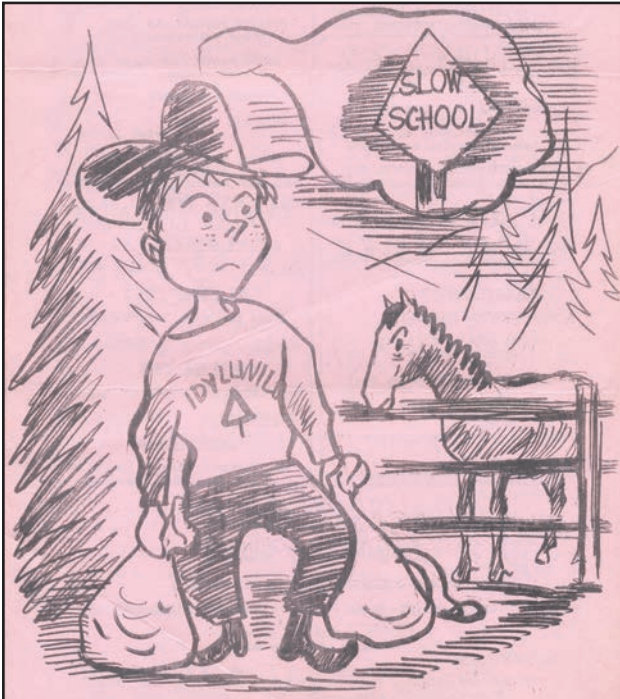

or using a fire, campfire or stove fire. (No wood or charcoal fires.)

- Individuals with a valid California Campfire Permit may use either a propane or gas cooking stove, or lantern.

- Smoking is prohibited, except within an enclosed vehicle, building or developed recreation sites, or while in a cleared area at least 3 feet in diameter.

- Recreational shooting, including within the public shooting ranges operated under special use permit issued by the Forest Service, also is prohibited. Persons engaged in lawful hunting are exempt from this prohibition.

- Welding or operating acetylene or other torch with open flame is prohibited.

- An approved spark arrester is required for all

off-highway vehicles.

The U.S. Forest Service will be aggressively citing those who do not comply with the posted restrictions. Violation of these prohibitions is subject to punishment by a fine of not more than \$10,000 or imprisonment for not more than six months or both, as Class B misdemeanors under federal law. Persons may also be responsible for resource damage, suppression costs and any injuries that occur if they are found liable for causing a wildfire, according to the release.

Forest visitors are encouraged to "Know Before You Go" and call ahead to the local Ranger Station to check on location conditions and restrictions at the following offices: San Bernardino National Forest Supervisor's Office 909-382-2600 or San Jacinto Ranger Station 909-382-2922.

MCFSC is working with Esri to prepare maps of the Hill and current project locations. The new CWPP will show where the U.S. Forest Service and Cal Fire have maintained existing fuelbreaks and created new breaks in the past decade.

One use of the CWPP is to secure grant funds to help construct new fuelbreaks, Kramer emphasized. "Many grant people ask us if the CWPP has been updated within the last five years," he stated.

Idyllwild Fire Chief

Patrick Reitz concurred that a current CWPP would be a practical and useful document for Hill groups. "And it is important for obtaining new grants," he added.

Since the last CWPP, three major fires — Esperanza, Mountain and Silver — have burned thousands of acres, houses and taken lives.

As work proceeds, Scott said there will be a round of community meetings, probably three, to review the draft plan and solicit suggestions.

scores year to year."

"The district and Idyllwild School made progress on the ... CAASPP. Specifically, Idyllwild School grew 9.6 percent in [English language] and 10.1 percent in mathematics," Christi Barrett, HUSD superintendent, commented. "This year's Local Control Accountability Plan has put in place a variety of support systems and programs to enhance student outcomes. HUSD is committed to excellence and will continue to focus on preparing our students not only for the CAASPP, but to graduate from our schools college and career ready."

In 2015, 49 percent of third-grade students reached these levels. After another year at IS, they improved nearly 30 percent. All five grades improved or met the English standards.

Nearly 80 percent of Idyllwild students were near or above the standards

for both the reading and writing sections of the English exams.

Similar results were achieved in the mathematics portion of the test, too. In 2015, 42 percent of the students met or exceeded the math standards and in 2016 this grew to 52 percent. Improvement grew at almost every grade level. The best results were achieved at the younger grades. For instance, in 2015, 77 percent and, in 2016, 82 percent of the third-grade students met or exceeded standards. More than 60 percent of all the students in grades three, four and five performed at these levels.

"I've got a great staff and the parent support is outstanding," Kraemer replied, when asked how to explain the outstanding results of the local students. "The community support is unprecedented, with smARTs, Idyllwild PTA, Idyll Booster Club, Idyllwild Rotary, Art Alliance, Doug Austin, Grant Makers, 5/10 K Committee and Idyllwild Arts."
