## Drama in the descent

### Idyllwild resident crash lands plane in Hemet

When you're at 8,000 feet altitude and your engine is shutting down, you have limited time to work with the problem. Descending at 800 feet per minute, with only 10 minutes to touchdown, and with the single prop wind-milling, that is what Idyllwild local Dave Pelham had to do — concentrate on working the protocols for which he had long been trained as a pilot but had never had to use outside of a simulation.

On Thursday, Nov. 10, Pelham and pilot companion Drew Womack faced an emergency situation that was intensely real with limited options for success. They had been up for 45 minutes when the small craft's single engine sputtered and lost function. Pelham had

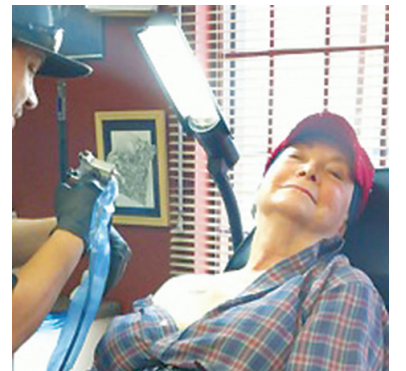
It was back. Ten years had passed since she had won the battle against breast cancer, yet here it was again. Judy Lawler felt her usual carefree demeanor abandon her just as surely as the test results inserted cancer, front and center, once again into her life.

## Two injury crashes on Hill roads

Two injury crashes occurred on Hill roads during the last week.

The first, on Wednesday, Nov. 9, occurred on Highway 74 one mile west of Strawberry Creek Bridge. At 6:15 p.m. Alec Blume, 17, from San Jacinto, was driving his 2003 black Toyota Celica east on Highway 74 when he made an unsafe turning move to the right which caused his vehicle to go over the side, into a ravine, and overturn, coming to rest on the vehicle's roof. According to the California Highway Patrol report, Blume complained of pain and lacerations and was transported by ground ambulance to Riverside University Health System hospital in Moreno Valley. Blume was wearing a seatbelt. There was no evidence of alcohol or drugs involved and no other vehicles were involved.

At 5:34 a.m. on Thursday, Nov. 10, Torben Beith, 59, of Mountain Center, was driving his black 2000 Volvo S70 westbound on Highway 74 near Bee Canyon Truck Trail when, for unknown reasons, he ran off the road causing his vehicle to overturn on

the roadway. Beith was transported by ground ambulance to Riverside University Health System Hospital in Moreno Valley with broken ribs, sore neck and pain to the left side of the torso. In his account to CHP officers, Beith said he was distracted at the time of the incident. No other vehicles were involved.

## Missing hiker found after six days

Would likely have died without RMRU rescue

Riverside Mountain Rescue Unit volunteers located a hiker missing for six days. At the time he was found on Saturday, Nov. 12, about 3 1/2 miles off South Ridge Trail, the hiker was severely dehydrated and malnourished, having gone most of the time he was missing without water or food.

"Given his condition at the time he was found, had RMRU not found him, I'm sure he would have died," said Sgt. Robert Duckett, Riverside County Sheriff's Department, Hemet Station.

In the report from RCSD, Duckett noted two hikers, Troy Beneke, 46, of Idyllwild, and Clide Mallatt, 66, of Hemet, set out Sunday, Nov. 6, on the South Ridge Trail and be-

came separated. According to Duckett, the two were somewhat reclusive and thought to be "gold hunters," who were accustomed to being gone and on their own for extended periods.

At the end of the day on Sunday, Beneke hiked back to his vehicle and waited for Mallatt who never showed up. Beneke went home and telephoned Mallatt around 10 p.m. that night. Mallatt, whose cell phone was still working but losing charge, said he was still on the mountain, lost and out of water, and that his legs were cramping. He told Beneke he would bed down and try to hike out in the morning. By around 11 a.m. Monday, Nov. 7, Mallatt's cell phone was dead, according to the RCSD report.

Beneke said he returned over the next several days to search for Mallatt but was unsuccessful.

Finally, on Friday, Nov. 11, again according to the report, "a friend told [Beneke] to call 911 and report the incident," which he did.

RMRU located Mallatt around 1:50 p.m. Saturday, Nov. 12. He was transported to Hemet Valley Medical Center for treatment suffering from exhaustion, extreme dehydration and malnourishment.

Although the circumstances of the incident initially prompted RCSD to launch a full investigation, the case is now closed, according to Duckett. He said when the department contacted Mallatt's wife, she indicated Mallatt often took off for weeks at a time and that it was not unusual for him to be gone without contact.

## Measure W losing, while majority favor it

The one local election in Idyllwild did generate a surprise. Measure W, the Idyllwild Fire Protection District's proposal to raise parcel fees, is losing as of Friday evening, Nov. 11. While 57.4 percent of voters chose "Yes," IFPD needs two-thirds of the ballots cast to support the increase.

Through Friday, 1,145 ballots have been counted and 657 were "Yes." However, IFPD would have needed 763 to have been cast for "Yes" for it to be approved. The county has about 200,000 ballots still to count. IFPD will need well more than 100 votes, even if all were "Yes" to gain approval for the measure.

On Sunday, Fire Chief Patrick Reitz was still hopeful and not ready to concede defeat yet when asked about future plans if the measure does not pass.

"The District is awaiting the full and complete counting of all ballots cast while the Registrars office works to finalize counting and verification," he said in an email. "It would be premature to make any assumptions or comments based on an incomplete count of the ballots, which is the voice of the voters."

## Idyllwild area voter registration data

Presidential elections like the one held Tuesday bring to light the changing political divisions that shape the electorate. While the state of California is perennially and reliably "blue," with Democrats outnumbering Republicans by two to one, Riverside County has been majority Republican at least since the state's online registration records went online in 1999.

That changed in August, when voter registration data showed Democrats finally edging Republicans for the first time in recent memory, and likely more. But while collective voter registration data for all county unincorporated areas, which includes the San Jacinto Mountains, show them to be an outlier Republican stronghold by 65,506 to 50,498 Democrats, localized data for Idyllwild and the surrounding communities tells a different story altogether.

Data obtained from the county Registrar of Voters Office on Sept. 7, show 2,702 voters registered across the five precincts on the Hill; of these, 1,033 (38.2 percent) are registered Republican and 1,014 (37.5 percent) registered Democratic, a gap of just 19 voters.

Of the remainder, 491 voters listed no party preference, with 24 and 25 voters registered Green and Libertarian, respectively. The only other party with a presidential ticket on the California ballot, Peace and Freedom, claims just six registered voters on the Hill.

Eighty-six voters are registered with the American Independent party, which has endorsed the Republican nominee, Donald Trump.

The margin of registered Democrats to registered Republicans widens significantly from the Hill average in three of five precincts. Idyllwild, with three times more voters than the second-largest precinct, leans firmly Democratic, with 673 (41 percent) registered voters to 558 (34 percent) Republicans. Mountain Center (33 R, 21 D) and Garner Valley (177 R, 61 D) tilt sharply Republican.

The two remaining precincts more directly reflect the tight numbers between the two major parties on the Hill: Pine Cove (196 R, 193 D) with a Republican advantage of three voters, and San Bernardino National Forest (69 R, 67 D), just two.

The proportion of voters registering No Party Prefer-

ence holds steady around the Hill average of 19 percent in all precincts except Garner Valley, where only 11 percent of voters decline to identify with any political party.

While Democrats may not have taken over the Hill just yet, they have made significant progress in recent years. Democrats make up 259 (43.2 percent) of the 599 new voters registered since the last presidential election in 2012, mostly in Idyllwild, Pine Cove and San Bernardino National Forest, compared with 172 (28 percent) Republicans dominating new registrations in Garner Valley and Mountain Center.

Voters under age 35 also lean disproportionately Democratic, with 117 (38 percent) registered voters to 86 (28 percent) registered Republicans. But this group represents just 10 percent of Idyllwild area voters, despite

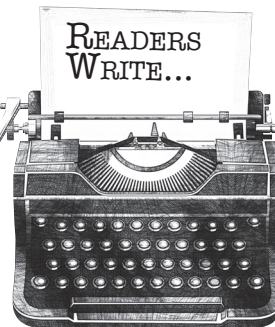
## IWD director candidates

The Pine Cove Water District directors unanimously authorized General Manager Jerry Holldber to sign the new lease with American Tower. They are leasing space for communications equipment at the district's Rocky Point Communications site.

American Tower is replacing Verizon on the new lease. Once formally signed, PCWD will receive a one-time \$20,000 signing bonus.

In other business, Holldber told the board that the district's counsel Brad Neufeld was leaving his current firm, Gresham Savage Nolan & Tilden of San Bernardino, to join a new firm, Varner & Brandt of Riverside. The board unanimously agreed to continue to use Neufeld for legal advice.

"He knows us, knows our business and we like him," said Director Diana Luther in support of maintaining the relationship with Neufeld.

Because of the move, Neufeld told the board he need-

ed additional time to review the revised Ordinance 4, which establishes basic board operating policies. With the extra time, Board President Robert Hewitt, Holldber and Marge Muir, Pine Cove resident and real estate agent, will meet next week to discuss her comments on the draft ordinance.

In water business, Holldber reported that the October consumption was 2.6 million gallons, only 2,260 gallons less than October 2015. For the year, 2016 consumption has been 27.3 million gallons compared to 26.9 million gallons for the first nine months of 2015.

For the same period in 2013, PCWD's production was 27.7 million gallons. The state Department of Water Resources uses 2013 as the base year to analyze water savings. PCWD's 2016 use is 1.4 percent less than 2013 and 4.2 percent less than 2014.

While the water loss estimates were not available this month, Holldber expressed gratitude for the district's efforts to pursue leak detection over the past two years. He attributed this success as one of the reasons that the 2016 October production was the same as 2015

rather than increasing as is occurring throughout the state. He plans to continue the effort in the Pine Ridge Road, Laurel and Nestwa trails neighborhoods.

PCWD is still in the midst of a meter replacement program, more than 100 water meters have been replaced this year. These were older and the most used, greater than one million gallons. The next tier will be addressed this year.

Groundwater well levels were very good in October Holldber told the board. "The static well stayed the same and my wells were up one or two feet. The lower Dutch Flats wells were up 4 feet despite regular pumping this fall."

He also reported that during the fall and winter he would begin some preparations for next summer. Since the drought may continue, Holldber plans to bring more wells into the distribution system.

In conclusion, the board and Holldber thanked office manager and Board Secretary Becky Smith for 10 years of service.

## Another Deer Sighting injury

On average, deer in the wild can live up to 10 years, but with man as either an accidental or intentional assailant, more often than not deer seldom reach 5 years of age.

And apparently, what applies to deer living in the wild also applies to the 22 aluminum painted deer of Idyllwild's Deer Sightings installed in Idyllwild and Pine Cove. Dedicated and placed on their pedestals in 2013, even aluminum deer find it hard to survive to ripe old age in the "wild" environs of Idyllwild.

On or before Monday, Nov. 7, an unknown assailant toppled "Jazzy," Deer Sightings resident at Café Aroma, causing damage to one of his antlers. Painted by Rachel Welch to commemorate Idyllwild's jazz history, Jazzy was found lying on pavement next to his mounting place at Café Aroma by restaurant staff. Dennis Gerdes and Dave Robb are looking at ways to repair the damage and return Jazzy to his site.

The stags, does and fawns of the Deer Sightings herd were decorated by local artists to commemorate Idyllwild history and themes. They were lovingly painted and installed to uplift visitors and to enhance Idyllwild's image as an art haven.

Unfortunately in three separate incidents, one painted deer was unceremoniously uplifted and stolen from its mounting, another was driven over and crushed by an errant automobile, and most recently, Jazzy was toppled from his pedestal and damaged.

Art Alliance of Idyllwild President Shanna Robb, who shepherded the Deer Sightings project into reality, found the latest instance of damage disheartening.

Rachel Welch, who painted Jazzy said, "I'm sad about the damage to Jazzy, but I realize that any time we put something out for everyone to enjoy, we cannot expect everyone to be respectful of it. But I think that the enjoyment that my deer has brought people over the years greatly outweighs this instance of disrespect. And I'm glad there are so many people that are helping to make Jazzy whole again. He is more than mine – he is part of this amazing community. It makes me happy that so many people care."

Patrons and admirers of the deer are admonished not to touch or sit on the sculptures. They are for viewing only.

# Local races bring few surprises

In a stunning upset at the national level, Donald Trump, the Republican candidate, defeated former Secretary of State Hillary Clinton to become the 45th President in January. Nationwide the Republicans held their majorities in both the Senate and House of Representatives.

In Riverside County, voters gave Clinton 49 percent of the vote, and Trump received 46.4 percent. Voters in the rest of the state were more strongly Clinton supporters. With more ballots to be counted, she has garnered more than 6.2 million votes, 61.4 percent; while Trump has pulled 3.4 million votes, which was 33.1 percent of the total.

The Riverside County Registrar of Voters Office an-

nounced on Friday, Nov. 11, that slightly more than 530,000 ballots have been counted and about 210,000 ballots remain to be counted. At this point, county turnout was about 52 percent and will be about 74 percent once all the ballots are counted. Statewide turnout was about 51.4 percent as of Sunday afternoon.

In the Senate race between Democrats Kamala Harris, state Attorney General, and Loretta Sanchez, U.S. Representative, Harris won overwhelmingly with about 63 percent of the vote. While her Riverside County percentage was 57 percent, she gained a 61,000-vote lead here.

For the Congressional District 36, which includes all of the Hill, incumbent Rep. Dr. Raul Ruiz, the Democrat, easily won re-election over challenger State Sen. Jeff Stone. Ruiz has more than 101,000 votes (60 percent) compared to Stone's 65,800 votes or 39 percent.

In the race for the county's 3rd District Supervisor's

seat, incumbent Chuck Washington, a Democrat, maintained a dominating lead from the first announced results Tuesday evening. He currently leads challenger Shellie Milne, Hemet Council woman, by nearly 19,000 votes, a 59 percent to 41 percent difference.

In the race to replace state Assemblyman Brian Jones, Randy Voepel easily defeated fellow Republican Leo Hamel, by a two to one margin. While the Hill resides in this Assembly District 71, nearly 90 percent of voters are in San Diego County. Both counties strongly supported Voepel since Hamel withdrew after the June primary.

For the Hemet Unified School District's three seats, incumbent Patrick Searl was re-elected, but Board President Jim Smith is last among the four candidates. The two new members will be Gene Hikel and Stacy Bailey.

## Five propositions fail Recreational marijuana now legal

Of the 17 propositions on Tuesday's ballot, the state's voters approved all but five. The defeated propositions were: 53, the requirement to gain voter approval before the state can issue or sell any revenue bonds for certain projects, if the bond amount exceeds \$2 billion; 60, the adult film condom requirement; 61, which would have prohibited the state from buying any prescription drug from a drug manufacturer at a price higher than the lowest price paid for the drug by United States Department of Veterans Affairs; 62, the repeal of the death penalty; and 65, shifting the tax revenue on plastic bags to environmental projects.

Riverside County voters generally made the same decisions with a few exceptions. In the county, voters supported propositions 53 and 60. And they opposed Proposition 59, the multilingual education change, and Proposition 67, opposing the ban of plastic bags.

Proposition 67, which approved the legislature's intent to ban plastic bags, passed with 52 percent of state voters' support. However, in Riverside County, nearly three out of every five voters opposed the ban.

Controversial Proposition 64, which legalizes the recreational use of marijuana, was passed easily with 56 percent of the vote. More than 5.4 million votes were cast in favor of it and 4.2 million opposed it. In Riverside County, the vote was closer, 52 percent for and 48 percent against. It will be at least January 2018 before licenses can be issued to sell marijuana. Today, it is legal to possess an ounce and to grow it at home, but it can't be visible from the street.

Three propositions received more than 6 million "Yes" votes. Highly popular were Proposition 52, the Medi-Cal hospital fees, Proposition 56, raising the cigarette tax, and Proposition 58, English proficiency and multilingual education. The latter collected the most "Yes" votes of all 17 propositions, 6.8 million.

Differences of views between Riverside County and state voters were apparent in the results for Proposition 62, the repeal of the death penalty, which received much greater support throughout the state than in the county. Also county voters were less enthusiastic towards Proposition 63, which requires a background check and Department of Justice authorization to purchase ammunition, than the rest of the state. In Riverside County, only 54 percent of voters were in favor of tighter restrictions, but statewide 63 percent favored them.

## School district offers teachers incentive for early retirement

The Hemet Unified School District and the Hemet Teachers Association have agreed to an incentive to encourage teachers to notify the district before the school ends if they plan to retire or leave the district.

This year, the district and the HTA have negotiated an agreement that offers teachers who plan to leave the district at the end of the school year \$1,500 if they make the commitment through a resignation letter by Jan. 20, 2017.

Any permanent teacher who plans on leaving the district after the 2016-17 school year is eligible for the payment.

Once submitted, the decision cannot be changed. The agreement states, "Resignations and retirements of par-

ticipating employees are irrevocable." The incentive will be paid in April. However, an individual can decide later in the year to leave or retire, but would be ineligible for the bonus.

The advantage to the HUSD is the early knowledge of number of vacancies that will have to be filled for next fall. Normally, teacher attrition is between 18 and 25 individuals district-wide and Vincent J. Christakos, assistant superintendent for business services, does not expect this incentive to augment the number of separations or retirements.

"It will allow the district to start recruiting replacements for the positions sooner," Christakos said. "Many teachers wait until the end of the school year to let us know they are leaving or retiring. May and June is very late to start searching for replacements."

With the number of qualified teachers decreasing, the additional recruiting time will help the district find better staff, Christakos added.

# Candidates for Idyllwild Water vacancies address public

The Idyllwild Water District lost two of its five directors in September. Former President James Billman and Director Mike Frietas resigned unexpectedly within the same week.

The remaining directors have not been able to appoint replacements because Vice President John Cook prefers to wait and hold an election in March 2017. Regardless of the victors, the newly elected directors would have to stand for re-election again in August 2017.

California Government Code section 1780, subdivision (f)(1), authorizes a county's board of supervisors to appoint replacements after 60 days of the resignation.

Four individuals — Geoffrey Caine, David Hunt, Dr. Charles "Chip" Schelly and Vic Sirkin — have decisively expressed their interest in serving on the IWD board.

Whether IWD ultimately holds an election or the Supervisors appoint the replacements, the Idyllwild Town Crier organized a forum for these individuals to speak to the district residents. The forum was last week, Thursday, Nov. 10.

Below are some of the questions posed to the candidates and their responses. More of the discussion will be in next week's paper.

## Q. If appointed, would you run for the 4-year term next year [in August 2017]?

Each person answered differently. First, David Hunt strongly said "No." Geoffrey Caine said he did not know for sure at this time. Dr. Schelly unequivocally said, "Yes" and Vic Sirkin replied, "I'd take that option."

## Q. Please summarize your take on advantages and disadvantages of merging the three local water districts [— Fern Valley, Idyllwild and Pine Cove]. Is it feasible?

VS: Yes it's desirable and ideal in the right circumstances, but it's not feasible right now. It will take one or two years for IWD to improve its image in the other districts.

GC: I'd love to see that. Until other issues are taken care of, I can't see us at the district beginning to connect with them.

DH: I don't think that's feasible. Fern Valley is a different type of district. [IWD is a county water district governed by its registered voters. FVWD is a state water district governed by its property owners, whether they live in district or not, and they have more votes the more property they own.]

Pine Cove wants nothing to do with us unless it's a hostile take over. While it's not feasible, we can work together more.

CS: If we would move in that direction and they want to move, today is the best time. If there are problems with consolidation, it's something to work toward.

## Q. What do you believe is the main purpose of a water district?

CS: Safe water and sewer service

GC: We need to work at two levels. Provide reliable

water — good and healthy — for the district's customers. Secondly, given the magnitude of the district's impacts, we have a larger role to help build community.

DH: Provide safe water quality, reliable wells, and let the community know the water company works for them.

VS: Well restoration, reliable and clean, safe water, sound financial judgment, maintenance of infrastructure and treat everyone with empathy and compassion. We need to be a transparent board.

## Q. What are your thoughts on a tiered billing rate system for water use?

DH: It serves conservation and you pay more if you use a lot.

VS: It's certainly important to have a tiered system. The higher charges are a way to encourage water savings. But you can't charge more for water than the cost of production. A tiered system prevents some of the public from using excessive water. I'd be in favor of charging more if justified.

GC: I'd be generous in tier 1 so people, who are not well off, get adequate water. And charge more for tier 2 and higher.

CS: I'd be aware of how much money it brings in above the base rate. For me this is very personal. We have a low flow toilet, low flow showers, and three kids and with a lot of laundry. That adds up. I'd offer a tier for families trying to conserve water. Even if a family has three, four or five kids, it would be nice to qualify for the base rate if you're not wasting water. Then I'd have two or three more tiers.

## Q. Of what concern to you are the by-laws or operating procedures for IWD? What would you consider doing to make these more transparent to the people of Idyllwild?

CS: I'd go back to get a certificate from the special district's Center for Excellence. Things should be post-

ed on our web site before the meetings under Brown Act. A lawyer tells you the minimum you must do to comply with the law. But we should go beyond for the public and provide information for public. Website doesn't cost anything to print for paper or ink. We can put documents online so public has all the information at its fingertips.

VS: I've asked for a copy of Idyllwild's bylaws, but they have no bylaws. I received a pile of paper with various policies and procedures. I'd research the bylaws of the other districts, then extract the best to create a set of bylaws. Then we'd have something we could use.

GC: I've been researching how to set up special districts. Why don't we have any bylaws? We have to have a set of procedures.

The second issue, I don't know what we can do. We need a simple set of bylaws. [GC then referred to an incident at a meeting where one of the directors had to step away from the dais. Cook would not delay a vote to wait for the director's return.] We need a foundation of etiquette to work together as human beings. We can begin small and grow.

Drown my puppy. Steal my chocolate. Put me in a dress. The guy knew how to get up my nose. Ah, all the while the key was in his pocket.

Zip ... one side ... zip ... two sides. I held my breath, craning to see.

The suitcase contained bottles of rum. Bacardi, a lot of it. No wonder he had such a hard time getting it up the stairs. Packed three deep with layers of socks, underwear and wrapping paper protecting them.

No present for me? Apparently not.

He offered me a cigar.

"I'm glad you're home," I whispered into his sleeve. And meant it.

There is no accounting for love.

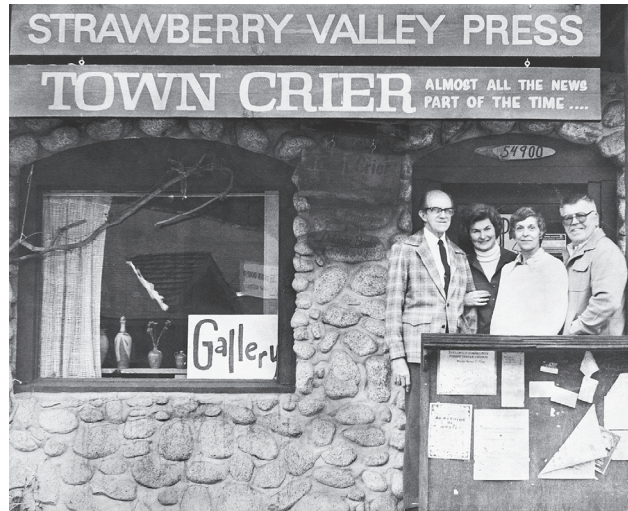

The Wildcats played two games this weekend. The first was Saturday against Orange County Hockey Club.

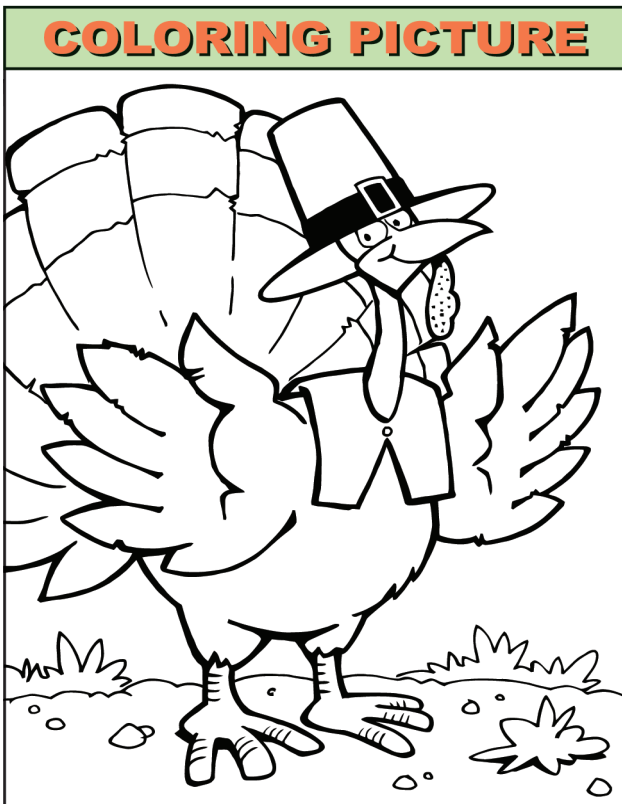

planned the scenic flyover to aerially reacquaint Womack with the mountain and the condition of browned-out and dying pines in the Idyllwild area. Womack lives in Hawaii but has a cabin in Idyllwild.

When the emergency began, Pelham thought to send a “mayday” but had too little time to do so as he worked through available options. First, he switched back and forth between fuel tanks and tried to determine if the electric fuel pump was working properly. With no response from the engine and a forced descent beginning, he next had to set the best glide speed to give them the most time in the air before emergency landing. And finally, and most importantly as it turned out, Pelham and Womack had to scout and pick the best emergency landing site in an urban Hemet Valley area with residences, commercial buildings and highways with traffic.

At just after 10 a.m. on a normal workday, traffic on local streets was busy, especially on potential landing target Florida Avenue. “Our first choice was a dirt road near the Santa Ana River, but I saw we were not going to make it,” said Pelham. “Second choice was an open field near the road, but we were not going to make that either. So I cranked the plane into a gentle left turn and took the rough field that was our last available option.

“You can’t see relief [ground condition] from the air, how high things are or how rocky an area is.” What they could not tell, until just before landing, was just how rocky the rough field was. As Pelham prepped the landing, Womack looked out the window from about 15 or 20 feet altitude and said, “Oh, this is going to be rough.”

“Flaps out, yoke back hard, touchdown with a good attitude, and immediately the soft dirt and rocks flipped the plane over violently,” recounted Pelham. The impact hurled Pelham and Womack backward into the luggage area of the small single-engine plane, an area that was structurally one of the strongest in the plane. The plane came to rest on the Soboba Reservation at the dirt extension of Indian Creek Road. It was upside down and both Pelham and Womack were trapped inside. According to a Riverside County Sheriff’s Department press release, deputies and emergency personnel responded to the crash at 10:41 a.m.

“With the condition of the plane after impact, no one could believe neither of us was significantly injured,” said Pelham. “We could have walked away, but we were pinned in the plane and had to be extricated by emergency responders.” And because it was an aircraft crash, emergency personnel were required to backboard and transport both Pelham and Womack to Riverside County Regional Medical Center in Moreno Valley, a trauma center.

“We were extremely fortunate,” said Pelham. “I have the mother of all stiff necks, but we are both fine with no serious injuries.”

Pelham said he does not know what caused the fuel emergency. He noted his craft did not have a fuel gauge in the traditional sense. Fuel consumption can be tracked during flight by viewing narrow glass tubes with float balls, but there is not a traditional fuel gauge on the instrument panel in front of the pilot.

According to information about Pelham’s plane, the Grumman AA-1C Lynx, those tubes can be “hard to see” during flight. Pelham explained that the tubes, one for each tank, are located on the left- and right-side

bottom front of the cockpit of the plane near where the legs of the pilot and passenger are — legs that block easy viewing of the tubes during flight.

Having conducted a pre-flight check before taking off, and knowing the time they planned to be in the air, Pelham did not anticipate a fuel shortage. Adding to the mystery of apparent fuel loss, Pelham was told by the company that transported the plane to an inspection holding site after the crash landing that there was fuel left in one of the tanks. The company representative estimated about 4 to 5 gallons remained in one of the 11 gallon tanks. “I’d love to have an answer,” said Pelham. The investigation of the cause of the crash is being conducted by the National Transportation Safety Board and the insurer of the craft.

What is extraordinary is for both Pelham and Womack to have survived relatively unscathed in a landing that crushed much of the plane. And for Pelham to have maintained clear focus during the descent and to have calmly determined landing site options least likely to injure people on the ground, was a testament to his training and level-headed handling of the crisis.

Even after the crash, Pelham was working the problem. He had had a camera around his neck while flying over Idyllwild and used it to record the widespread browning-out of pines in the downtown area. After the crash, with the camera still around his neck while he lay flat on a backboard, with emergency personnel around him, Pelham raised the camera, turned on the video function and scanned the side of the plane nearest him from one end to the other. “I also took some stills to document the damage,” said Pelham.

of her close friend and fellow quilter, Sally, promptly shaves his head to let her know she is not alone.

As the chemo therapy concludes, she is faced with the news that this time around the treatment has achieved no positive results. She’s once again bald and now facing a mastectomy and radiation. Lawler, mentally donning the robes of a warrior, announces to her quilting friends that she is going to get a tattoo on her breast; one that clearly tells cancer what she thinks of it. She can’t wait to see the first nurse or doctor who happens upon that declaration forever inked onto her skin.

Joined by half dozen or so friends at the Hemet tattoo parlor, she’s completely surprised to see that many of those in her posse also have appointments. Lawler is not alone in this new experience as she witnesses a variety of tattoos blossoming on the chests, arms and legs of quilting grandmothers. “In that moment I was overwhelmed by this sense of protection, surrounded by my friend’s laughter. Their support empowered me and left me thoroughly delighted,” Lawler concludes.

The tattoos barely healed, Lawler is headed this lovely fall day to A Cut Above Salon and Day Spa located one half block from where the quilting group holds their monthly meetings and workshops. Today her heart is full at the news that Carmen Terrazas, close friend and quilt guild president, is having her shiny, shoulder length locks completely shorn so they can both run around town in snazzy hats. “Just what I needed,” Lawler muses, adding, “If people could grasp how impactful these gestures can be, right when one feels the most alone, they wouldn’t hesitate sharing their life-affirming gift of friendship.”

The following week’s itinerary is discussed, confirming that Lawler’s sister and niece will be driving her to the hospital for the mastectomy. The surgery-day game plan continues as carpools are set for the hospital-bound warrior friends. A lively debate ensues as to who is preparing what meals to stock in Lawler’s refrigerator during her recovery.

Once again, there it is: that bond of friendship popping up like cheerful detour signs in the face of cancer.
