Uncertainty when water district vacancies will be filled

Cook prefers spring or sooner

In the middle of September, two Idyllwild Water District directors unexpectedly resigned but Acting Board President John Cook asserted that the vacancies would remain unfilled until a special election was called, no earlier than March.

Whoever won that election would have to be re-elected for a full term in August.

After the meeting ended abruptly

and in chaos, the board had not met until Wednesday evening, Nov. 16. A week earlier, a Town Crier Candidates Forum was held for prospective directors. Four local residents — Geoffrey Caine, David Hunt, Dr. Charles Schelly and Vic Sirkin — stood up and explained their views and reasons for wanting to serve on the board. Cook was not present.

As IWD's November meeting began, Caine addressed the three remaining IWD directors and requested they defer any actions until the December meeting. He said

Idyllwild Water board finds some areas to agree

Water consumption increasing

The Idyllwild Water District board met Wednesday evening and finished the meeting before adjourning, even taking some actions. Two vacant board seats were not sufficient to prevent the three current directors from transacting some business, although many items were deferred or tabled until the regular December meeting.

The hiring of an interim general manager was one item that may occur before that meeting. The three directors requested Hosny Shouman, chief financial officer, to advertise for an interim or part-time general manager. Next they agreed to a special meeting on Dec. 9 to interview possible candidates.

Shouman has been collecting general manager applications and said already three people have expressed interest in the interim position.

The Dec. 9 date was acceptable to directors Steve Kunkle and June Rockwell because they hope 3rd District Supv. Chuck Washington will have appointed two people to fill the board vacancies. Therefore, a full board could make the selection.

The other issue, to which the three could concur, was a request from a customer whose property was disturbed because of a pipeline leak. The plans for new pipeline in the area would also affect the same property, so the board had Shouman contact the individual to negotiate an agreement. The customer wanted an explanation of the time frame and agreement to repair the driveway surface after work was done.

Four other items were deferred for future meetings, at which Kunkle and Rockwell hope there will be five directors present. The first was authorizing Shouman to hire engineering and wastewater employees.

Cook felt that the work and reports were more technical

Collision sends local to hospital

A serious injury collision on Saturday, Nov. 19, sent one local woman to the hospital. The California Highway Patrol's preliminary report stated that at 5:05 p.m., Edwin Hansen, 66, of Idyllwild, was driving his 2006 red Honda CRV eastbound on North Circle Drive in Idyllwild, just east of River Road, when he struck "a pedestrian," Cynthia Hinds, 56, of Idyllwild.

Hinds suffered serious injuries. According to son Kurt Hinds, injuries included a fractured pelvis, bruised adrenal gland and possible liver damage. After the incident, Hinds was transported by Mercy Air to Desert Regional Medical Center in Palm Springs.

Hinds and husband Rick had bought and just completed renovating Strawberry Creek Village vacation rentals at the corner of North Circle and River Road. The Hinds, recently relocated from the Bay Area, had scheduled a formal Open House on Sunday, Nov. 27, but that has been cancelled because of the incident. Hinds' recovery may take significant time.

What is unclear as of this writing is Hinds' location at the time of the incident. According to family and Hinds herself, she was on her property, about 10 feet from the roadway adjusting a Malibu light that was illuminating a recently placed sculpture. The CHP report notes she was a pedestrian but the report is not clear as to her exact location.

CHP Public Information Officer Darren Meyer said the investigation is ongoing.

Several witnesses across the street from the incident also said it appeared to them that Hinds was not on the street but on her property.

Hansen said he can't remember what happened — that he didn't see anyone and only knew he had hit

someone when he heard screaming.

Meyer said it might take eight to 10 days to complete the investigation.

In other on-Hill collisions, at 5:15 p.m. Saturday, Nov. 19, Shelly Alcala, 53, of Idyllwild, was driving her 2016 black Ford Fusion northbound on Highway 243, 1 mile north of Mt. Etna Road when she made an unsafe turning movement and collided head on with a 2006 tan Toyota Highlander driven by Julian Muller, 32, of Boulder, Colorado. Muller had been driving southbound on Highway 243 at the time of the collision.

Alcala was cited for driving under the influence (alcohol). Although there was major damage to both vehicles, no one was injured in the crash and no other vehicles were involved.

An off-Hill fatality collision involved Idyllwild Arts alum, Arthur Pembroke, 20, of Sky Valley. Pembroke was discovered in his vehicle, a 2000 silver Ford Taurus, on Saturday, Nov. 19, near the intersection

of Dillon Road and Long Canyon Road in Desert Hot Springs. According to the CHP report, Pembroke's vehicle left the roadway and hit a tree either on the night of Thursday, Nov. 17, or the early morning of Nov. 18. Pembroke was killed in the crash.

Pembroke was remembered as a talented actor and engaging personality on numerous Facebook posts.

Fern Valley water resources in 'good shape'

At last week's Fern Valley Water District board meeting, General Manager Victor Jimenez reported that water conditions were stable. While creek flow has declined in October, he relied on wells for a larger portion of the district's water source.

"The well levels have moved very little, which is great," Jimenez said. "There is no [water] issue. Everything is moving very smoothly."

President James Rees asked if the water resources would remain stable if the drought were to continue into the summer of 2017.

"We're in good shape," Jimenez replied. "If the creek were to dry up, we would use our wells more. But we're only using a fraction of our well water. If we were to use

the wells more, it will be more expensive to produce water because of the pumping costs."

In October, the wells supplied about 43 percent of the water, which is about 2.5 percent more than last year.

During the September and October billing period, FVWD customers used 5.9 million gallons, which is 4.7 percent greater than the 5.6 million used during September and October 2015.

The consumption this period is about 33 percent less than in the July and August billing period. Jimenez attributed the reduction to lower temperatures and less irrigation in the district.

Since January, Fern Valley consumption has been 28.3 million gallons, which is 2 million gallons or 7.7 percent more than the first eight months of 2015.

Compared to 2015, water production in 2016 has increased in all three Hill water districts. Idyllwild Wa-

ter District has had a 10.5 percent increase, but still less consumption than in 2014 or 2013.

Pine Cove Water customers have used 27.3 million gallons, which is about 370,000 more gallons or 1.4 percent more than last year, but also less than the two prior years.

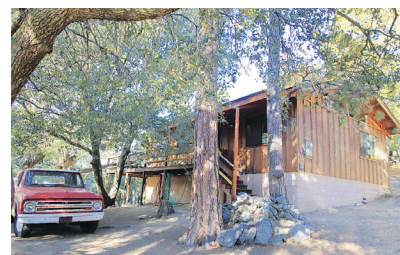

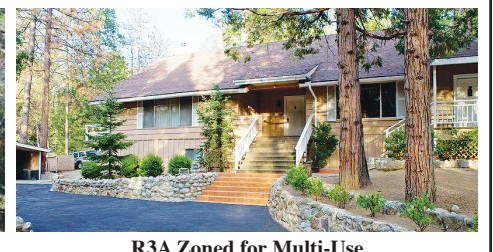

Editor's note: Co-publisher Jack Clark is writing "Out Loud" this week:

For the Nov. 16 Idyllwild Water District meeting, Acting Board President John Cook hired an armed, uniformed sheriff's deputy at a cost of \$300 because of disturbances at the Sept. 22 meeting caused by one member of the public and "a reporter," he said.

After the meeting, Cook confirmed to me that he had been speaking of JP Crumrine of our newspaper — the only reporter who covers IWD meetings. Hiker dies in Round Valley

Hikers on the Round Valley Hiking Trail discovered an unresponsive 46-year-old man in full cardiac arrest around 4:30 p.m. Friday, Nov. 11. Hikers notified rangers at the mountaintop Tram Station.

According to Mark Hudgens, state park superintendent, rangers went to the scene with an automated external defibrillator. Hikers who had found the man had been administering CPR, but to no effect. Similarly, according to Hudgens, rangers could not revive the man using the AED. The subject was pronounced dead at 5:15 p.m.

The man was identified as Jose Antonio Macias, 46, of Los Angeles. The elevation at which Macias was discovered is 8,816 feet. "He had been hiking. We don't know whether it was a day hike or he had been camping," said Hudgens. "The death is currently under investigation."

County seeking help for homeless census

"We're looking for volunteers to help us with Point-In-Time, an annual counting of homeless within the community," stated Supv. Chuck Washington, 3rd District.

The Point-In-Time census will be held Jan. 27, 2017, throughout Riverside County.

"This count is used by the Department of Housing and Urban Development not only as a measure of the homeless population, but also as a basis to determine many of the resources and funding the county receives from HUD and other federal funding sources to address homelessness in Riverside County," Washington added.

Part 2: Candidates for Idyllwild Water vacancies address the public

The Idyllwild Water District lost two of its five directors in September. Former President James Billman and Director Mike Freitas resigned unexpectedly within the same week.

The remaining directors have not been able to appoint replacements because Vice President John Cook prefers to wait and hold an election in March 2017. Regardless of the victors, the newly elected directors would have to stand for re-election again in August 2017.

California Government Code section 1780, subdivision (f)(1), authorizes a county's board of supervisors to appoint replacements after 60 days of the resignations.

Four individuals — Geoffrey Caine, David Hunt, Dr. Charles "Chip" Schelly and Vic Sirkin — have decisively and publicly expressed their interest in serving on the IWD board.

Whether IWD ultimately holds an election or the supervisors choose the replacements, the Town Crier organized a forum for these individuals to speak to the district residents. The forum was Thursday, Nov. 10.

The Nov. 17 issue had part one of the forum's questions and answers. Below are more of the questions posed to the candidates and their responses.

Q. How do you believe climate change is affecting the local water supply for IWD and the other two water districts? How does this shape your opinion about "will serve" letters?

DH: We need to pay attention to our water sources. "Will serve" letters have to be coordinated and worked with Riverside County planning staff. In some cases, you can't supply water.

VS: That's the paramount question in a period of climate change. The reality is life on the mountain is different than in the flat lands. We have precipitation, no agribusiness, no burgeoning population. We should find a professional, independent [water] engineering company to develop a comprehensive capability plan. For example, ask them how much rain do we need to re-charge our wells?

Before denying a water meter, give the property owner, in writing, an explanation for why they can't have one. It should not be an arbitrary water board decision. They are not de facto economic decision makers. We should sell meters if we have water and; and if not, no.

CS: We know we haven't had the precipitation we'd like for several years. What are our well levels — up or down? Do more research and identify some indicators of precipitation and wells.

We shouldn't deny "will serve" letters because we think the worse. The best solution is to get additional opinions on what we have and need.

GC: In an ideal situation, 10,000 gallons captures all water running off roofs. We need water in the long term. The policy of the board should be to guarantee more service. Rain water is a place to begin.

Q. Do you have any relationship, as a board member or otherwise, with the Idyllwild Community Center?

CS: I have no connection, but I do like it. It's a good project and I support it.

VS: I'm strongly in favor of the community center. The contention that the facility would use too much water is mistaken. There's no irrigation. They could use a 5/8-inch line, but are required to use 2 inch simply for the water sprinkler system. The community center will be built to safe earthquake standards and in event of a major quake here, it could help us.

DH: I serve on the County Service Area 36 Advisory Committee. We may handle recreation in the future, but I'm not in favor of the pool.

GC: No.

VS: Pool is a contentious topic, but offers opportunistic service of water in case of fire; it's a dual purpose.

Q. Are you aware of the board of directors' compensation per meeting? And what is your view of it?

DH: It's \$100 per meeting and I'm willing to forego it.

GC: It used to be \$50 per meeting and became \$100. I'd like to go back to \$50.

CS: I want a box of chocolates.

VS: I'm not planning to take the stipend and not interested in the money.

Q. What qualities can you bring to the board?

DH: One quality that I bring is knowing the community for a long time; also, the ability to work as a team member and solve problems.

CS: I research things well.

GC: A long time ago, I studied and understood the nature of legal procedures. I know group processes and how to help people work together.

VS: I was an electronic technician, workforce engineer with a technical background and in real estate for 30 years. I'll look for the balance between property rights and stewardship of water.

Q. Are you aware, according to a report from the IWD board, that nearly all of IWD wells are not working and have not for several years?

DH: I wouldn't say "nearly all are not working," but they need a lot of maintenance.

CSA 38 awaits several equipment purchases

Type 6 engine expected in 2017

The County Service Area 38 Advisory Committee (Pine Cove fire and ambulance) reviewed the various projects funded in its 2016-17 budget at its Nov. 16 meeting.

The Bautista Division Chief Bill Weiser, Riverside County Fire Department, reported that estimates for the masticator and chipper have been obtained. Their purchases will occur within the next couple of months. The estimated cost of the masticator is \$46,000 and will have to be processed through the county's purchasing department, according to Michael Franklin, CSA project manager in the county's Economic Development Agency.

Acquisition of the Type 6 engine should occur before summer, Weiser assured the committee. However, the county fire department's equipment committee is still working on specifications for these units, since it plans to buy several for deployment throughout the county.

A couple of projects will require more time before their approval or purchase is completed. A question has been raised about the five water hydrants, which will cost \$16,000. The staff of 3rd District Supervisor Chuck Washington and county counsel will discuss a possible conflict-of-interest issue.

The CSA 38 committee includes two board members

VS: IWD has more than 27 wells but uses only nine or 10. Seventeen wells are not being used, or are damaged or abandoned. This should part of the study — how many do we rehabilitate.

CS: I was not aware of that study.

Q. What is your knowledge of and intention regarding the reclaimed water grant and project?

CS: We have time, I suppose, to save unrecoverable water, but we need to recover the costs; otherwise, we've spent a lot time and energy deciding it wasn't effective.

GC: We're damned if we do and damned if we don't. Already spent modest amount of money, and it may cost even more.

My initial impression is to cancel it and go after more potable water. Really difficult to know based on conversations.

DH: The grant money is not spent, and I don't support it.

VS: I agree with everyone else. It appears to be a failed project and we have to repay the grant funds. State refuses to grant approval to deliver the recycled water to Dutch Flats and Pine Cove residents don't want it. Again, I suggest an independent study and analysis of its costs and benefits. Make clear we have to answer taxpayers.

and the general manager from the Pine Cove Water District. The supervisor wants to ensure that acquiring the hydrants, which are for fire protection, does not pose a conflict with the water district.

Since this purchase is being made jointly between CSA 38 and PCWD, it will not be delayed, according to Franklin. But the supervisor wants to get clearer guidelines to answer the question in the future.

Work on the station's deck and the shade covering in the rear also have been slowed at the county level. Weiser expressed disappointment that more planning may raise the cost of this work, perhaps as much as 40 percent.

Nevertheless, he stressed that he and his staff were investigating alternative approaches to accomplish the work at less cost.

"We're trying to be good stewards of the CSA funds," Weiser said. The shaded cover area behind the station, while on PCWD property, is to protect the fuel tanks and to cover the station's squad unit after the Type 6 engine arrives.

A similar delay has occurred with construction for the deck along the station, Weiser said.

County fire is moving forward with the shaded fuel-break project on the Ernie Maxwell Trail, Point of Rocks and other areas in Pine Cove, according to Weiser. "But we're not starting pile burning yet. The county has to lift the open-flame ban," he said.

Propane prices likely to be higher this winter

Editor's Note: As winter begins, we resume our series on propane pricing and trends over the upcoming heating season. Each week we'll interview a local supplier spokesperson about their company's policies. Next week we'll begin listing price per gallon and other charges for all companies that serve the Hill and agree to provide pricing information.

To recap from last year: propane prices are not government regulated. They are market responsive, based on what it costs local companies to buy, store and distribute propane to residential and business users on the Hill. And because propane prices are not government regulated, they are sometimes negotiable, depending on the particular business model of the local supplier.

Because prices can be negotiated, it is important to know what questions to ask in addition to price per gallon before contracting with a local supplier — such as: what is the price per gallon (ppg) for new user “first fill” as opposed to ppg for existing customers; difference in ppg if the tank is owned by customer instead of leased from propane provider (ppg for customer-owned tank can be significantly lower); does propane provider sell tanks, and, if so, what is the cost, for either new or refurbished tanks; what does the provider charge for annual tank rentals (those fees can vary widely among area providers); does the provider have large capacity propane

storage facilities either on the Hill or at the bottom of the Hill (if a company has storage facilities, it is better able to keep customer ppg relatively stable when refinery spot prices are spiking); what are the policy differences and additional charges for being on a “fill-as-needed route” as opposed to fill on demand from customer who has elected to call in when they need a fill; and lastly, what charges are there, if any, for “emergency” fills if, for any reason, the propane tank becomes empty?

Based on national surveys from the U.S. Energy Information Administration (EIA), propane prices this year will be slightly higher than last year. Last year saw historically low prices that held throughout most of the winter heating season.

Retail propane prices nationally are based on “spot” prices at points of production. Many are tied to Mt. Belvieu, Texas, refinery pricing. As of Nov. 11, 2016, Mt. Belvieu's spot price was \$0.553. This time last year that spot price was \$0.443. EIA quotes an average national spot price at \$0.659 for the week ending Nov. 7.

Nationally, the average retail delivered price was \$2.061 for week ending Nov. 7, 2016. Last year at the same time the delivery ppg was \$1.919. The difference between spot price and delivered retail price is an up-charge each propane supplier adds to cover their costs of transportation from point of production, storage and truck delivery to end users.

The current ppg breakdown per region for retail pro-

pane delivery is as follows: New England \$2.928; Central Atlantic \$2.758; Lower Atlantic \$2.845; Midwest \$1.484; Gulf Coast \$2.063; and Rocky Mountain and the West \$2.079. Last year at the same time, ppg in the West was \$1.730.

Each week we'll interview other Hill propane provider spokespersons about their views on pricing trends and their company policies on ppg and other fees. Andrew Kotyuk, CEO of SoCal Propane, spoke about pricing trends this year.

Kotyuk expects ppg for his company to stay within the \$2 to \$3 dollar ppg range throughout the heating season. Currently SoCal charges \$2.42 to customers with leased tanks and \$2.12 for customers with owned tanks. Veterans receive an ongoing 10 cents per gallon discount, when they provide proof of having served in the military. Customers who refer another, receive 10 cents a gallon discount throughout the season as does the new referral.

Kotyuk anticipates a “status quo” season — neither a low price season similar to last year nor high price season more characteristic of 2013 and 2014.

Kotyuk said his company is completing escrow on a San Jacinto storage facility that, when finished next year, will give SoCal the ability to store up to 360,000 gallons of propane. “That will allow us to keep our prices more stable,” said Kotyuk.

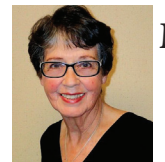

Taylor Dravenstatt sentenced

Idyllwild local Taylor Dravenstatt, 24, previously sent to state prison for felony burglary in 2013, was sentenced for a second felony burglary of a Perris residence that occurred on Sept. 6, 2016.

As part of the minute order from the sentencing proceeding on Friday, Nov. 18, Dravenstatt's burglary charge was reduced from first to second degree. He pleaded guilty to the reduced count and received 36 months of formal probation and a sentence of 180 days.

Dravenstatt was given credit for presentence time served of 74 days, plus an another 74 days for a total of 148 days credit.

The balance of the sentence, 32 days, will be served in the work release program. Dravenstatt was ordered to report on or before Jan. 3, 2017. As part of the court order, priors one and two (prior serious felony conviction and prison prior within five years) were stricken.

After sentencing, Dravenstatt was released on probation. Part of probationary terms requires Dravenstatt to pay costs of probation supervision in an amount to be determined by the Probation Department ranging from \$591 to \$3,744.

Dravenstatt's co-defendants Charles Stratton and Geoffrey Helmick were granted probation on similar terms.

Idyllwild Fire Finance Committee still waiting for adequate reports

Two weeks past the end of the fourth month of the current fiscal year, the financial consultant for the Idyllwild Fire Protection District provided more data for the first three months of fiscal 2016-17.

Commissioner Nancy Layton, also a member of the finance committee that was to review the current financial data said, "October is not complete." She hopes the October and November financial reports will be available for the committee's December meeting.

According to Layton, the new accounting software is not as user friendly as the committee and staff expected. This unexpected consequence is proving difficult for Rob Dennis, the consultant, and his ability to provide timely reports to the committee.

With respect to the first quarter data, Layton recommended that the committee tell the full commission that "... the financial status has been reviewed, but there are too many questions to approve them now."

According to the preliminary reports, expenses were \$113,000 greater than revenue for the three months from July 1 through Sept. 30. This was about a 50-percent increase from the reports provided to the commission in October.

But a deficit at this time of year is not necessarily a major concern. The county does not receive its first property tax receipts until December, which is when it begins to distribute this money to school and special districts.

IFPD has received its \$400,000 request for an advance of the property taxes to help with payroll and other expenses until receiving its property tax receipts

next month.

The committee also did an early review of the Measure W results. This was the proposal to increase its parcel fees from \$65 to \$130. As of Friday evening, Nov. 18, the "Yes" votes totaled 765 or 57.3 percent of the total 1,354 votes cast on the measure. Unfortunately, passage of the measure required two-thirds of the voters' support.

According to the county registrar of voters, about 74,000 ballots remain to be counted.

"I don't think it will make a difference," Layton lamented. "The apathy shown by the citizens, it was such a negative election all the way down to the propositions. I'm not surprised nor pleased with the results."

Committee Chair Calvin Gogerty recognized that the committee would need to address the result in future meetings. "Either we find a way to increase revenues or reduce expenditures, or the capital improvement program really gets hit," he said.

Specific recommendations and plans were not discussed at the meeting.

Gogerty ended the meeting sadly announcing he did not yet have any recommendations to fill the two vacant seats on the committee.

Film festival in eighth year

The Idyllwild International Festival of Cinema enters year eight strong and healthy with 11 days and two weekends in which to see all films. IIFC opens on Thursday, Jan. 5 and runs through Sunday, Jan. 15.

Stephen Savage's idea for an independent film festival began as a valentine to Idyllwild — a way to bring tourists and film professionals to the town that means more to Savage than any other. And an on-Hill festival celebrating film has historical antecedents.

Idyllwild was a much-used location site for Hollywood movies beginning in the mid 20th century. More recently, Savage has filmed several of his feature films here.

To Savage, a festival celebrating independent filmmakers would be both a tip of the hat to Idyllwild's film history as well as an economic boost for the town's businesses.

By expanding the number of days to see films and keeping the local all-venue pass at bargain prices, Savage hopes to woo back the record number of locals who attended year one of the festival. "We'll be screening 125 to 130 films, including many Idyllwild Arts student films, and, with the expanded schedule, locals should be able to see everything," said Savage.

He noted the local pass is \$35 and any church and/

or charity that sells tickets would receive another \$10 discount for their members. "I've always wanted community involvement with the festival," said Savage.

And to make it more convenient for locals and visitors, all films will be screened at only two venues, the Rustic Theatre and Silver Pines Lodge, walking distance from each other. "Both venues are in the downtown area," said Savage. "Thanks to Shane Stewart, the Rustic has state-of-the-art digital projection and sound. At Silver Pines we'll be using a 7K [higher intensity] digital projector and a 15-foot-by-15-foot screen for a great viewing experience."

Formats for the festival remain similar — films, seminars, parties and the always popular awards ceremony at the Rustic. "The only thing we've dropped this year is the music video category," said Savage. "The Rustic will be more involved as a liaison. [New owner] Kevin Nett has been great."

Savage is as excited about IIFC 8 as he was about the first festival in 2010. "I never cease to be amazed that we got this far," he recalled. "It's become a viable and highly regarded independent festival. The question is no longer whether we'll be doing a festival. It's now a foregone conclusion that we'll be doing one every year."

While local support may have dipped, attendance from off-Hill film professionals and visitors has grown. Savage noted average attendance for the shorter six-day festival was from 700 to 900. This year he expects greater attendance given the expand-

ed viewing schedule and the two included weekends.

Savage said part of his focus as a filmmaker, producer and entrepreneur is to encourage and showcase the work of student filmmakers. This year, there will be an expanded segment of Idyllwild Arts student films. "We have a great relationship with Idyllwild Arts film department," said Savage.

There will also be a children's film segment hosted at the Idyllwild Library. The Town Crier will write more about that aspect of IIFC 8 in a subsequent article.

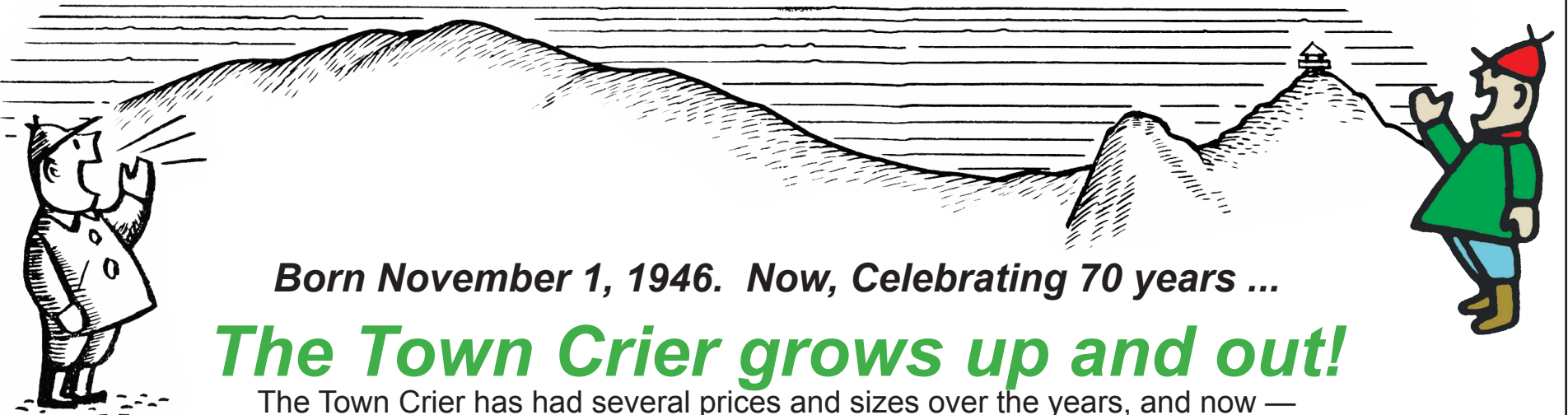

CSA 36 recreation status stalled until new year

Tax-funded recreation in Idyllwild continues under Riverside County Regional Park & Open Space management until January of 2017 when a new recreation provider will be selected. Until then, major decisions are held in abeyance.

A Request for Proposal to manage local recreation was sent out by the county last month and closed at 5 p.m. Wednesday, Nov. 16. Opal Hellweg, 3rd District Supervisor Chuck Washington's legislative assistant, said at the CSA 36 Advisory Committee meeting on Thursday, Nov. 17, that no further information about the RFP respondents would be released until a review of the proposals is completed by a county Real Estate Division/Economic Development Agency panel. That review should be completed within 30 days of the RFP closure, by mid-December.

Bob Lewis, current recreation director, reported that \$45/hour charges for use of the Idyllwild School gym may require raising certain recreation user fees. Meeting attendee Pete Capparelli suggested it might be time to go before the Hemet Unified School District board to renegotiate those fees. Marge Muir agreed, stating, "We worked to clean the gym up after use before without having to pay those fees."

Advisory Committee Chair John Metroka Jr. said, "EDA should know about these fees and see if they can do anything. We need clarification when the new [recreation] management is in place."

Muir also suggested that many local businesses might be willing to help sponsor teams using the gym so that participant fees don't have to be raised.

The Advisory Committee does not meet in December. Its next scheduled meeting is at 5:30 p.m. Thursday, Jan.

Historical issues of Town Crier online and free at library

The Town Crier, the Idyllwild Library and the Idyllwild Area Historical Society have partnered to provide vintage issues of the town newspaper online and free at the Idyllwild Library. Started in November 1946 by Ernie and Betty Maxwell, the Town Crier is one of Idyllwild's oldest ongoing businesses.

Shannon Ng, Idyllwild Library librarian, cited the many questions library staff regularly receive as an impetus for starting the online archive, questions such as: "My parents owned a store here in Idyllwild and I'd like to find any of the advertisements they put in the paper"; "When did the Independence Day Parade begin and who was responsible for starting it?"; and "My sister, my friend and I were photographed for the paper in the late '50s. Can you help me find that picture?"

Said Ng, "Visitors and locals alike pose these questions. Here's the rub. We usually aren't able to answer them without thumbing through bound volumes of the old newspapers. Without specific date information, this can be an arduous and time-consuming task."

So the partnership of the three organizations was born with the goal of digitizing all of the historical issues

and making them available and searchable online — at the library and free to the public. Other than at the library, the archive would be available and searchable through NewsBank.com, but with a fee.

Since 2005, the Town Crier has been digitizing each issue as it is published. These issues are searchable by keyword but that feature is not available to the general public or even at the library prior to the launch of this service. In 2014, IAHS began digitizing the historical volumes and making them available on NewsBank.com (at GenealogyBank.com) but only through subscription.

"We have reached an agreement with NewsBank to complete the digitization and host the database providing open and free access through the Idyllwild Library Public Access Computers, and providing password access for the IAHS and the Town Crier to all the pub-

lished issues from 1946 through 2014," said Ng.

Ng said both the Friends of the Idyllwild Library and IAHS are soliciting donations to pay the \$15,000 cost for digitization. Both organizations have agreed to partner to pay the \$150 annual hosting fee in perpetuity.

Currently available are issues from 1946 through 1980 with a still-unfinished gap of 1967 through 1970, but Ng said those years are being processed now. "It takes about three months to digitize 10 years worth of issues," said Ng.

"We at the library are very grateful for the partnership and the community support that is making this happen," she added. "Our entire community will benefit from having our history available to browse and search here at the library."

Leia: You know, George, they may always call ARF to set up a time to meet.

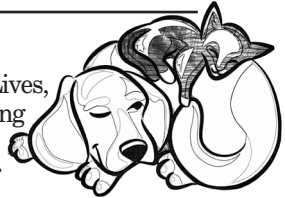

Three random facts we didn't know 100 years ago ...

Around 100 years ago, humans didn't know much about things like genetics, quantum mechanics or why certain foods can actually prolong our lives. So, in no particular order of importance, here we go:

Starting with no. 3. We did not know that DNA is in the shape of a double helix.

As early as the 1950s, researchers working on DNA were almost sure it had lots of genetic information that was passed down from parent to offspring. They could not figure out how this process worked, however, without first knowing its structure.

Scientists Rosalind Franklin and Maurice Wilkins started experimenting with a process called X-ray diffraction where they shined X-rays onto DNA. This experiment revealed a helical structure.

In the early 1950s, this research, along with other experiments dealing with the chemistry of DNA, ended up with James Watson and Francis Crick who were able to piece it all together and come up with the double-helix model.

This model has since pushed modern biology research and a better understanding of how DNA's chemical code can make something as complex as organisms such as ours.

Moving on to no. 2. We didn't know that the universe was bigger than the Milky Way Galaxy.

At the start of the last century, astronomers knew that the universe was filled with things like planets, stars, gases and dust. They did not yet have an idea of how big the universe was, or how certain clouds of gas and dust were spiral-shaped and appeared to be so far away.

This began the debate among astronomers who believed that everything in the universe was contained in our galaxy, including these spiral-shaped nebula, versus those who understood that the universe was much, much bigger.

It was not until the early 1920s when Edwin Hubble used the Hooker telescope located on Mount Wilson Observatory in Pasadena and took pictures of the spiral-shaped Andromeda Galaxy that this debate was settled.

Finally, the no. 1 random fact. We didn't know that hydrogen is the most abundant element in the universe.

Before 1925, scientists assumed that the rest of the universe was made of the same kinds of elements and in the same proportions as planet Earth.

It would not be until astronomer Cecilia Payne-Gaposchkin analyzed the Sun and made a series of observations. She realized that the Sun was mostly made of hydrogen and helium.

The different forms of these elements cause the variations in light we observe. Her 1925 doctoral thesis concluded that hydrogen is about a million times more abundant in stars than previously thought, thus making it the most abundant element in the universe.

I know I'm missing several other important facts or observations but that is why the word "random" is in the title of this column.

Now, if you will excuse me, I have to go place myself in a self-induced coma for the next four years. Feel free to wake me up early if either the Electoral College has been eliminated or scientists figure out how someone who wins by 2 million votes comes in second place.

Obituary Heath "Bo" Bottomly 1919-2016

Heath "Bo" Bottomly was born in Chinook, Montana, on Sept. 30, 1919.

He was a graduate of the University of Montana and the West Point class of 1944, and a decorated fighter pilot who served in the Pacific in World War II, and later in Vietnam and Thailand.

Upon retirement from the Air Force, he was a Christian speaker, storyteller, writer and coach.

He died peacefully at home in Winchester on Monday, Oct. 24, 2016.

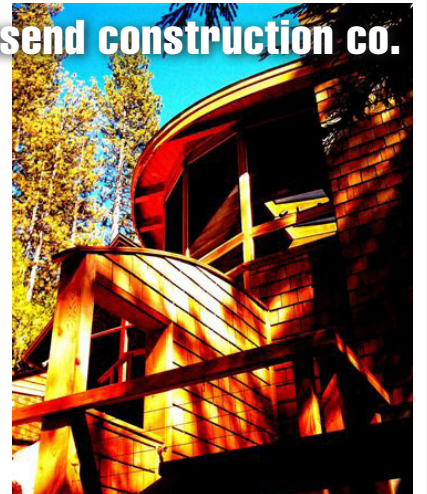

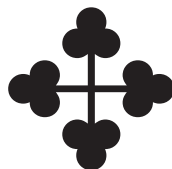

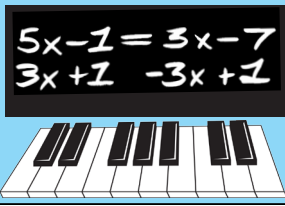

Supervisor John Benoit reduces workload due to illness

Last week, Riverside County Supervisor and Chair of the Board John Benoit, who is also the former assemblyman and state senator representing Idyllwild and the Hill communities, announced he has health problems.

He has been admitted to Eisenhower Medical Center in Rancho Mirage and will undergo tests and treatment. He does not expect to be able to attend board meetings for the next several months.

In a letter to his board colleagues, Benoit wrote, “Weeks of discomfort, dry coughing and extreme fatigue led to my having a CT scan Wednesday. The scan revealed a number of pulmonary embolisms as well as a growth on the pancreas. There are also spots on my liver and in my lungs.”

Expecting aggressive chemotherapy, Benoit has reduced his workload until treatments are complete. But he did say, “... I intend to continue attending board of supervisors meetings, but I may utilize video or teleconferencing.”

Benoit represents the desert cities and east to Blythe on the Riverside County board. He was initially appointed to the board to fill the term of former Supervisor Roy Wilson, after his death.

and outside Shouman’s bailiwick, and recommended hiring the new staff.

“We don’t have a GM and need to keep things moving,” he argued. “We need to keep the well rehabilitation moving so let’s hire an engineer.”

Rockwell expressed disagreement that it had to be done in the next few weeks. Cook failed to mention that the grant for the work had been approved in the summer of 2015 and the district has yet to take any action. Waiting until a full board was able to address the issue would not be critical, she countered.

Kunkle agreed with Cook, but Cook at the last meeting argued that a majority of a quorum was insufficient to make decisions. His opinion is that unanimity on actions was necessary. As a result, the 2-1 vote prevented the hiring of part-time help.

The other three agenda items — negotiating a new mutual-aid agreement with Fern Valley and Pine Cove

that 3rd District Supervisor Chuck Washington, who, with his board of supervisors colleagues, has the authority to appoint board replacements after 60 days, was planning to interview the four candidates later this month.

“Four people are being considered for appointment to the board,” Caine stated. “Interviews are Nov. 22 and an appointment might be Dec. 6. At the meeting in December, there would be a full board. Please table all motions until you have a full board.”

From 10 a.m. to 4 p.m., the public is invited to enjoy games, puzzles, popcorn and other refreshments for free.

Since a formal appointment might be only a few weeks in the future and the IWD board has failed to meet since September, the short delay would allow a full board to address current management and other issues.

While the board did not postpone all the actions, it appeared that Cook had accepted that the two vacancies would be filled through the supervisors. He agreed with his two colleagues to hold a special meeting to interview interim general manager candidates on Dec. 9, after the date the supervisors might act.

However, later in the

meeting, he expressed annoyance that another issue was being deferred until a full board was available. He argued that the positions would remain unfilled until March or April when he would call a special election.

This brought a collective gasp from the audience, who clearly reacted negatively. They want the board filled and taking actions necessary to keep the district functioning, such as hiring a general manager and seeking additional water resources.

Several stories in the Town Crier about former General Manager Tom

Lynch’s assertion that a state water certificate for him was pending seemed to precipitate the resignation of Jim Billman, board president, and Mike Freitas. The former’s resignation was part of Lynch’s resignation note to Cook. These directors, along with Cook, had required Lynch to obtain the permit shortly after hiring him, but had never verified whether he accomplished it.

The State Water Resources Control Board has said several times Lynch failed the exam three times.
