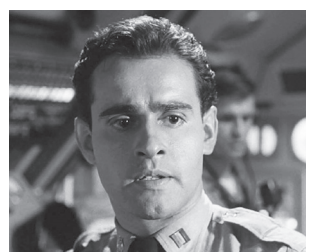

Supervisor convenes all-agency meeting on snow issues

Last January, after several weeks of unprecedented snow-visitor traffic, Riverside County 3rd District Supv. Chuck Washington convened a multi-agency meeting to address issues growing out of the snow-play visitor glut. Washington did so at the request of Idyllwild Fire Chief Patrick Reitz, who was concerned about emergency vehicle blockage by illegally parked cars as well as widespread littering, trespassing and destruction of property both public and private.

Washington recalled the same agencies to a meeting in Riverside on Monday,

Nov. 21, to discuss contingency plans should off-Hill, snow-play visitors again create safety and property-destruction problems. "The purpose of this meeting is to discuss mountain snow emergencies, traffic congestion and safe movement of public safety agencies and vehicles in this environment," said Washington.

Reitz noted the greatest parking problems were in neighborhoods where snow visitors parked in residential areas to play, significantly narrowing roadways. Capt. Joe Borja, Hemet Station commander, Riverside County Sheriff's Department, warned against confrontation with snow visitors. "If people refuse to leave private property, owners can call

Winter weather contributes to traffic crashes

Update on Nov. 19 car vs. pedestrian incident

The California Highway Patrol updated its investigation and report of an incident on Saturday, Nov. 19, involving a car driven by Ed Hansen, 66, of Idyllwild that struck Cynthia Hinds, 55, also of Idyllwild, at around 5:05 p.m.

According to CHP Public Information Officer Darren Meyer, Hinds was on her property, “in her front yard planter area” adjusting a landscape feature when Hansen failed to properly negotiate a left curve on North Circle Drive near the intersection with River Road. Hansen’s vehicle struck Hinds before coming to rest on a large rock landscape feature on Hinds’ property. The initial CHP report had indicated Hinds was a “pedestrian,” seeming to indicate she was on the roadway. Subsequent investigation revised that information.

According to the report, Hansen was not cited but the case was referred to the Department of Motor

Vehicles for “re-evaluation” of Hansen’s driver’s license.

Hinds and husband Rick had just finished renovating existing buildings to create Strawberry Creek Village vacation rentals when the incident occurred. A planned open house and scheduled rentals have been blocked until the first of the year because of Hinds’ injuries.

Winter conditions contributed to at least one Hill traffic incident over the last week.

On Wednesday, Nov. 23, at an unknown time, an unidentified individual was driving a silver 2004 GMC Sierra south on Highway 243 just south of Penn Way when for unknown reasons the individual lost control, veered to the right, and went off the roadway and 150 feet down the mountainside, overturning several times in the descent. The vehicle came to rest on its wheels but the individual fled on foot. The vehicle was registered in Redlands.

At 5:05 p.m. Saturday, Nov. 26, Milton Gomez, 26, of Hemet, was driving

a 2007 blue Honda Civic westbound on Highway 74, three-tenths of a mile west of May Valley Road, when he failed to execute a left curve in the road, drifted to the right and collided with a tree. A passenger in the right front seat, Asia Evans, 21, also of Hemet, complained of pain and was transported to Desert Regional Medical Center in Palm Springs. No drugs or alcohol were involved. Gomez was not injured or transported, and no other vehicles were involved in the incident.

At 2 p.m. Sunday, Nov. 27, Michael Irvin, 29, of La Quinta, was driving his gray 2016 Mazda3 westbound on Highway 74 in the 53000 block when, in winter rain conditions, a white 2009 GMC Sierra struck Irvin’s vehicle and continued on without stopping. In Irvin’s vehicle was passenger Maritssa Cantu, 25, also of La Quinta. The CHP preliminary report did not indicate if anyone was injured or required transport.

Shawn Gooch pleads guilty to abusive behavior

Sentencing set in January

An Idyllwild man has pleaded guilty to inflicting corporal injury with a prior conviction within seven years. The charge is enhanced because the crime was committed while Shawn Gooch, 37, was technically on bail for a previous identical charge.

Judge Mark Mandio will sentence Gooch on Jan. 20. He is expected to enroll and successfully complete a residential substance abuse treatment program before the judge rules.

Without completing the substance abuse program, Gooch potentially risks receiving a sentence of at least four years behind bars. If he completes the program, the judge may grant probation for the term of the sentence.

The incident occurred on Sept. 30 and involved a woman. Gooch was arrested on Nov. 4 and pleaded guilty in court on Nov. 22. The guilty plea included admission that he violated a court order to prevent domestic violence and was awaiting sentencing on a similar charge in May.

Stone announces Senate fellowships

Sen. Jeff Stone (R-Riverside County) has announced the availability of applications for the 2017-18 California Senate Fellows program.

The program provides college graduates an opportunity to become full-time Senate staff members at the state Capitol in Sacramento for 11 months beginning in October 2017. Fellows are assigned to the personal or committee staff of a senator and also participate in academic seminars with senators, senior staff, journalists, lobbyists and state government officials.

Fellows are paid a stipend of \$2,627 per month plus health, vision and dental benefits. They earn six units of graduate credit from Sacramento State University for the academic portion of the program.

"Being a Fellow provides an excellent opportunity to gain first-hand knowledge of the legislative process," said Stone. "Whether your career goals are in the public or private sector, the Senate Fellows program provides valuable training."

Stone said fellows experience the broad range of activities conducted in busy Senate offices. Responsibilities include researching public policy issues, helping develop legislative proposals, analyzing and staffing legislation, assisting with constituent inquiries and casework, participating in meetings as the senator's representative, writing press releases and speeches, and performing other delegated tasks. A five-week orientation at the beginning of the program provides background on state government, the legislative process and major policy issues.

Anyone who will be at least 20 years of age and a graduate of a four-year college or university by Sept. 1, 2017, is eligible to apply. There is no preferred major. Individuals with advanced degrees and those in mid-career are encouraged to apply.

Brochures may be requested online and also are available in the senator's Indio and Murrieta offices.

For more information or to apply, visit the Senate Fellows website (www.csus.edu/calst/senate).

The deadline for submitting applications is Feb. 13, 2017. Eighteen fellows will be selected in May after an initial screening of applications and a subsequent panel interview of finalists.

The California Senate and the Center for California Studies at Sacramento State University jointly operate the fellowship program.

Feeding Idyllwild hummingbirds during winter

As winter approaches, you may be wondering when you should take your hummingbird feeder down. The answer may surprise you. In winter, hummingbird feeders should just be taken down to clean and refill, then it's a good idea to put them right back up again.

The biggest hummingbird myth is that leaving feeders up in the winter will harm our tiny-winged friends as it could prevent them from migrating when they should. It's simply not true.

The experts at the Cornell Lab of Ornithology and the Audubon Society agree that hummingbirds who migrate do so based on their internal clock, not on the availability of hummingbird feeders. As the days shorten, many hummingbirds head for warmer pastures but, luckily for us, plenty choose to winter in Idyllwild. When the temperatures plummet, they need the nectar in our feeders more than ever.

Among hummingbird experts and enthusiasts, there's a difference of opinion on whether or not changing the nectar recipe is a good idea during winter. The recommended year-round recipe is 1/4 cup sugar to 1 cup of water, or 1:4. The Cornell Lab advises that during colder weather, increasing the sugar to 1/3 cup per cup of water (1:3) will help hummingbirds.

Others disagree and insist that sticking with the standard ratio is healthier for the birds. Whose advice should you take? Perhaps another factor will play a role in your decision — freezing.

Hummingbird nectar in the 1:4 ratio will begin freezing when temperatures drop to 27 degrees, preventing the hungry birds from being able to use your feeder. Following the 1:3 recipe is one way to slightly lower that freezing point.

Fortunately, that's not the only way to reduce the chances of your hummingbird feeder freezing. Here are a few other options:

Place your hummingbird feeder under an overhang where it will be more protected from wind and snow.

Try covering the nectar area of the feeder with an insulating material. Our local hardware stores have plenty of options that will still be safe for the hummingbirds.

Install a light near the hummingbird feeder that will let off just enough heat to prevent freezing. Be careful it's not too hot or too close to the feeder.

On nights when we're expecting unusually cold temperatures, bring your hummingbird feeder inside. Just be sure to put it back out just before dawn when hummingbirds need it the most.

If all else fails, purchase a bird bath heater to keep your hummingbird feeder warm.

Additional tips for winter feeding:

If you notice a hummingbird sitting on your feeder but not moving, there's no need to panic or attempt to "rescue" him. He's likely just conserving his energy in order to keep warm.

Never use honey, raw sugar, organic cane sugar, molasses or brown sugar to make hummingbird nectar. While those options may be healthier for humans than refined white sugar, they're not suitable for hummingbird feeders any time of year and can actually harm your visitors.

Be sure to clean your feeder and replace the nectar every three to five days. This eliminates mold and mildew that can be deadly to hummingbirds. Don't use soap on a hummingbird feeder. Just hot water, a brush and a good scrubbing will do the job. If your feeder really needs help, try a diluted bleach solution but then rinse it repeatedly and let it dry completely before refilling it.

We're so lucky to live in a place where hummingbirds can be found all year long. Providing a clean, safe and accessible source of hummingbird nectar will ensure that these magical little birds can thrive no matter what the temperature.

This agency has much business to conduct but current leadership places it in a stalemate. With a five-member board, there's no way one man can block the others' affirmative votes.

The acting president has come up with this outrageous rule that all three must be unanimous in their votes. If not, votes don't pass. And he's enforcing it by steamrolling right into the next agenda item.

It's like he's saying to the two other directors, "I know they voted for you, but they shouldn't have, so go away. I'm making the decisions here."

Requiring unanimous board decisions is not uncommon in a corporation, especially when involving decisions to invest in other company securities.

But IWD is not a corporation. It is a public agency and as a public agency, it should possess a set of by-laws to follow that refer to Robert's Rules of Order.

The first order of business should be electing new officers, as that is traditionally done anyway in December, and doing away with this silliness.

This is why we need our supervisors to waste no time in appointing directors to this board.

I could have opted for chemo and radiation, but I couldn't imagine being sick for months, while not knowing if the poisonous treatments would be effective. Chemo comes from derivatives found in Mustard gas. We know what radiation can do.

They both kill cancer cells, but they also kill healthy cells, and compromise our gastrointestinal tract and immune system so that we cannot fight infections.

Non-target cells, tissues and organs also are damaged.

I didn't want to risk the health that I had worked so hard to attain, so I chose to have a mastectomy.

Because of my decision, I am enjoying my life, here and now. I'm not suffering with the ill effects of chemo or radiation, or wondering what the long-term effects will be.

Fortunately, I retained my good health, and, after a few weeks of recovery, I was able to resume doing all of the things that I love to do. I can take care of myself, and I am there for those who need me.

I could get an implant, or wear a padded bra, or just let myself be how I am — lopsided.

Having less breast does not make you less of a person; it does not diminish your spirit; it does not make you less of a woman. But, if need be, you may have to drastically change what and how you eat, drink and think.

Just say no to pharmaceutical HRT, and chemo/radiation. Less breast is best, for your overall health and happiness.

for such a quick response! However, my question is unanswered. How do I know my vote was not changed?"

And here is their response I got Nov. 26, 2016:

"Official election ballots are opened under dual control, which then are taken into the counting process which is monitored under 24 hour surveillance.

Our Hitler

In our house, Nov. 25 is called Markmas because it is exactly a month before Christmas, and my husband, Mark's, birthday. He loves holidays and adding another is a tradition that our family and friends gladly celebrate.

So what should we call Nov. 25 now that the day has been tainted by the death of the tyrannical Cuban dictator Fidel Castro?

Castro's passing is politically irrelevant, yet "mourned" by many in the streets of Havana (whether they want to or not). Nine days of mourning have been ordered. That means anyone caught listening to a radio or watching television or just humming to himself — even in the privacy of their own home — will see consequences. So if you're grappling with the terms "tyrannical" and "dictator," this should resolve that conflict.

Simultaneously, in Little Havana there is loud and joy-

ous celebration. Enormous Cuban flags are paraded down 8th street alongside the U.S. flag, a commemoration of the adoptive country that constitutionally guarantees their freedom of assembly.

Although Cubans are known around the world for their music, there wasn't a musical instrument in sight. Instead, there was the traditional beating of pots and pans, and I was delighted that this tradition now includes banging on electric rice makers. We are, after all, Americans now.

During television coverage of Little Havana, an English-speaking Cuban man put down the celebratory pots and pans just long enough to deliver a provocative sound bite, "He was our Hitler."

The comparison, which gets bandied about quite frequently, has never felt appropriate to me. There is no comparison between the systematic extermination of more than 8 million people, with the inconveniences caused by a charismatic and arrogant dictator adept at unmitigated hypocrisy, making political deals that, above all, lined his own pockets, and turning a once prosperous nation into a morbid tourist attraction like Alcatraz and Auschwitz.

If there's a similarity between the Cubans and the Jews, it might be their sentient cry of, "Never forget."

But is not forgetting enough? How has not forgetting served us? As a sinister new administration steps into the White House, the muffled cry in too many hearts appears to be, "Could it happen here?"

For those grappling with the word sinister, look no further than the appointment of alt right leader Steve Bannon as chief strategist.

The answers will be much more clear come Markmas.

MCFSC PLANS COMMUNITY MEETING ...

As we start the last month of the year, the landscape around us is going through its annual change that takes place during this time. Leaves have changed color and quickly taken their place on the ground.

The telltale smell of wood stoves in the early morning and evening brings warm thoughts. Darkness comes much too early with the recent time change.

The deer that seemed to disappear during October hunting season have ventured back to their usual places on the Hill and around town.

While we expect these things to happen this time every year, something else that has become a common sight throughout this year has been the number of trees slowly turning brown.

The number of dead or dying trees that are evident all across the Hill show that our years of drought continue to stress these

giants that rely on a greater amount of annual water than we have had. This has allowed different types of bugs, mostly bark beetles, to further their demise.

The drought is also affecting the oak trees, which the Gold-spotted oak borer continues to assault. This bug continues to move through the oaks and is usually fatal to this tree within years after infestation.

The Mountain Communities Fire Safe Council, along with the local foresters of both Cal Fire and the U.S. Forest Service, are planning a community meeting on Saturday, Jan. 28, 2017. The purpose is to bring information, updates and an explanation of past and future projects to the public about our forest. Speakers from the University of California, Riverside, will participate.

Mark your calendar and watch for the location of this educational meeting.

Part 3: Candidates for Idyllwild Water vacancies address public

The Idyllwild Water District lost two of its five directors in September. Former President James Billman and Director Mike Freitas resigned unexpectedly within the same week.

The remaining directors have not been able to appoint replacements because Vice President John Cook prefers to wait and hold an election in March 2017. Regardless of the victors, the newly elected directors would have to stand for re-election again in August 2017.

California Government Code section 1780, subdivision (f)(1), authorizes a county's board of supervisors to appoint replacements after 60 days of the resignations.

Four individuals — Geoffrey Caine, David Hunt, Dr. Charles "Chip" Schelly and Vic Sirkin — have decisively and publicly expressed their interest in serving on the IWD board.

Whether IWD ultimately holds an election or the supervisors choose the replacements, the Town Crier organized a forum for these individuals to speak to the district residents. The forum was Thursday, Nov. 10.

Part 1 of the forum's questions and answers was in the Nov. 17 issue and Part 2 was in the Nov. 24 issue. Below are the remaining questions posed to the candidates and their responses.

Q. Cal Fire identifies water availability through hydrants on the rim of Idyllwild as limited. Given that IWD has the fewest steamer hydrants and lowest water fire flow per resident on the mountain, will you upgrade lines and hydrants on the rim?

CS: I have been a volunteer fireman at IFPD. I know several places on the Hill where [water] pressure is inadequate. I don't think the fire department did the test, but after several years, we definitely need to upgrade several lines.

DH: I'm in favor of upgrading the lines.

VS: This really speaks to the quality of the general manager we hire to address this issue.

Q. Are you for "No growth?"

CS: I'm for limited growth. I like to support new people.

GC: It's the nature of a small town. I would oppose high rises, but no growth is stagnation. I will prefer limited growth.

DH: General population, yes. We can't generate changes. That's why Idyllwild is a unique community.

VS: No. If 15,000 people want to have resources to build, our board shouldn't control growth. We will sell water if we have it. What is the status of our water supply is what we need to know.

Q. Of these five actions, which is the most critical for IWD and which is the least?

1. Hire a new manager
2. Replace the water lines
3. Repair existing wells
4. Issue new water meters for additional revenue
5. Drill new wells

DH: Hiring a manager is number one for me. That will get the whole operation going. Number two is maintenance of wells and third would be water line replacement if old lines rupture.

GC: Hiring a manager is first priority. Then the manager works with the board to determine the priority of the other issues.

VS: Hire a manager is clearly important. Then replace old water lines. We can't sell water without substantiation of its availability.

CS: I disagree with Geoffrey. The board, not the manager, develops the priorities. Board has to have consensus to tell manager.

GC: Board give priority to manager who can work with board. The ultimate responsibility for the decisions is the members.

Q. Would you limit public discussion at the monthly IWD public meetings?

CS: I go for transparency at the meeting. It's the public's meeting, not the board's meeting.

The public comes to listen and learn, which is good. But they also come to tell the board what they need and want. We can't do everything, but we should listen to the comments and try to meet them.

VS: Personally offended by the current 4-minute limit. If a person is going on and on ad nauseam, then certain limits are needed to keep them from going off the road. But most people are offering something we can learn from.

Q. Do you believe the owner of a parcel of land in the district is entitled to have water supplied to their lot, even if they do not build a house?

VS: Sure they should, if the water is available and if a study says there's adequate water resources for IWD. Without a meter, they can't sell the property unless they have a meter. Then it's a valuable investment.

GC: I'm on a learning curve. I need to study the issue and find out how much water we have. It's much more complex. In principle, they are entitled to water unless there is a limited reserve. A policy can set some priorities. Not everybody is entitled until we know how much water we're getting.

CS: Six or seven meters sold each year wouldn't use a lot of water. If we look at presentations, we haven't seen anything saying we don't have enough water. I don't see issuing meters as a dangerous policy.

DH: Depends on the supply of water, which we need to research.

Q. How do you intend to fix the breach in trust between IWD and its customers and adjacent districts?

DH: Transparency is important. The first step is more meetings and give the community opportunities to talk. Then we need to get out in the community. It will take a long time to re-earn their trust. Nobody trusts the members, but the district should be the defender of the people.

GC: Step one is the board of directors work together. Even if they disagree, they should do it in the public eye. It

will be a struggle in the beginning. Once the board begins to deal together, you begin to gain trust.

CS: Something very conducive for our community. I don't think trust in IWD is completely lost, but dangerously close. It can be done quickly if the board is willing to be very transparent.

VS: If we operate in the public eye, smooth transition.

Q. For which other organizations have you worked for or donated time?

CS: I've been a member of the school site council, an IFPD volunteer, the Boy Scouts and the Idyllwild Community Fund.

GC: With my wife, we founded the charter high school here. I've been a past vice president and president of the Chamber of Commerce. And I'm regularly at every restaurant in town.

DH: I'm a member of the County Service Area 36 Advisory Committee, Camp Easter Seals, and advisory councils in Hemet and San Jacinto.

VS: I've been a member of the Chamber of Commerce, the Idyllwild Recreation Community Council, the HELP Center plays and Living Free.

Q. There were several questions soliciting their opinions about consolidating the three local water districts — Idyllwild, Fern Valley and Pine Cove.

CS: Now is just as good as a year from now. Like to do it through a combination of projects. The more we do together now means the more we can do together in the future.

GC: Love to do it. Perfect time is without general manager, but it's not possible yet. I'd wait to see us amalgamate.

DH: I think a lot of legislation complicates the matter. It would be nice to work together, but consolidation will take an actual vote of residents.

VS: I think it's doable. Wish it were doable today; not enough trust yet. IWD has money, Fern Valley has different government, and Pine Cove wants us to clean up our act, then it should be good.

Q. How can IWD balance the need for water conservation and environmental protection with legitimate concerns for responsible growth?

DH: We have to examine all of the wells, then maintain them and see if we have an ample supply. There won't be high growth up here.

CS: Really hard because the board behind the learning curve. We need some time to do long-term planning. It's very viable for the board to have two-year and four-year plans. A long-term plan will be very beneficial for the water district.

GC: It's a mistake to put the board in the center. If the long-term environmental issues impact growth, then the residents need an open-ended and long community conversation.

VS: Any board, particularly our board, needs to be educated. The board needs to be prepared. It's time to evaluate and question where we're at. If there is no water, changes this. If we have water, then fine.

the sheriff's department," said Borja. Washington agreed. "It should not turn into a confrontation," he suggested. "Go back into your home and call the sheriff."

County Transportation representatives discussed using portable trailers with electronic signs, having secured encroachment permits from Caltrans, to warn of traffic congestion on mountain roads — posting these warnings on both highways 74 and 243. Discussion at the meeting seemed to indicate this option is currently ready to be deployed if and when needed.

California Highway Patrol representatives said their primary responsibility during snow emergencies is to keep traffic moving. They suggested, if personnel and resources were available, CHP officers could conduct traffic control for limited periods to facilitate safe movement of vehicles and prevent illegal parking that encroaches onto roadways.

Shelli Lombardo, Caltrans public information officer, said her agency does not have sufficient resources to assist in traffic control. "We're in the same situation as CHP without resources to conduct ongoing traffic control," she said. "Our crews are out clearing snow from roadways."

Attending agencies noted the challenges involved having sufficient resources

and personnel to deploy to the mountain during snow emergencies. Said Washington, "We can't just abandon efforts to create safety. We need more social media outreach regarding weather conditions, traffic, driving, and chain requirements and closures. We must plan for the worst and hope for the best."

Also reviewed at the Nov. 21 meeting were suggestions made last January to deal with litter, traffic congestion and illegal parking. Still on the table as potential solutions, but as yet not currently in progress, are:

- Extra trash cans in Idyllwild public recreation areas and in the village business district;

- Mobilizing Idyllwild's volunteer agency base (Rotary, Mountain Disaster Preparedness, Mountain Community Patrol and resident Community Emergency Response Team members) to greet, help educate and monitor snow visitors;

- Signage in turnouts primarily on Highway 243 reading "no parking" for snow recreation — only for putting on chains or other emergencies;
- Identifying "traffic/parking/congestion pinch points" and deploying law enforcement to those areas.

Washington thanked attendees and stressed the importance of staying connected to deal with future mountain snow emergencies.

Give thanks for Thanksgiving rains ... and snow

During Thanksgiving week, Hill residents must have been extremely grateful for their life and friends here. The reward was significant rain and the first snowfall of the 2016-17 winter season.

The U.S. Forest Service's Keenwild Ranger Station recorded 1.2 inches of rain from Saturday through Sunday evening. In Pine Cove, 1.76 inches of rain fell and another 4 inches of snow came down, too.

Since July 1, total rainfall at Keenwild has been nearly 5 inches, which is close to the long-term average rainfall of 5.9 inches through the end of November.

In Pine Cove, rainfall has been 6.5 inches since July 1, which already exceeds this historic average.

However, in prior years, abundant rain fell during the first half of the rain year and the rainy months — January through March — proved disappointing.

Just last year, precipitation through November was nearly 7 inches at Keenwild and more than 8 inches in Pine Cove. Yet the total rain through June 30 again was below average. In 2014, more than 9 inches of rain fell through early December, but the drought persisted.

The last year Keenwild exceeded the average annual rain was 2011, when 29.4 inches fell.

Derrik Lewis, newest Stratford Player, has storied career

Derrik Lewis, newest member of Idyllwild's Stratford Players, has a storied background in stage, television and film that began when he was 15 with his first professional performance. Lewis is now a regular member of the Stratford Players and can be seen in its Idyllwild productions.

At age 18, Lewis made his debut as an Actors' Equity Association member with a San Fernando Valley Shakespeare company. From there, he transitioned easily to television with appearances on "The Twilight Zone," "Route 66," "My Three Sons," "The Monkees," and many other series and soaps. His first movie role was in "Love in a Goldfish Bowl" with Tommy Sands and Fabian in 1961.

In addition to his AEA card, Lewis held memberships in the Screen Actors Guild, American Federation of Television and Radio Artists and the Musicians' Union — an impressive collection of union memberships for a young artist not yet 20 years of age.

Sci-Fi fans will remember Lewis as Lt. O'Brien in the popular television series "Voyage to the Bottom of the Sea," a role he began in 1964.

Serendipity and luck played a major part in Lewis landing the "Voyage" gig. His agent called to say they needed an actor for one day for filming the pilot. Lewis was to be an enlisted man with no lines, but wardrobe could not fit him as an enlisted man, only as an officer. "So when I filmed the pilot later that day, I was established as an 'officer' on the submarine 'Seaview,'" Lewis is remembered.

He said he was happy when he heard Fox had picked up "Voyage" for a series and hoped he might book an episode or two. "Then I heard they were filming and no one called, so I almost forgot about it," he said. Then one day he had nothing to do and called a friend at Fox to meet there for lunch.

"Irwin Allen [the director] was there and they were filming one of the first two segments on the back lot and I was on a little hill watching. I'd been watching for about 10 minutes when Irwin stopped everything looking over at me. He charged up the hill, put his face in mine and said, 'Where the hell have you been? We've been looking for you.' Apparently, he had seen me a couple nights before on "Arrest and Trial" and remembered me from the 'Voyage' pilot. Why he couldn't find me I'll never know but they needed an actor for the Lt. O'Brien role and that's how I got it."

But it is as a stage actor that Lewis said he feels most comfortable. He made his musical theater debut with the Sacramento Music Circus at age 21 in shows including "Wildcat" and "West Side Story," and with L.A. Civic Light Opera's productions of "Company," "Oklahoma" and "The Music Man."

For 10 years, Lewis lived in Santa Fe, New Mexico, where he received the Governor's Award for his contribution to the Arts of New Mexico (1978).

While working in Hollywood in television and film, Lewis performed regularly as a pianist and singer at many top Hollywood venues. "I gave a farewell concert at the Gardenia [Restaurant and Lounge] in 1997," he remembered. "It was a great way to say goodbye to my Hollywood career. Then when I wanted to retire, Palm Springs seemed a natural for me."

Subsequently, Lewis appeared in many Palm Springs musical theater productions. For 12 years, he was the host and producer of "Musical Chairs Concerts," a revue production featuring name entertainers performing the music of 20th century composers and lyricists in an educational, entertaining concert format.

Concerts were performed at the 400-seat Annenberg Theater at the Palm Springs Art Museum and at the Indio Performing Arts Center, and featured legendary artists such as Margaret Whiting, the Page Cavanaugh Trio, Gogi Grant and Russell Arms, as well as contemporary artists Sam Harris, Jim Bai-

He can next be seen in its "Cheers, A Warm and Humorous Look at Christmas" production this weekend, Saturday and Sunday, at 2 p.m. at First Church of Christ Scientist in Idyllwild.

current term will end in December 2018. Her seat is up for re-election in November 2018. A replacement will have to stand for election on the November 2018 ballot.

Commission President Jerry Buchanan said he would appoint a committee to search for a replacement at the December meeting. At that meeting, the commission also will elect its officers for 2017.

Layton was elected as a commissioner in August 2013. In September, former Commissioner Pete Capparelli resigned and Layton was selected to fill the position in November, a month before her official term began. She has served as treasurer since the position was established in early 2014.

As a member of the finance committee, Layton asked the commission to review the reports, which included October's data, but to give the committee more time to work with the financial consultant Rob Dennis.

"We noted a number of concerns and I've requested a meeting with Mr. Dennis, the chief [Patrick Reitz], Battalion Chief [Mark] LaMont and you [Buchanan] to discuss these issues," she reported. "There are still software issues with the new accounting system, so [the meeting] will wait until some of that is resolved."

Ambulance service continues to make a significant contribution to both the community and the IFPD budget. Revenues are much ahead of last year, Reitz reported.

Last month, nearly 75 percent of calls were medical related. Patient service numbered 197 compared to 129 in October 2017. Ambulance revenue for November continues to outperform 2016. Reitz then opined, "We are an [Emergency Medical Service] provider in a fire department business; that's why we have such a focus on the emergency medical care."

The commission briefly discussed the election results for Measure W, IFPD's proposal to increase the parcel fee, which is unlikely to be approved.

While the "Yes" votes continue to exceed the "No" votes by 57 percent to 43 percent, approval requires two-thirds of voters choosing "Yes."

With about 70,000 votes out of 800,000 in Riverside County to be counted, the commission was not ready to concede.

"This shows we do have strong support in the community, but two-thirds is a tough nut to crack," Buchanan said. "Future thoughts are premature until the final count."

The commission expressed interest in understanding why a large percentage of voters did not support the fee increase. Buchanan said he put a survey on the December agenda "to determine what we have to do differently to get 66 2/3 percent."

Firefighter Greg Minor, who was at the meeting, expressed concern that some of the public might be concerned that service will change as a result of the election results.

"It would change regardless of the measure; we need to do some education. We need to pick up our boots and move on," he recommended. And Layton agreed that the "district needs to get the message to citizens that service will not be curtailed."

On the positive side of finances, besides increasing ambulance revenue, Reitz reported two other increases. IFPD received a \$33,000 check for reimbursement for past ambulance underpayments. This is the second payment from the state.

Through its Ground Emergency Ambulance Transportation program, the state Department of Health Care Services obtains additional federal funds. It uses these to provide supplemental payments to public agencies who accept Medicaid payments for ambulance transports. These payments typically do not cover the entire cost of transporting a patient to a hospital.

The second financial benefit was a \$10,000 volunteer firefighter grant, which the department will match, for purchase of equipment.

Layton and Foster moving to Hemet

Nancy Layton announced her resignation from the Idyllwild Fire Protection District commission last week. Layton and her husband, Rick Foster, have been intensively involved in Idyllwild emergency activities since moving here in 2001.

In her resignation letter, Layton wrote, "With heavy heart, I hereby tender my resignation from the IFPD Board of Commissioners, effective January 1, 2017."

Hemet will be their next home, but she doesn't believe their community participation will be as intensive as it has been in Idyllwild. They plan to do more traveling and camping, she said. Visiting family in New York and locations on the East Coast, such as Washington, D.C. and Civil War sites, are going to receive more attention beginning this spring and summer.

The move will bring them closer to family and help Foster, who has a pulmonary disease. "It's more difficult for his breathing at this elevation," she said.

Besides being a fire commissioner, Layton is the former president of the Mountain Disaster Preparedness group and former treasurer for the Associates of Idyllwild Arts Foundation. Foster has been instrumental in organizing the warming center at the American Legion, and involved in RACES and MDP himself.

After hearing her resignation, Commission President Jerry Buchanan immediately expressed his gratitude and the department's.

"I want to thank you for your good service," Buchanan said. "It's labor of love serving this department, which is so important to the community. Lots of love."

Layton's service makes a full commitment to help the organization and move it forward. When she volunteers, she puts all her energy into the service.

As head of MDP, Layton said, "I had a mission [to populate my board] and I was determined to accomplish the goal." She worked hard to expand the group's training program, which now has assistance from the Idyllwild Fire Department.

After serving as the department's bookkeeper in 2013, Layton saw the opportunity to do more as a commissioner. She was one of four candidates in the race. Layton and Commissioner Jeannine Charles-Stigall, who was running for her second term, received the greatest vote total.

"I wanted to continue the process of clarifying the financial records and transaction recording. These reports are meaningful for the department and the public," Layton said. As a commissioner, Layton helped identify the IFPD's needs, and strongly supported and advocated for an increase in revenue to help acquire equipment to serve the community. Measure W, the proposal to increase the parcel fees, was on last month's ballot with her help.

"The voters spoke absolutely and I respect that," she noted. "More people in Idyllwild supported Measure W, but not enough for a supermajority to pass it."

Despite the measure's apparent defeat, Layton, as always, remains upbeat about the future.

"The department is in good hands," she shared. "I'm feeling good about the future."

Her future will bring new adventures, but Idyllwild will remain part of their lives. While she already has several jobs planned for Foster at the new home, she said, "We'll come to visit. My heart and soul will always be here."
