





# Mountain Disaster Preparedness presents a forum on evacuation

‘What to know, what to expect and what to do’

Mountain Disaster Preparedness, the local nonprofit in the forefront of citizen disaster preparation measures, will present a forum about issues surrounding mandatory disaster evacuation.

Mike Feyder, MDP president, said the topic is important now for a number of reasons: that many new residents have moved to the Hill since the 2013 Mountain Fire, the most recent mass evacuation of Idyllwild and Fern Valley residents; that greater-than-normal rainfall will produce more fire fuel and increase wildfire risk; and that evacuation could come without advance warning, unlike the Mountain Fire that began on Monday and evacuation was not ordered until midday Wednesday.

Feyder noted the Mountain Fire evacuation was textbook and orderly largely because of residents’ two-day notice that evacuation could be called at any time. “The next time might be different,” he said.

The Mountain Fire began at 1:43 p.m. Monday, July 15, and burned for 16 days until full containment on July 30. Idyllwild and Fern Valley residents were ordered to evacuate on Wednesday, July 17, and allowed to return on Sunday, July 21.

Feyder said representatives from Cal Fire, Idyllwild Fire, Riverside County Sheriff’s Department, County Emergency Management and the Red Cross would attend and speak.

He cited the following questions as ones he has asked to have covered by attending representatives: how mandatory evacuations are called and what are the markers for calling them; how will residents be notified; how much time is allowed; what things to take; what security would be provided for homes, businesses and vehicles left behind and by what agency; what do people do who don’t have transportation; where would shelters be organized for people and animals;

how do residents learn about the lifting of the evacuation order; and what identification must residents carry to be readmitted after evacuation (important since most Hill driver’s licenses list post office boxes, not street addresses).

Feyder stressed that wildfire could come at the worst possible time — during a weekend or holiday festival when tourists, who have little knowledge of Hill roads or fire danger, could complicate orderly evacuation. Feyder also questioned whether some evacuees might try to leave using fire roads, increasing the danger of getting stuck or disoriented by smoke.

But primarily, Feyder was concerned about residents who refuse to leave. “Those who stay put an additional strain on first responders,” he noted.

Feyder said the format would encourage audience questions at the time of officials’ presentations, not at the end of the meeting.

The forum, “Evacuation of the Hill: What to Know, What to Expect and What to Do” takes place from 6 to 7:30 p.m. Tuesday, April 25, in the Idyllwild Library Community Room. Seating may be limited, given the nature of the presentation. The event is open to the public and there is no cost to attend.

# Supervisors want to keep three-person fire crews

## County fire budget still in red, further changes may come

The Ad Hoc Fire Committee of the Riverside County Board of Supervisors did not agree fully with the recommendations to save nearly \$12 million in the current county fire budget last week.

The biggest difference was rather than using two-person medical crews and reducing the number of three-person engines, the committee recommended maintaining the three-person engine policy. However, it recommended replacing about 49 captains with firefighters and engineers.

The committee did not recommend closing Station 63 (Poppet Flats) but did agree with the proposal to close Station 43 in Blythe and two medic squads at stations 40 in Mecca and 44 in Ripley. The county will still maintain two stations outside the city of Blythe.

The committee's recommendations reduced the budget shortfall to \$4.2 million. The county executive officer

and fire chief would develop further savings.

"We don't support the general concept of moving to two-person, quick-response vehicles," said Supervisor Kevin Jeffries, 1st District, and a member of the committee. "And the board made it clear it is not closing Poppet Flats. We're pursuing other ways to try to find savings."

He argued that the two-person squads were not the equivalent of staffed fire engines.

Third District Supervisor Chuck Washington said, "I think we can do a little better than this. I will have a very difficult time rolling back a municipal staffing structure. I think that's the wrong direction for us to be heading."

He also suggested that the county could mitigate the effect of the budget changes on the fire staff with a resolution stating that the decision would be reconsidered in a few years if the budget revenue is restored.

The state and the firefighters' Association 2881 negotiated a new contract in December. The four-year proposal authorizes raises for from firefighters to battalion chiefs in the range of 11 to 18 percent. The estimated cost of the new contract for Riverside County for next fiscal year (beginning July 1) is \$11.9 million.

CEO Jay Orr felt this was too big an amount for the county to absorb without any cuts to its current fire bud-

get. At the supervisors' March 7 meeting, County Fire Chief John Hawkins offered several proposals to generate \$12 million in savings.

Last week, Hawkins said, "I strongly believe the people of Riverside County need fire services delivered with a minimum of three people on every engine. But I also understand clearly that the county has a budget hole."

Replacing the number of captains with firefighters at 22 stations would save about \$2 million annually, according to Hawkins.

Second District Supervisor John Tavaglione, board president and the other member of the committee, spoke firmly: "We're not playing games. We've got real problems. As the biggest contract in the state with Cal Fire, we expect the state to work with us. They have to be cooperating with us."

"We're an urbanized county and I don't think Cal Fire looks at us like that," he added later.

"If we want to fully fund [RCFD], then we have to go to the other agencies for \$11.9 million," Jeffries said at the conclusion of the committee's presentation.

The board did not make a decision last week and wants to hear about other budget issues first.

## Robert Baird named regional director of fire

The U.S. Forest Service has named Robert Baird as the director of Fire and Aviation Management for its Pacific Southwest Region. Since May 2014, Baird has been the forest supervisor on the Los Padres National Forest.

Besides on-ground fire experience at the LPNF, Baird has fire program-management experience. He is the former deputy national fire director for Operations, Aviation and Risk Management on the Fire and Aviation Management staff in the Forest Service's national headquarters in Washington, D.C.

He also served an assignment as the acting associate deputy director of Cal Fire, where he fostered partnership and cooperation with the Forest Service in California.

While in Washington, Baird oversaw the National Interagency Fire Center and developed the plans leading to the transition of next-generation air tankers.

Prior to joining the Forest Service, Baird spent 24 years in the U.S. Marine Corps where he achieved the rank of lieutenant colonel before retiring in early 2012. He is a veteran of combat operations in both Iraq and Af-

ghanistan, according to a Forest Service statement.

In a press release, Pacific Southwest Regional Forester Randy Moore said, "I'm very pleased to welcome Bob Baird as our Regional Director for Fire and Aviation Management. Bob has demonstrated expertise in managing large, complex organizations and he has developed innovative strategies to build partnerships and coalitions. Bob's leadership background and experience are a perfect fit for this key position. We look forward to a challenging but successful fire season with Bob at the helm."

"I couldn't be more proud of this opportunity," Baird said. "I've had the great pleasure of serving both at the forest level and at the Washington office level, and this regional position will tie those experiences together. I think the opportunity to serve in both Cal Fire and with the Forest Service has given me a broad perspective on fire in this region, and I look forward to taking on the challenges with the support of the best firefighters in the world."


Baird is a Riverside native and is expected to report to his new position May 15, according to the release.

Healthcare savings

EDITOR:  
I like Dr. Tom's ideas on Medicare-for-All. I recognize the benefits and cost savings — if everyone, in fact, pays (just like Medicare). The 3-percent off of everyone's income is much less than healthcare plans cost now.

However, I'm not entirely sold on the savings he points out in eliminating the "middlemen" — the insurance companies. Someone will still need to watch what's being done and how much is paid — you know, since there are still dishonest people in the world. But there may be a way to save even more money.

According to a report on Medscape.com provided by Carol Peckham on April 1, 2016, physicians in the U.S. earn an average in the neighborhood of \$204,000 for pediatrics up to around \$443,000 for the orthopedics specialty. Not bad neighborhoods, eh?

It states in the report that surgical specialties like cardiology surgery, etc., can earn even more. But, let's take those "low" figures. If you average the incomes listed for the 26 specialties in that report, it works out to just short of \$300,000. You can check my math — the total income for the 26 specialties listed equals \$7,733,000 divided by 26 equals \$297,423.08 per year.

These numbers put physician's pay in the 99th to 99.5th percentile of U.S. earners. Have you ever met a poor doctor? How about this alternative: Let's reduce the pay to physicians by 50 percent across the board. That'll still allow docs to be in the 96th to 99th percentile of earners and yet, we'll save more billions of dollars, too.

Next, let's reduce the gross overpayments to hospitals: \$50 per Tylenol tablet?

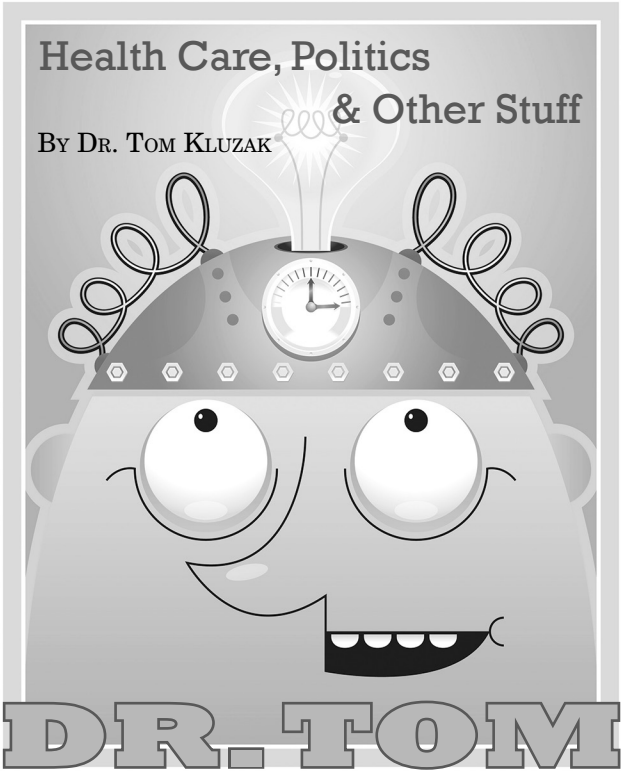

A Brief History of the U.S. Government and Healthcare, Part II...

While everyone would agree that the passage of Medicare in 1965 was a landmark event in not only American healthcare but also American politics, the failure to include Americans of all ages created a hole that many have tried to fill while others have tried to dig deeper. The lack of the political will or the political capital to pass Medicare-for-All has been a constant companion to all discussions of healthcare policy over the past 50-plus years.

But, building on the perceived success of Medicare and Medicaid in providing healthcare to the elderly and poor, forces aligned to push for better coverage for everyone. Thus, President Nixon (1968-74) proposed an employer mandate to provide insurance and didn't want anyone to be denied basic medical care by the inability to pay, but didn't want to compel Americans to have insurance. He wanted to increase funding to medical schools to train more doctors and add incentives to increase preventive care, and proposed \$100 million to cure cancer. Sound familiar?

Although rhetoric continued, the next major push to reform healthcare came during the Clinton presidency (1993-2001), and we all know how that fared. Lobbyists funded by doctors had stopped reforms under President Truman in 1945 and lobbyists funded by insurance companies stopped them here. The TV commercials featuring Harry and Louise, sitting at their kitchen table lamenting the loss of their good insurance policy because of government interference, helped to kill the Clinton plan.

Some things were accomplished in the meantime, however. The Emergency Medical Treatment and Active Labor Act of 1986 prevented "patient dumping" by hospitals and required all hospitals to provide emergency care to anyone who needed it, regardless of citizenship, legal status or the ability to pay, in effect mandating "universal care," though not providing for a way to pay for it.

The Medicare Prescription Drug, Improvement, and Modernization Act, passed in 2003, created Part D Medicare to help cover drug costs but also specifically prevented Medicare from negotiating drug prices. Governor Romney signed a bill in Massachusetts in 2006 based on three principles: coverage of all, regardless of health status; an individual mandate; and subsidies to cover the cost of insurance for low-income individuals.

Welcome to 2010 and the Affordable Care Act, also known as Obamacare. The machinations that created this law are reminiscent of sausage making — best to avoid viewing it if you want to eat the sausage — and are thoroughly discussed in Steven Brill's eye-opening book "America's Bitter Pill." Suffice it to say that the act was created by and for health-insurance companies.

Nevertheless, it has had many positive consequences that should not be overlooked. One specific issue I found

# Homeless population within county growing Fewer counted in Idyllwild

Last week, Riverside County’s Department of Public Social Services released the results of its 2017 winter homeless survey.

In January 2017, the survey identified 2,413 homeless county residents. This is 248 more individuals (about 11.4 percent) than were recorded in January 2016. This was the first countywide increase since 2011. During the period between January 2011 and January 2016, the homeless population decreased 61 percent.

The county identifies both individuals seen on the street and those who took advantage of county or city services. This year, the number of unsheltered individuals was 20 percent greater than the 2016 unsheltered homeless, while the number of homeless using designated shelters declined 5 percent.

In both years, more than 90 percent of the homeless were found in the county’s cities. The largest number of homeless were identified in Riverside. In Hemet, the homeless count increased from 107 to 119, making it the second-largest homeless population in the county.

Within the unincorporated areas, 10 individuals were counted in Idyllwild, which was two less than in 2016.

The authors of the report attributed the 2017 countywide increase in homeless individuals partially to a more intensive survey, “... a countywide commitment to conducting a more collaborative and rigorous count.” And, “In 2017, following HUD’s new requirements to have a separate youth count, we increased our efforts to obtain a more accurate count of youth ages 24 and under that are experiencing homelessness.”

In the press release, Public Social Services Director Susan von Zabern said, “We believe the increase this year may be attributed to several factors, including more participation and engagement from our cities, increased law enforcement participation, and unprecedented weather conditions in the days leading up to the count which resulted in some city and county volunteers revisiting areas where people may have been displaced.”

The survey was conducted, as usual, by more than 500 community volunteers, outreach staff and experienced professionals from more than 130 agencies canvassing pre-identified areas countywide.

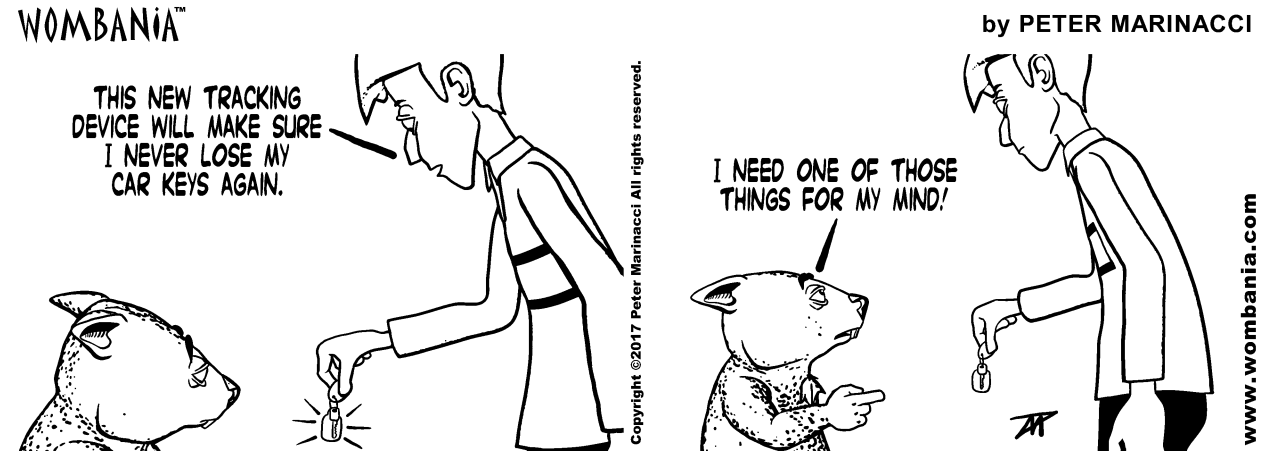

# Pine Cove water production is up

The water production in Pine Cove took a major jump last month. March production was 2.6 million gallons, which is 800,000 gallons (or 44 percent) more than the March 2016 volume of 1.8 million. Two years ago, in 2015, Pine Cove Water District’s production was 2.3 million gallons, which is the average March production since 2002.

The March production was also 700,000 gallons greater than the February volume of 1.9 million gallons. For the first quarter of 2017, production is nearly 900,000 gallons greater than the same period in 2016, but only 60,000 gallons more than the first three months of 2015.

The district has been proceeding with a program of repairing main-line leaks for several months. The success of this effort was demonstrated with the steady decrease in unaccounted-for water. In December, unaccounted-for water losses were 5.7 percent of total production and 10 percent for all of 2016. However, unaccounted-for loss rose to 13 percent for the first four months of 2017.

General Manager Jerry Holldber attributed the surprising increase in water consumption to a few leaks in the distribution system, as well as several private leaks. The private leaks were large volumes and over an extended period, he said.

“These were on the customer side of the meter,” he said. Referring to part-time residents, Holldber added, “The water was not shut off properly or sometimes not at all.”

Nevertheless, water sources continue to improve. Holldber reported that the groundwater level for well no 10, the static well, rose 7 feet in March, the largest increase in years.

“Signs of positive movement are starting to show in the majority of wells,” he told the board. “In April, we’ll see significant increases. I expect that well 10 may be up 40 to 50 feet over the summer season.”

After Gov. Jerry Brown rescinded the drought-emergency regulations, PCWD reverted to Stage 1 and plans to remain there, according to Holldber. May 2015 was the last month PCWD was in a Stage 1 status.

“This requires voluntary compliance as far as conservation,” Holldber told the board. “We’ll stay in Stage 1 with the support of our customers who believe there should always be an emphasis on conservation.”

At the end of three quarters of the current fiscal year 2016-17, both President Robert Hewitt and Holldber thought finances were in a good condition. Income has exceeded expenses by about \$30,000 and should increase through the end of the fiscal year.

In April and May, Riverside County will disperse the remaining property tax revenue to special districts. PCWD expects to receive another \$50,000 in tax revenue, which is about 60 percent of the tax revenue already distributed.

In March, PCWD sold

a new water meter, according to Becky Smith, office manager. She said three more new meters may be bought this spring.

“Over the past few months, we’ve had several inquiries on various properties throughout Pine Cove,” Holldber said.

Staff also is exploring and evaluating the possibility of creating the option for online water-bill payments. “This is one of the most common requests we receive,” Holldber said. “We’ll look at the pros and cons, but it will take more than one or two months.”

In other business, the board approved a resolution requesting the Riverside County Registrar of Voters to conduct an election for the district in August. This is the fourth year of the terms for three directors — Louis Padula, Joel Palmer and Hewitt.

Vicki Jakubac, who was appointed in April 2016 to replace former Director Tim Lange, whose term started December 2015, will have to stand for election for the remaining two years of that term.

Holldber also distributed draft copies of the proposed revision to Ordinance 9, PCWD’s rules and regulations for water service. Hewitt told his colleagues that approval of the revised ordinance would be on the May agenda.

Some of the topics in the ordinance include the duties of the general manager, installation of services, responsibility for charges, water services per parcel, water conservation, backflow responsibility, meter installation and size, billing plans and conditions for discontinuance of service.

During the public-comment period, Bill Tell, president of Mile High Radio Club, delivered a letter to the district in response to a letter from Holldber to the club on March 31.

In that letter, which was a culmination of several exchanges over the past few years, Holldber wrote, “So on July 31, 2017, the cabinets will be gone and updated radios installed, or we will consider the license terminated.”

The communication facility is located at the PCWD Rocky Point site. The district built the facility to improve radio communication and for 20 years has not charged community groups any rent for its use. In order to improve the facility’s usefulness for all leasees, the district asked MHRC to upgrade and remove certain cabinets.

Tell made it clear that MHRC does not wish to move, but believes it does not have the funds to respond to the PCWD request to consolidate equipment. PCWD is trying to build a more efficient radio and communication site, especially with the addition of two recent customers — American Medical Response and a wireless internet provider.

Hewitt responded to Tell’s comments recommending that the board’s committee and MHRC set a meeting to resolve this issue.

# Do you know for whom Lily Rock was named?

Mark Dean was the only one to respond with, “Here’s a cool history from “Rock Climbs of Tahquitz and Suicide Rocks,” by Randy Vogel, 1985 ...”

“More recently, Tahquitz Rock drew the attention of turn of the century hikers who often worked their way to its class 2 summit. During this period of time Tahquitz was also referred to as ‘Lilly Rock’ and ‘The Pallisades.’ To this day, Tahquitz is often mistakenly referred [sic] to as Lilly Rock.”

However, according to [www.summitpost.org](http://www.summitpost.org); “Named Lily Rock in 1898 by a USGS team; it has been thought that this was possibly for its lily-white appearance. But T.W. Patterson of Riverside has seen an old

photograph of Lily Eastman, on the reverse of which is written ‘She was the one for whom Lily Rock was named’.

“Lily was the daughter of Dr. Sanford Eastman, the first Secretary and a Director of the ‘Southern California Colony Association’ which later became Riverside. She was much admired locally for her grace and beauty.

“She and her father, both suffering from tuberculosis had come to Riverside for their health, but she nonetheless died young and was mourned by many. How the USGS could have become aware of her is unknown.

“It had previously been known as ‘Taukwitch Rock’ (by area pioneers) and allowing for many variants in spelling, ‘Tauquitz’ [sic] is still its preferred name by rock climbers.”

In other business, the wood-chipper purchase has been approved and its delivery will be soon, according to county officials. Its cost was about \$40,000, according to Holldber. “It was basically bought for the benefit of this community,” stressed committee member Marge Muir, local real estate agent. While RCFD will maintain the chipper, Weiser concurred that its uses will be to assist the maintenance of county fuelbreaks and the community chip site. “We’ll be stewards of this equipment.” After the wood chipper is delivered, the masticator will be next on the purchasing department’s list of projects, Weiser added. Work on the shaded fuel-

break in the Pine Cove area will begin in the next few weeks, according to Weiser. The environmental reports are nearly complete and Chief Greg Bratcher, Forest Division at the Mountain Resource Center, should be issuing a contract shortly. RCFD burned more than 1,200 piles of slash and dead material this winter in the Stone Creek area of the Mt. San Jacinto State Park. This work will tie into the Shade Fuel-break, he added. “With that much dead material, this was a fantastic job,” Weiser told the committee. “The window in the weather allowed crews and heavy equipment to complete it just days ago — a monumental task.” *JP Crumrine can be reached at [jp@towncrier.com](mailto:jp@towncrier.com).*

Caine suggested that once every four years might be a fair effort to reduce the cost and “... alleviate a hardship without costing the board too much.” Another issue was the possibility of a water customer collecting and re-selling their water to third parties. This is another issue, which the current rules do not address, according to Hoagland. He added that if the customer has a private well, the regulation would not apply to that water. Director Peter Szabadi suggested that, since the district has no limit on water use, as long as the customer pays for the water consumed the use might not matter. But Caine replied, “It doesn’t seem right to make a profit off the district’s water.” “We’re just out of a drought, why sell a precious commodity?” asked Director Vic Sirkin. “If they want to sell to a third party, come to the board and make a request.” Hoagland reported that the committee was inclined to delete language in the water rules referring to equivalent dwelling units and, therefore, eliminate the number of EDUs in calculating a new connection fee. Some of the other water issues included a shortening of the period for assessing a late fee and dropping the fee for changing the ownership of a district property.

**Sewer system rule changes** For the sewer system, the committee is considering adding language prohibiting the connection of a recreational vehicle to a customer’s sewer line. Hoagland said the chemicals in RVs can affect IWD’s waste-treatment facility. The number of plumbing fixtures within a structure will affect commercial properties but not residential. Also, the district will consider discouraging the splitting of parcels for new construction within the sewer district. Hoagland argued that the capacity of the current treatment system is not unlimited and the number of current vacant lots should establish the ultimate capacity limit. IWD’s next regular meeting is at 6 p.m. Wednesday, April 19. But Hoagland confirmed that another workshop has tentatively been scheduled for Wednesday, May 3. *JP Crumrine can be reached at [jp@towncrier.com](mailto:jp@towncrier.com).*

**Water rates** A heated exchange ensued between Sirkin and Hoagland about the possible changes in water-rate calculation. Hoagland maintained that the size of the meter should affect the individual’s monthly rate. The size of the meter imposes responsibility on the district to provide for larger volume and adequate pressure. The larger meters are becoming more common with new construction complying with fire-sprinkler regulations. Sirkin countered that as long as each customer pays for their use of water, they would be paying the same rate. The difference in connection fees would address the district’s responsibility for capacity.

board. According to Valenzuela, “... Hemet’s salary, in comparison to neighboring districts, was lower than average for teachers just settling in for the middle of their careers ... We have seen so many teachers and professionals move out of the valley, we hoped that this would help stem the high turnover rate in HUSD.” HUSD offered a 1-percent increase and eventually raised that to 1.25 percent. This increase would be effective April 1, although HTA members have been working without a contract since July 1, 2016. “We found this insulting,” Valenzuela wrote. Thus, the need for mediation, which is not the first time the two parties have had to rely on the third party to achieve an agreement. In 2015, HUSD and HTA reached a mediated settlement that provided an 8-percent salary increase effective July 1, 2014. Another 2-percent increase became effective July 1, 2015, as well as some health and welfare benefit increases. These increases cost the district about \$12 million annually. HUSD does have a multi-million-dollar reserve, which HTA believes is “over and beyond what the state requires.” But Valenzuela believes that after the governor issues the May revision for the state budget, HUSD will have a firmer idea of what state funding is coming to it. With a better understanding of future funding, he hopes the district will make an improved salary offer. “We think the state budget is in good order,” Valenzuela opined. “The recent tax increase for roads will alleviate an impact on educational funding.” The salary dispute is a surprise since HUSD and HTA have agreed to several issues this winter and spring. Both groups were in agreement on class sizes for the current school year, the teachers’ schedule at Alessandro High School for the next two school years, staffing for special education and agreement on late start, and early release days for administrative meetings for the next two years. “While I am sorry to see negotiations go to impasse, I am confident that, with the help of a mediator, we can reach an agreement.

The negotiations thus far have been productive and amicable, and I hope that continues,” said Vic Scavarda, HUSD board president and Idyllwild representative. While disappointed that mediation is necessary, Valenzuela is still optimistic that HTA and HUSD will find agreement. HTA’s goal is to “keep our salaries up with inflation,” otherwise, “[I]t will become increasingly difficult to attract educators to this valley, and keep them in our schools. About one-third of our entire Association has only been with Hemet three years or less. This type of turnover is impossible to sustain if you are trying to build a community.” *JP Crumrine can be reached at [jp@towncrier.com](mailto:jp@towncrier.com).*

## Phoenix Alliance presents art workshop to release trauma

The Phoenix Alliance presents a participatory art experience to help attendees release attachment to an embedded painful memory or experience. It is held this month in support of sexual-assault awareness month. Organizers stress that the event is for all ages.

Facilitated by Callie Wight, registered nurse and Master of Arts in human development and psychology, Julie Steiger, Master of Science in social work and Bachelor of Science in psychology, and art therapist Karla Leopold, with support from Rev. Shelly Downes and Mary Morse, executive director of Spirit Mountain Retreat, the art therapy workshop is designed to help release deeply held trauma — to use art to get it out of the body and onto paper that will then be ceremonially shredded.

Art therapist Leopold's career mission has been to use art as a cathartic process to heal others. She has helped guide many suffering from life-altering losses to work through their loss using art as the healing agent.

In the fall of 2005, Rosie O'Donnell's foundation "For All Kids" asked Leopold to lead a team of California therapists to work in an evacuation camp in Baton Rouge, Louisiana, with children traumatized by Hurricane Katrina. O'Donnell's foundation fully funded the team's work.

Those attending the "Finding Your Silver Lining" workshop will be offered the opportunity, with support from the facilitators, to write or draw on paper an attachment they would like to release. Participants then walk with their paper to a shredder and while shredding the paper, they visualize their attachment dis-

solving. Leopold references Joseph Campbell who stated, "We must be willing to let go of the life we have planned so as to accept the life that is waiting for us."

After that, as a doorway to embracing a life without negative attachments, workshop participants create a piece of art that represents the feelings, sensations or visions of letting go of what does not serve them and being open to a "silver lining" of personal happiness and fulfillment.

"Trauma does not have to define you for the rest of your life," said Wight, whose career focused on counseling women veterans suffering from sexual trauma.

"The process we'll use at the workshop symbolizes renewal and rebirth — a new beginning," said Steiger, whose background is in counseling and leading therapy groups.

Artwork created will be displayed at the workshop site with permission of participants, and subsequently at the Idyllwild Library. There has been discussion of using some or all of the workshop-created art in specially made quilts — much like the iconic AIDS Memorial Quilt, The Names Project.

The art created is primarily a process for releasing trauma. As

Leopold notes, participants should leave their "art critic" somewhere else. "There is no right or wrong," she said. "This creation is yours and yours alone."

Wight notes that trauma, especially trauma associated with sexual assault, crosses all genders, age groups and socio-economic bases. "Sexual assault happens to women, men, boys, girls and elders," said Wight. "It is not about sex, it is about power and domination over another."

Wight and Steiger stressed that their organization, the Phoenix Alliance, is about moving forward from gender-based violence to structuring healthy relationships and healthy communication. "Love is never abusive," said Wight.

The Phoenix Alliance is the successor to The Mountain Community Alliance Against Gender Violence.

"Finding Your Silver Lining" will be held from 10 a.m. to 3 p.m. Saturday, April 22, at the gazebo adjacent to Higher Ground Coffee Shop. Refreshments and all art materials will be provided.

All are welcome and there is no cost to attend.

# Service vets hike PCT trail

## Warrior Hikers to visit Legion

As part of the annual spring influx of Pacific Crest Trail thru-hikers, six military veteran hikers will be welcomed by American Legion Post 800.

This is the fourth year returning combat vets are hiking the PCT and visiting Idyllwild as part of Warrior Expeditions' "Warrior Hike — Walk off the War," a program designed to provide vets a wilderness trek opportunity to decompress after war-zone deployments.

Post 800 Sons of the AL will host the vets, representing Air Force, Marine Corp, Army and Navy service branches, from 5 to 7 p.m. Saturday, April 22. The public is welcome to meet the vets, hear about their duty tours and share dinner.

This year's PCT trekking corps includes Winchester, Kansas native Patrick Booth, Marine Corp rifleman, Af-

ghanistan deployment; Thomas Jones, Beaufort, South Carolina, Army infantryman, Iraq and Afghanistan deployments; James Mattingly, Chattanooga, Tennessee, Air Force security forces, Iraq deployment; Jose Montanez, Las Vegas, Nevada, Navy field medical service technician, Afghanistan deployment; Keith Rinehart, Detroit, Michigan, Marine Corps scout sniper, Iraq deployment; and Emory Wanger, Vancouver, Washington, Marine Corps communications collection analyst, Iraq deployment.

The vets are hiking the 2,650-mile PCT to publicize health challenges facing returning veterans as well as to experience the camaraderie and solitude of a five- to six-month hike shared with service comrades. The PCT begins at Campo on the border with Mexico just east of San Diego and ends in British Columbia, Canada, just north of the U.S. border.

In 1948, veteran Earl Shaffer told a friend he was going to "walk off the war" to process the sights, sounds and losses he experienced while serving in World War II. Fulfilling his mission, Shaffer became the first person to

hike the full length of the Appalachian Trail from Georgia to Maine.

Following in Shaffer's footsteps, former Marine Corps Capt. Sean Gobin started the Warrior Expeditions program in 2013 after completing a six-month hike of the 2,185-mile Appalachian Trail in 2012. Gobin had previously served three combat-duty tours in Iraq and Afghanistan. Cognizant that 20 percent of the 2.5 million returning Afghanistan/Iraq combat vets suffer from post-traumatic stress disorder, Gobin believed others could heal from a prolonged wilderness experience, just as he had.

The Warrior Hike program is now conducted on eight trails across the U.S. There is a 4,229-mile bike expedition from Virginia to Oregon and a 2,320-mile Minnesota to Louisiana paddle trip in which veterans can participate. This year, Warrior Expeditions is sponsoring 40 veterans participating in its menu of hikes, bikes and water treks.

# Peter Szabadi appointed to CSA 36 Advisory Committee

The Riverside County Board of Supervisors appointed retired attorney Peter Szabadi to the County Service Area 36 Advisory Committee at its Tuesday, April 11, board meeting.

Szabadi, who also serves on the boards of the Art Alliance of Idyllwild and the Idyllwild Water District, said his interest in serving on the CSA 36 Advisory Committee is to better understand how the town is evolving and to get a sense of what district residents want from their recreation program. Szabadi, who is married to well-known actress Michèle Marsh, has been a full-time Idyllwild resident since 2013.

A native of Budapest, Hungary, Szabadi was 2 when the Nazis occupied his country. Several family members survived the Holocaust. In 1956, Szabadi and his brother fled Hungary when the USSR invaded and occupied Budapest and other regions of the country following a nationwide uprising against Soviet-imposed policies. Szabadi and his brother were part of an exodus of more than 200,000 Hungarians who fled during the conflict.

Eight years after arriving in the U.S., Szabadi received his bachelor's degree from City College of New York in 1964, and three years later his juris doctor from New York Law School. Evincing his broad range of in-

tellectual interests, Szabadi received a second bachelor's degree, this one in archaeology, from the University of California, Berkeley, in 1975.

His introduction to the Hill area came in the 1970s when his father, wanting to be a farmer, had a house in Anza. "I came up in the summers for four or five years," he remembered.

Through much of his legal career, Szabadi focused on labor and civil rights law, mostly on behalf of plaintiffs. While practicing law, Szabadi was a member of the bars of the New York, California, the Supreme Court of the U.S., the Second and Ninth Circuit Court of Appeals, and the New York, California and District of Columbia court bars.

Once retired, Szabadi devoted his time to another of his passions, photography. As photographer, Sz-

abadi has shot for the Dinah Shore Weekend, the Palm Springs International Film Festival, Jazz in the Pines in Idyllwild and the Idyllwild Town Crier. He has mounted gallery shows of his photographs in Los Angeles and Idyllwild.

The Advisory Committee meets at 5:30 p.m. Thursday, April 27 at Town Hall. Szabadi will be sworn in at the meeting. He was appointed to fill an existing vacancy and his term runs through June 30, 2018.

Community members are invited to attend. The Advisory Committee is tasked by the Riverside County 3rd District Supervisor Chuck Washington to solicit input from district residents on recreation desires.

# Project architect for Getty Center speaks at library

## Jeff Turner's dream career

Idyllwild resident Jeffrey Turner is modest and taciturn. He also is extraordinarily accomplished in his field of architecture and design. "You can build anything you can dream," said Turner. "That's what I like about architecture — the fantasy."

Turner will talk at the Idyllwild Library about his dream career and particularly his experience as project architect for the Getty Center in Los Angeles. His talk, "The Getty Center," takes place at 4 p.m. Monday, May 1, in the Idyllwild Library Community Room.

Because of the huge fortune J. Paul Getty allocated to the Getty Museum in Malibu and the Getty Center in Los Angeles, the money available for design, construction, operation and collection of art for the 110-acre hilltop Getty Center campus is unparalleled.

Getty Center trustees have the heady responsibility of spending \$180 million annually on artistic endeavors, including augmenting the existing art collection, as well as funding educational and outreach endeavors.

The Getty Center, 14 years in the making and a \$1.3 billion project, sits on a hilltop campus with more than 2 million square feet of space and facilities in eight buildings and gardens. Designed by architect Richard Meier, the Getty Center opened in 1997. Turner joined as project architect in 1992 and was there until the grand opening on Dec. 16, 1997.

"The Getty was a design challenge from the beginning," said Turner. "It straddles two faults and required massive footings. Dirt could not be removed from the building site because of the Conditional Use Permit. Also, neighboring residents did not want the buildings to be white because it would make them stick out." The travertine marble eventually used to clad the buildings was an off-white color to assuage neighbors' concerns.

Turner will talk about these design and construction challenges as well as the massive security devices and fire


prevention installations that had to be undertaken because of the value of the art housed in the center. "The security room underneath the center is like a small Fort Knox," said Turner. Installing the security and fire-prevention equipment was held until the last possible moment in order to obtain the latest and best equipment available.

Educated at Boston Architectural Center in Massachusetts, with more study at Harvard Graduate School of Design, Turner has worked continuously on prestigious projects — including the Horton Plaza in San Diego, the downtown Los Angeles Biltmore Hotel update, the Sony Music Center, the Columbia Records building, a new city in India and a hospital in Saudi Arabia.

Although he came to Idyllwild to retire, Turner is currently working as architect on two new homes and three additions.


Turner's talk, presented by the Friends of the Idyllwild Library, is open to the public and there is no charge for admission.

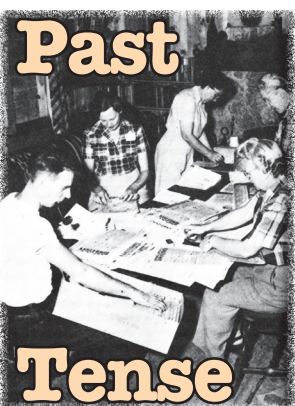

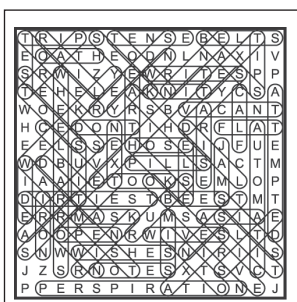

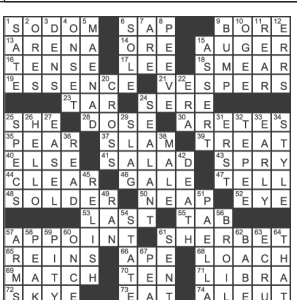

UPCYCLING

Earth Day is April 22. One of the best things you can do on that day and every day is to follow the three Rs: reduce, reuse and recycle.

Following the three Rs keeps things out of the landfill. Reduce means to use less of something, like taking shorter showers to save water or reading an online magazine to save paper. Reuse means to use something again, like refilling a shampoo bottle or using a glass jar as a vase. Recycling means to use old things to make new things, like saving all of your old aluminum cans for the recycler so they can be used to make new cans.

Upcycling is a combination of recycling and reusing. Instead of setting things on the curb to be recycled, you find a better use for them. Old clothes, for example, make great pillows and quilts.
