County to update cannabis laws

Shops currently still illegal in unincorporated areas

The Riverside County a plan to change its ordinances regarding the legality of pot, marijuana or cannabis. The immediate changes will be consistent with Proposition 64, the Adult Use of Marijuana Act, approved last November.

However, these changes are intended to "... maintain the status quo and avoid the state issuing licenses for cannabis businesses and cannabis activities in the unincorporated areas."

The key event to the legalization of these activities in the Riverside County will be a vote in November 2018 on imposing a tax on marijuana or cannabis.

Following its March 21 workshop, the board's Cannabis ad hoc committee, composed of Supervisors Chuck Washington (District 3) and Kevin Jeffries (District 1), has drafted a plan to modify existing ordinances and to impose new taxes in order to change the regulatory environment in the county for marijuana or cannabis businesses.

But the board has stressed and is amending existing ordinances to clarify that any marijuana business — medical or adult-use — continues to be prohibited throughout the unincorporated areas of River $side\ \bar{C}ounty.$

The report to the board stated, "... no permit of any type shall be issued for cannabis businesses or cannabis activities until the county adopts a comprehensive regulatory framework for medical and adult-use cannabis."

The board and staff will begin working on comprehensive cannabis regulatory policies. But Tuesday, the board amended four ordinances —348, 866, 925, and 928 — to strengthen and clarify the current prohibition of cannabis business.

On Aug. 2, the County Planning Commission approved the changes to Ordinance 348 regarding the current prohibition of cannabis business or activity within any county land-use zone.

The changes will also clarify that cultivation of six plants inside a private residence or a secure fully enclosed structure of the private residence is now permitted.

The ad hoc committee report and staff report for the Board meeting emphasized

County OKs HUD funding for ICC

Last December, the Riverside County Board of Supervisors offered \$1.2 million to the San Jacinto Mountain Community Center board toward the construction of the Idyllwild Community Center. The next step in making these funds available occurred at the board's Aug. 29

The board's latest actions formally adopted the environmental statements confirming that the project would not have any significant effect on the environment and requested the U.S. Department of Housing and Urban Development transfer and release the funds to this project.

The county reported that a Notice of a Finding of No Significant Impact had been published last month in both the Town Crier and the Press Enterprise. Further, the construction and completion of the project will have no effect on the county's General Fund budget.

In early fall, site development at the Butterfield Commons on Strawberry Creek, which Loie and Dave Butterfield generously donated to the community, will begin, according to Chris Trout, advisor to the board for marketing.

step — another donation — to ensure sufficient funds were available so site development can move forward immediate-

An amphitheater was originally part of Phase 1, but the SJMCC board is re-assessing its costs. "If we can reduce the cost of the amphitheater and if we have enough money, it will be included in the site development," said SJMCC President Janice Lyle

The HUD funding is for Phase 2, construction of the community center. However, Lyle added, "we'll re-invigorate fund raising this year" in order to have enough money to finish the community center building.

Gulp! State Senate may tax drinking water from tap

The cost of water may increase and local water districts may have no role in the change. The California Assembly's Appropriations Committee held a hearing on Senate Bill 623 last week, which would establish the Safe and Affordable Drinking Water Fund.

SB 623 authorizes a monthly 95¢ tax on drinking water. That's for customers with pipelines of 1 inch or smaller. As the customer's pipeline increases, the monthly

tax would be \$4 for a 1- to 2-inch pipe and up to \$10 monthly if the pipe were larger than 4 inches.

Generating about \$100 million annually, these funds, along with revenue from two other taxes, would be used to improve aquifers and water systems, which are considered contaminated and exceed federal or state water quality limits.

The proposal authorizes two other tax levies: a \$0.005 per-dollar sales fee on all fertilizer materials is estimated to yield about \$17 million annually.

The third tax would impose a \$0.01355 per-hundred weight of milk on every milk handler already subject to specified regulatory milk fees, producing about \$5.3 million each year.

The bill's primary sponsor, Sen. William W. Monning, who represents the 17th Senate District, which includes all of San Luis Obispo and Santa Cruz counties, and portions of Monterey and Santa Clara counties, said in a press release after the hearing, "In Flint, Michigan, 100,000 people were exposed to unsafe drinking water, but right here in California more than 1 million Californians are annually exposed to unsafe drinking water. Having access to clean drinking water is a basic human right that should be guaranteed to every person in California, and it is time that we act on this issue."

According to the Appropriation Committee's report, the target beneficiaries of these funds would be the more than 300 drinking water systems in disadvantaged communities — serving about 200,000

It's hot! And will be

The National Weather Service has issued an excessive heat advisory for the San Jacinto Mountains at least through Friday night.

However, while winter is colder and more dangerous in Idyllwild than in the valleys and coastal areas, this heat weather is considered "dangerous" for those areas.

NWS has issued a heat advisory for the San Jacinto Mountains at least through this Friday night. The high pressure that is trapping the heat in Southern California is expected to rebuild Thursday, so the excessive heat warning will continue through Labor Day weekend, according to Alex Tardy of the San Diego NWS.

The NWS Advisory says, "The heat may relent slightly for Thursday into next weekend ... but with high temperatures remaining well above average."

A slight chance of thunderstorms is forecast for any day this week. A high ridge of high pressure brought this sweltering heat to Southern California, according to NWS meteorologist Stephen Harrison.

One advantage of the high-pressure system over Utah is that it blocks Hurricane Harvey from traveling west, Tardy

"The long duration of the heat wave and the lack of significant relief overnight will result in potentially deadly heat for much of the region," Harrison said Friday in a You Tube video.

A heat advisory, according to the NWS, is a "period of hot temperatures, which is expected [to] create a situation in which heat illnesses are possible."

NWS advises people to drink plenty of fluids, stay in an air-conditioned room and stay out of the Sun. Also, "check up on relatives and neighbors."

Idyllwild Fire joins fire district association

County provides property-tax advance

With only three commission members present last week, the Idyllwild Fire Protection District Commission reviewed financial data for the first month of the fiscal year and discussed joining the Fire Districts Association of Califor-

In July, the beginning of fiscal year 2017-18, expenses were about \$35,000 greater than revenue. However, reserves on June 30, the end of fiscal year

2016-17, were more than \$500,000.

At its July 11 meeting, the Riverside County Board of Supervisors approved IFPD's request for a \$400,000 advance of property-tax revenue until the first tax payment is received in December.

These funds will help IFPD through the traditional summer period of low revenue and will be repaid during the current fiscal year from property-tax revenue. The county and IFPD have made and repaid the advance for several

The July revenue came from ambulance-service collections and repayment of IFPD's costs for helping other agencies, such as the U.S. Forest Service and Cal Fire, fighting fires in their jurisdic-

Eighty-five percent of costs were salary and benefits for staff. Of the remainder, the two largest were costs for the contract to collect the payments for the ambulance service, and audit and accounting fees.

The charges for emergency medical services were about \$94,000 in July, nearly \$35,000 less than a year ago. But overdue accounts receivables have declined since IFPD has been using more electronic billing and payment procedures, Chief Patrick Reitz told the commission.

Later, Reitz recommended that the

district join Fire Districts

Association of California. Although IFPD is a member of the California Special District Association, Reitz has found that FDAC has information and news specifically relevant to fire districts.

"They push issues of importance to fire districts, and it's a level of communication that we don't currently have," Reitz said. While there are not many fire districts in California, his conversation with several other fire chiefs in Northern California demonstrated the value

American Legion burglarized

When Michael Schnalzer opened the American Legion Post 800 at 11 a.m. Saturday, Aug. 26, he found a tripped alarm and much destruction. A burglar or burglars had broken into and ransacked the Legion's offices.

A file cabinet had been pried open, its contents strewn around the office, and the office safe was missing. According to Danny Richardson, Legion commander, the safe contained about \$1,200-\$1,500 in cash and valuables at the time.

Other damage included the destruction of three locked wooden boxes, and at least two doors appeared to have been jimmied with a 2-inch wide tool.

The alarm had been tripped at 3:07 a.m., but the sound had not alerted any-

According to Schnalzer, the person who dialed 911 and spoke to Riverside County Sheriff's Department personnel, they indicated that because the break-in had taken place so many hours previously, it was too late for them to respond or do anything but take a report.

At the time of this writing, security camera recordings had not yet been ana-

Idyllwild Water makes peace with **Director Kunkle**

Former board's lawsuit dismissed

On April 4, the Idyllwild Water District dismissed its litigation against current Director Steve Kunkle.

"I'm relieved that it isn't costing the taxpayers any more for a fruitless lawsuit," said Kunkle.

in July 2016, the previous board filed the case alleging Kun-

kle's "negligence" created an environmental incident which the district had to clean up. The case demanded \$50,000 for those costs from Kunkle.

In the suit papers, IWD alleged Kunkle, as an employee before becoming a director, knew about and allowed equipment to leak hydraulic fluid into the ground at the wastewater treatment facility.

"I was scared. I was on the hook for costs including an attorney," Kunkle admitted. The current board did reimburse Kunkle for his attorney costs, he added.

In March, the current board decided to dismiss the case after its attorney reviewed it. In February, the board held a closed session to discuss the case's merits and referred it to the attorney, according to General Manager Jack Hoagland.


The subsequent request for dismissal gave no specific reason. It simply asked the Riverside County Superior Court to dismiss the case with prejudice, meaning it is dismissed permanently.

Refer madness

The only madness that appears in this movie title, "Refer Madness," 1936, is the promotion of such a ludicrous claim. Drugs having 10 times the strength and voracity go unchallenged: cocaine, alcohol, heroin and the numerous legal pharmaceuticals on the market that are opium-based, despite their addictive nature and destructive potential on the human body.

To further my argument, opiates killed more than 33,000 Americans in 2015, according to the accounts for a small amount of forestry products. Centers for Disease Control and Prevention, noting that marijuana actually killed no one.

Between 1999 and 2014, opioid overdoses quadrupled, according to CDC. Plus, nearly 1.3 million Americans were hospitalized for opiate-related issues between 2005 and 2014, according to the Agency for Healthcare Research and Quality.

So, what is the big complaint with marijuana? Back mainly due to the lobbying efforts of the newspaper giant William Randolph Hearst, and the pharmaceutical and alcohol industries, who stood to lose millions of dollars if the hemp plant remained legalized. Hemp, the third-largest crop in the U.S. in 1910, with its naturally strong fibers, was a popular choice for making paper, fabric and rope.

Since Hearst and his newspapers needed newsprint (wood pulp) to publish, he acquired large forest holdings in North America where they would use most of the softwood trees to make the pulp to make the newsprint.

Since that time, every softwood evergreen tree (cedar, hemlock and fir) in North America was now a marketable product. This was a major factor in the complete destruction of our once-beautiful evergreen forests dominating North America.

The lumber industry was not in a position to be replaced as the pulp industry was when hemp could be grown all over North America. The lumber industry only

Since 1935 and the banning of hemp products, we have relied heavily on deforestation at unsustainable levels when the hemp plant could have solved the problem of paper production with little drawback to quality.

Here and now, almost a century later, the same problem exists. The forest, pharmaceutical and alcohol lobbies still dominate control of marijuana. With many states voting for medical and recreational use of marijuana, it's a good time to exert our freedom and liberty to provide our own forest of herbal remedies and replace the destructive effects of alcohol and opiates in all their

Jewel box or black hole?

Idyllwild is an exquisite jewel box, beautiful in itself but also filled with priceless jewels: Idyllwild Arts, Art Alliance, and a multitude of other volunteer organizations and public agencies that make the community a desirable place

But the golden chain linking all these jewels and making them accessible is the Idyllwild Town Crier. There are way too many organizations to list, but one need only to open any edition of the TC to view the wealth available to

Since its founding in Ernie Maxwell's attic (amid spiders and all) with a typewriter and mimeograph, it has grown into a first-rate, award-winning local newspaper, filling a unique niche for the community.

Now over the last several weeks, Becky Clark's dire prognosis of the paper's future raises the specter of an informational black hole. Imagine reaching for the latest edition, as suggested above, to check on the doings of the water companies, clubs, fire agencies, or any of the many jewels in the box and coming up empty-handed. Where else could you track community events?

Perhaps people don't realize the paper is the life's blood of the community. I can offer two examples from personal experience. Eleven years ago, when I was president of the fledgling Mountain Communities Fire Safe Council, federal legislation was passed enabling hazardous communities to establish Community Wildfire Protection Plans,

working with public input and interacting with fire-fighting agencies. JP Crumrine called me to ask if MCFSC was going to participate. I had no such plans, since we were struggling to get the organization up and running, but what could I say? I told him yes and the result was a CWPP whose most recent update was reported in the TC.

Another incident occurred around the same time when a Forest Service employee confided to me that the FS was planning a cutback in firefighting personnel for the upcoming fire season. I then phoned JP and said I had heard about a looming cutback, asking him if he had any knowledge about it. He hadn't, but he contacted the Forest Service authorities and asked if there were any such plans. The result was that the mountain was fully staffed that

The TC's value has been well established in emergency situations, most dramatically during the recent Mountain Fire with its online posts reporting the progress in evacuation and progress by the fire agencies, as well as in many

Now, Becky has informed us that she and Jack, struggling to keep the paper going, are worn out, pleading for support from the community. The danger is real. I hope the community joins me in pledging support in the Town Crier Membership program.

Further, I would suggest the formation of a Friends of the Town Crier nonprofit dedicated to volunteer help, such as going to the print shop and bringing the paper up for distribution. All the creative minds on the Hill could come up with many ways to help.

I hope this message is not an elegy, but part of a response already underway. A black hole is unthinkable.

sands more Town Crier newspapers, Explore Idyllwild Directories and Explore Idyllwild Maps in the hands of Hill visitors than ever before. We published the Town Crier's actual distribution and circulation numbers on page A4 every week, and we offered to share with potential advertisers the detailed records of our increased distribution and circulation.

We even appealed directly to local businesses' civic spirit, asking them to support the Town Crier for the benefit of our community, growing their businesses through advertising at the same time.

Although these efforts helped somewhat, they did not nearly produce the needed level of advertising from our local businesses. Some businesses say they can't afford to advertise (?), others say they don't need to advertise (!), and some give no explanation at all. But, whatever the reason, the traditional advertiser-funded community newspaper model does not work on our Hill anymore. So we must try something different.

So, beginning with the issue of Sept. 7, we can no longer provide the Town Crier free to the Hill.

We both are volunteers at the Town Crier, serving these years with no compensation. That was fine for us, but it means that when we retire, the Town Crier will retire with us, since nobody likely would want to acquire a newspaper that is viable only if the editor, proofreader, pickup/distribution man, light-duty handyman and occasional lawyer all are willing to work for free. And since Jack is 72, our retirement will be soon — not likely much later than this time next year; perhaps sooner than that. Our goal now is to quickly make the Town Crier financially viable so we can pass it on to other, younger publishers wishing to operate a real newspaper for our Hill.

And the truly major difference we must make is to our funding:

We now realize that Town Crier support is going to have to come from those who value us most — our readers. And our readers frequently tell us that they do not want an online-only newspaper; they still want a real ink-on-paper newspaper, too.

We have received many "thank yous" and favorable comments from our readers who really do appreciate what the Town Crier is doing for our community. During the past 16 to 18 months alone, the Town Crier's investigative journalism produced several articles revealing important information that had been misrepresented and/or concealed by our local governmental agencies.

'Going out of business'?!

From where did that notion come?

Our readers read our article "Does the Town Crier have a future? Our Readers must decide" (reprinted today on page A4) about forming a Membership model for the Town Crier, and they immediately and enthusiastically charged into action with their support. It's humbling, inspiring, exciting ... it's wonderful.

But three different town business owners, who read the very same article, have expressed to us that they were sorry we were "going out of business." Huh? Odd, the difference in reaction. (Please see the "Town Crier Readers to the rescue" on page A4-A5 of today's paper.)

The Town Crier is certainly NOT going out of business. There is nothing in the article — either before or after updating — that says such a thing.

The article is about our preparation for our retirement. We don't want the paper to retire with us. We

want to see it acquired by other, younger "mom-andpop" types who will bring community newspaper experience to Idyllwild and continue to run it as a real community newspaper. But we're not likely to find such pair if they're going to have to work for free, like we've been doing the past four years.

So Town Crier readers are building the paper up around the new Membership model; they clearly want to keep a real community newspaper serving our Hill. That is the objective.

As far as us retiring, we've set no hard-and-fast deadline. As long as our readers can create and support a viable newspaper, we want to stay on until we can find the right people to continue forward with the Town Crier. They may come sooner; they may come later. But we're already looking.

We have many contacts in this state through the California News Publishers Association and the California Press Foundation. And we have numerous national and international contacts through the International Society of Weekly Newspaper Editors. We will do our very best to find the right people for the Town Crier and our

Does the Town Crier have a future? Our Readers must decide [UPDATED Aug. 22 & Aug. 29]

On June 28, 2013, our small, close corporation purchased the Town Crier, which had not made any money during the previous four and one-half years. We had one objective: to save the newspaper on our Hill. We could not imagine our community without one. Three weeks later our online coverage of the Mountain Fire for Hill evacuees underscored that point.

What is a "newspaper"? A newspaper is a community watchdog that publishes the bad with the good. It warns of danger, advises of opportunity, challenges authority, praises accomplishment, investigates irregularity, marvels at art, exposes abuse, celebrates life and publishes its readers' letters. If a publication doesn't do all of these things, it may be something else, but it's not a newspa-

Why does our Hill need a newspaper? Well, to do all of those things just mentioned — but particularly because we have nine local public boards that are funded by our tax dollars, and they make decisions and recommendations as to how to spend even more of our tax dollars and what public services we get for them. These are the Fern Valley, Idyllwild, Lake Hemet and Pine Cove water districts, County Service areas 36 and 38, Idyllwild Fire Protection District Board of Commissioners, the IFPD Finance Committee and the Idyllwild Historic District Review Board.

These nine boards are monitored by nobody but the

Town Crier.

The old, traditional model for a community newspaper was to publish the news, sign up readers for subscriptions and sell advertising to local businesses. But subscriptions themselves never provided much revenue beyond paying for the postage to mail them out. A traditional community newspaper survived on advertising by local businesses.

When we began operating the Town Crier four years ago, it did not have enough business advertising to survive. So we tried a series of incentives in an attempt to attract advertising: We slashed our advertising prices by 25 percent, we offered full-color ads at no additional price, we tried publishing a promotional magazine, we introduced contests and new columns and improved our games, and our office remained open seven days a week to serve the needs of visitors to our Hill, hoping that those visitors would increase business for our advertis-

We tried "bundling" advertising in our various publications, providing deeper discounts for advertising in more than one publication. We changed printing companies and went to a broadsheet size because we knew it would produce a more reliable, better-quality newspaper with consistently sharper, more-colorful photos and ads, which it did.

Eight months ago, we made the Town Crier "free on the Hill" with free issues in each Hill mailbox, and the paper's circulation went from about 2,350 to about 5,500 more than 230 percent of what it had been previously -which meant more than twice as many eyes on our advertisers' ads.

We distributed Town Crier publications at more than 60 locations around the Hill which resulted in thou-

August mail-in ballot elections may disappear

Special districts may be moved to statewide elections

The last August election for members of the Pine Cove Water District may have occurred this week. The Aug. 29 election was conducted with mail-in ballots. (The results are online now and will be in the Sept. 4 issue of the Town Crier.)

When there are more candidates than available seats, both Fern Valley and Idyllwild Water districts conduct August mail-in elections.

But an obscure and barely noticed law, passed two years ago, limits future municipal and special-district elections held in off-year elections. These are defined as elections other than the statewide presidential and gubernatorial elections held in November of even-numbered years.

Gov. Jerry Brown signed Senate Bill 415 in September 2015. Beginning in January 2018, political jurisdictions may not hold an election other than during a statewide general election if prior off-year elections resulted in too low of a voter turnout.

Low voter turnout is considered 25 percent less than the average turnout for the previous four statewide general elections.

In 2010 and 2014, the state held gubernatorial elections and in 2012 and 2016, presidential elections occurred. In Pine Cove, the average voter turnout for those four elections was 79.9 percent.

While the results of last week's vote were not available in time for this story, the turnout for the 2015 election of directors was 43.5 percent. That is about 55 percent of the average for the four latest general elections.

Unless turnout for last week was greater than 60, PCWD will likely have to shift its election of board mem-

that all the recent state legislation — including Senate Bill 94, the Medicinal and Adult-Use Cannabis Regulation and Safety Act, enacted and signed this June — clearly recognizes and does not limit the county's authority to adopt and enforce local ordinances to regulate cannabis businesses.

Regulating state licensed cannabis business is within the scope of this legislation and extends to a county's right to ban cannabis activity.

The ad hoc committee felt that authorizing the legal cannabis businesses could help reduce the illegal market

The board did direct county staff drafting the new ordinances to reach out to communities through the use of public meetings to solicit the public's thoughts about this issue.

Some of the issues to be addressed include the careful location of these

away from businesses schools, parks and neighborhoods.

Approval of the tax measure will be the critical step in the future legality of cannabis businesses in the county. All county voters, not just in the unincorporated areas, will vote on the tax measure.

The board has not yet determined the level or amount of the tax. One important reason for the tax revenue is to provide funding for any additional staff necessary to enforce and to over see these activities.

The ad hoc committee emphasized the importance of the tax measure's approval with this statement to its board colleagues, "If the tax initiative fails, it is recommended that any ordinances or ordinance amendments establishing a comprehensive regulatory framework to permit cannabis businesses and cannabis activities not be enacted.

Some have argued that turnout for the 2016 election, 92 percent in Pine Cove, was unusually high because of President Donald Trump's presence on the ballot. If this election turnout were excluded from the calculation of the average and replaced with the 2008 presidential election turnout, the new four-election average turnout would be 88.1 percent, which would reduce the four-election average only 1 percent.

However, the law allows jurisdictions to delay this election shift if they have approved a plan to move future elections to statewide elections by Nov. 8, 2022.

IWD held elections for directors in 2007 and 2015. The turnout was 40 percent and 36 percent, respectively. The average turnout for the last four statewide general elections in Idyllwild has been 78.6 percent.

According to Rebecca Spencer, the county's registrar of voters, the cost to the districts for having an election at a different time and different manner "... will be about

During a statewide election, many more jurisdictions are on the ballot. The total cost is allocated based on the number of registered voters in each jurisdiction. The Hill water districts would be very small compared to the municipalities and multiple school districts.

"All mail-ballot elections are generally cheaper, but due to the large amount of cost sharing in even years, it pretty much ends up being about the same," she said and added the office is working with county counsel on the effect of possible changes on landowner districts, such as FVWD.

In April 2015, the Idyllwild Fire Protection District enacted a resolution to shift its commission elections to the November general election dates. The Riverside County Board of Supervisors approved the election change in November 2015. Normally, IFPD would have had an election for commissioners this month. The next election will now be on the November 2018 ballot.

No change to Sand to Snow Monument

On Wednesday, Aug. 16, U.S. Secretary of the Interior Ryan Zinke announced that he will recommend no changes be made to the Sand to Snow National Monument.

The monument, along with 26 other national monuments, were under review pursuant to President Donald Trump's April Executive Order. He directed Zinke to review all national monuments established since January 1996 and greater than 100,000 acres.

"Today, I am recommending that no changes be made to the Sand to Snow National Monument and that the Monument is no longer under official Department of the Interior review," said Secretary Zinke in his press release. "The land of Sand to Snow National

Monument is some of the most diverse terrain in the West, and the monument is home to incredible geographic, biologic, and archaeological history of our nation."

The Sand to Snow National Monument connects the San Bernardino National Forest and Joshua Tree National Park. It encompasses about 154,000 acres, of which about 100,000 acres have already been designated as Congressional wilderness areas.

The review included six monuments in California, including two Mojave Trails and the Sand to Snow National monuments -Southern California.

At the end of June, the 17 Republican Congressmen sent their recommendations on the various national monuments to Zinke. In this 26-page letter, they did not recommend any change to the Sand to

"While the designation by President Obama circumvented active legislation that enjoyed widespread support among local officials and stakeholders, it largely adhered to the proposed boundaries and management plans ... We recommend no changes to the boundaries of the Sand to Snow National Monument," they wrote.

In their letter to Zinke, the representatives did recommend that the Mojave Trails Monument be "confined to the smallest area compatible with proper care and management of the objects to be protect-

The results of reviewing this monument and several others have not been announced but are expected later this month.

Right-to-try drug proposal is a solution for a non-existent problem

This fall, the House of Representatives is likely to take up legislation passed by the Senate that gives terminally ill patients the right to try unproven, experimental drugs that are not yet on the market. Thirty-seven states have already passed similar legislation.

All this may sound like terrific news for very sick patients with few or no treatment options left, but the issue deserves a much deeper look thanks to its potential impact on people's pocketbooks and health.

"The public has no idea this is not a good thing," says Alison Bateman-House, a medical ethicist at New York University's Langone Medical Center. They know nothing about the bill except that the right-to-try sounds like a good thing."

For example, she said, few people in those 37 states know they may lose hospice coverage, or they may be denied coverage for home health care if they use an experimental treatment. In Colorado, Connecticut, Oklahoma and West Virginia, patients may lose their health insurance. Their coverage may be denied for six months after treatment

So why is there a drive for a national law? According to Bateman-House and others who oppose the law, from a process that's currently in place regarding MedPage Today. experimental drugs.

Under the current pro- the gatekeeper cess for obtaining such Bateman-House will agree to try the therapy and contact the drug company for permission to use the experimental treatment. Once the doctor and patient have that permission, they fill out paperwork and send it to the FDA. If the FDA says yes, a patient can try the drug.

But there are other hurdles. An Institutional Review Board, also called an IRB, at the hospital or other institution where the treatment will take place, must also approve the treatment. Finally, the patient must give consent and have money to pay for

The right-to-try bill pending in Congress eliminates the FDA from the process. The Goldwater Institute, a libertarian think tank based in Phoenix, has led the drive for legislation, and other like-minded thinks tanks that aren't keen on government regulations have also weighed in. It's the drug companies that decide if they'll let someone try one of their drugs that's still being developed and is not for sale to the public. "We don't know how many times requests to drug companies are approved or denied," says Bateman-House. "If the drug company says 'no,' that's the end of it."

The FDA. however. approves about 99 percent of the drugs that people who are terminally ill ask for, and the process moves quickly. The FDA turns around emergency requests within 24 hours, and in non-emergency situations within three to four days.

Why is FDA involvement important? For one thing, it doesn't have a vested interest in the outcome of someone's treatment the way a doctor or drug company has. For another, it knows about other drugs in the same class as the experimental drug and can look for problems that or agency has a right to tell have arisen with those

drugs. For example, how does the drug affect the heart? The FDA can also call for safety adjustments in the administration of the drug - such as what's $\,$ the best dosage - should the patient be on a heart monitor.

Many patient advocacy groups don't support the legislation pending in Congress. The American Society of Clinical Oncology says it supports access to investigational drugs outside of clinical trials when adequate protections are in place. It doesn't support right-to-try legislation because it ignores "key patient protections without actually improving patient access to investigational drugs outside of clinical tri-

Pharmaceutical The Research Manufacturers Association has issued noncommittal statements about the bill. "As long as you have private sector investment driving drug development, the priority is get the drug approved and sold and not to start giving it away, says medical ethicist Arthur Caplan.

It seems right-to-try laws are a solution looking for a problem, but that solution can cause problems of its own for desperately ill patients.

Pinyon homicide defendant seeks trial in juvenile court

Judge grants review

News Editor At the Aug. 18 hearing, the attorney for Cristin Conrad Smith, one of two defendants in the 2006 triple homicide in Pinyon Pines, filed a motion to move his trial in Riverside County Superior Court to

juvenile court. Smith was a juvenile when the murders occurred. His lawyer, John Dolan of Indio, argued that the request is consistent with Proposition 57, the Public Safety and Rehabilitation Act of 2016, which was approved last Novem-

The law "requires that a judge, not prosecutor, must decide whether juveniles should be tried in

adult court," Dolan said

in the motion to the court. Smith was about five weeks from his 18th birthday when the murders oc-

curred. "Under Proposition 57, even those who have committed the most heinous crimes, and even if they are nearer to the age of majority, are entitled to a fitness hearing and the exercise of judicial discretion before transfer to adult

court," Dolan argued. Bernard Judge Schwartz granted the request over the district attorney's objection, including reference to a prior Riverside Court case (Walker), which rejected these argu-

"The result of that hearing will determine whether or not defendant Smith will be tried in adult or juvenile court," wrote John Hall, public information of-

ficer for the DA's Office. The fitness hearing

will address several issues, Hall explained. "The judge considers five factors in making that determination: 1) the degree of criminal sophistication, 2) whether the defendant can be rehabilitated prior to the expiration of the juvenile court's jurisdiction, 3) any prior delinquent history, 4) success of any prior attempts by the juvenile court to rehabilitate the defendant, and 5) the circumstances and gravity of

the case." As of Aug. 28, a date for the fitness hearing had not been set; however, a hearing on the motion and the fitness report is schedule

for Oct. 20. Schwartz did deny two other motions submitted

by Smith's attorney. In April, Dolan challenged affidavits used by the Sheriff's Department

Electric vehicle program

The South Coast Air Quality Management District has established a residential Electric Vehicle charging incentive pilot program to offset Level 2 (240 volt) EV charger hardware costs. This program will be available to residents within the SCAQMD's four-county jurisdic-

The program will provide an incentive to buy-down the cost of residential chargers, which typically range from \$400 to \$800. The program will be implemented on a first-come, first-served basis and will provide up to \$250 for the cost of hardware for Level 2 residential

Another incentive of up to \$250 will be available for low-income residents. A charger would need to be installed at a 240-volt outlet or by a licensed electrician if no 240-volt outlet exists.

The charger would need to be in place for a minimum of three years and would be considered a permanent, not temporary, installation. The installer would need to obtain any required city

From Edyllwild: Alexae Visel

In this new regular feature, we highlight the accomplishments of our own young people, the kids who grew up in these mountains. We're reconnecting to hear about the incredible things they're doing locally and out in the world.

This week we catch up with Alexae Visel who currently resides in Brooklyn, New York...

Alexae Visel moved to Idyllwild with her parents Tom and Karen and little sister Kelly shortly before her 5th birthday. She attended Idyllwild School, where Karen worked as the school librarian. Tom, of course, was the town's preeminent locksmith for decades.

Alexae went to high school at Idyllwild Arts, graduating in 1997. After high school, she was admitted to the University of Cincinnati, where she earned her bachelor's of fine art in Theatre Design and Production.

From there she moved to the San Francisco Bay Area where she worked "all jobs possible in theatre costumes. I worked backstage, in costume shops, rental houses and worked as a costume designer." In 2012, she was accepted to the Yale School of Drama, where she earned her master's degree in Costume Design. Since graduation, she has lived in New York, New York, where she has done a couple of Off Broadway designs, and assisted on a Broadway show, and is now working on getting into film work.

How did you get into your current occupation?

I did school plays and camp plays and

put on performances in the living room since I was a little kid. It was always the thing that I just did that stuck.

Early in high school, performing didn't interest me anymore but scenic painting took over. In college, I took a majority of scenic and costume design classes until eventually, costume work became more dominant.

I love the psychology involved in figuring out characters' inner and physical lives

Describe your work.

As a designer, it is my job to tell stories through clothes. I am given a script that I read and from there I figure out logistics of who is wearing what and when. I must take into consideration each character's individual story, psychology, historical period and social context.

I create concept sketches and then collaborate with the director, scenic and light designers about what the style of the show is, what colors we'll be using, and how we want the production to feel. From there, I go out into the world on a strategic scav-

enger hunt to find these clothes or fabrics from which to make clothes, and when I am lucky, work with a team of skilled drapers and tailors to create them.

Often costumes are pulled from stock rooms and rental houses at various theaters since building everything from scratch is normally too cost prohibitive. Found garments are altered to fit actors and concepts.

What was special about growing up in Idyllwild?

It's hard to say since I didn't know another place to grow up. I do feel blessed to have grown up in the middle of nature and with so much access to the artists who call Idyllwild home. I was always watching bugs, exploring creeks and climbing trees as a kid.

Who were some of your mentors growing up?

I still have fondness for my Idyllwild teachers. The ones I remember the most are the ones who encouraged my creativity. Mrs. Lombard and Mrs. Sazer-Krebbers both encouraged my interests of art and science. They made third- and eighthgrade particularly memorable.

Mrs. Caratello ran a tight ship with writing and critical thought; the ability to analyze literature and string sentences together became vital for every part of life after.

I could ring off a long list of memorable lessons Barbara Pelham provided. My favorite Barbara lesson was a stop-motion animation project that gave me an early taste of

how art can be rewarding, exciting and excruciatingly slow work all at once. It was nice to have friends' parents who were professional artists. Isabelle McCaughey, Greg Kennedy, Marshall Hawkins, Buzz Holmes and Ann Hogan all proved that growing up to be an artist was possible.

Do you have a favorite Idyllwild memory from childhood?

The summer I learned how to throw pottery was pretty great. Greg Kennedy had challenged my dad to fill a kiln so instead of sending me to a sitter, I got to spend a lot of time with my dad and Greg; hands in clay, working on a potter's wheel and painting with glaze.

Any advice to young Idyllwilders?

When you're thinking about your future, try to picture and reach for the life you want more than the job you want.

Also, when and if you move to the city, learn how to use the bus even if you have a car.



Twenty years ago on Mars...

On July 4, 1997, NASA's Mars Pathfinder landed on the surface of Mars. It landed in an ancient flood plain that is now dry and covered with rocks. Pathfinder's mission was to study the Martian climate, atmosphere and geology. At the same time, the mission was also testing lots of new technologies.

For example, the Pathfinder mission tried a brand-new way of landing on Mars. After speeding into the Martian atmosphere, Pathfinder used a parachute to slow down and drift toward the surface of the Red Planet. Before landing, Pathfinder inflated huge airbags around itself. The spacecraft released its parachute and dropped to the ground, bouncing on its airbags about 15 times. After Pathfinder came to a stop, the airbags deflated.

Before Pathfinder, spacecraft had to use lots of fuel to slow down for a safe landing on another planet. Pathfinder's airbags allowed engineers to use and store less fuel for the landing. This made the mission less expensive. After seeing the successful Pathfinder landing, future missions used this airbag technique, too!

Pathfinder had two parts: a lander that stayed in one place, and a wheeled rover that could move around. The Pathfinder lander had special instruments to study Martian weather. These instruments measured air temperature, pressure and winds. The measurements helped us better understand the climate of Mars.

The lander also had a camera for taking images of the Martian land-

scape. The lander sent back more than 16,000 pictures of Mars. Its last signal was sent to Earth on Sept. 27, 1997. The Pathfinder lander was renamed the Carl Sagan Memo-Station. Carl Sagan was a wellknown astronomer and science educator.

Pathfinder also carried the very first rover to Mars. This remotely-controlled rover was about the

size of a microwave oven and was called Sojourner. It was named to honor Sojourner Truth, who fought for African-American and women's rights. Two days after Pathfinder landed, Sojourner rolled onto the surface of Mars. Sojourner gathered data on Martian rocks and soil. The rover also carried cameras. In the

three months that Sojourner operated on Mars, the rover took more than 550 photos!

Pathfinder helped us learn how to better design missions to Mars. It gave us valuable new information on the Martian climate and surface. Together, these things helped lay the groundwork for future missions to Mars.

Labor Day on the Hill is a treasure and a tribute

Labor Day on the Hill has its own quintessentially small-town vibe. Although conceived as a federal holiday to acknowledge and honor the American labor movement, celebrated on the first Monday in September, the three-day weekend has morphed into an unofficial end-of-summer ritual — a last chance to vacation and party as a family before kids go back to school (though Idyllwild School begins earlier now).

But originally, during a time of "robber baron" exploitation and abuse of American workers, Labor Day emerged as a tribute to trade unions and labor movements that fought for dignity and fair treatment of American workers. And lest the reason for the holiday were to be forgotten, the fight for fair treatment by employers of American workers came with sacrifice and causalities.

Thirty died and 57 were injured when President Grover Cleveland ordered the U.S. Army and Marshal's Service to intervene to stop the strike of workers at the Pullman factory in Chicago in 1894. Cleveland ordered the action because the strike had interrupted commerce and mail delivery. Following the deaths of strikers, the U.S. Congress unanimously

voted to make Labor Day a federal holiday. Cleveland signed the legislation six days after the end of the strike.

In Idyllwild, in a tip-of-the-hat to the entrepreneurial spirit of U.S. workers, Labor Day weekend has become one of industrious selling of family treasures to on- and off-Hill shoppers. The frenzy begins on Friday with early shoppers combing the main and back streets of Idyllwild in search of that certain something that, to the shopper, has incalculable value. Check Town Crier ads and map for sale destinations.

In addition to private sellers, churches, synagogues and other organizations also host yard sales. The shopping activity usually concludes before Labor Day on Monday.

From 10 a.m. to 2 p.m. Saturday, Sept. 2, the Friends of the Idyllwild Library holds its Sidewalk Book Sale.

From 1 to 4 p.m. Saturday, Sept. 2, Sons of the American Legion Post 800 host a barbecue with hamburgers, hot dogs and all the trimmings for \$7 a plate at the post. That night, from 7 to 11 p.m., Mark Huston hosts karaoke.

From 2 to 6 p.m. Sunday, Sept. 3, the Idyllwild Rotary Club will serve a Deep Pit Barbecue at Town Hall.

Stratford Players present 'Will in the Woods V'

What's in a name? Well, if the name is Shakespeare, the answer is some of the greatest, if not the greatest writing in the English language — magnificent and eloquent language with characters and plots to satisfy every appetite and attention span.

Heartbreaking romances, bawdy humor, epic adventure, conniving and skullduggery, heroes, thieves and villains — Shakespeare's comedies, tragedies and histories shine with the signature of a genius wordsmith

The names of his characters — Shylock, Romeo, Juliet, Othello, Iago, Macbeth and Hamlet — are known internationally. Many readers and theatergoers can recite the plotlines of his most cherished plays. Some linger over his words simply for their inherent beauty — "But

soft what light through yonder window breaks? It is the east and Juliet is the sun."

After more than 400 years, Shakespeare's stories remain compelling, engaging, thrilling and passionate.

At 3 p.m. Saturday, Sept. 9, and Sunday, Sept. 3 and 10, the Stratford Players perform scenes from "Macbeth," "Romeo & Juliet," "Hamlet," "The Merchant of Venice," and famous speeches from "Henry V" and "Julius Caesar" — all presented as they were in London during Shakespeare's day — in a theater open to the sky and lit by natural light.

And unlike attending the Globe as groundlings standing in the pit, Stratford patrons can sit for the duration of the performance.

There will be music, laughter, tears and a "new" play which Shakespeare is thought to have had a hand in writing — "Arden of Faver-

sham." Sir Jonathan Bate, professor of English literature at Oxford University, says "Arden" and several other linguistically fingerprinted texts, present Shakespeare in a new light, as "reviser, rewriter and collaborator." Kennedy posited that "Arden" would likely be a West Coast premiere of this "rediscovered" work. "It's also different from other Shakespeare works in that it's a crime thriller based on a true story."

Actors include Christopher Morse, Rena May, Christine Hunt, Derrik Lewis, Doug Austin, Harriet Briant, Dick English, Barbara Rayliss and Scott Wilson. Marsha Kennedy directs.



Camp Ronald McDonald for Good Times celebrates 35 years of healing

On Saturday, June 3, at a small gathering of Camp Ronald McDonald's most loyal supporters, founder Dr. Stuart Siegel and Fran Wiley, RN and longtime leader and volunteer, shared their memories of the 35 years since the camp's founding.

When Siegel founded Camp Ronald McDonald in Mountain Center, the goal was a simple one, with an altogether uncertain outcome. Bring a group of children with cancer up to the mountains to have the normal experiences summer campers have had for generations — no physiological sessions or formal therapy or focus on their white-cell counts, just the experience of being together in a summer-camp environment, being themselves and doing things they had not dreamed they could do.

Thirty-five years ago, the first session had 60 kids. At the end of the session, the results seemed conclusive. "By the end of the session, I remember this vividly. We were all standing there waiting for the buses to arrive," he remembered. "The session had gone incredibly, it could not have gone better and we were all standing there crying because no one wanted to leave. I knew we had something that worked."

When Siegel wrote that 35 years ago, 85 percent of children with cancer would not survive their diagnosis. Today, that trend has reversed with more than 80 percent surviving into adulthood.

What Camp Ronald McDonald for Good Times gave these children was a chance to regain their self-esteem and self-confidence — to have a break from worrying about their "condition" and provide an opportunity to just be themselves, with other children like them.

"That's the whole problem," said Siegel. "Cancer is such a rare disease in kids they don't re-

alize that there are other people that have this. Bringing kids together, they discover they're not alone and have other kids they can talk to."

In 35 years, the camp's sessions have grown from one a year with 60 campers to 12 sessions serving more than 1,800 campers. More than 42,000 campers have experienced the healing effects of the mountain camp. Volunteer oncologists and nurses work with camp staff to evolve this summer home to serve more campers.


On June 13, Los Angeles County Supervisor Sheila Kuehl presented the camp a commendation for the program's 35 years of serving children and families in the Southern California region.

"What we did was to take children out of the terrible hospital environment and let them be as normal as possible," said Siegel. That therapy has produced extraordinary results.









Grinding facility open Mondays





Free/reduced-price school lunches

Hemet Unified School District is distributing application forms to all households for free and reduced-price meals for enrolled children. Applications are also available at the principal's office in each

To apply for free or reduced-price meal benefits, complete an application and return it to the school. Applications may be submitted at any time during the school year.

The information households provide on the application will be used to determine meal eligibility and may be verified at any time during the school year by school or program officials.

Requirements for free and reduced-price benefits are as follows: For households receiving Food Stamp, CalWORKs, Kin-GAP, or FDPIR benefits, applications need only include the enrolled child(ren)'s name, Food Stamp, CalWORKs, Kin-GAP or FDPIR case number, and the signature of an adult household member.

For households who do not list a Food Stamp, Cal-WORKs, Kin-GAP or FDPIR case number, the application must include the names of all household members, the amount and source of the income received by each household member, and the signature and corresponding Social Security number of an adult household member.

Take precautions against high heat

With temperatures reaching triple-digits in parts of Riverside County, health officials are urging the community to take precautions against the heat and remind residents about the availability of cool centers located throughout the county. Idyllwild does not have a cool center, however.

"High temperatures always present challenges, but the first heat wave of the year can be particularly dangerous since people may have forgotten the danger high temperatures can present," said Sarah Mack, director of Riverside University Health System-Public Health. "There are some simple precautions that people can take to protect themselves."

Among the precautions, officials suggest residents drink water to prevent dehydration; avoid direct sunlight and stay indoors when possible; close blinds or curtains to minimize the heat; visit a mall, library or restaurant to stay cool; and make sure not to leave children, elderly, disabled individuals or pets inside unattended vehicles.

Some of the signs of symptoms of heat-related illness are headache, dizziness, muscle weakness or cramps, and nausea and vomiting.





Checking for ID theft of a child

The Federal Trade Commission advises: Any parent or guardian of a child knows the milestones that come with turning 16 – learning to drive, maybe dating, or thinking about college. But now, there's one more: checking their credit report.

But my kids don't have a credit card, house or car. Why should I check their credit report?

Because somebody else could be using your child's personal information. Once a child's — or anyone's — Social Security number is stolen, it can be used by identity thieves.

Checking to see if your child has a credit history, and then thoroughly reviewing it when they turn 16, can help you spot signs of identity theft. If you find false or inaccurate information, you'll have time to correct it before your child applies for a job, a loan for college or a car, or tries to get a credit card or a place to live.

Generally, children won't have credit reports unless someone is using their information for fraud.

What if my child has a credit report with incorrect or false information? Visit IdentityTheft.gov/child to report the problem and follow the steps outlined to resolve it.

Identity theft reporting simpler

When it comes to reporting and recovering from identity theft, the Federal Trade Commission has simplified the process by eliminating the need for a police report in most cases.

How does it work? When you report identity theft using IdentityTheft.gov, you'll answer some questions about what happened. IdentityTheft.gov then uses your information to create the tools you need to begin your recovery, including: a personal recovery plan; pre-filled letters to send to merchants, banks and others affected by the identity theft; and an "Identity Theft Report," which is your official statement about the crime.

In most cases, you can use your report in place of a police report to clear your account and credit records of transactions that resulted from the identity theft. That's because when you use IdentityTheft.gov, you're reporting the crime to the Federal Trade Commission, a federal law enforcement agency.


CDC recommends fewer shots

The Center for Disease Control now recommends that 11- to 12-year-olds receive two doses of human papillomavirus vaccine at least six months apart rather than the previously recommended three doses to protect against cancers caused by HPV infections. Teens and young adults who start the series later, at ages 15-26, will continue to need three doses of HPV vaccine.

CDC Director Tom Frieden said, "This recommendation will make it simpler for parents to get their children protected in time."

Generally, preteens receive HPV vaccine at the same time as whooping cough and meningitis vaccines. Adolescents ages 13-14 also are able to receive an HPV vaccination on the new two-dose schedule.






