## **Former FSC** president loses home in Santa Rosa fires

Editor's note: Mike Esnard and his wife, Robin DiMatteo, suffered an unimaginable and horrific tragedy during the Santa Rosa fires. Their home, their belongings, their family treasures were all burned and lost. They have found an apartment in San Francisco where their daughter lives and will re-settle there. The following comes from correspondence from Mike.

"We will stay in SF, and not rebuild in Santa Rosa. This is our new home," Esnard wrote in an

Many Hill residents know and remember Mike as a former Pine Cove Water District director from February 2007 until he resigned in June 2015. He served as president during his last two years.

Esnard also was a member of the Mountain Communities Fire Safe Council for more than a decade and served as president from 2006 until his resignation in January 2015.

Esnard described the community's sense of fire danger and the night it started in his email.

"As far as the fire is concerned, Idyllwild should be very proud of all its done in prevention. People up here had the sense that fires like this one simply did not happen in this area, so prevention was not high

## Assemblyman Voepel hears locals' views

Assemblyman Randy Voepel who represents the Hill, a small portion of Riverside County and a large swath of San Diego County from Riverside to Mexican border, was in Idyllwild last week.

He came to Town Hall on his "Listening Tour" of District 71. More than 30 people attended and posed questions on topics such

as healthcare, immigration, housing, public funding of elections and climate change during the 90-minute session.

Most of the attendees are active members of the Idyllwild Indivisible group who

are not supporters of Voepel. But the questions, answers and deeper discussions were insightful and helpful to all, including Voepel, who learned where many in Idyllwild stand on the political spectrum.

Introducing himself, Voepel said, "It's an honor to represent you in Sacramento. I'm a very conservative Republican. A supermajority of Democrats is running the state.'

He continued with his honesty and some humor. "My right-wing credentials are all in order, which I assume will play well here.' His conservative philosophy begins with "very little government, a balanced budget and an equal opportunity for all."

LaMont spent nearly three weeks in Klamath back country stopping fire

Editor's note: This is the first of two parts. The Salmon August Complex burned from July into August. Several local firefighters were part of the thousands who fought the fire during the late summer.

Firefighters focus on three conditions when they are battling a fire, especially a large fire. The fire's size, rate of spread, and intensity are largely governed by

these three variables — fuels, weather and topography.

What can burn and how rapidly it will burn are based on the fuels. Weather addresses the obvious, such as wind speed, temperature, but also relative humidity and forecasts. Topography affects the direction and also rate of spread.

This summer, before the catastrophic fires in Sonoma and Napa, there were other larger and more dangerous fires in Northern California. This complex was in very steep back county burning very dry fuels and shifting winds.

Idyllwild Fire Battalion Chief Mark LaMont was intimately involved in fighting the Salmon August Complex Fire,

## Meet Kimberlin Brown Pelzer

#### She plans to unseat Rep. Raul Ruiz

In October, Kimberlin Brown Pelzer announced her intent to challenge Congressman Dr. Raul Ruiz, representative of California's 36th House District, which includes the Hill communities.

Pelzer, who works in daytime television (soap opera) and owns several businesses, essentially began her political career at the 2016 Republican Convention. She was a featured speaker during the convention.

The opportunity to speak at the convention was the result of an inspired spontaneous moment at a Women in Business Forum in Anaheim during the California presidential primary in 2016. While they were awaiting candidate Donald Trump to arrive, several of the attendees were invited to use the microphone.

The first woman owned a medical insurance company. As a result of the costs for employee insur- Next, she addressed issues ance under the Affordable about Black Lives Matter. Care Act, she had to reduce staff from 25 to seven. Then a woman from Laguna spoke and a judge followed. At that point, a friend of Pelzer's urged her to stand and speak.

Obamacare. We used to pay 75 percent [of employee insurance] and they could choose the plan. After Obamacare, we can't afford those," she stated at the meeting.

She also shared that many young people were seeking work for cash to avoid paying for health insurance.

The Affordable Care Act was nothing more than catastrophic. It needs to change. Kids are not paying taxes or getting Social Security credit," Pelzer emphasized.

At the women's forum, she also discussed how the North American Free Trade Agreement affected employment and staffing on the sets of her shows. When passed, she assumed there would be little effect since the shows Canada, New Zealand and Australia were supplanting U.S. crews, she said.

"After that, they were vetting me to speak at the GOP convention," she said proudly.

Pelzer was the first major Republican to announce a challenge to "I started talking about Ruiz. Former desert news anchor Dan Ball also announced his candidacy the next week. The two candidates with the most votes in the June 2018 primary will face-off in the November general election.

"Truthfully, I am focused totally on unseating Ruiz," Pelzer said. "Too many politicians are afraid to make tough decisions. They're afraid to lose their job.'

Small businesses, improving their opportunities, will be the focus of her campaign. Change is needed "when business increases each year, but your take-home pay doesn't change," she ar-

Healthcare and taxes are two of the culprits limiting small businesses, in Pelzer's opinion.

While she stars on dayare filmed in the U.S., but time television, she and production crews from her husband have several small businesses, including her design business. So, she addresses the ob-

stacles and difficulties for my grandparents' ranch in small businesses from experience, she said.

"You fix taxes by starting with Congress," Pelzer said. "I'm thrilled this Congress passed a budget bill. It's the first in eight years. Anyone in business knows you need a budget."

Pelzer and her husband have a home in the desert. She is a native Californian, born in Northern California, and raised there and in Southern Cal-

"I got to play cowgirl on my interest and I can't be

Northern California and go to the beach in San Diego County," she said. The desert has been an important part of her life for nearly 25 years, she add-

It began with helping Dinah Shore raise money for local charities and continued after Shore's death.

"We did business here, up until one vear ago, but because of the rules and regulations, it became unaffordable. That peaked quiet anymore," Pelzer stated. "I can't sit home and rail at the TV. Something needs to be done. I've got to get in there and bring success to the district.

"I'm not establishment or like to be different," she concluded. "It's important to get results. That means work with each party. That's what's missing in Washington. I've set my sights on Raul Ruiz."

Despite his political views, or perhaps because of them, Voepel remained calm, open and direct. This impression was re-enforced with his comments that he has "... Democratic friends in the Assembly."

He said when he asked them why he was given such good committee assignments, their reply was, "You're a low-priced consultant." This was reference to his diligence reading and evaluating the bills, which come before his committees.

He is the vice chair of the Aging and Long-Term Care Committee and a member of the Insurance, Local Government, Veterans Affairs, Communications and Conveyance committees and the Education Budget Subcommittee. Voepel stressed that almost all the action in Sacramento happens in the committee meetings.

Voepel began with some "My very conservative friends get on Gov. Brown, but I tell them that Gov. Brown has vetoed more bills than [former Gov. Arnold] Schwarzenegger did. [Brown] runs a tight ship. And he put \$3 billion in the Rainy Day Fund."

The Indivisibles prepared a list of six questions for Voepel (see the accompanying table), and the first one asked was whether he considered healthcare a right or privilege.

"It's a right, certainly not a privilege. Yes, everyone should have healthcare, but who pays for it?" he responded. He pointed out that everyone in California who is poor, by the federal definition, has access to health insurance, Medi-Cal.

When asked about sin-

gle-payer insurance, he emphatically opposed it. He does not favor one type of insurance for everyone. He called his recommendation "layering."

In his example, the federal government would be responsible for health costs exceeding a high level, the state would cover costs in a middle level and local governments would be responsible for the small level of costs.

This did raise substantial feedback from the audience about Canada's health insurance and how family members living there do prefer it to the U.S. insurance system.

One female member of the audience expressed displeasure with the mandated requirements of the Affordable Care Act. She claimed that she has been paying substantially more for health insurance since the ACA was passed and she attributed this to the mandate requirements.

"I'd be happy with a praise for Gov. Jerry Brown. high-risk policy," she stated. "Not every policy should cover everything. I don't buy maternity care now."

> These comments led the discussion into the topic of women's healthcare and their right to decide whether to use birth control or to elect abortions. Voepel was asked to explain his "no" vote on Assembly Bill 569, which prohibits employers from taking adverse actions against employees for reproductive health decisions.

> "I voted 'no' because it was worded very anti-busi-Voepel responded. "I'm a businessman first and very conservative ... it required birth control and required abortions to be offered. A very small employer can't afford that. This raises the price of doing business."

This answer elicited several rejoinders about the rights of choosing which insurance policy and other medicines (such as for coronary, and who should have the right to choose.

When questioned about climate change, Voepel acknowledges its occurrence but questions its cause.

"I take a conservative stance. No doubt we have climate change, but what is the human impact?" he asked, and answered, "Most conservatives think it's about 1 percent. The conservative response is long-term climatic cycles, volcanic eruptions and God."

Again, the audience debated his view and countered with other reports.

While he opposed pubpaigns, he believes "more wealth is concentrated in fewer hands ever since 1929. Something's got to give. It's a privileged ruling government — both Republicans and Democrats. I resist that and would like to see a change."

Requiring candidates to release tax returns is not a policy Voepel supports, but he pointed out that the state requires lawmakers and employees to complete forms, which do shed considerable light on income, its sources and assets.

Admitting that Donald Trump was not his choice for the Republican presidential nomination (Ben Carson was his first choice), Voepel believes people should give Trump more time to accomplish some things, such as changing the wealth patterns.

As the evening moved toward an end, Voepel was asked what bills he was working on. He discussed a bill to support all veterans, reached at jp@towncrier. including LGBTQ, and not com.



on anyone's list.

"Unfortunately, that night we had a wind that was right out of the desert winds we knew too well in the south, and when the fire got going, they could not put it out and they were not well prepared for either alert or evacuation.

The fire destroyed everything in our neighborhood, which we thought to be a nearly ideal place to live. It is all gone, all the houses leveled — I am sure you have seen the pictures. We were right below the Fountain Grove community, and a fire storm  $came\ through\ just\ before\ 4\ a.m.$ 

We did not receive an alert, since our cells were turned off and AT&T made the house phone dependent on the internet, and power, which was off. I woke Robin at one point when embers were flying into our backyard and I saw trees start to ignite nearby.

"We got our dogs, laptops and drove away. After I manually raised our garage door I saw a pick-up with two firefighters going through our streets on a loudspeaker telling people to leave. We left minutes after. I could see houses igniting a block up, and the smoke was intense," Esnard wrote solemnly, but grateful he and Robin were able to respond.

They drove to San Francisco and stayed with his daughter until they located an apartment. So, the city will be their future, he said. "We are not going to rebuild — we think it will take 4-5 years to get all the houses back up and the area is not going to be the same for decades. We are very happy to be in SF.'


Reflecting on the catastrophic fire they endured and survived, and comparing that experience with the constant fire threat here, Mike wrote, "The irony of all this is enormous for us — I spent years working with the MCFSC and thinking about fire every day.

"I was relieved in some ways to put it behind me in Santa Rosa, since fire was not a concern. I think about things I could have done to save our house, but nothing would have mattered. The new firehouse on top of the ridge burned down, and that had harder materials and more clearance than was possible for us.

"As I said, Idyllwild and its major actors seem to me years ahead of people up here. I think Edwina [Scott, executive director of the MCFSC], Jerry [Holldber, Pine Cove Water general manager], Norm [Walker, former fire manager for the San Jacinto Ranger District and current MCFSC president], Dan Felix [succeeded Walker as Ranger District fire manager], and Chief [John] Hawkins [Riverside County Fire chief] were models of handling the fire threat.

"They should just keep doing what they have been doing. People up here will have to come around to the idea that climate change probably means fire will be the threat in northern California that has been in the south," Mike concluded.

which burned 65,000 acres in or near the Klamath National Forest. The Salmon August Complex was actually a group of fires that initially began in July from a lightning strike. Most of the acreage burning was deep in forest. However, in early August, more lightning strikes ignited several other fires in the Klamath and they began burning vigorously.

By Aug. 13, the KNF leadership combined seven single fires into the Complex and requested assistance from a National Incident Management team. Team 2 from California was the available team and it was deployed north. This included LaMont, who only had hours to get to the forest, assess the situation and organize his units to combat the growing conflagration.

The Forest Service has nearly 50 Type 1 and Type 2 Incident Management teams. Southern California has three teams. The commander of Team 1 is Chris Fogle, battalion chief on the San Jacinto Ranger District, and the deputy is Norm Walker, former fire manager office for the ranger district and former chief of the Idyllwild Fire Department. LaMont is a member of this team, composed of about 80 members from fire agencies and departments throughout Southern California.

On Aug. 17, LaMont got the call to collect his gear and head north to the KNF. There was major fire awaiting

Preparation has been learned and developed over years of training, and he stresses, "You don't leave without anything you would need to exist for 21 days in the wilderness." Most firefighting does not occur in the wilderness, but that is where the Salmon August Complex was burning. So, this aphorism applied readily for this call.

LaMont is one of a few division chiefs on the IC team. Twelve hours later, he arrived at the KNF. The IC team headquarters was located at the forest's Happy Camp District Office in Scott Valley. The walls of the building's

conference room were covered with maps of the district identifying the fires' locations.

For the next 12 hours, he and the team management had to accept the delegation from the NF, assess the situation, start to develop plans of attack — including initial resource orders, such as engines, aircraft, hotshots, and food for his team — understand the terrain in which they would be working and organize dozens of firefighters to battle a blazing forest.

As a division chief, LaMont was responsible for a specific area, Alpha area, of the whole fire. "We had that piece of dirt. Our responsibility was to come up with a tactical plan to safely suppress our piece of ground," he

To impede and halt the spreading wildfire, the firefighting divisions have to create fuelbreaks. In the high country, where LaMont's crews were assigned, engines would have a very difficult time getting to the fire site. So, bodies were the important asset. They would have to physically cut and burn fuelbreaks, with the intent of creating a zone with minimal fuel so that as the raging fire reaches this area, it will have no where to go and nothing rejuvenating its strength.

So, one of their tools was fire — fighting fire with fire. "It was one of the first tools I used as a tactical advantage to halt the fire's progress, which was already running for four days."

During the initial planning, LaMont learned that the Redding smoke jumper team, which was put into this area, already had to be evacuated. "They were overwhelmed right away," he reported. "The fire's activity increased substantially. It was running hundreds of acres per hour."

LaMont and his firefighting contingent would be located in very steep terrain, during hot weather and low relative humidity. The fuel moisture was relatively nonexistent. "There was no resistance to the fire," he sum-

## Therapist provides tips on discussing tragic events with children

In the days and weeks following a high-profile tragedy, violent confrontations, mass shootings, or natural disasters, news stories may cause stress and anxiety for the vounger audience. It is normal for adults and kids to feel anxious after a devastating event, but there are ways to help minimize the stress and maintain a sense of normalcy.

With the pervasiveness and invasiveness of TV news and social media, children today have more access to disturbing news and images than ever before. The most common reason I'm seeing for children being referred to therapy (even as young as 4) in the last several years is excessive, and sometimes debilitating, anxiety," said Susan Kelsey, a licensed marriage and family therapist specializing in mental-health services for children and adolescents.

Here are a few suggestions for parents to help reduce their child's risk of becoming overly anxious during trying

First and foremost, parents should limit exposure to disturbing material as much as possible for these very young children, including visual images and overheard adult con-

All children (even little ones) pick up on and respond to feelings their parents are experiencing, so if parents are feeling overly anxious by the news, they should seek help to reduce their own anxiety.

Parents should answer any questions the child has in an age-appropriate way, keeping in mind that small children scare easily and don't have the capacity yet for critical thinking.

#### Early childhood through adolescence (ages 6-19)

Again, limit exposure to disturbing news and images (as age appropriate).

Younger children in this group are beginning to develop more awareness of the world around them and will likely have more questions, fears and misconceptions. Encourage children to express their fears (either verbally or through art), and respond by listening to what they have to say, clearing up any myths or misunderstandings they have, and discussing ways they are safe.

Make sure there is plenty of time for children in this age group to engage in imaginative play and to focus on school. In other words, let them be kids. Sports, dance and any other ways kids can move their bodies can be helpful in reduc-

Where teens are vulnerable to anxiety and depression, teens also tend to be very empathic and intolerant of injustice, so conversations can focus on ways they can get involved in making the world a better, safer and more tolerant place for all people in the future. Help exchange feelings of helplessness with feelings of empowerment.

Kelsey also recommends that parents keep eating and sleeping routines in place for children, and to prevent children's access to adult content on computers, phones and TV. Also, children of all ages who are in the groups that are being targeted for hate and discrimination are especially vulnerable to anxiety and depression. Children are at risk on many levels. "Any parent who is concerned about their child's mental health should seek counseling from a therapist who is experienced with children's issues," said Kelsey.



## Stone receives perfect score from Howard Jarvis

#### Assemblyman Voepel close

Last week, the Howard Jarvis Taxpayer Association announced its 2017 Legislative Report Card grades. Two local officials received ery high grades.

State Sen. Jeff Stone (R-28 District) earned a 100 percent rating from HJTA. Assemblyman Randy Voepel (R-71 District) received a 98.4 percent rating.

Stone was one of only 10 legislators — five senators and five assembly members — out of 120 to receive the perfect rating. Of the five sen-

ators, four, including Stone, were from Southern California. In 2016, HJTA gave Stone a 95.8 percent

Voepel's abstention during a committee vote on Assembly Bill 1189, which authorizes the Riverside County Transportation Commission to impose a 1-percent tax, an increase of ½ percent for transportation projects, cost him a perfect rating, according to David Wolfe of

Voepel opposed the bill on the Assembly floor. This year was his first in the Legislature so he did not have a 2016 rating.

"Are we troubled or worried about Randy?" asked Wolfe. "No! San Diego County and Temecula have a lot of limited-government conservatives."

The HJTA scored a total of 22 bills in 2017. Stone voted on the side of HJTA each time he had an opportunity to do so.

"It is an honor working with the Howard Jarvis Taxpayers Association — an organization that puts the interests of everyday taxpayers ahead of special interests — to fight for lower and fairer taxes here in California," Stone said in a press re-

"Every vote I cast in Sacramento is done with the best interests of my constituents, and I'm proud to associate myself with a non-partisan organization that puts taxpayers first," he added.

## Ruiz 2018 campaign raising more funds than 2016

The June 2018 primary is about eight months from now and the November general election is only a year in the future. Rep. Dr. Raul Ruiz continues to solicit and receive substantial campaign contributions. Through the end of September, Ruiz had nearly \$1.8 million in available cash. At this point two years ago, Ruiz had about \$1.29 million available for his second re-election campaign. He went on to raise a total of \$3.4 million for his race.

Three challengers against Ruiz have filed preliminary financial paperwork with the Federal Elections Commission. Kimberlin Brown Pelzer and Dan Ball, both of the desert, are entering their first political campaign. Stephan Wolkowicz, from Indio, is a third Republican candidate. He was a candidate in the 2016 race also, but had no donations or expens-

Since January, Ruiz's campaign has raised nearly \$1.3 million in contributions and spent about \$525,000

without a specific opponent. The three Republican challengers did not announce their candidacy until October.

Ruiz has expended more than \$100,000 to raise campaign funds. The principal help are Mothership Strategies and consultant Amy Strathdee of D.C. Although Ruiz has received thou-

sands of contributions, some for as little as \$3, more than half of the total funds have been from contributions greater than \$2,500.

#### Ruiz introduces Environmental Justice bill

Last week, local Congressman Dr. Raul Ruiz (D-Cal 36) and New Jersey Sen. Corey Booker introduced into both houses of the U.S. Congress the

Environmental Justice Act of 2017. The bill's purpose is to "eliminate environmental injustice ... [by] requir[ing] federal agencies to address environmental justice through agency actions and permitting decisions, and strengthens legal protections against environmental injustice for communities of color, underserved communities, and indigenous communities," ac-

cording to Ruiz's press release. The legislation is the product of many months of working with commu-

nity groups from across the nation. Already, many local 40 public-health and environmental-justice organizations have expressed support for the bill.

Both legislators held press conferences and spoke out against the treatment of minorities' environmental

"Can you imagine watching your child with asthma struggle to draw breath because of new, preventable air pollutants and feeling powerless? Can you picture the anxiety in finding out there are toxic chemicals in your water or near your children's school and having little way to hold anyone accountable? This is happening in rural and underserved populations in my district and across the country; I know because I have treated them in

the emergency department," said Dr.

"This legislation gives voice to the voiceless. It strengthens protections for vulnerable populations, gives impacted communities the ability to hold big corporations and government accountable, and provides the funds needed to mitigate and prevent future instances of environmental injustice," Dr. Ruiz added.

In a conference call with reporters, Ruiz stated the legislation has particular relevance in his congressional district, which includes Idyllwild and all the Hill neighborhoods. Many of the district's communities cope with contaminated drinking water and some of the highest childhood asthma rates in the state.



# From ldyllwild: Wes Wills

. I leave this stage tonight even more optimistic about this country than I was when we started... This generation coming up - unselfish, altruistic, creative, patriotic - I've seen you in every corner of the country... You'll soon outnumber any of us, and I believe as a result that the future is in good hands."—President Barack Obama in his farewell speech on Jan. 10,

In this new regular feature, we highlight the accomplishments of our own young people, the kids who grew up in these mountains. We're reconnecting to hear about the incredible things they're doing locally and out in the world.

This week we catch up with Wes Wills, who works at Yosemite National Park protecting our cultural resources ...

William and Mary Wills moved Wes and his sister Andrea from Fallbrook to a house on Cascade Drive (between Idyllwild and Pine Cove) in the summer of 1990. William commuted to a teaching job in Temecula while Mary worked for a time as the Idyllwild School nurse and in other jobs in medicine.

Wes attended Idyllwild School from first through eighth grade. He enjoyed many extracurricular activities, from drama, choir, band and chess club, to baseball, track, cross country, basketball and soccer.

"I grew up with a few guys that were like brothers to me and was really fortunate to have spent nearly a decade sharing the same classes and social groups," Wes recalls.

Wes graduated from Hemet High School in 2002 and went on to Sonoma State University. He graduated in 2005 with a Bachelor of Arts in anthropology, then went on to earn a master's in cultural resource managment in 2013.

"I worked a variety of jobs in college, particularly food service and construction labor," he said. "Majoring in anthropology did not lend itself to a clear career path and up until I was 22, I really didn't know what I wanted to do. I started learning about archeological methods in 2004 and saw it as the best route for finding work. It also combined my interests in science, working outside in a variety of locations, and learning about the past."

#### How did you get into your current occupation?

In 2005, I started working as an archeologist at Sonoma State. I also briefly worked for the California Office of Historic Preservation and California State Parks before starting a job for the National Park Service at Yosemite National Park in 2008.

I also occasionally work as a wildland firefighter and have served on many incidents in the Central Sierra Nevada.

#### Please describe the work you do.

My job is to document and protect archeological sites in Yosemite while serving as a park ranger. This role is within the Division of Resources Management and Science. Tasks range from assisting with planning for construction projects, providing interpretive programs to visitors and employees, supervising other archeologists, consulting with American Indian tribes and groups, leading surface survey and test excavation projects, map and database production, and writing technical reports.

This summer, I led two 10-day backpacking trips to remote areas of Yosemite as part of test excavations at archeological sites with a team of seven others. I'm currently working on writing a report about this project in collaboration with a professor from UC Merced.

I will also be leading a couple of small survey and excavation projects within and close to Yosemite Valley. Occasionally, I also work on research projects and my master's thesis focused on prehistory in the northwestern part of Yosemite.

#### What do you enjoy doing outside of working in Yosemite?

I have travelled extensively over the past few years and have been to 32 countries. My wife Hillary and I even went on a single trip around the world. Traveling is definitely my biggest passion and I am looking forward to an upcoming journey to Norway and Kosovo.

#### Who were some of your Idyllwild mentors?

I really enjoyed my classes with Doris Lombard, Patty Carratello, Lenore Sazer-Krebbers and Mr. Valdez. Holly Guntermann was a great P.E. teacher and occasional coach. I also received a lot of support from my friends' parents, particularly Dave and Lori Fraser.

My parents used to visit Doris Lombard in Mountain Center. However, my parents are now very ill and are unable to make the trip from their new home in Oceanside.

Don't look for perfection. Lower your standard for appearance on fruits and vegetables, ignoring those bruises and blemishes. You'll find they taste no different from unblemished produce.

Use old produce. We tend to throw out lettuce that's beginning to wilt or bananas that are bruising. Why not throw them into a soup or smoothie instead? Wilting leaves also can be revived by leaving them in a bowl of

It has become an American standard to serve big portions. Use smaller plates and serve less to avoid throwing out any uneaten food. It also might help you lose a

Composting takes your unwanted food and transfers the nutrients back into the soil. You can compost fruit peels, coffee grounds, egg shells and other items you'd normally toss in the trash.







It was when the guns stopped to signal the end of World War I — the 11th hour of the 11th day of the 11th month in 1918. Originally called Armistice Day, or Remembrance Day in other parts of the world, the annual observance was established by President Woodrow Wilson and first commemorated on Nov. 11, 1919.

In 1926, the United States Congress passed a resolution commemorating the end of World War I with these words: "It is fitting that the recurring anniversary of this date should be commemorated with thanksgiving and prayer and exercises designed to perpetuate peace through good will and mutual understanding between nations

In 1938 before the outbreak of WWII in 1939, a formal act of Congress made Nov. 11 each year a legal holiday. In 1954, following the Korean conflict, Congress renamed the holiday Veterans

Nov. 11 honors American men and women who gave their lives serving their country, as well as veterans from all America's conflicts.

Idyllwild's American Legion Post 800 will observe this solemn occasion, on

ning at 11 a.m. Organizers hope to have a speaker, but at this time, that is not yet set. As part of the ceremony, an honor guard will perform the traditional folding of the flag ceremony, with each fold honoring service in a particular war or conflict in which American military men and women fought.

Depending on weather conditions, the service may be held outside. There will be three rounds of rifle volleys honoring those who gave their lives after which Cid Castillo, former Navy petty officer 3rd Class, will play







## New album features 23 musicians, most local

#### Brewpub release party is Nov. 16

Editor's note: Taken from press release and interview with Wilson by Marshall Smith, Staff Reporter

Singer/songwriter Johnny Wilson has deep Idyllwild roots and many local connections and friends. What started out as a solo album of six or seven original songs evolved into an album called "Johnny & The Competition," featuring 22 other musicians and 15 additional instruments. As it turns out, even in recording, it does take a village of friends to come together, collaborate and grow an initial concept into something altogether different.

"It was going to be just me, one guitar and one mic," Wilson recalled. "But in discussing it with Brian [Par-

nell, album producer], he began suggesting additional instruments that would be good for particular songs — like this song might be great with a cello, this one with a violin or this one with a trombone. I had actually envisioned a horn section for that particular song."

And with each suggestion, Wilson said he knew someone who played that instrument and might be interested in joining the sessions. "That's kind of how it developed," said Wilson who, by nature, is upbeat and positive.

Eventually, full-session instru- Album cover of "Johnny & The Commentation included acoustic guitar, Petition' electric guitar, bass guitar, U (ukulele) bass, drums, percussion, piano, keyboard, cello, violin, fiddle, banjo, accordion, trumpet and trombone played by Wilson and 22 friends and musical colleagues.

Wilson laughed when he explained how a homemade kazoo proved critical in the sessions and the eventual musical arrangements. "I created one on the spot to show horn players the lines I wanted them to play," he said. "Each musician wrote their own parts for the recording." It was, he noted, a true collaboration in which 22 additional musical colleagues lent their talents to create a diverse, vibrant and multi-genre compilation.

Wilson's songwriting inspiration comes from artists who include Johnny Cash, Jimmy Cliff, Gerry Rafferty, The Descendents, Jurassic 5, The Bronx, Stone Temple Pilots, Jimi Hendrix, G. Love and Special Sauce, FYI,

Toots & The Maytals, Led Zeppelin, Queens of the Stone Age, Bob Dylan and Alice in Chains.

He said his motive for writing the album came from his love of the wonderful world of music in all its different forms and genres. "One of my mentors, Bob Benjamin back in Costa Rica, told me to 'never stop writing,' so

I'm just following his advice. Bob is in his 60s and still coming out with new albums," he recalled.

Wilson had been writing songs since he was a teenager, but he cut his teeth professionally on the streets of Tamarindo, Costa Rica, after college, where he learned — first by busking, then by being asked to play in local clubs — how to get paid to play. He spent two years there polishing his professional chops.

He also was an original member of the local band Throw the Goat.

Wilson said the biggest surprise that came out of the album's collaborative process was the development of a hip-hop track, "Here We Go."

"Originally, we were going to have just one MC [in rap, the rapper or mic controller]," he noted. "Then we decided to have seven MCs write their own verse but with rules. Their first line had to be 'I'm living my life. not trying to think twice,' and the verse had to contain at least one food item. The result was a catchy beat-driven hip-hop track with seven totally unique

When asked about the name "Johnny & The Competition," Wilson explained, "This was a little tricky since each track has a different cast of musicians. Then a Huey Lewis and The News song popped into my head [I've always loved that band name] and I wanted to do something similar but different. I've always been a competitive guy. I thought maybe we should name the artists on the album The Competition."

From a solo vocal and guitar album concept to "Johnny & the Competition," the creative process was emblematic of the kind of cooperation and collaboration found in Idyllwild if one is open to going with the flow, as Wilson is.

## Opal and the Secret Code

This is the third in a nine-part weekly series. The series is unique because it tells the true story of a deaf girl, Opal Mehigan Fleming, and how in the 1930s, learning American Sign Language opened up a whole new world for her. It shows how her new language made her feel equal to others and not left out in a dark, lonely world.

Opal's resilient spirit enabled her to overcome so much in her lifetime. She became a well-educated, dignified person loved by so many, including the author of Opal's story. For 20 years, she was a teacher's aide at the North Carolina School for the Deaf. She died in 2003.

This year (2017) is the 200th Bicentennial of the first American School for the Deaf. Janie, who lives in Hemet, is available to visit classrooms to help motivate kids to write their own stories and build believable characters.

#### Chapter Two: Still No Pa

The next morning, I found myself in a strange room. The morning sun flickered through tall windows behind me and the smell of something cooking filled the air. In the room there were two long rows of beds — each one with a girl in it. Some of the girls were older and tall like my sister. Others were my size, some even smaller.

Where was I? I wanted Pa. Where was he?

I sat up in the bed. The tall woman with hair like a cinnamon bun came toward me. She had a blue dress in her hand and motioned for me to put it on. I looked her in the eye and folded my arms. It wasn't my dress and I wasn't going to put it on! The woman hovered over me, pinched her lips together and folded her arms. She poked me on the shoulder again and again as she pointed to the dress. Finally, I got so tired of being poked on the shoulder that I stuck my arms through the holes and the woman pulled the dress over my head.

didn't want her to keep poking me so I got in line, too. We went down the hall to a stairway. I stomped down that long stairway behind the other girls. We marched single file straight down another hall and around the corner to the right. Then we each stood next to a chair at long wooden tables. There was a white plate and a tin cup on the table in front of each one of us.

I refused to look at anyone, except out of the corner of my eye. I decided that they could force me to get dressed, march in lines and sit in chairs. But they couldn't force me to like it or to like any of them. I wasn't going to stay there long anyway. I'd be out of there when my Pa comes.

For the next few days I dressed myself, marched in long lines and sat on their hard, wooden chairs. I kept to myself wherever we went, even when we were all marched outside to play. Day after day I kept an eye on each one of them and an eye out for Pa.

Pa never came.

I wondered what Ma and my brother and sister were doing. I wondered if the prairie winds had swept away the new flowers Ma and I had planted around the fence posts close to the house. I wondered if the man next door ever got rid of his crazy bull with the long curved horns. But most of all, I wondered why Pa didn't come back for
