

## **IWD** sets rate hearing

n June 15, the board of the Idyllwild Water District (IWD) will conduct a public hearing on the issue of raising water rates. At the hearing, the board will discuss its needs for a 6-percent rate increase effective July 1 and language to impose a 6-percent rate increase for each of the following four years.

Last week, at a special meeting, the board originally set the hearing date for May 18. Since then, the board decided the later date allowed them to fully comply with the requirements of Proposition 218. California voters adopted this proposition in 1996 and it became article X111, sections C and D of the state constitution. The language governs

existing and proposed increases in property taxes, assessments and special government fees. IWD, in order to increase its water rates and related fees, must comply with this language.

Prior to the June session, the district will mail more information and details to district voters. If more than half object to the proposed increase, the board may have to reject it. Other fee increases, such as meter installation, will be on the agenda, too.

During the discussion of the level of rate increase needed, Director John Cook stated IWD's average annual operating or expenditures increase has been 5.7 percent.

"We're also trying to keep a reasonable and prudent reserve," added Director See IWD, page 13

### Weekend rescue and snow survey

On Saturday, April 24, Les Walker and Pete Carlson, of Riverside Mountain Rescue Unit (RMRU), rescued a Skyline Trail hiker who had lost the trail the previous evening. The 40-year-old man had begun hiking early Friday from Palm Springs and intended to complete his hike at the tram. Unlike many who attempt that trail, the man was properly equipped for his expedition, according to Walker. "He just got lost," said Walker.

A Riverside County Sheriff's Department Aviation Unit helicopter spotted the man around 5 p.m. RMRU got the dispatch call and arrived at the tram base around 9:30 p.m., about one-half hour after the last regular tram car dispatch. Tram officials refused to authorize a car for the six-man RMRU team to ascend.

Consequently, they camped in their cars in the parking lot and took the first tram up at 6:30 a.m. Saturday. Walker and Carlson were the first to reach the hiker. "We located the man, See RMRU, page 10

#### Outside Idyllwild

#### It's still about the snow ...

Last week's snowstorm put a damper on the rites of spring and caused yours truly to go into a brief funk as I spent my days-off indoors.

I am chomping at the bit to get out on the trail and am totally focused on the Pacific Crest Trail (PCT) hikers and work issues. It seems that it is hard to get my act together when the weather will not cooperate but the bottom line is that the next month or so belongs to the PCT hikers.

At least a couple dozen hikers have come into town already and most of them are not particularly anxious to tackle the trail through our mountains. I don't blame them for being cautious as things are not looking so good out on the trails currently [see snow survey on page 2]. Of course, it is nothing that a couple of weeks of warm, sunny skies can't take care of, but here and now things look bleak for all but the most ambitious PCTers.

My local informant, better known as Forest Service Volunteer Joe Bressi, reports 10 inches of new snow on top of a 3-foot base at Chinquapin Flat and no other footprints other than his own. The trail is not really visible past the Tahquitz Peak junction. I have not spoken to a single hiker that has made the trip from Highway 74 to Humber Park.

Next weekend there will be a three-day snow course in our local mountains and I think that most of those seeking instruction will be PCT hikers. At any rate, they will either have to hike and camp on snow or take the Black Mountain Road to bypass the local trails. It is a decision that has to be made most every year unless a hiker is traveling through in late May or June.

So far this year, in additon to meeting PCTers from all over the United States, I have met hikers from France, England and Austria. I believe this is the first Austrian hiker I have met in the shop.

The French hiker was a woman hiking solo on the PCT. We met when I was out shoveling snow at work on Thursday morning. I happened to look up and she was standing in the driveway looking a little cold and forlorn. She asked if she could help me shovel snow because she had nothing else to do as she was not going out on the trail during a snowstorm.

I made a deal with her; I would "let" her shovel some snow if she would teach me the French words for some of the gear in the shop. We never got around to the French lessons but I did manage to find her a ride down to the PCT kickoff at Lake Morena.

On Sunday, I met another Karen Keller. Not Idyllwild's own Karen Keller, who I dubbed "Special K," but another PCT hiker named Karen Keller. Luckily they have different





to hear discussion about recreational opportunities in Idyllwild and to demonstrate their support for Bob Lewis, executive director, Claudia Posey, administrative director,

A week ago, more than 70 people filled

the Idyllwild Fire Station conference room,

and all the other paid Idyllwild Community Recreation Council staff who were concerned their jobs were at stake.

Neither there nor since has anyone spoken up for the potential loss of teachers at Idyllwild School.

I must confess I enjoy conversations with Bob, especially during softball games and the youth basketball games he referees (but I think he needs to wear his glasses more often if he intends to use his whistle). But I'm sure he would agree that the recreation brouhaha is not about where one resides; it's about the quality of performance or service. As the venerated Marge Muir said, "It's what's best for Idyllwild."

I could viscerally sense the community's support for Bob and his staff last week. And it made me comfortable to realize I live in a community that cared about neighbors

But why can we organize and agitate about recreation and not education?

As we know, "all work and no play ...", but "readin, ritin', and 'rithmetic" are still important for our children's and their children's futures. Recently 3rd District Supervisor Jeff Stone said, "Riverside County can not compete with Orange and San Diego counties because we don't have the same level of an educated workforce."

Inadequate education is not Bob's fault. I'm blaming all of us. Several times, I've written of the possible deleterious effects reduced state funding will have here. Last week, the Town Crier reported that Hemet Unified School District (HUSD), of which Idyllwild School is part, will have to lay off 15 teachers.

HUSD's offices may be in Hemet, but their authority extends to Idyllwild. Now Principal Matt Kraemer may face the next school year with two, maybe three, fewer teachers. Full-time kindergarten teacher, Michelle Adler, Kirsten Ingbretsen, a sixth grade teacher, and Colleen Sandlin, the Helen Hunt Jackson teacher assigned to Idyllwild, are targeted in this lay-off procedure.

Except for Dawn Sonnier, who is a teacher and married to one, too, and Jessica Priefer, also an educator's spouse, and my astute colleague, James Larkin, I have not heard discussion on this situation. Education, jobs and income are inextricably related.

How can we congregate at the fire station, populated mostly with off the Hill employees, demand that the softball umpire be retained, but express no opposition to the decimation of our local school's faculty and the concomitant erosion of our children's future earning potential?

Is it really because Michelle lives off the Hill? Right now, more people seemed worried about who will order softballs than who will be able to keep the score correctly.

We need to focus the district administration's attention on Idyllwild's concerns and desires for our children.

Think Adler and Ingbretson are just teachers who come out of molds? Then look at the photo on page 18. The Parent Teacher Association of the 23rd District, which encompasses Hemet and San Jacinto, thought Ingbretsen was the best. Why don't the rest of us? Why aren't we telling Bill Sanborn, help us keep Michelle, Kirsten and Colleen and help us keep the faculty size stable?

I also suggest you turn to page 19 in last week's paper and discover Michelle plays softball, too. Isn't that enough to defend her?

On a sadder and more personal note, my son, Jamie, and I don't share the same value of the relative priority of education versus recreation in his daily life. Unfortunately, he will no longer have to worry about the state of HUSD.




#### Hello Idyllwild!





Proposition 13 (Limits on Property Tax Assessment. Seismic Retrofitting of Existing Buildings. Legislative Constitutional Amendment) is likely to pass because it faces no public opposition. It proposes to amend the state constitution to prohibit tax assessors from re-evaluating new construction performed on existing buildings, including those made of unreinforced masonry, when the purpose is seismic retrofit. The California Constitution excludes from classification as "newly constructed" re-constructing or improving a building to comply with any local ordinances that relate to earthquake safety.

Re-evaluation after new construction that adds space, converts a building to a new use, or renovates the building, typically leads to higher assessed value and consequently higher property taxes. The proposed change eliminates an existing 15-year cap on property tax reevaluation for buildings made of unreinforced masonry and sets a statewide standard for types of buildings and seis-



The underlying purpose of primary sponsor State Senator Roy Ashburn's legislation is to encourage wider seismic retrofitting by extending exemptions to

mic retrofit improvements more types of structures and making costs of retrofitting more affordable in the long run.

Advocates note passage of Proposition 13 would remove a dangerous disincentive for property owners to upgrade unreinforced masonry structures in order to improve earthquake safety the 15-year cap. Unreinforced masonry structures are those most likely See Proposition 13, next page

# IFPD and volunteers discuss past training

The Idyllwild Fire Protection District (IFPD) commission held a special meeting Friday, April 23. The session was an opportunity to address several issues deferred during the April 13 regular meeting.

The principal subject is the evolving turmoil over the capability of the paid call (volunteer) officers to function at their rank in case of incidents outside the district. The commission also discussed the adequacy of the crews' turnouts (fire protection outer clothing such as pants, jackets and boots) and the establishment of routine reviews of equipment.

The clothing's purpose is to protect firefighters from the heat and flames while fighting a blaze. A complete set of gear costs about \$1,500 per firefighter, according to Acting Capt. Mike Yount. The commission approved the purchase of two full sets for firefighters Mark LaMont and Logan Bates and new pants for Capt. James Reyes.

Yount, however, told the board that several other departmental members need gear repaired or replaced and estimated that \$20,000 would be needed

"It depends on the immediate need," Yount told the board. "A lot of the stuff can be repaired." Commissioner and Vice President Pete Capparelli concurred that the board wanted all firefighters to be safe and perhaps each member should have his turnout gear inspected. Interim Chief Mike Mulhall said that Cal OSHA regulations require an approved inspector conduct the equipment review.

Mulhall showed the commission a list of classes the State Fire Marshal's training requires for eligibility

to become a fire officer in California. President Jeannine Charles-Stigall made it clear that the commission, with only three members present,

would not make any decisions at the meeting regarding the role of volunteers or how much training was sufficient. Their objective was to learn more about the issue of adequate training and to be aware of the various views about the subject.

Mulhall highlighted a list of 10 classes that a California fire officer should have completed for eligibility for a fire officer position, including a captain of a paid call department or crew.

"California is currently revamping the classes and adding some more," Mulhall said. "Before being hired or promoted, a firefighter needs fire officer training. For example, one captain and myself have the training for the chief officer position."

The commission asked questions about previous training given to volunteers and whether documentation of these classes was available in the crew's personnel files.

In its absence, Commissioner Paul Riggi and Charles-Stigall inquired about the ability to recreate and verify past training. Riggi said he is aware of many cases where the State Fire Marshal's office will recognize past training as sufficient for current requirements if the fire department has some documentation of the content and participants. The commission explored this approach as well as several other means to confirm an individual's qualifications without requiring that person to start over.

Former San Jacinto Ranger District Fire Chief Norm Walker supported this approach. He explained to the commission that he had personally taken

nearly 70 training classes in 25 years.

"There are different names and titles, but I had to look for equivalencies in content," he said. "This is a classic struggle to do the research to demonstrate the equivalency of content and get the State Fire Marshal to accept it. It's universal."

Riggi concurred that the department needs to review what training the volunteers have received and taken and get recognition for that effort.

The subject of a retroactive pay raise for Capt. Alan Lott was also on the agenda, but he did not attend the meeting. In his absence, Stigall said his request would be withdrawn and may or may not be brought forward again in the future.

At last week's board meeting, Supervisor John Tavaglione suggested the county simply not pay the requested increase.

"The state refuses to do what other local government agencies had to do — slim down," Stone emphasized. "I would look forward to a decrease in administrative fees not an increase. Certainly a floor, no more than last year."

however, have indicated that they either: (1) do not track the number of years that unreinforced masonry upgrades have received an exclusion or (2) classify these upgrades as maintenance or repair [in which case they would not trigger reassessment]. In addition, many properties sell before the 15-year period is up [thereby triggering a reassessment of the entire property]. For these reasons, the loss to local property taxes as a result is probably minor."

Editorial boards of the Contra Costa Times, San Luis Obispo Tribune, San Francisco Chronicle and the Los Angeles

Times support the measure, as does the California Democratic Party. The Los Angeles Times board calls the ballot proposition "as close as a California ballot measure comes to being a no-brainer."

No one submitted arguments to the state's official Voter Guide opposing the measure. In the final votes the California Legislature cast on SCA 4 (Proposition 13) prior to its being put on the ballot, both the Senate and Assembly voted unanimously to approve the changes.

In March, the IWD operating water budget had a \$36,000 deficit. Since July 1, expenses have exceeded revenues by nearly \$133,000. However nonoperating rev-

The projected loss through nine months was \$57,900, almost five times the actual deficit.

less than projections. For the year, water sales have slighted exceeded the budget projections, according to Auditor/Controller Jim Ludy. March water production of 5.3 million gallons was 270,000 gallons more

than February, but nearly 475,000 gallons less than March 2009. Since January, water production is nearly 18 percent less than the first three months of 2009.

Pine Cove and Fern Valley are also experiencing water demand declines. IWD's conservation program must be making some contribu-

tion, according to President Allan Morphett. Since July, IWD has given almost \$10,000 for 27 installed water-efficient clothes washers and \$4,900 for the installation of 50 low-flush, waterefficient toilets.

While demand is declining, the district is still working to strengthen its water sources. Two test wells were drilled in March.

The tentative results and estimates of production levels for both wells disappointed General Manager Terry Lyons. The projected production level for the first well was less than 5 gallons per minute (gpm). Lyons was prepared to abandon the site after cleaning it

requested the well for irrigational uses. "I said he could have it," Lyons told the board. The second well, drilled

200 feet deeper (a total of 800 feet), also disappointed Lyons. Its projected produc-

tion rate (with pumping) was only 15 gpm. While below his goal for a good production well, Lyons decided to cap it and keep it in reserve for emergencies.

# Art as a cultural and economic bridge

On Monday evening, April 26, an enthusiastic group convened at the Creekstone Inn to hear about participatory art. Local artist Judith Schonebaum brought to the Hill Katherine Bonalos and Ming Ng, coordinators of the Active Arts events at the Los Angeles Music Center.

The two spoke about the democratization of participatory art and how it can create a bond between people with different cultural and economic backgrounds. "It's using the performing arts to connect the surrounding and disparate communities," said Ng. "That's what this is about - bringing people together and being around a wide diversity of people to enjoy participatory performing art." Even the term "participatory art" carries a democratic ring, said Schonebaum who hopes to import some of the Active Arts concepts to the Idyllwild Community Center (ICC) site to augment Idyllwild's annual summer concert series. Four Idyllwild Community Recreation Council (ICRC) directors attended to hear the presentation.

At the open-air plazas at the Music Center, Active Arts offers free or low cost group participation events in dance, sing alongs, story telling and group instrumentals. Supported by grants and

donations, Active Arts links non-professionals who love to dance, sing, tell stories or play instruments, and are mentored and lead by paid facilitators. Proficiency is not a requirement for participation, noted Ng, just enthusiasm. "Active Arts has taken the judgment out of public performing," she smiled. Los Angeles County and the Music Center fund the space, the electricity and the insurance. Private non-profits operate the programs which include Friday night singalongs, holiday sing-alongs, 20-minute dance lessons in a variety of disciplines at \$1 per class, and a free 45 minute Bollywood Blast. Schonebaum arranged for Ng and Bonalos to make the presentation in Idyllwild. Schonebaum believes the ICC site would be the ideal venue for an event of this nature. In response to a question about how to keep the program running year-round, ICC Chair Chris Singer and Recreation Director Bob Lewis said they would explore ways to subsidize the program at Town Hall.

Attendee Bronwyn Jones immediately understood the concept of bridging economic and cultural divides as the central theme. "I teach ESL [English as a second language] classes and I'd like to involve our Hispanic community in these events," she said. "I'd love to learn and enjoy dances from Central and South America."

For two reasons, the Music Center's location in Los Angeles is key to Active Arts success. First, the professional performing venues provide a funding base. "Our bread and butter is really selling tickets," said Ng. Secondly, patrons



### Scott Carlson benefit May 8

Idyllwild Fire Department fire fighter Scott Carlson has spent 15 years bravely battling blazes and rescuing people in peril. Now he faces a great personal challenge of recovery from cancer. As a firefighter, Carlson understood the need to sacrifice in order to rescue and save. About six weeks ago in the desert, Carlson had to give up a lung for life and he's not ashamed to admit, "I'm scared to death."

Carlson spent six weeks at Eisenhower Medical Center after his surgery, being released and readmitted twice before he finally came home on his 36th birthday on Friday, April 23. "You have no idea how glad I was to get out," Carlson said. The first thing he did was eat a cheeseburger. "It tasted really, really good," he said with a chuckle.

Carlson, who lives in Hemet, visited his friends and colleagues at the Idyllwild Fire Station on Sunday and had his vitals checked out. He was fine with the altitude and his blood oxygen level was 98 percent that day, according to him. Every day, Carlson says, he still deals with pain excited to see everyone, share

recovery, "I probably over did it," he admitted.

Out of the hospital, Carlson's immediate priority is to interview oncologists and select one to be the primary physician to guide his recov-ery process. The hospital's doctors expect he will need chemotherapy, meanwhile they just prescribed rest, he said. But that's not easy advice. "I'm used to being a really active guy," Carlson said.

The support shown by family and friends has meant a lot to Carlson. He gave special credit to his girlfriend, Amanda Anderson. "She spent weeks at the hospital, all her time when she wasn't at work, by my side," he said. "It really made a difference." Anderson works at the BBVA Compass bank and Carlson said cards to him can be delivered to her.

This year, the Idyllwild Firefighters Association's Spaghetti Dinner is a benefit for Carlson. He is hoping to make it and said, "If I can, I'll see everybody there." The Dinner will be from 5 to 7:30 p.m. Saturday, May 8 at Idyllwild Pines Camp.





#### Lake Hemet

Darlene Redner at Lake Hemet had this report on fishing:

Tuesday, April 20, was a bountiful day for anglers at the lake. Tom Miller of Pine Cove took home his limit using spinners near the spillway. Tom Duncan of Pine Cove, also caught his limit of trout. He was using needlefish by the dam.

The bounty continued through the weekend with Kenneth Coggin of Torrance taking home his limit, Joseph Leewood of Yucca Valley bringing in three trout with roostertails, and Anthony Asebedo of Hemet taking

home four trout.

Sunday, April 25, was a little slower than Satuday. **Peter** Hernandez of Palm Desert reeled in a limit with spinner bait. And, Mark Agregado of Palm Springs brought in a variety of trout, bluegill and carp using worms from the shore.

Water level at the dam is 126.5 feet. Last year's level was 125.4 feet.

#### **Diamond Valley**

Jesse Dinkins at Diamond Valley (DV) Reservoir had this report on fishing:

Bedding bass have been biting in the coves and along the dams between 5 and 15 feet. Gary Baker of San Marcos caught a 7.5-pound bass fishing the north shore with a green pumpkin Senko. Steven Frazier had his best topwater day ever, catching over 20 bass back to back in the early morning.

Trout fishing has been fair for boaters and shore anglers. Nightcrawlers, Powerbait, Powerworms and mini Jigs have been the best baits. Most

trout catches have been on the east dam or the coves west of the marina.

Anglers reported a few small striper catches this week on swimbaits. The most reported spots have been Rawson Cove, near the rock quarry, and by restroom 2. Louie Vega of Hemet caught three striper at 22, 19, and 18 pounds fishing from shore with a Zplug.

The cats have made a comeback! Several anglers reported catches over 5 pounds.

The panfish reports were

fair this week with crappie being the predominant species for panfish anglers. The bite will improve as the water gets warmer. Rawson Cove and the saddle dam were the most reported spots. Mini jigs, and live worms are the most common panfish baits. Andrew Anchondo of Stanton reported a 1.11-pound crappie fishing with jigs near restroom 1.
