Historic District at county

n Wednesday, May 5, several county officials presented a workshop to the Riverside County Planning Commission. Deputy Planning Director Jerry Jolliffe led commissioner, on a tour of a possible Idyllwild's Historic Preservation District.

Jolliffe believes a stumbling block in creating a historic district is the current "cumbersome" existing historic district ordinance 578. "The ordinance needs to be streamlined," said Jolliffe. "We need a more streamlined process, considering county financial issues now and in the future."

As part of creating the district, Jolliffe noted the need to create an "overlay" district that specifically deals

with parking and landscaping issues. "Parking spaces with somewhat different dimensions [than are required in other parts of the county] are needed to preserve Idyllwild's unique ambiance," said Jolliffe, "as well creating a community parking lot with restrooms that are ADA [Americans with Disabilities Act] compliant."

Jolliffe noted that creation of a historic district for Idyllwild, what he called the "jewel of Riverside County," would bring a new cachet to Idyllwild as a heritage tourist destination. "The primary goal of a historic district would be to allow the Idyllwild business community to be vibrant, create economic savings to local businesses, and still meet state health and safety codes." winter of near-average rainfall has not been nenough to eliminate drought concerns, but it is more than adequate to raise fire concerns.

"It will be a long and dangerous fire season in Riverside County," said County Fire Chief John Hawkins. The grass crop is already drying." Leaving the Hill and going west on Highway 74, one can see the dark green hillsides west of the North

Fork of the San Jacinto River are already brown.

For Southern California, the early fire season forecast is "... expected weather conditions along with the antecedent fuel conditions suggest a normal fire season



Obituary Marilyn Moneysmith

A celebration of a long life, well lived! A light has been extinguished in Idyllwild. Marilyn Jean (Johnson) Moneysmith has passed from this world, leaving a legacy of kindness, generosity and intelligent creativity behind for those who loved her to remem-

Born June 9, 1925, in Chicago, she married A.D. "Slim" Moneysmith on January 15, 1944 in Oklahoma City. Marilyn and Slim met when he visited the USO where she served fresh donuts to military men during WWII. Slim was a handsome Marine and the two quickly fell in love.

Following the war, Marilyn and Slim made their home in San Diego for more than 40 years. In 1988, they moved to Idyllwild where Marilyn was a founding member of the Idyllwild Quilt Guild. Over the 22 years Marilyn lived here, she won many awards for her wonderful quilts and mentored new quilters in the craft. Her sewing room was always open to those needing a lesson or two.

Marilyn was also a member of the American Legion Post 800 Auxiliary and could often be found at the Post on Friday nights enjoying dinner with friends. She also joined Soroptimists until her health forced her to cut back on her volunteer activities.

Marilyn died of cancer on May 1, 2010. She was preceded in death by her parents; a sister; and her husband, Slim. She is survived by her daughter, Carol Mendoza; two grandsons, Robert D. 



California's "Global Warming Solutions Act" (AB 32) is bipartisan-supported legislation that passed in 2006 to create clean-energy jobs and cut down on air pollution created in the state. It makes California a real leader in the world in demanding real reductions of greenhouse gasses and has already attracted millions

of investment [dollars] in clean energy programs and thousands of new jobs to the state.

Valero, a Texas corporation and a top polluter in the United States, has committed more than \$500,000 to foster an "Astroturf" (fake grass-roots) initiative to effectively overturn AB 32. This company had to pay \$711 million in a settlement with the EPA [U.S.

Proposition 14 changes party primaries

Proposition 14, "The Top Two Open Primary Act," proposes to amend the California Constitution to create a non-partisan run-off primary for state and congressional races in which the two candidates receiving the highest vote totals, regardless of party affiliation, compete in the general election. Rather than the tradition of a Republican facing a Democrat, the run-off primary could result in a general election squaring off two candidates from the same

California currently has a closed primary in which people may vote in a party's primary only if they are registered members of that party. Independents or more properly, non-affiliated, cannot participate in closed primaries.

An analysis by the nonpartisan Center for Governmental Studies found that more than one third of general election races could end up being fought between two members of the same party. Most of these contests would be between two Democrats, largely in Los Angeles County and the Bay Area. Just two races analyzed would have resulted in contests between two Republicans. The report also found that campaigns would be "significantly more expensive." The necessity for candidates to campaign in a primary with a broader base of voters, not just those in their own party, will increase campaign costs which could enhance the chances of big

money candidates.

As opposed to traditional "open" primaries that allow a voter of one party to pick a party primary in which to vote either prior to or on election day, a "run-off," "top two" or "Louisiana" primary (also in effect in Washington) allows voters to choose to vote for anyone on the ballot with no required prior selection of a particular party primary.

Advocates say it would lead to a more democratic (small "d") result, give California's nearly three and a half million independents a voice in primary elections, and allow voters registered in any party to cast their votes for any candidate regardless of party affiliation. Opponents fear one-party and/or incumbent domina-

When Washington state first used "top two" in 2008, out of 123 state legislative races, eight Congressional races and eight statewide races, only a single incumbent was defeated in the primary. Proponents argue that "Top Two" will increase chances for third parties and independents, but Ballot Access News reported that in 2008, for the first time since it achieved statehood in 1889, Washington had no minor party or independent candidates in November for any statewide or congressional race. California voters defeated a previous version of this proposition (62 in 2004) by 54 to 46 percent.

Under the measure, voters may disclose their party preference when registering; but refusal to state a preference would not deny them the right to vote

Disclosure of party preference does not carry any implied or actual endorsement by party. Alternatively, a political party has no right to have its preferred or endorsed candidate on the ballot if that candidate is not among the top two vote getters. Presidential primaries would be unaffected by passage of this proposition, leaving each political party the right to close its primary.



Jolliffe outlined the first steps to be taken if the district is approved by property owners within district boundaries and the Board of Supervisors: a local board will need to be appointed and design guidelines and standards developed. County Preservation Officer Keith Herron said that design guidelines are always tailored to the buildings in the district with the objective of maintaining the character of the business core or neighborhood. He noted that historic districts generally stabilize and increase property values.

The Planning Commissioners reacted positively to the proposal. Third District Commissioner John Petty urged Jolliffe and group to consider expanding district boundaries at this time if that made sense. Both Herron and Iolliffe said that expansion, other than for a few buildings already surveyed such as Town Hall and Silver Pines

to determine the extent of historic resources in any other area.

The county staff has a preliminary draft of a new district ordinance and is awaiting county counsel approval before presenting it to the Idyllwild community for discussion. Jolliffe says presentation of the draft will occur probably in late June or early July. "Most people want to see the benefits of the district that would be made clearer by a second draft ordinance," said Herron.

Jolliffe told the Commission the idea for the historic district came from Third District Supervisor Ieff Stone's concern over Idyllwild's difficulty in meeting mandated county code requirements given the age of most of Idyllwild's buildings. Stone noted that there were legal issues that the county faced if Idyllwild was not brought to code and that a historic district carved out certain flexibilities for property owners to meet those requirements.


IDYLLWILD WATER DISTRICT MAY 2010 NEWSLETTER

Since the mid 1980's, customer service charges, water meter costs, and associated water and sewer capacity fees for new services have not changed significantly and the District has worked within its existing budgets. The District's last water and sewer rate increase of 10% occurred in 2005. Since that time, the District has implemented new programs to improve the overall efficiency of our operation, allowing the District to moderate staff time and mitigate expenditures. Some of them are as follows:

- •The Foster Lake Solar system, which operates our wells and water treatment plants, was a major improvement. This solargenerated system allows us to generate our own power and also allows us to operate with SCE or independently.
- Another District efficiency program was to overhaul three existing wells each year, improving the efficiency and controlling our production costs. Fifteen of our 23 wells and three of our booster pumps have been upgraded.
- •IWD began installing new "capacitor devices" to improve pump efficiency. At present a well, a water treatment plant and our wastewater treatment plant have been retrofitted. Installing these devices has saved us 10% to 15% by reducing power consumption and lowering our SCE bills.
- IWD's toilet and washing machine rebate program has reduced our sales revenue and decreased our cash inflow.

At right is an 11-year graph showing the District's operating revenues verses operating expenses. Since FY 2008/2009, our operating expenses have exceeded our operating revenues. We are proposing a 6% water and sewer rate increase which will be discussed at a Public Hearing at 7:00 p.m. on June 15th. More detailed information can be seen on our Web site @ idyllwildwater.com.

Teachers are powerful

EDITOR:

I would like to comment on last week's letters from Kari Arnson and Matthew

Teacher tenure is not a union rule. Tenure has its roots in the concept of academic freedom — freedom to teach things that may be controversial and in ways that are innovative and possibly unconventional.

Academic freedom is necessary not only for an effective educational system but also for a democracy in which education is valued over indoctrination and where diversity in teaching methods is embraced just as diversity is embraced in other areas. Teachers are given a few years to prove they know their craft, and then they are told to practice it as they see fit, not as some bureaucrat or administrator (with his/her own personal ambitions and agendas) sees fit.

That's the theory, but administrators often pervert it — in part by tending to hire teachers who are sheep. Docile employees make an administrator's job less complex and his/her career goals easier to attain.

Is performance-based pay a cure for our educational ills? A fast-food restaurant doesn't pay minimum wage because doing so attracts top talent. It pays minimum wage because doing so attracts adequate talent. Can we

be sure schools would pay extra for top talent? In the next budgetary crisis, the top talent (highest paid) might well be the ones fired while the "just adequate" are kept on. Impossible, you say? McDonalds (with X billion served) will tell you it's quite possible, and it works just fine — if you like burgers.

It is not CTA's [California Teachers Association] job to promote the interests of students. CTA's job is to promote the interests of teachers. And considering that 37 percent of teachers are over 50, it's not surprising that CTA (made up entirely of teachers) looks out carefully for the interests of older teachers. That's not so much selfishness as it is simply the nature of a democracy.

If there are areas where CTA needs improvement, teachers should change it from within rather than imagining that yet another bit of government legislation (SB 955) will be a panacea. If you are a teacher, you ARE the CTA. Don't like something? Get active. Make your voice heard. Ruffle some feathers. When the next CTA election comes around, do more than just vote.

Don't bemoan the immense power of CTA. Embrace that power and use it from within to bring about positive change in educa-

"Bigger & better" recreation?

When the editor in his column last week patently forwarded the county's assertion that they can deliver recreation "bigger and better" to Idyllwild with no supporting financial documentation, I think the community deserves to

be accomplished given the restrictions of a finite base of available funds.

At the April 15 CSA [County Service Area 36] regular meeting Bill Brown, County Service Area administrator, stated that if the county steps in to manage the recreation contract all Town Hall employees would then be Riverside County employees. He went on to say that they would receive the full menu of benefits that government employees enjoy including, among others, eligibility for health insurance and retirement benefits. Although he also listed a slate of undeniably terrific recreation programs, no hard figures for their implementation were provided.

At the April 19 CSA 36 special meeting, CSA board member Mike Freitas offered the perspective that benefits can often be the equivalent of up to 60 percent of a county employee's wages. I understood the formula as in the following example: If an employee earns \$50,000 annually, his or her cost to the employer for taxes and benefits would equal approximately \$30,000. The total wage and benefit burden to the employer would then equal \$80,000 annually for that employee.

As it stands now, the 10 or so Town Hall employees by and large unfortunately receive few or none of the benefits promised to county employees. Mr. Brown has said that there will be no increase in available funds to manage Town Hall RecIdyllwild riders in Spring Challenge



Famous filmmaker's belongings saved

On Tuesday, May 4, Idyllwild local Diane Christopher and friend Cathy Genitempo stopped at a garage sale on Country Club Drive. They were shocked at what they discovered in the garage. In a knee-high heap of apparent trash, were film canisters containing original film footage shot by awardwinning cinematographer and documentary filmmaker Baird Bryant, an Idyllwild resident who died Nov. 13, 2008. Other items, such as original scripts and book notes written in Bryant's hand, were also trashed. Christopher and Genitempo recognized the potential value and historical importance of the items.

Bryant won prestigious awards, including a shared Oscar for "Broken Rainbow,"

a 1985 documentary about the Hopi and Navajo and an Emmy for "A First Class Miracle." Yet, Bryant was best known for his work on two controversial films - the 1969 cult film "Easy Rider" and the 1970 Rolling Stones' documentary "Gimme Shelter."

Christopher was alarmed to hear the two men hosting the sale say they had to clear the property and would take everything remaining to the dump that evening. Christopher said she and Genitempo sorted through the debris and collected many items of historical interest, but that there was more of potential value she feared would be lost. Among the items she saved was a letter written by the Dalai Lama to Bryant and 16 mm film footage of "Easy Rider" shot by Bryant.

When questioned by this

Town Crier cyber attack

crowds gathered on the corners to stare in awe. But the cyber-community of Idyllwild was in a major panic over the weekend as a mysterious intruder hoisted bright red flags all over the Town Crier's Web site.

Reports began to come in on Sunday that the Town Crier's site was inexplicably redirecting users to a seriously infected area of cyberland in which they were invited to download a bogus application.

Warning bells and sirens went off in PCs all over the Hill, and maybe beyond. E-mails outlining the problem, complete with photos of all the warning messages, began coming in to Town Crier Editor J.P. Crumrine and Chief Operations Officer Jim Crandall.

Crandall immediately called tech support at GoDaddy, the Web site host for the Town Crier, and explained the

There were no sirens. There were no helicopters. No problem to the techies. They assured us that our site was clean. But the e-mails kept coming in.

> On Monday morning, the Town Crier took the site off-line. Crandall called local techies Joey Latimer and Francoise Frigola, both of whom offered immediate and very helpful advise.

> Frigola continued to research the potential problem and reported on Monday afternoon that there was an attack on many newspapers across the country. She sent info on how to "clean" our site of the threat (see page 22), and Crandall performed the operation.

> Frigola's fix appeared to work, and the site went back online at 5 p.m. Monday.

> However, a warning has been posted on the home page urging people to use extreme caution if they see See Virus, page 22

reporter about the need to clear the property, Stephan Whitcomb and Pat Ladd, who were running the sale, said they were "contractors for the bank and have to clear everything out or we don't get paid." When asked what they were going to do with the remaining items since the dump was closed, Ladd answered, "Well then, I'll torch it all."

A call was placed to Wachovia Bank representative Jim Tyler in San Diego to inquire if the deadline could be extended so that members of the Idyllwild Area Historical Society could clear the remaining items out of the garage. Loni Vogler of Keller Williams Realty in Hemet returned the call and said Whitcomb was not employed by Wachovia but was on a deadline to clear the property in exchange for a "cash for keys" settlement, an arrangement in which the occupant of a foreclosed property is given

a cash incentive to vacate. Vogler said Whitcomb and others were living there with permission of the Bryant family and that the bank could not give an extension on the deadline.

On Saturday, May 8, Christopher contacted Pablo Bryant, Baird's son who lives in Los Angeles. Pablo immediately came to Idyllwild. He said he never gave permission for anyone to live on the property. He recounted that a month ago he came

to Idyllwild to clear belongings out of the house and found Whitcomb parked in the driveway, repairing his van. "I told him it was OK to be there, but I thought he was going to fix his van and leave."

Pablo said he contacted the sheriff on Saturday, but was told that the inhabitants had squatters' rights. "It was very disturbing," Pablo

breakage in the San Bernardino and San Jacinto ranges. In the south, curing of the herbaceous fuels is progressing rapidly, with initial attack fires already occurring."

A 48-acre fire started Thursday above Snow Creek near the San Jacinto Wilderness area. Forest Service San Jacinto Ranger District Fire Chief Dan Felix said crews had to hike into the area, spend Thursday night and battle to contain the fire through Saturday.

"It will be contained this evening [Saturday afternoon]," said incident Commander Chris Fogle, a battalion chief on the San Jacinto to highlight the importance Ranger District.

Earlier in the week, Felix had warned about grasses at lower elevations already curing and the denser crop of grass this year. He was somewhat surprised about a fire this soon at that elevation. Its cause is still under investigation.

The Forest Service expects its contract helicopter for the San Jacinto District to be available the first week of June. Six of seven district fire stations will be staffed seven days a week and the seventh will be on a five-day rotation which may be changed to seven, according to Felix.

Governor Arnold Schwarzenegger declared May 2 to 8 Wildfire Awareness Week. CalFire also used the week



Summer work for Idyllwild youth

By Marshall Smith STAFF REPORTER

Applications are online at www.rivcoyouth.com for the federally funded Summer Work Experience Program (SWEP). According to Bill Brown, County Service Area operations manager, the program will provide 20 Idyllwild youth ages 14 to 24 the opportunity to work for Idyllwild employers and earn \$8 an hour with no taxes taken out.

Participants will receive meaningful paid work experience during the summer months. They can work a minimum of 120 hours and a maximum of 240 hours with public, nonprofit and for-profit businesses in the community. In addition, they will receive work readiness skills training.

To date, 17 Idyllwild employers have applied to host a SWEP applicant. Additional employers can download application at the same site as youth applicants.

Youth employment applicants should go to the Web site, access "swep," then click on "applicant." After reading the program information, marshall@towncrier.com.

clicking on "application" will download both the application and eligibility guide-

As a service for youth who do not have access to a computer, program eligibility information and applications will be available at the Town Crier office.

Completed applications may be dropped off at or sent to Hemet Youth Opportunity Center, 930 State Street, Hemet 92543. The center's phone number is (951) 765-0917.

The SWEP program is aimed at youth from lower income homes. Economic eligibility guidelines apply and are available online. Local youth who meet guidelines will be interviewed for placement. According to Brown, interviewers will come to Idyllwild for a day of interviews once the applicant pool is determined. Once a full complement of Idyllwild applicants is finalized, funds will be available to hire a local supervisor at \$16 an hour. The program runs May through October.







The fix, if infected

If you have a Windows-based computer and visited the Town Crier Web site May 9 or 10, before it was shut down, and do not have a firewall to protect your computer, below are simple steps to restore your computer. (Note that an anti-virus will not protect your computer from such attacks.)

If you have an Apple computer, so far, it does not seem that your computer has been affected.

Windows ME, XP, Vista, and I believe 2000

- · Save your files
- Close all your programs
- · Click on Start/icon at the bottom left of your
- · Click on "All Programs"
- · Click on "Accessories"
- Click on "System Tools" Click on "System Restore"
- The "Welcome to System restore" window opens and should have a dot next to "Restore my computer to an earlier time"
 - · Click "Next"
- · On the left, in the calendar, look for a bold number May 8 or earlier (if there are none in May, click on the back arrow on the left of the month of May, to display the month of April)
 - · Click on that number
 - Click Next
- · Click Next again and do not touch the computer until it finished rebooting and coming back
- · If you have installed or updated any software do so again.

Windows 7

- · Click on the Windows icon on the bottom left of your computer
- In the right column, RIGHT-click on "Computer" and go down to "Properties"
 - Click on the "System Restore"
 - · The "System Restore" Window opens
 - · Click "Next"
- In the "Date and Time" column, look for Saturday May 8 or earlier
 - Click to highlight it
- · To make sure you will not lose any important drivers or updates, click on "Scan for affected programs"
 - · Click "Close"
 - · Click "Next"
- · Click "Finish" and do not touch the computer until it finishes rebooting and coming back
- · If a message tells you that the computer could not be restored, restart in Safe Mode, and restore back again (It is beyond the scope of this article to explain Safe Mode: look at your user's manual)
- · If you have installed or updated any software do so again.

For all versions of Windows, if a message tells you that the computer could not be restored, restart in Safe Mode, and restore back again.

Next step: install a Firewall as soon as possible and keep it up-to-date!


