## **Monument** will be moved

ark your calendars. The David Roy tree monument, "Harmony," will move to a new home on Village Center Drive next month. "Nov. 8 is our soft target date," said Idyllwild Chamber of Commerce Secretary Julie Johnson.

The announcement at the Chamber's Monday, Oct. 18 meeting capped a period of negotiation that ended in amicable resolution of an issue that has long bedeviled the community — a carving contract between Roy and the Chamber that will have taken three years to fulfill, rather than the three months outlined in the contract.

The details of who would finance the move, who would be responsible for continuing maintenance costs and whether Roy would receive any further payment were not announced or explained at the meeting. ast week, two local couples became crime victims when their debit cards were fraudu-Ilently used at several department stores in San Diego. Neither couple had given their debit card to anyone else to use or shared their pin number. Both couples suffered very similar circumstances and both have had to deal with financial hardship as a result of the crimes.

On Monday, Oct. 11, Idyllwild residents Shane and Wendy Fender received a call from Chase Manhattan Bank's fraud department. They were told of \$1,700 in department store charges made in quick succession and charged to their account.

Although the Fenders hadn't made the charges, they were only able to have the most recent charge of \$500 reversed. To correct the earlier two, the Fenders had to wait for the

## Vigil for hospital staff

idnight, Wednesday, Oct. 13, Physicians for Healthy Hospitals (PHH) finally closed its deal to purchase Valley Health Systems (the local public hospital district). The physicians' first action was to let several dozen employees go. So far a total of 14 registered nurses and more than 40 other employees were asked to leave.

Today marks the beginning of a new era in quality healthcare for our communities and area residents," said PHH spokesman Dr. Alex Denes, in a press release. "We will honor voters' confidence in PHH by rebuilding our hospitals into centers of medical excellence, with an emphasis on quality patient care."

Thursday night, a vigil for the dismissed staff was held outside the Hemet hospital. Cars, vans and trucks blared their horns in support of the former hospital staff, making normal conversation

## Deputies arrest Pine Cove woman

On Wednesday, Oct. 13, Riverside County Sheriff's Department deputies arrested Pine Cove resident Teri Danette Blackburn, 50, for suspected felony financial abuse of an elder and felony making false statements with the intent to defraud.

Deputies, under direction of Special Investigations Supervisor Sgt. Steven Mike,

served a search warrant on the residence. Deputies removed boxes of files from Blackburn's residence. The arrest was the result of a departmental investigation that began in August. Executors of a deceased Winchester woman's estate alerted Hemet Station investigators about numerous charges paid from the estate to a former caregiver. The charges began in August 2009 and continued through July 2010.

According to Mike, Blackburn had served as caregiver for the deceased woman from October 2008 until November 2009 when she resigned. According to bank records, the charges totaled over \$36,000 during the year. The Winchester woman died in March 2010. The investigation also revealed that Blackburn opened two separate life insurance policies in the victim's name, deducting the premiums See Arrest, page 26

# Vandals deface Idyllwild School

Idyllwild School Principal Matt Kraemer confirmed that vandals defaced the middle school sometime between the close of school Tuesday, Oct. 12 and Wednesday morning, Oct. 13. Vandals glued doors and sprayed an insulation substance into exterior middle school locks causing about \$900 in damage, Kraemer said. Vandals also wrote some graphic language directed at Kraemer and de-

faced bathroom signage.

The vandals wrote the names of two students previously involved in school incidents, apparently seeking to incriminate them. "We do not suspect current students. ... I do not feel this was a hate crime," said Kraemer, referencing a March 1, 2010 hate crime attack on the school committed by two enrolled students. Kraemer filed a police report on this latest incident.

## Outside Idyllwild

#### Long underwear time

Though winter is still eight weeks away, you can feel it coming to the mountains. On the mountain, winter comes when it comes regardless of the date.

Last week, it felt like 80 degrees on Monday, but now my knees are a little cold in my shorts. Like some of my customers, I will continue to wear shorts as long as possible or until the first snowfall.

When that chilly feeling finally overcomes me, I know it is time to put on the long underwear or baselayer, as it's called in the outdoor industry.

Since I have talked about it before, many of you are familiar with the concept of layering. Anyone who does a lot of outdoor activities knows that everything starts with your next-to-the-skin layer.

When you are selecting a baselayer, look for these three attributes: warmth, moisture control (called wicking) and odor control. Of course, comfort and, to some degree, style come into play. Some baselayers look like underwear and some are nice enough to wear as outerwear, like Icebreaker brand tops.

The warmth factor is usually just a matter of the material's thickness. But it can also be a factor of the material itself. Take Patagonia's Capilene, for example. They make four different weights — silkweight, lightweight, midweight and expedition weight. These names have been replaced by a letter grade of C1 through C4.

The C1 and C2 are the summer weights and can be used in late spring and early fall. The C3 or midweight is the fall and winter standard. The C4 is for very cold environments. Most outdoor companies have equivalent weights available in their baselayer lines.

Another warmth factor is the material itself. For example, Merino wool is very warm for its weight. As an added bonus, it is very comfortable next to your skin. Capilene is made from polyester but it can be blended with other materials such as cotton and even wool. Personally, I think nothing feels as good as Merino wool, but Capilene and other blended fabrics work well also.

Moisture wicking is a major consideration when picking a baselayer. After all, you have other layers to keep you

from the inside perspiration. Any baselayer that is meant for outdoor use should be moisture wicking; otherwise, it will not be comfortable for hiking and climbing.

Finally, when you are out on multi-day excursions odor control can be a big factor in selecting your baselayer. Merino wool has natural anti-bacterial qualities that fight odor and can be worn for several days.

Polyester tends to build up strong odors very quickly.

warm and dry so it makes no sense for you to be wet For this reason, most manufacturers try to add an odor control system to their baselayers. One such system is to weave silver threads into the garment itself. I don't really know how the silver threads mitigate odors but I imagine they act as some sort of anti-bacterial agent.

> There are other forms of odor control but I don't really know the particulars about them. The bottom line is that if you are going to be wearing your baselayer 24/7, you have to take odor control into account.


## Obituary Ella Mae Welker King

64 years when Wayne passed in April 2004.



#### ATTENTION HOMEOWNERS AND UNLICENSED CONTRACTORS

"California Business and Professions (B&P) Code requires all home improvement jobs (grading, construction, remodeling, landscaping, etc.) valued at more than \$500 for labor and materials be done by an individual or company with a CSLB (Contractors State License Board) license, and that license number must be included in all advertisements for their contracting services. ... The number is required by law to be printed on all contractor business and advertising documents, such as the bid, contract, print ad, or business card." (This is not the same as a Riverside County Business Registration number, AKA: County Business License number.)

If you're caught contracting (verbally or in writing, by bid or hourly) without a license, you will likely have to go in front of a judge to answer to misdemeanor charges, which carry a potential sentence of up to six months in jail and/or a \$500 fine, and a potential administrative fine of \$200 to \$15,000. If you get caught again, the penalties get stiffer. You could face a mandatory 90-day jail sentence as well as a fine of 20 percent of the contract price of the work performed, or a \$4,500 fine."



#### INITIAL THOUGHTS

#### To do or not to do — inspections ...



Fire Prevention Week may be over, but the concern and precaution about possible wildland fires is present every day of the year for local residents. As Idyllwild Fire Chief Norm Walker advises in his "Chief's Corner" column on the next page, the fire inspection is only the first step. Homeowners

and residents must be vigilant throughout the year.

Potential fire dangers can occur at any time because of the availability of fuel here. Seasonally, as spring ends and summer begins, the moisture content of most plants declines. When fall arrives, dead, dying brush and fallen leaves are potential ignition targets.

If Santa Ana winds occur, a small fire that is normally containable can quickly spread out of control.

In 2003, during the October Fire Siege, the Cedar Fire in San Diego County burned more than 275,000 acres. It is still the largest fire in CAL FIRE's history. It traveled nearly 12 miles the first night.

When a fire is approaching, it's too late to take action. The prevention and protection work has to be done in advance, as Chief Walker implores.

However, community protection is a cooperative effort between residents, whose responsibilities are discussed in the Chief's Corner, and the local fire departments.

Obviously, the most important action a fire company can take is to protect your dwelling if a fire approaches or if it catches on fire. That's the origin of fire departments and remains a critically high priority function.

But fire departments also perform a critical role in fire prevention. Despite the admonitions, despite the columns and written words, inspections are necessary on the Hill. Nothing compares to a failed inspection to motivate a resident to rake some needles or leaves or to sweep a roof.

Unfortunately, IFPD has not inspected all the properties in its district. This year, Chief Walker says the budget was insufficient to use extra crews for the inspections. According to his report from last week's meeting, IFPD inspected 1,806 parcels. There are more than 3,000 parcels in the district.

Does your neighbor's yard look safe? Is their roof free of needles and debris?

Of the total inspections, more than two-thirds failed the first inspection — 1,355 failed inspection one. While the owners of more than 816 properties took the time and effort to improve, 539 still failed the second time. That's almost one-third of the parcels actually inspected. Can we extrapolate to all Idyllwild parcels and estimate that a thousand or more are dangerous?

Of those 539 homes, 80 percent of the owners finally agreed to protect themselves and their neighbors. But a reluctant or recalcitrant 42 failed the third inspection. According to Walker, seven are facing possible forced abatements.

Although IFPD has a contract with several local tree removal companies to help with abatement work, IFPD is still responsible for the inspections.

Negotiating abatement work and costs with a property owner is difficult if they can see a worse situation next door, according to several members of these compa-

Outside Idyllwild, Mountain Battalion Chief Dan Johnson, Riverside County Fire Department, informed the County Service Area 38 (Pine Cove) Advisory committee that his crews conducted more than 3,600 inspections this summer. That's from Pinyon Pines north of Pine

IFPD has been an inspection laggard for years. Its peak performance was in 2007, when the department performed more than 3,800 inspections. The number of inspections has declined every year since.

That's actually irrelevant. What is the necessary ingredient that will juice IFPD's inspection capability?


Perhaps we should pay tourists to come to Idyllwild; then the tourists can pay the BID tax for the pleasure of coming here. I fear that makes sense for some.

## Chief's Corner

#### Resident help needed; apply below ...

The month of October brings holidays, changing colors, hints of winter, firewood gathering and Santa Ana winds.

Most of us passed our residential fire inspections months ago and I thank everyone who continually works hard to make their

property firesafe. Almost every week, I make a trip to the transfer site, dump my trash and look at the pile of green waste. The bigger the pile, the more cleanup happening in our communities!

While this has been a relatively slow fire season, we should never become complacent. October is statistically the month when the most acreage and most homes burn in Southern California. Fuel moistures have been steadily declining all summer (as always) and all that is needed to turn peace and calm into a tragic wildland fire are Santa Ana winds and an ignition.

My intention with this article is to explain why it is so critical that we all remain vigilant with fire abatement all year long.

In the early stages of a fast-moving wildland fire, the engines assigned to structure protection employ what is known as "bump and run" tactics. As the flaming front of the fire arrives at structures, those structures that are accessible are actively protected. As the flaming front passes, those engine companies must then move to the next structures threatened and mitigate that threat.

This process repeats itself until enough apparatus arrives in the community to allow neighborhoods inside the fire perimeter to be patrolled constantly until the fire is completely mopped up.

This time lag between the initial action (bump and run) and the ability to patrol and extinguish hot spots is when our homes are most vulnerable. It is very hot, very smoky and visibility can be less than 30 feet.

Imagine you have been evacuated because of a fire and the almost untenable atmosphere it creates. Now, your home sits right in the middle of this situation. Will it survive?



# **County reviews ICRC** contract performance

Five months after the Idyllwild Community Recreation Council (ICRC) agreed, as a condition for extending their county recreation contract, to a series of 15 contract performance requirements, they reported on what they had and had not completed to the County Service Area (CSA) 36 Advisory Committee.

Only eight of the requirements have been completed or started and seven have not been completed. "The County came to the meeting with the express goal of seeing ICRC succeed," said CSA Operations Manager Bill Brown. "However, four months have passed since the new agreement terms were accepted by ICRC (May 20, 2010) and ICRC has not shown the county proof that most items have been completed. For the good of the community, the county would like to see faster compliance by the recreation contractor to expedite the process of forming a new longterm Recreation Agreement. Delays serve no good public purpose."



# IFPD considers solar power

The Idyllwild Fire Protection District (IFPD) commissioners listened to two speakers, but still had to postpone purchasing new equipment because of budgetary concerns.

The Commission heard Bill Baker, emergency manager for the Radio Amateur Civil Emergency Service (RACES), and Mike Patton of PermaCity Company, which installs solar power equipment.

Baker explained the role and service that RACES members provide during local emergencies. "RACES' communication task is support during emergencies," Baker said. "We do not do MDP's [Mountain Disaster Preparedness] function — for example, search and rescue."

In his introduction of Patton, Fire Chief Norm Walker explained that he had been exploring the cost and value of installing solar power equipment at the IFPD station.

"I started thinking about no electric bill around here and the ability to give energy for the community," Walker said. "This is just an informational presentation; no decision is necessary. [Patton] is one of several mendation to use \$15,000

bidders [I've contracted]."

install about 150 solar panels on the IFPD fire station roof. The total cost would be about \$178,000, but the net cost for IFPD would be \$139,000 because of incentives worth about \$39,000 that would accrue to the fire agency for the installation of the solar equipment.

Based on average usage, Patton estimated IFPD's payback period would be slightly more than 12 years. He said his firm has already qualified IFPD for a loan so that it would not need the full capital cost. Instead, the monthly loan payment would be about \$1,500 per month for 10 years.

After discussing the possibility of reducing electric bills, the commission faced its 2010-11 budget. During the first quarter, expenses have exceeded revenue by almost \$300,000. This typically occurs at the beginning of the fiscal year because the first property tax payments do not arrive until December. Consequently, IFPD has reduced its reserves from \$438,000 in May to \$238,000 at the end of September.

As a result of the budget condition, the board postponed two requests. One was Walker's recom-

to complete the purchase Patton's proposal would of the new dispatch equipment.

After the board agreed to defer the full purchase, Walker said he would delay the installation of the equipment. The priority will be two ambulances and a truck.

The board also deferred decision on whether to change administrative assistant Rhonda Andrewson's position from less than 40 hours per week to full-

Commissioner Ben Killingsworth recommended the change and Walker said she was a valuable member of his team, doing much more than the previous contractor. Nevertheless, commissioners Pete Capparelli and Dr. Charles "Chip" Schelly preferred to defer the decision until November when a full commission would be present.

# CSA 38 supports IFPD ambulance fees

At its Oct. 13 meeting, the County Service Area (CSA) 38 (Pine Cove) Advisory Committee agreed to recommend that the Riverside County Board of Supervisors approve Idyllwild Fire Protection District's (IFPD) proposed ambulance fee request.

After a brief discussion with IFPD Fire Chief Norm Walker, the committee unanimously recommended that Chairman Jerry Holldber send a letter of support to 3rd District Supervisor Jeff Stone. The letter was dispatched Friday.

The Advisory Board did discuss at our Oct. 13, 2010 meeting and by unanimous vote support their new fees," Holldber wrote to county officials. "We also acknowledge they need Board of Supervisor approval and we so recommend the Board of Supervisors to approve."

Committee member Marge Muir observed the final fee schedule was original IFPD proposal. The fixed fee increase was less,

went from \$20 to \$26.

"I told REMS [Riverside County Emergency Medical Services, the agency that oversees the ambulance contract between IFPD and the county] that I took your advice on that part," Walker replied.

Following the decision to support the fee increases, Holldber asked Walker to convey the Advisory Committee thoughts about the adequacy of the process to the IFPD board.

"Next time or any fee increase, especially one affecting us: we wish you'd adhere to the Brown Act [California's open government statute] and hold a public hearing," Holldber said. # Measures L and M: County pension benefits

"L" and "M" sounds like a childhood lyric or a rock band but not so in 21st century Riverside County. Measures L and M are like two competing, antagonistic athletes. Only one will win. While they both claim they provide help for local taxpayers, measure proponents are fighting tooth and nail in order to prevail.

Measure L is called Public Safety & Taxpayer Protection Act 2010. Measure L requires any future change, increase or decrease, in public safety pensions to be approved by county voters. It also removes the responsibility for this portion of the county budget from the County Board of Supervisors.

Measure M was the Board's reaction to the Riverside Sheriff's Association's (RSA) attempt to usurp the board's job. This would require any pension increase to go before county voters. The

board would retain authority Recreation. to reduce costs.

The first sentence of Measure M's section is: "The purpose of this ordinance is to prohibit increases in public safety employee retirement and death benefits without voter approval." It goes on to state that the supervisors can decrease these benefits without voter approval.

Shortly after the Board of Supervisors began the 2010-11 budget formulation process and only a few months after finishing the 2009-10 process, they made the county's fiscal problems clear. Within six years, retirement benefits will consume one of every three dollars of the county's public safety personnel budget.

Their intent was to review every department's budget and workload. They spent time with every county department head, from the District Attorney and Sheriff to the head of Economic Development and Parks and

In May 2010, RSA had obtained enough signatures to place the Public Safety & Taxpayer Protection Act 2010 on the November ballot.

Just as Proposition 13 protects taxpayers by requiring a vote of the people to approve raising local taxes, Measure L will require a vote of the people if Riverside County negotiates higher pensions with the unions for public safety employees.

In the past, the Riverside County Board of Supervisors have given larger pensions to the unions that represent Riverside County's public safety employees without a vote of the people.

Proponents argue that with Measure L, voters will have greater power to hold Riverside County's politicians accountable. For the first time ever, voters will be able to approve or reject any pension increases County Supervisors agree to with these unions.

A May 2010 report on the county's pension finances stated that annual costs will increase \$20 million in the next two years. On an actuarial basis, it could have been \$65 million, but CalPERS has agreed to a longer payment period.

As the Board of Supervisors attempts to find solutions to the current county budget problems, they are examining revisions to the pension benefits. This would not affect existing employees, but new employees might receive a lower pension benefit.

For example, limiting the retirement amount to two percent of longevity might save the county \$15 to \$30 million for safety employee retirement costs and \$22 to \$226 million for other employee retirement costs.

## Feds blind to possible **Prop 19 approval**

Federal law enforcement does not intend to recognize the legality of Proposition 19 if state voters approve it next month.

Various media organizations have reported that U.S. Attorney General Eric Holder, Jr. announced Friday, Oct. 15 that the Department of Justice would aggressively enforce federal law against possession of marijuana even if state voters approve Proposition 19.

This proposition would authorize the possession of one ounce or less of marijuana and allow California local jurisdictions to regulate

and tax sales. This is in addition to the current medical marijuana provisions enacted in 1996.

Holder expressed his view in a letter to nine former administrators of the federal Drug Enforcement Agency. They had been urging him to take this position publicly since August.

'We will vigorously enforce the CSA [Controlled Substances Act] against those individuals and organizations that possess, manufacture or distribute marijuana for recreation use, even if such activities are permitted under state law," he wrote.

## Money flows to Hill campaigns

The lifeblood of most elections is money. Riverside County is no different, but the level of the office attracts vastly different amounts of finances.

Candidates for California's 45th Congressional District - incumbent Mary Bono Mack and her challenger, Palms Springs Mayor Steve Pougnet — have each raised more than \$1.5 million.

Through Sept. 30, Bono Mack's net contributions totaled \$2 million and she had expended \$1.1 million. For the final month of the campaign, she had \$1.1 million available.

She has received more

than 200 individual contributions greater than \$2,000. Political committees, such as the AT&T and Pfizer Political Action Committees, have given \$5,000 contributions.

Pougnet's net contributions total \$1.6 million. His expenditures of \$1.3 million have left him with \$354,000 remaining. He has received 18 political action committee gifts greater than \$5,000, nearly matching Bono Mack's total at this level. But his total committee contributions are only \$280,000, nearly half a million less than Bono Mack's \$770,000. Through Sept. 30, Pougnet's individual contributions were about \$40,000 more than hers. Both have received about \$1 million from more than 1,200 indi-

vidual contributions.

Both candidates will be raising money during October and outside groups are expected to independently finance commercial and mail fliers. For example, Pougnet will benefit from President Barack Obama's visit to Los Angeles this week.

However, the state level candidates have received far less money.

Through Sept. 30, Assemblyman Brian Nestande has received \$276,000 in contributions this calendar year for his re-election race. In the first nine months of 2010, he spent \$149,000, leaving him

cash for the campaign's final month.

He has received 36 donations greater than \$3,000. The California Dental Political Action Committee and the Barona Band of Indians have given the campaign \$7,800.

Jose Medina, Nestande's challenger, raised nearly \$64,000 through Sept. 30, of which \$25,000 was raised since July 1. Since January, Medina has spent \$47,000.

Medina has received six contributions greater than \$3,000. The largest, \$7,800, was from the California Association of Electrical Workers.



and interviews difficult.

"Ninety-six percent of VHS' approximately 1,350 employees were rehired as PHH employees. Those not hired represent departments across both hospitals and include staff and management, union and nonunion members," said Jerri Ran-drup, the VHS vice president for communication and marketing. "Some were caregivers. The law requires that we maintain specific staffing ratios between patients and caregivers."

At least seven emergency room (ER) nurses and several from the regular night shift were part of the employee group the physicians released, according to John Stead-Mendez, labor representative for California Nurses Association. Lawanda Turner has more than 20 years working in emergency and critical care nursing. VHS paid her a bonus to join their staff.

But Jessica Lopez and Helen Ostott, as well many more nurses, had been with VHS for decades. Lela Valencia had been a 15-year registered nurse in the ER. Rose, a resource secretary for the ER, had been with VHS for years.

"It's a travesty. People should be concerned," Stead-Mendez said. "There will be drastic understaffing in the ER. A year ago, PHH said they wanted to keep the ER

in the community. Who will hold them to their commitment? This seems politically motivated."

Randrup did not respond to questions about the criteria for the doctors' decision not to hire these employees. None had been told they were underperforming. Many of the employees felt it was retaliation for their involvement in employee organizations.

"I checked the hire dates and there has not been a nurse hired into ER since August, despite the fact that there have been positions posted there for some time. So it is simply disingenuous to claim, as Jerri Randrup did, that 'We've continued to fill vacancies as they've occurred.' In fact, they have not filled vacancies in ER for months and they just created [seven] more vacancies there," Stead-Mendez said in an e-mail.

"I'll fight the battle 24/7 now," Turner said, angry about how the nursing staff has been treated. "I'll protect the workers." Though she was not concerned about a new job for herself, she worried about her co-workers and patients. "The quality of care isn't what is should be," she stressed.

Lopez, a respiratory therapist, has more than 30 years experience. She now has to find new employment. She cares for her grandson, Elijah, who is now worried about where Grandma will

I have no savings," Sharon Robinson, an oncology nurse, lamented. She was hired only 90 days ago, although she has more than 20 years nursing experience. While some nurses already have potential new jobs, many are still looking and worried. Despite state mandates for minimal nurse to patient ratios, the market for nurses has been weak. according to many.

While many nurses will have problems until new jobs are found, most still "I could lose my home; expressed concern about getting them to return to

patient care. "We assumed they would be adding staff for winter," Turner said.

When PHH initially engaged the district in selling the hospitals, one of the main arguments was that doctors lived here and wanted to protect the community. In an interview a year ago, Denes said, "We want to provide as much [medical] service as the communities need. We need to re-establish trust in these hospitals.

pass without challenging an unauthorized charge, they could lose some protection. Three things the DA advises must be protected, and not shared collectively, are name, date of birth and social security number. These are gold for identity theft criminals.

The DA also advises not to respond to phishing contacts made by criminals pretending to be banks, stores or government agencies. "Don't give out your personal information unless you made the contact," said the DA's office. "Also don't respond to a request to verify your account number

or password. Legitimate companies will not request that information. Don't allow identify information to go into your trash without cutting or shredding it. Especially important to shred are credit card offers and 'convenience checks' you don't use. Also, consumers have the right to limit sharing of their personal financial information by banks and other financial institutions. Finally, check your credit reports regularly. You can get one free credit report every year from each of the three national credit reporting bureaus."







The answer is never 100 percent certain. But your decisions and actions determine the probability of your home's survival. Passing your LE [Law Enforcement]100 inspection is only the first part of protecting your home.

Pine needles and leaves are constantly falling. In this forest environment, that's life's process. You must constantly remove this "fuel" from your roof, deck, rain gutters and the first 10 feet from your structure(s) down to mineral soil or green ornamental plants.

If you don't, these fine dead fuels will lead a smoldering fire to your house. Nationally, more homes are lost in a wildland fire under these conditions than are lost during the passing of the fire's flaming front.

I know that keeping needle and leaf litter cleaned up on our properties is a PINE COVE | real pain. However, this is

the unfortunate truth about Southern California. If it's not raining or snowing in the wildland urban interface, wind and an ignition is all that's needed and we will have a wildland fire any time of the year.

People accept this risk and continue to move here because of the great climate and the variety of entertainment it allows us to

Please, whether you are a full-time resident, landlord or weekender, check your property often to make sure it is firesafe. Remember that you have as much to do with your home's survivability as the fire department does.

So, while you're cleaning up your property or writing a check to someone who has just done it for you, remember it's the price we pay for the lifestyle we choose to live!






