Abrams leaves hospital Ready to perform

On Thursday, March 10, after an outstanding performance on the first "finals" segment of this year's American Idol competition, Idyllwild's Casey Abrams returned a second time to Cedars-Sinai Hospital in Los Angeles. After receiving two blood transfusions and continued medical and dietary care, Abrams was released four days later on Monday, March 14.

Abrams suffers from ulcerative colitis, an inflammatory bowel disease that affects the lining of the large intestine. It can be both genetically influenced and stress-induced.

From his hospital bed, Abrams worked on arrangements for his Wednesday, March 16 American Idol performance. He collaborated, via Skype, with his in-studio music producer for this week, Don Was.

At the March 9 Idol telecast, Abrams earned judges' kudos with his knockout Joe Cockeresque take-on "With a Little Help From My Friends." Judge Steven Tyler said, "You are a rainbow of talent, a plethora of passion. Everyone in the house felt what you sang."

"I'm watching somebody important," said Jennifer Lopez. "You blew me away. Great stuff!" Randy Jackson, who has been on the panel since season one, said, "So unbelievable, so

exciting. You make us listen to you."

When Idol host Ryan Seacrest announced results on Thursday, viewers had voted to affirm judges' praise for Abrams. Casey, on track for a deep Idol run, sailed through to the top 12. One contestant, Ashton Jones, was eliminated.

Casey's mother, Pam Pierce, reported he "sends his bear hugs to the town and Idyllwild Arts and to everyone who helped by their thoughts, wishes and prayers."

IFPD finances worsen

The Idyllwild Fire Protection District (IFPD) finances continue to deteriorate. At the March 8 meeting, Commissioner and Treasurer Ben Killingsworth announced that revenues for this year (ending June 30) would be about \$115,000 less than expected.

Lower revenues plus unanticipated costs for prior year retirement payments that were not made have extraordinarily strained IFPD's fiscal resources.

The plight appears to be growing at an alarming rate. Commission President Pete Capparelli would not confirm that the budget would

be on the April agenda. Both he and Killingsworth said that the projected deficit needed to be more accurate and a letter would be sent to the career firefighters association asking it to confer with the agency about the problem.

The possible decrease in current-year revenue estimates ranges from \$75,000 to \$115,000. But mounting unexpected expenses could create a larger current-year deficit. While the district's reserves are sufficient to replenish this loss one-time, Killingsworth said the lower revenue estimates are not an isolated 2011 phenomenon, but would continue next year (which begins July 1, 2011).

Emmerson says door is still open

Republican State Senator Bill Emmerson (CA 37) and four colleagues have been dubbed the "Gang of 5" or the "GOP 5," but he prefers the "Reform 5." For almost two weeks, they have been deliberating and negotiating with Governor Jerry Brown to achieve a meaningful breakthrough on the state's financial crisis and put tax extensions on a June ballot.

Although the conferences have stopped without that achievement, Emmerson

says, "The door is still open with the governor."

Emmerson said the five senators hope to accomplish several objectives as a result of these political risky negotiations: "Spending caps, rainy day funds, pension reform and regulatory changes to improve the state's job creation capability."

Although no meetings are scheduled, Emmerson remains open to further talks. "I'm optimistic, that's my nature," he said. He said Brown indicated a willingness to address these key issues during his campaign and on his website.

MEMSCOMM prepares for many disasters

The Mountain Emergency Services Committee (MEMSCOMM) spent most of its Thursday, March 10 meeting in a workshop in which volunteer emergency responders could coordinate their radio frequencies. The purpose was to promote clear and non-interfering radio communication among volunteers during times of emergency.

The balance of the meeting consisted of updates, including one for a new Community Emergency Response Team (CERT) training class in Banning on April 16, 17 and 18. Fourteen people are registered and there is room for 40. Another class will be held in Lake Riverside Estates on June 24, 25 and 26. Contact MEMSCOMM coordinator Gina McGough for registration information at (951) 955-4700 or gina.moran-mcgough@fire.

ca.gov. CERT training is important for mountain communities given that many disasters could cut access to the Hill for sustained periods, rendering emergency volunteers important in minimizing deleterious effects.

Members also discussed new steps Riverside County Public Health is taking to monitor people fleeing Orange and San Diego counties should there be a nuclear accident at the San Onofre Nuclear Generating Station south of San Clemente. These steps were being planned before the March 11 Japanese earthquake that has damaged five nuclear reactors.

In other business, Clyde Bacon reported that the Aguanga Emergency Preparedness group has 11 Red Cross trained and 19 CERT trained volunteers. They are also stocking a mobile Disaster Aid Station.

March madness

Since the snow has almost completely melted in town and the weather has been warm enough for shorts and T-shirts, I decided to take a short hike on Sunday. I don't normally venture out this early in the year but nothing about this year's weather has been normal.

Sunday morning saw the change to daylight saving time. Even though it seems odd to have the change occur so early in March, I was ready to take my knees out for a test drive.

The day was very warm and the sky was about as blue as it gets, with a few wispy clouds to the west.

I decided to hike the Deer Springs Trail because it was likely to be free of snow, at least for the first mile or two. Although I took along my Yaktrax just in case I encountered snow, I told myself if I needed to put them on, I would probably turn back. If any snow patch was longer than a hop, skip and a jump, I would just stop.

The trail's lower section was completely free of snow. After about a mile, I encountered only small patches of snow. What I did navigate were several small creeks crossing the trail and a few wet and muddy spots that I could not jump over. Also, I could hear the sound of a larger creek to my right that usually isn't running during the spring and summer months.

Since I have hiked Deer Springs more times than I can count, I have gotten into the habit of marking my progress by naming various spots on the trail. As I progressed up the trail, which I seemed to have all to myself, I checked off my miniature landmarks.

The first landmark is called Buena Vista, which is followed by Niagara Falls, roots rocks reggae, Rivendale, shady grove, western azalea stream, fern corner and the mosquito swimming hole.

Since this was my first time out for the year, I decided to hike 2.3 miles to the first trail junction. Other than stopping to take pictures and videos, I seemed to have no trouble going uphill. I was very pleased with my progress and felt I could go on for several hours if only I would not have to turn around and hike back down again.

As I reached the trail junction, the clouds from the west started to move in. When the sun was briefly covered, the temperature felt as if it dropped about 10 degrees almost instantly. Luckily, I had brought a light jacket, which I put on for the hike downhill.

The mechanics of hiking downhill seems to be elusive to my knees. Both knees lock and I feel as if I am walking on stilts. After taking some Vitamin I and making an effort to bend my knees, things went much better for me.

I always start a hike with thoughts of my everyday life running through my head. Once I start really looking at the world around me, those thoughts slowly slip from my consciousness and I am, once again, living only in the moment. When this happens, I remember why I like hiking and being out in nature.

Stone offers sixth economic forum

On Thursday, March 24 Riverside County Third District Supervisor Jeff Stone will hold his 6th-annual Economic Development Forum at the Soboba Country Club in San Jacinto.

The Forum is a combination "State of the Third District" summation and the supervisor's vision for how to deal with challenges facing the county and its businesses. Attendees are chambers of commerce from throughout the district, including Idyllwild, Hemet and San Jacinto, Menifee Valley, Murrieta, Temecula Valley, Canyon Lake and Anza Valley. In the past, Stone's Forums have drawn audiences of upwards of 500. This year, capacity is limited to 330 owing to banquet room size.

This year's speakers are the county's elected officials: Stone; Larry Ward, county assessor, clerk and recorder; Paul Angulo, auditor-controller; Paul Zellerbach, the new district attorney; Stanley Sniff, sheriff-coroner; and Don Kent, treasurer-tax collector. Rob Field, assistant county executive officer/EDA head will join the other speakers, each of whom will present an overview of their department's responsibilities, challenges, budget issues and visions

for the future.

"We'll spend some time on what has happened, but more time on projections for the future, what's going to go on," said Stone's Chief of Staff, Verne Lauritzen. "It's very much like a large town hall. We'll present true facts and real possibilities." Lauritzen said the Forum also gives the supervisor a chance to give a pep talk to attendees about ways chambers and the county can work together to address the issues and challenges that are coming. With approximately 500,000 residents in the district, the demands on infrastructure and public services are daunting.

There is a cost to attend the Forum: \$35 in advance and \$50 at the door. Breakfast is served. Contact www.idyllwildchamber.com for more information about this event. The club is located at 1020 Soboba Road in San Jacinto.

Attending chambers of commerce split aggregated ticket sales based on the proportion of attending members. Distribution favors smaller chambers that can turn out a higher proportion of their members. Stone's Forum could produce \$2,000 or more for the Idyllwild Chamber depending on Idyllwild attendees.

Final bald eagle count conducted

With the help of volunteers, the final bald eagle count of the winter was conducted last Saturday by local federal and state biologists, around the lakes in the San Bernardino and San Jacinto Mountains. This marks the 32nd year that the San Bernardino National Forest has organized the counts.

A grand total of eight eagles (six adults and two juveniles) were observed at the lake areas during the 1-hour count. At Lake Hemet, just one adult was observed but two were observed last month. Additionally, three were spotted in the Big Bear/Baldwin Lake, one at Lake Silverwood, two at Lake Arrowhead, and one at Lake Perris.

According to biologists, our mountain region supports the largest wintering bald eagle population in Southern California. The established pair at Lake Hemet live there year-round. Once on the brink of extinction, the bald eagle's population began to improve in 1972 when DDT, a pesticide that damaged the bird's eggs, was banned in the United States.

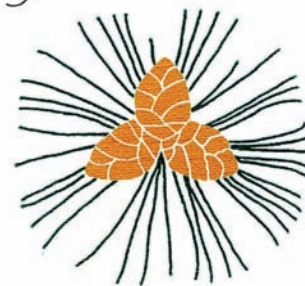

INITIAL THOUGHTS

IFPD needs the sun's heat ...



But don't make light of the subject, Sunshine Week is an opportunity to inform the public about its rights to know and participate in its government's activities.

Many of us think we are familiar with Otto von Bismarck's famous observation about open government, in which he compared the legislative process with the manufacture of sausages. In the spirit of investigative reporting and transparency, you're mistaken.

Bismarck apparently did not first utter this thought. A Yale scholar, Fred Shapiro attributes it to John Godfrey Saxe (1816-1887), better known for introducing North American residents to the Indian parable of the blind men and the elephant.

Shapiro cites The Daily Cleveland Herald, which, on March 29, 1869, quoted Saxe as saying, "Laws, like sausages, cease to inspire respect in proportion as we know how they are made." By the way, Saxe was a lawyer and twice defeated to be Vermont's governor prior to the Civil War.

Sunshine Week is about more than legislation. Since implementation occurs more often than creation, administering the laws is many times more important. While it may be dreary to attend public meetings and listen to redundant discussions and boring topics that seem unrelated to our lives, sometimes government in action alerts just as a fire siren.

Last week's Idyllwild Fire Protection District (IFPD) meeting offered two juicy moments. The first was the revelation of the district's dire financial situation. While miscommunication between the county and IFPD may be the reason IFPD expects \$100,000 more than will be received this year, Treasurer Ben Killingsworth's description of the IFPD budget process is amazing.

"It should be noted that when we put together a budget we do not figure out what our income is likely to be and then figure out how we can spend it all," he wrote in the financial report. "On the contrary, our projected expenses are based on what we determine our needs are based on current circumstances, and then we pray we're going to receive enough income to cover it, which, with each passing year, becomes more and more unlikely."

The IFPD budget story (page 1) describes the expanding expenses. The commission and staff will need a lot of help with prayers.

Then, the commission revealed an explicit Brown Act violation. While discussing Chief Norm Walker's contract, which was on the meeting's agenda, the commission admitted that they knew about the issue because it was subject of a closed meeting discussion two weeks earlier.

Not only did they fail to identify over-compensation to the chief as an item for their closed session, but if they had, we would have advised them it doesn't qualify. Compensation must be discussed in open session.

The issue is not the district's overpayment to the chief. As Commissioner Schelly acknowledged, while a public subject, we need to be respectful about how to approach it. Resolving the issue is now in the hands of the commission and its Ad Hoc committee.

But once again, IFPD is violating the Brown Act, California's open government LAW. I'm wondering what else occurs when this commission goes to closed session.

Unable to balance its budget, there's talk, not murmurs about a parcel fee increase.

The current IFPD commission is working very hard to recover from all the errors and indifference of past officials. But one important and easy change would be to follow the Brown Act — transparency. Government is more like a gourmet meal than simply sausage.

So at \$1 to \$2 a month savings, it would take 37 to 74 years to break even using the 22 percent savings your article alleges!

Two sides of free speech ...

Two seemingly unrelated events occurred in the past two weeks. I say seemingly because at first glance they don't appear to be related. But upon deeper examination, I think they are opposite sides of the same coin.

The first event was the assassination of Shahbaz Bhatti, 41, the Christian minister of minorities in Pakistan's cabinet. Many believe that he was killed for his outspoken criticism of Pakistan's blasphemy law, which imposes the death penalty on anyone who insults Islam. Bhatti was a brave, outspoken man and knew the risks that came with speaking for his people and his faith and still chose to carry on all the same.

The other event was the U.S. Supreme Court's decision to uphold the First Amendment rights of the Westboro Baptist Church to picket and protest near the funerals of fallen American soldiers.

The church's vehement verbal attacks on the soldiers, the country and gay people are particularly heinous but the court saw fit to protect their right to speak, though all of the justices found their speech reprehensible. Only Justice Samuel Alito, of the nine justices, dissented from the majority's opinion.



I agree with the court's ruling. The foundational precepts of our Constitution are most meaningful when put to the test by a difficult situation. This is one area where America is that light on the hill, declaring to the world that free speech is important to us, even speech we despise.

A radical Muslim group is taking credit for Mr. Bhatti's death. They don't want free speech in Pakistan. They would rather people remain silent, fearing that they might say something that could be construed as an insult to Islam and lose their life for it. They found Mr. Bhatti's views offensive and they killed him for it.

But did the good Muslim people of Pakistan speak out against this barbarism? Did they make it clear that there is no room for this sort of reaction to dissenting opinions in a civilized society? I don't know. But I think they should.

I think all good rational people should speak out against intolerance, Muslim or Christian. So I think I will. In honor of the Supreme Court's decision, I'm going to exercise my right to free speech.

To the 50 or so members of the Westboro Baptist Church, I speak to you.

Pine Cove ready for Realtor inspections

Mirroring the Hill's other water districts, the Pine Cove Water District approved a request by Idyllwild Board of Realtors President Steve Taylor to draft policy that would permit water turn-on for Realtor inspections of water-liened properties.

Following General Manager Jerry Holldber's recommendation, the board voted unanimously at its Wednesday, March 9 meeting to charge \$60 for turning water on and off in the same day at a Realtor's request. The policy requires real estate agents to supply the district with names of listing agents of water-liened properties as soon as the property enters escrow. This gives the district a chance to recover the lien

as soon as possible.

In other business, Holldber reported February 2011 water production was virtually identical with one year ago. System demand remains low at about 40 GPM (gallons per minute). Holldber also announced that Ed Cicchillo and Linda Riley, private accountants, would train district staff on data entry to best facilitate audit compliance. Riley and Cicchillo are not the district's audit firm.

With the April billing, Holldber is considering inclusion of a request for customer comments about whether the district should remain in Stage 1 voluntary compliance or move to Stage 2 as a conservation measure. The district would then make a determination in May about water stage level.

CSA 36 discusses loan repayment

At a joint meeting with the County Service Area (CSA) 36 Advisory Committee, Idyllwild Community Recreation Council (ICRC) submitted a proposal for closing a \$20,000 advance. The county made the loan more than 15 years ago to the Chamber of Commerce when it was responsible for Idyllwild's recreation. It has been carried on the books since.

Recreation Director Bob Lewis and ICRC President John Simpson submitted a proposal that repays the funds in two years and eight months. Lewis and Simpson used a formula to apply 50 percent of projected monthly event rental and contract program revenue to the repayment of the \$20,000. This formula, ac-

cording to ICRC, would allow recreation to operate at its present levels without seriously impacting programs.

Economic Development Agency representative Michael Franklin and CSA Operations Manager Bill Brown will review it in the coming weeks. Franklin thought the proposal was a starting point and stressed the payback should not impact programs. Last month, Brown said a 6-month return would be deemed a "good start."

Advisory Committee Chair Holly Maag voiced concern that she might not be able to endorse the proposal if it were only salaries that were being protected by the repayment formula. Both boards reached resolution that this matter and the repayment formula would be resubmitted as a con-

tinuing agenda item until a final formula is agreed upon between ICRC and the county.

For another county-requested item, to which ICRC had previously agreed in principle, Simpson submitted a draft of a Town Hall lease with a proposed termination clause. Franklin suggested that the lease be either submitted to the

county and Chamber simultaneously or in a joint meeting.

In other business, Carol McClintic was voted vice chair of the advisory committee and, at Maag's suggestion, discussion of the 2011-12 recreation budget was deferred until April.

These have been tough times here in Idyllwild for our friends and neighbors who are struggling with this economy. Never in the history of the Idyllwild HELP Center have we seen such a need in this community. When I started in April 2007, our client count was 147, and today we are seeing over 600 clients even with our stricter guidelines and intake process.

WE ARE PROVIDING MORE FOOD TO MORE PEOPLE

In January 2009, we provided approximately 164 people with food. In January 2011, that number was over 200.

WE ARE ASKING FOR FUNDS/FOOD FOR OUR FOOD PANTRY

Because of the increase need for food, our pantry is slowly running out of even the basic food items. While the biggest single surprise was Killingsworth's announcement about lower revenue collections, expenses, especially unanticipated costs, have continued to multiply and plague the district.

Audit issue

For example, Killingsworth reported that Rogers, Anderson, Malody and Scott, IFPD's new accounting firm, said the 2009-2010 audit cannot be completed without significant review of the district's financial records. The condition of IFPD's financial records is so bad that the auditors said they cannot proceed without a labor-intensive review and verification of the financial records.

While Killingsworth did not share the expected cost, he said the firm said that it would not bid on doing the additional work if IFPD pursued a competitive bid for the work. They were initially engaged in November to do the audit for \$7,000.

With respect to the audit costs, IFPD has already paid \$11,200 of its \$11,500 budget for this year. However, none of those payments have gone to the new audit firm.

When Smith Marion, the former auditor, ended its relationship with IFPD in October 2010, one of the stated reasons was its inability to verify and track IFPD's financial records.

Unpaid bills

The greatest impact on the 2010-11 budget has been the need to make payments to CalPERS and an employee deferred compensation program, which IFPD failed to make in 2009. The total

cost is greater than \$65,000, nearly 3.7 percent of the full-year budget.

These are not the only past due payments IFPD had to make. The agency's physician went unpaid for two years. The annual cost is about \$2,000, but no payment was made last year. Thus, two payments were necessary this year, resulting in a \$4,450 expenditure for a \$2,000 authorization.

Other expenses

Other areas growing faster than estimated when the budget was approved include administration, overtime, health insurance, other insurance and audit costs.

Meanwhile, the contract with career firefighters continues to require \$2,400 annual raises. This may be one of the issues that the commission wants to discuss with the association, but no public announcement has been made.

Another unspoken but looming issue is the district's burgeoning pension costs. This phenomenon is affecting all levels of government, but IFPD has not taken any steps to address or control it. Retirement costs have grown from \$85,000 in 2004 to \$165,000 in 2006, and this year those costs will exceed \$235,000 (exclusive of the prior year payments).

This amount will continue to grow. CalPERS estimates the increase for next fiscal year will be 27 percent. And last week, CalPERS staff recommended that the pension behemoth lower its expected returns. That would require local governments (including IFPD) to increase its payments to ensure the benefits they have bestowed on current staff are funded.

"It's an opportunity to make California work," he said.

Emmerson noted that risks and impediments are building on both sides of the legislative aisle. The formation of the "Taxpayers Caucus" two weeks ago created some division within his party, divisions that Emmerson dubbed "destructive." But he shared his position with his party's legislative members. "I looked at that [formation of the Taxpayers Caucus] as campaigning," he said. "Now it's time to govern." Emmerson believes that his group's position has now gained respect within the larger Republican caucus.

Emmerson is unsure if Brown has the full support of his party's legislators. For example, Senator Leeland Yee (San Francisco) has publicly opposed the governor's plan unless it raises income taxes on millionaires and taxes on oil severance.

More importantly, Emmerson says the "Reform 5" and the governor have encountered significant obstacles with Democratic

legislators over pension reforms. "The public employees unions are very strong," he said.

In the absence of agreement between the two parties, Emmerson believes the governor and his party will move forward with some budget reductions and tax extensions. "They have a legal opinion saying they can probably do all the budget issues on a majority vote."

Two, which will require a two-thirds vote, are changes to the redevelopment agency and enterprise zone laws. While Emmerson is sympathetic to some changes to the redevelopment laws, such as recovering revenue for school districts, he is concerned about penalizing some counties that do not abuse these laws.

For example, Riverside County's plan to renovate Hemet-Ryan airbase, to support CAL FIRE's air tanker needs, and then to lease the base back to the state would be endangered by some of these changes. Emmerson said the state would have no money to fund the lease.

"The governor stated we [elected officials] need to do the right thing," said Emmerson.

Skate Park needs triage

At the Thursday, March 10 joint meeting of the Idyllwild Community Recreation Council (ICRC) and the County Service Area (CSA) 36 Advisory Committee, Recreation Director Bob Lewis asked for \$3,000 to \$3,500 to replace ramps at the Skate Park. Lewis reported several ramps had "big cracks" that "can't [be] repair[ed] anymore."

Advisory Committee member Bob Schraff questioned the value of the investment since the Skate Park costs about \$14,000 to run and brings in around \$1,000 annually. Lewis said that the employee assigned to the park also does other things. Schraff suggested accurately accounting for the other use of the employee's time so as to get a better estimate of Skate Park op-

eration costs. CSA member Mike Frietas worried that keeping the park open with possible publicly stated safety concerns would raise liability issues.

After the meeting, Lewis reported that the safety issue had been resolved. "After extensive review, we found that there's plywood underneath the ramps. We put screws in by the uneven cracks and it totally worked. The cracks are not uneven any more and it's not a safety issue anymore."

This repair is temporary and Lewis stated the ramps, imported from Belgium, would still be needed "within the next few months." Meanwhile, Lewis and ICRC officials concluded, "The Skate Park will remain fully operational and the safety issues have been mitigated."

Jazz combo first at Berklee fest

In its first national competition, an Idyllwild Arts (IA) jazz sextet took first-place honors at the prestigious Berklee High School Jazz Festival on Saturday, March 5. In addition, two combo members, guitarist and IA junior Lake Jiroudek and sax man and senior Jacob Scesney, won individual honors, first- and second-place respectively.

The combo, called "Eagle's Nest" after its IA rehearsal space, and the two players garnered awards in the most competitive small-enrollment category, which features arts schools with highly touted jazz programs. In all, 150 high schools entered ensembles, with most from the northeast U.S. and only three from California.

IA jazz program instructors Marshall Hawkins and Paul Carman, the combo director, accompanied the sextet to Boston for the competition. Earlier in the year, they had approached IA's Music Department to fund, for the first time, the combo's participation in the two most prestigious national high school jazz festivals, Berklee and the Reno Jazz Festival. When it could only fund the Reno festival, Carman approached the Admissions Department for funding. The request was granted because of the possibilities of enhancing IA's national recognition.

IA had never before sent its jazz players to competitions, primarily because neither Hawkins nor Carman believed in having their students play jazz competitively. The impetus for participating came from the students who wanted to hear other up-and-coming players and get a flavor for what was out there, according to Carman.

This year, for the first time, Carman and Hawkins divided up their jazz students at the beginning of the student year, with Hawkins taking the younger ones and Carman the more advanced. As teachers, Carman and Hawkins complement each other. Hawkins provides students with familial mentoring and imparts the oral history tradition of jazz and appreciation for its unique place in America's

music. Carman incorporates technological innovations in recording and notation software, computer music application and expanded theory classes.

Asked how he works the advanced combo, Carman said he directs as if it were his own band. "I have this ideal," he said. "They operate as if they're a professional unit. I just sculpt it, adjusting what they're doing here and there." Carman explained that most professional jazz players step outside their own playing and see the combo as a whole, adjusting their playing as a result. "Then they're orchestrating," he observed. "And that's really what I want to hear. The better the group, the more they're thinking big picture."

Carman noted that most high schools come in with three tunes and three styles — swing, bossa nova and ballad. Carman felt the process should be more organic for his group. "I thought the tunes we do would evolve out of our process," he said. "About two months out I suggested we start thinking about 'this gig we have.' We chose two tunes so the boys had more room to stretch out — a 1950s post-bop, very fast Freddie Hubbard tune, 'Intrepid Fox,' and a tune called 'Aliso' off of the latest David Binney CD." The Binney chart was available because trumpet player Caleb Hensinger had a con-

nection with saxophonist Binney.

Carman described the competition rooms as small — combo in front, room for about 40 in the audience and five judges at a table in the back. Since a majority of high schools that compete are within busing distance and arrive with fans in tow, Carman and Hawkins worried they would have a very small audience. "Somehow word got out," said Carman. "By the time we started, it was standing room only with about 80 to 90 people. The energy and the expectations could not have been higher."

Carman thought at the time that the group could go in one of two directions. "They'd either fold or focus," he said. "And it [turned out to be] the best they ever played." Hawkins, the jazz program's founder and pater familias, said this about the Boston trip. "The point is, we were family — an incredible family."

"Eagle's Nest" is Jiroudek on guitar, Scesney on sax, Hensinger on trumpet, Ashi Manoff on drums, Alejandro Barron on bass and Ben Kleinerman on keyboard. Next month, the sextet heads to Reno. For this competition, Hawkins said they might use a tune that better features trumpet man Hensinger. "They're all my kids," said Hawkins. "But to have guys like Lake, Jacob and Caleb is heaven."

And, in an interesting side-

bar, Scesney, Hensinger and Jiroudek played regularly at Idyllwild's Café Aroma with bass player Casey Abrams. "They didn't even know he [Abrams] could sing until he told them he'd have to

miss some rehearsals," said Tom Jiroudek, Lake's father. Abrams is an American Idol season 10 finalist.



ter, strengthens self-esteem, trains them in the responsibilities of participating in community and local citizenship and develops outdoor skills and training, he said.

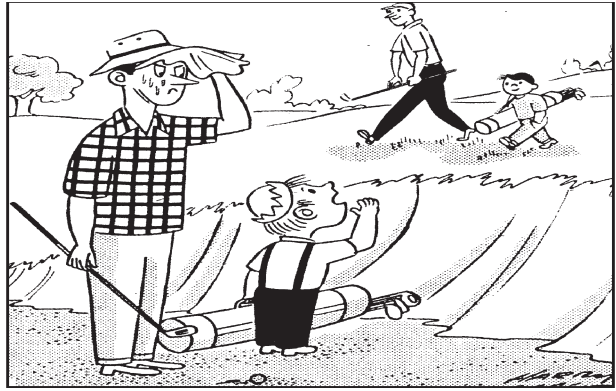

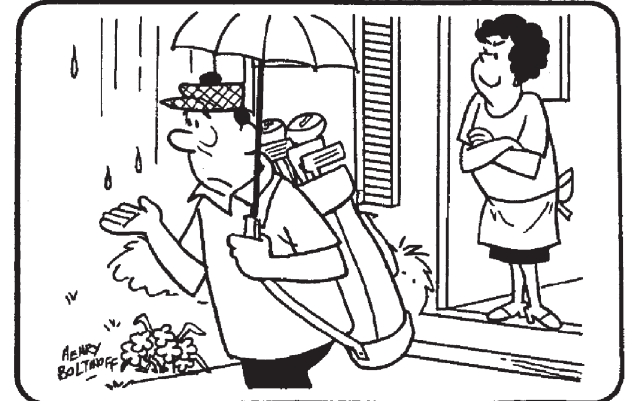

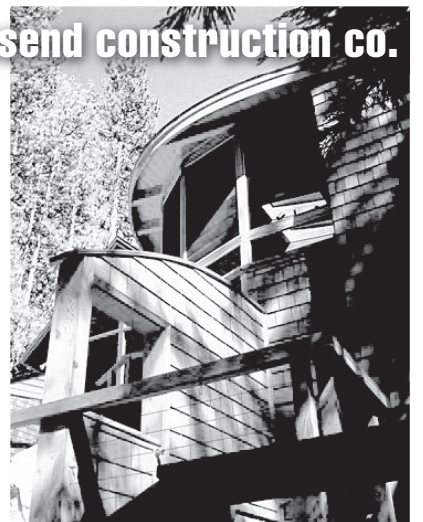
