## Improvisation composition

*Editor's note: This past weekend, the Idyllwild Arts Academy Orchestra performed its "What's New" concert. Four different pieces, each a world premiere, were played in Idyllwild Saturday and at the Walt Disney Concert Hall on Sunday.*

Rufus Reid, renowned jazz bassist and music educator, composed "Mass Transit" for the academy's orchestra.

On Friday, May 6, the Town Crier had the opportunity to discuss the process of composition with Reid. The following is an abridgement of that conversation, which

Peter Askim, Idyllwild Arts' music director and composer-in-residence, arranged.

### How did you become a composer?

Although he was on the faculty of William Paterson University in Wayne, N.J., as full professor and director of the Jazz Studies and Performance program for 20 years, Reid, a Northwestern University graduate, says he never formally studied music composition.

"When I retired from William Paterson, I joined the BMI composers workshop, that thrust me into composing big time," Reid said. "It took me years to write."

The workshop gave him freedom to explore music in ways that had eluded him as a jazz musician. "I didn't know what I liked," he said.

He had to move from his comfort zone, not only arranging a piece, but creating the entire piece, not just the bass line, from scratch. "My pieces sound different, their sensibilities are different," he added.

### How does it compare to playing?

"People who write memorable stuff are generally good players," said Reid who has been a performer all his life. "I'm hearing more

## ICRC playground on hold

On Friday, May 6, Idyllwild Community Recreation Council (ICRC) President John Simpson and Vice President Dawn Sonnier told the community, via email, that the scheduled June construction for the playground on the Idyllwild Community Center (ICC) property would be delayed for four to six months.

Simpson indicated that the county Planning Department notified ICRC on May 4 that zoning restrictions require ICRC to obtain a Conditional Use Permit (CUP), since the zoning

for the parcel on which the playground is to be built is "Commercial, Scenic Highway," (CPS).

That process, explained Deputy Planning Director Greg Neal, is different from the process that ICRC previously negotiated for its Par Course. According to Neal, the Par Course is on a parcel zoned either R-1 or R-2 (residential) and that the playground is sited "mostly or entirely on CPS."

Neal noted that the planning process begins with the requirements applicable to existing zoning. "That is planning 101, you pull out the zone [before proceeding]," he noted. CPS zoning

## SmartMeters back in the news

*Editor's note: We will continue with more articles about SmartMeter installation, examining issues of safety, privacy, and where applicable, opt-out provisions. The meters are again in the news with a recent recall of 1,600 Pacific Gas & Electric meters.*

Pacific Gas & Electric (PG&E) said on Monday, May 2, that it would replace 1,600 wireless SmartMeters due to "a rare defect" that causes the wireless meters to run fast and inflate customers' electric bills. However, Southern California Edison (SCE) officials were quick to point

out that their meters come from a different manufacturer and are "defect free."

The PG&E SmartMeters in question are manufactured by a Swiss company, Landis+Gyr (LG), and represent a small percentage of the 1.2 million LG meters already installed in California, according to PG&E. The utility also contracts with General Electric for SmartMeter manufacture.

Because of a cascade of citizen complaints, the California Public Utilities Commission (CPUC) required PG&E to develop and submit to the CPUC a customer opt-out provision. The prospective provision has further stoked customer

Lost hikers rescued on Black Mountain trail

On Sunday, May 8, at about 4:30 p.m., Riverside County Sheriff's Department (RCSD) deputies responded to a lost hiker call at the trailhead of Black Mountain Trail and Highway 243, north of Idyllwild.

Two hikers, Lucia Terrasas, 27, and Justin Gerard, 36, both of San Diego, used a cellphone to call RCSD when they became lost and disori-

ented after leaving the trail sometime after 11 a.m. The Riverside Mountain Rescue Unit (RMRU) was mobilized but weather conditions, fog and low visibility prevented use of helicopters. As a result, RCSD advised the hikers to settle into a camp site for the night.

On Monday, May 9, at about 8:20 a.m., RMRU spotted the hikers about three-quarters of a mile north of the trailhead. Neither hiker required medical attention.

Household hazardous waste collection in Idyllwild Saturday

A Household Hazardous Waste Collection event is scheduled for Saturday, May 14, in Idyllwild at the Riverside County Road Yard (first right past the Idyllwild Fire Station). The event will go from 9 a.m. to 2 p.m. The collection is open to all Riverside County residents.

The event will accept residentially generated household hazardous wastes; business or nonprofit waste will not be accepted.

Typical wastes include used motor oil, paint, antifreeze, household and automotive batteries, pesticides, cleaning products, sharps (needles/syringes or lancets), fluorescent

lamps, and electronic wastes such as televisions, computers, VCRs and telephones. Limit the amount of waste transported to no more than 5 gallons or 50 pounds maximum per vehicle.

The collection will not accept explosives, radioactives, ammunition, asbestos, compressed gas cylinders over 40 pounds and infectious or medical waste other than sharps.

The Collection Event is subject to cancellation during inclement weather or for other hazardous conditions as determined by the county.

# OUTSIDE IDYLLWILD

## Tidbits ...

The Pacific Crest Trail (PCT) hiking season is now, like the local wildflowers, in full bloom. The hikers are everywhere you look, shopping in the market, collecting mail at the post office, using the computers in the library and walking up and down all the streets in town.

It is very easy to engage them in conversation; just ask where they are from and if this is their first time on the PCT. Most of the hikers are happy to share this information and I have had some pleasant conversations this past week.

Although it is still rare to see young children out on the trail, the hikers seem to come from all age groups between the late teens and up to 70s and even 80s in a few cases. It is always encouraging to see the older hikers out on the trail, including Idyllwild's own Special K, who not only is hiking this year but always takes the time to be a trail angel.

Speaking of trail angels, I got a good laugh out of Yogi at the PCT kickoff when I told her that Les and I were trail devils. I told her we try to exploit, take advantage of and use hikers for profit. The reason it is so funny is that most hikers have nothing to exploit other than a good story for the Town Crier.

The PCT is not the only local trail for hikers. A couple of weeks ago, I hiked the Ernie Maxwell Scenic Trail. Much to my surprise, I saw five mountain bikes chained to the trailhead sign on the Tahquitz View side of the trail. Right next to that was a sign that had a bike with the international symbol for "No."

Last week, I hiked the Deer Springs Trail to Suicide Rock, which I had yet to complete this year. It was a very beautiful spring day, warm, but not too hot. There were still six streams running across the trail and I was surprised that Marion Creek had nicely flowing creeks on either side. I don't remember if I have ever seen the two smaller creeks before.

I met a couple from Philadelphia who now live in Ventura County. This was their first trip to Idyllwild and they had hiked Devil's Slide Trail on Saturday and then Deer Springs Trail on Sunday. They really liked everything about the town of Idyllwild and were happy to have discovered our mountain village. I told them there is no place like 92549.

Finally, the wet year we are having seems to have made an explosion of not only wildflowers but of all living creatures as I have been seeing lots of rabbits, quail and baby squirrels.

When I went outside yesterday, I saw about a dozen squirrels all running along a PVC pipe fence rail and

chasing each other up into the trees. I went back inside and got my video camera as they put on an exhibition of baby squirrel gymnastics or, as I like to call it, squirrel practice. I filmed them leaping from tree branch to tree branch and then all playing follow the leader across my roof and into the tree directly above my head. One by one they all jumped back onto the roof, which created a pleasant plopping sound as they landed.



Golden eardrops (*Dicentra chrysantha*) is a gray perennial, 2-foot-tall with 4-foot spikes of yellow, aromatic flowers that appear in early May and often continue into July. It is one of the species in the "bleeding-heart" genus of plants. It is cold tolerant to 5 degrees Fahrenheit or less. Unfortunately, deer browse this native plant. The seeds usually do not germinate unless desiccated or seared by fire. The Kawaiisu Indians applied dried, mashed roots of *Dicentra chrysantha* to the chest for heart pains.

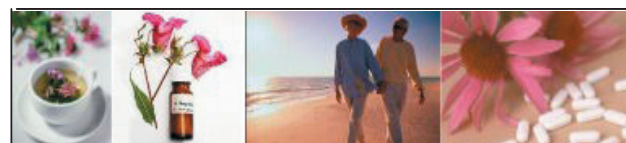

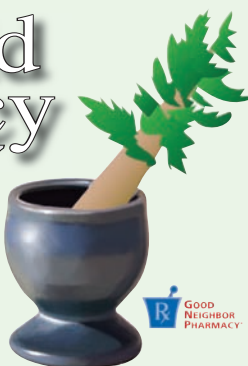

## Wildfire Awareness week ends, preparation continues

At a press conference to highlight Wildfire Awareness Week, CAL FIRE Director Ken Pimlott advised Southern California residents to take precautions in the advent of local wildfires.

"As we moved from Northern to Southern California, we could see signs of how fast the conditions were turning dry," he said. "You must not become complacent." More than 5,000 wildfires occur in California annually.

Pimlott stressed the importance of defensible space

and the "Ready, Set, Go" policy, which was discussed and featured at the Mountain Communities Fire Safe Council community meeting only days before the CAL FIRE event.

Despite uncertainties about the eventual state budget, Pimlott said he was confident CAL FIRE would have the resources to defend against wildfires this year. He stressed he has had meetings with the governor's office and explained that fire season is year-round and not limited to summer and early fall.

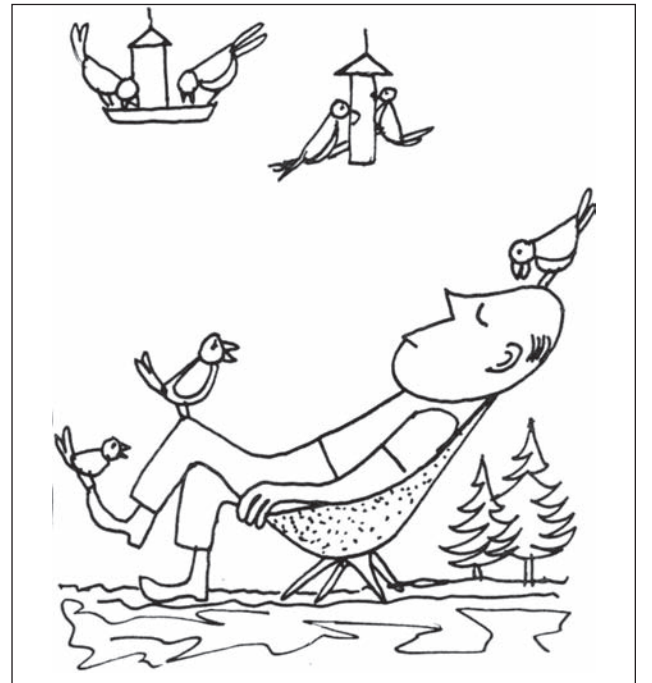

## OFF THE MAIN ROADS

### While hiking, be aware of and prepared for rattlesnakes ...

With spring in full swing, it is time again to explore our local hiking trails. However, the potential threat of rattlesnakes might concern those who are interested in this activity.

"Watch where you sit and where you step," said Department of Fish and Game Lt. Dan Sforza. Snakes are particularly active during spring when they come out of hibernation and warm themselves in the sun, Sforza warned. When aggravated, rattlesnakes give a nasty, venomous bite.

The breed of rattlesnake that inhabits our local trails and mountains is the *Crotalus oreganus helleri* — Southern Pacific Rattlesnake. This snake is primarily nocturnal and active during periods of excessive daytime heat. Even moderate temperatures can bring this snake out. So, this makes it active for most of the time on our trails.

When alarmed, a rattlesnake shakes its tail back and forth. The movement rubs the rattle segments together producing a buzzing sound, which serves as a warning. Juveniles are born with only a silent button at the end of the tail and are less likely to be heard.

Contrary to popular belief, rattlesnakes do not deliberately stalk human beings — their natural diet consists of rats, mice, gophers, small birds, frogs, and even the occasional



meaty insect. Nevertheless, people still get bit. This is mostly due to their own fault.

To avoid being bitten, first, know your snake. Rattlesnakes like summer evenings the best, just as the sun is going down and when it has gone. They are most active during the summer nights. This just happens to coincide with the frailty of human eyesight kicking in as the sun goes down, so take care.

Use a flashlight when walking about and wear good footwear. Rattlesnakes like warm days, period. Be it any season of the year, even winter, a rattlesnake can venture out in search of the warmth. Suitable air temperature for rattlesnakes is between 70 and 90 degrees Fahrenheit (or 21 to 32 degrees Celsius).

Most rattlesnakes are not generally sitting about in the open. If they are in the open, they are usually moving through it to cover or protection. Rattlesnakes want to avoid contact with predators who can easily spot them in the open, including humans and large animals.

Therefore, you will most likely encounter rattlesnakes around rocks, shrub and brush, or wherever there are nooks for them to hide. So again, "Watch where you sit and where you step."

I am often surprised at how little parents and educators in general actually understand what and who drive the education agenda. Let me give you some examples:

In the 1990s there was an explosion in innovative teaching. Educators were only beginning to acknowledge that teaching needed to be tailored to the student because of their different and often unique abilities.

There was an interest in what is still called "learning styles" or is also known as individual "intelligences." It was during this time also that educators began to realize that students needed a variety of resources instead of relying on only one textbook per subject or grade.

This more complex approach to teaching required real expertise and created a problem because many teachers often did not have that. Those of you who recall whole language probably saw either great results or a real mess. The results depended on the depth of training of the teacher. Teachers doing their own version of "whole language" was often a disaster.

These differences were worrisome and it looked as though teachers were largely experimenting, often leaving them unable



to justify what they were doing. Suddenly, there was the beginning cry for a more direct, controllable approach to instruction, largely because students were not competitive on international math and science exams.

Beginning with the year 2001, the Bush administration, supported by many Democrats, joined with the business community and particularly publishing companies to formulate policies that in much of the U.S. led to the following:

- One prescribed textbook per grade and subject;
- A teacher's guide for textbooks or subjects, often telling teachers where to stand, how to point, and what to say ("Saxon Math"). Other programs were more intelligently scripted ("Reading Recovery") but teachers noticed that they were often forced to move on whether kids were ready or not, largely ignoring individual differences and needs of students.

In fact, the publishing companies acquired immense influence over education because their products led to scripted teaching and they created mandated tests largely tied to their teaching guides. (See "The 500 pound Gorilla," <http://www.alfiekohn.org/teaching/500pound.htm>). This entire effort became

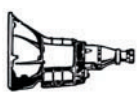

ire, since it requires a one-time payment of either \$270 or \$135 and monthly add-ons of \$14 or \$20, depending on the size of the original payment. The CPUC has not yet ruled on the proposal. Customers are still required to have the meters installed.

The opt-out only disconnects the microwave transmission method. In addition, PG&E is suggesting that, should a customer move, they will have to pay again to have the microwave transmission recon-

nected.

Ken Devore, Southern California Edison's SmartMeter project chief, said that SCE is under no duty at this time to provide an opt-out provision. With respect to its SmartMeters, Devore said ITron is the manufacturer and that it has received relatively few complaints to date about its SmartMeter rollout.

"Our meters do not have [that LG manufacturer] defect," said Devore. "We've only had one other press inquiry, after the news of the PG&E recall."

requirements specifically mention "parks and playgrounds" as falling within the CUP extended permitting process which includes an eventual public hearing to be held before the Planning Commission. "The Planning Commission has the final say," he said.

"This was a hard call to make," said Neal, "given that the group (ICRC) are all volunteers, but the zoning requirements leave no choice. I know they were disappointed."

Third District Supervisor Jeff Stone had set up a special meeting with ICRC representatives and Neal to see if the approval process could be expedited, but, as Neal explained, the zoning requirements were clear and left no wiggle room. Olivia Barnes, a member of Stone's staff, confirmed Stone's sympathy with the project and intervention with Planning. "Once Greg Neal looked at the CUP, he had no choice," she said. "What ICRC submitted in March was a site plan with a request for staff to review.

It was not the formal application that the specific zoning [for the playground parcel] required." Neal said that the planner with whom ICRC had been working has been out sick for the last four weeks and, as a result, Neal could not comment on why that planner had not pointed out the zoning discrepancy in March.

Simpson said that ICRC has begun the process of seeking the CUP and that a formal application would be submitted in June, with the application process expected to take four to six months. That would delay the playground construction, assuming all approvals are obtained in a timely manner, until early fall.

At this point, there was no mention of the future of the Community Center intended for the site as part of the land donor's requirements. Neal said, however, that if ICRC intends to build a community center, it will have to repeat the CUP process for each modular component unless one master plan for the site were approved.

## IDYLLWILD WATER DISTRICT MAY 2011 NEWSLETTER

### *IWD Mission Statement -*

*To provide reliable water & sewer service in a safe, cost-effective & environmentally sound manner in accordance with the community needs.*

**\$75,000 GRANT FUNDS** — The District has been working through each phase of the State's Recycling Water program. Last month, IWD received an official letter of approval for our State Water Resources Control Board (SWRCB) application for \$75,000 in grant funding. These approved funds will be used to cover 50% of the facility planning phase. Last month, we submitted a revised Facility Planning Report that addressed all the comments from the SWRCB's Division of Financial Assistance. We are waiting for the State's approval so we can proceed to the next Construction Grant Funds phase. We will submit an application to build the proposed Recycled Water Treatment Plant. Based on receiving a letter of approval for the funding, the board will consider constructing the Recycled Water Treatment project.

**CONGRATULATIONS NICK!** — Nick Iliev has received a letter from the California Department of Public Health that he passed his exam to receive a Grade II Water Distribution Operator Certificate. IWD's water system is rated as a Class II system that requires a Grade II Water Operator to oversee the system. The District is fortunate to have qualified certified water distribution and treatment operators for our water system. Staff who attend classes along with additional hands-on experience provides us with proficient operators. Nick has acquired the needed work experience under his Grade I Wastewater Treatment Operator guidelines. Last month, he applied for his Grade II Wastewater Treatment Operator certificate. Our wastewater plant is rated as a Class II system. The District will recognize Nick at our May board meeting.

**NEW MAINTENANCE TECHNICIAN I** — The District received more than 30 applications for this vacant position. After several interviews, Bill Rojas was selected. He began work on April 25th. Bill has completed six water/wastewater classes. He is scheduled to take his Grade II Water Treatment Operator exam this month and is scheduled to take his Grade II Water Distribution Operator exam this September. Bill grew up in Idyllwild and he and his wife are looking forward to moving back.

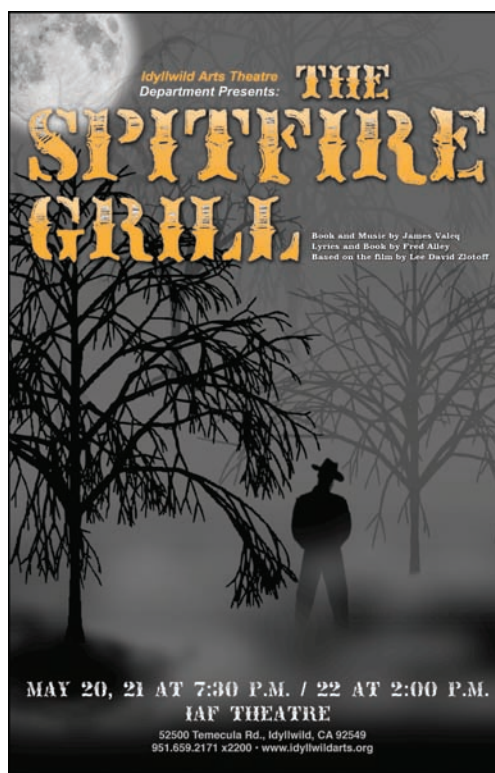

# Casey discusses Idol experiences

*Editor's note: Idyllwild's Casey Abrams gave an exclusive interview to the Town Crier, arranged through Fox Television, on Friday, May 6.*

American Idol top six finalist Casey Abrams came home to Idyllwild after his April 28 elimination. At an all school meeting at Idyllwild Arts (AI) on Friday May 6, Abrams, dressed in his trademark casual scruff, talked about his AI run with candor, humor and humility, and showed no trace of being impressed with his present celebrity status.

This article combines Abrams' answers both to Town Crier questions and to ones raised at the Idyllwild Arts school meeting:

You're primarily a jazz instrumental musician and Idol is a pop singing show. What made you decide to audition?

"I watched Adam Lambert and Crystal Bowersox shake up the show with different genres and approaches. And that was good. I thought if they could do it so could I. The audition process was rough — four auditions in front of producers before you even got to meet the [AI]

judges. It's rougher than you think."

Jazz is improvisational. I had heard that you didn't like to over-rehearse your AI tunes. If so, why? How did you prepare before the telecast?

"I'd rehearse my tunes a couple of times. I liked to mix it up [on the show]. Some of the others [James and Scotty] rehearsed and rehearsed. For the show telecast, I really didn't do anything [to prepare]. That's my jazz background. I'd go into the bathroom [before the show], sing a couple notes to make sure I had them, then go out for the performance. I wanted to keep it fresh. In

performance I did improvise moments, especially in "I Put A Spell On You," [during the final performance]."

How did being an instrumental musician help you in your AI singing performances?

"As a singer, if you're also going to be a good musician, you have to know where the notes are [in the chord structure]. Since I did, that helped me. Being a musician also helped me have a connection with the band on [the AI] stage."

How much time did you have to prepare for each show?

"Not a lot. It was horrible, but I hear that real life is probably worse. We chose our tunes at a Friday rehearsal. Saturday we recorded them. Sunday we did interviews. Monday we rehearsed the group [or duet] performances. Tuesday we did an onstage rehearsal with cameras and Wednesday we had a dress rehearsal before the show."

How much of your own arranging did you do on the tunes you sang?

"Initially they [coaches and producers] discouraged me from doing it [my own arranging]. But I held out for how I wanted to do the tunes. On some, like [Elton John's] "Your Song" it was pretty straight ahead, very simple. But on others, "Nature Boy," "Harder to Breathe," and "I Put A Spell On You," that was completely me — weird chord changes, different."

What was your most exciting moment on the show?

"Singing 'Moanin' with Haley [Reinhart]."

What was the biggest challenge during your Idol run?

"Struggling between being an artist and being what voters wanted me to do. But I stuck to my guns figuring that if I

got kicked off, I've gone out with integrity."

What was it like being part of the top 11? You seemed like a family.

"Yeah, it definitely was so. We just liked being together. That seemed more important than the competition. Everybody was talented."

Idyllwild came together in a big way to support you during the competition. Did you have any idea of the level of support at home?

"I had no idea of the support. So, I want to say thanks for being there for me. I would

have done the same for someone from my hometown."

What's next after the [AI] national tour?

"I want to try acting. I saw what Jennifer Hudson did with that. Maybe that. We'll be talking with some people [in the industry]."

Finally, what are your values as a musician and a performer?

"First, never take yourself too seriously. But always take the music seriously."

# New resident brings authors series

Some new Idyllwild residents bring their dogs, cats, furniture, and their city predilections and expectations to this deceptively somnambulant mountain hamlet. Eduardo Santiago brought an authors series, with an elevated objective — to save, or at least enliven, a local independent bookstore.

"A town without a bookstore is a town without a soul," said Santiago, a published writer, a Cuban immigrant and a man who believes that the written word is what civilizes us, gives us meaning and knits us together as a literate, informed and thinking people.

With no money or independent support, Santiago enrolled an impressive cadre of eight edgy and provocative authors to import the vital independent Los Angeles literary scene to Idyllwild at B's Mountain of Books beginning Sunday, May 15. The series

will feature eight published authors on select Sundays, May through July. Author David Francis, whose book "Stray Dog Winter" has earned broad-based critical accolades, opens the series.

Australian by birth, cosmopolitan by choice, Francis will discuss "Stray Dog," his novel of intrigue, sexual innuendo, politics and espionage that traverses a landscape from Australia in the 60s to the Soviet Union in the 80s. Francis infuses "Stray Dog" with sharp literary and political intelligence to craft an engrossing and darkly fascinating love story.

echoes all the best attributes of Graham Greene's classic novel 'The Third Man' — the brooding atmosphere, the unrelenting sense of wariness that abounds in the curious protagonist, and the romance that brews against the backdrop of the Cold War."

Santiago, who convinced the A-list authors to come to Idyllwild, has an impressive backstory himself. Santiago and his family emigrated from Cuba by way of Spain on Christmas Eve when he was 9 years old. "I fell in love with reading when I

was [age] 7, suffering from hepatitis," he remembered. "I read 'Tom Sawyer' in Spanish. I idolized writers."

The trajectory of his first published novel, "Tomorrow They Will Kiss," was, said Santiago, "miraculous." "Once, every two weeks I send out a short story to 20 literary agents," said Santiago. "I got an e-mail from Little Brown and Company [the eventual publishers of 'Tomorrow'] asking if I had a novel. I thought it was friends playing a joke. It wasn't. Two or three months later I had a contract. A year later it was published."

As a struggling writer, Santiago understood the importance of independent bookstores in promoting the work of new authors. "My model is the Skylight

Bookstore in Los Feliz [Los Angeles]," he said. "Almost daily there were appearances by authors. I was introduced to the major writers coming into Los Angeles."

"As a writer, when you come into a new place, the first thing you look for is a bookstore," he said. "I wanted to help B's Mountain to succeed as Idyllwild's independent bookstore. That's the reason for the series. And, I have a profound affection for Idyllwild and how it makes me feel up here — peacefully energetic."

## COUNTY CORNER

### E.R.A.C.E.

Last month, 3rd District Supervisor Jeff Stone requested Board of Supervisors concurrence to have county counsel prepare an ordinance that would limit registered sexual offenders' access to Riverside County property where children may congregate.

In his proposal, Stone would limit access to all county parks, recreation centers, aquatic centers and other facilities where children may be present. This would include all county-sponsored public events on county property, such as the Date Festival and the Temecula Balloon and Wine Festival.

In addition, the proposal would prohibit any dwelling housing a registered sexual offender from participating in Halloween or any other holiday, which might attract children to the residence.

Stone has named his proposed ordinance Eliminate Registrant Attendance at County Entities or E.R.A.C.E. The proposed ordinance should be ready for Board consideration in the next 30 to 45 days, according to Stone, who said an Orange County ordinance was the idea's inspiration.

### IFPD and county fire agreements

The Board of Supervisors was asked to approve a Cooperative Agreement with the Riverside County Fire

Department (RCFD) to provide dispatch and communication services to the Idyllwild Fire Protection District (IFPD).

IFPD will reimburse the county based on the number of calls. The first-year cost of the agreement will be about \$40,000. However, RCFD has agreed to credit IFPD with \$10,000 for the use of its FCC licensed radio frequency. For the first year, the parties estimate the number of dispatch calls will be about 325. The initial term of the agreement is for three years, beginning July 1, 2010.

In addition, RCFD and IFPD signed an agreement for the county to provide IFPD with mobile data computers to be installed in its vehicles. IFPD will pay for hardware, software, licensing installation and maintenance of equipment. This 3-year agreement assumes an annual connectivity fee of \$725.

### Hazardous fire areas

With the arrival of spring and onset of warmer and eventually hot temperatures, the RCFD is proposing to close several hazardous fire areas. These areas will be closed to the public except for public roadways and inhabited areas.

These areas were chosen because of the hazard of potential dangerous fires due to the availability of substantial fuels caused by winter's precipitation.

The request to the Board of Supervisors identified seven specific areas: Avery Canyon (Gibbel Road east of State St.

# County budget still in the red

After the third quarter of the current fiscal year (ending June 30), county officials still anticipate a budget shortfall. But the estimate is \$24.8 million, \$3 million less than the mid-year estimate.

The Riverside County Sheriff's Department's projected deficit of \$10 million represents 40 percent of the total and the largest single agency loss. Additional budget deficits are \$5.6 million in social services, \$5.5 million in the District Attorney's office

and \$3.7 million in the fire department.

"The Board has shown true grit and determination to close the structural budget deficit. ... Had the Board not taken this action, our situation would be more dire," wrote County Executive Officer Bill Luna. "It is crucial, therefore, to continue this budget discipline and not rely on additional use of reserves to extend the deficit."

Luna did report that building permit volume was 1 percent higher during the first eight months of fiscal 2011 compared to a year ago. In

addition, the auditor-controller is projecting property tax receipts would be about \$269 million, or \$5.3 million more

### Public hearing on health cuts

On May 16, proposals to cut health care will be heard before the Board of Supervisors. Notices describing the cuts and announcing the public hearing were posted on May 2 at the affected county public health facilities.

Based on county projections, the proposed cuts would reduce funding to the California Children's Services (CCS) Program and deny new applications for service to 436 children who do not qualify for Medi-Cal or Healthy Families. The cuts will also cause the fund that pays medical providers to be exhausted before the fiscal year ends on June 30, 2012. Payment could be delayed until the following fiscal year.

in Hemet); North Mountain and Indian Canyon (San Jacinto); Whitewater Canyon (Cabazon and N. Palm Springs); Nuevo/Lakeview (East of Menifee Road and San Jacinto Ave.); Minto (Sage); Reinhardt Canyon (north of Highway 74 and California Ave. in Hemet); Ramona Bowl and Bautista Canyon (Southeast of Hemet).

### State and federal redistricting

At its May 3 meeting, the Board of Supervisors passed a resolution asking the state commission responsible for redrawing boundaries for the state Senate, state Assembly and federal Congressional districts to consider Riverside County as a single jurisdiction in order to eliminate district overlaps into other counties. Many of the current seats overlap with populations in San Diego and San Bernardino counties.

"Fractionalizing Riverside County would diminish local

agencies' effectiveness in seeking coordinated assistance from legislators; in protecting access to communication relevant to the election process for, in many instances, a poor minority population; and in addressing health, transportation, education and safety issues that affect the quality of life for every resident," declared the Board's resolution.

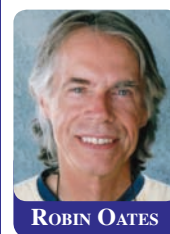

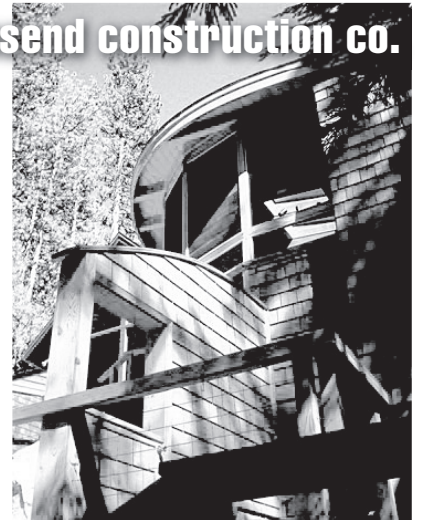

You can also protect yourself with proper clothing. The majority of bites occur on the hands, feet and ankles. So, apart from not sticking your hands where they shouldn't be, clothing becomes important protection.

The key protection is to wear long, loose-fitting pants, thick hiking boots, and decent socks or gaiters if possible, especially if you choose not to wear long pants. Now you have some good insight on how to avoid getting bit.

But if you do get bitten, what should you do? Look for symptoms. If the area of the bite begins to swell and change color, the snake was probably poisonous. Keep the bitten area still. You can immobilize the area with an improvised splint made from a stick or other stiff material tied to the limb. Don't tie it too tight — you don't want to reduce blood flow. Do not cut open the wound and try to suck out the venom. Remove any jewelry or constricting items near the affected area in case of swelling. Keep the area of the snake bite lower than the heart. Go to a hospital immediately. If you cannot get to a hospital on your own, call 9-1-1 and a Riverside Mountain Rescue Unit will be dispatched.

the foundation of what is now known as "No Child Left Behind."

Now, almost 10 years later, it has had several devastating results. Teaching has largely been reduced to prescriptive direct instruction, resulting for the first time in recent history, as Newsweek reports, the decline of creativity in the U.S. We may not have done so well on international exams but our creativity and initiative were the envy of many nations.

Secondly, learning has been reduced to memorization of facts and basic skills at the cost of ignoring thinking, problem solving, creating, planning, working well with others (social skills), developing independent initiative and following through on goals.

Finally, "No Child Left Behind" focuses almost entirely on math, reading and writing. Other subjects, such as civics, history, science and art, are largely ignored. These did not receive federal funding and were, therefore, left behind.

So, where does that leave education in the U.S.? We have another mess. Because research on how students learn has been ignored, learning tied to a script bores many of our kids. For that and other reasons, they spend more than 50 hours a week on often violent video games, television, social networking online and making unsupervised Web searches.

Is there hope? Oddly enough, this entire scenario could develop into a fantastic age for education. The focus has to change from too much testing to educating teachers to teach for powerful learning. They have a lot of catching up to do in order to bring their teaching into this century. They need to provide a more project-based type of teaching that allows students to choose how to study a subject based on their own interests, and then to conduct research by going to all kinds of experts in school, in the community, online and on the Web.

In this way we genuinely provide the education that prepares students for the real world they already inhabit.

County Supervisors approved \$3,000 to drill a well in the campground at Idyllwild County Park. The park was operating on a dry basis with campers required to bring their own water.

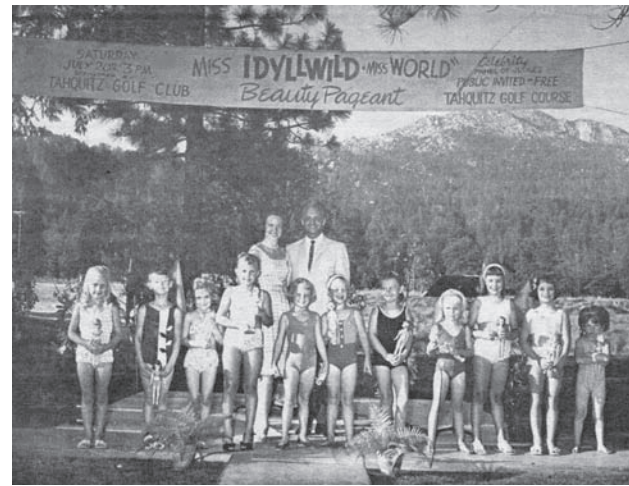
### 40 years ago - 1971

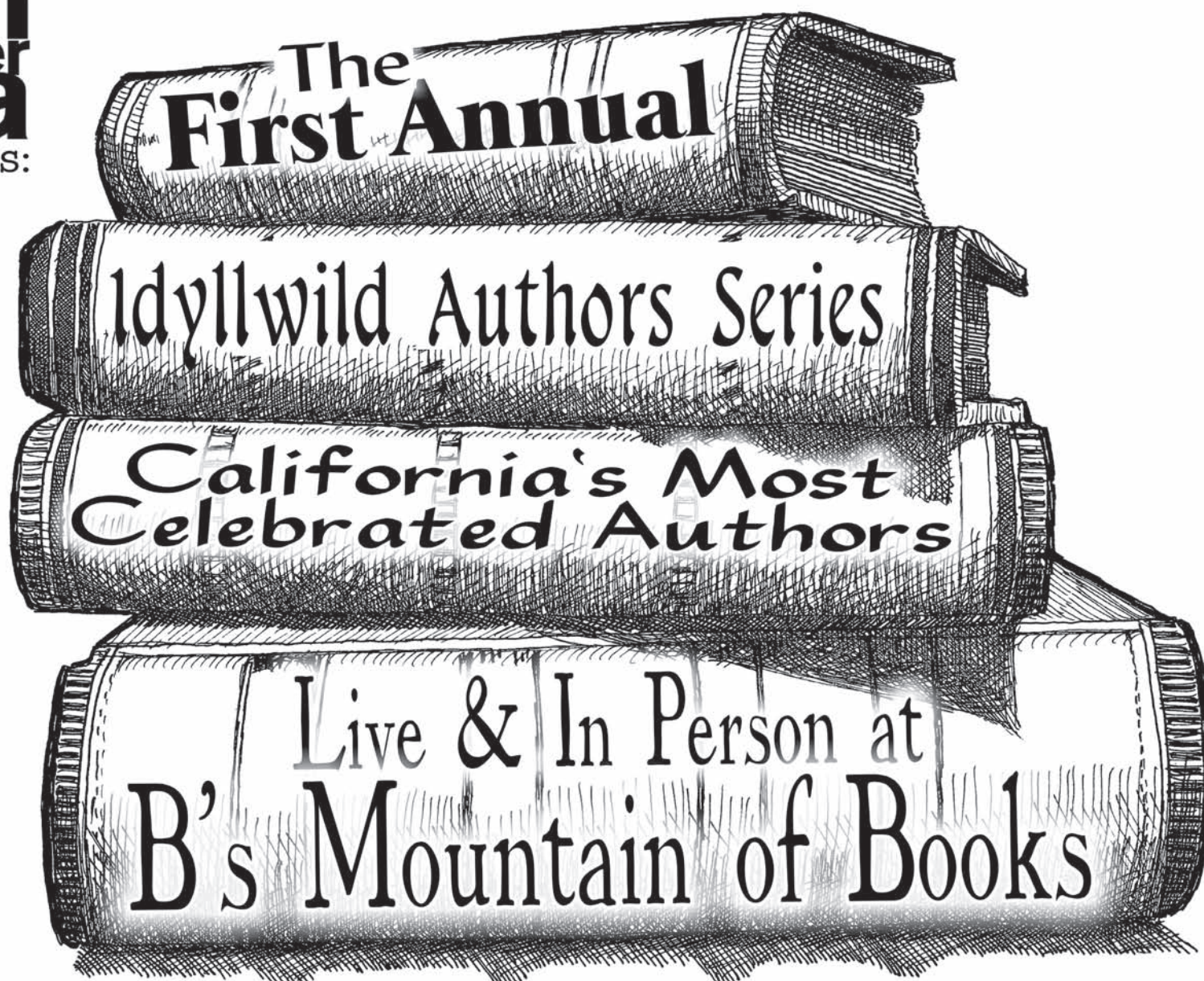
