IFPD commissioner suggests Pine Cove join fire board

At the June 20 special meeting of the County Service Area 38 Advisory Committee meeting, Idyllwild Fire Commissioner Dr. Charles "Chip" Schelly addressed the committee and the community lamenting the lack of agreement, comity and teamwork between Pine Cove and the Idyllwild Fire Department.

He suggested investigating ways in which Pine Cove

residents might have some formal recognition on the IFPD commission.

The next CSA 38 Advisory Committee meeting is 5:30 p.m. Wednesday, July 11. Schelly plans to attend and speak further on this subject.

"I want to ask the committee or audience about how to strengthen the relationship that already exists between Pine Cove and Idyllwild," Schelly said. "I'd like to find a way where some of the community

Commercial recycling in force; implementation unclear

Assembly Bill 341, which the California Legislature passed and Gov. Jerry Brown signed in October 2011, requires any business, multifamily residential dwelling of five or more units, industrial facility, and school or special district that generates more than four cubic yards of solid waste per week to recycle. Although the law's regulations and requirements took effect on July 1, 2012, the practical mechanics of implemen-

tation and enforcement remain unclear or as yet unspecified.

The law leaves specifics of implementation and enforcement to covered jurisdictions, in the case of the Hill, to the county. The law makes a "legislative declaration" regarding the state's goals to require these local jurisdictions "to develop an integrated waste management plan ... including source reduction, recycling and composting components." The state Department of Resources Recycling and Recovery is required to

Injured climber rescued from Tahquitz Rock

A climber was rescued from Tahquitz Rock in Idyllwild after sustaining an injury to an extremity, according to Jody Hagemann, Riverside County Fire Department spokesperson. The injured female was extracted from the area by a helicopter hoist and transported by ground ambulance to an area hospital in stable condition, according to Hagemann.

Riverside Mountain Rescue Unit local volunteers Les Walker and Ralph Hoetger were called out but ultimately did not assist in the rescue. Walker recounted that the climber's partner was belaying her down the rock face but had given her too much slack. As a result, when she slipped she fell about 10 feet onto a ledge breaking or badly injuring her ankle. Other climbers were able to carry her up to the top where CALFIRE's helicopter was able to hoist and extract her.

RMRU completes two rescues on holiday

The Riverside Mountain Rescue Unit completed two rescues over the Fourth of July holiday. Long accustomed to interruption of holiday celebrations, the RMRU team began one mission around 9 p.m. Tuesday, July 3. Two hikers from the San Francisco area had left the Palm Springs Aerial Tramway mountaintop station at 2:15 p.m. for a day hike to Long Valley and had gotten badly off trail in the Saddle Junction area. Christopher Wimmer, 36, and Victoria Oliver, 29, used a cell phone to call authorities.

Five local RMRU members, Lee Arnson, Helene Lohr, Ralph Hoetger, Les Walker and Donny Goetz were part of the team called out at 9 p.m. They reached the hikers at 12:30 a.m. several miles from the tram station.

"They were freezing," Arnson said, "cold and miserable. We outfitted them and hiked them down to Humber Park, arriving around 3 a.m. Both hikers were uninjured and in good spirits. The pair was later transported back to Palm Springs.

"We were lined up for the [Idyllwild Fourth of July] parade by 9 a.m.," said

OUTSIDE IDYLLWILD

Wildflower odyssey ...

The wildflower season is winding down and only the stream orchid and the lemon lily remain on my most wanted list. After returning to some of the same sites that I visited in early spring, I am finding new species to add to my photo collection. I now plan to organize the photos I have by families, then develop a "hit list" for next season.

After four visits to the Hub, west of Idyllwild Arts, I have finally found the royal rein orchids (*Piperia transversa*) in full bloom. There were well over a dozen flower stalks that can easily be seen from the bike path or trail. The flowers are very small and they would be easy to overlook. I thank Norm Johnson once again for pointing them out.

On the Fourth of July, I went out Saunders Meadow Road to photograph the beautiful clouds that had moved into Southern California. The unexpected sprinkles in the early morning of July 4 were really welcome and made the weather very pleasant for the parade. While shooting clouds I noticed a profusion of pink and creamy white flowers, a few scattered brilliant blue blossoms and a tall plant with star-shaped light purple flowers.

The white flowers turned out to be California buckwheat (*Eriogonum fasciculatum*) which is extremely abundant this time of year. It can be seen growing close to the road on Highway 243 between Idyllwild and Mountain Center. The small pink and white flowers grow in clusters on stalks above the foliage. From a distance, the flowers appear dirty white in color and are a very strong attractant to honey bees.

The low growing blue flowers are woolly Eriastrum (*Eriastrum densifolium*). This phlox family member also has flowers in clusters and with their blue color they really stand out and cannot be mistaken for any other species.

I have yet to identify the third species I saw that day but it may have been a color variety of fireweed. The star-shaped flowers are well spaced on stalks up to 2 feet long and are a pink to light purple in color. I will keep searching for more information on this plant.

Another wildflower on my hit list was the Humboldt lily (*Lilium humboldtii*). I have to admit I never actually thought I would see one growing in the wild in our mountains. So I was pretty amazed when I was driving in Fern Valley when I saw several plants growing in someone's front yard. One particularly tall plant was growing right on the road side and I was not going to miss a chance to get a photo of this impressive species.

Everything about the Humboldt lily looks like an alien life form. From 8-foot tall stems to the odd foliage which grows around the stem in whorls to the orange-yellow flowers with dark red blotches and large hanging stamens this plant is one of the most impressive I have ever seen.

Even though it is a California endemic, this is not technically a wildflower; since it is obviously being cultivated in someone's yard, it is still an incredibly beautiful plant. This concludes my coverage of wildflowers for this year. I have learned a lot about our local flora and have enjoyed the hunt for rare and beautiful wildflowers.

Dick Goldberg honored for a lifetime of service

Local resident Dr. Richard Goldberg received a Lifetime Achievement Award from the Los Angeles County USC Medical Center Department of Emergency Medicine at a ceremony at the Biltmore Hotel in downtown Los Angeles. The ceremony, held Sunday, July 1, recognized Goldberg's more than 40 years serving L.A. County USC Hospital. He was one of its first emergency medicine residents.

Then, as a clinical professor of emergency medicine, he taught future residents, and developed programs in this relatively new medical specialty.

Goldberg's teaching appointment was without salary. He served as a volunteer. "It's the way my values are set. I was happy to do it," he said. "It was part of being a physician and using my training to assist others."

Goldberg, modest in mien, does not like to talk about himself; rather, he serves. Whether it's as Moun-

tain Disaster Preparedness' Medical Officer, originator of the Idyllwild Community Recreation Council's long popular Speaker Series, as ICRC board member, as a relief team member following a 1976 earthquake in Guatemala, setting up a 1,000 bed shelter outside of New Orleans following Hurricane Katrina in 2005 or supervising emergency care in a hospital 30 miles from heavily damaged Port-au-Prince after Haiti's 2010 earthquake, he volunteers

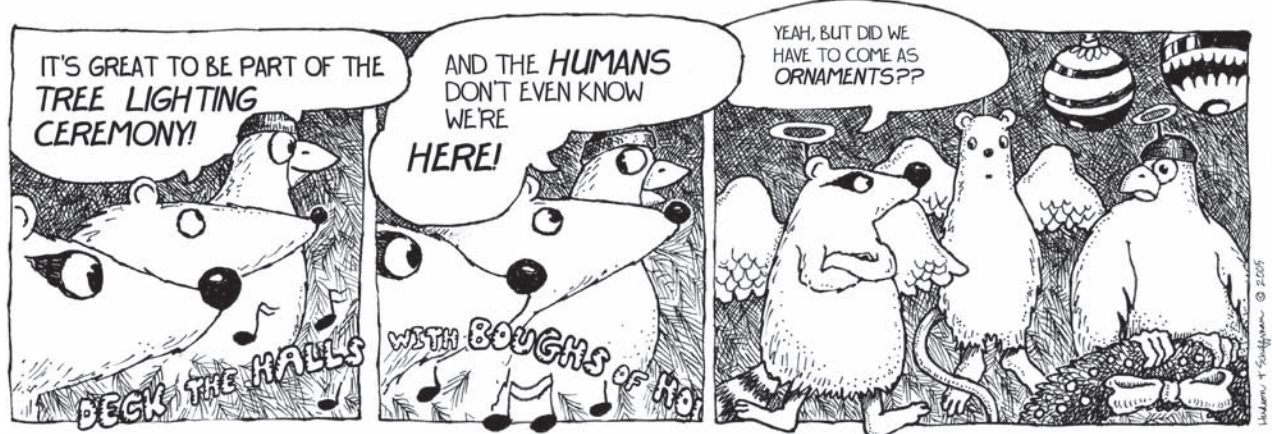
On Saturday, July 7, Idyllwild resident and Idyllwild Arts faculty member **Steve Hudson** unexpectedly passed away.

Wine ...

Growing up in Santa Clara Valley, San Jose, California, filled my childhood memories with visions of fruit orchards bursting with spring blossoms. Acres of mustard plants with raging yellow blooms were throughout my father's property. The Mount Hamilton range was on the east side of the valley, the Santa Cruz range was on the west. Both sides of the mountains were scattered with oaks and brilliant green in spring. My friends either lived on dairies, cattle ranches or family owned orchards.

My father, Anselmo was his name, was a gifted farmer. As a child I have memories of him teaching me how to graft fruit trees. I would carry the hot tar bucket, following him from tree to tree. Before he died, I asked him to tell me his secret for grafting.

He said it is an exact science. If you have a plum tree it is possible to graft peaches on the same tree. My dad had a tree with two varieties of plums, nectarines and peaches, all on the same tree, different branches.

If you email me, I will share with you how to graft; no guarantees it will work in Idyllwild.

Now let me talk about my dad's wine, but I do not have a recipe, sorry.

My father and his best friend, Manuel, would make wine every year. Manuel owned a vineyard up against the Mount Hamilton range — a beautiful area. Manuel's grape arbor was to die for, thick with grapes and lush, it was dark inside when walking through.

Dad and Manuel would sit in the old arbor and drink wine. Dad would slave labor my siblings and I out to cut grape bunches in the vineyard. In exchange, he was given a truck load of red grapes to make his wine.

I hated cutting grapes because the bees were all over the place. We did get to swim in Manuel's pool.

There are several vineyards in Santa Clara Valley. I think some of them are still there, Mirassou Vineyard, Cribari Vineyard, Almaden Winery, and of course my dad's wine which was only known to my family.



Dad only made rich red wine, did not like white wine but would drink anything in a pinch; you could say I am a chip off the old block. My son still has the old wine press dad used.

The recipe I am sharing with you is from the Los Angeles Times Food section. It was suggested to serve with martinis but I have served the tidbits with dry wine. They are yummy. They also have a tendency to dry your taste buds so you drink more. Pity.

Cheese beignets

52 small servings

5 tablespoons butter, cut into small pieces
1 tablespoon dry mustard
1 teaspoon kosher salt, or to taste
1/8 teaspoon cayenne
Freshly ground black pepper
1 generous cup flour
4 large eggs, at room temperature
1 cup grated Gruyere or Parmigiano-Reggiano (about 4 oz)
peanut oil for deep-frying

Combine the butter, mustard, salt, cayenne and pepper in a medium heavy saucepan over medium heat. Add 1 cup water and bring to a boil. Add flour all at once and beat quickly with a wooden spoon until the ingredients come together into a ball that pulls away from the sides of the pan.

Remove the pan from the heat and immediately beat in two of the eggs, beating until they are completely incorporated. Return to the heat briefly while continuing to beat, then remove from the heat and beat in the remaining two

eggs, beating until the dough is very smooth. Return to the heat and cook, stirring, for one to two minutes, until the dough is shiny and smooth. Cool slightly, then beat in the cheese.

Pour about three inches of oil into a deep fryer and heat to 375 degrees. Working in small batches, drop the dough by the rounded teaspoon into the hot oil. Fry, turning once, until each beignet is puffed and evenly browned on all sides, 3-1/2 to four minutes. Drain on paper towels before servings. Total time is about 1 hour.

Note: I use my electric wok to fry the beignets, the wok makes them perfect. Enjoy.

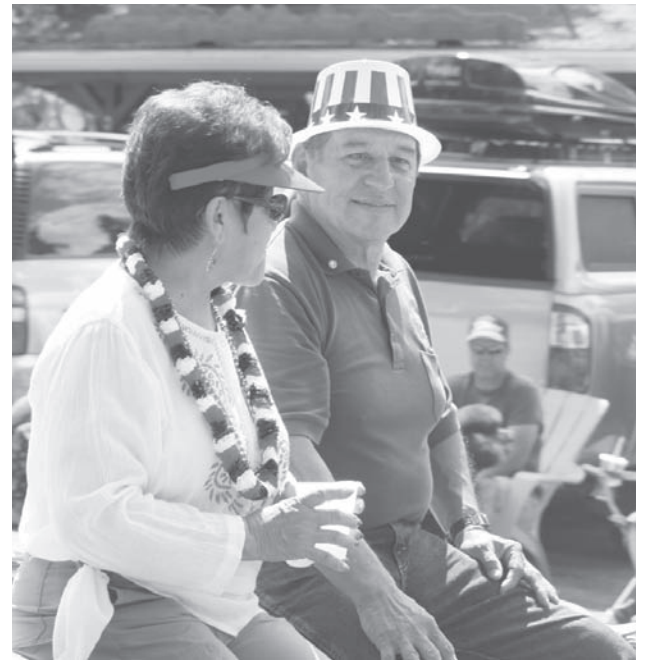

The dangers and miracles of technology

Technology appears to be everywhere. We connect socially using email, Facebook, Twitter (to name a few) in order to let others know what we are up to and most of all, send photos and alert them to YouTube videos or websites we want to share.

News is instant (even if it largely ignores depth of coverage), and many of us can conference using Skype, iPads and our phones.

We have information about almost anything at our fingertips and research has become a breeze using search engines like Google or Yahoo. In addition to information and photographs on particular topics, you can find maps of any place on earth, purchase games and videos related to your topic, attend an online course at minimum cost and do online shopping. And kids are growing up in this world of what (Geoffrey Caine and I) called "videotech" in our latest book.

If what I just wrote sounds unfamiliar to you, welcome to a new generation growing up all around you. All of this technology leads to freedoms most people over the age of 50 never experienced. And with it come cautions and some concerns.

To begin with, real understanding and deeper learning requires much more than either technology or education alone and separately can provide. And then there are some disturbing changes in the ways that students function in the world, particularly when they don't have wise adult and parental guidance.

So teachers are noticing decided differences in this generation. Students have a shorter attention span. They prefer to communicate using pictures rather than words, and spelling and writing have deteriorated.



Given the traditional model of directed or didactic teaching, many more appear to actually have learning difficulties. Research suggests that they are far less able to control their impulses.

"Flaming" is something students do when they think that they are unsupervised online and includes the worst examples of bad language and thoughtless comments (to put it mildly). We have all been witnesses to even adults creating YouTube videos doing something embarrassing and damaging to their careers.

Most frightening, from my point of view, is that higher order thinking and action such as setting goals and personal timelines, thinking reflectively, analyzing a situation, noticing critical details and so forth are going by the wayside in this fast paced and "instant answer" world.

Questions not asked enough are where are the parents in all this and is there anything parents and grandparents can do?

To make the situation clearer, here are some statistics about TV usage and its effect on our kids and society (I will get to other aspects of videotech, such as the impact of smartphones, in future columns).

In 2009 alone, Americans spent \$10.5 billion on videotech for their kids according to the Entertainment Software Association. Children's bedrooms have become multimedia centers with 71 percent of all 8- to 18-year-olds having a TV in their bedroom. According to a 2010 Kaiser Family Foundation report, 50 percent had a video player in their bedroom as well. And those with a TV in their room spent almost 90 minutes more in a typical day watching TV than those without a set in their room. Those kids watching more TV were also more likely to be obese and have lower grades.

By the time an American child is 18, he or she has spent more time in front of the TV than in school, talking with

teachers, interacting with peers or talking and interacting with parents. So who and what are really educating them? You can check this out for yourself.

A generation or two ago, when kids got together they would talk about what they actively did and experienced with others. With the possible exception of sports, notice how often kids now refer to TV programs with comments such as "just like on 'American Idol'" or by referring to some actor or program they watched.

What can parents and grandparents do? First, make bedrooms for sleeping. If at all possible, TVs and all electronics should be located elsewhere in the house.

Second, limit the time kids spend just watching TV.

Even more frightening statistics relate to the amount of violence to which our children are exposed. By the time the average child reaches elementary school, he or she has seen 8,000 murders and 100,000 acts of violence on TV.

Those with unrestricted access to a DVD player or VCR have even more exposure. The television and media industry keeps muddying the waters by contesting research showing long term increase in violent behaviors following too much exposure to film, video and TV violence.

The truth is that the harmful effects are moderated by how healthy the immediate relationships are in the home. Adults can do much to discuss issues that relate to violent content and we can never underestimate the sheer power of adult guidance.

Another small step for science: A leap for the rest of us

track jurisdictions’ compliance and provide annual documentation to the Legislature.

Nearly two weeks after the implementation date, neither Riverside County’s Waste Management Department nor Waste Management Inc., the designated trash hauler and transfer station operator in the Idyllwild area, have implementation plans in place, according to Janet Moreland, recycling specialist, county waste management and Eloisa Orozco, Waste Management, Inc. area communications manager.

Moreland said the county would authorize free disposal of commercial recyclables but cannot provide bins for separating recycled materials nor transport them to county transfer stations. “Our department is not in charge of hauling,” said Moreland, referring questions to contractor Waste Management.

“Within the next 30 days, customers will be receiving a letter about the law with information about their options to establish their recycling program. and serves and tries very hard to do it under the radar.

Goldberg, a Chicago native, completed medical school at the University of Illinois, Chicago, and was one of the first three residents in the USC Emergency Medical program.

“There was a realization that trauma injury was a major killer and that treatment should be spe-

cialized and appropriate,” said Goldberg. “Prior to that, emergency treatment could be administered by any available doctor at a particular hospital. People needed more sophisticated trauma treatment.” In 1968, the American College of Emergency Physicians was formed to develop this new field. It now has 28,000 members and was Goldberg at the forefront of its development, as teacher, research coordinator and practicing physician.

His wife Jan assisted with

at no cost to them,” Orozco said.

No county enforcement provisions or penalties for noncompliance are yet in place, according to Moreland. On Friday, July 6, county Waste Management Department suggested on its website that affected businesses should “take at least one of the following actions in order to reuse, recycle, compost or otherwise divert commercial solid waste from disposal: source separate recyclable and/or compostable material from solid waste and donate or self-haul the material to recycling facilities; subscribe to a recycling service with your waste hauler; property owners of commercial or multi-family complexes are required to provide recycling service to their tenants; [and] each business shall be responsible for ensuring and

demonstrating its compliance with the requirements of [AB 341].”

What the law requires for each jurisdiction, on or after July 1, 2012, is: “to implement an education, outreach and monitoring program [and] efforts may be phased in over time”; for covered businesses and multifamily dwellings of five or more units to recycle as of July 1; by August 2013, each jurisdiction shall report to the state its progress in achieving the Legislature’s goals and “enforcement efforts and exemptions, if applicable”; and by August 2014 the state will conduct its first review of all jurisdictions’ compliance efforts.

his research and actually co-authored papers with him in this growing specialty. “He was really invested in this facility [County USC],” said Jan. “He loved it. He was always available.”

Goldberg, again assisted by his wife Jan, founded “The Red Blanket Society,” and with an initial grant, helped fund books, teaching materials and conferences for County USC residents. “The residents make little income,” said Goldberg. “This was a way to assist

them.” The society, named after the practice of putting red blankets on critical cases that came into hospitals, continues to this day funded by alumnae contributions.

Of his career and the recent honor conferred on him, Goldberg said, “I’m fortunate. This hospital was my professional birthplace and it has one of the finest emergency medicine departments in the country.”

can work together toward solutions.”

The recent debates over the extension of the contract for ambulance service to Pine Cove from Idyllwild Fire was Schelly's example of the communities being at odds rather than unified. Without changes, he foresees a perpetual situation every three or four years where

Pine Cove and Idyllwild Fire are squabbling and the differences intensify.

In his view, placing a Pine Cove resident on the fire commission might help ameliorate the situation. Schelly didn't explain how that step might be achieved, but encouraged its discussion among the participants.

“There must be ways to work it,” he acknowledged.

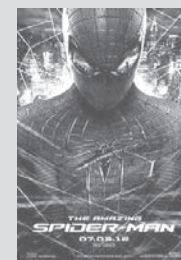

Lisa and Kats scorch summer series

Lisa Haley and her Zydekats, one of the most popular bands to play in Idyllwild, return to the Summer Concert Series on Thursday, July 19.

Returning are Gigi Rabe, on accordion and vocals and Andy Anders, bass and vocals.

Haley said "Joy Ride" moves more into fusion, incorporating world and Americana roots as musical influences. "By broadening our music into other genres we're getting more airplay as a result," she said, "and I think our fans are happy. It's easier for them to share

with friends. It's more eclectic and consequently more available."

Haley said that all music evolves and changes from generation to generation and Cajun zydeco is no exception, according to Haley, who said, "Each generation changes the music from what their parents enjoyed."

The question posed to Scott Fisher, board president of the Idyllwild Nature Center, was "What would be your goal for the Nature Center?"

His answer was surprising, "To become better known. Even with hosting the Lemon Lily Festival, less than half of the locals have ever visited us."

Accessible with miles of easy to moderate hiking trails and surrounded by views of the entire valley and mountains, this premier Nature Center has so much to offer the community. Part of the Riverside County Parks and Open Space District, it's open 9 a.m. to 4:30 p.m. Tuesday through Sunday and has programs throughout the year.

The Visitor Center has many resources including books and films on the Cahuilla Indians, history and nature. There are plenty of picnic tables to enjoy a lunch

in the sweet smelling Yellow Pine Forest.

A daily use fee is required: adults, \$3; children between 3 and 11, \$2; and dogs on leashes, \$1. For an annual membership fee of \$15 an individual can use the facilities all year. A whole family membership is \$30. These memberships provide free admission to all the Riverside County Parks.

Each summer children, ages 7 to 11, are given the opportunity to learn and explore nature through the Junior Naturalist Program. The cost is \$3 per child and is limited to 20 participants on a first-come basis. All programs are held on Saturdays from 10 a.m. to noon at the Nature Center.

On July 14, Nancy Savatera will lead "Project Bugs" that includes a bug scavenger hunt and making a bug observation box. There will be no Junior Naturalist Program on July 21, but the Lemon Lily Festival promises many kids' activities.

Priamos talks "Shyster's Daughter" at next author series

Editor's Note: Two authors are scheduled to speak at Eduardo Santiago's Idyllwild Authors Series the weekend of July 21 and 22. Paula Priamos will appear at 3 p.m. Saturday, July 21, at Café Aroma. The next day, Sunday, July 22, Amy Wallace, "The Sorcerer's Apprentice: My Life With Carlos Castaneda," will speak at 2 p.m. at the regular series venue, INK Book Gathering on North Circle Drive.

Paula Priamos, the next author for Eduardo Santiago's Idyllwild Authors Series, examines whether a shyster defense attorney, disbarred for embezzlement, can also be a good father. The father in this case is hers, and her memoir "The Shyster's Daughter" chronicles her father's peccadillos and unsavory professional practices and at the same time credits his attentiveness and firm hand in raising her.

According to her publisher, Priamos breaks new genre ground in what is now being called a detective memoir. Although the facts are laid out with accuracy, and that is important to Priamos, she gives the reader many opportunities to sort through the facts and arrive at their own conclusions.

"I leave it up to the reader to participate," said Priamos. "I use many quotes, contradictory pieces of information. The reader pieces together the information."

Priamos has been writing professionally for 10 years — essays, blogs, memoirs and an upcoming novel. But it was a quote from her father the night before he died, that launched the book she'll be discussing with Santiago. "I cheated death," he told her in a telephone call. A man in a ski mask had attempted to rob him. Her father flipped him off and managed to get away. And yet he died the next morning. "I wanted to investigate those hours from the phone call until his death," she said. "It haunted me."

Priamos said she struc-

tured her memoir to read like a novel using plot and dialogue. "It was a way of memorializing my father," she said.

The title she chose caused Priamos some difficulty, offending as it did the sensibilities of some. At a book party a female Jewish author objected that the word should only come out of Jewish mouths, not from a Greek about a Greek. "My father was a shyster," wrote Priamos in her blog. "He was a crooked lawyer who cheated his clients out of money. Everybody called him that word."

Yet, in the course of her work, what emerges is a portrait of a present and loving father who made time and room for his daughter.

With those seemingly conflicting elements, Priamos' book should prove a compelling read.

Priamos' appearance at Café Aroma is free to the public. Frank Ferro is supplying complimentary refreshments to attendees.

Steele seventh in French Open — again

For the second consecutive year, Brendan Steele scored a seventh-place tie in the Alstom Open de France — the French Open — on the Le Golf National course in Paris last week. The native Idyllwilder's four-under-par 70-70-71-69 — 280 total was two strokes better than he posted last year and earned 86,625 euros (about \$106,000), which will not count toward winnings on his PGA Tour record. His PGA Tour official winnings for this his sophomore year remain at \$613,045, but his European Tour winnings bring the year's overall total to more than \$719,000.

Steele played no round over par and was one of only 16 players to post a four-round sub-par score. He carded 20 birdies against 12 bogeys and two doubles. Again this year, Steele was the only American of three in the field to make the cut. Rich Beem and Shaun Micheel, both PGA Championship winners, were sent home early last week.

Credit card theft

EDITOR:

We had a great couple of days during the Fourth on Daffodil Hill. The "non-fireworks" were better than those in San Diego.

Big surprise this evening when my credit card called and advised me of probable fraudulent charges against my credit card.

The caller knew the charges that originated in Michigan were not in accord with my spending patterns and details of my account. I heard out the call and thanked the caller.

I then called my credit card provider and verified that my card had, indeed, been compromised.

Destroy old card, obtain new card within seven to 10 business days, letters of explanation, change credit card auto-pay and on and on.

I think that this case is similar to one several months ago in Idyllwild. While my credit card provider told me that my credit card account may have been hacked re-

cently, the theft and intrusion may have incurred a year ago.

Lesson-learned: Do not let your credit card out of sight and be sure that it is swiped only once. There

are gadgets that can record credit card numbers in bogus swipes. Let it not be yours. Never record your credit card number on a transaction from an incoming telephone call, and if you

can, avoid using your credit card number on a wireless, unsecured Wi-Fi call.

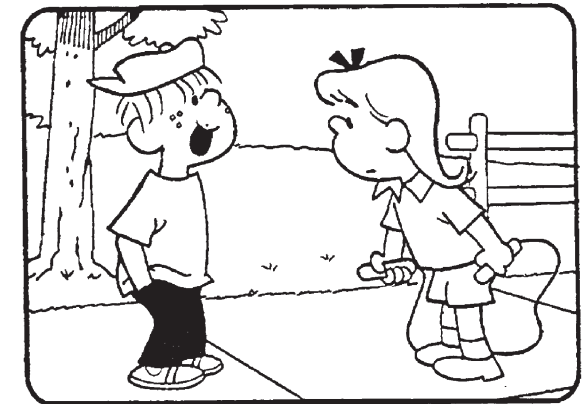
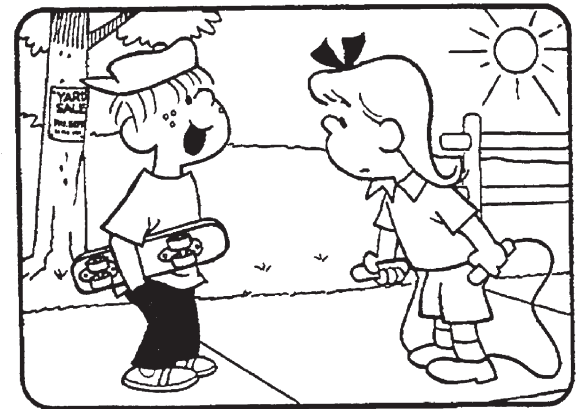

Affordable Care Act helps IFPD

EDITOR:

It's time to terminate the IFPD and CSA 38 special assessments.

Congress passed, the President signed and the U.S. Su-

preme Court affirmed that each resident of the country, legal or not, must have health insurance. Wow!

It pays 100 percent of our paramedic and ambulance service — when up to this point only 36 percent of the users [of IFPD's service] paid their medical bills.

Since \$1.2 million of IFPD'S \$1.6 million budget is for these services, it's time to stop having the property owners flip the bill for residents and visitors alike.

Wanna bet that salaries head north again and property owners not the users will be left holding the bag?

Those board members who claim to be about the Constitution will once again compromise their beliefs to keep their pet projects, not only fully funded, but make more excuses on how to spend this new windfall of tax dollars. Just listen to them squeal about how this new funding won't be enough again.

Wake up Idyllwild, now you're taxed for health care and the property owners are again taxed for your health care, not to mention being taxed for your fire protection three times: once through the ad valorem property taxes, again through the special district assessments, and finally through the newly adopted state fire assessment.

The official rate of inflation is around 2.5 percent but gross pay for those who provide these services flew off the charts, sometimes exceeding base pay by 100 percent. It's a state and federal sponsored employee rip off and redistribution of wealth, folks, with IFPD fanning the flames at the property tax payers expense.

Eliminate IFPD, and make the county, state, and feds who take our dollars and spend them elsewhere return those dollars to Idyllwild. So long as IFPD exists we will be taxed at three times the normal rate and receive services less than the standard rate.
