September rain reaches record levels

uring the past week, Idyllwild has seen near-record September rainfall. Since Sept. 1, nearly 2.8 inches of rain has been recorded at the Idyllwild Fire Station and 2.4 inches of rain recorded at the Keenwild Ranger Station in Mountain Center.

The 70-year average is .83 inches during September. The maximum is 8.3 inches, which fell in September 1976. During the past 70 years, the recorded rain at Idyllwild Fire Station exceeded 2.8 inches only four times. The year 1997 was the most recent, with 4.1 inches recorded.

Since July 1, the beginning of the rain year, nearly 3.6 inches have fallen at Keenwild and 3.1 inches in Idyllwild. The long-term average for the first three months of the rain year (from July through Sept. 30) is 2.35 inches.

Since July, rainfall in Pine Cove totaled 2.7 inches and nearly 1.7 inches fell just this week, according to resident George Tate, who tracks Pine Cove's precipitation for the Town Crier. About 1.25 inches of rain fell at Mt. San Jacinto Peak this week, according to National Weather Service data.

The average annual rainfall since 1946 is 25.4 inches, last exceeded in 2010. In the last decade, only 2005 and 2010 exceeded the average yearly rain.

The past two rain years have been significantly less than average. In 2012, about 20 inches, or 80 percent of the average, fell. Last year's precipitation was 14 inches or only 56 percent of the average.

While the recent deluge may temporarily reduce fire danger and relive water stress, the long-term benefits are not yet significant.

The level of Idyllwild Water District's Foster Lake has barely improved, according to General Manager Terry Lyons. "It's too much, too fast," he said.

"While the rainfall may have quelled fire activity in the near-term, most of the rainfall was too heavy and brief to result in significant moisture uptake by brush, shrubs and other vegetation. Heavy timber was largely unaffected by the rain and 1,000-hour fuel moisture continues to surpass the 90th percentile over most regions," the Southern California Geographic Coordination Center's Thursday, Sept. 6 bi-weekly fuels discussion stated. The center is an organization composed

Funds for low-income fire victims

he Riverside County Board of Supervisors approved a \$15,000 agreement to provide assistance to low-income victims of the Mountain Fire.

The state's Department of Community Services is providing the funds to the Community Action Partnership of Riverside County that can help these people with mortgages, rentals, utility or food costs, according to Colleen Meyer, client services administrator at the Idyllwild HELP Center.

"This is a really great program," said Meyer. "It's not an either/or grant; rent or utilities. The recipients can do whatever they need, such as pay for prescriptions because of the extra cost of gas to evacuate or lost food."

Food vouchers worth \$100 each will be available to families through the HELP Center.

In addition to this grant, Riverside County Third District Supervisor Jeff Stone has given \$5,000 to the HELP Center for fire victims' food and utility expenses.

CAP requested the state funding after several discussions with the HELP Center about how the fire cost many people, even if homes were not lost. Lost wages, wasted food and other inconveniences were some of the examples of the fire's effects.

Individuals or families who may need help may call Meyer at 951-659-2110.

Other coming events at the HELP Center are:

- Sept. 20: Women, Infants and Children program will be in Idyllwild to provide food vouchers.
- Oct. 8: CAP will be in Idyllwild to help with winter utility costs.



Storms overwhelm roads, wipe-out ponds

Increased September rainfall brought a host of problems for area residents and businesses. The rain and hail storm on Tuesday, Sept. 3, was the beginning of more than a week of flash flood warnings and advisories from the National Weather Service.

On Tuesday, Sept. 3, Dentist Heber Dunn was traveling to Idyllwild on Highway 74 about 4:30 p.m. when he encountered a flash flood at the McCall Park Road turn-off near Mountain Center.

"The car stopped ahead of me and then about three or four more cars stopped," Dunn said. "I looked ahead and it looked like the road was just bubbling with water coming across the top, just ferocious. We had a river coming right down the middle of the road. It was amazing.

"There were several places on the road after Mountain Center where you could see debris in the road where [the water] had crossed. It looked dangerous," Dunn said.

Also that day, the parking lot adjacent to Fairway Market became a river of water, hail and debris. Manager Linda Higgins said, "It started thundering, then it started hailing and it poured. [There was] lots of rain coming down from the top of the parking lot and flooding in front of the store. There was so much hail that it formed little icebergs running through the parking lot; it was really neat." The store sustained no damage.

Idyllwild School sustained flooding in some of the classrooms that day, too. "We had two classrooms that were flooded ... We weren't able to get the sandbags out in time, it came too quick," Principal Matt Kraemer said. "The C Building by Saunders Meadow was flooded. We also have flooding in the main hallway, but it didn't get into the classrooms

there, just in the hallway. The kids really got a kick out of the hail."

The Town Crier received a call just before 11 a.m. Friday, Sept. 4, from Sarita Silen of Garner Valley advising of a dire situation in Bonita Vista near Apple Canyon in the Mountain Fire burn area. Silen's friend, Dia Abrams, owner of Bonita Vista Ranch, a 130-acre property surrounded by burnt land, was in fear that more storms would threaten her already flooded property.

Publisher-Editor Becky Clark contacted Mike Feyder, president of Mountain Disaster Preparedness. Feyder then contacted Cal Fire at Station 53 in Garner Valley and was advised that Cal Fire was on Abram's property trying to assist her in preparing for the storm predicted for that afternoon [Sept. 6]. Cal Fire advised Feyder that there was not much anyone could do at this point, that preparations - such as rocks and retaining walls - should have been made well in advance of the storms.

The Sept. 5 torrential storm washed away two natural ponds that provided water and shelter for indigenous wildlife on the ranch and came dangerously close

to claiming the ranch owner's house.

After the story ran on the Town Crier's website, Siren wrote that that brought the help Abrams needed.

The children's area downstairs at Town Hall was damaged by the rain/ hail storm in Idyllwild last Tuesday, too.

"The drain clogged and the room flooded. It was under about an inch of water," said Recreation Coordinator Michael Rinehart. Outwardly, it appeared that the room sustained no damage, but upon entering, the stench is overwhelming.

Rinehart said that Town Hall is addressing the problem and had scheduled professionals to come out and assess the damage.

of multiple Southern California fire agencies.

"At least the rain gave firefighters the opportunity to knock down many of the western fires," said Pine Cove Water District General Manager Jerry Holldber. This weekend, the National Preparedness Level was reduced to 2. During the Silver Fire it had been raised to the maximum of 5.

Forecasts predict a return to normal September weather this weekend. Further in the future, the National Weather Service climate predictions do not foresee either an El Niño or La Niña weather pattern developing this year.


I picture myself as a John Candy-James Bond character ordering at the snack bar: I'll have a virus-martini, shaken not stirred.

released pending notification of relatives.

Hernandez said that three men from the Los Angeles area were fishing from shore on the Lake Hemet peninsula early in the morning when one of the men entered the water to retrieve his fishing pole. "He never came out," said Hernandez.

The victim's fishing line became tangled and the victim swam out into the water in an attempt to untangle his line. The victim became tired and was unable to make it back to shore, according to the sheriff's press release.

A witness, a friend of the victim, swam out in an attempt to assist the victim back to shore. The victim was unable to stay above water and the witness was unable to rescue the victim.

The victim was identified as a Korean male in his 40s.

Community meeting on disasters

The American Red Cross, in association with Mountain Disaster Preparedness, will host a community meeting on Wednesday, Sept. 18, targeting camp leaders, innkeepers, hoteliers, school officials and area community leaders. The goal of the meeting is to begin creating a master plan in emergency situations, such as the Mountain Fire this July.

"The Red Cross would be involved in this master plan but it is going to be the Mountain Area Safety Task Force, us, Mile High Radio Club and the Woodies," said MDP President Mike Feyder. "Once again this is dealing with worst case scenario, shelter in place for 10 to 14 days. When the camps are full, we've got 3,000 kids up here during the event.

"What resources are we going to need to bring to bear so that those kids are sheltered, taken care of and information about our situation here is getting out to the outside world?"

MDP was inundated with calls from concerned relatives and evacuees during the Mountain Fire. A major event could leave Idyllwild isolated by virtue of road closures and loss of electrical and phone service.

Feyder believes they have a solution: "One of the things we are going to unveil at the meeting on the 18th is a device that [Riverside County Third District] Supervisor Jeff Stone granted money for to the MDP.

What we have done is purchase a satellite telephone If telephone service is interrupted and electricity is out, the

satellite phone will still allow for an immediate uplink to the MDP website. It will be a data transmission source that will allow us to update our Idyllwild emergency website and let the world know that Johnny is OK or that Mary is fine at Idyllwild Pines; or that the roads are closed and you can't come pick up your kids," said Feyder.

Cost is a factor in operating the satellite phone. "The transmission fees and costs are very very expensive and something we cannot underwrite ourselves," said Feyder. These and other issues will be addressed at the Sept. 18 meeting starting at 4 p.m. at the Idyllwild Pines Amphitheater.

On Oct. 19, MDP is planning an all-hands-on-deck drill. CERT teams will be mobilized as well as the MDP Medial Group, the Mile High Radio Club and the Woodies. The groups will go through a real case scenaraio at each Disaster Aid Station (DAS) unit.

"We are so vulnerable up here. We have a lot of senior citizens that live up here. A lot of our folks are up in age and they are going to need help. For every one of us that is trained, there's 20 of us that aren't. For every one of us that is prepared, there's another 30 that aren't," said Feyder.

Shingle replacement grants available

Funds to help local homeowners replace wood shingles will soon be available.

The Riverside County Board of Supervisors formally accepted an \$870,000 grant from the Federal Emergency Management Agency for this purpose. The Mountain Communities Fire Safe Council had submitted the application in 2009 and will manage the funds under the auspices of the county's Office of Emergency Services.

Considerable preliminary planning has occurred in order to gain approval. MCFSC identified 123 eligible properties and is already re-evaluating them and estimating costs.

Homeowners are responsible for paying contractors for the wooden shingle replacement. MCFSC will document the final and total costs, for which the property owner will be eligible for 75-percent reimbursement.

Two hikers rescued

On Sunday afternoon, Sept. 8, Riverside County Sheriff's Department's Cabazon station deputies responded to the Palm Springs Tram regarding a report of two hikers needing rescue. They became lost while hiking at the top of the Palm Springs Tram.

The hikers were identified as Alejandro Escobedo, 62, of Austin, Texas and Tracey Pomeroy, 50, of Tempe, Ariz., according to the Sheriff's Department.

Riverside County Sheriff's Emergency Response Team was notified and members of the Mt. San Jacinto State Park, the Riverside Mountain Rescue Unit (RMRU), and the Riverside County Sheriff's Aviation Unit, assisted with the rescue.

Escobedo had sufficient power in his cell phone to dial 911 and gave dispatchers an idea of where they were; however, later his cell phone battery ran out of charge. About 6:15 p.m., Riverside County Sheriff's Aviation Unit located the lost hikers.

Due to the area where they were located (between Hidden Divide Reserve and Caramba) and nightfall approaching, it was necessary that aviation airlift the hikers to the bottom

Les Walker of Idyllwild and a Riverside Mountain Rescur Unit member was picked up at Keenwild Helibase and hoisted down to the stranded couple. He moved them to another location more conducive for lifting them up to the helicopter. They were returned to the tram parking lot.

"It was 55 degrees and getting colder," Walker said. "They were in shorts and without water. They could have survived the night but it would have been uncomfortable.'

The Sheriff's Department reminds hiking enthusiasts to carry proper equipment for any outdoor excursion. Proper preparedness includes a well thought out travel plan shared with friends and family, as well as familiarity with common hiking equipment, such as G.P.S., sufficient water, maps and compasses.

TC can't let go

EDITOR:

"Many refused to vote for candidates," read the damning headline. Refused? How about, "Didn't vote for three candidates, only voted for two, or only voted for one?"

Well, 37.10 percent of the Idyllwild Fire Protection District registered voters at least voted, which is pretty much in line with the turnout in both 2001 and 2009. That's far from ideal, but at least it's better than the county-wide turnout which was only 28 percent.

As for the IFPD commissioners election, could it be some voters were just not comfortable voting for people they don't know anything about and decided to leave it to other voters to decide? I've done that myself, like when there's a contest between two people running for a judge's seat and I don't know anything about either one of them.

Oh, I suppose I could flip a coin or something but I take exercising my right to vote a lot more seriously than that. Or, I guess you could say, I "refused" to vote for either one of them.

The obvious intent of the Town Crier is to make it appear that there are many Idyllwild voters who, like themselves, are so dissatisfied with our fire department that they decided to demonstrate their feelings by refusing to vote for three seats on the board of commissioners, and instead only voted for one or two — but they did take the time to vote which is more than you can say for the other 62.9 percent of IFPD registered

And there's one other subject the Town Crier can't seem to let go of — the financial struggles of IFPD. First of all, our federal government is dealing with financial problems as are just about every state, county and city in the country, not to mention almost every country in the world, so why is it such a surprise that IFPD has similar problems?

In fiscal year 2008-09 IFPD received about \$936,723 in secured prop-

erty tax income. In 2011-12 that figure had dropped to \$812,450. That's a difference of \$124,273. That figure only represents about half of the budget, but the remaining sources of income stay about the same. It's also the reason IFPD has to request an advance from the county in order to pay its bills that come due between July 1 and the end of December.

These members will advise and make recommendations to the supervisor concerning recreation and street lighting in the Idyllwild area.

Historic voter records available

Historians, researchers, and people exploring genealogy will have an new window to the past thanks to a new law Secretary of State Debra Bowen sponsored and the governor approved last Friday.

California voter rolls will be available to the public after 100 years. Personal identifiers, such as Social Security and drivers license numbers, were not used in voter registration until 1994, and waiting 100 years to open these records ensures that no living individual's information will be vulnerable to identity theft.

Each county Registar of Voters office maintains voter registration records containing information such as the date of birth, address, occupation, and in some cases the country of origin, and physical characteristics of each voter such as height, hair color and distinguishing marks.

OFF THE MAIN ROADS

Plastic fantastic ...

Hiking up the steep slope of a mountain can be hot and sweaty. The refreshingly cool feeling of raindrops merrily pelting off your head in a sudden downpour is a welcome relief. Getting rained on can be fun, but it's easy to get chilled to the bone if you're not properly prepared.



As we've seen in the last couple of weeks, unpredictable storms can suddenly change hiking conditions from dry and hot, to cold, wet and miserable in minutes. But getting caught in the rain without hi-tech hiking gear doesn't have to be miserable.

Although plenty of great tips exist for prepping yourself for rain, let's focus on some options I always carry with me, rain or shine, all waterproof, durable, economical, lightweight and in a wide variety of sizes. That's right, the humble plastic bag will finally be given a place in the spotlight as a top tool for emergency rain.

Plastic bags: hiking buddies

Want a versatile, durable, waterproof and multi-use item? Plastic bags meet all the criteria and come in all shapes and sizes. They can, at least temporarily, solve almost any backcountry rainy need.

- For a backpack cover and stuff sack, use two or more large, heavy-duty contractor bags. These flexible black bags serve as a waterproof backpack cover and, packed around sleeping bag and clothing, serve as extra protection. As a bonus, use contractor bags as emergency rain ponchos, bivys (place two end to end), water carriers, waterproof seats for wet logs, basically anything you can come up with.
- · Miniature dry bags, such as small Ziplock baggies, can keep cell phones, cameras and other small items dry and easily accessible. Pack clothes in 1-gallon Ziplock bags to keep dry in case the pack gets wet. Baggies make good waterproof map cases, too.
- · Didn't bring any gloves and a freezing wet wind is turning your fingertips blue? Insert hands in plastic produce bags inflated slightly, with just enough air to keep them from direct contact with skin, and tie around wrists. The "dead air" space helps insulate hands from the worst of the cold, at least for the short term. Head back to warmth and safety as soon as possible. Don't have waterproof shoes and need to keep feet dry in an emergency? Bring plastic produce bags or grocery bags to slip over socks and stick feet back inside shoes. Close the gaps at ankles with a rubber band.
- I'm a big proponent of bringing the 10 essentials on every hike, so please don't take this as an invitation to leave out important gear to save time, money or weight.

The best tip for dealing with a rainy day is adequate planning, preparing and packing. These tips and tools are not meant to replace any of the 10 essentials, but sure are nice to have if taken off guard or when meeting someone less prepared along the trail.

A new luxury bed and breakfast, set to open on Upper Pine Crest in Idyllwild in early October, hosted an open house on Aug. 17.

"Our open house was phenomenal. We had twice as many people as we expected," Grand Idyllwild Lodge owner Brad Rechtfertig said.

Now Brad and his wife Jacki are planning for their "soft" opening.

"We're trying to open, our soft opening, by the start of October. So yes, we're kind of scrambling, but we're really close," Brad said.

The Rechtfertigs both hail from small towns, which made Idyllwild especially appealing. "The reason we picked Idyllwild was that we really liked the mountains. You hear the same story over and over; lots of people come up here to visit and they stay.

"You have everything you need up here. You have deer that show up every day. We just love the pace," Brad said, smiling. "The community kind of depends on each other. We are a tourist community and those tourist dollars are what help everybody.

"The inn was Jacki's idea. I came up with the basic design and concept, and I gave it to my engineer who is also a draftsman and then they did the engineering and the actual plans that were submitted to the county," said Brad, who is a contractor and built the lodge himself with his crew.

"We were very deliberately understated," Brad said. "We didn't want to

The lodge is fully American Disabilities Act compliant and in addition to the elevator and ramps, will offer an ADA-compliant room that includes a wheel-in shower and rails. "A lot of older people are leery of coming to the mountains, especially in the winter because they are afraid of slipping and falling and walking upstairs. If you have an elevator you can literally get anywhere without having to walk upstairs," Brad said.

"The other thing that makes us extremely unique is that we are probably the greenest inn in Southern California. I say that for a couple of reasons. It is new construction, so pretty much any new construction

in California has strict codes you have to follow, so we are very energy efficient. All of our common-area lighting is LEED [Leadership in Energy and Environmental Design designation], which is the newest and it is all controlled by a computer," he explained.

"We wanted to keep it very natural," Brad said. "We already had two major deer trails that came through here. We left all the trails natural. It's kind of like a little nature park that surrounds the inn so that when guests are here they feel like they have escaped.

"It's a destination resort. It's the kind of place where you just come here and you could stay all week without ever leaving. You'll have everything you need," Brad said.

Parents object at local meeting to losing teacher

Since the 2013-14 school year started, Idyllwild School has lost a permanent teacher, which has resulted in the combination of two fourth-grade classes into one class.

Hemet Unified School District's enrollment is about 400 to 500 students below expectations. Consequently, the district has had to eliminate seven teacher positions since the beginning of the school year.

One of these was the transfer of Michelle Adler from Idyllwild to Whittier elementary. This loss has resulted in combining the two fourth-grade classes.

Adler was the kindergarten teacher. Lisa Draper, one of the fourth-grade teachers, replaces her. Draper's fourth-grade class is combined with Tom Dillion's class, which now has 35 students. And three other students were transferred to Brennen Priefer's combined fourth and fifth grade class, but they go to Dillion for math and English, according to Idyllwild Principal Matt Kraemer.

"I shifted staff to the best possible situation," he said. "It wasn't my choice."

This action provoked a reaction at the HUSD Sept.

3 board meeting, which was coincidentally held at Idyllwild School. Several parents shared both their opposition and dismay with the board.

Questions, which parent Verna McQueeney asked, were why the adjustment was made after the school year began and its effect on special-needs students in such a large classroom.

"Combining these classrooms is a rash decision and detrimental to the children," said her husband Michael McQueeney.

Parent Dawn Sonnier told the board that despite the district's declining enrollment, Idyllwild School's enrollment is increasing, and therefore could not understand the justification for its loss of a teaching position.

Idyllwild's current enrollment is 293 students, 11 more than the June enrollment of 282

Later in the meeting, the board did reject the transfer of a teacher from Helen Hunt Jackson School to Whittier, but approved the other involuntary transfers, including Adler's transfer to Whittier.

Idyllwild board trustee Vic Scavarda voted against the package, which included the action affecting Idyllwild. "If I were a fourth-grade parent, I'd be extremely upset. And I heard from many upset parents," Scavarda said. "I wish it were in my power to fix the numbers we're dealing with. With the isolation [of Idyllwild from the rest of district] up here, historically our class sizes have been lower than the rest of the district."

In other business, Pam Buckhout, director of financial services, told the board that the final results for fiscal year 2012-13 improved from the initial estimates. The year-end balance was \$1.5 million more than originally estimated and \$500,000 more than the

previous year-end balance.

The board also approved a package of contract changes to complete the ramp to Idyllwild School's athletic fields. In June, the trustees approved a notice of default for the original contractors, Falcon Builders. HUSD had numerous problems with the quality and completion of the work.

New contracts for railings and to remove and replace concrete and asphalt have been issued. The estimated completion date is the middle of October.

The state of the Hemet Unified School District

Editor's note: On Tuesday, Sept. 3, Hemet Unified School District Superintendent Dr. Barry Kayrell and Trustee Vic Scavarda of Idyllwild met with the Town Crier to discuss the "State of the District" and trends in the next few years. This is the first of three parts of the interview.

What is the state of the district?

"Overall it's very positive. A lot of good things are going on," Kayrell said, describing the overall conditions of HUSD. "Our financial health is starting to improve. For the first time in seven years, we didn't have a deficit last year."

The state's new funding formula for school districts will be a substantial benefit to HUSD, Kayrell emphasized. "The new formula really helps us out."

Besides the base grants to districts, the new formula augments state funding for English learners, eligible to receive a free or reduced-price meal and foster youth. Also, if the targeted student population exceeds 55 percent of a district's enrollment, more funds will be awarded.

The new legislation also requires districts to develop and adopt a plan for how the locally controlled funding will be allocated. Kayrell said his staff is drafting the plan and public comments will be sought later this fall. "This will dictate how we spend this money," he stressed.

"Great people are teaching our students, which is very important to me," Kayrell added. "The teaching component makes everything else go smoother." What are you goals for this year?

HUSD is implementing the first phase of the new Common Core curriculum, according to Kayrell.

Since 2010, 45 states have adopted the same standards for English and math. These standards are called the Common Core State Standards. These new standards will replace the existing standardized tests. In California, full implementation is expected during the 2014-15 school year, but HUSD is about a year ahead of schedule. Local teachers have been preparing for more than a

"The teachers have worked hard to develop these units. They've been training for two years," Kayrell said.

"The shift is already evident," said Scarvarda, citing the example that English lessons will not just address writing, but how to blog and publish writings to the

web

How do you feel about HUSD's financial condition?

Kayrell is pleased and optimistic about HUSD's future finances and the new state funding formula. "The new [funding formula] is based on actual profile of the district," he said.

"We have a very high population of students who receive free or reduced rate meals," Kayrell stated. On an average day, the district prepares more than 20,000 breakfasts and lunches for these students.

The newly required spending plans will benefit the district. Since fund-

ing for the numerous and various categorical grants is being provided without specific requirements for use, these plans will empower the school board, in Kayrell's opinion.

Federal Title 1 funds will still be available as a safety net, Scavarda added.

"Still, this is a big change for the school district," Kayrell emphasized. "We even received \$200 per student for Common Core material. This is one time only, but it helps the teachers implement the new curriculum. There are also some additional funds for teacher supplies."


Besides getting this new funding, Kayrell stressed that HUSD's financial condition is better than many districts because its salary costs are about 83 percent of the total budget.

"Many other districts are in the range of 85 to 89 percent," he said. "So we still have a cushion for salaries and benefits."





years as the district implements the Federal Affordable Care Act that will affect employee health benefits.

"Overall, our finances are looking good," Kayrell said proudly.

Do you see the district adopting teacher pay standards that incorporate student test performances?

"It's a novel concept. But teachers don't always control everything for the kids in the classroom," Kayrell said.

A major problem, according to Kayrell, is how to address special education students. Expecting and rewarding results for them based on the other student population would be difficult.

"It's hard for them to reach their targets. We'd need rations that work for all people," he stressed.

Scavarda re-enforced this problem, "My concern is everybody will want the higher-end kids."

"Yes, we can't all teach GATE [gifted and talented education] and advanced placement courses," Kayrell added.

County losses continue

The Riverside County Board of Supervisors adopted a \$4.7 billion budget for fiscal year 2013-14, which began July 1. The new budget is about \$278 million less than the 2012-13 level. However, the board's discretion applies to only \$630 million.

This year, County Executive Jay Orr projects discretionary county revenue will grow by \$19 million

to \$588 million, the first revenue boost since fiscal year 2007-08 — six years ago. The county anticipates property tax revenue will increase \$7 million as a result of a 3.5-percent growth in assessed value. Sales tax revenue is expected to rise nearly 40 percent next year.

Still, expenses exceed the revenue forecast. The projected deficit will be filled with \$30 million of unexpended funds from the 2012-13 fiscal year and available this year, and another \$14 million from reserves.

"Over the next fiscal year, the drive to increase operating efficiencies countywide will continue while we strive to achieve more with less," Orr wrote to the board.

He identified four major initiatives to be implemented during this year and the near future: the Affordable Care Act, construction of the East County detention center, increases reserves and providing adequate public safety resources.

The financial problems confronting the county's Regional Medical Center will come to the board later this month. Orr plans a board workshop Sept. 23

to present a consultant's review of the hopital's operations. In 2012-13, its operating deficit was \$10 million and the losses will continue.

The sheriff, fire and district attorney's offices will receive about \$330 million of the county's discretionary funds. Each agency absorbed the pay raises for staff, which were negotiated last year to help reduce future pension costs.

The final 2013-14 budget will be submitted to the board for adoption in September, according to Orr.

Making the grade through homeschooling

Editor's note: This story deals mainly with Hemet Unified School District and U.S. statistics on homeschooling. The TC also is interested in talking with local parents/guardians currently homeschooling their children.

Homeschooling in the U.S. is growing by leaps and bounds. From 1999 to 2012 the number of children being homeschooled jumped a whopping 75 percent and that number is expected to surge over the next 10 years, according to a report by Education News.

Parents elect to homeschool their children for many reasons — religious beliefs, personal needs, peer pressure, disappointment in the public school system, family-run business, etc.

Idyllwild School Principal Matt Kraemer reasons, "If a child is helping with the family business, home schooling might be more suitable. Or there might be extenuating circumstances where the child is a better fit in a homeschool program

rather than being in school."

Dr. Brian D. Ray of the National Home Education Research Institute wrote, "There are about 2.04 million home-educated students in the United States. There were an estimated 1.73 to 2.35 million children (in grades K to 12) home educated during the spring of 2010 in the United States. It appears the homeschool population is continuing to grow (at an estimated 2 to 8 percent per annum over the past few years)."

The curriculum must be California approved, but "the rigor of how it is delivered can vary greatly," said Kraemer. Academically, many believe that homeschool students are more advanced than students in traditional public schools. "The students that we've recently got from the homeschool program have been a little behind," Kraemer observed, however.

Based on Ray's studies, "The home-educated typically score 15 to 30 percentile points above public-school students on standardized academic achievement tests. (The

public school average is the 50th percentile; scores range from 1 to 99.)"

Some districts are now offering independent study programs such as Hemet Unified School District's Family Tree Learning Center. "We have the learning tree program for elementary kids K-8; they do independent work under the guidance of their parents, but they do have to go down to Hemet to meet with their teacher once a week to review their work," said Kraemer.

The Helen Hunt Jackson program serves high school students. "We have a teacher that comes on Tuesdays and she meets with high school students at Idyllwild Elementary," Kraemer added.

Kraemer feels there can be drawbacks to homeschooling, "Putting academics aside they say that most people who get fired or terminated from their job is not because they can't do the job, it is because they have trouble socializing with their co-workers. That is so much part of being in school, the socialization factor and learning how to interact with people. It is really important to your future success."

Kraemer believes that some kids can still be socialized in a homeschool program but it is more difficult. "I've seen kids be very successful in homeschool programs that have managed to teach them socialization skills. Some parents do a really good job on taking their kids on field trips in the homeschool program and they really get out and see the real world."

Under normal circumstances, homeschooled students do not participate in after-school programs, but there is an exception in the HUSD program.

"We do the Missoula Children's Theater every year. It is a production where the PTA hires a company and they send out two people, usually theater students, who work with the kids for the play," said Kraemer. "They work with them for one week. This year it is going to be the 'Wizard of Oz.' It's the first week in December.

"They do a phenomenal job. They bring props and

everything and they work hard with the kids to study their lines," Kraemer said. They practice four days a week to get their lines down and then they do their performance at the end.

"I extend that to the homeschool kids because I think it is a good opportunity for them to participate in something they wouldn't normally get to participate in. The PTA is behind it, too. They thought it was a good idea to incorporate the homeschooled kids," said Kraemer.

Academically, Idyllwild Elementary broke 900 on its Academic Performance Index this year while the Family Tree Learning Center score was 726.

The Helen Hunt Jackson independent high school study program dropped 26 points to 682.

Still, Kraemer believes

the program can be successful for some students, "Some of the students who have left here as eighth graders and gone on to HHJ [Helen Hunt Jackson] are really good students. I know of one student that graduated high school in three years. He's now in his first year of college."

Rep. Dr. Raul Ruiz (D-36) was elected just 10 months ago. But the race for the 2014 election has already begun. Raising money to finance campaigns has become a full-time occupation for elected officials and those who wish they were

Through June 30, Ruiz has raised \$763,000. More than half came from individual contributions. Political committees representing various medical associations

have been significant contributors to Ruiz's future campaigns.

For example, American Academy of Ophthalmology and the American Hospital Association each gave \$5,000. Also, the American Academy of Family Physicians Political Action Committee, American Association of Neurological Surgeons PAC, American Association of Orthopaedic Surgeons PAC, American College of Radiology, American Congress of Obstetricians and Gynecologists, American

Osteopathic Information Association PAC, American Pharmacists Association PAC and the American Urological Association gave \$2,500 each. At the end of September 2011, Ruiz had just about \$50,000 in cash. Now he has more than 10 times that amount and it will See Ruiz, next page

grow next year. Former Congresswoman Mary Bono Mack, at the same point, had \$435,000 in cash.

Despite his early fundraising success, Ruiz will have competition for a district that many pundits consider leaning Republican. State Assemblyman Brian Nestande (R-42) represents nearby cities such as Hemet to Palm Springs and Palm Desert. Before the redistricting, he represented Idyllwild and the Hill, too. Being first elected in 2008, his six years in the Assembly prevents him from seeking re-election.

He is developing a team to challenge Ruiz next year. Thus far he has raised \$145,000 for the race. Nearly 80 percent is from individual contributions.


