MDP leads discussion of evacuation preparation

Be prepared to evacuate your Hill domiciles, was the message of the latest Mountain Disaster Preparedness meeting last week. Nothing imminently threatens the Hill's residents, but all of the speakers at Tuesday's meeting, held at Idyllwild Library, emphasized the importance of being prepared for an emergency.

Many of the speakers used the example of the amount of time between the start of the Mountain and Silver fires, and the issuing of evacuation orders.

"The Mountain Fire and Silver Fire were two different animals," said MDP President Michael Feyder. "How lucky we were during the Mountain Fire. The evacuation went smoothly. A month later, [with] the Silver Fire, there was no time to prepare to go. They had to go without any thought to what to do."

Idyllwild Fire Chief Patrick Reitz compared the two fires. The evacuation order for Idyllwild due to the

Mountain Fire was issued Wednesday, July 17, two days after the fire began. The Silver Fire in Poppet Flats and Twin Pines began burning Wednesday, Aug. 7, and the evacuation order was issued within hours.

Residents were permitted to return to Idyllwild Sunday, July 21. The evacuation order for the Silver Fire was partially lifted Saturday, Aug. 10, and fully lifted Monday, Aug. 12. Both evacuations lasted at least three days.

Residents, even part-time residents, need to be prepared to go on a moment's notice and for days. Each speaker discussed the steps to take to be prepared.

Insurance is important, stressed Caleb Kirk of TWFG Insurance. Homeowners' policies and many others for renters have a clause to cover expenses from the loss of residential use. This would include costs for meals and places to stay, such as motels.

He also recommended taking photos, even digital, of personal property in case the house is permanently lost due to disaster. Also, scanning important per-

sonal documents such as insurance policies is a good practice.

Back-up medicine is a good precaution advised Idyllwild Pharmacist Barry Shapiro. Collecting a few extra pills from each month's supply can quickly provide one or two weeks' back-up in case of evacuation.

However, he did advise taking copies of a prescription bottle. With this and a call to one's doctor, most pharmacists would gladly fill a new prescription, he said.

Besides Reitz, fire officials from Riverside County Fire Department, including Chief John Hawkins, and the county Sheriff's Department's Hemet Station, including Capt. Ray Wood, were at the meeting.

As he began, Reitz said his comments were to be "thought provoking and help motivate you to learn more about disaster preparedness, and becoming prepared for [disaster] is not if, but when."

The questions one has to ask themselves before they evacuate, according to Reitz, begin with, "How long might

State considers groundwater regulation

All three of the Hill's local water districts — Fern Valley, Idyllwild and Pine Cove — rely on groundwater for their customers. For PCWD, groundwater is the exclusive water source; for the other two districts, diversions from local streams also are a source.

While none of the local districts has expressed any concern about the long-term viability of its groundwater sources, this is not true for many water districts in other areas of the state, including the Coachella Valley.

Consequently, because of the severity of the drought, concern over water availability is leading many state officials to consider regulating groundwater usage. The governor has a proposal and both the California Senate and Assembly have held hearings in the past month on this subject.

In California, there is virtually no regulation of groundwater. Surface and flowing water are regulated. Permits are required to use these waters and some water rights are more than a century old. But property owners have traditionally had the right to water under their land.

If a well is drilled, the owner may use that water. If it is distributed beyond the property, it must meet water-quality standards the state and county set. A loosely enforced state requirement expects water districts to report the amount of water extracted from ground wells. On March 11, the As-

sembly Committee on Water, Parks and Wildlife and the Assembly Budget Subcommittee on Resources and Transportation held a joint informational hearing on the managing California's groundwater resources.

Several speakers encouraged the legislature to take action to strengthen the regulation of groundwater as a form of protection and good management.

The Legislative Analyst's Office explained the patchwork of state and local rules, which governs aspects of groundwater. No statewide groundwater use permitting (groundwater rights) system exists. Some local governments have established ordinances to ensure the availability of water supplies to users within the local jurisdiction, often by limiting the transfer of groundwater out of the area.

But current law does not acknowledge the physical connection between groundwater and surface waters. Dr. Maurice Hall, speaking for The Nature Conservancy, argued that wells near flowing streams can, under some conditions, pull stream water into the ground and eventually reduce stream flow.

The LAO recommended legislation to phase in a system for monitoring groundwater extraction. Components would include requiring local water districts to submit standardized extraction data from all groundwater wells.

Establishing Active Management Areas, as in most other Western states, was also recommended. An AMA

Revised Community Wildfire Protection Plan being prepared

The Mountain Communities Fire Safe Council hosted the second meeting to plan the 2014 Community Wildfire Protection Plan last week. The group's goal is to have the new CWPP completed by early fall. Before it is finished, President Mike Esnard plans at least one community meeting to discuss and garner public thoughts and recommendations.

All participants agreed that this year's plan should include two new topics, both critical to combating and restraining fires on the Hill. One is a more comprehensive discussion and analysis of water resources on the Hill and their availability for firefighting and will be

the responsibility of Pine Cove Water District General Manager Jerry Holldber. An issue addressed in this write-up will be run-off from fire-burned areas.

Secondly, Mile High Radio Club President Bill Tell will organize a more thorough discussion of radio communications on the Hill, including local emergency station WNKI.

Esnard led the discussion about content. "What have we done, what has worked and what are we going to do, simple and basic?" he summarized.

While all agreed that the plan must include all of the proposed fuel treatment work and other possible projects, there was debate over how much history of completed work should be provided.

The question of the extent of past actions appropriate for the revised CWPP was raised when Riverside County Fire Department Division Chief Gregg Bratcher asked how far back he should collect historical data. He recommended concentrating on projects

related to the area's major fuelbreaks.

Idyllwild Fire Chief Patrick Reitz and former Idyllwild and Forest Service Ranger District Chief Norm Walker agreed that a comprehensive historical section would lower the interest in reading the document and the proposed actions.

Sue Nash recommended more attention be given to relating the overall strategy of fuel projects on the Hill with the specific projects: "How do the individual projects fit the overall strategy?"

In response, Dan Felix, current fire manager for the San Jacinto Ranger District, agreed, giving the example of better explaining how fuelbreaks improve protection of the watershed. He added that federal reviewers will focus attention on an "all-lands" approach, regardless of management agency, with an emphasis on restoration after fires.

you be gone?" But he emphasized that these questions should be posed now, not when the evacuation order is announced.

To effectively endure an evacuation, Reitz stressed, have a plan and practice, practice and practice. When asked what that means, he replied, "Whatever you plan to take with you, carry it out to the car — several times."

Lt. Robert Perdue discussed how the Riverside County Sheriff's Department organizes and implements the evacuation. He also stressed, "Know what you'll do ahead of time."

Once the evacuation has been implemented, the

Sheriff's Department intensifies its patrols of the area since so many people are now away. Nearly 100 sheriff's deputies were watching Idyllwild during the Mountain Fire evacuation, he said.

Concluding the session, Nancy Layton, IFPD commissioner and MDP member, discussed a "go box" for these emergencies. Reitz also recommended a "go bag" for pets, too.

is a groundwater management institution with jurisdiction over a groundwater basin (that may cross political boundaries), and that is especially vulnerable to contamination or overdraft. An AMA regulates all groundwater extractions and surface withdrawals from the basin to ensure the sustainability of the area's groundwater supply.

Fern Valley Water District President Robert Krieger,

who also is chair of Krieger and Stewart, consulting engineers, feels many of the Southern California groundwater basins are already in litigated adjudications.

A related action is part of Gov. Jerry Brown's 2015 budget proposal. He recommends transferring the drinking water activities from the Department of Public Health to the State Water Resource Control Board. The governor's budget proposes that drinking-water regulatory and technical assistance activities be housed in a newly created

Division of Drinking Water Quality within SWRCB. Administering financial assistance programs would be consolidated with SWRCB's existing Division of Financial Assistance.

The SWRCB would have the authority to regulate drinking water systems and the quality of the groundwater that supplies those systems.

The governor's "California Water Action Plan," released in February, also addresses groundwater. While it urges collecting more data and improving groundwater

recharge, it also calls for legislation similar to the recommendations from the LAO.

Idyllwild Water General Manager Tom Lynch and Pine Cove Water GM Jerry Holldber were skeptical of the idea to regulate groundwater usage. While details are not available, Lynch says he has been monitoring some actions on the state level, and says, "On one hand, the state has taken responsive action to stress the drought emergency and promote conservation. On the other hand, I am con-

cerned that any state actions relative to regulation not be a 'one-size-fits-all' solution. I think local management would best be able to determine what an appropriate course of action should be if drought conditions intensify."

While the National Weather Service sees hints that next winter may see the arrival of El Niño events, unless the drought ends quickly it is unlikely that efforts to regulate groundwater will evaporate.

Consequently, there will be some effect on Hill

agencies, if only to increase the administrative burden, as Krieger thinks will happen.

Although the regulatory protocols are still unknown, Holldber knows state actions are not without costs for local jurisdictions. "I feel we do a good job managing groundwater; but my greatest concern is new regulations come with additional costs. We already spend a small fortune for testing and monitoring our existing 18 wells."

Steele ties for 20th in the Arnold Palmer Invitational

Brendan Steele came back from a two-week rest and scored his fourth top-20 and fifth top-25 finish of this 2013-14 season last week. On the Bay Hill course in Orlando, Fla., he shot a 4-under-par 68-74-70-72 — 284 to earn more than \$67,000 and 48.5 FedExCup points.

The local native, who still lists as playing out of Idyllwild, now has 394 FedExCup points on the season, moving him up to 48th place on the list. Another 50 to 60 points should probably seal his ticket for the next PGA

Tour season, if he hasn't done that already.

On the course last week, Steele collected 13 birdies against seven bogies and a double. He putted well on Thursday and Sunday, gaining strokes putting on the field both days. Overall for the tournament, he hit 69 percent of the fairways with drives averaging 296 yards and hit 69 percent of the greens in regulation.

This week Steele travels to San Antonio for the Valero Texas Open, which he won in 2011, his rookie season. The tournament carries a purse of \$6.2 million with more than \$1.1 million going to the winner.

IDYLLWILD WATER DISTRICT MARCH 2014 NEWSLETTER

IWD Mission Statement: To provide reliable water & sewer service in a safe, cost effective & environmentally sound manner in accordance with the community needs.

WATER CONDITIONS – After the third consecutive year of extremely dry conditions, California faces one of the worst droughts ever recorded. Governor Brown declared a statewide drought emergency in January 2014, calling for increased conservation and the provision of emergency conditions to preserve water supplies. Foster Lake, which supplies most of our wells, is dry at this time. Droughts are a recurring feature of California's climate, and 2013 is now the driest calendar year on record with a total of just 30% of average statewide precipitation. The previous record low was in 1976 with 56% of average statewide precipitation. Although we experienced a two-day storm earlier this month, it did little to impact our water conditions, and IWD's static wells continue to decline. We appreciate the water conservation efforts being made by our customers. Your conservation efforts help provide flexibility to allocate drinking water and fire protection services. We take seriously our responsibility to provide water to our customers. We carefully monitor our wells and water storage. We remain at a Stage II Conservation Water Plan.

WHAT YOU CAN DO TO HELP – Limit landscape irrigation to once a week, repair all leaks, minimize car washing using a hand-held hose equipped with a positive shut-off nozzle, don't wash down patios and driveways, shut off the tap when brushing your teeth, stop filling ornamental ponds, except to the extent needed to sustain aquatic life. Remember to shut off your customer valve at the street when you leave your residence for any length of time. Consider purchasing a rain barrel to capture run-off for irrigation.

On a personal level and as the person handling the workings of the Visitors Center, I get a large number of tourists from Canada and Europe who are visiting the desert and other places who had no idea Idyllwild existed. When they come in to the Visitors Center, I usually hear it was mentioned by someone in the desert to visit our community — and they love it.

Now, let's magnify that by all major cities in Southern California, many who have no idea we exist, and voilà, increased tourism.

Now, back to the party. First, I wish to thank the owners of the Grand Idyllwild Lodge, Brad and Jacki



Rechtfertig for their kind support. Both of you are a welcome addition to the community.

As usual, I was in charge of the food. For some reason I don't understand, they will not let me be in charge of the wine. Becky Clark made a delicious hummus served with pita chips. Halie Johnson made a spinach dip, but not your ordinary spinach dip. This one was slightly spicy and served with fresh vegetables. Wow. The table was full of other wonderful dishes.

I made a crab spread served with sliced bagette. The recipe is years old, given to me by an old friend's mother. It's an appetizer recipe that must be taken to a party. It's good with crackers but I prefer a soft, fresh-sliced bagette.

One more thing and this will put a smile on your face. All Town Crier staff at the party had name tags with their new magazine title. They couldn't figure out one for me so mine said my name, and my title was, "Goddess of all things." That is how I was introduced. I like it. I'm thinking about ordering a T-shirt.

Now for the crab spread recipe.

Gladys' Crab-cheese Spread

Ingredients

- 8 oz. cream cheese
- 1 can cream of mushroom soup,
- 1 cup mayonnaise
- chopped onions

- chopped celery
- 6-oz. can crab, drained well (I couldn't find 6-oz., bought 2 cans at lesser weight and used all)
- 2 packets Knox Gelatin
- 1/4 cup water

Directions

Warm soup without water, then whip with a beater. In a bowl, mix together everything but the gelatine and the water.

In a sauce pan, mix gelatine with water and heat on stove until slightly thick.

Add to bowl and mix, then place in greased mold. Refrigerate for four hours or overnight.

I did not unmold until I was at the party. Unmold on a bed of lettuce surrounded by cherry tomatoes. My mold is a copper fish in the shape of a half circle, however, use anything. It will probably work in a cake or gelatine mold.

Lola's note: Although the recipe calls for the vegetables to be chopped, it makes an easier spreading consistency if the vegetables are diced instead. This recipe can be made the night before. Use your imagination. You can use diced jicama instead of celery for the crunch or diced olives, drained. Throw in some scallions for color. Enjoy.

DON'T BE SCAMMED

"Work at home" and "be your own boss" opportunities are in abundance online but not all of them are legitimate.

State and federal agencies, including the Federal Trade Commission, have been taking action against companies promising work-at-home opportunities targeting the unemployed. The Online Entrepreneur was said to have swindled consumers by selling a website program promising six-figure earnings using affiliate marketing for only \$27. Once the program was purchased, however, consumers would be forced to pay another \$100 or more to complete the set-up of the website.

In a settlement with the FTC, the company's assets were frozen and put into receivership pending a hearing; further, the company was banned from selling business and work-at-home programs.

Gravitational waves detection: science and The Big Bang ...

As I was getting ready to write about "Cosmos" — a 13-part series that originally aired on PBS in 1980 — coming back on air and why astrophysicist Neil deGrasse Tyson was the best choice to carry Carl Sagan's legacy, something big happened.

At a March 17 press conference, the Harvard-Smithsonian Center for Astrophysics announced the detection of gravitational waves. The scientists studied the data collected from the BICEP2 telescope located on an ice sheet less than a mile from the geographic South Pole. It was gathering data from the cosmic microwave background of deep space.

Gravitational waves were first predicted in 1916. In his theory of relativity, Albert Einstein showed matter and energy warp space-time resulting in the force of gravity.

"This fantastic new discovery of evidence for gravitational waves gives us an entirely new view and much further back into our universe's history," said theoretical physicist Garrett Lisi. "It strongly supports the theoretical Big Bang model called inflation, which until now was considered speculative."



So what is inflation, you may ask? Theoretical physicist Alan Guth first proposed the theory of cosmic inflation in 1980. In the very early moments after the universe was born, it went through a rapid expansion, which is still occurring today.

How rapid an expansion? Inflation proposed that in the first billionth of a trillionth of a trillionth of a trillionth of a second the universe underwent an expansion that created ripples through space-time that Einstein called gravitational waves. As these gravitational waves pass through, they compress and expand space-time. The expansion of the universe would have stretched these waves so much that by today they would be so miniscule it would be almost impossible to detect them — almost.

"This new data is almost as important as the recent discovery of the Higgs boson," Lisi added. "Both of these pieces of the grand puzzle will help physicists in our continuing efforts to understand what the universe is."

Some scientists also believe the data BICEP2 collects may lend support to what is known as "the grand unified theory," which states that all the forces that hold the universe together (strong force, weak force and electromagnetic force) were once united as one but eventually separated from the force of gravity.

Unifying gravity with the other three forces would finally give us that elusive "theory of everything" that Einstein, Guth, Lisi and the rest of us who love scientific discovery are so desperate for.



and ministry leaders while making a contribution to the lives of the summer campers.



Obituary

Justice William A. Masterson

Born June 25, 1931, during the Depression to a struggling Catholic family in the Irish Ghetto of Flushing, Long Island, N.Y., Bill Masterson felt blessed to spend his last years overlooking the mountains of Idyllwild and the ocean of Mendocino from his beautiful home. Before his full retirement, Bill and his wife Julie enjoyed 17 years living literally on the border of San Marino and Pasadena in their English cottage on Old Mill Road.



Bill's rise to success in life was no accident. He won scholarships, while working full-time, to Loyola High School and to UCLA, where he was a candidate for a Rhodes Scholarship in 1951-1952. After serving as a drill instructor in the U. S. Army for two years, Bill continued his education at UCLA Law School, graduating in the class of 1958.

Bill's peers describe his law career as nothing short of brilliant. He was a business trial lawyer for close to 30 years, practicing as a partner in three major law firms, including Skaddan, Arps, Slate, Meagher and Flom. In 1988 Bill began his many years on the bench, and he felt his biggest contribution to the law was as a judge. He served on the Superior Court of Los Angeles County, hearing both civil and criminal cases, until he was elevated to Associate Justice on the California Court of Appeal. Before retiring completely, Bill worked as a private judge resolving disputes through arbitration.

Born under the astrological sign of Cancer, Bill was devoted to his home and family. For 40 years he showered his wife Julie with love, bringing her coffee and oatmeal in bed every day and toasting her as "the girl of my dreams who became the love of my life" at every possible occasion.

A natural-born father, he adored his four children, Mark, Mary, Tim and Barbara. Parenting was a joy, from bedtime stories as he tucked them in at night, to wise counsel and unflagging support as they grew up. Being the only member of his family to go to college, Bill deeply valued the power of a good education and made sure his children and four grandchildren, Patrick, Meghan, Finian and Rory, would have the same opportunity for higher education. He took great pride that, like him, each of his children went on to build successful careers after graduation.

Suffering from incurable cancer for over a year, his only regret was that he would not live to see his grandchildren make their way in the world. He died March 11, 2014. He will be deeply missed by all his family and the wide circle of friends and associates whose lives he touched. God bless, my darling.

Fern Valley considers expanded leak detection program

Leak detection was discussed thoroughly during last week's Fern Valley Water District meeting. Following up on President Robert Krieger's suggestion during the February meeting, General Manager Steve Erler said he had contacted American Leak Detection about the possibility of surveying the district's entire pipeline system.

A decision was not made during the meeting, but Erler thought the cost, between \$5,000 and \$6,000 for a week, was reasonable and could be paid from maintenance funds.

"Our water losses continue and it seems to me that we need to grab ahold of problem rather than go segment to segment," urged Krieger. Over the past six months, the district has found and repaired 14 leaks that were flowing at about 6 to 10 gallons per minute, according to Erler.

He complimented the staff for how quickly they repaired the identified leaks. Erler also praised Adam Baker, field operator, for his ability to find, pursue and fix leaks.

Yet Krieger thought a system-wide review would provide a reliable base of the status quo to pursue and reduce future leaks.

Referring to the FVWD's unaccounted-for water production each month, which was 18.8 percent during January and February, Krieger said, "It normally ranges between 10 and 20 percent. Ten percent is acceptable, but

20 percent is too high."

Director Charlie Wix and Krieger also emphasized that the continuing repair effort must be compared to the cost of replacing the pipeline. Erler replied that he was considering another pipeline project next year. Doing these projects every other year would allow the district to save fixed costs, such as logistics, which are required for every project, but unrelated to the project's size.

In other business, Erler discussed the district's current water supply. "Our water supply is sufficient to meet the demand and future demand," he told the board. "The stream flow is going down each day." The groundwater level of FVWD wells all rose during February. Well no. 2 increased more than 11 feet, according to Erler.

During the spring and summer, he expects the district will be relying on its groundwater to a much greater extent. "It should be sufficient to keep up with demand; but I monitor the situation regularly," he stated.

"During the last drought, the groundwater was sufficient for two to three years," commented Krieger.

During January and February, FVWD consumption was 4.2 million gallons, which was 1.1 million (20 percent) less than the same period in 2013. "The good news is people are conserving, the bad news is conservation," said Director Ron Korman, who was commenting on the nearly \$10,000 decline in water revenues between the two years.

However, Office Manager Jessica Priefer pointed out that the decline was related to circumstances unique to last year since the 2014 consumption was very similar to the 2012 level of 4.3 million gallons.

Idyllwild Fire ambulance collections less than billings

At the third meeting of the Idyllwild Fire Protection District Finance Committee, the members learned about the complicated processes of collecting fees for emergency medical service and for fighting fires outside the district.

Chief Patrick Reitz explained that final ambulance payment depends on whether the individual has insurance and who the insurer is.

Medicare and California's Medi-Cal patients represented about 45 percent of the ambulance runs in 2013, according to Reitz. While the average claim for both groups is about the same, IFPD collects about 25 percent from Medicare, while Medi-Cal pays only 9 percent after withholding 1 percent for administrative costs.

Recovering the cost of transporting a patient to the hospital is growing more difficult, he said. Riverside County has established its own low-income health plan, but it limits transport reimbursements to \$60 per trip. "We're not even getting gas money," Reitz lamented. "That doesn't pay for the time [of staff] or equipment."

With the implementation of the Affordable Care Act, Reitz said he expects Medicare rates to increase for several

years, but then begin declining.

In 2013, IFPD collected about \$350,000 from emergency medical services, but its actual billings were about twice that amount. Insurers reduce payments and some individuals have no insurance and are unable to pay from their own resources.

The Rustic Theatre hosts INHALE, a reggae/rock/punk/ska band from Riverside, this Friday, March 28 at 10 p.m.

so that we can bring in bigger acts for intimate shows," Thorington wrote. "Working Brilliantly would act as the Rustic's booking agent at that point for those specific shows."


The Rustic is coming off a successful March 8 show featuring Idyllwild rock/metal band Throw the Goat and UK punk/metal band The Bastard Sons.

Chris Trout is anything but average

It may come as a surprise to learn that one of the people responsible for creating the Art Alliance of Idyllwild was not herself an artist. But, five minutes into a conversation with Chris Trout — and it is less a surprise and more a realization — it becomes apparent that this lady can do anything she puts her mind to.

She is self-deprecating about her artistic ability. “I knew I could never be an artist; I don’t have the patience. I took watercolor classes, oh, my God,” Trout laughs. “It was like mud on the paper. I did sculpture and I did a squirrel and everybody would say, ‘What is that.’” But Trout had a love and appreciation for art that was ever-present in her life and a passion for it that would eventually lead her to Idyllwild.

According to Trout, it was during her tenure as a sixth-grade teacher in Delaware that she drew inspiration from the words of the school’s art teacher who said, “You know, Chris, it’s not about just doing art, it’s about appreciating art.” Those words were the seeds that grew into an idea Trout had to inspire the students, “We came up with this idea that for \$5 we could buy prints of the masters and we got someone in the community to make frames and we lined the elementary school walls with Van Goghs, Monets and Kandinskys,” Trout explained. “You’d be walking behind the fifth-graders and they’d say, ‘Hey, did you see the new Kandinsky on the wall.’ and I’d go, ‘Yes, it’s working.’”

While in Delaware, Trout, along with a friend, built and furnished two homes. “Both of us were interested in interior design. We were looking for authentic, hand-created art pieces, whether it be for the wall or sit-about. They weren’t available,” Trout said frustrated. “We wanted to be able to say it was made by so and so and here is their story.” As is typical of Trout, she turned her frustration into action. “I started saving my money to open a gallery.”

With a doctorate in technology and strategic planning, Trout was tapped to work on developing computer systems not only for teaching, but for managing registration systems at a Delaware college. After a short but successful interview with the data processing department, “They decided I would be part of this state-wide group that was looking at the advancement of technology in the colleges and universities,” Trout said. Later, she would become the president of the Personnel Association for colleges and universities.

Trout’s “eye” for composition, detail and color would land her the job as the creative services and marketing director. “I was the catalog director and the director of marketing. I was responsible for the way the catalog looked. I chose the

models, went to the photo shoots and then I really learned to move dots around. Color is dots, but we were doing film then, so then I went on press and did all the press OKs and moved color around and looked at all of the layouts,” Trout said. “I had the gift of an eye; I could look at a layout and say, ‘That is out of kilter, it’s not right,’ and my eye tells me when things are right and when things are wrong, whether that is in designing homes which I did for the last seven or eight years or in a layout.” Trout, who was also the information technology director, was fascinated by the process. “You needed the technology to understand moving the dots and the evolution of the printing industry and I was fascinated by it,” she said.

A move from the academic world to the corporate world landed Trout in Hawaii working for the number one coffee brand there. “I was the director of marketing and creative services and I was the only ‘howlie’ [Hawaiian slang for foreigner]. I had a team of Asians and Japanese and Chinese and Polynesians. The first thing I did was eat what they ate. I’d come down to the lunch room and I could smell the kimchi and I’m thinking, ‘Oh, can I do it today?’ But for six weeks they were my team and if I hadn’t done that, it could have never happened. You have to eat the food,” Trout said laughing.

The brand, Lion Coffee, was also sold in grocery stores in the U.S. and Trout had everything to do with creating the packaging and even wrote jingles set to the tune of “The Lion Sleeps Tonight.”

Returning to California after 25 years of work, Trout

had saved enough money to realize her dream of opening a gallery. “I grew up in the San Joaquin Valley so Yosemite was my playground, so to me when you drive in [to Idyllwild] this [Tahquitz Rock] is Half Dome, this is mini-Half Dome,” said Trout. “I thought someday when I was done with my career and business, Mariposa would be the place. But then I found Idyllwild.” It was also home to the Idyllwild Arts Academy which Trout found inspirational.

Trout’s first order of business was to explore the art scene in Idyllwild. “I walked into one of the galleries and said, ‘So when’s the first art walk,’ and they said, ‘Oh, we don’t do that,’ and I said, ‘Well do you have exhibitions?’ And they said, ‘No, we don’t have them,’ so then I thought, ‘Oh, my gosh, maybe I made the wrong decision.’” A friend and local gallery owner, Grace Songolo, had a different take; she said, “No, Chris, you just have work to do.” And the pair, dubbed “Mutt and Jeff” by locals, set out to change the [art] world in Idyllwild.

The first art walk in Idyllwild in 1998 started with 250 plastic cups purchased 10¢ at a time from K-Mart. “K-Mart had glasses on sale for 99 cents but you could only buy 10 so we had to keep going back,” Trout laughed. “We thought, ‘Oh, if we have 250 people we’ll just ... Oh, my gosh. Not only did we sell those, we went through paper cups and we went to the market and got Styrofoam cups. It was a huge success, so that was the inspiration.”

A wiz at research and organization, Trout and a group of friends met for three months in her dining room to begin planning what would become the Art Alliance. “I wouldn’t have associated myself or try to build the Art Alliance as a ho-hum organization. It had to shine, it had to sparkle; it had to do what it said it was going to do. You can’t go out half-cocked and say, ‘Well, this is what they have in Santa Fe. Idyllwild is not Santa Fe. So Grace went to Santa Fe, I went to Ojai, Marcia Cox went to Orange County, someone else went to the Bay area and Riverside,” Trout explained. “We gathered their bylaws, their calendars and we spent three months in research. All of us were anxious to get going but we needed to research ... That’s the only way I know how to do things. You don’t just fly by the seat of your pants because you are asking people for a commitment and spending.”

With AAI in full swing, it was time to garner some recognition for the community. “We got in touch with John Villani [100 Best Art Towns in America]. He contacted me

"Getting that allowed all of the inns and businesses to say, 'Please come to Idyllwild, it is one of the 100 best art towns in America'; not small art town, best art town. It took six years and then I left the board. I was ready for younger people [to take over]."

Today, Trout is thrilled with the direction of the Art Alliance. "They are doing a fantastic job. It's phenomenal. Shanna Robb just amazes me; she's organized up the ying-yang and she doesn't take no for an answer. The fact that my name is associated [with AAI] and that Gary [Kuscher, AAI president] acknowledges me when I show up I'm just I'm shouting encouragement and cheering at the top of my voice."

Trout is directing all of her passion and skill to the de-

velopment of the new community center. "I am in charge at the community center in marketing and so forth. I am just up to here with commitment and passion and any skill I have ever had; I want it to happen. I want it to happen in my lifetime," Trout said emphatically. IWD requesting disadvantaged status from state

Idyllwild Water District's quest for greater funding and cost sharing from the state for the district's proposed recycled water facility is inching forward, according to General Manager Tom Lynch at the board's meeting last week.

The state water agencies rely on the U.S. Census Bureau's American Community Survey for calculating the community's median household income. This is the basis for designating a community as disadvantaged and therefore eligible

for more grant funds rather than loans. IWD failed to meet this designation because the 2012 survey estimated Idyllwild's median household income as \$54,167, but this included residents of Fern Valley and Pine Cove.

On the recommendation of former General Manager Terry Lyons, the board requested an income survey of just district residents. That income survey, which the district commissioned last fall, was completed and submitted to the state in February.

Specialized Utility Services Program Inc. con-

ducted the work during November and December. The result of the survey was a median household income of IWD residents of only \$42,996, which is just below the state's threshold for a disadvantaged community.

Besides the median income, the state applies two other criteria — population and customer fees. Lynch told the board that the population threshold was less than 20,000 people, which IWD easily satisfies. However, the fee sewer customers pay has been a more difficult hurdle for IWD to meet.

Financial Officer Hosny Shouman and Lynch are negotiating with the state over the sewer fees IWD customers pay. Generally, the state prefers to award communities who impose fees in the \$53-per-year range. Idyllwild's sewer fees average \$28 annually. With the inclusion of the customers' property taxes earmarked for the sewer district operations, it increases to \$48.

"The state thinks the sewer fees are too low for the median household income for this community," Shouman explained.

"One other area that

we might include is deferred payments and I'm recommending some other adjustments," Lynch told the board. "I think we can barely get there."

Most other business was deferred to the April meeting. A public hearing on the standby water and sewer assessments is scheduled for the April 16 meeting. Changes to the Personnel Manual will be considered then, too.

Also, consideration of a proposed revision to District Ordinance 62, which specifies how the district will establish and implement a water-shortage emergency plan also was deferred to April.

The revision is needed to account for statewide code requiring water sprinklers in construction. Since IWD restricts the number of "will serve" or equivalent dwelling unit (a usage metric), Lynch said, "Now that fire sprinklers must be installed with any new construction, we need a way to account for the additional water fixtures [sprinklers]. We are looking at different ways to account for the new fire requirements. Do we do it by fire sprinkler count, the size of the service, the size

of the meter, etc.? We are still researching the matter."

Since IWD entered Stage 2 status on Sept. 1, 2013, the district has issued three "will serve" letters, whose total EDU count was 3.84.

Lynch also reported that the projected cost of the new Tollgate storage tank is about \$456,000, which is \$116,000 more than the original estimate of \$300,000. The board authorized the difference to be transferred from reserves.

The tank is awaiting warmer weather to thoroughly dry inside, then the interior and exterior painting can be completed so the tank can begin being filled.

In the first two months of 2014, water production was 11.6 million gallons — 2.5 million (12.6 percent) less than the first two months of 2013. Despite the drought, this production level still exceeds the average production level for 2010 through 2012 by 14 percent.

Before the meeting started, the board adjourned to closed session to discuss potential litigation, which President Jim Billman said came to the board's attention after its March agenda had been posted.



Besides ambulance collections, IFPD has delays receiving payments for its work on fires outside the district. While these amounts are smaller, IFPD must still pay the staff's time and expenses while waiting months, and sometimes longer, before reimbursements are received from the federal or state governments, Capt. Mark LaMont explained.

For example, in August 2012, IFPD was dispatched to

the Volcano Fire in Riverside County and the Jawbone Fire in Kern County. Now more than 18 months later, the department still is awaiting reimbursement. Costs for another six fires, all within the past year, are still outstanding, he added.

The committee plans to review the budget before it goes to the commission for approval. Reitz expressed his goal that final commission approval of the budget might occur in June. He said an initial budget must be approved by July 1 and a final budget must be approved before Oct. 1.





Welcome! ...Come on in

This is the first in a series of unveilings.....of opening the doors to the actual designs and detailed plans for materials and building elements to be used in the construction of Phase 1 of the Idyllwild Community Center. Phase 1 includes the Butterfield Family Center, named after the benefactors who have contributed so much to making the dream a reality, and the amphitheater, the anxiously awaited facility for the performing arts that are so much a part of the essence of life in Idyllwild. Phase 1 also includes site development elements like parking and roads. The specific questions about the conceptual renderings and the building process have come from the Idyllwild community during presentations of videos of the plans in the last few months. The responses from Jim Marsh, the project architect, are printed below. To continue the conversation with Jim just email your questions and inquiries to info@idyllwildcommunitycenter.org.



Q. Jim, as an architect and artist, how do you begin the creative process of designing a building?

A. Initially, I go as far out and overboard as possible. I take all the ideas, dreams, hopes and wishes of my client and just let it rip. I create on paper a building that would be my greatest dream. As my vision is shared with my client, ideas are expressed and concepts are visualized. Then I pull back so that the final design, while functional, sustainable and cost effective, maintains the characteristics and aesthetics of the original dream.

Q. How do you resolve the struggle between free-rein design and budget realities?

A. We live in a world of constraints. We, ourselves, are spirits within a body. We design buildings that have a spirit but they have to be built with real money for a real client.

Q. What are the most striking features of the ICC design?

A. Idyllwild is a community of artists and intellectuals all living in a majestic environment. With this design we have had the opportunity to do something on a unique piece of property and make it not only fit the landscape but the community standards and expectations as well. The first feature will be the Idyllwild flavor of the building, a mountain craftsman style that fits into the pine trees and onto the deep sloping mountains. We will use natural elements for the retaining walls and ledger stone for the front accents of the

building. In doing so, we have kept and enhanced the natural environment without destroying river beds.

Secondly, the entrance gallery will be beautiful with windows connecting the inside of the building to the outdoors. The space will be filled with natural light and when you walk in the front door you will be able to see the forest setting right out the back windows. By using super energy efficient Low E2 windows and more insulation than normal, we will be creating a building envelope that is extremely energy efficient. California has the strictest energy requirements in the nation. With this design we will surpass the highest code requirements while still creating visual excitement.

And number three would have to be the 3000 feet of usable, revenue-generating space on the upper deck and lower terrace. When you are standing on the deck you are only 110 feet from the amphitheater so you have the best view of the activities held there and the very best place to take in the magnificent natural setting along Strawberry Creek. What a special place to have weddings, receptions, dinners, reunions, birthday parties or to just enjoy the summer concerts. With direct access to activity rooms and the kitchen, 350 people can be accommodated comfortably. Not only functional....these surfaces are taking advantage of the very latest building technology. The material is noncombustible, impervious to termites, and is virtually maintenance free, needing treatment only every 15 years. We will be using recycled content to be environmentally conscientious.

Q. How do you unify the design features of the project with the steep slopes, Strawberry Creek and a forest of indigenous trees?

A. The building is placed on the upper level to take best advantage of the pristine beauty of the site. The lower level is a natural habitat and the buildings will neither overpower nor compete with it.

Q. What do you want people in the community to say when they walk through the front door?

A. Both physically and philosophically this building belongs in Idyllwild.

Q. And finally, Jim, what has been the most rewarding aspect of your involvement with the ICC project?

A. That's an easy one.....the opportunity to work with the talented Robert Priefer. After all, we're both Cleveland Browns fans.
