## Fire officials ready for the fire season

Worried that residents are not prepared

In a formal proclamation, Gov. Edmund G. Brown Jr. declared May 4 through May 10 as "Wildfire Awareness Week," and as part of the week's activities, Cal Fire held an open house at the Hemet-Ryan Air Attack Base in Hemet last Friday.

Not only the governor, but speakers at the

Air Base stressed that residents and property owners have a responsibility to help reduce the chance and risk of

wildland fires.

"Firefighting alone cannot protect us, and every citizen, especially

## Judge restricts need for Adventure Pass

Forest use must be for more than parking

At least temporarily, a federal judge has restricted the U.S. Forest Service's Adventure Pass program.

On April 28, Judge Terry Hatter of the U.S. District Court in the Central District of California, sided with four hikers who objected to paying for an Adventure Pass solely for parking. The judge ruled that the

Forest Service can no longer charge a parking fee to forest visitors who do not use developed facilities such as picnic tables or restrooms.

The case, Richard Fragosa, et al. v. Randy Moore, et al., involved the four Southern California national forests — the Angeles, Cleveland, Las Padres and San Bernardino. The judge's decision was based on a section of the law that explicitly states that amenity recreation fees cannot be charged solely for parking.

Hatter's injunction prohibits requiring an Adventure Pass to

## Sheriff's deputies instrumental in saving life after crash

On Wednesday, May 7, Idyllwild resident James Sheahan, 53, lost control of his white 1992 Jeep Wrangler while driving west on Highway 74 between Valle Vista and Mountain Center. Sheahan and the Jeep plunged about 75 feet off the highway with the Jeep landing on its roof.

Sheahan, who was transported by ambulance to the Riverside County Regional Medical Center, has incurred major facial surgery. His wife, Kelly,

expects him to return home this week. "The doctors called it a 'mortal accident,'" she said gratefully.

The Jeep was unstable when it landed and Sheahan was hanging upside down, strapped by his seat belts. His faced was severely damaged and the gas tank was leaking, according to Kelly.

Several Riverside County Sheriff's deputies and an officer arrived on the scene shortly after the vehicle went over the side and ensured that Sheahan's Jeep did not tumble any further down the mountain.

# Banning man competent to be tried for arson

A trial readiness conference has been scheduled for June 18, and a jury trial may begin as soon as Aug. 4, for Steven Taylor Rutherford, 48, of Banning, the man charged with 13 felony counts of arson with enhancements including use of a delayed ignition device.

A medical report on Rutherford's ability to stand trial was submitted to a Riverside County Superior Court on April 29 and a hearing on its conclusion was held May 1. Following

the hearing and on the basis of the reports on Rutherford's mental competency, Judge Mark Johnson ruled that Rutherford "... is mentally competent to stand trial pursuant to 1368 [Penal Code]."

He then sent the dates for the next court proceedings in June and August.

The new charges against Rutherford involve nine arson fires in Riverside and San Bernardino counties. Rutherford has a prior arson conviction for a 1989 fire set in Riverside County.

# Charges reduced for Idyllwild man

Michael Darrenger Kellner, 20, of Idyllwild, was arrested April 7. The arresting charges included several felonies, but the Riverside County district attorney filed only a misdemeanor charge of stolen property (Penal Code 496 (A)). So the arresting felonies have been dropped, and only the one misdemeanor

charge remains on the record.

Kellner has pleaded not guilty to this charge, and an arraignment is scheduled for May 29. A drug court evaluation has been scheduled for May 12.

Kellner has previous possession of controlled-substance-related arrests and convictions.

Riverside County Mountain Battalion Chief Sean Dakin, also on the scene, confirmed that the action of the sheriff's men was critical to protecting Sheahan from further danger.

First on the scene was Community Service Officer Rodney Weirich, who acted quickly. Sheahan was going into and out of unconsciousness, so Weirich kept talking to him, while holding the Jeep tightly to prevent it from rolling further.

Soon three deputies arrived and gave needed assistance, too. Deputies

Carrasco, Schmitt and Kurtz were all instrumental in ensuring Sheahan's situation did not become a tragedy, according to Sgt. Agcaoili.

These men smelled the gas and got Sheahan out of the Jeep before a potential fire ignited. Hemet Station Capt. Ray Wood said, "We are submitting the employees involved for a department life-saving award."

According to Kelly, a vehicle coming up the Hill drove into her husband's lane, hitting the Jeep, and causing him to drive off the highway.

# Hill fire drill coming May 22

The Riverside County Fire Chiefs Association has organized a major fire exercise on the Hill for Thursday, May 22.

"It will offer several challenges to participant agencies," said Riverside County Fire Chief John Hawkins. "It will be a rapid response requiring unified command and a communication center, along with resource allocations."

Residents should neither be surprised nor fearful to see many fire vehicles and equipment moving around the Hill throughout that morning. According to Cal Fire/RCFD Division Chief Kevin Gaines, the exercise design incident commander, 40 to 45 fire engines may be visible on the Hill and in town that morning.

Signs will be posted throughout town and on the

highways alerting drivers to the ongoing fire exercise, said Jody Hagemann, senior public information specialist for Cal Fire/RCFD.

The Incident Command post will be at Idyllwild Pines Camp, so the presence of fire equipment, California Highway Patrol or Sheriff's Department vehicles does not indicate an ongoing fire or crime.

"I just hope we don't have so many fires that we can't do it," Gaines said. "This will be a very valuable exercise for all the agencies."

This will be a major fire drill that includes the activation of the county's emergency operations center and unified command during the exercise. Hagemann suggested it will be a full-scale simulation with the challenge for the public safety agencies to be ready and to react.

The last major fire exercise on the Hill was nearly a decade ago in June 2005. Nearly a dozen different federal, state and local agencies participated in that

drill to combat an imaginary fire burning through Bear Trap Canyon from Idyllwild Arts to Pine Cove. One of the objectives of this exercise was to test an evacuation plan, which the Mountain Area Safety Taskforce had prepared.

The value and quality of those evacuation plans were demonstrated last summer as the Mountain Fire burned from Keenwild south into Garner Valley and north on the eastern edge of the mountain.

Besides the local fire agencies — Idyllwild Fire Department, the U.S. Forest Service and RCFD — and law enforcement, several other nearby fire departments will be involved, including Hemet, Cathedral City, Palm Springs, Corona, Murietta and perhaps others.

## Droughts and wildfires in the future

Last week, the White House released the third National Climate Assessment report. The more than 800-page report stressed, "... climate change, once considered an issue for a distant future, has moved firmly into the present ... The observed warming and other climatic changes are triggering wide-ranging impacts in every region of our country and throughout our economy."

The authors — dozens of scientists from universities as well as the government — argue that human actions, many of which are beneficial, such as power plants producing electricity, have changed the planet's climate. And these changes will continue and, in some cases, intensify.

For the Southwest Region that includes Idyllwild, key messages were a continued reduction in snowpack and its concurrent diminishing stream flow. Less rain and snow also will create more drought conditions, which will increase threats of insect outbreaks and wildfires.

Just a week earlier, the American Lung Association issued its annual "State of the Air" report, which gave Riverside County an "F" grade for air quality.

The report reinforces the statements and warnings offered at Cal Fire's kickoff of "Wildfire Awareness Week" event last week. "There is mounting evidence that the combination of human-caused temperature increases and recent drought has influenced widespread tree mortality, increased

fire occurrence and area burned, and forest insect outbreaks."

While the report acknowledges that precipitation predictions are less reliable than predictions for temperatures, evidence and data mounts that rainfall and snow packs are becoming fewer and smaller. The report suggests that conservation efforts "... are not projected to be sufficient if current trends for water supply and demand continue."

The number of wildland fires and acreage burned has been

increasing for decades. The models employed in the report indicate there may be "a 74-percent increase in burned areas in California, with Northern California potentially experiencing a doubling under a high-emissions scenario toward the end of the century."

The recommended protective measures, such prescribed burning, mechanical thinning, and retention of large trees, are activities the U.S. Forest Service and Cal Fire began implementing on the Hill since the 2003 fire siege.

## Community Wildfire Plan under revision

The San Jacinto Mountains' Community Wildfire Protection Plan was the topic at the May 8 Mountain Emergency Services Committee meeting.

"It's a huge community impact and is not done by the [fire or forest] agencies," stressed Kathleen Henderson, Riverside County emergency services coordinator for the mountain.

The Brown Act issues revolving around Idyllwild Fire's March 18 visit to the Emergency Command Center in Perris remain critical to your health on the Hill.

I want to keep this issue on the front burner because IFPD seems determined to loosen itself from the county and give its dispatch service to a cheaper provider, eliminating those medically trained dispatchers we now have who could save our lives by phone while we await an ambulance.

It seems that everyone over at IFPD who should be representing you, the taxpayer, are drinking the Kool-aid of employees there who fear a county takeover. If you think they're looking out for your interests before their own, just note that many of those employees don't even live within the district but commute from off the Hill.

I'm not criticizing their own medical skills, but I am critical of the fact that the employees at that station seem to have a political grip on the commissioners and committees supposedly representing you.

At least the county is taking an interest in the mess there and considering bringing back American Medical Response to the Pine Cove area instead of continuing its contract with IFPD.

In the Feb. 6 issue of the Town Crier, I urged you to pay attention to this issue. Repeating what I wrote then, IFPD should not risk our lives just to save money. Let's all make our voices heard on this matter. Because we are isolated in the backwoods with no hospital, we especially shouldn't be backward in our approach to emergency medical care.

## Up the river without water ...

This week I'm heading up to the Kings River to do some kayaking. We had to go up to the Kings because the Kern River, our closest river for paddling, has no water.

The southern Sierras have 13 percent of normal snowpack and the Sierras overall have 16 percent of normal.

California has a water problem, or more to the point, California has a people problem. California has almost twice as many people as Australia, a country roughly the same size as the United States.

The Earth has a people problem — dwindling resources for an ever-growing population. We know that fossil fuel will eventually run out, clean drinking water is problem for many countries and it becomes more difficult to feed the world's seven-plus billion people. (I wonder what Kim Khardasian is wearing this week?)

I have an old friend who has been quite heavy most of his adult life. Over the years he has gone on many diets to lose the weight. Once

he hits his targeted weight loss, he goes off the diet and winds up at the weight he started with. This has been a trend for many years.

I've told him that he doesn't need a diet, he needs to change his lifestyle, but he continues to yo-yo back and forth. When it comes to resources, humans are diet-obsessed.

A few years back, when gas prices spiked, truck and SUV sales declined, but when gas prices settled down people started buying trucks and SUVs again. Now gas prices are high again and many are stuck complaining about the cost of operating their gas-guzzling vehicles. It's time for another diet.

When I was working in Australia, the driest continent on the planet, I noticed that every house I visited had both greywater and rain-water collecting systems. Everyone had them. By the airport was a Home Depot-sized building that sold nothing but hardware to create and outfit water-collecting systems.

Australians lived a lifestyle of resource management and efficiency, as much of the world does. Gas was \$12 a gallon, they had good mass transit and most cars were small and economical. I noticed that the majority of Australians adjusted to their circumstances and lived quite a nice lifestyle.

As Californians we need to come to terms with where we live. The West, with a couple of exceptions, is a desert that resides in the shadow of mountains. The arid landscape determined how the West was settled, where towns sprung up and how water rights were established.

California, more than any Western state, needs to adapt a lifestyle of water efficiency, not just going on a diet of water use every time a drought comes along. Water will always be an issue here.

The Japanese have toilets where the sink rests on top of the toilet bowl. When you wash your hands the water fills the bowl for the next time you flush the toilet. Modern watering techniques for agriculture reduce evaporation and save water.

We have the ingenuity, but do we have the will? Most of these problems can be reduced or solved if we have the will and flexibility to adapt to the world we live in.

## Brown and legislators agree on Rainy Day Fund

Partisanship and logjams are the results that the public has come to expect and frequently sees emanating from Washington and Sacramento. But last week, without rancor and name calling, Gov. Jerry Brown and state legislative leaders were able to reach a bipartisan agreement to create the Rainy Day Fund.

A preliminary budget proposal (Assembly Constitutional Amendment 4) was scheduled to be on November's ballot. It had originally been part of a 2010 budget deal and was scheduled to be on the November 2012 ballot but was moved to 2014.

But that device was complicated and raised some objections. The major issues with the proposal were that it does not address the volatility of capital gains revenue, does not provide a reserve for schools to help cushion future downturns and constrains the state's ability to pay down long-term liabilities.

In April, Brown asked legislators to reconsider this proposal and called a special session of the legislature to replace this Rainy Day Fund on the November ballot.

According to the governor's press office, the current Rainy Day Fund agreement announced on May 8 will provide the following:

- Increase deposits when the state experiences spikes in capital gains revenues, the state's most volatile tax revenue, and require annual deposits.
- Require supplemental payments to accelerate payoffs of the state's debts and liabilities.
- Raise the maximum size of the Rainy Day Fund to 10 percent of General Fund revenues.
- Allow transfers to be suspended and withdrawals to be made from the Rainy Day Fund when needed during recessions within prescribed limits.
- Create a Proposition 98 reserve to smooth school spending and avoid future cuts. This reserve for schools makes no changes to the guaranteed level of funding dedicated to schools under Proposition 98. Also, the Proposition 98 reserve would



## Supervisors react to grand jury report

The Riverside County Board of Supervisors officially received the grand jury report, which challenges its use of discretionary or Community Improvement Designation Funds. The county has 90 days to respond, but County Executive Officer Jay Orr and several supervisors clearly objected with the findings during their May 6 session.

Orr, a former deputy district attorney, stated that only seven of the 50 states have laws establishing civil grand juries. One of

the concerns is that these proceedings have no judge or lawyers involved. "It's very easy to seize an issue, and pick and choose evidence ... often the rules of due process are lacking, [consequently] unsubstantiated testimony can lead to questionable reports."

He stressed that Riverside County's program and policies for allocating CID funds was based on similar programs in both San Bernardino and San Diego counties.

Both supervisors Jeff Stone (3rd District) and John Benoit (5th District) supported the *See Grand jury, page 7*

not begin until school funding is fully restored following cuts made during the Great Recession.

Voters enacted the current Rainy Day Fund in 2004 with the passage of Proposition 58, which earmarks 3 percent of annual revenues into the Budget Stabilization Account. The current system has no restriction on when funds can be withdrawn and requires deposits, even in deficit years, unless the law is suspended.

# Sheriff Stan Sniff touts his record in re-election run

Stan Sniff, has served as Riverside County's sheriff since October 2007 and was first elected in 2010. He is running for re-election against a challenger from within his ranks, correctional Lt. Chad Bianco. Sniff also serves as coroner-public administrator since the Sheriff's and Coroner's departments were merged in 1999. As sheriff/coroner, Sniff oversees countywide patrol operations, jail operations, court security and coroner investigations.

A retired U.S. Army colonel with a bachelor's degree from the University of California, Riverside, and a master's from the University of Redlands, Sniff runs a large county department, with more than 4,600 full-time staff, 1,600 volunteers and an annual budget of more than \$602 million for the current fiscal year. In addition to providing law enforcement in all unincorporated areas of the county, the department provides contract policing for 17 of the county's 28 cities, serving 1.4 million of the county's 2.3 million residents.

Sniff cites his previous command assignments and experience as qualification for administering a large and multifaceted department – captain of the Robert Presley Detention Center in Riverside, the Banning Sheriff's Station and the Ben Clark Training Center. As chief deputy, Sniff supervised departmental training and personnel and East and West county patrol operations. As assistant sheriff, he oversaw all county court, jail and patrol operations.

As sheriff, Sniff instituted educational incentives to better the quality of serving personnel. He expanded educational requirements for advancement to include degrees not only in administration of justice or criminal justice, but also in liberal arts, sociology and other courses that emphasized communication, understanding diversity and critical-thinking skills. In 2010, Sniff imposed a requirement that anyone promoted to rank of captain must have, at minimum, a bachelor's degree from an accredited college or university, given the administrative complexity of overseeing department bureaus, facilities or stations.

In his statement in the Registrar of Voters Sample Ballot and Election Pamphlet, Sniff's challenger Bianco promises to add 350 sworn deputies to patrol stations while saving taxpayers \$10 to \$15 million per year through operational efficiencies; expand efforts to prevent early release of inmates; and create and implement a community-oriented policing program to proactively combat crime in the county. He faults Sniff for not instituting community policing and for maintaining a department with fewer sworn deputies than are necessary to provide effective countywide policing.

In the registrar pamphlet, Bianco states, "Real community change requires more than just a political figurehead. I am a motivated leader, actively engaged in the daily operations of the Sheriff's Department and fully committed to your safety."

In the pamphlet, Bianco noted that he "led the nation's most successful sting operation televised on NBC's 'To Catch a Predator,' taking 51 child sexual predators off the streets."

Bianco did not respond to requests for interview for this article but Sniff met with Town Crier management and editorial staff, something he has done annually since taking office.

In noting Bianco's charges and proposals, Sniff emphasized that although he proposes a departmental budget, it is the county Board of Supervisors that decides at what levels his department will be funded. Sniff has gotten BOS authority to begin up-staffing to 1.2 deputies per 1,000 residents in the unincorporated areas. "They've approved me spending red ink," said Sniff, noting that this year there would be no budget surpluses and that there still remains a \$20- to \$25-million gap in department funding that needs to be bridged. Given that reality, Sniff questioned how Bianco could either find or fund 350 new deputies. Sniff noted the difficulty of finding fully qualified sworn deputies — the significant training expense and years from sheriff's academy graduation to becoming a "turnkey" deputy as impediments to quickly increasing qualified deputy staffing.

Sniff pointed out that in 2007, when the department was last at 1.2 deputies per 1,000, the BOS, responding to emergent financial necessities caused by the economic downturn, ordered Sheriff's Department downsizing. And at that time, before downsizing, community policing was and had been in place in the unincorporated areas. While in effect, there had been two sheriff's cars on the Hill at all times and deputies spent six months on assignment before being rotated out, getting to know Hill communities, their residents and learning who were the upstanding citizens and who were the miscreants.

Sniff called Bianco's charges regarding no prior community policing "bogus" and noted that under his administration the department had received several large federal grants because of its successful community-policing programs. "We had won a lot of awards and community policing was our gold standard," he said. Regarding downsizing, that did disrupt existent community-policing programs in the unincorporated areas, Sniff said, "It was a budget decision [from the BOS] and my forced choice." He noted that community policing is still in place in contract cities served by the department because of greater municipal budgets.

Regarding early release of inmates forced by implementation of AB 109 and court decrees to reduce California prison populations, another area Bianco said he would address, Sniff noted that those decisions are not made by his department, but by the district attorney and the judicial system. He pointed out that early release is forced by current lack of adequate county jail bed space because of court-ordered transfer of state prison inmates to county jails. Sniff noted that expansion of the Indio jail facility will not be completed until 2017 and even when those beds are added, the number of beds will still be inadequate.

Sniff said the challenges of running and administering a large department complicated by financial difficulties and lack of adequate jail beds, require both administrative experience and significant field background. Of Bianco, a current lieutenant, not an administrative captain, Sniff said, "It's easy to throw jabs when you don't have a lot of credentials."

program and the past use of the funds.

"What's missing in the report is the real impact of the CID funds," Benoit said. "This is not inappropriate. It is entirely well-justified and transparent county support for some great projects."

Stone was equally appalled at the report's assertions and claims that supervisors were using the fund for political gains.

"With the exception of public safety expenditures that the Board of Supervisors allocates, funds from CID have had more of an impact on our citizens than probably any other program," Stone said.

"I am not ashamed of this program, I'm very proud of this program," he concluded. "It

works to get money to nonprofits quickly so they can help those in unfortunate times."

However, in a press release last week, Bonnie Garcia, one of his opponents in the state Senate 28 District race, opined differently: "Jeff Stone has been picking the pockets of taxpayers for years and past behavior always dictates future actions. We don't need another shake-down artist in the senate at a time when the institution is already under enormous scrutiny with three Democratic senators suspended from the body."

Former county District Attorney Grover Trask has been retained to advise and guide the Executive Office as it develops its response.

# Entertainment, food, Greenwood Award at Earth Fair

Idyllwild's 24th-annual Earth Fair this Saturday is themed "Born to be Wild!" The event is from 11 a.m. to 5 p.m. at its traditional venue — Town Hall.

The theme was chosen because this year is the 50th anniversary of the passage of the Wilderness Act, which President Lyndon Johnson signed Sept. 3, 1964, creating the Mt. San Jacinto Wilderness area. Also, Earth Fair Chair Holly Owens stressed that "wild" is in the town's name and home of the Earth Fair.

This year's Greenwood Award recipient is Wilber "Bill" Mayhew, emeritus professor of zoology at University of California, Riverside. During his 35-year career, he touched the lives of students, and his field classes introduced thousands to the natural world.

Mayhew co-founded the UC Natural Reserve System in the 1960s and he worked tirelessly to acquire wild lands for it, including the UC Riverside James San Jacinto Mountains

More than 750 areas have been designated as wilderness and preserve, nearly 110 million acres throughout the U.S. The states with the most wilderness areas are California, Arizona, Nevada, Alaska and Oregon. Wilderness areas are parts of national parks, wildlife refuges, national forests and the public domain, and they may include land in several different units managed by different agencies.

The U.S. Congress designated the San Jacinto Wilderness in 1964. It comprises 32,250 acres, which fall within both the Forest Service's San Jacinto Ranger

District and California's Mt. San Jacinto State Park. Within the San Jacinto Wilderness are 48 miles of trails, including 28 miles of the Pacific Crest Trail.

"One of the most unique features about where we live is the fact that we are surrounded by remarkable federal and state wilderness," Owens wrote in an email. "People come from around the world to enjoy and recreate in these areas, and many of us live here because of them. We are incredibly fortunate."

Earth Fair 2014 will feature live entertainment, organic Himalayan and Mexican food, and a diversity of interactive booths with recycled art and jewelry, composting and wildlife education. Entertainment during the day will include the a cappella style of Local Color, European/folk/gypsy-inspired music of

# Planning begins for Idyllwild Lilac Festival

Gary Parton presented his ideas for an Idyllwild Lilac Festival to the Garden Club at its May 6 meeting. Parton is devoted to establishing Idyllwild as the lilac center of Southern California and the festival would be a celebration of lilacs.

Over the past four years, he has organized the planting of more than 1,000 lilac saplings throughout town, especially in the Village Center area — Idyllwild Inn and Jo'An's.

His concept for the Lilac Festival is expansive, too. Beginning next May, he envisions a two- or three-week event, not the typical one weekend

excitement.

"Building a community spirit is what will happen out of this venture," he suggested. "It will make Idyllwild a May floral destination."

Parton has done his

research and found many lilac festivals throughout the U.S., mostly in the East, and a few have origins more than 100 years ago. Each is different, but each offers ideas of what events can be organized and held during the festival.

Examples include judged shows for individual lilac hybrids or lilac arrangements. Lilac walks from the garden at the Idyllwild Area Historical Society to the Idyllwild Library would pass many different varieties, each of which could be discussed, Parton said.

Another judged show might feature lilacs for the gourmet. "They are edible," he said with a smile. "Lilac desserts

or lilac salads would be created."

Other possibilities include school-oriented activities such as botany or writing, and parties or a barbecue at his Alpenglow Lilac Garden.

Parton is the third in an Idyllwild lineage of lilac devotees and propagators. Ron (Tommy) Emanuel, the "Lilac King," was first. Then Reva Ballreich, the "Lilac Lady," whose May opening of her lilac garden drew crowds from on and off the Hill, was Parton's lilac mentor.

Ballreich eventually served as president of the International Lilac Society. She also developed several lilac varieties here, including the "Idyllwild."

Parton is hosting a 2015 Idyllwild Lilac Festival Committee meeting at 2 p.m. Saturday, May 17. Volunteers and interested participants are welcome for this first organizing and planning session at 25025 Fern Valley Road.

"What we make of the festival is up to us," he said. "It doesn't have to be gigantic. It can be little; we don't have to

conquer the world in the first year." But he obviously imagines the festival continuing into the future.

A few of the cities and communities hosting lilac festivals are Mackinac Island, Michigan; Rochester, New York; and Spokane, Washington.

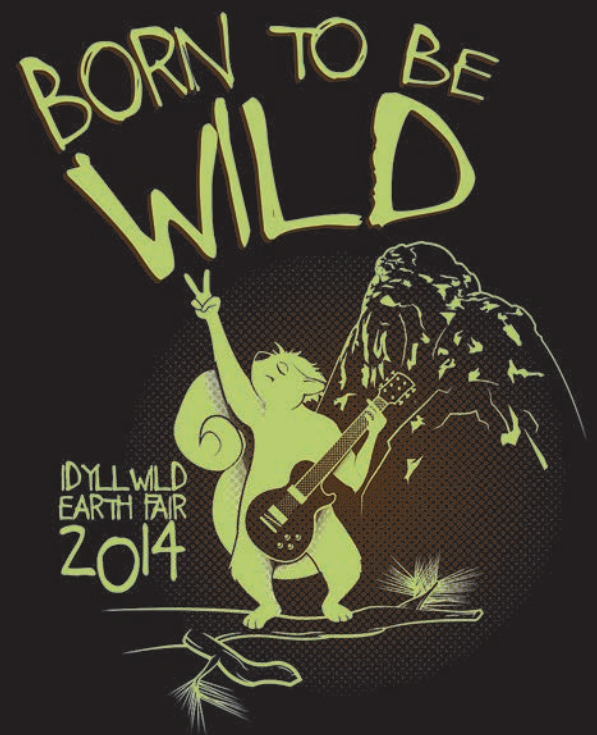
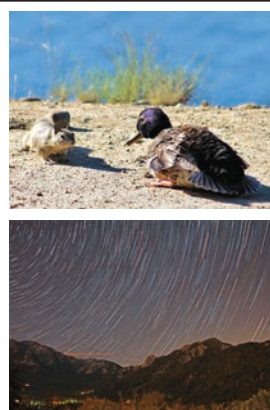

# Idyllwild Arts orchestra conductor Peter Askim moves on

After nine years helming the Idyllwild Arts Academy Orchestra as music director, conductor and composer in residence, Peter Askim is moving east to North Carolina.

Askim will become music director and conductor of the Raleigh Civic Symphony and Chamber Orchestra in Raleigh, North Carolina and the director of orchestral studies at North Carolina State University. "I'm excited to be working in the intellectual environment of the university, working with students from all around the world, and being part of the Raleigh Durham Research Triangle high-tech area," he said.

Askim recounts his tenure at Idyllwild Arts as one highlighted by 19 world and six West Coast premieres of new-music works. He also conducted the IAA Orchestra in the world premiere of John Cage's orchestral version of "Credo in US."

"There was an endowed fund established by Ransom [Wilson, previous IAA music director] set up to commission new works," said Askim.

As composer, double bass player and conductor, Askim is a leader in the new-music field. He is proud to have introduced so many IAA Orchestra students to new orchestral works.

"It was also really great to have the students have the opportunity to work with the composers," he said. Askim noted that in all but one instance, composers of the commissioned and premiered pieces attended the performances in Idyllwild. "It meant a lot to me to bring so much of this new music into the world."

Askim's reputation in the contemporary classical music scene

has earned him the sobriquet, "A Modern Master," from Strad, a monthly magazine for bowed string players, students and teachers.

He said he explained to his IAA students that if they were to be professionals in today's classical music scene, they needed to be familiar with and experienced in playing repertoire from all classical periods and genres, not just the traditional classical faire.

He cited as highlights some "out-of-the-box" premieres the orchestra performed with guest artists, including Richard Thompson's, "Cabaret Souls," the only recording of which the IAA Orchestra made under Askim's direction; Prokofiev's, "Peter and the Wolf," narrated by "This is Spinal Tap" creator and co-star and National Public Radio "Le Show" creator and host Harry Shearer and the appearance of So Percussion, an American percussion quartet based in New York City, whose appearances are "happenings" in which even the audience's emotions influence the live performance.

Askim was constantly trying to interest prospective students in attending the academy. "I spent a lot of time recruiting at festivals, conducting and doing extra teaching to promote Idyllwild Arts as a destination for serious music students," he said. "That was very important to me. I've always really enjoyed meeting and working with young artists. It's a time in their lives when, as a teacher, you can do something important with them."

Askim said he demanded and expected serious work from his students. "It takes a lot of effort to really care," he said. "I felt my job was to give them some kind of idea what's expected of them in

the professional music world, to play all kinds and styles of music.

"I told them that whether they liked a piece of music or not, while they played, it had to be their favorite in that moment, they had to love it."

Askim said he is passionate about his music and his teaching. "One must be honest and have the integrity of their work and do things for the right

reason. It's always about the music," he said. "You are your art."

Askim is also fundraising for his own summer teaching project, Director of The Next Festival of Emerging Artists ([www.next-fest.org](http://www.next-fest.org)) in which orchestral artists from ages 20 to 30 can study and be coached intensively, in a week dedicated to helping them move from school to professional work.

Riverside County's newest and fifth water park — the Drop Zone — opens Saturday, May 24, in Perris.

The 12-acre, \$25 million project started last summer just east of Interstate 215. The pools hold nearly 1.1 million gallons of water.

There are admission fees. The facility offers swim lessons on weekdays and Saturdays throughout the summer for fees, too. Besides an Olympic-sized pool, the park offers several other

water features, and includes a full concessions stand and small retail shop.

Among its numerous attractions are the Hydroplane FlowRider, a double-sized wave simulator, and a continuous river Jet Stream that can be enjoyed on available inner tubes. Terminal velocity slides and mat racers offer exciting challenges. Jumpers of all sizes can have a blast on Lil' Jumper's Landing Activity Pool. Three slides, sprays, cannons, jets and a giant tipping bucket are also

available to summer water lovers. And the Meridan Spring Pool is available for smaller kids. A sandy area for building castles and volleyball courts may also be enjoyed.

Height restrictions do apply to some of the features.

# Lisa Coffaro is living her art

By all indications, Lisa Coffaro of Idyllwild was born to be an artist. What else could explain a child, under the age of 10, picking up a drawing book and successfully drawing everything in it? "For my 5th birthday my friend got me a book I still have called, 'Girls Can Draw,' or, 'Drawing for Girls,' and I found I could draw everything in it and I was like, 'Where did that come from?'" Coffaro said, laughing. "For years I was afraid it would go away as quickly as it came." But it didn't go away; for Coffaro, it only got better.

Raised in Redwood City in Northern California, just 30 miles from San Francisco,

Coffaro was born to a mother who expressed her art through baking, decorating cakes and the like, and a father who dabbled in painting while working full-time for Lucky's, a grocery-store chain. "I can remember him helping me with my very first painting. It was a little tiny acrylic painting, like an 8-by-10, and it was this lone little pine tree with snow in the background. I wish I still had it," Coffaro reminisced. "[My Dad] painted and we have a picture of him sitting on the couch painting in one of my old floppy leather hats from the '70s in high school. He was my inspiration, I guess; everybody always said I was like him." Sadly, her father passed at age 58 (about 30 years ago) and her mother passed after being struck by a car seven years ago. Coffaro has three siblings who still reside in the Bay area and while none of them are artists, they are all creative.

In high school, Coffaro took every art class she could and, after a short break to create one of her finest works (son Gabe, who lives in Oakland), Coffaro entered college at San Francisco State with the same passion for art she had demonstrated since childhood. "My Mom used to try to talk me out of it and say, 'You should get a second degree in something practical,' but I said, 'No.' I can't type, I don't want to type," she said.

At San Francisco State, she studied art, painting and drawing, and dabbled in jewelry.

Coffaro, once an "oil" snob working only with oil paint until roughly 20 years ago, now paints with acrylics. "I had a teacher in school that made me feel like you can't get a good color with acrylic paint so I would never do acrylics. I changed my views on that," she said.

Like many artists, Coffaro found that supporting herself with her art was no easy task. "Unfortunately, I never truly supported myself completely as an artist, which I don't think is an unusual story. I did a lot of different jobs," she said. Those jobs included working in a bakery and an art supply store, and working as a teacher's aide with autistic kids. "I taught preschool art classes for 15 years, like 'Mommy and Me' classes, [to children ages] 18 months to 5 years old, through the recreation centers in the Bay area. I would go to different cities and work. It was fun. They were so cute. I do kind of miss that," Coffaro said.

Coffaro's job at an art supply store would prove fortuitous. "When I was in my early 30s, I was working in an art supply store and

they had a little jewelry section; that's when I started making paper and mixed-media jewelry," said Coffaro. "I took a silver-smithing class at a local community college and liked it, but I've taught myself everything about silver and glass." Jewelry became a big part of Coffaro's art out of necessity, but the work sparked a passion for the art form. "I started working in silver and semi-precious stones, then I saw glass and it

was, 'Wow, I can make my own stones. I can do anything I want in glass; I don't have to go find something someone else did.' Then I got hooked on glass. Glass is mesmerizing. You can do so much with it." Coffaro began making jewelry to sell about 25 years ago.

A friend who relocated from the Bay area to Palm Desert would introduce Coffaro to Idyllwild. "I came down to visit once and they brought me up here and

that was probably two years before I moved and I just fell in love with it," Coffaro recalled. "I never even knew [Idyllwild] existed."

A change in circumstance would allow Coffaro to live in the mountain community she fell in love with. "I wanted to live in the mountains and things happened in my life where I could do it," Coffaro said. "Within a month I decided I was doing it and I just packed up and moved. I drove all the way down and looked at one place and it was 'the' place. It's my dream place to live so I just did it and I've never looked back and I love it here." And while her friends thought she was crazy to pick up and move, she relied on Idyllwild's 'Top 100 Art Towns in America' status to convince her friends that she was, indeed, sane.

Now a full-time artist, Coffaro is living her dream. "It is so perfect. When I moved here, I decided I was going to become a working artist. I've always wanted to and it's happening now. I'm pretty excited."

A chance meeting with artist Scott Finnell would be the beginning of a collaborative relationship that introduced Coffaro to stained glass, a medium she now regularly incorporates into her art. "I had met [Finnell] through the Art Alliance. He needed someone to draw a design for him, and my friend actually said, 'She can draw it for you.' He said, 'Do you want to work with me?' and I said, 'Sure.' I've learned

a lot from him. He's very talented. We work on windows together then I do my own thing and he does his own thing and it's a good combination," said Coffaro. "I do my own stained glass — small sun catchers. They are on my website. He doesn't do sun catchers, he doesn't want to do them, so we don't conflict with each other."

After three years in Idyllwild, Coffaro's love for the small town has only grown stronger. "There's something about [Idyllwild]. I think it goes back to when the Native Americans were here. It was three years in April since I moved here and I still sometimes think, 'I live here, I can't believe I live here,'" she said passionately.

In addition to the art community, Coffaro also enjoys the many talented musicians that call Idyllwild home. "I knew that this was the place for me; the whole art aspect and the music. There are so many cool musicians here that are so talented. And for free? It amazes me. And the summer concerts. I look forward to those every year, it is just so cool."

With a successful outing at the first Second Saturday Art Show of the season on May 10, Coffaro is looking forward to the many Art Alliance events planned throughout the summer and to her future as an Idyllwild artist. "I plan on staying; there is no place else I'd rather be."

those living in fire-prone areas, has an important role in preventing loss of life and property for wildfire events,” Brown stated in his proclamation.

At the Hemet event, Cal Fire Director Ken Pimlott spoke about the interdependent roles of his agency and the public. “We are prepared; we’ve been staffing early. We’re asking the public to provide defensible space. We’ve done our part, it’s time for you to do your part.” This is the message being carried throughout the state.

All the speakers stressed that the drought exacerbates the fire threat. In Southern California, Cal Fire views the fire season as year round “... 365/7,” Pimlott said.

From January

through the end of April of this year, Cal Fire has already responded to more than 1,100 fires. During the same period last year, the number of fires was almost 700 while the five-year average is only 500.

“It is more apparent here in Southern California,” Pimlott said. “We don’t go out of fire season. Since January there’s been more than 400 fires. Generally there are zero or only a few.”

As if in response to the fire officials’ concerns, last week’s cool week turned unseasonably warm this week, and a Santa Ana wind advisory was issued Monday with high wind warnings for Tuesday and Red Flag warnings through Wednesday.

Riverside County 3rd District Supervisor Jeff Stone stressed the cooperation and partner-

ships that exist among the public safety agencies in order to provide necessary protection from wildland fires.

The continuing use of Hemet-Ryan Air Attack Base and its proximity to the mountains is critical, and there is no better demonstration of that than during the 2013 Mountain Fire. Stone was instrumental in preventing the shifting of the Hemet-Ryan Air Attack Base to March Air Base.

He announced that the long-promised expansion of Hemet’s airfield should be approved within months and work beginning next year.

“The board fully supports the work of the [Mountain Area Safety Taskforce] and the [Mountain Communities] Fire Safe Council to prepare for emergencies like the Mountain and Silver fires,” Stone said.

“But I can’t stress enough the need for wildland fire preparation.”

Forest Service Region 5 (Pacific Southwest) Fire Chief Shauna Lagarza also stressed the increase in fire danger and noted how smoothly the evacuation of the Hill occurred last summer due to the agencies’ cooperation and preparation.

“History repeats itself and last year’s major fires are a reminder for the future,” said County Fire Chief John Hawkins. “We have to be fire-ready. As the population grows in the wildland urban interface, I’m concerned. Property owners must follow the public resource code and create the 100-foot clearance around their parcels and make their properties safe.”

be purchased and displayed if the visitor’s use is solely limited to hiking and does not include using any developed facilities near the parking area.

The Adventure Pass costs \$5 per day or \$30 annually.

The Forest Service has no specific comment on the order because it is considered pending litigation. “The Forest Service is evaluating the court’s decision and assessing the next steps to take,” John C. Heil III, press officer for the Forest Service’s Pacific Southwest Region, wrote in an email to the Town Crier.

However, the Forest Service is modifying its current Adventure Pass policy, according to Heil.

“Recreation fees are still in effect in the four

Southern California national forests, and the Adventure Pass is still valid,” he added. “In the four Southern California forests, visitors parked in a designated fee site should display a valid Adventure Pass if they use any of the site’s other amenities.”

The basis for Hatter’s order was a 2012 case, Adams v. United States Forest Service, in the 9th Circuit Court of Appeals, which includes California. Hatter said, “Adams is quite clear. The Forest Service is prohibited from charging a fee solely for parking. If a visitor does nothing other than park, the fee is solely for parking and is, therefore, plainly prohibited by the [Federal Lands Recreation Enhancement Act].”

Mountain Communities Fire Safe Council Executive Director Edwina Scott described the history of the current CWPP and presented MCFSC’s plans for revising and preparing a new plan.

CWPPs were originally authorized in the “Healthy Forests Restoration Act of 2003.” One of the critical purposes of a CWPP, according to the Act, is “... it identifies and prioritizes areas for hazardous fuel reduction treatments and recommends the types and methods of treatment on federal and non-federal land that will protect [one] or more at-risk communities and essential infrastructure.”

The Mountain Area Safety Taskforce initially led the effort begun in 2004 and completed in March 2006. Eventually, the MCFSC planned and organized community meetings, which were significant and critical components of the final document.

Originally, the plan was going to address fuel treatments in the Idyllwild and Pine Cove areas; but as work progressed, the coverage area expanded, Scott said. It was clear that “all the communities on the Hill from Twin Pines to Anza were interconnected by fire threats.

“When it comes to fire, we’re all affected,” Scott said. “The right decision was to include everyone.”

The law requires regular review and updates.

Some work was done in 2010. In February, MCFSC President Michael Esnard contacted local agencies — such as Riverside County Fire and Sheriff’s departments, Idyllwild Fire Protection District, U.S. Forest Service and other agencies — to begin another review of accomplishments and recommendations for future projects on the Hill.

Esnard is planning a community meeting to discuss the plan and needed work later this year. When a draft is completed, it will be available for review and comments at [www.rvcweb.org/mastportal/FIREPREVENTION/SanJacintoMountainsCWPP/tabid/76/Default.aspx](http://www.rvcweb.org/mastportal/FIREPREVENTION/SanJacintoMountainsCWPP/tabid/76/Default.aspx), Scott promised.

“We want everyone at a community meeting to hear the fire people talking to them about the fuel treatments,” Scott said.

In other MEMSCOMM business, abatement inspections are underway. Cal Fire Battalion Chief Sean Dakin said outside-Idyllwild properties are being inspected. Idyllwild Fire Capt. Mark LaMont said all Idyllwild properties will be inspected by the end of May.

Before the meeting ended, Henderson briefly described the topics for meetings later this year. She hopes to have several water district managers discuss conservation and to have Mile High Radio Club make a presentation. Vector control and the mental health of disasters may also be topics.
