## Hill receives much needed rain

Rain drenched parts of the Hill this weekend, and while it was far from sufficient to eliminate the drought, it will help.

The U.S. Forest Service's Keenwild Ranger Station recorded 1.2 inches of rain from about noon Saturday, Aug. 2 through early Monday morning. But George Tate, an unofficial weatherman in Pine Cove, recorded slightly more than 2.5 inches over the weekend.

Historically, the area normally receives about 0.7 inches during July and another 0.8 in August. Already, about 1.25 inches have fallen at Keenwild and twice that amount in Pine Cove.

The weekend's rain varied across the Hill. While Pine Cove received nearly twice what Keenwild recorded, the James Reserve north of Pine Cove recorded more than 3.5 inches of rain and 2.6 inches fell on Mt. San Jacinto Peak. Anza to the south recorded only 1.23 inches and less than an inch fell in Hemet.

While some roads in Southern California, including a portion of Interstate 10, were closed partially or fully because of rain, roads on the Hill remained open and clear.

Through this week, the National Weather Service does not forecast any more precipitation. However, the Cal Fire Predictive Services forecast for August through November states, "This may allow the import of a greater amount of subtropical moisture into the region during the next few months. Therefore, precipitation through September may

remain close to seasonal normals." Nevertheless, it suggested that winter rains may arrive later than normal this year.

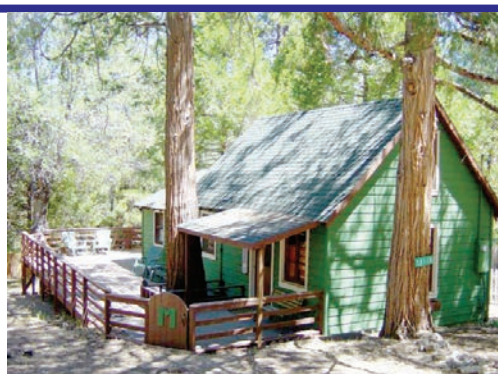

# Three Idyllwild crashes with injuries mar the week

Three crashes, one a motorcycle, one a solo vehicle, and one a two-vehicle incident with serious injuries marred the week in Idyllwild.

According to California Highway Patrol Public Information Officer Darren Meyer, the first took place at 11:50 a.m. Wednesday, July 30, on Highway 243 a mile and a quarter north of the Highway 74 intersection in Mountain Center. Rossen Chemelekov, 30, of North Hollywood, was traveling on his Honda motorcycle at an allegedly unsafe speed on a clear day, failed to negotiate a hard left turn and ran off the road. He was transported to Riverside County Regional Medical Center with minor injuries. According to Meyer, no drugs or alcohol were involved.

At 3:40 p.m. Saturday, Aug. 2 during a rainstorm, Madison Clowdus, 18, of Temecula lost control of her vehicle and struck a tree and utility pole on Highway 243 just south of Riverside County Playground Road. Meyer reported Clowdus had to be cut from her vehicle and required transportation to Riverside County Regional Medical Center with non-life-threatening injuries.

A third incident, at about 4:45 p.m. Monday, Aug. 4, resulted in major injuries to driver and passenger near McCall Park Road on Highway 74 in Mountain Center. A green Honda Civic allegedly traveling at an unsafe speed swerved to avoid a big rig, hit the embankment on the right side of the highway and sustained major front end damage.

Both the driver of the Honda, Benny Walter, 50, of Perris, and the passenger, Levante Hensley, 20, of Hemet, sustained serious injuries. Both were airlifted, Walter to Riverside Regional Medical Center and Hensley to Desert Regional Medical Center.

The driver of the truck was uninjured and the CHP report did not identify him by name. No fault has yet been assigned, according to CHP.



According to CHP Officer **Mike Murawski**, two males suffered major injuries after losing control of their Honda Civic while traveling at a high speed eastbound on Highway 74 near McCall Park Road Monday around 4:30 p.m. The Honda crossed the double-yellow line, colliding with a Penske truck traveling westbound. Idyllwild Fire transported both men in the Honda to Keenwild Forest Service station where they were transported by Mercy Air to nearby hospitals. The truck driver was uninjured. Idyllwild Fire Chief **Patrick Reitz** said one man was seriously injured and the other critically.

# Two small lightning fires in between downpours

Two small lightning fires occurred Saturday afternoon in the San Jacinto Ranger District. Both were in the proximity of Suicide Rock, thus their names, Rock 1 and Rock 2.

Both fires were small, about 50 by 50 feet. On both days, crews and helicopters were fighting and monitoring both fires. U.S. Forest Service crews from Kenworthy Guard Station in Garner Valley and Keenwild Guard Station in Mountain Center, as well as a crew from Cal Fire's Bautista unit, were on site. Helicopters, both

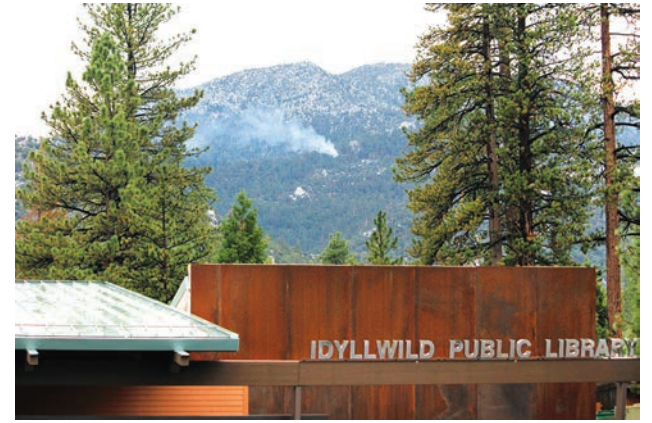
Forest Service and Cal Fire, dropped water on the sites, according to San Jacinto District Fire Chief Dan Felix.

Neither fire necessitated maintaining ground coverage overnight. Both fires were contained Monday afternoon, according to Felix.

The Forest Service

conducts aerial reconnaissance flights each day over the forest to assist with detection of new lightning-related fires. The reconnaissance flights are part of their normal operating plans after lightning storms.

## San Jacinto widening Ramona Expressway

The city of San Jacinto is widening the Ramona Expressway over about a 10-month period beginning Monday, Aug. 11, from the two existing lanes to five lanes.

Sean Motlagh, project manager in the City Engineering Department, said the project will modify traffic signals, improve drainage and add a bike path, too. The project is between Eagle Road and Lake Park Avenue/Main Street in San Jacinto, and will cost \$3.9 million to build with a final cost of \$5.2 million that includes plans and engineering costs.

Motlagh said though traffic will not be blocked, commuters from Idyllwild "may want to use alternative routes." The project is expected to end in June 2015.

## Lost hikers rescued Thursday night

The Riverside Mountain Rescue Unit helped extricate two lost hikers from the Mt. San Jacinto State Park and State Wilderness, Thursday night, July 31.

About 8:45 p.m., the Riverside County Sheriff's dispatch unit received a call from the two lost hikers. During the late morning and afternoon, they had hiked to San Jacinto Peak. But when leaving the Peak area, they mistakenly took a trail that put them on the Pacific Crest Trail between Little Round Valley Camp and Black Mountain Group Camp, according to the Sheriff's Department press release.

The hikers were identified as Ali Esparza, 23, of Jamul, CA and Phuong Nguyen, 25, of San Diego.

Besides RMRU and sheriff's deputies, the Sheriff's Aviation unit and staff from the Palm Springs Aerial Tramway participated in searching for the two lost hikers. About two hours later, the helicopter and RMRU members found them and they were airlifted to safety. The hikers were found in good health and no medical treatment was needed.

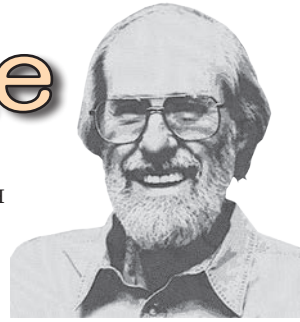

# Before Our Time

DESERT SUN SCHOOL ...

For nearly a century teaching and learning have been major activities in and around Idyllwild. Among the schools and camps responsible, one of the most interesting was the Desert Sun School, which for 44 years occupied the campus that now houses Astrocamp.

"Desert Sun" seems an odd name for an institution nestled in a mountain forest, but it's an artifact of the school's origin.

During the 1920s, newlyweds Edith and Richard Elliott were starting their family on a ranch in Coachella Valley near Mecca. As their two children approached school age, Edith's unhappy experience teaching in the local school suggested that the Elliotts might do better home-schooling them.

Three other families agreed, and in 1929 under the desert sun, Edith embarked on a year's experiment with five children, teaching at one of the homes that had playground equipment. Word got around and others clamored to join up.

So Edith enlisted her sister, Helen Jayne, as a colleague, and a little tent house was erected at the Elliotts' ranch. The instantly successful school was launched with 12 pupils in 1930. Before long it needed more space, and a second ranch was purchased.

Desert Sun School's future was foretold when the Elliotts added a summer camp at High Castle on the low ridge separating Saunders Meadow from Idyllwild village. The camp's popularity soon outgrew the premises. After three summers at Herkey Creek, the Elliotts leased 40 acres on Saunders Meadow, a site so inviting that in 1944 they bought it.

Maintaining three locations was expensive, so the desert properties were sold, and in 1946 Desert Sun School moved permanently to Idyllwild.

Living facilities were built for students and growth continued. In 1951, the school began a transition to a high-school program, ultimately discontinuing course work be-

low eighth-grade level. Purchase of surrounding lots and homes expanded the campus to 93 acres.

Desert Sun seemed especially compatible with Idyllwild developer Claudius Lee Emerson's original vision for a family friendly community. In the Elliott philosophy, boarding school was an extended family, fostering spiritual individuality, responsibility and moral values, along with academic learning.

This atmosphere appealed to celebrities, as well as parents with "difficult" children. The alumni roster became studded with such names as Sinatra, Lockheed, Linkletter, Astaire, Carmichael and Sellers.

Richard retired from teaching in 1968, but remained a trustee and active participant in Idyllwild community affairs. Edith continued as headmistress until 1971 when she retired shortly before her death.

Financial hard times of the 1970s soon caught up with Desert Sun. By 1983, resident enrollment had fallen from its targeted 250 to 156, plus 32 commuting Idyllwild students.

A decision was made to change the school's name to The Elliott-Pope Preparatory School, honoring equally the founders and the family that lately had kept it afloat financially.

But enrollment continued to decline, dropping to 100 boarders and 30 commuters by 1990, when Elliott-Pope finally closed its doors. The campus was sold to Guided Discoveries Inc., which inaugurated Astrocamp in 1991.

### FIRE ADAPTED COMMUNITIES ...

A fairly new term in wildfire policy is "Fire Adapted Communities." Important fire organizations have placed a new emphasis on this concept over the last few years and I think it leads us all in the right direction regarding the challenge of wildfire.

To begin with, by referring to adaptation, the term leads us to think of natural systems, and of the challenges presented to life within any particular ecosystem. For example, all the life we see around us in these mountains has successfully adapted to long dry summers when water is scarce.

If we are also going to live here successfully, we also need to accept that fire is a natural feature of our ecosystem and has been for millennia.

So a Fire Adapted Community is one where everyone accepts that fire is a feature of their landscape. Consequently, the community as a whole takes regular and consistent action to prepare for its occurrence.

Preparation involves several features. Foremost among them is reducing fuel within and around the community. This fuel reduction involves both the actions of homeowners cleaning their properties of hazardous vegetation as well as the actions of land managers creating and maintaining fuelbreaks at key points around the community.

Hardening homes is another important aspect. If we accept fire as an inevitable landscape feature, it makes sense for us to build and retrofit homes and other buildings in the area to be made increasingly difficult to ignite.

Another characteristic of an FAC is the creation and implementation of a Community Wildfire Protection Plan. This plan is put together by multiple parties to provide an overall view of fire prevention work in and around the community, including fuel reduction priorities, and to keep track of specific projects aimed at reducing community risk. It is intended to be a collaborative effort from public and private organizations, as well as area residents.

For action in response to the inevitable fire, another aspect of an FAC is public awareness of the "Ready, Set, Go" program. This program encourages residents to prepare their properties through abatement and ignition resistance, to prepare an evacuation plan by thinking about what one would take, and to be ready to leave immediately if an evacuation order is given.

I am very pleased to note that our mountain community has taken action in all these areas. The land management agencies, the U.S. Forest Service, Cal Fire and the Bureau of Land Management have long been active in creating and maintaining fuelbreaks.

The Mountain Communities Fire Safe Council has been assisting homeowners with education and grant funds for abatement for a decade as well. Recently, MCFSC began implementing the first hardening grant on the mountain, assisting homeowners in replacing vulnerable wooden roofs with Class A fire-resistant shingles and ember-resistant vents.

Our mountain also developed its own CWPP several years ago, and participating groups are now engaged in updating the plan. We should have an accurate and useful update by the holidays.

The essential systems theme that underlies the idea of the Fire Adapted Community is all based on the need for effective collaboration among all key stakeholders in the community. This idea is represented here by the Mountain Area Safety Task Force, which has been and continues to be an effective collaborative group. People who attend MAST understand that successful adaptation to fire involves just about everybody.

# Korman resigns from Fern Valley Water board

On June 20, Ron Korman resigned as director of the Fern Valley Water District. He was appointed to the board just one year ago at the June 21, 2013, meeting to fill the term of Diana Johnson who had resigned.

Only 16 months remained in Korman's term, which ends in December 2015. Next May, the Riverside County Registrar of Voters will begin accepting candidate papers for the August 2015 election.

In a June 20 letter to the district, Korman stated his reason for resigning: "I do not agree with the board's decision to employ the services of an outside consultant to address rate and revenue issues, nor can I, as FVWD director, support and condone needlessly spending nearly \$20,000 for a study."

Idyllwild Water District will be considering water and sewer rate increases without resorting to the use of con-

sultants, Korman stressed, and he feels strongly that FVWD should not go down the consultant road either.

When asked if he might reconsider before the FVWD August meeting, Korman responded adamantly, "No."

"It's too bad he resigned, he could have contributed," said board Chair Robert Krieger.

Korman left with a total of 14 years on the board. He served from 1998 through December 2011, when he retired with plans for extensive traveling that would result in missing multiple meetings.

But when FVWD announced Diana Johnson's vacancy in 2013, Korman was the sole applicant to complete her term.

The board will discuss plans for filling the vacancy at its Aug. 22 meeting, Krieger said. "We'll seek candidates and have them apply and go through the process."

## Supervisors consider pay raises for county officials

Raises for top Riverside County officials were on the agenda for the Board of Supervisors Aug. 5 meeting. The board considered increases for themselves as well as the other elected county officials — assessor/county clerk/recorder, auditor-controller, district attorney, sheriff/coroner and treasurer/tax collector.

State law authorizes each county's supervisors to set their own compensation. The Riverside board members have received no increases since 2007. Their current annual salary is \$143,031.

In 1998, a Blue Ribbon Salary Review Committee recommended that county supervisors' salary be set at 80 percent of the salary for a state Superior Court judge. Judges have recently received 1.4-percent and 1.83-percent increases.

If approved, the Riverside supervisors' salaries would increase \$4,656 — to \$147,688.

Elected officials would receive increases between 20 to 22 percent. The sheriff's and district attorney's annual salaries would increase by 22.33 percent to \$273,000 annually from the current level of \$223,200. Other elected officials would receive a 20.68 percent raise — to \$200,000 annually. Their current salary is \$166,700.

The new salaries would be effective Sept. 18. District Attorney Paul Zellerbach would enjoy only a few months of the raise before he leaves office in January for Michael Hestrin who won the June election.

## Pinyon murder suspects' trials separate or combined?

A hearing last Friday to combine the trial of Robert Pape and Cristin Smith for a triple homicide in Pinyon in 2006 was rescheduled for Friday, Aug. 22.

According to other media accounts, at the request of Smith's attorney, John Patrick Dolan, Riverside County Superior Court Judge Charles Stafford ordered medical tests for Smith because of a possible lump on his chest.

In July, the prosecution submitted a request to consolidate the trials, but Pape's defense objected. A hearing on the motion is later this month.

The District Attorney's office recommended that trials of Pape and Smith be joined based on California Penal Code 1098. "The present case grows out of the same event, occurring on the same date, involving similar behavior, and the elements of the three charges each defendant faces are the same ... Given the similarities between the cases of the two defendants, a joint trial is consistent with the legislative intent behind Cal. Penal Code sec. 1098," accord-

ing to the brief submitted to the judge.

Pape's attorney, Richard Blumenfeld, objected to the joining of the two trials for several reasons, which he argued would be prejudicial to his client. For example, Smith made a statement to Riverside County Sheriff's Department investigators that he might not want admitted to his trial. Further, Blumenfeld feels "the case against Mr. Smith is forensically much stronger (there is an utter absence of forensic evidence implicating Mr. Pape) ..."

On the night of Sept. 17, 2006, Becky Friedli, 18, her mother, Vicki Friedli, 53, and Vicki's boyfriend, Jon Hayward, 55, were found dead on their Pinyon property. Becky's body was found burning in a wheelbarrow outside the house. The other bodies were found inside the burning home.

On March 11 this year, both Pape, 26, and Smith, 25, were arrested and charged for these murders. They were high school friends.

## Smokey Bear plans birthday party in Idyllwild

Smokey Bear celebrates his 70th birthday Saturday, Aug. 9, in Idyllwild.

"Our Wildfire Prevention campaign has helped children and adults throughout the country understand their role in preventing wildfires," said U.S. Forest Service Chief Tom Tidwell. "For 70 years, Smokey Bear has empowered people to make a difference; his message of personal responsibility continues to be as critical and relevant now as ever. We look forward to cele-

brating many more birth-days of our beloved icon."

Smokey will be joined by the Forest Service Volunteer Association, along with the U.S. Forest Service, the National Association of State Foresters and the Ad Council at the Forest Service's Idyllwild Ranger Station from 1:30 to 3:30 p.m.

Smokey Bear is America's wildfire prevention icon. He has educated generations of Americans about their role in preventing human-caused wildfires. Smokey Bear was born on Aug. 9, 1944, when the U.S. Forest Service and the Ad Council agreed

that a fictional bear named Smokey would be the symbol for their joint effort to promote forest fire prevention. The Smokey Bear Wildfire Prevention campaign is the longest-running public service advertising campaign in U.S. history.

Artist Albert Staehle was asked to paint the first poster of Smokey Bear. It depicted a bear pouring a bucket of water on a campfire and saying, "Care will prevent 9 out of 10 fires." Smokey Bear soon became very popular as his image appeared on a variety of forest fire prevention materials. In 1947, his slogan became the familiar, "Only YOU Can Prevent Forest Fires!" In 2001, it was again modified to, "Only You Can Prevent Wildfires" in response to a massive outbreak of wildfires in natural areas other than forests.

In the spring of 1950, in the Capitan Mountains of New Mexico, a young bear cub found himself caught in a burning forest. He took refuge in a tree, and while managing to stay alive was left badly burned. The firefighters who retrieved him were so moved by his bravery they named him Smokey.

News about this real bear named Smokey spread across the nation and he was soon given a new home at the National Zoo in Washington, D.C. The living symbol of Smokey Bear, he played an important role in spreading messages of wildfire prevention and forest conservation. Smokey died in 1976 and was returned to Capitan, New Mexico, where he is buried in the State Historical Park.

## Noted anthropologist featured speaker at Historical Society

Dr. William "Pete" Lee's resume, rather than being a dry recital of credits and plaudits, reads like an adventure story — so many universities attended, so many languages and native dialects spoken, so many research projects in fascinating parts of the world while working as an anthropologist and documentary film and television producer. Lee seems a modern-day Indiana Jones — college professor, cinematographer, anthropologist and adventurer.

Lee is the featured speaker at the annual meeting of the Idyllwild Area Historical Society at 4 p.m. Sunday, Aug. 10, at Creekstone Inn in Fern Valley Corners. Lee said he would talk about museums — what they do, how they are governed and how they are funded.

As part of his varied career, Lee has served as executive director for a number of prestigious Southern California museums, among them the Los Angeles County Museum of Natural History, the Bowers Museum in Santa Ana and the Los Angeles Maritime Museum in San Pe-

dro. He currently serves on the board of the Hamilton Museum in Anza, sister museum of IAHS. Lee is a resident of Lake Riverside Estates in Aguanga just south of the Anza Valley.

Lee's museum experience, combined with his extensive fieldwork, makes his professional story a fascinating one. He recently returned from a month in Peru helping an archaeologist friend document a pre-Incan people, the Moche. He has conducted fieldwork in Kiribati, Japan, Peru, Venezuela, Canada and the Navajo nation in Arizona, New Mexico, Utah and Colorado. He has served as consultant for the Smithsonian Institution, the National Civil War Maritime

Museum, the U.S. Department of Interior, San Francisco National Maritime Park and the Museo del Oro, Bogota, Columbia. He has also organized numerous exhibitions at the museums for which he served as executive director.

Lee comes to his interest in history partly through family history. He is the great-great-nephew of Robert E. Lee, the Confederate States of America's leading general during the War Between the States.

IAHS President Marlene Pierce said the balance of the Sunday meeting, after Lee's presentation, will be a business meeting with reports on the state of the society and election of officers and directors.

## Steele scores another top-25

Brendan Steele chalked up his eighth top-25 finish in 23 entries so far this season at the Barracuda Championship in Reno last week.

He found more than 80 percent of the fairways with drives averaging 321 yards. Steele also hit more than 77 percent of the greens in regulation and gained 0.292 strokes putting against the field.

For a while on Sunday, the native Idyllwilder was in second place, only 1 Stableford point behind the leader, but a double bogey pulled him back as others advanced. He eventually dropped to 25th place, but still managed to earn some \$25,000 in official prize money, giving him more than \$1.3 million thus far this season.

More importantly, Steele earned 25 FedExCup points, giving him 718 total and placing him 62nd place in the standings with only two tournaments left in the regular season. Should he maintain a top-70 FedExCup standing through the first two playoff tournaments, he will be eligible for the third of the four playoff tournaments as well.

This week, Steele tees it up in the PGA Championship at Valhalla Golf Club in Louisville, the fourth and final major of the season. Total purse is worth \$10 million.

## ART'S CORNER

CONCERT REVIEWER

Putting together a musical program of any appreciable length for performance requires a reasonable amount of thought as to presentation — the material presented must be neither too long nor too short, must be balanced enough as to lend an agreeable amount of time for audience absorbing, and above all, must never be boring. The three presentations at Idyllwild Arts' Stephens Recital Hall provided ample evidence of this kind of thought process, even though some of the proceedings fared better than others.

Last Wednesday's program (which, unfortunately, this reviewer could not attend due to a previous commitment) was a prime example of balance aforethought — Beethoven's "D Major Violin Sonata," Bartok's "Contrasts" for violin, clarinet and piano, and Brahms' "G Minor Piano Quartet," in succession (with intermission between the second and third works) provided ample opportunity for enjoyment of both players (generally members of the Pacific Trio) and listeners alike. This was not quite as obvious in the Pacific Trio's second presentation on Saturday evening, with a program of Brahms' "G Major Sextet," effecting an overload in the first part (following an-

other genial analysis by Rich Capparella), and necessitating a longer intermission than usual in preparing for the next two programmed items.

Fortunately, the lighter moods of those two provided relief from the heaviness of the Brahms, even though the composer's intentions were well carried across by the violin, viola and cello pairings, and the remainder of the evening proved to be a falling-away rather than a letdown. Preceding the playing of Francis Poulenc's "Cello Sonata," soloist John Walz provided an anecdote of his teacher Pierre Fournier's characterization of the piece as "not friendly to the cello." Walz proved that statement's contrary, as his account of the four movements gave out all the good humor that is part and parcel of the composer's usual output — from the Parisian music hall to the mock seriousness of his post-World War II efforts.

Following that exhibition, the suite of themes from George Gershwin's "Porgy and Bess" was most effective, with both Walz and violinist Roger Wilkie providing the main melodic lines with the lyrics in mind (as should be typical for maximum theatrical effect). Nor should the efforts of pianist Edith Orloff be neglected (in both the Poulenc as well as the Gershwin); admirable in both embellishing melodies as well as in her accompanist's mode.

In between those two concerts, the summer faculty of Idyllwild Arts provided general examples of their talents on Friday evening, though the overall effect of skewing the performance toward the end items was present, somewhat

to the detriment of the performers themselves, as they allowed for a general drive to that end. The selections of short pieces did not make up for that thrust, however virtuosic in intent; and in general, the effect was a push toward the end without any relief, even with such exemplary oboe playing of two of Carl Nielsen's "Fantasy Pieces" by Ted Sugata and equally admirable piano accompaniments by Clara Cheng and Jeanette Louise Yaryan.

Virtuosity of the superlative kind, however, was reached before the final two items on the program by violinist Pasha Tseitlin, whose

solo accounting of the Ernst etude (theme and variations on "The Last Rose of Summer") was a marvel of technical effects; multiple stoppings, left-handed pizzicatos and such were virtually flawless in execution, and the audience rose to its feet in general approbation at its conclusion.

Tseitlin returned as first violinist in the final item, the also rarely heard "Terzetto" for two violins and viola of Antonin Dvorak, and as speedily a rate as its four movements go, it, too, showed marvelous effects in both bowing and harmonic techniques on the part of all participants.

In between the last-mentioned works, the vocal talent of Olga Perez was once again put forward; and though not so spectacular as her last season's display (with the "Habanera" from Bizet's "Carmen"), the short aria of Charlotte in Massenet's "Werther" still did provide ample enough evidence of vocal ability and power.

Coming up — the third in this summer's program of chamber music in Idyllwild, this Thursday at 8 p.m. in Stephens Recital Hall, with more of the Pacific Trio's virtuosity and eclectic programming on display.

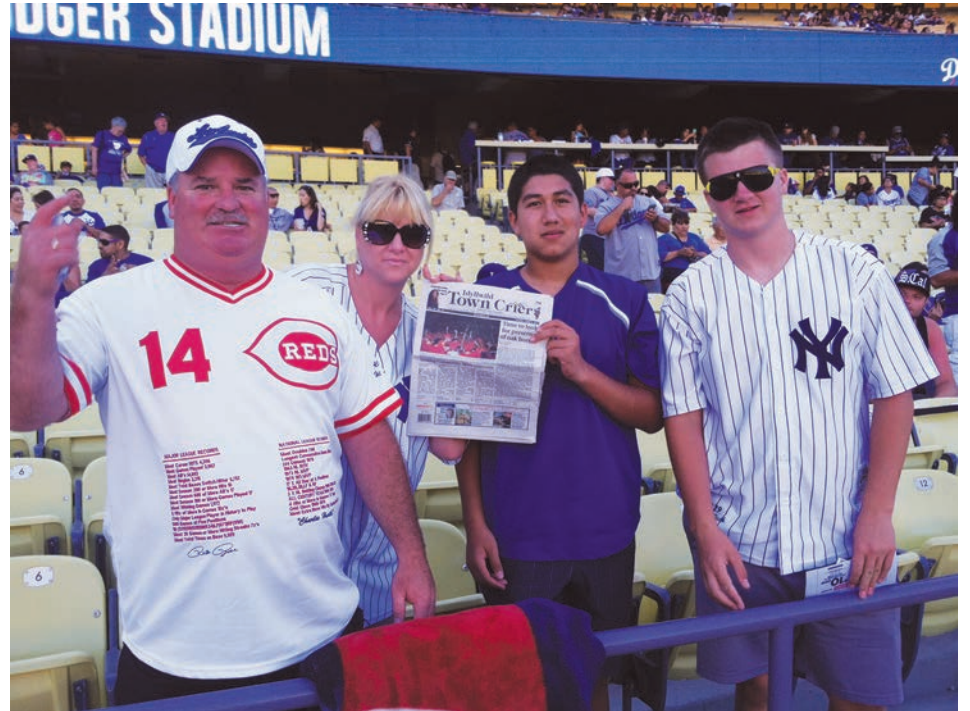

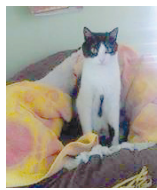

### 35 years ago - 1979

Locals were watching the night sky to view the largest annual meteorite show, the "Perseid Shower."

### 30 years ago - 1984

Bids were opened for the construction of the new Idyllwild Fire Station.

### 25 years ago - 1989

The owner of the last septic tank pumping service on the Hill shut his business after the closing of the Anza septic ponds. He joined other local septic tank pumping

business owners who refused to make the trip off the Hill, citing the danger of transporting heavy liquid loads.

### 15 years ago - 1999

### 10 years ago - 2004

Fire destroyed Arriba Mexican Restaurant.

### 5 years ago - 2009

Three locals qualified for triathlon world championships at Australia's Gold Coast Sept. 9 to 13. Brad Rechtferg, Lee Piche and Bill Whitman qualified for the swim, bike and running competition to be held at the Southport Broadwater Parklands in Queensland, Australia. Piche, 52, and Whitman, 46, were going. Rechtferg, 35, said for him it was not a good time to take a vacation.

### 1 year ago - 2013

The Strong Fire, reported shortly after noon Monday along Strong Drive in Fern Valley, was no match for human strength. Following on the heels of a mandatory evacuation because of the Mountain Fire in July, the 2-acre vegetation fire in Idyllwild brought panic but quick response as not only firefighters, but neighbors, readily quashed the blaze.

# IFPD looking into ambulance and water tender buys

## Current budget balanced, surplus expected

The Idyllwild Fire Protection District Finance Committee will begin investigating the possibility of consolidating existing debt and new loans for acquiring new ambulances and water tenders.

At the Aug. 4 meeting, Fire Chief Patrick Reitz asked the committee to begin examining the dis-

trict's options for paying off existing loans for two brush trucks and heart monitors.

These debts total \$213,800. The outstanding balance on the two engines is about \$173,300 and the balance is for heart monitors purchased in 2010.

Also, Reitz recommended the committee plan for several vehicle purchases, financed with loans and, thus, part of the total fi-

nancing package, Reitz said.

The top priority is a new ambulance and possibly a second ambulance within a year or two. Also, IFPD is considering purchasing one or two water tenders.

Reitz said the new ambulance could be "a demonstration unit returned to service after being rebuilt" or a previously used ambulance with a replaced chassis. "We want an option that maximizes taxpayers' benefits," he told the committee.

When asked about disposing of the existing ambulances, he replied that several options were available, including keeping one in reserve.

Cost estimates for the ambulances are between \$105,000 and \$150,000, depending on how new or pristine the vehicle. Water tenders may cost about \$65,000 each.

Commissioner Nancy Layton, committee chair, appointed citizen committee members Sue Weisbart and Calvin Gogerty to a subcommittee to pur-

sue the financing options. They hope to have an initial report at the committee's September meeting.

In other business, the committee recommended a proposed 2014-15 budget to the IFPD Commission for review at the August meeting and approval at the September meeting.

Estimated revenues total \$1,932,600, an increase of \$184,800 (10.6 percent) more than received in fiscal 2013-14, which ended June 30. Expenditures are estimated to total about \$1,805,378, or \$73,800

more than last year.

As a result IFPD anticipates a net surplus of about \$126,000 this fiscal year. IFPD's operating budget generated a \$16,200 net surplus last fiscal year, in addition to carrying over \$218,000 from the sale of a cell tower lease.

The committee agreed to hold its regular meetings on the first Tuesday of each month, a week before the regular commission meeting. The Finance Committee will convene next at 2 p.m. Tuesday, Sept. 2.

## Garcia and Stone battle for votes and dollars

The June 3 primary election determined that Republicans Bonnie Garcia and Jeff Stone would be competing against each other to fill the vacant State Sen. District 28 seat.

If the primary race was an indication of the level of competition, summer and fall will see a major battle between these two candidates.

Entering the campaign, Garcia has \$36,200 in cash available, slightly more than Stone's \$15,600. But fundraising for both candidates took a respite after the June 3 primary.

Since beginning the campaign, both candidates have received about the same amount of contributions. Stone's total since 2013 is \$436,700 and Garcia has collected \$417,200. The competition for more funding will be intense

over the final months.

Nearly 95 percent of contributions to Stone have come from California, including nearly \$2,000 from Idyllwild residents. The largest amount from outside California is \$9,200 from Arizona contributors.

About 87 percent of Garcia's contributions are from California. The 12.5 percent from other states includes \$13,200 from Phillips 66 and AFSCME in the District of Columbia, \$12,100 from Tennessee

donors, including Federal Express, and \$9,500 from Florida contributors.

Another significant difference between the contributors to the two candidates is the overwhelming support Garcia has from the local Indian tribal bands. Nine different bands, including the Soboba Band of Luiseno Indians and the Morongo Band of Mission Indians, have given her \$34,000. Stone's lone contribution is from the Pechanga Band of Lu-

iseno Indians, who gave him \$4,100 and the same amount to Garcia.

Garcia has also garnered support from several local Republicans, such as former state Sen. Bill Emerson and Assemblyman Brian Nestande.

Since the primary, the

third Republican in the race, Glenn Miller, has endorsed Stone while the fourth, Democratic candidate Anna Nevenic, has announced her support for Garcia.

with the Town Crier. "That philosophy is reinforced further by showcases featuring recent alumni such as Casey Abrams or musicians like Jason Jackson and myself who attended Idyllwild over 25 years ago." Since its inception in 1993, the festival has been a fundraiser for the school and Hawkins has long felt it was important to highlight the success of alumni so the audience "sees where their money is going." Many know that the opportunities and lessons they gleaned at IA gave them a head start in college and the professional music world, according to Jackson. "It always feels like coming home," Jackson said. "It always feels good. The festival gives me a chance to thank a lot of people. And I enjoy seeing

Marshall, Bob Boss and Evan." What Hawkins teaches is practice and patience. The 75-year-old still practices daily. Just before the interview, he had practiced scales for half an hour. "I'm teaching kids how to get in here," he said, pointing to his heart. Christopher, both a student of jazz and international performer, said this about his Idyllwild experience: "To be a successful professional in music is largely dependent on having a wide range of skills, not just musical. Entrepreneurship, empathy and listening more to your own voice than the opinions of others ... Popularity is not the arbiter of the quality of what one does. Reality is." Even on vacation, Hawkins participated in the music festival and teaching the bass to musicians from elementary age to adults in Alaska. Between

So teamwork is another skill he employs. For this year's jazz fest, he gives credit to co-chair Anne Finch for "... a collaboration that's been a lot of fun. Any suggestion was well taken and she ran with it. "The success of this year is her hands-on work.

She has taken the bull by the horns," Hawkins said admiringly. "She and Jeff Hocker have made it so smooth." Besides his former students, Hawkins is happy that many friends will be playing this year. Henry

Franklin, whom he met perhaps 50 years ago in Washington, D.C., will close the Stephens Recital Hall on Sunday. Another long-time friend and Idyllwild favorite, Harry Pickens, returns and will play for the first time with a new and younger friend and also a pianist, Josh White, of San Diego. Whether friends or students of Hawkins, these musicians will be living a dream in front of thousands. "I'm doing something I really believe in and was meant to do. Music is part of who I am," Jackson said with pleasure. Tickets for both days are \$110.
