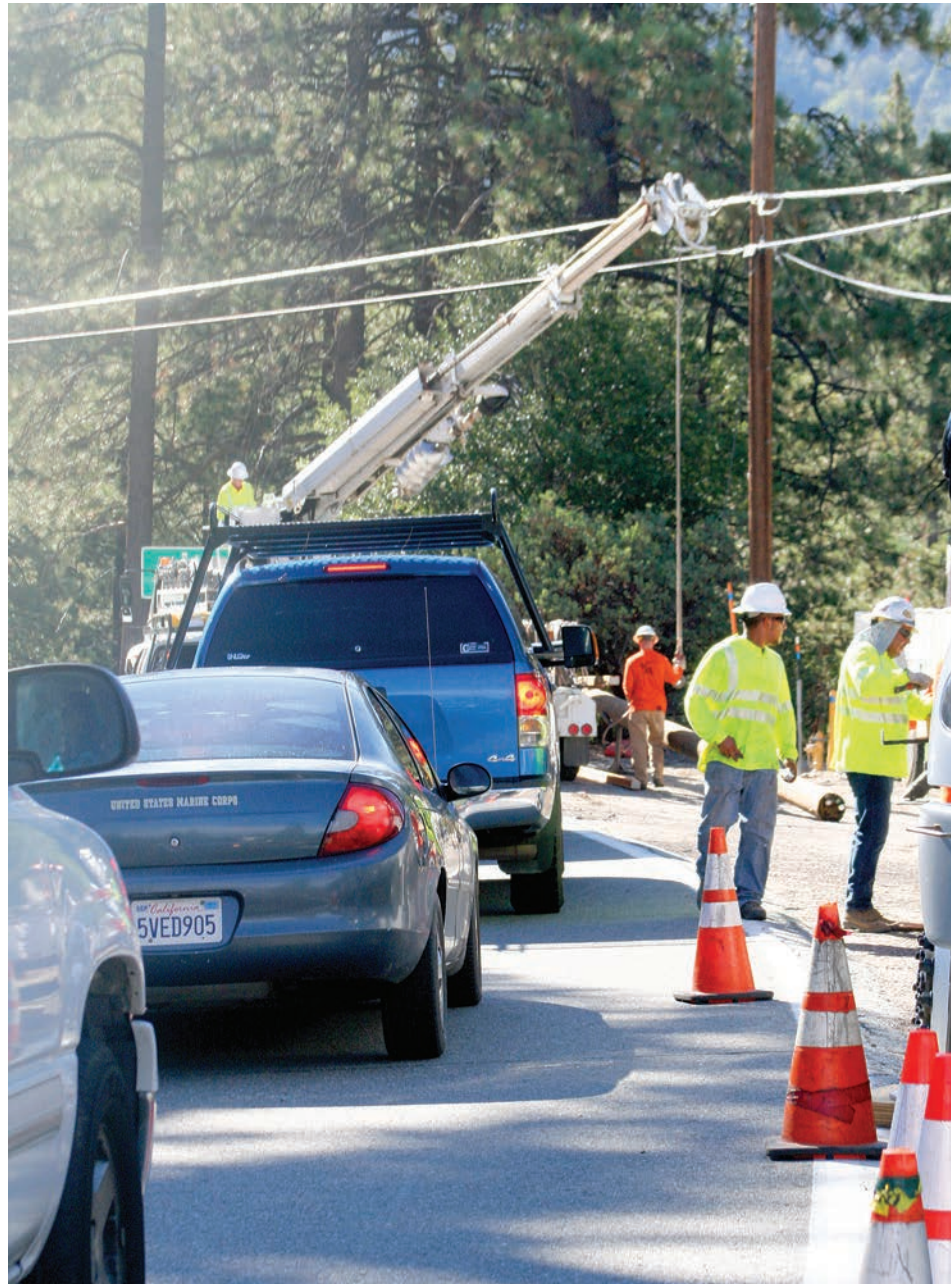

Arsonist sentenced to 45 years in prison

Last month, Steven Taylor Rutherford, 49, of Banning, pleaded guilty to 10 felony counts of arson. On Friday, Sept. 5, Riverside County Superior Court Judge Becky Dugan sentenced him to 45 years in prison.

Rutherford was initially charged with 13 counts, but three counts were dismissed as part of a plea agreement with prosecutors.

“Serial arsonists like Mr. Rutherford present a continual danger and threat to everyone in the Inland Empire region,” Riverside County District Attorney Paul Zellerbach said in a press release. “This sentence ensures that he will spend the rest of his life in prison and will no longer be a threat.”

Cal Fire/Riverside County Fire Department Chief John Hawkins, who attended the sentencing hearing with several other fire officials and arson investigators, told the Town Crier, “I think justice was appropriately done. He was a recidivist arsonist in our area and he admitted he got immense rush from setting fires.”

Rutherford’s arrest on June 28, 2013, was the culmination of a lengthy investigation by Cal Fire arson investigators. He was connected to the series of arson fires through law enforcement and commercial business surveillance cameras, as well as lawfully placed GPS trackers on his vehicles, according to a district attorney press release.

“We knew he was in the area and our team put two and two together and focused on him,” Hawkins said. “We used pretty tight surveillance.”

Several of the fires were along Highway 243 in the Poppet Flats and Mt. Edna areas.

“The public deserves and expects the highest level of protection and not worrying blindly,” Hawkins added.

Rain storm comes and goes, drought remains

Hurricane Norbert, which formed last week and evolved from a tropical storm into a hurricane on Sept. 3, moved north from Mexico and Baja along the California coast. As Norbert weakened, it drew significant moisture into the atmosphere and over the local mountains.

The storm's intensity varied through the local area and region. Sunday afternoon, almost 1.8 inches of rain fell at the Idyllwild Fire Station and 1.6 inches in Pine Cove. However, the U.S. Forest Service recorded just 0.1 inches of precipitation at the Keenwild Fire Station.

The gauge on Mt. San Jacinto recorded 1.5 inches of rain late Saturday afternoon, but only 0.12 inches at the peak on Sunday.

At Vista Grande, further north, 0.75 inches was recorded.

Both Sunday and Monday, the National Weather

Service issued flash-flood warnings for Riverside County Mountains and desert areas.

Highway 74 was closed for nearly five hours Sunday afternoon from Willowbrook Road to Mountain Center. At the Cranston Fire Station 2.1 inches of rain fell in two hours. This was the most recorded in the area. The flash flooding and debris created an impassable situation, which Caltrans cleared.

An off-road vehicle got trapped in the water near the bottom of Bee Canyon, according to Darren Meyers, public information officer for the California Highway Patrol San Geronio Pass unit.

Norbert was the 14th named tropical storm during the busy Eastern Pacific storm season.

Fall tropical storms are not unusual in this area. The National Weather Service has records of major storms back to August 1878. In September 1997, Hurricane Nora

brought almost 5 inches of rain to Mt. San Jacinto and nearly 3 inches at the Idyllwild Fire Station. But that pales compared to the 10 inches at the peak and almost 4.5 inches in town that fell in September 1976 due to Tropical Storm Kathleen.

However, the cooling rain is not a harbinger of an El Niño relief to the current three-year drought. Last week, National Weather Service forecasts said, "At this time, the consensus of forecasters expects El Niño to emerge during

September-October and to peak at weak strength during the late fall and early winter."

Last week's report placed a 60- to 65-percent chance of an El Niño pattern developing during the fall and winter.

The Cal Fire Predictive Services forecast for September through December reinforces this forecast: "Precipitation is still expected to be near average this winter, but the prospect of wintertime rainfall bounty courtesy of a strong El Niño is probably off the table."

As a consequence, it

opined, "Large fire potential may not decrease to normal over Southern California until December."

While a reprieve from the drought does not appear imminent, a recent study published in the "Journal of Climate" predicted that the current drought has an 80 percent chance of lasting a decade. This research combined paleoclimate data with climate model projections to arrive at this estimate.

Hearings on possible rate changes

The California Public Utilities Commission will hold a series of Public Participation Hearings throughout the state to hear directly from members of the public about cases related to electricity rates.

Restrictions on residential rate design were lifted after the signing of Assembly Bill 327 in October 2013, and utilities can now propose residential rates that are more reflective of cost. These could include baseline percentage changes and time of use rates. Hearings are:

- 2 and 6:30 p.m. Tuesday, Sept. 16, Al Bahr Shriners Center, Upstairs Room, 5440 Kearny Mesa Rd., San Diego.
- 2 and 6:30 p.m. Thursday, Sept. 18, El Cajon City Council Chambers, 200 Civic Center Way, El Cajon.
- 2 and 6:30 p.m., Tuesday, Sept. 23, CPUC Auditorium, 505 Van Ness Ave., San Francisco.

Enforcement increases on highways

Caltrans and the California Highway Patrol are warning motorists statewide that the CHP is conducting maximum enforcement of traffic laws in active construction zones as part of a public safety campaign focused on work zone safety.

As part of this campaign, Caltrans will activate its electronic highway message signs in active construction and maintenance work zones around the state to display the following warning: "Workers Ahead, CHP on Patrol, Max Enforcement."

"This is about protecting the safety of California's motorists and the men and women working along the state's highways," said Caltrans Director Malcolm Dougherty. "Using our highway message signs and increasing CHP's presence around these areas, we are reminding California drivers to do their part in reducing collisions and hazardous conditions in these work zones."

Drivers should be aware that any traffic infraction committed within a construction work zone will result in a doubling of the usual fine. The enforcement message will be displayed Sept. 23 to 25 on any electronic highway message signs within 5 miles in advance of active construction work zones. The enforcement message will be activated when there are no critical emergency or traffic safety messages or Amber Alerts.

Health care for local uninsured

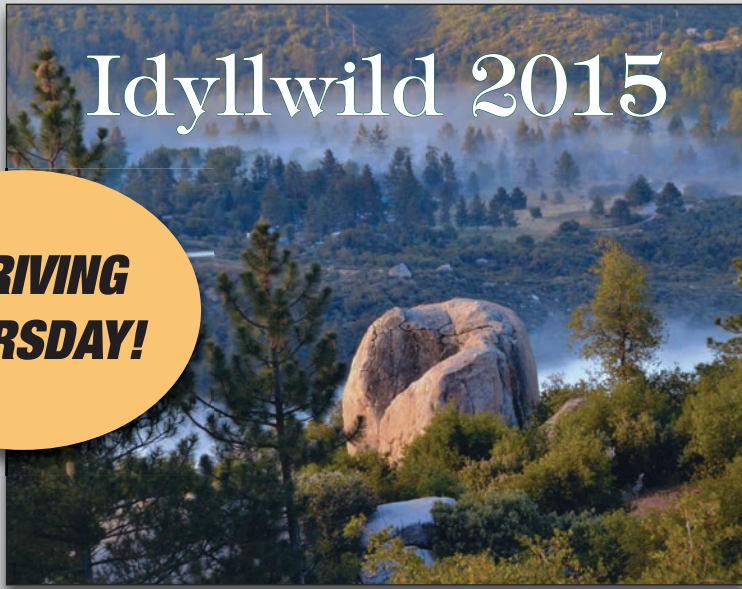
A Riverside County Mobile Health Clinic brings free health care services to Idyllwild at Town Hall, usually the second Wednesday of every month.

Services include general medical exams, sick-child visits and health screenings for blood pressure, diabetes and vision.

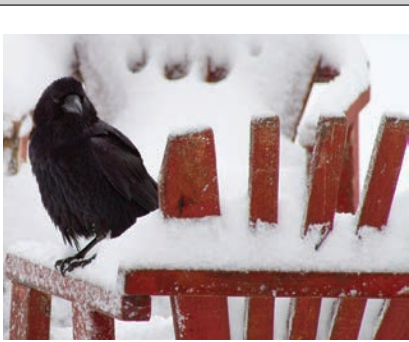

Covered California offers dental plans in 2015

Last month, Covered California announced that it is offering family dental plans in 2015. However, "You need to enroll in a Covered California health plan to be eligible for their dental plans," affirmed Larry Hicks, Covered California spokesperson.

Individual health plans will include pediatric dental benefits starting in 2015.

"This is great news for families and children, because all children enrolled in Covered California will have dental coverage embedded in their comprehensive health plan," Covered California Executive Director Peter V. Lee said in a recent press release. "They will be getting better coverage and more for their money."

The pediatric plans are for children up to age 19. Covered California has three different products from five com-

panies. The products range from a dental preferred provider, an exclusive provider, to a dental health maintenance organization.

The children's dental insurance plans feature standard copayment, deductibles and coinsurance requirements, according to the brochure available online at hwww.covered-ca.com/PDFs/CC_Childrens_dental_plan_rates.pdf.

The optional stand-alone family dental plans that offer coverage for adults will not be available at the beginning of open enrollment, which starts Nov. 15, but are planned to be added in early 2015.

Covered California will offer both dental health maintenance organization (DHMO) and dental preferred provider organization (DPPPO) plans, giving consumers a choice in

the type of plan that will work best for them. There is no financial assistance available for the optional adult dental benefits.

In Riverside County, the monthly premiums for an adult family plan range from \$11 to \$53.99.

Families who wish to purchase a family dental plan must include at least one adult who has purchased a Platinum, Gold, Silver or Bronze insurance plan through Covered California.

Legislature enacts attorney general's truancy proposals

Nearly a year after California Attorney General Kamala Harris released her first report on "In School + On Track," the state legislature responded to her plea to change the pattern of truancy in state schools.

In September 2013, Harris released the report as an effort to draw attention to the problem of truancy of school-aged children and its lifetime effects on them. In March, she, along with Superintendent of Public Instruction Tom Torlakson and four state legislators, proposed a package of legislation to encourage reducing elementary-school truancy throughout the state.

The legislature approved all four bills that are now awaiting Gov. Jerry Brown's signature.

"Each year, approximately 1 million California elementary-school children are truant from class. Good education policies are meaningless if students aren't at their desks," Harris said. "I applaud the legislature for bringing us one step closer to stopping this crisis."

If signed into law, these bills will help schools and

counties work with parents to address the core reasons behind truancy and chronic absence. They give local school districts and counties tools to comply with attendance-tracking requirements in the Local Control Funding Formula, state truancy mandates, and state and federal reporting requirements.

Two of the bills will help ensure that schools, districts, counties and the state can evaluate the success of interventions to combat truancy and chronic absence.

Assembly Bill 1672 expands the annual reports from local School Attendance Review Boards to include information on student enrollment, absence and truancy rates, district attorney referrals and intervention outcomes. Current annual attendance reports provide minimal information about intervention outcomes, so it is difficult to get the full picture of efforts around the state.

AB 2141 requires that district attorney offices provide a report to school officials on the outcome of truancy-related referrals. This will help school officials determine which outcomes are most effective and guarantees baseline information sharing between referring agencies and prosecutors.

Harris' 2013 report, "In School + On Track" (<https://oag.ca.gov/truancy>) contained the first statewide statistics on California's elementary-school truancy crisis. It revealed that in the 2012-13 school year, 1 million elementary-school students were truant and 250,000 elementary-school students missed 18 or more school days at a cost of \$1.4 billion in lost funds to California school districts. In some California elementary-schools, 92 percent of the students were truant last year. Annually, dropouts cost California taxpayers an estimated \$46.4 billion in incarceration, lost productivity and lost taxes.

Next month, Harris will issue the 2014 "In School + On Track" report containing updated statewide figures on elementary-school truancy and its fiscal impact on local school districts.

Second chance to see 'Will in the Woods'

"Will in the Woods: A Shakespeare Collage" is the latest production from Idyllwild's Stratford Players. Sunday's rain didn't dampen the event since the players moved the St. Hugh's Episcopal Church outdoor performance to the Christian Science Church across from Town Hall.

But for those who missed Saturday's outdoor event, the Stratford Players will be performing "Will in the Woods" at 3 p.m. this Saturday and Sunday, Sept. 13 and 14. Before the performance at 2:35 p.m., Doug Austin and Rob Crisell share their insights into Shakespeare and the history of the time he was writing.

"It is a collage of Shakespeare — scenes and soliloquies," said Christopher Morse, a Stratford founding member and a cast member, about the 3 p.m. performance. "We're taking William Shakespeare's best moments."

Director Marsha Kennedy, another Stratford founder, said the idea occurred to her as she became aware that a number of people do not love Shakespeare or have not been exposed to his works.

"This is a good experience for play-goers to develop a sense of Shakespeare's ability," she said. "It surprises some people who previously can't take Shakespeare that there's a great deal of intensity in his plays."

And director Kennedy assures that the lines and scenes are delivered in a very conversational style. "This gives them a better chance to understand what was said and meant," she stated.

According to Kennedy and Morse, there is no formula for the selections. Each was chosen for a different reason. For example, Morse chose Cassius's monologue from "Julius Caesar" where he tried to persuade Brutus to join the conspiracy to assassinate Caesar.

This production is the third year Stratford has performed "Will in the Woods." Kennedy stressed that all the scenes and soliloquies are different from prior performances.

Tickets are \$15. On their website, the Stratford Players say, "Our performances are like those in Shakespeare's time — outdoors in the afternoon."

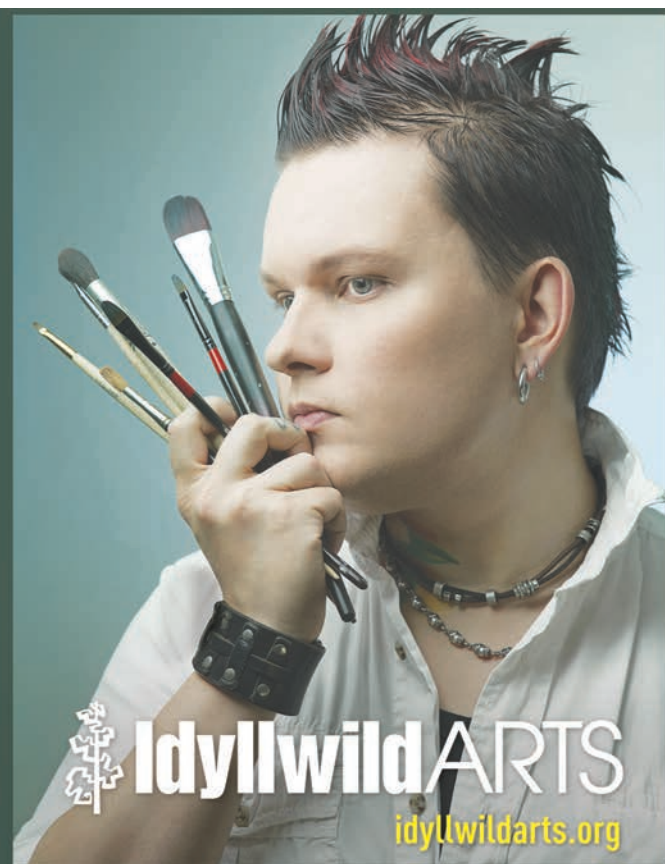

Paul Carman is playing for keeps

Paul Carman first picked up the saxophone when he was in seventh grade, but his family had begun planting the seeds for what would become a lifetime filled with music early on. "I studied piano when I was 6 years old, so that was in the first grade, and then by about the third grade, I rebelled," Carman recalled. "I wanted to play guitar, so I finally got to have guitar lessons." And while his parents relented, they still insisted that he take classical guitar lessons. After a year or so, he finally convinced them to allow him to take rock 'n' roll guitar lessons. "I wanted to play 'House of the Rising Sun,'" he said with a smile.

A natural at the piano and guitar, Carman, at his father Jerry's urging, decided on the saxophone at a "pick-an-instrument thing" at school. "My Dad was into Charlie Parker and Gerry Mulligan and Paul Desmond," he said. "I was good at music, so when I picked up the saxophone in seventh grade it just took off because I already had music training," he explained.

A California native, Carman was born and raised in Los Angeles near the airport in the Playa del Rey and Westchester areas. In 1969, his father received a promotion that resulted in the relocation of the family to Cleveland. While a high school freshman in Cleveland, Carman met a sophomore and junior, also saxophone players, who were into old big band music. "One of the guys, the tenor sax player, would wear vintage clothes; he would wear zoot suits to school. [He was] a total outcast," Carman said. They formed a band. "There weren't enough players in our high school, but they got the best players from about five different area high schools and formed an 18-piece big band." Carman played with the band at country clubs every Friday and Saturday night all through high

school.

After graduating from high school in 1973, Carman attended college for a year as an engineering major and after dropping out for a time, he changed his major to music and returned to finish college. He was also newly married with a child. A pool man by day and musician by night, Carman supported his family working three days a week and performing gigs at night. After six or seven years, he burned out on the poolman gig and sold his route using the money to purchase recording equipment. At age 26, after a stint as a massage therapist, Carman decided to become a full-time musician. Seven years later, he met recording artist Frank Zappa.

In the mid-1980s, Carman met Zappa at his home studio. "The Synclavier was the first sampling keyboard. Sampling means it actually records a person playing something and then when you press the keys on the piano it plays the recording back, so it is a real instrument," said Carman. "Zappa was one of the first people to embrace this instrument; it was horribly expensive back then — hundreds of thousands of dollars. My friend Bob became mostly his Synclavier engineer... So Zappa told my friend Bob one day, 'I want an old Ben Webster tenor saxophone sound. Know anybody?' Once in the studio, an accidental meeting with Zappa proved fortuitous. "Frank wasn't supposed to be there that day, but he ended up being there," Carman recalled. "He starts asking me to do strange things like, 'Make kind of a crazy fluttery sound.' What that led to was that the session went like four hours long and by the end of the session, he's got me playing with low B flat harmonics running across the studio and spinning in front of stereo microphones. He called that the Queen Mary sample." Carman's sound would be included in Zappa's first Synclavier album titled

"Jazz From Hell," released in late 1986 or early 1987.

Zappa formed a new band in 1988 and, as promised, Zappa called Carman. The band toured throughout the U.S. and Europe with Carman being away from home three to four months at a time. "The music was amazing. Most guys do like a Brittany Spears tour and there's 15 songs they do every night for two years; with Frank, we did about 30 songs a night ... We had over 100 tunes rehearsed and we would sit down just ahead of time and he'd say, 'Here's the 30 we're doing tonight.' A lot of people followed him around to every show and they would get a different show every time. We would do these really long sound checks where he would develop new material; we got into Paris and he wanted to do Ravel's 'Bolero,' so we learned it in a sound check and played it that night," he said laughing.

Carman has produced seven albums with bands he has formed; he also has three albums in the can. "I'm going to release them digitally very soon. I'm not going to press anything anymore, just release them as downloads," he said. Carman's CDs are available on

From the age of 20, Carman had always taught private lessons and that evolved into teaching jazz, jazz history, saxophone and computer music applications at the University of Southern California, University of California at Irvine, California State Fullerton, Cal Poly San Luis Obispo, Saddleback College and several high schools around the country. Currently, he is assistant professor of jazz studies and a saxophone teacher at Idyllwild Arts Academy where he has taught for nine years.

Carman also is an innovator, having developed a teaching tool years ago called a CD Metronome. "It's a recording of a live drummer that you use to practice with as your Metronome," he explained. "I sell a handful every month and the orders come in from all over the world. Everybody seems to know about it. That was about 15 years ago that I [developed] that." Visit his website at www.paulcarman.com.

Grace Songolo and Don Laffoon introduced Carman to Idyllwild through a charity Laffoon

ran called "Stop-Gap." The organization performs healing theater for troubled kids and kids with cancer. Carman was asked to perform in a play about a gymnast and a girl in a wheelchair who had a love affair. "[Laffoon] wanted a solo saxophonist to come on stage and be improvising music to the play," Carman said. "We did that play together and they had the gallery up in Idyllwild, so I'd go up and visit them."

As his family grew, Carman decided in October 2001 he would leave the exorbitant rent he and his wife could no longer afford in Laguna for a home on the Hill. "I just called my friend and said, 'What are the rents like up there?' and my jaw dropped," Carman exclaimed. "It was cheap. I went from \$2,000 a month in Laguna for a little two-bedroom cottage to a four-bedroom house up here for \$800. So I said to my wife, 'You know what, I think we should just leap and go and if it doesn't work, we'll move back.'"

Not sure what to expect of life on the Hill, Carman was pleasantly surprised at the welcome he received. "I had no idea that there were even good musicians up here to play with," he said. "I found that out in the first

month or two and I'm being invited to these jam sessions at people's houses and Barnaby [Finch] is there and Marshall [Hawkins] is there and Don Reed is there. I'm just going, 'What have I walked into?'"

A staple on the entertainment scene in Idyllwild, Carman can be found doing exactly what he loves doing — entertaining folk with his incredible saxophone artistry.

"I love community. I love being around people, especially playing my saxophone and looking out at the audience and knowing half of the people there and knowing their stories; they know my kids ... I just saw my boys' kindergarten teacher in the market the other day," he said smiling. "I guess that's probably the thing; the fact that those connections are so amazing coupled with so many creative people [that live] here."

A disappointed women's pool team captained by former Idyllwild resident Geri Peterson was defeated in Round 3 on the first day at the American Poolplayers Association National Team Championships in Las Vegas mid-August.

Peterson, who now lives in Hemet but has worked at Fairway Market for years, said, "We were very disappointed. What we did not know was that the ladies' tournament was excluded from the national opening ceremonies as well as the national tournament room."

The tournament was scheduled from Aug. 14 to 16, and she said, as captain,

she was thrown off by the news of exclusion and challenged to keep her team in mental shape to play.

"We were put in the national minis room," she said. It did have 400 tables but the tournament room was huge compared. And the pots of money for the winners were small, too.

When asked why she thinks they were treated this way, Peterson said she heard that APA wants to do away with the women's teams altogether because fewer women are competing and competitions cost time and money.

"The numbers just aren't there to keep the women's a national event," she said.

"As captain, I tried to rally the team

because there was still an \$8,000 prize.”

The rest of the trip, Peterson and the team players — Lisa Timm, Becky Prater, Louise Wood and

Vicky Sundholm — played mini-games and placed between second and fourth places. “That made it a little bit lighter of a weekend,” she said.

In 2011, the team finished fifth in the nation — the first team from this county to finish that high in 15 years. In July of this year, the Town Crier published a story to help raise

money for the team to go to Las Vegas. More than \$5,000 was raised.

“If it wasn't for the grace of God and the help of Idyllwild, we would have never gotten to go,” said Peterson. “All of us want to thank everyone who supported us. If the rest of the world was like Idyllwild, people wouldn't be beheading people.”

Same-sex marriage benefits

The Social Security Administration is now able to process requests for Medicare parts A and B special enrollment periods, and reductions in Part B and premium Part A late enrollment penalties for certain eligible people in same-sex marriages. This is in response to the June 26, 2013, Supreme Court ruling in U.S. v. Windsor, which held section 3 of the Defense of Marriage Act unconstitutional.

Because of this ruling, Medicare is no longer prevented by DOMA from recognizing same-sex marriages for determining entitlement to, or eligibility for, Medicare.

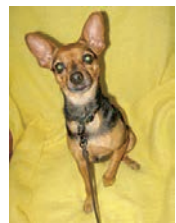

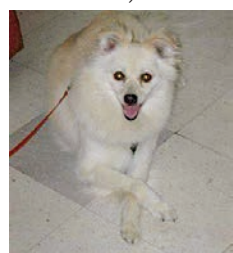

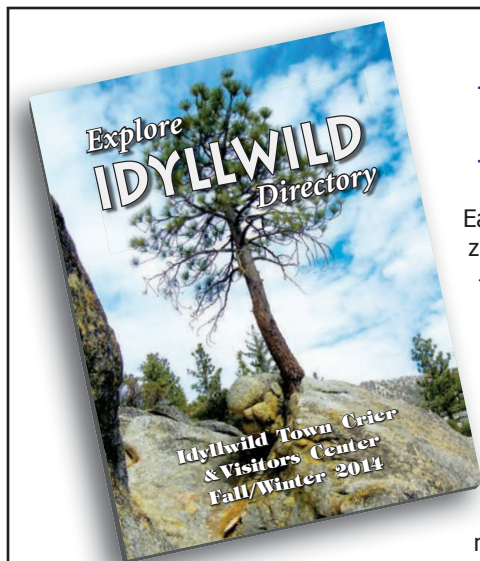
As a result of devastation caused by bark beetles, Southern California Edison reported that it had removed 12,000 trees in the Idyllwild-area mountains in less than a year.



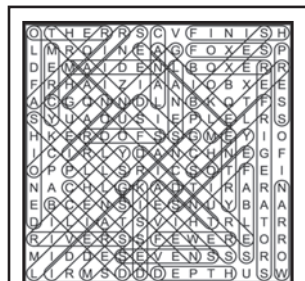

'The Hidden Enemy' documentary

In early 2013, the official website of the U.S. Department of Defense announced the startling statistic that the number of military suicides in 2012 had far exceeded the total of those killed in battle — an average of nearly one a day. A month later came an even more sobering statistic from the U.S. Department of Veterans Affairs: Veteran suicide was running at 22 a day — about 8,000 a year.

The situation was so dire that the U.S. Secretary of Defense called suicide in the military an "epidemic." Some have claimed that this self-harm is because of the stresses of war. The increased aggression and suicidal thinking are reflected in similar uptrends in the rates of military domestic violence, child abuse and sex crimes, as well as self-harm.

The reasons why and the solutions are contained in a new documentary called, "The Hidden Enemy."

John Henke, a retired Air Force colonel from San Jacinto, said, "What you will experience in watching this documentary will undoubtedly shock you. I am a veteran of both Korea and Vietnam and have had personal experience of losing comrades and friends to this 'epidemic.' I want to see our troops and veterans given the respect and care they deserve and they deserve the very best we can give them."

Steele has fine 2014 PGA Tour Season

Brendan Steele now has four seasons on the PGA Tour under his belt. Apart from his rookie season, his fourth was his most successful.

Moneywise, Steele captured more than \$1.3 million this 2014 season, second only to 2011, when he scored a million-dollar win at the Valero Texas Open. So far in his PGA Tour career, the Idyllwild native has earned more than \$5.1 million in official prize money.

FedExCup points-wise, Steele earned 881 points this season, second only to the 2011 season that included a win.

Some key stats for his 2014 season, each followed by his PGA Tour ranking in that stat, include: drives averaging 298.9 yards (28th) that found 59.51 percent of the fairways (121st); 56.47 percent of the greens in regulation (53rd); and proximity to the hole of 35 feet, 5 inches (72nd); sand save percentage of 49.24 percent (103rd), and a scrambling percentage of 59.45 percent (72nd). His stat for average points gained, tee to green, was 0.318 (61st), and average points gained putting was 0.122 (74th).

Other stats in which Steele ranked high in 2014 against the rest of the PGA Tour field included: total eagles, 10 (16th); par 5 performance (27th); approaches from more than 200 yards (10th); approaches from 250-275 yards (5th); and lowest round 62, twice (7th).

Steele will tee up to start the 2015 season next month on Oct. 9 at the Frys.com Open on the Silverado Resort and Spa course in Napa.
