## Ebola preparedness topic of emergency services group

Riverside County's preparedness for potential Ebola victims was the topic of last week's Mountain Emergency Medical Services Committee meeting. Marie Weller and Dan Bates of the county's Emergency Preparedness and Re-

sponse agency described how the county is prepared to respond in case this emergency strikes locally.

"As of now there are zero cases in Riverside County and absolutely no cases in California," Weller said.

As an example of their caution and concern, county health officials did monitor two low-risk individuals

who had traveled to West African countries where Ebola existed. Last week, Dr. Cameron Kaiser, county public health officer, announced that neither person showed any symptoms

of Ebola during the 21 days of active monitoring.

The two individuals took their temperatures with a digital thermometer twice a day and reported

# Major crash on Sunday

Four people were injured in a traffic collision Sunday afternoon on Highway 74.

Michael Ayala, 18, of San Jacinto was traveling east on Highway 74 just east of Strawberry Creek in a 2007 white Subaru at 3:55 p.m. when he crossed the double-yellow lines into the path of a 2002 silver Toyota Highlander driven by Philip Deschene, 74, also of San Jacinto, according to California Highway Patrol Public Information Officer Darren Meyer.

Mercy Air transported Ayala to Riverside Regional Medical Center with a

possible broken hip. American Medical Response ground-transported Deschene and two male passengers, one 72 and one 54, all complaining of chest pains and Deschene also of shortness of breath, to the same hospital.

Riverside County Fire Department personnel were involved in extricating the injured. Idyllwild Garage towed the vehicles, both of which sustained major damages.

Meyer said no drugs or alcohol were involved and though speed may have been a factor in the crash, no final cause has been determined.

# Too soon to know effect of Proposition 47

California voters easily approved Proposition 47, which reduces certain nonserious and nonviolent property and drug offenses from felonies to misdemeanors. The measure also allows certain offenders who have been previously convicted of such crimes to apply for reduced sentences.

In general, offenders convicted of misdemeanor crimes are punished less severely than felony offenders. The anticipated long-term result would lessen prison overcrowding.

Proponents argued that, if enacted, the population of inmates in the state prison system and county jails would be reduced, thus saving money and ensuring capacity for violent and serious offenders.

Opponents worried that 10,000 existing inmates might be granted release based on the proposed changes. The Center on Juvenile and Criminal Justice estimated that about 40,000 fewer individuals would be incarcerated as a result.

Despite these stories, caution and carefulness, not superficial reactions, come from Riverside County officials. "The impact(s) of Proposition 47 to the department and our commu-

nities are not yet known, as it is much too early to speculate," said Sheriff Stan Sniff.

Immediately following the election results, law enforcement officials and the media began reporting on the potential effects of implementing Prop 47. For example, a Los Angeles Times article suggested that in the future there might be insufficient inmates to staff the inmate firefighting crews. The Riverside County Bautista crew is composed of inmates and is deployed for many of the major fires in the county.

However, state and local firefighting officials say it is much too early to describe the consequences of Prop 47.

At the state level, officials from Cal Fire and the California Department of Corrections and Rehabilitation are still evaluating potential effects. They have not yet met, according to Daniel Berlant, chief of public information for Cal Fire.

A meeting is scheduled for this week "... to discuss the expected impact to the inmate population used in our program. Both departments agree the program is critical to our firefighting mission, but at this time we don't know what, if any, impact there will be," Berlant wrote in an email to the

Town Crier.

Riverside County Battalion Chief Tim Chavez also said it was much too early to assess the effect of Prop 47. "A lot of unknowns right now," he said.

The law is very specific about how it applies to current inmates; therefore, officials do not know how many may apply for release. "It may be a small segment of the inmate population," Chavez said.

He also emphasized that Assembly Bill 109, which implemented the state's realignment of prison population to county jails, was supposed to affect the fire crews, but "... there's been no appreciable effect," Chavez stated.

If the prison population is reduced, according to the proposition's language, the savings are to be transferred from the General Fund into a new state fund,

the Safe Neighborhoods and Schools Fund. Monies in this fund would be divided among the following programs: reducing truancy and drop-outs among K-12 students in public schools; victim services grants; and mental health and drug abuse treatment services designed to help keep individuals out of prison and jail.

In the analysis of the proposition, the state's Legislative Analyst's Office estimated annual savings would "eventually result in net state criminal justice system savings in the low hundreds of millions of dollars annually... [and] ... net criminal justice system savings to the counties of several hundred million dollars annually, primarily from freeing jail capacity."

## What Proposition 47 changes

This measure reduces certain non-serious and nonviolent property and drug offenses from felonies to misdemeanors. The measure limits these reduced penalties to offenders who have not committed certain severe crimes listed in the measure — including murder and certain sex and gun crimes.

Specifically, the measure reduces the penalties for the following crimes:

- Grand theft: Limits when theft of property of \$950 or less can be charged as grand theft.
  - Shoplifting: Shoplifting property worth \$950 or less would always be a misdemeanor and could not be charged as burglary.
  - Receiving stolen property: Receiving stolen property worth \$950 or less would always be a misdemeanor.
  - Writing bad checks: It would be a misdemeanor to write a bad check unless the check is worth more than \$950 or the offender had previously committed three forgery-related crimes, in which case it would remain a wobbler\* crime.
  - Check forgery: Forging a check worth \$950 or less would always be a misdemeanor, except that it would remain a wobbler\* crime if the offender commits identity theft in connection with forging a check.
  - Drug possession: These would always be misdemeanors. The measure would not change the penalty for possession of marijuana, which is currently either an infraction or a misdemeanor.
- \*Wobbler Sentencing: Under current law, some crimes — such as check forgery and being found in possession of stolen property — can be charged as either a felony or a misdemeanor. These crimes are known as "wobblers." Courts decide how to charge wobbler crimes based on the details of the crime and the criminal history of the offender.

# OUT LOUD



Since I wrote about motorcycle crashes last week, I've been working both with Caltrans and CHP, and going through our own files, gathering statistics about these tragedies.

Statistics may or may not give us all we need to know. They may tell us who, what, when and how but may never tell us why.

Let's start with a little of what I've gathered so far on MC crashes in our Hills:

2014 — 14 TCs, 7 fatal  
2013 — 14 TCs, 0 fatal  
2012 — 17 TCs, 0 fatal  
2011 — 12 TCs, 0 fatal  
2010 — 14 TCs, 3 fatal

The "why" is a valuable piece of information in getting to the root of these crashes but, unfortunately, doesn't necessarily find its way into a report.

For instance, in several of the captions in the newspaper, we published that the motorcycle was rented.

CHP PIO Darren Meyer told me they don't keep stats on rented vs. owned vs. borrowed. Why is that important? I asked Meyer why he thinks we're having so many more MC TCs than before.

He believes the economy's improvement gives people more disposable income to buy or rent MCs and take trips. That, combined with inexperience. But he can't really say for sure; it's just an observation.

So I asked him, "What does it take to get a motorcycle license?" Take a written test and either pass a driving test or a driving course.

However, he added, in this state exists a motorcycle "permit" that allows you to ride in daylight hours, not on a freeway and not with passengers. You only have to take a written test.

And another thing he added: Out-of-state/country motorcycle licenses are acknowledged in this state, even if the other state/country has lesser requirements.

Is the "why" inexperience on mountain roads? Maybe so. Still exploring...

I hope we all get involved and look at the cost of this new program.

They are talking about each one of us paying inspectors and enforcers (a whole staff of them), strict new laws and heavy penalties for any missteps — inspectors going to each and every home and us paying for them. And not even giving us the chance to



vote on it.

Aren't we paying enough taxes already? Property taxes are going up. We're already paying a new fire tax each year.

Why can't we vote on it? If what they're doing is for the community, why can't the community vote on it? We can't even vote on who is running MCFSC. They appoint themselves.

## Questions re: local flora and fauna

Congratulations and good work on the Town Crier column. The James Reserve is highly esteemed and the column should be well received.

I was particularly interested in the comments about the relationship between lions, deer and the flora. We see many Lemon Lily flower buds that are eaten by deer (as much as one-third in some years in

some places). I have written about this delicate balance. If the deer population is fixed and the Lemon Lily numbers are high, the percentage of flowers eaten remains low. However, if the deer population increases and/or the Lemon Lily population decreases, that percentage could change and result in a slow, downward spiral for the Lemon Lilies. Perhaps this is already occurring.

I remember visiting the wolf reserve near Julian. They spoke about the beneficial effect on the flora following the introduction of wolves into Yellowstone. It wasn't so much that the wolves were eating a lot of elk, reducing their numbers, but it changed the behavior of the elk. They were always on the move looking over their shoulder for the wolves, so to speak, which reduced the amount of time spent foraging in any one area, preventing over-grazing, which is the same relationship you describe between lions and deer.

We never see mountain lions on our forays into the San Jacintos, but we are aware they are there. While conducting the Lemon Lily survey in 2009, we saw a badly decomposed deer carcass in Tahquitz Creek. One in our party speculated that it had been killed by a lion and dragged into the creek in an attempt to keep the meat fresh in the cold water. Do you know if that is a documented behavior of lions?

DAVE:

Glad to see that you found the column on mountain lions interesting. I myself found your observations regarding the Lemon Lilies and they being eaten by deer interesting. It is this type of relationship you outlined that is the true basis of my assertion that top predators like mountain lions are indeed the shepherds of nature. The many past experiences where we have purposely reduced or eliminated mountain lions, wolves and other large predators have taught many of us their true value.

I and many have written extensively on the impacts of the lack of predators. In Yellowstone, we were indeed the first to document that the return of wolves changed elk

behavior and we predicted the changes we are now seeing there.

It is the basis of this work that we formulated the concept of the landscape of fear where, as I pointed out in the column, prey, such as deer, alter their use of the landscape based on the fear of being killed. What this does is to basically provide safe areas for favored plants, such as the Lemon Lily, where they can survive. Without this landscape of fear, deer can roam the landscape like cows, searching for the food they prefer, leaving the plants, such as exotics, they don't care for. The result of this is a major decline in these preferred native species.

This is the situation in the East where wolves and mountain lions have been absent for more than 100 years. In the South, the ginseng industry is declining because deer are getting to them before humans can. In fact, the whole Eastern forest ecosystems are in danger because deer love the seedlings of many of the major tree species, halting recruitment and thus threatening regeneration.

Foresters have particularly significant problems with deer regarding reforestation efforts. The people of the West need to visit Eastern forests just to appreciate the value of having mountain lions and now wolves on the landscape.

As for your specific question regarding whether mountain lions might "cache" a deer in the water, I have not heard of this before. Usually, the major concern of lions regarding their food is to hide it from other animals, such as coyotes, and so they normally drag it under a tree and bury it. Although I have not heard of it, however, it does not mean it is not possible. Lions are very adaptive and possibly in the dry, southern areas, it is something they might do. As they do leave distinct signs when they kill a deer, it is possible many times to verify that they did kill an animal.

I hope I have provided you with additional information on how important predators like mountain lions are to the maintenance of biodiversity, especially for many flowering plant species, and again appreciate your interest in the column. Feel free to contact me in the future and we can discuss this even more.

# Fiscal past, present and future discussed at Pine Cove Water

Financial matters dominated the latest meeting of the Pine Cove Water District's directors. The board heard from its auditor and accepted the 2013-14 audit, reviewed its first quarter 2014-15 financial report, and approved a new proposal for the renewal of two cell tower site leases.

## Past: 2013-14 audit

"The district is in good financial shape. There are no significant audit findings," reported Terry Shea, partner at Rogers, Anderson, Malody & Scott, LLP, the district's auditor. PCWD's ratio of current assets to liabilities is 4:1, which is very good since most districts are about 2:1, according to Shea.

However, he did advise the board to look at ways, including rate changes, to

raise more cash over the next three to five years.

"Consider cutting costs or loans or raising revenue to get cash [balance] up," he recommended. His warning was because PCWD had a cash balance of about \$200,000 at the end of the fiscal year (June 30, 2014). Annual expenditures are about \$600,000 or \$50,000 monthly, and he recommends that his clients maintain a cash availability of about four to six months of expenses.

"If a fire or earthquake occurred, you need to build cash," Shea said. Emphasizing his admonition, Shea noted that PCWD's cash balance declined about \$45,000 this past year, which was largely attributable to greater investments in infrastructure and a land purchase.

The last rate increase was approved in January 2011 and implemented a \$3

increase in the bi-monthly minimum level on Feb. 1, 2011 and again each of the next two years to the current level of \$53 bi-monthly. PCWD General Manager Jerry Holldber indicated that he will evaluate PCWD's financial condition over the next few months and may recommend a rate increase to the board then.

## Present: 2014-15 budget

At the end of the first quarter of the current fiscal year (Sept. 30), PCWD had received about 18 percent of expected revenues. There are normal collections since property tax revenue is not received until mid-December.

"Everything is on target for this time of year," reported Holldber.

Expenses for the first three months were about 29 percent of projected costs. Salaries and benefits were about 27 percent,

while other categories were slightly higher because full annual costs of some items, such as insurance, were paid in the first quarter.

PCWD has already expended about 60 percent of its projected overtime costs. Holldber explained that was caused by one employee on extended sick leave and another, Jerry Johnson, resigning last month.

"More overtime, but less salary," noted President Michael Esnard.

Director Lou Padula noted that PCWD had awarded several customers \$25 each for identifying and reporting water leaks.

"It's the best program," responded Office Manager Becky Smith. "We have spent about \$400 in the three years since it began and it's saved a lot of water."

## Future

The board also reviewed

and approved a proposed extension of the current tower contracts with AT&T and T-Mobile.

The new terms include a 15-percent rental increase for AT&T. Both companies will reimburse PCWD for maintenance of the sites, extend the leases to October 2049, guarantee the rental payments for 10 years and provide potentially \$7,500 in bonus payments if the amended leases are signed within 60 days.

Also, Holldber said he has approached a firm to research the status of the district's property tax revenue from the county. For several years, there have been questions about its accuracy.

"For some time, how little property tax [revenue PCWD receives] bugs us," Holldber said. After discussing the subject with legal counsel, he is investigating the possibility of using a firm to research the collection and allocation of these tax payments.

After Shea advised the board to look at alternatives to increase its cash, Holldber agreed and said he plans to review the options of possible future rate increases. Revenue changes may occur once the district has revised Ordinance 4, which addresses its rules and procedures. PCWD's legal counsel is currently reviewing this ordinance from the 1950s and subsequent amendments.

## PCWD to expand fire protection coverage

Water production in the Pine Cove Water District declined in September and climbed again in October. For the 10 months of 2014, total production of 28.4 million gallons is nearly 780,000 gallons (2.8 percent) more than the same period in 2013. And despite the drought conditions, this is the most for this 10-month period since 2009, when Pine Cove customers needed 30.8 million gallons.

"The wells are holding up good," General Manager Jerry Holldber told the board last week and added, "Static well no. 10 has maintained its groundwater level for several months."

However, the district's water loss reached 14 percent in the August and September period. "I don't know why. That's really high," he told the directors.

Looking to the future, Holldber is preparing a concept paper for extending water lines to the western edge of the district. If the state is receptive to the idea, he will submit a grant application for funds from \$10 million of the Fire Prevention Fee funds set aside for grants to local agencies.

"The Bee Fire burned up to this area and it's a

high fire hazard," he said. "It would be another tool to help." For example, it would be beneficial when fire agencies, such as the U.S. Forest Service, need to burn piles of slash and debris.

The plan would include about 5,000 feet of 6-inch pipe and 12 hydrants to serve the area. The estimated cost is \$292,000. If the concept is approved, Holldber will apply for a grant to pay about two-thirds of the cost.

"Pine Cove structures have an assessed value greater than \$134 million," he stressed. "This is a small price to pay to add to protection to Pine Cove and the entire community."

The board unanimously supported the idea. "We commend this thinking. Not all water districts care about water for firefighters," said Board President Michael Esnard.

Holldber also announced he would be submitting a separate grant request to the U.S. Department of Agriculture for funds to refurbish several wells in the district.

"This is a new grant program in support of the emergency drought," he said. "I'll have more information at future meetings."

## Only one response to Forest Service plan

In October, the U.S. Forest Service proposed a plan to reforest a portion of the land, not within the wilderness area, burned during the Mountain Fire in July 2013. The agency requested comments on the proposal by Oct. 24.

As of Oct. 29, only one comment had been submitted, according to San

Jacinto Ranger District Forester Kayanna Warren.

This will be analyzed and included in the packet for the final decision, which is expected before the new year. However, the Forest Service is also awaiting a response from the U.S. Fish and Wildlife Service on the request for consultation about potential effects to endangered or threatened species in the area

or their critical habitat.

The agency is proposing to plant about 53,000 Jeffrey and Coulter pine seedlings on more than 300 acres. Chaparral occupied much of the other burned area outside the wilderness area. If the proposal is approved, the work will begin during the winter and early spring of 2015, according to Warren.

The Jeffrey and Coulter seedlings will

only be planted in areas where they had formerly dominated. The seedlings will come from the Forest Service's Placerville nursery, which collected seed stock from this elevation in both the San Jacinto and Santa Rosa mountains, Warren said. The project is estimated to cost about \$250,000.

## Fire Fee suit in discovery phase

The litigation filed against California's State Regulated Area Fire Fee has been dormant for many months. Lawyers for the Howard Jarvis Taxpayers Association, who filed the suit, have reported that the case is still active and work is continuing.

"Our legal department is currently working on a phase of the case known as 'discovery,' where both sides are given the opportunity to ask each other for relevant information," HJTA reported last week. "After our attorneys sent the state's lawyers formal questions and requests for important documents, the state sent back 13,000 pages of material."

The Fire Prevention Fee was en-

acted in July 2011. After the State Board of Forestry adopted regulations for assessing and collecting the \$150 fee, HJTA filed its lawsuit alleging the fee was actually a tax in October 2012. If the court agrees it is a tax, then its enactment was flawed because taxes require the approval of two-thirds of the legislature.

# Full day of fun promised at Tree Lighting Ceremony

Last Saturday, a team of volunteers installed 4,500 lights (500 more than last year) onto and mounted the giant star atop the 100-foot Sequoia that serves as the center-piece for Idyllwild's 54th-annual Tree Lighting Ceremony.

The ceremony, sponsored by Soroptimist International of Idyllwild, starts at 4:45 p.m. Saturday, Nov. 29. But a full day of festivities begins at 10 a.m. in the center of the village.

The ceremony has a rich history in Idyllwild and the festival, put on entirely by more than 200 volunteers, is the culmination of a year of intense preparation and planning. Event Chair Phyllis Mueller is tasked with preparing a memorable celebration for thousands of Hill folk and visitors. "I have a 200-page document on how to run the Tree Lighting Ceremony, all the elements of it," Mueller said. "It is more detail than you'd ever want to know. That's why it takes a couple of hundred people to do it."

This is Mueller's third year at the helm of the event and she promises a day filled with wonder and excitement for the entire family. Mueller and husband, Glenn Warren, are best known in Idyllwild as chiefs of staff to Idyllwild's Mayor Max and Deputy Mayors Mitzi and Mikey (three golden retrievers) who will be on hand to greet the crowds and hand out "Mini Me" stuffed animals, while supplies last. Animal Rescue Friends of Idyllwild will be on hand to remind families of the importance of the rescue and adoption of homeless animals.

Beginning at 10 a.m. strolling carolers will roam the village singing Christmas favorites as visitors enjoy the morning with friends and family. The Idyllwild Fire Department will deliver Santa and Mrs. Claus, and several of Santa's elves, via fire truck to their workshop located at the Gazebo in the Village Center Plaza. Two Santa's workshop sessions will be held so that all children have a chance to meet Santa; the first is from noon to 2 p.m. and the sec-

ond from 4:45 to 6:30 p.m. (or until the last child in line has had a visit with Santa). Santa's elves will hand out candy canes to the children visiting Mr. and Mrs. Claus.

Long-time Idyllwild resident and local treasure Marge Muir is in charge of the Children's Santa Program. Muir has lived in Idyllwild since 1957 and recalls lighting a tree every year since she has lived here. Last Friday, Muir along with long-time local Emily Pearson and her family's Pearson Wood Services, installed Christmas lights on the children's tree located at The Fort on the corner of N. Circle Drive and Highway 243. At last year's ceremony, Santa visited with more than 300 children.

More than 20 local charities will host festive booths offering everything from one-of-a-kind gift items to tasty food and baked goods to raise funds for their charity. It's the perfect time for holiday shopping at the many shops and stores throughout the village, all decorated in the spirit of the holiday. For more shopping opportunities head over to Town Hall on Cedar Street for the Rotary Club of Idyllwild's Harvest Festival that runs from 9 a.m. to 4 p.m.

The Tree Lighting Ceremony is at the corner of N. Circle and Village Center drives on JoAn's Restaurant property in the center of town. The program will begin with a reading by Doug Austin and The Olde English Theatre Players of "Twas the Night Before Christmas." Dianne Burt's Grammy-nominated The Caroling Company will be on hand to entertain the crowd and lead the audience in a sing-along of some holiday standards and the Idyllwild Children's Choir (ages 3-6) will take the stage to sing renditions of "Jingle Bells," "Rudolph the

Red-Nosed Reindeer" and "Santa Claus is Coming to Town."

Mueller promises there will be a lot more for our holiday guests. "I haven't told you everything that's going on because we have some surprises in store," she said with a wink.

Following the Tree Lighting Ceremony, with weather permitting, Mueller and her volunteers have planned a concert featuring local and visiting performers for people who want to stay and enjoy more holiday cheer and music.

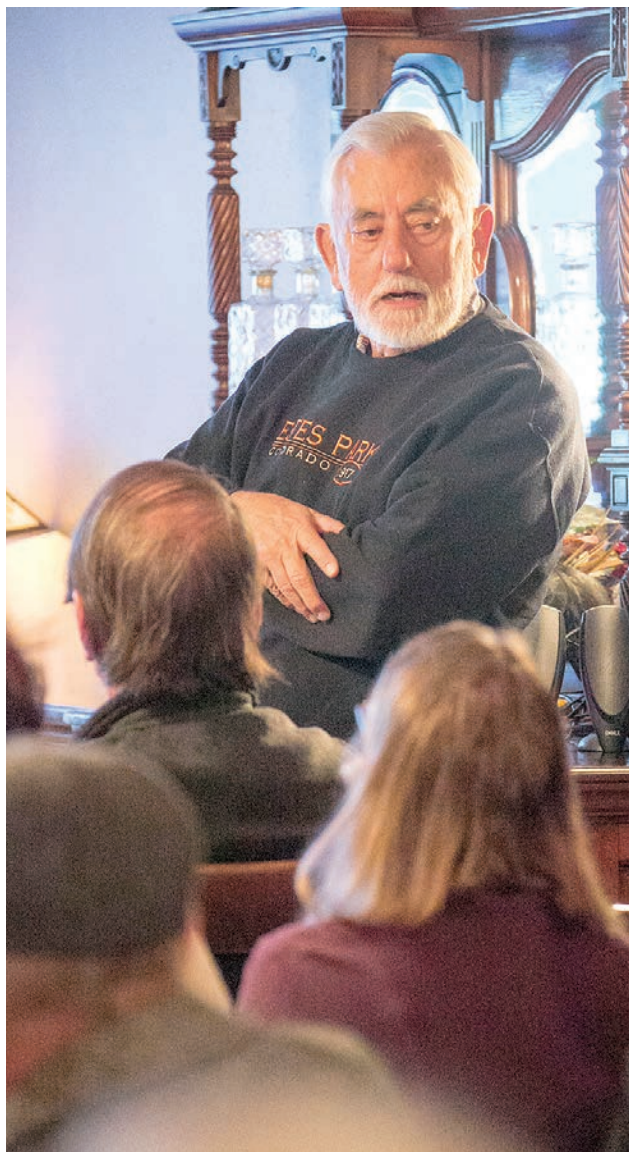

## Health care and holiday scams ...

Open enrollment for the Affordable Care Act for 2015, which began Nov. 15, has spawned some new scams just in time for the holidays. Scammers are contacting unsuspecting consumers in an attempt to sell bogus insurance plans covered under the ACA. Health-care.gov is the safe place for consumers to obtain information and consult with one of the agency's free official helpers.

Some Medicare recipients have reported receiving calls informing them that their coverage will be lost unless they sign up for their prescription drug plan; the Medicare prescription drug plan is voluntary (Part D). The call is bogus. Other recipients have been asked to provide their Medicare number in order to continue coverage, another scam. Never give out personal information over the telephone. Contact Medicare at 1-800-MEDICARE (633-2273) or go to [www.medicare.gov](http://www.medicare.gov).

Medical discount plans marketed by a number of scammers under the guise of being health insurance plans have some consumers confused. Many purport to

be comprehensive health plans but fail to deliver the services promised; others are just a way for identity thieves to obtain your personal information. Contact the State Insurance Commissioner's office at [www.naic.org](http://www.naic.org) to verify the legitimacy of any health insurance plan that appears to be suspicious.

## Grinding facility to close Saturdays

The Idyllwild grinding facility will be closed Saturdays from Dec. 6 through May 1. It is currently open on Saturdays from 10 a.m. to 2 p.m. through Nov. 29.

# Steele going into 2015 cut free

Brendan Steele played again last weekend, making his fourth cut in as many tournaments this very early 2015 PGA Tour season. The Idyllwild native now has made eight consecutive cuts in tour events, counting the end of last season. Last week in Playa del Carmen, Mexico, he posted a 7-under-par 68-68-70-71 — 277, good

enough to tie for 37th place and earn \$26,000 in official prize money.

The information coming out of Mexico is not as complete as for many other tournaments, but his available stats suggest he placed high against the field in driving distance and greens in regulation, but fell back in driving accuracy and putting. Double bogies are still a problem this early on; he suffered two of them in last week's tournament. To

give you an idea of their importance, had they just been two pars instead of two doubles, he would have scored a top-10 finish, earned about \$110,000 more in prize money, and captured twice as many FedExCup points.

Still, he picked up 31 FedExCup points last week, which gives him 120 points on the season, likely already more than a quarter of what he will need by next fall to retain his PGA Tour playing card

for the 2016 tournament year.

After a fine start, we're not looking for Steele to play again before January, but we'll let you know if there is a change in that plan. He now has about six weeks to work on his game with the new sticks he'll carry into the new year. We'll report on what's in his bag when he resumes play.

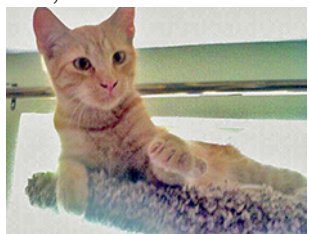

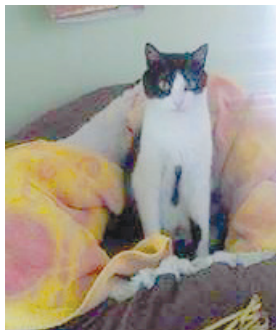
He has bravely said goodbye to his brothers and sisters, and has had to take matters into his own paws.

the readings to the health department. Both individuals cooperated with health officials while being monitored, Kaiser reported in press release. The monitoring was a precaution that follows protocols recently announced by the Centers for Disease Control and Prevention, he added.

Weller stressed that Ebola is transmitted through direct contact with a victim's blood or bodily fluids. Further at the time of contact, they must be in the symptomatic stage rather than early in their infection.

The first symptoms to appear—fever, joint aches and headaches—are similar to flu symptoms. Later in the infectious stage, abdominal pains and diarrhea begin to occur, according to Weller.

Thus far, the disease appears treatable if caught early. Victims need rest and fluids. But there is no effective test, yet, according to Weller.

When asked if coughing were a possible transmission means, Weller replied,

"Only if they cough directly in your mouth."

Riverside County's Public Health Preparedness Branch has established protocols for responding to any contagious disease, such as pertussis or measles. For Ebola virus, the county health planners had to expand their existing toolkit, according to Weller.

A major component of the preparedness is communication. That includes weekly teleconference calls with state officials, as well as regional communications and local teleconferences to hospitals, clinics, emergency responders and other medical personnel, Bates explained. County Public Health and emergency agencies have been pre-

paring and planning since March, Bates said, "long before the Texas incidents."

In October, the University of California Medical Centers—Davis, Irvine, Los Angeles, San Diego and San Francisco facilities—announced they are positioned to accept patients in California with confirmed cases of Ebola.

The state's Emergency Preparedness Office has organized and will conduct a statewide drill this Thursday to evaluate current response concepts, plans and capabilities based upon related objectives and an emerging infectious disease scenario, which will be the Ebola virus.
