County to provide ambulance service to Pine Cove

A new countywide ambulance service contract was approved 3-1 at the Riverside County Board of Supervisor's Tuesday morning meeting. Only 1st District Supervisor Kevin Jeffries opposed it, because he favored new competition for the contract.

In the new contract, effective July 1, the county ambulance provider, American Medical Response, will take over emergency medical service to Pine Cove and the areas known as zones 2 and 3 in the existing contract between Idyllwild Fire Protection District and Riverside County.

IFPD retains its exclusive operating area — the Idyllwild Fire District — but its contract with the county to provide ambulance

and emergency medical service outside the fire district will expire after June 30.

Pine Cove residents will not longer reimburse the county for ambulance service beyond the cost of the actual call and transport, if necessary. Since the 1990s, Pine Cove residents have paid, through their County Service Area 38 parcel fees, for the ambulance service from IFPD.

"[Former] Supervisor [Jeff] Stone made that commitment and the county will honor the commitment [to drop the parcel fees]," said Bruce Barton, director of Riverside County Emergency Medical Services Agency. "We will not waffle."

In February 2014, when the board decided to renegotiate the countywide ambulance contract with AMR, Stone explicitly

The seats were filled at the Rustic Theatre. The graphics had sheen. The trophies sparkled. Presenters hit their marks. After their names were called, award recipients walked to center stage, hugged presenters, spoke briefly, thanked the people "without whom the award would not have been possible," walked to stage right for a photo op, then offstage as the next category was called — in short, an awards walk reminiscent of major film and television awards.

The Idyllwild International Festival of Cinema, in year six, showed how much it has grown at its Saturday evening Awards Ceremony. Helmed by IIFC Director and Founder Stephen Savage, opening remarks and awards presentations hummed along with zest, enthusiasm and good humor.

Prior to the start, the capacity crowd buzzed, still networking and brimming with energy from the five-day, five-venue festival. Even dress style popped with a little more glitz than in previous outings.

Charges inflate e-waste disposal fees

Recently enforced e-waste disposal fees at the Idyllwild Transfer Station, (\$25 per electronic waste item for televisions, computer screens or similarly covered electronic items) are not the only fees local residents desiring to responsibly recycle and dispose of electronic waste will have to pay. Consumers may actually be paying twice to recycle certain items.

As a result of the new Waste Management Inc. fees, Idyllwild residents who recycle covered electronic equipment at the station could be paying up to \$40 per item to properly dispose of used equipment.

Beginning Jan. 1, 2005, California consumers who brought certain covered electronic items, such as TVs and computer screens, were charged from \$3 to \$15 per item by retailers at point of sale, based on size

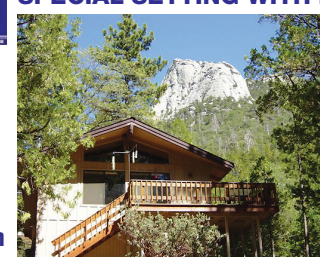

Gov. Brown releases 2015-16 budget proposal

Education receives significant attention

Gov. Jerry Brown proposed a \$113.4 billion budget for the fiscal year 2015-16, which begins July 1, and is about \$1.5 billion more than the current year budget.

The budget is balanced and sets aside \$2.8 billion in the state's rainy-day fund.

While Brown did not have to deal with the expansive deficit he faced in 2011 when he presented his first budget, he still had to address, manage and balance several important issues that have major budgetary consequences.

"This carefully balanced budget builds for the future by saving money, paying down debt and investing in our state's core needs," said Brown in a press release. "Our long-term fiscal health depends on the wise and prudent actions we take today."

Increased spending for the state's secondary school, college and university funding, expanding Medi-Cal coverage, responding to water needs, retiree costs for health care and pensions, as well as debt service and rainy-day savings were among the many issues Brown addressed during his budget conference.

In a press release, State Sen. Jeff Stone (R-Riverside County) applauded the governor for the fiscally prudent measures contained in his proposed budget.

Stone added that he looked forward to working with the governor to find ways to formulate a responsible and balanced budget. "With estimated state revenues coming in higher than expected, the governor needs to continue to pay off California's debts and not launch new and expensive programs," said Stone.

Funding for kindergarten through 12th

grade schools will increase \$4.8 billion to a total of \$65.7 billion in 2015-16. Another \$2.3 billion will be made available to schools this fiscal year.

"The greatest consensus we have for spending in California is for education," Brown said during his press conference.

"Ongoing K-12 Proposition 98 per-pupil expenditures in the budget are \$9,667 in 2015-16, an increase of \$306 per pupil over the level provided in 2014-15, and up significantly from the \$7,008 per pupil provided in 2011-12," according to the governor's Budget Summary.

The governor's budget proposal also recommends changes to school facility construction programs. This will be negotiated with the legislature.

Higher education funding also increases about \$1.1 billion, but Brown wants the money for the state's universities to be contingent on holding tuition steady and fewer out-of-state students.

Since 2012-13, the number of Medi-Cal participants has increased by nearly four million enrollees to 12.2 million people, or 32 percent of the state's population. Medi-Cal General Fund spending is projected to increase 4.3 percent from \$17.8 billion in 2014-15 to \$18.6 billion in 2015-16.

"This is real money going to real people," Brown stated. "Health security will improve the quality of their lives. One of biggest causes of bankruptcy is medical bills."

The state's employee and retiree health care has received limited attention in recent years. State health-care benefits remain one of the fastest growing areas of state government. The budget includes nearly \$1.9 billion for retiree health-care benefits for 2015-16. These payments are fourfold what the state paid in 2001 (\$458 million) and now represent 1.6 percent of the General Fund. Long term, these liabilities exceed \$100 billion.

Worried about the accelerating liability for retiree health-care benefits, Brown is pro-

posing to share these costs and to increase the amount of prefunding. Many tenets of the plan involve the collective bargaining process, and he will bring them to the bargaining table as public employee unions' contracts come up for negotiation.

"If we don't reign these things in, down the road there will be drastic cuts just like there were in the last few years," Brown warned.

The budget also includes \$532 million from the recently approved water bond measure. These funds will be used for a variety of purposes, including watershed protection, water storage, recycling and groundwater sustainability.

Another \$93.5 million is being proposed for responses to the existing drought. Cal Fire would receive \$59.4 million to continue firefighter surge capacity and additional defensible space inspectors.

Cal Fire also will receive funding to initiate a procurement to replace its existing helicopter fleet.

Brown also recommends a one-time increase of \$16.8 million to continue existing service levels throughout the state park system. The budget request also allocates \$20 million for deferred maintenance in the state park system.

A newly established transformation team is charged with identifying improvements for the state park's long-term fiscal operations. A two-year funding commitment of \$3 million is for the team of experts to develop solutions and evaluate the recommendations of the Parks Forward Commission.

Radio Club accepts responsibility to operate WNKI

The Mile High Radio Club is moving forward with implementing the agreement with the Idyllwild Fire Protection District to operate WNKI.

Despite MHRC board member Jeff Smith's concerns raised privately to President Bill Tell and publicly, members at the Jan. 8 meeting felt they had the talent to capably and prudently carry out their responsibilities in the agreement.

Basically, Tell has said the club intends to comply with Federal Communications Commission regulations and if a problem arises, it will be addressed.

"As stated in several places in the WNKI agreement, all actions concerning the station must be consistent with FCC rules and regulations. Standard operating procedures are to be developed to ensure proper consideration is given to the needs of the public and the requirements of the FCC.

To the extent it is determined any provision of the WNKI agreement is not consistent with FCC rules and regulations, the parties will adjust their conduct accordingly," Tell told Smith in an email.

To the members at the meeting, Tell read aloud portions of several emails to him from Smith and his responses to Smith. In general, Tell referred to several sections of the FCC rules, which grant licensees some discretion on broadcast content.

While the FCC did state, "[we] ... believe that [Travel Information Stations] should retain [their] historical focus on serving the needs of the traveling public," Tell stressed that also includes Hill residents who need to know the conditions in case of an emergency.

"This position was reinforced with the statement in the rules that broadcasting emergency information and information related to imminent threats to safety and property, whether travel-related or not, is already allowed under our Part 90 rules," he said.

Interpretation and implementation of the agreement pursuant to these rules is still subject to the operator, Tell said. The FCC states, "We are persuaded ... that the Part 90 rules should allow for discretion on the part of the TIS licensees regarding use of the TIS service. Given their intimate knowledge of local conditions and considering the limited area of operation of TIS base stations, TIS licensees are in the best position to determine what constitutes an 'imminent [threat to] safety-of-life or property.'"

Also, section 90.405 (a) (2) permits communications directly related and necessary to those activities which make the licensee eligible for the station license. The FCC continues with "... the licensee providing such service may transmit communications related to the activities for which the parties receiving the service would be eligible to be licensed."

The club is in the process of developing its operating procedures for WNKI and forming committees for its operation and management.

Flu season taking a toll; still light in California

What do measles and Disneyland have in common?

While the current flu season continues spreading rapidly throughout the country, it remains relatively low in California. Nevertheless, on Friday, Jan. 9, the California Department of Public Health confirmed the first influenza death in the state this season.

The flu victim was a Southern California resident and under age 65, CDPH reported. Outpatient visits for influenza-like-illness has begun to increase in the western region and is now above the normal threshold.

"Flu activity is begin-

ning to increase statewide, including reports of hospitalizations and severe disease," said CDPH Director Dr. Ronald Chapman. "We are early on in what could be a severe flu season, and I encourage everyone who has not yet gotten a flu vaccination to do so. The influenza vaccine remains the most effective way to protect yourself from the flu."

Already this season, 26 pediatric deaths have been attributed to the flu. During the 2013-14 flu season, 109 pediatric deaths were reported.

"Patient visits to doctors for influenza-like-illness (ILI) are now almost even with the peak of 2012-13 season, the last time H3N2 viruses predominated," the CDC reported last week. The total flu-related deaths declined sharply in early December, but have begun climbing in the past couple of weeks. The percentage of deaths due to pneumonia and influenza were 7 percent, just above the 6.9-percent epidemic threshold.

Last month, the Gal-

lup organization, which has been conducting polls on the health of Americans since 2008, reported that this flu season may be one of the worse in recent years.

"Americans' reports of being sick with the flu in December are among the highest Gallup has recorded since beginning to track the flu daily in 2008. Flu reports typically peak in January or February, which indicates that this may be one of the worst flu seasons in at least seven years," Gallup reported on Jan. 8.

Through the end of 2014, most individuals admitted to hospitals for influenza-like symptoms were adults older than 65.

The majority of these people also suffered from other underlying medical conditions, such as metabolic disorders, cardiovascular disease or obesity. The next most vulnerable group was children younger than 4 years.

Those at highest risk of severe influenza — the elderly, pregnant women, infants or people with other health conditions — who show flu symptoms should contact their physician immediately in order to get the most effective treatment for influenza. Symptoms include fever, cough, sore throat, runny or stuffy nose, muscle or body aches, headaches and fatigue.

doses of MMR vaccine). Several large contact investigations are ongoing ...

"Two doses of measles-containing vaccine are more than 99 percent effective in preventing measles. Measles vaccines have been available in the United States since 1963, and two doses have been recommended since 1989," according to CDPH.

"Measles typically begins with fever, cough, runny nose and red eyes and within a few days a red rash appears, usually first on the face and then spreads downward to the rest of the body. Measles is a highly infectious, airborne disease," CDPH reports.

CDPH also confirmed seven cases of measles from five different locations in California, one of which is Riverside County. Four of the other individuals also live in Southern California and are between ages 8 months and 21.

All individuals with confirmed or suspected cases of measles reported visiting Disneyland of Disney California Adventure Park between Dec. 15 and 20.

CDPH reports, "Six cases were unvaccinated for measles (two were too young to be vaccinated), and one had received an appropriate vaccination (two

Most of the time, when a reporter goes to cover a feature story, they've done some background research and carry along some questions to ask of the subject(s) of the interview. Because I was tasked with babysitting three grandchildren over a four-day period, when I headed for the Rustic on Saturday, I carried only an empty notebook, pencil and camera, and an inkling of what "A Man Called God" was about.

When the credits began, I wrote down names of principal players — Christopher, Kristoff and Maria St. John, Baird Bryant — and an image popped into my head of a Town Hall photo in my office files of a young couple and a little boy — maybe 6 or 7 — from the 1970s (see page 15).

At some point in time, I had hoped to research the people in that photo since I remember the faces of the grown-ups from TV and film. And here I was, watching a very personal documentary another Idyllwild resident, Baird, had filmed of their lives.

After this powerful documentary showed, I met up with Kristoff with a notebook full of notes and questions. He talked about his film and about those two years in his Idyllwild playground.

Among other things, I asked him about the gripping scene in an otherwise colorful movie where the film drops to black and white with subtitles — a scene where his father, among thousands of people, is trying to get the attention of the guru for a private interview about Kristoff's molestations.

Personally for me, opting for B&W turned this orange-robed "God" into an ordinary man and his father into a hero. "I thought it was more poignant with no sound, that this was such a severe moment in time that we didn't need it," he said. "When I drained it, it was just perfect."

Fire abatement

EDITOR:

I'd like to share my perspective about the possible new fire abatement enforcement protocols currently under committee discussion. I was at the chief's meeting in June 2014 when this was initially brought up.

In that meeting, which was open to the public, the chiefs and members of the community discussed possible ways to make enforcement possible, or at least easier. Community members brought this up, not the chiefs.

Right now, it's cheaper for many property owners to not abate and then pay any fines that currently exist. In a nearby county, they had success with a policy that allowed abatement to be done on non-compliant properties and the money charged to the owner's property tax bill. Not in any of this, as far as I know, is there any discussion of stricter abatement standards. I could be wrong.

I understand that some are concerned about increased costs, and even though I don't believe that is proposed, wouldn't it be cheaper to spend more upfront on prevention than it would to rebuild the entire community after a wildland fire?

For those who think abatement can't make a difference in such a large forest, remember that many wildland fires, including the Mountain Fire in 2013, ignite on private property, where if fuels were reduced, the spark may have nothing to ignite in the first place.

I believe, but could be wrong, that the new protocols being discussed are designed to motivate everyone to abate their properties, not penalize or charge people who already abate.

I do hope to see more community meetings so these issues can be discussed and people's concerns addressed by the chiefs and others.

I, for one, am grateful that we have nonprofits such as MCFSC in the community operating for our benefit, and that we have a county fire chief who responds to community feedback.

AB 32 concerns

I saw your article(s) about AB32.

It hit us at about \$0.10 per gallon. I went to get gas today and sure enough, it



was about 10 cents more.

So, if you work it, it comes out to almost a 5 percent increase in price. What will that do to our food prices? Prices of everything else? I tried reaching out to Suburban to find out what the propane rate hike would be but there is no answer.

I'll reach out to our freight carriers we use to see what our fuel surcharges

will be now. We just had a small increase last quarter. I will find out if they'll put the touch on us again.

The thing your article pointed out that I did not realize is that this tax will reduce available carbon credits by 3 percent per year. When that happens over the next five years we will have a cumulative effect of about 14 percent fewer available credits. That's easy to understand.

However, the free-market competition for those carbon credits will affect fuel prices to the end consumer in an unpredictable way.

The earlier estimates from some pundits said it would impact us from \$0.15 to \$0.75 per gallon of gasoline. I am happy that it was only \$0.10.

Frankly, I am most concerned about what this will do for the folk having a hard enough time buying their groceries, paying their heating bill and getting to and from work. The current fuel prices will not stay this low for long.

Childhood trauma: choosing self-pity or empathy for others

Editor's note: With permission from Rick, this is a letter he addressed to Bryan Asch regarding Bryan's recent series on mental health in the Town Crier.

BRYAN:

Suffering raises awareness, especially self-awareness. I was introduced to this concept decades ago by Dostoyevsky:

"Pain and suffering are always inevitable for a large intelligence and a deep heart. The really great men must, I think, have great sadness on earth."

I'm not saying that's "fair." And clearly, there are other routes to heightened awareness. But it seems that suffering can be a shortcut of sorts.

Sometimes trauma results in the person being damaged goods, and this is especially true of chronic childhood trauma. But it is often a precursor to greatness of character. An unexceptional, "pleasant" life need not be examined, rebelled against, transcended. Childhood trauma can be a launching pad for soaring to the highest heights.

I'm reminded of something the shaman Juan Matus told Carlos Castaneda. Speaking of men who never face great challenges, he said:

"Men for whom an entire life was like one Sunday afternoon, an afternoon which was not altogether miserable, but

rather hot and dull and uncomfortable. They sweated and fussed a great deal. They didn't know where to go, or what to do. That afternoon left them only with the memory of petty annoyances and tedium, and then suddenly it was over; it was already night."

What causes one sufferer to be broken, while another rises like a Phoenix from the ashes? One factor that can make a huge difference is whether the person fixates on himself, losing himself in martyrdom and victimhood, while another breaks the spell by focusing on the needs of others.

Developing a great capacity to feel empathy is important, for sure, but the key is to not just feel empathy, but act upon it; that is, in service to others. This principle has long been recognized in psychology as a lasting cure for depression, and it is a cornerstone of the 12-Step program. I've never been through 12-Step myself, but many of the most empathetic, spiritual, grounded and mindful people on the Hill were/are in 12-Step.

Knowing the importance of service, it was no surprise to me that you wrote "... I found true happiness operating a small business dedicated to helping people."

Nice article, I really enjoyed it. Your strength of character is revealed in your capacity to be transparent and vulnerable. I'm looking forward to the next in stallment.

Help available ...

Keeping with the self-reflective tone of last month's column, I'd like to talk to you about taking care of my side of the street.

I like to think of myself as a guy who takes pleasure out of helping a friend but, as of late, I have noticed that trying to lend an unsolicited hand or offering a word of advice to someone who didn't ask for it turns into an invitation to heartache, no matter how helpful I may think I'm trying to be.

I'm learning that people who want help will ask for help and if they don't ask, let them figure it out. I've had too many experiences, meddling into someone else's problems, that have blown up in my face and strained the relationship to the breaking point, even though my intentions were to be helpful.

I remember an evening years ago when I lived in L.A. I pulled into a gas station to fill up. Off to the side of the mini-mart, a man and a woman were having a heated argument and the man was starting to get physical. The woman was calling out for help.

I deliberated for a moment and decided to intervene. I got the man down on the ground and was on top of him when the woman started hitting me and screaming for me to leave her husband alone.

At the time, I thought that I didn't want to be one of those people who stands by while a woman gets the crap beat of her. But I learned what police officers know all too well — domestic conflicts can be very tricky situations.

The gas station incident was extreme, but I've found that the principle carries over into less volatile situations. It may appear that help is wanted but people don't like to be told how to take care of their side of the street. They would rather figure it out in their own due time.

Maybe my motivations are suspect. Maybe what I think is just a desire to help is more a desire to remind myself that I've got everything figured out. That I know the answers. And should you not take my advice, well, then the hell with you, you're on your own.

"Why should I cast my pearls before swine?" I ask myself. Before I know it, I'm in an avalanche of resentments and convoluted motivations that lead to nothing but grief and confusion about how I got to this place.

It's a nasty little affair, crossing over into someone else's side of the street, a short stroll, fraught with dubious intentions and hurtful consequences.

My resolution this year is to stay out of other people's business. If they want help, they will ask for help and I will be happy to lend a hand; otherwise, I'm staying over here on my side of the street, sweeping up my trash and whistling a happy tune.

We must never be made afraid to exercise our Constitutional rights. But I do wonder if it isn't time that we discuss what it means to exercise those rights in a responsible manner.

Je suis Charlie? Non, Monsieur, not I.

Summer Concert Series ICC rent faces major increase

Ken Dahleen is not happy with a significant rent raise for use of the Idyllwild Community Center site. The founder and promoter of the well-attended Idyllwild Summer Concert Series, said, "We have done a lot to bring people to the Idyllwild Community Center site." He said his series has increased the profile of ICC and its fundraising and building campaign.

And, referring to what is part of a newly inaugurated 2015 fee schedule for rental of the ICC site, Dahleen said he is a bit perplexed why rent for his eight-concert series has increased to 500 percent of what it has been for the

last two years.

"Up to two years ago, there was no fee for use of the park because ICRC [prior governing entity of the park site] wanted us in there because the summer concerts helped establish and support [Riverside County] use applications [playground and building construction approvals] for the site," said Dahleen, ISCS founder and promoter. "Two years ago, a \$20 per concert or \$160 per summer season was levied per contract. Now it is \$100 per concert or \$800 for the summer."

Dahleen noted the ISCS charges no admission fee for its concerts. Concerts are scheduled for Thursday nights and are primarily a gift to locals. They have steadily built attendance in the 15 years they have been an Idyllwild attraction, sometimes bringing in as many as 1,200 people to the site. Dahleen and board begin the season with no guarantee they will be able to raise the \$20,000-plus budget needed to fund the series. They rely on community sponsors and donations — jars handed out at each concert. "Now there is a need to raise an additional \$640 per season and it is a struggle to raise necessary costs as it is," he said.

"I was told that [the rent increase] is because of overall overhead increase of the park," he said. Dahleen said he does not believe the ISCS series costs ICC or significantly economically impacts it through its use. "We provide full insurance and indemnification for the ICC and its own-

ers, provide all trash removal including their cans, provide trash liners for all cans during the season, clean the park each week, including the basketball court at the north end of the park before and after each use and at the end of the season, provide additional portable toilets for concert use, and take responsibility for security and arrange for Mountain Community Patrol to patrol as needed for parking and security." Dahleen that the amount of electricity the series uses is small (he takes meter readings before and after each concert) and although by contract he agrees to pay for electricity, ISCS has never been billed for electrical use.

Dahleen said he and his ISCS board are concerned about the fee raise for a number of reasons. One, it was unexpectedly large and two, because whatever fees are set, those will be passed on to the community.

Chris Trout, ICC spokesperson, said the fee schedule is available on the ICC website at www.idyllwildcommunity-center.org/icc-pac.html. It will impact not only Dahleen and the ISCS board, but all users. Fees charged for park use are: "Partial day use" (four hours or less) — private party, \$60; nonprofit, \$40; business, \$100. "Full day use" (sunrise to dusk) — private party, \$100; nonprofit, \$100 and business, \$150.

Said Trout, "This has been an across-the-board fee increase determined by the board and these are the new fees for 2015 that are fair and equitable for all."

Through the help of volunteers, careful and vigilant eyes spotted two bald eagles by their nest during Saturday's U.S. Forest Service bald eagle count. Charles Reinhardt is

Bald eagles number 13 in latest count

During the second of four Saturday bald eagle counts, two adults were seen at Lake Hemet last weekend. A total of 13 bald eagles were seen in the San Bernardino National Forest on Jan. 10 during the count period, four more than the December count.

Public volunteers and U.S. Forest Service biologists again saw one adult eagle at Lake Perris and one at Lake Gregory. Observers counted four eagles (two adults and two juveniles) at Lake Silverwood. This count saw two adult eagles at Lake Arrowhead and three eagles (two adults and a juvenile) at Big Bear Lake.

The remaining bald eagle counts for this winter are scheduled for Saturday morning, Feb. 14 and March 14. No experience is needed to participate in the counts.

Bald eagles are usually found close to water, such as Lake Hemet, because their diet is primarily made up of fish and ducks. As winter approaches in northern regions, lakes freeze over and waterfowl fly south. For bald eagles, that means the food they eat has become scarce. So, they head south looking for areas with abundant food supplies and end up wintering in Southern California, according to the Forest Service.

Breeding populations of bald eagles in Southern California were extinct by the late 1950s. Since 2003, several pairs of bald eagles have decided the Southern California neighborhoods were too nice to leave — they built nests and have successfully raised families. Nesting bald eagles can now be found at Lake Hemet, Lake Skinner, Lake Matthews and Big Bear Lake.

As the local populations continue to grow in North America, year-round residency and nesting is becoming more common.

A female eagle hatched at the San Francisco Zoo in 2000 was released as a chick on Catalina Island as part of the reintroduction efforts. In 2004, she arrived at Lake Hemet and decided to take up year-round residence with the male bald eagle already there. This pair has nested every year since then and fledged several eaglets over the past 10 years.

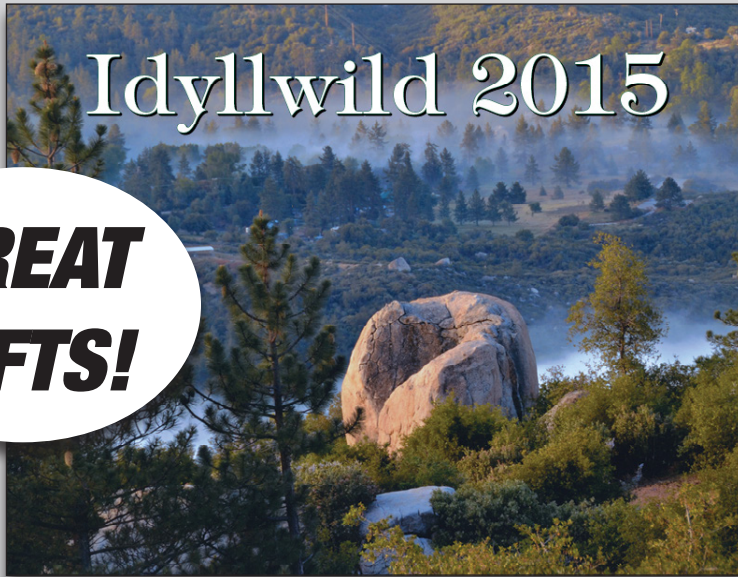

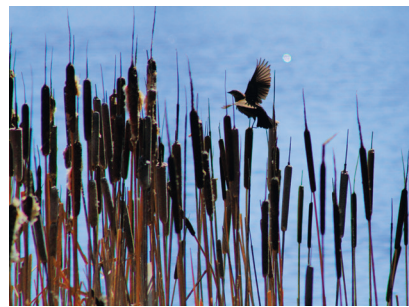

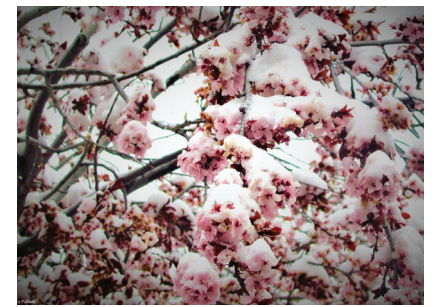

equipment." Retailers send collected fees to the California Board of Equalization for distribution to approved waste collectors.

The legislation was drafted to encourage responsible recycling and disposal of specified items by California consumers. According to the Cal Recycle website, www.calrecycle.ca.gov/Electronics/Act2003/Consumer/Fee.htm, "The intent of the [point of sale] fee is to reduce or eliminate the costs associated with properly recycling this material when it

becomes waste."

Waste Management Inc., the "approved waste collector" that operates the local transfer station, receives these fees through the Board of Equalization. When spokesperson Eloisa Orozco, area communications manager of Waste Management of Southern California, was contacted about electronic waste fees assessed twice (consumer payment at point of sale and then at transfer station) she said she was unaware of the cited California legislation.

Allan Katz, Idyllwild 2015 Lifetime Achievement Award

His portfolio is not complete

At Saturday's Award Ceremony for the 2015 Idyllwild International Festival of Cinema, Allan Katz received the Lifetime Achievement Award.

"He was genuinely taken aback and surprised by the honor," said IIFC Chair and founder Stephen Savage.

Katz's career included several years writing for "M*A*S*H", which Savage says was enough alone to qualify him for the award, "But his resume includes hundreds of other shows.

"He's an iconic Hollywood denizen, a filmmaker who is often under the limelight," Savage added.

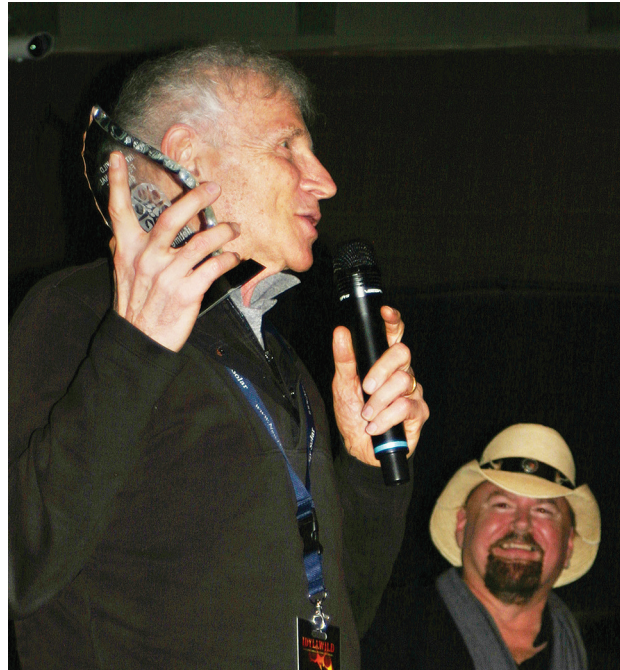
Katz, from Chicago, began his Hollywood writing career in 1967 on "Rowan & Martin's Laugh-In." He also wrote for several other popular vintage comedies such as "Sanford and Son," "All in the Family" and "The Mary Tyler Moore Show." Besides writing, he also helped produce "M*A*S*H," "The Cher Show," "Rhoda" and "Roseanne."

"[The business] has changed a lot since then," Katz said. Network management is much more involved in the creative process, to the distress of many writers and creative partners. When he was producing, there might be three or four other people involved in production activities. Today, there are dozens of producers for each show. On one show recently, Katz encountered more than 20 production staff and "... at a studio, anyone can change a script."

The number of writers has grown substantially, too, according to Katz. Now, six or seven people develop one half-hour script.

The serially, or episodic, nature of today's programs is also a major change, Katz said. "It used to be 'must see TV.' You didn't have to know what happened before the episode you were watching."

Filmmaking or movies is all about financing now, creativity is secondary. Independent filmmakers have to demonstrate how much advance sales are available before studios consider financing. Pre-sales to cable, Eu-

rope, Asia, DVDs and accessories are all part of the money-making equation. A mediocre \$150-million movie, with renowned actors, might have \$170 million in pre-sales so it's made and will appear on thousands of neighborhood screens.

However, Katz's most recent movie production is in a different league. "Bucky and the Squirrels," his film at Idyllwild 2015, cost slightly less than \$500,000 to produce. "Of course, that's because we're professionals and have done many and know how to schedule," he said proudly.

Contributing to the successful production of a low-budget independent was the commitment of much of the crew, who were Katz's friends and who promised to work: "If we don't lose money, we'll do it."

Katz's long-time friends Tom and Julie Hurvis, alumni of Appleton University in Wisconsin where the film was made, financed "Bucky."

"If this film sucks, I've got no one to blame but myself. If 'Bucky and the Squirrels' has a message, trust me, it's

in there by accident," said Katz proudly, who wrote and directed the film.

"I loved doing this film. I'd do it again. It's the perfect way to do a movie and everybody did it for the right reason," he added adamantly. "This has been my favorite writing experience — up until now."

While Katz has written many television and film scripts, his talent goes beyond dialogue. His repertoire includes the libretto for the musical "Zapata" and others. His essays have been published in the Times — on both coasts, the New York and Los Angeles papers.

The 800-word satirical essay for the New York Times was completed after 39 drafts, Katz said while describing his work process. "I rewrite, rewrite and rewrite until it's the best I can do."

But he did lament the numerous scripts he has in his head. "It's hard to write another script and not know how to get it made. It's easier for me when I know it will be produced."

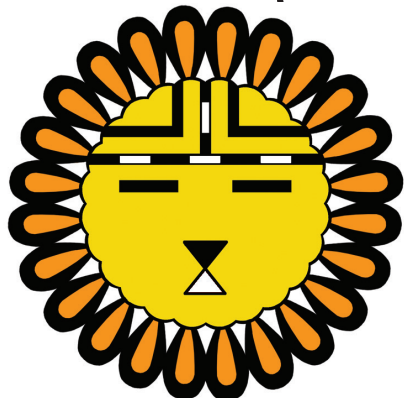

the James Song dogs ...

Greetings from the James Reserve. In continuing at our peeks into the natural world, this installment will be on another species of mammal found in the James and Idyllwild area, the coyote. I refer to them as song dogs in the title because we not only often see coyotes around our woodland homes but we hear them! Their howling is one of those iconic sounds of the West. No western movie is complete without the campfire and the forlorn howling of coyotes in the distance.

And not surprisingly, this species has figured substantially in the legends and stories of the native peoples. Most native stories depict coyotes as cunning and tricksters. The coyote totem symbolized playfulness, intelligence, joy, being highly adaptable and forming strong family bonds.

But beyond the legends and stories, what are the facts behind the song dog? Well, having studied them for many years, I can attest that coyotes live up to their reputation well. Cunning and intelligent they certainly are. In my attempts to capture them, many times the traps

were left empty as clever animals figured out how to trip the trap and steal the bait. Also, if caught, I never recaptured the same animal twice.

However, I think the greatest testament to their intelligence and adaptability is that after hundreds of years of persecution by us, coyotes not only have survived but have thrived. I also have seen ample evidence of their close family ties, male and female working together to raise their litter of pups, keeping the pack together with their "songs."

So coyotes do live up to their centuries-old reputation, which is nice. They are a species we can and have admired for many reasons. However, we often hear the time worn admonition, "Ya, but what good are they? Ar-

en't they just a predator who kills our chickens and other small livestock?"

What good are coyotes? As I wrote in a previous column on mountain lions, predators are not vermin but do have very beneficial roles in the ecosystems in which they live. And coyotes are no exception. As a medium carnivore, at about 25 pounds, coyotes eat medium to small prey. Extensive studies of their diet repeatedly show coyotes are specialists on rabbits and rodents, the same rabbits and rodents we often complain about eating our plants and vegetables. I have estimated that a single coyote could consume up to 3,500 rodents per year. Imagine if those rodents lived and reproduced.

Needless to say, as mountain lions do with deer, coyotes are the guardians of ecosystems against damage from excess medium and small herbivores. Besides catching live prey, coyotes also scavenge on animals who have died. So they have another role as a cleanup crew, ridding the environment of dead carcasses that could harbor diseases.

Considering everything, we should feel lucky to have the song dogs on our mountain to serenade us with their spirited refrains and maintain the integrity of the environments we call home.

Wildlife watch: Entering into the winter months, we often see coyotes moving along the highway even during the day. The reason for this is that December is the time when pups of the year disperse and moving along roads or trails makes it easier. We will also hear a difference in their songs as the howling shifts in meaning from maintaining family groups to territorial defense of mated pairs who will produce a new set of pups in early spring.

Jo'An's Restaurant closed for renovations

Jo'An's Restaurant & Bar is in phase 1 of a four-phase renovation, according to new owner Mo Jacob, and was expected to re-open the middle of this week. The restaurant closed at 5 p.m. Sunday, Jan. 4.

Heading the renovation is contractor Brad Rechtfermig, owner and builder of the boutique inn The Grand Idyllwild Lodge. In a two-hour interview, Jacob lined out the changes coming.

Carpet was pulled, as well as the separating wall in the middle of the room, and new tile was being laid that looked like wood. Steve Zaccardi was putting all booths under re-upholstery with, as Zaccardi said, "higher-end," leather-like fabric in bright red.

Booths will be located on the outer perimeters of the restaurant. New tables and chairs will occupy the center of the room and be moved for a temporary dance floor with a portable stage occupying the space between the two large windows facing Village Center Drive.

The interior walls will be painted a brownish color to complement the booths while the outside of the

restaurant will be similar to the exterior colors at the Grand Idyllwild Lodge. Other changes will include lighting.

However, no changes will be made to the bar, the kitchen or the restrooms at this time.

Jacob purchased Idyllwild Property Management last year. IPM is a long-term property manager of about 75 properties, he said. But Jacob, a real estate broker, plans to expand to offering short-term property management, as well as hiring two real estate agents and offering escrow services.

In phase 2 of Jo'An's, the beer garden will undergo upgrades: picket fence replaced with ranch-style fencing; plants added between fencing and rock wall for color; new stage; garden area covered with paving stones; barbecue grills replaced with professional one; new, low-voltage lighting; and possible replacement of tables and chairs. May of this year is the planned completion of phase 2 for the summer season.

He emphasized that a rumor that he plans to cut down the Christmas tree is false. "It's not going to happen," he said. Jo'An's made a significant donation to Phyllis Mueller's efforts to save the tree. He said the tree needs more than water; it needs nutrients, too.

"To the contrary, we love the tree, we want to support the tree ... We're keeping all the trees ... We will

keep the tradition of the Christmas tree."

In phase 3, ranch-style fencing also will surround the south and east sides of the property; broken concrete will be replaced; flowers and trees added; a canopy over the back patio will allow for the restaurant's overflow; and possibly a game area. He also is thinking of the possibility of a playground along that side facing Ridgeview Drive.

Phase 4 is undecided with two ideas at this time: a coffee kiosk with tables and free wi-fi in warm months on that corner facing Village Center Drive; or an area providing E-ZUps and tables for people to rent and sell their wares with a right of first refusal to local businesses. Fresh sandwiches made in Jo'An's kitchen might be sold at the coffee kiosk.

When asked, "Is there a phase 5?" Jacob replied, "Not yet. I'm talking to Brad about something unique for Idyllwild."

He said he already has upgraded the food at the restaurant and his goals are to improve the food, the look, the service and the entertainment.

In the meantime, he's also asking for recommendations whether to keep or change the restaurant's name. Email your entry to jo.ans.restaurant.bar@gmail.com.

Former resident returns with powerful documentary

Idyllwild International Festival of Cinema Founder and Director Steve Savage said of his friend's movie before it played Saturday afternoon, "It is very special, very poignant, very moving," and left the stage for the audience to witness themselves.

"A Man Called God" is the story of a handsome, 14-year-old American boy who lost his innocence in 1980 in a South Indian ashram to a world-renowned guru named Sai Baba who had 50 million followers, all believing he was God. Emmy-award-winning actor Kristoff St. John, best known as Neil Winters in the "Young and the Restless," narrates his own story through footage the late Baird Bryant shot and Kristoff's actor father, Christopher St. John, directed.

After struggling with shame and confusion, Kristoff told his father of the three molestations in hopes his parents would get him away from Sai Baba. Lucky for him, his father took notice. Sadly, his step-mother, Maria St. John, an actress in her own right, was so swept up in Sai Baba's movement she did not believe her son. While father, son and film crew — there to film the trip — packed up and came back to America after four months, Maria remained behind, ousted from the ashram because Sai Baba suspected the family knew of his "sins." She stayed in the neighboring village, begging to return, waiting at the gate of the ashram but finally returning to America after receiving death threats.

Chris and Maria's marriage would not survive the trip. "God" didn't make it either. Sai Baba, claiming immaculate conception and to be the father of Jesus Christ, died in 2011, still with millions of followers, despite years of allegations of molesting hundreds of boys and other wrongdoings.

Nearly three years ago and after much prodding by Kristoff, Chris allowed his son to view the footage he and Bryant produced and shelved. Kristoff took what was to be a tribute to "God," and came away with a powerful message about religious leaders and men in power who indoctrinate their beliefs into the minds of people so weak and searching for answers, as he said in the film, "We sell our souls for one little piece of heaven ..." "Remember Jonestown" is repeated throughout the film.

Just seven years before this now 48-year-old lost his innocence to a powerful, only 5-foot-tall orange-robed avatar behind a red curtain for the reason of "divine purification" while his parents naively waited for him not far away, Kristoff was a happy boy living in Idyllwild.

"Some of my greatest memories were of here as a boy playing in the grotto, swinging from trees on ropes, riding my bike up and down Inspiration Point, going to Idyllwild Elementary ..." said Kristoff. "Idyllwild has a special soul to it ... I retreat to Idyllwild for brief periods of time just to feel it again."

The St. Johns lived here full-time in 1973 and 1974, living an alternative lifestyle away from the insanity of Hollywood — bell bottoms and health food, like many young people during that era.

The family became friends with Town Crier former owners Luther and Marilyn Weare, so close that one day, one of the Weares' daughters came home and caught Kristoff stealing cheese from their refrigerator.

"My parents had me on an austere diet of raw foods and it was not uncommon for me to go to school with a big shopping bag full of carrots, celery, sunflower seeds (not salted), sprouts, maybe an avocado and that would be it. So I started stealing lunches — this is why I stole from Marilyn and Luther — I stole lunches from Idyllwild Elementary. No one knew for, I don't know, a good six months. Then finally the lunch thief was caught because in the lunchroom, one of the kids was named Bud. I'll never forget it. He saw me eating an item from his lunch and he said, 'Hey, that's mine,' ... and he

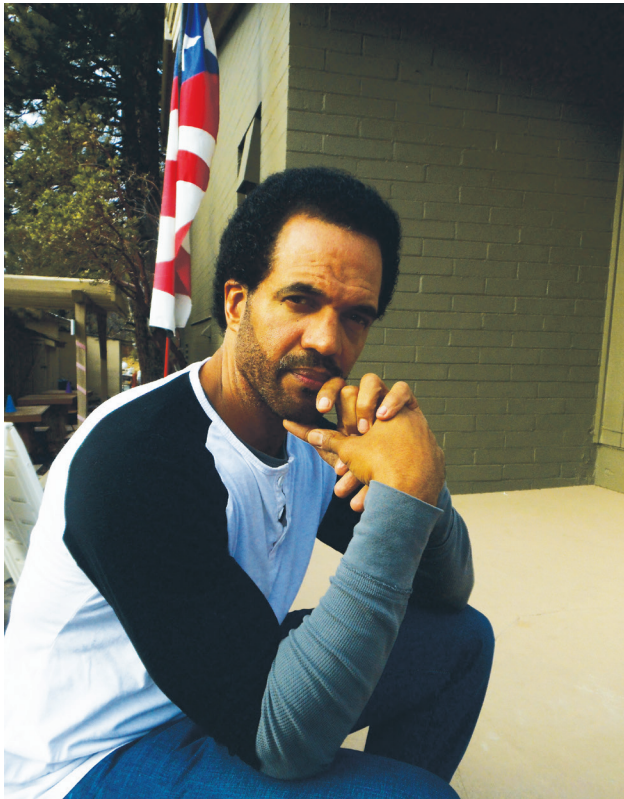

ripped open my bag and out fell his lunch that said 'Bud' in big letters. I was busted," he said, laughing.

Baird Bryant is another Idyllwild connection, though Bryant would not move to Idyllwild for several more decades. Chris, best known for such films as "Shaft," had worked professionally with the award-winning cinematographer. In the early 1970s, Maria became very much caught up in Sai Baba's movement. From that came the idea to go to India and have Bryant film the trip. Sai Baba also wanted the filming. Kristoff said Bryant was reluctant but finally decided to go.

"Baird Bryant was a champion," said Kristoff. "He shot this film so beautifully and cinematically, unlike any other documentarian would do. He had a film style, because he was a director of photography, so he would set up and then just roll the camera. Nine times out of 10 the entire reel would be useable, we just couldn't use it all. We had 20 hours of film we had to whittle down." Bryant died in Hemet in 2008. (View his obituary at <http://idyllwildtowncrier.com/2008/11/27/obituary-baird-bryant/>)

When asked how he was able to narrate a story so personal without an-

ger, Kristoff said, "Well, it was important to tell this story in such a way that the audience would be able to digest the information without a hostile environment. The story itself is hostile enough. The images, which are very surreal, colorful, a lot of super impositions, a lot of slow motion, a lot of time lapse — I thought the narration should be gentle, yet pointed, strong and poetic."

Did he ever think of having someone else do the narration? "Never, never, because then it would have taken away the personal touch. It's my story. There was no one else who could narrate this."

The award-winning documentary, unfortunately, has not been released to the general public, but it at least touched a few who attended its showing. Several in the audience during the Q&A afterward said they had similar experiences as children, thanking Kristoff for opening up about such a private experience. "I think [the film] will help ease the pain of a lot of young people, and old people alike, who have experienced this ...," said Kristoff. Later that evening at the IIFC awards show, it earned the Best Documentary Award.

Marshall Hawkins — musician, educator, mentor ... Idyllwild icon.

His contributions to the lives of others are legion. Student after student, year after year, his accolades amass. What they've learned from him about music, jazz, character — life in general — would fill a thousand films.

The life work of a rare few is preserved forever in a 70-minute documentary. Two of Hawkins' former students, (Devon Gilpatrick and Ashi Manoff), have remarkably captured the Marshall Hawkins who enhanced their lives.

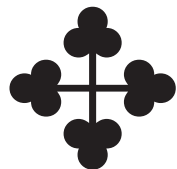

Sen. Stone appointed to key senate committees

Last week, Sen. Jeff Stone (R-28th District) announced his appointment to serve on four major committees and one Budget Subcommittee in the California State Senate.

Stone will serve as vice chair of the Natural Resources Committee and also of the Labor and Industrial Relations. He also will serve on the Budget and Fiscal Review Committee, the Public Safety Committee and the Budget Subcommittee for Health and Human Services.

On the Natural Resources Committee, Stone will have key input and influence into the future of one the region's most valuable and beloved assets, the Salton Sea.

"Water is going to be very important in this legislative session," Stone said in a press release. "I look forward to working with my colleagues on both sides of the aisle to make sure adequate funding is provided for the Salton Sea

restoration."

The NRC has jurisdiction over bills relating to conservation and the management of public resources, fish and wildlife, regulation of oil, mining and geothermal development, acid deposition, wetlands and lakes, global atmospheric effects, ocean and bay pollution, coastal resources, forestry practices, recreation, parks and historic resources.

The PSC has jurisdiction over bills that amend the existing Evidence Code, the Penal Code, and those that deal with the Department of Corrections and Rehabilitation.

The LIRC has jurisdiction over bills relating to labor, industrial safety, unemployment, workers' compensation and insurance, and non-certified public school employees.

The BFRC handles the main budget bill and legislation necessary to implement the state budget, including deficiencies and re-appropriations.

tasked Barton with finding a way to include service for Pine Cove in the negotiations.

"... I have constituents in Idyllwild and Pine Cove, especially Pine Cove, that pay a fee for ambulance services. If we go with [this option], is it assumed that we will be working with AMR to provide for ambulance coverage in that underserved area?" Stone asked Barton.

And the new contract does relieve these residents of the additional fee collected and paid through their CSA property taxes and a parcel fee.

Many areas of the county have a much higher call and transport volume than the Hill and the rest of the Mountain Plateau area. Because of AMR's will-serve to

these highly profitable areas, Barton said, "[T]hese pay for them to take lower-call volume areas which don't generate enough revenue."

This fiscal year, the CSA 38 cost for the Pine Cove ambulance service to IFPD is \$128,900. With the county's payment to IFPD for service to zones 2 and 3, which extend north of Pine Cove, IFPD will receive nearly a total of \$180,000 in 2014-15. In addition, there will be fewer transports of patients to hospitals, which means IFPD may lose about \$225,000 a year starting July 1.

In 2013, 61 of IFPD's 317 transports were from Pine Cove and Zone 3. Through November 2014, Idyllwild Fire Chief Patrick Reitz reported that 53 of its 360 patient transports were from outside the district. So perhaps 15 to 20 percent of

the district's ambulance receipts, or an additional \$50,000 to \$70,000, also are in jeopardy.

IFPD officials have consistently insisted the district loses money providing this service. Consequently, the money saved maybe able to help the district with its current financial condition. When asked about the contract's effect on the IFPD's revenues, Chief Patrick Reitz replied, "The district has been and will continue to be supportive of the proposed contract between Riverside County and AMR. The district maintains an excellent working relationship with both [Riverside Emergency Medical Services] and AMR and will continue to into the future."

AMR already stations an ambulance in the Anza area and is expected to find a location in Pine Cove. County Fire Station 23 is the most

likely location, but no formal agreement has been reached, according to Barton and County Fire Chief John Hawkins. Thus, AMR will have coverage at both ends of the Mountain Plateau area.

"There could be more resources in the future if we can develop a public/private partnership," Barton added.

Within Pine Cove, the maximum acceptable response time will be 12 minutes; it currently is 10 minutes for IFPD. Along highways 371 and 74 and all of Garner Valley, the response time is set at 20 minutes. Most of the remainder of this ambulance zone will receive 30-minute response, except for the isolated wilderness areas, which will have 60-minute response goals.

She noted Waste Management Inc. obtained approval from the Board of Supervisors in July 2014 to enact these new fees but delayed their implementation until November.

Extra fees WMI charges are permitted by state legislation (see California statutory regulations, Title 14, Natural Resources, Chapter 8.2, Electronic Waste Recovery and Recycling, Article 2) if the recovery payment

(from the retailer) does not cover full disposal costs and the collector can document the additional costs.

Orozco said the fee on property owners' yearly tax bills for the transfer station includes handling of "standard municipal solid waste and recycling and does not include services for the handling of electronic wastes. Electronic waste is a specialty item that must be diverted from landfills and regular recycling processors."

As a result, she said, "The fee of \$25 per item is

to help cover the costs associated with having this convenient drop-off service available to residents at the transfer station where our personnel handle the devices, which are inherently hard-to-handle items, as we comply with laws and regulations that are applicable from the point of drop off." That's the the reason for the new fees.

Orozco's alternative for residents who don't want to pay the \$25: "Idyllwild residents are welcome to bring their electronic waste at no

charge to our Moreno Valley Transfer Station located at 17700 Indian St. ... Monday through Friday from 7 a.m. to 5 p.m. and from 7 a.m. to 1 p.m. on Saturday."

Sondra Reynolds, Cal Recycle Public Affairs spokesperson, said the initial legislation's intent was that "consumers were not supposed to be doubly charged. You're not supposed to be charged an additional tipping fee; we pay that."
