## Isis Theatre Company changes name

For 12 seasons, one of Idyllwild's premiere theater companies has served the community with varied and ambitious theatrical fare under the name Isis Theatre Company. Company founder Suzanne Avalon chose the name 12 years ago because the Egyptian god-

dess Isis represented power and wisdom, and the theater company was formed with an all-women board.

Unfortunately and untimely for Avalon's company, another entity not devoted to culture and education has cast a pall over the company's use of its long-held name. ISIS, the self-styled Islamic State

Lois Denholm has worked at Fairway for 15 years. Now because of husband Bob's COPD and congestive heart failure, she has to move off the Hill. She faces the unexpected challenge and expense of having to relocate after many years and do so within a very short time frame.

"He's been on oxygen for several years, but all of a sudden, two weeks ago it didn't seem to be enough," said Lois. After an emergency trip to Eisenhower Medical Center in Rancho Mirage, doctors discovered that Bob's condition had worsened and that he was not able to expel the carbon dioxide that was building up in his lungs.

## Rep. Ruiz visits Hill, talks with local firefighters

### Discusses legislation and abatement with Fire Safe Council

Congressman Dr. Raul Ruiz (Cal-36) was on the Hill Friday to discuss and advance his concerns about wildfires and his legislation (H.R. 1009) submitted last month.

Ruiz met with officials from the three local fire departments —

Idyllwild Fire, Riverside County and the U.S Forest Service staff from the San Jacinto Ranger District — as well as the Mountain Communities Fire Safe Council.

Following that session, Dan Felix, San Jacinto District fire officer, led the whole group on a tour of the area in Apple Canyon and the Bonita Vista community burned during the 2013 Mountain Fire.

Before returning to Idyllwild, Ruiz told the group, "Your spirit is very unique. I don't really see it at other places. I think this is an indication of





# NRCS has forest project funds for local landowners

During the Mountain Area Safety Taskforce meeting last week, Peter Hoagland of the Natural Resource Conservation Service announced the availability of grant funds for abatement on the Hill.

The money is available to help landowners and residents address problems such as soil erosion, water quality, invasion of non-native and native pests, degraded riparian forests, fuel abatement and tree planting. Landowners normally contribute 25 percent of the project cost.

"We have a lot of funding this year," Hoagland said. "There is a reimbursable cost-share, but we haven't had a lot of applicants this year."

The funds are for projects in both the San Bernardino and San Jacinto mountains. Robert Hewitt, district conservationist at the NRCS San Jacinto office, indicated that since the contractor payments are on a per-acre basis, it is more cost-effective to work in 4- or 5-acre parcels.

"We need significant size lots, given the costs," he said. For example, NRCS will commence work at Living Free later this

year and has completed projects at Pine Springs Camp and Camp Joe Scherman.

When Hoagland indicated at the MAST meeting that projects required a minimum of 1 acre to qualify, Marge Muir, local real estate agent, asked if property owners with less than an acre could combine for one project since many homes on the Hill are on less than an acre.

Hoagland replied that NRCS has worked with homeowner associations in the past. Hewitt said each owner would still have to complete an application. He encouraged small parcel owners to still contact his office at 951-654-7139.

If one is interested in applying for these funds, contact either Hewitt at the San Jacinto office or Hoagland or Kim Lary, district conservationist, at the NRCS Redland Service Center at 909-799-7407.

The funds are part of a special partnership between NRCS and the Forest Service. The Chief's Joint Landscape Restoration Project has \$30 million to allocate among 13 projects in 12 states, including private forest lands within and adjacent to the San Bernardino National Forest.

# Two injured in motorcycle crashes on Highway 74

A solo motorcycle rider struck gravel on Highway 74 and overturned at 12:50 p.m. Sunday, March 15. The rider, Chase Choe, 34, of La Crescenta in Los Angeles County, sustained major injuries and was taken by California Highway Patrol helicopter to Desert Regional Hospital in Palm Springs.

Chloe was riding his 2004 Harley-Davidson up the mountain when he encountered gravel, according to CHP Indio Public Information Officer Mike Radford. Radford noted no alcohol seemed apparent in the crash, Choe was wearing a proper helmet and no other vehicles were involved.

A solo motorcycle crash on Highway 74, one-tenth of a mile west of Keen Camp Road at 12:20 p.m. Saturday, March 14, left the rider with moderate injuries.

Darren Koepnick, 22, of Twenty Nine Palms, was riding west on his black 2013 Kawasaki street bike when he ran off the road, according to CHP San Geronio Pass Public Information Officer Darren Meyer. No other vehicle was involved, said Meyer.

Koepnick was transported by American Medical Response to Riverside County Regional Medical Center in Moreno Valley for treatment of his injuries.

Chloe's and Koepnick's crashes continue a string of motorcycle incidents over the last four months on highways 74 and 243 that have exceeded previous years for fatal and moderate-to-major injury crashes.

# Lost hikers rescued in wilderness

California Department of Parks and Recreation rescued two female hikers of Ramona in the early morning of Saturday, March 14, at Mt. San Jacinto State Park Wilderness.

About 8:30 p.m. Friday, State Parks received notification of two missing females ages 64 and 65. A four-person

State Parks rescue team was activated and started the search for the missing hikers.

With very little information on the location of the missing hikers, the rescue team was split into two groups, finding the missing hikers in fair condition about 2 miles from the ranger station, down a

route known as Skyline. The last 2 miles of the Skyline route are the most treacherous.

The State Parks rescue team began its 2-mile ascent with the female hikers safely arriving at the ranger station at about 3:30 a.m.

The rescue team and the missing hikers stayed at the ranger station until 6:30 a.m. waiting for the Palm Springs Aerial Tramway to open so they could make their way down the mountain.

# Expect more dying trees this spring

Forest threats were the main topics during last week's Mountain Area Safety Taskforce meeting.

A public meeting about the status of the Goldspotted oak borer has been scheduled for Saturday, April 18, at the Nature Center. Cal Fire's Mountain Area Forester Gregg Bratcher announced the meeting and said the Mountain Communities Fire Safe Council has organized it. Speakers will include Kevin Turner, GSOB coordinator for University of California Agricultural and Natural Resources Riverside, and Tom Coleman, U.S. Forest Service entomologist.

The grove of oaks in Orange County, which Bratcher first discussed at the December MAST session, has seen the number of affected trees more than double from the 30 first identified late last year. "We have no idea how they got there," he said. "However, we think it is from firewood."

If anyone is transporting firewood through the San Jacinto Ranger District, they must have either a permit from the Forest Service for gathering the wood or a bill of lading proving the source of its purchase, according to Battalion Chief Chris Fogle, U.S. Forest Service.

Based on his experience on the Hill combating the GSOB, Bratcher has been helping Orange County officials develop and implement their rapid intervention program.

On the Hill, the number of oaks that have confirmed GSOB presence is 62, which is only an increase of one since December. With the arrival of spring, MCFSC volunteers have resumed their neighborhood inspections for possible infected trees.

Before the new leaves appear, oaks, which are still holding many dead leaves, should be assessed. Bratcher encouraged residents to be constantly vigilant.

If a property owners suspects an oak tree may be infected, they should first visit the University of California, Riverside's GSOB site, <http://ucanr.edu/sites/gsobinfo/>. Then call Cal Fire's GSOB hotline at 951-659-8328.

But the GSOB is not the only pest threatening the local forest. As the meeting began, Riverside County Fire Chief John Hawkins asked about a cluster of dead pine trees just north of the Transfer Station. "And what has killed three great sequoias in front of the school; they are not easily killed by insects or diseases?"

Marge Muir, Pine Cove resident/real estate agent, also mentioned a number of pines dying along Tollgate

Road. Bratcher stressed that, as warmer spring temperatures arrive, residents will see more clusters of dead pines.

On Friday, while touring the Mountain Fire burned area, Hawkins warned Rep. Dr. Raul Ruiz that the Hill will see a lot of brown pines in the next four to six weeks as a result of beetle attacks during the drought.

Later in the MAST meeting, while discussing the dangers of transporting firewood between different ecological zones, Bratcher and Dan Felix, San Jacinto Ranger District fire officer, warned the group about the potential threat from Polyphagous shot hole borer. While this beetle favors avocado trees, and local growers are very worried, it will attack many other trees, such as oaks and willows common to the Hill. Consequently, transporting firewood harboring the PSHB many introduce it to the Hill.

The message was: People shouldn't be moving firewood.

The PSHB beetle is very small. The female will lay its eggs in a host tree and in some, but not all instances, transmit a fungi, Fusarium Dieback disease. UCR already has a group of scientists addressing this pest similar to their studies of the GSOB.

Besides these beetles, the black pineleaf scale has established itself on the Hill. In 2013, the California Forest Pest Council said 200 acres of Jeffrey pine were infected by the scale. Turner said the scale takes fluids from pines, which during a severe drought, weakens the tree and puts it under stress, making it more susceptible to bark beetle attack. However, it is a native pest.

During a discussion of agency projects, Division Chief Bill Weiser, Riverside County Fire, announced that Cal Fire will again augment its Hill resources with a type 3 engine in early April and a second engine in May.

The agency is burning piles in the Dark Canyon and Stone Creek areas, Bratcher said. Future projects are still under study, he added.

The Forest Service is working in the South Ridge and along the Strawberry Fuelbreak areas, according to Felix. Soon, the masticator will be used to maintain the Pine Cove Fuelbreak. He also said that with a good weather window, residents in the West Ridge and Strawberry Fuelbreak neighborhoods should expect to see some pile burning.

A request for proposals to install a new early warning system in the county may be released within the next month, according to Peter Lent, deputy director of the County's Office of Emergency Services.

"The schedule is for the new system to be online, tested,

and operational by Nov. 30, 2015," Lent wrote in an email. A 2014 Homeland Security grant of \$225,000 provided the funds for the project.

Stacey Hubbard, of the county's Waste Management Department, said the county will assume operation of the Grinding Station on May 17. A drop in tonnage caused the county to re-consider using a contractor to manage the station. It will be open two days a week, probably Tuesday and Saturday, she said. The station will open Saturdays beginning May 2. The \$32.89 fee per ton will continue. If homeowners are turned away from the Transfer Station, they may bring green waste to the Grinding Station, she said.

Until the station is fully operational, Bratcher said he has an alternate plan for removing GSOB-infected trees from the Hill, especially with flight season approaching.

of Iraq and Syria, is an extremist terrorist group now controlling territory in Iraq and Syria and expanding into Lebanon, Libya and the Sinai Peninsula of Egypt. And new among Islamic extremist groups, ISIS uses social media to promote its agenda, using beheadings to frighten and intimidate opponents. That use of social media has pushed the ISIS name into the forefront of world news and effectively branded the name as one associated with terror.

"We thought about changing the name several months ago," said Avalon, "but after researching how many worldwide organizations or works of art shared the name we decided to hold firm." Others using the

name Isis include a French opera, the second track on a Bob Dylan album "Desire," a post-metal band in Los Angeles and a creative integrative arts therapy training program in Canada.

But as questions over using the name surfaced, and licensing companies holding the rights to plays also raised eyebrows, Avalon said her board began to rethink its position. Then a producing organization in Indio, the Indio Performing Arts Center, said they could not move forward on a proposed contract if "Isis" were in the name. "With the coming on board of a new executive director at the Indio Performing Arts Center, we were told that they would keep the contract but they could not use 'Isis' in any advertising or promotion," said Avalon.

And with that, Avalon and board bowed to the inevitable — that a terrorist group thousands of miles away had so co-opted and branded the word ISIS, that the name could no longer serve the company's interests and, in fact, could stand in the way of potential business and contracts.

"It's a shame after 12 successful seasons to have to change the name," she said. The company has nearly 60 productions under the name. She said highlights from those seasons include plays directed toward young audiences. "Being able to get kids involved with theater, maybe even seeing their first play, was very satisfying," she said. "Also, we have grown so much professionally during these 12 years. Having Howard Shangraw as our

artistic director has made a big difference."

Avalon said the challenge facing not just her company, but others in Idyllwild, is not having a permanent theater. "It's so difficult to have to load in sound, lights and stage when we produce a play," she noted. Avalon said a company in Joshua Tree, where she and Shangraw performed "Love Letters," has its own black-box theater, something that all actors and directors in Idyllwild would very much like to have — a goal for the future.

Now, said Avalon, it's moving forward under a new name, one incorporating "Idyllwild." The first production as Idyllwild Actors Theatre will be "Seminar" by Theresa Rebeck, May 22 and 23 at The Rainbow Inn.

From Dan Weikel of the Los Angeles Times, on Oct. 2, 2005: "Ortega Highway has for years been one of California's deadliest roads — 30 miles of twisting narrow asphalt, plunging cliffs, say-a-prayer blind spots and heavy commuter traffic meandering through the mountains of south Orange County." <http://articles.latimes.com/2005/oct/02/local/me-ortega2>

Today, the same can be said of highways 74 and 243 without exaggeration.

I've been regularly driving Ortega Highway between Orange County and Idyllwild since 2003. I've witnessed numerous accidents, some fatalities, along that winding stretch.


Several years ago, Ortega Highway went through extensive improvements to widen particular stretches, shore up bridges and add turnouts. Yes, it was an inconvenience for myself and other motorists while we were at a standstill, cars piled 24 deep waiting for up to 16 minutes to be led through one-lane sections.

Was it worth the frustration and tax dollars? Absolutely. The difference before and after is like night and day. Or perhaps I should say life and death. Wider roads leave drivers more room to maneuver on turns or if a deer jumps onto the road. More turnouts mean less tailgating, and that, in turn, leads to fewer rear-end collisions.

Additional signage gives advanced notice of sharp turns and reminds us to slow down.

I don't know the current statistics of accidents on Ortega Highway since the improvements were made, but I personally haven't seen any in recent years. I would speculate crash numbers are down.

I fully support the efforts of the CHP to seek funding and cooperation with other government agencies to designate highways 74 and 243 Safety Corridors so our Hill can become a safer place to drive. Let's



be patient should the funding come through and construction begin. The next life saved might be yours.

### Fire safety statement

Cal Fire/Riverside County Fire Department/County Office of Emergency Services is committed to providing the best public protection possible and to always work to improve community life and property safety. We will analyze what is best to reduce risks for a community, report what is best, and work hard to implement what is best for life and property risk reduction. This is just what we have always done and will continue to do for the San Jacinto/Santa Rosa mountains area.

We support collaborative private/public partnerships that jointly work to reduce risk from all types of hazards, person- or naturally caused. County Fire/County OES will work very closely with citizen volunteer organizations, including the Mountain Communities Fire Safe Council and its Woodies, Mountain Disaster Preparedness, the Idyllwild HELP Center, Mountain Radio Amateur Civil Emergency Services, the Mile High Radio Club/WNKI AM 1610, the Mountain Community Patrol and the Riverside Mountain Rescue Unit.

As such, last year, I implemented a public/private working group, the Fire Code Committee, to look at the oft-repeated community concern requesting community fire hazard reduction, particularly vacant parcels interspersed between developed parcels. Initially, the FCC set collaborative goals. The goals as originally created and remain the same today are as follows:

1. Determine and recommend the best practices application of fire statutes and codes for the reduction of fire hazards on occupied and vacant properties.

2. Review and evaluate the fire statute or fire code authorities available to reduce the fire hazard. This includes the application of Public Resources Code § 4291 to occupied parcels and the application of Riverside County Ordinance 695, et. al. to vacant properties.

3. If warranted, provide recommendations for the improvement of existing fire statutes and fire codes.

4. Provide recommendations for the elimination of natural vegetative waste created from hazard reduction efforts.

The FCC to date has only had time to conduct fact finding and to determine what statutes and regulations exist allowing or regulating community fire safety. The committee will continue due-diligence fact finding and transparent actions before making any recommendations to elected officials. The community will be involved once recommendations are developed.

MCFSC is a great organization and one that has stood tall and strong in the best interests of community fire safety. It seriously cares about community safety, as witnessed by the commitment of its citizen volunteers who literally give thousands of hours to reduce the risk of fire through dooryard fire inspections, surveys for the extension of the Goldenspotted oak borer and much more.

I am honored to serve as the county fire chief and will always strive for the best community life and property safety. The public deserves and expects the best; I am continually committed to that outcome.

Since I first came to Riverside County in early 2004 and became an incident commander for the Mountain Areas Safety Taskforce, I have worked hard to implement hazardous fuel reduction projects, including dooryard and community hazard reduction, grant acquisition and execution for fuels projects, pre-planning for evacuation, including developing a very comprehensive evacuation plan that was successfully tested on the July 2013 Mountain Fire and execution of multiple training exercises to ensure our first responders play the way they practice and that they, indeed, do train. I will continue the same commitment throughout my tenure as the Riverside County fire chief.

### Public records and you

The annual nationwide Sunshine Week is celebrated this year from March 15 to 21. USA newspapers publish stories about public records and the difficulty in obtaining some of them. "Public records" are generally defined as records regardless of their physical form (so email would be included), made or received in connection with the transaction of official business by any government agency.

This week, newspapers judge government agencies on their compliance with public records laws. They will publish their findings from experiments they have done, such as submitting the identical request for records to various agencies and evaluating the response from each.

Public records have an impact on a reporter's paycheck because they form the backbone of many stories that newspapers sell. If you peruse any newspaper article, at least part of the article will probably be from a public record. Therefore, public records are very important to reporters. That's the reason reporters cozy up to the PIOs (public information officers) at government agencies.

Agencies give reporters preferential treatment, and their requests for records are made a priority. You can't blame an agency for wanting to look good to taxpayers on the front page, so they snap to attention, when a reporter calls. The power of the pen is undeniable.

Papers get uptight when legislators propose exemptions to public records laws as this limits access to information. So, many times, during legislative sessions, you will see this see-saw of legislators filing bills to limit access and papers hollering back to get the politicians to back off. The federal law governing public records is called The Freedom of Information Act, but each state has their own laws, ([www.foiadvocates.com/records.html](http://www.foiadvocates.com/records.html)) and there are quirks. In Rhode Island e-mail correspondence of their elected officials is not public. (<http://webserver.rilin.state.ri.us/Statutes/title38/38-2/38-2-2.HTM>)

The FBI won't release records on a living person if they haven't consented. ([www.fbi.gov/foia/u.s.-department-of-justice-form-361-certification-of-identity](http://www.fbi.gov/foia/u.s.-department-of-justice-form-361-certification-of-identity)). Certain criminal records are provided in Georgia, but only with the consent of the criminal. ([www.gip.org/wp-content/uploads/The-Red-Ink-State\\_Necessary-Revisions-to-Restore-the-Intent-of-Georgias-First-Offender-Act.pdf](http://www.gip.org/wp-content/uploads/The-Red-Ink-State_Necessary-Revisions-to-Restore-the-Intent-of-Georgias-First-Offender-Act.pdf))

Reporters certainly don't have the market cornered on public records. They are public records. They belong to you. The information contained in public records comes in many varieties, too many to mention briefly, but one example is discipline records from state licensing agencies on health-care providers. You can use this to check on your doctor before you accept his prescription. Other types of public records include lawsuits, criminal cases, marriage and divorce records, property records and the e-mails of your local bureaucrats and so on.

In many states, e-mails are public record. So, before you press "send" on your request for records, ask yourself: "Do I mind if this shows up on the front page of the New York Times?"

Most public agencies are polite and helpful and follow the law, and will give you your public records upon request. Some agencies have attorneys guarding the hen house who are reluctant to hand over records. Try finding online discipline records on a Mississippi psychiatrist. Luckily, this is rare, so just persist and you will eventually obtain the public records you seek.

If you are uncertain whether information is a public record, don't worry about it, just ask for it. You may just get it. If not, it is the responsibility of the agency to inform you why your request was denied.

You may have to be patient. Usually you will get your

records instantly, but the most extreme example I've run across is asking the Florida Medicaid Fraud Control Unit for criminal investigation records on a Florida psychiatrist — seven-and-a-half years ago. Still waiting. I do reiterate the request occasionally, about every six months now. I am told the records are not public because there is an ongoing criminal investigation.

## New quake study elevates chance of big one

Last week, the U.S. Geological Survey released a new report on the probability of earthquakes throughout California. Using a new methodology, the agency prediction for quakes of moderate size (magnitude 6.5 to 7.5) decreased, but the likelihood of a quake greater than that size has increased.

In terms of an earthquake of magnitude 6.7 (the size of the 1994 Northridge quake) or greater occurring within the next 30 years, the model probability is 99 percent, a "near certainty." The probability of a quake greater than magnitude 8 occurring is projected to be 7 percent, a near doubling of values.

"Overall the results confirm earlier finds (California is earthquake country), but with some important refinements in certain areas," the report's authors wrote. The average time between a magnitude 6.7 and greater quake has increased from every 4.8 years to every 6.3 years — a 30-percent decrease in frequency.

The study and forecasts of earthquakes have evolved significantly in the past quarter century. For example, in 1988, the agency had identified 16 faults in the state. Twenty years later the number of significant faults was more than 200. For this study, the USGS has identified and included more than 350 faults.

Another change was the realization that quakes were not totally independent and faults are interconnected. Previously, the forecasts appeared to be over estimating the number of moderate quakes compared to actual results. The current model recognizes that quakes

## Pine Cove Water approves new cell-tower lease with county

After several months of negotiating, the Pine Cove Water District directors last week unanimously agreed to change the terms of their lease with Riverside County for a Rocky Point cell tower. The county initiated the request last summer.

The amendment to the existing lease, which will be effective April 1, will increase the rental payment 5 percent to \$2,443.33 monthly. PCWD has agreed to reduce its annual increase beginning next April from 5 to 4 percent. PCWD's annual increase remains one of the largest the county has accepted. The lease will be for five years with automatic options for extensions.

"We felt it was the right thing to do," said Director Robert Hewitt. "There are a lot of benefits for not playing hard ball."

The board also agreed to revised language, not involving the rental cost, for its lease with Crown Castle.

In other action, the board also unanimously approved its annual standby charges. These remain at \$30 per acre per year. A public hearing on the resolution will be scheduled for June.

During the public-comment period, resident Marge Muir posed some questions about the district's proposed water-rate increases, which will be presented at a public hearing.

"I'm concerned about what is the district willing to give up while the public is paying up?" she asked. "Are you still planning to raise the rates at the hearing?"

In response, President Michael Esnard said these would be addressed at the public hearing on the proposed

rate increases, which has been scheduled for 10 a.m. Wednesday, April 1. Depending upon the comments, the board will decide on the implementation date at the hearing.

In water business, PCWD customers used 1.9 million gallons of water in February, which was nearly 760,000 less than January and 30,000 gallons less than February 2014. During the month, General Manager Jerry Holldber reported that the groundwater level of PCWD's monitoring well no. 10 had dropped 2 feet to 124 feet below the surface.

"Well 10 is down a couple of more feet, but several other wells have come up since the rains," he said. "Wells are up and down. It depends on how much we pump these wells."

## Post-disaster psychology discussed at MEMSCOMM

The Mountain Emergency Services Committee monthly meeting last Thursday featured Jim Cook, Cal Fire retired battalion chief and current president and chief chaplain of the California Fire Chaplain Association. His topic was "Disaster Psychology."

Although Cook's talk was framed as training for Community Emergency Response Team volunteers, there were topics and discussion points that could be useful for mountain community residents.

In a tight-knit area such as Idyllwild, the effect of assisting neighbors after a disaster can leave individuals troubled and feeling unsafe and insecure. In the stress of the moment while assisting others, personal feelings can be held back and surface later causing trauma, said Cook. Symptoms of post-disaster trauma can include irritability, self-blame (I survived, others didn't), a feeling of needing to isolate oneself, feeling helpless, mood swings, depression, concentration and memory problems, and relationship problems. Cook advised discussing how one felt during and after the disaster and then discussing the feelings that surfaced later. "People need to talk," said Cook, "but emergency responders have no time to offer counsel."

Cook also advised the best assistance one can provide to someone exhibiting post-disaster trauma symptoms is to listen. "Spend time with them, listen, be there," he counseled.


Cook described how memories of difficult disaster incidents can survive for years after the occurrences. "I've been retired six years and I still see things that

happened 20 years ago," he said. "When you have a major disruptive event in your life, it changes things. The question is, do you acknowledge what happened or do you repress it?"

For professional responders, CERT volunteers or neighbors helping neighbors, the advice is the same, said Cook. "Knowing the possible symptoms of disaster trauma, and watching for those symptoms in those around you, can help you to manage the impact on those people," he observed. "The losses to them are strong. Just be there to listen. You don't need to speak." He counseled that the first instinct is to do something to fix or alleviate the suffering but that listening provides the most healing.

As to critical incident stress management after a disaster, the most important things a person can do to be valuable to others is "to contact the people you love, eat right, avoid drugs and alcohol, sleep and talk to someone about your own feelings — receive as well as give," Cook said.

# Ruiz wildfire bill started with local communities

## Other priorities have his attention, too

"I prefer this Hill. It's much better than the other [Hill — in Washington, DC]," Rep. Dr. Raul Ruiz said during his visit Friday.

doing your best. You don't have to wait for action from Congress.

"You're an emblem of public service. You put yourself in harm's way so the public doesn't go through that," Ruiz said. "I want to be a full partner as part of your community."

Ruiz finished his afternoon with a long discussion of abatement, incentives for abatement and fire insurance with the MCFSC board and officers at the Mountain Resource Center.

At one of the stops, San Jacinto District Ranger Arturo Delgado discussed his plans for restoring the burned area. Already members of the Public Lands Education Project are replanting trees in various locations of the burned area. They will continue this work through the end of March, he told Ruiz.

"The mountain has an incredible capacity to recover — over time it will come back," he stated. "The recovery is slow because there has not been much precipitation."

Ruiz was curious about how much recovery has occurred in the nearly 20 months since the fire and Delgado estimated "... maybe 50 percent, but it depends upon the conditions."

In addition, PLEP participants help mitigate hazards, such as dead trees, left from the fire. When Ruiz asked how the Forest Service disposes of the cut wood, Delgado replied, "It's collected in a special place made available with permits to the public for firewood."

"Also, a portion of the Pacific Crest Trail is out of commission," Delgado told Ruiz. "The hikers have to use some of these roads."

After a final stop near Bonita Vista, Ruiz continued to the MCFSC offices where he discussed H.R. 1009 and other issues affecting prevention of wildland fires on the Hill. His bill has been assigned to the House Transportation and Infrastructure Committee, which referred it to its subcommittee on Economic Development, Public

can jump faults. This change explains the decrease in the likelihood of moderate quakes and the 20-percent increase in the expectation of a larger quake.

"The San Jacinto Fault has a three-fold decrease in the likelihood of a magnitude 6.7 or larger earthquakes ... but a factor of 57 increase in the likelihood of magnitude 8 and larger earthquake," the report stated. Basically, the model says the fault has less chance of a moderate quake while the chance of a large one has grown.

"The southern San Andreas, going through the Coachella Valley and up through the Mojave, is the most likely place in the state to host a large earthquake," said Ned Field, a USGS geophysicist and lead author of the study, in a press release issued with the report.

The results of the study will be used to revise earthquake maps and by the California Earthquake Authority, which will consider them as part of the evaluation of insurance premiums.

Ruiz is optimistic that his Wildfire Prevention Act of 2015 (H.R. 1009) will be enacted during this Congress. "This cycle we're certain to push more support because both sides of the aisle are involved," he stated. "I'm hopeful it will get through committee and pass the House."

Ruiz's bill is designed to allow up to 15 percent of the Federal Emergency Management Agency funds for prevention work.

"That idea came as a result of communication with local communities during and after the Mountain and Sil-

ver fires in 2013," he said.

In addition to his efforts to achieve the wildland fire legislation, Ruiz said he will continue to pursue efforts to help small businesses and focus on health-care access.

"The interplay between health care and the economy is critical," he added.

"Two other big issues that we will continue to pursue are to protect access to Medicare and Social Security," Ruiz said. "People are still struggling to make ends meet."

Buildings and Emergency Management.

"I don't need to be convinced now of your value. I'm at the point of rolling up sleeves and doing our best to advocate for you," he told the MCFSC board.

As the group discussed abatement and efforts to encourage it, Ruiz quickly compared the social and private responsibilities of conducting abatement to similar social and private responsibilities in the health-care field, which is his background.

"The work you do in education helps the community come together for abatement. The personal responsibility is the onus of homeowners and residents. How can we change the behavior in the community?" Ruiz asked. Then he compared the abatement issue to health-care issues such as stopping smoking and discouraging drinking while driving. "All are concerns of public health, matters of life and death," he summarized.

He agreed with MCFSC Director Larry Kueneman that property owners, who do not live on the Hill, still have a responsibility to ensure their land is fire safe and a threat to the residential portion of the community. Ruiz asked what kind of incentives might encourage greater compliance with abatement ordinances.

MCFSC Vice President Norm Walker explained how the group uses grant money. All of the grant money goes toward projects on the ground or education efforts. Landowners are asked to pay about two-thirds the cost of abatement projects. "A lot of people can't afford the initial abatement cost, but this is only 35 percent of it. Maintenance of the property is much cheaper," Walker said.

Fire insurance on the Hill was another issue Director Ron Perry raised with Ruiz and his staff. "It's next to impossible to buy new fire insurance," he stated.

After some discussion of the situation and examples of people having fire policies canceled, Ruiz said he

would approach the state Insurance Commissioner David Jones and request that he and his staff hold a meeting in the area to hear more about the problem and discuss the issue.

Again, Ruiz compared health care and fire problems. Before the Affordable Care Act, health insurers could deny insurance to individuals with pre-existing diseases. The ACA has changed that limitation and Ruiz will ask Jones to look at the fire insurance issue with a similar lens.

The mallards weren't providing opportunities for a photograph, and the red-winged blackbirds were too far away. So I started searching for something interesting on the peaks and ridges surrounding the lake. I pointed the long lens up at a steep angle in an approximate northeast direction and spotted Rocky. He posed stoically. My guess is that only from this and a nearby vantage point would this formation look like a person. I named it Rocky for fun, but think the gender is indeterminate."



# Master Chorale sings madrigals and 'West Side Story'

Sherry Williams fuses jazz and Elizabethan odes

Dwight "Buzz" Holmes, Idyllwild Master Chorale musical director and conductor, likes to mix it up. Recently, IMC's biggest successes have been Holmes' fusion concerts. Examples include the Winter Solstice celebrations mixing traditional Christmas carols and sacred music and a second half with jazz soloists and a jazz combo; the spring concerts where Holmes combines traditional secular and sacred music with a second half devoted to more modern choral music and selections from some of the greatest musical comedy box-office triumphs, Lerner and Loewe's "Camelot" and "My Fair Lady," and last season's "Les Misérables" by the European team Alain Boublil and Claude-Michel Schönberg.

This year, Saturday, March 28, Holmes offers up English madrigals, the pop music of the English Renaissance and Leonard Bernstein and Stephen Sondheim's "West Side Story." Why "West Side Story"? "It's musical evolution," said Holmes. "Shakespeare's 'Romeo and Juliet' becomes Bernstein's 'West Side Story.' Shakespeare's texts and themes continue to reappear in some incantation or other from his time until now."

The idea for the madrigal-themed presentation came from a conversation Holmes had with regular IMC guest soloist and fan favorite, jazz chanteuse Sherry Williams. "We talked about Cleo Laine and her work fusing Elizabethan texts to jazz," remembered Holmes. From that came the idea for featuring madrigals, a new and broadly expressive form that burst forth during the Renaissance.

Holmes said he thought madrigals were a perfect choice for spring — the blossoming of secular freedom of expression during the Italian and English Renaissance that infused and brightened madrigal verses and texts. "It's hard through our lens at this point in time to imagine that prior to madrigals, musical expression was only through listening to or participating in sacred ceremony," said Holmes. "The birth of madrigals gave rise to everyone's traditional popular favorite subject in song — 'love,' be it happy, affirming, sad and disarming, or disappointing with lamentation and woe — all followed by the musical onomatopoeia of human laughter in madrigals, sung, 'Fa, la, las,' in a sense confirming an understanding of the human condition and our ability to laugh about it and at ourselves."

Williams is featured this spring with Laine's jazz riffs on traditional madrigals, "Blow, Blow Thou Winter Winds," "It Was A Lover and His Lass," "O Mistress Mine" and "Sign No More Ladies" — the Renaissance texts set to rhythmic jazz with choral accompaniment.

Also returning as featured IMC soloists, in the "West Side Story" segment, are Dimyana Pelev and Justin Holmes, reunited after their leading roles in last summer's IMC production of Sondheim's "Into the Woods."

Dr. Marja Kay, premiering as a featured IMC soloist, joins Pelev and Holmes, adding some attitude and heat in "America," "A Boy Like That" and "I Have a Love." Kay is a soprano with established careers in opera, as a studio singer in Hollywood and in premiering new music works of contemporary composers. She holds a doctorate from the University of York in England, a master's in fine art from the California Institute of the Arts and a bachelor's of music from Chapman University.

The concert, at Stephens Hall on the Idyllwild Arts campus, begins at 7:30 p.m. Saturday, March 28. Tickets are \$20 for adults and \$10 for students, available both at the door and online at [www.idyllwildmasterchorale.org](http://www.idyllwildmasterchorale.org).

# Santiago continues to open doors

"The Adventures of Tom Sawyer," in Spanish, was what started Eduardo Santiago on his career path. "I was confined in bed for two months with hepatitis when I was 7," said Santiago remembering his boyhood in Cuba. "It felt like two years." The gift of the book from his uncle not only helped Santiago through his confinement but played a big role in shaping him into the adult he is today. "From that moment on I started becoming who I am — adventurous, curious, reckless. It came from the book."

By the time Santiago and his family left Cuba for the United States in 1968 when he was 10, that early immersion in literary fiction had taken hold. "I wanted to write from the time I was young. I always thought being a novelist was the highest accomplishment one could achieve in life." And in getting to that goal, it was Mark Twain, driven by curiosity, who inspired him. "I went down the Mississippi of the imagination," remembered Santiago. "I was that kid that adults didn't know where I had gone. I was off investigating."

After graduating from Cal Arts with a Bachelor's in Fine Arts, he worked successfully in television, writing for Group W Productions, an entertainment arm of Westinghouse, with syndicated afternoon shows. "None of them lasted too long, which was good for me because I didn't get too comfortable in television," he said. He noted the money was good and allowed him to continue to hone his craft — writing short stories and learning as he went along. "You don't realize until you are older that you have lived your life as an adventurer," he said. "My father can't figure out why I live my life this way and why I left a career in television. Nothing I have done since has made me that much money, yet."

He left television for his second career, as a novelist. By the time he graduated from Antioch University with a Master of Fine Arts in creative writing, he had already published his first novel "Tomorrow They Will Kiss" (Little Brown and Co. 2006) which took Best Historical Novel and Best First Book honors at the International Latino Book Awards and was a finalist for

the Edmund White Award for Debut Fiction. His second novel, "Midnight Rumba," was published in 2012. His shorter works of fiction have appeared in the Los Angeles Times, the Advocate and other publications.

Many in Idyllwild know Santiago from his annual author series, now in its fifth year. Upon buying a home in Idyllwild five years ago, Santiago, already a successful novelist, started his eight-week summer series. He used his Los Angeles connections to import a broad mix of Los Angeles authors for his free series. He had no money to fund it, but characteristically, he launched it anyway, certain he'd find ways to make it work. He quickly developed a following, both because of the diverse authors he featured and also because of his engaging interview style.

The series, in many ways, was part of a transition into Santiago's next and present career — as a teacher at UCLA Extension and the Menifee Campus of Mt. San Jacinto College. He said he finds incredible satisfaction and fulfillment in teaching. "I got to live my dream of becoming a published author," he said. "It makes me happy to help others achieve a similar dream. If you have to work for a living, and I do, how much more wonderful can it be to sit in a room with people who love books and get paid for it?"

As a writer and teacher, Santiago has drawn upon his journey from being that 7-year-old reading Tom Sawyer, to being an immigrant who "fell in love with the English language," to being a professional who fashioned multiple careers from always being curious. "As a boy, I took emotional photographs, forcing myself to remember — not the visual details, not the colors of the wall, but how I felt about what was going on," he said. "If I can write a scene emotionally, I can always fill in the physical details to support the scene."

Santiago is presenting his second Idyllwild Writer's Retreat in May and has one writer returning from China for the four-day course.

"I'm open to having a fourth career," said Santiago, smiling. "I just don't know what it is yet."

# Casey Abrams, Graham Dechter, Charles McPherson headline 2015 Jazz in the Pines

The 2015 Jazz in Pines festival is still five months away, but planning, preparations and work have already begun. This year, the major change is behind the scenes as the Idyllwild Arts Academy assumes management of the Festival production from the Associates of the Idyllwild Arts Foundation.

"There will be a lot of familiar faces and the same music that people are accustomed to," said John Newman, who has overall responsibility for the festival, but the Associates are still an essential piece in the machinery.

Already, Newman, IAA's director of Business Operations, has enticed popular and well-known alumni jazz musician to headline both days.

As he did last year, 2009 IA graduate Casey Abrams will close the festival Sunday afternoon. This year, Abrams will bring a seven-piece ensemble to accompany him as he features his jazz repertoire, according to Newman.

And Saturday afternoon, Graham Dechter, a 2004 alumnus, and his quartet — John Clayton on bass, Jeff Hamilton on drums and Tamir Hendelman on piano — will be featured on the Holmes Amphitheatre stage. Dechter will be returning to the festival after several years' absence.

"It's an honor to be coming back, especially with John, Jeff and Tamir in my group. While I was at Idyllwild Arts I was studying the music of Jeff [Hamilton] and John [Clayton]. So to be coming back with them is very special," Dechter said.

On Sunday, before Abrams takes over the stage, saxophonist Charles McPherson will entertain the fans with his bebop jazz.

In 2007, McPherson told the Town Crier, "Bebop, what is it? What does it mean?" he paused, and then answered. "It's melodic, rhythmic and harmonic. It has a good representation of all music components. It's structure and form."

Accompanying McPherson will be several very popular and influential San Diego jazz titans: Gilbert Castellanos on trumpet, Joshua White on piano, Rob Thorsen on bass and Charles McPherson Jr. on drums.

While Newman has worked with the Associates on many of the past festivals, this is his first year producing the event and he is enjoying it very much. Former Jazz in the Pines Chair Anne Finch has been a very good mentor arranging the booking of the performers, he added.

"I really enjoy talking with the musicians and their representatives," he said. "They want to play the festival. Peter Sprague, one of my favorites, is calling me."

Newman also mentioned that he receives many unsolicited calls from production companies and musicians' agents asking about performing in the festival, thus confirming the festival's reputation and attraction among the jazz world.

Newman is also excited about the return of the Seahawk Modern Jazz Orchestra this year. He is planning a special performance Saturday evening.

And on Friday evening, Aug. 14, the traditional Patrons Dinner will open the weekend of stellar jazz. The evening's cuisine will be a tribute to jazz, Newman shared, such as Cajun-grilled shrimp and baby-back ribs.

"The menu is very mouthwatering," affirmed Anne Erikson, who with Pam Goldwasser and Karen Metz is organizing the Patrons Dinner and party. "That is, all the volunteer servers, the look, decor and atmosphere; coordination with the French Quarter directors [volunteers] for the overnight transition to the look of the French Quarter for the weekend."

Erikson and Goldwasser have been working with Newman to assure a smooth and complete transition for the festival. But one feature — the many, many volunteers — will continue.

"In addition to some very experienced volunteers stepping up to positions on the Jazz Committee, most of the committee members have returned for 2015," she added. "The Associates' goal is to continue the tradition of a smooth-running festival. We expect that we'll need the approximately 300-plus dedicated volunteers to continue that tradition."

Newman repeated, "We are going to offer volunteers ticket comps for the entire weekend in exchange for working one shift," which was also done in 2014.

While the volunteers will ensure the festival retains its familiar and popular character, Newman, after consulting with Marshall Hawkins, one of the festival's originators, plans to bring the educational component — to teach people about jazz and "to remind us of the treasure of jazz, an exclusive American music genre."

He hopes to present a panel to discuss the history of jazz. "What does it mean to be part of the tradition?" will be a topic, Newman suggested.

"... [H]ad it not been for Marshall Hawkins, I doubt if I would even be playing jazz or even playing guitar," Dechter said. "I started at Idyllwild Arts as a violin and composition major. Marshall had this welcoming attitude about being in his classes. Because of his style of 'anyone's welcome,' his love of jazz and his mission of jazz education, I would not have the career I have today. He brought me into this ..."

Newman also stressed that the festival will offer many different jazz styles and not be an exclusive be-bop festival. Other jazz genres to be heard over the weekend include African, Latin and even some familiar gospel.

"It is definitely a lot of work, but it is going to be a fabulous festival," he said.

Ticket prices for the jazz weekend of Aug. 15 and 16 are the same as in 2014 and go on sale April 1. The early-bird discount will be available then and tickets may be purchased at [idyllwildjazz.com](http://idyllwildjazz.com).




**Buddy** is a 3-year-old

"The doctor told us he had to move off the Hill as soon as possible," Lois related, "because he was being poisoned with the CO<sub>2</sub> buildup."

She's found an apartment in Hemet but has a short window of time to get it ready for Bob's transfer from the rehab facility to which he was sent after his hospital stay. Doctors told her on Monday that, because of insurance, he may have only until the end of this week to remain at the rehab facility. She was told she could appeal that and possibly get more time, but she is not certain of that. She had hoped to have until March 31 to get Bob resettled. That is when she will return to work, commuting to her job at the market from Hemet.

Donations are being taken at the market to help the Denholms with the unexpected costs of moving and because Lois has been on unpaid leave while getting all the arrangements made for the move.

An account at Idyllwild BBVA Compass Bank is being opened for donations for Lois and Bob but details are not yet finalized. Check with BBVA or see the Town Crier's next print edition or online edition for more information.

Lois may also need help loading the U-Haul for the move. If anyone is available to help they can inquire at the market, since the timing of the move is still being determined. "They've been very good at the market about leaving notes for me," said Lois.

# Final bald eagle count records seven

## Two adults at Lake Hemet

Despite wonderful spring weather, or perhaps because of the heat, only seven bald eagles were seen during the final bald eagle count of the 2014-15 winter. Just a month ago, the February count recorded 17 bald eagles around the multiple lakes in Southern California.

Last Saturday, bald eagles were observed at six different lakes in the Inland Empire and mountains. Two adult eagles were seen at Lake Hemet and two adults and one chick were observed at Big Bear Lake. One adult eagle was seen at both Lake Silverwood and Lake Arrowhead.

The warm weather probably accounts for the lower number of bald eagles seen; they may have decided that it was time to start their migration north during the great weather conditions, according to Robin Eliason, wildlife biologist for the Mountaintop Ranger District in the San Bernardino National Forest.

About 226 citizens and agency staff participated in

the eagle search at all the lakes. Heidi Lake Hoggan, lands, special uses, and mineral administrator for the Forest Service's San Jacinto Ranger District, reported 29 people turned out at Lake Hemet.

The participants at Lake Hemet were lucky enough to observe a pair of bald eagles tending their nest and hunting for food.

"Last month we witnessed them building the nest. This past Saturday we saw confirmed incubation behavior so there are definitely eggs in the nest," Hoggan said. "We were also lucky enough to see one of the adults hunt and catch and eat a fish."

Besides seeing the eagle pair, the Lake Hemet observers were also treated to two turkey vultures roosting close to where the participants were standing, a flock of white pelicans, and the great blue heron and northern harrier that have been there for each of this season's counts, Hoggan added.

A number of bald eagles migrate to Southern California to spend their winter vacations around the lakes. They migrate here because their prey animals (fish and ducks) are no longer available to them in the cold northern regions as ice covers the lakes and rivers.
