## New board, new officers, new start for Art Alliance

Board pledges  
financial transparency

The Art Alliance of Idyllwild has a new board, new officers and is, once again, fully operational.

At a Saturday, May 16 public meeting, the new board met to introduce itself to the community, to elect officers and to resume work, including staging of public events, halted by the mass resignation of the previous board on April 15.

Pledging to provide financial transparency to and greater consultation with the membership and community, the new board got quickly to work — both in open public and closed executive sessions.

# More late spring rain and more than 2014

Spring's arrival on the Hill is still anxiously awaited. Since Thursday, cool temperatures and precipitation brought more rain and some snow to Hill residents. Next weekend may still seem like late winter rather than the warmth of spring.

The U.S. Forest Service's Keenwild Ranger Station and the Idyllwild Fire Station recorded nearly 1.5 inches of rain from Thursday to Friday. The total precipitation this rain year (July 1 through June 30) has been 12.65 inches at Keenwild and 19.35 inches at the IFS. Keenwild's total precipitation is about half the long-term average of 25.5; whereas Idyllwild has recorded about 75 percent of the average.

Precipitation this year in Idyllwild and Pine Cove, through the middle of May, is more than the 17.1 inches received in 2013-14.

Pine Cove has received significantly more rain. Through Monday, a total of 20.3 inches of rain and 27.75 inches of snow have fallen to the north of the village. Both amounts are greater than last year's precipitation, but still trailing the long-term average for the fourth consecutive year.

The Town Crier weather site recorded an additional 1.7 inches of precipitation Friday and Saturday mornings, which included rain and moisture from snow.

While this month has been unusually wet, the historic May rainfall has been three-quarters of an inch, which all weather sites have exceeded by nearly twice that amount.

Entering the fourth year of the current drought, the National Weather Service announced last week that El Niño conditions are forming in the Pacific. Consequently, NWS has raised the probability of it continuing through summer to 90 percent and more than 80 percent through the end of 2015.

Normally, El Niño conditions of this strength bring significant rain. And some weather forecasters see a similarity to the 1997-98 period, when 39.4 inches fell on the Hill.

# CSA 38 parcel fee has one-year reprieve

## Vote on its future may be in 2016

The Advisory Committee for County Service Area 38 (Pine Cove) unanimously recommended that Riverside County continue to collect the parcel fee, without any change, through fiscal 2015-16.

During 2016, either at the June primary or November General Election, the committee will ask CSA 38 residents whether to continue the fee or eliminate it.

In 2004, more than three-quarters of the CSA voters approved the parcel fee. Its initial level was \$50 and increased 2 percent annually, to the current level of about \$59. The purpose of the assessment was to provide additional funding for ambulance service to Pine Cove and support for the volunteer firefighters at Station 23.

Since the mid-1990s, Riverside County has contracted with Idyllwild Fire Department to provide emergency ambulance service to the CSA 38 residents. The cost of this contract, currently \$128,000, came from the CSA 38 revenue.

The parcel fee raises about \$96,000 annually, which is considerably less than the ambulance contract cost. The additional funds come from the CSA's property-tax revenues.

CSA 38 was established before California voters approved Proposition 13 in 1978. Consequently, CSA 38 receives a portion of the county property taxes paid by Pine Cove residents. These revenues are about \$60,000 annually.

Beginning July 1, the county has contracted with American Medical Response to provide the ambulance service to Pine Cove. CSA 38, similar to the past policy applied to the rest of the county's unincorporated areas, will no longer be responsible for paying the ambulance cost. Individuals who receive emergency service are responsible for those costs, including transportation to a medical facility.

Since the major reason for establishing the parcel fee has been shifted to the county, the Advisory Committee has begun discussing whether the fee is still needed and, if so, at what rate. Use of the parcel fee revenue is restricted to its original intent.

"I'm comfortable continuing the fee, but not indefinitely," Bill Brown, CSA operational manager for the county's Economic Development Agency, told the committee, "but we need to clarify to the community the need for a broader language. How many things can you do [with the funds]? How much needs to be collected?"

He felt the Board of Supervisors would prefer that CSA residents express a current opinion on the direction for the parcel fee.

The discussion initially revolved around the level of the fee. Since CSA 38 reserves are about \$530,000, committee member Thom Wallace questioned whether the full amount was needed immediately.

However, for several years, the Advisory Committee has recommended the county purchase for Station 23 a new 4-wheel drive engine, whose cost will exceed \$400,000. This recommendation is included in the proposed 2015-16 budget, which the committee had approved earlier in the meeting.

While the county continues to support this proposal, Mountain Division Chief Sean Dakin, of Riverside County Fire De-

partment, explained that discussions and a search for other funding sources have been ongoing, which is one reason the purchase hasn't happened yet.

Brown also recommended that the engine purchase remain in the CSA budget, "... so you have flexibility, but don't expect action for awhile."

Committee Chair Jerry Holldber thought the parcel fee might be used to enhance future AMR service. He favored a reduction this year, "... we need to be flexible in the future and can always go back up if merited."

"Categorically, I can imagine AMR wanting to give you a level [of service] above other areas," Brown assured the committee.

Since AMR is a private company rather than public, "... I think it is prudent to keep some level of fee for a year," responded committee member Robert Hewitt.

Nancy Borchers, CSA 38 resident, agreed with Hewitt: "We do not know the quality of ambulance service and may need the fee. If we don't have the funds, we may be letting the people of Pine Cove down. It is stupid to drop it now and have to beg the population to rescue us if we need it."

When resident Norm Cassen asked how much of the current reserve was contributed from the parcel-fee revenues, Brown replied, "Nothing. For many years the cost of the contract was more than the parcel-fee revenue. The [property tax] revenues paid the difference for the contract. None of the reserves are from the parcel fee."

Lou Padula then recommended maintaining the fee through fiscal 2015-16 and letting residents decide its future beyond then.

If the parcel fee's future were decided during the June 2016 primary election, Brown opined that the "... higher turnout would be more representative of the voter base."

I heard more stories at the party of oak tree branches breaking off. Such a wet snow that even our sturdy oaks fell victim.

# Fern Valley anticipates declining water sales

## Rate study postponed

The Fern Valley Water District postponed its review of water rates and charges again. President Robert Krieger hopes to bring a report to the board at the June meeting.

The directors did review a proposed 2015-16 budget and also expect to adopt it at the next meeting.

The proposed budget for next fiscal year, which begins July 1, forecasts slightly lower revenue and a four-fold increase in the capital-improvements budget.

Total revenue is projected to be \$1.024 million, \$85,000 less than this year. The lower revenue estimate is entirely due to a projected 17-percent decline in water sales revenue due to the recent imposition of a Stage 3 water emergency condition. This requires mandatory, outside water-use cutbacks. Less water use will result in less revenue.

"This still may underestimate the diminishing water sales," said General Manager Steve Erler. Despite the slight increase in water consumption this billing period (March and April), the district's sales fell nearly \$3,000 or 7.8 percent.

The capital budget will grow from almost \$170,000 this year to \$805,000 next year, as the district begins a major pipeline replacement project.

The operational budget will increase about \$27,000, to a total of \$709,000. Increases are proposed for a vari-

ety of programs. Cost of holding the election for two directors' seats is expected to be \$7,000.

Directors Trisha Clark and Richard Schnetzer both confirmed they plan to file candidacy papers for re-election.

Salaries are projected at \$258,000, up 2.8 percent, and benefits increase \$3,000, 2.1 percent, to \$139,200. Insurance and workers' compensation are projected to increase about \$8,100.

Other increases are related to water production. For example, the power needed to pump more groundwater due to the low stream flow is projected to be \$35,000, which is \$5,000 more than this year. Water quality monitoring may grow \$5,000 also.

Offsetting these increases is an expected \$10,000 drop in cost to operate the filtration plant.

Schnetzer, chair of the Information Committee, reported that it had approved a significant upgrade to the district's computer hardware and billing software. The \$16,100 cost is slightly more than half the approved budget of \$30,000 for these improvements.

Circumstances have changed since the original rate report draft, Krieger said, citing the recent state appellate decision regarding San Juan Capistrano's tiered rates.

"[A] question as to whether we need to review our tiered rates and the relationship service charges to tiered rates," reported Rates and Revenue Committee chair Krieger. "We may be shifting to capacity rather than multiple service and need to examine that with respect to equality to other customers."

The rate issue will be on the FVWD's agenda within

the next two months, he added.

In water business, Erler reported well production in April supplied more than three-quarters of the district's water, compared to about half in 2014.

The groundwater level of the district's wells varied in April, but all are below the April 2014 levels. The office well, used for monitoring, is 4 feet below its level last year.

Total water production for the March and April period was 4.7 million gallons, about 16,800 gallons more than the same period in 2014. Since the beginning of 2015, FVWD has produced about 8.9 million gallons of water, only 3,500 gallons more than the first four months of 2014.

The district's 12-month average water loss fell to 15.2 percent from 17.4 percent in April 2014. Erler expects that the loss will continue to fall after the expanded leak detection effort last month. More than 20 small leaks were found and repaired. Although each was tiny, their cumulative effect contributed about 10 percent to the district's water loss, Krieger estimated. Erler plans to complete the leak detection project this month.

"Quite a few of these leaks are on the pipeline which we plan to replace," he said.

In other business, the board granted an easement to a customer whose deck extended into the FVWD's right-of-way along Strawberry Creek. This was an old property and the district has granted these easements several times in the past.

At the request of another customer, their appeal for a water bill reduction was deferred to June.

## County plans major review of sheriff's budget

### More deputies for unincorporated areas on hold

At its May 11 budget workshop, the Riverside County Board of Supervisors reviewed the current budget and discussed the potential deficit projected in fiscal 2015-16, which begins July 1. The next day, it approved the rates to be charged to county cities that contract for Sheriff's Department services.

While the fiscal problems at the county's Regional Medical Center in Moreno Valley are improving considerably and revenues are projected to grow slightly, much attention was directed to the Sheriff's Department budget. This continued the next day when the board approved cost allocations for the cities that contract for the Sheriff's services.

The county's initial projection for the Sheriff's Department is that costs will exceed the budget allocation

by about \$67 million. Several representatives from the contract cities addressed the board about the increasing growth of their costs compared to their revenue growth.

The expected opening of the East County Detention Center in spring 2018 will be another large increase in the sheriff's costs. County Financial Officer Ed Corser acknowledged that these deficits were not the sheriff's fault.

The county has continually underfunded the budget in order to alleviate significant reductions in non-public safety agencies.

Nevertheless, several supervisors were concerned about the spiraling growth of the sheriff's costs and effect on the rest of the county's budget and the contract cities.

"Our concern is not the quality of service, but the cost of service," said Jesse Molina, Moreno Valley mayor. "It outpaces the

city's general revenue and no revenue is left to address other programs."

"The [sheriff's] service is great. We love the guys in blue," said Steve Manos, Lake Elsinore mayor. "But it is a very simple math problem. Our revenue stream can't keep pace with the sheriff's contract cost."

Sheriff Stan Sniff acknowledged the continuing growth of his department's budget and pointed to the negotiated contracts with employee unions that saved retirement expenses, but raised salaries. While the Detention Center will be a significant increase to the budget, he argued that additional deputies for the unincorporated areas were a small increase, less than one deputy per sheriff's station area.

The supervisors recommended an audit of the budget, including a phased approach to staffing the

Detention Center.

"Two years ago, we adopted a 1.2 [ratio of sheriff's deputies per 1,000 residents of the unincorporated areas] because of the increasing crime rate when the ratio fell to 0.75 deputies," began Board Chair Marion Ashley (5th District supervisor).

"We can hold at the current level 1.04 deputies this year," Ashley continued. "If the next budget year is more favorable, conditions then start to move back up to 1.2 deputies."

Agreeing with Ashley, Supervisor John Benoit (4th District) recommended that the audit also address the additional costs imposed by implementing Proposition 47, passed in November.

"I'm hearing from my cities about the recent increase of their rates. I've never seen the level of angst expressed before," he said. "[We need] an in-



dependent review or audit of the sheriff's operation and [to] ask why his costs continue to grow."

Supervisor John Tavaglione (2nd District) also concurred: "I agree with the 1.04 freeze that will stop the bleeding with our budget since the crime rate is down. The 1.2 is wonderful, but we just

don't have the money to continue."

"Every year we've been balancing our budget and we'll balance this year and year after," Ashley stated. "But I won't vote for a budget that is not balanced."

# Idyllwild Water reviewing rates and meter policies

The Idyllwild Water District is also considering a rate increase later this year. Last Friday, its Rules and Regulations Committee met to discuss several changes to its water policies, including possible rate increases.

Should the district go to Stage 3 water conservation, the tiered rate structure may need to be modified, and the committee, composed of directors John Cook and Warren Monroe, reviewed three options, which General Manager Tom Lynch proposed.

One option would be to keep the existing tiers as they are. A second would be to begin charging for water that currently is included within the current

base rate of \$28.70. A third would be a more gradual staggering of the rate increase among the tiers.

One of these options would impose a nickel charge per cubic foot for the first 3,740 gallons and another option would impose the nickel-per-cubic-foot for the first 1,870 gallons and a dime for the 1,870 gallons up to 3,740. Usage beyond these limits would cost 21 cents per cubic foot. (A cubic foot is the equivalent of 7.48 gallons.)

At the end of the discussion, both Monroe and Cook indicated they tended to favor a rate increase with more gradual, staggered tiers, but no decision was made at the meeting and the full board will discuss a possible rate change in the future.

The committee and

general manager acknowledged that the conservation measures Gov. Jerry Brown wants are somewhat at odds with a recent appellate court decision that any rate tiers would be required to be based on production costs.

"What we are looking at is balancing the directive we received from the state, and what we heard from the court about the San Juan Capistrano decision," Lynch told the Town Crier after the meeting. "We know that on the one hand, the governor wants penalty fees for high-water consumers, yet, on the other hand, the courts have indicated that fees need to correlate to cost of production ...

"Based on our present rate structure, we can address the problem in sev-

eral ways, which could include keeping our rates as they presently exist, readjusting the amounts we charge in more graduated steps, or separating out our meter charge from our consumption charge, and charging a per-cubic-foot amount commensurate with straight production costs," Lynch said.

The committee discussed a variety of other issues that affect water use and regulation during water emergency stages, including criteria that would trigger the various water stages.

Other topics included the need and availability of meters. As more homeowners install sprinklers, which may require a larger meter, can they obtain the larger meter during Stage 2?

Also bandied about was the expansion of sprinkler systems for fire protection. While actual installation of a sprinkler system for fires does not necessarily consume more water, it creates the promise of water availability. The committee discussed how this might affect the need for expanded supply and cost. In the case of an actual home fire, the committee wondered how long a sprinkler system would continue to flow unattended.

Other meter issues addressed the question of whether an individual who owns two properties separate and possibly non-adjacent, one with a meter and one without, can transfer the meter from one property to the other. "Why does it matter which lot they use?" asked Cook. Lynch responded that the district wanted to prevent an unofficial commodity market in water meters.

Also, does the district require a meter of a property owner who has their own well?

And what to do about businesses that consume large amounts of water, such as the laundry and restaurants, during higher water stages? "We don't want to impact the integrity of business customers," Lynch told the committee.

For rental properties, IWD currently bills the tenant at the request of the property owner, but may end this option for legal reasons.

The committee also discussed the need for education regarding, for example, people who want to water big trees. It was pointed out that it does no good to irrigate at the base of a tree trunk when the tree's roots are actually collecting water from a perimeter a good distance away from the trunk.

Cook raised the question of whether persons should be prohibited from collecting water in tanks, just as persons are prohibited from filling swimming pools. But Monroe pointed out that they were not the same, since water in tanks could still be used in the future for watering purposes. Lynch suggested that perhaps they could require that recycled water be used to fill tanks.

"Depending on how long our state drought lasts, we are still only in Stage 2, but we want to be prepared if we have to go to a State 3, or if the state imposes standards that we need to comply with," Lynch added.

## Proposed Pine Cove Water budget has slight growth

The Pine Cove Water District Board of Directors reviewed the proposed budget for fiscal 2015-16, which begins July 1. The total budget of \$821,000 is only 2.6 percent more than the current-year budget and is balanced without the need to use reserves, General Manager Jerry Holldber told the board.

Revenues are expected to increase \$46,000, primarily due to the recent rate increase. However, rentals from the leases at the district's Rocky Point communications site will grow \$7,000 (4 percent).

District expenses are budgeted for \$821,000. The principal increase is for services and supplies, and facility improvements. These total \$31,000 and are offset by a \$12,000 reduction in right-of-way fees to Southern California Edison.

The improvements budget includes \$13,000 to buy 200 new water meters, a \$6,000 increase to continue the main line replacement and \$5,000 to inspect water-storage tanks.

The Salaries and Benefits account remains at \$470,000, although a \$4,000 increase in salaries is planned. Overtime and part-time employee costs de-

crease about \$11,000 because of the recent addition of two new employees.

For the current fiscal year, expenditures have exceeded revenue by about \$58,000 through March 31. However, two more billing periods and the final property tax receipts will be received before June 30.

In water business, PCWD has produced about 9.5 million gallons of water in the first four months of 2015. In 2014, the production through April was 8.5 million gallons. The last time production exceeded the 2015 level was 2009, when the district used 10.3 million gallons in the first four months of the year.

Actual production in April was 2.7 million gallons, which is 18,800 gallons less than in 2014.

Although the district's water loss was 14 percent, Holldber said there are no major leaks. In his opinion, the water meters are inefficient. Replacing meters, which have registered more than 1 million gallons, and meters more than 15 years in the ground will be part of the next year's capital program. He hopes to replace about 150 meters annually for three years.

To encourage conservation, the district has barrels to collect rainwater available for \$57.19, which is the district's cost.

of his decision to lift restrictions from volunteer conservation to tightened mandatory actions. However, he did recommend that the board approve retaining the Stage 1 water rates rather than the higher Stage 2 rates.

The board unanimously approved his recommendation, which will save customers some money.

"A year ago, we declared Water Emergency Stage 1. Since that time, we've relied on voluntary compliance," Holldber began his statement to the directors. "It's prudent management to go to Stage 2, especially planning for the long duration of the drought."

"Since then, a lot has been going on with the state. It's to the point that the governor has state mandatory restrictions on," he stated.

Increasing the water conservation stage is prudent management during the drought and indicates that PCWD is following the State Water Resources Control Board's guidelines, Holldber added.

The recommendation to continue to apply Stage 1 water rates was discussed with the district's legal counsel, who supported it. Holldber told the board, "I don't feel it's fair to penalize customers now. We've just raised rates, and I thought it was the fair and proper thing to do for Pine Covers."

The average PCWD customer uses 6,000 gallons or less for every bimonthly billing period. During Stage 1, the bimonthly bill would be \$67.80, which includes the \$57 advance minimum and \$10.80 for using 6,000 gallons of water. The Stage 2 water usage rate remains \$1.80 per 1,000 gallons up to 5,000. An additional 1,000 gallons would cost \$3.10, another \$1.30.

For customers who consume more than 6,000 gallons and less than 12,000 gallons, the Stage 2 rates would increase the cost of the 2,000 beyond 10,000 to \$4.40 per 1,000. The total usage charge for 12,000 gallons would be \$33.30 compared to \$29.40, which is 13.3 percent more under Stage 2 rates.

Holldber will monitor water usage over the next few months to verify that the mandatory restrictions are reducing consumption. Those results, if unsuccessful, may cause him to recommend imposition of the higher Stage 2 water rates.

"We'll go the summer and report back on the conservation usage," he said. "We're putting [saving water] back on the people."

## Water use rules in Pine Cove Water District

### Stage 1 is voluntary compliance

Customers are asked to conserve, when possible, the amount of water used to that amount necessary for domestic and business purposes. Fix leaky plumbing, prevent irrigation runoff, refrain from washing down sidewalks, driveways and parking areas and avoid sprinkling unplanted areas for dust control. Customers are encouraged to utilize wood chips and mulch around all plants and trees to minimize outside watering.

### Stage 2 is mandatory compliance

Customers are required to limit irrigation of outdoor plants and gardens to the period between 6 p.m. and 8 a.m. daily and stop all water runoff. Customers cannot fill or refill swimming pools except the small amount needed to replace evaporation in already filled pools. Vehicles can only be washed using a bucket and a hose with a shut-off nozzle. Immediate repairs must be made to any and all leaking water lines and faucets in household plumbing and yard piping. Customers must also cease watering native vegetation and unplanted areas for dust control. Restaurants shall only provide drinking water to patrons upon specific request.

## IDYLLWILD WATER DISTRICT MAY 2015 NEWSLETTER

*IWD Mission Statement: To provide reliable water & sewer service in a safe, cost effective & environmentally sound manner in accordance with the community needs*

As you know, California is experiencing an extreme drought. During this time Californians have become keenly aware about the need to protect our vital natural resource: water. The District is dedicated to preserving our watershed and sustaining our environment, now and well into the future. In the past few months, the District has rehabilitated our horizontal lines, rehabilitated old wells and added additional tank storage. These efforts will provide additional production capacity which cushions against extended drought. To hold IWD pumping costs to a minimum, we have recently upgraded the control panels for our solar array. Saving water is essential to ensure we have supplies for the future. We need to work together to renew our efforts to avoid water waste so we protect this precious resource every day. Following are some tips to save water:

- Reduce shower time by five minutes and save over 4,700 gallons of water a year. The District has free shower timers and water efficient shower heads in the office for you to pick up.
- Run the dishwasher with a full load once a week rather than twice and save over 300 gallons of water a year.
- Install aerators on kitchen and bathroom faucets and save over 700 gallons of water a year. The District has free kitchen and bathroom aerators for you to pick up.
- Upgrade to a high-efficiency washing machine and save over 1,400 gallons of water a year.

The District is still in a Stage Two Water Shortage Emergency Alert. During this stage it is imperative that water users conscientiously employ water conservation practices. During Stage Two customers are required to:

- Limit irrigation of outdoor plants and gardens to the period between 6:00 p.m. and 8:00 a.m. twice a week and stop all water run-off.
- Cease filling or refilling swimming pools except for evaporation.
- Wash motor vehicles only from a bucket using a hose with an automatic shutoff nozzle.
- Restaurants shall only provide drinking water upon request.
- Immediate repairs to any and all leaking water lines and faucets.
- Cease irrigating native vegetation and unplanted areas for dust control.

Many customers are concerned about our native pines and oaks. Due to the extreme drought these native trees are suffering damage from bark beetles and the spotted oak borer. These dead and dying trees present a very real fire danger, however, watering them this late in the drought would not be beneficial and is contrary to our Stage Two restrictions. Mulching these trees is beneficial, since it will hold in any rain water we may receive, however, keep in mind that IFPD may require defensible space around your residence which could limit mulching.

This week, IWD has been approved for a \$2,045,217 water recycling grant. It is a \$1,329,295 grant and a \$715,921 loan from the State Water Resources Control Board. This large capital project is necessary to extend our potable water sustainability and will save our customers significant dollars in the long run. At this time we are also rebuilding our sewer effluent line to maintain our capacity to serve our customers.

# Some Memorial Day events this weekend

Memorial Day, originally Decoration Day, is observed to honor all Americans who died while in military service. The observance originated after the American Civil War and was held on the last Monday in May to commemorate both Union and Confederate soldiers who died during the war.

In many parts of the country, it is traditional to visit and decorate the graves of family and friends.

In Idyllwild, Memorial Day is observed at American Legion Post 800 starting at 11 a.m. Monday, May 25. Post Commander Danny Richardson said the ceremony will include an honor guard, a traditional folding of the American flag, 13 folds commemorating the wars in which American soldiers fought, a reading of the names of legionnaires who have passed, a rifle salute and the playing of taps.

Afterward, the post's Ladies Auxiliary will host a free luncheon for all attending.

Memorial Day also is a time to celebrate the living, with picnics and recreation with friends and family. Memorial Day 2015 launches new recreational opportunities available at Lake Hemet. For

"The lake itself is technically open for swimming on the weekend," he said. Lam said the floating water park would have an official grand opening on Saturday, June 6. "It will be a free event," said Lam. "Come early and have a good time. There will also be free food at the grand opening."

# Cherry Vanilla opens Santiago Idyllwild Authors Series

She's been there and done that, more than once

"It will be fabulous," said author Cherry Vanilla of her upcoming interview with Eduardo Santiago. She will be talking about her life with rock and roll royalty as recounted in her memoir, "Lick Me, How I Became Cherry Vanilla (by way of the Copacabana, Madison Avenue, the Fillmore East, Andy Warhol, David Bowie and the Police)."

Santiago chose Vanilla because of the scope and honesty of her personal journey from the heyday of rock to the birth of punk during one of the most electrifying and transformational eras in music and in the country.

"I don't think people who weren't there can grasp what it was like, the electricity everyone was giving off," said Vanilla. Born Kathleen Dorritie in Queens in 1943, Vanilla grew up loving show business. "I used to go to the Copacabana with my parents, starting when I was 6 years old," she remembered. "My mom was a telephone operator at Hotel 14 on East 60th. The Copa was in the basement of the hotel. My dad would hold me up to see the shows. My sister was a governess for Don Ameche [actor and comedian] and I used to stay with them as well. My fascination with show business started early."

That fascination evolved into an extraordinary career, with incredible highs and sobering lows, recounted by Vanilla with fierce honesty, humor and sassy innocence.

After graduating from high school, Vanilla (still Dorritie) went to work on Madison Avenue in advertising. She also began to DJ on the French Riviera and in a Manhattan club scene fueled by acid and pot. "It was an amazing time, a little bit of everything," she said, "the Kennedys, birth control, women's lib, LSD and marijuana, the Vietnam War and protests. There were so many elements." Then, even with a successful career in advertising and as a radio and TV producer, Dorritie had an epiphany at age 26 after seeing a documentary about rock and roll groupies. She decided to become one and changed her name to Cherry Vanilla. "There was such an energetic vortex then," she said. "We were so much

freer and lived with an abandon our parents never had."

Soon parties and trysts led to meeting David Bowie, then just beginning his career. Vanilla became Bowie's personal PR person and helped introduce him to U.S. audiences. She slept with soon-to-be-famous people, including Bowie, Leon Russell and Kris Kristofferson, but all the while grew her own substantial career as a singer, actress, songwriter and publicist. She starred in Andy Warhol's play "Pork" in London at age 27 and recorded for RCA Records in Europe with the Police as her backup band. Post punk, she shaped a successful career as a West Coast publicist, establishing Europa Entertainment Inc. as the U.S. office for Academy Award-winning composer Vangelis.

Vanilla said she lived it all and loved it all. And yet,

looking back, Vanilla said there was an innocence about the era and that time in her life. "We were a lot more innocent then," she said. "We trusted people more. Now children are exposed to so much fear at such an early age. It's part of marketing — be afraid, be very afraid."

Asked if sex is different now from how it was then, she said, "In the '50s, America was still sort of Victorian and as a result, sex was naughty and because it was naughty it was more exciting, sexier. It's what we did to rebel. Now, if I were young and wanted to rebel, I would probably go against the grain and not have sex, certainly not at as young an age as girls are having it now. It is so different now from then and not nearly as much fun."

And if fun and nostalgia for the rock and roll era are part of your makeup, Vanilla's honest and touchingly sweet account of her fame-fueled life is a "must" experience.

Vanilla and Santiago talk at 3 p.m. Sunday, May 31, on the deck of Cafe Aroma.

Brendan Steele shot an even-par 72 Sunday in the final round of the Wells Fargo Championship in Charlotte, North Carolina. He finished in a tie for ninth, his third top-10 and his seventh top-25 in 15 starts so far this season.

The candidates and their accomplishments, in alphabetical order, are:

1. **Ted Cummings**, who contributes his time and expertise to nearly every event on the Hill. Ted is an expert on permits required and how to obtain them.

He volunteers countless hours to help organizations pull together mounds of paperwork to secure the necessary permits. He always shares his knowledge of the little intricacies of events and event planning.

Among many other events, he has worked tirelessly for Jazz in the Pines, the Fourth of July Festival, last year's Animal Rescue Friends and Living Free's Festival and Adoption Fair and the upcoming ARF Paws for Rhythm and Brews.

In charge of logistic planning for Jazz in the Pines, years ago he created the template for the festival still being used today.

Ernie Maxwell would have been proud of this man's battle with rubbish to keep our mountain clean.

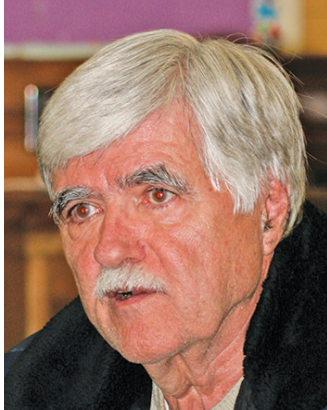

# Fees increase at Joshua Tree park

Joshua Tree National Park announced that effective June 1, park fees will increase. These increases come after extensive civic engagement from Oct. 21 to Nov. 22, 2014, and a high level of support from federal, state and county stakeholders, as well as commercial operators. Outreach included radio broadcasts, town hall meetings, local community events, print media and social media.

Generally, the public was in support of the fee increases, despite some concern that the increases be made in smaller increments than originally planned. In consideration of those concerns, the park will maintain the current fee for the annual park pass and reduce the proposed fee increase for motorcycles.

New entrance fees are:

- 7-Day Single Vehicle Pass will increase from \$15 to \$20. (The fee is scheduled to increase to \$25 in 2017.)
- 7-Day Motorcycle Pass will increase from \$5 to \$10. (The fee is scheduled to increase to \$12 in 2017.)
- 7-Day Person Pass will increase from \$5 to \$10. (The fee is scheduled to increase to \$12 in 2017.)

The Joshua Tree National Park Annual Pass will not increase at this time.

New camping fees are:

- Reservation campground (Indian Cove and Black Rock, Black Rock Horse Camp and Cottonwood). Individual sites increase from \$15 to \$20 per night/site.
- First-come, first-served campground (Belle, White Tank, Jumbo Rock, Ryan, and Hidden Valley). Individual sites increase from \$10 to \$15 per night/site.
- Group camping sites (Indian Cove, Sheep Pass, Cottonwood) increase from \$25-\$40 to \$35-\$50 per night/site.

There is a backcountry camping fee implementation approval using recreation.gov, however, that may take place at a later time.

New interpretive tour (Keys Ranch) fees are:

- Adult ticket will increase from \$5 to \$10.
- Child ticket (ages 6-11) will increase from \$2.50 to \$5
- Child ticket (ages 5 and under), admission is free.

# Local group to take over Youth Grantmakers

The Idyllwild Community Fund is planning to assume full responsibility of the local Youth Grantmakers program for 2015-16. The Community Foundation of Riverside and San Bernardino Counties, in conjunction with ICF, initiated the program in 2013 but decided it has successfully nurtured it and has withdrawn its financial and staff support.

The foundation had funded a high school youth grantmakers program, a precursor to the Idyllwild program. Former ICF members Trish Tuley and Dianne Suechika suggested the foundation expand the pilot program to middle-school students and recommended Idyllwild School.

The foundation, along with the ICF, agreed and has managed the program since its implementation. After three years, the foundation is proud of the accomplishments in Idyllwild, but can no longer fund the program as it expands the high-school grantmakers to other county areas.

"I was surprised when the Community Foundation decided not to continue the program," said ICF President Marshall Smith. "But we have agreed in principle to continue it."

ICF has provided the student philanthropists about \$4,000 each year to award to local non-profits that want to offer projects focused on the local student population. In 2013, the first year of this initiative, the Youth Grantmakers awarded \$3,713; in 2014, the awards totaled \$4,000; and this March, the awards totaled \$3,500 to local non-profits ranging from the Idyllwild Garden Club to the San Jacinto Mountain County Parks.

While the local ICF provided the money for the grants, the umbrella CF was providing slightly more than \$6,000 to oversee and implement the program.

For example, CF staff provided classes and skills to Youth Grantmakers' sessions so they could collectively review and assess the grant applications.

If ICF board members volunteer to provide the education component, Smith said the direct costs would be about \$6,000 and the CF may contribute \$1,000.

In order to raise the \$5,000, ICF plans a fundraiser and appeal letter to people supportive of local youth and educational efforts. Former Idyllwild School Physical Education Teacher Holly Guntermann has volunteered to head the continuation of Youth Grantmakers program.

## Religious freedom...

Back in 2004, the retired rector of All Saints Episcopal Church in Pasadena was asked to come back and speak. That Sunday morning he spoke out against the U.S. involvement in Iraq. The following week, All Saints received notification from the IRS that its non-profit status was being repealed.

A court case followed and with support from other faith communities, All Saints won its appeal and its non-profit status was restored. That is an example of government intrusion on religious freedom.

In the past few weeks, conservative presidential candidates have been weighing in on, what they think to be, a plan by the Obama Administration to undermine religious freedom.

Jeb Bush is the most recent candidate to jump on the band wagon during an interview this week with David Brody of the Christian Broadcasting Network. This paranoia is centered on the stepping back from a law in Indiana allowing business owners to refuse service to groups or individuals in conflict with the owners' religious beliefs.

In reaction to the protests, candidates like Jeb Bush and Ted Cruz seem to be blaming the Obama Administration for what they call an attack on religious freedoms.

I don't know where they got the idea that the government is behind this "religious persecution." In the case in Indiana, as well as Arkansas, it was businesses that responded to what they saw as a discriminatory law, targeted mainly against the LGBT community.

The NCAA was threatening to relocate its headquarters out of the state of Indiana. This was not a function of government, but rather a function of capitalism. It's called a boycott. The boycott wasn't focused on religious groups but rather on a law that gave businesses an invitation to discriminate against particular groups of people, whether the business owner was religious or not.

This function of capitalism was used in a courageous and touching way back in 1964, when Dr. Martin Luther King won the Nobel Peace Prize. The mayor of Atlanta wanted to host a special luncheon to honor Dr. King's ac-

complishment, inviting many Georgia business leaders to attend.

This happened at the height of the African-American struggle for civil equality. Many of the businesses found it distasteful to sit and break bread with a Negro activist who was working against their moral sensibilities.

Upon hearing this, the CEO of Coca Cola and the retired CEO of the company made it clear to the Atlanta business community that, should they be absent at the luncheon, Coca Cola would move its headquarters to another state. They made clear that they did not care to do business in a state where its community leaders would not participate in celebrating one of its fellow citizens who had received such a prestigious award.

The business community attended the luncheon. That is the power of boycott — putting your money where your conscience lies — that is available to religious and non-religious people alike.

So I ask of those who are concerned about losing their religious freedoms: Where was your outrage when the government went after All Saints in Pasadena for voicing their opposition to war? That was not people refusing to attend their church as a result of their anti-war position, that was a threat and an assault by government, using its power to squelch the dissenting voice of good people of conscience.

I believe all people of faith should act according to their moral compass, but by doing so, there is always a price to pay.

# Anna Ancheta, musician, conductor, educator and artist

Anna Ancheta teaches voice and how to project when singing, yet her own voice is quiet. Her accomplishments as a musician, conductor, educator and multi-discipline artist and intellect are stellar, and yet Ancheta is modest. Her contributions to community life, both in Idyllwild and in the Hemet/San Jacinto Valley, create civilizing influences that make a difference, and yet few are aware of the extent of her contributions.

Known locally as the conductor and arranger for the female a cappella group Local Color, Ancheta also heads a nonprofit, Musica, that provides music training and orchestral experience for young and old, in Idyllwild and in Hemet/San Jacinto. Musica offers string classes and orchestral experience with the Inland Valley Youth Orchestra. It also provides master classes and mentoring to young musicians.

"Making music together serves to enrich our community and the world," said Ancheta. "It helps to maintain community health and pride and aligns diverse ages, language groups, and cultural and racial groups. These are qualities sorely needed in communities which are stressed economically and where youth are at risk for drugs, teen pregnancy and gang involvement."

Ancheta holds a bachelor of arts degree from U.C. Davis in history and fine arts and a master's degree in conducting from the University of Southern California. She taught for many years at the Westridge School in Pasadena and Little Lake School in Hemet and then as part of the San Jacinto Unified School District. While

there, she started a string program that remains in place today. She received awards as teacher of the year in both the Hemet and San Jacinto districts and was honored by the Soroptimists with the club's "Ruby" award for enhancing the lives of women in her community.

When she speaks about how people learn, finding a "portal" into each person to create a trusting bridge for learning, she shows both her passion for education and her belief in the arts as the consummate civilizing influence. "Whether with old or young, I am fascinated by how people learn," she enthused. "I've always believed in experiential learning, kinesthetic hands-on learning. My father was a carver who made things. My mother was a seamstress who made things. I believe the best learning has a muscle component, a component of doing, of practice. Also, my Zen Buddhist practice has influenced how I teach. Thinking about something is just that. It is important to be."

Ancheta explains how effective it is to use the body to find the instrument within, to connect and find or reclaim one's own voice — that effective teaching is all about finding a portal in that suits the person. She notes it's different with young people than with those who are older. "Kids now have lost that safety zone of making communal music, of just trying stuff," she said. "With teaching, one has to create a safety zone where it is OK to make mistakes. I often talk to parents about the importance of finding a safety haven or sanctuary for children so that they can learn not to judge themselves." She notes that 40 years of teaching have equipped her with a large kit of instructional tools that help find that entry portal for young people.

"Older people have their own set of experiences, and so my job is to really listen and find out who they are and how I can best communicate," she said. "It is a more creative challenge."

It is clear, after talking with Ancheta, that these challenges, whether with old or young, are what excite and sustain her. "We make mistakes so we can learn," she notes. "We make mistakes, practice, then deconstruct and then go back and reconstruct." And with that, Ancheta provides a guide and model for lifelong experiential learning.

## Unclaimed refunds deadline is Aug. 3

People who own residential or business property in Riverside County have until Aug. 3 to file for unclaimed property tax refunds.

The date gives taxpayers sufficient time to file for refunds and not be caught short by the deadline. Filing instructions and a list of all unclaimed property-tax refunds from tax year 2010 and prior are available on the Treasurer-Tax Collector's website at [www.countytreasurer.org/TaxCollector/UnclaimedMoney/PropertyTaxUnclaimedRefund.aspx](http://www.countytreasurer.org/TaxCollector/UnclaimedMoney/PropertyTaxUnclaimedRefund.aspx).

Kent said 1,217 refunds totaling \$2,243,482.66 remain unclaimed. Most refunds stem from valuation reductions by the County Assessor and are related to corrections or cancellations to the tax roll after taxes already had been paid.

Under California law, property-tax refunds unclaimed for four years after the payment date — or one year after a requested claim form has been mailed back to a taxpayer by the county, whichever is later — may be transferred to the county general fund by order of the Board

of Supervisors. After Aug. 3, any unclaimed money shifts to the general fund and no longer can be claimed.

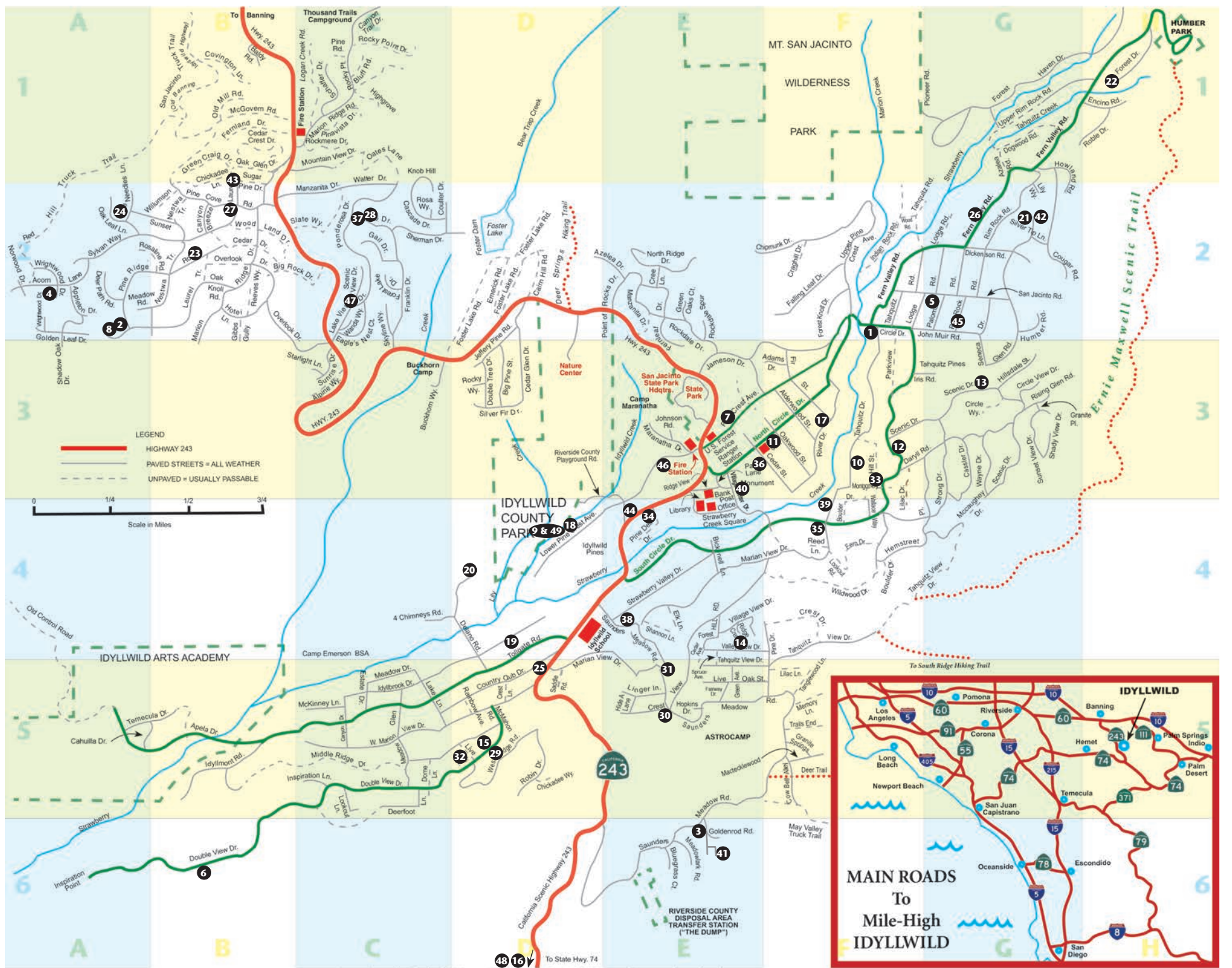

Electric bill credits may come

The California Public Utilities Commission and California Air Resources Board are reminding consumers that in April and May, about 10.7 million California households would see a credit averaging \$27 on their electricity bills thanks to the state's Cap-and-Trade Program to fight climate change. This is the third time consumers will receive the Climate Credit, as they also received it in April and October 2014, resulting in an overall total credit to date of \$736 million to California households in 2014. A forecasted \$577 million will be credited to households in 2015. Households receive the credit on their October or November and April or May bills each year, regardless of energy consumption or bill amount. About one million small businesses receive the credit every month as a credit if they use less than 20 kilowatts of electricity each month. Adrian Adams, legal counsel for the previous board, had acted during the month-long hiatus as pro-bono AAI director and administrator charged with conducting the election for the new board. Adams also served as trustee for AAI assets turned over to him by the previous board. Adams set the agenda and conducted the meeting until new directors selected their officers. Once new officers were elected, Adams resigned as interim director and turned the meeting over to newly elected AAI President Shanna Robb.

In addition to Robb as president, the 10-member board elected Byron Ely as vice president, collaboration; Erin O'Neill as vice president, membership; Del Marcussen as treasurer; and Veda Roubideaux as secretary. Prior to the meeting, elected director Barry Zander had submitted his resignation, citing his belief he could be more helpful to AAI working in conjunction with and showing support for the board rather than serving on it. "I support the new board and will help it achieve its objectives," said Zander.

In addition to the five officers, the other board members are Gerry High, Darcy Gerdes, Terryann Halloran, Peter Szabadi and Cate. Neither Szabadi nor Cate attended the meeting, citing travel commitments.

In open session, the board moved quickly to resume AAI community events, pending review of board financial documents and available resources. It voted to provisionally green-light combining two events halted by the hiatus — the Plein Air Festival and Sizzling Summer Gallery Tour, targeting the weekend of June 12 to 14 for the combined event. Said O'Neill, "The reason for putting this vote on the May 16 agenda versus waiting until a follow-up meeting is that the proposed June date is less than a month off."

Board approval is conditioned upon having sufficient resources to stage the June event, given the new board had not yet reviewed financial documents it had just received from Adams.

Although Adams turned over documents and assets on Saturday given to him by the previous board, he did not specifically inventory those documents, nor did he verify the bank account balances the incoming board inherited. Robb commented, "As for the assets, since there was no accompanying inventory signoff provided when we took possession, the newly elected board are taking a team approach in documenting

what was received."

In answer to an email query regarding transfer of assets, Adams said, "There were boxes of materials, a laptop computer, two forms of electronic backup of records, bank accounts, websites, email accounts and a large mini-storage [locker] of materials turned over to me to hold for the incoming board. Once I had possession, I had locks changed on the mini-storage and P.O. Box, passwords changed on the website, Facebook and Gmail accounts, and control of the bank accounts shifted to me. Everything was frozen in place awaiting the new board, with my firm absorbing all the costs.

"Once the new board was seated on Saturday, all passwords, keys and assets were delivered to them, including full electronic back-ups made by my office for [10] thumb drives that were then given to each of the new directors ... I could have hired someone to make a detailed inventory, but it is a better use of Alliance funds for the new board to catalog everything."

The board also voted to authorize all five officers to sign AAI checks, and require any check over \$500 to have two authorized signatures.

In introducing themselves, new directors stressed the board's commitment to financial transparency, prompt posting of meeting minutes, monthly posting of AAI finances, and greater consultation with AAI membership and the community. As evidence of that, one vice presidency, that of Ely, is dedicated to community collaboration. Said Ely, "We want our process to be in-

clusive, to work with all artist groups and businesses to restart events, so that we regain momentum, pick up lost pieces and move forward to solutions."

Said Robb, "The involvement of the membership and our community supporters will be key in restructuring the AAI. The board believes that the more informed and involved our members become in the delivery of events and programs, the more likely the entire community will benefit. That means collaboration with our members, our media and our community. I look forward to bringing that attitude."

Adams stated that while serving as interim director he had filed all required documents with the California Secretary of State, reviewed the existing AAI bylaws and compiled a list of amendments he believed needed to be made.

Gerdes volunteered to head a committee to oversee bylaw revision. Adams' suggestions included: reduce number of directors from 11 to five or seven (an odd number), stagger terms, institute term limits, establish annual elections and protocols for conducting them, create qualifications for directors, establish a process for their removal for cause, add a provision for filling director vacancies and "add a number of procedural provisions for how boards should function."
