



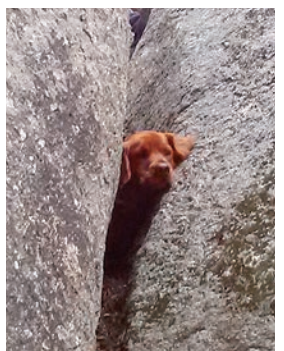

May unusually wet despite four-year drought

In 2015, local residents are hoping that May showers may bring June flowers. This has been one of the wettest Mays in decades.

Through this weekend, the U.S. Forest Service's Keenwild Ranger Station has recorded 2.7 inches of rain for May, including a half-inch from Friday through Sunday. Pine Cove received about 0.3 inches during this

period also totaling 2.7 inches in May. The long-term average for May is only three-quarters of an inch but in 2015, the fourth year of a statewide drought, the Hill has received almost four times the normal precipitation.

Nevertheless, both areas are still below the long-term average for rainfall from July 1 through May 31, which is 25.5 inches. Keenwild's total this rain year is 13.15 inches, while Pine Cove's total is 20.5

inches. The Idyllwild Fire Station reports 19.8 inches of rain through May.

Unless June is as unusually wet as May was, 2014-15 is the third consecutive year of below-average rain on the Hill, and the ninth year in the past decade.

National Weather Service Meteorologist Alex Tardy reported that the "past 48 months through April have been the driest in California. We're missing 28 inches

Idyllwild Water to get \$2 million for recycling plant

Legally recycling wastewater is now in Idyllwild's future. At the May 20 meeting, Idyllwild Water District General Manager Tom Lynch announced that the State Water Resources Control Board is awarding the district slightly more than \$2 million to construct a tertiary

water treatment facility.

Of the total \$2,045,217 financing package, one-sixth (\$306,687) is a direct grant. One-third (\$715,921) will be a low-interest, long-term loan and the balance, half of the financing, is designated a principal forgiveness.

"Upon completion of the project, if [IWD] has met the terms and conditions of

New Idyllwild Fire ambulance in crash

Idyllwild Fire Chief Patrick Reitz reported that one of the district's new ambulances was involved in a crash while transferring a patient during the foggy weather this past weekend.

This was one of several items he mentioned during his report at Tuesday's Idyllwild Fire Protection District commission meeting.

"Last weekend, there was an accident with one of our recently acquired ambulances," he stated. "It's out of commission until we take it to a dealer

repair shop in Anaheim."

The collision happened during heavy fog and the drive "caught a rock" along the road, damaging the vehicle's body.

"We visited the scene and found a debris field, which has been accumulating for a while. So others have hit it, too," Reitz said and added that he reported the incident to Cal Trans.

The ambulances were purchased at auction at the end of February. Within the past month, IFPD finally had them ready for use.

Dog walker discovers injured man

A local man made a grim discovery Tuesday afternoon, May 19, when out walking his dog on a trail near Strawberry Creek.

Brad Pace of Idyllwild was walking at around 2 p.m. about 200 yards east of the Strawberry Creek Bridge at Highway 243 when his dog pulled him toward something off the trail. Pace saw a bloodied man lying next to a boulder also covered in blood. He thought the man was dead so he called the Riverside County Sheriff's Department.

When deputies arrived about 45 minutes later, Pace said they, too, at first thought the man was dead. Then they saw the man's chest move and called Idyllwild Fire to the scene.

Idyllwild Fire Chief Patrick Reitz said the paramedics transported the man to Keenwild Helibase where he was flown to an area hospital.

Capt. Ray Wood of the Hemet Sheriff's Station said the man had attempted suicide by stabbing himself in both sides of the neck. He had deep lacerations to both sides of his neck but "he is expected to make a full recovery," Wood said. Because of the mental condition of the man, Wood would not release his name.

"We don't know his residence and when we went to his last known residence, the resident there doesn't know him," added Wood.

Asked why paramedics were not dispatched when the deputies were originally dispatched, Wood said he would look into the issue.

Relatively quiet on Hill roads over holiday weekend

Even though much of the Memorial Day weekend was cold, foggy and rainy, Hill roads remained free of major traffic incidents. California Highway Patrol Cabazon Pass Station Public Information Officer Darren Meyer reported two incidents, neither near Idyllwild.

The first, a rollover, occurred at 8:06 a.m. Wednesday, May 20, on Highway 74 1.8 miles

east of the intersection of Highway 371. Ricardo Barragan, 24, of Anza, ran off the road and his 1992 green Toyota Camry overturned. Barragan was not injured and no fault was cited in the CHP report.

The second occurred at 10:59 p.m. Sunday, May 24, also on Highway 74. Andreas Sandoval, 24, of Hemet, was driving west 3.4 miles east of Bee Canyon when his 2005 Nissan 350Z ran off the road and crashed into the mountain. Sandoval was not injured, according to the

report, and no fault was cited.

A third, not yet verified in a formal CHP report, occurred in Idyllwild on Highway 243 reportedly near the intersection with Saunders Meadow Road at around 3:35 p.m. Wednesday, May 20. A semi-truck hay hauler struck an Edison power pole. Two power lines became entangled with the truck's exhaust and had to be freed by Edison crews.

Idyllwild Fire to raise ambulance charges

Loss of county contract affecting next year's budget

The cost of an ambulance trip to a local hospital will increase next year. In order to maintain current services, Idyllwild Fire Chief Patrick Reitz last week offered a proposed 2015-16 budget (which begins July 1) to the district's Finance Committee that would raise the cost of a trip to \$1,405 from the current level of \$1,135 — a nearly 24% increase. The Idyllwild Fire Protection District Commission approved the rate increase Tuesday, May 26.

This and other medical-service cost increases are necessary to continue current service levels as a consequence of losing the ambulance service contract with Riverside County for transporting residents of Pine Cove and Zone 3 (north and south of the Idyllwild Fire Protection District).

Without the rate increases, Reitz's revenue estimate is \$1.6 million compared to the current year (which ends June 30) of \$1.85 million. The quarter-of-a-million-dollar difference would primarily affect staffing, according to Reitz. If the rate increase were approved, Reitz projected revenues of about \$1.7 million.

Two engineer positions and one firefighter position would not be filled on a permanent basis. Limited-term firefighters, such as reserves, would serve in the jobs, according to Reitz. Also, the weekly hours for the administrative assistant would be reduced from 24 to 16. These actions would save about \$86,000, according to two budget submissions.

With possible limitations on budget resources, Reitz stated that the issue is "... do we need a two-, three- or four-person staff and how many ambulances for our district?" Currently, with the benefit of the county ambulance contract, Idyllwild normally has staff to support two concurrent ambulance calls; however, the lower revenue estimate might necessitate that the district can only staff one ambulance call, Reitz lamented, and added that his preference is to always have staff available for two ambulances.

The district currently has two to three dispatch calls daily, he noted.

The rate increase will enable IFPD to fill several posi-

tions on a permanent basis rather than relying on reserves, according to Reitz.

"We're making up for past inactions [to raise revenue], to ensure fire and emergency service is in line with our residents' expectations," he stated.

IFPD will lose about \$180,000 in revenue from the contracts with Riverside County, but expects revenue from ambulance fees to continue at the 2014-15 level although total transports will decline due to shift of responsibility in Pine Cove and beyond to the county's ambulance provider — American Medical Response.

The county has already approved a \$1,415 transport rate for AMR and IFPD will propose a rate of \$1,405 for advanced life service. Also, IFPD's mileage rate will increase 18 percent, from \$28.15 to \$33.30 per mile. Reitz pointed to AMR's mileage rate of \$34.42.

The proposed budget still includes one dilemma. The county's new ambulance policies will require standardization of equipment and installation of communication device to local, first-responder vehicles in case of any emergency.

The cost of this equipment for IFPD is estimated to be about \$100,000 to outfit all nine vehicles, but the budget does not include this cost, Reitz said. However, he is still negotiating with the county about what it will expect or, possibly, require from IFPD.

Since these devices have not performed well in the mountains, he is hopeful he can convince the county to allow IFPD to use less sophisticated equipment that will still achieve a similar purpose.

Reitz stressed that these increases are for the costs associated with an ambulance call or transport. When residents ask about the property tax and parcel fee, he stresses that those revenues "... guarantee the ambulance service is available, they are not for the actual service."

Idyllwild residents do not want a third service or outside provider, Reitz said. Ambulance service is about 85 percent of the district's workload and those taxes ensure IFPD can provide fire and emergency medical service when called.

"We used to be a fire department that provided EMS [emergency medical services], now we're an EMS department that provides fire," he added.

Several reasons explain and may alleviate the present

\$270,000 deficit in the current-year budget. Finance Chair and Commissioner Nancy Layton said IFPD will receive the final \$380,000 of property tax and parcel fee revenue this month and the final \$45,000 payment for the county ambulance contract; ambulance revenue for the 10 months of the year has already equaled the full-year projection; and a loan agreement for the purchase of the two ambulances in February would remove the cost from the budget.

Besides the ambulance costs, a finance subcommittee also will consider including other purchases, such as water tenders and projects such as repaving the concrete on both sides of the station.

Legal fees have reached \$90,000, nearly twice the mid-year estimate. These are largely associated with the litigation stemming from the chief's dismissal of former Capt. James Reyes. For next year, Reitz projects that legal costs will be about \$37,000.

Rutherford hearing deferred to June

Rob Rutherford, who has been accused of damaging a sculpted deer in front of Idyllwild Inn earlier this year, had his hearing for violation of probation, for a previous offense, re-scheduled to June 29. Riverside County Superior Court agreed to the deferral since he is in a residential rehabilitation facility.

The notes from the May 19 scheduled hearing stated, "Court orders defendant present at the next hearing unless the program does not allow him to leave. Court orders a written update from the rehabilitation facility."

The damaged deer was

one of 22 painted deer sculptures the Art Alliance of Idyllwild placed throughout Idyllwild and PineCove. The initial story of the damage to this deer was reported in the Feb. 12 issue of the Town Crier.

During the following week, Rutherford called the paper and denied his involvement in the incident. However, the California Highway Patrol had his license plate number and made an arrest the night of the incident.

He stressed that it was not his car, although two CHP officers reported that the car that appeared to damage the deer is registered to Rutherford. He did not respond to this statement.

Six candidates seek three Idyllwild Water board seats

As the deadline, May 29, for filing to run for a seat on any of the local special districts approaches, several interesting results have already appeared.

The major development is that six people have requested candidacy papers for a seat on the Idyllwild Water board. Three — James Billman, board president, Dean Lattin and Warren Monroe — are incumbents seeking re-election.

However, three other community members also have requested the candidacy papers — Steven Kunkle, retired IWD employee, Richard Nash and June Rockwell, the only one of the six who has already qualified for the ballot in August.

The other development

is that the actual deadline for the Pine Cove Water District board seats will be extended until Wednesday, June 3, since board President Michael Esnard will not be seeking re-election. Diana Eskew, the other board member whose term expires this year, has filed for re-election and Timothy Lange, a retired school psychologist, also has filed candidacy papers.

Idyllwild Fire Protection District commissioners Jerry Buchanan and Larry Donahoo have filed for re-election, but no challengers have appeared.

As of Tuesday, May 26, no papers have been filed for the Fern Valley Water District election although the incumbents, Trischa Clark and Richard Schnetzer say they will seek re-election.

Some time back, Jack and I received a letter from our long-time Allstate broker advising us of an upcoming inspection of our home exterior. We knew abatement wasn't an issue so we expected our property to pass with flying colors.

The inspection report returned advising us to paint our peeling garage door and add some more fencing posts to our front porch, which already met even today's building codes. If we failed to comply, our home insurance faced termination.

We suspected — because we saw other issues more dangerous around our home — that the inspection was a red herring, an excuse to drop our policy because of our high fire-risk area.

Jack painted that garage door anyway and fixed some other more important issues but failed to get to the porch. Along the way, our broker's office assured us the policy would not be canceled and the paint job would suffice to quell the honchos at Allstate.

Nevertheless, like a hot potato, Allstate dumped us. We heard that Allstate no longer wrote new policies up here, but Jack talked to an Allstate contact who admitted the agency didn't want to keep old ones either.

After more than 26 years without one claim, we found ourselves searching for home insurance again.

In 2006, Allstate dropped 120,000 Florida property policies because of hurricanes. We experience wildfires and earthquakes; the Pacific Northwest, earthquakes; the Midwest, tornadoes and now earthquakes; the eastern and southern states, hurricanes and also tornadoes. Floods occur where it rains. Where might Allstate be comfortable insuring homes?

Now, every time I see Dennis Haysbert in an Allstate commercial stating, "You're in good hands with Allstate," I wonder who he's talking to: The stockholders?

Toxic tidbits

EDITOR:

Aspartame is an artificial sweetener created in laboratory by Monsanto, a pesticide and GMO manufacturer. This sickening sweetness is brought to us in little packets of NutraSweet, Sweeta, Equal, Spoonful, Canderel and Benevia. Diet sodas are full of it, and so are low-calorie, low-fat and sugar free food products. We think we're eating healthy when we consume fat-free and sugar-free drinks and foods. In reality, we're eating and ingesting poison with every calorie-saving bite. Often, we tend to feel it's OK to eat more because it doesn't have fat or sugar. Cost to eat out is high

EDITOR:

Looking at the Town Crier last week, it looks like some restaurant owners may be finally waking up. I saw deals on food.

I have been up here now for 15 years and have been saying the same thing over and over: The prices up here to eat are crazy.

Chelsea's was one of the only places up here where you could eat and not cost you an arm and a leg. Chelsea's made it for years in this town.

How many restaurants have come and gone in the last 15 years? Slowly, year after year, restaurant owners who had a somewhat reasonable price and had been here for years decided it was time to retire.

They sold their business and the new owners had the same food but raised the price within a year \$3 or more. Some have specials and within a year they are back up to the regular price.

I remember one place would just put a line through the price and add another and do it two or three times before changing menus. Always the excuse is, "We are so far from everything," like many of the stores up here. I think that was proven wrong when one owner started selling gas 50 to 80 cents a gallon cheaper. He even did it on food until that got screwed up.

This is a disadvantaged community and most people can't afford to eat here who live here. I never owned a restaurant and maybe I don't know what I am talking about, but the way I see it is if you can't get the people who live here to come into your restaurant once or twice a

County seeks special assessment to battle mosquitos

Residents of Riverside County's unincorporated areas, including Idyllwild, will be asked to approve a special assessment in order to maintain the county's pest control program — such as pertains to mosquitoes and rodents.

At its May 12 meeting, the Board of Supervisors approved a resolution authorizing the Proposition 218 ballot, which the county began mailing to residents Friday, May 22.

The county has identified three areas benefiting from continuing the program. Zone A, the largest of three areas, includes the Idyllwild and Pine Cove communities and would be assessed \$7.14 per parcel annually. The other zones would be assessed lesser amounts. Zone B's assessment would be \$2.04 and the lowest assessment, \$1.02 per parcel, would apply in Zone C. The amounts are assessed annually, and assessments for vacant and agricultural land are significantly lower.

Here, in Idyllwild, our firefighters are my heroes and so are the police.

What would we do without them? There are bad apples in every group. They should be removed. Think about it: Would you, right now, want your husband, brother or boyfriend to be a policeman? I wouldn't. Here they are protecting us, but are we protecting them?

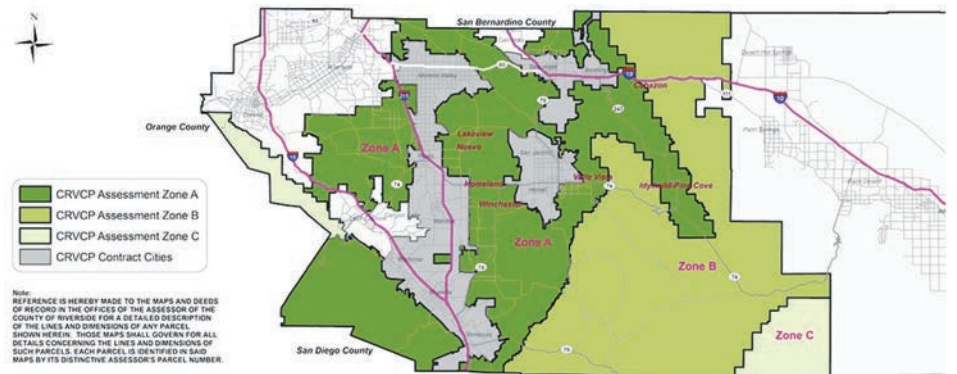

Mosquito, Vector & Disease Control Assessment

The program helps protect against diseases such as West Nile virus, Lyme disease, plague and hantavirus. Southern California also faces emerging threats from diseases such as Chikungunya, dengue and yellow fever. Besides mosquitoes, the program also protects against rodents, which also may harbor infectious diseases.

Historically, the Mosquito and Vector Control Program had been funded

primarily from the county's General Fund. However, as a result of budget cuts, the program no longer receives General Fund revenue. Currently, the program within the service areas is funded from a reduced and limited portion of county discretionary fees, including poultry ranch inspection fees. This limited funding for vector control is not considered stable or reliable, and the program's future operation is in significant jeopardy.

Future program annual costs are estimated to be \$614,000, of which \$129,000 will come from special funds. The assessments are estimated to raise the \$485,000 balance.

If property owners approve the proposed benefit assessment, the program will continue working to control mosquitoes, identify vectors, educate the community about protecting against vectors, and conduct rapid testing for existing and emerging vectors and diseases in Riverside County.

If the proposed assessment is not approved, the program will be forced to cut services drastically, according to the county's press release.

After the ballots are mailed to property owners, a minimum 45-day time period must be provided for the return of the assessment ballots. A public hearing on the assessment is scheduled for 9:30 a.m. Tuesday, July 7, at the County Administrative Center in Riverside.

At this hearing, the public will have the opportunity to provide input on this issue and a final opportunity to submit ballots.

Fifth District Supervisor Kevin Jeffries was the lone opposition to the proposal. "Riverside County taxpayers should not be required to pay an extra tax for what should be basic public health service proved by the county," he said.

Local writes FCC regarding use of WNKI

In a May 9 letter, Pine Cove resident and Mile High Radio Club member Jeff Smith requested both the radio club and the Idyllwild Fire Protection District terminate using WNKI-578. In his complaint filed with the Federal Communications Commission rules, Smith states, "... WNKI-578 transmits reliably only tourism and disaster preparedness messaging during non-declared emergency operating times including repeated broadcast citations of numerous specific commercial point-of-sale business listings and solicitations operating in Idyllwild and the surrounding area."

Smith says this violates the FCC rules for stations in the WNKI category. According to the FCC regulation, which Smith cites, it states, "Travelers' Information Stations (TIS) to transmit noncommercial, travel-related information over AM band frequencies to motorists on a localized basis."

At the May 26 IFPD meeting, Commission

President Jerry Buchanan affirmed that the district's legal counsel reviewed the agreement with MHRC thoroughly before the commission approved it last fall. "We're operating legally and even though the transmitter is 250 [watts], we've limited its output to 10 [watts, the licensed transmission power]. While we still have the license, MHRC is qualified and has the expertise to operate the station."

Bill Tell, MHRC president, interpreted the FCC rules differently than Smith and responded, "We have no plans of backing off from our goals of moving WNKI forward with the upgrades as outlined in our strategic plan."

Smith is relying on a FCC July 2013 rulemaking, which states, "We find that allowing routine TIS broadcasts during nonemergency periods of terrorist threat levels, public health alerts, emergency preparedness messages, conservation messages and the like, is not in the public interest, as such routine broadcasts also would dilute situational awareness pertinent to the traveling motorist."

"The primary purpose of the TIS is to assist motorists in the process of traveling and to provide emergency and imminent threat information in covered areas. Therefore, we will continue to disallow messages that do not have a travel nexus, are not emergency-related, or do not relate directly to an imminent threat because such messages would dilute the convenience and efficacy of TIS."

"Regarding the rules and regulations, we have been in communications for a third time in 2.5 years with a leading authority on this topic, one who works closely with the FCC," Tell wrote. "Our contact states that Mr. Smith is splitting hairs like he has never seen in his 35 years working these types of stations. In fact, we have pointed out to this individual details that he says we have in black and white that we are in the right."

Smith believes the use of the station for transmissions, which are not related to emergencies, but rather general tourist information and advertisements of Idyllwild as a vis-

itation site, are a violation of the station's license.

"I've had private conversations with members of the radio club board for awhile. Their response was to ignore me," he said. "I've presented this issue to the membership already, so it's not a sudden surprise."

But Tell believes Smith has not been as open as he might with the club. "During the MHRC meeting of May 14, Mr. Smith had several opportunities as a MHRC board member and director to speak up on any topic that may be of his concern; however, he chose not to do so. The MHRC did not receive Mr.

Smith's letter till the 15th of May, the day after the MHRC's general meeting."

In this correspondence to IFPD, which is part of the commission's package distributed for IFPD's May 28 meeting, Smith also wanted the December agreement between IFPD and the MHRC to be terminated until the FCC has approved the station's operating limits.

Smith also expressed concern about the power wattage of the station's transmission, believing these may also exceed the limitation for TISs, the authority for WNKI's license.

In his conclusion,

Smith wrote, "As a long-term homeowner within Idyllwild, it my desire to have effective and widely accessible situational, hazard and emergency awareness information for residents and motorists."

He argues that the current WNKI transmissions have limited geographic scope and are overshadowed by competing services, including the emergency alert systems and cell phone access alerts. WNKI "... serves no purpose other than to promote specific businesses and tourism for a few seconds."

Court of appeal modifies Capistrano decision

On April 20, the 4th District Court of Appeal, Division 3, decided the case of Capistrano Taxpayers Association Inc. vs. City of San Juan Capistrano, in which the taxpayers sought to overturn the action of a local governmental body to impose, unilaterally without a vote, tiered rates not based on cost of service for the incremental levels of usage. The taxpayers argued that the city's new rates violated Proposition 218, which requires public water agencies to base their rates on the actual costs of providing water at the various levels of usage. The trial court and the appellate court agreed with the taxpayers association on that issue.

On May 6, the city filed a petition for rehearing before the same court of appeal, but five days later the city requested withdrawal of its petition for rehearing, which the appellate court granted.

However, the court of appeal also took the opportunity to modify its opinion in

several places, clarifying the avenues open to water agencies seeking to raise rates in tiers. The key modification was the insertion of the following paragraph:

"The way Proposition 218 operates, water rates that exceed the cost of service operate as a tax, similar to the way a 'carbon tax' might be imposed on the use of energy. But, we should emphasize: Just because such above-cost rates are a tax does not mean they cannot be imposed — they just have to be submitted to the relevant electorate and approved by the people in a vote. There is no reason, for example, why a water district or local government cannot, consistent with Proposition 218, seek the approval of the voters to impose a tax on water over a given level of usage — as we indicated earlier, that might be a good idea.

"However, if a local government body chooses to impose tiered rates unilaterally without a vote, those tiers must be based on cost of service for the incremental level of usage, not pre-determined

State revenues growing

Education benefits

On May 14, Gov. Jerry Brown announced revisions to his proposed 2015-16 state budget, boosting the General Fund expenditures to a total of \$115.3 billion, an increase of \$6.7 billion.

"The state is definitely on a rebound from just a few years ago when the state was mired in red ink," Brown said at his news conference releasing the revised budget proposal. "The finances of California are stabilized. Just since January, several million dollars came in the state treasury."

Much of the increased revenue will go toward educational programs, pursuant to Proposition 98, enacted in 1988. Funding for K-12 schools and community colleges will increase \$5.5 billion for a total allocation of \$68.4 billion. Funding for K-12 is nearly \$10,000 per student, a \$3,000 or 45 percent increase over 2011-12 levels when \$47.3 million was distributed under Prop 98.

In combination with the growth in Medi-Cal spending, which is now supporting 12 million people, a 50-percent jump, Brown emphasized, "... the fundamental of what government is supposed to do — health and education — that's the focus of our spending."

Last week, the Legislative Analyst's Office released its comments on the May revised budget. The LAO estimates that the combination of personal income, corporate, and sales and use taxes will be \$3.1 billion more than the governor's projection for the current fiscal year.

Regardless of whose revenue estimates are more accurate, voter-approved propositions 2 (November 2014) and 98 (approved in 1988) earmark most of the growth to reserves and educational spending.

Consistent with his promises to protect future

funding, Brown proposes to set aside \$3.8 billion, an increase of \$633 million, in the state's Rainy Day Fund. Total state reserves will be \$4.6 billion compared to \$3.4 billion in the January plan.

The May revision also maintains flat tuition for California undergraduates at the state's universities.

Recognizing the depth and extent of the recent recession, Brown also is proposing to use \$380 million for an earned income tax credit, similar to the federal tax credit. If the legislature enacts this proposal, residents earning less than \$6,580 with no dependents or \$13,870 with three or more dependents will benefit. Matching 85 percent of the federal credit will provide households a minimum savings of \$460 and a maximum of \$2,653.

The budget also repays money to local schools and local governments, which the state borrowed more than 10 years ago to balance the budget.

Funding to improve the state's water problems, since the drought began four years ago, will go toward various infrastructure water projects, including enhanced recycling. Most of this money comes from the water bond approved in November 2014. The 2015-16 budget proposal uses about a third of the \$7.5 billion

approved as part of Proposition 1, the water bond.

Part of the drought-response funding provides \$1.4 million to the State Water Resources Control Board for enforcing water-use restrictions and more inspections of diversion facilities.

The governor has maintained the \$62-million emergency drought funding for Cal Fire, which was part of his January budget proposal. The budget also includes \$6.1 million to replace an air tanker.

Other increases in the May revision, which will have a local impact, are for the literacy and English acquisition program and the state's broadband project for local libraries, according to Idyllwild Librarian Shannon Ng.

Although current-year and next year's budget projections are rosy, both the governor and the LAO warned the legislature that this situation could turn around quickly because of the fragile nature of the national economy. State revenues are very volatile since they rely greatly on income and sales taxes.

"A recession is on the way; it's around the corner. It's coming," Brown stressed. "We take what we have and spend it prudently."

budgets. (For the moment, of course, we need not decide whether such a proposed tax would constitute a general tax or special tax.)" (Capistrano Taxpayers Association, Inc. v. City of San Juan Capistrano, G048969, modified May 19, 2015, p. 27)

Consequently, any of our local water agencies who may seek to establish tiered rates, or raise existing ones, must either base the new rates on the cost of service for each tier or bring them before the people of the district for a vote.

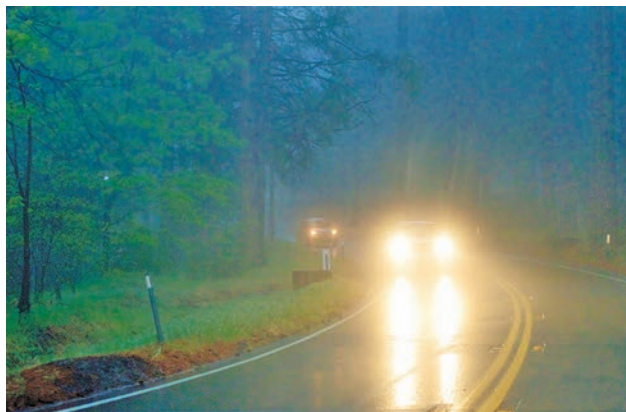
One aside: We recently received an emphatic email from a disbarred attorney attempting to convince us, and presumably other newspapers, that decisions of the 4th District, Division 3, have no statewide application, but are limited to the geographical area of the 4th District, or perhaps even of Division 3 — in which Idyllwild is not. That contention is false.

It is elementary law that "[D]ecisions of every division of the District Courts of Appeal are binding upon all the justice and municipal courts and upon all the Superior Courts of this state, and this is so whether or not the Superior Court is acting as a trial or appellate court. Courts ex-

ercising inferior jurisdiction must accept the law declared by courts of superior jurisdiction. It is not their function to attempt to overrule decisions of a higher court." (Auto Equity Sales, Inc. v. Superior Court (1962) 57 Cal.2d 450, 455)

Consequently, a published 4th District opinion is binding on every trial court in California hearing a relevant water agency matter — and it will remain so binding unless and until a court of appeal of another appellate district renders a published decision to the contrary or the California Supreme Court decides the issue itself.

[of rain] across the state." In Idyllwild, the four-year rain deficit now totals 41.2 inches or the equivalent of one-and-half rain seasons.

NWS still expects an El Niño to strengthen during the summer and maintain into winter, Tardy said. In fact, from July through September, the Hill might experience above-average

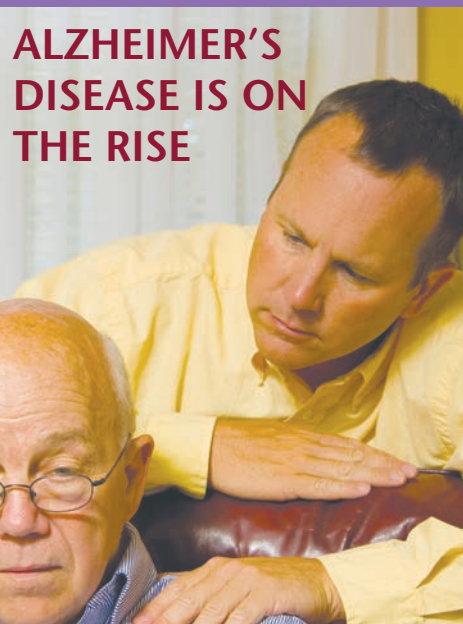
monsoonal activity.

Despite all the recent wet and cool weather, he reported that the past year, "May through April is still running record warmth. March average 8.2 degrees above normal" and the higher temperatures may continue even if an El Niño condition forms, Tardy added.

Hiking safety

We are entering the time of year when hiking is a popular outdoor activity enjoyed by the public in various locations throughout Riverside County.

The Riverside County Sheriff's Department reminds hiking enthusiasts to carry proper equipment for any outdoor excursion.

Proper preparedness includes a well-thought-out travel plan shared with friends and family, as well as familiarity with common hiking equipment, such as GPS, maps and compasses, proper clothing and plenty of water. It is also a good practice to stay on the trail and conserve your cell-phone battery.

Electric bill credits may come

The California Public Utilities Commission and California Air Resources Board are reminding consumers that in April and May, about 10.7 million California households would see a credit averaging \$27 on their electricity bills thanks to the state's Cap-and-Trade Program to fight climate change. This is the third time consumers will receive the Climate Credit, as they also received it in April and October 2014, resulting in an overall total credit to date of \$736 million to California house-

holds in 2014. A forecasted \$577 million will be credited to households in 2015.

Households receive the credit on their October or November and April or May bills each year, regardless of energy consumption or bill amount. About one million small businesses receive the credit every month as a credit if they use less than 20 kilowatts of electricity each month.

The dollar amount being returned to many Edison households in April/May is \$29.

Visitors and residents may view artists painting outdoors from 8 a.m. to 5 p.m. on Saturday in a style popularized by French impressionists in the mid- to late-19th century. Called plein air painting, the movement extolled the virtues of painting outdoors in natural light rather than in a studio.

AAI artists also will be creating art at participating galleries. Gallery owners provide both gallery tours and refreshments for visitors.

Featured art will be exhibited at host venue Wilder Cabins from 9 a.m. to noon Sunday, June 14.

Plein-air painters, competing for AAI judged awards, register for the event and often come from both on and off the Hill. They choose where they will paint and have all day Saturday, June 13, to complete the piece they will enter in the competition. In past years, plein-air painters have drawn appreciative crowds gathered to watch each brushstroke.

AAI Director Gerry High is heading the gallery event component and listed the following galleries as participants: Artspresso Gallery, Cafe Aroma, Courtyard Gallery, Everitt's Minerals and Gallery, Florist in the Forest, Four Corners at Fern Valley Emporium, Idyll Awhile Wine Shoppe Bistro, Oh My Dog Gallery and The Spruce Moose. High noted there may be more galleries participating by the time of the event.

AAI Vice President for Membership Erin O'Neill heads the plein air event. Wilder Cabins at 54550 S. Circle Drive is the host location, serving both as a site at which plein-air artists can paint and as the venue for the Sunday champagne brunch and awards ceremony. O'Neill noted the Wilder setting is perfect for plein air painting given its cozy ambience and historic nature. She also thanked

"The AAI is passionate about continuing to grow our town's reputation as an arts destination," said O'Neill. "Idyllwild's reputation as one of the top 100 arts towns in the country was hard won and we are committed to staging events and incorporating all the arts, not just the visual arts, to grow that reputation."

Said board President Shanna Robb, "By merging the two events, plein-air artists who will be competing for prize money will be joined by many of our Art Alliance artists working at our galleries and at key locations around town." Unclaimed refunds deadline is Aug. 3

People who own residential or business property in Riverside County have until Aug. 3 to file for unclaimed property tax refunds.

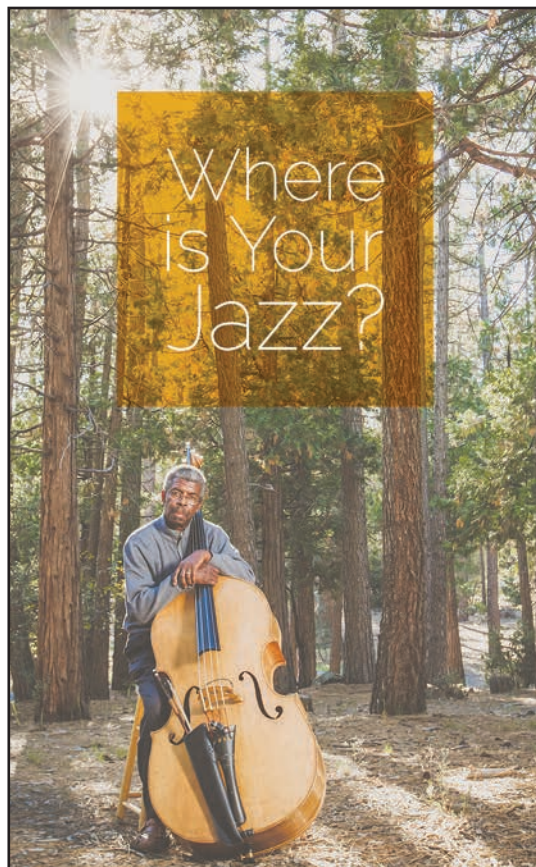
The date gives taxpayers sufficient time to file for refunds and not be caught short by the deadline. Filing instructions and a list of all unclaimed property-tax refunds from tax year 2010 and prior are available on the Treasurer-Tax Collector's website at www.countytreasurer.org/TaxCollector/UnclaimedMoney/PropertyTax-UnclaimedRefund.aspx.

Kent said 1,217 refunds totaling \$2,243,482.66 remain unclaimed. Most refunds stem from valuation reductions by the County Assessor and are related to corrections or cancellations to the tax roll after taxes already had been paid.

Under California law, property-tax refunds unclaimed for four years after the payment date — or one year after a requested claim form has been mailed back to a taxpayer by the county, whichever is later — may be transferred to the county general fund by order of the Board of Supervisors. After Aug. 3, any unclaimed money shifts to the general fund and no longer can be claimed.

Toni Ann Johnson coming to Idyllwild Author Series

Established film, stage and television writer discusses first novel

Toni Ann Johnson is an established writer in both television and film. She will be discussing her first novel, "Remedy for a Fallen Angel," (2014 Norton Press) as part of Eduardo Santiago's Idyllwild Authors Series, now in its fifth. "Fallen Angel" is the story of a young female photographer trying to deal with the psychological wounds she suffered from her narcissistic mother — a successful Bermudian jazz singer consumed by anger over feeling unloved as a child, an anger she then transfers to her own child. She will talk about the novel, which has received strong reviews, with Santiago at 4 p.m. Sunday, June 7, on the deck of Cafe Aroma.

For fans of the series, Johnson's appearance would be one not to miss. She is soft-spoken and engaging, and describes her writing and her life cinematically, so that one is easily drawn in. Her accomplishments at a young age could also be the subject of the screenplays of others. Raised in an upper middle class black family, one of the few in Monroe, New York, Johnson fell in love with jazz at an early age. Her father, a psychologist, had offices in Manhattan near Greenwich Village jazz clubs and he often took Toni with him to hear jazz. The family travelled extensively to Europe, Africa and the Middle East. Academically brilliant, Johnson graduated from high school

at 16 and attended New York University where she studied screenwriting, graduating at 20. She studied playwriting privately with Charles Fuller and Arthur Kopit. During this time she also worked as a professional actress and member of Actors Equity, SAG and AFTRA. She appeared in two films of Spike Lee and popular television soap operas "All My Children" and "Loving."

Her play, "Gramercy Park is Closed to the Public," was staged in New York and caught the attention of literary agent Dave Wirtshafter. That connection led Johnson to move to Los Angeles with screenplay drafts in hand.

After moving to L.A. in 1992, she began writing for studios and networks, including Disney, Warner Brothers, Paramount and Fox. In 1998, Johnson won the Humanitas Prize for her screenplay "Ruby Bridges," an ABC movie and true story of the young girl who integrated the New Orleans Public School System. She won a second Humanitas Prize for her screenplay for a Showtime movie, "Crown Heights," that examined a relationship between an African-American teen and a Hasidic Jewish teen that formed after the 1991 Crown Heights riots.

While busy with her film and television career, Johnson had a dream that was the genesis for "Remedy for a Broken Angel." "It started as a film script, but it was horrible so I left it, but continued to think about the subject matter. I came back to it in 2003, and then worked it until 2006 when I began submitting it. Nothing came of it but the characters remained vital." Johnson completed a final draft in 2012 and found a publisher in 2013.

"The novel is about forgiving the seemingly unfor-

giveable," said Johnson of "Fallen Angel"'s story of complicated and damaging family relationships, with jazz as tapestry weaving it all together.

Johnson holds a bachelor's of fine arts in drama from NYU Tisch School of the Arts, a Certificate in Cinema Production from Los Angeles City College and a master's degree in fine arts in creative writing from Antioch University Los Angeles. She cites Percival Everett as one of her major influences. "What he writes is of particular interest to me, because in addition to being fun to read, he doesn't limit his writing to the so-called black experience as it's been defined in our culture. His characters have interests, proclivities and experiences beyond the narrow view that the mainstream promotes in its depiction of black life."

Dog rescued from jaws of boulders

Aslan, her faithful companion, literally got stuck trying to return to owner Sara Norris of San Marcos.

"It's not like him not to come back," she said.

On Thursday afternoon, Norris, who was staying at Thousand Trails in Pine Cove, called the emergency number at Animal Rescue Friends of Idyllwild for help finding Aslan. Norris continued her search, returning to the rocks, which she said she had circled several times before. Then she saw Aslan peering out between the boulders.

Robert Hewitt responded, and he and Norris discovered Aslan was trapped and stuck between two huge boulders. Fortunately, the dog's paws could touch the ground, but he was exhausted from his frightening situation.

"This was more than I could do alone," Hewitt said.

So he contacted the Cal Fire crews at Station 23 (Pine Cove). They responded and devised a technique to free Aslan. He was scared, but one of the firefighters held his head during the rescue ordeal, according to Norris.

They used hammers and chisels to carefully, stroke-by-stroke, create enough space for Aslan to finally be released. While chiseling, they covered the dog with a heavy safety blanket to ensure that he was not hurt from the rock's splinters.

Aslan was probably trapped for about four hours, but the extraction from his boulder jail took at least 90 minutes. "A lot of things went right," Hewitt acknowledged.

On Friday, Aslan and Norris were walking together again. "He's doing fine today, but not sure of the leash," she said happily.

Mobutta, mo betta...

Who doesn't love butter? I use butter in most of my cooking. If a recipe calls for olive oil, I will sometimes throw in a tbsp. or two of butter, just to give the additional melt-in-your-mouth taste to the recipe.

Slicing off a thin sliver of butter, letting it melt in my mouth — what a treat.

I am well aware of all the animal fat health issues, although reading the latest food trends, it seems butter isn't such a bad guy after all.

Over Memorial Day weekend, I made Italian cookies calling for 2 sticks of butter — one-half pound. The recipe made seven-dozen cookies, too many for just my fiancé and me. The Town Crier staff is benefiting from my baking.

The following recipe is my own and will generously serve about 6.

Roast Pork Loin With Apricots & Onions

Ingredients:

- 3 to 3-1/2 lbs. pork loin
- 2 tsps. salt
- 2 tsps. cracked pepper
- 2 med. sweet onions, cut in wedges
- 1 jar (16 oz.) apricot preserves
- 2 tbsps. Balsamic vinegar
- 4 cloves of garlic, slivered
- 2 tbsps. melted butter
- 1 tbsp. honey mustard
- 1 tbsp. brown sugar
- 1 tbsp. finely chopped thyme
- 1/4 cup water
- 4 fresh apricots, cut in quarters

Directions:

Preheat oven to 325 degrees. Rub salt and pepper over pork loin. Cut small slits and insert garlic slivers in pork loin, place in aluminum foil-lined baking dish. Add onion wedges. Set aside.

In a medium bowl whisk preserves, vinegar, melted butter, honey mustard, brown sugar, thyme and water. With a spoon, drizzle half the glaze on the pork loin, spreading with the back of the spoon.

Bake until juices run clear, about 1 hour and 40 minutes. After the first hour of cooking, drizzle remaining glaze on pork and spread with spoon.

Fifteen minutes before removing from oven, add apricot quarters to baking dish and brush with pan juices.

To serve, slice into 1-inch rounds, place on platter, one slice slightly over the other. Add onions and apricots to the platter, drizzle generously with pan juices, garnish with fresh thyme.

Note: The pork loin package I bought contained two pork loins in it. I made them both. In retrospect, I should have only made one and frozen the other, as there are only two of us in my family. Enjoy.

The best practice for verifying the identity of an employee of a government agency or public utility is to find the phone number of the agency by using a telephone directory or web site and call that number to verify the employee. You should not ask the employee what number to call. Make sure you are calling a published number for that agency.

Proximity to Hole Revisited

As explained in a recent interview, Steele says that "proximity to hole" is not a stat he follows closely in his own game because, as a long hitter, he would not rank well in that stat. Presumably, this is because on par 5s, long hitters often are hitting long approach shots

to reach in two, while short hitters lay up and hit short third shots for their approaches.

So we began keeping our own experimental stat we're calling "iron approach proximity" (IAP) as an effort to evaluate just how his irons are working. Of course, we cannot discern Steele's club selection by computer. So, after some trial and error, we've modified this stat a bit to include all of his approach shots that

are between 100 and 270 yards on all holes. In most cases, that should eliminate soft-wedge pitches at the one end and 3-woods at the other, but should still allow for full wedges and 2-iron approaches. Wind, weather and other intangibles inject uncertainty, of course, but this may be the best we can do in an attempt to isolate his iron approaches.

Thermographic scanning and gas discharge visualization: A different way to understand our bodies ...

As you probably already know, I am a proponent of being proactive instead of reactive with regards to health. While I usually take pride in how well I deal with setbacks, some recent ones have caused me to branch out and explore alternative scientific methods with this in mind.

During my initial research I came across a method known as thermography scanning. So, I made a trip to Psy-Tek Labs, a research facility in San Diego County, that uses what is called subtle energy testing, measurement and research.

Are you familiar with Kirlian photography? The well-known photograph of a leaf cut in half but still with an aura surrounding the "phantom" half should come to mind.

This is the same method being used here, except now it's applied to the human body. Dr. Konstantin Korotkov, a Russian physicist, was the first to combine Kirlian (auric) photography with the Korean Su Jok hand acupuncture system. This system traces all the organs of the body via energy pathways through the fingertips using what is known as Gas Discharge Visualization.

GDV shows the energy level in different areas and layers of the body allowing proper protocols to be developed in response to these changes.

"The GDV images the glow it produces around each fingertip and maps this 'aura' based on the Korean Su Jok System", said Jessica Luibrand, Psy-Tek's chief medical thermographer and subtle energy researcher.

"Thermography scans the body for inflammation and inflammation is well known and documented as the beginning of any degenerative disease. Scanning the body with these non-invasive devices allows a first glance so you can see indicators of disease before they manifest," she added.

As someone with experience with pharmaceuticals (and not a pleasant one) to deal with physical and emotional ailments, I am always on the search to try things that allow my body to do what it does best — heal.

Which is why when it comes to my body the more tools to gather information I have at my disposal the better.

As you also know, I am not a conspiracy theorist. I believe doctors care about their patients and want us to be healthy and avoid illness (as my previous column on vaccinations explained). But we are all different and what works for someone may not work for another.

The methods mentioned above are not considered to be diagnostic. According to the Food and Drug Administration, thermography should be used as an adjunctive assessment as it does not diagnose.

What is most important is to "educate and empower people and create relationships in the community with other holistically-minded practitioners to help assess the health of their patients non-invasively and to monitor changing physiology," Luibrand stressed.

Buzz Holmes continues an arts legacy

Dwight “Buzz” Holmes is part of a distinguished lineage in Idyllwild’s musical history, part of a legacy begun when his father, Robert Evans Holmes, began conducting the Festival Choir at Idyllwild School of Music and the Arts in 1957 and formed the Idyllwild Master Chorale in 1975. Holmes Amphitheatre at Idyllwild Arts, the successor to ISOMATA, is named after Robert Evans Holmes. And Buzz was connected to the seminal years of ISOMATA, singing in the Youth and Festival choirs at a time when legends Pete Seeger, Meredith Willson, Ansel Adams and Bella Lewitsky were on campus and Idyllwild was becoming the arts destination it is today.

Buzz was not only his father’s son but also his student. Bob Holmes was supervisor of music and director of choral groups at Beverly Hills High. Buzz studied under his father and sang with his father’s most elite group, the Beverly Hills High School Madrigal Singers, a group of 16 who toured internationally. “That time spanned a lot of different artists that would go on to work on Broadway and in movies and television, including Richard Dreyfuss, Alfred Brooks, Joanna Gleason, Rob Reiner and Carol White,” said Buzz. Dreyfuss later starred in “Mr. Holland’s Opus,” inspired, so Dreyfuss said, by his having studied under the elder Holmes. “It was such an amazing time, so much creative energy,” said Buzz of his years at BHHS.

Buzz graduated in 1967, moving on to the University of Southern California where he studied composition and theory under Morton Lauridsen, now recognized as one the greatest contemporary choral composers. He also studied counterpoint and orchestration privately with Lauridsen. Buzz described a first significant meeting with his wife Julie in one of Lauridsen’s music theory classes. “Julie was in the same class,” he remembered. “Over this 12-bar rest I asked her if she wanted to go to see Alice Cooper at the Whiskey.” She accepted.

While at USC, Buzz was lead singer in a rock group, “Generation,” in which Ray Brown Jr. played. He graduated in 1972 and before starting a teaching career, served as director for the first staged version of the rock opera “Tommy” by the English rock group The Who. “I had this interesting conversation with Roger Daltry about who should play Tommy in the movie,” said Buzz. “He kept suggesting people and I said, ‘Why don’t you play him?’ and he eventually did.”

Holmes began his teaching career in South Los Angeles. “It was an interesting time, he recalled. I had to learn to communicate and bring my students along. I learned so much from them.” Later, in another connection with his father, he taught at Hollywood High where his father had previously taught. In 1977, he returned to ISOMATA. “They wanted me to come up to help develop the Summer Program and coordinate student life,” he said. “I did a lot of recruiting for them in Southern California. Those years broadened my abilities to deal with challenging situations.”

Buzz began teaching music at Idyllwild School in 1995 and also serves as supervisor of music for Hemet Unified School District’s four high schools, four middle schools, three K-8 schools and 11 elementary schools. He assumed the mantle of conductor of the Idyllwild Master Chorale after his father’s retirement. The chorale is now celebrating its 40th anniversary and will

present its winter concert in the new Lowman Concert Hall on the Idyllwild Arts campus. He has served on the board of governors for Idyllwild Arts, continuing the Holmes legacy connection.

He will retire this year from teaching and is now dedicated to perpetuating Idyllwild’s reputation as an arts destination — both for performing and fine arts. “It’s important what we do to nurture arts in this town,” he stressed. “We need a coordinated arts strategy, a chamber of commerce for the arts that promotes Idyllwild as an arts destination,” said Holmes. “I think there is magic in this place. It’s what drew me here as a young kid. There’s talent here and we need both venues and programs to develop that talent.”

Candidates unsure about the local district offices for which they are eligible, based on residency, should contact the Registrar of Voters office for help. Candidates will receive informational handbooks when they obtain their papers.

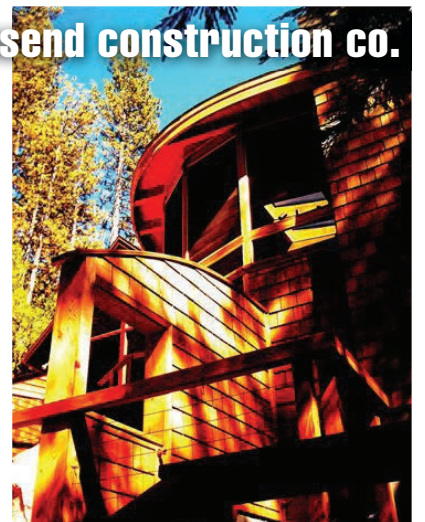

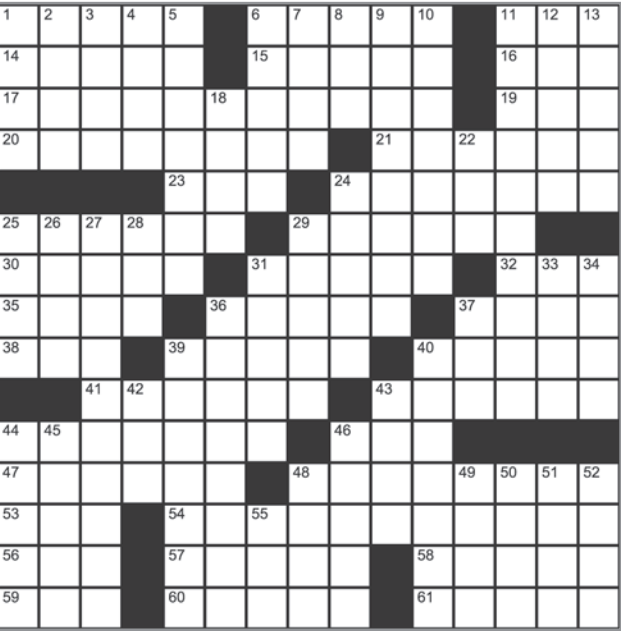

the agreement, we will forgive a portion of the loan," said Dan Newton of the SWRCB's Water Recycling Funding Program. "This is one of the best agreements we've made. It's thrilling."

The treatment facilities are additions to the district's current wastewater facility. And, nearly 10,000 feet of new pipeline will be installed to move the water back through the Tollgate area and to the county and state park areas for irrigation use where a new 50,000-gallon storage tank will be constructed.

"The project includes the installation and operation of a tertiary (being or relating to the purification of wastewater by removal of fine particles, nitrates

and phosphates) treatment system that complies with Title 22 standards for recycled water, installation and operation of a pump station and pipelines for water conveyance, and installation and operation of a recycled water storage tank," Lynch said. Then added, "Those that use this water for landscape irrigation will see reduced costs for water."

Wastewater will go through several filtration steps. "The solids will be discharged with the waste activated sludge to the existing solids treatment facility," Lynch stressed. "[Additional] disinfection of the recycled water will be accomplished with ultraviolet light."

"Tertiary treatment is good thing. Idyllwild is a very environmentally oriented community," said

Director John Cook. "To the extent this offsets the use of potable water use, it's to our advantage."

Construction could begin next spring, Lynch said. And Newton confirmed, "The SWRCB is ready to distribute the funds [once paperwork is completed]. We can disburse soft costs immediately."

"The agreement with the state will allow us an ability to recoup costs expended to date for preparing various special studies and preliminary design costs," Lynch told the board.

IWD is still awaiting

word from the U.S. Department of Agriculture about several other grant requests to help with other infrastructure projects, according to Lynch. He also announced that replacing the effluent lines at the wastewater facility began last month.

In water business, IWD remains in Stage 2 Water Emergency. "Good storms have come though and helped our water levels [at] downtown [wells] and at Foster Lake," Lynch said. "The recent storms really helped us."

Through April, IWD

has produced 23.8 million gallons of water compared to 23.2 million in 2014, a 2.5 percent increase. For the same period in 2013, its production was 27.3 million gallons.

Although water sales for April were below original estimates, the water program still had a net income of \$16,000.

During the meeting, the board also held a public hearing on the proposed stand-by rates of \$30 per acre for vacant lots in the water or sewer district. There is no change in the rate and nobody testified

in opposition of the rate, which the board unanimously approved.

A proposed 2015-16 budget was not on the agenda and Lynch requested that the Finance Committee meet to review and discuss it prior to the June meeting.

"The board will likely adopt it at that June 17 meeting unless special meetings are called," Lynch replied to a question about the budget adoption by June 30.

Whether this project or others influenced Petty's decision is unknown.
