



# Bonfire near **Idyllwild Arts** fuels fire threats

Chief Patrick Reitz, Idyllwild Fire Protection District, confirmed his department responded to reports of a bonfire in Alvin Meadows in back of the Idyllwild Arts campus. Reitz noted a response time of 10:30 pm. Saturday, Aug. 15, the first night of the annual Jazz in the Pines festival on the IA campus — a time when the town is packed with tourists.

Reitz confirmed the fire was allegedly started by local youths, but noted none were around when IFPD arrived and the fire had already been extinguished. Nonetheless, with fire danger at maximum threat levels, the danger of a major calamity during a time when the town is full was very real.

Michael McDonald, an employee at the campus dining hall, called 911 to report the fire. McDonald identified three participants by name, none of them minors, and stated that the fire site was a regular party spot for a small group of Idyllwild locals.

IAF administration and the U.S. Forest Service, on whose land the bonfire site was discovered by firefighters, did not respond to inquiries before press time.

Names of the three young men identified by McDon- this summer, the State Water Resourcald are being withheld until law enforcement identifica-

In one further threat to the town and forest, residents on the turn-out on Highway 243 leading out of Idyllwild, near the Banana Belt, reported squatters on the large acreage plot for sale on the downhill side of the highway. Resident Penelope Smrz called the Riverside County Sheriff's Department, Hemet Station, to warn of at least two tents that had been there for some time and of the danger of squatter campfires.

Deputy Jason Green responded to the property location, 40-plus acres owned by Charlene Lane. Smrz showed Green dozens of large garbage bags filled with ic drought," said SWRCB Chair Feli-

# Requires lower flow for shower heads

To help Californians save more water es Control Board, the California Department of Technology and Save Our Water announced the launch of SaveWater. CA.Gov (no www. in front). The new mobile-optimized website will allow residents to report suspected leaks and water waste anywhere in the state from their smartphones, tablets or computers.

"Everyone needs to save water, and this is one effective way alert residents can help everyone - and every community - save water during this histor-See Bonfire, page 7 cia Marcus in the press release. "Every drop saved — and every suspected leak or water waste reported and corrected — will help stretch the state's limited water supply, because we don't know if next year will be a fifth year of drought."

Many local water agencies have their own methods for reporting water waste, whether by email, phone or online app. SaveWater.CA.Gov is a tool for Californians to help their communities and state save water and assist those water suppliers who may not have the resources to build their own online reporting system.

The site is available statewide and complements local efforts by providing an easy-to-use tool that directly reports water waste to the proper authority, anywhere in California. Through SaveWater.CA.Gov, users may report and send



# Anza Fire contained Saturday Fire burns 2 acres on

# 543 acres burned

The Anza Fire, which started Monday, Aug. 10, was fully contained, Saturday, Aug. 15. The fire, which was actually in the Piñyon area, burned a total of 543 acres over the five days.

It started when a motor home caught fire and pulled to the side of Highway 74. The initial response to the fire required the closure of the highway Monday afternoon, but it was re-opened in both directions by Tuesday afternoon.

During the fire's duration, 353 firefighters were involved in battling it. This included five helicopters and seven air tankers. Units from Cal Fire, the U.S. Forest Service and various Riverside County fire departments participated in the effort.

The Red Cross established an evacuation center at Hamilton High School Monday afternoon. Since most residents sheltered in place, according to Riverside County Fire, the evacuation orders were lifted Tuesday morning, Aug. 11.

That day, the South Coast Air Quality Management Division issued a smoke advisory for portions of Riverside and San Bernardino counties due to the smoke drift that day. These were considered unhealthful levels due to significant amounts of smoke.

Four people suffered injuries from the fire. The driver of the mobile home suffered first and second degree burns on his right arm. Three firefighters suffered minor injuries. After transport to local hospitals, they were released and cleared to return to work on Wednesday, Aug. 12.

# Toro Peak

A 2-acre fire started near Toro Peak Monday afternoon, Aug. 17. As of Tuesday morning, the fire was 90 percent contained and full containment was expected by Tuesday evening.

To prevent the fire's spread, more than 130 firefighters were committed, including two helicopters and four air tankers. Units from Riverside, San Bernardino and San Diego counties were involved.

The first engine on the scene "reported a quarter-acre of light fuels, with moderate rate of spread," according to the Riverside County Fire Department.

Cause of the fire is unknown.

# Epperly charges reduced to misdemeanor, but still owes restitution

Karen Epperly appeared in court Monday, Aug. 3. Pursuant to her agreement with the Riverside County District Attorney's Office, she began paying fines, penalties and restitution for her embezzlement.

Epperly, 50, Idyllwild, pleaded guilty to embezzlement on July 21. Sentencing was scheduled for Aug. 3. She was initially charged in December 2013.

With the District Attor-

ney's concurrence, Judge Judith Clark granted Epperly five years of probation and reduced the charges on her two counts from felonies to misdemeanors.

The court order also requires her to re-pay more than \$56,000 to Richard and Karen Greenwood, owners of Community Lumber, from whom embezzled nearly \$100,000. Some of the monies have already been repaid. Interest on the balance accrues at 10 percent, according to the court.



# A strong El Niño is lurking in the future

# May be very wet fall and winter

A fourth year of drought may be interrupted this fall and winter. The National Weather Service is forecasting "a significant and strengthening El Niño." But while relief is expected, the water deficits of the last four years will not be overcome with one extremely wet winter.

On Aug. 13, NWS predicted a 90 percent chance this El Niño will continue through the winter and even an 85 percent chance that its effects will continue into spring 2016, which is 5 percent greater than the previous forecast.

While conditions could still change, several forecasters say the strength will depend on the fall tradewinds. Nevertheless, the latest NWS Climate Prediction Center reported, "all multi-model averages predict a strong event at its peak in late fall/early winter."

'It's still too early to say exactly how El Niño will influence California's upcoming winter, though it still appears that there's a significantly increased chance of a wetter-than-average winter," said Daniel Swain, a Ph.D. candidate in the Department of Earth System Science at Stanford University.

This El Niño is already being labeled as a "Bruce Lee" or "Godzilla" event, but it will still be months before its weather results are known. However, as of early August, the ocean measurements appear to be similar to the summer of 1997, which brought the last great wet winter to Southern California.

That year, the Idyllwild Fire Station recorded more than 30 inches of rain from November through February and more than 30 inches of snowfall.

Of shorter-term interest: Extremely warm nearshore, sea-surface temperatures off the Mexican and California coasts will continue to present an increased potential for East Pacific tropical remnant events through September and possibly October," Swain add-

# Wildfire preparedness at maximum level

The National Fire Preparedness Level has been raised to its highest point 5. On Thursday morning, Aug. 13, the National Multi-Agency Coordinating Group, which consists of top federal and state fire managers, raised the preparedness level to 5 (PL-5).

They were concerned about the high degree of wildfire activity nationwide and the probability that severe conditions will continue for at least a few days. There has been a major commitment of fire re-

"A significant amount

of initial and extended attack and large-fire activity has occurred over the past several days as a result of lightning storms that have intensified local and geographic response," said Aitor Bidaburu, chair of NMAC. "Given the continuing hot and dry weather and the increase in fire activity in the western U.S., the decision to move to Preparedness Level 5 depicts the complexity that fire managers are encountering to assure that adequate firefighting resources are available for protection of life, property and our nation's natural resources."

Wildfire activity esca-

lated last week after thunderstorms, many with little or no moisture, moved across parts of California, Oregon, Washington, Idaho and Montana, sparking hundreds of new fires.

Through Monday, Aug. 17, 40,509 wildfires have burned nearly 7 million acres in the U.S. this year. The number of wildfires in 2015 represents about 82 percent of the 10-year average, and nearly 3,750 more fires than during the same period in 2014. The number of acres burned this year represents about a 45-percent increase over the 10-year average at this point in the year and more than 2.5 times the acreage burned during the same period last year.

The last time the NPL was raised to 5 was on Aug. 20, 2013. The NPL remained at 5 for seven days until it was dropped to 4 on Aug. 26, 2013. This is the fifth time that PL-5 has been reached in the last 10

During PL-5, further assistance from the military, beyond what is already in use, and international resources may be considered and requested, but no decisions have been made concerning those

# Second grant this year

Riverside County 3rd District Supervisor Chuck Washington granted the local Forest Folk \$2,500 for their shuttle bus service program.

These are Community Improvement Designation funds and will be used to pay drivers and purchase gasoline for the shuttle service.

Earlier this year, Forest Folk received a \$157,000, three-year grant from the Riverside County Transportation Commission to initiate the shuttle service.

Last week, the Town Crier reported that Reba Coulter of Forest Folk said the group envisions a fixedroute system, with designated pick-up points in the Idvllwild and Pine Cove areas.

We're thinking, based on demand, perhaps three days a week, maybe Monday, Wednesday and Friday," she said. "We'll accommodate those who might not be able to get to the designated pick-up points, especially those who are older or disabled.

"We know there's a need, we just don't yet know how much of a need."

Coulter said the group already has a scheduler/dispatcher and a phone number dedicated to van transport -951-292-UĤOP (8467).

The recycled water will be used for landscape irrigation and other non-potable uses, and will be offered at a discounted price, which will benefit customers of both recycled water users and potable water users by maintaining and supplementing potable water supplies.
- The District's solar project has reduced the S.C.E. electric costs of the District by a substantial amount every year, over the past 10 plus years, thus saving costs that would otherwise be passed on to customers.
- Mr. Kunkle has asked to see over 15 years of District records. (A strange request for an employee of the District for over 28 years.) # Sky Islands

. . .


Greetings from the sky island of Machu Picchu, Peru. I write this as we return to Cusco after a heady day at the famous Inca ruins. As we took the train in the morning to Machu Picchu, the spectacular mountain views reminded me of our mountain home in Idyllwild. Though the steepness of the slopes and the vegetation differ between the two, the similarity is that they are both sky islands.

I know we toss that term around a lot in Idyllwild but I think it is good to consider what it really means to us — to plants and animals that live there. Like real islands surrounded by water, sky islands are surrounded by low-elevation flatlands. Also like real

islands, sky islands have their own unique assembly of plants and animals, determined by their size, their altitude and the distance they are from other mountainous islands. And like real islands, the size, altitude and distance vary tremendously.

About 20 percent of the Earth's land surface is classified as mountainous. However, most of that is the lower elevations, less than 3,000 feet above sea level. As we go up slope, the amount of landmass decreases rapidly. The San Jacintos, for example, cover more than 300 square miles but only a small portion of the range towers above 6,000 feet.

And the higher one goes, the smaller, more isolated and more unique the sky islands become. This struck home to me, looking at the towering peaks surrounding Machu Picchu. Plants and many animals separated by only a few 100 yards can be totally isolated from each

other for hundreds if not thousands of years. Each small isolated population, living under the specific combinations of environmental conditions on their peak, can drift apart becoming even more unique, adding to the diversity these sky islands.

But apart from the unique assemblages of nature, mountains have also played important roles as refuges from human encroachment. Unlike flatter areas that are easily altered for human needs, mountains often defy humans and their wishes.

Their climate, their steepness makes mountains hard to "tame." So more than islands surrounded by flat, they are refuges in a sea of humanity.

In the conquest of the West, many flatland species of wildlife found refuge in the higher and steeper mountains. It is in the mountains where large expanses of native vegetation can still be found. Even people, pursued by other humans, have found refuge in these sky islands, oftentimes developing unique cultures, for example the Basque of the Pyrenees, the Swiss of

the Alps — Idyllwilders of the San Jacintos.

All these factors, uniqueness of conditions, inaccessibility, isolation and refuges makes sky islands, be they the San Jacintos or the Peruvian Andes, indeed distinctive and, as we know, very special places to live. But wait, there is more.

In the next installment on sky islands, we will explore how mountains not only create their own special environment but how they can have continental consequences on the surrounding flatlands extending for thousands of miles.

# Free/reduced-price school lunches

Dottie and Grace have coffee together every morning after their husbands go to work and they get the kids off to school. They are neighbors and have been faithful to this ritual for the past five years. It's their way of managing their oftentimes mundane lives.

One morning, Grace was a no-show — no phone call, no heads up — just a no-show. Concerned, Dottie gave Grace a call. It was out of character for Grace to break their routine without any notice. There was no answer.

Dottie decided to walk down a couple of doors and check on her friend. After a few knocks, Grace responded through the closed door. She said she was feeling under the weather and promised to give Dottie a call in few days when she was feeling better. Dottie returned home and went about her day.

What Dottie didn't know was that Grace was in bad shape. Her husband, Bob, tied one on the night before and took his frustrations out on his defenseless wife. It wasn't the first time this had happened, but with the exception of her kids, no one in the neighborhood knew the humiliating hell Grace endured.

# Pine Cove directors consider taking Live Scan

# Decision in September

Diana "De" Eskew is the new vice president of the Pine Cove Water District Board of Directors. She was elected unanimously at the Aug. 12 meeting. Robert Hewitt, former vice president, was chosen president at the July meeting, following the resignation of former President Michael

Following the filling of its officer positions, the board held a long discussion on whether to recommend that directors submit to a Live Scan, which is an inkless, electronic means of capturing fingerprints in a digitized for-

The Live Scan operator checks the applicant's identification, inputs the applicant's personal descriptor information, captures the applicant's finelectronically gerprints and transmits the data to the California Department of Justice. Once the transaction is received by the DOJ, the fingerprint images are used to automatically search against all other fingerprint images in the fingerprint data-

Further discussion, including how to pay for the scan, was deferred to the September meeting. In general, board members endorsed the concept but differed on its application and who pays for it.

We have nothing to hide. We are representing the public and can demonstrate we have no past that would compromise our representation," Hewitt said, introducing the idea.

The newest board member, Tim Lange, said, 'It's a great idea. I'm for anything that supports transparency.'

After Hewitt said the board could not require directors to subject themselves to the investigation, also were lower this year new directors in the future would simply be subject to peer pressure to take the Live Scan.

Eskew made a motion recommending "Live Scan for all board members with the exception of how to pay for it." Then Direc-tor Lou Padula objected, "I don't think we need Live Scan for everybody, just [future] new members. Anybody new should get it done."

Director Joel Palmer withdrew his second of the motion for the same reason, "It should be mandatory. If optional. I withdraw.

Both Hewitt and General Manager Jerry Holdber stressed that having a Live Scan could not be made a mandatory condition for being a director.

Padula also had a second problem with the specifics of implementing the idea. He was opposed to requiring directors to donate the cost of their scan.

Marge Muir, a Pine Cove Realtor attending the meeting, noted that individuals may have criminal records for youthful indiscretions or may have served a sentence for whatever crime had been convicted. These issues have been settled, she said.

Hewitt, recognizing that no consensus or majority was going to form during this discussion, asked to table the item to the September meeting.

In water business, Holldber reported that July production was 2.9 million gallons, 20 percent less than the July 2014 production.

While the district's production since January is about 4 percent less than the same period last year, production for the past 12 months is about 1 percent more than the prior 12 months.

When asked if customer conservation had contributed to the reduced consumption, Holldber concurred. He noted that for the May-June billing period, actual water sales

despite the recent rate increases.

"Demand is down because of the people's efforts. We sold less water this year," he told the

Going forward, Holldber is optimistic that the recently completed leak detection program also will show an improvement. Thirteen leaks were identified and repaired, characterized 'seepers," but some were more substantial.

"Maybe we found a total of 10 gallons per minute. Most of the repairs were near the end of the month, a week before reading the meters," he said. "Hopefully, we'll see a difference in October and a reduction in the unaccounted-for water."

While the drought is four years old, Holldber reported that the district wells continue to be in very good condition. The district's static well has fallen only 1 foot since May, he said, "It's holding up very well compared to

In addition, the output of several wells was greater last month than in July 2014. He attributed this to the May and July rains.

past droughts."

After hearing about the status of the wells and production, Ian Tober, Pine Cove customer, said, We've had no problem supplying water in the district during droughts. And there are probably few lots that can be developed, so water use is unlikely to grow much. It appears to me the district overall and into the future is in a great position."

# **Supervisors** approve IFPD tax advance request

The Riverside County Board of Supervisors has approved the request from the Idyllwild Fire Protection District for an advance of its property tax revenue.

IFPD requested an advance of \$350,000 from the county in June. The advance will be repaid, with interest, in December and January when Riverside County makes its first allocation of property tax receipts to the cities and special districts.

From July through the middle of December, IFPD's cash flow is limited to ambulance collections because it receives no property tax or assessments during that period.

The commission's \$350,000 request is a \$50,000 increase from last year. This is the first request for a larger advance in the five years since IFPD has been using this process. Until 2014, it had requested at least a \$400,000 advance

The California Constitution and Government Code have provisions allowing the county to temporarily advance and transfer funds to special districts. The limit is 85 percent of the anticipated revenues for the current fiscal year.



# Film, TV composer Peter Davison finds the perfect studio — Idyllwild

Award-winning film and television composer and orchestrator Peter Davison built a major career in Los Angeles until he found the perfect studio in which to work—Idyllwild.

"My music is changing," said Davison. "Here there are so few distractions. Moving full-time to Idyllwild is the best thing we ever did. Living here has made me more of who I really am."

He and the career he built in Hollywood before moving full-time to Idyllwild are impressive: original music for more than 500 episodes of multiple TV series for which he owns music rights, and scores for major indie features and shorts. Davison has composed musical scores for the History Channel, Bravo, Biography, A&E, PBS, Discovery Warner Brothers, Disney, Universal, MTV and CBS.

And as the industry began to change, commissioning fewer original scores and using more "library music," Davison changed with it. He began writing cues and custom scores for Jingle Punx (www.jinglepunx. com), currently the foremost music content management service, making original downloadable music available for "any style, any mood and for any project." Jingle Punx claims to provide "content searchable" music, "the perfect track and the best licensed music out there." For Davison, it proved to be a beneficial transition. "I can sit down and write any kind of music theme or style I'm thinking or feeling — atmospheric, romantic, comedy, horror, mysterious and so on and eventually it will be used."

Stars align, doors open and new directions become apparent. Davison

scribed the synchronistic pull Idyllwild has long had over his life, a subtle force incrementally drawing him closer to living full-time on the Hill. It all began with an

"In 1978, I auditioned in Los Angeles to be the accompanist for the Bella Lewitzky dance company for a summer session at ISO-MATA [Idvllwild School of Music and the Arts, precursor to the Idyllwild Arts Academy and Summer Program]. Davison had attended California State University, Northridge, where he had received both bachelor's and master's degrees in music composition. He got the Lewitzky gig and was assigned to a class taught by Lewitzky company member Iris Pell. Being assigned to Pell's class and living near her during that Idyllwild summer proved fortuitous. Not long after, Pell and Davison married. "We were living in Santa Monica and started coming back to Idyllwild regularly, in the spring and in the winter," said Davison. "In 1999, we noticed an ad in the Town Crier for a house. We saw the house and made an offer that same day. It became our vacation home."

On Aug. 17, 2011, Davison and Iris moved full-time to Idyllwild. He built his home studio and sound-conditioned it so he could work

any time of day and not disturb neighbors. His musical to change as he was drawn to the peace and tranquility of Idyllwild's outdoors — its streams, its trails, its night sky, its canyons and its crit-

Davison's music, whether CDs of his own compositions ("Music from the Heart of the Forest," "Galileo's Telescope," "Forest Home,""Release" and "Take Me Back to Eden") or commissioned music for meditation and massage, began more and more to reflect his mountain home. Davison is currently composing for At Peace Media, one of the largest library sources for

massage therapist music.

"Since 1980, my day job interests and muses began has been writing music," said Davison. "I kept asking the universe to let me write music full-time. The answer was, "OK, but you have to work really hard."

At his Idyllwild studio, Davison has a wall of CDs, all his, evidence that he has worked diligently and kept his part of the bargain. He has worked very hard. Now, living in Idyllwild, Davison says it's as good as it could possibly be.

"Here I'm just in the moment and fully present," he said. "Idyllwild has a very natural, spiritual non-denominational vibe. People here aren't always trying to get something from you. I don't have so many desires - to have things. I can just write my music and be part of this town. I feel accepted

Davison's CDs "Meditate" and "Exhale" both made Billboard's Top 10 New Age albums. His instrumental "Sip of Wine" (from his CD "Future, Present, Past") received Best Song of the Year at the Hollywood Music in Media Awards. His score for the PBS series "The Endless Voyage" was nominated for "Best Score of the Year, TV Show.'

# Idyllwild Haunted Ghost Town moves to Town Hall

With details still to be resolved, it appears Kathy Sacher Wilson's popular Idyllwild Haunted Ghost Town will move to Town Hall for its 12th year.

Wilson confirmed an agreement in principle with Riverside County Regional Parks and Open Space District. The month-long event, from Friday, Oct. 9. through Halloween night, Saturday, Oct. 31, would feature a live-action and animatronics walk-through Haunted Ghost Town spook fest, a Haunted Hayride and Zombie Run.

According to Wilson, the Ghost Town would be built behind Town Hall, the Haunted Hayride would take place at the Nature Center, with shuttle rides from and to Town Hall, and a Zombie Run would take deathly detours throughout town, exact routes to be determined.

Wilson said all ticket proceeds would go to Town Hall recreation, earmarked to fund sports scholarships for area kids and teens. In the past, Wilson's events have netted from \$4,000 to \$8,000 annually, an amount she noted could make sports participation in Town Hall programs possible for a large number of Idyllwild youth. "This will fund a lot of scholarships and help support Town Hall sports programs, with T-shirt purchases and other related expenses," said Wilson.

"My focus [with the Halloween event] is to get local youth and young adults out of the house, away from computer screens and video games and outdoors where they can breathe some good, healthy mountain air," she related. "I also want to introduce my cast and crew of 75 to 100 locals to community volunteerism." Wilson's volunteers perform many functions before, during and after the event — building sets, constructing costumes, coordinating special effects, helping with ghostly and ghoul-

ish makeup, and performing as live actors determined to earn a screech or two from guests.

Wilson said the walk-through ghost town would be newly built, with new lumber and many new effects. Local contractor and actor Jacob Teel has volunteered to coordinate construction. Wilson said the county would also provide some logistical and construction support.

"We'll have a community barn-raising on Saturday, Sept. 12, from 9 a.m. to 5 p.m. to get the basic structure built," said Wilson. "We'll feed volunteers with a lunch barbecue."

# Steele scores T12 at PGA Championship

In his highest finish ever in a PGA major, Brendan Steele posted a 10-under-par 69-69-73-67 — 278 to tie for 12th place in last week's PGA Championship at the Whistling Straits course in Kohler, Wisconsin. His top-16 finish guarantees him a place in the 2016 PGA Championship. His previous major-tournament best was 19th in the PGA in 2011, his rookie season.

For the tournament, the Idyllwild native posted an eagle and 13 birdies against only three bogeys and a double. He tied for fifth in driving accuracy at 73.21 percent and he was sixth in strokes gained, tee-to-green at 9.623.

He gained 1.822 strokes putting against the field and required only 1.667 putts per green.

Brendan now has 895 FedExCup points and is 45th on that list. He is ranked the 78th-best player in the world in the Official World Golf Ranking, his highest ranking ever.

Brendan has a new caddie. He and Bobby Brown parted ways while in Europe this season, and Christian Donald is now on B's bag. Christian, a fine player in his own right, knows Brendan's game and the courses, having formerly caddied for Martin Kaymer, Paul Casey and his own brother, Luke Donald.

According to Kent Steele, Brendan's father, who spent time with the two of them during the recent Bar-

racuda Championship in Reno, Christian is the perfect caddie for B right now. "He keeps him in the moment," commented Kent.

Perhaps most impressive is that with Christian on the bag, Brendan was able to carry over his quality of play from the Barracuda, a PGA secondary tournament, into a PGA major the following week.

Christian currently resides in Dubai, but Kent says he likely will move to the states, as he and Brendan are expected to be together for the foreseeable future.

Brendan has this week off, but next week he will play in The Barclays, the first of the season-ending four playoff tournaments in the race for the FedExCup.

# 22nd Jazz in the Pines continues string of successes

# The air was hot and so was the music

Memories — fond, good, great and loving — are all that remain of the 22nd-annual Jazz in the Pines. Once again, the Hill has been graced with rhythm, mirth, blues and improvisation of beautiful jazz music.

The festival's popularity continues to attract thousands to Idyllwild for the two special days and to depend on the devotion of hundreds of residents to provide the hospitality that makes the jazz fest the equivalent of "Brigadoon."

Saturday morning, Bert McCarty of Lake Forest, and his friends Diane McVey and Bob Skaug of Pine Cove were at the front of the line waiting for the gates to open.

Typical of the attendees who arrive early, they were not attending their first jazz fest. And they knew the wait was worth it to secure good seating in the Holmes Amphi-

But more than the audience enjoyed the festival and loved coming back, despite the 90-degree temperatures Saturday. Ron Bocian, snare drummer with Euphoria Brass Band, said he loves playing in Idyllwild. So much so, the band has marched in on Idyllwild's Fourth of July

This is the band's third year at Jazz in Pines. Not only did it march and escort the first attendees into the festival area, Euphoria opened the entertainment in the French Quarter Saturday morning and closed the day on the Holmes Amphitheatre stage.

The IA network and a strong bond with Hawkins keeps Christopher and others committed to sharing this music. "We feel Marshall's teachings so strongly. We stepped into the role [of mentors and leaders] the minute there were musicians younger than us on stage," he said.

The IA network of professional musicians filled the headliner spots on both days. On Saturday, jazz guitarist Graham Dechter (class of 2004) and his quartet filled the Amphitheatrre and on Sunday, Casey Abrams (2009), with Haley Reinhart, thrilled fans.

Dechter has performed on the main stage several times since leaving the school, but this year he was a headliner. "It was a really amazing experience ... it felt very much like coming home," he said.

Similar to many of the other jazz graduates, Dechter is a teacher and leader for the next generation. "The position of teaching and mentoring younger jazz musicians is very gratifying," he said and added, "I only teach what I know and what I know is the learning curve as a performer. I have to be as authentic and honest as possible."


And he also acknowledges his lessons from Hawkins. "My goal is to get better, to keep learning. No matter how







# West Nile virus cases reported in county

In the past week, Riverside County health officials have confirmed three cases of West Nile virus this year.

The first two are a 37-year-old man and 53-year-old woman, according to Dr. Cameron Kaiser, public health officer. The individuals live in western Riverside County.

Both patients were hospitalized but are expected to

The third case is a Thermal resident This is the Coachella Valley's first human case of West Nile infection this year.

The Coachella Valley Mosquito and Vector Control District planned to be in the Thermal area to set more traps, increase lar-

mosquito breeding sources, and carry out larval and adult control as necessary in an effort to reduce the number of mosquitoes and interrupt further transmission of the virus.

The virus is transmitted to humans and animals through a mosquito bite. Mosquitoes become infected when they feed on infected birds Health officials emphasized that the risk of serious illness to humans is low. Most individuals infected with the virus will not experience any illness. Elderly individuals and those with compromised immune systems are at greatest risk for serious illness.

"While West Nile is rare-

val surveillance to identify ly life-threatening, it can be occasionally serious," Kaiser said.

A comprehensive surveillance program to monitor the virus in Riverside County has been established by DEH's Vector Control Program. However, a public vote to approve a property assessment to continue to fund the program was defeated in June.

The Board of Supervisors may consider its future during the Aug. 18 meeting.

# Some ways to protect yourself

Avoid spending time outside when mosquitoes are most active, especially at dawn and dusk, and wear long pants, longsleeved shirts and other protective clothing outside.

Apply EPA-registered insect repellent that contains DEET.

Make sure doors and windows have tight-fitting screens. Repair or replace screens that have tears or holes.

Eliminate all sources of standing water on your property, such as old tires, buckets, flower pots and toys that can support mosquito breeding.

# County establishes new emergency health services department

In a lightly attended Mountain Emergency Services Committee meeting, Kathleen Henderson, Riverside County emergency services coordinator for the mountain, described the new Emergency Management Department, which the Board of Supervisors established in May and was effective July 1.

EMD will be composed of two Public Health agencies -the Emergency Preparedand the Emergency Medical Services Agency — and the Office of Emergency Services from the county Fire Department.

"All of these deal with preparedness and emergency responses to some is extent," Henderson said, explaining why they were merged into one. "I don't expect any change to our delivery of service," she stressed. "OES operations haven't changed.

pictures of leaks or water waste. Users can select the type of water waste from a list of common problems, type in the address where the potential waste is occurring and click send.

Anonymous reports are transmitted directly to the water agency serving the geographic area where the report is made. Users don't need to know the name of the local water agency. SaveWater.CA.Gov The site does it for them.

Marcus said, "Since the State Water Board passed emergency water conservations regulations in July 2014, hundreds of state residents have emailed us and called asking what they can do to report suspected water waste."

SaveWater.CA.Gov is the product of a partnership between the SWRCB and the Department of Technology's Office of the State Geographic Information Officer.

Reporting water waste is only one of the many ways residents can save water. To learn more easy ways to conserve, visit Save Our Water.

# Showerheads

Besides offering opportunities to report water waste, the state took other actions last week. On Aug. 12, the California Energy Commission approved new standards for showerheads, expected to save more than 2.4 billion gal-

lons of water in the first year and 38 billion gallons after full stock turnover in 10 years.

The current California showerhead standard is 2.5 gallons per minute. CalGreen code, the California Plumbing Code and the voluntary WaterSense specification are all 2.0

The standards adopted Aug. 12 require that all showerheads not exceed 2.0 gpm maximum flow rate. This applies to fixed and handheld showerheads, as well as horizontal body sprayers manufactured on or after July 1, 2016.

To increase water savings over time, the standard for showerheads will change to 1.8 gpm maximum flow rate starting July 1, 2018, making this the most stringent standard in the country.

In April, the Energy Commission adopted a standard of 1.2 gpm flow rate for residential lavatory faucets, among other water appliances, that would have taken effect Jan. 1, 2016. Commissioners voted to change the current standard of 2.2 gpm flow rate to 1.5, effective Sept. 1.

The Energy Commission also voted to implement the 1.2 gpm flow rate on July 1, 2016. The changes are in response to manufacturers who said they would not be able to supply retailers with enough 1.2 gpm lavatory faucets on Jan. 1, but have 1.5 gpm models available today.







Counties across California, including Riverside, could have problems issuing birth, death and marriage certificates because a paper manufacturer recently went out of business. Riverside County is working to solve supply questions before its existing stock runs out around the end of the year.

"We are addressing the issue and hope to have a solution very soon," said Riverside County Assessor-County Clerk-Recorder Peter Aldana. "Our office will continue to provide certificates to all of our custom-

California requires counties to print certificates using intaglio printing to pre-

vent fraud. Very few companies worldwide use intaglio printing and the sole supplier of the required security paper to all California counties closed its doors in July, leaving most with a short supply. In intaglio printing, ink is transferred from a design cut, scratched or etched below the surface of a printing plate rather than from a raised design.

Even if the requirement for intaglio printing were removed to make paper stock more readily available, measures that include fluorescent fibers and consecutive numbering combined with matching barcodes would help keep the process secure.

The Assessor-County Clerk-Recorder's office issues about 350 to 400 certificates a day with mostly same-day service. Requests for certificates also can be made to the California Department of Public Health, which says orders can be filled in about seven days.

County officials, however, said they hope to continue providing residents with the fast, local service they are accustomed to receiving from the county, Aldana said.

# Superior Court enhances customer service

Last week, the Riverside County Superior Court announced several new systems to make obtaining court services easier and more convenient for the public.

# Public kiosk enhancement

Court customers now have the ability to make a criminal payment at the public kiosks stationed in the court's clerical offices. This enhances a system that previously took only traffic payments. The service is free and is provided as a convenience so customers don't have to wait in line at the public counters.

# Public queuing system

A new public queuing system will now be used in some of the busier and more crowded clerical offices of the court. The system is similar to that used by many DMV offices.

Upon entering the lobby, the customer signs in using a public kiosk. A ticket is issued using a sequential numbering system according to the assistance needed. Instead of the customer standing in a long line, they will now be able to sit and wait until their number is called. An announcement notifies the person to proceed to an assigned window. As the numbers are called the information is also displayed on three different monitors located throughout the waiting area.

Court staff will have information available on the number of customers waiting for assistance and they can call a new customer to their window as soon as they've finished assisting the previous customer.

The new system has been implemented in the Moreno Valley Court and the Southwest Justice Center. It will provide a more convenient environment for the public, reduce congestion in crowded lobbies and allow customers to be helped quicker.

# New juror reporting capabilities

The court's juror reporting automated system has been updated to include several new features that include using text messaging to provide jurors with reporting instructions and reminders, as well as automated phone calls to jurors with important information about their jury service.


