## Wildfires burn up Forest Service budgets, too

Not only has the horrendous fire season burned thousands of acres, destroyed homes and taken lives, but the cost of fighting these disasters is devastating the U.S. Forest Service's budget resources.

"We are expending in excess of \$150 million per week on fire suppression activities," said secretary of Agriculture Tom Vilsack, on Sept. 11. "And that will grow in the days and weeks ahead."

The cost of wildfire suppression reached a record \$243 million in a one-week period during the height of suppression activity in late August, according to the Forest Service.

On Aug. 25, Forest Service Director Tom Tidwell

## MC Market burglary suspects arrested

The two men arrested for breaking into the Mountain Center Market and stealing the ATM machine and its cash contents were Ryan Mason, 24, of Hemet, and Nickolas Melendez, 26, of Cabazon.

The two men were arrested on Highway 74, just west of the U.S. Forest Service's Cranston Ranger Station, shortly after they allegedly ransacked the ATM to get the cash.

Later, the investigation identified possible links between this break-in and a string of ATM thefts in San Bernardino County.

Both men were arrested in a coordinated effort with the San Bernardino Sheriff's De-

partment for burglary. The District Attorney's Office later filed, against both men, two charges of burglary and two charges of grand theft of more than \$400,000.

Both suspects have been released on bail. Mason's arraignment is scheduled for Nov. 9 and Melendez has one scheduled for Nov. 10

The break-in occurred during the early morning hours of Monday, Sept. 14, and the security cameras owner Shane Stewart has in all of his business locations were instrumental in the arrest. Apparently, the thieves took the ATM to McGaugh Road, where they broke into it and took the cash. The machine was found there.

The market remained open Monday, Sept. 14, and the ATM machine was replaced that afternoon, according to Stewart.

# Idyllwild Water creates reserve funds

## Announces grant money

Financial matters, including a grant receipt and new financial management policies, dominated the Idyllwild Water District's Sept. 16 board meeting. Following up on recommendations from their auditor and Budget Committee, directors approved two important financial policies.

With little discussion, the board approved both a policy to establish several reserve funds and how those monies may be used, and a policy governing fixed assets.

The reserve-fund policy establishes six categories of reserves and sets target allocations for each category. How soon each target is achieved will depend upon the district's net income over the coming years. Fiscal years 2012-13 and 2013-14 both ended with negative — albeit about \$20,000 each year — net incomes. The past year, 2014-15, has an estimated positive outcome of nearly \$245,000, although the audit has not been completed.

The new policy allows for both restricted and non-restricted reserves. The former limits the use of those funds to the stated purpose of the reserve and these monies will be separated from the general district accounts. To use restricted funds, the board must affirm their approval. Non-restricted funds have none of these controls.

The six reserve funds are: working capital, emergency, capital improvement and replacement, vehicle and equipment replacement, vacation/sick/annual leave liability and other post-employment benefits. Each reserve fund will support both the water and sewer programs. The accompanying table shows the target levels for each reserve and whether it is a restricted fund.

The working capital fund level of about \$750,000 is estimated to be about two months of normal expenditures, according to General Manager Tom Lynch's recommendation to the board.

The total projected reserve funding goal is \$5 million. At the end of fiscal year 2014-15, IWD had about \$3 million in cash generally available for district use, although

a portion was restricted.

"Contributions to the various reserve funds will be determined at budget time," said Director Warren Monroe.

The fixed-asset policy will oversee the acquisition and accountability of any tangible or intangible asset whose cost is greater than \$5,000 and life expectancy more than one year.

Assets whose costs are less than \$5,000 will be included in the annual expenditures and not capitalized, according to Chief Financial Officer Hosny Shouman.

The policy also specifies a physical inventory at least every five years and that depreciation of the asset will begin after one month.

Lynch also announced that the U.S. Department of Agriculture's Rural Utilities Service has granted IWD \$215,000 to rehabilitate its horizontal wells and five vertical wells. The grant is for all the costs of the work and does not require IWD to match any portion of the costs.

"Funding from this grant will be utilized to rehabilitate well numbers 5, 8, 11, 16 and 27, and additional horizontal wells," Lynch wrote in his memorandum to the board. "These wells require extensive improvements, including pumps, motors, pipe, casings and electrical components."

Also, IWD received the first reimbursement of its costs (\$275,600) for the recycled water project. This money reimburses IWD for expenses it has incurred preparing various studies, which were necessary for the funding request submission, according to Lynch. He plans to request bids within the next month.

The water program had a net income of nearly \$30,000 in August with the help of \$115,000 in water revenue, nearly \$9,000 more than estimated. The majority of the additional revenue has come from commercial customers, Shouman said.

In the first two months of fiscal 2015-16, water revenue has totaled nearly \$230,000, or about 24 percent of the estimated full-year's collections.

IWD remains on the verge of going to a Stage 3 water emergency, Lynch told the board. While the summer rains have been a welcome occurrence, only the level of the Foster Lake wells has prevented IWD from declaring Stage 3. Rehabilitating the horizontal wells earlier this year has benefited these wells, he added.

In August, the level of the Foster Lake wells remained 43 feet below the surface, which was no change from July, but was a 3-foot improvement compared to August 2014 and still 20 feet below the 2013 level. The Rockdale well also had no change this month, but IWD's other wells incurred lowered levels, particularly the downtown wells, which Lynch said were being pumped more frequently recently.

Total production was 7.4 million gallons, about 560,000 gallons more than July, but 270,000 gallons less than August 2014. For the first eight months of 2015, production totaled 50.7 million gallons, which is 6.2 million gallons (or 12 percent) less than the same period in 2014. The usage for this period is the lowest in more than a decade.

Acceptable items include used oil/filters, latex/oil-based paint, fluorescent tubes/bulbs, pesticides, cleaners, barbecue/camp-size propane, aerosol cans, anti-freeze, auto/household batteries, garden chemicals, pool chlorine, TVs and computers, electronic waste and sharps.

Unacceptable items are government, business, non-profit or out-of-county hazardous waste, explosives/ammunition, medical/infectious waste (except sharps), asbestos, radioactive/remediation material, containers larger than 5 gallons or weighing more than 50 pounds, appliances, tires and trash.

In a small bowl, combine salt and spices. Set aside. In a large heavy skillet, melt butter. Add walnuts and pecans. Cook over medium heat until nuts are toasted, about 4 minutes. Sprinkle with spice mixture. Add brown sugar, water, Worcestershire sauce and hot sauce. Cook and stir for 2 minutes or until sugar is melted. Spread on foil to cool. Store in airtight container. Yield: 2 cups. Enjoy.

## How to arrive on Mars way faster ...

It has been a few months since I've mentioned any cool science-related movies coming up. When I went to see "Black Mass" (which I recommend, although it's not science-related), there was a preview for a movie called "The Martian."

"The Martian" is about an astronaut (played by Matt Damon) stranded on planet Mars. If you get a chance to see the poster it reads: "Help is only 140 million miles away." While no one would disagree that's pretty far (just ask the Mars Rover), scientists are currently developing ways for us to get there in 30 days.

First, with all due respect to the movie's marketing team, there is a way to shorten the distance by 100 million miles without lifting a finger. The orbits of Earth and Mars come into what is called "opposition" (which is when they are closest) every 26 months. The next occurrence will be in June 2016.

Also, the ships being used now for space travel seem fast but are actually quite slow. The rockets we see on

television taking off from places like Cape Canaveral are called chemical rockets.

This type of fuel is quite heavy and the amount of thrust they produce is somewhat inefficient. NASA and the University of Washington are currently working on a new method of propulsion using nuclear fusion called "The Fusion Drive."

Nuclear fusion happens when the nucleus of two atoms are pushed together so much that they actually merge, releasing a huge amount of energy. This method is so efficient and produces so much thrust that it could theoretically get us to Mars in about 30 days.

Using a grain of sand of this fuel is equivalent to using a gallon of rocket fuel. That's pretty efficient. NASA hopes to have an experimental spacecraft that uses this type of fuel developed by the year 2020.

There also are some scientists big on a method called "ion thruster," a form of electric propulsion, that creates thrust by accelerating ions.

The Deep Space 1 probe launched in 1998 was the first to use a ion thruster engine as its main source of propulsion.

Although they are good at maintaining impulse, ion drives do not have anywhere near the thrust power of even conventional rockets. It is comparable to a car that takes a couple of days to go from 0 to 60 mph.

For this reason, ion thrusters are not considered the most promising type of electrically powered spacecraft propulsion. I think if you ask Matt Damon, he would rather go with the nuclear fusion option once it's ready to go or send a regular spaceship in June 2016. (Then again, he is already back on Earth, I heard).

# Lisa Absher joins Idyllwild School faculty as speech therapist

Lisa Absher, with a bachelor's and master's degree in Communication Disorders, has joined the Idyllwild School faculty as a speech-language pathologist providing services to preschool to middle school students.

Absher's training and experience equip her to treat a variety of communication and swallowing disorders including autism, dysphagia, Down syndrome, fetal alcohol syndrome and traumatic brain injury. "I have worked with people from the ages of 1 through 104," she said.

Absher has worked constantly since receiving her master's from Appalachian State University in Boone, North Carolina, in 1999, including: as a speech and language pathologist for Navajo Reservation pre- and elementary-school students in New Mexico; for Native American Tlingit pre- through high-school students in Juneau, Alaska, and for school districts including those in Gallup, New Mexico, San Jacinto, Corona-Norco and Banning.

She began work for Hemet Unified in August of this year. Late in her career, Absher decided to hone her medical skills by serving in both hospital and rest-home environments. "Any speech therapist with a master's has the credentials to work in those settings," said Absher. "The training is experiential and gave me the opportunity to work with patients with traumatic brain injuries and other conditions needing speech therapy." In addition to being at Idyllwild School on Tuesdays and Thursdays, Absher also provides speech and language pathology treatment for Hamilton elementary, middle and high school students.

Of her work, Absher said, "It is truly interesting and

you can do so much with it. Whether you are working with someone 2 or 92, the most important thing is to establish rapport and trust. When talking is difficult, it is important to have the trust so that when you correct them they can understand and accept that you are trying to help."

Asked what kinds of issues she encounters in school situations, she said, "With little ones, they may not be producing sounds or words correctly, omitting beginning

or ending sounds. To them they think they are saying a word correctly. I ask them to look at me, and imitate me when I say the word, then to repeat if they don't add in what they had been missing. Trust is important in the process.

"With middle- or high-school students, there might be autism issues, where the students lack the ability to understand their peers' emotions, expressions and feelings. Finding common ground and establishing rapport is again where you begin."

Absher said another big role for a speech therapist within a school faculty is to also educate and assist teachers, administrators and parents in understanding how speech issues and impairments can affect performance in the classroom. "Again, with autism, the brain's cellular structure makes it difficult for the students to interpret facial gestures. They don't get humor or figurative language. So a teacher might misinterpret the students' lack of understanding as their just being difficult or argumentative."

Absher said speech therapists are always listening for voice problems and indications of underlying issues. As an example, a child's difficulty with pragmatic social skills, such as taking turns, changing a routine, loosing in a game situation, making eye contact or greetings, could be indicative of underlying structural issues.

Absher is relaxed and easy to engage. Born near Boone, North Carolina, in the Appalachian's Great Smoky Mountains, Absher has the graciousness and politeness of her country-girl upbringing. "I tried to find work near Boone after I graduated, but there was none to be had," she said. "They say you can take the girl out of the country but you can never take the country out of the girl, and that's the case with me."

Absher said she has four brothers, had been married for 20 years, and then divorced for 20. "But I'm getting married again this coming Saturday, to Michael Houghton in Hemet. I couldn't have children before but Mike has two children and three grandchildren. So now I will be a grandmother," Absher smiled, as she does often.

# Attorney General Kamala D. Harris unveils 2015 truancy report

On Wednesday, Sept. 16, California Attorney General Kamala D. Harris issued her third annual statewide report on elementary school truancy and chronic absence. The report, *In School + On Track 2015*, is available online at [www.oag.ca.gov/truancy/2015](http://www.oag.ca.gov/truancy/2015).

The report finds that, compared to last year, California still faces a crisis in school attendance. Nearly 230,000 California elementary school students are chronically absent — missing more than 10 percent of the school year — and more than one in five are truant, having three or more unexcused absences. Annually, dropouts cost California taxpayers an estimated \$46.4 billion in incarceration, lost productivity and lost taxes, according to the report.

The report also outlines significant progress made in the past year in increasing awareness of the importance of attendance within school districts, tracking attendance year over year and rethinking discipline policies that remove students from the classroom.

"Elementary school truancy has sweeping implications for our state's economy and public safety," said Harris in the press release announcing the latest study.

"When our youngest students are missing more than 10 percent of the school year, we know that they often fall behind and never catch up."

The report quickly states the problem: "When students are chronically absent from elementary school, they fall behind academically, they are less likely to graduate from high school, and they are more likely to be unemployed, on public assistance, or victims or perpetrators of crime." And then labels it the "School-to-prison pipeline."

The report offers updated data on the truancy crisis, which is particularly stark in the earliest grades. According to the report, nearly 15 percent of kindergarteners are chronically absent (missing more than 10 percent of the school year) and the kindergarten truancy rate for the past year neared 30 percent. Attendance modestly improves as students progress through school. For example, 9 percent of first graders are chronically absent and it drops to 6 percent of third graders.

The consequence of missing this much schooling is that 80 percent of students who missed more than 10 percent of the school year in kindergarten and first grade

were unable to read on grade-level when they reached third grade. When that happens, they are four times more likely to drop out of school.

Racial disparities are alarming in these early grades. Chronic absence rates for Native American and African American students were almost 30 percent in kindergarten.

Also, racial and income disparities persist beyond kindergarten and throughout elementary school. Close to 20 percent of African American and Native American students are chronically absent, and more than three-quarters of the students who are chronically absent are low-income.

Since last year's report was issued, however, school districts have made significant strides. For example, more than 95 percent of districts reported they have made changes to policies and programs to improve attendance, or plan to do so for the 2015-16 school year.

Since the first report two years ago, schools are developing more programs to address and reduce absenteeism and truancy. For example, many schools have shifted their actions from focusing on punishment to a focus on prevention, including greater efforts to engage parents.

Part of these programs is an effort to correct common misconceptions about early school absences. The four most common misconceptions are:

- Early grade attendance isn't as important as high school.
- Students will catch up before they get to high school.
- Only absences on consecutive days have a negative impact.
- Absences are OK as long as the parent signs off.

Another improvement is that a number of districts have changed policies so that students would miss less time in school for suspensions. Importantly, many districts are using local control and accountability plans to set clear goals to reduce truancy and chronic absenteeism.

As district attorney of San Francisco, Harris started a citywide elementary school truancy initiative in 2006. In October 2009, she published a report indicating: "In the last year alone, truancy among elementary school students declined on average by 20 percent."

The next U.S. Forest Service fee-free day is Saturday, Sept. 26, in conjunction with the 22nd-annual National Public Lands Day, the nation's largest, single-day volunteer effort for public lands projects that ensure sustainable ecosystems and promote vibrant communities.

The San Bernardino National Forest Service is waiving fees and no Adventure Pass is required for use of standard amenity fee sites in recognition of National Public Lands Day.

The U.S. Forest Service will hold three events Saturday on the SBNF, one of which will be in the San Jacinto Ranger District.

From 9 a.m. to 1 p.m., local dis-

trict officials will partner with the Santa Rosa and San Jacinto Mountains National Monument at the Pinyon Flats Transfer Station, off Highway 74, and the Sawmill Trailhead near the Pinyon Flats Campground. They will be assisting with trail improvements, trimming plants, planting native vegetation, removing weeds, sweeping and repairing fences. An educational presentation on tool safety, leave-no-trace principles, back-country gear and Dutch-oven cooking also will be available.

The next fee-free day is Veterans

Day, Nov. 11.

National Public Lands Day began in 1994 with three sites and 700 volunteers. It proved to be a huge success and became a yearly tradition, typically held on the last Saturday in September. Since the first NPLD, the event has grown by leaps and bounds. In 2014, 175,000 volunteers served at over 2,000 sites in every state, the District of Columbia and Puerto Rico.

On national forests, grasslands and prairies, nearly 110,000 volunteers and service members contributed 4.6 million hours on critical projects last year. Their service was valued at close to \$105 million.

# 'Thomas Jefferson' to appear at Friends' meeting

The Friends of the Idyllwild Library announces its upcoming annual meeting, to take place at the Rainbow Inn at 2 p.m. Saturday, Sept. 26. The short business agenda is to be followed by a presentation by Logan Creighton, who will be assuming the historical persona of Thomas Jefferson.

Many facets of Jefferson's life could be incorporated into a short program; however, Creighton's prime focal point on this afternoon will be the sweltering Philadelphia summer of 1776 and the writing of the Declaration of Independence.

As a member of the drafting committee for the actual statement of independent status to Great Britain (as put forward by Richard Henry Lee), Jefferson's first draft differs from the final version in

several turns of phrase, influenced by the committee's four other members (notably, Benjamin Franklin and John Adams), as well as by treatises on civil government by John Locke and others.

The list of grievances against George III of England also underwent changes from the first to final wording, and several of the more significant as well as memorable portions of the document may not have been totally conceived by Jefferson himself.

Nevertheless, he did count the declaration's authorship as one of the salient events of his life, even to the extent of mentioning it in his self-written epitaph, while not mentioning his time as president of the United States.

Many other facets of the project are sure to be covered in Saturday's presentation, and audience questions will certainly be welcomed.

Creighton is more than qualified as a historical presenter, both as a student and teacher of history, as well as a seasoned performer of many significant roles. His career really began at the age of 16, when he began teaching history to several homeschool groups. As a specialist in "first-person history," this Pine Cove resident (along with his wife Elizabeth) is clearly a community asset, and deserves as wide and diverse an audience as can be provided.

# Rene Eram, filmmaker and author, counsels on breaking addictive patterns

'A part of our being wants to be free'



Rene Eram, filmmaker, author and local gallery owner, once made \$10,000 a day as a sought-after commercial TV director. He painstakingly sought to compose the perfect visual balance between a glass of orange juice and a bowl of cereal to satisfy ad execs and their clients. While achieving perfect balance on the small screen, he was at the same time destroying any semblance of balance in his larger life.

Successful in his mid 20s, he remembers directing a TV commercial in which a live butterfly had to land on a rose, flap its wings a few times and then fly away. The shot had to be live, since at this time there were no computerized special effects. "Filming that butterfly debacle was the day I decided to add rum to my can of Coke and drink on the set," he recalled.

He described directing as the perfect environment to feed and sustain ingrained co-dependent patterns — a place to be in control, hide any weaknesses or doubts, and be celebrated and highly paid for his talent. As he became more successful, he described how his unconscious patterns were causing him to spin out of control. "I had discovered the 'Golden Rule' of Hollywood very early," he wrote. "The more talented and messed up you are, the more they pay and enable you."

Fortunately for Eram, there was an epiphany, a moment of realization that a change in medium, in form, and in approach had to occur in order to move forward. He was 32. He described how his addictions had progressed and destroyed his filmmaking career, his relationships, his family and his friendships. "Everything had stopped working," he recalled. He was at the edge. He made a choice that would define his way forward and his life's mission. "I could get sober in a 12-step Program; white knuckle it and, once again, go it alone; or kill my-

self," he wrote. "I decided to go with choice number one. I wasn't ready to die and knew I could not stay sober alone."

Even with a 12-Step Program, he thought there was something missing — some missing information without which, even after years of sobriety, he could still fall back and once again slip over the edge. He began to train as a drug and alcohol counselor and to research the causes of addiction. Through his training and research, Eram found what he calls the missing "mousetrap" — the awareness and mechanism that could stop his unconscious and deadly choices.

Fast forward to Idyllwild, where Eram capped a decades-long journey of spiritual and emotional growth by writing "The Addict's Loop: A New Understanding and Workbook for Codependent Relationships and Addiction." Eram describes the book as an easy-to-understand model that shows what he believes had been missing in traditional approaches to breaking addictive habits.

"What I saw were people unaware of their unconscious codependent patterns," he said.

His book details what he teaches as the mechanism to break addictive patterns: the need to become conscious of, identify and name ingrained and inculcated unconscious dependencies and destructive patterns — the repetitive and constantly recycling addict's loop leading from fear, repressed anger, abuse and emotional pain upward to hoped-for connection, love and a euphoric fix, to a downward spiral of betrayal, rejection, abandonment and, once again, fear. The learning, as Eram counsels, is that the loop continues as long as it is left unconscious. The key, as he teaches, is to consciously recognize and identify the steps in the progressive loop.

Eram said Idyllwild gave him the space and solace he needed to write his book. He and wife Linda Lauderbaugh had chosen Idyllwild for home base to reboot after their Los Angeles careers.

They opened their gallery, Over the Rainbow, on North Circle to market art made principally by Lauderbaugh, a successful commissioned fine and commercial artist. "I named the gallery 'Over the Rainbow' because I think that is where we've landed," said Lauderbaugh.

On any weekend, Eram can be found at the gallery, greeting customers and soaking up Idyllwild's open and free-flowing creative ambience. "It's inspiring here," he said. "It's a hot spot for creativity and deep thinking."

For Eram, relocating to Idyllwild gave him what he needed to complete this leg of his journey, write his book and to continue to grow as an artist. He has articles coming out in two magazines, Serene Scene and Sober World Magazine, and has a screenplay that is under option with James Franco. "I write every day," he said. "I also have begun to counsel with singles, couples and families, to counter-condition and help break co-dependent and addictive patterns."

Eram said the picture on the cover of his book tells his and his book's story — that of a child abandoning who they are in their truth and running toward a dishonest identity they think might better serve them. "It's all out of survival," said Eram. "The child feels invisible in their truth and runs toward a role they think will give them power and purpose."

"There is a part of our being that wants to be free, and that requires being conscious of what has hijacked our authentic self and created destructive behaviors."



# Steele ties for 13th in BMW Championship

Brendan Steele closed out his PGA Tour season last week by carding 36-34 — 70 in the final round of the BMW Championship, the third of the four season-ending FedExCup playoff tournaments. For the tournament, he posted an 11-under-par 68-67-68-70 — 273, finishing in a tie for 13th place.

This was by far the best playoff performance of the native Idyllwild's career, both his best finish in the BMW and his best final Fed Ex Cup ranking at 50th. In 2011, he finished 68th in the BMW, and in 2013 he finished 61st.

For the tournament, the native Idyllwild placed

ninth in both driving accuracy and driving distance, but placed only 60th in greens in regulation at 58.33 percent. We calculated his approach iron proximity — which is our own stat for all approaches from between 100-250 yards — at 30.4 feet, which is probably higher than he would have liked. (His AIP in the second round, when he fired a 67, was a low 22 feet.)

Even though he didn't score a win as he did in 2011, this season was still Brendan's best in many ways, and we'll be presenting a recap of his 2015 season in next week's paper.

We've heard nothing official as to when Brendan's next PGA Tour appearance will be, but he's played in the Frys.com every season but one. That tournament will open the 2015-2016 season in just three weeks, Oct. 15 to 18.







Alfred James Monroe, a World War II veteran and award-winning engineer, died of natural causes at his home in Hemet surrounded by family Tuesday, Sept. 15, 2015. He was 90.

Alfred, an electrical engineer, spent the majority of his career focused on intercontinental ballistic missile systems.

For nearly two decades, he worked on the Atlas, Titan and Minuteman missiles for TRW Space Technology Laboratories. This work led him to publish his first of three books, "Digital Process-

es for Sampled Data Systems," in 1962.

While at TRW, Al served as editor in chief of the final reports of a national committee called the Weapon Systems Effectiveness Industry Advisory Committee. He received the Air Force Ballistic Systems Division Commanders Award for this service.

Al was born June 30, 1925, in Detroit, Michigan, to Alfred Elmer Monroe and Joyce Wright.

When he was 7, he moved to the heartland of Michigan and began his educational journey by walking more than a



mile each day (uphill both ways, he said) to a one-room schoolhouse.

Later, he would graduate top of his class at Gladwin High School but miss the commencement address because he was drafted into the Army.

He was deployed to a maintenance battalion in the Hawaiian Islands where he won a meritorious award for a modification he made to the M9 and M10 directors.

After the war, Al returned to Michigan.

He graduated with honors from Michigan State University, where he was a member of the Tau Beta Pi engineering honor society.

He then hitchhiked to California and eventually

began attending the California Institute of Technology.

He earned his master's degree and started his first engineering job in 1950.

He married Nancy Jane Gorman on June 30, 1955.

They spent much of their lives at their cabin in Idyllwild, which was filled with food, drinks, music, good conversation, laughter and love.

Papa Al, as his grandchildren affectionately knew him, was a renaissance man who dabbled in many passions: painting, woodworking, writing and most of all gardening.

His children are thankful for the lessons he taught them and for all he and Nancy have given of themselves over these many years.

He is survived by three children, Sean Monroe, Sandy Lewis and Kathleen Phillips; and seven grandchildren, Glen and Michelle Monroe, Ryan and Shauna Barton, Samantha, Bryce and Alora Phillips.

## Wildfires

told his staff, "Currently, there remains approximately \$174 million for fire suppression in fiscal year 2015. We anticipate the current extreme fire activity to continue through the end of the fiscal year and are projecting that the Forest Service will not have sufficient suppression funds.

"At this time, the only option for financing the fire suppression shortfall is to use the agency's transfer authority. We must avoid incurring additional financial obligations wherever possible to cover projected suppression costs," he added, "We have developed a transfer strategy for transferring up to \$450 million involving two increments, the first for \$250 million and the next for \$200 million."

In 2015, 52 percent of the Forest Service budget was for fire suppression, up from 16 percent in 1995. By September 2015, the Forest Service had already exceeded the funding set aside for fire suppression and has been forced to borrow funds meant for other Forest Service activities.

In a report, "The Rising Cost of Wildfire Operations: Effects on the Forest Service's Non-Fire Work," released in August, the Forest Service discussed how its programs are affected by the constantly increasing costs of wildland firefighting. "As more and more of the agency's resources are spent each year to provide the firefighters, aircraft and other assets necessary to protect lives, property and natural resources from catastrophic wildfires, fewer and fewer funds and resources are available to support other agency work — including the very programs and restoration projects that reduce the fire threat.

"The depletion of non-fire programs to pay for the ever-increasing costs of fire has real implications ... also for the protection of watersheds and cultural resources, upkeep of programs and infrastructure that support thousands of recreation jobs and billions of dollars of economic growth in rural communities, and support for the range of multiple uses, benefits and ecosystem services, as well as research, technical assistance and other programs that deliver value to the American public," the report continued.

Meanwhile, Congress is working on legislation to change the manner in which wildfire funding is provided.
