## Town Hall closed because of asbestos

The Town Hall building has been closed for a duration yet to be determined, according to Kyla Brown, parks and recreation bureau chief for the Riverside County Regional Parks and Open-space District, although she hopes it will be only a week.

A notice on the door this weekend stated, "Upon recent inspection

were found to contain asbestos in some areas ..."

Another notice stressed, "Preliminary tests have determined this facility has material containing asbestos. Do not disturb." But it stressed that the park district is taking comprehensive precautionary steps, "... therefore, this facility is not being used for programs until further testing is conducted."

More inspections and chemical tests will be made this week, according to Brown.

## Scenic Drive house burns Sunday evening

A major house fire occurred Sunday evening, Nov. 15, essentially destroying the house. At about 4:30 p.m., Idyllwild Fire Department received a dispatch alert about a house burning at 25435 Scenic Drive.

When IFD arrived, the house was already "ful-

ly involved," according to Idyllwild Fire Chief Patrick Reitz.

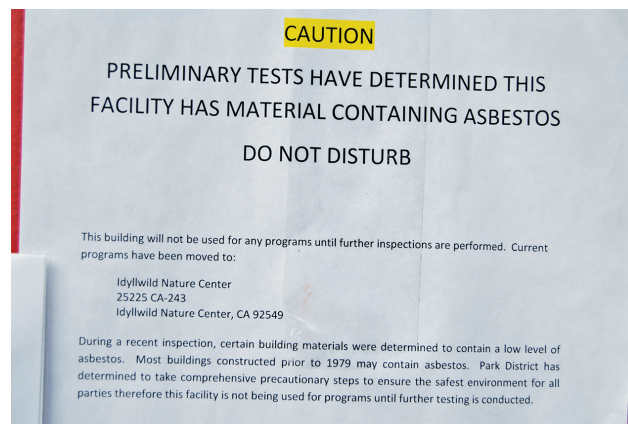
"Crews had some difficulty accessing the residence due to its location off of the roadway and the lack of driveway access to the residence," he said. "[This] caused crews to hand-carry all hose and equipment to the residence."

Because of the car in

the driveway and neighbors' comments, IFD was concerned the owner may have been inside. Consequently, Reitz said, "Crews searched the residence under heavy fire conditions in an attempt to locate the owner."

Eventually, IFD confirmed the owner was not at home. "The owner's dog, however, died in the

# Near-hit spares injury to 45 children in a school bus

At 7:10 a.m. Friday, Nov. 13, a school bus carrying 45 students was traveling westbound on Highway 74, 1.1 miles west of McGaugh Road, when an eastbound big rig crossed into the westbound lane. The bus driver swerved to miss the big rig, avoiding what could have been a catastrophic outcome.

The big rig continued eastbound without stopping. As of this report, neither the rig nor the driver has been identified or located. There were no injuries in the school bus, according to California Highway Patrol Officer Ben Bolon.

# County to take part in statewide emergency drill

Riverside County will participate in a hazardous-material response drill this week, along with numerous state and federal agencies. The drill involves a simulated response by hazardous-materials teams after anthrax is detected in multiple locations.

The drill, from Monday to Friday, Nov. 16 to 20, will include the California Department of Public Health, the California Emergency Services Medical Authority, the county Department of Public Health, Emergency Management Department, and the Riverside County Sheriff's Department and CalFire.

fire," said Reitz.

IFPD responded with an engine, a truck, a squad, an administrative unit and two ambulances. Mutual aid was received from Riverside County Fire and Cal Fire.

Sunday's weather also contributed to IFD's ability to prevent the spreading. Reitz said, "The rain helped prevent the spread into the vegetation; the increased humidity increased the effectiveness of firefighting efforts."

At this time, the cause of the fire is

still being investigated, Reitz added.

According to Zillow.com, the house was built in 1946 and was 1,200 square feet, though the realtor's listing showed it at 1,742 square feet and a sale pending. The house was in escrow but had not yet closed, according to Idyllwild Realty Agent Sheila Zacker.

According to Zacker, the house had been in the owner's family since it was built, compounding the loss, since many antiques and years of family history and memorabilia were lost.

# El Niño on the way

## Expect well-above-average precipitation this winter

Discussions of the pending El Niño weather pattern have shifted from its probability to which month will it peak and its longevity.

Last week, the latest National Weather Service forecast stated, "El Niño will likely peak during the Northern Hemisphere winter 2015-16." Neutral conditions are expected by late spring and possibly early summer 2016.

The environmental indicators, such as sea surface temperatures, are well above their normal range. "Collectively, these atmospheric and oceanic anomalies reflect a strong and mature El Niño episode," was the NWS conclusion.

NWS continues to expect a very wet winter, "[T]his El Niño could rank among the top three strongest episodes ... going back to 1950." A strong El Niño is correlated with above normal precipitation in Southern California. According to a NWS advisory last week, the current con-

ditions are the strongest recorded.

"Above-normal precipitation and frequent storms are expected for Southern California with the best chance from December through March and moderate snow levels (not the tropical high snow events and not the arctic air mass)," is the most current NWS forecast.

The expectation for greater rainfall is being enhanced by the "blob" of warm Pacific water to the west of California. El Niños are created and influenced by equatorial warm waters.

NWS adds, "El Nino can impact the jet stream to bring more frequent storms during the wet season, but not necessarily stronger storms (not just the Pineapple

Express or Atmospheric River)."

Even though the foreboding El Niño has not yet arrived yet, in both Idyllwild and Pine Cove rainfall since July 1, the beginning of the rain year, has exceeded the average long-term rain through the end of November.

No additional precipitation is forecast through the end of November. However, U.S. Forest Service meteorologists have said, "... confidence is high that our region will see above-normal rainfall this winter, however, as with the last strong El Niño (1997-98), significant (season-ending) rains did not occur until the early to middle part of December." And they expect Southern California "... may bear the brunt of the storms."

## Sandbags to be available throughout Hill

A single person attended the latest Mountain Emergency Service Committee meeting. But Kathleen Henderson, the Riverside County emergency services coordinator for the mountain, briefly discussed the county's plans to help residents on the Hill and throughout the county prepare for the impending El Niño event. (See other story, this page.)

The county's new Emergency Management Department is drafting a concept paper to help respond to the possibility of major events, such as flooding and mudslides.

The basic message is to prepare just as one would for earthquakes. No one knows when and how much rain will fall, but residents should be ready for considerable rain and potential flooding, which might close or even wash out roads.

Protect your property. To avoid flooded areas, know where alternative routes may be. And be prepared for possible outages with a supply of food and water.

A series of community meetings has been scheduled in Idyllwild and other Hill locations. See the accompanying box.

At these meetings, representatives of several county agencies, including EMD, Flood Control and Transportation, will be available to address the potential problems and answer questions.

Print commands a reader's attention unlike electronic media and the authors also believe readers process print differently, thinking beyond the literal words on the page and invoking a reader's imagination.

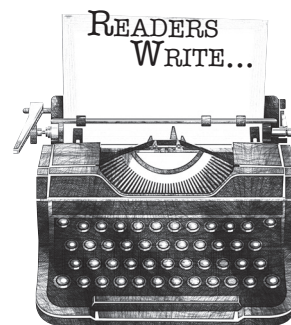

### Environmental agenda will cost Californians

EDITOR:

Gov. Brown signed SB 350 (De León) into law, a bill that mandates that half of California's electricity come from renewable sources in 15 years. This law will dramatically increase energy cost for Californians, who are already living with one of the highest electricity rates in the nation.

Currently, the average Californian residential electricity rate is 15.34 cents per kilowatt-hour, 29.12 percent greater than the national average. The average residents in Eastern San Diego County pay another 6.5 percent in electricity rate on top

of it. Those living in areas with warmer temperatures will be hit especially hard by the electricity hikes this law causes.

A study by Energy and Environmental Economics Inc. estimated that the average retail electricity rates in California will likely increase 47 percent between 2012 and 2030 prior to this law's passage, and will increase another 9 to 23 percent after.

Such dramatic rate hikes not only will raise prices and reduce spending power, but also increase the already burdensome costs of doing business in California, potentially pushing more businesses to leave the state and worsening the economy in California.

Californian businesses are already one of the most energy-efficient in the nation. Incentivized to maintain productivity and profitability, they consume 11.32 percent less electricity than the national average per month. Not to be outdone, Californian residents consume 36.54 percent less than the national average residential electricity consumption per month.

SB 350, however, imposes another 50 percent energy reduction on top of this progress without providing any detail as to how California will reach this goal, or accounting for the steps Californians have already taken.

The bill's author, commenting on its passage, said: "We are doing away with the tired old stereotypes of environmentalism as a pastime of the wealthy and the elite. Soon, whether you live in Boyle Heights or Beverly Hills, Modesto or Marin, Sausalito or Santa Ana, Sacramento or Logan Heights, San Diego, you will have the same access to clean electricity and clean air." Yet, unlike the "wealthy and the elite," poorer residents will not be able to endure the skyrocketing utility costs.

It's time for the legislature to work for the majority of all Californians, rather than the few, out of touch, misguided environmental special interests. California can be the golden state again if we are good stewards of our environment while promoting intelligent, science-based policies.

# Off the Main Roads

## The Clocks Within Nature ...

Your own body follows a clock. All of its processes flow in a sweeping daily rhythm, merging into a larger seasonal cycle. Our daily clock is set by our interaction with the natural world around us, especially the movement of the Sun.

Exposure to bright-morning light sends a cascade of wakefulness chemicals through our bloodstream. The bright-blue light of a noonday Sun helps us set our midpoint for the day and the warm-red dying rays of the sunset spiral us down toward sleep.

We are not the only ones with built-in clocks. These internal timepieces are so ancient that this sensitivity to light and dark cycles was set in place far before animal and plants diverged from their common stock.

If you pay close attention, you can watch the effects of these internal clocks play out in nature. As you walk down the trail (or even the street), watch for the subtle signs that a plant is on the daily roller coaster ride of wakefulness.

One of my favorite examples of diurnal (daily) rhythms

in plants is the dandelions that adorn the edge of a meadow near my house. Each afternoon as I passed them, I would stop and collect their bright yellow flowers for a nutritious, wild-food snack.

Early one morning, I decided to visit the same patch in hopes of garnering a few tasty morsels to go with breakfast. But, I discovered that I couldn't find a single one.

All of the dandelion blossoms had wrapped themselves up tightly in their green buds, asleep until the Sun would come to wake them. You can see this on the trail, as well.

Plants on the northern face of slopes receive less morning light and will often "wake" later in the day. This daily pattern of "sleeping in" leaves them with less time and energy to grow, so you will likely notice they lag behind in their development of leafing out, flowering and setting fruit compared to their neighbors on the sunny, south-facing slope.

Other living things can reveal the culmination effects of rhythms on longer timescales. In most lichens, the brilliance of the color green you see is a good reflection of the average daily amount of sunlight they receive.

Searching for a nice bright rock for future sunbathing? Want a campsite that will stay cool and out of direct sun? Look to the nearby lichens. You can use this to map out areas on and around rocks that should fit your needs through most of the year.

Want to know the age of a pine tree? You don't have to cut it down and count the rings. Just look to the limbs. Each year, a conifer adds a whirl of branches. Each level or whirl corresponds to a year of growth. If your children (or you) enjoy climbing trees, it's exciting to realize that you are climbing up through time.

# Art Alliance offers opportunity to honor Paris victims

The Art Alliance of Idyllwild has established three sites to enable locals to commemorate the horrific events that occurred in Paris last week.

Tri-color boards will be set up at the Idyllwild Post Office, Town Monument and Town Baker where the community and visitors may express their feelings, sorrows and hopes for a better future.

The idea originated with AAI director Peter Szabadi, who wished to offer the whole community a way to respond to these events in a concrete and demonstrative manner.

"We have all been shocked by the recent senseless massacre in Paris. I think all of us cannot understand the barbarity, which would justify the deaths of so many innocent lives," Szabadi said. "These awful moments are sometimes easily forgotten by the next news events and tragedies."

People may write comments, draw, paint or leave remembrances at the boards, which will be available for five days. The boards will be displayed at a future AAI event, Szabadi added.

# State water conservation measures likely to extend through 2016

Gov. Jerry Brown issued his second executive order last Friday regarding water conservation this year. Last April, the governor's first order mandated a 25-percent reduction in water use throughout the state.

The Nov. 13 order authorizes the State Water Resources Control Board to extend the water reductions through October 2016 if drought conditions persist through January 2016.

Current forecasts for the arrival of El Niño rains expect the frequency of storms to begin in late December or January and peak during the first quarter of 2016. This suggests that water conservations, possibly at a reduced level, will continue through 2016.

The order also directed the SWRCB and the regional water quality control boards to give priority to water-right permits, water-quality certification and waste-discharge requirements for projects that can use available high-water flows to recharge local groundwater while minimizing flood risks.

The governor also directed the SWRCB to use \$5 million for water projects to help water systems serving fewer than 15 drinking-water connections or households.

Hall programs, including the afterschool program, were being held at the Idyllwild Nature Center. Parks had already arranged with Hemet Unified School District to transport the children in the program to the Nature Center.

"Regular park district staff will continue to run the program at the Nature Center and provide the

same services," read the notice on the door.

Although Idyllwild School will be closed next week for the Thanksgiving holiday, its own afterschool program will be at the school on Monday and Tuesday from 8:30 a.m. to 2:30 p.m. Principal Matt Kraemer said, if parents plan to have children participate, "they need to be there from 9 a.m. to 2 p.m."

If the problem at Town Hall is greater than the

Parks and Open Space District currently believes, Brown said they hope to relocate the program to a space closer to town, perhaps Idyllwild School.

According to Brown, a routine inspection in the attic area in preparation for some maintenance work discovered some disturbed asbestos. As a precaution before determining the condition of the asbestos, the building was closed for county recreation use.

Verne Lauritzen, 3rd District Supervisor Chuck Washington's chief of staff, cautioned that asbestos, when it begins to deteriorate, may become airborne particles that can be inhaled and cause health hazards. "That's why the decision was made to move recreation programs until further inspections and necessary repairs can be made," said Lauritzen.

At this point it is un-

certain who will make repairs if they prove necessary. "I'm not aware that the county has a Memorandum of Understanding with the Johnsons [the owners of Town Hall] regarding responsibility for repair."

"I've asked the Parks District to have a long

term contingency plan in place for relocating recreation if Town Hall remains unsuitable," Lauritzen said.

# Out of the ashes

## A Thanksgiving story of tenacity, hard work and gratitude

For many years, Sasha Fisher had struggled as a single mother to raise her two children, always maintaining a positive “can do” attitude as a model for her children. “I wanted to show my children that nothing is impossible if you have enough love for yourself and are willing to work hard.”

Originally from Minneapolis, Fisher grew up in the San Diego area. She first visited Idyllwild in 2005. “I fell in love with the town as an arts community,” she remembered. She moved here in 2007 from Hemet. She met local contractor Marty Prevosto and began a new life in Apple Canyon. Two years ago, with the Mountain Fire, that peaceful idyll and the new life Fisher and Prevosto were building was brutally interrupted when fire destroyed their home.

When the fire began, Prevosto was on a job in Pine Cove and Fisher at work in The Fort at Lady of the Lake. They tried to get to their home by taking three different routes and were stopped each time. Finally, they spent the night in the Lake Hemet Market parking lot watching the fire burn the hills across from them — the hills that surrounded their sequestered valley. Not until Thursday, four days after the fire began, did they learn their home had been totally destroyed.

They spent the next year struggling to recoup, emotionally and physically — dealing with county bureaucracy to get permits to clear and rebuild, living in an Idyllwild rental so son Dylan could attend school. “It was a very difficult year,” said Fisher, “the loss of everything, the insurance, the bureaucracy, the emotion. You have to keep the emotional stuff harnessed so that you can function for your family. It was very hard, but so many people were very kind.

“We found a rental that we loved, owned by Jane and Ron Huddleston. I told Jane we loved the house but our funding [from insurance] had not yet come through. She said ‘I don’t care about the funding. Here is the key.’ Peo-

ple had been waiting to give us furniture. It all was so lovely how it came together.”

Finally, in August 2014, about one year after the Mountain Fire, they were able to resettle on their land. “It was beautiful to be back on our property,” said Fisher. “It has a special feeling; it’s a sacred place.”

Then in August 2015, a rebirth and resettlement of a different kind occurred.

“It had always been my dream to have a storefront gallery and boutique of my own, a place to display beautiful art,” said Fisher. Fisher has a college background in art, business and psychology. “I’ve always been in business and retail but my passion is art.”

Then, once again during a providential and auspicious August, Fisher learned the Spruce Moose was for sale. “A friend told me it was for sale, that it was right for me and that I should talk with Bryan [Tallent] and John [Stonitsch],” she remembered. “I came in asking for information and the next day Bryan said, ‘Let’s do this.’ They could not have been more supportive. It all happened very quickly.” Fisher took over on Oct. 1. “Just as Bryan and John did, I will be the owner in residence, present each day we are open,” she said.

Fisher said she will maintain the vision and many of the products, especially the candles Tallent makes, as hallmarks of the store. “What they have marketed and sold, we’ll preserve. It had always been like walking into a forest of dreams and we will keep that feeling going. I want to expand the art that is featured, and give local artists more opportunities to exhibit and sell.”

Three summers, one of fire and ash, a second of resettlement and rebuilding, and a third of realizing a long-held dream have consummated a progression Fisher believes is truly miraculous. “I want this for my children, to show what we as a family can accomplish together, by believing it can be done and by never giving up.”

Fisher and her family celebrate this Thanksgiving with gratitude for the support of friends and Idyllwild



# Wolves in Idyllwild on Friday the 13th

*"I'd rather sing one wild song and burst my heart with it than live a thousand years."*

On a very dark night on Friday the 13th, two white wolves visited the Idyllwild Nature Center as part of an "Ambassador Wolves" program presented by Project Wildsong, a nonprofit located in Murrieta.

Called "The Myth and Lore of Wolves," the presentation recounted wolf mythology from around the world and was followed by a question-and-answer session. About 60 people attended, including 15 children. Project Wildsong notes that throughout history, wolves as an archetype can be found etched indelibly in the culture and lore of many countries.

Project Wildsong's mission is to "rewild" people's hearts, connecting them with creatures of the wild, fellow inhabitants of our planet. Said Wildsong Executive Director Kimmi Kraus, "Rewilding" starts by awakening a deeply rooted connection that entwines the existence of humans and animals on an emotional, physical and spiritual level. With the help of our Ambassador Animals who represent their wild counterparts, we strive to bring to fruition William Shakespeare's words, "One touch of nature makes the whole world kin."

Project Wildsong has three core objectives: education, collaboration and conversation — education to refine public perception of wolves and North American wildlife; collaboration with partner schools, libraries, governmental entities, businesses and zoos to further that educational mission; and conservation by protecting wilderness and wildlife.

Attending with Kraus and handler Beth Katte, were Wildsong's two Ambassador Wolves, Damu (meaning "guardian" in Sumerian) and Cael ("light bringer" in

Gaelic), snow white "high content" wolfdogs. According to Katte, wolfdogs are a breed of mostly wolf and a minor component of dog. "Generally, [wolfdogs] range from 85 to 98 percent wolf and have a small dog foundation from breeds such as Giant Alaskan Malamute, German Shepherd, Siberian Husky or Great Pyrenees," said Katte. "Wolfdogs originated in the 1930s, initially by crossing a pure dog and wolf. Today, wolfdogs are bred wolfdog to wolfdog."

Katte noted wolves live on average 7 years in the wild and up to 20 years in captivity. Many of the questions raised by attendees were about what Damu and Cael ate. "They are hand fed," said Katte, "basically a

raw diet of chicken, pork ribs, salmon heads and green tripe. Damu likes fruits and veggies and is especially fond of green-tea ice cubes. Gael likes pumpkin, eating it and rolling in it."

Damu and Gael were raised from pups by Wildsong, attended by a Siberian Husky "nanny," 5-year-old Jax.

"All dogs were descended from wolves," said Katte, "having about 98 percent of the DNA of wolves. It's just that dogs were bred to please people and wolves are more separate and solitary." She observed that wolves know in the wild to be silent when stalking prey and are considered more mature than domesticated dogs. Wolves may bark as pups but not as adults. As adults, they howl and huff. Silence allows them to be more effective predators.

Said Katte, "Part of our mission is to show the place in nature that predators occupy." Dogs, on the other hand, bark to announce themselves, to get the attention of their human companions, who are often blind to their visual signals.

Noting the large attendance at the Friday gathering, Katte said Project Wildsong would return to Idyllwild next summer.

"I'm a beach person and wasn't sure I'd like the mountains. We came up from San Diego and rented a house. But then I started meeting people here."

"It started with the people. People here don't talk about what they do. I didn't know what they did but they all seemed really nice. And I'm the kind of person that wants to know about the spirit and hearts of others."

Soon she and then husband Pete bought a house and launched into the life of Idyllwild. Actually "burst" onto Idyllwild's art scene would better characterize Betty's entrance — she is a woman of enormous talent, energy, caring and heart. Whatever she undertakes, she undertakes with full commitment and enthusiasm. And, her levels of talent and expertise in singing, acting, teaching, living and giving are every bit as strong as her enthusiasm and commitment.

Betty had found her passion and migrated from opera study to musical theater. "I got involved in musical theater and that was it. It was both my passion and a family."

She graduated with a degree in education and a minor in musical theater, and alternated between teaching and performing for most of her career. "Both gave me the same levels of satisfaction and feelings of accomplishment," she said.

She moved to Tucson, Arizona, and taught at every grade level. She began a master's degree program at the University of Arizona but after one year was hired to perform regularly at the still popular Gaslight Theatre Melodrama.

"Pete and I started forming bands," she remembered. "They were all across the board — jazz, '60s pop and all styles. One of the most popular was one called Betty and the Bebops, a house band at this club. When we started, there were maybe three people in the audience. Not long after there were lines around the block. It was great."

"They say the thing that you do when you lose track of time is your passion. For me, that's performing. When I perform I can be in shoes that squeeze my toes blue for four hours and not notice. It's the same with

teaching. I just get so caught up in what I'm doing, loving every minute of the experience. My greatest journey as a performer has been to learn 'less is more,'" she said. "Of course, there's 'always leave them wanting more,' but I mean the less affectation I put on, the more I strip down a performance, that is what brings people in."

And Anderson has done quite a lot to bring people in — teaching in public and private schools, conducting a performance arts residency for kids who have been through drug and alcohol treatment, performing her own arrangements of songs with the Tucson Symphony, performing in opera and musical theater throughout her career, serving as an adjunct professor of musical theater at Belmont University in Nashville, winning "Best Voice of the Fringe," at the Orlando Fringe Festival — and all the while, doing so with indefatigable enthusiasm, joy and pleasure in giving. Because, what most characterizes Betty Ginsberg Anderson is her willingness to share, to help others, to encourage and to support.

"Art lets people know that it's going to go on and it's going to be OK," she said. "It's also a safe place for people to look at themselves and say, 'Hmmm, I wonder if I could be doing that?'"

Betty is returning to her classical roots by singing soprano with the Idyllwild Master Chorale in its presentation of the Christmas section of Handel's "Messiah." Last year, she starred in the IMC production of Stephen Sondheim's musical "Into the Woods."

"That role, of the Witch, is my favorite. It let me show two sides of myself and was very challenging, both as an actor and singer." She also has thrilled and challenged Idyllwild audiences with her audacious cabaret performances. She is a large and magnetic presence on stage and has a large heart in person.

Betty also will be performing in the Idyllwild Actors Theatre's upcoming Christmas show.

"We can't deny what we need for our spirit," she said.

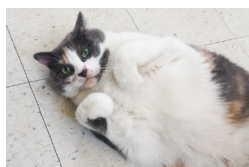




