Portion of Pacific Crest Trail may re-open in spring 2016

In July 2013, the Mountain Fire burned more than 26,000 acres with both the fire and the immediate rainstorm destroying miles of the Pacific Crest National Scenic Trail. Almost 15 miles from Garner Valley near Paradise Corner to Saddle Junction had to be closed for safety reasons.

Much of this trail remains closed. For the past two springs, PCT hikers have had either to walk Highway 243 to Idyllwild or be fortunate enough to catch a ride to town.

Now, maintenance on the trail portion east of Garner Valley has started and the Forest Service expects it to be completed next spring, according to John Ladley, recreation officer for the San Jacinto Ranger District.

However, the greater portion of the trails remain unrestored. Their repair will require several more years, he added.

The severe rain, not the fire, damaged the trails, according to the Forest Service report. "This area experienced two heavy rain events that created debris flows, rock fall, severe erosion, and mass wasting in the burn area and to the PCT ... more than 90 percent of the trail within the burned area affected by heavy erosion and gullies, wash outs, rock fall, and structurally compromised retention walls and switch-back structures. Numerous down trees across the trail and hazard trees within striking distance of the trail were observed."

Restoration could not begin immediately. Furthermore, the district did not have the funds to repair the massive damage. The Forest Service evaluated needed repairs, developed plans for three phases and completed the environmental planning in July 2015.

The first two phases are the 6.3 miles from the

County considering regs for short-term home rentals

Short-term rentals within Riverside County are becoming more popular and now are within the purview of the Board of Supervisors. The subject was on the agenda of the board's Nov. 17 meeting because supervisors John

Benoit (4th District) and Chuck Washington (3rd District) proposed an ordinance (927) to regulate this burgeoning industry.

While the Coachella Valley is the primary locus of concern, Benoit feels the desert cities already regulate this industry to the disadvantage of neighborhoods in the adjoining unin-

corporated areas. Idyllwild and the wine country were identified as other areas where these rentals occur.

On a 4-1 vote, the board agreed to redraft the ordinance and bring it back in the future. Benoit's intention is to regulate the industry and not ban it.

Benoit introduced the

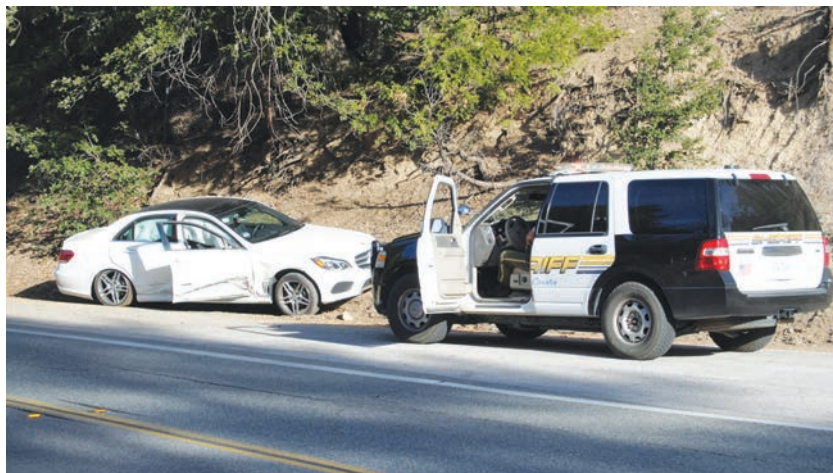
Two Hill traffic incidents during last week, one with serious injuries

Two traffic incidents, one with serious injuries, marred Hill roads over the last week. According to California Highway Patrol Officer Ben Bolon, the first occurred at 2:30 p.m. Friday, Nov. 20, when Gia Hongbin, 19, of Corona, was driving a 2015 white Mercedes sedan southbound on Highway 243 near lower Saunders Meadow Road when she crossed over a double yellow line to pass a truck in front of her. In pulling into the northbound lane, Hongbin swerved to avoid a head-on collision with a 2011 silver Toyota Tacoma truck driven by Donald Rhodes, 60, of Temecula. The right front side of Rhodes' truck scraped along the right side of Hongbin's vehicle. Neither driver required medical transport, according to Bolon.

At 2:50 p.m. Saturday, Nov. 21, Christopher Jones, 30, of Wildomar, was riding his 2007 Suzuki motorcycle on Highway 74 east of the junction with Highway 243 when he lost control on a sharp curve and laid the bike down. Jones suffered serious injuries, according to Bolon, and was transported to Riverside County Regional Medical Center in Moreno Valley. No other vehicle was involved in the incident.

Christopher Jones, 30, of Wildomar, crashed his blue 2007 Suzuki GSX R 600 around 3 p.m. Saturday. Jones was traveling westbound on Highway 74 east of Highway 243 when he lost control and skidded off the highway. He suffered a fractured left arm and left ankle, according to California Highway Patrol Officer **Mike Murawski**. Jones had no recollection of the incident, and American Medical Response transported him to a local hospital for further evaluation. CHP, Riverside County Fire, AMR and Idyllwild Fire all responded to the incident.

Supervisors already proclaim local emergency due to El Niño

With all the warnings that the approaching El Niño weather pattern and its accompanying rains will be greater than the 1997-98 rainfall, the Riverside County Board of Supervisors has already adopted a proclamation of local emergency.

Emergency Management Department Director Kim Saruwatari made the unusual request. In her memorandum to the board, she said El Niño would have, "...an extremely high probability of severe rains, damaging floods, devastating mud

and debris flows, and imminent peril to residents of Riverside County."

The county has prepared a Concept of Operations plan that defines the roles and responsibility of county agencies if dangerous flooding occurs. The plan addresses topics such as mitigation, preparedness, response and recovery.

For example, the plan recommends purchasing 500,000 sandbags for distribution throughout the county.

The upcoming community meetings in Idyllwild, Anza and Pinyon are part of the plan's effort to reach out to communities and educate residents of the impending threats.

Community outreach meetings

7-9 p.m. Thursday, Dec. 10, Pinyon Community Council meeting (CSA 60)

Although the emergency proclamation is being requested before the presence of flooding or other emergency incidents, Saruwatari stated, "With this proclamation of local emergency in place before the effects of El Niño are felt in Riverside County, the legal processes will help to expedite mitigation activities in flood-prone areas, and the resource requesting process will help in response and recovery efforts. Mitigation and preparedness ef-

forts are essential to keeping our residents and critical infrastructure safe."

The proclamation establishes EMD as the primary agency to manage any emergency incidents within the county. As such, they may direct any county agency to respond, even if it outside the normal authority.

Another paragraph authorizes agencies, with board approval, to waive permitting fees for restoration of essential services and activities.

Idyllwild Fire Finance Committee still trying to improve reports

Although its contract accountant could not produce the financial reports for October, the Idyllwild Fire Protection District Finance Committee did review some reports that had data through September, the first quarter of the fiscal year.

Again this month, Committee Chair and Commissioner Nancy Layton expressed disappointment with the presentation of the financial data available.

According to the reports, IFPD spent \$145,000 more than the revenue it collected during the first quarter of 2015-16. However, the five months from July through November is the period when its income is the lowest. The first property tax receipts are not realized until December.

This is the reason the agency requested a \$350,000 advance from the county during the summer. While that will help, the budget report includes nearly \$250,000 in revenue for assisting in fires outside the district. This is what was requested, however, and not the actual cash reimbursement. Consequently the \$145,000 deficit underestimates the real financial situation during this quarter.

Reports show the district had nearly \$450,000 in cash at the end of Septem-

ber; Layton reported the cash balance last week had dropped to about \$215,000. The first property tax receipts arrive in December but much of that amount will repay the tax advance.

Early in 2016, Fire Chief Patrick Reitz said IFPD plans to re-issue a request for a contract for accounting support as well as the possibility of a new contract for an audit later in the year.

Committee member Sue Weisbart recommended that Reitz consider assigning more of the financial

processing, such as check preparation work, to his administrative assistant and use the savings from hiring an a certified accountant to hire another administrative person so staff can man the front desk five days a week.

Layton reported that new accounting software had been purchased and she plans to have it installed, transitioning from the current software by Jan. 1.

Thanksgiving reunites us with family and friends. We give thanks for what we have, and share a nice, long meal — even if it's vegetarian — and, of course, we dance a special dance.

Send IFPD a message. Asking for more tax dollars isn't the answer with so many concerns. Don't feed this monster. IFPD can be replaced with Cal Fire and AMR tomorrow at no additional cost. Do what's right for your family.

General relativity 100 years and still going ...

Since becoming your science writer, I have been asked several questions related to discoveries about how nature works. One I've been asked repeatedly is, "What theory we accept as true today will one day be proven wrong?"

My answer is usually the same, "I don't know." One day we may discover that the Earth does not actually go around the Sun, one day we may learn that we are not made of atoms or one day we may learn that we are not evolving just like every other creature in the tree of life.

But for any of those scenarios to be correct, they would need to have a theoretical framework that can be proven correct (obviously based on how nature works and not how we would like it to work).

This month marks the 100th anniversary of Albert Einstein completing his general theory of relativity.

By 1905, Einstein had found that the laws of physics are the same for all non-accelerating observers. He concluded that the speed of light within a vacuum was independent

of the motion of all observers no matter what speed the observer travels.

This theory of special relativity introduced a new framework for all of physics and proposed a new understanding of space and time. Ten years later, he determined that massive objects can actually distort what he now described as space time — exerting a force of attraction on one another. This force is what we know as gravity.

Two hundred years earlier, Sir Issac Newton had quantified the gravity between two objects when formulating his three laws of motion. However Newton's laws assumed that gravity was an innate force of the object acting over a distance.

When completing his equations, Einstein realized not only that massive objects caused a distortion in space time, but no innate force was needed for gravity to work.

Imagine setting a heavy rock in the center of a trampoline. The rock presses down on the fabric causing it to distort the fabric. If you release a marble on the edge of the trampoline it will spiral inward toward the rock. This works in the same way that the gravity of a planet pulls at rocks in space.

So why doesn't the Earth get pulled in by the Sun or the Moon get pulled in by the Earth? The Earth also has some sideways momentum in relation to the Sun, as the Moon does to the Earth. This motion we know as their orbits.

In other words, we are moving sideways fast enough that a constant distance is maintained despite our acceleration toward the Sun. I just throw this topic out there not simply to remind us of Einstein's achievements 100 years later, but to make the holidays a little more lively when not watching football all day.

As for me, I already know what awaits — my grandma's tirade about how she will believe in evolution when she sees a "chimp driving a car or flying an airplane."

I love you, Nana.

ANOTHER POINT OF VIEW

Animal Rescue Friends of Idyllwild is an all-volunteer organization dedicated to helping dogs and cats in need. ARF is not a shelter and relies on foster families to house dogs until forever families are found. ARF does have a small cattery for cats in need, but can house a maximum of 10 cats only.

ARF is the only go-to rescue for mountain community residents who have found a stray dog or cat, lost a dog or cat, or who need help in rehoming a pet.

When ARF receives a call from a mountain resident who has lost pet, a volunteer (or volunteers) will assist the resident by spreading the word via social media and, when possible, will physically assist in a search. ARF also assists by posting "lost dog" signs in the area the dog was last seen.

When someone needs help in rehoming a pet, ARF cannot always take the pet into its possession. If there is room in the cattery and the cat is able to co-exist with the existing cat population, ARF welcomes it with open arms. If there is no room, or the cat will not work out in the cattery, ARF will assist the cat's owner through an assisted adoption where ARF volunteers, through various avenues, help to find a new forever home.

When a dog needs to be rehomed, ARF cannot take possession of the dog unless a foster family is available. Herein lies the biggest challenge facing ARF.

As it now stands, ARF has only two foster families. One

of the foster families is able to take only very small, house-trained dogs. The other foster family can take only a dog that will get along with their own dog. If the dog being surrendered does not meet one of these two criteria, ARF is unable to assist except for an assisted adoption.

ARF's hands are tied. ARF cannot take in a dog (whether it is being surrendered or is a "found" stray) unless there is a foster family willing to step up and help.

Unless more mountain residents decide to open their hearts and homes to help, ARF's program is in jeopardy. With no foster family available, stray/lost dogs brought to ARF will have to be taken to the San Jacinto Valley Animal Campus as ARF has no place to house the dogs. ARF does not want to be put in this predicament of wanting so badly to help the pet, but not being able to because of a lack of foster families.

Foster families are not left on their own when taking in a dog. ARF provides all food, bedding, medical care and dog training. What are the requirements for being a foster? Foster families need to have a secure yard and be willing to work with the dog, possibly in house-training and good manners. Fosters are asked to bring the dog to the ARF House during its open hours on Saturdays and Sundays.

And in return, the foster family receives endless love from a beautiful pet and the knowledge that an innocent life has been saved. Potential fosters are encouraged to contact ARF for more information at 951-659-1122. Please leave a message and a volunteer will return your call within 24 hours.

Idyllwild Water focusing on wastewater projects

Says goodbye to two directors, will welcome new directors in December

While the business conducted at the Idyllwild Water District's Nov. 18 meeting carries several projects forward into the future, the board also took time to salute two directors whose terms are ending.

Warren Monroe, first elected in August 2003, and Dean Lattin, appointed in 2013, completed their service. New directors Steve Kunkle and June Rockwell will be sworn into office at the Dec. 16 IWD meeting, General Manager Tom Lynch announced.

Much of the board's actions addressed matters affecting the sewer system and waste-treatment plant. The current Sewer System Management Plan was amended to allow for pre-treating waste entering the system.

Idyllwild Brewpub plans to treat its waste before it enters Idyllwild's sewer system, which Lynch said, "Will improve the quality of the discharges to acceptable treatment levels to discharge into our wastewater system."

IWD's current sewer plan did not address pre-treated waster, so this amendment allows IWD to continue to work and negotiate with the brewery without adopting a specific ordinance to regulate pre-treatment requirements, Lynch told the board.

Before the brewery begins operation, IWD will require a Sewer Connection and Use Permit, stipulating operation of machinery and disposal methods. The next step will be

negotiating a memorandum of understanding between the two entities, which "will specifically address the particular details of the brewery discharges and will include limits to various material chemicals and the timing of discharge releases," Lynch stated.

The board approved hiring Separation Processes Inc. of Carlsbad to assess whether microfiltration could and should be incorporated into the design of the future recycled-water facility. The project should be completed within six to eight weeks, according to Lynch.

He reported that the engineering companies interested in designing the plant have raised questions about using microfiltration; therefore, Lynch recommended IWD evaluate its inclusion before issuing a design contract. This work

will cost about \$32,500 and will be reimbursed from the state grant for the recycling project.

The board also approved using \$21,000 for equipment to help automate its wastewater treatment plant.

"The district could save money, effort and water by minor upgrades to the original Filtronics systems," Lynch reported. IWD has older and seldom-used Filtronics equipment at the plant, which can be upgraded to improve efficiency.

Lynch plans to add this equipment to the network to enable remote control and monitoring.

In water business, Lynch reported that the groundwater level for many of the district's wells has risen as a result of the fall rains. For example, Foster Lake wells were 3 feet higher in October than September and even higher than in the autumn of 2014. The downtown wells also are higher.

However, Foster Lake remains dry and "TWD is still in stage 2 [water emergency] and the Stage 3 triggers are close," Lynch stressed.

Water usage in October was 5.4 million gallons, which was 1.4 million gallons or 21 percent less than October 2014. For the year 2015, water usage has totaled 62.4 million gallons, which is 10.2 million gallons or 14 percent less than the same period in 2014.

The lower water usage resulted in an accompanying \$32,000 fall in water sales revenue compared to September. Revenues declined about 25 percent while usage fell 16.5 percent.

"Although revenue was down, expenses were down, too," said Hosny Shouman, chief financial officer. "But the net income was \$4,600 for October."

Water losses also declined from 3.75 percent of production last month to 1.1 percent in October.

Fern Valley customers save water while revenues fall

Water usage during the September and October period at Fern Valley Water District was 1.1 million gallons less than the same two months in 2014. For the year, Fern Valley customers have reduced consumption nearly 3.5 million gallons compared to the first 10 months of 2014. The October savings was about 16 percent and for the whole year consumption is nearly 12 percent less than in 2014.

Compared to consumption in 2013, which is Gov. Jerry Brown's and the State Water Resources Control Board's benchmark year, Fern Valley consumption is 26 percent less.

The results of the reduced consumption appear mixed. General Manager Steve Erler reported that well production increased 20 percent in October from

September. However, the groundwater level of the district's wells fell again in October. For example, the observation well at the district office fell almost 7 inches and is now nearly 4-and-a-half feet below the October 2014 level.

Director James Rees acknowledged the customers' water saving, but President Robert Krieger also recognized that the conservation resulted in a drop in water sales revenue.

The September and October billing period generated sales of about \$43,100, which is \$12,700 or 23 percent less than the same period in 2014.

Erler mentioned that the Idyllwild Fire Department needed about 60,000 gallons of water to extinguish the house fire on Scenic Drive on Nov. 15. This usage will appear in the November and December billing report, he said.

Erler also announced

the completion of the pipeline project along San Jacinto, Tahquitz and Rim Rock roads. While a final payment remains due, the whole project was about \$135,000 below the original budgeted figure.

The board also reviewed the draft audit report and expects the final audit to be available at the December meeting.

Forest Service to begin prescribed burns

Prescribed burning operations in the San Jacinto Ranger District of the San Bernardino National Forest will begin in the next few weeks, according to a U.S. Forest Service release.

Firefighters will be burning slash and debris piles adjacent to Forest Service fire stations. Signs will be posted along the roadways to alert passersby to the burning activity. The Forest Service will send out occasional reminders to the public, alerting to potential smoke in the air.

Winter burning projects also will resume as part of a continuing effort to reduce the threat of catastrophic wildfire and improve forest health. The

prescribed fire program will continue through the winter and spring months as weather and conditions permit.

Prescribed fires, including both understory and pile burning, are intended to reduce the amount of vegetation — such as needles, small plants, brush and small trees — that can carry fire from the forest floor into the treetops. Studies and experience have shown that prescribed fires will stimulate the growth of grasses, forbs and shrubs that provide food for deer, mountain quail and other wildlife, the Forest Service reported in its press release.

Gender-based violence subject of evening discussion

Gender-based violence is the concern of a new group on the Hill and the subject of a public event Tuesday, Dec. 1. Callie Wight, a member of the group, says its formation was not a reaction to incidents on the Hill and stressed that children who live here from high school to later, spend considerable time in environments where this preparation will be beneficial.

The origin is the Center for Women's Global Leadership at Rutgers University. Members of St. Hugh's Episcopal Church have been involved in the center's programs for many years, according to Vicar Daniel Rondeau. The center's 2015 topic is "16 Days of Activism Against Gender-based Violence Campaign," which runs from Nov. 25 to Dec. 10.

However, the St. Hugh's group, which is named the Mountain Communities Alliance Against Gender-based Violence, will address the issue throughout the year.

"If your community has children in school, we want to keep the school children safe from gender-based violence," he explained. "We hope to show parents how to identify gender-based violence and give kids and parents the courage to face that."

While youth in their mid-teens have the highest rate of sexual assault, the group is not implying this is rampant in Hemet or Anza. "Nevertheless, these are much bigger communities and can be an initial cultural shock to students from the Hill," he said.

"We want to bring to the community that it can and does happen here," said Julie Steiger, a local therapist and social worker, who is a member of the local alliance. "I've lived here two years and it's definitely a problem which we don't speak about. Whether it's secrets or shame, we don't talk about it."

The purpose of the December event is to provide parents and kids with tools to deal with these situations, said Mary Morse, director of the Spirit Mountain Retreat Center and one of the group's members. The intent is to distract the attacker and defuse the incident.

"For example, if someone sees another person being teased or bullied, rather than saying nothing, these tools will give them something to say, which can help alleviate the situation," Rondeau added. "If one person will intervene, it often empowers the entire group."

The basic structure of the tools is to offer a statement that challenges the behavior, asks questions about the situation, employs "I" statements and makes it personal.

For example, if one sees someone harassing another student, the can say, "Stop being a jerk." The challenge is to tell the harasser to stop and the behavior is not OK.

Questions such as, "Why are you acting this way?" or "What's your goal here?" can be raised. Besides the use of "I" statements, it becomes personal for the perpetrator when asked, "How would you feel if some guy treated your mom or sister or girlfriend that way?"

Besides a discussion of the tools and their use, participants can discuss the whole problem, Wight said. What is gender-based violence? What's going on in the world? Solutions will be part of the discussion.

Morse also stressed that men — homosexuals and transgender — can be victims of sexual assault, too.

Two practitioners will be at the event. One of the featured speakers will be Gayle Hepner, executive director of the Center Against Sexual Assault of Southwest Riverside County. She and Steiger have significant experience working with survivors of this form of violence. They can speak to the reactions, consequences and long-term feelings.

"There are not a lot of resources here. This evening will give awareness to the problem and let people talk about it," Steiger said. "This can reduce the shame and embarrassment, so the victim does not feel so alone."

The importance of survivors participating is powerful, they all stressed, especially to learn how to handle a situation and its repercussions.

At the conclusion, Rondeau hopes all who attend will depart with an awareness of the problem and what can be done to change it. "It's the need for a powerful bystander," he said. And Morse re-enforced the point,

with her comment, "Intervening can make a difference."

The presentation "Beyond Bystander: Keeping Youth Safe From Gender-based Violence" is from 6 to 7:30 p.m., Tuesday, Dec. 1, at the Rainbow Inn. For more information, you may call 951-634-4048 or visit the Facebook page, Mountain Communities Alliance Against Gender-based Violence.

On this Thanksgiving, former Marine and American Legion Post 800 Commander Danny Richardson will remember a Thanksgiving many years ago in Orrick, Missouri.

Richardson, then a fresh-faced Marine, and his high school cheerleader sister answered a frantic knock at the door several days before Thanksgiving. There, in the cold, stood his sister-in-law with her two infant daughters, snugly wrapped in snow suits. One was 6 weeks old and the other 15 months. Richardson's brother knew nothing of what his then wife was doing. After first asking for Richardson's parents who were at work, she left the infants in the arms of Richardson and his sister, explaining she could no longer care for them.

Richardson's parents took in both the girls and their father when he returned from work. The fa-

ther and daughters would stay four years with his parents until he met the woman who would choose to become his wife and mother to his children.

Forty years later, Richardson and his sister again held their nieces as they said goodbye to their father as he lay dying.

In speaking at the funeral, Richardson said he was so grateful that he had told his brother he loved him, something that does not come easy for men of that generation in that part of the country.

"It's Thanksgiving and saying 'I love you' to those you love is important," he said. "I am thankful I told my brother how I felt before he passed."

Richardson thought it important to share his family story in the hope that it would remind others of how much we have to be thankful for — for friends and family and the love we share with them, throughout our lives together and especially at Thanksgiving.

Safety deserves a place at the Thanksgiving table

Keep an eye on what you fry ... or grill ... or broil. And never leave stovetop cooking unattended.

This is true all year, but especially on Thanksgiving Day, which has three times more home fires than any other day largely because of unattended stovetop cooking, according to the National Fire Protection Association.

In its most recent report, NFPA said 1,550 cooking fires occurred on Thanksgiving in 2013, marking a 230-percent increase over the daily average of 470 cooking fires that year.

"People might want to leave or even run to the store," said Randall

Wright, an inspector and nine-year veteran of the L.A. County Fire Department. "It's not worth it. We never want to leave the stove unattended or leave the home with any cooking appliances on. Either turn them off or have someone else watch them for you."

More than 60 percent of cooking fires start on stovetops and about one-third of them result from unattended cooking. On Thanksgiving, these fires cause an estimated 10 deaths, 50 injuries and \$28 million in damage.

Wright, however, cautions that "when there's a grease or electrical fire, don't put water on it." Instead, start by putting a lid atop a burning item, turning everything off and having the fire extinguisher ready if it spreads.

Frying is the culprit in

two-thirds of stovetop incidents. But while cooking is the leading cause of home fires and their injuries and the third-leading cause of home-fire deaths, damaged appliance and extension cords are another leading reason for fires and electrical incidents.

"Frayed or worn cords are dangerous in a couple of ways," said Don Neal, director of Corporate Health and Safety at Southern California Edison. "They, of course, could potentially spark a fire, but they also no longer offer people protection from shock or serious injury. Bad cords should be replaced immediately."

Never plug more than one large appliance into an outlet and never plug large appliances such as refrigerators or space heaters into extension cords that

should also only be used temporarily.

All countertop appliances should also be plugged into Ground Fault Circuit Interrupter (GFCI)-protected outlets in addition to being placed away from the sink. And people should never disconnect their smoke detectors while cooking.

Underwriters Laboratories (UL), the top independent product safety organization, still refuses to certify turkey fryers, which cause about 700 fires, 40 injuries and \$19 million in damage annually.

"From entertaining to talking on the phone, checking emails or watching television, distractions should never compromise safety while cooking this Thanksgiving or on any day," said Neal.

MDP partners with Idyllwild Pines to offer disaster medical care

Dr. Dick Goldberg, Mountain Disaster Preparedness' medical director, has long sought an Idyllwild facility in which post-disaster medical treatment could be conducted.

Goldberg noted the Idyllwild Fire Department would likely be overwhelmed as an incident command center and the two local medical clinics, if open, would also be swamped with walk-ins.

Goldberg is a retired emergency room physician with experience shaping disaster responses and setting up emergency clinics in New Orleans, after Katrina, in the Dominican Republic after the Haiti earthquake, and also in the Philippines and Japan.

MDP, with its core medical group of Goldberg, Dr. Ken Browning and 11 volunteer nurses, LVNs and others experienced in trauma care, has the expertise and personnel to provide post-disaster treatment but has lacked a facility.

That is no longer the case. Kelly Schlenz, new operations director at Idyllwild Pines Camp, continues the community outreach of which his father had been a part when he was camp director. Schlenz and his board have agreed to allow MDP to use McNeil Hall, the largest facility on the Idyllwild Pines campus, as a medical treatment and surgery center in the event of a significant disaster that isolates Idyllwild for an extended period.

"This is a critical piece that has been missing," said Goldberg. "It is such an important element for our disaster response."

For Schlenz, it was a "no-brainer" to form this liaison with the community. Schlenz is a "Hillbilly," having attended kindergarten through eighth grade at Idyllwild School and ninth through 12th grades at Hemet High. He also is fourth generation at Idyllwild Pines. His great-grandfather, Earnest Schlenz, volunteered as a groundskeeper at the camp; his grandfather Walt and father Paul both held the position of executive director for a combined 50 years.

Schlenz grew up at Idyllwild Pines and now lives, with his family, in the same house in which he grew up. "This is an opportunity to support the community and play a role in a disaster," said Schlenz. "I grew up here and want to continue to be a part of the community."

Goldberg expects the pieces to be in place within two weeks, including a mobile storage facility for medical equipment to be located near McNeil on the Idyllwild Pines campus. He noted members of his core medical group have backgrounds in critical care, obstetrics and counseling — valuable components to deal with the most common post-disaster problems such as muscular/skeletal injuries, precipitous deliveries (births) and post-traumatic stress.

Even though the agreement with Schlenz and Idyllwild Pines is a plus for the community, Goldberg cautioned that it is not an all-situations solution. "We don't want to give the impression we can care for a large number of people," said Goldberg. "We'll still have limited capacity and will only be able to care for the most serious cases. We need to have the community be as self-sufficient as possible." Goldberg stressed preparation — having adequate storage of family medications, first-aid supplies, equipment and, especially, water. "Everyone needs to have clothing and blankets sufficient to prevent exposure to the elements," he said. "Preparation ultimately involves having adequate food, shelter and water after a disaster."

Goldberg noted MDP has information available to the public to help in preparing for disaster scenarios. Common post-disaster injuries include dust-related problems that interfere with breathing, foreign bodies in the eyes and lacerations. Goldberg recommends stocking remedies for dealing with these most common issues.

A life purpose with 88 keys

In many cultures, coming of age begins at 12. For Luann Hanf Carman, it was when she found her personal purpose and passion, the piano. "My parents divorced [when I was age] 12," she remembered. "The piano was my way to shut the door. No one was making me play. I just loved it."

For Carman, it was not to be a solitary experience — years of lessons and practice all geared to solo classical recitals and performances. "Immediately, I found a way to make it social, to get out there with it, to play in pit bands and to accompany the high school chorus," she said. "I've always directed my own path."

There is a certain affirmative stability for any who find their life path early — a reassuring knowledge that they are pursuing a course that is authentic for them. Once Carman discovered the piano, 88 keys to her future, she did not look back. The New Jersey native attended college as a piano performance major at California State University, Long Beach. "At that time the music department was one of the best," she said. "I was surrounded by world-class jazz musicians. The classical training was integral, absolutely the foundation. But I realized that studying and playing the classical masters was essential but not, for me, an end in and of itself. I learned, through jazz, how important improvisation is."

For Carman, that exposure to jazz was one more key to her own musical authenticity. "One of the things I like to do is to blend styles, to be creative with all I've learned and all I've done. And playing in ensembles, being collaborative and supportive, has been a major part of my work."

Carman continued her piano performance studies at the University of California, Santa Barbara, obtaining her master's degree in piano performance. Then it was immersion in the Los Angeles and Orange County music scene, playing gigs and teaching. Carman taught at Cerritos College in Norwalk, Golden West College in Huntington Beach, California Lutheran in Thousand Oaks, Rancho Santiago College in Santa Ana and Cal State Fullerton. She taught jazz harmony, classical piano, electronic music, songwriting, ear training, music appreciation, applied piano, synthesis, arranging, MIDI and sequencing, and the history of jazz.

But the gigs grew wearisome. Booked into cushy upscale parties and events by the entertainment agency with which she was signed, she experienced a class separation that musicians sometimes experience — to be the featured entertainment at a party but asked to eat with the help in the garage. "There was this feeling of disdain from the music patrons," she remembered. For Carman, it wasn't so much about the class separation, it was about where she was playing — the L.A. and Orange County music and party scene.

She needed a break and took it when she and musician husband Paul Carman moved to Idyllwild. "There was a period of 10 years when I stopped playing," she said. "I needed the seclusion and the time to raise my boys. The joy in the playing had ebbed."

"During that time I would look over at my piano bench, which was 10 feet away, and I would think, 'I don't know how to get over there.'"

Love is a strong emotion. Three or four years ago, Car-

man realized what she wanted. "I wanted to fall in love with playing again," she recalled. "I knew I couldn't do what I was doing when I had quit. It had to be something different."

She was hired by Idyllwild writer Ken Luber to play a musical that was in development. "I was sitting there in the room with the composer and lyricist and book writer as they were putting it together and I thought, 'This is cool. It is collaborative and part of being in the creative process, just like Rodgers and Hammerstein in their formative moments.'"

And it was that door in, being part of the creative and collaborative genesis of new work, that helped Carman reboot her music career. "Accompanying is one of my strengths," she said. "I like being where the energy is. It's exciting when people are doing what they love."

And Idyllwild provided the place to reboot. "Part of not wanting to play was a symptom of what was going on in my life," she said. "Coming here was bittersweet but I really needed the seclusion. I needed to fall in love with life again. I'm still working on my reboot — being more authentic. All of this has been a very rich experience in every way. This part of my life has been about opening, not closing off, listening to my gut and being myself."

Carman has been busy — as rehearsal and performance pianist for the Inland Valley Symphony Orchestra, the Southwest Women's Chorus in Temecula, the United Church of Christ in Temecula and Idyllwild Master Chorale's musicals. Her son Isaiah is a songwriting major at Idyllwild Arts Academy and she said one of her greatest joys is studying with him. "I teach through discussion," she said. "I stay out of the way and I'm there to support."

For Carman, finding her joy early in life, and returning to the piano with new energy has been a reaffirmation. "Once I started playing, I had to play and keep going. It was just one of those things."

40 years ago - 1975

The Idyllwild Inn or Shop-In, an abandoned landmark in the center of town that had become an eyesore, was going to be demolished because it was a fire safety hazard.

35 years ago - 1980

The mountain-area Red Flag Patrol, a group of volunteers organized by the U.S. Forest Service and the Izaak Walton League to patrol Highway 243 during periods of low humidity and Santa Ana winds, were called out a record of five consecutive days.

30 years ago - 1985

The recent snowstorm was enough to allow California Department of Forestry and Fire Protection officials to call an end to the 1985 fire season.

25 years ago - 1990

Because of a proposed replacement of the Strawberry Creek bridge, nearby businesses were concerned that the two-week absence of highway traffic would impact sales.

20 years ago - 1995

Doris Lombard's "artistic, literary and science-savvy" third-grade classroom won first place in the Wildlife Art Festival for the fourth time.

15 years ago - 2000

Due to low student enrollment at Idyllwild School, a middle school teacher was going to be laid off, a Hemet Unified School District decision

that had many parents and teachers alarmed and worried.

10 years ago - 2005

Posing as Riverside County Fire Department Station 23 volunteers, scammers had been calling Pine Cove residents soliciting donations. Residents were quickly notified.

5 years ago - 2010

The Hemet High School Girls' Volleyball team won the new California Interscholastic championship. The Hemet girls defeated the Upland Church Academy in three very close games.

1 year ago - 2014

Idyllwild Skate Park, which opened in 2004, was closed until further notice until sufficient funds were raised to complete a full rehabilitation of all ramp surfaces.

Food safety resources for Thanksgiving troubles

Thanksgiving is the largest meal many cooks prepare every year. Its centerpiece — the turkey — is the largest dish most cooks ever encounter, and many are not experienced at roasting one.

The U.S. Department of Agriculture wants consumers to know that a range of resources, from smartphone apps to its 30-year-old Meat and Poultry Hotline, exist to help consumers through any food preparation conundrums this holiday season, wherever and whenever they may arise.

"Unsafe handling and undercooking of your turkey can lead to serious foodborne illness," said Al Almanza, USDA deputy under secretary for Food Safety. "USDA's Food Safety and Inspection Service has a variety of food safety resources to help with any questions related to preparing Thanksgiving dinner, including our Meat and Poultry Hotline that will be staffed with helpful experts on Thanksgiving Day."

This Thanksgiving more than 46 million turkeys will be eaten. Cooking the Thanksgiving turkey can be tricky, and trying to figure out when the turkey is done is often the hardest task. But, it doesn't have to be. Impress your family by using a food thermometer to cook like a PRO: Place the

thermometer, Read the temperature, Out of the oven.

- Place the thermometer in the innermost part of the thigh, the innermost part of the wing and the thickest part of the breast.

- Read the temperature to make sure the bird has reached a minimum internal temperature of 165°F.

- Take the turkey Out of the oven, and serve it to your family without worry.

Planning ahead:

For big Thanksgiving dinners, planning ahead is very important. You can assess your pantry, refrigerator and freezer to plan out your meals and your shopping list. When you are trying to figure out if you can use something you already have at home, keep the FoodKeeper application handy.

The FoodKeeper is a mobile application created by FSIS in partnership with The Food Marketing Institute and Cornell University. The FoodKeeper offers storage advice on more than 400 different food and beverage items and can help you decide what you can keep and what you should throw out.

It also offers handy guidance on leftovers, which you'll

probably have a lot of after the big meal. Download the FoodKeeper today on your Android or iOS device.

If you have questions about your Thanksgiving dinner, you can call the USDA Meat and Poultry Hotline at 1-888-MPHotline (1-888-674-6854) to talk to a food safety expert.

Last November, it received more than 3,000 calls mostly about Thanksgiving dinner. You can also chat live with a food safety expert at AskKaren.gov, available from 7 a.m. to 1 p.m. Pacific time, Monday through Friday, in English and Spanish.

If you need help on Thanksgiving Day, the Meat and Poultry Hotline is available from 5 a.m. to 11 a.m. Pacific time.

Consumers with more food safety questions may visit FoodSafety.gov to learn more about how to safely select, thaw and prepare a turkey. FSIS will provide Thanksgiving food safety information during November on Twitter, @USDAFoodSafety, and on Facebook, at Facebook.com/FoodSafety.gov.

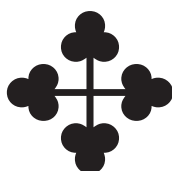

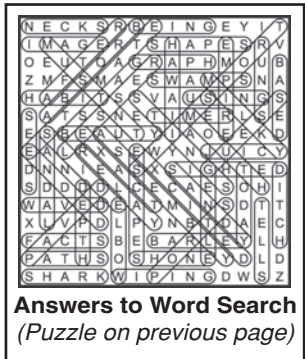

Supervisors already proclaim local emergency due to El Niño

With all the warnings that the approaching El Niño weather pattern and its accompanying rains will be greater than the 1997-98 rainfall, the Riverside County Board of Supervisors has already adopted a proclamation of local emergency.

Emergency Management Department Director Kim Saruwatari made the unusual request. In her memorandum to the board, she said El Niño would have, "...an extremely high probability of severe rains, damaging floods, devastating mud and debris flows, and imminent peril to residents of Riverside County."

The county has prepared a Concept of Operations plan that defines the roles and responsibility of county agencies if dangerous flooding occurs. The plan addresses topics such as mitigation, preparedness, response and recovery. For example, the plan recommends purchasing 500,000 sandbags for distribution throughout the county.

The upcoming community meetings in Idyllwild,

Anza and Pinyon are part of the plan's effort to reach out to communities and educate residents of the impending threats.

Although the emergency proclamation is being requested before the presence of flooding or other emergency incidents, Saruwatari stated, "With this proclamation of local emergency in place before the effects of El Niño are felt in Riverside County, the legal processes will help to expedite mitigation activities in flood-prone areas, and the resource requesting process will help in response and recovery efforts. Mitigation and preparedness efforts are essential to keeping our residents and critical infrastructure safe."

The proclamation establishes EMD as the primary agency to manage any emergency incidents within the county. As such, they may direct any county agency to respond, even if it outside the normal authority.

Another paragraph authorizes agencies, with board approval, to waive permitting fees for restoration of essential services and activities.

The ignition of all prescribed burns is dependent on the availability of personnel and equipment, and appropriate conditions, and in coordination with the National Weather Service and South Coast Air Quality Management District before and during prescribed burns in order to manage smoke production and minimize impacts as much as possible.

Fire managers follow a burn plan that outlines the "prescription" or environmental conditions, such as temperature, wind, fuel moisture, ventilation and relative humidity that need to be present before the project begins. When the criteria are met, crews implement, monitor and patrol each burn to ensure it meets the goals and objectives outlined by managers.

In addition to the station pile burning, the public may also see smoke from pile-burning activities in the following San Jacinto Mountains forest locations over the next several months:

- Prescribed fire on Thomas Mountain, east of Ramona Indian Reservation and west of Garner Valley.

Slash and debris piles burning:

- Unit 1 Pine Cove, south and west of Pine Cove
- Unit 2 South Ridge, south of Idyllwild
- Unit 3 Strawberry/West Ridge, southeast of Strawberry Creek and west of Dry Creek
- Near various fire stations

PCT junction with Cedar Spring Trail, north to the junction with Apache Spring Trail, as well as the 1.5 miles of the Fobes access trail.

Funding (\$250,000) for this work was secured this year. Repair and maintenance work began on the Fobes access trail and Phase I of the PCT in September. Organizations helping with this work include the Urban Conservation Corps, American Conservation Experience and PCT Association crews.

"It is anticipated, depending upon weather, that most or all of the repair and maintenance work for phases I and II of the PCT project and the Fobes trail will be completed ... by the end of summer 2016," Ladley wrote in a recent email to the Town Crier.

But the damage to the rest of the trail was much more severe and will require

more money and time. Almost a year ago, in January, California State Park trail experts completed an extensive trail assessment for the Phase III segment of the PCT project (8.5 miles from the junction with Spitler Peak Trail, north to trail 3E41 at the Tahquitz Creek crossing), according to Ladley.

Funding has been requested, but may not be available until 2017 or 2018. When available, the current plan focuses first on repair and maintenance of the Spitler Peak access Trail, and storm proofing of Phase III (8.5 miles) of the PCT project.

Phase III of the PCT project will repair the most challenging portions of the damaged trail. Not only will the logistics be challenging, but there is extensive damage such as unstable soils on steep slopes (eastern face of the San Jacinto Mountains) and extensive rock retention wall reconstruction, according to Ladley.

Washington helps HELP Center for holidays

Third District Supv. Chuck Washington asked his board colleagues Tuesday, Nov. 13, to approve the use of Community Improvement Funds for several community

service agencies within his district.

The Idyllwild HELP Center is the beneficiary of \$2,000. Washington's memo said the funds would be used for the holiday program and winter support.

HELP Center clients

may apply one time per household per calendar year for a \$25 gift card to purchase holiday food.

The winter support is for \$30 for emergency supplies in anticipation of the coming El Niño and cold temperatures. The money may be used for

sandbags, traps and other emergency supplies, according to Washington's memorandum to the board.

proposal and made clear it was subject to revision after his colleagues had time to review it and discuss with their constituents. He stressed it would not be intrusive and would be easy to comply with.

Washington had already been involved but expressed some concerns about various aspects of the proposal, which Benoit's staff has been working on for nearly a year.

"It is important to have some regulation," said Supervisor John Tavaglione (2nd District). "But it is hard to compare large and small properties. Might be worthwhile to engage a small group of realtors."

The proposal would apply to single-family detached or multiple-family attached dwelling units, including apartments and condominiums. It would not apply to hotels,

motels, lodging houses or inns.

The growth of this short-term rental practice throughout the county has created many complaints and objections, according to the proposal. Benoit said one of its goals was to create some balance for neighborhoods in the unincorporated areas compared to nearby communities within cities such as Palm Desert and Cathedral City, which regulate this industry now.

However, Supervisor Kevin Jeffries (1st District) opposed pursuing the idea. He argued that the marketplace was able to make distinctions between hotels and inns, and rentals in private homes in residential neighborhoods.

"We don't need to level the playing field because these are market-driven issues," he said.

While the proposed ordinance will be revised,

the initial draft included some of these restrictions:

- Maximum overnight guests limited to two persons per bedroom, excluding children under age 3, and a maximum of eight bedrooms.

- Quiet hours between 10 p.m. and 7 a.m.

- All parking must be on site. Street parking for these rentals will be prohibited.

- Trash and refuse must be stored outside of public view.

- An owner or designee must be available 24 hours and able to respond to complaints with an hour.

- All properties within 100 feet must be notified of the owner's intent to list the property as a short-term rental.

Staff also made it clear that these properties are still subject to other county regulations and ordinances, such as fire and transient occupancy taxes.

Explaining the pro-

posal to the Board, Joseph Pradetto, legislative assistant on Benoit's staff, said many issues have arisen during the drafting of the proposed ordinance over the past year. These include trash, noise, disorderly conduct, zoning and more.

"The others issues don't matter as long as their sleep is not disturbed and they don't wake up to trash," Pradetto said.

And Benoit added, "Noise is the number one concern and this doesn't change the noise ordinance. It makes people aware of it."

One of the requirements would be a \$250 initial county fee for rental property and a \$100 annual renewal fee. County staff compared the regulations being developed in other county cities and Southern California.

The type of work necessary to repair the Pacific Crest Trail before it can be reopened.

- Brushing maintenance: Removal of living or dead vegetation within the trail way that is prohibiting the designed use of the trail or is out of compliance with the brushing standards for that trail.
- Down Tree Removal: Logging and removal of trees lying across the trail way.
- Tread maintenance: This work involves removal of all organic debris from the trail bed, removal of soil and debris on the inboard hinge and the soil berm on the outboard hinge of the trail to reveal the existing hardened tread surface, includes de-compacting; reshaping and compacting the entire trail bed to achieve proper out slope and sheet drainage.
- Drainage features: These features include rock or wood water bars and drainage dips. Cleaning, maintenance and resetting rock bars along tread surface will be necessary.
- Rock retention walls: Retention walls along sections of trail that have failed due to the fire will be maintained and repaired. This work includes gathering rocks, preferably ones left behind, and repairing the wall to Forest Service standards.
- Armoring switchbacks: Rocks will be placed throughout the interior of switchback climbing turns to mitigate water damage to trail tread. This technique is also beneficial in preventing users from cutting switchbacks and furthering trail and resource degradation.
- Signing: Replacing trailhead and directional signage at intersections.
