## Local lawyer and medic aids rescue effort in Lesbos

Idyllwild resident Mary Lehman has a history of aiding others. Whether as an emergency medical technician at fire camp, a lookout for the U.S. Forest Service or on ski patrol, showing up to help others who are injured or in distress is not new to her. So it was not surprising, after having discussed it with her husband, that Lehman decided to go to the Greek island of Lesbos, just south of the Turkish coast, to as-

sist refugees arriving from Syria and Iraq. "I knew about the drama and flood of refugees arriving there in the beginning of November," she recalled. "I booked my ticket Nov. 1 or 2 and departed on Nov. 10. I'm a problem-solving person. When I saw the need and realized I could go, I knew I had to go."

A distinguished lawyer, admitted to practice before the U.S. Supreme Court, federal Appeals Courts (third, fourth, fifth, ninth and 10th districts),

## County tells what it's doing to prepare for El Niño

Recommends residents prepare now

The effects of the rainfall from impending El Niño conditions create more responsibilities in the rural parts of River-

side County than urban residents will experience, according to several county representatives. They were on the Hill to discuss what local residents can do to prepare for the rain, run-off and potential prob-

lems.

The speakers encouraged an audience of more than 60 people Wednesday night, Dec. 2, at the Idyllwild Nature Center to "protect yourself, but don't harm your neighbors."

Cities have curbs, gutters and large drain sys-

tems, which will help remove the flowing and flooding water from those streets. Those urban conveniences are not present here. Many properties on the Hill are lower than the adjacent roadway. Locals need to prepare before the storms arrive.

Flood insurance is one option, said Robert Cullen, chief of the Design and Construction Division for the County Flood Control and Water Conservation District. For those who may be interested, he directed them to the website

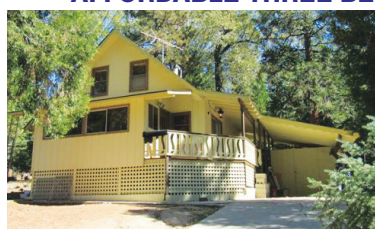

Other counts that day within the San Bernardino National Forest will be at Big Bear Lake, Lake Arrowhead, Lake Gregory, Silverwood Lake State Recreation Area and Lake Perris State Recreation Area.

# Attempted break-ins on same night

Both the Town Baker and the Kingdom Hall of the Jehovah's Witnesses experienced attempted break-ins on the same night, with the same basic modus operandi.

Paul Amick, co-owner of the Town Baker, reported that he received a call from his alarm service at 12:30 a.m. Sunday that his alarm had been activated. Amick reported that the vandal or burglar had destroyed the door leading into the kitchen, and ripped off and tossed security

lights into the yard. "It looked as if he had been there for a while, based on the level of damage that was done," said Amick.

Amick was told by customers that the same night the Kingdom Hall of the Jehovah's Witnesses also had suffered an attempted break in, with a door being badly damaged. That could not be independently verified as of press time.

In neither attempt did the individual succeed in gaining entry into either structure, according to Amick.

Inquiries made to Hemet Station, Riverside County Sheriff's Department, were not answered prior to press time.

# Local avoids head-on collision with motorcyclist

Idyllwild local Stacey Grant avoided a head-on collision with a motorcyclist on Sunday, Dec. 6. Grant was driving her 2011 silver Subaru Outback west on Highway 74 around 11:00 a.m. just after the last turnout near the bottom of the Hill on the Hemet side.

Grant noted she had slowed as cars ahead of her pulled into the turnout, and was just speeding up, going about 35 mph, when several motorcycles rounded the horseshoe bend into which she was headed. Grant said California Highway Patrol estimated the bikers were traveling at about 60 mph. Two made the curve and one seemed to be unable to control his bike and correct out of the turn. He crossed the double-yellow line and headed, according to

Grant, directly toward her, now in her lane and positioned for a head-on.

Grant said she started to correct into the other lane to avoid the head-on when the 19-year-old motorcyclist clipped the right front side of her car and then the mid-section of the right side.

Grant said her car was hardly drivable after the collision but she managed to get it back into the westbound lane and partially off the road. "My first instinct was to get any part of the car out of the oncoming lane," she said.

The biker was thrown from his bike into a culvert and required medical transport. Grant also required transport complaining of neck and hip pain.

As of press time, CHP did not have an official report of the incident.

# Town Hall will re-open for community recreation

Town Hall will reopen as the primary venue for county-managed community recreation, Scott Bangle, Riverside County Regional Park and Open-Space District parks director and general manager, confirmed Wednesday, Dec. 3.

In the Town Crier edition of Nov. 19, we reported the closure of Town Hall. A notice had been posted on the door stating, "Preliminary tests have determined this facility has material containing asbestos. Do not disturb." Recreation programs were relocated to the County Parks Nature Center on Highway 243.

Bangle stated in response to a Town Crier inquiry that a second inspection of the historic building revealed "... no obvious signs that would warrant an immediate response action [removal or abatement.]" He stated, "It was recommended that we consider undertaking some minor work as a precautionary, proactive measure."

Bangle said the recommended work would begin "as quickly as possible with the goal of returning [recreation] programs to Town Hall by January, if not sooner." Kyla Brown, Parks and Recreation bureau chief, said costs of estimated repairs would be less than \$2,000. Work began this week.

Previous inspections also revealed the presence of bat droppings in the attic, which also are being removed. "We will likely contract with a local pest control company to remove any bats that may still be inhabiting the attic area," said Brown.

A letter from William T. Cloake IV, superintendent of Community Parks and Recreation Centers, to parents and guardians of the Idyllwild Town Hall Afterschool Program participants, confirmed Bangle's and Brown's statements.

Verne Lauritzen, Riverside County 3rd District Supervisor Chuck Washington's chief of staff, stated the county made the decision to proceed with repair even though the month-to-month lease agreement could have been interpreted to require the building owners to do so. The repair will involve installing a false ceiling to seal the area beneath the asbestos. "The county just needs to do the right thing and get the community back in the

building," said Lauritzen.

Jay Johnson, whose family owns Town Hall, said he would be negotiating a longer-term rental agreement with the county for its continued use of Town Hall. The current agreement is month-to-month, based on the original contract with the county's Economic Development Agency, signed when the county began managing local recreation in 2011.

Riverside County manages local recreation for residents of County Service Area 36 (Idyllwild and Fern Valley). The county levies parcel taxes on CSA 36 property owners to fund community recreation. Those taxes, plus property taxes, yield annual recreation budgets in the neighborhood of \$200,000 (see article on page 7 regarding the role of the CSA 36 Advisory Council in reviewing how tax dollars are spent). Initially managed by EDA, tax-funded recreation and street light maintenance are now managed by County Parks and Open Space.

But when we landed back in Ontario Sunday and waited outside to deliver our granddaughter Mina back to her Mom, it was a different scene.

We sat for about 20 minutes watching cars parked in front of the terminal for longer than that with potential for holding explosives, etc. As travelers, we can't carry weapons but they can.

We looked all around the front of the terminal for security guards and saw none. Not one.

What happened to the security we saw following 9/11? What happened to obeying signs outside the airport that still instruct drivers not to "park or wait" for longer than it takes to drop off or pick up passengers?

I'm feeling less secure about flying out of Ontario just because of the lack of security outside.

## Losing what makes us tick

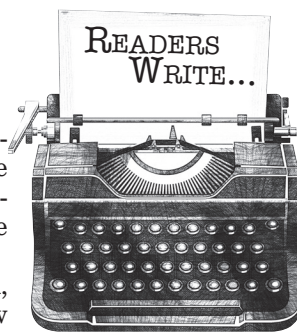
EDITOR:

# Journal from the James

## What's wild in Idyllwild? Bobcats ...

On Nov. 19, the Idyllwild Community Center sponsored my presentation at its Speakers Series at Silver Pines Lodge. The topic was the motion-sensitive cameras I've placed around Idyllwild and that I wrote about in a previous installment of "Journal From the James" (April 9, 2015).

The presentation was well attended and I enjoyed letting the audience know what we have been finding with the cameras. At the end of the presentation, I mentioned that we would like to make the information we are finding more accessible to all in Idyllwild who would be interested. I proposed putting together a "coffee table" book highlighting photos of each species captured by the cameras with pertinent natural history information on them. That way it is hoped the people of Idyllwild can not only become more aware of "what's wild in Idyllwild," but also learn a little

more about wildlife roaming around our town.

As a prelude to this effort, I will periodically provide in this column an example of what the book would present. For the first installment, I have chosen the bobcat. What follows is the type of information we would like to provide and hope it is of interest to readers. Feedback on what other information might be interesting would be useful in producing a book. That would indeed help us appreciate even more what's wild in Idyllwild.

Bobcats: alias catamount, lynx cat, wildcat and others. With the scientific name of *Lynx rufus*, the bobcat is taxonomically related to the Canadian lynx, both representing the only short-tailed wild cats we have in North America. Its species name, *rufus*, hints at the reddish (rufous) color and, of course, its common name refers to its short, bobbed tail.

Bobcats are found across most of the U.S. and into Canada and Mexico. Even in the areas where they have been previously absent, in recent years, they have been expanding their range. With a range so extensive, it is not surprising that bobcats can be found in a variety of habitats, ranging from denser forests to shrub-dominated deserts to the mountain habitat of Idyllwild.

Like all cats, the bobcat is a strict carnivore, consuming small mammals such as rodents, squirrels and rabbits. Also like most other cats, bobcats stalk their prey so they need shrub cover for hunting.

Female bobcats give birth to two to three young each spring and the kittens stay with her until the late summer/early fall. We were fortunate enough to have one of the cameras capture a female with her kitten as they moved along Strawberry Creek.

Except for a brief courtship with the female, males do not participate in raising the young and spend most of their time defending their territory from other males.

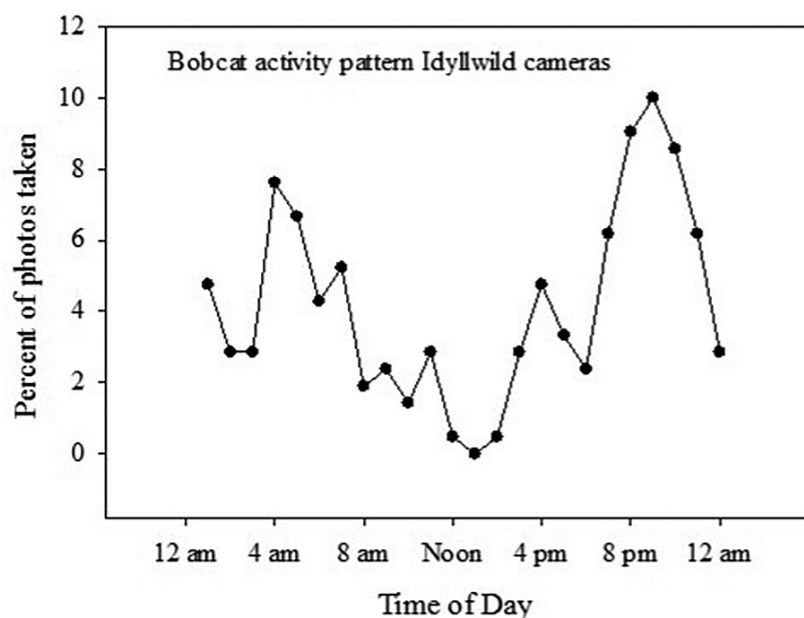
The bobcats of Idyllwild proved to be one of those surprising results

from the camera efforts. There was no doubt they occurred in the area but what was surprising was how close into town they live, including the back yards of Fern Valley.

In all, we found bobcat photos from more than 70 percent of the places the cameras were placed. In several of these areas, multiple photos — more than 150 in one site — indicated the ease at which bobcats have adapted to living in Idyllwild.

How can there be so many bobcats in Idyllwild and still not be commonly noted by human residents? The answer can be seen in the timing of when the photos were taken, as seen in the activity graph (shown). Like a lot of predators, bobcats are normally most active in early evenings and mornings.

The drop in activity around midnight indicates they do like to sleep some at night. However, it is the daytime when most carnivores sleep and the bobcat is no exception. Still, even during these daytime hours, indicating the ease at which they feel around humans, bobcats in Idyllwild do occasionally move about and at those times can be seen. As they are never a threat to humans and rarely to our pets, bobcats indeed make great wildlife neighbors and help keep the wild in Idyllwild.

# Dwight Kealy wants to replace Rep. Raul Ruiz

A new candidate is seeking the Republican nomination to challenge incumbent Congressman Dr. Raul Ruiz for the 36th California House of Representative seat.

On Wednesday, Dec. 3, Dwight Kealy of Palm Springs announced his candidacy with a road trip through the district. At 7:30 a.m., he started in Blythe and traveled west and north finishing in Beaumont at 5 p.m. At mid-day, he stopped at Paradise Valley Café in Anza.

Kealy is actually the third person to announce for the Republican nomination and appears to be the only active candidate. At the end of 2014, Kirk Thompson of Indio filed paperwork with the U.S. Federal Election Commission but has yet to raise any funds. Lupe Ramos Watson, mayor of Indio, announced her candidacy in April but has apparently withdrawn and also raised no funds.

A former Marine, Yale master's degree graduate, insurance broker for contractors and attorneys, Kealy is new to the 36th District, although he is a long-term Riverside County resident. His has moved his residence from Temecula to Palm Springs, but acknowledges his name recognition among voters will need to be raised.

Ruiz, an emergency-room physician, also was a political novice when he ran and defeated incumbent Mary Bono Mack. But he continues to be a proficient fundraiser. In 2012 for his first campaign, he raised nearly \$2 million and in 2014 when he defeated former Assemblyman Brian Nestande, his war chest exceeded \$3.4 million. Through September 2015, more than a year before the election, he already had nearly \$1.3 million cash available.

On Thursday, the day after Kealy's announcement,

Ruiz's campaign was sending emails seeking contributions with the text of "Big news: A Republican has officially announced he's running for Dr. Raul Ruiz's seat."

Kealy admits he is just starting to raise campaign finances. "It's not a concern at this point," he said. He is optimistic he will have financial success to report to the FEC at the end of December.

In his insurance business, Kealy has encountered several contractors whose frustration with California's laws and regulations has led them to move their businesses to other states. After numerous conversations about these problems, Kealy decided to step up and seek public office.

"My wife and I have a beautiful home and instead of giving up, someone should stand up and help people," he stated. "I've done research and more members of Congress served in the Marines than any other branch of the military. We come from a sense of service."

He earned his law degree in 2012, entered the bar and established his own firm. Kealy has worked with World War II veterans and women seeking families for newborn babies.

In his opinion, Ruiz doesn't represent the values of the 36th District. Those values, which will identify Kealy's campaign, are national security, jobs, family values and less-intrusive government regulation.

In the Marines, he was an intelligence officer who spoke fluent Arabic and Spanish. The latter, he hopes, will help him re-gain the support of the Hispanic population in the district.

But he stressed that he considers ISIS a threat. "I agree with Sen. Dianne Feinstein, a Democrat. We have to defeat ISIS and that is by taking them out," he said. "You may be surprised that a Republican Congressional candidate would say this, but Sen. Feinstein was right."

## Open fire ban and fire hazard area closures removed

The suspension of open burning and the closure of several hazardous fire areas has been revoked due to the wet fall and expectation of a wetter winter.

Cal Fire/Riverside County Fire Chief John Hawkins announced that these changes to previous proclamations were effective at 8 a.m. Monday, Dec. 7.

"Due to the increased relative humidity, higher fuel moisture and a general improvement in predicted fire weather conditions, and the increased availability of fire-protection resources, my proclamation suspending burning under permit and other uses of open fire ... is being terminated ..." he said in a press release.

Burning with a permit and open fires are not permitted on any state responsibility area lands within the county.

Also, Hawkins reopened seven hazardous fire areas throughout the region. The following areas that are reopened were previously closed due to extreme fire danger:

- Avery Canyon (Gibbel Road east of State Street in Hemet)
  - North Mountain and Indian Canyon (San Jacinto area)
  - Whitewater Canyon (Cabazon, north of Palm Springs)
  - Nuevo/Lakeview (east of Menifee Road and San Jacinto Avenue)
  - Minto (Sage)
  - Reinhardt Canyon (north of Highway 74 and California Avenue in Hemet)
  - Ramona Bowl and Bautista Canyon (southeast Hemet)
- The long-term drought and weather conditions will affect these decisions in the future.

## Post office holidays hours

Blue collection boxes having final collection times after noon may be collected early on Dec. 24 and Dec. 31. Therefore, mail should be deposited into all blue collection boxes by noon for early pickup on these days.

Customers requiring postal services later on these days are encouraged to contact their local post office. Customers also may call 1-800-ASK-USPS for more information.

Post offices will be closed Dec. 25 and Jan. 1. Only Priority Mail Express will be delivered on Christmas Day and New Year's Day. All post offices will be open and regular mail delivery will resume Dec. 26 and Jan. 2.

www.floodsmart.gov or to call 1-888-call-flood.

Cullen stressed that the current warm-water temperatures in the eastern Pacific portend a very wet winter. "It's a good indicator of above-average rainfall," he said. "... more storms, not super storms, very similar to the 1997-98 winter."

The concern, he expressed, was that local hill-sides become saturated from the rainfall, and rock-slides or collapsing hill-sides might result.

Jared Gibbon, of the County Department of Transportation, urged that before the storms begin, residents be sure their gutters and roofs are clear, fix roof leaks, check for loose

roof tiles or shingles, and store outdoor furniture or other objects that might be damaged or thrown by strong winds.

Although fire officials urge removing pine needles and leaves, he said that in preparation for an above normal rain season, they help mitigate soil erosion. Also, drainage areas should be cleared to permit water to flow naturally downhill.

If property owners have questions about cleaning or slope stabilization, removing debris from drainage areas or regulatory issues, they may call the county's Community Drainage Task Force at 951-955-2004.

The major stream on the Hill is Strawberry Creek. Property owners

adjacent to the creek need to check with the county before disturbing the creek's flow because county, state or federal permits may be needed, Gibbon warned. For example, do not remove soil or rocks from the streambed before asking these questions.

If channels, road culverts or roadside ditches are clogged during a storm and water is building up, Kathy Henderson of the county's Emergency Management Department told attendees that they may call 951-955-1230 for help.

She also recommended that people prepare hazard kits in case flooding occurs and to have a plan in case utilities are affected.

# Hill realtors respond to supervisors' interest in regulating short-term rentals

After learning that the Riverside County Board of Supervisors had discussed a new ordinance to regulate short-term rentals, the local Idyllwild Association of Realtors created a committee of four to review how this action might affect the local rental market, according to Marge Muir, one of the committee members.

In an initial vote, the board approved the ordinance 4-1. But supervisors agreed to redraft it and bring it back to a future meeting, tentatively set for Jan. 12, 2016. The principal sponsor was Supervisor John Benoit (4th District), who said his intention was to regulate

the industry and not ban it.

Third District Supervisor Chuck Washington co-sponsored the draft ordinance with Benoit, but expressed some concerns and reservations during the board's discussion of it.

"So much doesn't apply up here," Muir said. "We hope to raise some things that don't apply."

The realtor group met Thursday, Dec. 3, and agreed to share the draft ordinance with the local innkeepers and vacation rental companies on the Hill, whom they feel may be affected to some extent, according to Johnny Wilson, another committee member.

"We wanted everyone to know about it and are waiting for any feedback," he said.

As drafted, the proposal specifically excludes hotels, motels, lodging houses, bed and breakfast inns, cottage or country inns, and many more facilities. It does focus on privately owned residential dwellings, including detached or multiple-family attached, apartments, condominiums and cooperative apartments, mobile homes and more.

A principal reason, which brought the supervisors' attention to this issue, is the many incidents of excessive noise and loud visitors. Benoit and his staff pointed to this problem as the number one complaint of short-term rentals in residential neighborhoods.

## What CSA 36 is and why it matters

Whether or not property owners in County Service Area 36 participate in local recreation programs conducted by the county or stand under the occasional streetlight to appreciate its illumination, they are paying for both.

Each year, CSA 36 property owners are billed \$35 as part of their property taxes to fund both recreation and streetlights. That amounts to about \$125,000 a year to conduct and maintain both elements that CSA 36 is charged to administer. Also, prior to Prop 13, special districts received and continue to receive a portion of county property taxes. For CSA 36, that amounts to another \$67,000, bringing the total annual CSA 36 budget to nearly \$200,000. That is the budget a CSA 36 Advisory Council could review and comment on.

For many years, the CSA 36 Advisory Council had been active, appointed by the 3rd District county supervisor to advise him or her on the conduct of local recreation and the condition and maintenance of streetlights within the district. It gave locals an opportunity to review recreation budgets, allocations and programs, and

make requests of county officials for more recreation programs. County officials were mandated to attend these meetings, give reports, and respond to requests and inquiries.

For the last two years, there has been no local council. Even when the council met, it often met and recessed because of lack of quorum of the five-member group. Often, few district residents attended.

Recently, there has been loud and vocal criticism of the county's conduct and management of local recreation. Nevertheless, when the call went out to repopulate a local advisory council, few in the community and none of the vocal opponents stepped up to volunteer to sit on the council. The window for applications is scheduled to close the end of December, although Opal Hellweg, 3rd District Supervisor Chuck Washington's legislative assistant, said she would extend the deadline, if needed.

The council presents an opportunity to participate in how tax dollars are being spent — taxation with representation.

# Idyllwild Arts presents 'The Importance of Being Earnest'

The scintillating and audacious wit of Oscar Wilde

The double entendre of Oscar Wilde's title "The Importance of Being Earnest" deftly sends up the conventions and snobbery of the final years of the Victorian Era when the British Empire was at its height.

An outsider by birth, the Irishman Wilde was nevertheless accepted by the British upper class. They loved his wit, his daring, his immaculate turns of phrase and his finger-in-the-eye of all that was proper. They loved him even when they were laughing about themselves.

In "Earnest," Wilde's three-delicate-act farce, words are everything — tossed about brilliantly, casually and with exquisite finesse. They are delicious, devilish and delectable — a feast for those for whom the subtlety of language is a venerated lost art.

Idyllwild Arts presents "Earnest" in an intimate setting, at Rush Hall's black box theater. It is a perfect setting for the drawing-room intimacy of "Earnest," where every word, the smallest gesture, expression, the hem in every garment and the twirl of every skirt are only a few feet from audience members.

And what will be astonishing for the audience is the skill with which these young actors perform and understand the period conventions of the late 1800s. As IA Academy senior Morgan Wheeler, who plays John (Jack) Worthing, noted, "Yes, these characters are wealthy, and upper class but they are still people, and you need to play them as real people." As Drama Chair and Director J. Barrett Cooper observed, "We have to care about them. Yes, it is the language, but

these characters must also be authentic human beings."

The period in which the piece is set also requires the cast to perform in a specific acting style — small, not expansive gestures, acting with the eyes and the smallest inflections in the voice and a very different physicality, especially for the women. Said Reynolds Sullivan who plays Cecily Cardew, "Performing the play in the time period in which it is set requires specific behavior — how do you cross your legs, women don't use the backs of chairs but sit poised on the front, how do you stand and walk?"

Caroline Quigley, who plays Gwendolyn Fairfax, agreed, "The physicality of the face is so important, gestures are small and restrained, and so much of the acting is done with the eyes."

Jaclyn Miller, who plays the pivotal role of Lady

Augusta Bracknell, spoke about the actual constraints period costumes place on the actors. "All the women are wearing corsets," she said. "I had never worn a corset. I had to learn to breathe differently and place my character's voice in the right register."

For anyone who has not seen "Earnest," it has all the turns of classical farce, surprises, unexpected reverses, revelations and language that are exquisitely crafted and fabulously funny. "Wilde wastes not one word," said Cooper. "I've acted in the play twice, am now directing it, and I am still finding new subtleties in the script — a word or expression introduced by one character that is later repeated by another in a different way."

Senior Lincoln Belford, often seen in the past as a musical comedy lead, is a supporting but critically important player in "Earnest," the Rev. Canon Chausable, D.D. Said Cooper, "Linc is an example of how to work professionally. He came in prepared and made choices from the beginning. It is what ensemble acting is all about."

"The Importance of Being Earnest" is directed by Cooper, with set design by senior Ahmet Buyukcinar, costume design by Minnie Christine Walters, light and sound design by Todd Carpenter and stage management by senior Madeline Bernstein. James Jones plays Algernon Moncrief, Kristen Clarke plays Miss Prism, and Rob Taylor and Narushi Fukuda round out the nine-member cast. The time is 1895 and the action takes place in Algernon's flat in London and at Worthing's manor house in the English countryside.

"Earnest" opens at 7:30 p.m. Friday, Dec. 11, and plays at 2 p.m. and 7:30 p.m. Saturday, Dec. 12 and at 2 p.m. Sunday, Dec. 13. Admission is free to the public, seats are not reserved and seating is limited.

# Art Alliance of Idyllwild donates more than \$15,000

The Art Alliance of Idyllwild, a 501(c)(3) organization, has announced it will be donating more than \$15,000 toward keeping art alive in Idyllwild. The proposed funding will further AAI's purpose as a nonprofit, which is to "enhance and expand Idyllwild's reputation as an art community, to support the achievement of artistic excellence, and to support education in the arts."

The organization is pleased to announce that this is the largest amount donated since its nonprofit designation in 2002.

Many of the organizations and projects receiving funding have never before benefited from financial support by the AAI.

AAI is leading the effort to create "a generation of artists one scholarship at a time," according to a press release. Those receiving funding this year include the local smARTS Program run by volunteers who provide ongoing art education at the local Idyllwild School for students. SmARTS will receive \$2,000 for supplies and

teacher stipends along with another \$1,000 to be applied toward a field trip or special project of its choice. The Idyllwild School music program also will receive \$1,000.

AAI is continuing to provide financial support to the Idyllwild Arts Academy, one of three independent high school boarding schools for the arts in the U.S. AAI will be donating a total of \$5,200 to IAA and the Associates of the Idyllwild Arts Foundation. Funding will provide scholarships for incoming local Idyllwild students, a college scholarship for a graduating Idyllwild student in the arts, financial assistance for Idyllwild youth wishing to attend the Summer Junior Artists Program, and support for the school's newly formed baby dance program that gives dance classes taught by students to local preschoolers.

More funding is being distributed to a variety of new organizations and programs. Hemet High School will receive a \$1,000 scholarship for a graduating Idyllwild

student going into the arts, and Musica!, an organization that offers a free music program to youth, will receive \$1,000. A total of \$2,400 will be applied toward the creation of two summer programs for local teens. These include a workshop to be named "The Science of Art" that will be held at The James Reserve and a "Writing for Performance" workshop.

AAI also has set aside \$1,500 to offer partial funding to help create a new art program for local home-schooled children.

AAI has 283 members. Its fundraising efforts are made possible thanks to membership dues and proceeds from two annual fundraising events. Known to provide unique art events throughout the year, AAI produces annual fundraisers which include the Eye of the Artist event, scheduled for March 19, and its popular Art Walk and Wine Tasting, to be held in 2016 on Oct. 8.

# Joe Gandelman, ventriloquist, to entertain at library

Saturday, Dec. 19 at 1 p.m. the kids will have a wonderful holiday treat at the Idyllwild Library. Even adults who accompany them may be chuckling and impressed. Local children will have an opportunity to see, hear and learn from a true ventriloquist — Joe Gandelman.

He has been interested in ventriloquism since his youth. After several decades as a print journalist — abroad and in San Diego — Gandelman devoted his full attention to the art of speaking through others.

Today's television rarely shares the talents of great ventriloquists. "I like Howdy Doody the best," Gandelman said.

Many Baby Boomers remember Howdy Doody. Gandelman's work emulates these early performers. But unlike the late Edgar Bergen, Gandelman does not need to move his lips when his sidekicks speak.

"But nobody understands how great [Bergen's] scripts were. People never noticed," he said.

As he did more ventriloquism, Gandelman needed to find and meet his own sidekicks and co-stars. But he could not satisfy his expectations as he searched the local toy stores. Fortunately, he wrote ventriloquist Paul Winchell, who told him, "Forget the toy stores, go to the magic stores. That's what ventriloquism is — magic," Gandelman remembered. John Raven is Gandelman's

main character.

After graduating from Colgate University, Gandelman wanted to do more work in international relations, but ended up as a journalist first in India for the Hindu Times and later in Spain, where he contributed to the Christian Science Monitor. In the late 1980s, while writing at the San Diego Union, he experienced two events that altered his life.

One weekend he was talking with a colleague from the paper, a 50ish woman. They were in downtown San Diego and she had a 15-year-old daughter. On Monday, she was dead from a heart attack. Shortly afterward, he was involved in near-death traffic collision.

Ventriloquism, to which he had returned on a casual basis for relief from writing (frequent weeks of 40 hours of overtime), became an end. A former mentor, Jimmy Nelson, star of the classic Nestles commercial, encouraged him to pursue it full-time. Now he performs throughout the country, at libraries such as Idyllwild, workplaces, television, summer camps, parties and more.

Gandelman has not forsaken his love of writing. "I certainly miss the print, it's in my blood," he said, and described his blog, "The Moderate Voice," where Gandelman continues to opine about current affairs.

Also, he wants to see this skill passed to future generations. He has written a book, "Tips from a Pro," for others who wish to "throw their voices." He also produced a CD entitled "Super Simplified Ventriloquism," in which he shares his technique.

"It's not hard. Last week in Ventura, two kids were doing it without moving their lips," he said proudly.

Besides bringing some of his favorites puppet friends with him to Idyllwild, Gandelman promises a time to remember. And before he finishes, he'll share some lessons and techniques with the kids in the audience.

# Large local crowd attends gender violence symposium

Organizers for "Beyond Bystander" expected a modest turnout for the symposium seeking to challenge and eliminate gender-based violence. But more than 50 people crowded into the Rainbow Inn venue on Tuesday, Dec. 1, to listen to presentations as part of a worldwide initiative.

Organized by the Mountain Communities Alliance Against Gender-based Violence, the local panel presentation and discussion sought to enroll attendees in speaking out against gender-based debasement and violence. Attendees were asked to consider this in a provided handout: "Bystander intervention doesn't need to involve heroics. Ask yourself: 'Do my words and actions help my community be a safe place for victims to report crimes against them and deal with the aftermath of their assault? Or, am I contributing [by silence] to a culture that imprisons victims in si-

lence and shame?"

Panelists offered four possible steps or strategies to counter gender-based violence: One is by being direct, by saying "stop it," "no" or "that's not OK." A second method is to distract in a developing situation, using a distraction to help the potential victim get out of the situation

and to safety. A third could be to delegate to others who are present and enroll them in helping to remove the potential victim to safety; and finally, to use a delaying tactic, alerting someone with more authority and then following up to find out the aftermath and if the victim is OK and needs further assistance.

Lead organizers were Father Dan Rondeau and Callie Wight of St. Hugh's Episcopal Church and Mary Morse of Spirit Mountain Retreat. The event also was endorsed by the Rotary Club of Idyllwild and Soroptimist International of Idyllwild.

Also present were representatives from the Center Against Sexual Assault of Southwest Riverside County as a resource with a 24-hour crisis hotline for counseling, information and referrals at 951-652-8300.

The event was part of a worldwide series of presentations designed to raise awareness about gender-based violence. Said Rondeau, "We are here to participate in this global initiative. No community is immune from violence based on gender. We hope others, like you who are here tonight, will go into the community and speak about this." Wight added, "The more of us sitting or watching when a critical event is going on, the fewer who will intervene. Learn to become an empowered bystander. Step up, step in and take action with safety."

# State says earned income tax credits available

The state budget, enacted in June, for the first time included nearly \$400 million for an earned income tax credit for California residents. Last week, state officials announced availability, eligibility and how to obtain the credit. The state credit is in addition to the federal earned income tax credit.

Gov. Jerry Brown estimated that nearly 600,000 California families will be eligible for the credit. California taxpayers can begin receiving the credit with filing of their 2015 income tax return on or before April 18, 2016.

## Eligibility

The first criterion is having income to report. The accompanying table provides the state tax credit for family sizes and income levels.

Other criteria include the following conditions:

- the filer must be between the ages of 25 and 65, unless they have a one or more qualifying children;
- the filer, spouse and all qualifying children each has to have a Social Security number;
- the tax return must be joint rather than "married/RDP filing separate" filing status; and
- the recipient must have lived in California for more than half the tax year.

## Filing

Those who qualify for the EITC can file their taxes for free through the Volunteer Income Tax Assistance program, whose locations will be announced in early February.

If one wants to file their taxes from the comfort of home online, California offers a free-file online option at

More information on free tax assistance in local communities will be announced in January 2016.

Californians who qualify for the state EITC also will likely qualify for the federal EITC. Both the state and federal credits will be available this tax season and may yield either a refund or reduce the amount of money owed. This will significantly boost household income for eligible families and individuals.

In 2013, more than 200,000 Riverside County residents claimed the federal EITC. Sixteen percent (233) of tax returns filed from zip code 92549 claimed the federal credit and nearly half relied on a paid tax preparer.

About 11 percent of local households reported income below \$15,000. The availability of the state EITC should help 40,000 county residents.

State officials stressed that the earned income tax credits are not automatic. They must be claimed on tax returns.

## Southern California Edison

Besides the state's efforts to assist low-income families, SCE has a California Alternate Rates for Energy program. Depending on the size of the household and income level, electric rates may be reduced 30 percent. For example, one- or two-person families with income less than \$31,860 would qualify.

Eligibility also is open if someone in the families qualifies for Medi-Cal, Medicaid, supplement security income or several other programs. The list is available at [www.sce.com/wps/portal/home/residential/assistance/care-fera](http://www.sce.com/wps/portal/home/residential/assistance/care-fera).

The South Coast Air Quality Management District established a residential Electric Vehicle Charging Incentive Pilot Program for southland residents to help make charging at home more affordable.

The program provides an incentive to buy-down the cost of Level 2 (240 volt) residential charging stations, which typically range from \$400 to \$800. Level 2 charging is faster than Level 1 because it uses a standard 120-volt outlet.

The incentive will be available on a first-come, first-served basis for a \$250 rebate for the cost of hardware with another rebate of up to \$250 for low-income residents.

Charging stations need to be installed at a 240-volt outlet or by a licensed electrician if there is no 240-volt outlet. They also need to be in place for a minimum of three years. Installers need to obtain any required county electrical permits for installation.

# Actor/writer Michèle Marsh has had a storied career

That Michèle Marsh has talent is evident from her rich and nuanced acting résumé — a long and successful career in a profession not known for steady work. That her career has unfolded in storybook fashion makes her story all the more compelling.

From a leading role in the movie version of “Fiddler on the Roof” at the age of 21 to solid recurring roles in television, to lead roles in major California and Arizona theater companies, and to lately playing “hip grandmothers” in national commercials, Michèle has worked continuously.

Born in France to a composer, musician and conductor father who fought in the French resistance, Michèle Buhler was exposed early in life to culture and the value of education. As a Christian Scientist, after the war, Michèle’s father was offered a lecture tour in the United States. That tour led to her father accepting a teaching position at the Desert Sun School in Idyllwild. She was 5 when the family arrived in Idyllwild. She completed all her elementary education at Idyllwild Elementary School. “I always felt like an oddball because I was French and we were Christian Scientists,” she remembered.

But feeling like an outsider led her to being outside — summer camp at Desert Sun learning archery and horseback riding, and handling snakes at the Nature Center. “The outdoors was home to me,” she recalled. “I played under manzanita bushes and made up all these stories and fantasies.” Later, when her father moved for work to Pacific Grove on the Monterey Peninsula, Michèle discovered theater. “I was 14 or 15 and danced in the dream sequence of a production of ‘The King and I’ at the Wharf Theatre. I became passionate about theater. In Carmel, in what became prophetic, I was in a production of ‘Tevya and his Daughters,’ on which ‘Fiddler on the Roof’ is based.”

Again, following her father who had been offered a position at North Carolina School of the Arts, Michèle studied acting there and received her bachelor’s degree. After graduating, she was offered a journeyman position at the American Conservatory Theatre School in San Francisco. Staff reductions forced cancellation of the journeyman program and Michèle found herself unemployed.

She heard about auditions for a production of “Oh! Calcutta!” and, although not enthused about the subject matter, did audition and wound up being booked into the Los Angeles production. While in the production, an aunt of a close friend heard about auditions for Norman Jewison’s movie version of “Fiddler on the Roof” that were being held in Los Angeles. “On advice of the aunt, I walked onto the studio lot carrying my résumé and pictures to casting director Lynn Stalmaster’s office,” she recalled. “He asked me if I could sing and dance. I said I could and he gave me two scenes and two songs and said to have them memorized for the next day. I came back the next day and performed the two songs, ‘Matchmaker’ and ‘Far From the Home I Love,’ with John Williams at the piano [Williams was arranger and conductor for the film and won his first Oscar for that work].” After the audition and screen test, representatives called Michèle on the last day before the casting decision had to be made.

“I was told Norman wants to hear you sing again,” she said. “John Williams worked with me for half an hour and then Norman came in. He listened and then walked back and forth, back and forth and looked at me. Then he said, ‘You’ve got the part.’ We were gone in London and Eastern Europe for about a year filming. It was shot in 1970 and released in 1971. It was only after ‘Fiddler’ that I realized how lucky I had been to have such a major role at such a young age.”

From that providential beginning, Michèle went on to other film roles, co-starring on television series “House, M.D.,” “West Wing” and “Desperate Housewives,” and guest turns on “Falcon Crest,” “Star-Trek: The Next Generation,” “Highway to Heaven” and “The Young and the Restless.” She appeared in major

theatrical roles at the Arizona Theatre Company, Alabama Shakespeare Company, Mark Taper Forum and Shubert Theatres in Los Angeles and ACT in San Francisco. For much of its 10-year run, Michèle appeared in “Tamara,” the multi-room “environmental” theater production that ran just south of the Hollywood Bowl and became a major theatrical event in Los Angeles.

Michèle currently acts in local productions and books commercials in Los Angeles. But, she admits, she has slowed down and is moving more into writing than making trips to Los Angeles to audition for acting roles. “Since moving here full time, I have not wanted to go to Los Angeles on a ‘maybe’ basis. I don’t have the passion I once did for acting. Now I write — short stories and creative non-fiction, much of it about my early life here in Idyllwild.

“I had been very shy when I was young, and not very sure of myself. But with acting I could be someone I’m not, very brave and very strong. For me, acting was empowering and energizing. It is wonderful to be listening

and be in the moment. And now, with writing it is the same. When I get inspired and something starts happening, I’m rapt.”

Michèle notes the secret to her long and successful career, other than providence, is to remain positive, energized and active.

In interview, notwithstanding her long and storied career, Michèle is soft-spoken, modest and still evinces a youthful sweetness and enthusiasm that is charming and captivating.

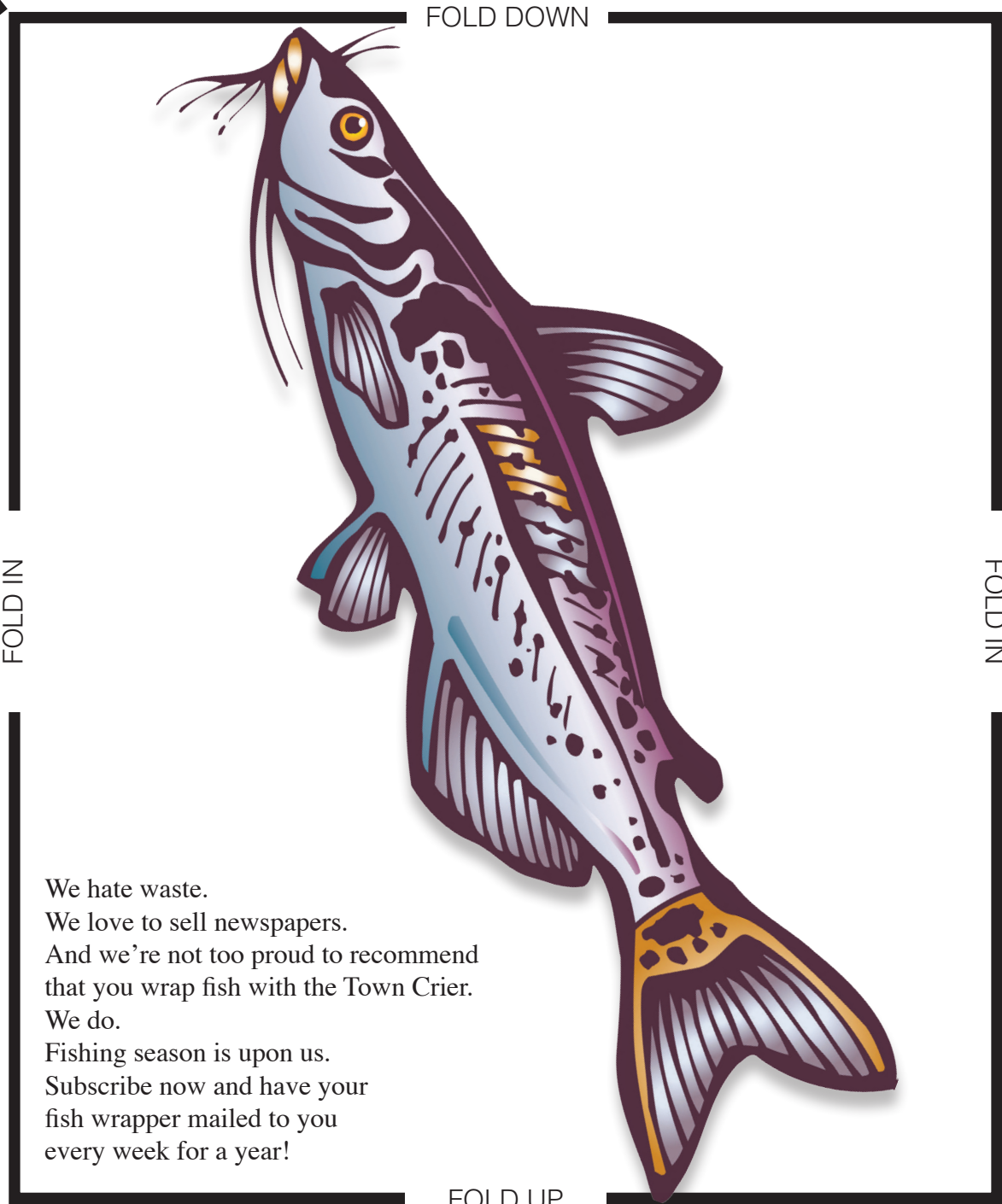

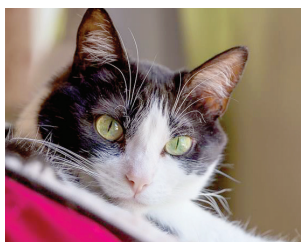

## New landline service approved

The California Public Utilities Commission on Dec. 3 approved, with certain conditions, the transfer of wireline assets of Verizon California to Frontier Communications.

The CPUC imposed conditions on the asset transfer that will result in significant improvements to the network, including expanded network redundancy in cases of emergencies, and more robust broadband deployment to rural areas.

Frontier also must offer broadband connectivity to all Lifeline-eligible Verizon customers, and Frontier must, for five years, collect and report annually data showing compliance of the merged companies with the CPUC's Supplier Diversity Program under General Order 156.

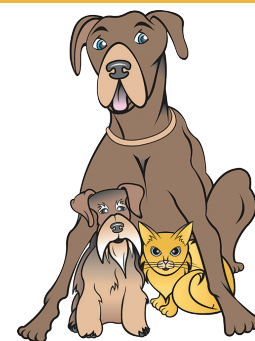
Further, Frontier will utilize the California Advanced Services Fund and the Federal Connect America Fund programs, coupled with its own investment, to expand and enhance broadband services in the Verizon California service areas.

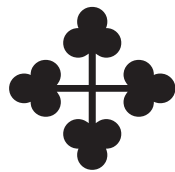

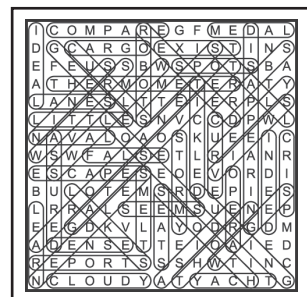

U.S. District Court (Southern District of California), the California Supreme Court and all California State Courts, Lehman navigates landscapes and waters that can pose major challenges to most others.

She also is a retired professional women's boxer, having left the profession ranked number nine in the world in super bantam weight division. She is a graduate of St. John's University in Santa Fe, New Mexico, and a cum laude graduate of the University of San Diego law school. "I have the confidence to find my way forward," she said of her surprising array of skill sets.

Before going, Lehman bought \$800 in medical equipment and supplies, gave herself a crash course in Greek (she also speaks Italian, German, French and Swahili), and set out to join what turned out to be an entirely volunteer operation — one not directed by any governmental or non-governmental organization.

"At first, when refugees began arriving, it was just the local island people helping them — local fishermen helping to tow disabled boats to shore, islanders getting them blankets off their own beds and finding dry clothes for them," she said. "Thousands of refugees were arriving daily and locals were overwhelmed. Then, from all over the world, people just started showing up to help. It was really amazing that it just happened. Organization came out of non-organization. People learned to work together, to work the problems. The intentions of all were good and we got better organized as it went along."

Lehman spoke about the misconception that refugees were all young, able-bodied men. "For the most part, those arriving were young families and old people," she said. "And their stories were heart-breaking. A young woman in her 20s, with a husband and young child, had had a kidney removed just 10 days before making the crossing. She had sold the kidney to finance the trip.

My first day, a young man arrived with welts all over his back where he had been beaten. On another island, a 109-year-old woman arrived in a wheelchair. Islanders wanted to put her in a hotel, but she refused, saying she wanted to stay with those with whom she had come."

Lehman noted smugglers charged on average \$1,500 per person to make the 5-mile crossing from the Turkish coast to the Greek island of Lesbos. "The boats were rick-

ety plywood boats or inflatable, made for 25. Usually there were 65 or more in each boat. Often, motors gave out because of malfunction or insufficient gas for the crossing." Lehman noted that smugglers gave discounts for more dangerous night crossings. "You just had to be there and aware 24/7, hearing people offshore and yelling in the night. At any moment boats could capsize. These people were so grateful for the aid we were giving. They

had so little but they insisted on giving us gifts for the help we provided.

"For me, the most difficult moment was when someone screamed medic and thrust a 3- or 4-year-old unconscious boy into my arms. We were able to revive him."

Lehman recalled stories refugees told of how families had pooled money to send young families or unaccompanied minors, to give them a better life, while other family members had to remain behind. "Pregnant women were terrified their babies had died in the womb during the crossing. A holistic practitioner from Switzerland felt their stomachs and listened for movement to reassure them their babies were still alive.

"People were kissing the ground when they arrived, unaware that other European Union country borders were closing and that further difficult travel to final sanctuaries in other parts of Europe was still necessary."

Lehman said coming back to the U.S., after having been in Lesbos for two weeks, was very dif-

ficult. "While there I had just been working the problem, accessing medical conditions and responding. But in coming back, I kept thinking I could have stayed longer and made more of a difference. I kept dreaming of looking for my headlamp to rush to assist arrivals, of being shot by a smuggler. I'm sure it's some level of post-traumatic stress."

Lehman still marvels at how so many came from so many disparate countries and cultures to assist the arriving refugees. "Everyone came because they were compelled to do so," she said. "There was this huge bonding of doctors, medics and everyday volunteers, each doing whatever they could to help. Sometimes it was rescue from the boats, sometimes trauma therapy and medical treatment, and sometimes arriving refugees just needed someone to hold their hands."
