## Propane prices fall slightly, reflecting market

For the week beginning Feb. 22, propane prices fell with several Hill suppliers, reflecting market conditions, and held steady for others who responded by deadline.

As we have previously reported, propane prices can vary daily and are based on "spot prices" at refinery points of production. Three companies of the six who supply the Hill are locally or regionally owned (AC Propane, Diamond Valley Propane and SoCal Propane) and three are national companies with local or regional offices (Amerigas, Ferrellgas and Suburban Propane.)

For this week, AC Propane's price-per-gallon fell to \$1.79 (from \$1.99 two weeks ago); Diamond Valley also fell to \$1.97, or \$1.77 to fill a customer-owned tank (from \$2.20 and \$2, respectively); and SoCal also fell to \$2.11, or \$1.91 to fill a customer-owned tank (from \$2.24 and \$1.94, respectively).

Amerigas held steady at \$1.99 per gallon as part

of its community pricing plan. We verified with Amerigas manager in Temecula, Stefan Moyè, that the company is not setting new tanks on the Hill. Moyè explained this a temporary halt and that he has requested more infrastructure support in order to better serve Hill communities. "Until we have added resources, we cannot service the area as responsibly as we would like," said Moyè. He noted that once those resources are in place, his office could begin setting new tanks.

"We have to make sure we can make the commitment and provide service responsibly," he said. He noted the requests for additional equipment and resources are in progress. He added, however, that as long as weather conditions remain mild, his office could possibly set new tanks on a case-by-case basis. "By next winter, we should be able to answer all requests for new service," he said.

Moyè said he would continue to be available to answer press questions about pricing and service.

## Prescribed burns important fire prevention tool

The recently signed memorandum of understanding between state fire agencies and several private environmental groups is intended to build support for prescribed burns throughout the state.

Cal Fire and the U.S. Forest Service took the step to help build support for the use of fire as a wildland fire-protection tool. The two agencies, along with the U.S. National Park Service and Sierra

Forest Legacy, the Sierra Nevada Conservancy, the Wilderness Society, the Nature Conservancy, the Sierra Club, the Center for Biological Diversity, and the Northern California and the Southern Sierra Nevada Prescribed Fire councils, signed the MOU last fall.

Two local firefighters agree that it is positive step; they feel quite comfortable and confident using prescribed burns in Southern California.

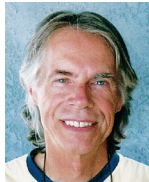

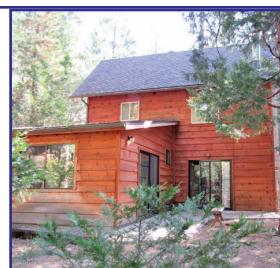

Idyllwild resident convicted of marijuana for sale

Two traffic collisions on Hill roads

Tiffany Marie Ramirez, 31, of Idyllwild, arrested on Jan. 6, pleaded guilty to one count of felony possession of marijuana with intent to sell.

Ramirez was arrested by the Riverside County Sheriff's Department Marijuana Eradication Team at McKinney Lane in Idyllwild.

Ramirez (a.k.a. Tiffany Marie Reddick) was sentenced to 90 days in county jail with credit for nine days time served for a balance of 81 days. She will serve the sentence as part of the county's work release program.

Ramirez was ordered to report for work release on or before Feb. 18, and pay fines, restitution and costs of probation supervi-

sion ranging from \$591.12 to \$3,744. Formal probation was granted for a period of 36 months under specific conditions. As part of probationary terms, Ramirez may withdraw her guilty plea and plead to a misdemeanor if she adheres to all probation terms and completes the mandatory 36 months with no violations.

Arrested with Ramirez and also convicted of possessing marijuana for sale was Henry Romero III. Because of a prior conviction that qualifies as a strike, the court, in sentencing, denied Romero probation and instead sentenced him to serve two years and eight months in state prison, with credit for 28 days. He remains incarcerated, according to the court record.

From Wednesday, Feb. 17, through Tuesday, Feb. 23, there were two crashes on Hill roads.

At 1:30 p.m. Friday, Feb. 19, Deputy Robert Miller, Riverside County Sheriff's Department, was driving a department Ford Expedition north on Forbes Ranch Road, a half-mile north of Highway 74, when he stopped in a dirt pullover on the west side of the road. He got out with his phone and neglected to put the vehicle in park. It rolled forward and hit a fence post. No one was injured. "When any allied agency has a crash we are required to investigate," said California Highway Patrol Public Information Officer Darren Meyer.

At 11:42 Saturday, Feb. 20, Hugo Garcia, 29, of San Bernardino, was riding his 2007 black Honda Sport bike north on Highway 243, one-tenth of a mile south of Vista Grande, when he failed to negotiate a lefthand turn, drifted onto the shoulder and laid the bike down. He complained of pain but did not request transport.

Underground hydrocarbons diminishing

Monitoring of underground leakage of petroleum products is continuing near and around the Chevron Station in Idyllwild.

RM Environmental Inc. of Calimesa continues to monitor the site semi-annually for the presence of various hydrocarbons. The latest results, reported last month from samples taken in December, detected total petroleum hydrocarbons and methyl-tertiary-butyl ether on the site and in monitoring well no. 15.

The concentrations had decreased since the September testing and are the lowest since 2013.

RM Environmental will continue to monitor the site and recommended the installation of two more monitoring wells.

Also, RM Environmental continues to recommend that a soil-vapor extraction test be conducted. If the results indicate that SVE remediation be implemented, that will take about three years to complete, previous reports have indicated.

# Financial reports, operating policy, mid-year review all on IFPD finance agenda

A new policy laying out the goals and operations of the finance committee was one of the main topics at the committee's meeting last week. However, much of the time was devoted to working with financial consultant Rob Dennis to identify reports the committee could use to monitor IFPD's financial status.

One major change to the committee's future operations was the decision to change the composition to include three public members and two commissioners, including the board treasurer. Currently, there are two members of the public — Calvin Gogerty and Sue Weisbart — serving on the finance committee and one alternate — Mark Lonsbury.

"It was always my belief this committee was designed to be a direct conduit from the community to the board," said Idyllwild Fire Chief Patrick Reitz, supporting the idea.

After the new policy is adopted, the three community committee members will have staggered terms and one of them will be the committee chair. Since its beginning two years ago, Commissioner Nancy Layton has chaired the committee.

The committee intends to review a revised draft policy at its March meeting and plans to move it to the commission meeting in March, too.

Each of the committee members had thoughts about what financial data would be appropriate in financial reports and how to present it. The exchange with Dennis resulted in agreement to prepare several new reports. Dennis hopes to have these available to committee members for the March meeting.

Examples of the new financial reports are a monthly vendor report, a complete monthly transactions report, a comparison of the budget, revenues and expenditures, year-to-date with past years, and more information on the reconciliation of the bank balances.

"We'll try. I don't want to deny them anything. Every report that goes to the board should go to the finance committee," Reitz said to Dennis.

Lonsbury urged the committee to make available on its website all the reports the committee receives.

"My goal is transparency so that the public has no

problems understanding our finances," he stated.

The committee reviewed the financials through January and began identifying accounts that will need adjusting when the committee does a mid-year budget review in March or, likely, April.

Through January, revenues have been about \$1.1 million and expenses have totaled about \$1.15 million, or \$50,000 more than revenues.

The committee felt several accounts would need to be increased before the end of the fiscal year (June 30). IFPD already has spent \$46,000 of its \$50,000 legal services budget, which is among the accounts needing adjustment. CalPERS appears to be underfunded, as well as the vehicle maintenance account, according to Gogerty.

Dennis explained that CalPERS changed how it funded its program and IFPD's new payment is less than originally budgeted, perhaps by \$25,000.

Vehicle-maintenance costs have already exceeded the original budget amount of \$4,200 by \$6,000. Also, Reitz told the committee he just received an \$8,000 estimate to do work on one of the new ambulances, which would increase the need for more money in that account.

However, he stressed that the total cost to purchase the two ambulances a year ago, and the subsequent maintenance and operational expenses is still significantly less than the cost of a brand-new ambulance.

"We're still watching the markets for ambulances," he said.

Reitz indicated that IFPD might need between \$10,000 and \$15,000 more for legal expenses. But a better estimate should be available within a few weeks.

Gogerty reported that he has met with U.S. Department of Agriculture officials and is optimistic that IFPD is eligible for some grants or low-interest loans to purchase new equipment. This may go to the commission in the next few months for approval to apply.

## Interviews for 11 applicants for CSA 36 Advisory Council

On Monday, Feb. 22, county representatives interviewed applicants for the County Service Area 36 Advisory Council. An additional applicant, John Metroka Jr., filed his application prior to the scheduling of interviews, bringing the total to 11 applicants for a five-member council.

Other applicants include Mark Davis, Kathy Wilson, Ginger Dagnall, Susan Nash, David Hunt, Bill Faurot, Bonnie Carpenter, Wendy Read, Reba Coulter and Amber Booth.

Opal Hellweg, 3rd District Supv. Chuck Washington's legislative assistant, reviewed the steps that remain prior to seating a new council. First, Washington will review the records of applicant interviews. He will then make his recommendations on the five to be seated and forward that to the full Board of Supervisors for approval. Hellweg suggested the submission of selected applicants to the Board of Supervisors would likely be in March. Once the CSA 36 Advisory Council is appointed, the county will determine frequency of meetings and set meeting dates, times and venue.

As in the past, the public is allowed to attend these meetings. The council advises the supervisor on matters relating to county-managed recreation and streetlight maintenance within the CSA district. It has no policy-making role.

County officials, currently responsible for managing community recreation, are tasked to attend these public meetings and report to the community on recreation programs and how property tax dollars are being spent on recreation programs.

The public meetings provide the community opportunities to question particular recreation programs, funding and make their desires and suggestions known to the supervisor.

She delights in my surprise when I find these little jewels. She has no idea that sometimes, on a particularly stressful workday, when she's on the other side of town at school, my stress is eased when I look at her ghoulish creature saying “Hi.”

## Lessons learned

EDITOR:

Friday last, I was run off the road (figuratively speaking) by a local delivery truck. My immediate reaction was fear mixed with a dash of confusion, followed by a slightly inappropriate feeling of anger. (Read here: I flipped the guy off. Sorry.)

Once I regathered myself, I reflected on the incident as I continued driving. As fate would have it I happened to walk right past this person a few minutes later. Words ensued that caused me to decide that action should be taken. So here's what you need to know.

I went in to discuss what I termed as a “reckless driving incident” with the proprietor and we had a very productive conversation. I went home, and on this person's advice, called and filed a report with the California Highway Patrol.

From that conversation I was informed that calling them should have been the first, and immediate, thing to do. (Lesson 1.)

Lesson 2, don't talk to or confront the other person or people when an occurrence such as this confronts you. This didn't go badly, but you only need to watch the news to get an idea of how things might have otherwise gone.

Lesson 3, not everyone really cares. In subsequent conversations throughout this process, I've discovered that “ruffling a few feathers” can cause knee-jerk reactions that show that some of us (or likely, most of us, myself included) tend to resist change.

But lastly (Lesson 4) is that our community needs protection, and that protection starts with us. Be diligent when you see something. Take action, do or say something.

My reason for following up was because this person's unsafe driving habits present a danger to the good citizens of our community. He could have, and may yet, hit a vehicle, or worse, run down a small child. If that were to happen, had I said nothing, I'm not certain I could live with myself.

At least now, if this person's peers decide to do nothing to correct this behavior, I'll still be able to sleep at night knowing that I did what small part I could to contribute to the safety of my Idyllwild neighbors.

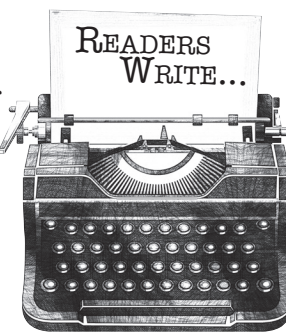
Unfortunately, the riders who frustrate Jim will never read his letter to the editor in the Town Crier.

There is a 3-foot law, but a motorist should not unsafely cross the double-yellow line which endangers the driver, the oncoming vehicle and the cyclist he is trying to pass.

## Helping sufferers of PTSD recover their lives ...

As someone who hasn't missed a single presidential debate or primary, I found one topic worth writing about amidst all the demagoguery and bravado.

Those who wish to "see if sand glows" or "kill the family members" of suspected terrorists did find time to mention (in the middle of putting their Captain America suit on) the topic of Post Traumatic Stress Disorder.

According to the Department of Veterans Affairs, one in five Iraq and Afghanistan war veterans suffer from PTSD (with the number closer to 30 percent for Vietnam War vets).

In response to these statistics, the VA Palo Alto Health Care System, in conjunction with Fujitsu Laboratories of America, developed a treatment study to help veterans reclaim their lives once they return home. This particular study focuses on the problems many veterans have in simply driving their cars. That burden leads to a higher-than-average collision rate than the general population.

As part of the study, investigators attach sensors to the steering wheel, brake pedal and gas pedal of the vet-

eran's car while recording their heart and respiration rate. The researchers then combine the data with the vehicle's location at different times, as well as road factors, that might trigger PTSD symptoms.

Investigators then introduce strategies like cognitive appraisal and breathing re-training as part of what they call "driving rehab therapy." This remedial practice is now offered to veterans at about a third of VA hospitals.

During the first year of the study (now in its fourth year), it was difficult for investigators to correlate the different data streams in order to understand what happened and when. Now they are implementing Fujitsu's remote monitoring technology in order to better time-synchronize the data. This allows EKG and GPS data to be integrated via iPhone to determine the exact location at every moment.

Most of the veterans in the study are survivors of improvised explosive devices explosions. After meeting with a psychologist to discuss their experiences in Afghanistan and Iraq, along with the stresses experienced while driving once returning home, they enrolled in the study.

During the same time, the University of California, San Diego, also has been conducting studies dealing with the impact on sleeping patterns of veterans suffering from PTSD endure. I had the privilege of volunteering as a healthy control for one of these studies and recommend that if given the opportunity, you do the same.

Once you come out of the functional magnetic resonance imaging scanner and are shown pictures of your brain compared with that of someone suffering from PTSD, you will see why more research and funding of treatment is necessary.

Now, if you will excuse me, I'm gonna watch the interview from the guy who now says he was against the Iraq War with the start, doesn't like people who were captured by the enemy and received five deferments to avoid serving in the Vietnam War. Weird, since I could have sworn his hair was a victim of Agent Orange.

## Burros for adoption

Riverside County is now offering wild burros for adoption. The adoption fee is \$50.

The burros were recently impounded from a pocket of land near a new Metrolink project area in the Highgrove area just north of Riverside. Animal Control officers with Riverside County Animal Services rounded up 19 burros. More burros are expected to be impounded in what is described as an ongoing operation.

"We're trying to round up roughly 40 burros from a sub herd of the much larger herds famous in the Reche Canyon area," Animal Services Director Robert Miller said. "This herd is the only known grouping in this particular pocket of Riverside County. Our intent is to preserve this sub herd by removing it from what will be a dangerous situation."

A new Metrolink project, scheduled to start running in early 2016, will result in new train runs through the area where the burros have often wandered to and near. The burros, although described as wild or undomesticated, have exhibited very docile behavior tendencies. The burros' mellow demeanors are attributed to a long-standing tradition of passersby feeding the burros carrots and apples, drawing them closer and closer to an industrial park and residential communities in the Highgrove area.

## Off the Main Roads

### Dawn's Early Light ...

One of my favorite things about backpacking is the way your body shifts over time to fall in line with natural cycles of dark and light.

There's nothing like snuggling sleepily into your sleeping bag at 8 p.m. (which somehow feels like midnight) and waking up in time to watch the first golden-pink blush of dawn diffusing across the high-country peaks.

I've always wondered: Why do we fall asleep so soon after sunset and wake so much earlier when we are out in nature?

This has been the subject of much scientific research. The answer is rooted in our biology.

Cycles of light and dark have governed metabolic cycles of activity and rest since the first intrepid little bacteria ventured forth in our sweeping oceans. Sunlight provided a source of energy for their activity, while they used the period of dark as a time to rest and repair. Even as life grew more complex, it retained this basic "circadian rhythm."

Around 400,000 (or possibly more) years ago, our ancestors started their friendship with fire and began to share the night with its comforting red glow. Nowadays, gathering around the campfire has been replaced by gathering around the TV, iPhone or computer.

But the glowing blue light of the various screens in our lives have an entirely different effect on us than the warm-red spectrum light from our old friend fire.

The production of several key hormones is tied to the amount and type of light exposure we receive. Red-spectrum light does little to disrupt our biological rhythms. Unfortunately, bluish light can really throw a wrench into our hormonal balance.

Cortisol is normally produced first thing in the morning to help crank up our insulin and blood sugar and wake us up. As we go through our day, it slowly tapers off and we begin to wind down.

As night falls and the world around us darkens, our bodies respond by producing melatonin — a natural brain antioxidant, which is a very important signal for our bodies to go to sleep and repair.

Melatonin production can be cut short rather abruptly with exposure to bright lighting — especially in the blue spectrum. Strong, blue light exposure only occurs in nature around noon.

So every time we stare at a brilliant screen after dark, the glowing blue light shining into the back of your retinas from your TV, computer or cell phone is telling your body that it is midday. This signals your body to stop producing deep, sleep-inducing melatonin and instead, switch over to cranking out wakeful cortisol.

"But I fall asleep just fine to the TV," you protest. It's not just the amount of sleep, but the quality.

If your body doesn't produce enough melatonin, then you may fall asleep, but you will not sleep as deeply. It is insufficient to reach the more restorative stages of sleep.

You also will rob yourself of the production of healing (and youth prolonging) human growth hormone. Lack of truly deep sleep can also compromise your immune system, insulin and blood sugar regulation. That can take your weight and your other hormones (like estrogen and testosterone) on a roller-coaster ride.

Even if we don't want to live like we are backpacking all the time, we can take some key lessons about how to manage our biology better from backcountry trips.

You can mimic our old friend fire to light up your nights by using low, warm, reddish light at night. Two sources might be either from a fireplace or at least dimmer bulbs.

At least a couple of hours before you go to sleep, stop exposing yourself to blue light from devices such as TV. Get exposure to the early morning sun to help reset your clock.

Getting reconnected with nature's rhythms can be an amazingly useful tool to help us manage our own health.

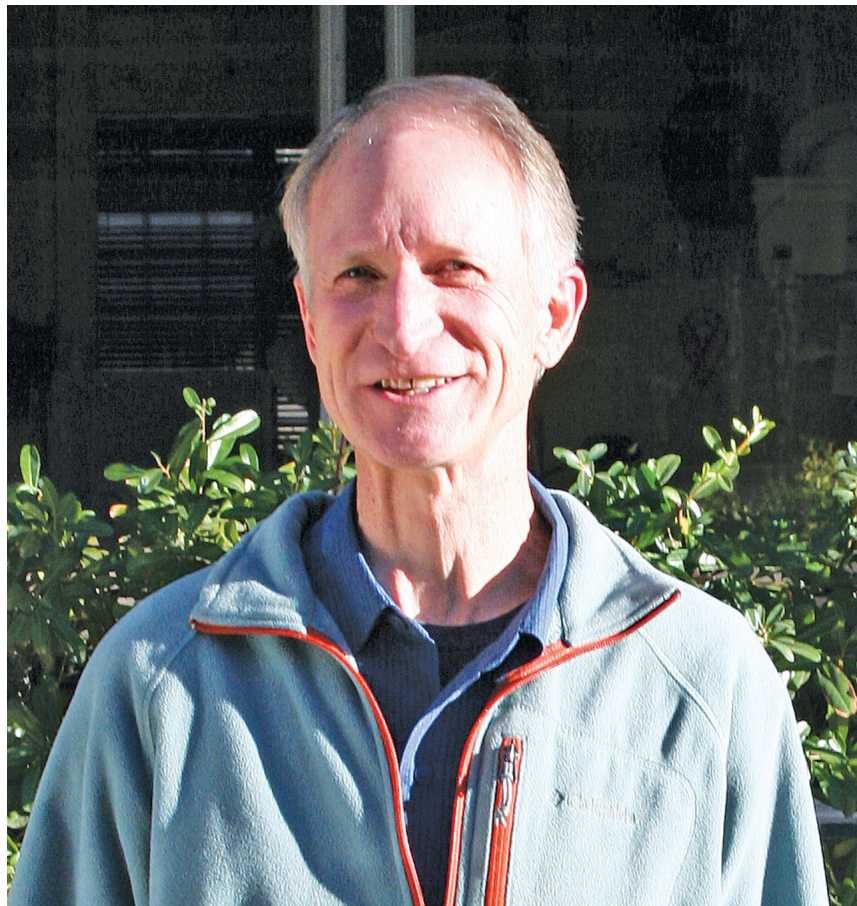

# Billman re-elected IWD president

January freezes  
increase water production  
and revenues

Jim Billman was re-elected as president of the Idyllwild Water District Board of Directors. John Cook was re-elected as vice president. Both have held these board positions since January 2014.

This year the vote was not unanimous. New Director Steve Kunkle nominated Cook for the presidency and Billman as the vice president after Director Mike Freitas moved to continue the current administration. The vote was 3-1-1 in favor of Freitas' motion. Director June Rockwell abstained from voting.

In financial business, the board accepted the recommendation of General Manager Tom Lynch and Chief Finance Officer Hosny Shouman to issue a new contract for the district's auditor to Rogers, Anderson, Malody & Scott, LLP of San Bernardino. This firm has been performing IWD audits since fiscal year 2010-11.

Two other accounting firms — Teaman, Ramirez & Smith Inc. of Riverside and Fedak & Brown LLP of Cypress — submitted bids to conduct the IWD audits for the next three fiscal years. Teaman has done audits for Hill special districts in the past and Fedak is the current Idyllwild Fire Protection District auditor.

Although the RAMS bid was not the lowest of the three submitted, IWD staff recommended its proposal because of "... uncertainty with both TRS and Fedak & Brown for additional fee charges ... staff believes

the district would be best served by the firm of Rogers, Anderson, Malody & Scott." For fiscal year 2015-16, the audit will cost IWD about \$9,250.

"RAMS is the current firm and their work is satisfactory," Lynch stated. "They warrant continuing."

The board unanimously adopted the recommendation.

At 7-million gallons, water production in January was 750,000 gallons greater than the January 2015 production, a 12-percent surge. As a result, water revenues were \$102,000, or \$12,000 greater than a year ago. While residential sales declined slightly, commercial water sales increased nearly \$20,000, to \$35,100.

This was the first increase in January's water production since 2013, when freezing weather caused significant leaks throughout the district. This year, many leaks on the customers' premises were identified and the customers notified.

Not only were water revenues more last month, but expenses for the water program declined \$12,000, resulting in a net income of more than \$24,000.

In response to Cook's question about whether the expenses would remain lower throughout the year, Lynch didn't expect this trend to continue. Many charges vary by month and a lower January cost may not continue.

For the year of 2015, total production was 74.5 million gallons, 10.5 million gallons less than the 2014 production.

IWD remains in Stage 2 water emergency, Lynch told the board, and added that Foster Lake finally had a puddle. "Hopefully, El Niño will manifest itself in the next month," he opined and expressed some concern for the slow re-charging of some IWD wells.

IWD has been notified that its recent Community Development Block Grant application for water-line replacement is eligible for funding. Lynch plans to attend a future Riverside County Board of Supervisors meeting to advocate for funding the proposal, which would replace about 3,000 feet of old and deteriorated pipeline.

## Water production up in Fern Valley Rate study on hold

In a brief meeting, Steve Erler, Fern Valley Water District general manager, told the directors last Friday that the district's well levels were beginning to come up. Well production was lower in January as the staff begins to use stored water in anticipation of its annual spring diversions.

January water production increased about 11 percent compared to a year ago. However, the 3-million gallons remain significantly lower than the seven-year average of about 3.6-million gallons. This was the first increase in water use during January since 2013. The increase this year was attributed to

the freezing weather early in the month, which created numerous customer leaks, Erler said.

He also reported that the State Water Resources Control Board had extended its conservation orders, including limiting outdoor watering and other non-drinking or non-hygienic uses, until Oct. 31.

Director Robert Krieger, chair of the Rate and Revenue Committee, reported that he and fellow member Director Trisha Clark had nothing to report. They plan to follow possible legislation in the state Legislature that may affect water districts' ability to implement conservation rates, as well as the possible November ballot measure.

"A lot of things are happening. And until we know more, we'll defer [any action] until there's more certainty," Krieger said.

acute onset of fever and severe joint pain. Dengue, another viral disease, is characterized by high fever, severe headache, muscle and joint pain, rash, and in severe cases bleeding manifestations. For both, treatment is supportive, the disease is not contagious person to person, and there is no vaccine.

CDPH recommends that travelers prevent exposure to mosquito bites by wearing protective clothing and applying insect repellent containing DEET, picaridin, oil of lemon eucalyptus, or IR3535 according to label instructions. DEET can be used safely on infants and children 2 months of age and older.

# IA jazz alums stage Hawkins tribute concert

## Alumni weekend centers on Marshall Hawkins' 30 years at Idyllwild Arts

More than 100 Idyllwild Arts alumni, from graduating years 1987 through 2015, are returning to campus for a reunion weekend honoring Marshall Hawkins Friday, March 3, through Sunday, March 6. For 30 years, Hawkins has lovingly told the story of jazz, inspired his students to find their individual voices and grow within this original American art form.

Two alums, Mike Barnett, '05, and Angelina Burnett, '96, are co-chairs of the centerpiece of the weekend, the Alumni Jazz Concert on Saturday, March 5. Thirteen of Hawkins' jazz graduates, many of them rising stars in the jazz family firmament, are returning to play for the teacher who, more than any other, influenced their career choices.

Returning are Evan Christopher, '87, clarinet; Ray Clemens, '96, bass; Patrick Farrell, '97, drums; Andy Fraga Jr., '97, drums; Daniel Sazer-Krebbers, '02, bass; Graham Dechter, '04, guitar; Tommy Cooper, '04, trumpet; Stephen "Stevo" Mann, '05, guitar; Nora Germain, '09, violin; Jacob Scesney, '11, alto sax; Luca Jacaruso, '14, piano; and Martin Budde, '14, guitar.

Barnett noted the emotional pull and influence Hawkins continues to have over his students, even after 30 years. "If you could think of any teacher who could get the most students to come back, it would be Marshall," he said. "He is such a quiet man. He never talks about himself, he just does it [the music and the story of jazz]. It's clear through his actions what he is thinking. He means so much to so many."

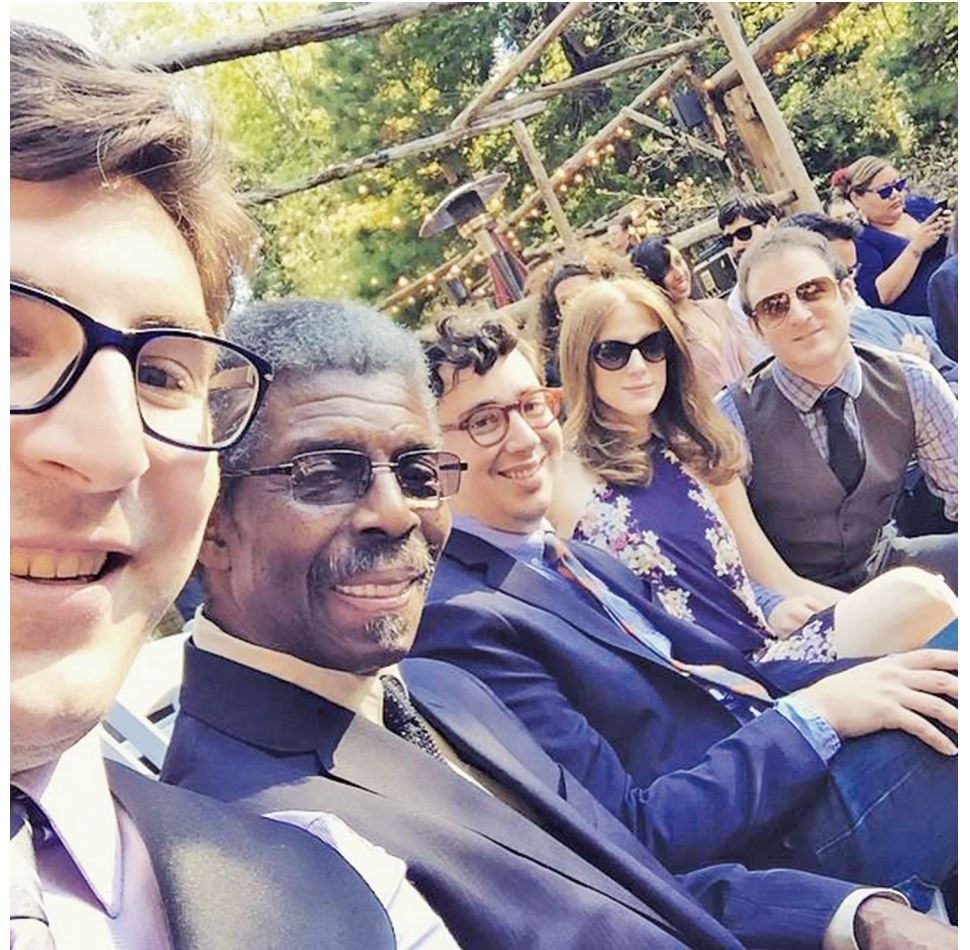
Barnett related how each year began with a faculty

concert with students loudly applauding their teachers. "All Marshall would have to do would be to walk on stage and there would be a standing ovation," he recalled. "What he does as a teacher that is so special is to show you how to feel and live jazz. It's not just the scales and the chords. He teaches you how to create your own voice and that is the biggest gift a teacher can give."

Other events planned for the Hawkins weekend include a screening of the documentary "Hawkins," by Devon Gilpatrick and Ashi Manoff, and a fireside chat between jazz pianist, mentor and inspirational speaker Harry Pickens and Hawkins. "Human beings have the capacity to live as instruments of grace and bringers of joy ... At the very core of our being is a reservoir of joy, of love, of possibility," said Pickens, of music and the source of his creative energy. Pickens' philosophy is part of the bond that unites him with Hawkins. They both live to love the music and to share that love with their students.

The Saturday Alumni Jazz Concert is open to the public but seating will be limited, noted both Barnett and Darren Schilling, Idyllwild Arts manager of alumni and parent relations. "We'll have 100 alumni on campus and our own student body, many of whom will be attending the concert," said Schilling.

The concert, from 8 to 9:30 p.m. Friday, March 5, is

"Wow, Grandma, I had no idea you used to be a Girl Scout like Mom and me. Just look at all the badges you have on your

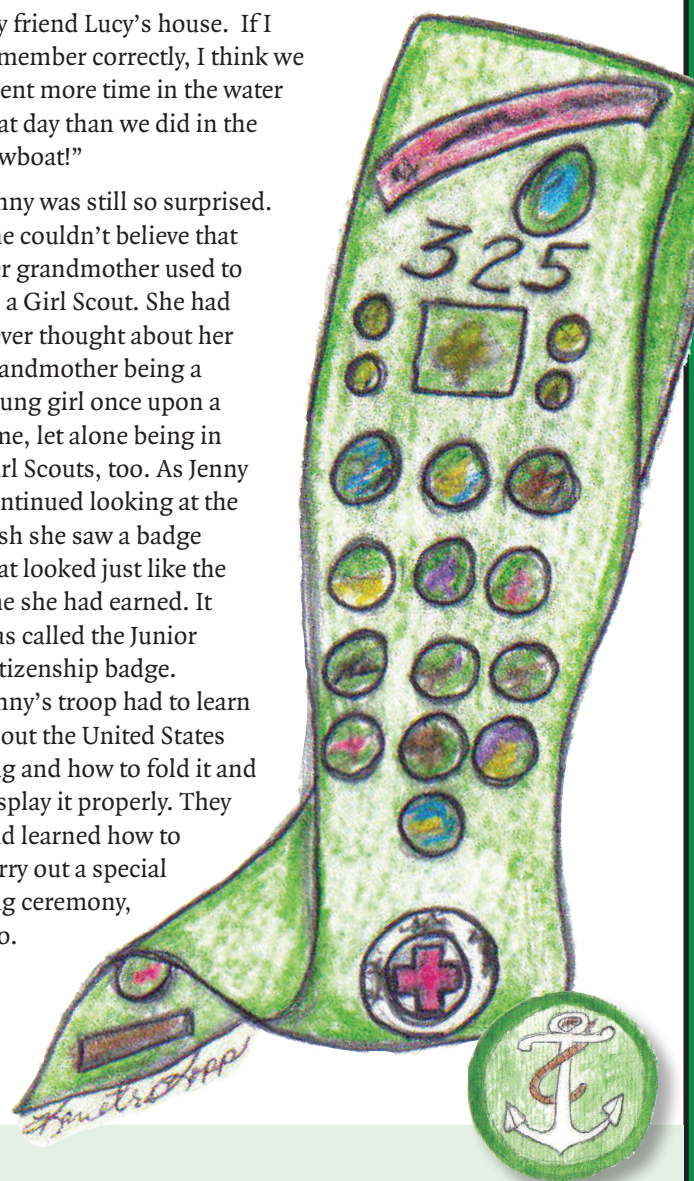
sash. Hey, what's this one for?" Jenny pointed to a round badge that had a bluebird on it.

## Electric vehicle program

The South Coast Air Quality Management District has established a residential Electric Vehicle charging incentive pilot program to offset Level 2 (240v) EV charger hardware costs. This program will be available to residents within the SCAQMD's four-county jurisdiction.

The program will provide an incentive to buy-down the cost of residential chargers, which typically range from \$400 to \$800. The program will be implemented on a first-come, first-served basis and will provide up to \$250 for the cost of hardware for Level 2 residential chargers.

Another incentive of up to \$250 will be available for low-income residents.

A charger would need to be installed at a 240-volt outlet or by a licensed electrician if no 240-volt outlet exists.

The charger would need to be in place for a minimum of three years and would be considered a permanent, not temporary, installation.

The installer would need to obtain any required city or county electrical permits for installation.

Brendan Steele posted a 3-under-par 70-67-68-76 — 281 at the Northern Trust Open on the Riviera Country Club course in Pacific Palisades last week to tie for 39th place.

The Idyllwild native picked up strokes on the field tee to green (-2.214), but he gave back almost three strokes putting (+2.887). He did sink a colossal 77-footer during his third round.

A reader inquired as to whether Brendan does better during the first three days of tournaments than he does on Sundays. We checked and found that during his first four years on the PGA Tour, his scoring average in final rounds was actually better than during the first three tournament days. But last year, 2015, he averaged 69.84 in rounds one through three and 71.26 in final rounds — 1.42 strokes higher. And so far this year, he's averaging 69.05 in rounds one through three and 73.67 in final rounds — 4.62 strokes higher.

But to be fair, this year's stat includes a closing round 79 at Torrey Pines on a cold, sideways-rainy Sunday when everybody scored high. In fact, Scott Brown, who led at Torrey during the first three days, shot an 87 in his final round and finished tied for 49th, same as Brendan.

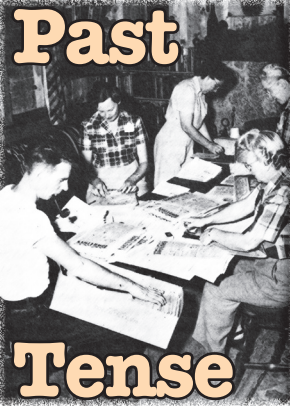

### 65 years ago - 1951

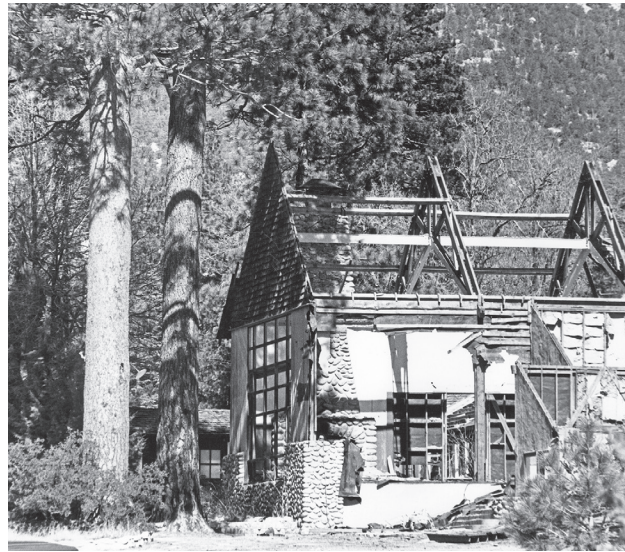

Among the suggestions offered: youth projects and recreation facilities, trash cans around the village, conservation education and individual meditation. Seems like some individuals have been meditating on these issues for some time.

### 60 years ago - 1956

The annual report of the California Electric office, serving Pine Cove, Idyllwild, Fern Valley and Mountain Center, showed 290 resident families (750 individuals) receiving electricity.

### 55 years ago - 1961

The Izaak Walton League asked the Walton Board of Supervisors to ban mechanized vehicles on San Jacinto mountain trails.

### 50 years ago - 1966

Winifred Wood reported on the 1964 data she collected on cars visiting the Hill for the San Jacinto Mt. Advisory Planning Committee. In 1964, she recorded an average of 1,470 cars traveling daily on Circle Drive, up from 610 cars daily in 1960.

### 45 years ago - 1971

Plans were revealed for the new Hemet High School campus scheduled to open in the first half of 1972. The school's first campus opened in 1894.

### 40 years ago - 1976

Cliff Dorn of Idyllwild drove the dogsled that retrieved the body of a man who perished from exposure near the Palm Springs Aerial Tramway.

Dorn was the operator of the Pacific Crest hiking supply store and manager of the warming hut concession at the 8,500-foot level of the Tramway.

### 35 years ago - 1981

Officials of the Mountain Area High School Project Team and members of the Hemet Unified School District board were recommending that Idyllwild School add an eighth-grade level.

### 30 years ago - 1986

The Idyll-Gazers, a local amateur astronomy group, invited the public to join an all-night star party to view Halley's Comet, which is only visible from Earth every 76 years.

### 20 years ago - 1996

County Service Area 36 board members were considering increasing parcel fees (then \$30 per parcel) between \$5 and \$40 to create an emergency fund and to raise funds for recreation facilities.

### 10 years ago - 2006

The Riverside County Board of Supervisors heard public comment on the section of the proposed noise ordinance (Ord. 847) that dealt with levels of "ambient noise," like that generated by musicians performing outdoors at local restaurants.

### 5 years ago - 2011

At its meeting, the board of the Lake Hemet Municipal Water District voted unanimously to transfer management of the Lake Hemet Campground and recreational facilities to the California Parks Company, with headquarters in Red Bluff.

### 1 year ago - 2015

In November 2014, California voters overwhelmingly approved Proposition 1, a bond measure to provide financing to increase water supply, provide clean, safe and reliable water, and restore habitat.

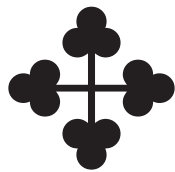

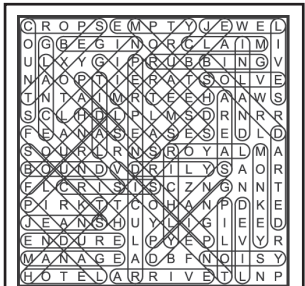

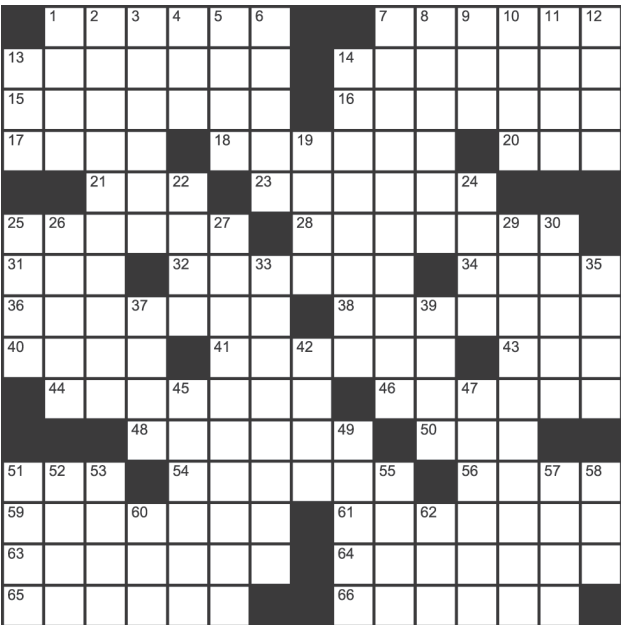

# 2015 tax changes include health-care updates

Most taxpayers will have until Monday, April 18, to file their 2015 returns and pay any taxes due. That's because Emancipation Day, a holiday observed in the District of Columbia, falls this year on Friday, April 15. By law, D.C. holidays impact tax deadlines in the same way federal holidays do.

Also, because of the Patriots' Day holiday observed on Monday, April 18, in Maine and Massachusetts, residents of those states will have until Tuesday, April 19, to file. Regardless of where they live, taxpayers requesting an extension will have until Monday, Oct. 17 to file.

## Health-care changes

This winter, many taxpayers will receive new, year-end forms providing them with information about health coverage they had or were offered. The new forms include Forms 1095-B and 1095-C.

If Form 1095-A is not received by early February, contact the Marketplace where coverage was purchased rather

than the IRS. The IRS does not have this information.

While the information on these forms may assist in preparing a return, they are not required. Like last year, taxpayers can prepare and file their returns using other information about their health insurance. To find out more about these year-end forms, visit [www.irs.gov/Affordable-Care-Act/Affordable-Care-Act-Tax-Provisions-Questions-and-Answers](http://www.irs.gov/Affordable-Care-Act/Affordable-Care-Act-Tax-Provisions-Questions-and-Answers) for questions and answers about the Affordable Care Act.

Taxpayers who do not have qualifying coverage or an exemption for each month of the year will need to make an individual, shared-responsibility payment with their return for choosing not to purchase coverage.

The payment increased from last year and will apply to taxpayers who did not have qualifying coverage or an exemption for each month during 2015. The annual payment amount is either a percentage of household income in excess of the return-filing threshold or a flat dollar amount, whichever is greater. If the taxpayer has coverage or an exemption for only part of the year, the IRS will prorate your payment for an amount less than the annual payment. The amount the taxpayer will have to pay may be limited depending on your circumstances.

For 2015, the payment is the greater of 2 percent of in-

come above the filing threshold or \$325 per adult, \$162.50 per child and a maximum per family of \$975. Examples and information about figuring the payment are available on the IRS Calculating the Payment page.

Once again this year, taxpayers who are reporting coverage, claiming a health-coverage exemption, making an individual, shared-responsibility payment, or claiming the premium tax credit should consider filing their tax return electronically. E-filing a tax return is the simplest way to file a complete and accurate tax return as it guides individuals through the process and does all the math for them.

As they did last year, most taxpayers simply need to check a box on their tax return to indicate they had health coverage for all of 2015.

Taxpayers who benefited from advance payments of the premium tax credit must file a federal income tax return. These taxpayers need to reconcile those advance payments with the amount of premium tax credit to which they're entitled, which is based on their actual income. Failure to do so may make them ineligible to receive future advance payments. Use IRS Form 8962, Premium Tax Credit, to calculate the premium tax credit and reconcile the credit with any advance payments.

The 2016 tax season is in full swing and Riverside County Community Action Partnership's Volunteer Income Tax Preparation program is available to help qualifying residents file their taxes.

The free tax-preparation services are provided by IRS-certified tax preparers and are available to anyone with a total household income below \$60,000.

Based on an individual's earnings and family circumstances, a taxpayer could receive as much as \$6,200 from the Earned Income Tax Credit. The taxpayer may also qualify for other tax credits, including the Child Tax Credit that offers up to \$1,000 per child.

"Every year, billions of dollars in tax refunds are left unclaimed by the very people who most need those funds," said Brenda Freeman, CAP executive director.

CAP volunteers prepared more than 4,000 tax returns at 17 locations in 2015, returning more than \$8.5 million in federal and state refunds to Riverside County residents, saving them more than \$1.2 million in tax preparation fees.

# Volunteers needed for bighorn sheep survey

The California Department of Fish and Wildlife, U.S. Forest Service and Society for Conservation of Bighorn Sheep on Saturday evening, March 5, and all day Sunday, March 6, are conducting a count of bighorn sheep. They are seeking volunteers to assist biologists.

No survey experience is necessary but volunteers must attend an orientation at 6 p.m. Saturday, March 5, at the Angeles National Forest Supervisor's

Office in Arcadia.

Volunteers will hike to designated observation sites in the San Gabriel Mountains early Sunday morning to count and record bighorn sheep. Representatives from CDFW, USFS or SCBS will lead the volunteer groups.

Participants must be at least 16 years old and capable of hiking 1 mile in rugged terrain, although most survey routes are longer. In general, hikes will not be along trails and ac-

cessing survey points will involve scrambling over boulders, climbing up steep slopes, and, possibly, bush-whacking through chaparral.

Volunteers are encouraged to bring binoculars or spotting scopes plus hiking gear. Mountain weather can be unpredictable and participants should be prepared to spend several hours hiking, and more time making observations in cold and windy weather. Volunteers

will need to start hiking early Sunday morning.

For volunteers who wish to camp, complimentary campsites will be available on a first-come, first-served basis at the Applewhite Campground in Lytle Creek the nights of March 4 and March 5.

Surveys for bighorn sheep in the San Gabriel range have been done annually since 1979. The mountain range once held an estimated 740 sheep, which

made the San Gabriel population the largest population of Desert Bighorn sheep in California. The bighorn population declined more than 80 percent through the 1980s but appears to be on the increase with recent estimates of about 400 animals.

With both Suburban and Ferrellgas, it proved difficult to obtain the same pricing information that both companies had supplied for our two previous reports. At Suburban, the customer representative who answered the phone said she had been told by her manager to answer "no comment," to pricing inquiries from the Town Crier. The local manager Jeff, who would not give his last name, said all further inquiries must go to Pete Teshima, Suburban vice president of Marketing and Communications in New Jersey.

Teshima, reached by phone early Tuesday morning, Feb. 23, said he would check into the situation and return the call (but not necessarily before deadline). He was told that the local Suburban office had previ-

ously supplied pricing, just as other Hill companies have been doing, but now refused to do so.

Similarly at Ferrellgas, the customer representative who answered the phone was only able to give pricing for first fill, \$1.74 per gallon, and \$2.19 for subsequent fills for members of the Idyllwild Property Owners Association. She said she was unable to quote a "flat rate" price for continuing customers who were not members of POA, and referred our call to Brandy, the office manager. A voice message was left for Brandy but as of deadline she had not responded.

We will continue this series in two weeks to both update pricing and report pertinent information not available prior to this week's deadline.

the Cleveland National Forest and Dan O'Connor of the San Bernardino National Forest were glad to hear about the signing of the MOU. But they were busy watching prescribed burns the same day they were interviewed.

Both advocated using more burns and expected that to continue in the future. While the details of the MOU had not filtered down to the individual forests, the two managers both agreed that there is much cooperation among agencies and environmental groups about the value of this tool.

The intent of prescribed burns is to help the forest ecosystem. Fires are a vital part of nature and help control the overgrowth of forest land, which can lead to extreme conflagrations.

Both agreed that even though the two Southern California Air Quality Management Districts cooperated in approving prescribed burns, they felt the San Diego District tended to be a little more lenient, though population densities are greater in the South Coast District.

"The [California Air Resources Board] is supportive of prescribed fire," Fillmore stressed.

Both men see prescribed burns as beneficial tools for protecting mountain communities such as Idyllwild, Big Bear and Arrowhead. O'Connor said the Forest Service is planning a late spring burn on Thomas Mountain, if weather and other conditions are consistent with burn specifications.
