Hill propane delivery prices fall slightly

Two national companies no longer will talk to Town Crier

The Town Crier's reporting of propane prices and policies of the six companies that serve the Hill began after reader inquiries. Readers said they often did not understand how prices were set and how they varied from company to company.

Beginning Jan. 28, and continuing thereafter every two to three weeks, we queried local providers about pricing — first fill versus subsequent fills, tank rental versus tank ownership and other variables that affect pricing, as well as general company policies.

Four companies, one

Mountain Center Market burglars plead guilty

Both men — Ryan Mason and Nickolas Melendez — charged with burglary of the Mountain Center Market in September, have pleaded guilty to burglary. Their sentencing has been deferred.

Melendez, 27, of Cabazon has his sentencing hearing scheduled for April 28.

Mason, 25, of Hemet had undergone an evaluation for possible residential substance abuse treatment prior to a Felony Settlement Conference. Judge Mark Mandio requested Riverside County Sheriff's Department Corrections Division conduct the assessment. As a result of the report, Mason's sentencing has been scheduled for Sept. 26, while he completes a program.

He also ordered that pending enrollment and completion of the program, Mason may not be released pursuant to the agreement with the federal government regarding jail population levels.

The two men were arrested on Highway 74, just west of the U.S. Forest Service's Cranston Ranger Station, shortly after they ransacked the ATM to get the cash.

Later, the investigation identified possible links between this break-in and a string of ATM thefts in San Bernardino County.

Both men were arrested for burglary in a coordinated effort with the San Bernardino Sheriff's Department. The District Attorney's Office later filed, against both men, two charges of burglary and two charges of grand theft of more than \$400,000.

The break-in occurred during the early morning hours of Monday, Sept. 14, and the security cameras that owner Shane Stewart has in all of his business locations were instrumental in the arrest.

The thieves took the ATM to McGaugh Road, where they broke into it and took the cash. The machine was found there.

Frank Gutierrez bail lowered

Felony conference next week

The bail hearing for Frank Gutierrez, 66, of Idyllwild, arrested in July 2015, was held Wednesday, March 9. After reading a report and hearing arguments from his public defender, Melissa McConaghay, Judge Bambi Moyer reduced his bail \$50,000 to \$200,000.

Gutierrez remains in custody until the rescheduled Felony Settlement Conference on Friday, March 18.

Gutierrez was arrested for various drug-related felonies and prior convictions. This occurred during

an arrest of Lisa Marie Brown, 40, of Riverside, for hit and run, vehicular manslaughter and possession for sales of methamphetamine. The arrests were made in Idyllwild.

His arrest appeared to be a by-product of Brown's arrest, who later pleaded guilty and was sentenced to six years in state prison.

In September, when his hearing was scheduled, Gutierrez failed to appear and violated his bail bond of \$5,000. But he was apprehended and turned over to the Riverside County Sheriff's Department last month.

Fire finance committee reviewing future costs and revenues

Comparison with other Riverside County communities made

At last Wednesday's finance committee meeting, Idyllwild Fire Capt. Mark LaMont described the budget preparation process and how different assumptions affect the budget request.

In her introduction of LaMont, committee chair and Commissioner Nancy Layton said, "He is in the thick of it; officer development and the most cognizant of pay and payroll issues."

Beginning the meeting was a discussion of the salary comparisons with several county cities such as Hemet, Palm Springs and Riverside. Committee member Sue Weisbart requested information on the salaries and budget for other mountain fire departments, such as Big Bear and Lake Arrowhead in San Bernardino County.

LaMont was also able to include data from the county Fire Department, too. He separated the county costs be-

tween resources allocated to service of the 17 contracts with cities for fire services and the rest of the department's responsibilities, such as the unincorporated area, Ryan Airbase, conservation crews, the Office of Emergency Services, pre-fire resources (the staff at the Mountain Resources Center) and hazardous materials teams.

LaMont did present some per-capita costs and Idyllwild's was high, about \$367 per person, based on a population of 4,600 people. Hemet had the lowest per-capita cost at \$115, followed by Cathedral City at about \$140.

Committee member Calvin Gogerty thought the per-capita calculation was unfair for Idyllwild because of its much-high visitation population compared to the permanent residents at the other cities.

LaMont also presented some long-term projections of revenue and costs. Total expenses will grow from \$1.7 million this fiscal year to \$2.3 million in 2024-25. The proportion between the budget categories remained the same. For example, salaries are always 53 percent of the total, so that account grew from \$911,000 to \$1.2 million, a 33-percent increase in 10 years.

Revenues will grow from \$1.7 million and a surplus

of \$35,000 this fiscal year to \$2.3 million in 2024-25 and a \$6,500 surplus. But the projection indicates that revenues will exceed expenditures every year during this 10-year period, for a total surplus projection of \$220,000.

LaMont also presented two salary alternatives. The first would restore the salary reduction negotiated in 2012. That would increase costs about \$330,000, according to LaMont.

The second alternative would add a battalion chief to the district. The change in costs depends upon whether that position replaces a captain or if three crew captains are kept.

The capital improvement budget was discussed briefly but no specific projects were discussed. The preliminary capital budget Chief Patrick Reitz gave to the committee in February recommended a capital investment of about \$850,000 over the next nine years. This included replacing two administrative vehicles, a brush engine and two ambulances.

The finance committee will meet again on March 16 and hopes to have a recommendation to the commission for its March 22 meeting.



Take all of this personally because it directly affects the quality and scope of government information you get from the press.

Wouldn't it be great if more people understood a reporter's exclusion from a meeting also excludes them, the general public, from learning details that are being hidden?

Wouldn't it be great if everyone embraced the notion that government openness is an essential pillar of democracy?

Wouldn't it be great if more people remembered the press serves as their eyes and ears in the halls of government?

Wouldn't it be great if more people became aware that jailing journalists not only intimidates the press, but also chills the public's right to know?

Wouldn't it be great to see thousands of citizens press Congress to pass a federal shield law protecting reporters from being locked

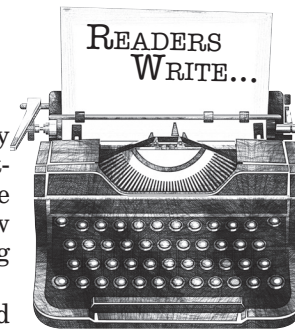

Dietrich Bonhoeffer offers a model to Christians and all believers in democracy...

Dietrich Bonhoeffer was a young Lutheran minister from Germany who came to America in 1930 to study at Union Theological Seminary in New York City. When he returned home, he found his country in turmoil. By 1933, Adolf Hitler was Germany's chancellor and his party, the National Socialist German Workers Party, had captured the minds of the German people.

They employed rumblings of war and scapegoating in an effort to restore the greatness of what Germany once was.

Dietrich was a peaceful man and a devout pacifist, but he could not ignore the dangerous road his countrymen were heading down. As a Christian, he felt he could not sit back and watch what was happening without speaking against the rhetoric of the Nazi Party in good conscience, a rhetoric he believed would bring great shame to the German people.

He was a theologian, who became a man of practicing faith. He wrote a book about his dilemma which became a landmark Christian text entitled "The Cost of Discipleship."

Eventually, Bonhoeffer, after much consideration, moved toward activism and joined the plot, centered in military intelligence, to assassinate Adolf Hitler. The plot was exposed and Bonhoeffer, along with his fellow accomplices, many of whom were highly ranked military officers, were imprisoned and eventually hung shortly before the fall of Berlin.

This is a crib note of the life of Dietrich Bonhoeffer. If you are interested in following up with a more in-depth account of his life, there are two good books you can read, "In Pursuit of Dietrich Bonhoeffer" by William Kuhns and "The Shame and the Sacrifice" by Edwin Robertson.

I had written another article for this month's column, but reading about what is occurring before and during Donald Trump's rallies, I felt compelled to speak out against the troubling events I am seeing.

Initially, I found Donald Trump to be a sideshow barker, bombastic, but nothing more than a distraction and an amusing entertainment that would slowly fizzle out and allow us to talk seriously about the problems facing our country. I was wrong; this has gone farther than I expected.

In the past couple of weeks, Trump has escalated his rhetoric to a point where it is seen as advocating and inciting violence as a response to dissent. This is a very dangerous road we are heading down. He can deny his complicity all he wants, but every word he speaks is on tape and it is clear that he eggs on his supporters to do his bidding for him. There is no excuse for this type of behavior; no matter where your political leanings reside. Violence is not how we should respond to disagreement.

I am not equating Trump and Hitler; but let's not forget that, initially, Hitler was seen as being benign to the world. In the beginning, all eyes were on Berlin for the 1936 Olympics when Hitler was newly elected. Months later he invaded Czechoslovakia and the rest is one of the darkest stains in human history.

It's tax time, and the "IRS Tax Scam" is out and about. Actually, this scam operates all year long, and it involves you receiving a recorded (usually) telephone message that "this is your second and last warning" that you owe the IRS money for back taxes and late fees, which you must pay off immediately or you will lose your home or go to jail.

Another IRS tax scam is a friendly phone call "just to verify information" on your tax return. The scammers want Social Security and/or credit card information.

If you really do have a problem with the IRS, it will not make initial contact with you by phone or email. It'll send you letters, and things will progress in the usual bureaucratic way — meetings, audits, etc. The IRS doesn't just suddenly demand that you send it money, nor will it demand a particular method of payment. The government is fully aware of these scams and will take every precaution to make sure you know you're really dealing with the IRS. (Visit the IRS website at www.irs.gov/Individuals/Taxes-Security-Together.)

Here's another classic scam called "the Nigerian Scam," which has unlimited variations. I received this email, exactly as written, this past Monday morning:

"Greeting From Godfrey's Family.

"I am sending you this private email to make a passionate appeal to you for assistance. Kindly accept my apology for contacting you this way and forgive me if this is not acceptable to you. I am introducing myself as Ms. Lillian Godfrey (23 Years Old), the only child of late Mr and Mrs Jack Godfrey. I wish to request for your assistance in a financial transaction and I also wish to invest in Manufacturing and Agricultural production in your country

"I have US\$ 15.200 million to invest in your country which my late father deposited in London UK. I will require your assistance in receiving the funds in your personal/company account for investment and also to enable me continue my education in your country i will give you more details.

"I look forward for your response for more details.

"Best Regards,

Ms. Lillian Godfrey."

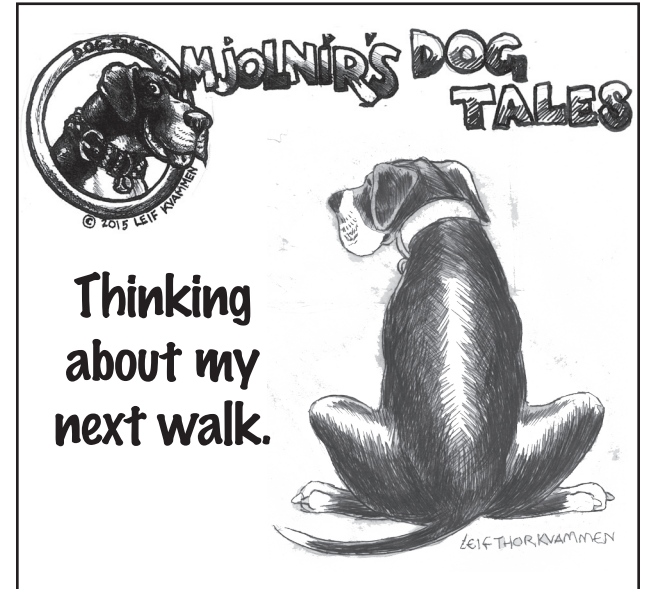
Lastly, here's one I call the "Loved-One-Needs-Bail-Money Scam." My son's grandparents were bitten by this one. They got a telephone call from someone purporting to be a lawyer in Mexico. He said their grandson (my son) had been arrested on what the lawyer believed was a trumped-up drug charge. He could get him out of it, but it required \$3,500 in bail money and fees, which he needed right away.

The lawyer said their grandson begged that they not contact his parents because he wasn't supposed to be in Mexico and they would be very angry. They sent the money — without first contacting me, of course.

Actually, there is no "Scam Season." You and your family are year-long prey for scammers, and variety of scams is unlimited. Be careful out there.

More tax changes this season

Standard Mileage Rates Revised

The standard mileage rates for the use of a car, van, pickup or panel truck have changed to the following amounts:

- for business miles driven in 2015, the mileage rate increased to 57.5 cents per mile from 56 cents in 2014. For those planning ahead, the 2016 rate, for use on a 2016 return filed next year, is 54 cents per mile.
- for medical or moving purposes, the rate was reduced to 23 cents per mile driven in 2015 from 23.5 cents in 2014. The 2016 rate will be 19 cents.
- for service of charitable organizations, the rate is unchanged, 14 cents per mile driven. This rate is set by law.

The tax instructions have details on taking advantage of each of these provisions.

Tax ID Number Required to Claim Three Key Tax Benefits

Taxpayers, along with any of their qualifying children, must have a taxpayer identification number to claim any of three key tax benefits. For most people, a TIN is a Social Security number. Furthermore, to get these benefits on a 2015 return, the taxpayer must receive the number before the due date for filing a 2015 return (either April 18 or April 19, or for those who get an extension, Oct. 17).

This requirement applies to the Earned Income Tax Credit for low- and moderate-income workers and working families, the Child Tax Credit claimed by many families, and the American Opportunity Tax Credit — the popular tax benefit that helps parents and students pay for college.

New Starter Retirement Account Available

Taxpayers can now take advantage of a new starter retirement account available free from the Treasury Department. Through the myRA program, eligible taxpayers can choose to fund a starter retirement account through payroll deductions, electronic transfers from a savings or checking account or by choosing direct deposit for their federal income tax refund. Local fire agencies preparing for next fire season

As Riverside County Fire Chief John Hawkins reminded local fire officials at last week's Mountain Area Safety Taskforce meeting, the 2016 fire season is approaching quickly.

"MAST is about preparation and cooperation," he stressed. "We do all we can in a systems approach to reduce probable threats ahead."

Confirming Hawkins' statement, items discussed during the meeting focused on planning and actions taken this winter to assist residents, contractors and public agencies during fire season.

For example, Edwina Scott, executive director of the Mountain Communities Fire Safe Council, reported that the roofing grant from the Federal Emergency Management Administration was nearly complete. There are some funds available through the middle of May.

The MCFSC has helped replace 92 shake shingle roofs in town, and seven more are being replaced.

The 2014 grant funds (\$180,000) have been expended for fuels reductions work on 117 parcels. The MCFSC's 2015 grant funds have already completed work on 10 parcels.

Both the U.S. Forest Service and Cal Fire are completing pile burn projects as well as work on the fuel breaks surrounding the Idyllwild and Pine Cove communities.

Forest Service Fire Chief Fred Espinosa said the agency is awaiting a good weather window to pursue its plan of work on Thomas Mountain in Garner Valley.

Hawkins also stressed that all fire command officers, who may be responsible for fighting fires on the Hill, should know the location of all fuel breaks and under what conditions they should be defended.

Besides fire season, spring helps identify the damage due to infestation of the bark beetle and the Gold-spotted oak borer. Both pests are still prevalent on the Hill and continue to kill off pines and oaks.

While Southern California Edison's work on the Hill has diminished since last summer, Project Manager Dave Simmons said, "From January 1, nearly 120 trees have been removed and the backlog is 20. With summer coming, we're waiting for another flair up."

Cal Fire's Mountain Resource Chief Gregg Bratcher reported that four more trees have been identified as victims of the GSOB. He asked the community to be looking for additional trees during spring.

"The spring leaf out is time to pay attention," he advised. "The new leaves are usually smaller and dead leaves are still hanging on these trees."

Also the County Waste Resources department is considering to move a grinder to its local site full time for the summer. This is important when oaks are removed because of GSOB infestation. Summer is flight season and the trees cannot remain whole for more than a few days or the GSOB will escape.

The presence of a grinder might also increase the eradication effort, Bratcher suggested. "It would be more cost-effective and more efficient for the community," he said.

This winter, the station has ground almost 1,000 tons according to Paul Spencer of the agency.

Currently the grinding station is open Tuesday and Friday. In May, it will also be open Saturday, according to Spencer; but they will look at changing that to Monday, Wednesday and Friday.

With the approaching fire season, both Cal Fire and the Forest Service will have additional crews trained and stationed on the Hill by June 1. Also training on the use of the water pumpkin kept near the Mountain Resource Center is being planned.

Lake Hemet eagles nesting during Saturday's count

Saturday was the fourth and last bald eagle count of the 2015-16 season. Volunteers and federal and state biologists spotted 12 bald eagles at various Southern California lakes. The nesting pair at Lake Hemet were among the dozen eagles seen this weekend.

Five adults and seven sub-adults or juveniles were observed during the one-hour count period Saturday morning. About 120 people participated in the count. The Lake Hemet contingent included more than a dozen observers.

At Silverwood State Recreation Area, two sub-adult bald eagles were seen. Ken Kietzer, senior environmental scientist at Lake Perris State Recreation Area, reported two sub-adult bald eagles, one of which was about 4 years old and had plumage that was close to the adult plumage.

At Lake Arrowhead, one sub-adult and two adult bald eagles were seen and another three eagles, two of which were sub-adults, were counted at Big Bear Lake.

The next eagle count will be in December for the beginning of the 2016-17 eagle census.

rollover from an IRA to another (or the same) IRA in any 12-month period, regardless of the number of IRAs he or she owns. The limit applies by aggregating all of an individual's IRAs, including SEP and SIMPLE IRAs as well as traditional and Roth IRAs, effectively treating them as one IRA for purposes of the limit.

But the IRA owner can continue to make unlimited trustee-to-trustee transfers between IRAs. Before 2015, the one-per-year limit applied

only on an IRA-by-IRA basis, that is, only to rollovers involving the same IRAs.

There is a 2015 transition rule that ignores some 2014 distributions. An IRA distribution rolled over to another (or the same) IRA in 2014 does not prevent a 2015 distribution (within the one-year period) from being rolled over provided the 2015 distribution is from an IRA that is different from any IRA involved in the 2014 rollover. More information, including examples, can be found in the Can You Move Retirement Plan Assets? Section in Publication 590-A.

Mosquitoes a concern on Hill

Stagnant water poses good homes for mosquito eggs

Vector control was the topic at last week's Mountain Emergency Services Committee meeting. With the expectation of above-normal precipitation this winter, Kathleen Henderson, the Riverside County emergency services coordinator for the mountain, thought a discussion of how to deal with mosquitoes and other disease carriers would be helpful for local residents.

Doug Osborn, the supervising environmental health specialist for the county Department of Environmental Health, began with an explanation of the meaning of a "vector" and the dangers some pose to Hill residents.

"A 'vector' is any organism, such as a mosquito or rodent, that transmits pathogens or bacteria to humans," he began. "On the Hill, 90 percent of our threats come from mosquitoes. These small-winged creatures can transmit to humans the following diseases: West Nile virus, yellow fever, chikungunya, dengue, malaria and now Zika. Our local canines are susceptible to heartworm, which mosquitoes also transmit."

Other dangers, which have been identified on the Hill, include the plague, hantavirus and Lyme disease.

The current and biggest concern is West Nile fever. Osborn stressed, "It does kill people and two different mosquito species transmit it."

The WNV has been in California for more than a decade. Since 2003, more than 5,500 people have been infected and 221 have died, 45 of them in 2015. While 17 percent of the infections last year were in Riverside County, none of the deaths occurred here.

Although there is no human vaccine for protection from the WNV, there is an equine vaccine, according to Osborn.

Vector Control can be reached at 955-766-9459. It will investigate the problem, identify the vector (mosquito, rodent, other or none) and provide treatment, Osborn stated.

The Zika virus has created a major international situation. Although the public health community has been aware of it for decades, it is now spreading into much larger populated areas.

Although several Californians have contracted the virus, they were infected outside the United States. Osborn emphasized that the virus has not been found in California.

While adults may suffer severe symptoms such as joint pain and fever, a fetus is susceptible to possible microcephaly or even Guillain-Barré syndrome, an uncommon sickness of the nervous system. GBS causes a person's immune system to damage nerve cells, which will result in muscle weakness, and sometimes, paralysis.

The mosquito species, which transmits this virus, has known habitat in the San Jacinto Valley, but Osborn stressed

that "there have been no locally transmitted cases in Riverside County."

Another vector is the deer mouse, which can carry the hantavirus. Several years ago, the virus was detected on the northern edges of the San Jacinto Mountains. Similarly, the plague, which is carried by fleas on rodents, has occasionally been identified on the Hill. There are no current cases reported, according to Osborn.

One danger, which Vector Control does not address, is rabies, which can be

transmitted by bats.

Before the meeting ended, Henderson introduced Jerry Hagen, who this spring will assume responsibility for the mountain area and all of Riverside County District 3. The county Emergency Management Department has realigned its staff to correspond with the county's supervisory districts. Henderson will work with District 2 agencies, when the change is implemented.

Tim Lange resigns from Pine Cove Water board

Tim Lange, elected to the Pine Cove Water District board in August, submitted his resignation at the March 9 meeting.

"It is given with mixed feelings," he said. He and his wife will be moving to Willamette Valley in Oregon, where he resided for about eight years in the 1970s.

Lange was consistently upbeat and positive about the community and his board colleagues. In his resignation letter, Lange wrote, "On the one hand, it has been a pleasure to serve the Pine Cove community. On another, I am under advisement to live at a lower elevation."

"I will miss Tim's presence on the board and wish him well as he moves to the next chapter in his life. His quiet, cerebral manner was a constant calming force for us all as we tackled some tough issues," said President Robert Hewitt about Lange's time with his fellow directors.

Lange was appointed to the PCWD board in July 2015 to finish the term of former board President Mike Esnard, whose term expired in December 2015. In the August election, Lange also ran for and won a full four-year term, which will expire in December 2019.

Whoever replaces Lange will serve until December 2017. The final two years of the term will be filled through an election in August 2017. State law requires appointees to stand for election if more than two years

remain in the term to which they were appointed.

His resignation was effective following the meeting. Hewitt announced that Pine Cove residents interested in replacing Lange should submit their applications by the close of business Friday, April 8, and the board will review the applicants and try to make a choice at its April 13 meeting.

The board tentatively approved a resolution for the annual standby assessment 5-0. A public hearing on the \$30 assessment will be held at the June 8 meeting, Hewitt said. The assessment is applied to parcels in the district without an active water meter.

In water business, PCWD's February water usage was 2.1 million gallons, which was about 100,000 gallons less than January, but 130,000 gallons more than February 2015.

"Well no. 10 [the monitoring well] is holding its own," General Manager Jerry Holldber said. "It will take a few months for the precipitation to affect it."

The groundwater level of several of the district's other wells has fallen some since the extra pumping during December when the district experienced inordinate leaks.

During the public comment period, Pine Cove resident and realtor Marge Muir again expressed her objection to the district's subsidization of rain barrels for individual's use and the time it is taking to propose a revision to the basic operating rule, Ordinance 4.

Edmund Yang, new owner of the Gastrognome, plans a steady course

Zhen "Edmund" Yang, new owner of the Gastrognome, plans a steady course as he moves the flagship restaurant forward. Yang took over from longtime owners Lanny and Jane Wagstaff on Feb. 20.

"I am asked by every customer if I am going to make changes," said Yang. "What I tell them is 'If this is so successful, why would I need to change it?' People like our restaurant, our service and our food."

Yang said he might introduce new items on the specials menu. "Some fusion cuisine such as seared sesame crust Ahi tuna, beef stir fry with a special Chinese sa cha sauce and maybe a curry coconut shrimp dish."

Yang knows his international cuisine. A native of Beijing, China, he served as executive chef in one of Beijing's largest and most luxurious hotels, the Hotel Nikko New Century Beijing, part of a joint venture with Japan Air Lines. "We served French cuisine, that's what I started with," said Yang. "And of course Chinese and Japanese cuisine as well. We had over 70 chefs in the kitchen."

In 1996 Yang and family moved to Vancouver, Canada, where he worked at the Vancouver Hyatt Regency as a chef. Two years later Yang and his wife started their first business, a food court in a busy shopping center. After four years they bought a restaurant on

Vancouver Island. Eventually they bought a franchise restaurant, Smitty's, the largest family restaurant franchise in Canada and, at the time, the largest restaurant on the island.

After spending 16 years in Canada, they began driving through the United States looking for a restaurant purchase opportunity and a warmer place to settle. The Yangs bought a Chinese restaurant in Riverside but continued to look for somewhere with a small town ambience. "We wanted to find a better business," said Yang. "When Lanny [Wagstaff] put the Gastrognome on the market, we just took it. It

was so established after so many years with the Wagstaffs."

Yang commutes every day from Riverside at this point. "We're currently looking for a house in Idyllwild," Yang and his wife have two sons, one 24 who is studying philosophy at a university in Canada and a 13-year-old at school in Riverside.

"I really enjoy this small town," he said. "Even with some new additions on the special menus, we will still keep everything as before."

Jazz chanteuse Rose Mallett performs for fundraiser

Chicago born jazz chanteuse Rose Mallett performs in Idyllwild to raise money for scholarships to the Idyllwild Arts Academy.

The Associates of the Idyllwild Arts Foundation are staging the fundraiser as a "jazz brunch" on Sunday, March 20. Active since 1968, the Associates have performed many functions that benefit the arts and arts education, particularly in providing scholarship assistance for IA students and cultural activities for the wider Idyllwild community.

Incorporated as a 501(c)(3) nonprofit, the Associates established an endowment fund in 1988 to support arts scholarships in perpetuity. Now comprising almost \$300,000, the fund provides interest income annually to scholarships for both the Academy and Summer Program. Ticket sales from Mallett's performance help the Associates in its mission to increase its scholarship-dedicated endowment fund.

Featured artist Mallett began singing in elementary school as part of the school chorus. At 16, after her family relocated to Los Angeles, she formed an R&B group with three girlfriends. Sam and Dave, the Rock & Roll and Grammy Hall of Fame R&B duo heard the group and offered them a chance to record a demo at Capitol Records in Los Angeles. The demo led to a Capitol recording contract for the young singers.

Mallett's career broadened after meeting Marvin

Gaye and Motown producer Hal Davis. Davis enlisted Mallett in recording demos of songs he had written to pitch to already-signed Motown female artists. Davis was producer and co-writer of Jackson Five hits "I'll Be There" and "Dancing Machine."

Mallett has performed in Las Vegas at the Hotel Riviera and the MGM Grand. She has recorded as a voice-over artist and is scheduled to perform this year at Jazz in the Pines. Critics have likened her vocal range to that of Sarah Vaughan, her style to the joy and playfulness of Ella Fitzgerald, the brooding pain of Billie Holiday and the regal bearing and articulation of Lena Horne. The Los Angeles Times called Mallett a "major attraction." "Sarah Vaughan is my all time favorite singer," said Mallett. "Right now I'm in the process of putting a one woman show together."

Mallett works regularly in Palm Springs – the Purple Room, the Palm House and Woody's. At the Sunday jazz

brunch she will be accompanied by jazz pianist Tateng Katindig.

Brunch will be served at the Fireside Room of Nelson Dining Hall on the IA campus at 11:30 a.m. Mallett's performance will be at Stephens Hall ("The Barn"), walking distance from the dining hall, at 1:00 p.m.

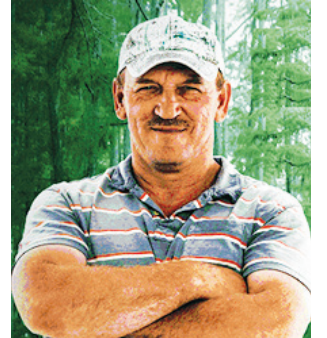

Idyllwild School grantmakers award \$3,000

The Idyllwild School Youth Grantmakers awarded \$3,000 to three separate groups last week. This is the fourth-consecutive year that a group of students made philanthropic decisions to the benefit of the community and student life.

During its award of grants to local nonprofit organizations, the Idyllwild Community Fund began to set aside funds for local students to learn about philanthropy and its effect on their community.

The students were looking for projects that provided space and opportunities for local youth, involved the arts, and encouraged good behavior, and all-around health and well-being in the community.

Each recipient received an award of \$1,000 this year.

Funds were provided to help produce a spring musical, "Alice in Wonderland," at Idyllwild School. The funds will purchase scripts and costumes, the students said.

"I'm thrilled," said Buzz Holmes, head of the school's Music Department.

Another \$1,000 was granted to the school's Outdoor Education programs, which the Booster Club organizes. The annual trips are for grades six through eight.

The sixth graders travel to Joshua Tree National Park, the seventh graders visit Catalina Island and the eighth graders go to AstroCamp. The funds will provide scholarships to enable all of the students to participate in these off-campus events.

The third grant was awarded to the Friends of the San Jacinto Mountains County Park to recruit student interns to help design and implement the Junior Naturalist Program at the Idyllwild Nature Center for the summer of 2016.

"This will sponsor several youth interns, who will research and explore an area of nature in Idyllwild and then present a workshop," said Amanda Allen, park interpreter at the Nature Center.

This is the second year the grantmakers have funded this program.

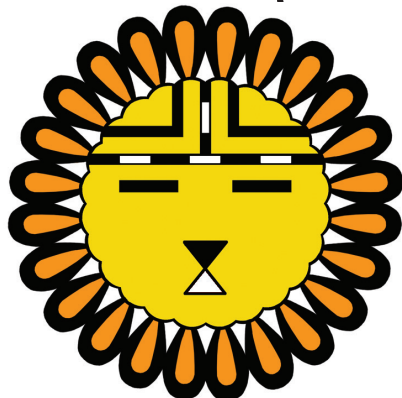

the James

Oasis de los Osos, our desert sister site ...

Many of our readers are familiar with the James Reserve from our writings and public talks. However, few know that the James officially consists of not only our site near Lake Fulmor, but a second site on the other side of the mountain in the northeast foothills of Mt. San Jacinto.

So I want to take some time here to introduce our "sister" site, Oasis de los Osos (Los Osos, for short). Why is it called Los Osos? As it turns out, oso is Spanish for bear and in the history of the area, a fellow by the name of Robert Bear donated the money to The Nature Conservancy to buy the property in 1987. It then deeded it to the University of California Natural Reserve System as part of the James Reserve complex.

And a fine addition it was. Together, the James and Los Osos represent the two extremes in climate and vegetation found in the region.

While the James is covered in relatively moist, tall pine-hardwood forest, Los Osos is a dry, low-shrub/grass area typical of the Colorado Desert that flanks the eastern edge of the San Jacintos. And therein lies the beauty of the relationship between the two sisters. Together, the James and Los Osos provide the researcher and the school groups an opportunity to study and learn about the vast and varied ecosystems that make up our mountain home here in the San Jacintos.

And Los Osos does this well. With an average annual rainfall of only 13 inches and summer temperatures above 100° F, Los Osos truly classifies as a hot desert. As a result, some of the more interesting things to learn are how the plants and animals that live there cope and survive.

And there are plenty of them that do. From the hardy California sagebrush (*Artemisia californica*) to the delicate scarlet monkeyflower (*Mimulus cardinalis*), more than 100 species of plants can be found at Los Osos. More than 100 bird species, from hummingbirds to eagles, fly over the desert vegetation. In excess of 30 mammal species, from shrews to coyotes, with a surprisingly high number of bat species (13), roam the area.

Not surprisingly, Los Osos is a reptile haven. Besides three species of rattlesnake, 24 lizard and snake species can be found there. This high diversity of plant and animal life, typical of desert areas, seems contradictory to the hot and dry conditions found there.

But that is the beauty and fascination of deserts. Unlike the closed canopy of a forest, the abundance of solar energy reaching the ground surface, along with a little bit of water, provides ample ways of making a living — we call them niches — for plants and animals.

However, not all is hot and arid at Los Osos. First, as we all know, being "down the Hill" in winter is actually

quite pleasant. Add to this the occasional rains that fall in winter, Los Osos is a very enjoyable place to work and learn.

Next, and most important, like its name indicated, Los Osos is an oasis. Lamb Creek, named after early settlers of the area, is a perennial stream providing water to wildlife and enabling a narrow band of green, including a native palm tree (*Washingtonia filifera*), to grow along its banks. The presence of the stream, including a waterfall, adds another dimension to the research and learning potential of the area.

Side-by-side comparisons of moist and dry communities can be made. Studies can be done to show the importance of this water source to surrounding wildlife, from insects to coyotes and bobcats. It also provides a cool and peaceful respite for school groups coming to the area.

Although Los Osos plays a unique role in UCR's research and teaching programs, we strive to help it reach its full potential. Toward this end, the director of the James and Los Osos, Dr. Jennifer Gee, applied for a planning grant to assemble a committee and hold workshops aimed at designing a five-year plan to improve the James and Oasis de los Osos reserves.

With the recommendations in hand, our next step is to apply for more funding from the National Science Foundation to

make the oasis field site as attractive as the James. We hope our efforts will result in new scientific discoveries and open up

young minds to the beauty and wonders of the desert environment that surround our mountain home here in Idyllwild.

Introducing Katy Kirkpatrick, new Town Crier front office manager

She attended Cal State University, Dominguez Hills and obtained post-baccalaureate certificates in prosthetics and orthotics in 2011. She worked for several orthotic and prosthetic practices in Los Angeles. As an orthotist/prosthetist, she worked directly with patients and also implemented new company inventory and marketing approaches. But again,

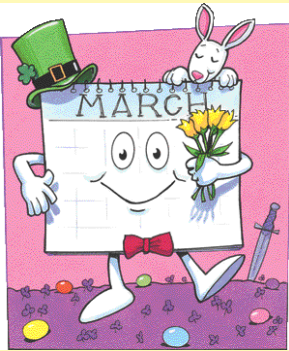

40 years ago - 1976

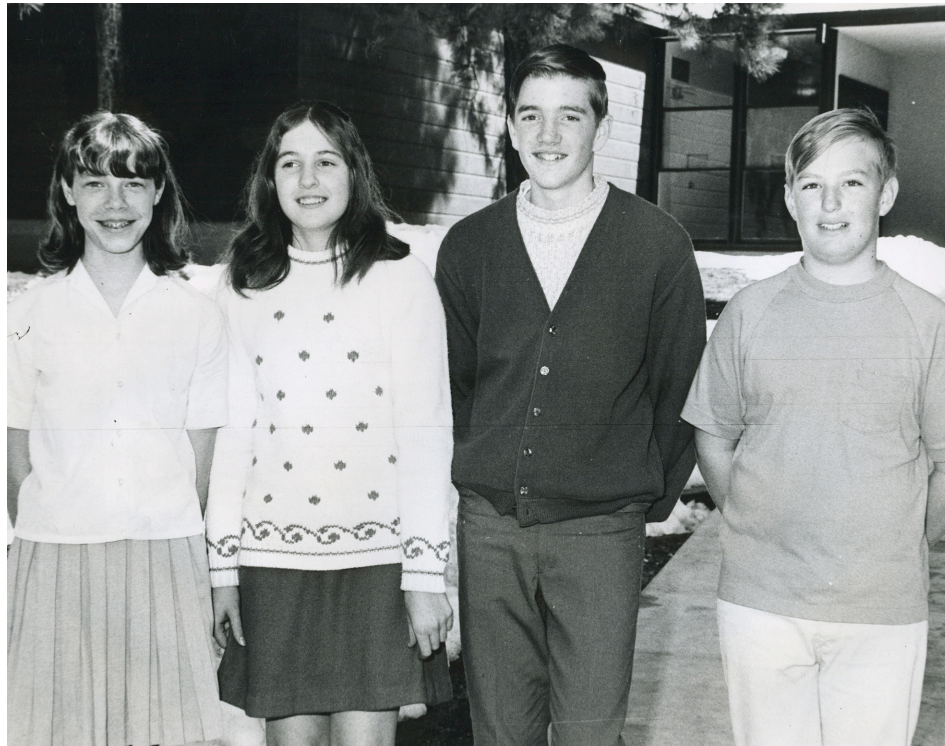

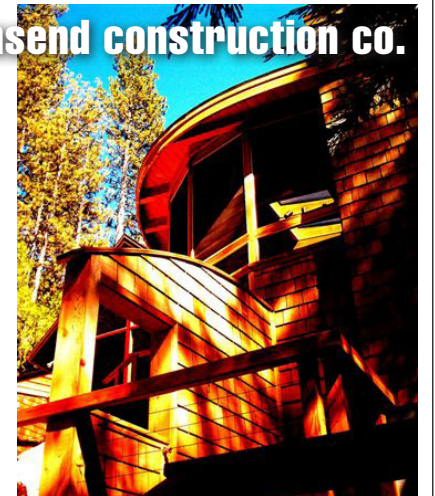

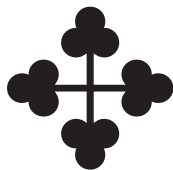

national company (Amerigas) and three local or regional companies (AC Propane, Diamond Valley Propane and SoCal Propane) continue to cooperate and report pricing and other information to the Town Crier. Two (Suburban and Ferrellgas) have stopped doing so.

Suburban's local manager in Idyllwild referred our inquiries to Peter Teshima, assistant vice president of marketing, at Suburban's corporate headquarters in Whippany, New Jersey. The Idyllwild office manager said his office would no longer report pricing to the press. Teshima, at corporate headquarters, has not returned calls after repeated inquiries.

Ferrellgas' local manager Brandy stressed that many factors influence pricing making it difficult to quote prices. She mentioned variables that could affect pricing at Ferrellgas such as membership in homeowners' associations, amounts of propane used per year and other factors. While she did report Ferrellgas' first fill price had fallen to \$1.69 per gallon (from a Jan. 22 price of \$1.74), she later said she could not quote other prices or policies and would forward our inquiries to Ferrellgas Director of Operations, Terry McGuire.

Shortly after that conversation, a male Ferrellgas representative left a message with our front office manager stating there would be no further reporting to the press of company pricing or policies and that the Town Crier would be receiving a letter from Ferrellgas' legal department.

In contrast, national company Amerigas, both at regional (Temecula) and national offices (King of Prussia, Pennsylvania) has stated its company's willingness to provide the information Idyllwild readers have been seeking. The three regional companies also comply by readily supplying information.

Propane prices and policies are not government regulated in the ways public utilities are. They are market responsive. Competition as well as customer loyalty and satisfaction are elements in companies' setting propane pricing and policy. Propane is priced at points of production (wholesale) and then at points of delivery (retail). Transportation and delivery costs are factors that help determine retail pricing.

As overview, propane "spot" prices at points of production can change daily and are generally reported weekly. For example, for the week of March 7, the U.S. Energy Information Administration reported national average wholesale propane prices at 50.9 cents per gallon and retail prices at \$2.021.

Locally and nationally, propane prices have fallen slightly from those last reported in our edition of Feb. 28. The good news continues to be that in the West, propane delivery prices for the week of March 7 are generally lower than in five of the seven regions monitored. Only the Midwest shows lower pricing than the western region. Highest per gallon prices are in New England at \$2.799. Lowest are in the Midwest at \$1.42. Average for the

West is \$1.855.

Companies reporting prices this week include Amerigas at \$1.99 per gallon community pricing, Diamond Valley at \$1.93 and \$1.73 for customer owned tanks, SoCal at \$2.03 per gallon and \$1.73 for customer owned tanks, and AC Propane at \$1.79 for first fill and subsequent fills vary.

In comparing companies, questions include: price for first fill, subsequent fills, and any per gallon discounts based on memberships in associations, amount of propane used on average (using more often results in a per gallon discount), and whether the provider is filling a tank rented from the company or one owned by the customer (propane for owned tanks is generally 20 cents less than for rented tanks.)

Other questions include tank rental fees, costs if any of removing a tank when changing providers, and company policy if you run out of propane. As each company will explain, they use many factors in determining propane pricing and policy.

In general, propane pricing seems to be holding steady throughout the periods for which we have been reporting. We will survey again in two to three weeks.
