## Sheriff to test drones for search and rescue

Riverside County plans to test the use of unmanned aerial vehicles, or drones, to enhance its search-and-rescue operations, particularly in the San Jacinto Mountain areas.

"We're constantly monitoring new technology that's more effective and will improve our operations," said Chief Deputy Kevin Vest of the Sheriff's Department.

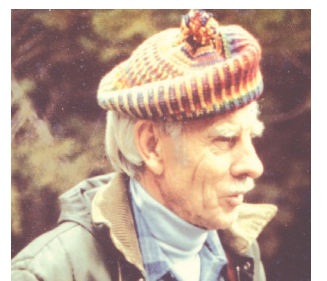
Having seen the success of this technology during fires in Northern California and flooding incidents in Colorado, Vest said the county is working with Sentera LLC of Minnesota to test its UAV for one year. The evaluation period will likely start in late May or early June after substantial training of personnel.

He stressed this equipment will be used only for search-and-rescue missions. There is not intent for an aerial observer. The fixed-wing technology is much less

# An ‘Only on the Hill’ traffic incident

The California Highway Patrol Banning Pass station reported only one incident on Hill roads over the last week and this one had an “Only in Idyllwild” flavor to it.

CHP Public Information Officer Darren Meyer reported a hit-and-run — more properly, an overturn-and-run, that happened at 10:52 a.m. Monday, April 18.

An unidentified male was driving his green 2004 Ford Explorer north on Highway 243 about 2 miles north of Mt. Edna Road when he lost control of the vehicle and it overturned. Directly in back of the incident was a Bautista Fire Crew bus that arrived on the scene as the “wheels of the vehicle were still turning,” according to the CHP report.

The fire captain got out of the bus and approached the driver of the vehicle, who was already out of the vehicle. Upon seeing the fire captain, the man, black and in his early 40s, according to the fire captain, seemed agitated but uninjured.

The man began rapidly grabbing his belongings and attempting to remove the plates on the vehicle. He succeeded in removing one, and with his belongings and the single license plate in hand, the man fled on foot into the woods.

A CHP officer arrived on the scene about 12 minutes later and began a search for the man in the direction he had fled. He did not find the individual.

CHP ran a search on the license plate and found the vehicle to be registered to a security company in Moreno Valley. CHP had the vehicle towed. The driver has still not been located.

# Female body still unidentified

The Riverside County Sheriff's Department is still investigating the death of an unknown female. The body, which was badly decomposed, was found Sunday, April 10, along Highway 74.

Monday, Lt. Dan Florez, of the Sheriff's Hemet Station, said, “Investigations is conducting a broader search of the crime-scene area for any other evidence related to the body located in the area.”

The department's Media Bureau said last week, “Our department is investigating this death and at this time it is unclear how the person died.”

As of Monday, the victim has not been positively identified and the cause of death is pending.

This is an active and ongoing investigation, according to the Sheriff's Department. Anyone with possible information should call Investigator Joshua Button at 760-393-3531.

## County supervisors decline budget committee oversight

### Brown Act compliance too costly

Last week, the Riverside County Board of Supervisors couldn't agree on how to approach, and the extent of its own involvement in, the annual budget process. The culprit, according to the majority, is the Brown Act.

Facing another budget deficit, during its previous meeting, the board agreed to spend \$18 million on a consultant to review its budget from top to bottom. But funds for public involvement in board reviews was considered too expensive.

Supervisor Kevin Jeffries (1st District) proposed that the board create four standing budget committees to improve the supervisors' involvement and understanding of the overall budget process.

As he began his argument for the proposal, Jeffries posted a Press-Enterprise story with the headline, "Budget issues await supers."

"This headline was three-and-half years ago. Budget problems are a problem every year I've been on the board," Jeffries said, stressing the need for the supervisors to invest more oversight in the budget work.

The four subcommittees would address the criminal justice and public safety agencies, general government, health and human services agencies, and public works.

However, a majority of the board, along with County Executive Officer Jay Orr and General Counsel Gregory Priamos, felt this would be creating a cumbersome, intrusive new bureaucracy that would only add to the county's expenses.

On a 4-1 vote, with Jeffries opposed, the board referred the idea to Orr and Chair John Benoit (4th District) to review and explore less expensive and less intrusive alternatives but still enhance the board's knowledge and involvement with the county budget. They were asked to bring a report back to the board by September, when work on the fiscal 2017-18 budget will begin.

"This is a very important area and we need to spend more time on it," Benoit told Jeffries.

Jeffries was dismayed that his colleagues essentially did not want to get involved and amazed that they blamed the Brown Act, the state's open government law.

"I knew it would be difficult with the CEO opposed," he stated. "I'm surprised the discussion is about not spending money to support Brown Act compliance. We just approved \$18 million for an external firm to do our job. How are we to gain control of ongoing budget deficits? ... This needs to be done in public, in compliance with the Brown Act, and with open discussions."

But Benoit, Ashley and Supervisor John Tavaglione were adamant that the creation of these subcommittees would be costly and bureaucratic without helping the board take responsibility for the county budget.

Orr warned the board in January that the fiscal year 2016-17 budget, which begins July 1, would suffer from a \$90- to \$100-million deficit. Some of this spending is the natural progression of negotiated salary increases and continued structural problems, but \$40 million is the result of a recent settlement to litigation over inmate health and mental health care.

Last month, the board agreed to spend \$18 million for KPMG, a consulting firm, to assess the county's criminal justice agencies — Sheriff, District Attorney, Probation and Public Defender — as well as an evaluation of the other county departments.

## OUT LOUD



The Riverside County Board of Supervisors developed an ingenious idea recently to deal with that pesky state open-meeting law, the Brown Act.

In its straining to develop a balanced budget for the 2016-17 fiscal year a few weeks back, Supv. Kevin Jeffries saw a need to create four subcommittees to deal with areas of the county government the board and CEO believes need addressing. The supervisors believe — and rightly so — they need to provide strong oversight in developing the budget.

But back at the table, on the advice of CEO Jay Orr and county counsel, in a 4-1 vote, the board decided the Brown Act would create intrusiveness into those subcommittees' deliberations. They scratched the subcommittees.

Chair John Benoit justified this decision by telling Jeffries, "This is a very important area and we need to spend more time on it." Jeffries, the only one opposed, was stunned.

As he stated, "This needs to be done in public, in compliance with the Brown Act, and with open discussions."

No, Jeffries, you don't get it. It costs too much money to be transparent — to prepare and post agendas, allow the public and the press into meetings where they might muck-up the proceedings with questions/comments and otherwise just slow down the whole process.

The county budget is just too important to let the county residents interfere in the supervisors' important doings.

The people/reporters should be kept out and let the leaders do their business. They might not like what the supervisors decide but they'll have to live with it. Afterall, it's for their own good.

Isn't that how it's done in other countries?

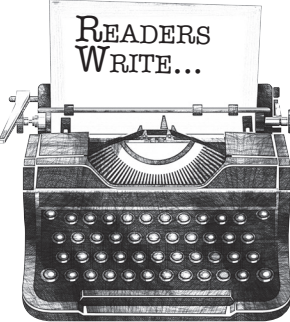

## Free/reduced-price school lunches

Hemet Unified School District is distributing application forms to all households for free and reduced-price meals for enrolled children. Applications are also available at the principal's office in each school.

To apply for free or reduced-price meal benefits, complete an application and return it to the school. Applications may be submitted at any time during the school year.

The information households provide on the application will be used to determine meal eligibility and may be verified at any time during the school year by school or program officials.

Requirements for free and reduced-price benefits are as follows: For households receiving Food Stamp, CalWORKs, Kin-GAP, or FDPIR benefits, applications need only include the enrolled child(ren)'s name, Food Stamp, CalWORKs, Kin-GAP or FDPIR case number, and the signature of an adult household member.

For households who do not list a Food Stamp, CalWORKs, Kin-GAP or FDPIR case number, the application must include the names of all household members, the amount and source of the income received by each household member, and the signature and corresponding Social Security number of an adult household member.

Riverside County Code Enforcement has issued an advisory notice to Idyllwild Property Management for two storage containers that have been placed in a lot at Fern Valley Corners in apparent violation of county code.

The alleged violation is of county Ordinance 348, specifically that “no land, building, or structure shall be used, constructed, altered or maintained except in conformance with the provisions of this title — Illegal Use.”

A subset of the ordinance relating to commercial storage containers, states in section 18.50 (b)(1) that metal shipping containers “shall not be allowed as a principal use in any zone.” Caveats allow temporary placement only when used for storage of equipment for construction or grading on the site in question, when there is a permit for construction on that site.

Ortiz confirmed there is currently no permit for construction on the site. Arn Hancock, who neighbors had seen moving things in and out of the containers, confirmed that his activity was related to business conducted by IPM at the direction of June Rockwell of IPM. “I was just helping them move things,” said Hancock. When contacted by telephone about the containers, Rockwell issued a terse “no comment” and then hung up.

In our Feb. 26, 2015, edition, we reported that IPM planned to open and operate a stacked, two-story storage facility on the narrow lot. At the time, Rockwell estimated it would take a year for plans to be drawn, permits pulled and the facility built. On April 26, we reported the proposed facility faced difficulty. Specifically, as noted by Olivia Balderrama, legislative assistant to 3rd District Supervisor Chuck Washington, it would be difficult to obtain a “Will Serve” letter from the water district. She also said the proposed facility would require a Conditional Use Permit because of zoning and that would also be difficult to obtain.

In contacting the West Hollywood office of IPM owner Moshe (Mo Jacob) Schnapp, his representative said he was aware of the issue but that it is being handled by his employee, June Rockwell, and he has nothing to do with it.

Contiguous neighbors had complained in 2015 when the storage facility had first been proposed because it would be out of keeping with the residences and kinds of business in that area of Idyllwild. They complained again when these two large storage containers were placed on the property several months ago, both to CE and to the county supervisor’s office.

Balderrama said the best solution would be for the alleged violation to be resolved through cooperation and removal of the containers by the owner and/or IPM managers. But failing that, Balderamma suggested there could be fines and forced removal, if CE finds the containers have been placed there illegally.

As part of CE procedure, an inspector must make a visual inspection, and notices of potential violation must be mailed to the property owner of record and other parties of interest.

If it is found there is a violation, and the violating articles are not removed within a stated compliance time, CE will issue administrative citations and consider legal remedies.

# SCE recommends defense against ongoing utility scam

## Customers lost over half-a-million dollars to scammers

A reader wrote to inform the Town Crier about being contacted by a purported Southern California Edison representative who demanded immediate payment for allegedly past-due electricity bills.

SCE Media Contact Susan Cox noted more than 700 SCE customers had been scammed at a total loss of nearly half-a-million dollars. "Since January 2014, more than 16,000 SCE customers have gotten telephone calls from impostors posing as SCE representatives," said Cox. Average scammer demands for immediate payment ranged from \$1,500 to \$2,000. In the last quarter of 2015, Cox reported that 5,500 SCE customers had received and reported scam calls. "Customer awareness and education are the best defense against utility phone scams," said Cox.

She explained how the scam works. "Phone imposters, claiming to be with SCE, call customers and fraudulently threaten to disconnect their electrical service unless immediate payment is made on a supposedly past-due bill," said Cox. "The caller demands payment immediately and tells the unsuspecting customer to buy a prepaid debit card and load a specific amount of money on it and call the impostor back, providing the serial number on the back of the card." The red flag, according to Cox, is the manner of payment — the prepaid debt card. "Once you give out the serial number on the prepaid card, the cash is untraceable and gone for good."

"Here's what we want our customers to know: Southern California Edison never calls customers on the telephone and demands immediate payment with the threat of service disconnection; SCE does not accept prepaid cash cards for bill payments; and we do not have a disconnection department."

Claremont Police Department Detective Hector Tamayo, working with SCE on the scam investigations, said, "Most people should be able to catch on when the

# Fern Valley budget in good shape and wells recovering

## New and old general managers in transition

In a brief meeting last Friday, the Fern Valley Water District board reviewed its fiscal 2015-16 budget and greeted Victor Jimenez, who will assume the general manager's position at the end of June.

Operating expenses continue to be less than revenues collected. In the final quarter of the fiscal year, Jessica Priefer, office manager, said the final property tax payments from the county should arrive and the district has one more water-usage billing to collect.

Capital expenses represent the largest expenditure this year. The pipeline replacement work along San Jacinto, Lodge and Tahquitz roads was completed for about \$670,000, which was 16 percent below the budgeted amount.

"Everything looks good," commented President James Rees.

In other budget business, the board agreed with Di-

rector Trischa Clark's recommendation that it was not necessary for FVWD to become an affiliate of the Idyllwild Association of Realtors. (IAR had sent a request to all three local water districts to join. Clark is a local real estate agent.)

Jimenez, who came from the City of El Monte, has begun ahead of current General Manager Steve Erler's retirement. The time is allowing Jimenez to interact with Erler and explore the district to learn its operations and its nuances before Erler departs.

After meeting and interacting with the staff, Jimenez told the board, "[The employees] have an amazing work effort. They are very conscientious and want to do what's best for the system."

Both directors Clark and Robert Krieger said that they were "... glad Jimenez was on board and that the transition was developing well."

In water business, Erler said the groundwater level of the wells was beginning to rise. Some of the groundwater levels were 12 feet above their level in March 2015.

Also, the district is diverting water from Strawberry and Tahquitz creeks. FVWD's wells produced 9.9 percent of the water usage last month, which is about half of the March 2015 well production.

caller is asking you to send a payment through a prepaid card."

Cox suggested any SCE customer who suspects a fraudulent call should ask for the caller's name as well as their department and business phone number. "End the call and report the incident immediately to local police or SCE at 800-655-4555 for residential customers or 800-990-7788 for business customers," said Cox. "And never use the callback number provided by the caller."

Cox noted more tips or clues to identify scammers:

- "SCE employees never ask for or collect money out in the field;
- SCE does not conduct credit transactions on weekends or holidays;
- SCE does not own or operate vehicles with Service Disconnection Department signage;
- SCE employees always have their SCE ID badge displayed on their person;
- Be suspicious of anyone who arrives at your house without an appointment asking to check an appliance, wiring or suggesting there may be some other electrical problem inside or outside your residence;
- Don't fall for the 15- to 30-minute rush drill to extract payment. Take your time and verify your bill by calling the SCE phone number listed on your bill."

Cox also recommended shredding utility bills be-

fore disposing in trash. "Scammers can get your account number, balance and other key information from bills not properly discarded," she said.

In Idyllwild, recent reports of thieves at the transfer station stealing paper, looking for personal identity information, stress the importance of shredding all paper with possible personal identity information before disposing in public trash receptacles. Sgt. Robert Duckett, Riverside County Sheriff's Department Hemet Station, said he checked with all patrol shifts and noted there have been no reports to the station of this activity. Nevertheless, Duckett requested extra patrol shifts last week to see if something had gone unreported. "No activity was found," said Duckett.

Another telephone scam, important year-round but especially at tax time, involves outbound calls purportedly from the IRS demanding payment or indicating that a case has been filed against the call recipient. As with SCE, that is not something the IRS does. # Pine Cove water may stay in stage 2

Pine Cove Water District General Manager Jerry Holldber plans to provide a detailed report on the district's water resources — well levels and possible future changes — at the June meeting.

"I'll have a better status of the well recovery rates then. Right now they are producing good," Holldber stated and advised his board last week, "I expect we'll stay in [Water Conservation Stage] 2 during the summer."

In March, the District's water production was 1.8 million gallons, which was 440,000 gallons or almost 20 percent less than during March 2015. During the first quarter of 2016, water production has totaled 6.1 million gallons, which is 834,000 gallons (13.7 percent) less than the first quarter of 2015. Except for 2012 and 2014, this year's first-quarter production was the lowest in volume in more than 10 years.

"March [production] was down compared to the past couple of years," Holldber said.

He also added that although the groundwater level of static well no. 10 had dropped 2 feet, overall he believes the groundwater levels of the wells have been steady for several months and he is not concerned.

The board reviewed the budget status through the third quarter of fiscal year 2015-16. As of the end of March, expenses have exceeded revenue by about \$6,000.

However, the fourth quarter will include two water statements and typically two property tax payments from Riverside County, in April and May.

"After three quarters, I didn't see any surprises

and don't anticipate any unforeseen expenses in the next quarter," commented Holldber.

During the public comment period, Pine Cove resident Marge Muir expressed her concern about the District subsidizing the sale of rain barrels. She feels that it is wrong for water payments from all customers to benefit the few who choose to purchase rain barrels. "... if one can buy one [barrel], they certainly can afford to pay the full price," she added.

She felt it was wrong for some purchasers of rain barrels to take them off the Hill, since that would not help PCWD customers who are subsidizing the price.

She felt particularly aggrieved about the subsidization of the rain barrels because the district has several outstanding loans for property and equipment.

The board has provided Muir with the cost and revenues of rain barrels and their benefit to the district. These are one of several conservation measures, such as subsidizing the cost of purchasing and installing low-flow toilets.

Vicki Jakubac is the new PCWD director (see separate story). The board unanimously chose her from three other applicants. She replaces Tim Lange who resigned at the March meeting for health reasons.

Jakubac is a long-time Pine Cove resident and also a former PCWD employee.

At the meeting, she told the board, "I resigned my position due to health problems. They have stabilized and I want to stay involved ... I have a lot of interest in conservation and helping the community."

## Protect yourself from fraud

The Riverside County Code Enforcement Department offers several tips to protect yourself from fraud.

Verify any employee of a government agency or public utility before providing them with personal information or access to your property.

Code Enforcement Officers:

- always wear uniforms
- always carry a photo identification card
- always drive a clearly marked vehicle
- always allow you to verify their identity
- never request or accept money

The best practice for verifying the identity of an employee of a government agency or public utility is to find the phone number of the agency by using a telephone directory or web site and call that number to verify the employee. You should not ask the employee what number to call. Make sure you are calling a published number for that agency.

# PCT Warrior Hikers to be hosted at American Legion

For the third year, U.S. military veterans return to Idyllwild as thru-hikers on the Pacific Crest Trail. They are part of "Warrior Hike: Walk Off the War," a program of outdoor wilderness exercise therapy designed to help veterans transition from front-line military service to civilian life.

Former Marine Corps Capt. Sean Gobin realized the potential benefit to other veterans after he hiked the 2,185-mile Appalachian Trail in 2012, immediately after returning from three combat deployments in Iraq and Afghanistan.

Gobin had several goals in establishing the program that now runs on the three National Scenic Trails — the Pacific Crest, Appalachian and Continental Divide — as well as a number of other regional trails. Gobin's first goal was to give veterans the tranquility and time to reboot and revive after stressful military front-line service. Second was to raise money to finance purchases of adaptive vehicles for injured vets; and third, and now the primary goal, was to acquaint residents in towns along the trails with the many difficulties returning vets have in adapting to civilian life after returning from war zones.

Gobin described how veterans could be on the front lines one day and on air transports back to the states a day or two later. As Gobin personally understood, that rapid transition was far too difficult, especially for vets suffering from post-traumatic stress and other mental conditions brought on by front-line deployment.

On Saturday, April 23, the American Legion Post 800 hosts an event to meet the five 2016 PCT Warrior Hikers, to hear their stories and to support their journeys. The post will honor them with a reception at 4 p.m. and a brats, sauerkraut and salad dinner from 5 to 7 p.m. Des-

sert donations are welcome. The event is open to the public.

This year's hikers are:

- Army vet Joseph Jamison of Pueblo, Colorado. Jamison served as a field artillery surveyor in Iraq and Afghanistan from 1990 to 2015.
- U.S. Navy Parachute Rigger Daniel Jones of Marshalltown, Iowa, who served from 1985 to 1992 with deployments in Saudi Arabia.
- Ruben Munoz, U.S. Navy field medical service technician of Miami, Florida, active service from 1991 to 2012 with tours in Iraq and Afghanistan.
- U.S. Army Special Forces Communications Sgt. Jimmy Sellers of Killeen, Texas, who served from 1987 to 2014 with tours in Saudi Arabia and Iraq.
- U.S. Navy Fire Control Technician Albert Woolum of Richland Hills, Texas, who served from 1971 through 1975 with deployment in Vietnam.

The Warrior Hikers will share their stories both of their hike and their military service. As part of their mission, they'll also pitch the importance of funding veteran care, especially for those suffering from PTSD and other conditions that have led to spikes in suicides among returning vets.

"I realized this could be an alternative therapy — that hiking and being outside in wilderness areas could provide a permanent coping mechanism," said Gobin. "It's not a cure but a reset button and one that is free and that vets can continue to use."

# Town Crier columnist stars in NBC series

O'Farrell, a natural pontificator, plays a politician

Conor O'Farrell, the Town Crier's award-winning columnist, also is an actor. Currently, he is a regular on the new series "Game of Silence" Thursdays on NBC.

While it is not his first television series, he said, "It is the first time I've been a series regular. That's a different thing for me."

Most of the filming was done during the fall in Atlanta, but O'Farrell took some comforts and had family to keep him company. His daughter, Georgia, now lives near Atlanta and he spent many days visiting her. An avid kayaker, he also took his equipment east and spent other off-days testing the East Coast whitewater rivers.

The "Game of Silence" premier show, which aired Tuesday, April 12, scored very good ratings, according to O'Farrell. The industry magazine "Deadline" described the Tuesday performance as "solid," winning its slot that night.

"It was a great party and the numbers were very good," he said after the premier.

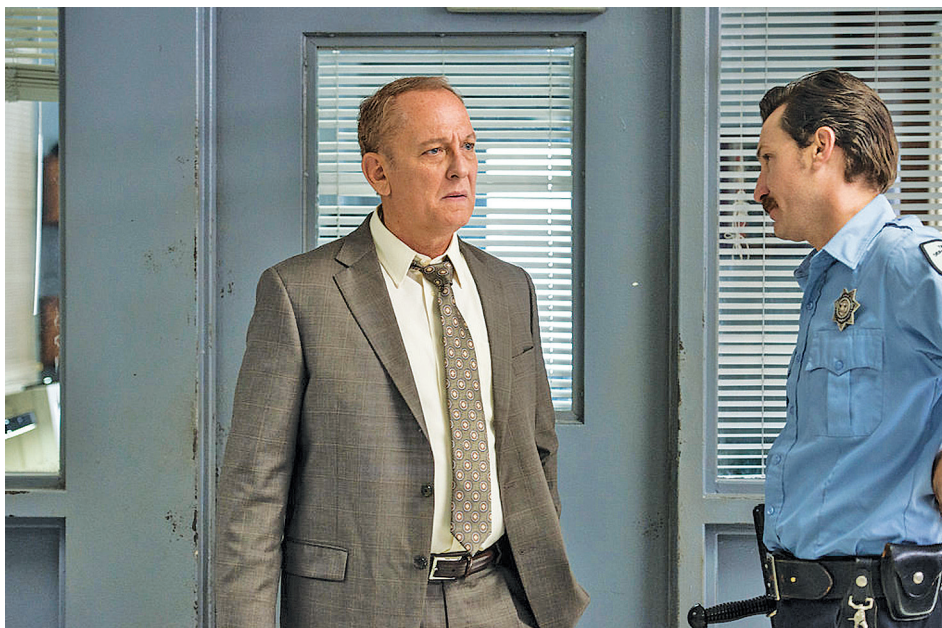
O'Farrell's talent as a writer and experience as an actor may benefit the show. As the final episode was being filmed, he offered some suggestions about the direction his character might go.

"I like that, it's really good," was the response from the show's creative team, he said.

O'Farrell had stressed that one of his pleasures working on this show was the stronger emphasis on characters. While it's still a network series with an over-arching plot, which is revealed in weekly episodes, the writers cared for and focused on the characters more than many network series.

"At my age, I like to be in a really creative show with good story telling," O'Farrell said, examining his career. "It's not the money, but being stimulated by a well-told story."

Nevertheless, his age did affect his contribution to the show's buzz. The network and producers organized a premier party during the East Coast broadcast. Cast

members were asked to use social media.

"They want live tweeting for the East Coast," he said days before the premier aired. "I'm not adept with social media."

During the showing, Georgia emailed him and asked why he stopped sending tweets. He was puzzled until he learned that Twitter had blocked further tweets. He promises to develop that skill now that he has his first iPhone.

It's as if O'Farrell embodies Yogi Berra's statement, "I tell the kids, somebody's gotta win, somebody's gotta lose. Just don't fight about it. Just try to get better." Practice and more practice, keep playing the game. Whether its acting or writing, O'Farrell has demonstrated that his performance does get better.

O'Farrell's acting career has spanned several decades. While never the classic heart-throb star, he has appeared in many films and television shows. For example, he was a mainstay in HBO's "From the Earth to the Moon" and ABC's "CSI: Crime Scene Investigator."

Early, he learned that acting was showing up at auditions. But he had to overcome the fear of rejection. He confronted his own thoughts that tried to talk him out of

going to the next audition.

"Acting is all about your state of mind," he stressed. Overcoming that anxiety took time and effort, which many actors can't endure.

Eventually he learned, "Playing a doctor isn't about what you know about medicine, it's selling the people in the room that you are a doctor."

As Woody Allen has said, "Eighty percent of success is just showing up." O'Farrell realized the value of persistence and consistency, which has led him to a successful and full-time acting career.

But his career as a columnist only began a few years ago. Similar to his acting, the more he does it, the better he becomes. Last spring, he received a second-place award for local columnist from the California Newspaper Publishers Association. This is a statewide competition. Later in the summer, the National Newspaper Association bestowed a third-place award on him. Again this spring, O'Farrell has earned either a first- or second-place CNPA columnist honor.

"These articles and recognition are much more meaningful," he stated. "The key is putting myself out there. They are my views of the world. It's validating and much more personal."

"Without a formal education, I always thought that everybody else was smarter than I was," he added.

The Riverside County Department of Waste Resources has scheduled a free household hazardous-waste collection event on in Idyllwild from 9 a.m. to 2 p.m. Saturday, April 23, at the County Road Yard. The collection is open to all Riverside County residents.

The event will accept residentially generated household hazardous wastes. Waste from businesses or nonprofits will not be accepted.

Typical wastes include used motor oil, paint, antifreeze, household and automotive batteries, pesticides, cleaning products, sharps (needles/syringes or lancets), unused medication (except controlled substances), fluorescent lamps,

and electronic wastes such as televisions, computers, VCRs and telephones. Limit the amount of waste transported to no more than 15 gallons, or 125 pounds maximum per vehicle. Individual containers should be no larger than five gallons nor weigh more than 50 pounds.

The collection will not accept explosives, radioactive material, ammunition, asbestos, compressed-gas cylinders over 40 pounds, or infectious or medical waste other than sharps.

The event is subject to cancellation during inclement weather or for other hazardous conditions as determined by the county.

AMAC says that you can work with your tax preparer to determine the exact amount of taxes you must pay using your Social Security Benefit Statement (Form SSA-1099/1042S). The Social Security Administration automatically sends that statement out to all benefit recipients each year.

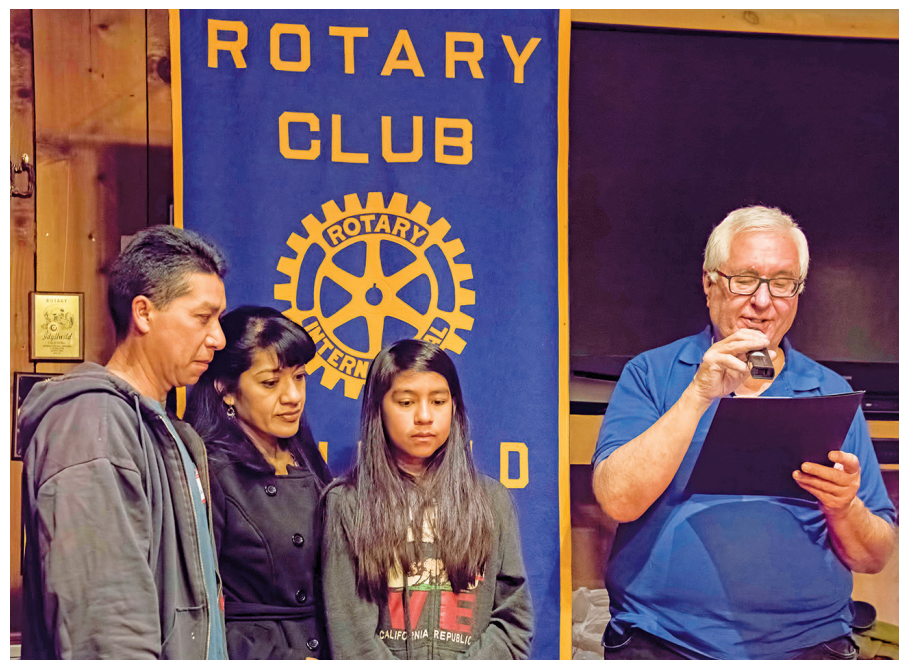
Whatever the outcome, let's not forget that we have each other. We are stronger when we choose to cooperate rather than alienate.

# Journal from the James

## El Niño, El Niño ...

We have heard a lot this past several months about El Niño — about how it is or was supposed to deluge us with rain — and other dire predictions. And in some areas, especially further north, that seems to be the case.

However, here, with every predicted rain or snowfall, we heard that the anticipated El Niño has arrived, only to be followed by even more of that sunshine we are famous for. Again, with this last series of rain, we wondered, has it finally come? Or is it just a typical April showers bring May flowers?

With a prediction of more than a week of sunny days coming up, we are not sure and one begins to wonder ... where is El Niño?

Although we and the weather people are all probably wondering the same, this article is actually not about whether they were right or wrong about El Niño but some background on why it is called El Niño. This in itself should not only prove interesting but demonstrates how important weather and its long-term sibling, climate, are to the livelihoods of humans all along the western coast of the Americas and even on the other side of the Pacific.

Scientifically, El Niño is properly called the El Niño-Southern Oscillation (ENSO for short). Like most scientific names of things, except for the El Niño part, they can be kind of dry and boring. The Southern Oscillation part of the name indicates how ENSO would affect our weather. It refers to the winds and sea surface temperatures over the tropical eastern Pacific Ocean (yawn ... straight out of Wikipedia.).

Though this is actually the important part of why ENSO has effects on our weather, it still does not explain the El Niño part.

To understand why we call it El Niño, we need to go back in time and south in distance, all the way to Peru and to colonial times. Back in colonial Peru, and likely for centuries before, people living along the coast of much of Peru depended on the ocean for food. This is

because much of western Peru is dry and desert-like.

This has to do with the wind patterns I wrote about earlier (Town Crier, Sept. 10, 2015) and the fact that most times the current along the coast brought cold water and air up from the Antarctic region. With little moisture in this cold air, little precipitation fell on the land.

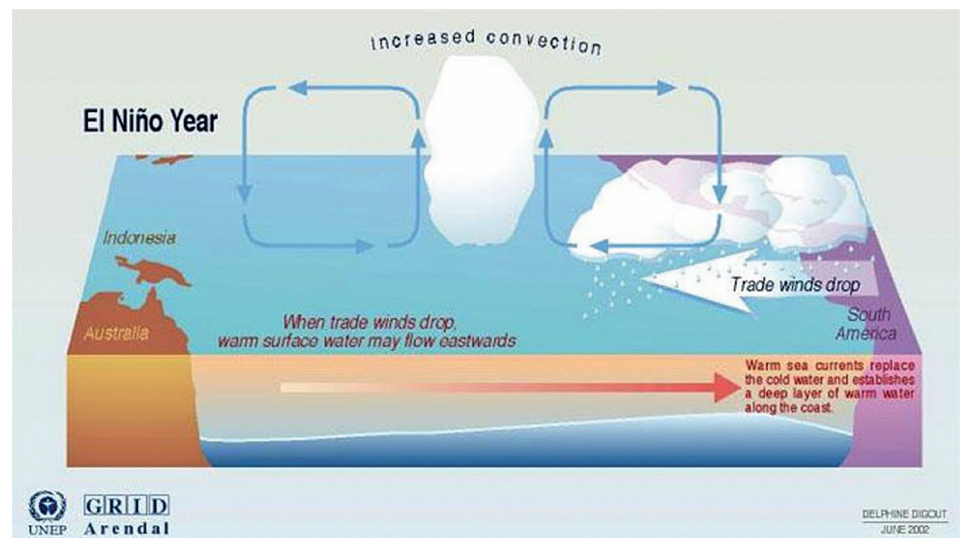
However, these cold waters were rich in nutrients and supported an abundant off-coast fishery. This is the “normal” pattern and the inhabitants, precolonial and after, adjusted to it.

However, periodically, at roughly five-year intervals, things changed. Instead of strong, cold water currents, warmer water moved toward shore. With warmer water came warmer air with more moisture and thus more precipitation on land.

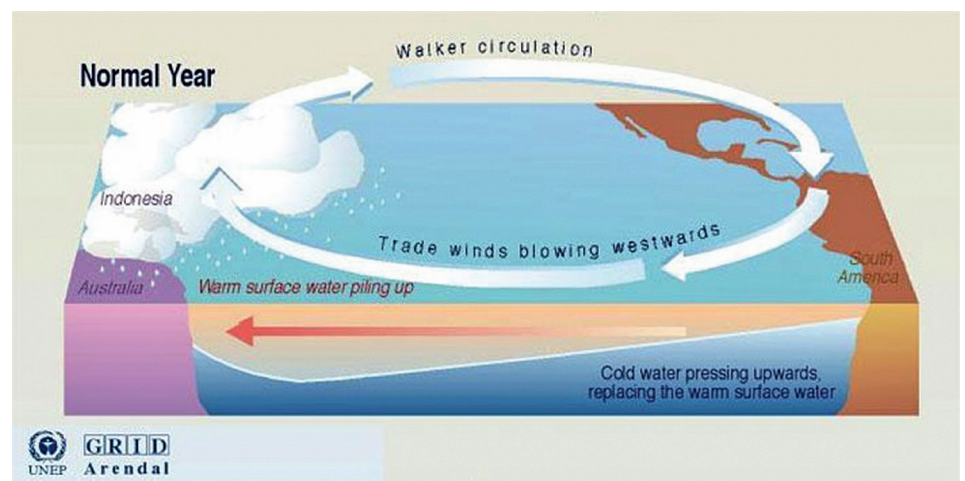
However beneficial the rain might have been, it often fell in such torrents that it caused local flooding and destruction. Coupled with this was the lack of nutrient-rich water offshore, which led to a collapse of the fishing industry and the death of sea birds and mammals. In general, El Niño years were looked upon with trepidation and fear by locals. But why call it El Niño?

As it turns out, the conditions leading to this devastating weather pattern usually began around Christmas time. El Niño in Spanish refers to the Christ child and so, one legend has it that the phenomenon was named after the season.

However, beyond that, even today many people hold rituals where they parade with a statue of the Christ child, pleading him to protect them from the destruction of the El Niño event. In fact, as many of these rituals are recorded in church history, some past El Niño

events have been tracked by examining these records.

So there you have it. With it occurring around Christmas and with rituals pleading the Christ child, El Niño, for protection from its devastation, the term came to be associated with a significant climatological event.

This event was originally thought to only affect the people of Peru. However, we now know that El Niño effects are felt globally and can explain periods of drought/deluge in places as far away as India and including right here in Idyllwild.

The influence of these El Niño events on human history in terms of famines, flooding, and disease continue to demonstrate that, even in these modern times, we are still a part of nature and not apart from her.

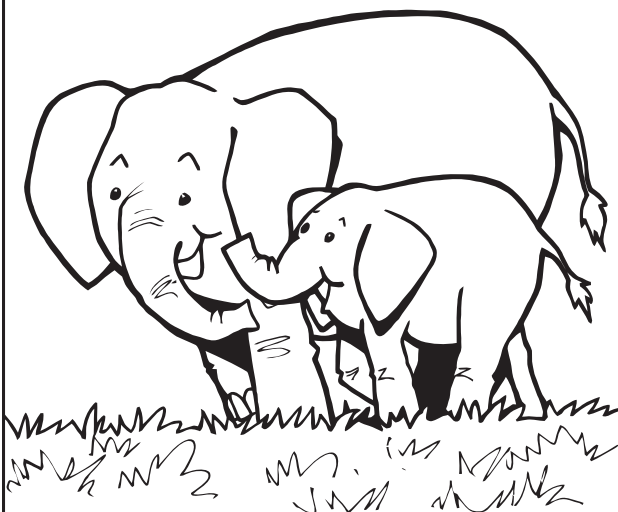

### 55 years ago - 1961

Pine Cove residents were organizing support for a post office.

### 50 years ago - 1966

The Riverside County Board of Supervisors approved 18 streetlights for Idyllwild.

### 45 years ago - 1971

As a maneuver to prevent a proposed subdivision in Garner Valley, a bill was introduced in Congress to permit the federal government to purchase 2,200 acres of land as an addition to the San Bernardino National Forest.

### 40 years ago - 1976

Softball leagues for adults and kids were brought back to the Hill after a four-year absence.

Town Hall organized the kids' teams and the American Legion coordinated the adults' teams.

After a short-lived increase to 65 mph, the speed limit on Highway 74 from Hemet to Palm Desert and on Highway 243 from Pine Cove to Banning reverted to 55 mph.

### 15 years ago - 2001

Idyllwild's Lioness Club met for the last time, ending almost 13 years of community service. Some of the Lionesses were invited to join the men's Lions Club, which held its last meeting in June 2008.

### 10 years ago - 2006

Nearly two months after a heated community meeting about Idyllwild recreation, representatives of the Idyllwild Chamber of Commerce and the Idyllwild Com-

munity Recreation Council met to begin discussions about how to peacefully transfer the county's recreation contract from the Chamber to ICRC.

### 5 years ago - 2011

Idyllwild's Casey Abrams risked it all on Wednesday's "American Idol" telecast. Rather than follow the advice of Idol coaches Jimmy Iovine and Will-I-Am and cover Phil Collins "In The Air Tonight," Abrams sang "Nature Boy," a Nat King Cole son, again accompanying himself on bass. Casey was right and earned the night's only standing ovation.

### 1 year ago - 2015

The State Water Resources Control Board released proposed regulations for implementing Gov. Jerry Brown's 25-percent conservation standard mandated by his April 7 executive order.

## The FoodKeeper app

The birth date of a family member may stick in your mind, but are you able to remember when you bought all the items in your refrigerator?

Every year, billions of pounds of food go to waste in the U.S. because consumers are not sure of its quality or safety. Last year, the U.S. Department of Agriculture launched the FoodKeeper app to help combat this cause of waste. The FoodKeeper is available for Apple and Android devices and allows users to set up automatic notifications when foods and beverages are nearing the end of their

recommended storage date.

By helping users understand how items should be stored in the refrigerator, freezer and pantry, the app empowers consumers to choose storage methods that extend the shelf life of their items.

It offers advice about more than 400 food and beverage items, including various types of baby food, dairy products, eggs, meat, poultry, produce, seafood and more.

Cooking advice also is offered to ensure users prepare products in ways that eliminate food-borne bacteria.

## A healthy mind in a healthy body

You are better off taking the stairs up to your next class, particularly if you are an older American out to improve your knowledge base and protect your brain, according to the Association of Mature American Citizens.

Canadian researchers found that “education and physical activity affect the difference between a physiological prediction of age and chronological age, and that people can actively do something to help their brains stay young.” Their study has been published in the journal, Neurobiology of Aging.

Jason Steffener, the lead author of the report, said the focus of the study was the positive effects of low-impact exercise such as climbing stairs on brain health. “In comparison to many other forms of physical activity, taking the stairs is something older adults can and already do at least once a day, unlike vigorous forms of physical activity.”

# Appeals Court overturns ruling on teacher tenure and seniority

## State laws are not unconstitutional, court rules

On Thursday, the state 2nd District Court of Appeals unanimously overturned Judge Rolf M. Treu's June 2014 decision in Vergara v. the State of California that the state laws on teacher tenure and seniority were unconstitutional.

The appeals court conceded that students may suffer from poorer educational opportunities, but that is because of administrative decisions, such as hiring ineffective teachers. The state laws protecting teachers and the "right" to employment are not at the root of different and biased educational opportunities.

Although the Appeals Court acknowledged that some principals transfer ineffective teachers to other schools, "often to low-income schools," and considered this "troubling and should not be allowed to occur," the fault is not the state statutes.

"Assuming that poor and minority students encounter more grossly ineffective teachers and that this im-

pacts their constitutional right to 'basic educational equality' [citing a California Supreme decision], the constitutional infringement is the product of staffing decisions, not the challenged statutes," the appeals court concluded.

"... the evidence presented at trial highlighted likely drawbacks to the current tenure, dismissal and layoff statutes, but it did not demonstrate a facial constitutional violation," the court wrote in its opinion. "The evidence also revealed deplorable staffing decisions being made by some local administrators that have a deleterious impact on poor and minority students in California's public schools."

Since upholding Treu's opinion would not guarantee better educational services, the appeals court reversed his decision.

"Any system will have some teachers who are not as effective as others," the court wrote.

At the local school district, Hemet Unified, Trustee Vic Scavarda wrote in an email, "there's no argument about dismissing incompetent teachers from the classroom. They should be dismissed if they aren't doing the best they can for our kids. It's also true that it is more complicated (but not impossible) to dismiss someone after the probationary period is over."

Scavarda noted that the appeals court did not fault the statute's language, but blamed administrators' im-

plementation of it. To overcome this problem, Scavarda said HUSD "emphasizes training, in-service and further education to help our teachers to be the best-prepared professionals possible, and it's best to catch and fix problems early on."

On Thursday after the appeals court decision was released, the California Teachers Association issued its response.

"This is a great day for educators and, more importantly, for students," said CTA President Eric C. Heins. "Today's ruling reversing Treu's decision overwhelmingly underscores that the laws under attack have been good for public education and for kids, and that the plaintiffs failed to establish any violation of a student's constitutional rights."

And State Superintendent of Public Instruction Tom Torlakson reinforced his long-standing support of CTA with the following statement, "All of our students deserve great teachers. Teachers are not the problem in our schools — they are the answer to helping students succeed on the pathway to 21st century college and careers."

During his re-election campaign in 2014, Torlakson publicly requested that California Attorney General Kamala Harris appeal the decision.

participant in seeing that the gymnasium and top-field projects were carried through to successful completion.

Read, whose work background is in office management, has a fondness for numbers and order. In organizing youth soccer, she emphasized the need for rules — for the young players to understand and play by the rules of the game. She brings an affable meticulousness to whatever task she takes on.

She volunteers in the classroom at Idyllwild School, something she has done since her first child started school there in 1998. On the Monday of her interview for this article, she cheerily made the transition from classroom to dirt and paint, working in one of the many student gardens she and her mother, Antje Banks, have helped create with and for the school Junior Garden Club.

What is notable about Read is that she continues to serve programs she has organized and on boards she has joined. Once involved, she stays committed.

She and her mother created and continue to manage the Victorian Tea that has become the signature event of the annual Idyllwild Lilac Festival in April. She worked with Town Hall recreation to

start the soccer program and will continue to review recreation programs as a CSA 36 council member.

She was the only female “captain” during the Idyllwild Playground build in 2012 and now serves as a member of the Idyllwild Community Center Board, currently as treasurer. She has remained on the Idyllwild School PTA board and served as a classroom aide throughout the tenure of all of her children — 18 years.

When asked why, with all her volunteer activities, she sought a seat on the CSA Advisory Council, she said, “I wanted to see that Town Hall recreation would be locally managed.” Read noted that over the last few years, especially under management of the county’s Parks and Open Space District, programs were not handled well. “They kept bringing people up here that didn’t know or didn’t care,” she said. “For the last year, the front door of Town Hall has not worked.”

And slipshod management does not work for Read. “If it was up to me, I would keep going until the job was done,” she said. And that statement sums up how Read views responsibility and the kind of overview she will bring to service on the CSA Council.

compliant with “spy in the sky” purposes.

The drones will enable the search process to begin earlier, particularly when the sheriff’s aircraft might be on another mission. But he stressed it does not obviate the need for the Riverside Mountain Rescue Unit.

The lost or injured hiker will still need to be found and physically extricated from the site.

One aspect of the year-long evaluation will be whether the drones are more cost effective than

helicopters. “[Helicopters] are pricey to operate on an hourly basis,” Vest noted.

Drones are small enough, about the size of a desk, Vest said, that they can be transported in vehicles and will not have to be stationed at Hemet-Ryan Airbase.

The UAVs will have cameras and heat sensors. The photographs can be transmitted to the ground for review and the sensors may detect body heat, particularly during winter searches.

“They could identify a person under a bush,” Vest said.
