# Fire Committee recommends raising unit fee

\$91 increase would generate \$300,000 annually

The Idyllwild Fire Protection District Finance Committee decided to recommend a tax measure for the commission to review and approve.

The committee agreed that increasing the current unit fee from \$65 to \$156, a 140 percent increase is necessary. It also will propose language to ensure the fee increases annually based on a local economic indicator.

The measure will be worded to be a replacement of the current unit fee. If it is defeated at the polls, the current unit fee will remain in place, the committee noted.

"After reflecting on the work we have done, it is clear to everyone, we arrived at this by careful study of staff recommendations," said Committee Member Mark Lonsbury as the committee began to formulate its recommendation. Capital improvements, a reserve and salary requirements were the three basic areas the committee wants to augment or fund.

While members recognize this increase will generate considerable revenue in the future, it also is recommending that IFPD cap its reserves at 10 percent of the annual operating budget. At the current budget, IFPD would have \$190,000 in reserves for unanticipated events.

Through fiscal 2022-23, the increased fee will produce about \$2.3 million in revenue. The committee intends that IFPD's current Capital Improvement Plan, which identifies projects totaling \$832,000 for the next 10 years, should be financed from the new revenue. The balance remaining would be for budget reserves, salaries and other new expenses.

The committee believes the capital program should be reviewed and possibly revised annually.

# Auto, motorcycle and DUI collisions on mountain roads Mountain Center

A single-vehicle driving-under-the-influence with passengers on Highway 243, a motorcycle crash on Highway 74 at the bottom of the Hill, and a single-vehicle crash on Highway 74 near Lake Hemet were the Hill incidents reported by the California Highway Patrol for the week beginning Wednesday, April 20.

At 8:30 a.m. Friday, April 22, Jolene White, 28, of Banning, was driving her 2004 tan Chevrolet Malibu north on Highway 243, a quarter mile north of Twin Pines Road, when she failed to execute a left curve, overcorrected, crossed over the double-yellow lines and crashed into the mountain. With White were two adult females and two male juveniles under age

White was arrested at the scene for a DUI with an enhancement for child endangerment and incarcerated at Larry D. Smith Correctional Facility in Banning. There were no other vehicles involved and none of the passengers were medically transported.

At 3 p.m. Saturday, April 23, William Schuler, 41, of Hemet, was riding his 2007 black Harley Davidson motorcycle west on Highway 74, 3/10ths of a mile east of Bee Canyon Truck Trail, when he lost control because of excessive speed and laid the bike down. Both Schuler and his passenger, Meredith Allingham, 36, of Hemet, complained of road rash and abrasions but refused transport. No other vehicles or individuals were involved in the incident.

And at 11:50 a.m. Monday, April 25, Catherine Mauge, 74, of Idyllwild, was driving her 2002 white Subaru Impreza west on Highway 74, 500 feet east of Hemet Lake Road, when she ran off the road and hit a Caltrans metal guard rail. The day was clear and the roads were dry. Mauge was not injured and no other vehicles were involved in the incident.

# Fire at Zen

Cal Fire responded to reports of a building filled with smoke at the Yokoji Zen Mountain Center on Thursday, April 21. When firefighters arrived just before 8 a.m., they found a single-story structure with light smoke showing, confined to one room.

Responders contained the fire within half an hour.

Zen Center resident Melissa Severa said no one was hurt. "A Zen student resident left an item near the wall heater and it caught fire," noted Severa. "The fire was contained to one room alone, the resident's bedroom. Her wardrobe is a loss, and she is a fashion designer just graduated from The Royal Academy in London, so [in the wardrobe] must have been some 'one-of-a-kinds.'

'What matters is that everyone is safe.'

Seventeen firefighters from companies 53 (Garner Valley), 23 (Pine Cove) and 30 (Pinyon) responded to the incident. During the Mountain Fire in 2014, the Zen Mountain Center narrowly escaped fire damage but was hugely impacted later by water-carried mud coursed over fire-ravaged hills directly in back of the center.

# Ellis sentenced on four counts

On April 19, Ira Robert Ellis, 37, of Poppet Flats, had two hearings before Judge Becky Dugan in Department 41, Riverside, of the Riverside County Superior Court.

The first was a Marsden/Sanchez hearing in which Ellis, who was represented by a deputy public defender, asserted that he had been denied his right to effective counsel. Dugan denied that motion and ordered the transcript of that hearing sealed.

The case was then called for a sentencing hearing, and Ellis requested immediate sentencing, waiving arraignment for pronouncement of judgment.

Under statutes providing for sentence enhancement due to prior felony convictions, Dugan found that Ellis had two or more convictions that qualified as a strike.

On count 1, which she deemed to be Ellis' principal count (possession of ammunition by one prohibited from owning or possessing a firearm), she denied probation and imposed a term of two years, eight months in state prison.

On count 3 (mail theft), count 6 (resisting or obstructing arrest) and count 7 (hit and run, property damage), Ellis was sentenced to 180 days in county jail, sentence to run concurrently with the state prison sentence on



# Idyllwild Water customers continue to conserve

# Board laments declining revenues, rejects lowering compensation

Money and finances were the dominant topics during the April 20 Idyllwild Water District meeting. While customers have diligently been conserving water, the revenue stream appears to be declining, according to General Manager Tom Lynch.

While water production was less in March compared to March 2015, revenue, according to Hosny Shouman, chief financial officer, was nearly \$11,700 less than anticipated.

Oddly, revenue still was about \$2,000 greater than the April 2015 water revenue, when production was about 700,000 gallons more.

Helping the finances was a "substantial variance between the budgeted expenses and the actual expenses" in March, according to Director John Cook. Shouman had budgeted costs for the water fund of \$114,000 and the actual expenses were \$74,500, yielding net income of more than  $\$10,\!000$  in March. Lynch also opined that customer conservation also contributed to the reduced expenses.

November has been the only month this fiscal year where the water fund has had a deficit. Total net revenue through March is greater than \$95,000 and expenses are \$185,000 less than budgeted.

However, Lynch has successfully pursued grant funding to supplement revenues. The largest will be about \$150,000 for pipeline replacement. The money will come

Grant. IWD will have to match the grant to install about 3,000 feet of pipe.

"We'll focus on the areas with the most problems or the oldest pipes," Lynch told the board.

The other grant for about \$25,000 is a request for Homeland Security money to improve security.

At the request of Director Steve Kunkle, Lynch placed the review of director compensation on the agenda. The current IWD director compensation is \$100 per meeting, including board, committee and other meetings. Fern Valley and Pine Cove water districts pay their directors \$50 per meeting and the Idyllwild Fire Protection District provides no compensation to its commissioners.

Kunkle argued that IWD was paying more than \$13,000 annually compared to the other two local districts, whose total director compensation was less than \$3,000

While he admitted he had accepted the compensation since he joined the board in December, he promised to decline it going forward, as Director June Rockwell has since she joined the board.

In commenting on the staff survey of water-board compensation in other Southern California districts, Kunkle said, "To me, the survey represents I'm entitled to the stipend because everybody else gets something and some get

He argued, "We are all public servants and should donate our time for the benefit of the community ... I know vou work hard at this position. It's demanding of your time and a sacrifice. But this will build trust with our constituents, especially if we need to raise rates."

In response, President Jim Billman said, "You could have good government with or without a stipend or bad government with or without a stipend." Reducing or eliminat-

from Riverside County's Community Development Block ing the board's compensation would have no effect on the community's opinion of the board, opined Billman.

Supporting him, Director Mike Freitas said, "I don't want to give up the money because of what others might think. We're doing a good job."

While Kunkle and Rockwell voted to reduce compensation, directors Billman, Freitas and John Cook, who called it just a token, opposed the idea, defeating it 3-2.

In water business, IWD produced about 5 million gallons of water in March, which was about 500,000 gallons less than March 2015 and 27,000 gallons less than Febru-

For the first quarter of 2016, IWD production is 4 percent below the 2015 first-quarter production; but this year was about 500,000 gallons more than the first quarter of

count 1.

Ellis, who has been in custody, was given 81 days of credit for time served. He was further ordered to pay

statutory restitutions and assessment fees totaling \$920, \$300 of which is suspended unless his future parole is revoked. He was also ordered to pay victim restitution in an amount to be determined by the Probation Department.

Counts 2, 4 and 5 were dismissed in the interests of justice, and Ellis remained remanded to the custody of the Riverside County Sheriff.



# **IWD GM claims** to understand the **Brown Act** he violates

Water District's GM Tom Lynch is at it again.

On Monday, April 11, IWD Director Steve Kunkle sent an email to Lynch asking to attend the next agenda meeting that Lynch generally has with IWD Board President Jim Billman a week before each board meeting.

Lynch responded that the Brown Act prohibited Kunkle from attending those meetings. When Kunkle asked him to cite wherein the Brown Act it did so, Lynch cited Government Code section 54952.2 regarding serial communications as his source.

Lynch then copied the email trail between himself and Kunkle to all the other members of the board of directors, which resulted in Director John Cook asking to attend the agenda meetings, also.

The Government Code sections known as the Brown Act prohibit "any congregation of a majority of the members" of the board to discuss, or even just hear, anything within the jurisdiction of the board — in this case, any IWD business. (Gov. Code, § 54952.2. subd. (a).) Any two members of the board may hear or discuss such business without constituting a Brown Act violation, as long as neither of them communicates their discussion either directly or through an intermediary — to a third member of the board. (Gov. Code, § 54952.2, subd. (b)

The presence of the general manager has nothing to do with this. So, board member Billman can meet together with both board

# Is the Town Crier biased against African-Americans?

EDITOR:

I was surprised while viewing the paper online, turning to page 2, featured prominently at the top of the page, a large photo of a young man named Nasir David Powell, 18, an IAA student.

Article by Jack Clark indicated Powell is charged with five felony sexual counts. May I say clearly, I definitely believe these are horrendous charges. If he is found guilty, it's even more disconcerting because the alleged victims are children. However, what struck me acutely, reading the  $\operatorname{Crier}$  for the year, there are others - charged, found guilty and have been sentenced - and I have yet to see their faces in the Crier.

Cases in point: Ira Robert Ellis, 37, sen-It appears that Idyllwild tenced, multiple felonies and misdemeanors; Frank Gutierrez, 67, arrested twice, various drug felonies; Lisa Marie Brown, 40, hit and run, meth sales, manslaughter; Jeff Allen Major, (age not given) sentenced, repeat sex offender

How is it that Powell's face figures so prominently but none of the aforementioned persons' pictures are featured? I do not know ethnicity of the others, but it's obvious that Mr. Powell is African-American. I cannot help but ponder whether the others are not African-Americans.

Irregardless of ethnicity, why can't we



see their faces. This information is available from law enforcement?

Again, if Mr. Powell is guilty he surely deserves to be punished. Whatever the sentence, as a young 18-yearold man, the punishment will be compounded by the fact that he will have a life of ruin for many years . The others have prior records for

repeated offenses; most have been found guilty; some have even been sentenced, yet we haven't seen their faces. It's no secret facts are clear — young African-American males are incarcerated disproportionately for their transgressions.

Also clear, life for them often begins at a loss, and too often ends as such. It is also factual that media throughout the country have routinely covered these circumstances prominently, unlike any other group.

I certainly hope the Crier is not a part of this kind of media bias and emphasis. If I missed the pictures of the others, I stand corrected. However, after re-reading all of the issues this year, I simply do not see their faces, especially prominently presented.

member Kunkle and GM the comments or position of Lynch without there being any Brown Act violation, as long as they do not thereafter communicate anything from that meeting — even just discussions — to another member of the board, either directly or through an intermediary. (Gov. Code, § 54952.2, subd. (b)(1).)

And section 54952.2, subd. (b)(2), relates that an employee, such as Lynch, may have a separate discussion with any member of the board "to answer questions or provide information" (such as the email discussion Lynch had with Kunkle, referenced above) "if that person [i.e., Lynch]

any other member" of the board. Kunkle

So, when emailed Lynch seeking answers and information, their exchange of emails was no violation. But when Lynch then copied the other members of the board with their email train, he violated the serial meeting provisions of the Brown Act. (Gov. Code, § 54952.2, subd. (h)(2)

In short, Lynch cited the serial-meeting provisions of the Brown Act as prohibiting Billman, Lynch and Kunkle from meeting to discuss the agenda — which is not true — then Lynch viodoes not communicate to lated the Brown Act himself members of the [board] ... by sending the email trail of

his discussions with Kunkle, containing Kunkle's position and comments, to each of the other members of the board

It's very clear that IWD directors and their GM need Brown Act training, which can be obtained through various sources, including the postings and publications of California Special Districts Association. (For example, visit www.csda. net/?s=brown+act.)

In the meantime, the board needs to rein in its GM, who thinks he knows the Brown Act, and get its Brown Act legal advice from someone who does.

# Dave Hunt new CSA 36 Advisory Council member



My perception clearly questions the stability, professionalism and trust of the Idyllwild Fire Protection District's chief and administrative captain. Persistent competency and trust issues continue to plague IFPD.

Major mistakes pile up. The Board of Commissioners and administration somehow blame poor supervision of employees on community interference. One has to wonder

whether its paramedic service is safe.

In reviewing the decision of IFPD vs. James Reyes, as well as filings and conclusions from grand jury reports, it's painfully obvious the pervasive lack of honesty, professionalism, transparency and unwillingness to correct or improve with no end in sight. Professional competence and public safety is at risk.

It's not about a free smoke detector to some IFPD voters, Santa on a fire truck, or who can tell the best 5-minute joke and story at Rotary or the Legion. It's about paramedics living up to national and state standards, doing the job we pay them for. The grotesque unprofessionalism and public safety concerns uncovered in recent inquiries compares to preious well-documented and buried employee misconduct.

I believe with the latest findings twisted in a web of IFPD misdeeds, for the sake of the mountain communities, it's time to cut bait. Major changes need to happen

A vote to raise taxes is no answer. Dissolve IFPD. Paramedic/firefighter service will stabilize while taxes go down, because you already pay a double tax. Let alone any new twisted tax increase to pay existing and new mid-six-figure litigation bills, not to mention the multi-million dollar judgment now knocking at the door.

One tax goes away if IFPD goes away.

Hunt feels strongly that community recreation programs should benefit all community demographics, not just youth recreation. "My goal is to see that recreation addresses all age groups," he said.

As an Idyllwild-raised "Hillbilly," Hunt believes the forest is a major recreational resource that, as part of the Wilderness Act, should be taken care of. "I'd like to see more hiking for kids, tied in to trail maintenance and teaching young people to respect the forest. That respect for the forest is what differentiates us from Big Bear.'

After his wife's death from cancer, Hunt, whose children are grown, resolved to spend more time volunteering in Idyllwild. He recently became a Forest Service Lookout Tower volunteer. "I've always wanted to do it since I was a kid," said Hunt.

When he noticed an article in the Town Crier noting the lack of volunteers for the CSA 36 Advisory Council, he jumped at the chance. "One of my first questions at the interview was, What is your definition of recreation?" He believes recreation should be broadly defined to include life-learning opportunities, not just tradi-

"I hope all people attend meetings so we understand why we are there and get to know what the community wants," said Hunt.

Of why Idyllwild seems so right for many, Hunt said, "The mountain accepts you and breathes you in, and it

# San Jacinto Post Office to host passport fair on May 7

The San Jacinto Post Office is hosting a Passport Fair from 9 a.m. to 1 p.m. Saturday, May 7. The fair will offer passport information to U.S. citizens and accept passport applications.

Families and individuals will be able to apply for passports on a walk-in basis without taking time off from work, school or other weekday activities. No appointments are necessary.

To obtain a passport for the first time, applicants need proof of U.S. citizenship and a valid form of photo identification, such as a driver's license. A certified copy of a birth certificate (not a California abstract or photocopy) or naturalization certificate is the best proof of citizenship.

One photograph is required and can be taken at the passport event.

The fee for a Passport Book for first-time adult participants is \$110 and \$30 for a Passport Card. The fee for minors under age 16 is \$80 for a Passport Book and \$15 for a Passport Card. There is also a \$25 processing fee per application.

Parents applying for Passport Books/Cards for children under age 16 must both be present, along with the child. An expedited service fee of \$60, plus Priority Express Mail postage, will reduce processing time to less than three weeks (normally it is four to six weeks). Passport photos are \$15. Payment is accepted in the form of cash, check or money orders only.

# 'Godzilla' El Niño was just a lizard

From fall until spring, Southern California was supposed to experience one of the strongest El Niño weather patterns in a century. Warnings of flooding and road washouts prevailed throughout the fall.

Although the precipitation since July 1 has exceeded recent years, it remains less than the long-term average. El Niño failed to dampen the spirits of Southern California residents.

Last week, Alex Tardy, meteorologist for the National Weather Service's San Diego office, offered some explanation for the missing rain.

The ocean conditions, much warmer than normal water temperatures, occurred and presaged the strong El Niño. However, the atmospheric conditions were different than during the 1982-83 and 1997-98 El Niño seasons

The only major storm this winter occurred the first week of January. The atmosphere partnered with the ocean to allow wet air to be pulled across the Pacific Ocean and then over California.

But after that event, the jet stream seemed to split. A strong and persistent high-pressure zone remained offshore, which deflected the storms further north and south, resulting in another relatively dry winter.

The Hill still received about 75 percent of normal precipitation but most other Southern California areas received less. For example, Santa Ana had 33 percent of normal, and Riverside and Palm Springs felt only half the normal rainfall.

"For most of the winter, the high was over California. The storms were still going across the Pacific, but as they reached California, they split, leaving us in a dry zone," Tardy said. "They completely missed us and went north."

Northern California received enough rain and snow this winter that the state has raised water allocations for communities that rely on the State Water Project. Many reservoirs are at 80 to 90 percent of capacity. Users should expect 60 percent of allocations, which is the highest since 2012, and compares to 20 percent last year.

The Association of California Water Agencies has recommended that the State Water Resources Control Board rescind its emergency regulations.

"...[D]rought conditions have been substantially alleviated by this winter's welcome precipitation and snowpack," the ACWA said in its April 14 letter. "Although precipitation and snowpack conditions may be only 'normal' or even somewhat 'below normal' in some regions, sufficient surface water supplies are clearly available to water agencies statewide such that storage is being fully replenished and the drought emergency has been substantially alleviated."

Tardy had other good news. The northern storms did help the rest of the West and the headwaters of the Colorado River.

El Niño is rapidly decreasing, according to Tardy. NWS' latest long-range forecast says that "... the chance of La Niña increases during the late summer or early fall. The official forecast is ... also supported by a historical tendency for La Niña to follow strong El Niño events."

La Niña conditions are created by colder water temperatures and generally produce drier-than-normal conditions in Southern California. It is too early to expect this to occur and the drought to continue.

The Forest Folk have a new van. The 1999 eight-passenger vehicle came from Riverside County after the group approached 3rd District Supervisor Chuck Washington.

With the new van, Reba Coulter, the group's treasurer and project director, said they hope to expand the existing shuttle bus service. The shuttle service has grown, she added.

On Wednesday and Friday, the bus service cycles between the Pine Cove Market and multiple stops in Idyllwild such as the HELP Center and Strawberry Plaza. Coulter said there have been requests to extend service to Mountain Center.

Currently, Tuesday and Thursday are reserved for trips off the Hill. On Tuesday, the van goes to the Coachella Valley and Hemet is Thursday's destination.

With another vehicle, there is an opportunity to add the Thursday "Caring Community Lunch" at St. Hugh's Episcopal Church and possibly the local exercise class to the bus route.

Coulter met with Washington last year and described the service and asked for help finding a second vehicle, anticipating the growth. Washington found a source at the county Transportation Department.

"I never asked for anything in my life until I became

involved in volunteer work," she said, laughing. "Now I've become a beggar."

Forest Folk is a nonprofit organization for adults older than age 50 and on the Hill, began the shuttle service only eight months ago, offering it at no cost.

Usage has been growing. In March, the shuttle provided rides to more than 200 individuals. Most of the riders took advantage of the Tuesday and Thursday trips off the Hill.

# Earthquake south of Mountain Center

In the early morning of Wednesday, April 20, an earthquake, magnitude 2.9, occurred about 2 to 3 miles west of Little Thomas Mountain and the same distance south of Baldy Mountain.

The quake was at about 4:40 a.m. During the next 12 minutes, another four minor quakes were recorded. Their magnitudes ranged from 0.3 to 1.7. About an hour later, a 0.5 shake was recorded about 10 miles southeast

of the original in the Santa Rosa Mountains area.

During the next five days, nearly 25 more and smaller tremors occurred. The largest of these was a 1.4 magnitude and occurred Saturday morning. The largest cluster was south of the Santa Rosa Indian Reservation, and another cluster occurred along Rouse Ridge.

The initial report of the April 20 quake, minutes after it occurred, measured the trembler at magnitude 3.3, but the current U.S. Geological Survey data indicates it was 2.9 magnitude.

# Fire severity may decrease as number/extent of wildfires increase

More wildfires and greater areas burned is the forecast for the future as climate change continues. Recently, a new study published in the "Environmental Research Letters" expects fire severity to decrease.

Fire severity is the extent of change in the local vegetation one year after a major fire. For example, if brushes and shrubs took over the burned area where previously pines or hardwoods dominated, extreme fire severity occurs.

Although the study expects longer fire seasons and larger fires, it is the water deficit and deficient precipitation that will encourage and permit the vegetative change to begin before a fire or to enhance the change after a fire, according to the authors.

"Fire severity generally decreased with [water deficit] and increased with [precipitation]," they reported. Con-

sequently, they believe the severity of fires will be greater in the Pacific Northwest and northern Rockies and less severe in the warmer and drier forest of Arizona and New Mexico. This is how climate change affects fire severity.

Also, as the number of fires increases, the amount of biomass available to burn will decrease, which will also reduce fire severity.

The authors concluded that a passive management approach would most likely be more effective. They argued that activities such as mechanical thinning can be limited for legal reasons, such as a wilderness designation, or geographical, such as steep slopes. Consequently, they recommended that greater reliance on managing wildfires would be more effective.

Regardless, the cumulative effect will be more and larger fires, but sudden and dramatic changes will be less likely since the water environment already will be ushering in these changes.

# Milne talks to Idyllwild residents

# Frustration with building delays

Shellie Milne, candidate for Riverside County supervisor from the 3rd District, met with supporters Saturday evening. Milne, a member of the Hemet City Council, and Randon Lane, a member of the Murrieta City Council and its current mayor, are challenging incumbent Supv. Chuck Washington, whom Gov. Jerry Brown appointed last March to replace Jeff Stone, who was elected to the state Senate.

Milne spoke to several Idyllwild residents during the evening at Uncle B's. She expressed concern about the length of time to obtain building and planning

permits. As a consultant, she has helped other agencies improve their service times.

If elected, Milne promised to establish a Property Rights Council for the 3rd District residents and developers. The council's purpose would be "... to provide comment and recommendations about all county actions involving land-use cases, master planning, General Plan Amendments and updates, all resources and related property issues."

The PRC would also advise district residents on how new state laws or county ordinances would affect their applications. "So that when they bring in the plan, they know in advance," she stated.

"The council will have a voice in the 3rd District," she said. "[The development delays in the county] are creeping up to the Hill. We didn't get into this overnight."

To improve the efficiency of obtaining

these permits, Milne wants the board to consider or return to a flat fee for permits rather than the current

which depends on an initial deposit and then charges for the time to review a permit application.

One of the attendees, Robert Righetti, commented, "If we proposed a master plan for Idyllwild, we'd never be able to build Idyllwild today."

Milne also advocates embracing the use of more technology in the review process in order to improve efficiency.

Elected to the Hemet council in 2012, Milne and two colleagues were threatened with recall for their support of contracting out the city fire service. The recall never went to the voters and eventually, the council chose to keep its fire department. In June, Hemet residents will

vote on Measure E to augment funding for public-safety services.

Consistent with her views, Milne's financial help comes from developers who have given at least \$25,000 and another two have donated \$10,000 each. She also has received five contributions greater than \$20,000, including two from local vineyards — Ponte and Callaway — and the Hemet Community Medical Group.

Milne and her husband, Kevin, who accompanied her to Idyllwild Saturday, have six children between ages 9 and 25. She is a management consultant for retail stores and municipalities.

# Heart attacks and strokes subject of MDP meeting

During the Mountain Disaster Preparedness group's monthly meeting, President Mike Feyder began to express feelings of discomfort and some trouble breathing. The Idyllwild Fire Department crew was present at the meeting and began to administer aid, including blood-pressure checks and heart monitors. Within minutes, they wheeled him out of the Idyllwild Library's community meeting room.

Fortunately, Feyder was acting ill, since the meeting's subjects were the symptoms and immediate treatment for heart attacks or strokes.

As the meeting opened, nearly 45 people were in the audience and Feyder introduced the program. "Health on the Hill is also an emergency, not just natural disasters such as fires and earthquakes," he said. "We're nearly an hour away from the nearest cardiac center, and response time is critical."

Gigi Kramer, one of MDP's medical directors, described the most common symptoms of heart attacks and strokes. She, as a former emergency room and flight nurse, and everyone else

who spoke during the session, stressed that the first action needs to be calling to 911.

"Every minute counts," she said. Because of the distance to hospitals, she emphasized, "If you think you have a heart problem, call 911."

Heart attacks diminish and, possibly, cut off flow of blood to heart muscles. A stroke is interruption of blood flow to the brain. There could be a clot in the vessels or a rupture and internal bleeding in the brain.

Heart-attack symptoms can vary, especially between

men and women. Men often experience chest pain, described as an elephant or very heavy pressure on the chest. Arm pain, especially the left arm, can occur, along with a shortness of breath. Also, one's face can turn pale from the lack of blood flow and sweat may break out.

Women can experience the same symptoms, but often the chest pain is less severe, but pain manifests in the jaws or shoulders. Also, nausea is a common occurrence with women.

"One third of the women have no chest pain," Kramer

"If you experience any symptoms, call 911," she repeated. Don't go to the fire station because the crew might not be there. Dispatch will alert an alternative ambulance.

She also recommended, for heart attack symptoms, chewing on aspirin until help arrives. These should not be enteric-coated aspirin; otherwise, try to substitute baby aspirins. For stroke symptoms, aspirin should not be taken.

For stroke symptoms, Kramer offered the acronym FAST to aid identification of a stroke.

**F**—Facial muscles will weaken, and the individual is likely to manifest drooping on one side of the face.

**A**—Arms should be held straight out in front of the body. If one is too weak to hold them steady, that's another sign of stroke.

**S** — Slurring of speech is another frequent symptom, she added.

 $\hat{\mathbf{T}}$  — If these are occurring, it's "time" to call

Numbness on one side of the body also can be a stroke symptom.

Idyllwild Fire Capt. Alan Lott and his crew also were at the meeting. The current procedure for heart-attack or stroke victims is for the crew

to contact air resources for transport to Eisenhower Center. Lott and Engineer Greg Minor stressed that this procedure will save valuable time, if weather permits. Otherwise, the Idyllwild ambulance will race the patient down the Hill.

"Call us. It's our job here to take care of you," Minor said. He also advocated that individuals should call 911 in case of heart palpitations. "These are not normal either," he added.



# Dark matter, black holes and the formation of galaxies

# UCR Professor Gabriela Canalizo speaks at AstroCamp

University of California, Riverside, Professor Gabriela Canalizo will discuss her research in the study of active galactic nuclei in the near and distant universe — what is observed in the formation of galaxies and what mysteries are still there to ponder.

Active galactic nuclei are some of the most powerful and luminous objects in the observable universe. They are centers of galaxies containing super-massive black holes that are actively attracting and accreting matter at extraordinarily high rates.

In fact, one of the mysteries, as noted by Canalizo, is how super-massive black holes could have formed to such enormous and powerful levels in the time the universe

"I'll be talking about the roles of black holes in how galaxies evolve, and especially about what active galactic nuclei are, where they are, how common they are and how they change our view of the universe," said Canalizo in in-

Canalizo is a professor in UCR's Department of Physics and Astronomy. Her research interests include the interaction between super-massive black holes and the galaxies in which they exist, galaxy collisions, star formation and galaxy evolution. She received a bachelor's degree in physics from MIT and a Ph.D. in astronomy from the University of Hawaii.

Canalizo will make her presentation, "Hungry Monsters, Active Galactic Nuclei and Their Role in Galaxy er.com.

# 'I fell in love with backpacking and helping others'

Demi Kapler is hiking the Pacific Crest Trail for the first time. She is hiking alone, well almost alone (more to come on that), for a cause that means a lot to her—to bring about a time when there are no more homeless pets and a world in which there is more kindness to animals.

Kapler, who grew up on a farm in Minnesota, interacted with animals from her earliest years. "I love the outdoors and grew up climbing trees and playing with chickens," said Kapler. "I grew up with every single type of animal — horses, cows, donkeys, sheep, lizards, ducks, geese, cats and dogs. We had many strays we adopted and took care of."

And through years of attending a YMCA family camp, later enrolling in its counselor training program and hiking the Superior Hiking Trail in northeastern Minnesota, Kapler grew to love the wilderness. "I fell in love with backpacking and helping others," she said. "I have a passion for animals and will always be pro-rescue."

In deciding to hike the full 2,650 miles of the PCT, Kapler knew she wanted to have a cause to promote and benefit. She discovered the nonprofit Best Friends Animal Society, with sites in New York, Los Angeles and Utah. It is the nation's largest sanctuary for homeless animals and provides adoption, spay/neuter and educational programs.

She will be hiking to raise money for Best Friends and to raise awareness about rescues and shelters. Animal Rescue Friends of Idyllwild will host a barbecue for anyone interested in hearing about Kapler's hike and mission at 1 p.m. Saturday, April 30, at the ARF House on Highway

And, as an extra benefit, those attending will be able to meet Evan, Kapler's Living Free Black Lab/Chow-mix hiking companion. Kapler will meet up with her new buddy at Living Free and hike with him into Idyllwild, arriving on Friday, April 29.

Evan's story is compelling. He is 1-and-a-half and was

found abandoned in a vacant field in Hemet, left there with only a bag of food. Evan was loyal. He waited in the field for his owners to return. A neighbor noticed Evan sitting there day after day, provided food and tried to get him to leave the field. Evan refused for over a month.

Living Free heard of the dog's plight and came to pick him up after the neighbor managed to catch him. Evan will return to Living Free after completing the trek into Idyllwild with Kapler.

Kapler is hoping to meet up with other rescue dogs in Tehachapi, Lake Tahoe and Washington, and to have them accompany her on sections of the PCT.

# **ART'S CORNER**

The recently completed Lowman Concert Hall on the Idyllwild Arts campus continues to be a source of sonic amazement as well as a functional musical environment, as this past Saturday's event proved to more than this particular reviewer. With a more than three-quarter capacity audience, both sound and sight potentials were fulfilled, and noted Guest Conductor Scott Hosfeld stood up quite well in those particular surroundings.

It was particularly impressive to this listener how the hall manages to integrate the various orchestral sounds required from the composer's wishes, and the first two program items served as instructive examples for sound production as well as integration.

The Hindemith excerpt — the first movement of the four-part work — emphasized the lower strings and winds, and Mr. Lan's viola solos stood out well enough against this background, as well as in contrast to harpist Allison Allport's part.

Mr. Hosfeld made a point of his overall prowess on the podium by his understated gestures and orchestral cues; a facet which also came to fore in the final movement of the Tchaikovsky violin concerto, where both motion and emotion can sometimes overtake any musical consideration.

Ms. Milcheva's run through the score's contrasting moods was never at odds with the orchestral background (and particularly the playing of the four horns required by the composer), and a very satisfying overall effect was perpetuated, generally by Mr. Hosfeld's knowledge of what needed to be brought to the auditor's attention at the right moment. Fortunately, the hall's acoustics were more than usually cooperative in that effort.

But it was in the final five-part "Czech Suite" of Dvorak that the conductorial gifts really became obvious. With the tempo variations of each dance-like movement, Mr. Hosfeld displayed a technique that was instantly communicated to the full orchestral complement, and the musical response was equally demonstrated, particularly in the work's more lively sections (the final "furiant" section was exemplary in its concluding vigor). But even in the quieter parts, Conductor Hosfeld's rather subdued method worked wonders, with the hall's sonic possibilities well on display.

And while the orchestra's members await regeneration (the departing seniors were all given well-deserved accolades, prior to the playing of the Dvorak), and even more guest conductors and performers are waiting in the building's backstage (figuratively speaking), Lowman Hall renews its promise as more than a symbolic structure and as a welcome addition to Idyllwild's musical community.

# Residents turn out to hear Warrior Hiker stories

In what is becoming an annual event, the Idyllwild American Legion Post 800 hosted a reception and dinner for American military veterans who are hiking the Pacific Crest Trail. Residents attended to talk, eat and drink with the Warrior Hikers.

"Warrior Hike: Walk off the War" is a program developed by Marine veteran Sean Gobin to help returning combat-zone vets gradually ease back into civilian life. Gobin hiked the 2,185 Appalachian Trail in 2012 immediately after he returned from three combat deployments in Iraq and Afghanistan and saw the health benefits for returning combat vets.

Originally, five vets were scheduled to hike the PCT in 2016. One, Navy vet Albert Woolum, the oldest of the vets, left the trail unable to continue. That left Joe Jamison, Army; Dan Janes, Navy; Ruben Munoz, Navy; and Jimmy Sellers, Army, to complete the mission. Ex-Marine Joe Thompson, who was solo hiking the PCT, met Munoz coming out of Julian and decided to join the group for the rest of the journey.

At the post, hikers swapped service stories with legion vets and attending residents, and spoke about the importance of the Warrior Hike program. Dan Janes, affable and articulate, hiked the Appalachian Trail last year. "The goal of the program is to bring the outdoor community and the veterans together," said Janes. "We tell our stories and are getting respect from everyone we talk to, on the trail and in the towns. We're making friends." Janes said the glue that holds the Warrior Hikers together is how every night, in their camp, they talk directly to each other about their deployments — the tension, the stress, losing comrades and buddies. He noted how those conversations are bonding this group together.

And in conversation with them, including newcomer Thompson, it is clear that they are already a tightly knit unit, dedicated to their primary mission — letting those they encounter know about the plight of military combat vets — whether it is about post-traumatic stress and other psychic injuries, physical impairments suffered in combat, high rates of suicide of those returning from combat deploy-







# Fear not ...

New recipes are created by screwing up old recipes. The presidential primary clearly has people talking and worried. Among other things, my hope is that we don't end up with a commander in chief who suggests we no longer have ethnic restaurants.

Given the diversity of the U.S. population, our choice in foods is amazing. Also, the organic and farm-to-table movement has made healthier foods readily available. When we dine out, we don't always know what the heck is in those bargain, one-dollar meals.

Yet, if we do the math, paying a little more for certified organic and non-GMO foods really isn't all that expensive. For one thing, meals prepared at home are normally smaller than meals prepared in fast-food and low-cost diners. Being cognizant of quality and portion size are important steps to being a wise cook.

Eating in restaurants is fun and allows us to try things we haven't a clue on how to prepare. Most of us wouldn't know if a fennel bulb or a Japanese eggplant is ripe or ruined. With that in mind, I always ask the produce manager, or the butcher, for guidance.

It also is true that most restaurants are not completely organic as they shop from purveyors with an eye toward controlling costs. At this moment, there are many competing eateries in Idyllwild. For the most part, I enjoy them all. Again, as I have previously said, that can be an expensive hobby. So, if you are going to cook, cook well. When you shop, shop smart and creatively. It is your opportunity to run your own bistro for any given meal. Preparing healthful and tasty food is a challenge that we need to keep up with. Why? Simply put, there are way too many people on the planet all wanting to live longer, healthier lives as well, and the competition for the best food will continue to increase.

Last month, I asked you to look around for a wok. A frying pan can work but a wok is best. It's easy to clean, cheap and can cook almost anything. Thrift stores may have them. Friends have them. The issue is having enough heat.

Mountain cooking poses unique challenges. For one, unless you have a commercial stove, you probably can't get the big flame like an Asian restaurant uses. Notice the fire under their woks next time you go for Asian food. So up here we need to work around that little nuisance. Stir-fried food is healthful.

Here are a few starting points. A slotted spoon is a good thing. You need oil (try canola or peanut oil), soy sauce, oyster sauce (some have no MSG), chili paste or something similar for heat. Some like fish sauce, but use just a little. Chinese five-spice is everywhere but has a really strong taste I personally do not care for.

The key to a good stir-fry is not to make it a mushy gruel. Cook things in order of density or crunchiness. Example: Start with a chicken breast or firm tofu chunk. Cut in small pieces to your liking; add a couple table-spoons of oil to the wok. Heat the oil well and stir-fry un-

til almost completely cooked. Remove and set aside.

Dice up some celery, onion, bok choy, etc., in sizes you enjoy. There are endless ingredient choices. Add a bit more oil and toss them in. Add some soy sauce and maybe a little pepper. As they just start to soften, add the more tender vegetables like sliced mushrooms, bean sprouts, etc., to the wok. Stir fry the veggies then put the chicken and/or tofu back into the fray and add a couple of tablespoons of oyster sauce, and a scant teaspoon of fish sauce, if you wish. Continue to stir fry.

Then add in some chili oil or paste if you like it hot and spicy. Taste and adjust the seasonings. If you like more liquid, then you can make a cup of broth into a sauce using corn starch or other thickeners. (Think about Better Than Boullion. You can get it at Fairway or other markets.) Always mix the corn starch with a little cold water to remove lumps. Then add it to the broth, and then pour into the wok. Bring to a boil and stop. It will be thicker and ready to eat.

If you have prepared some rice or noodles then serve on top. Make enough as it goes fast. People appear magically when they smell food.

Always try to use some protein like chicken, beef, pork, shrimp or tofu. Shrimp cooks really fast and overcooking ruins it.

As for the veggies, use what looks good to YOU. Typical additions are canned bamboo shoots, baby corn, and sliced water chestnuts. Also nice are cashews, sliced almond, green onion, peas, etc. etc. etc... to quote a king.

Practice in the order that preserves the texture and keeps the flavors separate. No one likes glop.

The fact is, it will be delicious, healthful and likely never be the same twice, as you will improve in technique and selection.

Live large and buy a rice cooker, you will never regret it. It cooks quickly and keeps rice hot and ready when you are.

# Restorative vibrations of a cat's purr ...

After enduring one of the worst headaches in years, which was probably due to going overboard on Fox News election coverage, I actually considered doing something I hadn't done since 2004 — take aspirin.

Who came to the rescue, you may ask?

My cat Tucker was the hero. Turns out all I needed was to lay my head next to him overnight as he purred away. I awoke the next morning headache free and ready to take on the world.

While this may have just been coincidence or a placebo effect, it did get me to wonder why the purr sound is so relaxing to both cat and human.

Turns out cats don't just purr when they are content, they also purr when they are in pain (e.g., giving birth or having suffered injury) and sometimes when dying.

Since purring occurs in such different communicative states, scientists do not consider it a true form

of communicative vocalization. Instead, it's termed a form of self-medication.

Veterinarians have known for years that cats are quicker to heal than dogs when suffering injury such as bone trauma. In the late 1990s, Dr. Clinton Rubin and his colleagues from the State University of New York discovered that exposure to low-level sound frequencies helps build bone density. A cat's purr falls exactly within that frequency sweet spot.

Let's face it, domesticated cats can be kind of lazy (sleeping an average of 16 hours a day depending on age); so purring can help them compensate for missing good-old-fashioned exercise. While other animals need to go fetch balls and chase after cars to maintain healthy bones, a cat may substitute that by putting his or her paws up and purring.

The smaller members of the felidae family, which includes cougars, lynx and ocelots, also purr the same way as domesticated cats. They pulse the muscles in their larynx and diaphragm. The resulting vibrations come in a rhythmic pattern during inhalation and exhalation at a frequency between 25 and 150 hertz (cycles per second).

Being close to those hertz vibrations may help other species, as well. Experiments conducted on turkeys, rats and sheep placed next to vibrating plates at the same purr frequency for 15 minutes showed a noticeable increase in bone strength.

Scientists are now looking at how this technology could benefit astronauts who suffer bone density loss after dealing with the low-gravity conditions of space.

Now, if you will excuse me, I have an appointment with Tucker because I woke up with a slight tweak in my back this morning. Just kidding. I'm actually going to see my chiropractor for this one (too bad he doesn't purr).





The proposed longrange budget, which Capt. Mark LaMont presented to the committee last month, projects 4-percent annual growth in salaries and benefits during this period.

After the salary raises and capital expenditures, IFPD would have \$1.3 million to expend. Lonsbury noted that this was not the specific goal, although it is the outcome of the staff pro-

Some committee members felt the commission might lower the unit fee if these surpluses were to occur; however, Nancy Layton, committee chair and commissioner, was hesitant to see the fee reduced.

In other financial business, the committee briefly reviewed the past contract with accountant Rob Dennis and the request for proposal, which IFPD issued to solicit possible financial help.

In looking at the financial reports for March, several committee members disappointed that past requests for information were not being provided. For example, Calvin Gogerty noted that the comparison between the current month's expenditures to the same month a year ago was not available.

Sue Weisbart And stressed the reason for an extensive financial committee review of the financial reports is because, "The department needs to protect itself. We can't blindly trust an account."

The committee prefers to see staff do the major bookkeeping work rather than

contract it out to the accountant as it is currently done.

"We could extend the hours of the current administrative assistant to this work and change the scope of the RFP," Weisbart recommended. And Layton confirmed that the commission was in agreement to retain this function in-house.

The committee did defer any mid-year budget adjustments until its May meeting.

According to the reports available to the committee, IFPD's expenses through three quarters of the fiscal year have exceeded its revenue by about \$250,000, which is a \$90,000 increase since the end of February. However, Layton was not sure these reports were complete.

You are better off taking the stairs up to your next class, particularly if you are an older American out to improve your knowledge base and protect your brain, according to the Association of Mature American Citizens.

Canadian researchers found that "education and physical activity affect the difference between a physiological prediction of age and chronological age, and that people can actively do something to help their brains stay young." Their study has been published in the journal, Neurobiology of Aging.

Jason Steffener, the lead author of the report, said the focus of the study was the positive effects of low-impact exercise such as climbing stairs on brain health. "In comparison to many other forms of physical activity, taking the stairs is something older adults can and already do at least once a day, unlike vigorous forms of physical activi-

Among politicians, candidates campaign managers, money and cash are the "lingua franca." In the race California's 36th Congressional District, incumbent Rep. Dr.

Raul Ruiz (D-Palm Desert) has the dominating and loudest voice.

As of March 31, Ruiz has nearly \$1.85 million in cash, awaiting the fall cam-

Two Republicans, state Sen. Jeff Stone (R-Temecula) and Steven Wolkowicz of Palm Desert, are challenging Ruiz in the June 7 primary. The top two vote getters will face off in the November general election. Most believe the fall campaign will pit Ruiz and Stone against each other.

Ruiz was elected in 2012, when he upset then incumbent Rep. Mary Bono. In 2014, he defeated former Assemblyman Brian Nestande. For that race, Ruiz had accumulated nearly \$1.2 million by the end of March 2014. By the election, he had collected more than \$3.4 million and spent about \$3.1 million for his re-elec-

During the first quarter of 2016, Ruiz has raised about \$460,000 and spent nearly \$120,000.

Stone entered the race only in December. Since then he has raised about \$118,000. Almost all of Stone's money, thus far, has come from California residents. Only \$6,600 came from donors outside the state. In contrast, Ruiz's fundraising is dominated by out-of-state contributions. Nearly 60 percent of his money came from outside California. From Alaska to Maine and from Alabama to Wisconsin, Ruiz has reached out to supporters across the continent.

About 70 percent of Ruiz's contributions have come from gifts greater than \$2,500. Even a few Idyllwild residents have helped Ruiz's campaign, but \$250 was their largest contribution. Stone's finances, although much less than Ruiz's, also are dominated by a few generous benefactors. About a third of his contributors have given \$2,700.

Of the total contributions from political committees, Ruiz has received about \$90,000 from state groups and nearly \$380,000 from political groups based in Washington, D.C. For example, political action committees, such as Democrats Reshaping America Political Action Committee and Democrats United to Change and Hope, have given, as has minority leader Nancy Pelosi. Other PACs included medical groups, such as American Academy of Orthopaedic Surgeons and American Osteopathic Information Association, and utilities, such as Cox, Time Warner and Verizon.

The third candidate, Wolkowicz, has not filed any financial reports through the end of March.

At the beginning of April, Democrats had 106,700 registered voters in District 36, slightly ahead of the 100,700 registered Republicans. The gap has grown by about 1,500 voters since January. The total number of registered voters in the district is about 275,400, of which 53,600 are Independents.

adolescents and has run homeless shelter in Hemet. "Through those experiences, I began to work for becoming a voice for people who could not speak for themselves," she said.

In working with disabled youth, Morse used unconventional methods to help these youngsters find their voices, literally. "We started a choir and helped them learn to perform," Morse recounted. "They were throw-away kids, bucked by the establishment. Throw aways don't know they have worth and choices.

In selecting Morse, the Fair Housing Council noted she had exhibited leadership that brought about change in the community, had demonstrated commitment to the furtherance of justice of those who have no voice, had been vilified and misunderstood as she pursued her search for truth and social justice, and that she was clearly a community consensus builder.

About being honored, Morse said, "I'm a bit embarrassed. There are so work with me in the Hu-

man Relations Council. We do this work together.

"I'm extremely proud that the honor is for work in civil rights. It is a nice way to wrap my career, especially with what is going on in our nation and culture today."

In her years as president of the Human Relations Council, Morse has helped provide 11 Black History Month essay contests, presented human trafficking symposia in Hemet, hosted a Tuskegee Airman presentation, organized a "Seeing Diversity Film Series" at the Rustic Theatre in Idyllwild for three years, co-sponsored the MSJC Martin Luther King breakfast for many years and presented a community forum on hate and violence, "The NIMBY Phenomenon," in Hemet.

Janet Green, president of the board of directors of the Fair Housing Council hosted the 14th-annual Champions for Justice Awards Banquet at the Riverside Convention Center on Thursday, April 7.

Notes about Morse in the banquet program said, "Mary Morse is the driving force behind the Human Relations Council and has been deeply involved many other people who its many activities. She coordinated these events

while dealing with chronic health conditions while still holding down a fulltime job as director of resource development at a large nonprofit in Hemet. She also serves on the Riverside County Community Action Commission. She is now the executive director of Spirit Mountain Retreat in Idyllwild, a supportive and nurturing environment inspiring individuals to connect with their own

"Her favorite quote is from Mr. Rogers, 'There isn't anyone you couldn't love once you've heard their story.' Her goal is to make possible every opportunity for people to share their stories and learn to love and respect each oth-
