## Idyllwild Fire OKs agreement with San Jacinto

With minimal discussion Tuesday morning, the Idyllwild Fire Protection District commission unanimously adopted the proposed agreement with San Jacinto city to form a joint powers authority.

The agreement between the two agencies will create an agency to serve as the San Jacinto Fire Department. The draft agreement specifies that the city will be responsible for authorizing the type of fire and emergency services and paying for their costs.

While San Jacinto city officials looked on, the commission easily adopted the draft agreement without any opposition. The San Jacinto City Council had the topic on its agenda for its June 7 evening meeting, too.

The JPA board will appoint its chief, who functions as the San Jacinto Fire Department chief. The agreement specifically allows the IFPD chief to assume that role.

## San Jacinto plans action on JPA with Idyllwild Fire

The city of San Jacinto placed the proposed Joint Powers Agreement with the Idyllwild Fire Protection District on its June 7 agenda.

City Manager Tim Hults, in a memorandum to the council, said they

had two basic options. The first was to continue to contract with Riverside County for fire and emergency services. This might be for just one year, in order to organize and get a San Jacinto Fire Department established through a JPA with IFPD.

The second choice was to authorize proceeding with

the JPA in order to have a city fire department operating by July 1. With only three weeks remaining before the old contract with the county expires, Hults recognizes that much needs to be done but acknowledged that the city and IFPD had already begun some preliminary steps that will save some time.

He noted that the JPA could be established without beginning operations. It "...would not be required to provide service unless directed by the city."

Based on the information Hults provided to the council, the IFPD proposal would cost the city \$1.7 million to operate one fire station. There may be cap-

ital costs to begin operations, Hults wrote, "Depending on the quantity and quality of the equipment, either the city or the authority will need to make an initial purchase of additional equipment, with a maximum cost of \$355,000."

# Break-in and car theft at Idyllwild Garage

At about 2 a.m. Wednesday, May 25, three masked and as-yet-unidentified persons broke into the Idyllwild Garage lot and stole a vehicle. They broke into the lot by cutting the lock on the gate.

Surveillance video showed the individuals checking cars in the lot before selecting a 2006 silver Ford Escape with California plates. Keys were in the vehicle, according to Lt. Dan Florez of the Riverside County Sheriff's Department, Hemet Station.

Sometime before 8:18 a.m. when Idyllwild Garage reported the car theft, the thieves crashed the vehicle into a tree near where Tollgate Road becomes Apela Drive close to the Idyllwild Arts campus. In addition to damage to the body of the car, windows also were smashed out.

Florez did not know whether the crash created the damage to the windows or whether the thieves vandalized the car before abandoning it.

An investigation is ongoing. Florez said investigators would be using the video surveillance footage in local interviews to see if anyone could identify the thieves. Anyone with information about the burglary and car theft should call the main number at the Hemet station at 951-791-3400.

# Sheriff explains budget issues

## Working with supervisors

*Editor's note: Riverside County Sheriff Stan Sniff met with the editorial and reporting staff of the Idyllwild Town Crier last week.*

Sheriff Stan Sniff acknowledged the crime rate has been creeping up throughout Riverside County. This is the principal reason he wants to protect his department's funding and has urged the Board of Supervisors to reconsider the retreat from increasing deputies in the unincorporated areas.

County Executive Officer Jay Orr warned the board this winter that revenues and expenses were not balanced. In October, the county hired KPMG, a consulting firm, to review the sheriff's budget as well as the other criminal justice agencies' budgets. In March, KPMG presented its report and Orr recommended, with board approval, to have KPMG pursue its 51 recommendations for the Sheriff's Department, the District Attorney's Office, the Probation Department and the Office of the Public Defender.

Part of this included the supervisors putting the goal of increasing the ratio of deputies in the unincorporated areas to 1.2 per 1,000 residents on hold. Currently, the ratio is about 1.04.

The number of deputies is one of the sheriff's more vulnerable budget items. "We can't cut the jails. The coroner is too small. We can't cut the cities with contracts because we bill them; the only place is the unincorporated areas," he lamented.

Sniff is optimistic that board members are realizing that the growth in his budget is the result of labor contracts signed several years ago. He had no control over what was negotiated, but he wants to maintain staff.

While it is easy to rely on attrition (about 5 percent annually) to help reduce staff, vacancies in the field cannot be filled quickly. Recruitment and training can take up to 18 months or more before an individual can be assigned to a station.

Although he believes working with KPMG will help convince the board and executive office that the depart-

ment is lean, it will take time. For example, the East County Detention Center, which will be ready to open in late 2017 or early 2018, has had its staffing delayed.

"We can just shift staff from the Indio jail to the ECDC," Sniff stressed. "It's a different configuration."

And again, the lead time for recruitment and training delay the availability of new staff. "We can always shut staffing down, but it is hard to start up quickly."

As always, Sniff emphasized that he will work with the supervisors and county executive on future budgets and remains optimistic that satisfactory solutions are on the horizon.

While dollars-and-cents issues have been in the forefront of the discussions with the board, Sniff has also been building the department's use of technology to help staff.

"We're only interested in technology which is a force multiplier," he added. For example, the department is about to begin a one-year test of how drones (unmanned aircraft) might help with search-and-rescue incidents.

This type of technology may help reduce the time to find the lost hiker or injured person, but humans from the Riverside Mountain Rescue Unit will always be needed to provide initial aid and extract the victim, Sniff stressed.

But technology brings its own problem, to which Sniff is very sensitive. Privacy issues can be a thorn both with the public and internally, he added. For example, as the department began planning the drone test, Sniff said they were adamant to avoid any unit other than fixed-winged drones. He didn't want someone claiming that the sheriff's staff was peering into houses.

Body cameras, which have become a public interest in recent years, raise questions with unions.

"But staff knows there is a national decline in credibility," Sniff said, explaining one value of a body camera. "It helps with the credibility and integrity of investigation, and are critical in the future."

Before departing, Sniff said he intends to run for re-election in the fall of 2018. A career law enforcement official, he was appointed to replace Bob Doyle as Riverside County sheriff in October 2007. He was easily elected and re-elected with more than 62 percent of the vote in 2010 and 2014.

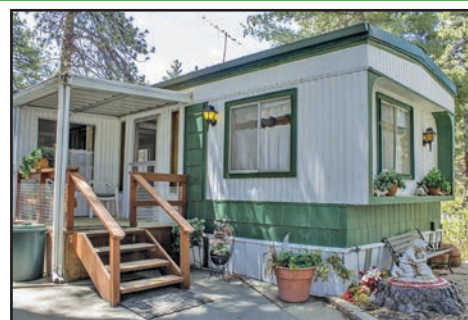

Many of you may not know that the Town Crier is as old as Idyllwild Arts. Our first issue printed in November 1946 and we are working out plans to celebrate our 70th year later with readers and advertisers invited.

I love looking through past Town Criers and often get lost in reading old stories and old ads, many of which Ernie illustrated himself.

A story in the Nov. 9, 1956 edition, "Record Vote in Election," reads:

"As goes the nation so goes Idyllwild! With a record vote of 515, mountain residents cast 416 votes for Eisenhower as against 93 for Stevenson.

"In the Congressional and Legislative the Idyllwild precincts reported a 3 to 1 Republican vote.

"Despite heavy Hill support, Idyllwild candidate J.G. Nusbaum running for the district hospital board, lost to Sherm Lewis of Hemet in a closely contested race.

"Serving on Precinct 1 were J.G. Nusbaum, Ella Braddock, Inie Wilson, Jesse Brown, Roger Hillis and Maye Lorenz.

"Precinct 2 included Deane Brennan, Coral Belden, Peg Geiser, Betty Jolley, Ida Wilder and Charlotte Weinkauff."

This was the story in the TC of the presidential race 60 years ago when Ike again beat Adlai for the top job as he did four years prior.

And Les Hogue advertised "Know Your Cabin is Safe!" Pat Wright of Fern Valley Beauty Shop advertised "Perk up With a Fall Cold Wave." California Electric Power Co. advised: "Live Better Electrically."

And Emax and Bmax celebrated the TC's 10th with a potluck at Town Hall. Attendees included Dr. Evarts Loomis, Val and Mary Hansen, Ruth Sorenson, Stefi Samuelson, and Frankie and Doug Emory.

## Leaf Blower Exchange Program

The South Coast Air Quality Management District is offering a Leaf Blower Exchange Program for commercial gardeners/landscapers. Registration is required to participate. Call the SCAQMD toll free at 1-888-425-6247 Tuesday through Friday from 8 a.m. to 5 p.m. to register.

## Electric vehicle program

The South Coast Air Quality Management District has established a residential Electric Vehicle charging incentive pilot program to offset Level 2 (240 volt) EV charger hardware costs. This program will be available to residents within the SCAQMD's four-county jurisdiction.

The program will provide an incentive to buy-down the cost of residential chargers, which typically range from \$400 to \$800. The program will be implemented on a first-come, first-served basis and will provide up to \$250 for the cost of hardware for Level 2 residential chargers.

Another incentive of up to \$250 will be available for low-income residents.

A charger would need to be installed at a 240-volt outlet or by a licensed electrician if no 240-volt outlet exists.

The charger would need to be in place for a minimum of three years and would be considered a permanent, not temporary, installation.

The installer would need to obtain any required city or county electrical permits for installation.

# Local resident Mary Lehman returns from Greek refugee camps

## Her second trip as a volunteer medic

Local resident and attorney Mary Lehman has a busy life and career. But it is not too busy for her to lend her skills as a volunteer emergency medical technician to the escalating refugee crisis in Europe.

Last November, Lehman went to the Greek island of Lesbos, just off the Turkish coast. She had read of the developing emergency on Lesbos — no organized camps ready to receive refugees, people dying at sea and confusion on the ground. She arrived prior to any organized structure having been put in place to deal with the medical and psychological needs of the arriving refugees.

After returning to the U.S. she continued to wake at night believing she was still there, crawling around her bedroom trying to find her headlamps and emergency equipment so she could meet arriving boats.

Since November, the crisis has been exacerbated by border closures and disagreements within the European Union over how to deal with refugees who continue to make the treacherous crossings to Greece. The result has been to strand thousands of refugees at camps both official and unofficial throughout Greece, and especially on the border with Macedonia (officially the former Yugoslav Republic of Macedonia).

Lehman felt she had to return. She had the medical skills and facility with languages that would be useful. In May, she went back, initially to an unofficial camp called Idomeni in Greece, just south of the border with Macedonia.

First planned as an unofficial settlement for 2,000 mostly Syrian and Iraqi refugees, the camp had more than 12,000 at the time Lehman arrived. Panagiotis Kouroumbilis, the Greek interior minister, called the conditions at Idomeni comparable to Nazi concentration camps. "The situation here is tragic," he said. "It doesn't honor the civilized world, it doesn't honor Europe. This is the result of the logic of closed borders." This was where Lehman had gone to volunteer.

"The camp was closed after the first five days I was there," she said. Although resistant, refugees were being moved to "official" camps run by the Greek military with strict entry and exit requirements.

Lehman explained that, based on agreements within the EU, refugees who arrived in Greece prior to March 20 were entitled to a "presumption" they had valid claims for asylum status, pending official review of their claims and documents. Those who came after were more likely to be returned to Turkey, regardless of whether other family members had already reached countries such as Germany and had been granted asylum.

Lehman noted that review of eligible cases could take six months to a year and many within the camps, official or unofficial, were losing hope. "The biggest distinction from my first trip [to Lesbos] was the despair in these camps. Many had lost hope. When I was in Lesbos, arriving refugees were joyful to have gotten to European soil." Now, not knowing how long it would take or even if their asylum claims would be granted, the current refugees were hopeless.

Even though she went as a medic, Lehman's time was spent primarily as a medical administrator. After the closure of Idomeni, she went to a spontaneous self-organized camp that formed around an Echo gas station in Chalkidona. "The medical care was easier;

not so many emergencies," she said. Because she had acquired some knowledge of Arabic and a working knowledge of Greek, she acted as translator and initial triage diagnostician. "Everyone came through me and then on to specific medical care," said Lehman. "We processed about 60 patients per day."

Lehman is already thinking of returning, next time to help in dispensing information. "More than anything, [the refugees] need information," she said. "More than half are women and children with [male relatives] who are already in Europe [countries accepting asylum claims]. The problem now is information flow — providing answers to the people waiting. People are stranded with no knowledge of if or when they might be able to move on."

Going forward, the process for resettlement of the refugees already in Greece is very complicated. Refugees must pre-register at designated sites and then get an appointment at a designated asylum service office for an interview at which they explain why they need asylum. Only people who have entered Greece between Jan. 1, 2015, and March 20, 2016, can pre-register. They must also hold a police note acknowledging their presence in Greece and be living on the mainland.

Lehman said she is considering using her legal skills on her next trip, volunteering with a group called Advocates Abroad. Advocates Abroad is a field-based team of lawyers who provide legal aid to refugees in camps and detention centers with a particular focus in Greece.

Lehman talked about the hospitality and graciousness of the Greek people, especially under strained economic conditions. "The camp that formed around the gas station was something that would not have hap-

# Fern Valley Water manager to retire within weeks

## Steve Erler has 22 years at district

After more than 20 years with Fern Valley Water District, of which he was general manager for 18 years, Steve Erler is floating off into the sunset. Erler finishes his FVWD career on Thursday, June 30 and begins retirement Friday, July 1.

Not a rambling or garrulous speaker, Erler simply described his career in these words, "I enjoyed it."

But during the time here, his planning and dedication were noticeable and enjoyed by his various boards.

Current FVWD board President Jim Rees, who has known Erler since their youth in Hemet, said, "Ever since I've been on there, I'm impressed with his job. Steve always does his best to save the district money and not overspend."

During his career, Erler said his proudest achievement was the purchase of 15 acres on Lodge Road. "Negotiating that piece of land was a big coup for the district," Erler said with a smile.

But it was not the land itself from which FVWD benefited, it was how Erler used it and what he did with it that created and will continue to generate benefits for FVWD customers.

With respect to water resources, the site is the source of three new wells that have doubled FVWD's groundwater capacity. A new maintenance facility was built there, which permitted FVWD to install surface water and granular-activated carbon treatment plants at the former maintenance site.

No manager experiences a continuing ascending ladder of successes, and Erler admitted he has encountered a few struggles during his two decades. The biggest has been his efforts to reduce water losses. And consistent with his thorough and persistent methods, he has nearly cut the water losses in half — from 20 percent to 10.

As the senior public servant for a public agency, much of a general manager's time is invested in work with the board. Erler is no different and expressed his gratitude for the support and ability of numerous individuals who have served as directors during his tenure.

"I couldn't ask for better directors," he said. During the period when he served with two engineers on the board, Erler accepted their insightful questions and his care for details was an advantage.

"Steve is a very hard-working and dedicated employee, who is careful about whatever he does," said Robert Krieger, a current director and chair of Krieger and Steward, an engineering consulting firm in Riverside. "He is detailed about whatever

he does and, as a consequence, he always does the right thing. He was a pleasure to work with."

One of his continuing challenges, as any water manager knows, is keeping current with changing Environmental Protection Agency rules and regulations. This has affected Fern Valley's water storage. More precisely, Erler has to ensure that the stored water rotates more quickly than past managers did. Storage capacity is not limited, but length of storage has become an important variable.

While dealing with directors, staff and the public, Erler also has found time to plan and execute the replacement of nearly 8 miles of pipeline in the district, thus ensuring reliable and safe water to his customers.

Also, Erler works with the other local water districts. General Manager Jerry Holddber of Pine Cove Water has known him since Erler began at FVWD. "Steve replaced Tom Horn and has done a good job. There's been lots of improvements.

"The two districts have a good working relationship and I hope it will continue," Holddber added.

Once retirement occurs and he adjusts, Erler and wife Anne plan to stay in Idyllwild while visiting their place on Lake Havasu. He also plans to purchase a recreational vehicle so they can travel more, and Erler enjoys restoring old trucks such as Land Cruisers.

He has been preparing for this stage of life and has no regrets. "I'm doing it while I can enjoy life," he said proudly. "I'll miss everybody. I was passionate about the district's success. Time flew by."

But he recognizes the value of changes, which can bring fresh ideas; so he has welcomed and prepared Victor Jimenez to become the next FVWD general manager on July 1.

pened in the U.S.," said Lehman. "The owner of the station provided services to the refugees and locals continued to come to the gas station to fill their tanks. The surrounding business owners made money, but it was their hospitality in allowing an area to literally be transformed into a village in Syria. That was amazing."

# June proclaimed Great Outdoors Month

June is Great Outdoors Month in California following Gov. Jerry Brown's proclamation on Wednesday, June 1.

In the proclamation, Brown highlighted just a few of the outdoor opportunities available in the state. ## County to increase time for decisions regarding noisy animals

At its June 7 meeting, the Riverside County Board of Supervisors was to consider an amendment to the current ordinance regarding noisy animals.

Ordinance 878 addresses disturbances, which may be caused "by excessive, unrelenting or habitual noise of any animal" and are "disruptive of the public's peace and tranquility, and represents an unwanted invasion of privacy of the residents of the unincorporated areas of the County of Riverside."

The ordinance effectively deems these animals a "public nuisance" and authorizes an investigation of noisy animal complaints. Procedures for notifying the pet's owner are part of the investigation and of arranging an administrative hearing.

Currently, Ordinance 878 requires the "the administrative hearing officer to notify the pet owner of the decision within three business days of the hearing."

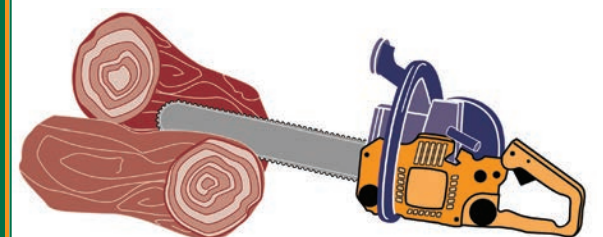

# Dahleen announces Summer Concert Series lineup

Creedence Clearwater cover band and Marine Band ensemble are new

Ken Dahleen, founder and impresario of the Idyllwild Summer Concert Series, has done it again — created a summer lineup with something for everyone.

For 16 years, Dahleen and his board have provided a Thursday-night summer series of music under the stars — free. He contracts the acts and begins each summer with insufficient money to fund the series. He does it on faith and the community responds with sponsorships, donations and enthusiastic attendance.

This year, two exciting additions are designed to bring out the crowds and justify the faith of the ISCS board. Dahleen had waited to announce the season until he could accomplish a major goal — contracting United States Marine band musicians for a return. It has been four years (2012) since a corps ensemble has played for ISCS. The men and women in their blue-dress uniforms are scheduled to play Thursday, July 28. Downbeat is at 7 p.m.

The series' musical flavor shifts to down-home Southern rock on July 14 when a Creedence Clearwater tribute band sends out some of the iconic group's biggest hits including "Proud Mary," "Bad Moon Rising," "Down on the Corner" and "Travelin' Band."

Although CCR was founded in San Francisco, the band parlayed Southern rock and South-centric lyrics to national fame — lyrics about bayous, catfish and the Mississippi River. It also penned and recorded songs with political and socially conscious lyrics in a time of Vietnam War national protests.

Opening the series on Thursday, July 7, is Santana tribute band Bohemio, an Idyllwild favorite; the Creedence tribute band follows on the 14th; on July 21, another band new to ISCS is clarinetist Dan St. Marseille's Dixieland Band; on July 28, the Marine Corps sends in some of its finest;

on Aug. 4, Harold Wherry and his Blue Breeze Band return to offer up some Motown motion and magic; on Aug. 11, Ken Dahleen's Big Band Staff returns; and on Aug. 18, locally renowned jazz guitarist Bob Boss comes in with his quintet. Closing the series are Lisa Haley and her Zydecats churning out some foot stompin' music that definitely turns up the heat.

For all but two headliners, the Marine Band ensemble and Dahleen's Big Band Staff, there will be opening acts that begin at 6:15 p.m. The Big Band Staff and the Marines start at 7 p.m.

# Friends of Nature Center board seeks to raise dues

The board of the Friends of the San Jacinto Mountain County Parks seeks to raise member dues in order to help finance program expansion at the Nature Center. To do so, it must change a provision in its existing Articles of Incorporation that requires any bylaw modification for dues and assessments be approved by "the vote or written consent of a majority of the voting members of this corporation."

Current board President George Ray estimates current membership at 400. "Our concern is that there's no way we can get everyone at a meeting," he said. "We don't expect to get 50 percent even with proxies."

To accomplish the goal of raising dues, Ray and his board plan to ask attending members at the annual meeting at 6 p.m. Friday, June 17, to approve deletion of the Article provision requiring majority vote of the voting members to change dues. Ray argued that current bylaws allow a membership vote to amend the Articles of Incorporation by a simple quorum of those attending its annual meeting. "To amend the Articles does not require a full vote of the membership," he said.

According to Ray, current bylaws define quorum at the annual meeting as 20. With 20 members present, a majority of those could vote to delete the Article provision. The net effect would allow directors to file an amendment to the Articles with the California Secretary of State deleting the referenced section.

With the Article section deleted, the board may then specify in the bylaws the methods by which members are assessed, how dues are collected, and the amount of those dues.

Ray noted raising dues could expand current programs, including the new speaker series, provide reimbursement to school districts for busing of students and grow current festivals. Ray said there has been some encouragement from the county to raise dues because doing so would expand programs and likely increase attendance at the county facility. Also, membership allows free entry into the center, thereby reducing possible county revenue given the large Friends membership base.

The board, currently numbering seven, also will seek to reduce the authorized number of directors from nine to seven, with a quorum being a majority of those then serving. Three director terms expire on June 30, 2016. No incumbents are seeking reelection. Anyone interested in running should nominate themselves or ask another member to nominate them at the meeting.

The meeting will be held at the Nature Center on Highway 243. The call to order is at 6:15 p.m. and dinner will be served at 6:30 p.m. The meeting centers on bylaw amendment and election of directors.

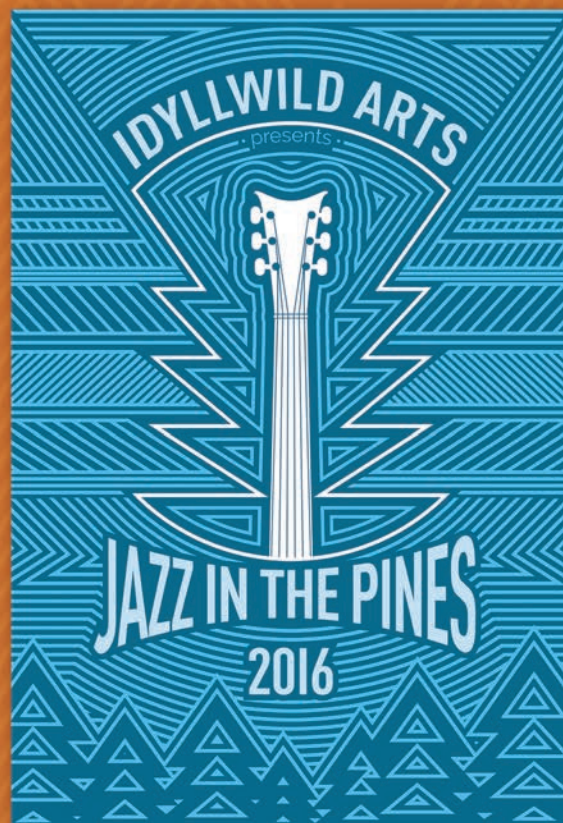

# Middle Ridge Tasting Gallery's wines are good to go

When Chris and Melody Johnston thought to open a gallery and tasting room in Idyllwild, they thought the official permitting processes might take several months. They envisioned a gathering spot where patrons could relax, taste Middle Ridge wines, experience art from Idyllwild's own and purchase wines to take home. Fifty-one weeks later, they received final approval to create that vision and sell wine to go.

That, as Melody explained, had been what took so long. It turns out their Tasting Gallery on North Circle is the first "remote wine tasting room" in the unincorporated areas of Riverside County. The Johnstons have a license to age and bottle wines in Temecula that permits one "remote" tasting room — the Middle Ridge Winery Tasting Gallery in Idyllwild.

Although wine tasting within the gallery confines had been approved by the county earlier, it took longer to secure the conditional use permit for wine "to go." That approval, said Melody, came just before the Memorial Day weekend.

What is now fully up and ready for all intended use is a 4,000-square-foot high-end gallery and wine tasting room, at which patrons may sample and now purchase wines to take out. "The Sunday of the Memorial Day weekend we had significantly more business than just an art gallery," said Melody.

Chris "designs" his Middle Ridge varietals in Idyllwild at his Innovation Lab. Wine production

takes place in Temecula. Melody manages the day-to-day business of the winery and the Tasting Gallery. Together they host a beautifully designed Idyllwild gathering place and social destination.

Middle Ridge Winery and Tasting Gallery evolved from the Johnstons' shared commitment to bring people together socially to appreciate and understand fine artisanal wine and to have conversations with everyone who experiences their wines.

Their tagline captures their philosophy —

"When the conversation is as important as the wine." The Tasting Gallery is located across from the Rustic Theatre at 54301 N. Circle Drive in the historic Idyllwild business district. With permits complete, wine tasting, to-go sales, locally hand-crafted furniture and art in place, the result is, as the Johnstons note, "a perfect pairing — wine and art."

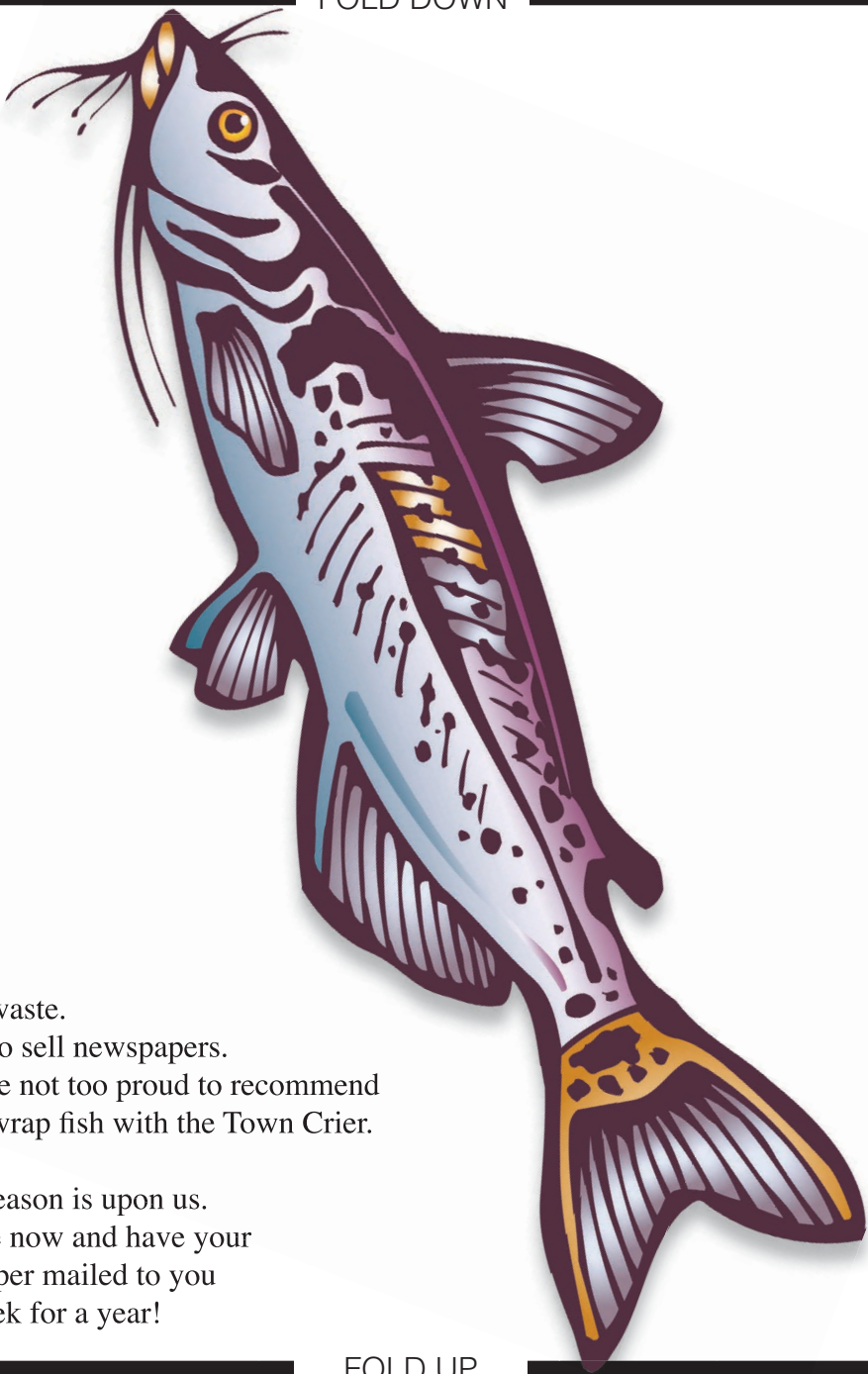

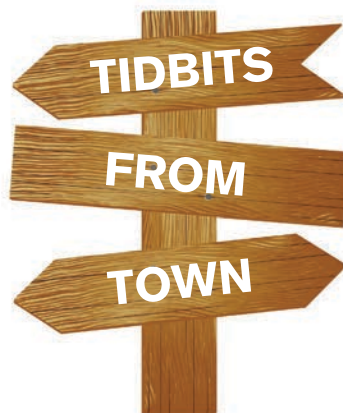

# Steele qualifies for U.S. Open

Brendan Steele collected his seventh top-20 finish in 16 tournaments this 2016 season at Jack Nicklaus' Memorial Tournament in Dublin, Ohio, this past week. The native Idyllwilder carded a 10-under-par 65-67-75-71 — 278 to finish tied for 20th.

He started out hot, standing second after Round 1 and tied for the lead after 36 holes, but faded Saturday when a double-bogey contributed to a 3-over-par round.

On Monday, Brendon stayed in Ohio to successfully qualify for a spot in this year's U.S. Open, which will be in Oakmont Pennsylvania, June 16-19. He fired an 8-under-par 66-68 — 134 to easily qualify on The Wedgewood Country Club course in Powell, Ohio.

With the season half over, Brendan now has 589 FedExCup points, ranking 59th on that list. He also is ranked 66th on the money list with more than \$1 million in official earnings so far this season, and he's now gone over the \$8 million mark for his career.

B will play in this week's \$6.2 million FedEx St. Jude Classic in Memphis.

By the way, at 6 p.m. Tuesday, June 14, Friends of the Idyllwild Library will host Kent and Jana Steele, Brendan's parents and longtime residents of the Hill. They will speak and answer questions about what it was like to encourage and support Brendan in his quest, from early teenage, to become a professional golfer while living in a town without a golf course or even a driving range.

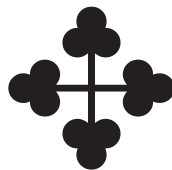

# Electric bills will have changes

## Small changes now, more next year

Another portion of the electric rate changes the California Public Utilities Commission adopted in July 2015 will be seen on local Southern California Edison bills this month.

SCE's residential rates moved from four to three tiers on June 1. However, the impacts of this change will be relatively small.

Edison expects residential rates to remain fairly stable through 2017. It has filed an application requesting a 3.5-percent increase for fuel and purchased power. According to Edison, rates are going up slightly as a result of reduced sales due to distributed generation.

In 2017, customers should expect increases as the three tiers are collapsed again, into two tiers. Also, in 2017 a high-usage surcharge will be imposed on customers who use twice the average amount of electricity per month. The commission created the surcharge to encourage electricity conservation.

In November 2015, the first step in the new rate structure was implemented. At the time, the monthly minimum delivery charge was increased to \$10 for many customers.

For SCE customers enrolled in the California Alternate Rates for Energy, Family Electric Rate Assistance or the Medical Baseline programs, the monthly minimum charge is \$5, when the actual delivery charge total is less than \$5. For all other residential customers, the monthly minimum charge will be \$10, only if the actual minimum delivery charge is less than \$10.

Protections for the lowest-income customers remain

under the CARE program. Nearly one-third of SCE's 4.3-million residential customers are on the low-income rate where the rates they pay are about one-third lower than those for other customers. California's low-income rate program provides some of the largest discounts in the country.

This June, low-to mid-usage CARE customers will not see a bill increase; high-usage CARE customers will see a bill increase of about 3 percent in their discounted bill.

SCE's residential customers will see a benefit through an increase in the California Climate Credit (a line-item credit on their April and October bills of \$38, up from \$29 in 2015). SCE's non-residential customers' rates are about 10 percent lower today than in 2015.

When 2019 begins, customers will have two tiers and rates will be based on time-of-use. Under time-of-use rates, the cost of electricity depends upon the time of day and time of year the energy is being used. A transition of all non-residential customers to time-of-use rates was completed in 2015. While default time-of-use rates are scheduled to take effect in 2019 for residential customers, SCE has already developed time-of-use programs for residential customers. Customers can take a look at those programs and sign up now if they are interested.

SCE has estimated that ultimately, these changes will increase the monthly bill for low-usage customers an average of \$1.50 to \$2 monthly each year as the changes are phased in over four years. Medium-usage customers will see an average of \$2 a month bill increase during the same time period, while high-usage customers will see an average \$1.50 to \$2 a month decrease during the transitional time.

The new structure is more closely aligned with the actual costs of providing electric service — more electric use will result in higher bills.

costs of operating the new agency, Hults specifically told the council "...the city would be responsible for the costs to operate the San Jacinto Fire Department. The city could determine its desired service level based on the costs it chooses to budget."

The new contract with the Riverside County Fire Department will cost the city \$2.1 million, but that includes some more services, such as hazardous materials.

If San Jacinto wants a squad capable of responding to medical emergencies from another station, Hults said it would cost the city another \$1.2 million.

The difference in costs appears to be the salaries for the staffing. The JPA proposal estimates that a fire captain would make \$170,000, including benefits. The county's contract is based on captains costing about \$204,000.

Of course, the new JPA board, composed of both the San Jacinto City Council and the IFPD commission, will have to set the actual salaries for all of the JPA staff, including firefighters.
