San Jacinto council extends fire contract with county

JPA to seek dispatch service ready for July 2017

Last week, the San Jacinto City Council decided to extend its fire services contract with Riverside County Fire Department for another year.

At a special council meeting Wednesday, June 15, San Jacinto decided that an adequate dispatch service would not be available by July 1, when its current contract with Cal Fire expires. Therefore, activating fire service through the Joint Powers Authority with the Idyllwild Fire Protection District would not be possible without an appropriate and adequate dispatch service.

The meeting began with City Manager Tim Hults acknowledging the efforts — such as recruiting and interviewing prospective staff — of Idyllwild Fire and city staff to get the JPA ready to provide the city with fire and emergency service by July 1.

"One big item where we've had no success is achieving dispatch service," he said. The JPA staff had contacted several dispatch agencies, including Banning, Riverside, Corona, Murrieta, San Bernardino County and North Comm in San Diego County.

"Unfortunately, we were not successful to get them to provide dispatch service," he added. Hults also indicated that the Riverside County counsel had expressed objections to the JPA concept, too.

The council expressed dismay about the situation and frustration that their only option was to return to Cal Fire/Riverside County Fire Department. It also praised the staff for how much was accomplished in the past few See Contract, page 28

Idyllwild Fire plans \$2 million budget for 2016-17

The Idyllwild Fire Department's Finance Committee reviewed the proposed fiscal year 2016-17 budget and moved it to the full commission with some minor changes. The new budget totals slightly more than \$2 million in both revenues and expenses. Revenues are projected to be \$7,500 more than total expenses.

For the current year, budget totals are about \$1.9 million, with expenses about \$2,000 more than revenues. The increase in 2016-17 is about \$180,000.

However, current-year totals are budget projections since a financial report for

May was not available.

Revenue increases are expected in property-tax collections. This year, the budgeted tax collections' estimate was about \$800,000 and the committee has projected \$934,000 for 2016-17. The other large revenue increase is for cost reimbursements of firefighting activities outside IFPD's jurisdiction. These revenues are projected to grow \$60,000 to a total of \$300,000.

Despite an increase in ambulance rates, the budgeted collections are about the same as this year. Fire Chief Patrick Reitz said it takes some time for insurance companies to adjust to the new rates.

Body found on identified

Homicide investigation

Riverside ty Sheriff's Department Homicide Unit is investigating the circumstances that circumstances led to the death of Jerome Salgado, 37, of San Jacinto. Salgado had been reported as missing on Sunday, May 22. He had last been seen Friday, May 20, in the Hemet area. Salgado's body



was found in a gravesite in a remote location on the Soboba Reservation in the San Jacinto mountains.

At 1:42 p.m. Saturday, June 11, Hemet Station deputies received a telephone call regarding human remains in a remote location on the Soboba Reservation, in the area of the Indian Creek and Ridge truck trails.

Investigating deputies found what appeared to be a gravesite. Homicide Unit investigators responded and owing to darkness, secured the gravesite until the next morning. Upon further investigation, an adult male was recovered from the burial site.

The victim was later identified as Salgado, missing since May 20. Salgado had suffered traumatic injuries that had caused his death. The investigation is being treated as a homicide and the sheriff's department said no further information would be released at this time.



New data led to re-arrests Soboba reservation in Pinyon triple homicides

week, Last Robert Pape (pictured left), 28, and Cristin Smith (right), 27, were re-arrested for the 2006 triple murder of Jon Hayward, Vicki Friedli, and Vicki's daughter, Becky Friedli in Pinyon Pines.

Both had been arrested for the triple murder in March 2014, but near-



Pape was arrested Wednesday, June 8, in Cathedral City. Smith was arrested Friday, June 10, in Sacramento.

In obtaining a warrant for their re-arrests, new information was revealed. One of the major items was the retesting of DNA found at the scene, which matches Smith's. According to the sheriff's office, the chances of the DNA being misidentified is 1 in 28

"Smith denied ever being present or near the scene of the murders," said Lester Harvey, an investigator with the Sheriff's Department in a statement seeking a warrant to arrest both men.

Also, a better forensic analysis of cell-tower data places Smith and Pape together on Monterrey Avenue, which becomes Highway 74 to Pinyon Pines, before the murders. This contradicts their earlier statement that they had never left the Cathedral

And a confidential informant has been identified who alleges Smith admitted to being involved in the arson and saying, "Something went wrong and we torched the whole f---ing place."

On the night of Sept. 17, 2006, Becky, 18, her mother Vicki, 53, and Vicki's boyfriend Hayward, 55, were found dead at their Pinyon home. Becky's body was found burning in a wheelbarrow outside the house. The other bodies were found inside the burning home.

Pape was Becky's former boyfriend. The two men were arrested in March 2014 and charged for the three murders. Then on Oct. 6, 2014, nearly seven months later, the DA's office dismissed all the charges against Pape and Smith.

Three counts of murder, with a special circumstance allegation of committing multiple murders, were filed on Wednesday, June 8, against both men,

Both Pape and Smith are in custody without bail currently. Their arraignments were scheduled for June 21.

Fire officials preparing for fire season

At the June 8 Mountain Area Safety Taskforce meeting, local fire officials discussed preparations for the current fire season and other local projects, which might affect fire threats.

Edwina Scott, executive director of the Mountain Communities Fire Safe Council, reported that MCFSC has helped 99 homeowners (and one more will be completed next week) to replace their shakeand wood-shingle roofs with fire-resistant Class A

"We are almost finished with the re-roofing grant," she said. "And we are under the budget." As a result of the savings, MCFSC may be able to increase the homeowner reimbursement to 75 percent

"We got two [State Responsibility Act] grants from Cal Fire," Scott added. "One is to remove dead and dying trees, and the other to abate fuels on private properties.'

These grant funds have resulted in completed work on 10 parcels (the total area is 13 acres) and more than 40 tons of fuel removed.

During the discussion of the Idyllwild Grinding Station, Marge Muir, Pine Cove resident and local real estate agent, urged CR&R to open an extra day

during the week. "Especially in the summer, people Fire's Pre-Fire Unit. visit and work weekends [cleaning property]," she

Currently, the site is open Tuesdays and Fridays from 8 a.m. to noon and 1 to 4 p.m. On Saturday, the hours are 10 a.m. to 2 p.m. Idyllwild Fire Chief Patrick Reitz agreed with Muir about opening another day. "It's mostly to help the contractors," he noted.

Lisa Thompson of the Riverside County Waste Resources Department reported that more than 230 tons of green waste has been collected at the grinding site since mid-March. "We expect a new grinder in the middle of July," she added.

Both the U.S. Forest Service and Cal Fire are completing pile-burn projects as well as work on the fuelbreaks surrounding the Idyllwild and Pine Cove communities.

Forest Service District Fire Chief Fred Espinoza said staffing is just about at full complement. "I've just done hiring temporary staff in Sacramento," he reported.

The Pine Cove Fuelbreak contract has been awarded, but first some road maintenance must be completed. Work has started on South Ridge and will start soon on West Ridge, according to Espino-


"Work on the Ernie Maxwell Fuelbreak is moving forward," reported Capt. Michael Sebastian of Cal

The State Parks [Mount San Jacinto State Park] working on trails in Long Valley and along the Fuller Ridge portion of the Pacific Crest Trail," said Ken Kietzer, senior environmental scientist for the State Parks.

Near the meeting's close, county Fire Chief John Hawkins said, "I've been involved with MAST since 2004. And I've seen a lot of high points and less high points; but we come together to do this." Then he suggested that MAST's command officers conduct a fire gaming exercise to deal with different scenarios.

Our job is to maximize similarities and minimize differences," he advised everyone.

Forest Service releases environmental assessment of May Valley trail project

Three years after initially requesting public comment on the proposed May Valley non-motorized trail project for the San Jacinto Ranger District, the U.S. Forest Service has just completed an Environmental Assessment of the project and its alternatives.

The May Valley area contains about 55 miles of both unclassified or unauthorized non-system trails and classified or authorized national forest roads and trails. Many are popular with mountain bikers, equestrians and hikers, according to the EA.

The FS evaluated adding non-motorized trails to the national forest Transportation System as well as rehabilitating unauthorized trails in the May Valley area.

The proposed action would incorporate 3.7 miles of existing authorized forest system trails; adopt 23.3 miles of presently unauthorized trails; reroute and construct 2.2 miles of new trails; and rehabilitate (remove and restore to natural vegetative state) 12.1 miles of unauthorized trails. All adopted and existing system trails in the project area would be managed as shared use, meaning they are open to all non-motorized users.

This alternative and two others would continue to support mountain biking, hiking and equestrian use in the area, but the amount of activity will be decreased due to the reduction in unauthorized trails in the allotment area, and increased enforcement to reduce user-created

Also, constructing mountain bike and equestrian access (bicycle and walk-through cattle guards, equestrian gates) on trails where they intersect livestock fences will help reduce conflicts between the different recreational users and livestock grazing.

An unauthorized trail on forest lands is not managed and maintained by the FS. An authorized trail known as a classified or system trail — is included within the system of trails authorized, managed and maintained by the FS (National Forest System Trail).

Many of the unauthorized trails are well established and some of the trails have been used for mountain-bike events under special-use permits during the past 12 years. Federal funding cannot be used to maintain unauthorized trails; therefore, these unauthorized roads and trails have not been adequately managed and the network has not been adequately maintained.

The 2006 San Bernardino National Forest Land Management Plan "restricts non-motorized vehicle travel to Forest System roads and trails." This limits mountain bikes and other non-motorized vehicles only to system roads and trails.

This restriction has created concern within the local and national mountain bike communities, according to the EA authors. The International Mountain Biking Association appealed the Forest Plan decision based on this concern. A settlement agreement was reached in which the FS would resolve unauthorized routes over time.

Two other alternatives were evaluated with the proposed action. Alternative 3 responds to two of the key issues brought up during the scoping process. First, the proposed action would reduce recreation opportunities for technical challenge, variety, different skill levels, experiences, variety of terrain and aesthetic values.

Secondly, the proposed action reduces the number of trails, which forces user groups to share trails mountain-bike riders presently use. This could cause trail congestion and other user conflicts.

This alternative maximizes approval of the existing forest system and unauthorized trails in the project area. In addition to the actions described in the proposed action, the Forest Service would adopt 11 more unauthorized trails.

Of the 37.2 miles of trail comprising this tive, 17 miles would be Class trails of which 16.6 miles would be adopted and 0.4 mile would be constructed. Another 20.2 miles would be Class 3 trails of which 14.5 miles would be adopted and 5.7 would be constructed.


The fourth and final alternative was developed to minimize area disturbance and resource effects, and still meet the purpose and need of the project. It was developed in response to the issue of stream sediment, which was brought up during scoping.

In addition to those trails that would not be adopted under the proposed action, the 18 other unauthorized trails also would not be adopted. They would be rehabilitated and removed from the landscape.

Of the approximately 12 of trail would be Class 2 and 11.9 miles of trail would be Class 3 trails.

The project documents can be viewed on the San Bernardino website at www.fs.usda.gov/projects/sbnf/landmanagement/projects. The 30-day review period will end on July 15, said SBNF Public Affairs Officer John Miller.

Only those individuals who submit timely, project-specific written comments during the scoping and the 30-day Draft EA public comment periods, are eligible to participate in the pre-decisional objection process. Individuals or representatives of an entity submitting

miles of trail that would exist in this alternative, 0.1 mile comments must sign the comments or verify identity upon request.

The FS will accept comments on this proposal for 30 days following publication of the legal notice of the opportunity to provide comment in the Idyllwild Town Cri-

San Jacinto Post Office to host passport fair June 25

The San Jacinto Post Office is hosting a Passport processing fee per application. Fair from 9 a.m. to 1 p.m. Saturday, June 25. The fair will offer passport information to U.S. citizens and accept passport applications.

Families and individuals will be able to apply for passports on a walk-in basis without taking time off from work, school or other weekday activities. No appointments are necessary.

Individuals will have the option of applying for a passport book (good for all international travel) or a passport card (good only for land and sea travel between the U.S. and Canada, Mexico, the Caribbean and Bermuda).

To obtain a passport for the first time, applicants need proof of U.S. citizenship and a valid form of photo identification such as a driver's license. A certified copy of a birth certificate (not a California abstract or photocopy) or naturalization certificate is the best proof of citizenship.

One photograph is required, and can be taken at the passport event.

The fee for a Passport Book for first-time adult participants is \$110 and \$30 for a Passport Card. The fee for minors under the age of 16 is \$80 for a Passport Book and \$15 for a Passport Card. There also is a \$25

Parents applying for Passport Books/Cards for children under the age of 16 must both be present, along with the child. An expedited service fee of \$60, plus Priority Express Mail postage, will reduce processing time to less than three weeks (normally it is four to six weeks). Passport photos are \$15. Payment accepted in the form of cash, check or money orders.

To apply for a passport, travelers need to complete Passport Application Form DS-11 (unsigned) and provide one of the following: a U.S. birth certificate from the Department of Vital Statistics (not a certificate of birth) or naturalization papers. Applicants also must show either a valid driver's license, a previous or current U.S. Passport Book or Card, Certificate of Naturalization, Certificate of Citizenship, military I.D. or a federal, state or municipal government employee I.D. card. Applicants ages 15 and under must be present with both parents unless consent is given; ages 16 and 17 require only one parent be present.

The latter really addressed the significance of the meeting. This was General Manager Steve Erler's final board meeting. He retires as of June 30 and Victor Jimenez is the new general manager.

Before the meeting adjourned, the directors took turns complimenting Erler's career and wishing him well in the future.

"Steve is one of the few people who works as hard at his job as anything else," said President Jim Rees. "He is one honest and hard-working guy. I'm extremely jealous he's retiring earlier than me."

"I'm sad Steve is leaving, but happy Victor is here," added Director Robert Krieger. "We have a smooth transition worked out for the district."

In water business, Erler reported well production is less than 10 percent of total production and less this spring than in 2015. Strawberry and Tahquitz

GSOB continues northward spread

Around 130 oaks infested in Idyllwild

The Gold Spotted Oak Borer continues its invasive spread northward from San Diego County. It is now found in both Orange and Riverside counties, infesting and ultimately killing coast live oak and California black oak.

GSOB-infested firewood is suspected to be the transportation agent, since beetle flight could not account for the significant distance jumps from points of infestation in San Diego County to Riverside and Orange counties locations.

The beetle, which has already killed 100,000 oaks in San Diego County, first reached Idyllwild in 2012. It was discovered in one tree on Highway 243 in Idyllwild's downtown corridor. In the succeeding four years, GSOB spread has been gradual and relatively modest — to about 112 trees in Idyllwild and 15 on U.S. Forest Service land in the San Jacinto Ranger District. It reached Weir Canyon in Orange County in 2015 and currently infests more than 100 trees.

Bratcher credits the slower spread on the Hill to the fact that Idyllwild has a mixed forest of oaks and conifers, in contrast to San Diego County's concentrated oak woodlands. A varied forest acts to impede beetle flight, since oaks are not necessarily contiguous as they are in oak woodlands.

"In Idyllwild, GSOB spread has been gradual and in spurts," said Bratcher. "If GSOB could make the jump [from Idyllwild] into the oak woodlands in Banning and Beaumont, the results would be catastrophic."

Dr. Tom Scott, University of California, Riverside, adjunct professor, said statewide damage could be immense. "This may be the biggest oak-mortality event since the Pleistocene [12,000 years ago]," he said. "If we can keep firewood from moving out of the region, we may be able to stop one of the biggest invasive pests to reach California in a long time.

"Quarantines don't work," said Scott. "But enlightened self-interest could keep oak woodland residents from importing GSOB-infested firewood."

But, regardless of the severity of the threat and a public education campaign against importing firewood, GSOB now infests more than 100 trees in Idyllwild and in Orange County — in the Weir Canyon Nature Preserve on the Irvine Ranch, north of Tustin and south of Anaheim.

Damaged trees can be identified by crown thinning, smaller leaves of less robust color, bark staining on the main stem, and D-shaped exit holes on the main stem and larger branches of the tree. According to the University of California Integrated Pest Management Program, trees with excessive crown thinning and dieback, and more than 100 emergence holes on the lower trunk, are considered severely infested and will die.

Current best practice is to remove severely infested trees to prevent GSOB spread to contiguous oaks.

Idyllwild Water adopts 2016-17 budget

Lower expenses mean more capital investment

Last week, the Idyllwild Water District board adopted its fiscal year 2016-17 budget. The total budget (water and sewer programs) is expected to be \$1.7 million, which is about \$100,000 less than the current year. These amounts do not include capital program investments.

Revenues are estimated to be \$2.3 million (the combination of both programs) compared to \$2 million in the combined revenue budget for fiscal year 2015-16. However, actual revenue in the previous fiscal year was \$2.3 million, according to the district's audit.

"The district is in good financial shape based on your actions taken in previous years," General Manager Tom Lynch told the directors.

IWD's net operating margin would be about \$550,000. The capital improvement program, which is estimated to require \$800,000, will result in a combined net loss of about \$260,000 for fiscal year 2016-17

Capital investments are projected to be about \$3.3 million. But federal and state grants and loans reduce IWD's direct cost to about \$800,000. The largest project will be completing plans and designs for the recycled water facility and, possibly the beginning of its construction. This project will cost nearly \$2.1

million, all paid from grants and loans, according to Lynch.

At the urging of Director Steve Kunkle, the board added \$100,000 for new well drilling next year. Also, Lynch had budgeted \$225,000 for well rehabilitation to increase water supply.

The other major capital program is the planned pipeline replacement. Nearly a third of the total cost, \$455,000, comes from a county grant.

While the dedicated reserve funds will decline from \$650,000 to \$390,000, IWD will still have about \$2 million in other cash assets.

In water business, Lynch reported that the district is staying in Water Conservation Stage 2. Foster Lake remains empty, Lynch stated, and added that the groundwater level of several wells seems to be improving.

May's water production was 6.4 million gallons, which was 112,000 gallons more than last May. Since January, production is 200,000 gallons less than the first five months of 2015.

May water revenues were \$103,000, which is \$7,300 more than the estimated budget and \$12,000 more than May 2015, although production increased only 2 percent.

For the first 11 months of the fiscal year, production was 67.7 million gallons, which is about 10 percent less than the first 11 months of fiscal year 2014-15.

In other business, the district set July 20 as the date to hold a public hearing for its annual standby charges. These remain the same as last year, \$30 per acre on unimproved property.

A healthy mind in a healthy body

You are better off taking the stairs up to your next class, particularly if you are an older American out to improve your knowledge base and protect your brain, according to the Association of Mature American Citizens.

Canadian researchers found that "education and physical activity affect the difference between a physiological prediction of age and chronological age, and that people can actively do something to help their brains stay young." Their study has been published in the journal, Neurobiology of Aging.

Jason Steffener, the lead author of the report, said the focus of the study was the positive effects of low-impact exercise such as climbing stairs on brain health. "In comparison to many other forms of physical activity, taking the stairs is something older adults can and already do at least once a day, unlike vigorous forms of physical activity."

Idyllwild Water director and staff have communication glitch

During the directors' comments portion of the Idyllwild Water District's board meeting last week, Director Steven Kunkle began to discuss the difficultly he has encountered trying to get information about the district's wells.

Director John Cook, who was acting as president during the meeting, replied that it was unfair to ask a question of staff and expect a response by the next Monday.

However, Kunkle's initial request for a list of the district's wells - and for those that are operational and those not, including their output - was made on May 5,

nearly six weeks prior to the June 15 session.

Well output is used to calculate monthly production, but was not available to a director.

Although Foster Lake remains empty, water supply comes from wells. IWD can divert water into Foster Lake from Strawberry Creek but has not made a diversion for several years. However, Fern Valley Water District has found the creek's flow sufficient to divert water for its use. In May, wells supplied only 10 percent of the FVWD production.

In response to Kunkle's request, Lynch replied that "... we are short on staff, so this special request for detailed information will take some time to put together."

Prophylactic spray treatments can help prevent tree death on oaks that still appear healthy and where dieback evidence is less than 40 percent, according to latest research. "Spraying trees is not a one-time treatment," said Bratcher, "because trees will continue to have hot spots."

Bratcher noted, even with more than 100 trees identified as infested in Idyllwild, some landowners remain reluctant to permit inspection. "People are afraid Cal Fire will come out and remove their trees," he said. But failure to remove severely infested trees will result in further GSOB spread, said Bratcher.

The farther north one goes in California, the greater the risk of massive GSOB damage. Riverside and Orange counties have relatively modest acreage in oak woodlands — 72,000 acres in Riverside County and 40,000 in Orange County. By comparison, San Luis Obispo County has 724,000 acres of oak woodlands and Monterey County has 921,000. San Diego County, where the beetle was first identified, has 320,000 acres in oak.

Currently, no financial assistance is available for removing infested oaks but Bratcher said there could be some coming. If you need further information or suspect your oaks are infested, contact the GSOB hotline at 951-659-8328 to arrange inspection.

Fire danger closes seven county areas

On the recommendation of Cal Fire/Riverside County Deputy Fire Chief Glenn Patterson, the Board of Supervisors, at its June 21 meeting, approved the closure of seven potentially fire hazard areas.

The closures will remain in effect until further notice in the following areas:

- Avery Canyon (Gibbel Road east of State Street in Hemet)
 - Minto (Sage)
- North Mountain and Indian Canyon (San Jacinto area)
- Nuevo/Lakeview (east of Menifee Road and San Jacinto Avenue)
- Ramona Bowl and Bautista Canyon (southeast Hemet)
- Whitewater Canyon (Cabazon, north of Palm Springs)

Riverside County Ordinance 7787 requires the Board of Supervisors to approve any closure that exceeds more than 15 days. The county fire chief considers the threat of large and damaging fires, cued to the continuing drought conditions, to justify these closures.

Ordinance 787.6 restricts public access to these identified hazardous fire areas unless private property access is required. Public roadway travel is permitted, providing travel is confined to those surfaces within hazardous fire areas. Violation of the order could result in a minimum fine of \$100 for first-time offenses.



JP sends me food articles weekly, yet he always says I should write about whatever I choose. His choices of articles are often about somebody's grandmother's potato salad or pies. I think he likes pie. I know he likes beer. He's a carbo loader.

So I just returned from a weeklong camping trip to Mammoth and I sent him a few pictures of myself cooking pasta sauce over a propane burner, and another of a pizza I made in an RV.

So he suggested I write about cooking over an open fire. Neither of the photos I sent him had anything whatsoever to do with an open fire.

On top of that, I have no idea how to make a pie or potato salad over an open fire. I fear I am getting mixed signals. I imagine I may soon be fired from writing this column as criticizing the news editor has historically not been a good move on my part.

So, in an effort to get along smoothly with my colleague, I will offer some time-proven suggestions on how to get the most out of cooking on a campfire.

First of all, don't start a fire in your yard to try these things. Idyllwild has fire and barbecuing requirements. If you are not sure about how to proceed, by all means call the fire department for the regulations on outdoor cooking.

When I first moved to Pine Cove in 1993, I dug a hole outside my cabin to cook in. The next morning Capt. Martinez of Riverside County Fire Department and his large truck paid us a visit. He told me I was required to have a permit, a shovel and a hose at specific distances. Makes even more sense now that things are so dry. Just call'em. You're better safe than sorry.

Here are some favorite foods Kate and I agree are super easy to prepare when camping.

Corn on the cob is amazing when cooked on a fire. The preferred method is to peel off the husk and wrap the corn in a wet paper towel, then wrap in foil. Place along-side the embers and rotate every so often. The intense heat caramelizes the sugar in the corn and elevates the flavor to amazing heights. If you go too long and burn it, it won't be good.

A good ear of corn tastes great even when undercooked. Once again, trial and error is the way to go with corn. Pull one out after 10 to 15 minutes and have a peek. Sweet potatoes, yams and big ole regular potatoes also are fantastic cooked in an open fire. No paper towels are necessary with these babies.

Stab them here and there with a fork so they don't split too badly and wrap them in a couple of layers of foil. They will take longer than corn. At least a half hour or more. Put on a leather glove and give 'em the squeeze test. If they yield nicely, they are done.

Another favorite requires some preparation. Pick up some bamboo skewers and load them up with veggies — zucchini, onion, yellow squash, mushrooms or anything you like.

Brush them with oil and seasonings. Cook on foil on a grill top or grate until they start to soften. Then, if you

like that smoky grill taste, roll them onto the grill for a few minutes and turn often. Don't let them get black.

Cooking food on a grill until it is darkly charred is not healthful.

Another tip about the use of barbecue sauce needs emphasis. Whether it is meat, fish or vegetables, don't load the sauce on your food at the beginning. It will drip all over and make a mess of the grill. It will burn on the food and look awful.

Better to oil the food, cook until almost done, then brush on the sauce a couple of times and turn the food to get all sides. Again, avoid burning the food black; charcoal is not good for you.


If you are camping and have a long stick, spread the embers into two piles with an open space between them. Cook the food over the open space. This is called indirect cooking. It will prevent flare-ups. Keep a spray bottle of water nearby. This will prevent too much fire on the food

We all remember eating burnt hot dogs on the Fourth of July. Although festive in concept, a nice juicy burger or hot dog beats the heck out of charcoal shards cutting into your tongue!

Cooking, like life, is all about finesse ... and lot of practice.

The birth date of a family member may stick in your mind, but are you able to remember when you bought all the items in your refrigerator?

Every year, billions of pounds of food go to waste in the U.S. because consumers are not sure of its quality or safety. Last year, the U.S. Department of Agriculture launched the Food Keeper app to help combat this cause of waste. The FoodKeeper is available for Apple and Android devices and allows users to set up automatic notifications when foods and beverages are nearing the end of their recommended storage date.



Free composting workshop Saturday

The Riverside County Department of Waste Resources will host a free backyard composting workshop in Idyllwild on Saturday, June 25.

Attend this how-to workshop to learn how to recycle organic resources such as yard trimmings, and fruit and vegetable waste into a dark, crumbly, sweet-smelling soil conditioner. Compost can be used to enrich the soil in gardens, lawns and house plants. Instead of putting

organic waste in the garbage to be hauled to the landfill, learn to compost.

The workshop begins at 10 a.m. at Town Hall.

Composting is nature's way of recycling. It's a great way to turn waste into a beneficial soil amendment. In composting, organic material is mixed together in a pile or bin, where literally millions of tiny microbes digest the material and turn it into a nutrient-rich soil amendment.

Low-cost compost bins, subsidized by the department, also will be available for purchase by Riverside County residents (limit three per household). County residents can purchase compost bins by personal check or Visa/MasterCard (75-cent processing fee applies).



Year six for Santiago's Idyllwild Author Series

Five writers headline varied series

Author, teacher, "book coach" and Idyllwild resident Eduardo Santiago smiled and shook his head as he recounted how his popular series began. "When you look back, what is odd is that I started this series just two months after buying the house in Idyllwild," he said. He recalled starting without funding simply because he wanted to contribute to the town. "The beauty of this town is how many people stepped up to help."

Former local fire chief to oversee national program

Shawna Legarza, former fire chief for the San Bernardino National Forest, will be the next national director of Fire and Aviation Management for the U.S. Forest Service, Chief Tom Tidwell announced Friday, June 17.

Legarza, who serves as the regional director of Fire and Aviation in the Pacific Southwest Region, California, will take on the leadership role to help create resilient landscapes, fire-adapted communities, while putting safety and lives first in responding to wildland fire.

The Forest Service has managed wildland fire for more than 100 years. While fire is a natural process necessary for the maintenance of many ecosystems, in the past two decades, extreme wildfire behavior has escalated, accompanied by significant increases in risk to responders, citizens, homes and businesses, as well as suppression costs and threats to communities and ecosys-

"I have great confidence in the experience and professionalism Shawna brings into this vital role at the U.S. Forest Service," said Chief Tidwell. "Shawna's leadership within the wildland fire community and the relationships she developed throughout her career make her the best fit for the job."

From the SBNF, Legarza was appointed fire and aviation director of the Pacific Southwest Region (headquartered in Vallejo). Region 5 experiences one of the most active and severe wildland fire seasons in the country.

In her new role, Legarza will oversee the Forest Service's fire and aviation management, wildland fire operations, including hazardous fuel reduction, and will advance efforts to create a culture of safety and improved decision-making for wildland fire suppression.

In the release, Legarza was quoted as saying, "I am excited for this new opportunity and look forward to the challenges the Forest Service and fire management face today in light of the growing length and severity of our fire seasons. I am honored to represent the U.S. Forest Service and lead the best wildland firefighting organization in the world. Thank you to those folks that have contributed to my career and educational experiences; I am very thankful."

Legarza launched her federal career with the Bureau of Land Management in 1989 as an engine crew member in Elko, Nevada. A short time later, she joined the Forest Service and worked as a hotshot crew member in Carson City, Nevada, and a hotshot superintendent in Durango, Colorado. She subsequently took on a number of leadership positions in fire and aviation that include district fire management officer on the San Juan National Forest in Colorado before coming to the SBNF.

She has represented the Forest Service at the regional scale, serving on the California Governor's Task Force on Climate Change, the California Wildfire Coordinating Group and FIRESCOPE.

In addition to her fire experience, she worked at the World Trade Center 9/11 recovery efforts, Hurricane Rita and the Greensburg Tornado, with significant contribution to agency leadership curriculums in fire management.

Legarza earned a bachelor's and a master's degree in kinesiology at the University of Nevada, Las Vegas, and doctorate of psychology at the University of the Rockies, Colorado Springs, Colorado. She replaces Tom Harbour who retired in January after a 46-year career with the Forest Service.

Fire and Aviation Director Patty Grantham, forest supervisor on the Klamath National Forest, will replace Legarza in Region 5. Grantham has worked on six national forests across the West and holds a bachelor's degree in Forest Science from the University of Washing-

Steele in top-15 at U.S. Open

Brendan Steele posted a fine 5-overpar 71-71-70-71 - 285 to earn a share of 15th place in this year's U.S. Open, played on the very tough Oakmont Country Club course in Oakmont, Pennsylvania. This was his third career top-20 in a major tournament. It was also his second-consecutive top-15 in a major, along with his 12th place finish in last year's PGA Championship.

At Oakmont, more than 58.9 percent of the native Idyllwilder's drives found fairways, with his longest drive measuring 327 yards. He hit exactly two-thirds of the greens in regulation and required 1.875 putts per green. Throughout his sixth season on the PGA Tour, Brendan has gained ground on the field with his play from tee to green and has given a bit of it back in his short-game play and put-

He now ranks 50th on the PGA Tour in the FedExCup standings with 648 points, and has climbed to no. 75 in the Official World Golf Ranking.

Brendan will play again this week in the \$6.9 million Quicken Loans National on the Congressional Country Club Blue course in Bethesda, Maryland. Todd Carpenter finishes first in under 50 in Race Across the West

Finished 16 hours ahead of his personal goal

Idyllwild Arts Technical Director and Theatre faculty member Todd Carpenter had said prior to beginning the 860-mile Race Across the West that his goal was to finish. He did considerably better than that, finishing first in the solo (not team) under-50 age division and second overall.

Thirty-two racers competed in the RAW solo category from Oceanside to Durango, Colorado. They left Tuesday, June 14. Todd crossed the finish line two days, 14 hours and 9 minutes later at 5:31 a.m. Friday June 17.

His goal was to complete the endurance race in 80 hours. He finished in slightly more than 62, 16 hours ahead of his personal goal and logging 928 miles in the process. "He finished so far ahead of his planned schedule that we arrived too early to get into the house we had rented," said Bonnie Carpenter, Todd's wife and crew chief. Luckily, another of his crew, former Idyllwild Arts student and current Durango resident Eric Bulrice, found temporary accommodations for them.

Bonnie credited Todd's fast uphill climbs as likely reasons for his early finish. "He was great on the eleva- er.com.

tion," said Bonnie. "He just blew past the others on the uphill inclines."


Todd also managed to beat his goal of continuous riding of 36 hours from the start of the race before stopping for sleep. He logged 39 hours of riding before stopping for an hour and 15 minutes of sleep. Any sleep time is counted as part of the overall race time. The clock runs continuously from start of the race until finish, much like a time trial.

Bonnie said her crew, including Idyllwild Arts Theatre Chair J. Barrett Cooper, functioned perfectly together. She recounted the many times the crew in one of the following vehicles came abreast of Todd and handed him water and food. "This was the first time he ate fast food as part of a race," said Bonnie. "It was a pretty textbook race for the crew. We just had to keep focused and remember how long the race was."

This is the first endurance cycling event Team Carpenter has attempted in three-and-a-half years. Although a textbook race from the standpoint of the crew, for Todd it was an amazing finish and a victory to savor.

Bonnie has managed all but one of Todd's endurance races. The very specific race rules required constant adherence to avoid elimination for any infraction. Bonnie's forte is organization and planning, and the result — strong rider and strong crew — was a united effort. Bill to end Daylight Saving Time takes step forward

Last week, a state Assembly committee passed Assembly Bill 385, which would allow state voters to decide whether to retain Daylight Saving Time.

The Senate Committee on Energy, Utilities and Communications voted 9-2 to send the bill to its Appropriations Committee.

If enacted and if voters rescind Daylight Saving Time, California will be the third state to choose to decline observation of the time change.

"Daylight Saving Time is an institution that has been in place largely without question for more than half a century," Assemblymember Kansen Chu (D-San Jose), the bill's author, said in press release. "I think we owe it to the general public to be given the opportunity to decide for themselves whether or not it ought to be continued."

Chu argues, "In addition to the lack of dramatic energy savings, there are also several public health issues that arise out of DST. For example, the number of recorded heart attacks, industrial and workplace injuries, and traffic accidents and fatalities also increase in the days following the time change."

In 1949, 55 percent of the state's voters approved Proposition 12, which established Daylight Saving Time in California from the last Sunday in April until the last Sunday in September.

According to the committee's report, The California Energy Commission researched DST and published a paper in 2007 that examined whether and how much the Policy Act of 2005 changed daily electricity. The extension of DST to March 2007 had little or no effect on energy consumption in California, according to a statistical analysis. The most likely approximation is a 0.2-percent decrease during these three weeks.

The intended benefits, besides energy savings, created from the later daylight in the evening from Daylight Saving Time was to provide a boost to tourism and shopping industries, the report stat-

months to get this far. "It's amazing that government can get things done in this time," said Mayor Pro Tem Scott Miller.

But midway through the meeting, San Jacinto Mayor Andrew Kotyuk, who participated in the meeting via teleconference from Las Vegas, said he had just received an email confirmation that dispatch service would be provided.

"These pieces are in place. We went after a lot of resources that could not handle the capability, but one entity does want to partner with us," he announced. "My feeling is we've accomplished what we wanted to accomplish."

However, Assistant City Attorney Mike Maurer reviewed the message and had a different reaction. He said the dispatcher was a private company without state approval, no costs were identified and no proposed contract had been presented for review.

Consequently, the council unanimously (5-0) accepted Hults recommendation to extend the contract and RCFD agreed to implement a pilot project, called Quick Attack, to serve the city's western communities. The proposed contract was approved 4-1 by the Riverside County Board of Supervisors at its Tuesday, June 21, meeting. The estimated cost for staffing Station 25 (downtown) is about \$2.2 million. The Quick Attack pilot will cost another \$1.2 million.

The lack of emergency service, particularly medical service, was a principal reason the council sought an alternative to replace the RCFD contract and developed the idea of a JPA with Idyllwild.

The Quick Attack program will be composed of a Type 6 engine capable of carrying 250 gallons of water and staffed with two medics at all times.

All the JPA key officials, including Miller, Hults and Idyllwild Fire Chief Patrick Reitz, indicated that the next 12 months would be devoted to preparing the JPA to be ready to deliver fire service to San Jacinto on July 1,

After the meeting, Reitz stated, "The JPA remains in discussions with several [dispatch] providers.'

'My expectation would be to continue to go forward to close the gaps and be ready for July 1, 2017," Miller said after the meeting.

When asked if the JPA might contact any other communities during the next year, Reitz added, We will be following up with those communities that have asked questions, requested more information and have expressed an interest in the concept of the JPA." Earlier, Miller had indicated that cities such as Canyon Lake, Moreno Valley and others might be interested in joining in the Idyllwild San Jacinto Regional Fire Authority.

total of about \$1 million. This will enable the IFPD to have its full complement of nine firefighting staff and a battalion chief in addition to the fire chief. The budget implements the new memorandum of understanding with the Idyllwild Career Firefighters Association, which provides a 2.3-percent salary increase in 2016-17.

A larger increase of

about \$110,000 is for benefits. About 90 percent is for Cal Pers, and the balance for health and welfare benefits. Costs for Other Post Employment Benefits declines almost 50 percent to \$25,000 due to reductions in the Cal Pers medical insurance rates, according to Battalion Chief Mark

The committee expects legal costs to drop substantially next year. Through April, IFPD has

legal support. Next year, the committee has budgeted slightly more than half that amount — \$82,000.

The proposed budget does not include any revenue from services to the recently formed Idyllwild Jacinto Regional Fire Authority. Although the City Council of San Jacinto has extended for one year its fire and emergency services contract with the Riverside County Fire Department, work on spent nearly \$150,000 for the project has incurred

expenses and Reitz has said this information will be presented to the commission.

While the new budget includes \$4,000 to pay the expenses of putting a unit or parcel fee increase on the November ballot, the committee has not included any more revenues in the budget in anticipation of its approval.

Also, the budget does not include any major capital project investments. "We couldn't go for it now

because of the budget," Reitz said.

In other business, the committee decided not to change the time of its regular meeting, the second Wednesday of each month. In July, IFPD will implement its recently approved procedures for the committee, which include appointing a community member as committee chair.

Commissioner Nancy Layton has served as chair since the committee's inception in 2013. Howev-

er, a poll of the committee members revealed that Mark Lonsbury and Susan Weisbart do not plan to continue and Calvin Gogerty wants only a onevear term.

Layton was hopeful she could recruit two new members who could be appointed when the commission convenes on June 28, the day of its next meeting.
