## Small-town America at its best, most inclusive

Our country was founded with bravery and later steadied by a Constitution and Bill of Rights. Men who signed our Declaration of Independence were labeled traitors by the British and would have been executed had we not prevailed. But in the face of the challenges, they remained resolute in their mission to guarantee freedom to the citizens of this new nation.

Two-hundred-and-forty years later, America celebrates its hard-won freedom and honors its founders and the principals they fought to enshrine. And in Idyllwild, the capstone of the celebration is an iconic small-town, charmingly innocent Fourth of July Parade sponsored by the Idyllwild Rotary. This is the 15th year the Rotary parade moves down North Circle Drive from Fern Valley Corners, starting promptly at 10 a.m. Immediately after the parade, the Rotary will host an in-town Family Freedom Festival on the Idyllwild Community Center site with food, entertainment and events for young and old.

Although fireworks are illegal in greater Idyllwild and the surrounding forest, the Soboba Casino will be hosting a fireworks spectacular that could be visible from many areas in Idyllwild such as Inspiration Point and parts of Pine Cove. The show begins at 9 p.m. Sunday, July 3. Fireworks of any kind, including sparklers, are illegal because of fire danger. They are not sold in any Idyllwild locations and must not be imported and used. Anyone caught with illegal fireworks will be subject to fines, citation and/or arrest; including confiscation of all illegal fireworks, according to the Riverside County Sheriff's Department.

On Saturday, July 2, Idyllwild's American Legion Post 800 hosts a Fourth of July barbecue from 3 to 7 p.m. and dance at the post, featuring the music of Mark Huston and the Workin' Men from 6 to 10 p.m.

Normally held the weekend of July 4, the Idyllwild

## Open fires, barbecues prohibited

With the Fourth of July weekend upon us, Idyllwild Fire Protection District reminds us that wood or charcoal open fires or barbecues are not permitted anywhere in the IFPD district. Electric or propane gas grills are approved, but a no-charge permit must first be obtained from IFPD. The permit allows electric or propane gas grilling between the hours of 10 a.m. and 9 p.m., but no charcoal, wood or other burnable material is permitted.

Application materials explain further safety requirements, including positioning the electric or propane grill on a fire-proof platform, 5 feet away from the nearest combustible material and 10 feet from any structure. A properly working garden hose or fire extinguisher must be within 10 feet of the electric or propane grill, and the whole premises is subject to inspection

by IFPD, which may cause a citation to be issued for problem offenders.

Pick up an application for an electric or propane grill permit at the Idyllwild Fire Station or at IFPD's website, and submit the application to the fire station.

Outside Idyllwild's fire district, Cal Fire Pine Cove Station 23 relates that there is no prohibition against charcoal or wood barbecuing in grills designed for those purposes, nor are campfires prohibited "within organized campgrounds or on private property" but only if a no-charge permit is first obtained and the campfire is maintained in a manner that will prevent its spread to wildlands. A campfire permit can be obtained at local Cal Fire stations or online at PreventWildfireCA.org.

However, Cal Fire reminds us that burning landscape debris, including tumbleweeds, by homeowners is not permitted in Riverside County and no permits for such burning are being issued.

# One rear-ended collision on Highway 243

Only one traffic incident took place on Hill roads during the last week. At 12:10 p.m. Friday, June 24, Paul Student, 68, of Moreno Valley, was driving his 2003 white Ford Ranger southbound on Highway 243, 2,000 feet south of Mt. Edna Road.

According to the California Highway Patrol report, Student was traveling too fast at the time of the incident. Ahead of Student's vehicle, and not in sight around a bend in the road, Jose Figueroa, 34, of North Shore, had halted his 2007 white Honda Accord because of an obstruction in the road — a broken-down truck that had been towing a trailer.

Student rounded the curve at too great a speed and collided with the rear of Figueroa's vehicle. There were no injuries and no other vehicle was involved in the incident.

A responding CHP officer verified that traffic had been halted because of the obstruction blocking the lane and that Student was at fault.

# Dirt bikers aid in rescue of hiker on remote trail

Around 11 a.m. Saturday, June 25, three dirt-bike riders came upon a man collapsed on a trail in the area of Forest Route 5S15 south of Highway 74 in Mountain Center.

The three riders alerted 911 and Riverside County Sheriff's Helicopter Star9 located the riders, and the man who was suffering from disorientation and dehydration.

The helicopter crew dropped water to the bystanders and patient. The three riders used the water to cool the man until paramedics made their way to the patient's location.

Reports described the man as having an altered level of consciousness. He was initially transported to the U.S. Forest Service's Cranston station and then to an area hospital.

As of this writing, his condition is unknown.

# County sells former library building on Pine Crest

## Supervisors seek funds for Town Hall facility

The former Idyllwild Library site on Pine Crest Avenue has been sold. Riverside County, which owned the building and shares the site with the Idyllwild Health Center, approved the sale for \$210,000 at the June 21 Board of Supervisors meeting.

According to the information from Rob Fields, assistant county executive for economic development, Ivon Dahl is buying the property and will install a pilates, fitness class and studio facility.

At the board meeting, 3rd District Supervisor Chuck Washington suggested ... "[the county] consid-

er utilizing the proceeds [estimated to be \$150,000] from the sale in the Idyllwild community."

Town Hall was Washington's concern. He told his colleagues, "I've had a lot of requests from the community and residents of the county about negotiating with the property owner to put money into the old Town Hall facility to upgrade the property so it can be used for cultural benefits."

Fields replied that existing policies allocate these proceeds to a different account.

But after learning of Washington's priorities, Fields' staff talked with the supervisor's staff. Field said the Economic Development Agency "... has identified other eligible sources of funds that can accomplish what your intentions are."

Washington's principal target is to do some work on the outside of Town Hall, such as the stage area, according to his Chief of Staff Verne Lauritzen.

Glad that some funding can be earmarked for

work at Town Hall, Washington moved to approved the sale, which the board unanimously supported.

The building had been on the market for two years.


## Re: Ms. Stearns' June 16 letter and Ms. Finch's June 23 response ...

## Parades can traumatize dogs

I'm sending this as a PSA for both resident and visiting dog owners: Please consider your pet's best interest when deciding whether to attend the 4th of July Parade in Idyllwild together. It's a wonderful event that we've enjoyed over many years, but in thinking like a dog and speaking just for myself, it's not a great place for the pooches.

I won't say that no dog likes a parade, but what's fun for people is often scary, confusing and damaging to dogs — the extremely high noise level (sirens, car-horn blasts, wild screams of delight), the chaos of a crowd and hot asphalt on tender feet are not the stuff of most doggie dreams.

In past years I've witnessed much abuse by owners who didn't notice or didn't care about the effects of the scenario I've described. I've seen overheated, over-stimulated dogs who couldn't explain their unhappiness at being dragged around the town for the amusement of others. A dog's panting may indicate more than thirst, by the way — it also can be a sign of great stress.

I've also seen a few dogs who seemed to love the excitement, the attention and the novelty of dressing up as Uncle Sam, but in my experience, these are the exceptions. I hope owners will heed this warning, but if they do choose to bring along their dog, frequent shade breaks in a secluded area, with plenty of drinking water, could make the difference between a happy day and a miserable one. Just ask yourself, "Am I my dog's best friend?" and act accordingly.

## ANOTHER POINT OF VIEW

### We are not being represented

EDITOR:

There are many reasons we all choose to live in Idyllwild. Perhaps the best reason of all is the sense of community and family we share. Lately, the Idyllwild Water District is challenging that caring attitude.

We realize there is a group of citizens who feel that as long as they get their water, everyone else doesn't matter. Those who have been paying taxes and standby fees for very long or short times on vacant parcels have seen their investment reduced drastically by a district that has no formal engineering studies to substantiate its claim we haven't enough water.

Most Idyllwild people we know feel we are all in this California drought together. Whether it is a stage 2, 3 or 10, we will get through it together. While the laws may allow owners to irrigate non-native lawns and gardens, other property owners can't get a meter to allow their investment to again realize full value. Currently, another speed bump to giving owners a meter is requiring approved county building plans.

Many owners never build even if they have a meter. However, their investment may be a primary source of their personal nest egg. Whether they choose to build, to sell or to leave it to their children, they shouldn't be deprived of the right to realize their parcel's full value.

IWD has a manager who makes over \$100,000 a year. A financial officer, that none of the other districts here have, makes a tidy sum. The board members make \$100 per public and other meetings. That's \$500 per get-together that citizens are paying. Other districts get \$50 per meeting.

Further, at this moment, IWD is not actively pursuing seeking more water it claims we haven't enough of. Instead, IWD just approved buying an expensive new backhoe.

When asked how many hours a year they use a backhoe, the general manager couldn't give a straight answer. Said it varies. We already have two that can be repaired. We can rent a newer one on an as-needed basis and use the savings to improve existing wells, and seek and drill new ones.

After Steve Kunkle, a previous IWD employee, was elected to the board by a landslide, he is now running into nonstop resistance to his inquiries regarding district matters. There are two new board members out of five and the votes are generally 3-2 against the new members "we the people" elected. He has recently been uninvited to closed meetings. They will not explain why.


We are a family and we have a district that is bullying the town by acting as a greater force than what was intended. It is time we replaced the rest of the board and the administration if they cannot realize what their role is.

No one is God and can tell when the drought will end. Yet we have done an amazing job of conserving our resources and when queried, the district doesn't seem to know our capacity, only what they sell.

They have essentially put the new homebuilders on a path of going out of business. They are obstructing our new community center.

They are out of line. Most in the know believe we have adequate reserves. Further, if there were to come a time to conserve even more, we would do it as a family, as a community, not at the hands of a tyrannical board who haven't the expertise nor information to back up its antics.

When a petition comes around, ask yourself how

## Plague detected in squirrels at two campgrounds

The Riverside County Department of Public Health reported that ground squirrels from Dark Canyon and Marion Mountain campgrounds tested antibody-positive this month for plague, according to state and local health officials.

The tests on squirrels from the two campgrounds were conducted on June 8 and June 13, respectively. The antibody-positive test means the squirrels had been exposed to the disease sometime in the past.

Follow-up rodent surveillance and an environmental assessment of the two campgrounds will be conducted this week. Risk to the public is currently considered to be low and campgrounds will remain open during follow-up investigations.

The California Department of Public Health notified the County Environmental Health, Vector Control Program, about the positive blood tests. Riverside County Vector Control routinely samples wild rodents in mountain recreational areas during the summer months for the presence of plague antibodies. The U.S. Forest Service district rangers and safety officer also have been notified.

Plague is a rare bacterial disease in rodents that can be transmitted through the bite of infected rodent fleas. The disease has been detected in ground squirrels, chipmunks and other wild rodents throughout many mountain regions in Southern California. The last positive plague samples in the San Jacinto Mountain Range were in 2012 and 2002. All campgrounds are continuously posted to remind campers that plague has been found in the area in the past.

Since the plague is typically spread by the bite of infected rodent fleas, visitors and campers should

# Supervisors approve fire contract with San Jacinto city

## Joint Fire Authority with Idyllwild less popular

The Riverside County Board of Supervisors approved the fire services contract between the county's fire department and the city of San Jacinto. For one year, the contract cost is \$3.4 million, which includes a "quick attack" squad at the city's western side.

Although the proposal passed 4-1, besides 5th District Supervisor Marion Ashley's negative vote, several other supervisors were

unhappy with the compromise but reluctantly supported county Fire Chief John Hawkins' efforts.

"We're in a very tough spot here," lamented 3rd District Supervisor Chuck Washington. "We're struggling to find some sort of resolution that does not compromise safety of our firefighters nor the residents of one of four cities within my district."

The controversial piece of the contract was the "Quick Response Vehicle" pilot project. This is a Type 6 engine

with a pump and 250-gallon water tank, manned by two paramedics. While the supervisors had little difficulty with a two-person medic squad, the idea that a fire engine could be less than the three-person minimal staffing, which the board adopted nearly four years ago, posed a political problem.

Several contract cities have been objecting to rising costs of their contracts with the county. One way to reduce costs is to reduce engine staffing from "3-0 to 2-0."

"You've got to understand the position it puts me in and your department with the city of Canyon Lake and the city of Calimesa," 1st District Supervisor

Kevin Jeffries said. "We've held a very firm line about three-person fire engines — period. End of discussion."

He preferred to refer to the unit as a medic squad "... and don't try to fool anyone that it's a fire engine. It's my golf cart with a pump on it and tank of water."

Hawkins firmly stressed to the board that the "quick attack" squad was a pilot test and not a policy change. "I unequivocally say this is a pilot study and will not be extended to any other community."

Washington stressed that he would support the proposal only if it were a trial pilot "and does not imply it will be utilized anywhere else in county."

Nevertheless, Ashley could not support it. "It still gives me heart burn. I'll be a lone vote against this. I just don't like the direction this is taking."

Chair John Benoit encouraged the proposal saying, "If we don't have some flexibility of this nature, we'll see more and more defects [from county contracts for public safety]."

So the compromise pilot test was preferred to the alternative that San Jacinto was developing with the Idyllwild Fire Protection District. The Joint Powers Authority posed an even bigger public safety problem in the minds of several of the supervisors.

In describing the ef-

orts to initiate operation of the Idyllwild San Jacinto Regional Fire Authority, Washington said, "... they quite honestly were not prepared to provide all the services that come with a professional fire protection entity."

Later in the meeting during the public comment period, Nancy Layton, an IFFD commissioner, spoke to the board. Grateful for the opportunity, Layton was direct in her comments about Cal Fire: "The JPA is not going away, but what has been done here by the unions and Cal Fire, I have two words — appalled and disgusted."

## Gutierrez's trial conference set for July

### DA wants to know who his witnesses may be

At the June 24 information arraignment for Frank Gutierrez, 66, of Idyllwild, who was arrested in July 2015, a July 25 trial readiness conference was set with a possible jury trial to begin Aug. 8.

Supervising District Attorney Deborah Lucky filed a paper elaborating on the charge against Gutierrez. In the document, she said, "... unlawfully receive[d] certain property, to wit, RIFLES [sic], which said property had been obtained by theft, knowing said property had been so obtained, and did conceal and withhold and aid in concealing and withholding said property ..." This charge is a felony.

The DA's Office also submitted a request to discover what witnesses the defense intends to call, and reports or expert statements made in connection with the case.

At a preliminary hearing on June 10, the DA's Office amended two charges — possession of a controlled substance and possession of more than 28.5 grams of marijuana — reducing them to misdemeanors and dropped two enhancements, which alleged prior felony convictions.

Gutierrez was arrested when Riverside City police, in cooperation with the Riverside County Sheriff's Department, arrested Lisa Marie Brown of Riverside for hit and run, vehicular manslaughter and possession for sales of methamphetamine. The arrests were made in Idyllwild.

Gutierrez was originally arrested for various drug-related felonies and possession of stolen firearms. His arrest appeared to be a byproduct of Brown's arrest, who later pleaded guilty and was sentenced to six years in state prison.

When his initial hearing was scheduled in September, Gutierrez failed to appear. In February, an agent for Aladdin Bail Bonds of Carlsbad, his bail bond firm, found, apprehended and turned him into the sheriff's department.

He remains in custody with bond set at \$200,000.

## Brian Tisdale, Lake Elsinore mayor, arrested and released on bail

Monday afternoon, June 20, Brian Tisdale, mayor of Lake Elsinore and a member of 3rd District Supervisor Chuck Washington's staff, was arrested on two misdemeanor charges — vandalism and battery on a former companion.

On Tuesday, Washington's office issued the following statement, "On Monday afternoon (6/20) I initiated action to place my staff member, Brian Tisdale, on administrative leave as a result of his arrest by Riverside County Sheriff's deputies for an incident occurring early Monday morning. This matter will now be handled by the justice system and the county Human Resources Department."

After being booked at the County's Southwest Detention Center, Tisdale, 53, was released on \$5,000 bail. The next court date will be Aug. 15.

Tisdale was elected to the Lake Elsinore City Council in 2010 and re-elected in 2014. His term expires in 2018.

As a member of the supervisor's staff, Tisdale worked on public safety issues.

Tisdale is a former Marine and worked in the county's Public Health Department.

## Pinyon homicide arraignments postponed again

Twice, arraignments for Robert Pape, 28, and Cristin Smith, 27, have been re-scheduled. The latest arraignment was for June 21 and a new time for the arraignment is now Tuesday, July 5.

Both men have been arrested for the 2006 triple murders of Jon Hayward, Vicki Friedli and Vicki's daughter, Becky Friedli, that occurred in Pinyon Pines. They had been arrested for the triple murder in March 2014, but nearly seven months later the District Attorney's Office dismissed all the charges against Pape and Smith.

In obtaining a warrant for their re-arrests, new information was revealed. One of the major items was the retesting of DNA found at the scene, which matches Smith's. According to the Riverside County Sheriff's Department, the chances of the DNA being misidentified is 1 in 28 trillion chances.

"Smith denied ever being present or near the scene of the murders," said Lester Harvey, an investigator with the Sheriff's Department, in a statement seeking a warrant to arrest both men.

In addition, a better forensic analysis of cell-tower data places Smith and Pape together on Monterey Avenue, which becomes Highway 74 to Pinyon Pines, before the murders. This contradicts their earlier statement that they had never left the Cathedral City area.

And a confidential informant has been identified who alleges Smith admitted to being involved in the arson and saying "Something went wrong and we torched the whole ---ing place."

On the night of Sept. 17, 2006, Becky, 18, her mother Vicki, 53, and Vicki's boyfriend Hayward, 55, were found dead at their Pinyon home. Becky's body was found burning in a wheelbarrow outside the house. The other bodies were found inside the burning home.

Pape was Becky's former boyfriend.

Both Pape and Smith are in custody without bail.

# Supervisors hear department heads

## Revenues trailing budget requests

The Riverside County Board of Supervisors spent more than a day listening to department heads discuss their needs for the 2016-17 budget, which begins Friday, July 1.

County Executive Jay Orr has recommended that the board approve a tentative budget and then make final decisions at its July 26 session.

For several months, Orr and Paul McDonnell, the county's chief finance officer, have been advising the board that projected revenues and budget requests are misaligned. They have urged the board to limit any budget increases because reserves will be needed to balance the budget.

As the county began to formulate the 2016-17 budget, agency requests were about \$130 million more than the current-year (2015-16) budget. In an effort to protect the county's finances, Orr has urged the board to keep funding level with this year, including for public-safety agencies.

Nevertheless, he organized the workshop for Monday, June 20, so that agency heads could make a case for more funding.

Opening the workshop, McDonnell told the board that revenue and spending recovery may be a couple of years in the future. Fiscal year 2017-18 would be the low point and reserves could fall, depending upon how much new spending is approved, to about \$115

million compared to more than \$200 million currently. "Going forward, unless we see a dramatic growth in revenue, which no one is expecting at this point, we're still going to maintain spending at this level in order to re-build reserves and reach a structural balance," McDonnell recommended.

Supervisor Marion Ashley (5th District) is concerned for the county's ability to provide services if an economic disruption occurred and reserves were too low. He had previously objected to reducing reserves below \$200 million, but last week, Ashley recommended an alternative policy.

"I'm willing to come off my previous position of maintaining reserves at 25 percent of general-fund revenues, which is in the range of \$187 to \$200 million, provided reserves are maintained at \$150 million or more," he said at the beginning of the workshop. "And [I want] a budget plan put in place that would replenish the reserves back to the policy level within five years."

Later, Supervisor Kevin Jeffries (1st District) expressed his concerns that the county would be able to hold spending levels for the time necessary to restore the reserves.

Both he and Ashley encouraged Orr and McDonnell to change the county's budgeting process. "We need to strike out on a new course," Ashley recommended. "The new goal should be a metric-driven system relying on performance measures in budgeting."

While the supervisors and the county's Executive Office focused on limiting spending and enduring several very tight budgets going forward, President John Benoit pointed out the county's full-time staffing level has increased from 18,000 to 22,840 currently. "Wow, that's huge," he commented.

During the presentations, Sheriff Stan Sniff emphasized to the board that nearly 90 percent of the department's \$700-million budget, half of which is county funds, is for salaries and benefits, including the county overhead charges. "The sheriff has control of about 10 percent of the budget," he said.

His budget proposal specifically excluded any costs for staffing for the East County Detention Center being built in Indio and to be completed next year.

"I don't need a decision in this budget, but the ECDC will be ready sometime in 2018," he advised the board.

He also recommended the board re-consider its decision to freeze hiring, which would limit the ratio of deputies per 1,000 residents in the unincorporated areas to 1.04.



# Hawaii's poet laureate opens Idyllwild Arts Native American Festival

The Idyllwild Arts Native American Festival Week starts at 6:30 p.m. Sunday, July 3, in the IAF Theatre on the Idyllwild Arts campus and runs through Saturday, July 9. The featured program for Sunday evening is Hawaii's first poet laureate and champion Slam Poet Kealoha performing "The Story of Everything." This multimedia stage show opened to raves in Honolulu last September and is a six-part creation story in epic-poem format that traces our origins from the Big Bang, stars, evolution of life and migration to Africa. The final part looks scientifically into the future of global climate change. That's right, 13.7 billion years told in 90 minutes using science, poetry, storytelling, visual art, music, chant and dancing.

Others in the cast are dancers Jamie Nakama and Jonathan Sybert, ukulele virtuoso Taimane Gardner and chants (Oli) by Kauai Kanaka'ole. When asked Kealoha's goal for the audience he replied, "Not to be scared of science and go deeper into how we truly got here."

According to Heather Companiott, director of the IA Adult Center and the Native American Arts Program, "Having Kealoha perform fits nicely with this year's Native American Festival theme, 'ART-ificial Borders.' Artists, scholars and tribal community members will look at actual, perceived, metaphorical, geographical and intellectual borders, and share their perspectives through art or social activism, locally, regionally and globally."

Kealoha, whose name means Love in Hawaiian, draws from his diverse background for all his work. "My performances incorporate all I have learned in life — hula, break dancing — everything all poured into a piece. Visual art is so important because every-

one learns differently so I use many approaches."

As a young boy of mixed ethnicity — Chinese, Hawaiian and Caucasian — he looks back on his childhood fondly. "My parents gave me a well-rounded approach to life." He enjoyed sports and school, never letting on he was that smart (he called himself a closet nerd) until he achieved a perfect score of 800 on his SAT math test and was accepted to MIT, the top engineering school in the country.

His life changed radically in Massachusetts where he studied applied Nuclear Physics and graduated in 1999 in Nuclear Engineering. "Going to MIT was like drinking from a fire hose. There was so much academics and science, and late-night discussions with super-bright friends who were interested in investigating the same things I was." While studying Fusion Energy he became aware of the political fund-

ing issues surrounding global climate change. "In 1998, scientists talked about global climate change. This was known for at least 10 years previously. Now, almost 20 years later it's being addressed."

After graduation, Kealoha worked as a consultant to many large companies in San Francisco. "My time was wasted on rich companies getting richer. I realized our time on Earth is limited and we spend many of our waking hours working. I wanted to help build a community or society which does not exploit people. I wanted to stand up for something so I derailed off the track."

While still in the Bay Area, he read about and attended Slam Poetry sessions. "My life changed 180 degrees." Slam Poetry's mission is to promote performance and creation of poetry while cultivating literary activities and spoken-word events, including audience participation, stimulate creativity, awaken minds, inspire and engage. "We

meet, discuss ideas, then build performances that are highly crafted."

He went home to Oahu to reflect on his goal, making a difference in the lives of people and their connections to the universe. Along with surfing and eating mangoes, he began to write down his ideas and act them out. He started a Hawaiian Slam Poet movement that grew to 600 people. "It was natural for Hawaii to embrace Slam Poetry because its history is based on oral traditions and storytelling." He entered National Poetry Slams in Chicago where he consistently ranks in the top 10 from around the country. Kealoha's poetic, storytelling style combines analysis with creative writing to investigate social, personal and philosophical themes for the 21st century.

The governor of Hawaii asked Kealoha to be the

# Art Alliance meets to amend bylaws

In a short meeting, on Sunday, June 26, five board members of the Art Alliance of Idyllwild and 12 members met to revise current bylaws.

first poet laureate of Hawaii in 2012 after he performed at the governor's inauguration. His duties are to write poems for governmental occasions and to visit other states. He has performed throughout the world, including the White House, and is part of the movement of indigenous people getting recognized or coming into their own.

Kealoha summed up the interview by saying, "The job of artists is to translate thoughts and put them in a way that expresses ideas in speech or artwork that allows individuals to perceive these ideas based on their own experiences."

# Santiago's Idyllwild Author Series opens with Nana-Ama Danquah

Author, editor, journalist and public speaker Nana-Ama Danquah opens Eduardo Santiago's Idyllwild Author Series on Sunday, July 10. This is year six for Santiago's popular series, held at 4 p.m. Sunday, for five weeks, on the deck of Café Aroma.

Danquah is a compelling choice to open the series. Born in Ghana, she immigrated to the United States with her family when she was 6. She arrived with an accent and a cultural heritage very different from those found in the Maryland area north of the District of Columbia where her family settled.

"On one side was America, on the other was Ghana," she wrote in a 1998 article, "Life as an Alien." "And I didn't know how to bring them together, how to make one make sense to, let alone in, the other. Why do you talk like that? Where are you from? Is that string in your hair? Newness is easy to detect, especially with immigrants."

It was that societal disconnect, the need to fit in by adopting multiple situational personas, that caused Danquah to fall into years of depression. Finding her way and finding herself was painful. She was black and yet not a black American. She was exotic and an African. Whether with her young black or Hispanic American friends, she was always adjusting, adopting the cadences and lilt of their speech, to modify and redefine her own.

Her memoir, "Willow Weep for Me: A Black Woman's Journey Through Depression" (One World/Galantine, 1999) is the story of her journey through depression and cultural disorientation to her emergence and embrace of the sum of all her parts. It is a story of healing that the Washington Post called "absorbing and inspirational" and former U.S. Surgeon General David Satcher called "a tremendous gift to all of us and to our understanding of depression and its pervasiveness throughout our society."

Asked in interview whether her depression was linked to her early cultural disorientation as an immigrant, Danquah answered, "They are absolutely linked. It is the isolation of not being understood. And yet the more I assimilated the less I was understood. I was both people [Ghanaian and American] with this weird cognitive dissonance that comes from leaving a part of yourself behind." It was not just the accent, she explained. It was the very different cultural norms. "Back then in Ghanaian culture, there was no 'me, me, me' as there was in the U.S. And one was not allowed to speak to elders in certain ways. For most immigrants there is a dance, a negotiation always trying to fit in."

Danquah is the editor of three anthologies, and her articles and commentaries have been published in media outlets ranging from the Wall Street Journal, the Washington Post, the Africa Report, Allure to Essence.

In discussing how American language has devolved in abbreviations and twittered briefs, Danquah shared how she approaches her writing day. "I write personal letters every morning, writing with the personal knowledge that the recipient will not necessarily write you back." She explained that writing in such a personal fashion to someone she knows helps free her to write her own books, not worrying if someone will buy the book and read it. "Writing the letters moves me further into language and wanting to tell a story. I think of my readers as listeners."

Danquah said one Portuguese word, "saudade," captures what it is to be an immigrant — a feeling of longing, melancholy and nostalgia which for her was a life-long journey of trying to be whole when there was a part of her that was absent. "When I was young, there was a space for blonde Jennifer with the pom-poms but there was not a space for me."

Santiago and Danquah will appear together at 4 p.m. Sunday, July 10, on the deck of Café Aroma. There is no charge for admission.

# Shawna Legarza speaks about leading Forest Service firefighters

Shawna Legarza, former fire chief for the San Bernardino National Forest, will be the next national director of Fire and Aviation Management for the U.S. Forest Service, Chief Tom Tidwell announced Friday, June 17.

During an interview with the Town Crier, Legarza said she will begin her new position on July 24. While she has had assignments for several months at the Forest Service Headquarters, residing in the Washington, D. C., area will be new adventure, too.

"I've had an amazing career and it's an honor to serve now in the next position," she said.

Legarza grew up on a cattle ranch near Elko, Nevada, which is where she developed her affinity for the outdoors, her acceptance of the unexpected and the importance of weather and hard work.

"My dad would be proud. I learned a lot from my parents and am very proud and appreciative of them and how I grew up," she said with affection and emotion. Her father died last year.

She has been a firefighter since 1989, when she started with the Bureau of Land Management in Elko. But she quickly joined the Forest Service's Hotshot crew in Carson

City, Nevada.

In those early days, she was not aspiring to Washington leadership positions. She was finishing her education at the same time. This focus on the present and awareness of others has been a long-standing trait of Legarza's. Then she earned her master's degree while a GS-5 firefighter.

The Hotshot time offered her an opportunity to travel around the country fighting many fires.

Being a woman has never seemed to be an impediment doing her job or in her career, Legarza said. "I've had that question before, but it never mattered on the ranch and hasn't in my career. I just did the job and was never aware of any differences."

Becoming the Hotshot supervisor of the Durango, Colorado, crew is evidence that she fought fires and could lead in the field.

After getting comfortable at a Washington desk, Legarza said her goal would be to continue to reinforce the cul-

ture where people can speak out and embrace the agency.

"The Forest Service is the best firefighters in the world. I'm part of that culture and want to make it better," which is why the work on the ground fighting fires to protect communities and landscape will be her focus.

She understands that life and career is not a steady upward line. It is the ability to accept those fluctuating patterns that helps. Some days it's an amazing job and other days, it's stress and fatigue.

"I think there's always days when you're the windshield and some days you're the bug," she emphasized. "You have to stay present in the job and learn for the ups and downs."

"I want people to take care of themselves so that they can care of others," she stressed.

The current efforts to change the funding pattern for wildfire fighting will continue to rest with the departmental leaders and Chief Tidwell. "I'll be in a supporting role," she said.



# Idyllwild's synagogue has new rabbi

## Malka Drucker has had an Idyllwild cabin for 40 years

Rabbi Malka Drucker has deep ties to Idyllwild. But she has only recently returned to Idyllwild to live, having spent the last several decades in Santa Fe, New Mexico, where she founded the synagogue HaMakom, the Place for Passionate and Progressive Judaism.

Drucker has had a cabin in Idyllwild for more than 40 years. A prolific writer, the author of more than 20 books, Drucker taught at the University of Southern California at a time when USC ran the Idyllwild Arts (then ISOMATA) Summer Program. Drucker served as workshop director at ISOMATA from 1982 through 1984. In that capacity she created curriculum, supervised instructors and taught adults how to write for children. As a fit and dedicated hiker, she knows Idyllwild's trails very well.

But she had not thought of returning to live in Idyllwild because, until recently, there had been no Jewish congregation here. So it seemed propitious when Har Shalom's first rabbi, Jules King, moved on, that Drucker would return to lead the growing congregation.

Drucker's professional résumé reads like a journey: a Bachelor of Arts in English from UCLA and a teaching credential from USC; and rabbinical training at Hebrew Union College in Jerusalem, the University of Judaism in Los Angeles, the Jewish Theological Seminary in New York City and the Academy for Jewish Religion, also in New York City.

Her 20 books, published by major houses, have been honored with prestigious awards, including a Southwest Pen Award for Non-Fiction in 2003, a 1993 New York Public Library Top 100 list, a 1983 Southern California Literature for Young People Award, a 1991 Bantam Publications Pick of the Lists Hungry Mind Award, and a 1978 Holiday House Sports Book of the Month selection for "Tom Seaver: Portrait of a Pitcher." Drucker is a major baseball fan.

She has lectured widely throughout the United States: at the Jewish Museum in New York City, the

Skirball Museum in Los Angeles, the Corcoran Gallery in Washington, D.C., Occidental College in Los Angeles and Wittenburg University in Springfield, Ohio, and many other venues.

But it is in conversation with Rabbi Malka, as she is known, that one experiences her passion, her conviction and her power. She teaches by asking questions, something that has historically been part of the relationship of rabbi to congregation in Judaism. "Why are we doing this?" asks Malka about the practice of her faith. "The answer is always going to be to love people and trust God, while knowing our own fallibility."

She mentioned two apparently contradictory concepts that, for her, best sum up our place, as humans, in a world of faith and of religious practice: "For me, the world was created," and, "I am but dust and ashes." The lesson is, explained Malka, that all we have been given is given only so that we can serve and give to others in humility.

In becoming a rabbi, Drucker said she wanted a deeper, creative understanding of spirit that was not academic. "I needed that creative piece," she said. When asked to clarify what she meant, she asked, "What is God's primary function? To create with the ongoing animating force. And, if I'm created in God's image, then it's in my creativity that I come closest to God. That's the love piece."

Quoting the Kol Nidre, a declaration recital on the Yom Kippur, the Day of Atonement, Drucker said, "A rabbi has two tasks: to bring forth creativity in others and to reveal oneself [Kol Nidre 5771]."

Asked how she would approach her new congregation, Drucker said, "I need to sit and listen in this congregation. My first job is to create maximum connectivity with whatever one feels is God, and to explore the inchoate longing for that connection. This is what I hope to offer, this impeccability of practice, where we are all doing the very best that we can to show how much we love God. It's not acceptable to just kind of do it."

Drucker displays a formidable intellect and powerful

spirit, while at the same time radiating graciousness and warmth. And always there is good-natured humor. She smiled when she explained how she would know when she was successful. "My job as your rabbi is to teach you everything I know so that I would be out of a job — to be of help in solidifying this community through love and kindness, and the practice of Judaism."

At her ordination speech, in becoming a rabbi, Drucker said, "It may take a village to raise a child, but it took a city the size of Manhattan to make me a rabbi."

Brendan Steele put up a 2-under-par 73-69-69-71 — 282 to tie for 39th place at last week's Quicken Loans National in Bethesda, Maryland. He missed a top-20 finish by three strokes.

Somewhat characteristically, the longer the club, the

better he did with it. The Idyllwild native led all players in the tournament in strokes gained off the tee with 5.060, gaining 4.948 strokes against the field overall, tee to green. But he gave back 0.650 strokes in play around the green and another 3.217 with the putter.

Brendan held his position as 50th in FedExCup standings, but slipped two spots — from 75th to 77th — in the Official World Golf Ranking.

This week, Brendan plays in one of his favorite tournaments: the Barracuda Championship on the Montreux Golf and Country Club course in Reno. The Barracuda is unique on the PGA Tour in that since 2012 it has employed a Modified Stableford points system. It's a bit of a cross between medal and match play in that it is played hole-by-hole, but with players accumulating

points overall.

A player scores 8 points for a double eagle on any hole, 5 for an eagle, 2 for a birdie, none for a par, minus 1 for a bogey and minus 3 for any double bogey or worse. This top-heavy scoring encourages a "go for it" strategy, since going for a risky birdie or eagle can score a player plus 2 or plus 5 points if he succeeds, but will cost him only minus 1 or minus 3 if he blows it. If a player doesn't make at least bogey on a given hole, he just picks up and writes a minus 3 for that hole score. So far at the Barracuda, the winner has always finished the four days with a score in the 40s.



# Journal from the James



## Climate change and its effect on quail ...

For many of us, climate change is an intangible that leaves us with more questions than answers. The term “climate change” evokes images of hurricanes, floods and all manner of cataclysmic natural disasters. When visualizing “climate-change research, we think of researchers in heavy jackets, faces peeking out of fur-lined hoods, pointing at receding glaciers. However, much is missing from this picture.

Results from ecological research can help fill in the gaps left in this popularized portrayal of climate change and give us a more concrete idea of what it all really means. The approach of climate-change ecologists vary dramatically from research focused on broad-scale population dynamics and distribution shifts to individual-level behavioral studies. Using either type of strategy, researchers can utilize mathematical models to predict changes 10, 20 and 50 years into the future under an extensive suite of conditions.

All of these efforts allow us to see beyond the impressive, albeit simple, view of climate change as melting glaciers and into the environment we occupy day-to-day. This is the true beauty of science: the ability to draw upon many different fields to paint a richer portrait of our ever-changing climate and landscapes.

But why does climate-change research matter? As it so happens, research that touches upon these themes is occurring in your own backyard. Quail, it so happens, are a wonderful system for asking ecological questions through the lens of climate change. In collaboration with Dr. Jen Gee, James Reserve director, researchers from the University of Colorado-Boulder are looking at the effects of climate change on the hybrid zone that occurs naturally between the Coachella Valley and the Santa Rosa/San Jacinto mountains.

David Zonana, doctoral candidate from the University of Colorado-Boulder, will quantify inter- and intra-species social structure and species distributions within this transect. Team Quail, consisting of David, Jen, and a slew of field assistants such as Eric Nuñez, Kyle Donahue and myself, is interested in determining how social and mating traits of these species differ between pure and hybrid populations, as well as how these species are distributed across the local microhabitats and their ranges across California. The beauty of this study is that we can use our results, combined with knowledge of natural history and climate models, to predict how these species will be affected by climate change. It is truly a “big picture” approach that allows us to get at multiple questions both directly and indirectly.

As a recent CU-Boulder graduate, my own part in this research is not only to assist in the field research with the day-to-day of trapping and banding quail, but also to document the research, especially with the angle on the climate story as told by quail in the region. Our work will be chronicled via the Inside the Greenhouse (insidethegreenhouse.colorado.edu) project through the University of Colorado and videos and write-ups of the research will be available there both now and later in the summer.

Thankfully, this has been made easier by the wonderful contributions of the Idyllwild community, including the Lanfrieds, David Jerome and many other helpful residents. They have been truly gracious in sharing their homes and birds with us. We would like to further extend thanks to quail research supporters, both on and off the Hill, outside of Idyllwild, including Ruth Watling, the Santa Rosa and San Jacinto Mountains Visitors Center, Buford Crites, and the Bighorn Institute for their help.







# Art Alliance donates nearly \$10,000

The Board of Directors for the Art Alliance of Idyllwild, a 501(c)(3) organization, has announced it will be distributing another \$9,935 to selected organizations or events that fall within its purpose as a nonprofit. According to Dave Robb, Scholarship and Funding chair, this is the first of two large distributions planned for the 2016 calendar year.

The funding aims to assist with providing art opportunities during the upcoming 2016-17 school year. A second round of funding will be discussed by the directors after its upcoming 19th-annual Art Walk and Wine Tasting fundraiser scheduled for Oct. 8. Robb believes AAI will ultimately exceed last year's funding, which at the time was a record year.

Those receiving funding include the local smARTS Program, run by volunteers who provide ongoing art education at Idyllwild School for students. They will receive \$2,000.

The music program at Idyllwild School, which used last year's funding to present "Alice in Wonderland," will again receive \$1,000 for a special music project of its choice.

Idyllwild Arts Academy, one of three independent high school boarding schools for the arts in the United States, will receive \$400 for its Baby Dance program and \$1,500 to help offset tuition for Idyllwild students at-

tending the academy.

Musica!, an organization that offers a free music program to youth, will receive \$1,000 for supplies and another \$1,000 for a proposed music project of its choice.

AAI Home School art program, which was a huge success in 2015, will receive \$2,000. The remaining funding will be set aside for two free community events to be led by local musician and educator Sandii Castleberry.

AAI has 288 members. It provides funding to art-related programs and events. Its fundraising efforts are made possible thanks to membership dues and proceeds from two annual fundraising events.




## Quail help needed in Idyllwild







funding to fight wildfires has grown from 16 percent of the agency's total budget in 1995 to more than 50 percent in 2015.

As these costs grow and exceed appropriated levels, the Forest Service must borrow funds from other programs such as recreation, acquisition and other management programs.

During the hearing, Robert Bonnie, the U.S. Department of Agriculture's undersecretary for Natural Resources and Environment, stated, "... in order to cover the 10-year average cost of suppression in FY 2017, more than \$237 million will be reallocated away from accomplishing work such as forest restoration projects that would help reduce the risk of future fires."

In her opening statement, Murkowski addressed this issue, saying, "This bipartisan discussion draft is an important first step toward ending the destructive practice of fire borrowing and restoring healthy, fire-resistant forests. I look forward to working with my colleagues on this critical effort as the legislative process advances."

Senators from both sides joined her in advancing the draft legislation to the Senate floor. Cantwell, the ranking member of the Energy Committee, said in her opening statement, "I'm ready to call fire borrowing, 'The Great Debate.' This senator is agnostic as to how we solve it, but I do have a couple of principles in general.

"We cannot rob Peter to pay Paul. The Forest Service needs both the money to fight the fires and the money dedicated to do fuel reductions. So we have to produce a draft out of here that gives them the ability to do both," Cantwell added.

The draft bill proposes Congress fund the agencies' fire needs at the beginning of the fiscal year. The funding level would be enough to cover 100 percent of the average annual cost of firefighting over the past 10 years. This could be adjusted in catastrophic years. Disaster funding would be the source for these additional monies. Also, in low fire years, agencies could use the excess funding for prevention projects.

However, while bi-partisanship was visible in the hearing, Bonnie, the administration's witness, was not completely satisfied with the proposed solution to fully fund the 10-year average cost and eliminate the need to borrow funds.

He argued that fully funding the fire costs within the Forest Service's total budget would still reduce funding for other programs. This was based on the agency's estimate that the 10-year average will continue to grow and could approximate two-thirds of the budget in 2025.

The draft bill also would authorize the use of drones, or unmanned aircraft systems, during wildfires. The intention of these tools is to improve the ability to scout fire lines, identify escape routes and track ground resources.

Another provision authorizes \$500 million over seven years to provide assistance to at-risk communities to invest in proven programs that reduce wildfire risk, property loss and suppression costs.

# Gov. Brown signs 2016-17 budget

## \$122 million in new spending

On Monday, June 27, Gov. Edmund G. Brown Jr. signed the legislative bill establishing the state budget for fiscal year 2016-17, which begins July 1.

"This solid budget makes responsible investments in California and sets aside billions of dollars to prepare for the next recession," said Brown in a press release.

Total state spending is estimated to be \$170.9 billion, of which \$122.5 will come from the General Fund.

The balanced, on-time state budget doubles California's Rainy Day Fund, pays down debt, increases school funding and boosts programs to combat poverty and homelessness.

In addition to the constitutionally required \$1.3-billion deposit, the budget directs an extra \$2 billion contribution into the Rainy Day Fund — bringing the state's reserve fund to \$6.7 billion, or 54 percent of the goal.

The budget also directs \$1.75 billion to the Special Fund for Economic Uncertainties, which also helps the state meet obligations in the face of declining revenue or unanticipated obligations, and pays down debts and liabilities by \$1.3 billion from Proposition 2 funds.

The minimum funding guarantee for K-12 schools and community colleges will grow to \$71.9 billion this year, the highest level in state history and a \$24.6 billion increase since 2011-12. Per-pupil K-12 funding is increased to \$10,643, a \$440 increase over last year and a \$3,600 increase over 2011-12 levels.

New funding for the Local Control Funding Formula is \$2.9 billion — bringing the formula's implementation to 96 percent complete.

This year's budget begins implementing the state's new \$15 per hour minimum wage by raising the statewide minimum wage to \$10.50 per hour beginning Jan. 1, 2017. The budget also funds cost-of-living increases for Supplemental Security Income/State Supplementary Payment, the first boost since 2005.

The budget also repeals the "maximum family grant rule" in CalWORKs, which had denied support to children born to parents who were receiving aid. It also limits the

state's asset recovery from the estates of deceased Medi-Cal recipients.

The budget reflects \$3.6 billion in state and federal funding and award authority for many affordable housing and homelessness programs, including increased funding for CalWORKs rapid rehousing and emergency homeless shelters.

Of this amount, the budget sets aside \$400 million in the General Fund for allocation later in the legislative session for affordable housing programs. Also, legislation will authorize a \$2 billion bond from a portion of future Proposition 63 mental health revenues to develop and administer homelessness and affordable housing programs for the mentally ill.

The budget includes funds for drought relief programs such as grants and emergency projects, as well as enhanced fire protection and tree removal grants. Also, Cal Fire received \$12 million to begin replacing its helicopter fleet.

Assembly Speaker Anthony Rendon (D-Lakewood) said in a statement, "The budget the governor just signed reflects the Assembly's top priorities, including lifting families out of poverty, increasing access to early childhood education and making college more accessible for California students. This balanced, on-time budget — which also responsibly grows the state's Rainy Day Fund — is the result of hundreds of hours of public hearings. That shows the budget process is working and our final product means California is in stronger fiscal shape than we have been for years."

But two weeks ago, after the Legislature passed the budget bills, local state Sen. Jeff Stone said, "... The budget — which spends a record \$122.5 billion from the General Fund the upcoming fiscal year — is an increase of \$6.9 billion from last year. Even as the cost of state government continues to skyrocket, Gov. Brown is warning of dire days ahead for state revenue. His own administration is projecting an operating deficit of \$4.1 billion in 2019-20, and that was before all of the additional spending legislative Democrats tacked on to this budget in recent days."

## Missing Persons Day in Perris


About 1,200 missing persons have been reported in Riverside County dating back several years. Do you know someone who's missing?

Family members and friends affected by a long-term missing loved one are encouraged to attend the Riverside County Sheriff's Department's Coroner's Bureau "Missing Persons Day" event from 9 a.m. to 3 p.m. Saturday, July 9, at 800 S. Redlands Ave., Perris (Coroner's Bureau).

Those who attend are encouraged to file a missing person's report, update an existing report, and provide medical records, dental records, X-rays, and photographs of the missing person.

Biological family members can also submit DNA cheek swabs so that it can be compared to the National Missing and Unidentified Persons System's database. Families are encouraged to bring at least two biologically related family members of the missing person to provide DNA samples.

Forensic professionals and law enforcement officers throughout Riverside County will be present to assist and provide information for this event. This is a free event open to the public. Appointments are recommended, but not necessary.
