CSA 36 Advisory Committee confronts possibility of Town Hall sale

On Thursday, Sept. 8, the County Service Area 36 Advisory Committee held its monthly meeting to review its responsibilities for overseeing recreation and street lights in the district.

Facing the committee and the community

is the likelihood that Town Hall will be listed for sale by the Johnson family. Town Hall is currently the primary venue for CSA 36 recreation. The Johnson family has been in negotiations with the county for either sale or a long-term lease of the historic structure, but no agreement has been reached.

At this point, an agreement is unlikely,

according to Michael Franklin, CSA project manager at the county's Economic Development Agency. "Our real property division is working with [3rd District] Supervisor [Chuck] Washington to find alternative sites," said Franklin, "but at this time, a long-term lease at Town Hall

Two traffic incidents on Hill roads last week

The California Highway Patrol reported two traffic collisions over the previous week.

The first, at 9 a.m. Thursday, Sept. 8, involved a single vehicle. Sandra Adolph, 52, of Idyllwild, was driving her silver 2016 Toyota Corolla eastbound on Highway 74, 3 miles west of McCall Park Road, when, according to the report, she fell asleep and crashed into the mountain. She was not injured and no other vehicles were involved in the incident. Adolph's car was moderately damaged and required towing.

At 3:45 p.m. Friday, Sept. 9, Grace Eaton, 20, of Mountain

Center, was driving her red 2011 Nissan Sentra south on Pine Crest Avenue in Idyllwild when she made a U-turn at the intersection with Jameson Drive, causing a collision with the vehicle that had been behind her.

Eliot Taylor, 52, of Idyllwild, had been driving his 2006 gray Ford Ranger truck when Eaton's vehicle struck his. Taylor complained of pain to his left arm but did not request transport. Neither Eaton nor Francesca Flax, 22, of Indian Wells, a passenger in Eaton's car, were injured. Damage to both vehicles was moderate, requiring towing.

Active shooter is subject of local presentation

The Mountain Emergency Services Committee highlighted its monthly meeting with a presentation by Michael Beltran, Imperial Irrigation District, regarding dangers posed by active shooters in public areas. The meeting was held last Wednesday at the Idyllwild Library Community Room.

Beltran is a retired policeman, with experience in special weapons and tactics (SWAT) and criminal intelligence. Jerry Hagen, MEMSCOMM county coordinator, asked Beltran to make the presentation following the San Bernardino and Orlando shootings.

Beltran began his presentation by stressing the old "shelter in place" advice is no longer valid. "It just leads to slaughter," said Beltran. "If a shooter is coming into your space, especially if its enclosed, the advice now is to run, hide and fight" — run out of the space if possible, hide in a concealed space and if the shooter is still com-

ing, fight as a last resort.

Beltran noted that premeditated shooters plan to attack in large, highly populated urban areas in enclosed places like the San Bernardino public building or the Orlando night club. "Seventy-percent of these incidents are at businesses or schools," said Beltran. He said the relative risk of an active-shooter incident in Idyllwild is not statistically high. Nevertheless, Idyllwild residents travel to other areas and venues in which the possibility of an active shooter is greater.

Beltran advised that even with heavy armament, a shooter may still have to stop to reload and that is where "fight" becomes important. "The shooter is distracted then and that provides an opportunity to stop him," he said. "An active shooter is just bent on killing as many people as possible. Pleading for one's life does not affect the result. In one case, a man pled for his life and the shooter shot him 14 times."

He also warned that in six out of 10 case studies, law enforcement was not in place for some time after the incident began. "The important thing today is to already have a plan in place before an incident begins," said Beltran. "You cannot be running your options as an incident is unfolding. You must have thought about your options in an active-shooter situation beforehand and have a pre-planned action. Have an action that is a motion. Your motion requires the shooter to have to think and respond. Civilians have stopped active shooters twice as often as police intervention."

Beltran noted that U.S. intelligence agencies used to

think of active-shooter situations as "when" they might happen. "Now, it's where it's going to happen," he said. "And don't think it can't happen here."

In 2015, Beltran said there were more than 330 active-shooter victims. In 2016, there have been 330 to date with three-and-a-half months to go in the year.

Statistically, 41 percent of active shooters are related professionally to their victims, 5 percent to family members and 22 percent have no relation to their victims at all.

In response to questions about what to do before an event — the plan to have in mind — Beltran suggested: Know your work area. Know your closest route to evacuate and alternate evacuation routes. If you have to lock down, where will you go and what around you can be used as a weapon?

What can alert you? He suggested: gunfire; a witness; a PA announcement; a phone alert; and screaming or fleeing individuals. Said Beltran, "You must react immediately when you become aware of an active shooter. If you are unprepared, your natural instinct will be disbelief and hesitation. Most people lose their lives due to denial or distraction. It's not being paranoid to plan for situations like this in advance. Preparation is critical."

MEMSCOMM monthly meetings are open to the public.

Pape hearing moved to Sept. 7

The preliminary hearings for Robert Pape, 28, and Cristin Smith, 27, have been rescheduled for Oct. 24.

At that hearing, the presiding judge will hear a motion from Smith's attorney to dismiss the charges against him and, if unsuccessful, a motion to reveal the name of a confidential informant working with the Riverside County District Attorney's office.

Both men have been arrested for the 2006 triple murder of Jon Hayward, Vicki Friedli, and Vicki's daughter, Becky Friedli in Pinyon Pines. They had been arrested for the murders in March 2014, but nearly seven months later, the DA's office dismissed all the charges against Pape and Smith. This June, both men were re-arrested for these murders.

Let's help our tourist industry by advertising. Live music. Yeah.

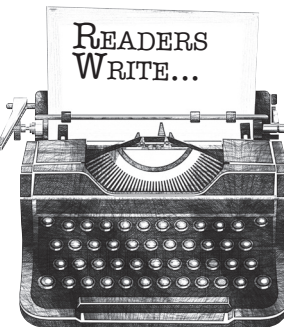

Voter scam

Response to complaints from voters

County elections officials and the California Secretary of State's office have received more than 100 complaints from voters who have received letters from a group called the Voter Participation Center.

The organization's letters claim that the voter is not registered to vote and offers a pre-filled voter registration form with incorrect or outdated information, or information for persons who don't live at the address. In many instances, the voter is, in fact, properly registered to vote, according to Secretary of State Alex Padilla.

It is important that organizations conducting voter registration drives through the mail ensure that their voter data is up-to-date and accurate. Causing confusion right before an election is wrong, he said.

"If you have questions about your voter registration status, check directly with your county elections office," Padilla said.

"Many counties have online tools that allow voters to verify their voter registration information. Also, contact information for county elections officials and links to county online voter registration status tools is available on the Secretary of State's website at www.sos.ca.gov/elections/registration-status/."

New voters or persons who want to update their voter registration information may visit the Secretary of State's official voter registration website at <http://registertovote.ca.gov/>. If you need to update your voter registration information, the deadline is Monday, Oct. 24.

Local Dravenstatt arrested again on felony charges

Idyllwild local Taylor James Dravenstatt, 24, previously sent to state prison for felony burglary in 2013, was arrested again on Sept. 6 for felony burglary of a dwelling. The arrest occurred in Perris. He also is charged with felony parole violation. He is currently in custody at Southwest Detention Center in Murietta. Dravenstatt's pri-

or conviction counts as a first strike under California's three-strike law.

Because of his prior conviction and sentence, Dravenstatt is ineligible for probation. He also has a prior felony and prison within the last five years.

Dravenstatt was arrested in 2012 for felony burglary with another defendant, Ron Kimmerle, also then of Idyllwild. Dravenstatt was arrested again this time with other

defendants — Charles Michael Stratton and Geoffrey Eugene Helmick, both of Hemet, each similarly charged with felony burglary on violation date Sept. 6.

The next action in the case is a felony settlement case for all three at 8:30 a.m. Tuesday, Sept. 20, in Department 63 in Riverside. Bail for Dravenstatt is set at \$170,000.

Forest Service criticized for lack of criteria to select hazardous fuels reduction projects

The allocation of funding for hazardous fuels projects and how the U.S. Forest Service sets its priorities for this work was questioned in a report last month. The U.S. De-

partment of Agriculture's Office of Inspector General spent more than year reviewing the program and visiting regional offices, national forest offices and several ranger districts, including two on the San Bernardino National Forest.

In general, the OIG did not find adequate data or procedures to support the priority and funding decisions. However, the Tom Tidwell, Chief of the Forest Service, said in his response to the report, "The Forest Service generally concurs

with the findings and recommendations and appreciates the time and effort that went into the report." He also set June 30, 2017, as the date for implementing the changes or improvements.

Basically, the Department's OIG is concerned

that the Forest Service is not spending the money appropriated for hazardous fuel reduction projects in the areas most in need of treatment. If priorities are not clear and consistent across the nation, the result could be "placing areas at increased risk of catastrophic wildland fire," the OIG suggested.

In addition, the OIG found several instances of inaccurate reporting and accounting, which seems to call the entire program's results into question.

Over three fiscal years, from 2012 to 2014, the Forest Service spent more than \$6 billion preparing for and fighting wildfires. Projects funded to reduce hazardous fuels are supposed to contribute to the reduction and possible intensity of these fires.

However, the OIG has found that the Forest Service, which agreed with 10 of the OIG recommendations, does not have a system or process to adequately assess the wildfire risk of where these funds are being spent.

The system the Forest Service uses only "assists in determining funding for regions and their forest

and does not assign priority to individual hazardous fuel reduction projects for completion," the OIG report stated. This funding was intended to "protect at-risk communities and watersheds" and the Forest Service cannot confirm, which projects are being funded.

"[Forest Service] unit did not document rationale behind project selection," the report authors wrote. None of the ranger districts, which were part of the study, "documented why they implemented one hazardous fuels reduction project in the [wildland urban interface] over a different hazardous fuels reduction treatment in the WUI."

The OIG investigators did state that three regions, including the Pacific Southwest, had started to move in this direction. During the investigation, the Mountain Top and Front Country ranger districts in the San Bernardino National Forest were visited. However, no specific comments referring to this forest or these districts were part of the report.

Prop 61, a prescription drug purchase and pricing initiative

Major drug manufacturer opposition

Proposition 61, titled by its drafters as "The California Drug Price Relief Act," and on the ballot as "State Prescription Drug Purchases. Pricing Standards. Initiative Statute," seeks to cap prices state agencies pay for prescription drugs to the lowest price paid by the U.S. Department of Veterans Affairs.

VA generally pays the lowest prices under mandatory discounts under federal law. Tying prices state agencies pay for prescription drugs to VA prices is intended to reduce prescription drug spending for the populations state agencies serve through their health-care programs.

Typically, state agencies pay for prescription drugs under programs that provide health care or health insurance to certain defined populations — low-income residents, through the state's Medi-Cal programs; current and retired state employees; and prison inmates. In 2014-15, the state paid \$3.8 billion for prescription drugs, with the largest amount, \$1.8 billion, going to Medi-Cal low-income residents; \$1.3 billion to public employees, dependents and retirees (Public Employees' Retirement System); \$334 million to University of California students, clinics and hospital patients; \$211 million to inmates; \$57 million to underinsured individuals who are HIV positive; \$8 million to developmental center residents; and \$4 million to California State University students.

Medi-Cal operates comprehensive health coverage to low-income residents through two delivery systems: the fee-for-service system serving 25 percent of Medi-Cal recipients and the managed care system which that 75 percent of recipients. Under terms of Prop 61, were it to pass, the managed care system comprising 75 percent of recipients would be exempted from any drug price relief tied to VA caps. As the California Legislative Analyst notes, "The measure exempts a portion of the state's largest health care program from its drug pricing requirements," thereby reducing the pool of potential beneficiaries of drug-price reductions.

The LA's Office also notes there are many end runs drug companies could make that might diminish actual prescription drug savings should the measure be enacted:

- The VA does not publish the lowest prices for some of the drugs for which it has negotiated lower fees because of confidentiality agreements with the drug manufacturers. Consequently, it would be impossible to determine "lowest price" for some drugs because the VA infor-

mation is restricted.

- In order to maintain current levels of profitability, drug manufacturers could raise VA drug prices.

- Drug manufacturers might decline to offer the lowest VA prices to state agencies for certain drugs. In such cases, those drugs would be unavailable to most state agencies and the state residents their programs serve.

And while the bill's sponsors correctly note the rapid rise of prescription drug prices (an 800-percent increase in prescription drug spending from 1990 to 2013), there is no enforcement provision in the measure to prevent drug manufacturer tactics that could vitiate the measure's effectiveness in actually reducing drug prices.

The California Department of Health Care Services is obligated under federal law to offer most FDA-approved prescription drugs to Medi-Cal and other recipients. Failure to offer an approved drug, because of drug manufacturers' refusal to offer lowest VA prices to the state, could result in loss of federal funding.

The prescription drug industry is fighting this measure, spending more than \$70 million to oppose, and making this one of the most expensive ballot measures in this election.

In short, although aimed at curbing rampant price rises state agencies pay for prescription drugs, tying them to a federally agreed VA "lowest price," the measure's outcome and effectiveness are unclear, according to the LAO. The analyst notes outcomes are unclear because there is no enforcement provision and there is a continuing likelihood of drug company actions that could reduce the measure's effectiveness.

Gov. signs bills affecting public agency website use

The 2015-16 legislative session ended on Aug. 31, and now Gov. Jerry Brown

has begun to sign and veto some of the many bills passed in the last month.

Last week, he signed two bills that affect public agencies.

Assembly Bill 2257, which Assemblyman Brian Maienschein (R-San Diego) sponsored, will require the legislative bodies of public agencies (city,

county, special districts and school districts) that have a website to prominently post their agendas online. The vote approving this bill was 79-0.

AB 2257 amends the Ralph M. Brown Act and requires the agencies to post the agenda in a consistent and visible location. The bill also requires that the posted agenda be in a machine-readable format, which will allow it to be indexed and searched via common search engines such as Google.

The effective date of this law is Jan. 1, 2019.

The second bill, AB 2853, amends the Califor-

nia Public Records Act. If an individual requests information from the agency that is already posted on its website, the new law allows the agency to refer the requestor to the site.

However, if the individual does not have access to the website or is unable to print the document, a physical copy must then be supplied.

Living Free, the local no-kill animal sanctuary, which rescues cats and dogs, is holding its third-annual Howl and Yowl fundraiser, Saturday, Sept. 24.

"There will be four great bands. They'll offer country music from progressive to traditional," said Randall Harris, Living Free's president. "We'll be rocking the meadow. It's going to be awesome."

The musical talent will be familiar to many of the event's faithful patrons. Returning this year will be Honey County, Jason Powers, Black Swan and Michael Thomas.

Honey County is a Southern California trio of women performing progressive country music. They travel between Southern California and Nashville offering their music to fans. Devon Eisenberger, a member of the group, is a nearby singer from Temecula. She has developed her own following, too.

Black Swan includes local musician Don Reed on guitar and string. Barry Baughn, on vocals and guitar, Bob Gross, vocals and bass, and Larry Mitchell on drums are the other swans. The group plays very popular blues.

Jason Powers brings his powerful music and sound back to Mountain Center. "Those who saw [Honey County and Powers] last year are very happy about their return," Harris said.

Last year, Powers found Gogi and adopted the dog before departing, demonstrating how helpful the event is for the abandoned animals.

"We are on track to find homes for about 320 animals this year, and will do about 600 total spay or neuter [surgeries] for our rescues and affordable public clinic," Harris said proudly. "That means we'll save about 600 [animal] lives."

Proceeds from Howl and Yowl help to pay for these surgeries, which help to reduce future stray and abandon animals.

Harris added that the music and patrons will have protection from the summer sun because a large tent will be erected for the performance area.

Besides the wonderful musicians, the popular Big Dev is returning with his special barbecue mix and food stand.

The event will be from 11 a.m. to 4 p.m. at Living Free in Mountain Center, 54250 Keen Camp Road. The phone number is 951-659-4687. The admission fee, which goes entirely to Living Free's mission, is \$15.

Shakespeare wrote about aging

Are there helpful clues for us?

Shakespeare wrote movingly about youth and old age. But it is with his older characters — Prospero, Falstaff, Lear and others — that Shakespeare reveals the depth of his understanding of the human condition. With his characters, there is wisdom with age, there is rage and there is surrender to the inevitable. “Last scene of all, that ends this strange eventful history, is second childishness and mere oblivion, sans teeth, sans eyes, sans taste, sans everything.” (“As You Like It,” Act II scene VII.)

Is it all bleak? Not by half. And that is what Broadway actress and director Dr. Jenny Egan’s interactive seminar, “Shakespeare’s Take on Aging,” is about. Said Egan, “The delights and terrors of aging are well documented by Shakespeare in both plays and sonnets. You will explore various adjustments his characters make to the aging process as you also examine your own thoughts on aging.”

Offered by Egan at the Idyllwild Library’s Community Room, the seminar is interactive, with opportunities for attendees to hear, read and better understand Shakespeare in an informal setting. No acting experience is necessary.

“Shakespeare can sometimes seem daunting,” said Egan. “This will not be a lecture. Those who come don’t have to act. But they can read if they like. The experience is intended to have Shakespeare become less daunting. Individual and group participation is

encouraged.”

Egan was an assistant director and actor with the New York Shakespeare Festival, acted in Broadway and Off Broadway productions, at Lincoln Center and in film and television.

Gemini Anderson, IA grad, heads to NYC talent showcase

Gemini Anderson, daughter of the late Pete "Pedro" Anderson and Betty Ginsberg Anderson, is heading to the New York City theater district for an invitation-only talent showcase.

Anderson, a 2012 Idyllwild Arts musical theater graduate, is also a 2015 honors bachelor's degree graduate of the Royal Welsh College of Music and Drama in Cardiff, Wales. Royal Welsh is one of the top-rated theater schools in the United Kingdom, named the top drama college by the Guardian University Guide twice in the last three years. It accepts very few American students annually. Anthony Hopkins is a graduate.

And it is for a first-ever showcase of 18 Royal Welsh graduates in Broadway's theater district that Anderson is in the United States. The showcase, for an invited audience of U.S. industry professionals — theater and film casting agents and representatives from major theatrical companies — will be held on Monday, Sept. 26 at 1 and 6 p.m. at the Alice Griffin Jewel Box Theater on West 42nd street in Manhattan. "We previously did one in London, at the Royal Court Theater in the West End," said Anderson. That resulted in acting work for her on the BBC, the British Broadcasting Corporation.

"Each person gets three minutes of time at the showcase," said Anderson. "I'm doing two contrasting speeches [as they are called in the U.K. — "monologues" in the U.S.] and one duologue. I'm not doing things that are too minimal. I want to showcase my physicality and move-

ment ability. I'll be telling my stories with my body as well as with my lines."

Anderson combines elegance, energy and an edgy contemporary style. She is articulate, intelligent and focused on social change. "Theater is a platform for social change," she stressed. She sings, dances, acts and writes. "While at Royal Welsh, I wrote two shows that were performed — a one-woman show focused on the Iraq war and a five-woman piece centering on sexual slavery. 'I restructured text from Shakespeare, from 'Pericles, Prince of Tyre' and 'A Midsummer Night's Dream,' with my own text into a one-act play called 'Marina's Story.'"

Anderson is currently pursuing a doctorate at Royal Welsh with her thesis subject as "Site Specific Theater; Social and Environmental Impact." She said her goal is to have her own traveling theatrical company, with her partner, Zaceus Emile, that presents plays with classical and political underpinnings. The company's working title is "Boxless Foxes Theater Company."

Anderson moved to Idyllwild with her family in 2010 in order to begin training at Idyllwild Arts. "I just loved everything about it — the people, the students, the staff," she said. "I would

not have gone to Royal Welsh had I not gone to Idyllwild Arts."

Steele closes out 2016 season

Brendan Steele had another rough outing last week, this time at the BMW Championship, the third of the four season-ending playoff tournaments. His 6-over-par 72-70-79-73 — 294 fell well short of what he needed to advance to the Tour Championship next week.

Although his season ended on a downturn, he was competing with

the very best players on the tour these final weeks. The Idyllwild native's season was not without a solid bright spot: He posted 10 top-20 finishes in 25 starts, his most top-20s in a season ever.

On the year, Brendan earned 1,001 FedExCup points to finish 63rd on that list, and he currently is ranked the 85th best player in the world on the Official World Golf Ranking. He earned more than \$1.5 million in official prize money this

year to rank 65th, and he's now surpassed \$8.5 million in career official earnings.

The 2016-17 PGA Tour season opens in only four weeks on Oct. 13, at the Safeway Open on the Silverado Country Club (North) course in Napa. Brendan generally has played in that tournament's predecessor, the Frys.com Open, also held in Napa.

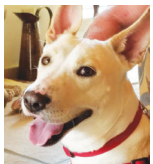

The Riverside County Board of Supervisors decided that funding for electrical service to county parks would be provided in the next year's budget.

45 years ago - 1971

American Legion offi-

40 years ago - 1976

Village Market was advertising lean ground beef for 69 cents a pound, red delicious apples for 29 cents a pound, a 5-pound bag of sugar for 89 cents and 10 pounds of potatoes for 79 cents.

35 years ago - 1981

With major league baseball out for the summer on strike, the Idyllwild Softball Association's playing season became big news. The league champions were: Taylor's Lodge in the Women's League; Trista-

no Realty in the Men's League; Soroptimist Oakies in the Girls' 11-15 League; Idyllwild Pharmacy Little Pills in the Girls' 8-10 League; Dinkel's Devils in the Boys' 11-15 League; and the Lions Club Cubs in the Boys' 8-10 League.

30 years ago - 1986

Marge Muir was elected president of the Idyllwild Board of Realtors for 1987.

25 years ago - 1991

Idyllwild resident Bill Sanborn, by a unanimous vote, became a member of the governing board of the Hemet Unified School District.

20 years ago - 1996

Black Mountain Look-out reopened after 13 years of being closed.

15 years ago - 2001

A group of Southern California physicists was seeking federal funds to carve a 5-mile tunnel into the San Jacinto Mountains in order to build a neutrino research lab under the Jean and San Jacinto peaks. The plan never came to fruition.

10 years ago - 2006

The Riverside County Board of Supervisors voted to impose a registration fee on businesses in unincorporated areas in order to fund federally mandated inspections for possible runoff pollution. They also voted to create a new code enforcement and regulation department.

5 years ago - 2011

More than 400 strikes occurred on the Hill overnight as thunder bellowed for hours and the lightning resembled the strobe lights at a discotheque. As of the next morning, none had triggered a fire response.

1 year ago - 2015

Hours after thieves broke into the Mountain Center Market and took the ATM machine, two men were arrested on Highway 74, just west of the Forest Service's Cranston Ranger Station.

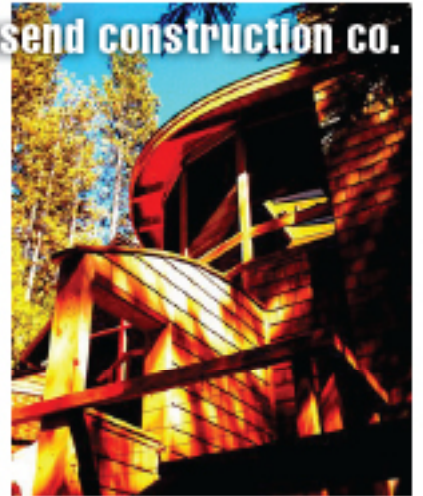

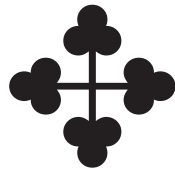

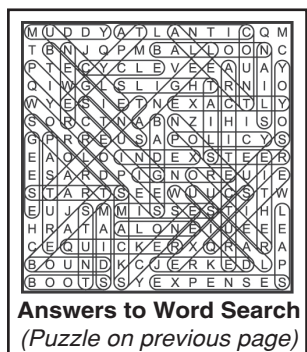

IWD cancels next meeting

Changes October meeting

Idyllwild Water District has canceled its September meeting scheduled for Wednesday, Sept. 21. In a brief announcement issued Friday, Sept. 9, the district announced the meeting's cancellation.

Also, the announce-

ment said the regularly scheduled October meeting would be moved to Oct. 12. Pursuant to the IWD's resolution setting the day and time of regular meetings, this would normally have been Wednesday, Oct. 19.

This will be the third-consecutive month IWD has moved or canceled its meeting from the

regular date of the third Wednesday of the month to a different day of the month.

No reason was provided for the meetings' cancellation or movement; although at least Director June Rockwell has objected to the September meeting's cancellation.

Pete Capparelli, who has served as an elected and appointed official on several

public bodies, including the Idyllwild Fire Protection Commission, said when asked about IWD continual shifting of meetings, "It seems surprising they keep changing. I don't think its appropriate. They're public servants and they need to deal with the public and be transparent."

State considering how recycled water can go directly to potable water

The California State Water Resources Control Board has announced a public workshop and solicited public comments on a draft "Report to the Legislature on the Feasibility of Developing Uniform Water Recycling Criteria for Direct Potable Reuse."

The report was prepared pursuant to Senate Bill 918, enacted in 2010, which defined the term "direct potable reuse" and directed the California Department of Public Health to investigate the feasibility of developing uniform water-recycling criteria for direct, potable reuse and provide a final report to the Legislature by Dec. 31.

In summary, the report concludes

it is technically feasible to develop uniform water-recycling criteria for direct potable water reuse in California, and that those criteria could incorporate a level of public-health protection as good as or better than what is currently provided by conventional drinking-water supplies.

An expert panel, who reviewed the draft report, found that there is no need for more research to establish criteria for DPR, but provides six research recommendations that would enhance the understanding and acceptability of DPR and further ensure that DPR is protective of public health.

The Southern California workshop is from 9 a.m. to noon Thursday, Oct. 4, at the Metropolitan Water District of Southern California Head-

quarters, Room US1-102, 700 North Alameda Street, Los Angeles.

None of the local water districts have expressed any intent to attend the meeting, although Idyllwild Water is planning construction of a recycling facility. The water treated there will not be considered potable.

is not in the county's interest." Scott Bangle, general manager of the County Parks and Open Space District, current recreation managers, concurred with Franklin. "There's not a lot of sense in pursuing a long-term lease at this time," said Bangle.

With no prospect of a lease at a reasonable commercial rate, Jay Johnson said he would be forced to list the property for sale. Other family members, who hold legal interests in the building and land, are pressing for a lease or sale. Johnson said in an interview on Tuesday, Sept. 13, that he had indicated to Bangle that the family would accept \$1.25 a square foot as a fair rent for Town Hall.

With a likely two-year wait until other recreation facilities are available at the Idyllwild Community Center Butterfield Commons site, the county would have to find other recreation facilities in the interim if no lease agreement could be reached and Town Hall were to sell. Because of the present uncertainty about Town Hall's future, the advisory committee was unable to take action on proposals for creating pickleball courts at Town Hall, or repairing or replacing the outdoor stage.

The only actions the committee did take at the meeting were to elect a chair, John Metroka Jr.,

and a vice chair, Kathy Wilson; change the meeting date to the fourth Thursday of every month at the same 5:30 p.m. time; and agree to circulate a public opinion survey, "The Future of Town Hall," at the post office.

The survey asks residents if and how they would be willing to help save Town Hall as a recreation venue or as a new arts center with a community theater. Franklin noted that Washington is interested in hearing what the community wants. "That is why he established this committee," said Franklin.

Town Hall Director Bob Lewis gave his report on current recreation, noting a significant increase in youth soccer registration from last year (120 players), a return of Idyllwild's Haunted Ghost Town, and plans to hold community dances and more events for seniors. Community movies on a large screen indoors in the fall and winter, and outdoors when the weather warms will also be placed on the recreation agenda. Lewis submitted a preliminary budget for the 2016-17 fiscal year, based on combined recreation fees and CSA income of just over \$220,000.

Unless a special meeting is called to deal with an imminent Town Hall sale, the next CSA 36 Advisory Committee meeting will be held at 5:30 p.m. Thursday, Oct. 27.
