## Supervisor picks Schelly, Sirkin for IWD seats

Vacancies on the Idyllwild Water District board were filled Tuesday after Riverside County 3rd District Supervisor Chuck Washington, frustrated by the current board's inaction, used his authority to nominate Dr. Charles "Chip" Schelly and Vic Sirkin to fill the two vacant seats.

At its Tuesday, Dec. 6 meeting, the county's Board of Supervisors approved the selections.

Not all are pleased with the action. John Cook, the current acting board president, said, "I think there should have been an election to fill these seats."

When asked if the issues he feels need public vetting were addressed during the August 2015 election, in which two incumbents — Warren Monroe and Dean Lattin — were defeated and the board president Jim Billman finished third, Cook replied, "No."

Before Washington's appointments, Cook was proposing an election in

March or April, but that would have continued the board's stalemate. Further, winners of that election would still have had to stand for re-election four months later during the

## Propane spot prices hold steady

Delivery fees similar to last year

*Editor's Note: We'll continue to profile propane company representatives and company policies in subsequent editions as well as updating pricing from companies willing to provide that information.*

In our Nov. 24 edition we reviewed propane spot prices nationally and regionally, and suggested to readers that it might be to the customer's advantage to check information other than price per gallon (ppg) before choosing or changing their propane supplier.

This week, refinery point-of-production "spot" prices have not fluctuated much

from two weeks ago. Previously the Mt. Belvieu, Texas spot price was \$0.553 per gallon. This week it is \$0.543, down slightly. A year ago, same date, it was \$0.443.

This week, the national propane per-gallon delivery prices also are down slightly. In the western region, the price this week is \$1.762, down from \$2.076 two weeks ago. A year ago, the ppg was actually higher than this week — \$1.919.

Propane-delivered ppg is forecast to be slightly higher than last year, which saw historically low prices. But with prices holding steady over the last two weeks, the forecast looks good for the season to come.

Amerigas continues to maintain its community pricing at \$1.99 per gallon.



# Two collisions on Hill roads on same day

Two crashes, both on Sunday, Dec. 4, took place on Hill roads over the last week.

At 11:27 a.m., Christopher Wrenn, 24, of Aguanaga, was riding his black 2014 Honda street bike east on Highway 371, a half mile west of the intersection with Highway 74 when, while negotiating a left-hand curve, he crossed over the double-yellow lines attempting to pass a slow-moving vehicle also heading eastbound.

As he entered the opposing lane of traffic, he saw a blue sedan coming directly toward him. In order to avoid a head-on collision, Wrenn swerved sharply to the right and laid his bike down on the side of the roadway. He was transported by ground ambulance to Eisenhower Medical Center in Rancho Mirage complaining of pain in the chest and left shoulder.

At 12:27 p.m., Brian Vasquez, 27, of La Quinta, was driving his 2016 white Subaru WRX STI north on Highway 243, a half-mile north of the intersection with Highway 74 in Mountain Center, when in executing a left-hand curve, he lost control and ran off the roadway coming to rest against rocks on the embankment. He was not injured and no other vehicles were involved in the crash.

# Warming center snafu — center moved to Town Hall in 2016

Legion was prepared to continue; not officially notified of change

In January 2016, the Idyllwild Warming Center was moved by the Community Action Partnership from the American Legion Post 800 where it had been for six years to Town Hall.

Town Hall is not open at night, as the American Legion was when it hosted the warming center. Also, Town Hall hosts a variety of town events and acts currently as a headquarters for parcel tax-funded community recreation. Children are often on the premises during the day.

Recreation Director Bob Lewis acknowledged the challenge of mixing populations (recreation users, including children, and those needing a warming center) could be met by shifting people from upstairs to downstairs if needed, but pointed out that Town Hall's future as a venue for community recreation or as a warming center is unclear for 2017.

In 2010, after a significant winter-storm power outage, the American Legion Post 800 signed a memorandum of partnership with CAP of Riverside County to host an Idyllwild Warming Center. The warming center was the idea of community residents and not, originally, of CAP. At the same time, a Memorandum of Understanding between the Legion and Mountain Disaster Preparedness was created to use MDP's communication network to inform residents when the center would be open.

In December 2011, a committee composed of Legion and MDP members drafted an activation protocol, with support from the Idyllwild Fire Department's then-Chief Norm Walker that specified when and under what conditions the warming center would be opened.

CAP agreed to supply blankets and hot chocolate. The Legion agreed to staff the center during periods of activation, including at night when it is most necessary on the Hill.

Post Commander Danny Richardson, who was involved in the original negotiations with CAP, said the center was not intended to be an overnight residence for homeless, but would be used as a warming center when opened under the agreed activation protocols.

In January 2016, CAP and the county's Health Department moved the warming center to Town Hall, which is not open at night. "We were never officially notified the center would be moved," said Richardson. "Somebody just decided it should be moved and it was moved. We were ready to continue. I tried to explain that having it at Town Hall made no sense since it isn't open at night, and we could be and we had volunteers in place to staff the warming center."

Jose Arballo Jr., Riverside Public Health public information officer, speaking for CAP, said, "The reason the center was moved was because we could not work out an agreement with the American Legion."

"That is not true," said Richardson. "We were prepared to continue."

Nancy Layton, who with Richardson was involved in the 2010 and 2011 negotiations to establish the warming center at the Legion and create activation protocols, said, "It was a fait accompli. They just moved it. When it was pulled, we were in the process of creating a warming center manual and had a committee of people in place to run it. The nuts and bolts were in place."

Layton commented that CAP is off the Hill, not in touch with Idyllwild winter temperatures and, therefore, not in the best position to understand Hill needs or activate an Idyllwild Warming Center based on CAP off-Hill standards and protocols. "We [Hill residents] were the ones, along with the [Idyllwild] Fire Department, who were capable of making those [activation] decisions and we had protocols in place for doing so."

Layton and husband Rick Foster are moving off the Hill for health reasons but Richardson and the Legion remain committed to assisting Idyllwild residents and providing a viable warming center that meets Idyllwild winter conditions.

Richardson, who has been post commander for the past three years, said the Legion believes hosting a warming center that can be open in the evenings would best serve the community, even if it is on an "unofficial" basis. "We still have emergency firewood we stocked in to give to people who came to the center — not a cord or anything, but enough to help them for a few days. And we've bought stuff for stew and other food to make available to those coming to the warming center."

Richardson said those who use the center are expected to respect post property. "We did have one incident with a homeless man who came to use the warming center but became unruly and started throwing things around," said Richardson. "He was asked to leave, but that is the only incident like that we had."

So "official" or not, Richardson said the Legion will provide a viable warming center that could be open when most needed.

Meanwhile, according to Arballo, the agreement CAP has with Town Hall is likely to expire at the end of December and that, as of this writing, there is no "official" CAP warming center alternative for 2017.

Arballo said Town Hall was used from mid-January to March and logged in 20 warming-center visitors during that period. Arballo also noted that there were

Jack and I flew to Oakland last Thursday morning to pick up the BART to ride into San Francisco. The California Press Foundation's 139th Winter Meeting takes place annually the first week of December at the Marines' Memorial Club.

Thursday night, we attended an awards ceremony there and listened to speaker David Talbot, author of "The Devil's Chessboard," speak about concerns of a threat to a free press because of the upcoming presidential term.

I imagine that this fire and some investigative journalism will bring an awareness to the nation of the extreme rising costs of living in the Bay Area, particularly in SF, making it nearly impossible for people to find affordable housing.

Journalists are professionals who work hard to inform us, but their pay is low. So, when you're out there blaming the media about everything wrong in your world, ask yourself how you will know if journalists are silenced.

## Not in Pine Cove's backyard

EDITOR:

I believe using its counsel at Ellison Schneider and Harris, IWD failed to demonstrate ownership by perfection



of its claimed 100-year-old pre-1914 water right to Strawberry Creek and by permit to their 60-year-old Foster Lake impound of Strawberry Creek based upon my knowledge of investigations and statements by the State Water Resources Control Board and John Cook. I believe it hides behind a failed and

continuing bluff.

This is why I believe they want to re-purpose Foster Lake as a treated wastewater impound and injection site. IWD just purchased property in Dutch Flats explicitly stated for this purpose. The only problem is that Pine Cove has at least four high-quality, high-production granite aquifer wells hydraulically down gradient near and below Foster Lake, not to mention lake and creek swimming a short distance away downstream. Nutrient loads, and deadly biologic contaminants, including the polio virus, make this a deal breaker, regardless how low the state allows the presence of these dangerous contaminants short of zero.

Here's why: They don't exist now so why introduce these highly toxic contaminants ever?

As Pine Cove property owners, we didn't buy our homes knowing this and we aren't afforded the right to vote within the IWD opposing this matter.

Keep Idyllwild's treated sewage wastewater out of Dutch Flats' and Pine Cove's drinking water.

And if you show them that it's not appreciated, then eventually they'll realize that what they're doing is not acceptable. ... But there's just this instinct to conform to the crowd, and to just keep laughing, and to tell yourself that the kid's ok, even though you know ... that this is going to have a real negative effect on this child."

I am impressed at how intelligent and socially adept the children of Idyllwild are. Bullying is probably relatively unknown on our Hill and when encountered, I bet our kids know how to respond.

But our kids don't stay safely ensconced on this Hill. At a critical point in their young lives, they must begin to negotiate very different environments with varying rules of engagement.

Bullying is so widespread nationally that it is being treated as a public health problem. Twenty percent of high schoolers stated they had been bullied on school property within the 12-month period preceding a national survey completed in 2015, and 16 percent reported being bullied electronically during that same period. Nationally, schools are required to establish anti-bullying programs but this is all a work in progress.

Bullying is unwanted, repetitive, aggressive behavior — physical, verbal or social — occurring face-to-face or electronically as in "cyberbullying." Bullies target those they perceive in some way as different and vulnerable.

As the quote from Hope Sanders expresses, bullies are often seeking attention themselves. They are encouraged when bullying succeeds in bringing them this attention.

Bullying is harmful. Being the victim is associated with depression, anxiety, sleep problems and poor school adjustment. Interestingly, being the bully is associated with substance use, academic problems and violence. Being both, known as "bully-victim," is associated with even more serious consequences.

You will not be surprised by the fact that open communication between parents and children plays a critical role here. Learn the signs of victimization and perpetration. Begin a calm discussion early if you suspect, or if your child lets you know, that bullying is going on or even that she or he has witnessed it happening to others. Don't minimize it or make excuses.

Implement cell phone and Internet use contracts with your children. Demonstrate that you will intervene rationally and logically and not "freak out." (When parents freak out, it's truly disturbing to children).

Discuss specific tactics to help your child to manage in the moment, even if the child is a witness only. Discuss pros and cons of different ways your child can react in the moment.

Which of their behaviors as a bystander might inadvertently condone bullying. Focus on this as an opportunity for your child to establish healthy boundaries in social relationships. This is a chance to develop empathy and compassion, as well as good citizenship in the context of a broad community.

## Bald Eagle counts start this weekend

The U. S. Forest Service has scheduled its four bald eagle counts for this winter. All counts will be on the Saturday mornings of Dec. 10, Jan. 14, Feb. 11 and March 11.

Migrating eagles typically begin arriving in the area in late November and leave in late March or early April. During the winter, Southern California bald eagles are typically found at many of the lakes, including Big Bear Lake, Baldwin Lake, Silverwood Lake, Lake Arrowhead, Green Valley Lake and Grass Valley Lake in the San Bernardino Mountains, and Prado Dam, Lake Perris, Lake Hemet, Lake Skinner, Diamond Valley Lake, Lake Matthews and the Salton Sea to the south.

The Forest Service stresses that no experience is necessary. Signing up ahead of time is not required either. Volunteers may just show up at the designated time and location. Dress should be warm to accommodate morning temperatures, and binoculars and a watch will be helpful.

Brief orientations are held prior to the count so volunteers know where to go and what to do.

Through radio-tracking of the bald eagles, biologists learned that some of the same individual eagles migrate year after year to the San Bernardino Mountains from Montana, Wyoming, Idaho and Canada. Some of the San Bernardino Mountains' eagles were tracked all the way to Alberta and the Northwest Territories in Canada — about 2,000 miles one-way — according to Ann Bowers, the San Jacinto Ranger District biologist.

"Breeding populations of bald eagles in Southern California were wiped out in the late 1950s. Since 2003, several pairs of bald eagles have decided that our Southern California neighborhoods were too nice to leave — they built nests and have successfully raised families. Nesting bald eagles are now found at Lake Hemet, Lake Skinner, Lake Matthews and Big Bear Lake," Bowers wrote in an email.

"K-02, a female eagle hatched at San Francisco Zoo in 2000, was released on Catalina Island as part of reintroduction efforts. In 2004, she arrived at Lake Hemet, took up year-round residence with the male bald eagle that was already there," Bowers wrote. The pair hatched and raised eaglet chicks for years.

During the 2014-15 nesting season, Forest Service staff at San Jacinto Ranger District noted that K-02 had not been sighted since March 2014. In December of 2014, two bald eagles were observed at Lake Hemet, neither one bearing tags.

In April 2015, K-02 was spotted flying over Lake Palmdale, confirming that the two eagles now residing at Lake Hemet were likely to be a new male and female pair. Although the new pair of eagles exhibited breeding behavior, such as incubating the nest, no offspring were observed until the 2015-16 nesting season. The parents have successfully fledged their first chick, according to Bowers.

As bald eagles raise families in Southern California, it is now possible to see bald eagles year-round (not just during winter migrations). Because of the influx of migrating bald eagles during the winter, the easiest time to see eagles is still between December and March.

The bald eagle count is a wonderful opportunity to catch a glimpse of the breath-taking national symbol.

The local count will be at Lake Hemet. Volunteers should meet at the Lake Hemet Grocery Store at 8:30 a.m. Saturday, Dec. 10, for orientation. Contact Ann Bowers ([annbowers@fs.fed.us](mailto:annbowers@fs.fed.us) or 909-382-2935) for more information.

# Drought with bark beetles has taken grave toll on state forests

Five years of drought has made most of us conscious of our water use, and more aware of rain and snow. Limitations on lawn watering and car washing may have even created some inconveniences.

But the state's forests have suffered a significant toll during this period. Last month, the U.S. Forest Service reported that since 2010, more than 100 million trees have died from the drought and bark beetle attacks. Nearly one-third have died since May, according to the Forest Service's aerial surveys of nearly 4.5 million acres of the state's forest lands, almost all in Northern California.

Also, millions more trees are threatened from lack of water and insects. Until more rainfall occurs, the trees remain endangered and the number of dying trees will continue to increase.

In response, the Forest Service has moved nearly \$43 million within its budget to conduct safety-focused restoration projects along roads, trails and recreation sites. The San Bernardino National Forest's budget for fuels mitigation work has remained steady at \$2.3 million, according to John Miller, public affairs officer for the forest.

The drought also makes it more difficult for the state's pines to stave off attacks from insects, especially the bark beetle, which also has been a major contributor to the forests' thinning. According to the Forest Service reports, "... tree health is in serious decline, often com-

promised by the existence of too many trees competing for limited resources, especially water."

However, the growing number of dead trees is not significantly increasing the threat of wildland fires, according to the Forest Service. "Typically, beetle-killed trees shed their needles within a few months of dying, so they don't create as big a threat to fire spread as expected. However, high amounts of dead trees do present a threat of spotting when a forest fire is burning around them. Once trees fall, a fire could potentially burn longer and hotter, damaging soils and adversely affecting the site in the long-term."

Once the beetles have infested a tree, there is little to do. But the agency is trying to improve the forest conditions by reducing competition for vital resources through expansion of its thinning programs.

# County fire lifts fire limitations

Re-opens areas closed for fire threats

With the arrival of winter and several rainstorms in the past two weeks, the Riverside County Fire Department lifted its burn suspension. The suspension was effective at 8 a.m. Monday, Dec. 5.

According to its press release, "... CAL FIRE Riverside Unit Chief John R. Hawkins is formally cancelling the burn permit suspension and advises that those possessing current and valid agriculture and residential burn permits can now resume burning on permissible burn days."

In addition, Hawkins reopened seven hazardous fire areas:

- Avery Canyon (Gibbel Road east of State Street in Hemet)
- North Mountain and Indian Canyon (San Jacinto area)
- Whitewater Canyon (Cabazon, north of Palm Springs)
- Nuevo/Lakeview (east of Menifee Road and San Jacinto Avenue)
- Minto (Sage)
- Reinhardt Canyon (north of Highway 74 and California Avenue in Hemet)
- Ramona Bowl and Bautista Canyon (southeast

Hemet)

Cal Fire burn permits are required for tumbleweed and commercial agricultural burning (along with an Air Quality Management District permit).

Landowners can contribute to reducing fire hazards when they burn residential piles safely, according to the press release, and is a crucial tool to decrease forest residue.

State, federal and local land management and fire agencies also will be using this window of opportunity to do prescribed burns aimed at improving forest health on private and public lands.

"Southern California is no stranger to increased fire danger risks from damaging Santa Ana winds," said Hawkins. "Residents must remain fire-ready even during winter months and take advantage of cooler days to harden your home against wildfire. Please visit the [www.readyforwildfire.org](http://www.readyforwildfire.org) website for step-by-step instructions to keep your family and home safe."

Day and overnight campers should check with their area state and county parks to verify if permit requirements are in place or have been lifted to have a campfire.



# Idyllwild Arts breaks new ground with original musical

'Welcome to Sleepy Hollow,' a musical thriller in two acts

Idyllwild Arts Academy Theatre Department breaks new ground with an original musical based on Washington Irving's short story "The Legend of Sleepy Hollow."

Heather Reba, IAA theater faculty and professional musical theater actor, wrote book, music and lyrics for "Welcome to Sleepy Hollow" and orchestrated her score for the IAA pit band. Reba is the show's musical director. Theater Arts Chair Bonnie Carpenter directs.

Reba adapted the short story, adding several characters and expanding the Irving tale into a two-act, 15-song musical, with ensemble numbers, duets and solos. "In many ways, it's a challenge for the students since this is a new piece with no prior production references with which they might be familiar," said Reba. "They have to spend more time developing character intent and theories to fully flesh out the character."

Adding to actor challenges is the fact that the production is being staged in the round in IAA's flexible space Rush Hall. "There are six entrance points into the space through the audience from which actors will enter and exit," observed Reba. "Also working in the round, rather than in proscenium [on stage], requires a different orientation to the audience and that, too, has been a learning experience for our student actors. It's also different to have the audience that close."

But as challenging as it is for IAA's acting ensemble, it will be especially exciting for the audience — actors entering through the audience, actors in close proximity to the audience and a feeling of being in the production rather than just observing it. Add to that the pleasure of hearing a new score for a musical for the first time.

Reba said part of her approach to the Sleepy Hollow book was to leave the ending ambiguous as it was in the Washington tale. What did happen to Ichabod Crane? Was the headless horseman a ghost or a disguised rival for a woman's hand? Who was the Woman in White?

"I wanted the audience to wonder about the ending, the mystery of what actually happened," said Reba. "People want closure and so did our actors, but it's also fun to come up with one's own theories of what happened in Sleepy Hollow."

Carpenter said she seized the opportunity to present Reba's new musical. "Having Heather Reba in our community presented a wonderful opportunity for our students to work directly with the creator of an original work," she noted. "Throughout the rehearsal process, the students have intentionally been included as observers and, when appropriate, a part of the conversations in order to understand the collaborative nature of working with contemporary works. It's not often the creative team is able to have a conversation with the playwright because she is in the room with the group."

Carpenter stressed this is the first fully staged musical to be presented in Rush Hall in the round. "Most of our produced musicals have happened in Bowman and this is a major departure from our norms," she said. "The kids experience a level of intimacy that is not typical of performing in a clearly defined proscenium space.

Allowing the audience of the show to become such an active part in the staging requires a level of trust between audience and actor.

"This production also marks a stronger commitment between the music and theater departments at Idyllwild Arts. Chris Reba, the music department chair, has provided great support both through student involvement and his own sound design experience. The six-piece pit band has two faculty and four students."

"Welcome to Sleepy Hollow" opens at 7:30 p.m. Thursday, Dec. 8, at Rush Hall on the IAA campus. Performances follow at 7:30 Friday, Dec. 9, and at 2 and 7:30 p.m. Saturday, Dec. 10. The production is open to the public with no charge for admission. Seating is limited in Rush Hall.

# Idyllwild Master Chorale serves up Vivaldi and jazz

First holiday fusion concert at the Lowman Concert Hall

The Idyllwild Master Chorale presents “Viva Vivaldi,” IMC’s always popular holiday fusion concert — serving up Antonio Vivaldi’s “Gloria” and other chorale confections and then, after intermission, a jubilant jazz holiday sampler.

And with choral music where dynamics matter, where pianissimo often goes unheard in many halls, Idyllwild’s new concert gem Lowman Concert Hall provides state-of-the-art acoustics.

This is the first time IMC will be staging its holiday concert at Lowman, and for lovers of choral music who want to hear and appreciate every subtlety, this will be a concert to remember. “Our humble first concert 41 years ago leads us today to the realization of the dream of many, including founders Max Krone and Robert Holmes, of a day in the future where musicians could thrive in a hall with excellent acoustics,” said Dwight “Buzz” Holmes, IMC artistic director and conductor. “Now that dream is a reality.” (Robert founded IMC and was Buzz’s father.)

In addition to Vivaldi’s “Gloria,” Holmes is also featuring a double bill of America’s leading contemporary choral composer Morten Lauridsen in “O Magnum Mysterium,” and “O Nata Lux” from his requiem “Lux Aeterna” (Eternal Light). Both are exquisite and harmonically evocative pairings of text and tonality — each a triumph of spirit and of light over dark.

IMC singers request Lauridsen’s music as often as Holmes can program it because of its ethereal beauty. There is something deeply moving about the way Lauridsen writes and arranges — where silence plays a part, and

tempo changes linger on shimmering chords and then gently move on.

Holmes’ connection to Lauridsen’s music runs deep. He studied composition with him at the University of Southern California where Lauridsen, 2007 Medal of Arts recipient, remains on faculty as Distinguished Professor of Composition. Also featured in the first half of “Viva Vivaldi” are Christmas pieces arranged by Robert Shaw, Alice Parker and Norman Luboff.

One of the reasons for the December concert’s popularity is the post-intermission jazz fusion segment. Marshall Hawkins grooves with his group of six, Sherry Williams and John Fleming vocally soothe and sizzle. Williams and the chorale join in a world premier of a John Rodby med-

ley arrangement of “Do You Hear What I Hear” and “Little Drummer Boy,” funded by a grant from the Idyllwild Community Fund.

The “Viva Vivaldi” entrée, side dishes and jazz desserts are served beginning at 7:30 p.m. Saturday, Dec. 17, and 1:30 p.m. Sunday, Dec. 18. 

## Dec. 15 Covered Cal deadline

regular election cycle in August 2017, when Cook's seat also is up for election.

In his recommendation to his board colleagues, Washington explained why he was interceding in water district business.

"Pursuant to Government Code section 1780, the Idyllwild Water District had sixty (60) days to call a special election or appoint individuals to fill the vacancies created by the resignation of Mr. Billman and Mr. Freitas. ... The Idyllwild Water District failed to call for a special election or fill the vacancies by appointment as allowed to do so under Government Code section 1780. As such, the oppor-

tunity to fill the vacancies by special election or appointment is now vested with the County's Board of Supervisors," he told his colleagues and then recommended Schelly and Sirkin for the vacancies.

"I'm honored," Sirkin said.

"It's a good group of people," said Schelly. "Now is time to make progress for the district."

Both Schelly and Sirkin feel that the board's immediate priority should be to find an interim general manager. A special board meeting, in anticipation of the appointments, has already been scheduled to interview applicants on Friday, Dec. 9.

Tank rental also remains the same at \$40 annually. First fill is \$1.29 a gallon. According to spokesperson Liz Martin, there is no ppg discount for an owner's tank. Martin noted the company had added an additional propane delivery truck to better serve Idyllwild. "Our community pricing at \$1.99 is the same price for everyone," said Martin.

SoCal is still at \$2.42 ppg and \$2.12 for an owner's tank fill. CEO Andrew Kotyuk said response from Crier readers to the 10-cent-per-gallon discount for veterans and for referrals has been strong. The 10-cent discount per vets is permanent. The referral discount is for the season, both for the party referred and the party making the referral.

Harry Javaherian at Diamond Valley sees no major changes from last year. "The refineries set the prices and when it's colder prices go up," he said. Javaherian offers no "first fill" specials. "That's just bait and switch," he noted. Diamond Valley ppg is now \$2.09, or \$1.84 for an owner's tank. "I cut into my margin a bit to lower our price per gallon," said Javaherian. Tank rental is \$50 annually. But if a customer signs up for three years, tank rental is \$30 annually — \$90 for three years as opposed to \$150. Javaherian said the three-year deal is because it's become difficult to collect tank rental from customers.

Dave Castaldo, AC Propane, said he'd have a better handle on how pricing may fluctuate over the season in about a week. For now, his ppg is \$2.39 and less for an owner's tank, depending on volume ordered. "It could be as low as \$1.99 for owner tank based on volume ordered," he said. Tank rental is \$59 per year with first year and tank set free.
