# No injuries, damage in 3.1 quake

Thursday morning, Aug. 17, an earthquake magnitude 3.1 occurred on the Morongo Indian Reservation just north of Cabazon and Banning. The quake was felt as far west as Riverside, south to Hemet and east to Cathedral City. Three residents from Idyllwild reported the quake and assigned it a value of "2-3," which the U.S. Geological Survey defines as "weak." Most responses seemed to describe it as a magnitude 2 quake. generally settled amicably among the settlers. Occasionally, guns entered the picture, as one did in early Wellman history. In 1897, Frank Wellman, then 39, married Clara Arnaiz, 13. They were one of the earliest families in the area. They had two children — Mary born in 1898 and Jim in 1901.

Known for his hard drinking and hot temper, an angry and drunken Wellman assaulted his wife in 1901. Fearing for her life and those of her two young children, Clara shot and killed her husband. She was exonerated by a jury. Widowed at 17, Clara later married Joe Hamilton. Together, they had four children and raised the two Wellman children, Mary and Jim.

Jim became a successful and respected cattleman, guide and big-game hunter. From 1931 to 1939, he served as area justice of the peace, mediating disputes and conducting marriage ceremonies among the early families whose names abound in area roads and valley locations.

Bud, born in 1921 to Jim and Elma Hall Wellman, was part of a can-do generation who lived through the Great Depression and World War II in a part of California relatively untouched by the conveniences of urban life. The pioneering spirits and ethical codes of these early settlers, living out their lives with hard work and integrity, are something rare in

today's developed and interconnected world. Bud was a World War II Navy veteran serving in the submarine service during the war. Before military service and returning to the family business of ranching and farming in Anza Valley, Wellman mined for gold in Alaska and was a heavy-equipment operator. He celebrated his 95th birthday with friends and family in Anza with friends last year. With his death on July 31, another member of the first families of Anza passes into history. A memorial was held on Saturday, Aug. 19, at the Hamilton Museum. Family, friends, the Southern California Patriot Guard Riders and the Hemet American Legion Post Color Guard attended to pay tribute to

# Idyllwild Water plans search for new general manager

The Idyllwild Water District directors last week formed a committee to begin the search for a permanent general manager, and to review and to adopt the job description for a field supervisor.

President Dr. Charles “Chip” Schelly appointed Director Steve Kunkle and himself to the Search Committee.

In other general manager business, the board approved interim General Manager Jack Hoagland’s request to reduce his monthly hours 25 percent from 120 to 90 hours per month. He will be working Monday, Wednesday and half of Friday, he told the board.

As part of the new employment agreement, Hoagland’s hourly wage will increase 6 percent to \$77.78 from \$73.33 per hour.

Hoagland has been the interim general manager since his appointment in December 2016. He currently is serving on the Rancho California Water District board and has more than 30 years experience working for, managing and consulting with Southern California water districts.

In response to a question about recruiting a permanent general manager,

Hoagland replied that he has been focusing on making the district “less dramatic” but “... recruiting will be a challenge to find qualified candidates.”

The field operator’s job description assigns this person as “... the chief waste-water plant operator and also total field, lead water person,” Hoagland told the board.

Kunkle recommended deferring approval of the description until the new general manager has been hired, so that person can make suggestions based on their management expectations.

Director Geoffrey Caine added, “I’d like to see a larger in-house capacity for laying line.” He and Director Peter Szabadi were concerned about the cost of the current pipeline replacement project and want to explore the option of doing more work with existing staff, such as Pine Cove Water District does.

However, Hoagland argued that IWD does not have enough staff or capability to undertake projects larger than emergencies. “This is an important economic discussion,” he advised the board. “We keep the current staff pretty busy.”

Both directors agreed that the issue needs further exploration, especially due to Hoagland’s estimate

last month that IWD has millions of dollars of pipe to replace over the next decade.

The board also discussed how it may take actions if two positions ever become vacant again, as has happened in the past. According to its legal counsel, in order for a water district to take action, California law requires it to have a majority of the board, not just a majority of active directors or a quorum.

If two vacancies exist, the three remaining directors must vote unanimously in order to approve any action.

Caine suggested that California code expects water districts to develop and approve their own bylaws. If the local bylaws specify that a majority of

active directors may take an action, then perhaps that would be lawful. His colleagues authorized him to discuss this option with the district’s counsel.

In financial business, Hosny Shouman, chief financial officer, reported net positive proceeds for the first month (July) of the new fiscal year, 2017-18. Water revenues exceeded costs by more than \$55,000 and sewer revenues were nearly \$10,000 more than costs during July.

Because of directors’ travel plans, the next two regular meetings have been re-scheduled. The September meeting will be 6 p.m. Wednesday, Sept. 27, rather than Sept. 20. The October meeting will be Wednesday, Oct. 25, rather than Oct. 18.

# Pine Cove Water revenue up

Water losses continue to plague district

The Pine Cove Water directors approved a new resolution reauthorizing its rebate policy and program last week.

Before the unanimous vote, General Manager Jerry Holldber described the differences between the new policy and the previous policy. For example, low-flow shower heads were deleted this year since the district includes them in the free water kits. Also, outside smart watering systems were deleted, too.

In financial business, Holldber reported that for fiscal year 2016-17, which ended June 30, the district had about \$290,000 available, of which about 20 percent was the result of earnings during the fiscal year.

The unexpected revenue came primarily from two sources: The signing bonus from renegotiating the contract with American Tower and the sale of six water meters last year.

When the fiscal year

ended, total revenue was about \$70,000 greater than costs.

This fall, Holldber plans to apply for several grants to help extend the pipeline, and water, to areas vulnerable to fire.

Holldber is working with the district’s engineer, John Egan, to develop some formulas for calculating the cost of water production. These will be used for possible future rate changes, he said.

In water business, Holldber reported that water use had exceeded 4 million gallons for the second consecutive month and the water loss was 25 percent.

In both June and July, water production was 20 percent greater than the same months in 2016.

While staff has scoured the district for potential leaks and discovered and repaired some, these are insufficient to explain the loss, he added.

“It’s probably the largest loss in any two-month period. We’ve spent many days looking for leaks,” Holldber said. Then added, “I think I have figured out where the loss has gone and why it happened. But more investigation needs to be done.”

# Fire commission happy with chief’s performance

The Idyllwild Fire Protection District Commission held a special meeting Tuesday evening, Aug. 15, to complete its performance review of Chief Patrick Reitz.

After the session, President Rhonda Andrewson reported that the commission is very pleased and happy with Reitz’s performance.

In particular, she mentioned his involvement with the Idyllwild community, relationship with the commission and management of the department’s staff.

“He has been dedicated to fire service for nearly 30 years,” she added.

On Monday, Reitz expressed his appreciation for

the support of the commission.

“I will continue to move forward with the business of the district and make improvements,” he added.

Reitz was appointed Idyllwild Fire chief five years ago in July 2012. He began his service here in August 2012. He came to Idyllwild from the Sheridan, Wyoming, where he was fire chief and emergency services director.

Reitz is originally from the Akron area in eastern Ohio, began his service as a volunteer firefighter, and then emergency medical technician and paramedic in 1989. From there, he migrated west, first to Washington, south to Oregon and then east to Wyoming, before joining the Idyllwild community.

# Catherine Dearing new Idyllwild Water director

Catherine Dearing was selected as the newest director of the Idyllwild Water District at the Aug. 16 meeting. The board unanimously chose Dearing to replace former Director Vic Sirkin, who resigned last month.

Besides Dearing, Sue Nash submitted a letter of interest to the board. After introducing the candidates, both were given an opportunity to make a statement.

In her introduction, Dearing said she has been an Idyllwild resident since 1976. This is her first foray into the public sector, although she has served on a hospital board before.

Stories about the adequacy of California’s phys-

ical infrastructure and the Oroville Dam problems in particular have motivated her to seek a seat on the local water board.

“We are responsible for our community,” she said. Then she related that after the last rate increase, a previous general manager had stated the funds were needed for new infrastructure.

“It never began and is not beginning,” she said. As a director, she wants to ensure that the district’s infrastructure is in good condition and improved for the community.

Nash’s statement was more brief: “Here is another qualified candidate,” and she offered to answer any questions posed to her.

Director Geoffrey Caine asked questions of both can-

didates. In particular, he asked Dearing about her interest since he had not seen her attend previous board meetings.

While she described herself as “never too much of a meeting person,” she added that she followed the board’s actions closely through the newspaper. She repeated her conversation about good infrastructure with previous district management and stressed, “I am really into infrastructure and intend to make them work.”

Caine asked Nash if she could work with the current board given her prior statements about its actions. In response, she explained that having been an attorney, one for a public body, she has had many instances of working with people — cli-

ents, co-counsel or judges — who had differing opinions.

“I respect the law,” she stated. “I want to follow procedural and substantive rules to get our job done.”

After time to contemplate the choice, President Dr. Charles “Chip” Schelly called for the question. Dearing was chosen. Her term will be until December 2019. In August 2019, she will have to stand for election for the remaining two years of this term.

After choosing Sirkin’s replacement on the board, the directors had to choose a vice president, since Sirkin was the vice president when he resigned. Only Director Peter Szabadi was nominated and elected unanimously 4-0-1. He abstained from voting.

If a publication doesn’t do all of these things, it may be something else, but it’s not a newspaper.

Why do we feel our Hill needs a newspaper? Well, to do all of those things we just mentioned above, but particularly because we have nine local public boards that are funded by our tax dollars, and they make decisions and recommenda-

## We must save the Town Crier

EDITOR:

Just received the July 27 issue that includes your column “Out Loud.” I am a voracious reader of print media, including the peerless Town Crier.

There are no equals that I’ve seen in my travels or libraries. While financial difficulties for the printed media are well known, it is shocking when it comes close to “home” in Idyllwild.

We all should recognize how important the Town Crier is to our communities and support it, with advertising — not just empty talk.

I just observed in March/April how advertising dropped in a dramatic way. We needed to have some repairs done to our local cabin. We found three licensed contractors advertising in the TC and we contacted all three (only) and have had one selected in April and all work done shortly. The point is now, in July, only one general contractor advertises — a two-third drop. Why?

Realtors, why don’t they all advertise in the TC? It would be in their interest to have the paper remain available on the Hill and off the Hill. Real shortsighted, penny-pinching operates here. They would be “hurt” greatly without the TC.

As far as comments/suggestions, I offer the following:  
1. The paper should have a physical presence. Online only availability will not work. I’ve seen magazines try but they ere gone in no time, for good. Regulars want paper copy.

tions as to how to spend even more of our tax monies — and what public services we get for them.

These nine boards are monitored by nobody but the Town Crier.

The old, traditional model for a community newspaper was to publish the news, sign up readers for subscriptions and sell advertising to local businesses. But subscriptions themselves never provide much revenue beyond paying for the postage to mail them out. A traditional community newspaper survives on advertising by local businesses.

When we began operating the Town Crier four years ago, it did not have enough business advertising to survive. So we tried a series of incentives in an attempt to attract advertising: We slashed our advertising prices by 25 percent, we offered full-color ads at no additional price, we tried a promotional magazine, we introduced contests and new columns and improved our games, and our office remained open seven days a week to serve the needs of visitors to our Hill, hoping that those visitors would increase business for our advertisers.

We tried “bundling” advertising in our various publications, providing more discounts for advertising in more than one publication. We changed printing companies and went to a broadsheet size because we knew it would produce a more reliable, better-quality newspaper with consistently sharper, more-colorful photos and ads, which it did. Seven months ago, we made the Town Crier “free on the Hill” with

2. If going to free distribution does not work, stop it immediately; it is not going to change.
3. The Community Calendar section is very helpful to the organizations and the readers. Ask for voluntary contributions from those listed.
4. Investigate the possibility of having individuals or organizations provide free, unpaid delivery service to distribution points. As I see, this might not have any obligations on the newspaper’s part.
5. “ ... the paper is critical to our community.” We must save it.

I appreciate you purchasing and “saving” the TC in 2013; please don’t give up.

free issues in each Hill mailbox, and the paper’s circulation went from about 2,350 to about 5,500 — more than 230 percent of what it had been previously — which meant more than twice as many eyes on our advertisers’ ads.

We published the Town Crier’s actual distribution and circulation numbers on page A4 every week, and we offered to share with potential advertisers the detailed records of our increased circulation.

We even made direct appeals to local businesses’ civic spirit, asking them to support the Town Crier for the benefit of our community, growing their businesses through advertising at the same time.

Although these efforts helped somewhat, they did not nearly produce the needed level of advertising from our local businesses. Some businesses say they can’t afford to advertise (?), others say they don’t need to advertise (!), and some give no explanation at all. But, whatever the reason, the traditional newspaper model does not work on our Hill anymore. So we must try something different.

So, beginning with the issue of Sept. 7, we can no longer provide the Town Crier free to Hill mailboxes.

We both are volunteers at the Town Crier, serving these years with no compensation. That was fine for us, but it means that when we retire, the Town Crier will retire with us, since nobody likely would want to acquire a newspaper that is viable only if the editor, proofreader, pickup/distribution man, light-duty handyman and occasional lawyer all are willing to work for free. And since Jack is 72, our retirement will be soon — not likely much later than this time next year; likely sooner than that. Our goal now is to quickly make the Town Crier financially viable so we can pass it on to other publishers wishing to operate a real newspaper for our Hill.

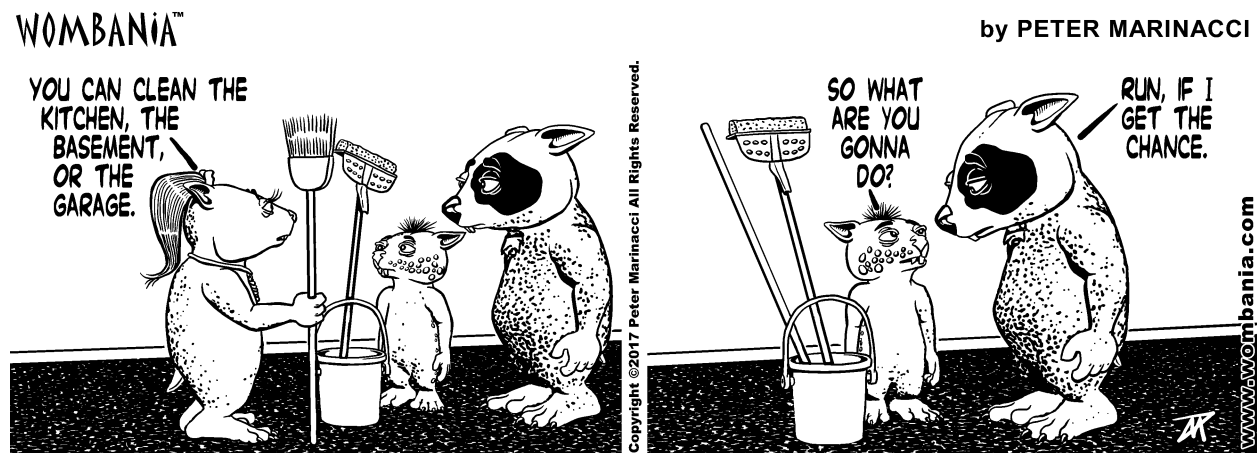

I am sure you've heard the buzz going around about opioid addiction or opioid use disorder.

First, sharing helping resources on the Hill, Mary Morse, executive director of Spirit Mountain Retreat, informs me our community offers 12-step help for opioid addiction through the "... Narcotics Anonymous program on Thursday evenings at 7:30 p.m. at the Spiritual Oneness Center on Cedar Street.... But anyone would be welcome at any of the 15+ Alcoholics Anonymous meetings on the Hill." (Also, see above websites). Many local psychotherapists also help.

Opioids are powerful and effective pain-killing medications. They are also highly addictive. (The statistics on opioid use or abuse in the U.S. are readily available elsewhere.)

The Diagnostic and Statistical Manual for Mental Disorders, Fifth Edition defines opioid use disorder as a "... problematic pattern of opioid use leading to clinically significant impairment or distress..." noted by behaviors leading to negative, life-changing outcomes. These usually include losing control over one's use of the drug and preoccupation with obtaining the drug. People become unable to live up to major obligations at home and at work. Some studies report a strong likelihood of a hereditary susceptibility to opioid dependence. In most U.S. cases, the drug is a recurring prescription

from a single physician (not obtained from drug dealers) to treat pain. Recently, it is especially given to treat chronic pain. Apparently, prescribers believe these drugs to somehow not be addictive when used for chronic pain. Prescribing practices became liberal. Many people get the drug free from a friend or relative.

On the other hand, illicit use often begins in the early teen years, along with cigarettes, alcohol and other drug experimentation.

Recently, the Centers for Disease Control released prescribing recommendations particularly for relief of chronic pain and stated that opioids should not be the first line of treatment. They encourage nonopioid pain relievers and non-pharmacological options.

Opioids mimic our own naturally occurring endorphins and, like them, effect a variety of body systems including:

- Pain
- Mood (decreased anxiety, euphoria)
- Motivation
- Stress
- Temperature
- Respiration
- Endocrine activity
- Gastrointestinal activity

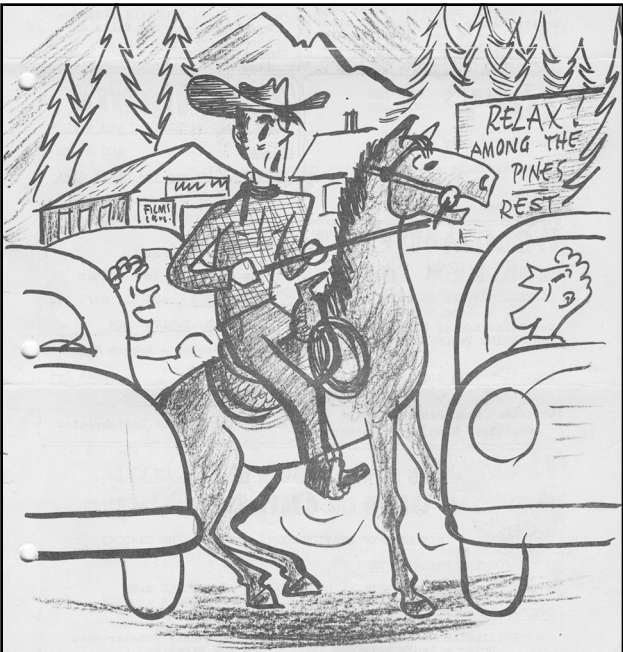
Overcoming opioid addiction is possible, but no easy task. Chronic pain still needs to be treated while managing addiction. Under-treating the pain is not an option.

Prescribers are turning to a combination of key medications, psychosocial therapy and 12-step programs. The medications include old, standby methadone plus newer buprenorphine.

Why treat with another drug that also causes dependence/tolerance? Methadone is legally used once per day. Once tolerance to it has developed, this drug has little effect on mood or judgment. The idea is that maintenance therapy manages addiction while improving destructive behaviors associated with out-of-control use.

Prognosis factors include access to medical care, whether employed, legal situation, education level, family status and other psychological difficulties. The above sites recommend straightforwardly informing the individual: that they're unable to use the opioid judiciously; that treatment must be accompanied by rehabilitation; to expect mood to suffer until stabilized; and to emphasize 12-step programs.

# Coop works to bring fiber optic internet to Mountain Center, Garner Valley and Pinyon

Members of the Anza Electric Cooperative, which services Aguanga, Anza, Pinyon down to UC Riverside's Deep Canyon Reserve, and Garner Valley to Mountain Center (covering more than 500 square miles), voted in 2015 to move forward with an ambitious project to bring "fiber-to-the-home" high-speed fiber optic internet to its member-owners. The new internet service is being called ConnectAnza.

Phase 1 of implementation began in 2015 with large parts of Anza and Aguanga online and other neighborhoods being built out now. But for members along the Highway 74 scenic byway, the wait continues as AEC works to get the California Public Utilities Commission to approve Phase 2 of the project.

AEC General Manager Kevin Short met with CPUC representatives on Aug. 2 to tour the Phase 1 project area and parts of the Phase 2 area, which straddles Highway 74 from Deep Canyon at the base of the Santa Rosas to Mountain Center.

Because of the scenic byway, ConnectAnza is required to undergo a California Environmental Quality Act review. "When we're proposing putting fiber optic wire on existing poles with existing wires, the CPUC still determines that is a new structure," Short explained, prompting CEQA jurisdiction.

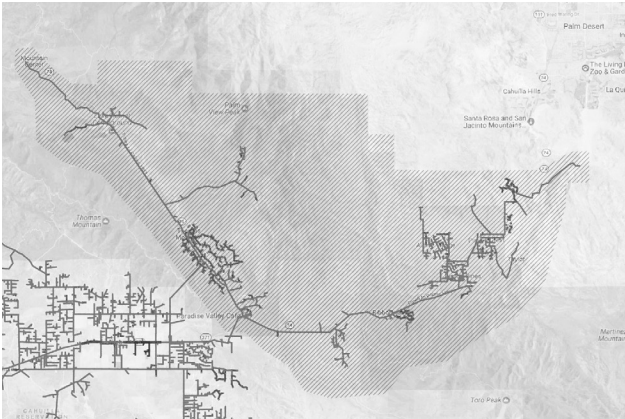
He said the cable being installed is about a half-inch in diameter. "The majority of our poles and cables are not even visible from the highway," he said.

Like Phase 1, Phase 2 would be funded primarily by a California Advanced Services Fund grant. CASF has identified rural areas within AEC's coverage as priority areas. Phase 2 (which covers about 200 square miles) will cost about \$3,689,000, with \$2,213,420 in CASF funding and \$1,475,613 coming from ConnectAnza.

ConnectAnza will offer speeds of 50 megabits per second of unlimited data at \$49 per month. Short is optimistic that the speed can expand to 1 gigabit per second within a year of being up and running.

ConnectAnza also provides free service to the area's fire stations and will offer free service to Camp Ronald McDonald in Mountain Center, which serves children with cancer and their families.

The main existing service provider for the area is Frontier, which acquired Verizon's internet customers

two years ago. When ConnectAnza applied for the funding, Frontier filed an appeal. But with the CASF requirements, Short explained, Frontier must show it can soon offer at least 6 megabits per second download speed and 1.5 megabits per second upload.

For one Garner Valley Frontier customer, myself, the upload speed on May 26 was 0.30 megabits per second and 1.07 mbps download. Frontier charges \$20 per month for internet when bundled with its Frontier Freedom Plan with a \$30-per-month phone service, making total the monthly charge after taxes and fees \$61.66.

Short is optimistic that with enough input from residents and after his meeting with the CPUC, the project will be deemed worthy and funding will come through.

He said he expects a decision from the CPUC within a month or two. Once Phase 2 gets the OK, and the CASF grant comes in, he said work could begin right away with some areas up as soon as two months from then. The grant allows two years maximum to complete the project.

# Lake Hemet Water defers GV rate vote

On Thursday evening, Aug. 17, the directors of the Lake Hemet Municipal Water District deferred making a decision on whether to increase water rates for Garner Valley customers.

After the public hearing on higher rates was held Aug. 10 at the Common Building in Garner Valley, the LHMWD board was scheduled to vote on Garner Valley and other district rates the following week.

After the meeting opened, President Frank Gorman said Director Rick Hoffman, who represents the Garner Valley area, wished to make a statement.

Referring to the previous week's meeting, Hoffman said, "It was a pretty good crowd and they requested in writing to delay the adoption of he Garner Valley increase."

"Based on the staff recommendation and my thoughts, I will make a motion to table the resolution," he announced.

The directors have asked General Manag-

er Tom Wagner and staff to re-visit the proposed rate changes. When that has been concluded, Hoffman said a hearing will be re-scheduled.

Gorman offered Garner Valley residents the opportunity to speak Thursday, but no questions were raised.

The rate-increase proposal, which was presented at the Aug. 10 public hearing, consolidated the five water tiers into one. Currently, water usage rates range from \$1.626 per 100 cubic feet (or about \$0.0021 per gallon) to \$3.711 per 100 cubic feet, when more than 250 cubic feet are consumed.

The proposal would unify the five tiers into one and the water cost would be \$2.54 per 100 cubic feet for the first year and rise to \$2.81 per 100 cubic feet in 2018.

In other business, Gorman announced that earlier in the day, the board had decided to promote Assistant General Manager Mike Gow to replace Wagner when he retires this fall.

# District Attorney withdraws death penalty in Pinyon homicides

The death penalty will not be considered in the Pinyon triple murder cases.

Riverside County District Attorney Michael Hestrin filed a notice that he would not seek the death penalty if defendant Robert Pape, 29, were found guilty.

In the Aug. 15 notice, Hestrin wrote "... after review of all facts and circumstances underlying the charges in [this] case and the defendant's background, the People do not intend to seek capital punishment for defendant Robert Lars Pape."

Hestrin did qualify that this notice was based on information known at

this time. "If new information is made available, this decision may be reconsidered," he added.

Co-defendant Christin Smith, 28, was a minor at the time of the crimes and the death penalty cannot be applied to him.

The next hearing is scheduled for November. Smith has several other motions pending before the court.

The murders of Jon Hayward, Vicki Friedli, and Vicki's daughter, Becky, occurred on Sept. 17, 2006, in Pinyon Pines. Becky's body was found burning in a wheelbarrow outside the house. The other bodies were found inside the burning home.

department to maintain current staffing. "It won't fund new positions, just maintain the status quo."

Further reductions, which have already decimated staffing for the unincorporated areas, will stop. "It will be 18 months to two years to repair the damage," Sniff said.

But staffing for the Benoit center has not started and new staff must go through months of training before they can take on these types of assignments, including patrol.

The press release emphasized that "Patrol staffing in the County's unincorporated areas is set through discretionary funding established each year by the Riverside County Board of Supervisors ... the Sheriff's countywide workforce has been reduced by 10 percent over the past two years to meet sharply reduced bud-

get targets for the agency as the County grapples with its stark fiscal challenges."

When the County budget results in reductions for the Sheriff's Department, staffing in the unincorporated areas and jails absorb the brunt of the cuts. The support to the contract cities cannot be reduced, since the cities, such as San Jacinto, are paying for that specific staffing level.

Altogether, the sheriff is responsible for policing nearly 1.4 million residents of the county's population of about 2.4 million. Annually, Sheriff's Department dispatchers receive more than 1.6 million phone calls from the public and dispatch nearly 900,000 calls for service, with nearly a third being in-progress calls for service, according to the press release.

FVWD. The cost of production from the surface collection is less than producing water from wells, Krieger said.

"No matter how much water we sell, it will be more difficult to justify tiers for conservation," General Manager Victor Jimenez told the board. He was referring to the 2015 state Appeals case, Capistrano Taxpayers Association Inc. vs. City of San Juan Capistrano.

The committee also recommended that the district establish specific reserve categories, such as operations and equipment, rather than just one general reserve account.

A second workshop is tentatively planned for September. If the board is fully satisfied, it will proceed with a Proposition 218 notification and public hearing before the end of 2017, according to Krieger.

During the regular meeting, Jimenez reported

that the preliminary balance for fiscal year 2016-17, which ended on June 30, was slightly more than \$200,000.

Contributing to this positive result, according to Jimenez, was the low level of capital investment this year. During fiscal year 2016-17, capital expenses were about \$125,000. In 2017-18, the capital budget is projected to be \$455,000, and remains at that level then increases for the next decade.

"If we don't maintain the system, we'll be like Los Angeles in the news weekly [about water leaks]," Jimenez said.

In water business, Jimenez reported that the water level of the office monitoring well dropped more than 18 inches in July and flow in Strawberry Creek has nearly stopped. Consequently, water production in August and early fall will rely more on the wells.

# After testing, health officials not worried about TB at school

Last week, the Town Crier reported an active tuberculosis case affecting a Tahquitz High School student in Hemet.

On Thursday, Aug. 17, Riverside County Public Health Officer Dr. Cameron Kaiser determined that tuberculosis test results from the clinic held at Tahquitz High School from approximately 150 students were within expected levels that health officials expect to find in the general public.

At this time, testing will not be expanded to other students or staff, Kaiser said.

The testing was done after a student was recently diagnosed with active TB. The student is receiving treatment and is expected to recover. The student is not being identified due to confidentiality requirements.

The other students were given skin tests Tuesday, Aug. 15, and results were read Thursday, Aug. 17, at the school. A positive test result means the person had been exposed to TB at some time in the past, but does not necessarily mean the person has an active case of the disease.

Those who tested positive will get a chest X-ray and follow up with an appropriate provider. The X-ray will help determine whether an individual might have a latent TB infection, which is not contagious, rather than active TB.

# Idyllwild Actors Theatre presents ‘The Gin Game’

## Conversations over gin rummy in Pulitzer Prize-winning play

Who wants to wind up in a nursing home and how does one adapt to the stasis and inactivity?

In the 1978 Pulitzer Prize-winning play “The Gin Game,” two elderly residents, bored with the residence routine, strike up a friendship. He offers to teach her gin rummy. She wins every hand. He becomes frustrated, she gains confidence.

While playing, they share conversations about their lives. The conversations also become increasingly com-

petitive, as both probe for weaknesses in each other and in the game. As their card games heat up, so do their battles of words and wit. If others at the nursing home are dozing off in easy chairs, these two are wide awake and fiercely focused.

Idyllwild Actors Theatre presents “The Gin Game,” starring two pedigreed performers — off-Broadway veteran Kathleen Walker, who starred in last year’s well-received IAT production “On Golden Pond,” and Ramona Pageant, stage and movie veteran Allen Purchis.

“The Gin Game” was the first play written by Donald L. Coburn and the first produced by American Theatre Arts in its initial production in Los Angeles. By way of the Actors Theatre of Louisville, Long Wharf Theatre in New Haven and the Wilbur Theatre in Boston, “The Gin Game” migrated to Broadway. It opened at the John Golden Theatre in

October 1977, directed by Mike Nichols. It played for 517 performances and closed in December 1978. It was nominated for Drama Desk and Tony awards, scoring a Tony Award Best Actress in a Play win for Jessica Tandy.

Her husband, Hume Cronyn, with whom she often appeared, was nominated for Best Actor Drama Desk and Tony Awards. This first play by new playwright Coburn scored a Pulitzer, with judges noting, “The one play ... of sufficient originality, invention and staying power was ‘The Gin Game.’”

# Tanzania village touches Idyllwild residents

Marshall Hawkins has had, by all accounts, a very eventful life, including touring with well-known entertainers and teaching students who would succeed in many aspects of life. The wisdom and grace he radiates certainly qualifies him to be Idyllwild's ambassador-at-large.

Therefore, when he says that his experience travelling to Tanzania with the Karimu Foundation was a life-changing event, it is very meaningful, and you pay attention. And when Marianne Kent-Stoll and Don Stoll discuss the 10th anniversary of the charity they founded, you begin to understand what it has accomplished, the people that have been helped, the friendships that have been created and the number of people who feel like Marshall does.

Marianne is assistant head of school and Don is manager of communications and international student relations at Idyllwild Arts where Marshall is head of the Jazz Department. The couple went to Tanzania as tourists in 2007 and stayed at a home in the village of Dareda Kati. Their retelling indicates they were overwhelmed with the warmth of the villagers who, in a short period of time, welcomed them as members of their family.

Ten years later, they fight back tears as they describe this first visit, knowing even then they would return of-

ten. The result was the Karimu Foundation, dedicated to helping the village with projects that could not be completed without outside help. They have accomplished much in the past 10 years, as portrayed on the foundation's web site [karimufoundation.org](http://karimufoundation.org). Marianne and Don gave a synopsis of this decade of friendship and mutual aid to the members of the Associates of the Idyllwild Arts Foundation at its monthly meeting on Thursday, Aug. 17, at Idyllwild Arts, after Hawkins gave his brief and moving introduction.

The first project of the foundation was an effort to im-

prove conditions for the students and teachers of the Ufani School. The results, as documented by photographs, were truly amazing. Using local experts, school buildings were built to offer protection from the elements and give students a proper environment in which to learn.

Also, housing was constructed so teachers could be recruited to this rural village from the cities that have more amenities to offer. An important part of the school construction was creating kitchen facilities that used efficient, ventilated stoves.

Respiratory disease is a significant cause of death in Tanzania because cooking fires were traditionally built inside homes and schools, resulting in the buildup of black tar on the walls of the buildings and in the lungs of the occupants. As an example, one of the school cooks had chronically inflamed eyes that cleared up after ventilated stoves were installed.

Another recent project was the construction of a bridge over a small stream that becomes a raging river during monsoon season. Without the bridge, it would take some students two hours to get to school; with the bridge, 15 minutes. Along with some of the other projects that have been completed, this has resulted in dramatic improvements in school attendance.

As with all of the foundation's projects, they are proposed by Dareda villagers and become joint efforts. The founders and board members of the foundation obviously take great pride in working with villagers, not just showering them with material goods they may or may not need or want.

If you want to know how to make a difference in our world, there is no better place to look than the Karimu Foundation, created by two individuals, born out of international partnerships and friendships, doing good and changing lives in both Idyllwild and Dareda Kati.

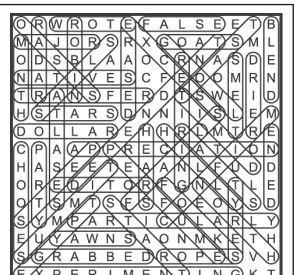

## Take precautions against high heat

With temperatures reaching triple-digits in parts of Riverside County, health officials are urging the community to take precautions against the heat and remind residents about the availability of cool centers located throughout the county. Idyllwild does not have a cool center, however. "High temperatures always present challenges, but the first heat wave of the year can be particularly dangerous since people may have forgotten the danger high temperatures can present," said Sarah Mack, director of Riverside University Health System-Public Health. "There are some simple precautions that people can take to protect themselves." Among the precautions, officials suggest residents drink water to prevent dehydration; avoid direct sunlight and stay indoors when possible; close blinds or curtains to minimize the heat; visit a mall, library or restaurant to stay cool; and make sure not to leave children, elderly, disabled individuals or pets inside unattended vehicles. Some of the signs of symptoms of heat-related illness are headache, dizziness, muscle weakness or cramps, and nausea and vomiting.

The principles are designed to minimize people's impact on nature while enjoying the outdoors responsibly. Visitors and residents are invited to this free talk.

## Drop & Shop reuse stores open

The Riverside County Department of Waste Resources will make good, reusable household products available for free to residents and businesses through the new Drop & Shop stores at the Lamb Canyon Landfill in Beaumont and Badlands Landfill in Moreno Valley. Many products collected through the Household Hazardous Waste Collection program are in good or unused condition and can be reused instead of processed for disposal. The Drop & Shop program is open from 6 a.m.-4:30 p.m. Saturdays at both landfills. Shoppers may take home used household, yard- and car-care products for free. Availability varies but may include: paint, cleaners, pool-, spa-, lawn-care and automotive products. Residents also may drop off common wastes like antifreeze, batteries, paint and used motor oil, and shop for free products at the same location. The program is funded by a grant from the Department of Resources Recycling and Recovery.
