## Capt. Purvis talks to community about crime

About 20 people took time from the busy Labor Day weekend to attend a not-widely announced public session with Capt. Leonard Purvis of the Riverside County Sheriff's Department's Hemet Station, who came to Idyllwild Saturday morning, Sept. 2, to discuss the local crime conditions.

He first visited with the Pine Cove Property Owners Association and later in the morning, he was the speaker at a community meeting held at Town Hall. About 20 residents, both full- and part-time, were interested in the topic, despite the heat and holiday activi-

Not only was Purvis here to answer questions, he wanted to learn about the concerns of Hill residents.

Initial fears were about organized gangs establishing a foothold in Idyllwild in order to

Purvis popped that balloon with his response that "... hasn't been on our radar. There is no major crime syndicate here. It's mostly a homeless issue and problem."

And he stressed that homelessness is not a crime, and he agreed as one audience member See Crime, page A2

## Supervisors take steps to begin cannabis legalization

## Ultimate decision depends upon 2018 tax vote

At the Aug. 29 board of supervisors meeting, the future regulation of the legal cannabis commerce within Riverside County was begun. However, as Supervisor Kevin Jeffries (1st District) emphasized, the future legalization of cannabis marketing will be totally dependent upon the approval of a tax measure on the November 2018 ballot.

The board, in a 3-0 vote, with Supervisor Marion Ashley (5th District) abstaining and Supervisor John Tavaglione (2nd District) absent, approved the recommendation of the Cannabis Ad Hoc Committee to direct staff to begin developing a comprehensive regulatory program for commercial cannabis.

As he introduced the recommendations of the ad hoc committee, of which he and Supervisor Chuck Washington (3rd District) are the members, Jeffries emphasized,

"I did not vote for Propo-

sition 64 nor am I a marijuana enthusiast or an advocate. But it is my opinion we have lost the war on cannabis in Riverside County. And it is time to start regulating it to protect our neighborhoods."

One of the reasons the ad hoc committee recommended the board move toward a legal, but regulated, cannabis industry, was the futility of banning it and trying to enforce the laws.

"I have five to nine illegal dispensaries within 2 miles of my house," he said. "It's like a whack-a-mole game for the county staff." He was sharing and repeating the frustration of many county residents, such as in Idyllwild, who oppose the presence of the dispensaries. Yet, they are in violation of a code-enforcement ordinance and their business is not a criminal venture.

"At the time, it appears to be a battle we are not winning," Washington lamented. Then he later added, "The most illuminative issue ... for me was the fact that whether we ban marijuana totally or regulate marijuana it is about the same level of staffing to fight marijuana growing and dispensaries in the county."

## Capturing flying squirrels on camera

## Nature Center meeting to discuss details

For local citizen scientists, Saturday, Sept. 9, is an opportunity to participate in regional wildlife study.

The San Diego Natural History Museum is asking local residents to help in efforts to identify whether the Southern California flying squirrel still resides in the San Jacinto Mountains. While several members of the species were captured on cameras during the past year in the San Bernardino Mountains, the San Jacinto Mountain squirrel has not been seen locally in decades.

The SDNHM will host a meeting at 1 p.m. Saturday, at the Idyllwild Nature Center. Brian Gibson of the museum's staff will describe the project and offer cameras to use to spot the squirrel if they are attracted to the neighborhood.

"In this first meeting, we will take a look at a slideshow outlining the history and design of the Flying Squirrels of Southern California study. We will assign you a camera and explain how to use it, as well as watch some instructional videos on camera installation and how to upload your data to iNaturalist,"

Gibson said. "Could it be that squirrels are already habituated to visiting these sites in the middle of the night undetected?"

For those with technical questions about the camera or its operation and location, Gibson will return the following weekend to help install the camera and bait station.



## September is National **Preparedness Month**

## Activities planned throughout county and Idyllwild

For those of you caught in the news of the Palmer Fire near Beaumont or the La Tuna Fire in the Verdugo Hills of Los Angeles or those who prefer rain, Hurricane Harvey or the impending Irma, Gov. Jerry Brown joined with the Federal Emergency Management Agency in declaring September National Preparedness Month.

The 2017 theme is "Disasters Don't Plan Ahead." The intent was explained in a FEMA press release earlier this month.

"Managed and sponsored by the Ready Campaign, National Preparedness Month is designed to raise awareness and encourage Americans to take steps to prepare for emergencies in their homes, schools, workplace, organizations, businesses and places of worship. National Preparedness Month is an opportunity to share emergency preparedness information and host activities across the country to help Americans understand what it truly means to be

And FEMA Administrator Craig Fugate said in the release, "Disasters don't always occur when we are together with our family and friends, and so it is important to take a few minutes now to plan what you will do in the event you are separated. It only takes a few minutes to talk through the greatest risks that can affect where you live, work or go to school. But by having that conversation or making a plan, families will have more confidence and be better prepared when the next event happens.

The California Office of Emergency Services has offered several suggestions for families to initiate plans in case of an emergency and steps to think about or issues of which to be aware. These can be found on its website at www.caloes. ca.gov/for-individuals-families.

The Riverside County Emergency Management Department has planned several events this month throughout the

EMD advises, "Looking at the evacuations taking place in East Texas, how would you let your family know you are safe? What would you take with you? Do you have copies of your important documents, such as prescriptions, insurance policies and important records?"

Locally, Mountain Disaster Preparedness is planning a community meeting Thursday, Sept. 28. The guest speaker will be Alex Tardy of the National Weather Service's San Diego Office. In 2015, he spoke to a full room of local residents about the forecast for a potential El Niño bringing winter rains.

stressed, "It's not just the homeless.'

Purvis said his staff will track the known criminals who are in jail and when they are released. This often follows a pattern of either fewer or more crimes.

But the recent spate of home and business crimes seem to be "crimes of opportunities, and frustration increases as crime is committed," he said. In the past, there were patterns related to the time of day, but "... it's happening all day now.'

The object of these break-ins, in Purvis's opinion, is to steal property, which can be converted to cash, necessary to buy drugs, including methamphetamine and even heroin. While the sources may be off the Hill, when the need exists, the individuals find a way to obtain the drug.

Treating the homeless compassionately and with empathy is appropriate. But a small number will take advantage of this assistance, according to Pur-

Individuals who frequently return for more or new clothing and utensils may be discarding them when they leave the Hill for drugs and need new supplies when they return, he advised.

When asked about the marijuana dispensaries in town, Purvis repeated that they are currently illegal. The Sheriff's Department and Code Enforcement are trying to stop them, but it is a misdemeanor and the sheriff doesn't have enough resources to constantly enforce the code ordinance when they must respond to crimes — bodily and property.

"Until a new county licensing process comes to fruition, any dispensaries in unincorporated areas are illegal," he said.

Before finishing, Purvis said citizens who believe a crime is occurring should call 951-776-1099 or 911 if it is an emergency.

dependent upon passage of the tax measure and residents from the whole county, not just the unincorporated areas will vote on it.

The intent is to create areas, such as near schools and neighborhoods, where the cannabis commerce would be banned. Jeffries also said there will be criterion for approval of license. For example, being "busted for an illegal dispensary or grow site" would prevent issuance of the license for some period.

Ashley expressed his mixed emotions about the action. "I'm really conflicted the way we're going. It is probably the best we can do, but I sure don't feel very happy about it." While he supports the availability of medical cannabis, he is concerned about recreational use, which is why he abstained from this vote.

## Straight-ahead and cutting-edge jazz held sway

## Ticket sales and attendance held steady

Straight-ahead and cutting-edge jazz held center stage at the Idyllwild 2017 Jazz in the Pines festival. Each of the three venues offered new acts and interesting arrangements and sounds.

And, according to John Newman, Idyllwild Arts Foundation director of business operations, ticket sales and attendance were remarkably consistent with last year's numbers. "Attendance was equal to last year," said Newman, "1,700 paid attendees through the gates Saturday [plus another few hundred volunteers, musicians, vendors and IAF staff], and around 1,200 paid attendees on Sunday."

Newman said net proceeds for scholarships were consistent with the last two years as well, but reports are still being finalized before any numbers are released to the IAF board. Newman added that combined ticket sales for the two days of this year's festival were within \$200 of last year, showing, in Newman's opinion, a strong level of consistent support from patrons and fans.



## Fire closed Highway 74 for afternoon

## Rouse Fire contained next day

The Rouse Fire, which started about 1:30 p.m. Wednesday, Aug. 30, near the U.S. Forest Service's Cranston Ranger Station, was contained the next evening. The fire's size was estimated to be about 14 acres, according to Lee Beyer, the USFS incident contact.

The fire started on the north side of Highway 74 near its junction with Bee Canyon Road. Then, spot fires ignited brush on the south side of the highway, causing its closure. Easterly winds pushed the fire west toward Forest Road 5S15 or Rouse Ridge Road, Beyer wrote.

During the initial firefighting Wednesday afternoon, the highway was closed in both directions. By evening, it was fully re-opened.

Matt Ahearn, battalion chief on the San Jacinto Ranger District, was the incident commander. The cause of the fire is under investigation, according to the USFS.



## **IWD** warns customers of phone scam

Several customers of the Idyllwild Water District have reported receiving telephone calls allegedly originating from the IWD office.

The caller ID is displayed at the IWD office number. When answered, the caller claims that they are with the water district.

The caller then instructs or asks the listener to use their phone's key pad to answer various ques-

IWD is alerting and warning customers and residents that this phone call is apparently a "phishing scam." IWD staff does not make calls requesting non-verbal responses.

IWD staff will call a customer for several reasons such as to advise that data indicates they may have a leak or to notify the customer that a water bill payment has not been received, which puts their service is in jeopardy of being discontinued.

If you receive a call purportedly from IWD and you feel the least bit uncomfortable, the district advises you to hang up and call our office immediately.

The Town Crier was the exception and became my primary source for almost all my "Hill" information. I turned to the Classified section and there I found all the information I needed. I hired contractors listed there to replace my septic system, replace the flooring, repair the plumbing and electrical, install a new roof, paint, sweep the chimney, repair the furnace and even an ongoing cleaning service.

We used the ads to learn which movies were playing and for help in choosing a restaurant. In 2012, the paper was filled with ads for local businesses. I would have been lost without that resource.

While reading the most recent edition, I noticed many fewer ads for local companies seeking my business. Why? Don't they still need or want new customers?

Our local paper is needed by everyone and, currently, the owners publish it at a financial loss. Where would the local businesses be financially if there were no local rag to advertise? If local businesses don't support our paper by taking out ads, how can it sustain itself? What will ultimately become of the businesses?

I believe our Hill communities need the Town Crier to survive. With no ads, businesses will fail; with fewer businesses, tourism will drop and more businesses will fail. Property values will drop and the local economy will

In case you missed it, the following is an updated version of the article originally published in the paper of Aug. 17:

#### Does the Town Crier have a future? Our readers must decide.

[UPDATED significantly on Aug. 22, Aug. 29 & Sept. 5]

On June 28, 2013, our small, close corporation purchased the Town Crier, which had not made any money during the previous four-and-one-half years. We had one objective: to save the newspaper on our Hill. We could not imagine our community without one. Three weeks later our online coverage of the Mountain Fire for Hill evacuees underscored that point.

What is a "newspaper"? A newspaper is a community watchdog that publishes the bad with the good. It warns of danger, advises of opportunity, challenges authority, praises accomplishment, investigates irregularity, marvels at art, exposes abuse, celebrates life and publishes its readers' letters. If a publication doesn't do all of these things, it may be something else, but it's not a newspaper.

Why does our Hill need a newspaper? Well, to do all of those things just mentioned — but particularly because we have nine local public boards that are funded by our tax dollars, and they make decisions and/or recommendations as to how to acquire and spend even more of our tax dollars and they determine what public services we get for them. These nine are: the Fern Valley, Idyllwild, Lake Hemet and Pine Cove water districts; County Service Areas 26 and 28; Idyllwild Fire Protection District Board of Commissioners and the IFPD Finance Committee; and the Idyllwild Historical Review Board.

These local agencies are monitored by nobody but the Town Crier.

The old, traditional model for a community newspaper was to publish the news, sign up readers for subscriptions and sell advertising to local businesses. But subscriptions themselves never provided much revenue beyond paying for the postage to mail them out. A traditional community newspaper survived on advertising by local businesses.

When we began operating the Town Crier four years

## **ANOTHER POINT OF VIEW**

#### Sixteen years ago, our world changed forever

To visit the site of the 9/11 attacks today, the National September 11 Memorial Plaza at the World Trade Center, is to see a country's spirit reborn and renewed with haunting tributes, graceful and soaring architecture, somber and beautiful museums, and the sound of water pouring from fountains outlining the bases of the two towers ----water that can be heard, at any time of day or night, over the noise and bustle of lower Manhattan, as a reminder.

At 8:46 Sept. 11, 16 years ago, the first plane struck the North Tower. It was the beginning of a coordinated attack that would down both skyscrapers, severely damage the Pentagon in an attack meant for the Capitol or White House, and send a fourth plane into a field in Pennsylvania as passengers united to take the plane back from hijackers.

It changed our country and was, along with Pearl Harbor, an attack that imbedded a new and lingering fear into each of us. Our oceans no longer provided the historic isolation and safety from foreign attack they had long provided. We discovered we were, and are, vulnerable.

Some reacted angrily denouncing Muslims and fostering suspicions of the "other" that continue to this day. Some sought to bring the county together — all races, all creeds, all religions — since, as a country of immigrants, we are all the "other," part of a rainbow American family.

Now, with the divisive election of 2016 behind us, and with the political rhetoric as divisive and heated as it has ever been, we are left to wonder what 9/11 taught us. Who are we today and how are we different from who we were before 9/11?

Many proclaim loudly with sanctimonious authority. Few listen. Cooperation and tolerance are victims.

In the shadow of the Twin Towers, there is a poem by Emma Lazarus on a bronze plaque in the pedestal of the Statue of Liberty that speaks of who we were, are and can perhaps still be as a country. On the 16th anniversary of 9/11, the poem speaks eloquently about what it is to be an

"Not like the brazen giant of Greek fame, With conquering limbs astride from land to land; Here at our sea-washed, sunset gates shall stand A mighty woman with a torch, whose flame Is the imprisoned lightning, and her name Mother of Exiles. From her beacon-hand Glows world-wide welcome; her mild eyes command The air-bridged harbor that twin cities frame. 'Keep ancient lands, your storied pomp!' cries she With silent lips. 'Give me your tired, your poor, Your huddled masses yearning to breathe free, The wretched refuse of your teeming shore. Send these, the homeless, tempest-tost to me, I lift my lamp beside the golden door!"

ago, it did not have enough business advertising to survive. So we tried a series of incentives in an attempt to attract advertising: We slashed our advertising prices by 25 percent. we offered full-color ads at no additional price, we tried publishing a promotional magazine, we introduced contests and new columns and improved our games, and our office remained open seven days a week as a Visitors Center to serve the needs of visitors to our Hill, hoping that serving them would increase business for our advertisers.

We tried "bundling" advertising in our various publications, providing deeper discounts for advertising in more than one publication. We changed printing companies and went to a broadsheet size because we knew it would produce a more reliable, better-quality newspaper with consistently sharper, more-colorful photos and ads, which it did.

Eight months ago, we made the Town Crier "free on the Hill" with free issues in each Hill mailbox, and the paper's circulation went from about 2,350 to about 5,500 — more than 230 percent of what it had been previously — which meant more than twice as many eyes on our advertisers'

We distributed Town Crier publications at more than 60 locations around the Hill which resulted in thousands more Town Crier newspapers, Explore Idyllwild Directories and Explore Idyllwild Maps in the hands of Hill visitors than

ever before. We published the Town Crier's actual distribution and circulation numbers on page A4 every week, and we offered to share with potential advertisers the detailed records of our increased distribution and circulation. We even appealed directly to local businesses' sense of

community spirit, asking them to support the Town Crier for the benefit of our whole community, growing their businesses through advertising at the same time.

Although these efforts helped somewhat, they did not produce nearly the needed level of advertising from our local businesses. Some businesses say they can't afford to advertise (?), others say they don't need to advertise (!), and some give no explanation at all. But, whatever the reason, the traditional advertiser-funded community newspaper model does not work on our Hill anymore. So we must try something different.

So, beginning with this issue, we can no longer provide the Town Crier free to the Hill.

We both are volunteers at the Town Crier, serving these years with no compensation. To be clear: no cash, wages, salaries, commissions, draws, advances, bonuses or dividends - no compensation of any type. (One month, we did try paying our publisher-editor minimum wage, but that lasted only one month. The paper couldn't afford it.) Whenever we dine out, or stay at a hotel or motel, it's all on our personal credit cards. The Town Crier cannot afford to budget for meals, travel or entertainment.



## Incumbents easily win re-election to Pine **Cove Water board**

Pine Cove voters continue to express their satisfaction with incumbents on the water district's board.

All three — Board President Robert Hewitt, Lou Padula and Joel Palmer — were easily re-elected to another four-year term. Challenger Jeffery Kleefisch finished with 60 votes (or 12.1 percent of the ballots cast), well behind the three incumbents who garnered more than 150 votes (or 29 percent) each.

Hewitt will begin his second four-year term. He has served on the board since 2012.

When learning of the election results, Hewitt wrote in an email, "I am grateful to the Pine Cove citizens for showing their confidence in the work we are doing at PCWD and look forward to continued success."

Padula, who was the leading vote getter, said, "I'm happy and glad all three got re-elected. The people want us to continue and we're a good team to keep going."

Padula was re-elected to his fourth full term. His first victory was in the 2005 election. Palmer will begin his third full term and has served on the board for 10 years.

Kleefisch is a relatively new full-time Pine Čove resident. He moved here as a full-time resident in 2015.

The county Registrar of Voters has not certified the current totals because any ballots with postmarks on or before Tuesday, Aug. 29, and received by Friday, Sept. 1, still have to be counted. The official final results will be announced Sept. 7.

## County and school district facing employee negotiations

## County union plans strike

The Labor Day weekend passed with the usually community events and political speeches throughout the nation and in California.

However, labor issues are coming to the forefront locally. Both Riverside County and Hemet Unified School District will be addressing them this fall.

Tuesday evening, Sept. 5, HUSD held a public hearing to receive the list of proposed issues from the Hemet Chapter of the California School Employees Association.

CSEA is separate from the Hemet Teachers Association, which signed a new contract with HUSD this spring after going through the impasse process. The new contract expires June 30, 2019.

The current CSEA contract expired last year. CSEA is proposing a new, three-year contract. The list of issues, the association wants to negotiate is three pages

Some of these, besides salaries and benefits, include leave time, use of building space, work schedules and evaluations. The county has already declared an impasse with

two of its labor groups. On Aug. 30, the county's labor counsel, Zappia Law Firm of Huntington Beach, wrote both Service Employees International Union Local 721 and Laborers' International Union of North America Local 777 informing them the county has declared an im-

The county also is negotiating a new contract with the Riverside Sheriff's Association.

SEIU, which represents about 7,300 of the county's roughly 20,000 employees, announced plans this week to go on strike starting Wednesday, Sept. 6.

Declaration of impasse begins a process that could lead to mediation if requested by a union. Then, there would be fact-finding," wrote county Public Information Officer Ray Smith in an email to the Town Crier.

"A person acceptable to the union and the county would hear both sides. If still no agreement at the end of fact-finding, the fact-finder would write a report that goes to the Board of Supervisors. The board members would could then direct staff to continue negotiating, impose terms, or do nothing," he said, adding that both sides might reach an agreement at any time during the mediation process.

In the letter to the two unions, Edward Zappia said the impasse was authorized because of "... parties' inability to reach agreement on numerous terms and conditions of employment after a year of negotiations and over 10s [sic] of bargaining sessions, and [the union's] failure to respond to the County's Last Best and Final offer issued back on July 12, 2017.'

The supervisors have had difficulty balancing the county budget for several years, and major salary or benefit increases will exacerbate their problem. But these employee groups have not had a new contract for several years.

The Associates of the Idyllwild Arts Foundation sponsors Spotlight on Leadership, a series at which faculty members, chairs of academic and arts departments, discuss their curricula, challenges and student projects.

At 10 a.m. Monday, Sept. 11, Inter Arts/Fashion Design Chair Abbie Bosworth with talk about the one major at Idyllwild Arts that integrates various artistic disciplines, giving students a broader scope of art studies.

The series is designed to familiarize Idyllwild residents with the school's academic and arts programs, and the challenges of teaching to an increasingly international student body. IAA's student enrollment is more than 50 percent international, with students from more than 30 countries attending the residential arts high school (ninth through 12th grade, as well as post-graduate students).

IAA provides pre-professional training in the arts and a comprehensive college preparatory curriculum. Majors include music, theater, dance, visual arts, creative writing, film and digital media, and inter arts/ fashion design.

Bosworth will talk about her department's approach to providing students with structured pathways to move between art forms. Ninth and tenth graders focus on different learning techniques inherent to specific art forms. Upper-class students focus on integrating several arts fields of study into a comprehensive, interdisciplinary project. Senior shows can take the form of gallery exhibitions, site specific

installations, performances, films, fashion shows or published texts.

Inter-arts students explore a variety of "pathways," finding their way through various areas of interest, including fashion design, design, storytelling, performance practice and digital communication.

Fashion design is a significant and growing component of the academy's arts programs. Students receive in-depth training from hand and machine sewing to fashion illustration, photography and conceptual design. Fashion shows take place each winter and

Storytelling, too, is a growing area of student interest, allowing students to explore writing fiction and non-fiction while working with other departments including creative writing, film, visual arts and theater.

Bosworth, with background as a writer, performer, director and teacher, is the ideal chair for the department. She is an engaging presenter and conversationalist. She teaches theater and creative writing at IAA and acting at Brockus Dance Conservatory in Redlands. She is a published playwright whose works have been performed at the Kennedy Center's American College Theatre Festival, Cal State San Bernardino and the Ruskin Group Theatre in Santa Monica where she is a member of the New Play Development program. She also is a teacher in the IAA Creative Writing Department.





## Third marijuana dispensary claims different objective

There are now three businesses in Idyllwild that in some form dispense medical marijuana or cannabis products. According to proprietors, they have different operational models and different objectives.

The latest, Higher Gardenz, according to spokesperson Mike Boris, is a non-profit 501(c)(3) cooperative run by a team of volunteers. Higher Gardenz shares a suite fronting Highway 243 near Village Market with two non-cannabis-based businesses.

Boris is a medical-marijuana educator who discusses the curative aspects of CBD topicals on FM stations in San Diego, Phoenix/Tempe and Las Vegas. He also writes for San Diego's Candid Chronicle to explain, in a confusion-prone market, how medical-marijuana topical salves and other products can be healthy treatment options for many chronic, pain-based conditions. Boris is a spokesperson for the cooperative, but not the senior manager.

Topicals are cannabis-infused lotions, balms and oils that are absorbed through the skin for localized relief of pain, soreness and inflammation. Because they're non-psychoactive, topicals are often chosen by patients, including the elderly, who want the therapeutic benefits of marijuana without the euphoria or disorientation of other delivery methods. According to cannabis educators, even if a topical contains active THC, it still won't induce the "high" one would get from smoking or ingesting cannabis.

Proponents claim cannabis salves can reduce muscle tension, unlock muscle spasms, and soothe aches and pains from stress and overwork. Those who, like proprietors of Higher Gardenz, say they are in business to serve medical needs, view themselves as healing cen-

Boris invites the Idyllwild public to visit Higher Gardenz to inquire about the benefits of medical cannabis. "Questions should never be met by confrontation, only by education," said Boris.

He said he is aware that attitudes regarding cannabis are shifting after statewide passage of Proposition nesses with the intention of complying with all applica-64. "It's a gray area," he said, when informed of the curble laws. Neither was aware of the county's current pro-

rent illegality of cannabis cooperatives under Riverside County's land-use regulations. He and others note the public pushback and campaigns against the evil of alcohol once prohibition was repealed. Many, including some medical practitioners, view potential for damage to the integrity of the body system to be greater with alcohol than with cannabis. Marijuana has been shown to relieve pain and ameliorate certain medical conditions, something which alcohol has not yet demonstrated.

County supervisors plan to put a measure on the November 2018 ballot to tax the sale of marijuana and cannabis products. The tax would fund regulatory efforts for cannabis in the unincorporated areas. If the tax passes, regulation could begin once measures and staff are in place to do so.

In the meantime, and this the board of supervisors stresses, until new regulatory ordinances are in place, any marijuana business, for medical or adult recreational use, is still prohibited in the county's unincorporated

The board stated, "... no permit of any type shall be issued for cannabis businesses or cannabis activities until the county adopts a comprehensive regulatory framework for medical and adult-use cannabis.

Within the space occupied by Higher Gardenz, two other businesses operate, sharing a pleasant and well-furnished reception room. One, Gardens of Wellness, is owned and operated by Leslie Scaramella Mays. Mays says she markets holistic healing products, such as essential and therapeutic oils, and a variety of diagnostic treatments. She said her line of Doterra oils are naturally powerful antioxidants that are 70 times more potent than and as pure as dried herbs. Mays also conducts foot detoxes, and skin scans and analyses through electrical stimuli.

The third business operating from the central suite is Bear Claw tattoo studio and Sea Miracle Super Food supplies. Owner Jamie Lachappa was not available for interview.

Boris said Higher Gardenz is Prop 215 compliant (the 1996 medical marijuana initiative) and both Boris and Mays stated they were operating their respective busi-

hibition of cannabis-based businesses in the unincorporated areas.

Whether sharing a single location with a central reception suite can negatively affect the non-cannabis-based businesses remains to be seen, since neither Code Enforcement nor the Sheriff's Department has visited or yet cited Higher Gardenz.


