

Idyllwild has best state test result in HUSD

Idyllwild School again led the Hemet Unified School District's performance on the California Assessment of Student Performance and Progress. The state exam was given last spring. The State Department of Education released individual school results last week.

The tests are English language arts and mathematics. The percentage of Idyllwild School students in all grades who met or exceeded the standards increased 3 percent for both subjects. In the whole Hemet district, for all students, the 2017 performance results declined slightly. Statewide, the similar results were about steady with 2016.

Idyllwild School easily led the HUSD results. More than 67 percent of the Idyllwild students in grades three through eight met or exceeded the English language

standards. Harmony Elementary had 49 percent of its students achieve the same levels. In the entire HUSD, 37 percent of the tested students met or exceeded the English standards.

For mathematics, the overall results were similar. Nearly 55 percent of the students met or exceeded the standards. See Result, page A8

IFPD settles employee litigation

As the first quarter of fiscal year 2017-18 ends, the Idyllwild Fire Protection District's financial consultant worked with its auditing team to prepare the audit from fiscal year 2016-17, which ended June 30. Consequently, he was unable to prepare any financial reports for the commission's review at its monthly meeting last week.

However, one long-term financial issue has been resolved. Fire Chief Patrick Reitz

announced a settlement in the two-and-half-year-old suit with former Capt. James Reyes.

The final amount has not been released, but Reitz said, "We came to a mutually agreed-upon settlement. The district is satisfied with a known outcome. We never stopped moving forward and can now put the energies of the case toward other things."

Reyes also confirmed that he has accepted a settlement. He is now with the Mohave Fire Department in Arizona.

In other business, the commission conducted its periodic review of agency policies. Six,

such as Purpose of Board Policies (1000) and Adoption or Amendment of Policies (1010), were approved with no changes and one with a minor amendment. The Purchasing Policy (3135) will be redrafted and brought back to the commission at its October meeting.

"This would be good when we're bigger," Reitz said. But as written, the policy is too cumbersome for the agency and the authorized vendor list needs to be made current, he added.



CDC recommends fewer shots
The Center for Disease Control now recommends that 11- to 12-year-olds receive two doses of human papillomavirus vaccine at least six months apart rather than the previously recommended three doses to protect against cancers caused by HPV infections. Teens and young adults who start the series later, at ages 15-26, will continue to need three doses of HPV vaccine. CDC Director Tom Frieden said, "This recommendation will make it simpler for parents to get their children protected in time." Generally, preteens receive HPV vaccine at the same time as whooping cough and meningitis vaccines. Adolescents ages 13-14 also are able to receive an HPV vaccination on the new two-dose schedule.

Idyllwild Water board becomes parsimonious

Declines to approve spending requests

Four of six action items on the Idyllwild Water District's agenda involved approval of recommendations from the general manager to purchase or proceed with actions that would require expenditures.

This month, the board decided to limit its expenses and only approved one recommendation — a contract to clean and video inspect the wastewater pipelines. The estimated cost is about \$137,000. Another \$26,000 may be necessary when IWD secures an encroachment permit from Caltrans in order to inspect 6,000 feet of sewer line along Highway 243.

Decisions on the other three projects were tabled or deferred until Interim General Manager Jack Hoagland develops a less costly and equally effective alternative.

For example, Hoagland presented a proposal from engineering firm Krieger and Stewart to design and repair facilities to measure the diversion from Strawberry Creek and the flow of Lily Creek into Foster Lake. These are new reporting requirements to the State Water Resources Control Board. This regulation is supposed to be implemented by Jan. 1, 2018, Hoagland added.

The estimated design work would cost about \$35,000, and construction of the facilities and installation of the measuring equipment would cost about another \$75,000.

The first comment from a board member was, "What happens if we don't have it done by Jan. 1?" asked Director Peter Szabadi. Hoagland replied that it's possible the

state could stop any further diversions because the district was not in compliance with the SWRCB regulation.

Szabadi commented, "\$100,000 seems high," and Director Catherine Dearing asked Hoagland if there was "... something between \$100,000 and this wreck [referring to the photo of a decade old weir]."

The board questioned the need to build a concrete weir rather than reconstructing a wooden structure and being prepared to replace it sometime in the future.

"We should just comply with the [regulation] and not try to be the best in the state," Szabadi concluded. So, Hoagland said he would have the firm reconsider the proposal.

A similar discussion occurred with the proposal to purchase a Caterpillar skid steer loader with accessories. The new equipment would cost about \$82,600, but the board again tabled the decision until the next meeting.

"My concern is we're spending a lot of money and this is not an essential item that you need now," Szabadi opined.

Then Director Steve Kunkle said, "I think what we have now is adequate. This is a 'want list' not a 'need list.' I can't see spending this amount of money."

The third item was a report from West Yost, evaluating the wastewater treatment plant and options for improvements. Hoagland commented, "With the existing unit, we are 50 years into the 35-to-40-year life," and added that the proposed changes "are not growth-inducing... but we need to move forward on a more reliable facility."

A new wastewater facility depending on the details would likely cost IWD about \$3 to \$4 million. Hoagland is hopeful state grant money will be available for a significant portion of the cost. So, he wanted board approval to continue developing plans for a treatment plant and

opening discussion with the state regarding finances.

Tom Paulek, an Idyllwild resident at the meeting, shared, "The proposal needs to be very well thought out even if it is a great cost. Take your time to get good information to evaluate the options."

The Board also was cautious about proceeding with this recommendation. "I feel part of the report is flawed," said Kunkle. "We've always been in compliance at the plant. I don't know what has happened. I don't think it is this plant but the operator ... It's a good start, but where do we go."

Szabadi expressed his disappointment with the report, also, while President Dr. Charles Schelly said, "I agree it's expensive, but always something to look at. If it stops working, we have no backup."

So, the board asked Hoagland to follow up with West Yost about its questions and suggestions offered during the discussion.

Before the meeting ended, Szabadi requested that the staff prepare a new rate study that would address how the district would pay for future costs, such as the projects discussed at this meeting, and how rate tiers should be approached.

Schelly requested that Hoagland present an analysis of the costs to the board of hiring three more staff members over the next 15 years and compare it to the costs of employing contractors to do most of the district's pipeline work.

Finally, he reported on the district's compliance with the Brown Act, California's open government law. After a discussion with the district's legal counsel, Schelly said, "We are confident that we are in complete compliance. But we acknowledge that we can do better than just compliance, and we want to encourage the vigorous airing and discussion of all issues at all of our events."

Preparedness needs preparation

Water supplies are critical

Shane Reichardt of the Riverside County Emergency Management Department was the guest speaker at the Sept. 28 Mountain Emergency Service Committee meeting.

September was National Preparedness Month. While it was nearly over when he spoke, Reichardt addressed the issue in the context of the recent emergencies created by hurricanes and earthquakes, one as close as Mexico.

He noted that a major difference between hurricanes and earthquakes is the amount of time preceding the event. Hurricanes can be seen coming — days, sometimes a week, before it arrives. This gives residents time to prepare. Earthquakes are the opposite. Even with the new earthquake-detection systems, the advance notice is limited to 1 or 2 minutes or less.

"In Southern California, with earthquakes and fire, there is little time for warning," Reichardt stressed. "Keep gas in your car and remember that utilities are easily and usually affected. Earthquake preparedness is a lot like fire."

Everyone needs a preparedness kit, with a change of clothes, bottles of water and important legal documents. Water is the key, he emphasized. Water mains can break and they are underground. It can take days to repair them, so it is important to have adequate water available.

"As an emergency manager, I'm most concerned about water infrastructure damage throughout Southern California," Reichardt said. "Even a temporary fix can take a while. Remember, you can't live without water."

CNBC reported that "the Metropolitan Water District of Southern California, a water wholesaler for nearly 19 million people, uses the Colorado River Aqueduct and said it could recover in six months from a disruption if there's

a big quake on the southern portion of the San Andreas fault." During the recovery, MWD's local reservoirs and groundwater would be interim water sources.

He urged everyone to have a plan for themselves and their families. Practicing how to implement the plan is important, too. He does this with his son, Reichardt said.

When asked how to convince people to prepare, he advised thinking of preparedness as a series of small tasks and not a big, long-term effort. First, gather supplies for two to three days, such as water, food and medicine. Then, add what you might be needed for another day, and continue to stretch your preparedness baskets into longer periods.

"[People] probably have the stuff, but it's spread throughout the house. Ask where the flashlight is and extra batteries?" he suggested.

Besides supplies, particularly water, he also emphasized knowing how to get emergency information. "Be informed. Knowing hazards and how to get information during an emergency or disaster can be critical," he added.

The common emergency responses are calling 911 and calling neighbors. But in a major emergency and disaster, phone lines can be exceeded. They require more bandwidth than text messages.

Consequently, he recommended having a set of emergency agencies that use Twitter to send messages, such as Cal Fire, California Highway Patrol, the Riverside County Sheriff's Department and EMD or websites with current information, such as the Town Crier or Idyllwild Area Emergencies. Facebook is less effective because, as Reichardt said, "It is very communication competitive." How quickly a message gets through depends on "likes" and the frequency of contact between two entities. Twitter distributes immediately and without favoritism.

If more information is necessary, these "tweets" will tell you what sites to visit, he added. He also recommended having somebody, such as family who live in another area or state, available whom you can call with status information and whom others can call to find out your situation or



condition.

Preparedness is a mindset, not a specific disaster, Reichardt concluded. For more information on preparedness, visit the EMD site at rivcoready.org.

EDITOR:


Enough is enough. Too much has been torn down already and torn apart. We must do something to keep our rights and liberties. I am so frustrated I could spit.

On weekends after a major snow, our village has been pummeled by snow-play visitors. Trespassing, streets clogged with illegally parked cars, littering and other nasty behaviors were rampant. With social media advertising Idyllwild as a snow-play destination and exploding populations on all sides of the Hill, the situation will likely continue.

Right now, Idyllwild has no defense against or provisions for snow-play visitors. Although the Snow Group continues to explore solutions with federal, state and county agencies, time and again we come to one conclusion: Idyllwild needs more law enforcement presence.

More deputies on the Hill handing out citations and initiating towing will send a clear message to misbehaving visitors that they must obey the law and respect the rights of area residents.

How can individuals help? Call the cops. It really is that simple. Capt. Leonard Purvis, Commander of the Hemet Sheriff’s Station, recommends that residents call whenever they observe illegal or dangerous activity, large or small. Those phone calls are counted and become statistics used to determine our deputy coverage.

Idyllwilders tend to be independent and self-reliant sorts. Yet, on this issue, we need to be vocal. If we quietly endure illegal, invasive behavior, we are part of the problem.

The Snow Group is launching a campaign: To Get More, Call More. We’ve had refrigerator magnets made bearing this motto along with the non-emergency phone numbers of the Sheriff’s Department and the California Highway Patrol.

We’ll hand out the free magnets to residents at the Idyllwild Post Office from 1 to 3 p.m. Friday, Oct. 6.

We also will be offering two types of signs to help residents deter snow-play visitors on their property. One sign can simply be stuck into your snow berm. Easy. The second is to mount on a post. They will be available at cost — \$4 and \$9.

The Pine Cove Property Owners Association and Brad Rechtfermig of Grand Idyllwild Lodge made donations, allowing us to give away the magnets for free.

Please do your part to bring more law enforcement presence to Idyllwild. Come to the Post Office Friday afternoon to get a magnet, and then make those calls.



California moves its Presidential Primary to March

Hoping for more sway in party choices

The California presidential primary is changing — again! Gov. Jerry Brown signed Senate Bill 568, which moves the California presidential primary to March. This is not the first time the Legislature has designated March as the time for the state to influence the selection of national presidential candidates.

The bill's name, "The Prime Time Primary Act," even suggests its intent. Beginning in January 2019, the state's "presidential primary" will be held on the first Tuesday after the first Monday in March of any year that is evenly divisible by four. The bill also moves the statewide primaries to March in even-numbered years.

While Brown made no statement when he signed the bill, California's Secretary of State Alex Padilla said, "The Golden State will no longer be relegated to last place in the presidential nominating process. California's primary will officially be in prime time ... The Prime Time Primary Act will help ensure that issues important to Californians are prioritized by presidential candidates from all political parties."

This is not the first effort to inject California to the front of the presidential race. In 1996 and 2000, the state's presidential primary was in March. By 2000, nine other states had already held their primary and 13 other states held their primary on the same day, according to the report from the Senate Committee on Elections and Constitutional Amendments.

In 2008, the California primary was in February for the presidential race but in June for state and local offices. Consequently, there were three statewide elections in 2008. By 2012, the presidential and state primaries returned to the first Tuesday after the first Monday in June.

Turnout in the presidential primaries peaked at more than 70 percent of registered voters in the two 1970s primaries. While it began to decline and was only 31 percent in the 2012 primary, it tends to be greater when neither major party has an incumbent on the ticket. The turnout in 2016 was nearly 48 percent. This was down from the nearly 58 percent in 2008 but



County approves \$800 million budget

At its Sept. 26 meeting, the Riverside County Board of Supervisors passed its final budget for fiscal year 2017-18 without any further discussion. The total budget from county revenue is about \$800 million, an \$8 million increase from County Executive Officer George Johnson's proposed budget in July.

"These increases will not prevent us from achieving structural balance next fiscal year, maintaining reserves above the \$150 million level, and achieving full replenishment by FY 20/21, while still preserving out-year capacity to address anticipated cost increases for the new detention center," Johnson wrote to the board.

He does not expect any uncommitted resources to be available for new programs for three years, in fiscal year 2020-21. Consequently, he told the board he cannot "recommend any further discretionary spending increases."

The total county budget, including state and federal funds, exceeds \$5.5 billion.

This increase was solely for the Sheriff's Department budget, bringing its total net county costs to about \$300 million. The District Attorney's Office budget is about \$100 million.

The board made no changes to Johnson's recommendations, which only included the \$8 million for the sheriff, which the board had agreed to in July.

greater than the turnouts in 2004 and 2012.

Opposition to the change, primarily the Peace and Freedom Party of California, emphasized the length and subsequent cost to the campaigns for state and Congressional offices from early March through early November. Further, to qualify for the March ballot, candidates would have to begin collecting signatures in September of the prior year.

Idyllwild's State Senator Jeff Stone strongly supports the primary shift. "California has long been a spectator with primaries," he lamented. "This puts California in play and will set the tone. We will be relevant."

Suspect in harpist's tip theft arrested

Michael Darendar Kellner, 24, of Idyllwild, was arrested at 6:51 p.m. Wednesday, Sept. 27, on Country Club Drive, on suspicion of a stealing a tip jar from Christian Chalifour, a harpist, performing outside in Strawberry Creek Square on Friday, Sept. 15. Chalifour said in a Facebook post that the tip jar con-

tained only "\$40 or so." The charge is a misdemeanor. However, Kellner was on probation resulting in a revocation of that condition, a felony charge, said Sgt. ence has been scheduled for 10:30 a.m. Friday, Oct. 6, in Riverside County Superior Court. "Frankly though, I'm moving on," said Chalifour.

Kellner has a significant background in criminal convictions, both misdemeanor and felony, in Riverside County ranging from burglary to narcotics possession.

According to court records, he goes by several aliases.

Operators of Perris medical marijuana dispensary get jail time

Thousands of dollars in fines, too

Operating a medical marijuana dispensary in the unincorporated areas of Riverside County is currently illegal. But it is a civil violation, a violation

of the county's land-use ordinance, not a criminal violation.

Nevertheless, on Sept. 21, a Riverside County judge directed "two men to spend five days in jail after they disobeyed a court order to close an illegal marijuana dispensary just outside Perris," according to a press release from Ray Smith, public information officer for Riverside County. They were

jailed for contempt in ignoring the court's previous order to close.

As part of the case, the court appointed a receiver to ensure the dispensary would be shut down.

This is one of 57 actions within the county to shut down illegal dispensaries. According to Smith, Riverside County has "... obtained settlements and judgments totaling \$5.7 million against illegal dis-

pensaries."

The defendants in the Perris case had already been ordered to pay \$34,000 in attorney's fees and code-enforcement abatement costs. Civil penalties of more than \$1 million also had been assessed against the dispensary's operators and property owners.

At 1:28 a.m. Sunday Oct. 1, Kohda French, 22, of Idyllwild, was driving a black 2009 Nissan Murano westbound on South Circle Drive 80 feet west of Wallace Way, when he made an unsafe turning movement and collided with a pine tree and a chainlink fence, causing damage to both. French was not injured in the incident.

percent of the Idyllwild students (grades three through eight) met or exceeded the math standards, compared to 23 percent of the whole district and 37.5 percent for the whole state.
At Idyllwild School, the percentage of students meeting or exceeding the test standards has increased in both 2016 and 2017 from the previous year. And in both years, the percentage has been greater than 50 percent.
However, HUSD saw the percentage of students meeting or exceeding these standards in the whole district decline in 2017 compared to last year. At the state level, there was a slight increase, but at both the district and state levels, the percentages were below 50 percent. For math, the percent of students meeting or exceeding standards was only 23 percent less than a year ago. The English language results also declined.
These results are disconcerting to some throughout the state, who felt the growth in state educational funding over the past five years and great-

er control of these funds at the local level would produce better results.
At Hemet High School, 56 percent of 11th graders met or exceeded the English language standards, but that was 11 percent less than in 2016. The math results were similar. In 2017, only 20 percent met or exceeded standards compared to 31 percent in 2016.
The tests consist of two parts: a computer adaptive assessment and a performance task. The computer assessment bases follow-up questions on a student's answers in real time and gives a more accurate picture of progress than paper-and-pencil, multiple choice tests. If a student answers a question correctly, they get a more difficult question. If they answer incorrectly, they get an easier question.
The performance task challenges students' ability to apply their knowledge and skills to problems in a real-world setting. The two parts measure depth of understanding, writing, research and problem-solving skills more thoroughly than the previous multiple-choice paper tests.

County Clerk of the Board has requested that the district update its conflict-of-interest policy. Every special district, including school districts, must submit a conflict-of-interest policy for the Riverside County Board of Supervisors' approval.

and rainfall, with superlatives — “driest, wettest, longest.”
He said without hesitation, “Things are extreme and out of whack. The trend is not our friend. Expect more extreme events — drier “dry” and wetter “wet.”
Nevertheless, when asked what kind of weather we should expect this winter, “I have no ‘frickin’ idea,” Tardy admitted succinctly.
MDP President Mike Feyder opened the session with his question about “the dry El Niño in 2015-16 and the wet La Niña in 2016-17.” But Tardy, with his maps and graphs, showed that those observations were both wrong and right.

A slight alteration in the jet stream two years ago sent most of the Pineapple Express storms to the north. “The atmosphere was angry and tried to make up for five years in one. And it almost did here and did in Northern California,” he said.
Seattle experienced its greatest rain ever that winter, according to Tardy. And this past winter, Southern California received as much total rain as it had for the previous three years together.
“From October [2016] to February 2017, for California, the average rainfall was 28 inches. That is the wettest ever,” Tardy said. “The Sierra Nevada area had 160 inches of rain and snow — more than twice the average.”
Meanwhile, in the past five years, Southern California has been experiencing both the driest period on record and the warmest years. Yet, the two wettest years were the ones that were supposed to be La Niñas — 2010-11 and 2016-17. Well more than 30 inches of rain fell in Idyllwild both years. (See accompanying table.)
The same was true in Riverside, Redlands and Big Bear, not just the microclimate of Idyllwild, according to Tardy.
“The drought was completely reversed in one winter,” Tardy stated. But it left a memory with millions of dead trees throughout California, he added.

“Not only has this been the driest period, but it's been the warmest period,” Tardy emphasized. “From 2013 through 2016, whether you look at 12-, 24-, 48- or 60-month periods, it's been the warmest period on record everywhere in Southern California.”

And the extremes continue unabated. Tardy showed that the average temperatures between June and July 2017 were “the warmest time ever seen.” There were 15 to 20 days with temperatures above 90 degrees. That is 6 to 8 degrees above normal, he added, “The all-time warmest period.”
“This was an unknown heat wave,” he said. “Palm Springs recorded four days when the temperature reached 122 degrees.” Even the low temperatures have been above normal.
Then he addressed some of the audience's concern that winter would bring snow and more visitors. While


Tardy said snowfalls won't stop, “it will be difficult for snow to keep on the ground. It will melt quicker.”
The average overnight winter low temperature was 35 degrees in 1950. “It keeps increasing,” he said. “Now it is about 40 degrees. In 60 years, the increase in the average low temp has been about 5-and-a-half degrees. The atmosphere is warmer. Winter will be shorter and warmer. It still may snow, but harder for snow to stay.”
“The temperatures, humidity, lack of snow are dangerous. They go hand in hand to make each other worse,” he concluded. “It's like we're making this stuff up. But four Category 5 hurricanes in one season, I don't know what it will bring us. It'll rain some, but look for more extremes.”
Forecasting three to five days in advance is possible and accurate, but three months out is increasingly difficult, according to Tardy.

Ernie Maxwell and his wife Betty founded the Town Crier in 1946. Until his death in 1996, Ernie was a leader in the community on conservation, art and education, among many causes. He would have been 105 years old on July 7, 2016.

Idyllwild's ghost town grows into a village

The Idyllwild Haunted Hotel moved to Lake Hemet and has expanded this year to a Haunted Village, complete with the Haunted Hotel, Boneyard Maze, Abandoned Mine and music stage featuring live bands every night.

A preview tour led by Young Idyllwild's Vice President Arn Hancock revealed an expanded Hotel, with additional themed rooms cast with actors, special effects and new animatronic characters.

Hundreds of shipping pallets came from all over the region and were stacked to build the new Boneyard Maze, which has its own cast of characters, those who couldn't find their way out.

And an Abandoned Mine will feature some subterranean thrills inside its cavernous walls.

After an adventure through the spooky features, visitors are invited to join the nightly Thriller Dance and "shake your bones" to live music.

"We were looking for a larger venue so we could expand and Town Hall couldn't give us enough time. It takes about a month to build it and it has to be open for at least a month," Kathy Wilson, president of Young Idyllwild, said.

Wilson approached Trish Purcell, regional marketing manager for CalParks Southern California region, which runs Lake Hemet Campground, Water Park and concessions, who welcomed Young Idyllwild's Halloween events.

"We know from experience with a Halloween event at Vail Lake that people love it," Purcell said. "We wanted to support Young Idyllwild's mission, providing opportu-

nities for youth in the community," she said, adding that this kind of event provides a unique experience for Lake Hemet visitors. "It just made sense. It's just a win-win."

"We lost a week on the decision because it had to be brought to Lake Hemet Municipal Water District board. We had three weeks to build it and we were three times larger," Wilson explained.

How did they pull it off? They partnered with Kids of Anza, another nonprofit, headed by Russell Kitchen, with a similar mission. Kids of Anza had the same idea for a Halloween ghost town, but didn't have time to pull it off. So Kitchen brought all of their manpower. "There's been about 30 [volunteers], at least, and a lot of them have Idyllwild connections," Wilson said. "The two nonprofits coming together was really awesome. It gives me chills thinking about it."

Wilson said there will be a Christmas Toy Drive on Oct. 20 and 21. Bring an unwrapped new gift and you can get one free admission. Those gifts will go to Kids of

Steel company reinforcing replacement casino

Editor's note: This story was taken from a press release.

The Soboba Band of Luiseño Indians' replacement casino and resort project has moved to the next level by installing 5,500 tons of structural steel that will allow the construction to move upwards.

Tom Groenendal, senior superintendent for C.W. Driver, said the replacement casino will use 3,900 tons of the product and the hotel will take the other 1,600 tons.

"The structural steel acts as the backbone for the entire project; it supports all the other elements," he said. "It will take roughly nine to 12 weeks to get all the steel in place."

Oklahoma City-based W&W/AFCO Steel was chosen after the scope of work was sent out for proposals from five companies.

"W&W was selected as a best value partner and presented 'outside the box' ideas to meet the schedule," Groenendal said. "Before the steel could be placed we had to complete mass excavation and grading (leveling of the site), and have rebar and concrete in place for the foundations and walls that support the steel."

The American-made steel is being fabricated in Oklahoma, Texas, Colorado, Arkansas and Arizona. Delivery of beams began Sept. 11.

"We don't purchase any foreign material for our projects, nor are we ever intending to do so," said Tim Hunter, W&W/AFCO Steel vice president/project manager. "W&W Steel has been in business since 1945 and AFCO opened in 1909; for a combined total of 180 years of experience."

Hunter said several members of his company's team visited the San Jacinto site prior to submitting a bid and felt the location was similar to other projects W&W/AFCO Steel has completed with success, and that the scope of work fit in well with past projects.

"As the largest steel fabricator and erector in the United States, we have specific strengths on which we relied for the Soboba Casino and Hotel projects," he said. "Our strategic geographical location next to the steel mill allows for us to expedite the process. Among these are the in-house production of the shop drawings, as well as utilizing all five fabrication facilities on this single project. Tapping into these resources allowed us to meet the demands of a tight schedule of this project size."

Among its many Southern California area projects, W&W/AFCO Steel has contributed structural steel to

the Rose Bowl Stadium Renovation, Cedars-Sinai Medical Center, LAX Control Tower, Palm Springs Convention Center, Pixar Animation Studios, Anaheim Angels Baseball Stadium and the Long Beach Convention Center.

"We received our California Contractors license in 1982 and have consistently been a powerful player in that market. We are always active in pursuits of this region," said Hunter, who is tasked with managing the project from the executive level, tracking and often coordinating activities on a daily basis.

Groenendal said experts in all facets of construction are working on the Soboba project using their skill and proficiency on grading, concrete, rebar, structural steel, metal decking, framing, roofing, millwork, mechanical, electrical, plumbing and fire protection, just to name a few. Once all the structural steel has been erected, the roof and walls will be completed so interior work can begin.

With a grand opening expected in the fall of 2018, the project includes a 200-room hotel, pool, two restau-

rants, a food court and sports bar, and a 15,000-square-foot banquet and meeting facility for conferences and special events. The casino itself will have 2,000 slot machines and 28 table games. The venue will be located north of Lake Park Drive, adjacent to The Country Club at Soboba Springs.



70 years ago - 1947
Postmaster Harry Wendelken lamented, "There's Idyllwilds all over the country, and all the mail for the other Idyllwilds comes to this station."

65 years ago - 1952
Wilma Chapman was conscientious about the change to standard time. She set her clock resolutely and hopped into bed. In the darkness of dawn, she mustered out Ken to report to his Forest Service duties. He staggered forth surprised to find nobody around. It was two hours later when he discovered that Wilma had set the clock ahead and he had risen at 4 a.m.

60 years ago - 1957
A county survey crew completed routing of a possible hiking and riding trail around Idyllwild. The survey was requested by the Izaak Walton League as a solution to the trail problems caused by loss of rights-of-way and increased paving. Howard Loy, club member, was in charge of aiding secure rights-of-way for the trail. (The trail is now the Ernie Maxwell Scenic Trail.)

55 years ago - 1962
Thundershowers ended a three-month drought in

the area. Rain measuring .88 inches fell on Idyllwild, bringing smiles to residents.

50 years ago - 1967
Public Health notified the Idyllwild County Service Area that a rabies vaccination clinic was being held at Town Hall.

45 years ago - 1972
Polly's Honey Bear Restaurant on North Circle Drive received a liquor license from the State Department of Alcoholic Beverage Control.

40 years ago - 1977
More than 80 children participated in pie eating, biggest gum bubble, cracker-whistling and other contests at the first Community Kids Day. Co-sponsored by Town Hall and the Lions Club, the event was held at the Idyllwild County Park.

35 years ago - 1982
After voting the previous week to direct the project engineers to stop work

on the Idyllwild-area sewer project, members of the San Jacinto Mountain Area Water Study Agency rescinded the motion. They had been advised by an attorney that the work stoppage might jeopardize the entire federal grant funding.

30 years ago - 1987
No problems were reported on the Hill following an earthquake that measured 6.1 and shook the entire southland.

25 years ago - 1992
Lake Fulmor was emptied completely for maintenance and restoration projects. The lake was to remain without water for about six weeks.

20 years ago - 1997
Richard Greenwood of Community Lumber of Idyllwild announced a clearinghouse/bulletin board service. The project put contractors and builders who generate scrap wood together with people who want free firewood. The bulletin board was located on the front desk of Community Lumber. The service was part of the Idyllwild company's ongoing efforts for community recycling.

15 years ago - 2002
Because of the looming threat of wildfires, the U.S. Forest Service closed most of the forest's public lands.

10 years ago - 2007
Not just some cash, but the entire register was taken from The Bread Basket Restaurant overnight. The register was more valuable than the \$100 left inside.

5 years ago - 2012
This year marked the 15th Art Alliance of Idyllwild Art Walk and Wine Tasting event, sponsored this year by Idyllwild's Middle Ridge Winery. With cheeses, appetizers and wares coming from more than 15 California wineries, people visited from as far away as San Diego and Los Angeles.

1 year ago - 2016
Alarmed at the occurrence of hundreds of earthquakes the prior week, only three greater than 4.0 in magnitude near the Salton Sea, state and federal geologists and seismologists issued a warning of an increased possibility of a bigger quake on the San Andreas Fault.


