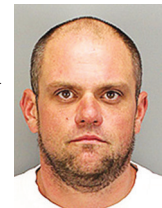

**Steele wins his third on PGA Tour**  
Defends title at Napa

Brendan Steele stayed cool under pressure from Phil Mickelson, Tony Finau and others Sunday to win the Safeway Open going away. His 72nd-hole birdie when he needed only a par to win capped a strong performance that established him as a solid championship competitor on the PGA Tour. The 34-year-old now has three PGA Tour victories in 178 starts — two in his last 26 starts.

**Trinity Houston weathers Hurricane Irma**

Idyllwild Film Fest executive helps many survive Cat 5 storm

The past eight weeks will never be forgotten. While we may not recall details or even trends during September 2015 or September 1995, September 2017 saw two major earthquakes in Mexico, several category 4 and 5 hurricanes in the Caribbean, which landed onshore, and a mass shooting in Las Vegas.

Trinity Houston, executive producer of the Idyllwild International Festival of Cinema, experienced and endured Hurricane Irma as it pummeled Sint Maarten. (The island known as St. Martin in English is divided between French Saint-Martin and Dutch Sint Maarten.)

More importantly, not only did she live through it, but thousands of others survived because of her actions before, during and after the Category 5 hurricane passed over the tiny Caribbean Island.

This is the first of three parts describing the ordeal Houston encountered, and the actions she took that helped so many.

Trinity Houston is a media management consultant. One of her major clients is Royal Resorts of Cancun. This resort manager also owns Simpson Bay Resort on Sint Maarten.

She had been working at Simpson Bay for about five to six weeks before the warning in early September that Hurricane Irma's path would pass over the island. She had tickets to depart on Wednesday, Sept. 6. Slightly worried about the impending Category 5 hurricane, Houston, who already had first-hand knowledge of another Category 5 hurricane when Wilma passed over Cancun in 2005, wanted to depart.

On Sept. 1, the local resort management held a meeting to discuss preparations for the approaching hurricane. Houston attended and was asked for advice from her previous experience.

"I suggested they board the windows, pull down all outdoor signs and anything else that might fly in the winds," she said. In the Caribbean and Mexico, inhabitants and officials generally know what to do when a hurricane threatens. "It is like earthquake preparation here," she said.

On Sept. 2, Houston investigated the possibility of getting tickets on an earlier flight since Irma's arrival was forecast for Thursday, Sept. 7. "But flights were booking up to get off the island," she lamented.

With no expectation of any early departure, the resort asked if she would stay and help with preparations. No senior management was available at the time and the local

**Howard Jarvis Association pursuing litigation challenging state fire fee**

While the state suspended the controversial State Fire Prevention Fee, the Howard Jarvis Tax Association is continuing its litigation over the legality of the fee.

In August, when the Legislature approved Gov. Jerry Brown's package of programs to improve air pollution throughout California, a suspension of collecting the fee until Jan. 1, 2031, was included.

Nevertheless, HJTA recently filed for a summary judgment to declare the fee a tax. If it is a tax, its collection would be prohibited because it was not approved by two-thirds of the Legislature and HJTA wants previous fee payments refunded to those who made them.

More than a year ago, the Sacramento court authorized HJTA to proceed with the litigation as a class action. During the interim, HJTA's legal team has been reviewing state documents and interviewing state residents within the State Responsibility Areas who are subject to the fee.

Late last month, HJTA filed the papers requesting a summary judgment, along with hundreds of pages of testimony and backup to support its argument that the fire prevention "tax" is masquerading as a fee.

In its Sept. 18, filing, HJTA told the court, "... the State Responsibility Area Fire Prevention Fee passed via [Assembly Bill] 29 in the 2011-12 legislative session ... was an illegal tax ... did not receive a 2/3 vote of each house [and] ... the class are therefore entitled to refunds of the [fee] payments..."

As part of its case, HJTA has collected numerous declarations from residents with the SRA. For example, Roger Brown of Alpine, San Diego, provided a statement attesting to his payment of the FPF for six years, beginning in 2011-12. However, he states that, during this period, his property has not received a fire inspection from Cal Fire or any other fire agency.

With no inspection, HJTA argues, how can Brown be charged a fee for specific services? He must be paying a general tax. If so, it was not approved by the requisite legislative two-thirds majority.

While the state claims this is a fee for services, HJTA argues that the state treats the overdue and unpaid fees as taxes when a property owner declares bankruptcy.

"In this way, the State attempts to have its cake and eat it, too," HJTA wrote in its support for the summary judgment. Then it quoted a California deputy attorney general who wrote in a federal bankruptcy filing, "... the Fire Prevention Fee is a fixed assessment levied against the owner of the properties in specific areas which does not depend on the

**Frisbee:** I’d like to say that Anastasia Beaverhausen is so adorable. She and I played and loved together on Sunday. I love playing with other dogs.

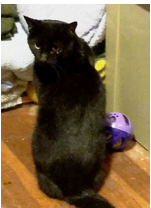
**Trenton:** Maybe all of these adoptions are signaling a trend, and we will all soon find our forever families, yes?

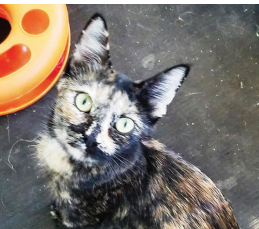

# HUSD trustees recognize Idyllwild employee

## Mary Pimentel receives Excellence Award

The Hemet Unified School District Board of Trustees held its annual meeting at Idyllwild School last week.

While no major agenda items were debated during the meeting, Dr. Alex Ballard, director of assessment and accountability, did provide a report to the board on the HUSD results of the spring 2017 California Assessment of Student Performance and Progress.

An Idyllwild School volunteer was honored and a local eighth-grade student led the pledge of allegiance to open the meeting.

After Matilda “Millie” Terry led the board and audience in the pledge, President Vic Scavarda, the Idyllwild representative, recognized Mary Pimentel for the work she does at the school. She is the school office parent liaison.

She was given the Governing Board Recognition of Excellence Award, which includes a \$500 certificate to spend on any school program of her choice.

“She has been an outstanding parent volunteer,” said Scavarda, who met Pimentel when her son Raul was in his class several years ago when he taught at Idyllwild School.

“She went to Anza first and returned to Idyllwild and is doing an incredible job,” he continued. “She is a vital link with the Hispanic parent and community. She’s highly respected and an important part of our office staff.”

He praised her problem solving and people skills, and mentioned that she would be co-teaching adult education classes later this year.

Idyllwild School Principal Matt Kraemer recommended the award for Pimentel’s contributions at the school. “She has been a true ambassador for Idyllwild School and we feel fortunate to have her!” he wrote in his recommendation.

The only educational item discussed during the meeting was Ballard’s presentation of the district’s performance, announced last week, on the CAASPP test. Fourteen states employ this tool, he told the board. This was the third year of using this instrument.

The four levels are exceeded, met, nearly met or not met the standard. Typically, the first two levels of achievement are grouped together. Students in grades three to eight and 11 were tested last May.

Unfortunately, HUSD declined 1 percent in English language and 2 percent in the math test. However, Idyllwild School, not only increased its percentage in the two top levels, it led the district in both tests.

“I am very proud of the job Idyllwild students and staff did on ELA and Math. And, it appears that all grades have grown since 2015 District-wide,” Scavarda wrote in an email before the meeting.

This year, two-thirds of the Idyllwild students met or exceeded the English-language standards, up from 2016, and 55 percent met or exceeded standards on the Math portion, also up from 2016. Idyllwild was the only elementary school in which more than half the students met or exceeded standards. For the whole district, about a quarter of students achieved these

levels.

HUSD underperformed at the state and county levels. According to Ballard, the district was 15th out of 22 in Riverside County.

Ballard said staff was examining the allocation of the district’s local-control state funds and found “several opportunities to re-focus” in efforts to help the students.

“We’ve had a courageous conversation about what’s to come in the future,” HUSD Superintendent Christi Barrett said. “Hemet[ic] is committed to ensuring improved academic outcomes for every student that we serve. While the district and

Idyllwild School have made progress compared to last year, we acknowledge that there are areas of opportunity for growth.”

In a district where nearly three-quarters of the student population are eligible for free or reduced lunches, the staff was pleased with the overall results. Barrett complimented the teamwork at each school. Yet she acknowledged that demographics have always been a factor in predicting performance and actual results.

# Riverside County Sheriff Lt. Chad Bianco announces campaign for sheriff

### Background

Lt. Chad Bianco has been with the Riverside County Sheriff’s Department for 24 years. He began in corrections and has had progressive assignments from patrol, internal affairs and supervision, and has been assigned to the Hemet Station since September 2016, so he is familiar with the issues and problems in Idyllwild.

“I’ve served in every department and area but court services,” he stated. “I have a very broad knowledge of the department under four different sheriffs.”

He was born at Hill Air Force Base in Ogden, Utah, and moved to California in 1989.

Bianco is married and has four children, ranging in ages from 21 to 27.

All are in or interested in a public-service career.

### Philosophy

“I believe the absolute mission of the sheriff is to provide the best quality service for residents and department members,” he said. “This is accomplished by utilizing the most resourceful and best interest of taxpayer funds as possible.”

### Previous campaign

Bianco challenged Sniff in 2014. He garnered about 38 percent of the vote to Sniff’s 62-percent lead. But that result has not deterred him from mounting another

challenge this year.

That effort has both prepared and steered him for this campaign. 2014 was his first entry in politics. He and his wife managed the campaign. This year, he has already hired a consultant and campaign manager.

“The events over the last three-and-a-half years have completely reinforced my opinion about the department,” he said.

### Departmental issues

He is adamant that Sniff is not managing the department successfully. Bianco argues that Sniff simply seeks more funding

# Assemblyman Randy Voepel to be in Idyllwild

## Meeting with residents Nov. 2 at Town Hall

Idyllwild’s representative to the State Assembly, Randy Voepel of Santee, will begin a “Listening Tour” in different towns of the 71st Assembly District. The tour will begin Oct. 18 and continue through Nov. 9.

From 5:30 p.m. to 7:30 p.m. Thursday, Nov. 2, he will listen to Hill constituents at Town Hall.

In the press release announcing the tour, Voepel said, “The Listening Tour provides a great opportunity for me to hear directly from my employers about the issues that matter most to them. Whether it’s reforming our state government, improving our state’s business climate, or making sure our state’s long-term finances are healthy, Sacramento faces

for the department rather than making the difficult decisions about resource allocations.

“He just demands more money. It is not the proper management and deployment of personnel,” Bianco claimed. “The county draw-down [reduction of deputy staffing in the unincorporated areas] was arbitrary and political ... For [departmental] administration,

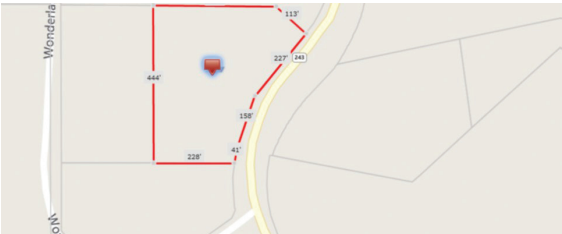

Evolution Paradigm

We have observed evolution. 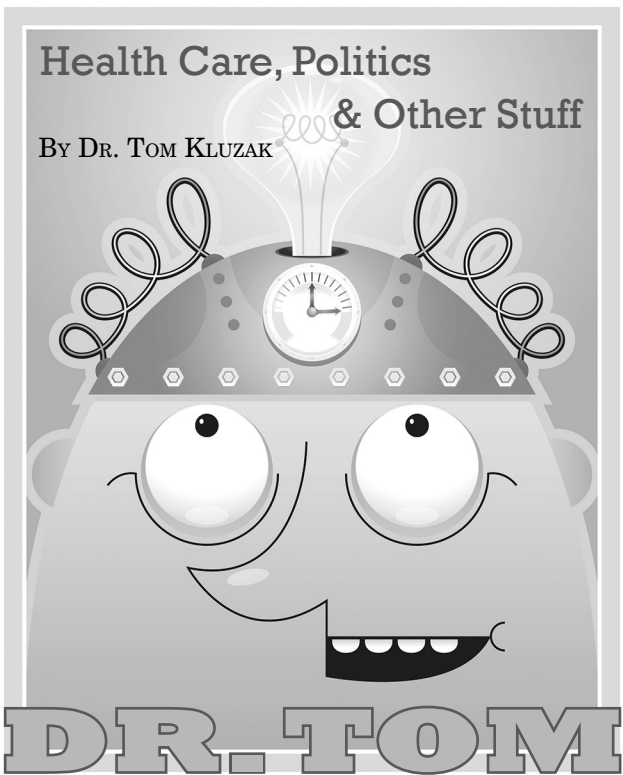


NARCISSISM: A NEW CATCHWORD

In common speech, we often use the term narcissism as a label; a way to disparage another’s character or behavior. Frequently, we are reacting to someone whom we experience as being much too interested in themselves — having an over-inflated ego. We find the narcissist to be someone who talks only about themselves and can’t seem to sustain interest in another’s story. We use narcissism as a synonym for egotistical, selfish or self-absorbed. But let’s explore what mental-health professionals have to say. Not all narcissism is seen as unhealthy, pathological or problematic. Synonyms for normal, healthy narcissism are “good self-esteem,” “self-assurance,” traits recognized as necessary for psychosocial success. People with these traits are likely to be empathic, sensitive and caring about the feelings/needs of others. They have no need to belittle or feel “better than” others when there is disagreement, but can listen and work collaboratively to find mutually beneficial solutions, accepting difference as normal and non-threatening. These personalities grow and develop over time, their healthy narcissism benefitting others around them. On the other hand, there are the extreme traits of Narcissistic Personality Disorder. Like all personality disorders by definition, NPD is unchanging over time, develops by adolescence and causes problems in functioning. Hallmarks of NPD are grandiosity, an unrealistic, over-blown sense of one’s importance, talents and contributions. This trait can swing from overestimating to underestimating oneself, with mood and behavior following the swings to “high” or “low.” This is accompanied by an exaggerated dependence on the approval of others. Excessive use of attention- and admiration-seeking See Narcissism, page A8



A reluctant response...

I have strong beliefs, as many of you do. My goal in writing this column was to encourage cogitation, not create controversy, but, of course, they often go hand in hand. Therefore, when a few readers have responded negatively, I read their responses but could find no value in continued arguments in print. Everyone is entitled to his or her own opinion. However, a letter to the editor in the Sept. 28 paper, “Evolution is not a fact,” is so full of falsehoods it demands correction. Opposition to evolution is essentially confined to creationists from many different faiths, including, but not limited to, several (far from all) Christian sects, and is not, as suggested, representative of a controversy among scientists. Scientists overwhelmingly accept evolution as a scientific fact and the idea that many reputable scientists reject evolution is just not true. Evolution is widely accepted as a central theme in biology. The statement that facts are not widely disputed ignores common sense and the lessons of history. When everyone accepted a moon god who floated in the sky, was that a fact? Did the Sun revolve around the Earth as most people believed? Was the Earth flat? Perhaps the author was referring to a scientific consensus, such as the one that exists about evolution. Evolution, like quantum mechanics, is complicated and not totally understood by those without extensive education. Therefore, neither the letter writer nor I are qualified to debate its intricacies, though I would happily discuss this in a public venue if it would be of any value. However, this will be my final response in print to avoid endless attempts at one-upmanship. In the meantime, readers are encouraged to seek their own answers. Many interesting websites and YouTube videos pop up after a search about evolution. I would caution that See Dr. Tom, page A8

Last week was productive for the Snow Group. On Tuesday, we met with California State Sen. Jeff Stone at his Murrieta office. We shared with him a PowerPoint presentation, which illustrated the Hill’s snow-play visitor problems and proposed solutions. Stone and District Representative Darrell Connerton immediately understood Idyllwild’s challenges and responded favorably to our proposals. Stone will organize a multi-agency meeting in November or December where representatives of county, state and federal government can coordinate on solutions to the Hill’s snow-play visitor issues. Also, the Snow Group met informally with residents outside the Idyllwild Post Office. We distributed free refrigerator magnets featuring law-enforcement phone numbers. As mentioned in last week’s column, it is vital that Idyllwilders call the authorities and report any illegal actions by snow-play visitors, or anyone, for that matter. Calls are counted and become statistics the county uses to determine allocation of law-enforcement coverage. More calls equal more cops. At the post office, we also offered two yard signs designed to be posted in residential yards (or snow berms) to discourage snow-play parking and trespassing. The response was gratifying; we sold more than 60 and have distributed about 250 refrigerator magnets. We also heard many words of support. One woman with whom we spoke did remark that she didn’t like the idea of our neighborhoods being dotted with signs. We don’t either. We suggest posting these signs only on snowy weekends. Residents who have endured the snow-play visitor onslaughts will surely prefer having a temporary sign in their yard rather than trespassers, illegally parked cars and the disgusting litter some leave behind. We still have free magnets available as well as a few signs we are offering at cost, \$4 and \$9. If interested, call 659-3884. ## Vowell pleads guilty Sentenced to state prison

On Oct. 4, three weeks after his arrest, Brian Dustin Vowell, 36, of Idyllwild, pleaded guilty to one count of felony residential burglary.

Judge Mark Mandio rejected probation and sentenced Vowell to two years in state prison. He will be given credit for serving 41 days already. He also will be responsible for other fines and levies of about \$675.

Vowell is still in custody, but the judge did grant the defense attorney’s motion to consider assigning Vowell to a fire camp, for which he will be evaluated.

Vowell was arrested on Sept. 14 for a burglary on Hotei Lane in Pine Cove two weeks earlier.

there never has been a major push to save money. It’s all about getting as much money from the board.”

Consequently, Bianco believes Sniff publicly blames the Board of Supervisors for inadequate funding. “This makes it a budget issue rather than a management decision.”

To put pressure on the board for more dollars, he threatens to close stations or reduce patrols. When the board doesn’t have more funding, Bianco argues that Sniff cuts these activities to save face.

**The fix**

Bianco believes he could restore more deputies and, at the same time, more patrols to Idyllwild and other unincorporated areas if he were elected.

One source of more staffing would be the resources assigned to the contract cities. Bianco said the cities contract for hours of work and not a specific number of staff. With more efficient assignments, perhaps helped by the recommendations from the county’s management consultant KPMG, more deputy time would be available for unincorporated patrols.

corporated patrols.

**Reasons to choose him**

Bianco argued that the opposition to Sniff aligning in the campaign should be a huge red flag for voters. First, the Riverside County Sheriff’s Association, a labor association composed of the deputy sheriffs, has announced its support for Bianco. It recently gave \$100,000 to his campaign.

“When people you’re supposed to be leading are supporting another member of the department as more capable, that speaks volumes,” he said.

Secondly, the entry of Hemet Police Chief Dave Brown is another red flag, according to Bianco. “He is someone from an outside agency we’re suppose to be working in conjunction with.”

“If elected, the first thing I’d do is mend political and working relationships with everyone in the county — the board, staff and cities,” he promised. “Morale is the lowest I’ve seen in 24 years. It has to be fixed.

“You just take the word of the sheriff. Internally, we know we can do better,” he concluded.

# Small fire near Black Mountain

About 9:15 p.m. Tuesday, Oct. 3, a fire was reported near Black Mountain. U.S. Forest Service crews responded.

The Azalea Fire was contained Saturday afternoon, Oct. 7, and its size was limited to 9 acres, slightly smaller than the original estimate.

“The crews from Engine 51 (led by Pedro Olague) and Engine 56 (led by Justin Foye) hiked in and attacked the fire working through the night and into the next day until relief resources arrived on scene the next day,” wrote Freddie Espinoza, San Jacinto Ranger District fire management officer. “The fire burned actively throughout the

night. The hard work from the crews of E-51 and E-56 throughout the night led to the establishment of containment lines around 60 percent of the fire and contributed greatly to the success of the incoming resources the next day.”

San Jacinto Ranger District Battalion Chief Matt Boss was the incident commander for the Azalea Fire. Several engine crews, helicopters and two Hot Shot crews were involved in controlling the fire.

“The fire is located about a quarter mile west of the Pacific Crest Trail on Marion Mountain Trail,” said Espinoza, and he added, “The cause is still under investigation.”

**Take precautions against high heat**

With temperatures reaching triple-digits in parts of Riverside County, health officials are urging the community to take precautions against the heat and remind residents about the availability of cool centers located throughout the county.

Idyllwild does not have a cool center, however.

“High temperatures always present challenges, but the first heat wave of the year can be particularly dangerous since people may have forgotten the danger high temperatures can present,” said Sarah Mack, director of Riverside University Health System-Public Health. “There are some simple precautions that people can take to protect themselves.”

Among the precautions, officials suggest residents drink water to prevent dehydration; avoid direct sunlight and stay indoors when possible; close blinds or curtains to minimize the heat; visit a mall, library or restaurant to stay cool; and make sure not to leave children, elderly, disabled individuals or pets inside unattended vehicles.

Some of the signs of symptoms of heat-related illness are headache, dizziness, muscle weakness or cramps, and nausea and vomiting.

**Checking for ID theft of a child**

The Federal Trade Commission advises: Any parent or guardian of a child knows the milestones that come with turning 16 – learning to drive, maybe dating, or thinking about college. But now, there’s one more: checking their credit report.

But my kids don’t have a credit card, house or car. Why should I check their credit report?

Because somebody else could be using your child’s personal information. Once a child’s — or anyone’s — Social Security number is stolen, it can be used by identity thieves.

Checking to see if your child has a credit history, and then thoroughly reviewing it when they turn 16, can help you spot signs of identity theft. If you find false or inaccurate information, you’ll have time to correct it before your child applies for a job, a loan for college or a car, or tries to get a credit card or a place to live.

Generally, children won’t have credit reports unless someone is using their information for fraud.

What if my child has a credit report with incorrect or false information? Visit [IdentityTheft.gov/child](http://IdentityTheft.gov/child) to report the problem and follow the steps outlined to resolve it.

# State to regulate home improvement energy loans

Improving your house's energy efficiency is prudent and praiseworthy. Not only will it reduce the costs of heating and cooling, but it also will benefit the environment. To encourage homeowners to undertake these types of improvements — solar panels, double pane windows, water efficient toilets and others — special loan programs have been created.

Property Assessed Clean Energy — or PACE loans — are available to help homeowners purchase these energy efficiencies.

Unfortunately, unscrupulous contracts and lenders are converting some PACE programs into the same problems that low- and no-interest home loans created in the mid-2000s.

“... [T]he laudable goal of improving home energy efficiency is being overshadowed by the lack of adequate consumer protection for these loans,” wrote the National Consumer Law Center. According to the center, the elderly living on fixed incomes are the targets.

Contractors can solicit homeowners to purchase this equipment. They promise large electric savings, and often conceal the interest rates and consequences of loan delinquencies. Often homeowners are not evaluated for qualifications for state and federal grants that would be free or have very low-interest repayments.

These are high-interest loans, which are guaranteed by the property. More importantly, they are placed on the tax rolls and are given higher priority than other loans. Many people who thought the electrical bill

savings would pay the loan, fell behind on payments and have lost their homes.

Since so many people have fallen prey to this problem, state governments are taking action. Last week, Gov. Jerry Brown signed legislation, Assembly Bill 1284, to eliminate one of the hidden tools used to obtain the loan.

Previously, lenders did not have to obtain a financial statement assessing the applicant's ability to repay the loan. Once the loan request papers were signed, the lender could ask local governments to place a lien on the property and to collect the payments without any verifiable data on the borrower's capability to repay the loan.

Being paid to make the collections was an incentive for local governments. But many of the borrowers would not have qualified for the loans if an as-

essment had been made prior to its approval. This will now be required in California.

While many organizations, such as the National Consumer Law Center, support the legislation and are glad the governor signed it, some are concerned with a section of the bill that permits the lenders to hide their behavior.

The new law permits the state's Business Development Administration to investigate lender behavior and to take actions. However, if the subject of the investigations agrees with the BDA recommendations, the whole investigation results will be confidential.

The California News Publishers Association wrote the bill's sponsor, Assemblyman Matt Dababneh, objecting to this provision that appeared at the last minute.

“The mandatory confidentiality proposed by this bill undermines any specter of real reform ... and prevents the press and the public from engaging in any oversight of the PACE program to detect and deter potential malfeasance,” wrote Nikki Moore, CNPA legal counsel.

CNPA argued that it inhibited media's ability to investigate or even identify possible collusion between the faulty lenders and the commissioners reviewing the charges.

In his press release following the governor's signature of the bill, Dababneh said, “This bill introduces the first state regulatory structure and ability-to-pay requirements in the country and provides an enforcement mechanism to guarantee increased consumer protections.”

behaviors is common in NPD. Persons with NPD believe themselves to be entitled to special considerations and feel they are uniquely better than others while also being quite emotionally vulnerable to criticism from others and, at times, consumed by envy of other's traits and accomplishments.

NPD is characterized by lack of empathy, being unable to internally register the needs of others or to be genuinely interested in others except when they are actively feeding one's ego and satisfying that ever-present need for attention. When others fail in this gratification of the needs of the person with NPD, the latter becomes irritable and enraged, and may actually feel empty inside.

Descriptions of a more extreme style of NPD called “malignant narcissism” adds the following to the above list: a deep sense of mistrust; preoccupation with conspiracy theories; a desire for revenge; pathological lying.

The business world (Wikipedia url above) is examining “narcissistic corporate leadership” styles. Included, among other characteristics, are: desire for power, wealth; pursuing power at all costs and lacking normal inhibitions in its pursuit; devaluing and exploiting others without remorse; being easily bored; often changing course; having a childhood undercutting a true sense of self-esteem and/or learning that he/she doesn't need to be considerate of others. Narcissistic leaders claim loyalty but sacrifice everything to their own interests. Corporate narcissists are considered destructive.

some of these sites hide their creationist bent and purport to be science-based. These, as you will see, are the basis for the letter, and sound familiar.

One site I visited spoke eloquently about the “science” against evolution. You could then click on a page about God and another to donate. This, of course, is the central problem: Science starts with a question; religion starts with the answer.

Another flaw in her arguments is the old “just a theory” ploy. Actually, in science, a theory is a “unifying and self-consistent explanation of fundamental natural processes or phenomena that is totally constructed of corroborated hypotheses.” The common usage of theory as a guess does not apply to scientific theories, like the theory of gravity and the theory of evolution.

The part of the writer's letter that is most disturbing is the idea that science should be separated from politics, meaning, I guess, government. Wow! This is scary! Should we try another Moon shot and just ignore the science? Should we develop new drugs based on beliefs? Should we develop approaches to climate change, gun violence and the environment without data? Science searches, without preconceived ideas, for the truth. Shouldn't our government?

staff wanted someone who knew what to expect. “But I worried a little since I have been in a 5 before, but it was on the mainland not an island,” she said. “It's a hurricane, that's still disturbing.”

Houston explained to the staff that preparing to withstand and survive the winds and rains was only the first step. The island will be damaged and services will be severely limited. “We'll need a plan to get people out after the hurricane,” she advised. “Normally, with the electricity out, especially at an airport, airlines won't be coming in soon.”

From Saturday to Tuesday, the days passed quickly because there were so many tasks to accomplish as everyone began to prepare for the hurricane's arrival, Houston said. After Irma moved on, time slowed dramatically from Thursday until Saturday as she tried to arrange for transportation off the island.

Over the preceding weekend and on Monday, she urged all the guests who were still resident to get food and water — enough for three to four

days. Since the resort was also a time share, many were in rooms with kitchens. These guests would not have to depend upon the resort food supplies.

Using her video skills, Houston created messages — red and yellow — for the guests' in-hotel network and a video about securing rooms. “But outside it was still beautiful, no clouds,” she said. The internal network functioned until the hurricane was over them.

By Tuesday, the winds began to appear and grew stronger. The resort occupants settled into their rooms. Bathrooms were considered secure, away from possible broken winds.

On Sept. 6, Irma's winds were clocked at 185 miles per hour. A Category 5 hurricane is designated when wind speed reaches 155 mph. It was the strongest hurricane of 2017. Irma caused catastrophic damage. According to news reports, as of Sept. 30, 132 people died from the hurricane, including four in Sint Maarten.

The Idyllwild native posted a 15-under-par 65-67-72-69 — 273 to win by two strokes over Tony Finau and three over Phil Mickelson. Past winners of the Safeway include Mike Weir, Rocco Mediate, Jimmy Walker and Emiliano Grillo, but no other player has won twice, much less successfully defended his title with a second consecutive win.

Brendan's game appears to love the Silverado Resort and Spa course. Since the Safeway has been played on that course the past three years, Brendan is 50-under-par, better than any other pro.

Brendan collected 19 birdies and an eagle against six bogeys on the way to victory last week. One of his best moments under pressure came at the par-4 14th on Sunday. He hit his drive into a fairway bunker, then came out into the rough and clunked his third shot into a green-side bunker. His out from there left him a 7-½-foot putt for bogey. It was an intensely pressure-packed moment to keep from posting a double. The putt drifted right to left, caught the right lip and dropped. Brendan described that putt as a “huge” factor in keeping his momentum.

Brendan was no. 1 in the field in driving distance at 327.8 yards, while hitting 67 percent of the fairways and 79 percent of the greens in regulation, and his proximity to the hole on approaches averaged under 30 feet. He gained 2,241 strokes on the field putting, needing only 1.8 putts per green.

Heavy, gusty winds

blasted the competitors on Sunday, a major change from the first three days. Although wind-aided shots produced huge drives (Brendan's final drive at no. 18 Sunday traveled 369 yards), Brendan related that it was easier to hit into the wind than with it. Club selection was a major question all day under these gusty conditions, and throughout the day Brendan communicated heavily on this issue with his substitute caddy, Chris Mason, who is one of his coaches.

Last year's win in the first tournament of the season propelled Brendan into his best year ever on the PGA Tour, and he said in an interview that he was expecting to get that same springboard effect from this year's early victory. Most immediately, this win makes him eligible for the Tournament of Champions in Hawaii in January, but it also opens doors to World Golf Championship tournaments and majors as well. It also jumped him from 59th to 47th in the Official World Golf Ranking.

Brendan said he learned a lot from the last season. Specifically, in a post-tournament interview, he acknowledged that from the British Open on, he found himself playing for points rather than playing for wins, which he now feels was a mistake he will correct this year.

Brendan competes this week in Malaysia in the \$7 million CIMB Classic. His regular caddie, Christian Donald, will be on his bag. His tee times have not yet been set, but will be available on the Town Crier website later this week.

owner's specific use of that property.”

HJTA concluded, “Independence from specific use of the property means no specific benefit, privilege, product, or service is directly provided to each payor.”

Consequently, HJTA takes the position that fire prevention is a general government service any homeowner within the jurisdiction should expect. These are financed through taxes, which are compulsory and do not grant any specific benefit.

As of Oct. 6, the state had not responded to the HJTA motion nor other filings. A hearing on the motion for summary judgment has been scheduled for Dec. 8 in the Sacramento County Superior Court.



## French Film Festival opens next weekend

Next weekend, Idyllwild will host its first French Film Festival. Seven French short films will be shown at the Idyllwild Library Saturday, Oct. 21.

The festival begins Friday night at Middle Ridge Winery Tasting Gallery, when “Heloise” will be shown. While this is an English-language film, the subject is French romance.

The idea for the festival originated with Debra Varnado Tobias, a “newbie to producing this type of event.” She is a member of Idyllwild’s French Fun Book Club. It is helping her French language skills on the way to fluency.

While studying and searching the Internet, she visited the French Embassy in New York website. There she discovered “The Best of French Short Films.” The Cultural Services program in the embassy offers a selection of short films from the most recent International Short Film Festival, Clermont-Ferrand. The films are shared with noncommercial theaters.

The Clermont-Ferrand Festival is an illustrious French event. Tobias said, “For several decades, the festival has had the bragging rights for being the biggest short-film festival — and the second-largest film festival — in France after Cannes when it comes to audience and professional attendance.”

Next, Tobias contacted Shannon Ng, the Idyllwild Library librarian, to see if the library could serve as a theater and the French Embassy to arrange for a selection of films. Late this summer, she achieved both and next week the town can share in her accomplishment.

But Tobias was not complacent after arranging for a French Film Festival in the San Jacinto Mountains. She then contacted Gayla Kraetsch Hartsough. If she cooperated, Tobias would have a bigger attraction for the film fest.

Hartsough is the film writer and producer of the film “Heloise,” which is about the historic relationship of two 12th century French lovers, Heloise and Abelard. It is a love affair, which turns sad, between a philosopher and theologian, and his student Heloise.

“It ends with profound consequences for both and raises a host of social, philosophical and theological questions,” Tobias wrote.

This addition to the festival was pure “serendipity,” according to Tobias. She was interested in another Hartsough film, but learned of “Heloise” and its French basis.

In response to an invitation, Hartsough wrote, “Sounds fabulous, I’m in.” Her films have been shown at more than 50 festivals, including Palm Springs, Denver Starz, Houston, LA Shorts International, New Orleans and Cannes Short Film Corner, she wrote.

“Heloise” is in English and will be shown about 8 p.m. Friday, Oct. 20, at Middle Ridge Winery Tasting Gallery. Hartsough will be at Middle Ridge Friday to discuss the film before it is shown and answer questions after it is screened. There is no charge for the “Heloise” showing. The festival event will start about 6 p.m. in the upper level of the gallery.

In preparation for “Heloise,” Tobias said, “French Fun’s Book Club is sponsoring a group reading of the letters of Heloise and Abelard, 3 p.m. Thursday, Oct. 19 at the Idyllwild Library. The reading will be in English and is open to the public.”

Again, Tobias wanted to attract more potential French linguists. She has invited Sandrine Cassidy, director of Festivals and Distribution at the University of Southern California’s School of Cinematic Arts, to talk at about 7 p.m. Friday at Middle Ridge. Cassidy is knowledgeable and experienced with film festivals, including the Clermont-Ferrand, Tobias said.

Saturday, at 9:30 a.m., the library’s doors will open for the first screening of the seven films. Later that day, about noon and 2:30 p.m., will be additional screenings. Tobias recommended, “Guests should reserve their seats by Oct. 16 at <http://idyllwildlibrary.eventbrite.com>.”

And she emphasized that the seven French films all have English subtitles.

Three IAA faculty members perform in Pasadena

'Gods and Monsters' a collaborative and multi-media production

Three Idyllwild Arts Academy faculty members are performing a multi-disciplinary and collaborative production, "Gods and Monsters," written by Dr. Jeannette Louise Yaryan, composer, pianist, arranger and author, that will be presented in Pasadena.

Joining Yaryan are Marshall Hawkins (jazz faculty) and David Reid-Marr (visual arts chair). "It is an anti-racism piece," said Yaryan. "This is a concept show that confronts social issues of our time. Although there are works on the program by traditional composers, there is also

my own spoken word and musical arranging, as well as a powerful visual art installation [by Reid-Marr]."

On the program, with Yaryan at the keyboard, are works by classical composers J.S. Bach, Beethoven and Debussy. Her own piece, "The Fabrication of Our Lives," includes Yaryan's arrangement of L. Allen's "Strange Fruit" and spoken words by Yaryan featuring bassist Hawkins and artist Reid-Marr.

"Gods and Monsters" concludes with a reading of the 13th Amendment that outlawed slavery after the Civil War.

"Gods and Monsters" was premiered in April 2017 at Idyllwild Arts. Yaryan holds two Masters of Music degrees from the Cleveland Institute of Music. A prize winner for the University of Southern California's concerto competition, Yaryan performed Liszt's "Toten-

tanz" with the USC Symphony in 2008. Yaryan also is a chamber musician as well as a performer, arranger and board member of the Definiens Project, a nonprofit chamber music organization based in Los Angeles.

Hawkins is a longtime IAA jazz faculty member, founder of Jazz in the Pines, bassist, composer and arranger. Reid-Marr, current chair of the IAA Visual Arts Department, works in painting, drawing and sculpture.

"Gods and Monsters" will be performed at Boston Court Performing Arts Center in Pasadena at 8 p.m. Thursday, Oct. 19, with a pre-concert talk at 7 p.m. Tickets for adults are \$10 and for students, they are free. 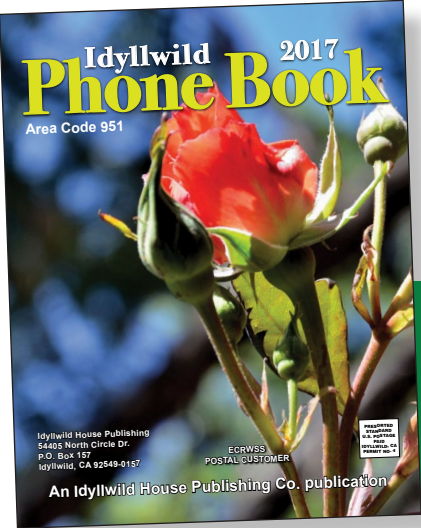

# Idyllwild Arts presents ‘House of Bernarda Alba’

## Federico Garcia Lorca’s final play explored taboo themes

Idyllwild Arts Academy Theatre Department, in association with the World Languages Department, presents Spanish playwright Federico Garcia Lorca’s final play. In English, it is called “The House of Bernarda Alba,” and, inasmuch as the IAA production is bilingual, interspersing English and Spanish, it is advertised as “La Casa de Bernarda Alba.”

It is Lorca’s last play, completed just two months before his assassination at the age of 38. Bernarda Alba is considered a masterpiece of 20th century Spanish literature. It explores taboo themes of sexuality, repression, passion, conformity and reputation in rural Spain, and the effects of men upon the lives of women in an increasingly masculine and totalitarian political environment. The rise of Francisco Franco’s right-wing Falange in July 1936 came two months before Lorca was killed.

The play will be performed in English and Spanish, with a translation by IAA students. Involved in the cast are native and non-native Spanish speakers from seven different countries. In making the translation, students

decided which passages and dialogue in the play should be in English and which in Spanish.

Directed by Theatre Arts Chair Bonnie Carpenter and co-directed by Dr. Mary Aebischer, chair of the Modern Languages Department, Bernarda Alba is the story of a household of seven women headed by a strict matriarch who enforces eight years of mourning after her husband’s death, repressing her six daughters’ freedom and desires while controlling their lives and futures.

“The daughters’ quests in the play echo the quest for all modern-day heroines — how not to over-value the masculine; how to honor one’s body and desires; and finally, how to be the author on one’s life,” wrote Aebischer.

Music, particularly with Flamenco sonorities and rhythms, will underscore the production. Music played a huge part in how Lorca penned his poems and plays. He studied piano and planned to be a classical composer before turning to writing.

At each of the three performances, IAA National Honor Society members will maintain concessions to raise money for earthquake victims near Mexico City and hurricane victims in Puerto Rico.

For an immersion into the austerity of rural Span-

ish life immediately before the beginning of the Spanish Civil War, plan to attend this free production at the IAF (Bowman) Theater on the IAA campus. “La Casa de Bernarda Alba” opens at 7:30 p.m. Friday, Oct. 13, plays at the same time on Saturday, Oct. 14 and at 2 p.m. Sunday, Oct. 15.

# Idyllwild Arts graduate finds musical theater success in NYC

Jacque Carnahan brings her one-woman show to campus

Jacque (Jacqueline) Carnahan, 1998 Idyllwild Arts Academy theater graduate, has established a solid career as a producer, actor and educator in New York City. At 4:30 p.m. Saturday, Oct. 21, Carnahan brings her one-woman biographical musical theater journey to IAA’s Bowman Theatre. “From Main Street to 42nd Street” chronicles Carnahan’s evolution as a performing artist from her middle-school days in San Luis Obispo to finding her NYC dream.

To work regularly in professional theater in the United States is, at best, difficult. For Carnahan to have founded a nonprofit focused on helping young actors find their professional footing in New York, and to have worked successfully as a musical theater performer in NYC, on national tours, and regionally, is a testament to her talent, work ethic and mission to pay it forward.

Carnahan’s nonprofit, Believe NYC, produces educational events designed to motivate and inspire performing-arts students. The events are in three parts — private performances by industry professionals for students, followed by intimate Q&As from the students to

the professionals, culminating with one-hour workshops in areas such as: mock auditions, learning dance breaks from Broadway musicals, musical theater, improv, stage combat, show choir, make up, acting “in the scene,” and “in the pit” — learning what it is to be a professional musician in NYC. Believe NYC Artistic Director Carnahan and associates — artist/educator Keve Wilson, music director Paul Staroba and performing artists John Michael Dias and Alicia Albright — know how challenging it is to persevere in theater and music in New York City. “We stand for living the dream,” stresses Carnahan.

A major part of Carnahan’s career is helping others. In addition to directing Believe NYC, she is co-producer of the annual Broadway ben-

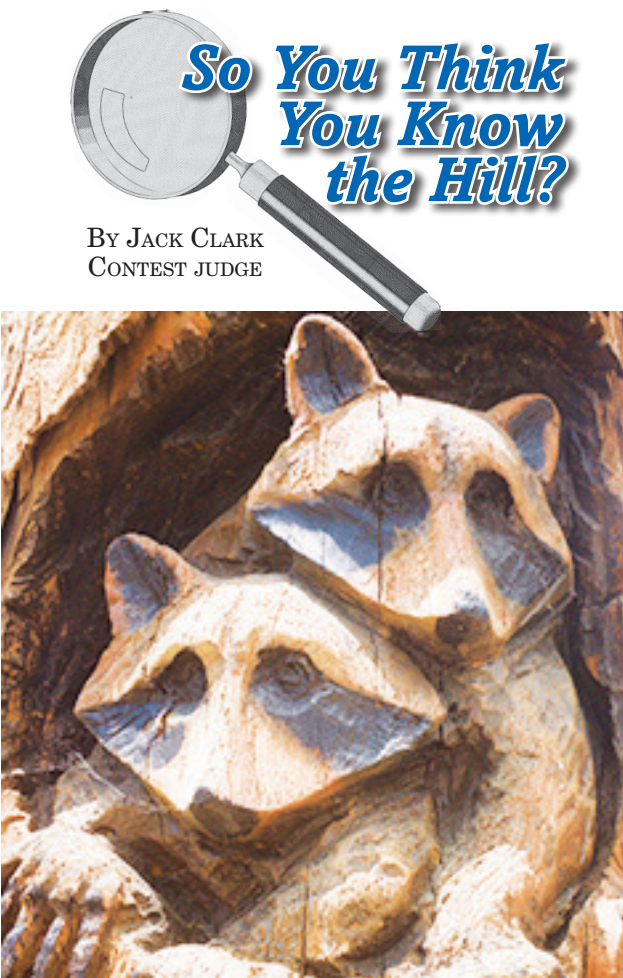
efit concert “Arts for Autism” hosted by Tony winner Kelli O’Hara at the Gershwin Theatre that has raised more than \$80,000 for Autism Speaks, an organization dedicated to promoting solutions, across the spectrum and throughout the lifespan, for the needs of individuals with autism and their families through advocacy and support.

Carnahan has performed off Broadway, in national Broadway tours, and at major regional theaters including the Paper Mill Playhouse, Baltimore Center Stage and Goodspeed Opera House. She is one of the senior company choreographers at McCarter Theatre Company in Princeton. In addition to her arts education at IAA, Carnahan holds a Bachelor of Fine Arts cum laude in musical theater from the Boston Conservatory and is a National Foundation for Advancement in the Arts awardee.

Carnahan will delight in her one-woman show as she sings and dances her way from SLO to the lights of Times Square in NYC. With affection and humor, she will carry the audience through the ups and downs and in-betweens of pursuing her passion for performing. “From Main Street to 42nd Street” is full of heart, charm and titanium tapping with musical arrangements by Broadway composer Barbara Anselmi.

There is no charge to attend the performance.

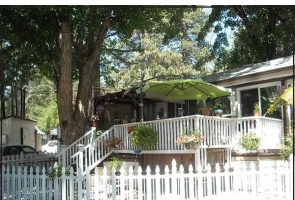

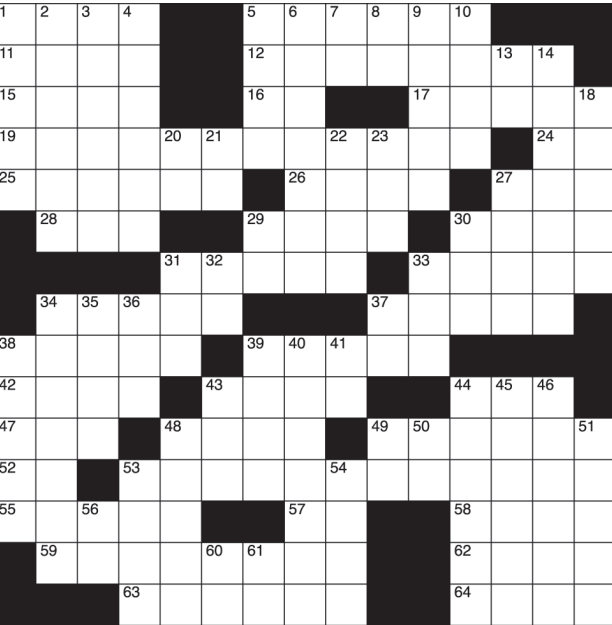
