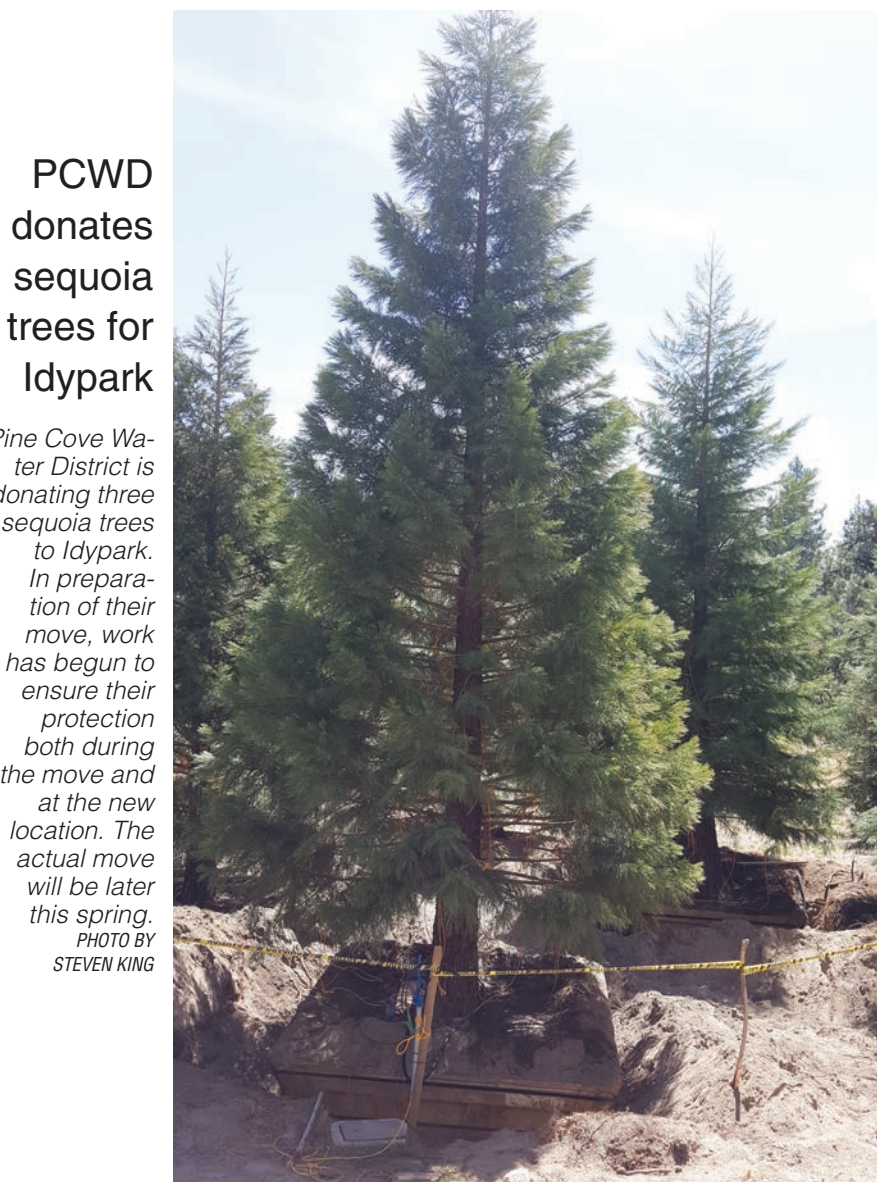

BofA to shutter Idyllwild ATM

The red-laminated sign posted on the wall next to the Bank of America's ATM located in the wall of BBVA's Compass bank, reads, "ATM Notice – On Tuesday, May 29 at 8:00 a.m., this ATM will permanently close. Your nearest Bank of America ATM is located at: Palm Springs Main, 588 S. Palm Canyon Drive, Palm Springs, CA, 92264. You may also visit us online at www.bankofamerica.com for other locations. Thank you for banking with Bank of America."

Notwithstanding the fact that the nearest BofA is actually in Hemet, the unilateral consequences of the decision to close versus immediately relocate the ATM in town, creates wide-ranging ramifications for personal and commercial account holders. Tourists' availability to funds can be expected to impact local businesses and the decision also impacts the cost of doing business for all three local water districts.

The ATM's closure forces BofA customers to drive a minimum of 40 minutes down winding mountain roads, in all manner of inclemental weather, to make payments, withdrawals or deposits in either Palm Desert, Hemet or Banning.

Additional customer feedback reports that the BofA ATM is often found empty by Sunday night or Monday due to the continuous cash needs of this community coupled with the influx of tourists making withdrawals. Upon inquiry, BofA media contact Colleen Haggerty mounted an investigation of ATM cash-out conditions, writing that "with the exception of an equipment failure which

Pine Cove Water discusses stretching rate increases an extra year

This will lower the initial rate increase

During the Pine Cove Water District's board meeting last week, General Manager Jerry Holldber offered some options to modify the water rate

increase proposal made at the March 14 meeting. Letters have notified property owners with meters within the district of a public hearing on the rate increases at 10 a.m. Wednesday, May 9.

"We've had good comments and bad comments, and a lot of questions," Holldber told the board. "But our charge of \$1.80 per 1,000 gallons for water is a long way from its \$7.35 cost."

Instead of increasing the charge for the first 7,500 gallons from \$1.80 per 1,000 to

\$4, Holldber recommended lowering the increase to \$3 per 1,000 in fiscal year 2018-19. Each succeeding year, the rate would increase \$1 until it reaches \$8 per 1,000 in fiscal year 2023-24. The ultimate goal of \$8 is reached but it takes one more year.

"The plan arrives at the same revenue numbers, but [the increases are] evenly distributed," he said.

Ambulance fees for Hill residents

With the upcoming changes in ambulance response effective May 1, the second-closest-available unit will be dispatched if American Medical Response is not available to respond because it is on another call. This could mean another AMR ambulance or Idyllwild Fire Protection District.

Locals have asked for a cost comparison of the two ambulance services. These are the current ambulance charges for AMR and IFPD. Note that non-IFPD residents are charged an additional \$313.95.

The Riverside County Emergency Medical Department annually approves AMR's rates. Its current contract allows AMR to adjust the fees once a year based on changes in the Southern California (Los Angeles and Riverside) consumer price index. These adjustments go into effect at the beginning of each fiscal year.

The IFPD commission sets its fees by resolution. These fees were approved May 23, 2017. The county does not regulate IFPD's fees.

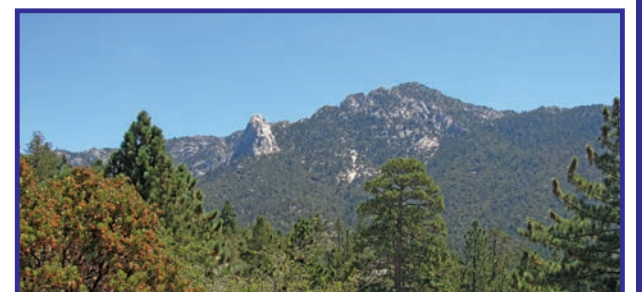

CSA 38 reviews purchases

Preparing for next year's budget

Members of County Service Area 38's (Pine Cove) Advisory Committee began preparation of its fiscal year 2018-19 budget, which begins July 1.

The committee, last week, reviewed the status of several already approved and funded projects, and its current financial balance before discussing some ideas for next fiscal year. At its May meeting, the committee expects to have the proposed budget completed and sent to the county.

Purchase of the masticator, for \$30,000, has moved through the Riverside County purchasing department and the equipment should be in Pine Cove by the middle of May, said Cal Fire Battalion Chief Robert Fish.

Work on a shaded fuelbreak near the Red Hill Truck Trail may begin later this spring, according to Fish. The management plan has been distributed for approval.

Items for the staff at Fire Station 23 are in various stages of being procured. The new lightweight and portable battery-operated extrication equipment has been approved and its purchase should be completed within the next two months.

Gaining approval for new rope and rescue equipment has presented Fish with some challenges, he lamented. Consequently, "I'm re-writing the specification myself," he shared.

Finally, he requested and recommended that the committee consider an automatic CPR device. "This would be a new tool and of great value to the communi-

ty," Fish said.

Not only would the repeated presses on the chest be more consistent and provide a constant resuscitation rate, it would be a safety tool for the medic in the ambulance. With their hands free, they could sit with a seat belt rather than unprotected on the drive to the hospital.

The committee unanimously approved funding for the Autopulse, the automated CPR device. Its estimated cost is about \$15,000.

Fish also confirmed that additional street address numbers were now available.

"Our goal is, reflector signs on every house in Pine Cove," said Committee Chair Jerry Holldber.

As of March 31, the CSA 38 cash balance was about \$407,000. Another \$30,000 from property taxes is expected next month before the end of the fiscal year.

The cost of the approved and pending projects is about \$90,000, and a separate \$17,000 for more fire hydrants in the community's undeveloped areas.

Holldber estimated that CSA 38 would have about \$345,000 cash available after all of the approved projects were purchased or completed. Also, next year's revenue would be \$60,000. So, the committee expects to have about \$400,000 for projects next year and into the future.

The special parcel fee for emergency medical service to Pine Cove was eliminated this year, reducing revenue by \$90,000.

Also, a small amount of funds may be available when the auction of Rescue 23 is completed, according to David Alvarez, development specialist with the county's Economic Development Agency. The new type 6 engine, purchased last year, replaced this vehicle.

Meeting to protest end of CSA 60 on Tuesday

A protest hearing on the proposed elimination of County Service Area 60 (Pinyon Pines and Pinyon Flats) will be held at 9:30 a.m. Tuesday, April 24.

The Riverside County Local Agency Formation Commission will hold the hearing at its office, 3850 Vine Street, Suite 240, in Riverside.

Any registered voter within the CSA 60 boundaries may file a written protest objecting to its dissolution. The protest must be filed before the end of the hearing and with the commission's executive officer (see address below).

In August 2017, the Riverside County Board of Supervisors passed a resolution requesting the county LAFCO review the need for CSA 60's continuation. In January, the LAFCO board unanimously approved its dissolution.

The board's resolution stated, "The purpose of [CSA 60] has been accomplished and there is no need to continue the service of operation and main-

taining the Pinyon Flats Fire Station as that responsibility is now performed as a core service of the County of Riverside through Riverside County Fire/Cal Fire."

CSA 60 was formed in December 1968 to construct, operate and maintain a fire station in the Pinyon Pines area. Station 30, on Highway 74, is the result of that effort.

Both the county's Economic Development Agency and Board of Supervisors believe the need for CSA 60 has ended. The collection of the \$25 special assessment ended in 2013.

Idyllwild board hears rate proposals from consultant

The Idyllwild Water District directors held a special meeting last week to hear an initial report from its rate consultant, NBS of Temecula.

Before describing the proposals for rate levels and structures, Greg Henry of NBS explained that the analysis started with IWD's draft budget for fiscal year 2018-19. From that point, it relied on IWD's projected future budgets as the basis for how much revenue would be necessary over the five-year period. NBS applied a variety of inflationary multipliers to the different expense categories, such as salaries, construction or fees, over this period.

The rate proposals would provide the revenue necessary to support these tentative future budget levels and ensure that the reserve levels were not drained because of future capital projects, Henry stated.

"Revenue needs to fund capital, and capital projects are needed to maintain the system," he said.

Sewer

He started with a presentation of the sewer program, whose revenue will increase to about \$750,000 in five years.

"There hasn't been an increase in sewer rates since 2013," said Financial Officer Hosny Shouman.

The standard measure of sewer service is the equivalent dwelling unit. Industry professionals define EDU as the measure of volume or expected flow of sewage equivalent that a single-family residence would normally generate. So, one EDU is assigned to a normal, single-family residence. A larger residence, with more bathrooms, could be assigned an EDU greater than one.

Currently, IWD charges its residential sewer customers \$38.25 per one EDU. NBS estimates this will have to increase to \$40 next fiscal year (2018-19) or about 4.6 percent. The annual increase from 2019-20 through 2022-23 is 2.5 percent, resulting in a \$44.15 charge for one EDU.

When Tom Paulek, an Idyllwild resident, asked if this was sufficient funding for IWD to improve its current sewage treatment to a tertiary level, Henry replied, "If the District goes to tertiary, that would increase rates substantially more."

General Manager Jack Hoagland added that there are no current plans to improve its treatment facility to that level.

Water

Devising a new water-rate schedule is more complicated. NBS had to first calculate what IWD's fixed and variable costs were to provide water to its customers. Fixed costs are considered the expenses to keep the district open and ensure water can be delivered to customers — staff, fees, pipes and wells. Variable costs are incurred when customers open the tap and consume water.

NBS estimated that IWD's fixed expenses are about 87 percent of its total annual budget and variable expenses are about 13 percent.

Relying on water-usage charges makes districts very dependent on revenue that is very variable. Encouraging conservation will reduce usage and, consequently, revenue, although there is no change in the fixed expenses.

Henry observed that the IWD capital-improvement program was already reducing the reserve totals.

NBS recommended three proposals, which differed only in how much revenue was collected from a fixed charge or from usage. Each of these would enable reserves to be maintained. And each is consistent with the 2014 state Superior Court case limiting the use of tiered-rate structures.

The first proposed rate schedule would raise the base monthly rate for customers with a 5/8-inch meter from \$29.70 to \$30.76; however, this new base would not include any water.

Currently, IWD includes the first 300 cubic feet of water (a cubic foot is the equivalent of 7.48 gallons) in the base. If the customer uses more than 300 cubic feet, the rate becomes 6.33 cents per cubic foot until the customer has used 600 cubic feet. More than 600 cubic feet currently costs 10 cents per cubic foot.

The first proposed rate schedule would charge 1.92

Pine Cove water consumption declines in March

Besides a discussion of the possible rate increases, the Pine Cove Water District directors reviewed the current financial condition and authorized a possible income survey of customers last week.

After three-quarters of the fiscal year, which ends June 30, expenses of \$655,000 are about \$41,500 greater than the district's revenues. However, May is when the balance of property tax revenue is received. The remaining portion of the estimated revenues is about \$60,000 greater than the estimated expenses through the end of June. Also, PCWD's cash balance at the end of May was slightly more than \$250,000.

General Manager Jerry Holldber reminded the board that "more of the [Rocky Point] lease money will be in the fourth quarter."

Speaking of the overall budget status, Holldber said, "I don't think there are any new surprises. Each [budget] category is in good shape. There's nothing unexpected."

During the meeting, Holldber recommended that the board consider conducting an income study of customers. The average census data for residents of zip code 92549 is too high for PCWD to qualify for disadvantaged community status, which would help it access additional funding from state grant programs.

The Idyllwild Water District did this several years ago and found that its residents were \$11,000 below the \$54,000 average for the whole zip code area. At the time, this did qualify IWD for more grant and loan money for its proposed new recycled water facility, which it subsequently decided not to pursue.

"This would increase our opportunity to get grant funds; it's not a guarantee," Holldber stated. The survey, which would be mailed to residents, is estimated to cost between \$5,000 or \$6,000.

Director Diana Luther described it as a worthwhile expenditure.

In water business, PCWD customers consumed about 2.3 million gallons of water in March, which was 11 percent or nearly 300,000 gallons less than a year ago.

"This is a little less than last year, but a good step," Holldber said. "But the water loss was 17 percent. Wow!" Two major leaks were the primary source of the lost water.

However, for the first quarter of the calendar year, total production has been 6.9 million gallons, which is 77,000 gallons or 1.1 percent less than the first quarter of 2017.

Regarding the water supply, he noted that the groundwater level of the district's monitoring well had risen a foot since February. "The key is, water is still going through the ground," he emphasized.

Before the meeting ended, in response to a question about the possibility of entering a Stage 2 water emergency,

The same change would apply to the water charge for use of 7,501 gallons to 15,000 gallons. The initial increase would be \$5, rather than \$6, and would reach the \$10 goal one year later in 2023-24. The same change would be applied to the cost of using more than 15,000 gallons. The first year, it would be \$7 rather than \$8 but still grow to \$12 in 2023-24 rather than

2022-23.

The bimonthly fixed charge would be increased \$3 per year, starting in fiscal year 2018-19 and also ending in 2023-24. In March, the proposed increase in the first year was \$6. In the next two years, it was a \$4 bimonthly increase and only \$2 bimonthly in fiscal years 2021-22 and 2022-23.

This proposal would be a \$3 bimonthly annual increase through fiscal year

Since buying the TC in 2013, Jack and I have little time to travel — unlike after he retired in 2010. We dream and talk about doing so again, and, hopefully, we'll get that chance soon.

In the meantime, we take mini-vacations, particularly when serving on the California News Publishers Association board and/or Government Affairs Committee.

Last week, the quarterly meeting and annual Press Summit landed in Sonoma, one of the wine country areas least hit during the fires in Santa Rosa last year.

Our visit up there was so short (Thursday to Sunday), we never made it into the fire-ravaged areas.

Traveling took up most of Thursday, from waking at 4 a.m. to getting to the Ontario airport before the plane lifted at 8:25 a.m.: the one-and-a-half-hour drive, the parking, the shuttle, checking bags, security — you know the routine, if you fly at all.

People doing what you're doing — trying to patiently wait in line. Some are dressed for business; some for pleasure. They mostly read their phones, avoiding eye contact unless necessary.

We flew to Oakland, waited to get off the plane in a line, waited for our bags, waited in line for a shuttle and got in a line for a rental car. We followed the line to leave the rental lot, got in a line for the freeway and left on highways for Sonoma — reading the map on the phone, following the lines.

I live an impatient life, one of newspaper deadlines and a toe-tapping spouse. To deal with my impatience, I knit. I knit in the car, I knit on the plane, and I knit in line. Socks are easy to pack and easy to whip out when you're in line. My tolerance level rises greatly as I watch another row grow beneath my needles and feel that I'm not wasting my time.

One of my greatest pleasures is the occasional time I can "sleep in," which often just means staying in bed in the morning, reading or doing crosswords, and getting up at my leisure. That's typically a weekend morning.

Because of the expense at the lodge and all the other motels in Sonoma, Jack and I stayed in an Airbnb — a guest home owned by a wonderful host couple. After the heavy traveling, an intense Thursday-afternoon board meeting and an equally intense day of sessions Friday that included deadline with an issue back at the paper, we welcomed the brief vacation weekend in Sonoma following no lines. We "slept in," piddled around, stopped at the Sonoma Market for a picnic lunch, and avoided downtown Sonoma, heading south into the country to a winery where we shared a tasting, bought a bottle and enjoyed our little picnic over a beautiful scenery of vineyards. I knitted and took a small hike around the vines. We relaxed. No lines.

The following day, we "slept in" again, then checked out to enjoy some time in Sonoma before heading back. After lunch, we reversed — driving the rental car back into the waiting lines as we traveled south to reach home. It was a short but sweet mini-vacation.

2023-24. While lowering the initial increase and extending the total increase, this proposal slows the collections of revenue for the district's reserves and future capital projects.

Currently, PCWD collects about \$410,000 from its bimonthly fee, but Engineer John Egan estimated that the district's annual fixed costs were more than \$600,000. At the end of the rate increases, the annual fixed revenue would be about \$535,000.

"Even with raises, the rates do not cover all of the fixed costs. It just gets us closer," Holldber said.

Since these changes are less than the original rate-increase proposals, Holldber told the board it was not required to change the public hearing date. This is necessary if the board might consider or approve rates higher than the original proposal described in the notifica-

tion letter.

Board members appreciated Holldber's response to the initial public comments. Director Steven King said, "The new plan reduces the shock value."

And Director Lou Padula added, "It's necessary. We need the increases, but do it as gently as possible."

Resident Laura Wilson asked why the letter explaining the increases and announcing the public hearing was not sent to district renters.

In response, Holldber explained that the district bills property owners, even if the property is rented. The property owner is responsible for any water usage through the property's meter.

Office Manager Becky Smith said 1,108 letters were mailed. If 51 percent or 564 property owners opposed the rate increase, it would not be approved.

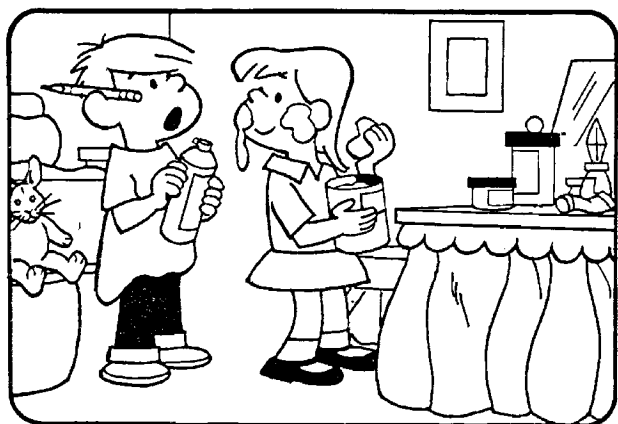

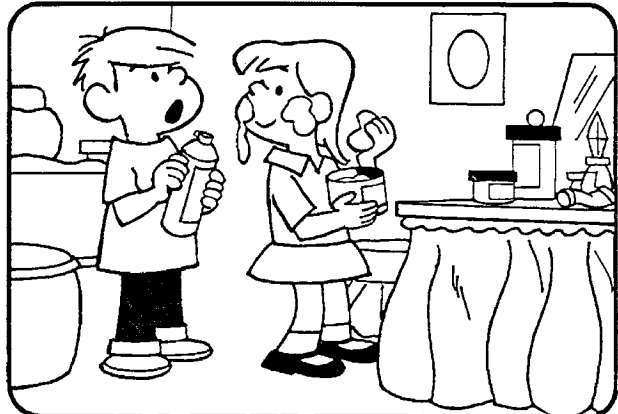

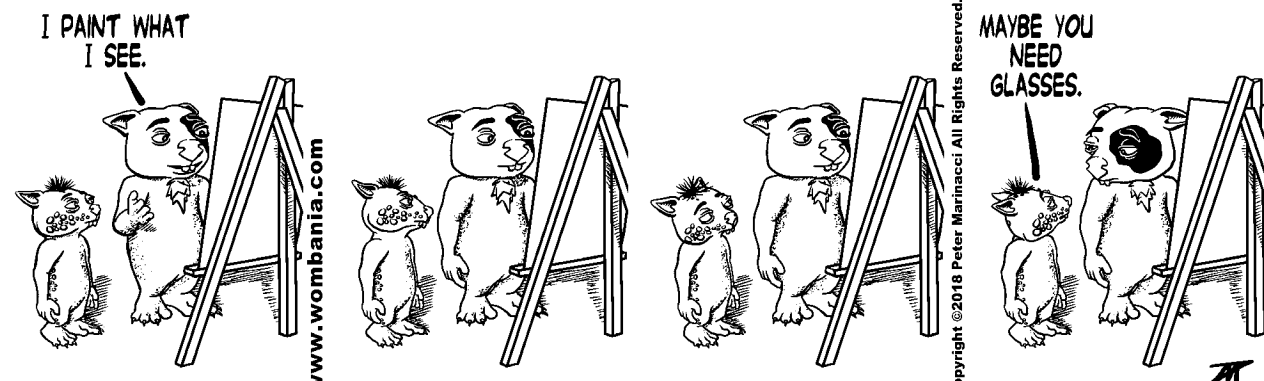

Pinyon murder trial starts

Opening statements in the trial of Robert Pape and Cristin Smith, both 29, charged with the 2006 murders of Jon Hayward, Vicki Friedli and Vicki's daughter Becky in Pinyon, began Monday. Both have pleaded not guilty.

Three counts of murder, with a special circumstance allegation of committing multiple murders, were filed on June 8, 2016, against the two men. If convicted, both men face life in prison without the possibility of parole, according to the Riverside County District Attorney's Office press release.

Charges were originally made in March 2014, but later dropped in the fall. After being elected district attorney, Michael Hestrin had the case reviewed. New evidence was collected and the charges filed in 2016.

Becky's body was found burning in a wheelbarrow outside the house. The other bodies were found inside the burning home. The autopsies, conducted in September 2006, revealed that all three were assaulted and may have died from the injuries before the fire.

Idyllwild grinding facility opens more days May 1

The Idyllwild grinding facility will resume Monday operations Monday, May 7. The facility will be open from 8 a.m. to 4 p.m. Mondays, Wednesdays and Fridays, (closed noon to 1 p.m. for lunch) from May 1 to Nov. 30.

The facility will then close again on Mondays during the winter months (December through April) due to low tonnage volumes and customer participation.

The grinding facility accepts wood waste affected by the bark beetle. Prohibited waste includes household waste, appliances, e-waste, metals, tires and other hazardous, explosive and medical wastes. Customers who use the facility pay a per-ton rate on pre-paid accounts.

The facility is located at the 5,000-foot marker, 1 mile south of the Idyllwild Transfer Station, on Highway 243.

was quickly resolved in early March, our system reported no cash out alerts since 1/1/18.”

It appears that BofA has underserved local Idyllwild depositors by incrementally limiting access to services since it closed the branch; actions which represent significant customer service issues. Idyllwild Community and Idyllwild Chit Chat Bulletin boards on Facebook record combined responses to the news of more than 150 comments in 24 hours. Brent Sechrest wrote, “... without an ATM option in Idy I’ll probably close my account.” Bill Judkins: “The only reason we chose B of A was because of the ATM in town. Now we’ll have to reassess.” Laura Huff: “Nooo... I use the ATM regularly.” Kai Van Bodhi: “I have a BOA account and depend on that ATM for deposits. It would def. effect my business.” Marilyn Baker: “Need Bank of America in Idyllwild...big time...!!!” Lindsey Oliver: “We use the ATM weekly for both personal and business use. The ATM up here is very convenient. If they remove the ATM they will lose our business, I’ll have to change banks.”

These reflective community concerns are mounting as news spreads, coupled with disappointment that BofA did not inform depositors directly.

Village Hardware Manager Larry Donahoo said, “When the branch was taken out many years ago, the manager came by the store and promised to keep the night deposit drawer; no added expense would be incurred. BofA would provide special deposit slips and a money bag for night deposits, no charge. A few years passed and they closed the night deposit. Now my staff drives 40-plus miles to Hemet, facing a dark parking lot with security concerns, to make deposits. Basically, BofA has forgotten their promises to Idyllwild; it’s a classic case of institutional amnesia.”

Jerry Holldber, general manager of the Pine Cover Water District, further pointed out: “With the removal of the large deposit drawer, our water district

was unable to make deposits into our BofA accounts. This created the initial need for staff to drive all deposits off the Hill. We have since solved this problem in part. However, I view closure of the ATM will create hardship for Idyllwild customers in general; if our customers can’t easily make deposits, they may find it difficult to pay their water bill — every one doesn’t own a Smartphone.”

Many years ago, BofA maintained a branch in Idyllwild acquiring a significant percentage of commercial and personal accounts in the area. “Over 10 years ago, that branch closed,” remembers PCWD Office Manager Becky Smith. “Pine Cove Water was informed by letter when the branch closed that the day would come when the ATM would be removed,” Smith recalled. The branch closure slid largely under the radar because BofA maintained an ATM outside BBVA’s main door, initially providing night deposit and standard ATM services for its customers.

In retrospect, the initial act of closing the Idyllwild branch by BofA more than 10 years ago was the first breach of community trust; the second breach occurred when BofA removed the external, secured depository system for use by government, educational and commercial customers. The final act, removal of the ATM entirely, will complete the erosion of reasonable access to deposit funds and investment share disbursements.

“The Community Reinvestment Act (CRA), [enacted by Congress in 1977] was created to encourage depository institutions to service the banking needs of the communities in which they operate; specifically under-served rural communities,” said retired bank executive and Idyllwild resident Les M. Gin, a vice-president with Wells Fargo for 10 years, Chase for 15 years and founding president of the Asian Bank of Arizona.

Gin added “The CRA rating, which is administered by the FFIEC and FDIC, are essential to a bank’s overall viability when governing bodies evaluate their applications for mergers, acquisitions and branches; any breach, thereof, is con-

sidered a serious violation. In fact, the FDIC website invites community comments which can trigger the need for a bank’s review by the Board of Governors of the Federal Reserve System Board. Also, negative media publicity and public outcry emphasizing actions a bank is taking to restrict accessibility to depositor funds can result in an under-served community having their services restored,” said Gin.

The FFIEC website [https://www.ffiec.gov/cra] states: “The Council is a formal interagency body empowered to prescribe uniform principles, standards, and report forms for the federal examination of financial institutions by the Board of Governors of the Federal Reserve System (FRB), the Federal Deposit Insurance Corporation (FDIC), the National Credit Union Administration (NCUA), the Office of the Comptroller of the Currency (OCC), and the Consumer Financial Protection Bureau (CFPB), and to make recommendations to promote uniformity in the supervision of financial institutions.”

Idyllwild residents have long endured the rigors and limitations presented by the absence of a full-service national bank whose products include a vast number of ATMs, broad-spectrum international banking relationships, nationwide branch locations, a LAIF deposit program for California state water utilities and management of expansive investment portfolios. This

is problematic for residents with diverse banking needs.

LAIF, the Local Area Investment Fund, is managed by California Treasurer John Chiang and his board to specifically enable California utilities the benefit of earnings from low-risk investments. LAIF does not accept deposits from water districts by mail.

Each of the local three water companies may perform online wire transactions into LAIF-chartered bank accounts, for no charge. The LAIF investment program had chartered eight U.S. banks and BBVA Compass is not on the list.

While the total combined savings deposits to LAIF by three water districts is small change to BofA, the state treasury may hold a collective expectation that participating LAIF banks, who reap significant income from participation, will support small constituencies such as Idyllwild by maintaining an ATM with night-deposit capability, at the very minimum.

It could be LAIF agrees. The disadvantage to the operation of local water districts appears to be of interest to Marc Lifsher, director of Communication for the California State Treasurer’s office responsible for managing LAIF. Lifsher said, he was “unaware of BofA’s intention to shut down in Idyllwild.” Lifsher went on record stating, “We recognize BofA has closed a lot of branches in the state, particularly in Northern California. Our banking unit

is now looking into the restricted banking implication for Idyllwild’s water districts.”

In a follow-up conversation, Lifsher advised, “Bank of America stated they are offering water companies and commercial account holders free check readers.”

Fern Valley Water District General Manager Victor Jimenez said, “Our district elected to abstain from opening multiple bank accounts off the Hill in response to this hardship and in service of cost containment.”

Fern Valley Office Manager Jessica Priefer additionally disclosed, “Some years ago when BofA removed the large deposit drawer from the ATM, we were very inconvenienced by having to drive deposits off the Hill. We subsequently purchased a manual check reader. However, it’s time consuming to insert individual checks, and when coin accumulates, I’m required to drive the deposit off the Hill.”

Idyllwild Water General Manager Jack Hoagland acknowledged his district has similar issues that have been solved by opening alternative bank accounts on and off the Hill. “Subsequently, bank fees, ACH and wire transfer costs incurred don’t exceed \$200 per month,” said Hoagland.

The Town Crier inquired of Haggerty as to how the bank justifies abandonment of the Idyllwild community of depositors cultivated over decades. She responded, “Your concerns have been

escalated to colleagues [—] we are considering an alternate location for our ATM.”

A subsequent response from Haggerty reads, “I am following up on the other part of your inquiry around the ATM. We certainly understand the importance of maintaining a full-service ATM for customers, residents and visitors in Idyllwild. While we would prefer to keep the current ATM location, our lease there expires on May 31. The current property tenants then plan to locate their own ATM at that location. We do, however, continue to actively work on securing a new location, in town, for a new Bank of America ATM.” The Town Crier will give updates on this issue.

Meantime, Wall Street Journal reporter Rachel Louise Ensign reported April 16, 2018, that “Bank of America Corp. said Monday that a boost from the U.S. tax law and continued rising interest rates helped push first-quarter profit 30 percent higher, extending the string of better-than-expected results from the nation’s biggest banks. Quarterly profit at the Charlotte, N.C.-based bank rose to \$6.92 billion from \$5.34 billion a year ago. Per-share earnings were 62 cents; analysts had expected 59 cents per share. Revenue came in at \$23.13 billion, up from \$22.25 billion a year ago. Analysts had expected \$23.06 billion.”

Holldber confirmed that he would likely make that decision and announce it at the May meeting.

“The purpose is heightened awareness,” he said. “The mandatory conservation rules do not apply.”

A Stage 2 decision is not needed because of a threat to the district’s water supply. Holldber stressed that he is not worried about running out of water, he just wants to keep customers aware of water’s dependence on weather and the need to conserve its use.

Holldber also reported that he has been discussing the water theft case with the District Attorney’s Office. An estimated 2.3 million gallons were stolen from the district and used to water an illegal cannabis grow last year. The estimated cost of water and staff work was nearly \$60,000.

In September, the Riverside County Sheriff’s Department arrested Joel Vargas-Hernandez of Moreno Valley for the recent water theft. He was shortly released on \$52,000 bail. A preliminary hearing is scheduled for May 17.

“I thought there might be some kind of proposal, but I did not receive anything,” he said. “If the DA can get a portion, that’s good. Otherwise, we have the right to sue and go to civil court for our expenses.”

cents per cubic foot from one to 450 cubic feet. The second tier would be 451 cubic feet to 900 and cost 11.54 cents per cubic foot.

Commercial users would also see an increase in their base levels but would pay a single uniform fee of 6.82 cents for each cubic foot of water consumed. There would be no tiers for commercial customers.

The other two rate schedules increased the amount of revenue from the base charge and relied less on the usage fee.

NBS estimated that for customers who consume less than 300 cubic feet, the monthly bill would increase from the current \$29.70 to \$36.53 in the first proposal (the greatest weight on usage) to \$41.79 for the third option, where fixed revenue is 65 percent of the total revenue collected.

For a customer at or less than the proposed tier of 450 cubic feet, the current bill would be about \$39.20. The estimated monthly increase under the first option is 22 cents and \$5.48 under the third option.

Commercial customers would see higher percentage increases, but the greatest increase would be when the fixed revenue was only 55 percent of the total.

Voices, a new chamber consort, premieres 'Tapestry'

"A Tapestry of Medieval Life" is a drama about medieval life complete with music of the time, compiled from period documents, directed by author Jenny Egan. The cast features well-known Idyllwild actors Scott Wilson, Derrik Lewis, Barbara Rayliss, Rena Lekach and Marilyn Beauchesne.

This production signals a debut of Voices – an Idyllwild Chamber Consort. Why Voices? "The word resounds on many levels. The human voice can speak, can sing, can murmur or cry out. Musical instruments also have voices. So do animals. So does the wind," muses Egan.

"Tapestry" is an enlarged and revised version of the program premiered at the Metropolitan Museum of Art by the nonprofit Four Winds Theatre Inc., the first ongoing documentary theater in America. Written and directed by the Four Winds founder and artistic director Egan, the "Tapestry" cast included the distinguished Alexander Scourby and Broadway actress Elizabeth Parrish.

Hailed by the New York

Times as "a new perspective on the arts," the Four Winds productions employed dialogue taken exclusively from primary sources. "Voices from the period without modern interpolation speak eloquently to our troubled era. Sometimes, when we listen to voices of the past, we hear ourselves talking," said Egan.

"Documentary theater is compilation. The choice was artistic," said Egan. "Based on the premise that a play could form a plot with dialogue derived entirely from actual writings of individuals living during a period or who witnessed an event, one finds a coherent theme that presents cues to the essence of social experience; the material itself makes you understand," Egan suggests.

Whether currents of the period reflected religion, superstition, music, art, romance or views of social mores, Four Winds' portrayals of historical accounts during the American Revolution, the conquest of Mexico or enlightenment in England were based on direct accuracy. For instance, the troupes' production on the topic of immigration due to relevance, was staged at the

Statue of Liberty Museum in New York.

Egan is a relatively recent transplant from New Mexico. Her journey, heavily researched and preceded by extensive traveling to a multitude of California's small towns, landed her unequivocally in Idyllwild. Artistic sensibility and a love of nature determined this was the place to continue her life-long contribution to the art of documentary theater and teaching.

Egan conceived of documentary theater as a genre as a young student of history and art in NYC. As founder and artistic director of Four Winds, Egan won the Clarence Derwent Award for her debut on Broadway as Mary Warren in "The Crucible." She created roles in the American premieres of plays by Albee, Arrabal and Ionesco, and was a fre-

quent performer on television and in film.

She's a recipient of two Ford Foundation grants to be assistant director of the New York Shakespeare Festival and the Lincoln Center Repertory Company. Egan has authored and produced more than 15 documentaries; she holds a doc-

torate in Humanities from New York University where she taught. Recently, she was honored with a Distinguished Alumna Citation from Grinnell College for her work in documentary dramas.

Author of five theater-related texts, including "A Space in Time," 2011 Lu-

mina Press, Egan provides succinct guidance for documentary theater creation.

"It's my impression that Idyllwild is ripe for developing its theater activity and would benefit from a teaching center. In order to produce and maintain quality theater productions, directors benefit when actors with homogenous training achieve congruency by employing similar techniques. It's a weighty consideration," said Egan.

"Tapestry" stages fire-side, Tuesday evening, April 24, at the Idyllwild Library. Admission is free. A tech and dress rehearsal, open to the public, will begin at 3 p.m. The performance begins at 6 p.m.

Citizens' Climate Lobby's local chapter hosts first gathering

With the initial formation of Idyllwild Indivisibles' environmental committee, Melanie Lamaga, Dr. Joan McCullough, Karen Johnston and Mallory Cremin became community leaders for climate change. However, it didn't take long to realize the overwhelming nature of their call to action.

Lamaga began researching. "I picked CCL because of their bi-partisan support in Congress, their market-friendly, carbon-fee dividend program and their simple positive approach which telegraphs non-violent communication," she said. "As I see it, changing climate is threatening this town's very existence by threatening the forest with drought and, potentially, fire."

When asked what motivated her involvement, she responded, "It's a feeling of necessity because the situation with climate change is dire. I love the planet, and I don't want people to suffer and I feel responsible to use the skills I have to do what I can."

Johnston added, "Personal involvement is so important; wouldn't it be great if Idyllwild residents would make it a priority to reduce their carbon footprint?" McCullough shared, "It's actually fun to make progress against something so intimidating. Our goal is to use science to demonstrate that climate problems are so huge that everybody needs to do their part."

In Cremin's view, "I'm impressed with CCL's tiered organizational structure offering so many ways people can offer their impact. I think CCL offers hope in this era of rising temperatures — through collective efforts we can affect change."

The Idyllwild chapter's first meeting took place Saturday at the library, led by CCL So Cal coordinators Craig Preston and Linda Kraemer. It was well attended by local residents and an interested educator from Hemet, "looking for education and direction for action steps," said Dawn Rizer.

Her husband, Jim Rizer, president of the San Jacinto Green Coalition added, "I lived in Idyllwild for 34 years. We moved our family off the Hill when education and jobs found us working or going to school off the Hill. We couldn't justify the amount of auto pollution we were generating daily. As a diver, I've seen degradation of coral reefs first hand. I came today because I want to get further involved."

He added, "As a science teacher teaching about climate change for 20 years, a concern is the effect on wildlife." His message, "keep fossil fuels in the ground."

Early on in the meeting during a group conversation addressing issues pertaining to consensus building, Kraemer offered a quote from University of Arizona Regent and Professor of Geography and Developmental Sciences Diana Liverman, who said, "The US' greatest problem is the politicizing of climate change. Europeans are able to separate the hard science from their political leanings. Americans really need to take a cue."

CCL lobby and Citizens' Climate Education materials entitled "A New Horizon for Climate Action" include purpose, action and solutions. Their carbon fee and dividend program provides a solution for unlimited carbon emissions while building responsible economic and social infrastructure. A Republican Climate Resolution, which declares that climate change is real and deserving of con-

gressional action, has been signed by seventeen Republican representatives to date. Also, 37 Republicans have teamed with Democrats across the aisle to stand together with the Climate Solutions Caucus to develop and implement advancing climate-change legislative directives.

Preston, a registered Republican, got involved with CCL when he learned about his individual climate footprint. "Building a climate constituency through education and bi-partisan support is CCL's national charter," said Preston. "Our plan will reduce greenhouse gas emissions enough to stabilize the climate while boosting the economy."

Idyllwild resident Frank Baele, a retired science teacher from Crossroads School in Santa Monica, said, "I'm most concerned about the effects of drought; climate change is of great importance."

The CCL Idyllwild chapter meets the second Saturday of each month and features a nationally linked speaker and breakfast snacks. The next meeting is at 9:45 a.m. Saturday, May 12, at the Idyllwild Library. 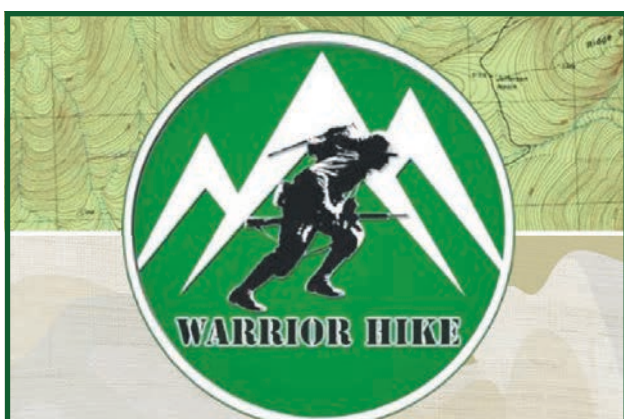
