Creation of community center begins

Village square — Idypark — is dedicated

May 26, a Saturday, began Memorial Day weekend, which we observe and is when we honor those who died serving our country. But this year, it seemed that Idyllwild, not the site of battles or military installations or cemeteries, was being honored.

While many residents are born and raised in Idyllwild — "hillbillies" — two former East Coast residents, who have moved to the Hill, have graciously and generously shared with this community. Their gifts were the focus of both public events Saturday.

First, at 10:30 a.m., the official ceremonial groundbreaking for the Idyllwild Community Center occurred. The concept and desire for a community center pre-dates the arrival of the Butterfields -Loie and Dave — but they have guided it to this point where fruition is no longer a dream, but merely the clock ticking.

New yearling bear shows up on the Hill



Bear carvings in Idyllwild are abundant; their images establish an enduring fascination with these affectionate mountain charmers who exude an abundance of strength, confidence and leadership. The San Jacinto Mountains, once generously populated with black bears coexisting with native tribes, are a testimony to the frontier spirit embodied by early Idyllwild settlers and are, for the most part, a fond memory, memorialized most notably by the Idyllwild town monument.

Once upon a time, great bears roamed the San Jacintos. Identifying with their presence and power led to their choice in 1846 for the

California state flag. Memorialized in Idyllwild by the annual Bear Festival circa 1950s, when a live bear was paraded through

Edison visits Hill, describes current, future plans

Big turn out for community discussion

Thursday evening, May 24, at the invitation of the Mountain Disaster Preparedness group, Southern California Edison staff were at Town Hall to discuss past and future plans to improve the delivery of electrical service to the Hill.

"You never know what power

means to you until you lose it. And it happens too frequently up here," said Mike Feyder, MDP president, introducing the evening's discussion. "It's more than an inconvenience; for those with medical needs, it can be an emergency.'

Speaking first was Jim Ward, assistant manager at the Wildomar SCE office. He described the work that has been done in the past several years to improve infrastructure on the Hill.


For example, the 4 kilovolt lines have been upgraded to 12 kV. Besides better reliability, the higher-voltage lines have several benefits. Obviously, greater capacity is one advantage. Also, outage times are fewer because there are now many more 12 kV circuits.

Besides the higher-voltage lines, SCE also has been replacing older wire with larger wires, some metal poles have been installed, and more and stronger cross bars decrease the probability that fallen branches will break wires.

This summer, Edison plans to make major improvements to the substation in Idyllwild. This is behind the Idyllwild Water District office. Among the upgrades will

Riverside County 3rd District Supervisor Chuck Washington attended and spoke, Janice Lyle, president of the board for the San Jacinto Mountain Community Center, announced another gift from the Butterfields.

On Friday, the day before the groundbreaking, they made another donation, which enables the planned outdoor amphitheater to be built during Phase 1. While that had been an original intention, the available funding was only sufficient to complete grading of the project site, and construction of the roadway and parking ar-

The main building is scheduled for the next phase and the SJMCC board already has \$1.6 million available for its construction.

Now, the amphitheater will be completed and summer concerts will have a permanent home conducive to entertainment.

After the groundbreaking, most of the attendees sauntered a few hundred feet east for the dedication of Idypark. A 50-foot flag pole has replaced Jo'An's restaurant.

Again, the Butterfields purchased the site in the fall. With the help and assistance of Shane Stewart, the building was razed, sidewalks and more stone walls installed, and three young sequoias, a gift of the Pine Cove Water District, were transplanted.

On Saturday, Idypark was dedicated in honor of veterans and first responders. Pastor Wally Boer, of the Cross Road 243 Church, led the ceremony. American Legion Post 800's Honor Guard presented the flag and fired the volleys. Buzz Holmes led the Idyllwild Master Chorale and Local Color in several patriotic songs.

During the ICC ceremony, long-time Idyllwild resident Robert Priefer described the long and slow path from the early 1980s the work. until Saturday morning.

2006. ... there was controversy over recreation ... and who was going to do recreation," Priefer said during his narration. "Then Dave Butterfield walked into my office ... I told him, What we really needed was a community center.' ... and a month later he returned and said, 'Let's do it."

With the 5 acres for the community center, Loie and Dave have donated more than \$5.5 million to the residents of the Hill. The funds for an amphitheater are just the latest

"This is a staggering number," Lyle said. "No other community is as lucky as us to have their help and encouragement."

She then introduced Washington, who also is proud and happy that the county's mountain communities share their beauty in his district. But he also brought a proclamation from the Board of Supervisors. All five signed it honoring the Butterfields for their generosity to the community.

The proclamation recognizes not only the gift of the community center, but the creation of Idypark.

The supervisors recognized, "... the significance of these tremendous gifts to the residents and visitors of Idyllwild and gratefully thank Loie and Dave Butterfield for enhancing the quality of life for everyone who resides in or visits this special mountain community."

And a huge applause broke out from the dozens attending the ceremony.

Earlier, Dave said that he and Loie were very blessed to do what they've accomplished. "And we only had one philosophy. The community should develop on this site whatever the community can fund and wants."

But they felt disappointment that the amphitheater could not be funded. So, with more generosity and love, they donated the funds for its completion as part of the first phase of

Hemet school district schedules three money hearings June 5

The Hemet Unified School District Board of Trustees has scheduled three separate public hearings during its Tuesday, June 5, meeting, which begins at 6:30 p.m. in the Professional Development Service Center Board Room, 1791 W. Acacia Ave., Hemet.

The hearings will address three different financial topics. The first will be the presentation and possible adoption of its budget for fiscal year 2018-19, which begins July 1.

The current year's budget for HUSD is about \$265.5 million, which when approved was about \$8.5 million greater than expected revenues.

The second hearing will be presentation and adoption of the portion of the budget identified for the Local Control Accountability Plan. These funds support the priorities that staff and parents have developed during the past year in FY 2017-18. The initial funding for Local Control was about \$200 million, including staff costs and basic ex-

The third hearing that night will be to hear the district financial staff discuss the current fiscal conditions, expectation for next year and how much funding should be assigned to the district's reserve accounts, such as for economic uncertainty.

California law allows time off to vote on election day

To help ensure voters can get to the polls on election day, June 5, California law allows workers to take up to two hours off work to vote if they are unable to during nonwork hours.

"Californians should make a plan now for how they will cast a ballot on election day," Secretary of State Alex Padilla said. "Every registered voter has a right to cast their ballot before the polls close. If you can't make it to your polling place outside of working hours, you have the right to take time off to vote, without a loss of pay."

California Elections Code section 14000 allows workers up to two hours off, without a loss of pay, to vote if they do not have enough time to do so in their non-work hours. The law requires workers to notify their employers two working days before the election if they need to take time off to vote.

Polling places are open between 7 a.m. and 8 p.m. on election day.


Also, every California employer is required to post, in a visible location, a notice informing employees of their rights at least 10 days before an election. The Secretary of State's office offers these free, print-ready notices in 10 languages at www.sos.ca.gov/elections/time-vote-notices/.



Idyllwild Fire adopts budget for next fiscal year

Requests advance of property-tax revenue until December

At its May 22 meeting, the Idyllwild Fire Protection District commission approved a preliminary budget for fiscal year 2018-19, which starts July 1.

IFPD is estimating that revenues will increase very little next fiscal year. Total revenue is projected to be \$2.345 million, which is about \$40,000 more than the current-year estimate. The growth in revenue is entirely from property taxes and parcel fees.

Battalion Chief Mark LaMont explained that he works closely with the county Auditor's Office to estimate expected tax reve-

With a 2-percent projected increase in revenue, the expenses for next year are also not expanding. Total salary costs are \$1,000 more than the \$1.196 million this year. The basic shifts are anticipating increases in regular overtime for firefighters, engineers and captains. Offsetting these increases are reductions for the battalion chief overtime and costs for reserves — regular pay, mutual aid and limited term.

In other operational costs, miscellaneous expenses and purchase of equipment for more than \$5,000 goes down about \$53,000. The ambulance-collection contract, the emergency services coordinator, dispatch services and vehicle costs grow about \$23,000 for a net decrease of \$29,000.

The cumulative effect for the expense changes is a savings of \$34,000, resulting in a total budget of \$2.28 million.

The commission is projecting that the current fiscal year is likely to produce a positive balance of \$40,000 and another \$74,000 next year. These funds will likely be directed into the district's reserve accounts.

Through the end of April, the current budget has a negative balance of \$100,000. However, Commissioner Jerry Buchanan, chair of the finance committee, reported that IFPD recently received a property-tax payment of nearly \$400,000.

He added that IFPD has not received reimbursement for all the mutual-aid costs; so, more revenue is expected.

In other financial business, the commission unanimously approved two resolutions. The first requests that the county collect IF-PD's annual \$65 parcel fee. The second resolution requests an advance of \$400,000 of IFPD's annual property-tax revenue. This is needed to help the district during the first five months of the fiscal year before the first property-tax payment is issued.

The \$400,000 requested has been the same since 2016. The district and county have agreed to an advance for each fall since

From July through the middle of December, IFPD's cash flow is limited to ambulance collections because it receives no property tax or assessments during that period.

With the advance from the county, bills are more easily paid, and the December revenue reimburses the county for the advance and small fee of about \$3,350.

LaMont and Buchanan agreed that the need for an advance may diminish in future years since cash flow has been improving in recent years.

Idyllwild Fire feels county not applying 'closest unit' policy

Although Riverside County has begun implementing its "closet unit policy," Idyllwild Fire Battalion Chief Mark LaMont told the commissioners last week that a special clause effectively results in no change from when there wasn't any policy.

"Unfortunately, we're still dealing with the same issue," he said. "It says [American Medical Response, the county ambulance servicel is the same distance as Idyllwild Fire for all calls on the mountain. I've argued with them for hours on

In effect, for any incident west or south of Idyllwild, such as Mountain Center or Garner Valley, the dispatch unit can send AMR before dispatching Idyllwild Fire.

"Fundamentally, it hasn't changed?" asked Commissioner Ralph Hoetger.

However, the director of the county's Emergency Management Department believes the changes have occurred and IFPD had concurred with them.

"At our meeting finalizing the policy in question that went into place on May 1, there was unanimous agreement from AMR (Doug Key), County FD (Chief Talbot) and IFPD (Chief Reitz) that for response purposes the AMR ambulance in quarters and IFPD ambulances in quarters would be considered equal distance to anything south of Idyllwild," wrote Bruce Barton, EMD director.

"I raised the question if it was a com-

mon practice for IFPD to post ambulances down 243 closer to Mountain Center where they may be closer; Chief Reitz stated they don't stage ambulances that way."

Barton also added that the vehicular-location equipment helps dispatch from where each ambulance is at the moment one is needed. "AMR can identify which ambulance is closer and send that ambulance," according to Barton, who added that his office will review and discuss the response data to assure the policy is being implemented as it was intended.

LaMont added that he did not feel he could garner any change in the policy. If the commission wished to raise the issue to the Riverside County Board of Supervisors, then a letter and request for a discussion at a future board meeting might be more successful.

"What possible reason is there for not sending the closet-possible unit to the incident?" LaMont asked rhetorically.

Commissioner Jerry Buchanan suggested that the residents in Mountain Center and Anza should consider preparing a request to the board to be annexed into the Idvllwild Fire district and file it with the county's Local Agency Formation Committee.

The commission asked LaMont and Fire Chief Patrick Reitz to prepare a letter from them to the supervisors and to arrange a meeting to discuss the issue with the county's elected officials.

"I've always been involved with political issues - public policy, affordable housing and immigration, but not as a candidate," he said. "I had thought running for office was an impenetrable, establishment, elitist exercise. But after Trump won, I had to rethink that.

"I was born and raised in this district. I know its people and its issues. That's why I'm running for office for the first time.

There are so many things that need improving a major housing crisis, health care, out-of-control student loans and wildfire response."

And although a Democrat in a Republican-leaning district, with endorse-

and mental-health checks. My position is much the same as Bernie Sanders regarding the right of citizens to have guns." (Sanders represents Vermont in the U.S. Senate and ran for president in 2016 as an Independent. When he ran in 2016, he noted that Vermont, with many hunters, is one of the most gun-friendly states in the country, but has a low level of gun violence. Sanders stated then that he believed in a "middle-ground solution in the national gun debate.") Elia also believes in finding middle ground with gun opponents and supporters.

Elia also does not support the current gas tax, a recent tax opposed by many Republicans in the California Legislature. "It's punishing the people in my district," he noted. "The Legislature should have worked out a budget to address state transportation infrastructure."

Elia believes he is better positioned than Republican incumbent Voepel to work effectively with the Democratic supermajority in Sacramento and better serve the district voters, Republican and Democrat. "Voepel's been ineffective," said Elia. "He's done nothing on committees and accomplished nothing for the voters or the district. I can be more effective and work across the aisle.

"Mine is a serious campaign. We have a full-time campaign manager, and are using house parties and social media to raise money. We take no corporate money. Most of over \$40,000 in contributions raised has come from small donors."

Part of Elia's professional background was working for Wells Fargo and as a financial consultant. He said he has seen firsthand the abuse and corruption in corporate banking.

Just as some cities in California and elsewhere are considering public banking options, Elia advocates establishing a California State Bank, much like the Bank of North Dakota, currently the sole public bank in the U.S. "We are being robbed by big banks the same way they unjustly foreclosed on hardworking Americans during the housing crash that they created," he observed. "We can manage our own finances and create a state bank that would lend, open accounts and protect Californians."

Elia also advocates for free tuition within the state college system. "Our state will be short 1.6 million tech jobs and 1.4 million labor jobs by the year

student loan assistance also will go to the Assembly floor soon.

As a member of the Assembly's budget committee, Voepel acknowledged the "funding frenzy" in Sacramento on how to spend the state's expected surplus of revenue next

Voepel expressed his support for Gov. Jerry Brown's recommendation to put more funds in the Rainy Day Fund. "No one crosses Jerry Brown," he added. "I don't agree with all the budget, but it's as good as a budget as I'd get from Pete Wilson [former governor from San Diego in the 1990sl.

Healthcare is a critiissue Voenel said "We should all have access to insurance coverage," he said.

But Voepel's decades as an insurance agent help create his perspective. A variety of policies should be offered, so that individuals can mix and match to the coverage best for them. He did advocate a "stop/loss" that would put a cap on an individual's medical costs.

But he is opposed to the concept of a single-payer system, unless there are provisions for individuals to opt out of it, and buy private insurance for themselves or their family.

Putting everyone in Medicare or Medi-Cal won't work, in his opinion. If the key benefits are required, it will only continue to raise premiums, he argued.

Becoming a legislator after being mayor was not a significant change, but the challenge he finds is the different language and bureaucratic procedures in the Legislature and Sacramento.

County budget prospects improving

serve."

Riverside County's current-year budget condition appears much better than it did when approved in September or at mid-year in January. But the supervisors continue to be concerned about the Sheriff's Department staffing the unincorporated areas.

"It's good news. We have had a short-term improvement," Chief Executive Officer George Johnson told the board to begin the presentation. "It is principally attributed to reduced expenditures across the board in the county."

Johnson and Financial Officer Don Kent reported to the Board of Supervisors that expected costs have been reduced by nearly \$40 million.

The reported savings come from a variety of offices and departments; even though some still may incur a smaller deficit when fiscal year 2017-18 ends on June 30. But now, both county officials were pleased to report these results.

Johnson identified several reasons for the reduced spending. First, he credits the county's agencies for embracing operational efficiencies; the hiring freeze; and the use of subfunds rather than general funds when possible.

The biggest savings were in two departments, but these were not the only ones to reduce spending. The Sheriff's Department has swung 180 degrees from an anticipated deficit of \$9.3 million in September to a projected surplus of \$10 million. The county's medical center eliminated its projected \$15-million deficit.

Total savings are likely to increase the county's reserves to \$200 million, well above the supervisors' minimum level.

The proposed budget presentations for FY 2018-19 will begin in June, but already, revenue growth is no longer dismal. Kent told the board that projected revenue is currently \$26 million greater than this year's total revenue.

He also identified several issues that are driving expenses up in the future. Included in next year's preliminary Continued on page A8





For Dan Ball, race for congressional seat means intra-party fight first

Dan Ball, former news anchor at desert television stations, is a Republican candidate for the U.S. House of Representatives. He is challenging incumbent Congressman Dr. Raul Ruiz for the 36th District's seat.

First, Ball has to defeat four other Republicans to face Ruiz on the November general election ballot, assuming Ruiz does not receive more than 50 percent

of the ballots cast in the June 5 primary.

Ball's principal Republican competition is Kimberlin Brown Pelzer. Contrary to the Republican "11th Commandment," "Thou shalt not speak ill of any Republican," Ball argues that Pelzer only moved into the 36th District after announcing her decision to run.


Further, he believes much of her fundraising has come from sources outside the district. Pelzer has received substantially more campaign contributions than Ball or cumulative for the other four Republicans. (See accompanying story below.)

"I had a good start last fall ... but Ms. Pelzer brought 100 percent of her money from out of the district and that crushed fundraising," Ball stated. His contributors felt it would be unproductive to continue to give to Ball given Pelzer's backing.

But Ball cautions that money is not the biggest indicator of electoral success. "People vote for the best candidate to serve them. That comes from the message, the platform and the person," Ball argued.

This intra-party disparagement originates in Ball's belief that Pelzer or her supports initiated a whispering campaign in the desert questioning his military service. He enlisted in the U.S. Air Force even before graduating from high school. And that's where his journalism career began. He has given his challengers proof of his service. See Ball, page A7

Congressman Ruiz seeks re-election to continue to serve district

Congressman Dr. Raul Ruiz is seeking his fourth term representing California's 36th House District. He was first elected in 2012, when he upset incumbent Mary Bono Mack, and was re-elected in 2014 and 2016. In each election, his percentage of the votes cast has grown. In 2016, when state Sen. Jeff Stone challenged Ruiz, the incumbent garnered 62 percent of the vote.

Now a congressman, a former emergency-room physician, a former senior associate dean at the University of California, Riverside, campus's medical school, Ruiz said his biggest joy has been what he found being a spouse and parent.

"There is no greater joy than being Sky and Sage's father," he said proudly. "It's harder and harder to leave home to go to Washington."

He admitted that he is often asked if he misses the life of a doctor versus being one of more than 400 legislators. And frequently, other doctors are posing the question, he added.

"Because I am a doctor, I ran for Congress," he acknowledged. "From my experience with the public-health profession, I seek pragmatic solutions. I put people above ideology."

While he finds the pace in Washington to be frustrating, and exacerbated being in the House minority, Ruiz has found success getting bills enacted.

Notably, he pointed to his bill expanding how the Federal Emergency Management Agency may use funding, not just for recovery from natural disasters, but to try to prevent future wildfire disaster.

The idea for this legislation originated during his tour of the damage and destruction that the 2013 Mountain Fire created, according to Ruiz.

Expanding the provision of broadband communication capability in rural areas has been another priority for him. His Tribal Broadband Deployment Act requires the Federal Communications Commission to help bring broadband Internet to unserved tribal lands. But with that effort, it will also make it easier to improve connectivity for surrounding rural communities such as those in the Eastern Coachella Valley, and the San Jacinto and Santa Rosa mountains.

The Anza Electric Cooperative was very supportive of the bill and grateful when it was enacted in March, Ruiz's staff said.

"One of the things I promise is to continue to be highly engaged and have a highly involved congressional office devoted to the people of my district," Ruiz emphasized. His focus on the benefits of his constituents not only motivates Ruiz, but, he hopes, "We're so focused and continue to advocate for people here and to show re- $See\,Ruiz, page\,A7$

Pelzer wants healthcare choices for individuals

Kimberlin Brown Pelzer is one of several Republican candidates seeking to represent California's 36th District in the U.S. House of Representatives. She is hoping to turn the tables on Democratic incumbent Dr. Raul Ruiz, who upset the incumbent Republican in

Brown, who owns a design company, and co-owns an avocado farm with her husband, is hoping her experience as a small-business owner will sway voters in the District.

If one of the six candi-

dates earns more than 50 percent of the ballots cast, the constituents' decision ever, if none can overcome that hurdle, the two candidates with the most votes will compete through the summer and fall for victory in the November general

As of Friday, May 25, Pelzer felt she would definitely be one of those two. She even suggested that a June victory surge may occur since she strongly believes the gap between her and Ruiz is narrowing based on recent polling trends.

In her opinion, the recent tax-reduction bill has been

benefiting small businesses in the district; consequently re-enforcing her policy positions.

"Small businesses across the [Coachella] Valley restaurants, stores, and growers — are fed up with the rules and regulations," she stated.

One of her strongest beliefs is that the Patient Protection and Affordable Care Act, or Obamacare, "is still crushing small businesses and employees across the

She argues that this legislation is too costly. "People need multiple jobs to pay for insurance." And the deductibles are too high, so the insurance barely pays for any of their direct healthcare

Simply opposing the current health-insurance environment is not where Pelzer stops. She has been "... meeting with health insurers and leaders of medical

organizations to build a coalition of medical professionals to give me ideas and assure a chance of success."

Pelzer also favors a solution that reduces the decision-making authority of healthcare insurers and relies more on the medical decisions of physicians.

"Put healthcare decisions back where they belong. People go to doctors they can trust," she opined, "Doctors should have to work for you and have our best interest at heart. Insurance companies don't deal with life and death."

Besides healthcare, Pelzer favors a border wall, to keep drugs and sex trafficking down. She also has plans to revise the Legislature's budget procedures.

We need less government, less budget, and use common sense and what's best for people to make decisions in Washington," Pelzer said.



With the primary a week away, Republican Kimberlin Brown Pelzer has received significantly more contributions and has a large cash surplus compared to her four fellow Republicans.

At the middle of May, Pelzer had slightly more than \$100,000 in cash. Her four Republican candidates had less than \$5,000 collectively.

Stephan Wolkowicz has loaned his campaign \$4,500, significantly more than the contributions given to his race. And Douglas Hassett has loaned \$1,500 to his campaign.

However, Ruiz's cash balance of \$2.27 million is more than 20 times Pelzer's cash funds. She is hoping and expecting contributions will dramatically increase after Congressman Dr. Raul Ruiz (D) maintains a huge the primary, assuming she is one of the two candidates

His current priority is to stop or deter the use of military burn pits near military bases in Iraq and Afghanistan. These are used to dispose of waste, chemicals and

trash. They can be large -10 acres, for example. Unfortunately, the smoke and debris can be carcinogenic. This peril came to Ruiz's attention when Staff Sgt. Jennifer Kepner, a local Air

Force veteran, died from pancreatic cancer. "This is the modern-day Agent Orange," Ruiz stated. His bill would stop this activity, notify veterans to contact Veterans Affairs for exams and authorize more research on the effects of burn pits.

Although he is not a member of the House Veterans' Affairs Committee, it has acknowledged his leadership on this issue and invited him to its hearing later in June.

He also recently prepared a bill to improve the benefits to surviving families of first responders who die in the line of duty.

"It's not right and I'm focused on trying to find fixes that come from the real experiences of my constituents," Ruiz stated.

He also expressed his pride in encouraging the Small Business Administration to locate an office in the Inland Empire. Previously, the nearest SBA office was in Los Angeles or Orange Coun-

While the recent Trump tax bill focused on corporations and high-income earners, Ruiz is drafting legislation that would "give small businesses a tax reduction proportional to their payroll increases."

And he also expressed dismay about the future premiums for health insurance. Since the administration is not funding the cost-sharing reductions, authorized in the Obamacare legislation, there is less incentive for individuals to enroll. Consequently, premiums are expected to sky rocket, he believes.

Further, the work requirement being imposed for Medicaid is a burden and hurdle for individuals living in rural areas, such as our district. Ruiz added, "It puts families at a major disadvan-

Further, as people are discouraged or prevented from obtaining Medicaid, Ruiz argues this will affect the efforts to reduce opioid dependence.

The prosecution has no weapon and no direct evidence placing either man at the murder scene. However, Deputy District Attorney John Aki presented substantial evidence, such as cell phone records, a business card with Smith's fingerprints and shoe impressions taken at the scene, that

would likely place them there. Witness Jeremy Todd Witt took the Fifth Amendment to avoid testifying. Previously, in the prosecution's filings, Witt, who worked with Smith at Knott's Soak City in Palm Springs, allegedly reported that in 2007, Smith said to him,

"Something went wrong and we torched the f...ing place." However, the defense attorneys for both defendants argue strongly that all of the prosecution's evidence was cir-

cumstantial and insufficient to find guilt. At one point, the defense argued that no motive was presented and, therefore, the trial should be stopped or charges dropped to second-degree murder. However, Judge Bernard Schwartz's ruled that a motive was not necessary for continuing or for conviction.

If elected, Ball said one of his high priorities will be the complete restoration of the Salton Sea. Describing the current condition of the Salton Sea as "massive environmental and health concern," he wants to restore it, not simply mitigate the situation.

"On Memorial weekend, many Californians fled to Arizona to enjoy the river and boating," he noted. "If we fix it, they'll spend money in California in our district and this will help diversify the dis-

trict's economy." He also advocates improv-

ing pediatric and veterans' care within the district. Traveling through the district, he has frequently heard voters raise concerns about the lack of adequate healthcare. "For veterans, they have

to go to Loma Linda or a long drive to the LA hospital," Ball lamented.

"I want to improve transportation for the veterans, expand clinics in Palm Desert and reach out to the more rural areas such as Idyllwild, where it is further and harder to get to these hospitals," he

Consequently, he promised to decline the "Cadillac" health insurance Congress members receive, and rely on his Veterans Administration healthcare. "I'll sacrifice because I don't need great health care if Americans can't afford it."

event was endemic to the region's wild spirit, proof indeed that Idyllwild was once a cutting-edge frontier.

Before May 2017, it had been 15 years since a bear was sighted in Idyllwild. But in early May of that year, two juvenile bears were observed in unlikely places; a male was spotted at the Rite Aid in Banning and a female was witnessed shopping a car dealership in Indio.

It didn't take long for them to find their way to Idyllwild last summer, creating property damage and quite the buzz. The Indio bear's proximity to the danger posed by I-10 necessitated her relocation to the nearest mountain habitat in the Santa Rosa Mountain area. Wildlife officials tranquilized the Indio bear, and ear-tagged and moved her to an area where she could safely roam and forage. The Rite Aid bear moved to Idyllwild and seems to have moved out of the greater area of his own volition, said California Department of Fish and Wildlife Biologist Kevin Brennan.

Brennan added, "We only relocate bears who are in danger from human behavior, such as freeways, power stations or any other human behavior that threatens their safety."

In May, Scott Bump of Pine Cove and Nancy Carter of Fern Valley affirmed we have a yearling in our midst. Brennan estimates its age at 18 months, adding, "It's the

budget is funding for the John J. Benoit Detention Center and the inmate healthcare settlement. However, tentative agency increases of \$30 million are not in this draft, Kent said. And these grow to \$60 million in FY 2021-22.

Also, pension costs are beginning to rise, although the tentative guidance to county departments was to absorb it within current allocations. Next year, the pension increases could add \$10 million to the budget and grow to \$32 million

"Pension growth is not unique to Riverside County," Kent emphasized to the board. "All participating agencies are experiencing it."

Additional staffing for the Sheriff's Department in the unincorporated areas was a specific concern of Supervisor Kevin Jeffries (1st District). "I am going to come to the board at the first June hearing with a proposal to restore some of our unincorporated-area staffing funding," he shared. "This is going to make our budget scenario a little tougher. But our unincorporated areas are below acceptable staffing levels, just too far below."

He urged his colleagues to work together on an agreement to restore funding for the staffing levels, to which they had previously agreed.

Before the session ended, Supervisor Marion Ashley (5th District) voiced his concern about the candidates for supervisor seats in the current election making claims about the failure of the county's financial consultant, KPMG, to identify cost savings greater than its contract

Ashley argued that \$50 million in savings has already been identified and it will grow to more than \$200 million going forward.

be the addition of a third circuit, which will be a backup to the two already there.

In its letter to local customers, SCE notified that the work will occur between May and October. SCE warned that outages will occur, but Ward said they should be limited to daytime and he does not expect any to be overnight.

Next year, Edison will begin work to improve and strengthen the line from Valle Vista to the Idyllwild substation. During work on this 14-mile line, Edison will use helicopters to bring in poles and heavy equipment.

"This will increase reliability and reduce the duration of outages and support safety," Ward said.

Another benefit Ward and Brad Persak, manager of technical planning, described, would be the ability to limit outages to smaller areas and, therefore, a smaller population segment would be affected. With added circuits, Edison also will have greater capability to switch power to downed circuits from nearby undamaged circuits.

Brian Chen, from the Grid Resiliency and Public Safety office, addressed the situation in December when all power to the Hill was dropped. This occurred because the danger of a wildfire igniting from downed power lines was very high. Edison already had several crews on the Hill and they recommended the action because they were already encountering several downed lines from fallen trees or limbs.

While this precaution, public safety power shutoff, may occur more frequently in the future, Chen stressed it will be a last resort.

Millions of acres and more than a hundred-million trees have died throughout California. These pose fire dangers, and Edison is trying to address them in advance, but can't prevent all fires. Pacific Gas and Electric is being criticized for not making greater use of power outages during the extensive Northern California fires last fall.

Chen added that SCE plans to expand its use of weather forecasting and has been installing small weather stations locally to improve its awareness of the local situation.

"We're evaluating its use more often. We are focused on your safety and this is a tool in our arsenal," said Chen. "We'll always work with the local agencies and emergency response teams."

If there is sufficient interest, Feyder said MDP is willing to schedule another meeting to educate people about the nuances of purchasing a generator for emergencies.

New Medicare cards are arriving

The U.S. Centers for Medicare and Medicaid Services is mailing new Medicare cards to protect the safety and security of people with Medicare benefits. The cards no longer contain a person's Social Security number, but rather a unique, randomly assigned Medicare number that protects the identities of people with Medicare, reduces fraud, and offers better safeguards of important health and financial information.

CMS has begun mailing the new Medicare cards to people who currently have Medicare benefits in California. As soon as people receive their new Medicare card, they should destroy their old Medicare card and keep their new Medicare number confidential.

they scavenge through available garbage, seed storage and generally wreak petty destruction to communities ill-prepared for them each summer. If they don't find food in a populated area, they move on; their presence is historically short lived."

On May 8 at 8:38 a.m., "a yearling, bear meandered across our driveway within 25 feet of where I sat safely ensconced behind glass," recalls Bump. "Earlier that day, I was awakened by an earthquake, followed by this surreal sighting of a honey-colored brown bear. Who said rural living is boring?"

"Black bears [the only wild bears now in California] are large-bodied animals that have a small, narrow head, powerful limbs, and small ears," according to CDFW. "Black Bear precautions in town bears vary in color from tan or brown to black."

"My dogs woke me about 6 a.m. Tuesday, May 22, and that's when I heard the racket," said Carter. "The bear came on my deck, destroyed bird feeders, broke open and made short work of the contents in my bird food storage container. and devoured the acorns in the squirrels' feeder. Yes, it's a young bear, yes, it's a honey-colored brown." When asked where in Fern Valley, Carter said she lives near the Iron Garden on Wayne and recalled having a visitation at her home last year, too.

A yearling can put on another 100 pounds in the second year of life, said Brennan. Food sources include vegetable matter such as grasses, fleshy plants, berries, nut crops, grubs, fish and carrion. Bears have been known to quickly ambush small animals such as rodents, chipmunks and ground squirrels, digging them right out of the ground, and sometimes take a fawn.

On the exceedingly rare occasion that an adult bear becomes an imminent public safety threat by exhibiting ag-

yearlings that create the most havoc in populated areas as gressive behavior towards humans, it's euthanized versus relocated, he said. This is because aggressive bears have been observed to repeat this behavior. This philosophy does not apply to bears found guilty of property destruction.

Last year, the Town Crier collected the following good advice: While this bear is exploring the area near Idyllwild, our job is to discourage it from taking up residence in or near town, Brennan said. "Bears have a keen sense of smell," he said. "They will go after fruit, pet food, hummingbird feeders, human food and compost piles. Put these things away or get rid of them. Clean your grills. Secure your garbage or take it to the dump. Rid your yard of odors that might attract the bear."

- Remove/put away anything edible or smelly.
- Garbage: Use bear-proof containers until pick-up or
- Food: Keep indoors in odor-free containers; put away picnic leftovers.
 - Pet food and bird-feeder: Store indoors.
- Fruit trees: Protect with electric fencing, pick up fallen
- Compost piles: Remove them.

Bear precautions at campsite or trail

- Food: Put it in bear-proof containers or in a car trunk, not in your tent.
 - Camp: Clean up immediately after meals.
 - Hiking: Make enough noise to avoid surprising a bear.
- · Bear encounter: Don't approach, don't run away. Make noise and appear as large as possible. Give the bear space to leave.

Idyllwild to welcome 'awesome, inspiring athletes' to June 9 run/walk

The longest-running, community-wide sporting event on the Hill will take place Saturday, June 9, with hundreds of runners and walkers pushing themselves beyond their usual limit in Idyllwild's annual 5K and 10K Run and Fitness Walk.

Athletes will pound the pavement through downtown and forest campgrounds, and in off-the-beaten path neighborhoods to help raise money for the physical-education program at Idyllwild School.

After more than 35 years and with the support of local merchants, community organizations and individuals, the foot race has pumped more than \$70,000 into

the kindergarten through eighth-grade school's coffers. Idyllwild Race Committee, a nonprofit organization, is hoping to attract 300 to 400 participants, maintaining the race's popularity and a steady flow of local and off-the-Hill participants who return year after year.

"The race itself is a challenge and the course strenuous because of the altitude, but our scenic rolling hills, sunny, cool, pleasant days are a big draw," Race Committee member Michael Slattery said. "And it's fun, with custom-designed, [long-sleeved] T-shirts.

"We've got an active volunteer committee including Idyllwild School's Principal Matt Kraemer and P.E Teacher Darren McKay, our president. We've been working on the event for several months," Slattery said.

"And on race day, we'll get good support from the

Idyllwild Mountain Community Patrol and Idyllwild's Fire Department. It will be on hand for traffic control and the paramedics for emergencies ... but I can't remember any emergencies during past races.

"Our advice to first-timers is to start out moderate and get acclimated to the altitude."

Along with high-school students, weekend athletes, experienced competitors and entrants with physical limitations, event Emcee Chip Schelly confirmed that a few septuagenarians and octogenarians are in the mix, as in years past.

A significant number of participants will travel from Riverside and San Diego counties, and in previous races, from Ojai, in Ventura County. Some participants may show up in costumes in a nod to their alter-egos. "All are welcome," Slattery said. "And the event's pet friendly, too."

Lucy Osak, a 64-year-old licensed vocational nurse from Hemet, owes her love of road-racing to grit, determination, training — and a bevy of roadside supporters shouting words of encouragement.

"I have found no matter your size, ability or speed, there are people ready to cheer you on," Osak said.

Osak's journey to Idyllwild's 5K and 10K began almost 40 years ago as a mother of two taking ballet classes for fun.

"During a class, I fell while doing a grand plié. The next day, my right knee was locked in a 90° angle. Six weeks later, I had my first knee surgery, an arthrotomy, to relieve the pain and other problems I was having.

"With hyper-mobility, my knees were most affected. They would 'go out' without warning. The meniscus — the cartilage between my thigh and shinbones — would tear and after a while, there was bone-on-bone.

"I had 24 knee surgeries to try to fix and repair the damage, sometimes with serious complications like inflammation and blood clots [thrombophlebitis]. Eventually, both of my knees had to be replaced."

By her late 50s, in addition to the surgeries, Osak had been diagnosed with a laundry list of medical conditions. "Heart problems —Tricuspid Valve Disorder (TVD) — and multiple connective tissue disorder (MCTD)," she said.

"I believe the MCTD and my last diagnosis, See Run/walk, next page

Ehlers-Danlos Syndrome, are related. Ehlers is a rare disorder and inherited. It affects my skin, joints, and the walls of my blood vessels. Both my niece and daughter have it."

Over the years, Osak says she has "suffered migraines and seizures, and learned to live with chronic pain. At one point, my orthopedist placed me on longterm disability.

"For so many decades, doctors couldn't figure out what was wrong with me. And every time I went to new doctors, they would find something else wrong. It was a long ... and very frustrating time in my life."

Pushing 60, Osak decided she "needed to work on myself. The thought of aging and not being able to move, walk and the loss of balance were scary."

Since November 2017, she has completed 10 races nine 5Ks and one 10K — in three states. Idyllwild's 5K, will be her seventh.

"I am unable to 'run' due to my Total Knee Replacement (TNR). My doctor does not want me to run since it can affect or possibly damage the replacements, but I have an X-ray yearly to make sure there are no changes.

"In my last race, I managed to woggle (walk/jog) a 13-minute mile, a personal record, but by mostly walk-

"I hope my story can give hope to those with disabilities to just start with a few steps a day, and just maybe Fun Run will receive an award at the finish line.

they, too, can run (walk) the event next year.

"Maybe someone will be inspired to get up and move. Wouldn't that be great?"

When not competing in races, Osak trains and stays fit in a variety of ways. She joined the 2018 "I Love to Run 1,000 Mile Challenge" and uses "Run Girl Run" for virtual runs. So far, she has completed 624 miles and has been successful in 50- and 100-mile monthly challenges.

"Both groups are very supportive and inspirational, no matter your size, ability or speed. 'Run, walk or crawl' is their motto. Just keep moving. I also joined a bunch of ladies in Hemet that walk three mornings a week.

"And you are never too old to find love again," Osak

"During my Rock 'n Roll races in Nevada, Arizona and Texas. I held hands the whole way with Bruce Mc-Querry, my first steady boyfriend from El Modena High School in Orange, California."


Last June, McQuerry and Osak went on a date.

"It was fantastic," Osak said. "He knew I walked a lot and I jumped at his invitation to 'run' the Las Vegas Rock 'n' Roll 5K together.

"I hadn't seen him in 46 years."

Osak and other Idyllwild 5K and 10K competitors will kick-off at Harmony Monument in the center of town; runners 7 years and younger will run a half-mile loop starting at nearby Town Hall.

Older participants are eligible to earn prizes, special awards and custom medallions. All kids in the half-mile





Artist Steve Gruber paints outside during the 2018 Plein Air competition Saturday sponsored by the Art Alliance of Idyllwild.



Artist Rob Padilla, ambassador for the arts

Southern California native Rob Padilla's wicked imagination sees a world awash in color and amplified with near palpable sound. Not what you'd call silent art, his brush literally strokes the senses, rendering and amplifying, scoring harmonics with electric vibrance. "When you understand it (Padilla's art), your eyes open and the canvas invites you into a world of humor, social commentary, community, humanity and as Padilla sees it, a higher consciousness," wrote Julie Penray for Art Bastard, November 2016.

"I was a pretty typical beach-hanging sports enthusiast as a teen, always traveling with a sketch book. I made up characters in the form of cartoons, filling hundreds of sketch books that provide reference material and a historical context for my life," said Padilla.

As an editorial cartoonist in college, Padilla spent his early years as a free-lance cartoonist and graphic artist developing his own comic strip based on a rock 'n' roll, garage-band theme. Prompted by wider markets, he shifted gears, licensing his designs for wearable art and household goods. Padilla was a featured artist for the California gift show in Los

Angeles, San Francisco and Dallas for several years.

After the great recession, Padilla was forced to re-think his medium and picked up a paintbrush, capturing scenes on canvas with his signature "cartoonish" style. "Lots of color, love color," smiles Padilla. "A trip to La Bufadora, Baja, resulted in an uninterrupted year-and-ahalf to finish work, live solo and connect with my own painting style. After Baja, I created a wide-ranging body of work in LA, found an agent and started again. This time my focus was less commercial. I pursued fine-art galleries in Laguna Beach, Long Beach, San Diego, Phoenix and Ensenada."

Designing and painting murals gives Padilla's eclectic interpretation an expanded pallet. "I think of myself as an ambassador for the arts whenever I've done interactive projects; sharing with others how dedication to art brings me closer to creating visual stories I care about and love." Padilla continues, "I believe in camaraderie between artists because to support one another and the role we play capturing abstract moments, networking, sharing skills, makes everybody better."

Padilla's murals can be seen in Long Beach, San Diego, the Belli-up Tavern in Solano Beach, Taco Mesa Mexican restaurants in Orange County, in Long Beach at The Center and various private commissions.

"My family, always supportive of my creative nature, understood that it's part of me to process life and the world around me visually; art also allows me to express my contribution to environmental topics, pollution and raise awareness for social justice," said Padilla.

Once decoded, Padilla's is statement art. He prefers to exaggerate life, make fun of the human anatomy, adding spice to otherwise

tedious scenes. "I amuse myself with my own paintings and my collectors seem to relate. My lens invites their imagination to expand their experience through color and mood. I share a thumbprint that's unique, and hope to encourage others to express their uniqueness as well."

"Tve lived a conventional life many times over my life but it doesn't seem to be a good fit for me. It's a privilege to have explored an organic life and soon enough, I envision my journey leading me back to the coast. Idyllwild has been very good to me,

Chris Johnston laid down his hammer to say, "This patio was part of our plan since day one, but we needed to settle into the business and let expansion happen organically. On our first anniversary, we opened the upstairs loft, increasing our gallery space to 35 artists. Building the Middle Ridge Winery Tasting Gallery patio for this year's anniversary milestone just made sense.

"We expect the new patio will add seating for 17 patrons who prefer to be outdoors, its dog-friendly and we may offer it as a venue for special events," said co-owner Melody Johnston.

"Synchronicity," the gallery's current show, will hang through July 8. "We show 33 to 35 artists per quarterly theme, rehanging the entire gallery at six weeks to refresh the collectors' experience. 

Crime victim protection bill

Senate Bill 1146 by Sen. Jeff Stone (R-Riverside County) to protect crime victims from harassment by incarcerated individuals today received unanimous support from the State Senate.

The bill would give prison officials the authority to open and inspect outgoing mail from incarcerated individuals for the purpose of enforcing a restraining or protective order against the inmate.

"SB 1146 gives an additional level of protection to those victims who have already suffered enough," said Stone.

SB 1146 now advances to the Assembly for consideration.
