DeAntonio arrested for reckless discharge of firearm

Dozens of law enforcement officers respond to scene in Pine Cove

Mark DeAntonio, 52, of Pine Cove, was arrested Monday morning after law enforcement descended on Pine Cove in a helicopter and vehicles, warning residents to stay inside their homes. Multiple charges included discharging a fire arm in a negligent manner and possession of a loaded fire arm while under the influence.

A court date is scheduled for Wednesday morning, June 27.

Monday morning, the Riverside County Sheriff's

Trash service and trash-service fees increasing

The proposed increase in the trash-service fees paid to Riverside County were approved at the Board of Supervisors' meeting June 19. This is only for residential service.

The current annual fee of \$116.88 would be increased \$19.80 annually through July 1, 2021, with a fifth increase of \$19.92 on July 1, 2022. The most-recent increase in the fee occurred in July 2010.

This July, the fee will be \$136.68 until July 1, 2019. By July 2022, the trash-service fee

will be \$216 annually.

Jeff Johnson, deputy director of the county's Environmental Health Department, made a brief presentation to the supervisors before the public comments. He said if the normal consumer-price index had been applied to the fee, it would now approach about \$170 annually.

As part of the fee increase, the department has added several services. An annual clean-up week will be offered at the Idyllwild and Anza sites.

At Idyllwild, a household hazardous waste center will be established to accept antifreeze,

batteries, oil and paint. It will be open once a month. Also, the Idyllwild site will have two free tire disposal days each year.

The fourth new service will be added trash service at designated snow-play areas.

The county mailed 6,400 letters notifying property owners of the proposed fee increase. Fifty-five people responded with protests opposing the increase, according to Johnson. Only two residents, both from Poppet Flats, spoke at the public hearing.

Both felt the added services would benefit Idyllwild residents and offer little help to

IWD board raises water, sewer rates

Room full of opposition to increase

The directors of the Idyllwild Water District eventually agreed to raise the water and sewer rates for their customers. The public-comment period, which opponents to the rate increases dominated, the public hearing on the proposed increases, and the agenda items to vote on each increase consumed nearly two-and-a-half hours of the June 20 meeting.

The final vote on both increases was 4-0-1. IWD's newest board member, Les Gin, who was appointed earlier in the meeting, abstained on both votes. The other directors unanimously agreed to the district's capital-improvement program, including pipeline maintenance and replacement, and the water treatment facility.

Work has been deferred, and the needs have accumulated and exceeded current district resources. "Our income does not meet

the cost of production. Almost no maintenance has been done in the district for about 20 years," said Director Peter Szabadi. "We have to make it up."

Later in the meeting, when the board approved the 2018-19 budget, it also approved General Manager Jack Hoagland's 10-year capital-improvement program, which will total more than \$5 million at current cost estimates.

Opponents of increasing the rates were not disputing IWD's need to address capital investment issues. They urged the board to take more time to explore options to reduce costs in other ways and then assess what the rate need would be.

For example, former Director Vic Sirkin pointed to the 2017 pipeline project along South Circle Drive. Its cost, boosted because of grant funding, was nearly three times the average cost per linear foot that Pine Cove Wa-

ter District says it spends on pipeline installation.

Currently, Hoagland estimates he can reduce the IWD cost by a third, which is still about twice the PCWD cost. Sirkin urged the board to fund several small pipeline projects to evaluate whether the IWD staff would be able to bring the installation costs closer to the PCWD level. He also asked whether funding was included to train IWD staff to handle larger pipeline projects.

After evaluating those projects, then the board should calculate if higher rates were still needed and, if so, what is the new rate.

Supporting this approach, Pete Capparelli, who has several properties in IWD, said, "I don't mind paying my fair share, but I expect the board to do its due diligence spending our money. Why can Pine Cove do pipelines for one-third the price in our commercial district?"

More than 15 customers attended the meeting and a letter from local inn owner Chris Singer Perrault was read to the board. One customer, Deidre Vail, a

part-time resident, came from Walnut to attend the meeting and learn about the proposals.

Several of the speakers encouraged the board to pursue consolidation efforts with Fern Valley and Pine Cove water districts or, at least, greater cooperation. The intent would be reducing costs for each of the districts.

"To dance, you need two dancers. We'll make every effort to reduce expenses, but there is inherent opposition to consolidation," commented Szabadi.

Trudy Levy was concerned that customers may face more rate increases shortly after this proposal is approved. This rate proposal does not include drought-condition rates and she questioned whether IWD would have to propose those shortly, thus needing a new rate study. As the other speakers said, she recommended delaying this decision so that a more comprehensive choice could be made in the future.

President Dr. Charles "Chip" Schelly responded that "Members of the board are working on the

Idyllwild Water approves new budget

Les Gin newest director

At its June 20 meeting, the Idyllwild Water District Board of Directors was busier than normal. Not only did it hold a public hearing on the proposed new water and sewer rates (see accompanying story on page A1), but the board filled a vacant director's seat, approved a budget for next fiscal year, formed a committee to explore Hill water district consolidation, and rejected incentives to attract new employees to Idyllwild.

New director

banker and financier, was selected to fill the director's seat vacated when Catherine Dearing resigned in May.

He moved to Idyllwild from Arizona in late 2016. For more than 40 years, he has served in the financial industry. He has volunteered for many public boards in the Phoenix and Tucson areas. His public service includes a hospital and a community college.

In his presentation to the board, Gin said, "I will be here with fresh eyes and look at issues objectively. I'll listen to constituents in order to form a consensus."

Sue Nash, a retired educator and still an active environmental attorney, was the other applicant for the seat.

Director David Hunt asked each candidate how they would recruit and retain staff.

Gin replied, "Training is critical." He discussed his banking experiences shepherding staff from teller to higher-level positions. Nash replied that the district's employee-benefits package was the critical component. She recommended the district return to CALPERS, which Fern Valley and

Pine Cove Water districts use, for employee retirement and other post-employment benefits.

No other questions were posed. Director Peter Szabadi nominated Gin and the board unanimously selected him as its newest member.

Gin is the second director appointed this year, and the fourth in the past 19 months. Although he replaces Dearing, she was appointed to replace Vic Sirkin, who resigned in July 2017. This was too late to remove his name from the August 2017 ballot. Subsequently, the Riverside County Board of Supervisors appointed him to a four-year term. With the change in the IWD election years, the term expires in December 2022. Gin will have to run for election for the remaining two years of the term.

2018-19 budget

The budget for fiscal year 2018-19, which begins July 1, was approved unanimously 4-0. New director Gin voted for the budget. Director Steve Kunkle recused himself from this vote and stepped out of the room.

As a former IWD employee, he continues to benefit from retiree health insurance and post-employment benefits.

The proposed water revenue is projected to increase about \$106,000 based on the rate change,

es, to \$1.4 million. Much of this will come from residential customers whose total costs — base and usage — will grow from \$778,000 to \$908,000, while commercial customers will absorb a \$13,000 increase to \$425,000 total costs.

Excluding IWD's capital-improvement program (\$700,000) and depreciation of capital (\$218,000), IWD anticipates the water program will have a net operating margin of \$270,000 and after funding the capital program, reserves will be tapped for about \$425,000.

The board did make one change to the budget. Kunkle objected to the removal of several pipeline projects to be done exclusively with IWD staff. "We need to show constituents we're trying to save mon-

ey," he implored his colleagues.

Directors Hunt and Szabadi agreed that IWD should fund a pipeline replacement project that IWD staff could install. At the suggestion of Kunkle, the board removed a repaving project and replaced it with a small pipeline project.

The sewer budget projects another \$35,000 in revenue. At the end of the fiscal year, the sewer budget (before depreciation and capital investment) would show a net margin of \$260,000. The \$175,000 capital program lowers that to \$85,000 compared to about \$70,000 this year.

Consolidation committee

In response to frequent public comments encouraging the board to pursue

discussions with FVWD and PCWD over the possibility of consolidation, Szabadi recommended the board establish a committee to explore this idea.

President Dr. Charles "Chip" Schelly appointed director Szabadi, Gin and a public member, Sue Nash, to the committee.

During the meeting, Pine Cove resident Jeff Smith frequently offered reasons why residents of the other two districts would be reluctant to combine with IWD. Basically, previous IWD boards have fomented distrust.

However, fellow Pine Cove resident and Idyllwild property owner Marge Muir encouraged the board to proceed. She referred to the former Hill joint powers agency — the San Jacinto Mountain See IWD Budget, page A3

drought rates, and that would not affect what we'll approve tonight."

During the public hearing, Gregg Henry of NBS, who conducted the rate study, stressed that his analysis shows nearly 86 percent of IWD's costs would occur regardless of the water sales. However, the district currently collects only 40 percent of its revenue from fixed rates. Consequently, Henry argued that IWD is vulnerable to rapid changes in water consumption, especially reductions supporting conservation.

The new rate structure increases the district's revenue from the fixed charges. In 2018-19, fixed charges would provide about 50 percent of its water-sales revenue and this would grow to 60 percent in 2021-22, which would be "a more stable financial footing," Henry said.

He also stated that the single-family residential revenues do not subsidize commercial production, as one person thought.

Before the board vote, Hoagland reported that 19 written protests/objections to the rate increase had been received. To negate a board vote, 827 negative protests were needed, he added.

"I'm very upset with what the board is saying and how they hurt

the community," said Sue Nash, an IWD customer.

By approving the new rates without addressing the recommendations to seek cost savings, David Lilieholm told the board, "It does not seem like the board and general manager care. It doesn't appear the board will have any incentive to save money."

"Previous boards started the process that landed in our laps, costing \$300 per foot [for pipeline installation]. Going forward, we intend to do it for less and train our staff to do more," responded Schelly.

In making the motion to raise the water rates, Director David Hunt said, "I want the community to know a lot of thought and discussion went into this decision. I don't want to raise rates, but we're losing money every month."

In the discussion of the sewer rates, Hoagland said, "The plant works marginally. We can meet our discharge requirement, but we've been repairing things. The basic structure of the plant is very old."

And Schelly added, "Everything is working, but I don't think it will last forever."

Both votes were 4-0-1 in favor of the proposed rate increases. Pursuant to the board's resolutions, the new rates are effective July 1.

Area Water Study Agency — as a time when the districts cooperated and worked together on a common goal.

Several people, including Szabadi, stressed that "consolidation" was not the goal; rather, IWD should seek to find paths that would improve and broaden cooperation among the three districts. He said, "If not consolidation, maybe cooperation. I'll urge that we do some projects together."

"The different districts must have different strengths," said Deidre Vail, a part-time Idyllwild resident from Walnut. "Look for the best practices in Pine Cove, Fern Valley and Idyllwild. Maybe you could save a lot of money."

Supporting this view was Dwight "Buzz" Holmes of Idyllwild: "Why not look at what we can do and bring out the best management of all, not just IWD take over."

Nash advised that cooperation could take many forms besides consolidation into one district, such

as a simple memorandum of agreement or a community-service district. She recommended that the committee contact the county's Local Agency Formation Commission for information and advice.

Employee incentive

General Manager Jack Hoagland suggested the board consider offering an incentive to some employees to reside within 6 miles of the district. The field staff is responsible for being "on-call" for emergencies. For those who live farther, such as in Banning or beyond Hemet, it takes considerable time to respond to situations in Idyllwild, he said.

Hoagland thought a \$400 monthly stipend might encourage staff and new staff to move closer.

While the board recognized the value of this policy, it preferred to explore staff retention policies broader than just one. Consequently, it decided not to approve this step now.

Department and the California Highway Patrol responded rapidly and with dozens of officers to a call of "shots fired" in Pine Cove.

By 10:45 a.m., DeAntonio was in custody.

His house was searched and fire arms were found, according to Riverside County Sheriff's Lt. Zach Hall of the Hemet Station.

Luiz Chavez called in the incident, according to his post on Facebook, after a man came onto his property with a shot gun.

During the initial stand off, a helicopter circled the Pine Cove area above DeAntonio's house while California Highway Patrol, Riverside County Sheriff's Department and SWAT team members de-

scended on the area. Pine Cove residents said deputies told them to stay in their houses.

No one was injured in the incident.

Why a Membership?

Why not just a subscription?

We received a note this past week from a reader explaining why they were rejecting our Membership model:

"Why would I pay \$100 a year or more, when I have always paid \$39 per year for several years? I will just buy my Town Crier at the market. Do not bill me again unless you bring your subscription down to where it used to be."

Well, the good news within that note is that this person lives locally and is, and will continue to be, a regular reader of the Town Crier. For that, we thank you.

But we're sure this person is not the only one who doesn't yet get it, so let me explain in different terms why we went to a Membership model.

The simple answer is that \$39 per year wasn't making it. It didn't begin to pay for producing and mailing out 52 copies a year to a subscriber. If we had kept the old subscription model at \$39, which we had done for years, this dear reader would not be able to buy a Town Crier this week at a local market — or anywhere else.

The longer answer is that, across our entire nation, newspaper advertising has decreased dramatically. While advertising used to be the backbone of a community newspaper, that no longer is the case, and this is true for the Idyllwild Town Crier, as well. The number of businesses and organizations advertising in the Town Crier has been increasing of late, but it's still nowhere near where it was when the paper was sustained by advertising.

So, last August we decided the fate of the newspaper would have to be written by those who appreciate it the most — our readers. We went with the headline "Does the Town Crier have a future? Our readers must decide." And they did.

We now have 553 Members at various levels of contribution who do get it and who realize that it will take our Members annually pitching in what they can afford to keep the Town Crier coming. But for those who just cannot afford an annual Membership, there are 10 locations on the Hill where the TC can be purchased by the issue. And for those whose budgets cannot include \$1 a week for a newspaper, we have made Town Criers available for free to clients of the Help Center. It also can be read at the Idyllwild and Hemet public libraries.

Again, our thanks to you all for saving and supporting a real newspaper for our community.

IWD smoke and mirrors

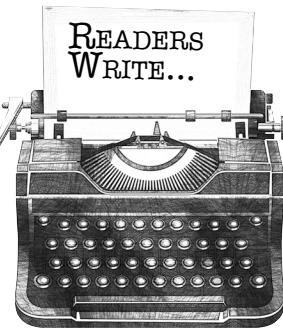
EDITOR:

1. If you live in Fern Valley, plan to use Lodge at South Circle to enter or exit that area between 8 a.m. and noon. 2. 4. I would urge anyone who must use North Circle Drive to enter or exit your property to plan on doing so either before the parade (9:30 a.m.) or after the parade (noon).

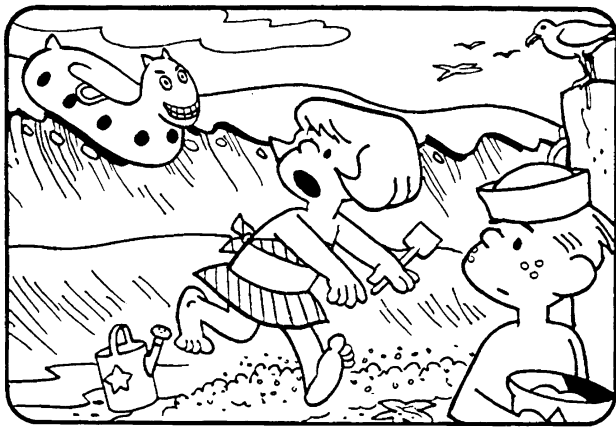

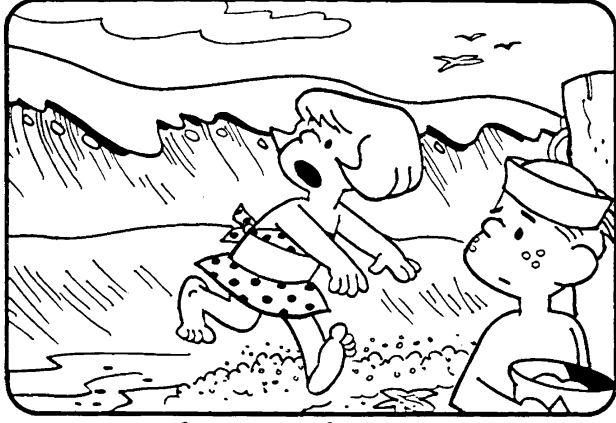

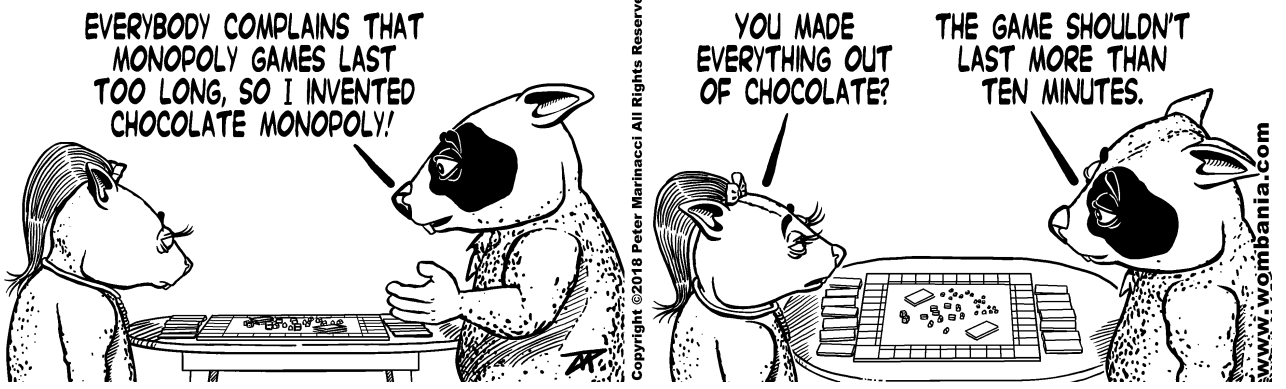

Health care on the Hill — your thoughts, please

Editor's note: Debra Varnado had an experience causing her to question emergency healthcare on the Hill. She plans to follow up on this issue with your help. Here is her story.

Last Friday night just before bedtime, I stubbed the middle toe on my right foot, leaving it unhinged at an odd angle as if poking fun at its strait-laced neighbors.

The next morning, several hours after the peak pain of my self-inflicted whacking had subsided, I took it upon myself to realign the errant toe.

"Easy enough," I thought, as my tugging on it during the night had barely registered a "6" on my pain meter. I casually and somewhat nonchalantly reached down and pulled it back in line.

"Ow, Ow, Ow," I howled, and lost my cookies right there in the bathroom, as my husband sat drinking his morning Joe only feet away in the bedroom.

Horrible, horrible, wretched pain like that of child birth, a whole-body experience, punishing and unrelenting for what seemed like forever.

In a minute, I hobbled my way back to bed, the pain having mellowed to an uncomfortable simmer, after which I dressed, and my husband rushed me off to receive medical care in Idyllwild at 8 a.m. on a Saturday.

There was none to be found. The clinic I had emailed and checked online to verify their weekend service was closed on Saturdays, according to the sign posted on the door.

Back home, I self-medicated with Tylenol PM, applied an ice compact and stayed in bed for the next 24 hours, but could not banish the "What ifs?" "What if I had fallen off of a ladder? What if I were feverish or vomiting? What if I had trouble breathing ...?"

"What's a poor girl to do for medical care in a painful situation like this," I asked my husband, "one that doesn't rise to the level of a full-fledged, life-threatening emergency?"

My husband said, "She'd do what any self-respecting

'mountain woman' would do: Cuss a little bit, spit on it, rub it and do exactly what you did: Pull it back in place and then go on about her business."

"So, now I am a bonafide 'mountain woman.' That's alright, not bad after only 13 months living on the Hill."

Next, I'll chainsaw that dangerous California live oak overhanging the garage — good for a couple cords; then I'll rake and haul a couple tons of duff to the dump; and put by some acorns to make meal for the winter. He'll love it when I shovel the driveway and dig his car out this winter.

But seriously, what are residents and visitors to do for urgent care when the urgent care doctors' offices are closed on the Hill?

Must they grouse, cry out in horrific pain, and then go to the fire department or drive down the Hill to Hemet or Banning?

Is access to urgent care adequate on the Hill or do Hill residents need additional service providers? Is it uncommon for several people to need urgent care on a Saturday morning, i.e., as my husband and I and two other people did last Saturday as we arrived simultaneously at the clinic?

Is demand high enough for... a hospital? How is urgent care managed in rural areas similar to Idyllwild, miles away from the nearest hospital?

Is the medical system on the Hill — urgent care and otherwise — optimal for the size and demographics of the population? If not, how can it be fixed?

These questions disturbed me as I tried lounging in bed, icing my toe, watching the awkward sex-play of this spring's juvenile squirrels on the deck; and working my way through Ken Follett's "A Column of Fire" tome. I could hardly enjoy my newly minted status as a real "mountain woman."

Gillman pleads guilty to felony

Vincent Daniel Gillman, 51, of Pine Cove, was arraigned in Riverside County Superior Court on Tuesday, June 19, charged by the District Attorney with one count of violating Penal Code section 487, subdivision (a), grand theft of more than \$950. Represented at the arraignment by a deputy public defender, Gillman originally entered a plea of not guilty.

Gillman had been arrested by Riverside County Sheriff's deputies the previous week and accused of embezzling more than \$100,000 over a period of months from Pine Cove Market and Mountain Center Market, where he worked as an attendant. (The markets are owned by the same company.)

Gillman's matter was set for a Felony Settlement Conference and a Trial Readiness Conference on June 28, with Preliminary Hearing set for July 2. But these hearing dates were vacated when Gillman withdrew his guilty plea and pleaded guilty Thursday, June 21.

On his guilty plea, Gillman was convicted of a violation of Penal Code 487, subdivision (a), grand theft of an amount in excess of \$950. He was sentenced to three

years of formal probation on condition that he serve 180 days in the custody of the Sheriff, 164 days of which is to be served in a work-release program on or before Aug. 6, 2018.

Gillman must report to his probation officer within two days of his release from custody and report all law enforcement contacts to his probation officer within 48 hours. He also was ordered to pay victim restitution in the amount of \$111,000, and he must submit to immediate searches of himself and all property under his control by a probation officer or law enforcement officer, with or without cause.

At his own expense, Gillman must participate in and complete any counseling, rehabilitation and treatment program deemed appropriate by his probation officer.

Several other terms and conditions of his probation deal with seeking and maintaining gainful employment or formal vocational education, banning all access to firearms or other deadly weapons, changes of residence address and other probation officer reporting requirements.

The manager of Pine Cove and Mountain Center markets remains unavailable for comment.

County agrees 'closest' will mean closest

Editor's note: The meeting in Mountain Center regarding ambulance response time was Monday evening, June 25. Below is brief report on the results. The July 5 edition of the Town Crier will include a fuller story of the discussion and issues.

Martha Pearson organized a meeting to discuss ambulance response time in the Mountain Center area, and she got a good response. About a dozen resi-

dents came out, but Riverside County officials from the Emergency Medical Department and Cal Fire, and Idyllwild Fire Department staff as well as some Idyllwild Fire commissioners attended and exchanged views and comments about resolving the residents' concerns.

Bruce Barton, EMD director, said he could eliminate the qualification in current "Closest [Advanced Life Support] Ambulance — Mountain Plateau" policy that says, "for purposes of closest ambulance, the

AMR Pine Cove Unit and IFPD ambulances are considered equal distance."

This pleased most at the meeting.

Barton did emphasize that he wants and needs Idyllwild Fire Protection District to sign the ALS contract, which all other ambulance providers in the county have signed. The contract specifies clinical, data collection, staffing and training standards that all providers agree to meet.

Planning Commission pursues cannabis land-use regs

On Wednesday, June 20, the Riverside County Planning Commission reviewed the proposed land-use ordinance for regulation of cannabis activities in Riverside County. After hearing testimony from dozens of citizens, the commission unanimously agreed to have its staff address several questions that were posed, such as permitting some activities in the R-A, R-R and W-2 zones.

The revised ordinance will come back to the Planning Commission at its July 18 session.

The majority of public comments were supportive of the ordinance's intent to permit multiple cannabis activities in the unincorporated areas of the county while maintaining public safety and health.

The proposed Ordinance 348 would establish allowable uses with certain county land-use zones and prohibit certain uses.

Prohibited throughout the unincorporated areas will be outdoor cultivation of mature cannabis. Several different indoor cultivation uses will be permitted, including personal cultivation of six or fewer plants.

The ordinance also prohibits mobile cannabis re-

tailers. Charissa Leach, assistant director for Community Development of the county's Transportation and Land Management Agency, explained that cannabis retailers with a physical store may deliver the product, but retailers may not sell from a vehicle. Examples of a mobile retailer were a food truck or ice-cream truck.

County planning staff has reviewed the regulations and procedures in other California jurisdictions and visited Denver, Colorado and Oregon, where cannabis is legal.

Uses that will be permitted and, therefore, regulated, include indoor cultivation, wholesale nurseries (excluding mature cannabis plants), retail stores, distribution, testing facilities, manufacturing facilities and micro-businesses.

Most activities will be limited to commercial, industrial or mixed zones. Nurseries will be restricted to agricultural zones as will mixed light cultivation. All activities must be at least 600 feet from child day-care centers, K-12 schools, public parks and youth centers. Retailers must be at least 1,000 feet apart, according to the ordinance.

Adoption of the ordinance does not require compliance with the California Environmental

Quality Act, but each permit the county may issue will require an assessment pursuant to CEQA, according to Leach.

Individuals applying for a county permit must be 21 years old and a background check will be done. The county will not investigate employees when reviewing a permit application. Operators must also obtain the appropriate state license.

The county plans to impose requirements, such as security, setbacks from lot lines and others, specific and more detailed for each cannabis activity. Consequently, each operator will have a specific conditional-use permit for the site of operations.

Also, each permit applicant will negotiate a development agreement with the county that the Board of Supervisors will review and approve.

If the supervisors approve the ordinance, Leach told the commission that in the first year, staff expects to issue 19 retail or dispensary permits and about 50 cultivation permits. She emphasized those are not limits, but what she expects the county staff to be capable of reviewing in the first year only. Over time, the number of permits will grow, according to Leach.

After ordinance approval and in the first year, the

county plan is to issue a request for proposals to operators interested in a county permit. The staff will review and grade the responses as part of the initial permitting process.

Temporary events must be on county property and are the only time consumption will be permitted on the site.

The overwhelming majority of the public comments supported adoption of the ordinance. The most common recommendation, especially from Anza residents, was to allow some cultivation on R-R, R-A, and W-2 zones.

This was one of the areas the commission asked Leach to review and offer recommendations at the next meeting.

Several speakers said cannabis cultivation was already occurring in these zones, which include much of the Anza Valley; therefore, the county should permit and collect some revenue.

One Anza resident argued that her 20-acre parcel, zoned R-R, was large enough to apply any setback requirement to protect neighbors from the odors; but she felt she was already surrounded by growers.

Another argued that the R-A zone is for agricultural activity and growing cannabis is consistent with that condition.

However, several Aguanga residents argued the opposite. They were glad that cultivation and other activities would be prohibited in their rural neighborhoods. The condition of their roads was a primary reason for restricting any commercial activity in their area.

Stepping forward from Idyllwild were Stuart Eberhardt, Alicia Berry and Dave Brown, and Morgan Knight of Pine Cove.

All expressed their gratitude to the county staff for developing the draft ordinance.

"Not all the people in the weed business are bad," Berry said. "We've gotten into our community and found out what is really needed in Idyllwild and Anza Valley."

"We're very concerned about security, seniors and meals on wheels in Idyllwild," she said, and then described her effort to help re-open the Idyllwild School snack bar [at the athletic field]. Proceeds will be earmarked for the school, she said. For Anza, she commented on the need for a youth center.

In finishing, she stated, "We want to be legit — 100 percent. We want to be completely legal, and you can generalize about weed people."

Brown recommended that activities in the R-A

and R-R zones should be examined on an individual basis because each is unique.

Knight expressed interest in permitting a non-store front retailer in his neighborhood, which is zone R-3A (mixed use). He argued that businesses such as antique and beauty shops or bookstores would be permitted. A non-store front retailer is only delivering a purchased product and he hoped, "R-3A would be considered for non-store front retail."

Some of the commissioners understood why speakers advocated greater flexibility in the R-R and R-A zones.

"I'm on the fence with R-R and R-A," said Commission Chair Ruthanne Taylor-Berger. "If you have 20 acres, maybe limit the lot size. I understand why someone wouldn't want it right next to them. But we might consider large lots in rural areas."

The commission unanimously requested the staff to review several issues, including how cannabis activities could be permitted but limited in the R-R, R-A and W-2 zones. The revised draft ordinance will be reviewed at the commission's July 18 meeting.

Composting and green cleaning

The Riverside County Department of Waste Resources will host free backyard composting and green cleaning classes Saturday, June 30, at the Idyllwild Nature Center.

Green cleaning teaches residents the benefits of using sustainable, environmentally sound cleaning practices. Presenters explain how to simplify your cleaning products, save money and make your home a safer environment.

The class demonstrates how easy it is to make cleaning products from ingredients most people already have in their home, such as vinegar, baking soda and rubbing alcohol. Participants will receive a booklet that contains basic recipes to make their own cleaning products at home.

The backyard composting class begins at 10 a.m. and the green cleaning class begins at noon.

CSA 38 builds 2018-19 budget plan

Members of the Community Service Area 38 (Pine Cove) Advisory Committee met last week to review the status of several projects previously approved. This would form the basis of the CSA 38 budget for fiscal year 2018-19, which begins July 1.

Through the first 11 months of the current fiscal year (2017-18), revenues from property taxes and interest received were about \$66,000. Expenditures this year for the same period have been about \$123,700.

The two major expenditures already paid from CSA funds were the acquisition of a wood chipper and the cost for the shaded cover over the gas pumps, which the Pine Cove Fire Station 23 and Pine Cove Water District share.

At the end of May, the county report indicates that CSA 38 has nearly \$420,000 still available.

During the meeting, with the help of Riverside County Battalion Chief Robert Fish, Station 23, and David Alvarez, development specialist for Economic Development Agency, the committee reviewed the status of previously approved purchases.

The masticator has been approved and the purchase order is with the manufacturer, Fish said. He expects it to be delivered in mid-July. The autopulse, an automated CPR device, has been delivered. Staff training must be conducted before it can be used on incidents.

The new rescue rope and extrication equipment has been ordered, according to Fish.

Collectively, these four purchases will cost CSA 38 about \$100,000 and are the basis for its proposed 2018-19 budget. There will be some other costs, such as additional fire hydrants.

Committee Chair Jerry Holdder estimated that these purchases and another estimated \$45,000 to help share the cost of fuelbreak maintenance for Pine Cove protection will total about \$165,000. After the acqui-

sitions are completed next year and the addition of the \$60,000 in property taxes, the CSA 38 cash balance at the end of 2018-19 should be about \$310,000, the committee estimated.

Committee member Marge Muir asked what the minimum balance or reserve should be. "Seems like we spend \$100,000 every year," she said. "We need to be conscientious and think of the community and what might come up in the future."

Alvarez pointed out the recent large acquisitions of a new engine, the masticator and chipper should not need replacing for eight to 10 years, giving the committee time to rebuild the cash.

Fish thanked the Advisory Committee for its willingness to invest in fire hydrants throughout the Pine Cove community, even in some of the non-residential areas.

"The Indian Fire [June 14] was held to a quarter acre thanks to the proximity of fire hydrants, which helped control it," Fish told the committee. "I'm supportive of any expansion of the fire hydrant system. I continue to believe that investment in the hydrant systems' infrastructure is a worthy protection."

County staff also reported that Rescue 23, which had been retired when the new patrol was purchased a year ago, had recently been sold at an auction. Since CSA 38 had originally purchased the vehicle for the community's benefit, the proceeds of more than \$12,000 will be returned to the CSA 38 account.

Prop 47 has had little effect on crime rates

It did help compliance with reducing prison population

Nearly four years ago, November 2014, California voters approved Proposition 47, but that was not the beginning of a crime wave — of any proportion — despite some law enforcement officials' concern about the effect of Prop 47.

Prop 47 reduced certain non-serious and nonviolent property and drug offenses from felonies to misdemeanors. The measure also allowed certain offenders who had been previously convicted of such crimes to apply for reduced sentences.

The proposition was a response to the U.S. Supreme Court decision requiring California to reduce its prison and jail populations.

This month, the Public Policy Institute of California released its study of how the proposition's new terms have affected crime and recidivism.

"We find no evidence that violent crime increased as a result of Proposition 47," the report's authors concluded. They also found no evidence that burglaries or auto thefts have increased since its passage.

The one correlated finding was an increase in larceny thefts, which have increased about 10 percent.

Thefts from motor vehicles and shoplifting typically represent three-quarters of these reports.

While some officials have attributed an increase in shoplifting to Prop 47, PPIC reported that shoplifting decreased in 2016. The number of incidents of shoplifting is about equal to the 2010 levels.

While violent crime reports have risen since the passage of Prop 47, PPIC identified two other more direct causes for the increase of reports. First, "the FBI implemented a change in 2014 that expanded the definition of sexual crimes that constitute rape." This alone represents more than 2 percent of the increase in the violent crime rate from 2014 and 2016.

Secondly, the Los Angeles Police Department was found to be significantly underreporting violent crimes prior to 2014. Accounting for both of these changes, PPIC determined that the 2016 violent crime rate was the lowest since 2010, except for 2014.

The reduction of sentences did lower prison population and the state has complied with the Supreme Court order.

Finally, the PPIC study also found that re-arrest and reconviction rates were lower after Prop 47's implementation than before.

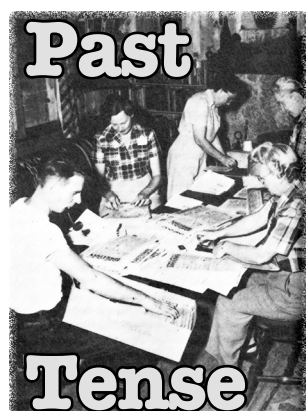

Cal Fire suspends burn permits

Due to potential for wildfire, Cal Fire/Riverside County Fire Chief Daniel L. Talbot is suspending burning by permit and other uses of open fire in all State Responsibility Area lands within the county.

The restrictions went into effect Monday, May 14, 2018, and apply until further notice:

- Use of campfires is restricted to within established campfire facilities located in established campgrounds open to the public.
- Cooking fires with a valid permit are permissive when no alternate means of cooking is available and requires an on-site inspection prior to the issuance of a permit.
- Warming fires are permissive and require an on-site inspection prior to issuing a permit when weather conditions exist to justify the request.

State rangers or other authorized agents of the Department of Forestry and Fire Protection may issue restricted temporary burning permits whenever it can be shown that burning or use of open fire is essential for reasons of public health, safety or welfare.

Twin Pines and Poppet Flats.

Supervisor Chuck Washington, whose 3rd District includes most of the property affected, recognized the costs and sympathized with the residents.

“But the franchisee has fixed costs,” he noted, and then made the motion to approve the new fees.

Supervisor Marion Ashley, whose 5th District does include some of the northern neighborhoods, was also torn by the choice. He recommended that CRR, the hauler, hold some community meetings to explain the need for the fee increase.

As he seconded the motion, Ashley said, “You can’t make the operator lose money to provide a public service.”

The board unanimously approved the increase, which is effective July 1. It will be applied to residential property taxes beginning with fiscal year 2018-19.

Franchise Area 8 includes Twin Pines and Poppet Flats in the north, continues south encompassing Pine Cove, Idyllwild and Mountain Center. The southern neighborhoods include Aguanga, Anza and Pinyon. Within the area are three drop-off sites — Idyllwild, Anza and Pinyon — which accept trash five days per week.

- 7 p.m. Friday, June 29: The week's highlight will be performances by the Mountain Cahuilla Bird Singers, and Canadian Inuit Throat Singers. Led by Bill Madrigal, the Bird Singers will open the evening by welcoming guests to the gift of bird singing given by the elders through oral teaching. The second act will offer the very rare opportunity to experience a Katajjaq performance by Inuit throat singers Kathryn Merritt and Charlotte Qamanig from Nunavut, Canada.

Katajjaq is a unique call and response form of traditional art found among the Inuit. A pastime between girls and women for thousands of years, these extraordinary songs and lullabies express emotions through the interpretation of sounds of animals, nature and tools.

Performed while looking into one another's eyes and holding one another at the elbow maintains the connection. Their blended voices, metered a half step off, create a compelling, mesmerizing and intimate cultural strength for the Inuit people, only passed through direct experience.

Jen Hajj kicks it up with new album 'Pale Blue Dot'

Jen Hajj doesn't remember a time before she began singing. From a young age, it was among her favorite activities. "I use music to express beauty by telling stories that move me or to appreciate something simple, even stunning," muses the Idyllwild lyricist and performing artist, who adds, "I have a strong feminist bent and really want to live in a world of equality using my voice to subtly promote social concepts."

Classified as a coloratura soprano, Hajj's melodic vocals bring a sense of elegance to her music. In the early years, Hajj joined choirs and bands, but as she matured, she looked for more personal ways to musically express herself. She picked up a guitar only about 13 years ago and has never looked back.

Self-accompaniment allowed Hajj to express herself individually. "After music school in Utah and learning the guitar, I found the proper vocal placement within its range where it's easy, then performing became second nature," Hajj said. "My process is to start with a phrase or a snippet of a verse, then add verses ... the last thing to come into play is the accompaniment."

A new song may take a year to get under my fingers."

Hajj recently won best performer, the equivalent of third prize, in the Morro Bay "Song Writers at Play" sponsored by Steve Key. "I've been told my lyrics are poetic and was recently asked to contribute my song 'The Pale Blue Dot' to the Santa Barbara literary journal. The editor was looking for lyrics expressed poetically," Hajj added.

"I have a strong feminist bent and really want to live in a world of equality using my voice to subtly promote social concepts."

To the question, have you found your voice? Hajj answers, "Yes, I think so. I'm venturing into the world of humor in song. It will come as commentary on the things that exasperate us like the news, or what angers us a little, or things that are unfair, by offering a coping perspective that moves me out of the middle. One example," smiles Hajj, "Does fitting into a young box mean wiring your jaw shut, eating raw 'veggies' while continuously taking classes to promote your art,

allow for any time to find it?"

One of Hajj's songs from her album "Shelter Songs" entitled "The Man Who Planted Trees" is a story about an individual's attempt to repair a broken world by planting 10 seeds a day. After the passage of decades, area residents grew to revere this massive forest. The narrator knows the forest isn't ancient ... but he's the only one.

Hajj performs in Idyllwild at least monthly. Her favorite performance spaces are Sam Kessler's Florist in the Forest, Spirit Mountain Retreat Center and other locales that are a good fit for music that opens a window and carries the listener away on a breeze.

Hajj's new album "The Pale Blue Dot" is in the works at Mike Gustin's MTG Studio. Most of the songs on the album deal with the contrast between opposites of scale. A wide point of view offers a different perspective. Her new album is scheduled for release at summer's end. Stay tuned for updates at JenHajj.com and on Facebook at Jen Hajj music.

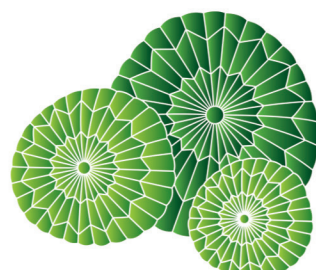

Community support builds garden

The Idyllwild Demonstration Garden keeps growing. Last week, a greenhouse was installed by Russell Kitchen and his team at The Soil Kitchen of Anza. The greenhouse is 17-feet-by-20-feet and will serve as a space to propagate plants and extend the Idyllwild growing season. The Idyllwild Association of Realtors gave the grant to purchase the greenhouse. Forest Folk donated an unused shuttle bus, which The Soil Kitchen purchased for their own business and non-profit Kids of Anza. The garden will use the proceeds to pay for more infrastructure and tools, and the Kids of Anza have a way to travel to various activities.

Village Hardware donated materials for the compost bin, and The Town Baker and Plant Food Support Club supply greens for the bin. Pino Tree Service, Pacific Slope and the Pine Cove Water District all donated the wood chips to retain water and build the soil.

Dora Dillman loaned the land. Tim Eddings helped with grading the lot, and Jon Millhouse of Town Realty helped spread mulch and is building the oak bench at the corner of North Circle Drive and Alderwood. Chiropractor Jack Stone will be donating several fruit trees for the planned food forest.

This Saturday, IDG is holding its third free garden education class at the garden. So far, students have learned about composting and built a compost bin, built a 4-foot-by-8-foot raised bed using recycled deck materials. New Medicare cards are arriving

CMS has begun mailing the new Medicare cards to people who currently have Medicare benefits in California. As soon as people receive their new Medicare card, they should destroy their old Medicare card and keep their new Medicare number confidential.

People with Medicare and their caregivers can visit medicare.gov/newcard to find out when new Medicare cards will be mailed to their area. They can also sign up for email notifications about the new card mailing and check the status in their state.

Summer Concert Series begins with a 17-piece big band

Patriotic music and themes from stage and screen

Ken Dahleen and his Big Band Staff open season 19 of the Idyllwild Summer Concert Series with a patriotic tribute to the Fourth of July and songs from Broadway and the movies.

The popular eight-week series, in a nod to locals, takes place on Thursday nights, not on tourist-heavy weekends. Season 19's downbeat takes place at 6:30 p.m. Thursday, July 5.

The location this year is new — the parking lot below the Idyllwild Brew Pub. The lot adjoins the Idyllwild Community Center property that has long been the series' home. Construction on the site makes the previous location unavailable this year.

Because the location requires navigating steps or the slope from the upper Strawberry Valley Plaza lot to the Brewpub Parking lot, Dahleen has arranged for the Idyllwild Shuttle bus to transport those who might need assistance from the upper lot to the concert site. The shuttle will operate both before and after the concert.

The pickup site in the Strawberry Valley Plaza lot will be clearly marked. Dahleen said this year's location will be able to accommodate as many attendees as in previous years.

The Idyllwild Brewpub will be open during the concert and provide another vantage point for concert patrons.

The inaugural evening will feature big-band patriotic music and themes from movies and Broadway with jazz-oriented arrangements. "We'll have selections from Doc Severinsen's 'Tonight Show' band, Count Basie, Ted Heath, Les Brown, Airmen of Note and others," said Dahleen. Tributes to the Fourth include "The Star Spangled Banner," "America the Beautiful and

"God Bless the USA."

"We're also featuring soprano Melissa Batalles," said Dahleen. "She has an extraordinary voice." Argentina-born Batalles has been widely featured with major orchestras. She can be heard on YouTube singing some of the most iconic Broadway classics, including "Glitter and Be Gay," from Leonard Bernstein's "Candide," an acknowledged test of the chops of any great soprano. Batalles will sing "Nessun Dorma" from Puccini's "Turandot," as well as Broadway and pop-standard favorites.

Producer Dahleen and his ISCS board mount this summer confection as a gift to town residents. There is no admission charge. But as Dahleen notes, although free, the series is not without cost.

"This year, because of the new location, there are extra costs we're not used to having, including new county permits and a generator," said Dahleen. "We're a long long way from meeting budget."

Each year, Dahleen and the board contract performers and launch the series on hope — hope that locals will donate enough to pay the bills — either as series sponsors or Thursday night contributors who fill the donation jars volunteers pass around.

Attendees are reminded to bring chairs and flashlights for after the concert.
